Khurda SP Swain contracts corona



"Eight patients admitted in burning and asphyxiation," said a senior police official of the Navrangpura police station.

RBI hits pause on key rates

GOLD TO FETCH HIGHER LOAN AMOUNT

Mumbai, August 6: The Reserve Bank

Thursday kept interest rates on hold to contain elevated inflation, even as it allowed banks to restructure some corporate and individual loans.

It also raised the limit of loans that can be availed against gold ornaments and jewellery and announced additional liquidity measures over and above those that have already been taken to reduce the asset-liability challenges in the NBFC sector over the last 3-4 months.

After reducing the interest rate by a total of 115 basis points since February, the six-member Monetary Policy Committee (MPC) voted unanimously in favour of the status quo, leaving repo rate at 4 per cent, RBI Governor Shaktikanta Das said on the three-day deliberations of the panel

The committee $\bar{\text{expects}}$ inflation to remain elevated in Q2 (July-September), ease only in the second half of 2020-21

The 115 basis point rate cut this year was on top of the 135 basis points reduction in an easing cycle last year.

'Given the uncertainty surrounding the inflation outlook and extremely weak state of the economy in the midst of an unprecedented shock from the ongoing pandemic, the MPC decided to keep the policy rate on hold," he said.


Das said the central bank would remain "watchful for a durable reduction in inflation to use the available space to support the revival of the economy."

The committee, however, unanimously decided to continue to keep its accommodative policy stance "as long as necessary to revive growth".

The RBI allowed banks to restructure

loans of companies that were not in de-

fault for more than 30 days as on March

1, 2020. Lenders can grant loan exten-

sions of as long as two years with or without a freeze on repayments.

Banks will however need to set aside higher provisioning for such a recast. There will be separate windows available for a restructuring of loans of Small and mid-size enterprises (SMEs) and individual borrowers who have been impacted by the pandemic.

Das said the limit to which individuals can borrow against gold ornaments and jewellery until March 31, is being increased to 90 per cent of the value from the current cap of 75 per cent.

RBI ending its rate cut spree is being seen as striking a balance between inflation and growth.

Moreover, as inflationary pressures mount and reached as high as 6.09 per cent in June 2020, RBI adopted a wait and watch stance to assess the impact of previous measures on various sec-

The pause on rate cuts was also on the back of the previous transmission of rate cuts to consumers through mortgage loans.

In response to the cumulative rate cut of 115 bps announced since February 2020, banks have already transmitted 70-90 bps in their home loan portfolio, being the fastest transmission.

While, economic activity had started to recover from the lows of April-May, a surge in fresh infections have forced re-clamping of lockdowns in several cities and states to "level-off" various high-frequency indicators. Das said.



NEGLECTED CITY AIIMS

Almost 50 per cent posts vacant; major equipment defunct

Bhubaneswar, August 6: Even though thousands of patients from across Odisha and neighbouring states rush to All India Institute of Medical Sciences (AIIMS). Bhubaneswar in case of emergencies, apathy of the institute's management is putting their lives in danger.

An RTI reply has brought to fore massive irregularities in this premier health institute of the state.

The RTI filed by noted Human rights activist Akhand revealed that almost half of the faculty positions at the hospital lie vacant. Similarly, various medical equipments needed for emergency surgical operations have been defunct since installation.

The data revealed that the AIIMS recorded an increase of around two lakh more patients during 2018-

19 than the previous year. The AIIMS in its reply to the RTI application mentioned that around 114 posts have been lying vacant out of the total sanctioned 305 faculty

post. The percentage of vacancy stands at 37.37%

Similarly, around 49 percent non-faculty posts including regular, contractual and deputation have been lying vacant at AIIMS. There are 1,864 non-faculty vacant posts as against the sanctioned strength of 3,776 in the institute.

Most astonishingly, several life saving machines have been lying defunct since their installations at AIIMS. touted as the most advanced

medical institution. The defibrillator machine that restores the normal heartbeats of a cardiac patient by sending an electric pulse or shock to the heart at the most critical moment_

has been lying defunct. "We have issued advertisement for the appointment of faculty but there are very few applicants and most of these are reserved posts. The defunct equipment mentioned in the RTI reply constitute a small percentage of the total equipment in use. All these machines are under warranty," said

Pertinently, the first instalment of ₹3000 crore was released in April to all States/UTs to aid and enable them to ramp up testing facilities, augment hospital infrastructure, conduct surveillance activities along with procurement of essential equipment, drugs and other supplies.

New Delhi, August 6: A document acknowledging Chinese intrusion into Indian territory was taken down Thursday by the Defence Ministry two days after it was uploaded on the MoD

"Chinese aggression has been increasing along the Line of Actual Control (LAC) and more particularly in Galwan Valley since May 5, 2020. The Chinese side has transgressed in removing documents areas of Kungrang Nala, Gogra and from websites won't north bank of Pangong Tso Lake on May 17-18," stated the document.

The document said ground level interactions were held between the armed forces of both sides to defuse the situation. A Corps commanders' flag meeting was held on June 6. "However, a violent face-off incident took place between the two sides on June 15, resulting in casualties on both sides."

Subsequently, said the document, a second corps commander level meeting took place on June 22 to discuss the modalities of de-escalation. "While engagement and dialogue at military and diplomatic level is continuing to arrive at mutually acceptable consensus, the present standoff is likely to be prolonged," the ministry said.

Meanwhile, Congress asked the government why the report mentioning Chinese 'transgressions' in eastern Ladakh was taken down with party leader Rahul Gandhi alleging that removal of the document from websites would not change facts. The document, was removed Thursday morning following publication of a media report based on it.

"Forget standing up to China, India's PM lacks the courage even to name them," Gandhi tweeted while tagging the news report based on the Defence ministry document.

The ministry report for the month of June had also said the situation in eastern Ladakh arising out of "unilateral aggression" by China continues to be sensitive and requires close monitoring as well as prompt action.

BCCI, Vivo cancel IPL deal for 1 year; may resume later

New Delhi, August 6: With 44 days left for the 13th edition of the Indian Premier League, the Board of Control for Cricket in India (BCCI) has decided to suspend the partnership with title sponsors Vivo.

This comes after the IPL Governing Council had Sunday decided to retain the company as title sponsors. "The Board of Control for Cricket in India (BCCI) and vivo Mobile India Pvt Ltd have decided to suspend their partnership for Indian Premier League in 2020," BCCI said in a media release.

The move to retain Vivo Sunday had seen a lot of backlash and there were even trends on social media about boycotting the league and the BCCI felt that it was in national interest to suspend the sponsorship deal as fan sentiments are a priority for the board.

Earlier Monday, Confederation of All India Traders (CAIT), which is spearheading a movement for boycott of Chinese goods, also criticised BCCI's decision to retain VIVO, the Chinese company, as IPL's title sponsor.

Puri: Devotees might catch glimpse of Holy Trinity soon

Puri, August 6: Devotees may soon have the opportunity to get glimpses of Lord Jagannath and his siblings at Srimandir here, said Srijagannath Temple Managing Committee member Ramchandra Dasmahapatra Thursday.

Dasmahapatra claimed that deliberations are on to introduce online registration for devotees to visit the 12th century shrine. However, sources in the Shree Jagannath Temple Administration (SJTA) made it clear that the shrine authorities have not taken any de- cision on the issue. Many devotees. meanwhile, opposed any move to introduce online registration system

for visiting Srimandir. According to Dasmahapatra, the residents of Puri city would get the chance to visit Srimandir in the initial phase. Subsequently, devotees from other places would have the opportunity to visit the shrine and pay obeisance to the Holy Trinity. 'A blueprint is being devised to introduce an online registration system for devotees. Devotees can register themselves by submitting their identity cards and other details. The shrine authorities would inform the devotees regarding the date and time of their visit to the Srimandir," he said.

It is worth mentioning here that the temple authorities had introduced a set of guidelines for devo-



tees March 16 this year to check the spread of coronavirus. As per the guidelines, devotees were told to wear masks and submit a self-declaration form describing their travel history and health status. Moreover. the devotees were advised to wash their hands before entering into Srimandir and refrain from touching Aruna and Garuda pillars.

However, the shrine was shut for devotees March 20 as there were several problems to enforce the new guidelines. Since then, the shrine doors have been closed for the devotees. However, rituals of the shrine are being performed without any interruption.

It is learnt that closing down of Srimandir has affected the tourism

sector of the Holy City. Most of the hotels and lodging houses are struggling hard to get tourists.

When contacted, SJTA administrator (rituals) Jitendra Kumar Sahu said the temple authorities have not held any discussion to introduce an online registration system. "The temple has been shut for devotees for last four and a half months," he added.

Many devotees, meanwhile, claimed that the online system would create issues for the common people. "Elderly people and many common devotees would find it very difficult to register themselves online to visit Srimandir. The temple authorities should not introduce the online system," said a devotee.

Fire safety at Covid hosps to be reviewed

Cuttack, August 6: The fire safety system at all Covid hospitals and Covid care centres in the state would be examined within 24 hours, said the Director General of Fire Services, Satyajit Mohanty, here,

Mohanty's statement came in the wake of the death of at least eight patients in a blaze at a Covid hospital at Ahmedabad in Guiarat in the wee hours of Thursday, Around 50 people have sustained burns in the hospital fire, sources said. "The assistant fire officers and additional fire officers have been directed to examine the fire safety system at all Covid hospitals and Covid care centres (CCCs) in the state. Any loophole in the fire safety system would be conveyed to the authorities concerned. Besides, the hospital authorities would be given suggestions to improve their safety system to deal with possible fire mishaps, Mohanty said.

The Fire Service DG further revealed that steps would be taken to ensure adequate fire safety measures at around 40 Covid hospitals and 6,770 CCCs in the state.

Total 67,491 beds have been arranged to provide treatment to the coronavirus infected people. Besides, there are also 1.490 cluster-level temporary medical camps in the state. "Our officials have been directed to examine the fire safety

"The state government has tied up with some private healthcare institutions to open dedicated Covid hospitals. These hospitals usually have fire safety system. However, most of the Covid care centres have been opened at stadiums, empty buildings and educational institutions. These centres may not have adequate safety measures to deal with fire mishaps," said a source.

New Delhi, August 6: Girish Chandra Murmu, a 1985-batch Gujarat cadre IAS officer from first Jammu and Kashmir Lt Governor last year, has been appointed as the new Comptroller and Auditor General (CAG) of India.

The decision came exactly a year after the Union government reorganised Jammu and Kashmir, bifurcating it into two Union Territories of Jammu and Kashmir, and Ladakh.

Official sources told IANS that Murmu has resigned as the Lt Governor. He will be replacing Rajiv Mehrishi, a 1978-batch IAS officer of the

Rajasthan cadre, as the CAG. Born in

Odisha's Mavurbhani district, Murmu had post-graduated

Political Science from Utkal University in Bhubaneswar. He was hand-picked by Prime Minister Narendra Modi for taking up the challenging job after Jammu and Kashmir became a Union Territory October 31.

Holding Business Administration degree from the Birmingham University, Murmu is perceived as one of the most trusted serving bureaucrats in the Union government. Before 2014, when Modi was the Chief Minister of Gujarat, Murmu was his Principal Secretary and was tasked to monitor all the prestigious projects of the state government.

Covid lock on rural water supply

PROGRESS IN KBK REGION NIL TILL END OF JULY

Bhubaneswar, August 6: Rural drinking water supply projects have been severely affected due to Covid-19 pandemic and the subsequent lockdowns.

The state was able to spend only 10 per cent of the approved amounts for implementation of drinking water supply projects under various schemes till July end.

According to sources at the Panchayati Raj and Drinking Water department, out of ₹9841.58 crore allotted for execution of drinking water supply projects, the engineering department personnel were able to spend only ₹976.19 crore till the end of July. It means only 9.92 per cent of the total funds was utilised till July end.

The government has set an ambitious target of executing 1,619 drinking water projects for the current year 2020-21. According to sources, 457 projects - 28.23 per cent - have so far been completed.

Out of 450 drinking water projects worth ₹2,240 crore sanctioned under Jal Jeevan Mission (JJM), only 105 projects have been taken up whereas 214 of 400 projects under Basudha scheme have been executed till July end, the sources

Only 31 out of 250 drinking water supply projects sanctioned under Rural Infrastructure Development Fund (RIDF) have been executed during the period.

Ironically, no project under State Finance Commission (SFC) grant has been implemented so far. Seven

mega water supply projects worth ₹135 crore are being implemented under this grant, the sources said. Likewise, only one out of 14 projects approved by Odisha Mineral Bearing Areas Development Corporation (OMBADC) has been completed till July end. Around ₹2,732 crore has been approved for these projects, of which only ₹229 crore has been utilised during first four months of this financial year.

The progress in KBK region is nil till July end. Although 22 projects worth ₹40 crore has been sanctioned for the KBK region, not a single project has been commissioned so far, the sources said.

The government has approved ₹1319.48 for execution of 476 water supply projects in the state during this year. However, 106 projects have been completed with an expenditure of ₹158 crore, they

The Panchayati Raj and Drinking Water department has asked the engineering staff concern to expedite the work to ensure timely completion of the projects.

Saurav Bhattacharjee, Nutrition Specialist from Unicef, Odisha said that breastfeeding prevents the new-

borns from several diseases and must not be shunned.

"Breastfeeding in the initial phases of a kid helps in boosting their immune system which can help them in fighting against diarrhoea, pneumonia and many other diseases besides ensuring their overall mental and physical well-being. The healthcare workers must counsel mothers for breastfeeding post birth especially during the pandemic time," he said.

August first week is observed as World Breastfeeding Week every year to improve the practices among the mothers of small children and enable the creation of a supportiveenvironment for successful breastfeeding of babies.

'Hospital on Wheels' for non-Covid patients in Ganjam

Berhampur, August 6: With several hospitals turning away non-Covid patients, amid the surge in coronavirus cases, the Ganjam administration has launched mobile health units to provide them basic medical services at their

The initiative—Hospital on Wheels—will be of great help to ment, especially in the rural parts of Ganjam, among the worst-affected districts in the state, a senior official said.

Five mobile health units, each consisting of at least one doctor, a pharmacist and other healthcare workers, will provide medical aid to those suffering from ailments other than Covid-19, District Collector Vijay Amruta Kulange

"If any patient exhibits symptoms of Covid-19, doctors will advise him or her to undergo swab tests. The patient will be shifted to a Covid Care Centre or a hospital if he or she tests positive for the disease," the Collector said.

Two mobile units will cover the Berhampur Municipal Corporation (BeMC) area, and the rest will cater to patients in three subdivisions—Berhampur, Bhanjanagar and Chhatrapur, Kulange said.

"The doctors at the mobile health units will attend to patients suffering from diseases other than Covid-19, much like what is being done at the clinics of Urban Primary Health Centres in the BeMC area," the Collector explained

Lauding the initiative, health activist Suresh Chandra Sahu said many ailing residents in the remote areas, who do not have access to medical facilities amid the pandemic-induced restrictions, will benefit from the move.

"While residents of the BeMC area can visit a nearby clinic for treatment, those living in the rural parts do not enjoy any such facility. The mobile units will be able to bridge the gap to an extent,


Bhubaneswar, August 6: State's Covid-19 tally surged past the 40,000mark Thursday with the biggest single-day spike of 1,699 cases, even as 10 more fatalities pushed the death toll to 235, an official of Health and Family Welfare department

Ganjam district, Odisha's coronavirus hotspot, reported three deaths while Sundargarh reported two and Bhadrak, Kandhamal, Keonjhar, Nabarangpur and Nayagarh reported one death each.

A 45-year-old coronavirus positive patient from Ganjam breathed her last, but the cause of her death was attributed to 'other health conditions', said the official, adding that Nabarangpur district reported its first Covid-19 fatality.

The state Thursday registered a total of 1,699 fresh cases, raising the tally to 40,717, the official pointed out. The latest Covid-19 cases were reported from 29 districts, with Ganjam topping the list (268), followed by Khurda (220), Sundargarh (178), Cuttack (105) and Sambalpur (101).

Altogether 1,073 people were detected positive from quarantine centres, the official said, adding that contact tracing and follow-up action have been initiated. Meanwhile, as many as 1,150 persons who had ear-



Shine & slump

old prices are making new records with every passing day. The precious metal (24 carat) Thursday inched up by Rs 225 to Rs 56,590 per 10 grams. It had closed Wednesday with an astounding gain of Rs 1,365. Weak dollar and concerns over economic growth worsened by galloping virus cases in the world are holding up international gold prices, as investors in western countries continue to put their faith in the yellow metal. Silver and gold have been the best performing assets so far this year with 40 per cent and 50 per cent returns, respectively and there is still a lot of upside. Ever since the outbreak of the pandemic, the price of gold has been relentlessly rising. There is a marked contradiction in the demand and price matrix, though. Demand for physical gold has slumped while its price has been escalating. Gold imports in the June quarter (April-June) saw a sharp plunge at 70 per cent to 64 tonnes--an 11-year low- as against 213 tonnes during the same period last year. What drives the current surge in gold prices? The demand drop is largely due to massive economic disruptions caused by the Covid-19. The pandemic broke out when the entire world was already in the grip of a global slowdown. Public demand has evaporated and so has consumption. People's incomes have drastically fallen. Job opportunities have gone through the window. Workers across industries and regions are struggling to live with truncated pay and job losses. In such desperate times, it is only natural that people hold on to whatever savings they are left with. Certainly not a time to spend on gold. Discretionary spend on gold, a major factor behind movement of gold, has come to naught. There is a drastic fall in demand for gold in China and India—world's two largest gold consumers. However, the fall in demand for gold in Asia has been more than made up by a surge in demand in western countries. Investors in Europe and America are piling into gold as a safe haven in the pandemic-ravaged economy, helping push its prices. Influx into exchange-traded funds this year in Europe and the US are at record level.

Although India is a major consumer of gold, its market is highly price sensitive. Buyers tend to shy away from gold whenever there is a markup in its price. The current slump in gold demand is largely due to its prohibitive prices. Moreover, repeated lockdowns/shutdowns in the country have ensured that businesses are shuttered and people stay inside. Shops have shut and malls have emptied. As regards lockdowns/shutdowns, there is no clear direction from the government. The pattern of lockdowns and shutdowns has so far been rather erratic. Shops and commercial establishments are $\,$ a confused lot. The fluidity of the situation has forced them to shun planning. The sharp rise in Covid-19 caseloads in July and August has dashed hopes of an early reopening of the economy. The situations are likely to remain so in near to medium term. If the demand in India and China for physical gold bounces back, the price will further run up. These are rather uncertain times for all stakeholders of gold such as traders, dealers, investors, artisans and consumers. With the discretionary spend on gold completely switched off, the yellow metal will have a troubled time ahead. The RBI Thursday raised the loan-to-value (LTV) on gold loans for non-farming purposes to 90 per cent from earlier 75 per cent. This would mean the same amount of gold can fetch larger loans when mortgaged with banks. This may not necessarily boost demand for gold in India as its current prices are already sky-high. At the most, this may raise short term liquidity for people holding onto gold. Gold will continue to shine amid slump.

Talk turkey


There are three well-known stories about this, none of them wholly convincing. We do know that it's a US term. It's first recorded in 1824, but is probably much older; one suggestion is that it goes back as far as colonial times. What the explanations have in common is of real turkeys. But the meaning of the phrase seems to have shifted down the years. To start with, it meant to speak agreeably, or to say pleasant things; nowadays it usually refers to speaking frankly, discussing hard facts, or getting down to serious business. The change seems to have happened because to "talk turkey" was augmented at some point in the 19th Century to "talk cold turkey", with the modern meaning. In the course of time it was abbreviated again, with the shorter form keeping the newer meaning. (The other meaning of "cold turkey" is unrelated.) The most prosaic answer is that the "to talk pleasantly" sense came about through the nature of family conversation around the Thanksgiving dinner table. It is also suggested that it arose because the first contacts between Native Americans and settlers often centered on the supply of wild turkeys, to the extent that Indians were said to have enquired whenever they met a colonist, "you come to talk turkey?" The most complicated explanation is a story about a colonist and a native who went hunting, agreeing to share their spoils equally. At the end of the day, the bag was four crows and four turkeys.

■ Tall tale

all is one of those curious words, like nice, that has had more meanings down the centuries than you can shake a stick at. Back in Anglo-Saxon times it meant swift or prompt, and later on it variously had senses of fine, handsome, bold, strong, brave, skilful and a good fighter. It was only in the sixteenth century that it started to mean somebody or something physically higher than normal. (Even now, we can speak of somebody being five feet tall, in which tall means having a specified height, not being of more than average height.) A little later, certainly by the 1840s, Americans had started to use it for something exaggerated or highly coloured, as in phrases like tall stories or tall writing. It's closely connected with tall order, something that is thought to be hard to achieve, and there were other phrases as well, such as tall time, meaning a long time, which Charles Dickens used. "Tall tale" obviously belongs in among these. I haven't been able to track down its earliest recorded use (for some reason, the Oxford English Dictionary has nothing earlier than 1933) but I did find this, from a lesser-known work by Jerome K Jerome of 1893 called Novel Notes: "I've come across monkeys as could give points to one or two lubbers I've sailed under; and elephants is pretty spry, if you can believe all that's told of 'em. I've heard some tall tales about elephants".



COVID, COMMON SENSE

WHAT WE NEED **ARE GUIDELINES WITH AN ARTICULATED RATIONALE, SO THAT PEOPLE CAN ADJUST** THEIR BEHAVIOR TO THE CONTEXT

s the Covid-19 pandemic rages on, our understanding of it is improving. Through a combination of epidemiology and physics - including knowledge of the virus's character and how aerosols float in the air – we are learning more about how the microbe infects new hosts. This understanding is fueling hopes that we will soon be able to counter the pandemic more effectively. But it has also led to some contentious exchanges regarding the social sciences and the interaction between social norms and the law.

Ever since the pandemic began to spread beyond Wuhan and around the world, there has been an increasingly acrimonious debate as to what all preventive measures should be decreed by governments and enforced by public officials and the police, and which should be promoted as social norms. Unfortunately, this debate has become so polarised that people are immediately classified as right-wing or left-wing depending on their view. Because people often do not like to be categorised in this way, and certainly not wrongly, many are reluctant to express themselves on this important question.

In fact, on many coronavirusrelated matters, we need enforceable laws. Especially in the early days of the pandemic, when people understood little about the virus, treating public-health measures as matters of personal choice was folly. Because some people decided to gather in large groups and not wear face masks, the disease became widespread in some countries, with Brazil under President Jair Bolsonaro and the United States under President Donald Trump being prime examples.

But it would be equally dangerous to swing to the other extreme and make governments solely responsible for changing our behavior. Autocratic regimes, in particular, are liable to use the pandemic as a pretext to arrest opponents and silence dissent. Furthermore, excessive government control is often the first step toward crony capitalism, whereby a few big firms use the levers of

state power to stifle competition and repress wages

Social norms are often more effective than government mandates, because they allow a degree of flexibility that statutes cannot provide. In Ithaca, for example, there is a bridge on Forest Home Drive that has featured in studies of games and social norms, including in William Ferguson's book Collective Action and Exchange. The bridge is so narrow that cars can pass only in one direction. Regulating the traffic flow by law might entail making it a oneway bridge, or requiring cars to travel from left to right in the morning and right to left in the evening. Or the law might require drivers to alternate, with one crossing from left to right and the next in the opposite direction, resulting in wasted space behind each car.

What happens in the absence of legal regulation is far better. There is a norm whereby three or four cars cross in one direction, and then the drivers behind them stop, allowing three or four cars to come from the other side. Because the norm, unlike a law, is flexible, you might, if you are in a hurry, decide to cross the bridge as the fifth or sixth car, delaying those waiting on the other side by a few seconds.

For example, if you are talking to a much taller person, or someone who holds their chin very high, you may need to move back an extra foot in order to allow any infected aerosol to complete its arcing

journey from face to floor. What we need are guidelines with an articulated rationale, so that people can adjust their behavior to the context. In a widely cited recent paper, for example, the University of California, San Francisco's Monica Gandhi and her co-authors show that face masks not only protect others from your Covid-19 germs, should you be carrying them, but also protect you from other people who may be infected.

There is thus both a social and a selfish reason for you to wear a mask. But if you are walking alone on a beach, you have every reason not to wear one. It is also reasonable not to wear a face mask in the company of people with whom you cohabit, given the likelihood that either all or none of you have

As we learn more about Covid-

19, we will develop better rules for ourselves. But two caveats are in order. First, many epidemiological studies warn that, for certain findings, causality has not yet been established. In fact, we can never establish causality definitively. We must regard all such claims with a dose of skepticism and the awareness that we may revise them later.

This is another reason to prefer the greater flexibility of social norms to the heavy hand of the law. For example, we now know that up to 40 per cent of people infected with the coronavirus are asymptomatic. In societies where only some people wear masks, the share of asymptomatic carriers could be as high as 90 per cent, as happened during one outbreak in Oregon. If they are not wearing a mask, their lack of symptoms puts us off guard, implying that wearing a mask may indirectly cause Covid-19 to spread more. This is of course not an argument for disregarding masks. Rather, it is a reminder that all ideas, whether rooted in folklore or science, must be comhined with common sense to optimize our behavior.

Health sector in doldrums

INDIA OCCUPIES, **ABYSMALLY, THE 170TH POSITION OUT OF 188 COUNTRIES IN TERMS OF PUBLIC** HEALTH **EXPENDITURE**

ith the number of Covid-19 victims rising exponentially, it is vital to assess where India stands in terms of medical capacity to provide the necessary healthcare. India's poor health infrastructure belies any hope; and the health sector is in doldrums. The nation ranked low at 145th among 195 countries in terms of healthcare access and quality, as per recent global assessments. To start with, the doctor-popu-

lation ratio. Here, it is 1:1456 against the WHO recommendation of 1:1000. This means, for a 1,000 population, India has only 0.9 doctors as against the world average of 1.6. India is behind China with 2 doctors and Pakistan and Sri Lanka one doctor each for a 1,000 population. If the number of government beds in India is considered, it was 0.7 per 1,000 population in 2011, which has declined to 0.58 in 2015 and further to 0.53 in 2017 -- as against a world average of 2.7.

Dismal health expenditure figures have triggered massive pressure on the existing health infrastructure, which is further enfeebled in the aftermath of Covid-19. As per a World Bank report in 2017, India's total healthcare spending was 3.53 per cent of the GDP, much lower than world average of 9.896 percent. However, public expenditure/government spending on healthcare as a percentage of GDP is a better index of the health-welfare of a people than the total health expenditure as a percentage of the GDP. On this count, India's performance is even more abysmal. Of the total public health expenditure, the Centre's share is 25 per cent.

The National Health Policy 2017 had recommended that the government's spending in health sector should be 2.5 per cent of the GDP by 2025. But, it is still ranging from 1 per cent to 1.29 per cent. India's public expenditure on health as a percentage of the GDP is far lower than those of the poorest countries. India occupies the 170th position out of 188 countries in terms of public health expenditure.

As per World Bank data in 2017, India's public health expenditure as a proportion of GDP is 0.96 percent against a world average of 5.89 per cent. India spends even lower than that of Bhutan with 2.37 percent, Sri Lanka 1.64 percent, and Nepal 1.24 percent. In terms of per capita health ex-

penditure per year, as of 2017, India's \$69.29 per cent is too low when compared to world average of \$1061.14. According to the National Health Profile of 2018, the public per capita expenditure on health increased from Rs 621 in 2009-10 to Rs 1,112 in 2015-16. That comes to Rs 93 per month or Rs three per day. Sri Lanka spends about four times as much. Question is: how people can cope with Covid-19, with a mere Rs 3 per day?

According to a WHO report, the total health spending is growing faster than the GDP in low and middle income countries (close to 6 per cent on average) than in high income countries (4 per cent). Health system resources are coming less from households paying out of pocket and more through pooled funds, in particular from domestic government sources. But. in India, this is declining.

India's health sector is the most privatized in the world. As out-ofpocket expenditure proportionate to total health expenditure in 2017, Indians spent 62.10 percent on health, compared to a world aver-

age of 18.207. According to National Health Profile data, the cost of treatment has been on the rise in India, which has led to inequity in access to healthcare. National Crime Records Bureau (NCRB) says that, troubled by illness, 3.85 lakh people committed suicide between 2001 and 2015.

The countries that have emerged as developed in course of time have seen increased expenditure in health as a percentage of GDP. Cuba spends 11.71 per cent of the GDP in health; with 10.47 per cent of the GDP being public health expenditure-the highest in the world. Cuba has 8.4 doctors per 1000 population, with 5.2 government beds for a 1,000 population.

Without increasing health care expenditure, relying on the health insurance route alone will serve no purpose. If the government invests more on health or provide health facilities to people at cheaper rates, they will have more income at disposal to spend. With the rise in discretionary spending, demand will rise, leading to an increase in economic activities and thereby faster growth and development.

The aid will also be used to strengthen the public health facilities infrastructure for treatment and development of ICU beds, installation of oxygen generators, cryogenic oxygen tanks and medical gas pipelines in public health facilities and procurement of oxygen concentrators, and engagement, training and capacity building of necessary Human Resources and incentives to healthcare workforce and volunteers, including ASHAs, on COVID duties.

The first instalment of Rs 3,000 crore was released in April to all states and union territories to aid and enable them to ramp up testing facilities, augment hospital infrastructure, conduct surveillance activities along with procurement of essential equipment, drugs, and other supplies. Prime Minister Narendra Modi had said that Rs 15 thousand crore have been provisioned for treating coronavirus patients and strengthening the medical infrastructure of the country.


Sushant case: CBI takes over probe

New Delhi, August 6: The CBI has taken over investigation into the actor Sushant Singh Rajput death case from the Bihar Police after reregistering an FIR of alleged criminal conspiracy and abetment to suicide against his rumoured girlfriend Rhea Chakraborty, officials said Thursday.

The case will be probed by a special investigation team under Superintendent of Police Nupur Prasad and will be supervised by DIG Gagandeep Gambhir and Joint Director Manoj Shashidhar, both senior IPS officers from the Gujarat cadre, they said.

The agency acted swiftly on a reference from the government in Bihar, the home state of 34-yearold Raiput, where his family had lodged an FIR against Chakraborty, they said. The Patna police had reg-



istered the FIR under IPC sections related to alleged criminal conspiracy, cheating and abetment to suicide, among others

The case has gone to the CBI on a reference from the Bihar government which has been forwarded to the agency by the central government. A state government cannot give a case to the CBI. It is routed through the Department of Personnel and Training, the nodal ministry for the CBI.

Seeing anguish over the death of Rajput in Bihar, which goes to assembly polls later this year, the state referred the matter to the CBI even as the Mumbai Police is probing the main case related to alleged suicide of the actor.

Disposing of a petition filed by Bahujan Samaj Party national Secretary Satish Mishra and Bharatiya Janata Party MLA Madan Dilawar, a division bench of Chief Justice Inderjit Mahanti and Justice Prakash Gupta said that notice, issued earlier by a single judge bench, should be delivered to all six former BSP MLAs,

by August 8. As the ruling party MLAs are camping in a Jaisalmer hotel, it said that the Jaisalmer District Judge should ensure timely delivery of the notice, taking the help of the local Superintendent of Police.

The notice should also be published in Jaisalmer newspapers, said the court.

The BSP and the BJP leaders had approached the division bench on Tuesday, challenging the order of a single judge bench that refused to stay the functioning of

the six as Congress legislators. Contending that the single judge bench has not given them interim relief, and that the notice it had issued to the MLAs concerned had not reached them as they are in Jaisalmer, they demanded that the court should, therefore, stay the merger order.

The single judge bench earlier issued notice to the Speaker, the Assembly Secretary and six MLAson July 30 and slated the next hearing on August 11.

'Pak trying to sneak weapons into J&K using UAVs'

Srinagar, August 6: Pakistan has adopted a new technique of sending arms and ammunition to Jammu and Kashmir using unmanned aerial vehicles (UAVs) and several such incidents have been detected in the recent past, Director General of Jammu and Kashmir Police Dilbag Singh said Thursday.

He also said less than 200 militants are currently active in Jammu and Kashmir, and just 26 terrorists could enter the Union Territory from across the border so far this year."Pakistan has been trying to send arms and ammunition to militants through drones (UAVs). We have detected several such incidents in the past," Singh said here.

The police chief said such incidents of Pakistani UAVs carrying weapons were detected in Kupwara, Heera Nagar, Kathua and Rajouri. Another modus operandi of Pakistan to dispatch weapons



through trucks to Jammu and Kashmir was unearthed in Punjab in the past, he said.

There has been a huge shortage of weapons for the militants operating here," the police chief said. The DGP said Pakistan has intensified cross-border firing this year so that terrorists could be pushed

into Jammu and Kashmir. "There has been 75 per cent more firing from across the border in the first seven months of 2020. There were 487 incidents of firing from Pakistan till July this year in comparison to 267 such incidents in the same period in 2019. The firings are cover to infiltrate militants. So far, just 26 militants could infiltrate

into Jammu and Kashmir," he said. Singh said due to sustained antimilitancy operations, the security forces have been able to curtail the number of active militants in Jammu and Kashmir to less than 200 now from 300 to 350 terrorists a few years ago. Referring to local youths join-

ing militancy, the DGP said 80 such youths have joined different terror groups this year of which 20 are now active and the self-life of such militant is now a maximum of 90 days. "Eighty local youths have joined

militancy this year so far of which 38 were killed and 22 arrested. Just 20 of those who have joined militancy are active now," he said. The police chief said as many as 150 militants were killed in 2020 so far, of which 30 are foreigners and another 39 are top commanders. "The terrorist groups are leaderless and facing a huge shortage of weapons,

Claiming success of the antimilitancy operations in last two years, the DGP said it has happened as the security forces have

gone against the terrorist support structure -- the Jamaat-e-Islami (JK), Hurriyat and their members and the Over Ground Workers (OGWs). Most of the leaders of the Jamaat and Hurriyat and OGWs are under custody and their funding has been halted, he said.

Singh said a Terror Monitoring Group (TMG) has been set up with representatives from the Jammu and Kashmir Police, Enforcement Directorate, Income Tax Department and a few other organisations, and the body is continuously working to curb funding of terrorists and their supporters. "Almost all links of sending money through hawala, western union money transfer and in tiffin boxes of couriers were shut," he said.

The police chief said security grade has been improved along the International Border and the Line of Control and as a result, six encounters have taken place along the borders so far this year.

Fire claims 8 Covid patients

Ahmedabad, August 6: Eight coronavirus patients died in a fire inside the ICU ward of a private hospital in Ahmedabad city in the early hours of Thursday, officials said. A para-medical staff member of

the hospital was injured in the tragedy. A cumulative compensation of Rs 6 lakh each for the families of the deceased -- five men and three women - was announced by the Centre and Gujarat government.

The blaze broke out around 3.30 am on the top floor of the fourstorey Shrey Hospital in Navrangpura area, officials said. It is one of the 60-odd 'designated' private hospitals which have been authorized by the Ahmedabad Municipal Corporation (AMC) to treat coronavirus patients.

"Eight coronavirus patients admitted in the ICU ward on the fourth floor of Shrey Hospital have died due to fire. 41 other COVID patients who were in the general ward on bottom floors were rescued and shifted to SVP Hospital," said Rajiv Kumar Gupta, an IAS officer.

Shrey Hospital was sealed for investigation, said Gupta, who has been deputed in Ahmedabad as an officer on special duty. Preliminary investigation showed that the fire was caused by a short circuit,

Gupta, Municipal Commissioner Mukesh Kumar and Principal Secretary (Health) Jayanti Ravi visited the spot. "We have learned that an electric short circuit led to a blast. The blaze spread in the ward within minutes," said Kumar.

According to Chirag Patel, a hospital attendant who saved the lives of three elderly patients, there were eleven patients on the fourth floor when the fire broke out. The deceased were identified as Lilavati Shah (72), Jyoti Sindhi (55), Ayesha Tirmizi (51), Navneet Shah (80), Arif Mansoori (42), Narendra Shah (62), Arvind Bhavsar (78) and Manu

Twist in Mallya case

The bench said let the explanation be furnished within two weeks. "The Review Petition shall, thereafter, be considered on merits," it added. In 2017, the apex court passed the order on a contempt petition against Mallya by a consortium of banks led by the SBI.



The therapy involves taking antibodies from the blood of a person who has recovered from COVID-19 and transfusing those into an active coronavirus infected patient to help kickstart the immune system to fight back the infection.



AIIMS Director Dr Randeep Guleria said Thursday no clear mortality benefit of convalescent plasma therapy was seen during a trial conducted among 30 COVID-

During the trial, one group of patients was given convalescent plasma therapy along with the standard supportive treatment while the other group only received standard treatment. The number of fatalities recorded in both the groups was equal and there was not much clinical improvement in the con-

dition of patients, he said. "However, this is just an interim

analysis and we need to do a more detailed evaluation to see if any sub-group may benefit from plasma therapy," Dr Guleria said. He also underlined that plasma has to be tested for its safety and should have sufficient antibody to be useful to

COVID-19 patients. The efficacy of convalescent plasma therapy in moderate to severe coronavirus-infected patients was discussed in the third National Clinical Grand Rounds (CGR) on COVID-19 held on Wednesday.

"Plasma is safe. As far as its efficacy is concerned, we do not have a green signal yet. So the clinical

within the ambit of national guidelines," Dr Monish Soneja, additional professor in the Medicine department at AIIMS, said at the

Convalescent plasma therapy has been listed as an investigational therapy for off-label use in coronavirus infected patients because as of now there is no conclusive evidence for its efficacy, Dr Soneja said.

About the initial findings of the randomised controlled trial, Soneja said, "Convalescent plasma is not a magic bullet." It may be used particularly in early moderate stage of the disease.

There may be a subset of patients with certain characteristics who may benefit from plasma, he said, adding, "This is a work in progress as we do not know those characteristics.

The findings highlight that relatives of the patients should not insist on plasma therapy until and unless the treating doctor considers the patient fit for it and where he may think that the mode of treatment would be beneficial, Dr Neeraj Nischal, associate Professor in the department of medicine at AIIMS, said.

Uninvited guest: Cobra comes home for dinner

Agra, August 6: A slithering serpent triggered a state of panic amongst members of a family as soon as they spotted the uninvited guest comfortably perched in a drawer of the almirah in their bedroom, perhaps waiting for dinner time to move out.

The local police man contacted the NGO Wildlife SOS which sent its team to nab the reptile. A two-member team from the NGO geared up with necessary rescue equipment and rushed to the location. After ensuring that the occupants were at a safe distance, the team carefully extricated the distressed cobra from the almirah and transferred it in a safe transport carrier. It took 30 minutes minutes for the rescue operation. The reptile was safely rescued by the team and was later released back in its natural habitat.

Baijuraj M.V, Director Conservation Projects for Wildlife SOS, said, "We are glad that more and more people are reaching out to us for help, rather than taking matters in their own hands. Snake sightings increase in the monsoons and our teams work round the clock to ensure no

call for aid goes unanswered. Kartick Satyanarayan, CEO and Co-founder of Wildlife SOS, said "Being one of the four most venomous snake species to be found in India, our team had to exercise a lot of caution while conducting the rescue in order to avoid any unnecessary casualties. Sometimes these rescues can be dangerous and risky, but our team is trained to handle and carry out such sensitive operations, in the interest of public safety and protection of urban wildlife.'

The cobra was kept under observation for a few hours and later released back in the wild. India is home to a variety of snake species ranging from extremely venomous snakes like the Cobra and Common krait to relatively harmless and non-venomous ones like the Common sand boa, Red sand boa. 

An unscheduled port visit led to disaster

Moscow, August 6: The chemicals that went up in flames in Beirut's deadliest peace-time explosion arrived in the Lebanese capital seven years ago on a leaky Russian-leased cargo ship that, according to its captain, should never have stopped there.

"They were being greedy," said Boris Prokoshev, who was captain of the Rhosus in 2013 when he says the owner told him to make an unscheduled stop in Lebanon to pick up extra cargo.

Prokoshev said the ship was carrying 2,750 tonnes of a highly combustible chemical from Georgia to Mozambique when the order came to divert to Beirut on its way through the Mediterranean. The crew were asked to load some heavy road equipment and take it to Jordan's Port of Agaba before resuming their journey onto Africa, where the ammonium nitrate was to be delivered to an explosives manufacturer. LEBANESE VENT FURY AT LEADERS

Residents of Beirut vented their fury at Lebanon's leaders Thursday during a visit by French President Emmanuel Macron, blaming them for the deadly explosion that ravaged the capital. Shouting, "Revolution!" they crowded around the visiting leader who promised to press the politicians for reform. For many Lebanese, Tuesday's giant blast was the last straw after years of corruption and mismanagement by a political elite that has ruled for decades. The blast, which killed more than 130 people, wounded thousands and left tens of thousands homeless, is believed to have been caused when a fire touched off a stockpile of 2,750 tons of highly explosive ammonium nitrate that authorities left sitting in a warehouse for years - despite a customs official's repeated warnings.

FB deletes Trump's Covid post

Houston: Social media giant Facebook, for the first time, has removed a post from US President Donald Trump in which he claimed that children were "almost immune" to COVID-19, saying it violated its policy against spreading "misinformation" about the novel coronavirus. The post in question was a video clip of a Trump interview on Fox News Channel uploaded by the Trump campaign Wednesday. The US President claims in the clip that children are "almost immune" to COVID-19. While much remains unknown about the novel coronavirus, children can contract COVID-19 and are believed to be able to spread it to others, even without symptoms. "This video includes false claims that a group of people is immune from COVID-19 which is a violation of our policies around harmful COVID misinformation," Andy Stone, a Facebook policy spokesperson said in a statement. It is the first time that Facebook has removed a post from Trump entirely, rather than labelling it, as it has done in the past, making it a rare instance in which it has been willing to censor the president.

'Sustainable mining can propel economic growth'

Bhubaneswar, August 6: The ongoing outbreak of COVID-19 has slowed economic activities with declining livelihood and opportunities. Amid such situation, the Federation of Indian Mineral Industries (FIMI) and Indian Bureau of Mines, Ministry of Mines, Government of India (IBM) stated that mining sector could be the key to tide over the economic crisis caused by the COVID-19 pandemic.

FIMI and IBM stated that a state like Odisha has the lion's share of the country's natural resources accounting for 25% of coal reserves and over 50% of bauxite reserves. Also, an extensive coastline provides the coastal state a direct gateway to the global trade market.



Over the years, the Indian Aluminium industry has invested over Rs. 1.4 lakh crore in Odisha.

FIMI believed that even with bauxite reserves of 2 billion tons, Odisha-based industries have to meet their bauxite requirements from imports, rendering them economically unviable and globally uncompetitive. Further, the federation said, due to imports, the industries operate at reduced capacity causing loss of local jobs. Import of bauxite, one of India's most abundant ores, has caused an estimated forex loss of over 400 million dollars

BCCI, VIVO SUSPEND IPL PARTNERSHIP FOR ONE YEAR

New Delhi, August 6: The BCCI Thursday suspended the IPL title sponsorship deal with Chinese mobile phone company Vivo for the event's upcoming edition amid the Sino-India border

The BCCI sent out a one-line statement, without giving any details, to say that Vivo will not be associated with the IPL this year.

'The Board of Control for Cricket in India (BCCI) and vivo Mobile India Pvt Ltd have decided to suspend their partnership for Indian Premier League in 2020," the press release stated.

The company, on its part, stated that the association is being paused. "The Board of Control for Cricket in India (BCCI) and vivo Mobile India Pvt Ltd have mutually decided to pause their partnership for the 2020 season of Indian Premier League," it stated.

Vivo won the IPL title sponsorship rights for five years from 2018 to 2022 for a reported sum of ₹2190 crore, approximately ₹440 crore per annum.

It is learnt that the two parties are now working out a plan in which Vivo

might come back for a fresh three-year period starting 2021 on revised terms. However, a top BCCI official offered a

Manchester, August 6: Real Madrid will be looking to overturn a 1-2 first leg deficit when they travel to Manchester City for the second leg of their last 16 UEFA Champions League (UCL) contest, Friday night.

City recorded an impressive victory when the pair met at the Santiago Bernabeu back in February meaning that Real have plenty to do if they are to advance to the quarterfinals of the competition once

It would be fair to say that it has not quite been the season that the City supporters would have been hoping for. Indeed, in addition to giving up the Premier League trophy to Liverpool, the Citizens suffered a 0-2 defeat to Arsenal in the semifinals of the FA Cup as they surprisingly bowed out.

Pep Guardiola's side did lift the EFL Cup courtesy of a 2-1 win over Aston Villa back in March, but it would go down as a disappointing campaign if that was the only silverware that they were to secure in 2019-20.

The English giants are in a strong position to reach the quarterfinals of the Champions League, though, holding a 2-1 advantage from the first leg of their clash with Madrid at the Bernabeu.

City would have been feeling good about themselves after the first leg, but there is a degree of uncertainty heading into the reserve match due to what has transpired across the world of football in recent months.

City ended their Premier League season with a thumping 5-0 win over Norwich City, which saw them finish on 81 points, 18 behind champions Liverpool in the Premier League table. They have been full of goals since returning to the field in June but have also lost to Chelsea. Southampton and Arsenal.

The Citizens were beaten by Tottenham Hotspur in the quarterfinals of last season's competition, while they have only won one of their five two-legged knockout ties against Spanish opposition, losing each of their last four, which will be a concern as they prepare to welcome the reigning La Liga champions. City's last home game against

a Spanish club saw them lose 1-3 to Barcelona in the group stages of the 2016-17 competition, although they have won four and lost just two of their nine previous home matches against teams from

Guardiola's side will be the favourites to progress considering what happened in the first leg back in February, with the onus very much on Madrid to turn the tie

The special circumstances, surrounding the contest, mean that anything is possible, though. and it remains to be seen whether Manchester giants can hold off the threat of Los Blancos to

> advance to the final eight once again.

Last season was actually the first time since 2009-10 that Madrid failed to reach at least the semifinals of the competition as they bowed out to Ajax in the round of 16, and an exit at this stage would have to go down as another huge disap-

ment considering their pedigree in the competition.

Madrid have won their last seven away matches in the round of 16, though, while they have been victorious in 16 of their last 25 European away fixtures, suffering just five defeats, which is a brilliant record at this level.

The Spanish outfit have also won eight of their 12 two-legged knockout ties against English clubs in European competition, notably overcoming City in the semifinals back in 2016 courtesy of a 1-0 suc-

That said, only on one previous occasion have Madrid lost the home first leg of a European tie and still managed to progress, which occurred back in 1971.

Gelsenkirchen (Germany), August 6: Manchester United and Inter Milan booked their places in the Europa League quarterfinals as continental soccer returned in empty stadiums amid the coronavirus pandemic.

United won 2-1 against LASK Linz Wednesday to complete a 7-1 aggregate win over the Austrian club, five months after the first leg was played. LASK held the lead on the night for two minutes after Philipp Wiesinger's 55th-minute goal, but Jesse Lingard soon leveled for United. Anthony Martial scored another for United in the 88th.

The win sets up a quarterfinal reunion for Solskjaer with his former Norway teammate Stale Solbakken, the coach of Copenhagen. They played together at the 1998 World Cup.

Inter beat Getafe 2-0 with goals from Romelu Lukaku and Christian Eriksen. It was a one-off game played in Germany because they did not complete a first leg before the European season was suspended.

Lukaku gave Inter the lead with his 30th goal of the season, picking up Alessandro Bastoni's high pass in the 33rd minute and holding off a defender before stroking the ball low into the far corner. Eriksen made it 2-0 in the 84th, hammering in a loose ball in the penalty area two minutes after he came on from the bench.

Shakhtar, the 2009 UEFA Cup winner, won 3-0 in the second leg against Wolfsburg to complete a 5-1 victory on aggregate. The Ukrainian club didn't score until a goal from Junior Moraes in the 89th minute. Moraes and Manor Solomon added a goal apiece in stoppage time.

Copenhagen reached the quarterfinals of a European competition for the first time after overturning a 0-1 deficit from the first leg against Istanbul Basaksehir to win 3-1 on aggregate thanks to two goals from Jonas Wind. All games from the quarterfi-

Jakobsen was airlifted to a hospital in serious condition and was put into an induced coma, the Tour de Pologne press office said. Race director Czeslaw Lang blamed Groenewegen saying, "Groenewegen changed his trajectory, was pressing Jakobsen to the right side and on top of that stuck out his elbow. You don't do that."

Premier League reverts to maximum three-substitution rule

London: The Premier League (EPL) will revert to a maximum of three substitutions in matches next season with England's top division clubs deciding to no longer allow two additional changes. Clubs previously backed the use of five substitutions to deal with the congested schedule after the league's pandemic-enforced 100-day shutdown ended in June. Despite the International Football Association Board allowing the temporary use of five substitutions next season, the league won't be adopting it. The rule had been seen to favor bigger clubs with more depth in their squads. A maximum seven substitutes will be allowed on the bench but only three can be brought on when the new
