Malkangiri, Sept 7: The state government has sanctioned ₹116.09 crore under Socio-Economic Transformation and Upliftment (SETU) scheme over past three years for the development of Swabhiman Anchal' (erstwhile cut-off region) in Malkangiri district.

However, brining in a major transitional development for the residents of Swabhiman Anchal, cellular services were launched Monday.

The Swabhiman Anchal in Malkangiri district had so far been deprived of basic amenities mostly due to high prevalence of Naxals. With continued efforts of the state government and Odisha Police, the presence of Naxals has dropped and development has begun. Mobile phone services began in Hantaguda, Tikilipadara, Jantasahi and Barlabeda in the district Monday morning, sources said.

During his visit to Malkangiri district August 29, DGP Abhay had mentioned that there had been a major development in the area over last six months. This included establishment of a large number of telecom towers, of which six are in Chitrakonda area. Construction work of eight roads is underway most of which are complete.

MLAs, Assembly staff to undergo Covid tests

Bhubaneswar, Sept 7: In view of the spike in Covid-19 cases, all MLAs and Assembly staff will undergo Covid-19 test two days before the commencement of the monsoon session of the State Assembly.

Though no specific date has been announced for the session, Speaker SN Patro said it will start before September 30.

Patro held a high-level meeting with health and Bhubaneswar Municipal Corporation (BMC) officials here Monday to chalk out a strategy to conduct the monsoon session. Parliamentary Affairs Minister Bikram Keshari Arukha and Health Minister Naba Kishore Das attended the meeting.

Patro said the legislators and staffers will undergo aCovid-19 test two days before the beginning of the Assembly session. RT-PCR tests of the MLAs will be done and those testing negative for the virus will be allowed to participate in the proceedings.

The tests will begin at 6 am two days before the commencement of the session.

Swabs will be collected from all. Test reports will be available before the commencement of the Assembly session, the Speaker stated.

Again on every fifth day the concerned persons will be tested for Covid-19. After the session is over for a day, the legislators have to remain in home isolation, Patro further said, adding special seating arrangements will be made for MLAs above 60 years of age.

BMC and health department officials were asked to make arrangement for conducting the tests on the Assembly premises with the help of a team of doctors, he added.

Welcoming the decision, Leader of Opposition Pradipta Naik urged the Speaker to convey an allparty meeting to decide the issues and businesses to be taken up during the session.

WCD Minister Smriti Irani on Monday assured Vice-President M Venkaiah Naidu that the central government would consider recommending to all the states to "include milk in the midday meal scheme".

cessfully flight-tested hypersonic technology that will pave the way towards development of missiles travelling at six times the speed of sound.

With this successful demonstration, the country enters an elite club to become a member of the hvpersonic regime. This is a step towards manufacture of advanced Hypersonic Vehicles. India became the fourth country after the United States, Russia and China to get this technology.

The Defence Research and Development Organisation (DRDO) successfully demonstrated the Hypersonic air-breathing scramjet technology with the flight test of Hypersonic Technology Demonstration Vehicle (HSTDV) at 11:03 am Monday from the APJ Abdul Kalam Launch Complex at Wheeler Island, off the coast of Odisha.

Defence Minister Rajnath Singh has appreciated the DRDO for achieving this milestone.



INDIA IN ELITE MISSILE CLUB

The Hypersonic cruise vehicle was launched using a proven solid rocket motor, which took it to an altitude of 30 km, where the aerodynamic heat shields were separated at hypersonic Mach number,' said the DRDO in a statement.

The cruise vehicle separated from the launch vehicle and the air intake opened as planned. The hypersonic combustion sustained and the cruise vehicle continued on its desired flight path at a velocity of six times the speed of sound.

Critical functions such as fuel injection and auto ignition of scramiet have demonstrated technological maturity. The scramjet engine performed in a textbook manner.

The parameters of launch and cruise vehicle, including scramjet engine, were monitored by multiple tracking radars, electro-optical systems and Telemetry Stations.

The scramjet engine worked at high dynamic pressure and at very high temperature. A ship was also deployed in the Bay of Bengal to monitor the performance during the cruise phase of hypersonic vehicle.

All the performance parameters have indicated a resounding success of the mission. With this successful demonstration, many critical technologies such as aerodynamic configuration for Hypersonic manoeuvers, use of scramjet propulsion for ignition and sustained combustion at hypersonic flow, thermo-structural characterisation of high temperature materials and separation mechanism at hypersonic velocities can be achieved.

Kangana given Y-plus security cover by Centre

New Delhi/Shimla, Sept 7: Kangana Ranaut has been given Yplus category security and will be protected by about 10 armed commandos, the Union Home Ministry said on Monday, prompting the Bollywood actor to thank Home Minister Amit Shah and declare that no one could crush a patriot.

The decision to provide 24X7 security comes two days before Ranaut, who is in her home state Himachal Pradesh and had likened Mumbai to Pakistan occupied Kashmir, plans to visit Mumbai September 9. Ranaut, whose comments led to a spat with Shiv Sena leader Sanjay Raut, had said she felt unsafe in Mumbai after the death of actor Sushant Singh Rajput and also spoke of drug use in a section of the film industry.

Describing the "Queen" star as a daughter of Himachal Pradesh, Chief Minister Jai Ram Thakur issued a video statement on Monday welcoming the decision to provide her with CRPF security.

He said the Central and the state governments are providing security to the actor and would do whatever necessary for her security. "I have got information that an 11-member commando team of the CRPF has been provided by the Ministry of Home Affairs for her security yesterday. I welcome this decision and also express my gratitude to union – home minister... her security is important for us," he said.

New Delhi, Sept 7: With 96.2 per cent literacy, Kerala has once again emerged as the most literate state in the country, while Andhra Pradesh featured at the bottom with a rate of 66.4 per cent, showed a report based on National Statistical Office (NSO) survey.

The report on 'Household Social Consumption: Education in India as part of 75th round of National Sample Survey - from July 2017 to June 2018' provides for state-wise detail of literacy rate among the persons aged seven years and above. According to the study, after

Kerala, Delhi has the best literacy rate at 88.7 per cent, followed by Uttarkhand's 87.6 per cent, Himachal Pradesh's 86.6 per cent and Assam's at 85.9 per cent.

On the other hand, Rajasthan is the second worst performer with literacy rate at 69.7 per cent, followed by Bihar at 70.9 per cent, Telangana at 72.8 per cent, Uttar Pradesh at 73 per cent and Madhya Pradesh at 73.7 per cent.

The study has pegged the overall literacy rate in the country at about 77.7 per cent. In rural areas, the literacy rate is 73.5 per cent compared to 87.7 per cent in urban areas of the women country. At all-India level, the male



literacy rate is higher at 84.7 per cent literacy rate is higher than female compared to 70.3 per cent among literacy rate among all states. In Kerala, the male literacy rate is The survey showed that the male 97.4 per cent compared to 95.2 per cent among females.

Similarly, the male literacy rate in Delhi stood a 93.7 per cent higher than 82.4 per cent among females. Even in the worst performing states. there was a considerable gap in male and female literacy rate.

In Andhra Pradesh, male literacy rate is 73.4 per cent, higher than 59.5 per cent among females (of the age of seven year or above). In Rajasthan, the gap was even wider as male literacy rate stood at 80.8 per cent compared to 57.6 per cent of females.

In Bihar, the male literacy rate was also higher at 79.7 per cent compared to 60.5 per cent of females.

A sample of 64,519 rural households from 8,097 villages and 49,238 urban households from 6,188 blocks was surveyed all-over India.

The report also revealed that nearly 4 per cent of rural households and 23 per cent of urban household possessed computer. Among persons of age 15-29 years, nearly 24 per cent in rural areas and 56 per cent in urban areas were able to operate a computer.

Nearly 35 per cent of persons of age 15-29 years reported use of internet during the 30 days prior to the date of survey. The proportions were nearly 25 per cent in rural areas and 58 per cent in urban areas.

However, the annual prison statistics by NCRB revealed that prison authorities in Odisha have shown little interest towards vocational training in the jails of the state. The 10-vear data revealed declining number of inmates getting vocational training like carpentry, tailoring, weaving, farming and soap or phenyl making.

As per NCRB data, 481 prisoners out of the total 12,429 received vocational training under various categories in 2010. The number witnessed a continuous rise till 2015 barring a small decline in 2014. As many as 937 prisoners comprising 5.86 per

cent of the total 15,965 inmates lodged in 90-odd jails of the state underwent training under various vocations in 2015.

However, the NCRB prison statistics for 2016 revealed a sharp decline as compared to the previous year's data on trainees. Only 92 prisoners were imparted vocational training in various jails of the state in 2016, as per NCRB data. What is more shocking is

that the prisons authorities failed to impart vocational training to any of the jail inmates in the state during 2017. Similarly, as many as 94 and 101 prisoners underwent training in 2018 and 2019 respectively.

The same was also unearthed by the audit report of prisons in Odisha in 2017. The report remarked, "The authorities had not imparted vocational training in any of the jails of Odisha except in Berhampur circle jail. Only 32 out of 162 convicts were trained in masonry and plumbing during 2015-17.³

ECoR strengthens fight against virus

Bhubaneswar, Sept 7: To cope with the pandemic, East Coast Railway (ECoR) here Monday announced elaborate initiatives to avoid a surge of infections.

and maintaining social distancing among others. Sanitisation of Railway establishments, workplaces. stations and circulating areas including trains are also being done on regular basis.

During the Antigen Test at ECoR HQs from 2nd to 4th September, 2020; a total of 25 positive cases have been detected who have been isolated and admitted in Railway Hospital and at other COVID Hospitals. High risk group of Railway employees, i.e. employees above 55 years with diabetes, hypertension, persons with history of contact with Covid suspect or positive cases were encouraged to undergo the tests organized by Railway Central Hospital.

Jajpur, Sept 7: The Brahmani and Baitarani rivers including their distributaries have caused severe surge of floodwaters in Jajpur district, over the past few weeks. Floodwaters have created 25 major road breaches in between August 26 and 29, which need ₹12.39 crore for repairs.

According to reports, 21 major road breaches were created on river dvkes under Jaraka irrigation division and four major road breaches were created under Jajpur irrigation division, respectively. Jajpur irrigation department has prepared an estimate in this regard.

Most of the parts in Jajpur district have been submerged and road connectivity snapped. It is said that, over 10,00,000 denizens in rural areas have been badly affected due to severe flood situation.

It is known that nearly 2,86,327 livestock of about 530 villages of 124 panchayats under 10 blocks have been badly affected due to surging floodwater in Jajpur district, an unconfirmed source revealed.

Worthy to note, the state irrigation department Principal Secretary Anu Garg had directed Collectors of 13 districts for repair as well as renovation of weak and rundown river dykes vide letter (No.-15301/29.08.2020), much before the occurrence of flood.

Janhapank, Sept 7: Around six months ago, they hired private buses to return to their home Odisha while escaping the woes of the COVID-19 lockdown and unemployment prospects. But today the migrant workers of Boudh district are waiting for the buses to take them back to their jobs which they had left as the industries have reopened in those states. Little did they know that they will be greeted with no-vacancy signs here.

The Odisha migrant workers made big splash in the news as they, in thousands, returned to the state on foot. Industries were shutting, they were running out of their savings but their expenses remained as they were and thus began the

journey towards home. But just after six months of their return journey, they are again keen

to go back to their previous job places as there are not so bright employment opportunities in Odisha. They are again struggling for sustenance. The Unlock-4.0 has removed all restrictions including inter-state movement of people. For this, the agents have informally started urging returnee migrant workers in Boudh district to prepare for going back to Surat and other industries in Tamil Nadu

As the textile units in Surat in Gujarat have reopened now, the owners of the factories need manpower. The owners are sending their agents to Odisha to ferry the returnee migrant workers back by luring them with extra wages.

Several returnee migrant workers in Janhapank area of Boudh district were seen waiting for a bus on NH-57 on the wee hours of Monday. When our correspondent asked some of them (who did not wish to be named) on why they are again keen to go back to their former job places, they answered that they

were being encouraged to return to Gujarat (Surat) and Tamil Nadu as early as possible, over phone calls and personal meetings with agents who claimed to be working on behalf of textile mill or other industry owners in Gujarat and Tamil Nadu. We are being urged to reach there and bargain with mill owners for better working conditions and other facilities, they said.

Now, the question remainswhat about the tall promises that the state government had made regarding providing employment to these returnee migrants.

Another thing which adds to the woes of these migrant workers is that they are doing manual labour in and outside the state without any official registration. Following this, there exploitation is happening be in terms of wages or job conditions. Notably, under the Inter-State Migrant workmen Regulation of Employment and Conditions of Service) Act, 1979 the migrant workers have to be provided with the basic benefits by their employer outside the state. According to this law, inter-state migrant workers are to be registered through li-

SOME ATTENTION **DIVERSIONS**

ttention-diversion seems to have become a familiar tactic used by many current politicians for different purposes. Magicians are believed to use such techniques with perfection to mesmerize the spectators. At a different level, criminals use it for theft, pick-pocketing in buses and trains, and chain-snatching in the streets. Today, political establishments are increasingly resorting to such techniques, and with lethal effects. Evidence of such behavior is visible in the Sushant Singh Rajput (SSR) death case, which is used and misused with ulterior motives by many including the media. Politics is clearly at play, and other vested interests too may have stepped into the scene to make a mess out of what could have been a normal police investigation.

Popular Hindi film and TV serial actor SSR's death by hanging from a ceiling fan – in his apartment in Mumbai on June 14 – was a tragic incident. Initial Mumbai police reports claimed it to be a suicide and that set the ball rolling. Sushant was reported to be under treatment for depression. There were also allegations of nepotism in the Mumbai film industry that added to his woes. The following days saw fresh theories being advanced every single day and TV channels like Repulsive TV played out conspiracy theories dime a dozen. Over a month later, Sushant's parents in Patna brought forth allegations against his girlfriend Rhea Chakraborty and five others. They were blamed for his death. SSR's parents filed a complaint with the police in Patna, which suggested that they did not trust the investigations in Mumbai. Keeping Bihar elections in sight, the state police, unknown for efficiency, sprang into action and landed up at Mumbai. The police team that arrived in Mumbai from Patna was quarantined by the Maharashtra government, allegedly to stall their investigations in the metropolis. It turned into a state-versus-state row for the media to play with. By mid-August, in the midst of all these, the Supreme Court allowed the CBI to take over the investigations. Later, the Enforcement Directorate (ED) and the Narcotics Control Bureau (NCB) stepped in

Politics obviously is playing multiple roles in the Sushant saga after his death. The name of Aaditya Thackeray, Cabinet minister and son of chief minister Uddhav Thackeray, came up prominently as one who interacted with SSR shortly before his death. In this context, fresh aspersions were cast on the Maharashtra Police investigations. However, present reports have conveniently forgotten Aaditya, which may be due to lack of evidence to connect him. The BJP's support to the cacophony over the SSR death too signified it sought to fish in troubled waters.

Worse, the current media frenzy running through the third month at a stretch after the death is seen as part of a motivated attempt by the powers-that-be at the Centre to divert public attention from the pressing issues of the day. The nation is facing its worst plight in the aftermath of the Covid-linked lockdowns, which virtually shut down the nation for over five months, and the pandemic scenario is still worsening. Demonetization followed by GST rollout contracted the economy to scary levels. Now, with a hit from Covid, the financial super structure is seen to be collapsing. This is evident from the call by the Centre to states, to borrow money from RBI and make up for the GST collection shortfall and failure of the Centre to keep up with its promise to the states in this respect. Governmental performance in every sector is seriously affected, and things are turning from bad to worse

Now, dominant sections of the media have little time or space to highlight the distress of the nation. They are concentrating mainly on the SSR case. debating for days on end whether it was a simple case of suicide or more, and what role Rhea Chakraborty and others played in the death. This is going on and on; one day, a debate on the role of the Maharashtra Police; another day on the accusations from the actor's parents; then on the Supreme Court nod for CBI probe; so on and so forth. Clearly, these are nothing more than an attention-diversion tactic to bail out the government in present times. That apart, the media seems to have realised that the upper and middle class of urbanised India laps up such titillation eagerly and is happy for the diversions. The more shocking the story angle, the more the views. The general public probably finds this to be a filmy plot. Newer characters are being thrown into the ring for increasing the excitement. One actor in particular, Kangana Ranaut has benefited greatly by spewing venom against her film colleagues in the matter of nepotism and casting aspersions on Rhea Chakraborty. As a reward, she has been given Y Plus Class security by the Centre for which she has profusely thanked Union Home Minister Amit Shah. While a death and charges of nepotism in the film industry were the main subjects of investigations, the involvement of ED and NCB is constantly changing the plot. Rhea's brother Showik Chakraborty and two others have been arrested by the NCB for allegedly sourcing curated marijuana. Rhea is also being ques tioned by the same agency for alleged drug connections. Sadly, the mainline investigation into the real reasons for SSR's death is being sidelined by the agencies with a purpose. The narrative needs to continue long like a Hindi movie. Maybe the plot needs to be thickened so that people's attention remains steadfast. The actor's death, possibly, could have been investigated as a standalone case. The investigative agencies seem to be more interested in fueling media frenzy and not focusing on the original issue.

SUICIDE AND SLANDER

The statement by the father of Rhea Chakraborty reflects the pain and the discomfort many might feel at the manner in which the suicide of Sushant Singh Rajput is being handled by the investigating agencies. Lt. Col (Retd) Chakraborty writes, addressing whole of India, the "Congratulations India, you have arrested my son. I'm sure next on the line is my daughter and I don't know who is next thereafter. You have effectively demolished a middle class family. But of course, for the sake of justice everything is justified. Jai Hind."

While there is no doubt that the CBI must be given a free hand to probe all possible leads, there is equally little doubt that the atmosphere has been so vitiated by a sharp, focused and carefully constructed campaign that has condemned, targeted and vilified Rhea mercilessly for reasons that have nothing to do with the investigation. The attack is ostensibly on Rhea Chakraborty but it is actually turning out to be an attack on institutions, civility and the very idea of living in a decent society. The entire air has been poi-

soned in such a manner that there is almost a pre-judged line that is being followed with political motivations that are not far to seek. Consider the manner in which the Mumbai police have been targeted, leading to some of the most ludicrous statements about the functioning of the police force in this city, so much so that several former police officers have been forced to come out and take a stand.

It is not that the Mumbai police are perfect. It is also not that investigations cannot be botched. But those who understand how investigations run would know that it is almost impossible to hide evidence if this was indeed a murder or a case of abetment to suicide. If there was anything remotely suspicious, Rhea Chakraborty would already have been arrested. Those making wild statements of the kind made in Mumbai or from Bihar would also know that the Mumbai police ar-

rested Sanjay Dutt under a tough law against terrorists called TADA in the 1993 Bombay bomb blasts case at a time Sunil Dutt, his father, was a Congress MP and the Congress government was in power at the Centre.

Tiddlywinks

The BBC regional television weather forecast map for the south-west of England once marked the usual cities such as Bristol and Exeter, but also added Tiddleywink in Wiltshire, an obscure hamlet ignored by gazetteers and all maps except those of largest scale. The BBC was having fun over its inhabitants' success in persuading the local council to put up road signs to mark this cluster of eight cottages, as up to now people driving past would miss it if they blinked. Those in favour of perpetuating the name did so not only out of local (very local) pride, but because of the name's associations with word history. Local historians say that the occupant of one of the cottages used to sell beer to passing cattle drovers. At the time presumably the eighteenth or early nineteenth century - the slang term for an unlicensed beer-house of this sort was tiddlywink (sometimes kiddlywink) and the name came in time to be attached to the hamlet as a whole. John Avto, in the Oxford Dictionary of Rhyming Slang, and Jonathon Green, in the Cassell Dictionary of Slang, both suggest that it was originally rhyming slang (tiddlywink = drink). In the way of such slang, it soon became shortened to tiddly as the name for an alcoholic drink, which by the early 20th Century had become the adjective tiddly for the state of being drunk. It may be that the first element is a variation on an even older term tiddy for something small, which would make a tiddlywink a small drink Jonathon Green points to yet another form, titley, as in the slang phrase titley and binder, for a glass of beer and a lump of bread and cheese, known from the middle of the 19th Century. Some writers suggest (for which read guess) that the second part comes from phrases like to tip the wink, to give somebody a private signal, so suggesting a tiddlywink was a place to which a man slipped off quietly with close friends to have a quick one.

Platforms deserted as metro services resume

New Delhi, Sept 7: Platforms and key hub stations, including Rajiv Chowk, wore a deserted look, eateries remained closed and the ambience far removed from the usual hustle-and-bustle as the Delhi Metro services resumed Monday after a 169day hiatus triggered by the COVID-19 pandemic.

Station employees frequently sanitised areas of the metro station and ensured social distancing norms, even as very few commuters opted for the services on the first day. Rajiv Chowk, which is one of the

busiest stations of the national capital, remained empty. At around 9 am, the usually busy entry point at Rajiv Chowk was deserted with officials, wearing masks and face shields, ready with sanitizers to ensure a safe ride for passengers.

After the entry point, there was a second layer of sanitisation process where thermal screening of passengers as well as their luggage was done.

Imran Khan, who was travelling from Chattarpur to Barakhamba, was on his way to attend a job interview.

"The ride was smooth and there were hardly less than five commuters in my compartment. So, we had ample space to maintain social distancing even within the coaches. I'm glad that metro services have finally begun or I wouldn't have been able to make it for my interview on time." he said.

Another commuter, Vishal Naik, has taken all the precautions. 21, a resident of Shastri Park, was

I had to start at least an hour early from home and wait for unusually longer hours at the bus stands and if the passenger count exceeded beyond 20, I had to again wait to catch the next bus, which is equally risky

during pandemic," he said. Deepika Nautiyal, a resident of

Laxmi Nagar, said she is scared but "I took an auto rickshaw from

my home in Laxmi Nagar and reached Rajiv Chowk metro station. I am a bit scared but have taken all the precautions," Nautival, who works at company in Gurgaon, said. Another commuter Mona Jha, who lives in Bhajanpura in northeast Delhi and works at Barakhamba Road, said she noticed that people are maintaining the norm of social distancing inside the metro train. "I boarded the metro at

Kashmiri Gate and have seen that

people are aware. I am not scared. People are more concerned but we must follow social distancing norms. The situation will take time to be come normal," Jha said.

At Kashmere Gate metro station, only two gates were opened.

When people were entering the premises, they were seen getting their bags sanitized by the metro employees. Before contactless frisking, CISF personnel were also seen helping the commuters maintain social distance.

The Delhi Metro Rail Corporation (DMRC) was making several announcements about dos and dont's during COVID-19.

"If you have cold cough or fever, then please don't take metro. Duration of opening and closing of metro doors have been increased for the convenience of commuters,' the announcer said.

Trains were stopping at station with an extra time so that the passengers can easily board or de-board the metro without get in contact with anyone.

The DMRC said all possible measures will be taken to ensure that services are smooth.

Parents averse to taking kids for vaccination

Paediatricians call it a disturbing trend as skipping timely administration of vaccines can have long-term impact on children's health

New Delhi, Sept 7: Parents are delaying vaccination for kids by avoiding hospital visits to prevent their exposure to coronavirus, even as paediatricians call it a disturbing trend as skipping timely administration of vaccines can have longterm impact on children's health. Experts said parents should take their children for timely vaccina-

tion, especially in the first year of a child's life.



He said he has had patients coming to him in September for vaccination of their kids which were due in March since they were scared

of stepping out. Assuring parents, Nagpal said many doctors have separated their immunisation clinics from the regular clinics to ensure that children are not exposed to other patients.

Underlining the importance of vaccines, Kwatra said primary vaccines are administered in the first year of a child's life and these are most important and should not be delayed.

These include pneumococcal, polio and DPT vaccine, he said, adding that measles vaccine is crucial in the first year.

"If a child catches measles, it reduces the immunity greatly," he noted

"I had a patient yesterday who came to me after three months for vaccinating their child for polio. There are certain vaccines that you cannot catch up. For instance, the rotavirus vaccine is limited to a specific time. The last dose can be given by seven months. The vaccines act best when they are administered on time," Rahul Nagpal, Director, Paediatrics, Fortis Hospital Vasant Kunj said.

In the second year of life, a child is given booster vaccines which are also important but a bit of delay is not harmful, Kwatra said.

Sandhya, a resident of north Delhi's Burari, said, "I have been delaying the vaccination of my 18month-old daughter because of_ COVID-19 scare. The vaccination was due in August, but I have been scared to take my child out due to the pandemic. Elders are fine with wearing face masks, but kids do not like them. We cannot force

New Delhi, Sept 7: A faux pas in a job advertisement for the position of a dog handler posted by the Indian Institute of Technology-Delhi created quite a buzz on social media, prompting the institute to issue a clarification and cancel the recruitment.

August 26, IIT-Delhi had sought applications for the post of a dog handler, and the notice stated that the eligibility criteria was "B.A/B.Sc/B.Com/B.Tech or any equivalent undergraduate degree" This led to a social media storm. In a statement issued September 6. the institute said. "In reference to a job advertisement dated 26-08-2020 for a post titled 'Dog Handler'

(on purely contract basis), IIT Delhi would like to clarify that the minimum qualification as mentioned in the advertisement got inadvertently copied from another job advertisement." The qualification intended in the advertisement was 'Bachelor of Veterinary Science', it said, adding that the recruitment process was cancelled after the mistake was brought to the notice of the higher authorities. "A fresh process in due course will be initiated to hire a Consultant (on purely contract basis) with suitable minimum qualification required for the job profile that involves proper care of a large number of stray dogs on the campus etc.," the stateINDO-ASIAN NEWS SERVICE

He likened the education policy to defence and foreign policies, saying they belong to the country not government. The education policy is linked to the nation's aspirations, he added.

We will have to show in a similar way maximum flexibility in implementing it," he told the conference, which was also attended by President Ram Nath Kovind, education ministers from states and union territories and vice chancellors besides governors. The prime minister urged them

to hold virtual conferences before September 25 in universities on the NEP, 2020 which, he said, has been widely welcomed, from a village teacher to noted educationists, as it was based on feedback received from across the country. Highlighting the main features

SC SEEKS REPLY ON PLEA FOR ELDERLY CARE

New Delhi, Sept 7: The Supreme Court Monday asked states to file a detailed affidavit within four weeks on a plea seeking directions to provide masks and sanitisers for senior citizens, who are living alone, amid the ongoing Covid-19 pandemic.

A bench comprising Justices Ashok Bhushan, R. Subhash Reddy and M. R. Shah was informed by former Union Minister and senior advocate Ashwini Kumar that the affidavits filed by states based on August 4 direction of the court lack



detail on actions taken to address the issue. Kumar submitted before the bench that except Orissa and Punjab, the affidavits on record lack details. On August 4, the top court had di-

amid the ongoing pandemic rected that all pensioners should be regularly paid pension, and states should provide them necessary medicines, masks, sanitisers and other essentials amid the ongoing pandemic.

Kumar had argued that the elderly amid the pandemic need more care and protection. Today, Kumar insisted that priority should be granted to senior citizens who are undergoing treatment at various hospitals. He cited the affidavit filed by Manipur and contended that state governments should file better affidavits with more details on the actions taken so far.

The Supreme Court had directed the Centre and the state governments to ensure timely pension to the elderly, besides ensuring availability of sanitisers, masks and PPE kits to them, wherever re-

quired, during the coronavirus pandemic. "We, in this application, which is specially confined to Covid-19 crisis, direct that all old age people who are eligible for pension should be regularly paid pension and those identified as older people should be provided necessary medicines, masks, sanitizers and other essential goods by respective states", said the bench. The top court asked the Centre

to ensure that all Covid-19 safety precautions are followed and caregivers in old-age homes were wellequipped with masks, PPE kits, and sanitisers

Antibodies won't guarantee protection from Covid: Scientists

New Delhi, Sept 7: The presence of antibodies indicates previous exposure to the SARS-CoV-2 virus but may not always translate into protection against the disease, say scientists, citing imponderables such as what kind of antibodies. how many and how long they last.

As worries over India's COVID-19 spike mount - the country added 90,062 cases Monday to take its tally past the 42-lakh mark - scientists are grappling with the pivotal issue of antibodies and trying to understand how they impact on the progression of the disease.

But the jury is still out there with several studies and hypotheses but no consensus yet. The only thing that can be said with any degree of un-

certainty is that antibodies is a sign that the person has already been infected with the novel coronavirus, the scientists said

Immunologist Satyajit Rath said he would prefer to "wait and see" where the evidence goes. Antibody presence in itself tells us nothing about disease progression in individuals, said the scientist from New Delhi's National Institute of Immunology (NII).

There are neutralising antibodies (nAbs) and also 'simple' antibodies. While nAbs produced against the novel coronavirus can block its entry into the host cell, other antibodies are also generated against many parts of the virus, added Vineeta Bal from Pune's Indian Institute of Science, Education and

Research (IISER).



The 'simple' antibodies are an indication of host response to viral presence but are not that useful to stop further spread of the virus,

Bal said. "Simple presence of antibodies is a clear indication of previous exposure to SARS-CoV2 but does not necessarily guarantee pro-

tection from the disease in the absence of neutralising antibodies.' the immunologist added.

'Presence of nAbs in sufficient concentrations and for longer period is the most likely indicator of protection of the individual from next exposure leading to illness i.e. COVID-19," she explained.

Bal also noted that there is no consensus on what levels of nAbs are 'protective' from the public health perspective or to ensure that plasma therapy is likely to be useful. Different sero-survey tests have been conducted in India in the last few months with the aim of indicating the actual number of infected cases in the country.

A sero-survey involves testing the blood serum of a group of individuals for the presence of antibodies against that infection to know who has been infected in the past and has now recovered.

Surveys carried across metros suggest that COVID-19 cases are far more than actually reported. According to Rath, one of the many problems in looking for easy patterns in the serological evidence is that not everyone is using the same antibody tests.

"In fact, all antibody tests in the market are not against the same viral protein target, and some investigators use only one target, others use more. And it is possible that tests differ in their sensitivity," Rath said. The scientist also noted that most surveys are reporting people as just 'positive' or 'negative', and not analysing antibody levels present in the blood.

Monsoon 2020 could end in normal to above normal category, says IMD

New Delhi, Sept 7: This year's monsoon could end in the range of normal to above normal, the India Meteorological Department said on Monday with the government saying that this is expected to benefit agriculture and the overall economy.

Of the four-month rainfall season, June and August have recorded 17 and 24 per cent more rainfall that normal respectively while July saw 10 per cent deficient precipitation. "Rainfall is likely to end in the normal or above normal category," IMD director general Mrutunjay Mohapatra said at a press briefing. He said the overall rainfall is likely to be 102 per cent



of the Long Period Average (LPA) with an error margin of plus or minus 4 per cent. The LPA rainfall over the country for the 1961-2010 period is 88 centimetres.

Monsoon in the range of 96-104 per cent of the LPA is considered normal. The official rainfall season in the country is from June 1 to September 30. "Overall, monsoon

will be good this year. It will help agriculture and the economy," M Rajeevan, Secretary, Ministry of Earth Sciences, said. "The plentiful and spread of southwest monsoon this year should help farmers and the output must be very good. It will also help Indian economy, though exact quantification cannot be made at this moment. We don't have an assessment as to how it will impact the economy," he said in a statement.

The country as a whole has so far received 7 percent excess rainfall, Rajeevan said. Predicting rainfall for September, he said there was an increase in rainfall over the foothills and adjoining northern plains and south peninsula in the first week of the month

Rhea files complaint against Sushant's sister

Mumbai, Sept 7: Actress Rhea Chakraborty, who is accused of abetting the suicide of actor Sushant Singh Rajput, has filed a complaint with Mumbai Police, accusing Rajput's sister Priyanka Singh and a Delhi-based doctor of forgery and preparing a "fake" prescrip tion of medicines for anxiety.

In her complaint sent to the Bandra police here Sunday, Chakraborty sought that Priyanka Singh and Dr Tarun Kumar, working with Ram Manohar Lohia Hospital in Delhi, be booked under relevant sections of the Indian Penal Code for forgery, the Narcotics Drugs and Psychotropic Substances (NDPS) Act and the Telemedicine Practice Guidelines.

The 28-year-old actress in her complaint said Rajput was diagnosed with bipolar disorder and was undergoing treatment for various other mental health issues. However, Rajput was not disci-

plined in following the treatment and would often abruptly stop his medications, she further said in the complaint.

"On June 8, 2020, Rajput showed me the messages he and his sister Privanka had exchanged in which Priyanka sent him a list of med icines to take. I explained to Rajput that he has already been prescribed medicines by doctors who are treating him," Chakraborty said in her complaint. On the same day, Rajput asked Chakraborty to leave the house as his sister Meetu Singh was coming to stay with him for a few days, according to the complaint. "It has now come to light that Rajput June 8 told his sister Priyanka that he would not be



able to obtain the said medicines without a prescription. His sister Privanka subsequently on the same day sent him a prescription signed by one Dr Tarun Kumar, working with the Dr Ram Manohar Lohia Hospital in Delhi," the complaint said. "Prima facie, the prescription appeared to be fabricated. The medicines prescribed by the doctor are prohibited from being prescribed electronically without consultation with the patient," Chakraborty said in the complaint.

On July 25, Rajputs father K K Singh lodged a complaint with Patna police against Rhea Chakraborty, her parents Indrajit and Sandhya Chakraborty, her brother Showik Chakraborty, the late actor's former manager Shruti Modi and his house manager Samuel Miranda.

He accused them of cheating and abetting his sons suicide.Based on this allegation, the Enforcement Directorate is probing money ২ laundering charges

The FIR lodged by Patna police was later transferred to the Central Bureau of Investigation (CBI). Meanwhile, Rhea was questioned by the NCB for around 8 hourson Monday, the second consecutive day of her interrogation.

Good news for disabled govt employees seeking VRS

The Personnel Ministry in an order issued Monday has said that disabled government employees seeking volutary retirement due to the hardships faced by them can continue in service with the same pay scale and benefits

New Delhi, Sept 7: Disabled government employees seeking voluntary retirement due to the hardships faced by them can continue in service with the same pay scale and benefits, the Personnel Ministry said in an order issued Monday, highlighting the different protections available to them.

Citing provisions under Section 20 of the Rights of Persons with Disabilities (RPWD) Act, 2016, it said every government establishment shall provide reasonable accommodation and appropriate barrierfree and conducive environment to employees with disability.

"No Government establishment

shall dispense with or reduce in rank, an employee who acquires a disability during his or her service," reads the Section 20(4) of the RPWD Act, cited by the ministry in its order. Referring to the RPWD Act and a Supreme Court's judgement, the order said "it is stated that whenever a government servant seeks voluntary retirement citing medical grounds, or when the said VRS notice has been submitted due to a disability, the administrative authorities shall examine as to whether the case is covered under Section 20(4) of RPWD Act, 2016". In case the provisions are applicable, the government ser-

vant shall be advised that he/she has the option of continuing in

service with the same pay scale and service benefits, said the order issued to secretaries of all central government departments.

"In case a disabled government servant reconsiders his decision and withdraws the notice for voluntary retirement, his case shall be dealt with the aforesaid provisions of Section 20 of RPWD Act, 2016. If however, in spite of being so advised, such government servant still wishes to take voluntary retirement, the request may be processed as per the applicable rules," it said.

The ministry has replaced in-structions issued in May 2015 with this latest order. According to the 2015 order, instances had come to the notice of the authorities where government servants apply for voluntary retirement "on account of hardships faced by them due to a disability, as they are unaware of the protection provided by the Section 47 of the Persons with Disabilities (Equal Opportunities, Protection of **Rights and Full Participation**) Act or the PWD Act of 1995.

Hence, Section 47 of PWD Act, 1995 as stated in the 2015 order is replaced by the provisions of Section 20 of the RPWD Act, 2016, it added. The Section 47 of the PWD Act had provisions on nondiscrimination against disabled government employees and for their protection.

Beijing, Sept 7: China is delaying the renewal of press cards for at least five journalists working at four US media outlets, an organisation of foreign correspondents said Monday, making them vulnerable to expulsion in apparent retribution for Washington's targeting of Chinese reporters working in the United States.

Atlanta-based CNN said its China correspondent was among those given a letter authorising him to continue reporting for the next two months instead of the usual oneyear press card.

He was told the move was unrelated to his reporting but was merely a reciprocal measure in response to the actions of the Trump administration toward Chinese media, making it the latest manifestation of the deteriorating state of US-China relations that have fallen to their lowest level in decades.

The Foreign Correspondents' Club of China, or FCCC, said The Wall Street Journal and Bloomberg have also been targeted. It did not name the fourth outlet, but said more foreign journalists are expected to receive similar treatment. While the targeted outlets are all American, the journalists involved

are of various nationalities. China's move comes after the US capped the number of Chinese citizens who could be employed by Chinese media outlets and placed them on 90-day visas.

China first responded in March by expelling reporters from The New York Times, The Wall Street Journal and The Washington Post. Those affected have been both US and non-US citizens. Official press cards are used to

obtain residency permits usually good for one year, while the letters issued by the Chinese foreign ministry "could be revoked at any time,

The US moves were fed by complaints that Chinese journalists working for state media acted more as propagandists and agents for the Communist Party than as genuine reporters.

The US had already required those outlets to register as foreign entities with the US, similar to consulates and embassies.

They also come against the backdrop of worsening US-China relations on a range of issues, including human rights, trade, technology, Taiwan, Hong Kong, the South China Sea and Chinese treatment of its Muslim minority in the north western region of Xinjiang.

Relations hit a new low in July when the US ordered China to close its consulate in Houston and China demanded the shuttering of the US mission in Chengdu.

With talks deadlocked, Johnson said an agreement would only be possible if EU negotiators are prepared to "rethink their current positions". The EU, in turn, accuses Britain of failing to negotiate seriously.

Britain left the now 27-nation EU January 31, three-and-a-half years after the country narrowly voted to end more than four decades

of membership. That political departure will be followed by an economic break when an 11-month transition period ends December 31 and the UK leaves the EU's single market and customs union.

Without a deal, the New Year will bring tariffs and other economic barriers between the UK and the bloc, its biggest trading partner. Johnson said the country would "prosper mightily" even if Britain had "a trading arrangement with the EU like Australia's" - the UK government's preferred description of a no-deal Brexit.

British chief negotiator David Frost and his counterpart Michel Barnier are due to meet in London starting Tuesday for the eighth round of negotiations. The key sticking points are European boats



access to UK fishing waters and state aid to industries. The EU is determined to ensure a "level playing field" for competition so British firms can't undercut the bloc's environmental or workplace standards or pump public money into UK industries.

Britain accuses the bloc of making demands that it has not imposed on other countries it has free trade deals with, such as Canada.

Beijing, Sept 7: China has put its homegrown coronavirus vaccines on display for the first time, as the country where the contagion was discovered looks to shape the narrative surrounding the pandemic.

High hopes hang on the small vials of liquid on show at a Beijing trade fair this week - vaccine candidates produced by Chinese companies Sinovac Biotech and Sinopharm. Neither has hit the market yet but the makers hope they will be approved after all-important phase 3 trials as early as year-end.

A Sinovac representative told AFP his firm has already "completed the construction of a vaccine factory" able to produce 300 million doses a year. On Monday, people at the trade fair crowded around booths showing the potential gamechanging vaccines. China is facing a storm of foreign criticism over its early handling of the pandemic.

Seoul, Sept 7: A powerful typhoon damaged buildings, flooded roads and knocked out power to thousands of homes in South Korea Monday after battering islands in southern Japan and injuring dozens of people.

The Korea Meteorological Administration said Typhoon Haishen was passing waters off the eastern coastal city of Sokcho on Monday afternoon after barrelling through South Korea's southern and eastern regions

The typhoon was weakening, with its maximum winds measured at 108 kilometres per hour after blowing at 144 kilometres in the morning, and it was forecast to be downgraded to a tropical storm

Japan's Fire and Disaster Management Agency said at least



38 people were injured, five of them seriously, after Haishen lashed southwestern Japan over the weekend with strong winds and rain. Schools and department stores were closed in Hiroshima and other cities in the country's southwest. In South Korea, cars struggled to

navigate flooded roads in Ulsan and other coastal cities such as Busan, Sokcho and Gangneung. Emergency workers scrambled to clean up toppled trees and damaged traffic signs, buildings, and other structures.

The Ministry of the Interior and Safety said a person in Busan was

injured after a car flipped in strong winds, but it didn't immediately provide further reports of casual ties. Hundreds of flights in and out of the southern island province of Jeju and across the mainland were cancelled.

Some bridges and railroad sections were shut down, thousands of fishing boats and other vessels were moved to safety, and more than 1,600 residents in the southern mainland regions were evacuated due to the possibility of landslides and other concerns.

Workers as of Monday morning had restored power to 11,523 of the 17,620 households that had lost electricity in the southern mainland areas and Jeju.

Hitting out at India, Bajwa said that in 1965, Pakistan had defeated India, an enemv he said many times greater in might than it. He also

reminded Pakistan's response to the 2019 Balakot airstrikes by India, insisting that there should be no doubt on the country's readiness to respond.

However, the government support so far has been "meagre", he said, primarily in terms of free food grains to poor households and credit guarantees to banks for lending to small and medium (SMEs) firms, where the takedown has been patchy.

"The government's reluctance to do more today seems partly because it wants to conserve resources



for a possible future stimulus. This strategy is self-defeating," the former RBI Governor said.

According to him, at a time when the government should expand resources to spend more and take more action, the Indian government "seems to have retreated into a shell", after an initial burst.

He said that the government and public sector firms should clear their payables quickly so that liquidity moves to corporations.

In addition, small firms below a certain size could be rebated on corporate income and GST tax they paid last year, or some portion thereof, with the rebate tapering off with firm size.

This would be an objective way of helping small, viable firms based on a hard-to-manipulate metric, even while rewarding them for their honesty, Rajan said, adding that finally, the government will likely have to set aside resources to recapitalise public sector banks as the extent of losses are recognised.

Diesel price extends its gap with petrol, falls again

New Delhi, Sept 7: Diesel price has extended its gap with petrol across the country with oil marketing companies (OMCs) cutting its retail price again while keeping petrol price steady. The OMCs Monday reduced the pump price of diesel, the third such downward revision in last five days.

In Bhubaneswar, the price of diesel has fallen by 12 paisa per litre, Mondav and now stands at ₹79.66 Meanwhile, petrol prices remained unchanged at ₹82.70.

In the National Capital Territory (NCT) of Delhi, it fell by 11 paisa per litre, bringing down the transport fuel price to ₹73.16 per litre. The price of diesel has also fallen Thursday by 16 paisa per litre and then again Saturday by 13 paisa.

While diesel prices have fallen, the OMCs have kept petrol prices steady. However, the fuel prices have remained at the same level so far this month. But petrol price has been rising regularly since August 16, when it stood at ₹80.57 per litre in Delhi. Petrol is now retailing at ₹82.08 per litre in the capital. OSAKA STORMS INTO LAST EIGHT

New York, Sept 7: Naomi Osaka returned to the US Open quarterfinals by taking advantage of some early jitters for Anett Kontaveit and showing no ill effects from a recent left hamstring problem.

The fourth-seeded Osaka never faced a break point and beat the 14th-seeded Kontaveit 6-3, 6-4 in Arthur Ashe Stadium.

Osaka owns two Grand Slam titles, including Flushing Meadows in 2018. She lost in the fourth round a year ago.

Kontaveit won the match's first point, but followed that with a pair of double-faults, followed by a pair of backhand errors to get broken. And Osaka was on her way, winning 35 of 45 service points

The 22-year-old from Japan improved to 5-0 head-to-head against Kontaveit and now faces unseeded Shelby Rogers of the United States in the quarterfinals. Rogers has won all three matches she's played against Osaka.

Rogers sweat it out hard to overcome Petra Kvitova challenge in her round of 16 match. She battled past the sixth seed Czech player 7-6(7-5), 3-6, 7-6(8-6)

In the men's draw, 12th seed Denis Shapovalov came back from a set down to beat seventh seed David Goffin 6-7 (0-7), 6-3, 6-4, 6-3. Shapovalov will face Pablo Carreno Busta in the next round.

New York, Sept 7: Novak Djokovic was kicked out of the US Open for accidentally hitting a line judge in the throat with a tennis ball after dropping a game in his fourth-round match Sunday, a stunning end to his 29-match winning streak and bid for an 18th Grand Slam title.

As he walked to the Arthur Ashe Stadium sideline for a changeover, trailing Pablo Carreno Busta 6-5 in the first set, Djokovic - who was seeded and ranked No.1 and an overwhelming favourite for the championship - angrily smacked a ball behind him. The ball flew right at the line judge, who dropped to her knees at the back of the court and reached for her neck.

During a discussion of about 10 minutes near the net involving chair umpire Aurelie Tourte, tournament referee Soeren Friemel and Grand Slam supervisor Andreas Egli, Djokovic appeared to be pleading his case. But eventually, he walked over to shake hands with Carreno Busta.

"His point was that he didn't hit the line umpire intentionally. He said, 'Yes, I was angry. I hit the ball. I hit the line umpire. The facts are very clear. But it wasn't my intent. I didn't do it on purpose'. So he said he shouldn't be defaulted for it," said Friemel, who made the decision to end the match.

"And we all agree that he didn't do it on purpose, but the facts are still that he hit the line umpire and the line umpire was clearly hurt.'

Tourte then announced that Djokovic was defaulted, the tennis equivalent of an ejection. "I was a little bit in shock, no?" Carreno Busta said later at a news conference done via video conference.

Djokovic left the tournament grounds without speaking to the media. He, however, posted an apology on social media hours later. "This whole situation has left me really sad and empty. I checked on the lines person and the tournament told me that thank God she is feeling ok. I'm extremely sorry to have caused her such stress. So unintended. So wrong,' Djokovic wrote.

"As for the disqualification, I need to go back within and work on my disappointment and turn this all into a lesson for my growth and evolution as a player and human being," he wrote. "I apologise to the @usopen tournament and everyone associated for my behavior."

Asked whether Djokovic should have been allowed to continue to play, Carreno Busta shrugged and replied: "Well, the rules are the rules The referee and the supervisor (did) the right thing, but it's not easy to do it."

Indeed, the US Tennis Association issued a statement saying that Friemel defaulted Diokovic 'in accordance with the Grand Slam rulebook, following his actions of intentionally hitting a ball dangerously or recklessly within the court or hitting a ball with negligent disregard of the consequences'

The USTA went on to say Djokovic forfeits the ranking points and USD 250,000 in prize money he earned in the tournament - 'in addition to any or all fines levied with respect to the offending incident'.

Djokovic began the day 26-0 this season and with an unbeaten run that extended to his last three matches of 2019. He had won five of the past seven Grand Slam tournaments to raise his total to 17. closing in on rivals Roger Federer, who has a men's-record 20, and Rafa Nadal, who has 19.

With reigning US Open champion Nadal, who cited concerns about travelling amid the pandemic, and Federer, sidelined after two knee operations, not in the field, the 33-year-old Djokovic was expected to claim a fourth trophy in New York and gain on them.

But it all came apart so suddenly Sunday, even if it was clear that Djokovic did not intend to hit the line judge. He wasn't looking in her direction when his racket made contact with the ball, and there was concern written on his face as soon as he realized what happened.

"I think the supervisors and all them are just doing their job, but very unlucky for Novak," said Alexander Zverev, the No.5-seeded man, who reached the quarterfinals by winning Sunday. "If it would have landed anywhere else —

we're talking a few inches — he would have been fine.

Among the many oddities about the 2020 US Open, the first Grand Slam tournament since the outset of the pandemic, is that there are no spectators.

Another is that only the two largest arenas - Ashe and Louis Armstrong Stadium - have full complements of line judges making calls at matches. At other courts, chair umpires are aided by an electronic line-calling system.

Djokovic's mood had soured over the preceding few minutes Sunday. In the prior game, he wasted three consecutive break points and after the last, which Carreno Busta won with a drop shot, Djokovic whacked a ball off a courtside advertising sign.

Then, on the second point of what would become the last game at

this year's US Open for Djokovic, he stumbled while chasing a shot and fell to the ground, clutching his left shoulder.

Play was delayed for a few minutes while a trainer checked on him. On the second point after they resumed, Carreno Busta hit a passing winner to break Djokovic's serve. That's when Djokovic got himself into trouble.

"Going to be a new Grand Slam champion, (that's) all I know. No Grand Slam champions left in the draw. Now it gets interesting," said Zverev, who beat Alejandro Davidovich Fokina 6-2, 6-2, 6-1. "Now I think is the time when it gets really interesting.'

Madrid, Sept 7: Teenager Ansu Fati became the youngest player to score for Spain in a 4-0 win against Ukraine in the Nations League.

Fati Sunday scored Spain's third goal from outside the area in the 32nd minute to become the country's youngest scorer at the age of 17 years, 311 days. The previous record was held by Juan Errazquin, who scored for Spain in 1925 at 18 years, 344 days.

Fati started his strong performance by dribbling past Oleksandr Tymchyk before he was tripped by Serhiy Kryvtsov in the area. That set up Sergio Ramos to go to the penalty spot in the third minute and score his first of two goals. Spain coach Luis Enrique said he

had rarely seen the level of confidence that Barcelona forward Fati has displayed with the national team since his debut Thursday against Germany.

Ramos got his second with a header in the 29th, netting his 23rd international goal to move level with Alfredo Di Stefano as Spain's eighth all-time leading scorer.

New Manchester City signing Ferran Torres capped the win with a goal in the 84th after coming on as a substitute.

Spain lead their Nations League group with four points after Germany drew 1-1 with Switzerland. Ukraine has three points, Germany two and Switzerland one in Group 4 of League A.

Luis Enrique continued to rejuvenate his side, giving debuts to Manchester City defender Eric Garcia and Real Madrid defender Sergio Reguilon.

The match was played at Real Madrid's Alfredo Di Stefano training ground without fans due to off the post.

Despite the presence of champion players like Kohli and AB de Villiers, RCB, in the last three seasons, has failed to even qualify for the playoffs. The team last played the final in 2016, a season in which Kohli struck an unprecedented four hundreds.

'The 2016 IPL, we all loved to be a part of (it). Since then, this is the most balanced I have felt about (the) squad," the Indian skipper said on RCB's Youtube show 'Bold Diaries', sharing his thoughts on the upcoming edition starting September 19 in the UAE.

Kohli said that both he and AB de Villiers feel that this could be the 'breakthrough season' when tables will turn for the franchise which has flattered to deceive on many occasions.

"I (have) never felt so calm going



into a season before. He (ABD) is coming from a very different space and he is enjoying his life and is very relaxed and fit as ever. I feel I am in a much better space, much more balanced, when it comes to environment of (the) IPL," the straight speaking RCB skipper said. This is the first time he feels that

he isn't carrying any baggage. "Disconnecting with things that have happened in the past and not taking that baggage, as we have done that way too many times," he responded to a query on what has changed for him this season.

"Just because we have a bunch of players that are so skilled, people like seeing them play is the reason people have had so much expectation as well."

IPL will be played across three venues this season - Dubai, Sharjah and Abu Dhabi. The tournament has been moved out of India due to the COVID-19 pandemic.

Kohli believes three venues close to each other is the sort of arrangement that makes life easy for players, who are mostly left 'packing a small little bag for a two-match or threematch trip and then come back'.
