

State stops top up sops under PMKSY

Bhubaneswar, Sept 14: Even as farmers are going through a hard time due to Covid-19, the state government has decided to stop providing additional 35 per cent subsidy for execution of micro irrigation projects under the Pradhan Mantri Krishi Sinchayee Yojana (PMKSY). The directorate of horticulture has stopped providing additional subsidy to farmers which it did over and above the assistance provided by the Centre from the current financial year due to the Covid-19. Horticulture director has written a letter in this regard to all field level officials. However, the State Level Sanctioning Committee (SLSC) under the chairmanship of Chief Secretary will take a final call on this move.

"This is to apprise that the provision of top-up subsidy over and above the subsidy provided under the Central Sponsored Scheme PMKSY (per drop more crop) for installation of drip/sprinkler irrigation system has been decided by the government not to be entertained from the state 2020-21," the director said in his letter. Nonetheless, the provision of subsidy as entertained under the scheme will continue as such as per the provisions of the scheme, he said. The district level officials have also been asked to prepare their plan for the current financial year accordingly. The Pradhan Mantri Krishi Sinchayee



ANTI-FARMER MOVE

- Govt to end extra 35 pc sops for execution of micro irrigation projects
- Director, horticulture writes to field level officials to stop programme
- Chief Secretary, chairman of SLSC, will take a final call on this move

Yojana (PMKSY) was launched in 2015 with an aim to provide assistance to farmers to set up micro irrigation system drip/sprinkler in their crop fields. As per the guidelines of the scheme, small and marginal farmers got 55 per cent subsidy for implementation of the micro irrigation project while the subsidy amount for other farmers was 45 per cent. The subsidy cost will be met by both the Centre and the state government in a ratio of 60:40 for all states except for the North Eastern and Himalayan states. In Odisha, the government was pro-

States' GST dues ₹1.51 lakh crore; Maha leads pack

New Delhi, Sept 14: The GST collection during April-August declined on account of COVID-19 induced lockdown, and the compensation due to states stands at over ₹1.51 lakh crore, Minister of State for Finance Anurag Singh Thakur said Monday.

The provisional GST compensation due to states stands at ₹22,485 crore, followed by Karnataka (₹13,763 crore), Uttar Pradesh (₹11,742 crore), Gujarat (₹11,563 crore) and Tamil Nadu (₹11,269 crore).

The compensation due to West Bengal stands at ₹7,750 crore, Kerala (₹7,077 crore), Punjab (₹6,959 crore), Delhi (₹6,931 crore), Rajasthan (₹6,312 crore), Telangana (₹5,424 crore) and Chhattisgarh (₹2,827 crore).

The total provisional GST compensation due to 31 states and UTs for 2020-21 put together stands at ₹1,51,365 crore, as per data shared in a written reply to a question in the Lok Sabha.

Thakur said the issue of pending compensation and future course of action to meet the shortfall was discussed in the 41st GST Council meeting August 27 wherein states were given two options to meet their GST compensation shortfall for current fiscal year from market borrowing. It was also decided that states will give their preference views thereon.

Harivansh RS dy chief; BJD supports NDA again

Earlier in the day, the BJD had announced that it would support the NDA candidate. According to party MPs, the decision was taken following a telephonic talk between Nitish Kumar and Chief Minister Naveen Patnaik.

Record 4,198 fresh Covid cases in state

Bhubaneswar: Odisha registered its highest single-day spike in COVID-19 cases Monday as 4,198 more people, a health official said. The fresh infections have pushed the state's tally to 1,55,005. Eleven more patients succumbed to the infection, taking the state's coronavirus death toll to 637, the official said. Odisha had reported its previous highest single-day spike of 3,996 cases September 11, he said. 2,476 cases were reported from quarantine centres, while 1,722 people tested positive during contact tracing. Kangana leaves Mumbai, calls PoK analogy 'bang on'

Mumbai, Sept 14: Actor Kangana Ranaut Monday said she is leaving Mumbai with a heavy heart but the way she was "terrorized", faced abuses and saw attempts to break her house, her analogy comparing the city with PoK was "bang on".

The actor, whose comment likening Mumbai to Pakistan occupied Kashmir triggered a spat with Maharashtra's ruling Shiv Sena, arrived in the city from her home state Himachal Pradesh last week. On the same day her office here faced action for "illegal" alterations by Shiv Sena-led Brihanmumbai Municipal Corporation following which she moved the Bombay High Court which stayed the demolition.

"With a heavy heart leaving Mumbai, the way I was terrorised all these days constant attacks and abuses hurled at me attempts to break my house after my work place, alert security with lethal weapons around me, must say my analogy about PoK was bang on(sic)," Ranaut wrote on Twitter.

Targetting the ruling party, she said the protectors had declared themselves to be "destroyers".

GOVT INTRODUCES 8 BILLS

New Delhi, Sept 14: The central government Monday introduced back-to-back eight Bills in the Lok Sabha on the first day of the Monsoon Session during four hour 15 minute proceedings.

The Salary, Allowances and Pension of Members of Parliament (Amendment) Bill, 2020; the Essential Commodities (Amendment) Bill, 2020; the Assisted Reproductive Technology (Regulation) Bill, 2020; the Bilateral Netting of Qualified Financial Contracts Bill, 2020; the Farmers' Produce Trade and Commerce (Promotion and Facilitation) Bill, 2020; the Farmers (Empowerment and Protection) Agreement of Price Assurance and Farm Services Bill, 2020; the Factoring Regulation (Amendment) Bill, 2020; and the Banking Regulation (Amendment) Bill, 2020 were introduced after the house met for the second time after a one-hour adjournment at 9 am.

Parliamentary Affairs Minister Pralhad Joshi began with the introduction of the Salary Allowances and Pension of Members of Parliament (Amendment) Bill, 2020 which was listed for

the Lok Sabha's legislative business for the day.

The Bill seeks immediate legislation by promulgation of the salary, allowances and pension of Members of Parliament (Amendment) Ordinance, 2020. It was among the more than 20 new Bills, including 11 that will replace ordinances, which the government targets to pass during this 18-day session of the Parliament which will conclude on October 1.

Minister of State for Consumer Affairs, Food and Public Distribution Raosaheb Dadarao Danve introduced the Essential Commodities (Amendment) Bill, 2020 which was promulgated on June 5, 2020. It amends the Essential Commodities Act, 1955. The Act empowers the central government to control the production, supply, distribution, trade, and commerce in certain commodities. Cabinet Minister Harsh Vardhan introduced the Assisted Reproductive Technology (Regulation) Bill, 2020 for the regulation and supervision of the assisted re-

productive technology clinics and the assisted reproductive technology banks. The Bill aims prevention of misuse, safe and ethical practice of assisted reproductive technology services and for matters connected therewith.

30 MPs Covid +ve

NEW DELHI: Around 30 MPs, including BJP's Meenakshi Lekhi and Pravesh Verma, and over 50 employees of parliament have tested positive for COVID-19 so far. Many of them tested positive after undergoing compulsory coronavirus tests on the parliament premises before the start of the monsoon session, while several of them had undergone tests in their respective constituencies. All parliamentarians and staff of the secretariats had undergone mandatory COVID-19 tests before the start of the session. Mediapersons covering the parliament's proceedings also underwent these tests.



STATE SUPPLEMENTARY BUDGET

Odisha to rework budget priorities

Bhubaneswar, Sept 14: With the pandemic having ruined the state's as well as nation's economy, the government has started preparing for a supplementary budget to be presented in the Assembly during its winter session. Laying down details of the proposals, the finance department has asked administrative departments to submit their proposals by October 12.

"Covid-19 has posed challenges in every sphere of our life. The state is fighting the pandemic with all its resources with a "life above rest" approach. The fight appears longer, which would require higher expenditure. However, the strategic lockdown and shutdown to contain the pandemic has adversely affected the economic activities and revenue realization. National and state economies are likely to contract during 2020-21. Thus, there would be a resource shortfall both on account of central transfer as well as own revenues," Finance Secretary AK Meena said in a letter to all departments.

SESSION FROM SEPT 29

The monsoon session of the State Assembly will begin from September 29 and continue till October 7. This session will have eight business days. The Assembly will remain closed on account of Gandhi Jayanti (October 2). However, it will hold business October 4 despite it being a Sunday.

Meena said that it would not be possible to make substantive provisions under any unit in absence of adequate resource back up except for priority sectors. Therefore, the supplementary budget will re-prioritize the annual budget in which departments would be allowed to augment the provision in one unit only by locating equivalent savings in some other units, he said.

All departments were asked to make realistic assessments of their requirements. Focus will be given to health sector. Besides, social security transfers, employment, creation of livelihood opportunities, protecting vulnerable sections, agriculture, MSMEs as well as industries would be given importance.

Covid vax for all not possible before 2024: Serum

Mumbai, Sept 14: Dampening hopes of a Covid-19 vaccine by year-end, the chief executive of the world's largest manufacturer of vaccines has said that adequate coronavirus vaccine will not be available for everybody in the world to be immunised until the end of 2024. Adar Poonawalla, chief executive of the Serum Institute of India, said that pharma firms were not ramping up production capacity swiftly to be able to inoculate the world population in less duration.

"It's going to take four to five years until everyone gets the vaccine on this planet," Poonawalla was quoted as saying. Poonawalla had earlier predicted that if the coronavirus shot is a two-dose vaccine, as is the case with measles or

rotavirus, then the world would require 15 billion doses. The family-operated Serum Institute, which is in Pune, has partnered with five international pharmaceutical companies, including AstraZeneca and Novavax, to develop a coronavirus vaccine and pledged to manufacture one billion doses, out of which it has promised 50% to India. The firm may also tie-up with Russia's Gamaleya Research Institute to produce the Sputnik vaccine.

Poonawalla's remarks on vaccine production and distribution are crucial, in view of the Serum Institute taking on the task of manufacturing shots for the majority of the developing world. Furthermore, his statements have increased scepticism on claims by political leaders who have committed to vaccines by next month amid concerns that huge pre-orders


from Europe and US will result in developing countries being bumped to the bottom of the list. Poonawalla added that the commitment had outdone the capacity of other vaccine manufacturers. "I know the world wants to be optimistic on it... [but] I have not heard of anyone coming even close

to that [level] right now," he told the publication. As part of its agreement with AstraZeneca, the firm will seek to produce Covid-19 vaccine doses that cost closed \$3 for 68 countries and under its deal with Novavax, for 92 countries. Poonawalla, who is the son of Cyrus Poonawalla, India's sev-

enth-richest billionaire, minimised the risks over the halt in AstraZeneca trials last week after a participant fell saying, and described it as "very normal". "We're doing a... raise and diluting equity so that we have enough capital to manage the raw materials and equipment we need in the next one or two years to operate at this scale," he told FT.

Poonawalla had in April ordered 600m glass vials and other particulars to gear up for the mass manufacturing of the Covid-19 vaccine. However, he expressed worries over distribution in India, which is witnessing a rapid rise in the number of coronavirus infections, and said that the process would be difficult as there is an absence of a sophisticated cold chain system to transport the vaccine safely to its 1.4 billion people.

Sahgal was in conversation with popular poet and art critic Kedar Mishra of Odisha. The discussion covered the author's early days of education and how she got inspired by Gandhi Ji. She lost her father Ranjit Sitaram Pandit in her teens and her mother Vijaya Lakshmi Pandit was a strong force of support.

Talking about how the transition in politics has inspired her writings, she highlighted that the characters from her novels continue to reflect the contemporary times. She stressed that writers have moral obligation to reflect the social reality. She cited how she wrote against the policies of Indira Gandhi and criticised the emergency and for that she was denied a posting to Italy as an ambassador.

KLF a premier literary festival of India has initiated an online literary webinar series as the entire nation has come to a standstill because of Covid19 lockdown and has witnessed precarious scenarios touching all strata of life. The platform has successfully conducted 51 sessions so far garnering over nine lakhs views.





Keep 50% beds for nCoV patients, pvt hosps told

Bhubaneswar, Sept 14: With the rapid surge in COVID-19 cases, state government Monday asked all private hospitals located in municipal corporation areas and having more than 30 beds to reserve 50 per cent of their beds for the patients.

Additional Chief Secretary, Health & Family Welfare, PK Mohapatra has issued a notification in this regard.

"All private hospitals having bed strength of 30 or above, located in Bhubaneswar, Cuttack, Berhampur, Sambalpur and Rourkela municipal corporations limits shall mandatorily designate minimum 50 per cent of their general beds and 80 per cent of ICUs for treatment of COVID positive patients, with an option to convert the entire hospital as a COVID hospital," read the notification. The hospitals can charge the patients as per fee prescribed by the government earlier.

Meanwhile, the government has also asked the Collectors to close down the temporary medical camps (TMCs) and Covid Care Homes

2 bureaucrats appear before Lokayukta

Bhubaneswar, Sept 14: Two senior bureaucrats of the state, Monday, appeared before the Odisha Lokayukta to submit their statements in connection with alleged PPE kit purchase scam.

The Lokayukta had earlier expressed annoyance as the IAS officers failed to appear and submit their replies regarding the allegations of irregularities in purchase of the PPE kits for COVID-19 on the previous date August 7.

Subsequently, the Lokayukta ordered the officers to present their cases during the hearing September 14.

Both Hemant Sharma, former Chairman of the state level purchase committee for COVID related items, and Yamini Sarangi, the Managing Director of Odisha State Medical Corporation Limited (OSMCL), Monday placed their written submissions before the Lokayukta.

They also refused to comment on the issue when the media persons tried to get their views on the allegations.

Sharma told the media that it was wrong to say anything related to the issue outside as the case is sub judice.

Fake ghee, sauce unit busted in Choudwar

Choudwar, Sept 14: Choudwar police Monday busted a fake ghee and sauce manufacturing unit near the Girls' High School here in Cuttack district.

The cops seized huge quantity of adulterated cow ghee and tomato sauce. They also detained the owner of the manufacturing unit.

According to the police, the unit had been manufacturing adulterated ghee and sauce for the last five years.

These adulterated food products were then being sold in nearby markets in the name of branded companies.

Cow ghee and tomato sauce are widely consumed food items. With the ghee and sauce manufacturing unit being busted, local people are now in a state of panic. They are trying to ascertain whether they will face health hazards after consuming such fake products. "A fake unit has been operating for five long years. How could the police be ignorant about this fact," locals rued.

The police have seized 1,448-kg adulterated ghee, tomato and chili sauces and other chemicals used for adulteration.

Congress slams BJD for backing NDA candidate

Following BJD support, Hariwansh was re-elected as Rajya Sabha deputy chairman by a voice vote. Notably, the regional party had backed the NDA candidate Hariwansh Narayan Singh in 2018 as well for the Rajya Sabha Deputy Chairman's post following a similar talk between him and Nitish Kumar.

Mahtab bats for drainage projects in urban areas

New Delhi, Sept 14: Biju Janata Dal (BJD) MP from Cuttack Bhartruhari Mahtab Monday urged the Union government to approve projects under Atal Mission for Rejuvenation and Urban Transformation (AMRUT) for improvement of storm water drainage system in Cuttack.

Significantly, the Union government has launched AMRUT scheme with the aim of providing basic amenities like water supply, sewerage, parks and urban transport facilities to improve the quality of life especially for the poor and the disadvantaged.

Large number of drainage systems in many urban areas of the state have collapsed resulting in flooding, said Mahtab, adding this could be seen during rains in major cities

Mahtab said proper disposal of surplus rainwater is essential to tackle waterlogging problems and keeping in view the projected rate of urbanisation, a 50-year planning has been done.

He urged the Centre to approve the projects under AMRUT scheme for improvement of storm water drainage systems in Cuttack and other urban areas of the state.

INSTALL BSNL TOWERS IN KALAHANDI: PANDA

He named a few places of these districts such as Sunagada and Maragada, and informed the Lower House that these places are Maoist-affected areas.

He urged the Union government to identify the black spots in these two districts and install BSNL towers for better connectivity in these areas.

NEW DELHI: The Rajya Sabha Monday mourned the demise of five former MPs of Odisha - Narendra Kumar Swain, Basant Kumar Das, Bishnu Charan Das, Sanatan Bisi and Bhabani Charan Patnaik - along with ex-President Pranab Mukherjee on the first day of Monsoon session.

The Upper House mourned the demise of 19 MPs including three sitting MPs.

Bhabani Charan Patnaik was a Congress leader from Odisha and a Rajya Sabha member for three terms. He was also awarded Padam

Rajya Sabha Chairman M Venkaiah Naidu adjourned the proceedings for an hour as a mark of respect to the departed members

Shri in 2018. Patnaik died in Bhubaneswar May 14 at the age 98. He had also taken part in the Quit India movement in 1942. Mourning the demise of Patnaik, RS

Chairman Venkaiah Naidu said that the country has lost a veteran freedom fighter, an able Parliamentarian and a great social worker.

Basant Kumar Das was Rajya Sabha member from 1990 to 1996 from Odisha. He died at the age of 80 in April this year. Bishnu Charan Das was a Biju Janata Dal leader and Rajya Sabha MP from July 2016 to March 2017.

He died July 6 this year at a hospital in Bhubaneswar weeks after he suffered a stroke. BJD leader Narendra Swain was a

member of Rajya Sabha from December 2015 to April 2020. He passed away September 7 at a hospital in Cuttack.

Rajya Sabha Chairman M Venkaiah Naidu adjourned the proceedings of the House for an hour as a mark of respect to the departed members.

Traditionally, proceedings are adjourned for the day when a sitting member or former President dies. However, the Chairman adjourned the House for an hour only in view of 18 days' short session due to COVID-19.

₹35Cr released for tiger, jumbo protection: Pradhan

The Union Minister said efforts to nurture traditional compassion and tolerance in people living in and around elephant habitats is also

CB BEGINS PROBE INTO JOB FRAUD

Bhubaneswar, Sept 14: The state Crime Branch (CB) has initiated a probe into alleged job fraud following a complaint of the Odisha Staff Selection Commission (OSSC). The CB also reportedly found prima facie evidence against the miscreants, who allegedly tried to secure jobs under OSSC using fake documents.

As per sources, one of the accused identified as Debabrata Pradhan is a resident of Odatarabai village under Delang police station in Puri. Pradhan reached the OSSC office at Barrack No-1 in Unit-V area here in October 2019 and claimed that he had received appointment letter for the post of Sub-Inspector of Police under the Combine Police Service exam conducted by the OSSC in 2013.

The OSSC staff immediately suspected his claims as the result for the said exam held during 2013 had already been declared in December 7, 2016.

Meanwhile, the OSSC selected the required number of candidates out of the total 840 who cleared the test as per the number of vacant posts. Many candidates who failed to get the job had also later staged dharna and gheraoed the OSSC office.

When the suspecting OSSC staff asked Pradhan to show documents, he presented a notice downloaded on his cell phone from his personal email address.

The OSSC staffers found the notice to be fake and created by forging the original notice related to the viva voce test for the post of welfare extension officer.

Later, OSSC authorities lodged a complaint with CB which also found during probe that along with Pradhan other persons are involved in the crime. The crime branch requested the Google search engine authorities to find out others involved in the fraud as well as the victims who were cheated.

The CB sleuths found that along with Pradhan some others are also involved in the fraud

SC clean chit to Asirbad in 'Barabati shops on rent' case

New Delhi, Sept 14: In a major relief to Asirbad Behera, the Supreme Court has given clean chit to him in a case related to financial irregularities at Barabati stadium and land grab allegations based on the report of Accountant General (AG).

A three-judge bench of the apex court headed by Chief Justice SA Bobde and comprising Justices AS Bopanna and V Ramasubramanian has taken on record the report submitted by the Central Bureau of Investigation (CBI) and accepted the final form for closure of the case.

The apex court's order came after CBI submitted to the court that "no prosecutable evidence could be gathered during the in-



vestigation to prove criminality on the part of then Odisha Olympic Association general secretary Asirbad Behera and M/s Incon Associates or its partners."

The bench also allowed the CBI to return seized documents to

Behera and other parties. CBI had indicated in its report that the Orissa Olympic Association (OOA) had constructed the shops and let out the same to the interested parties.

The report also indicated that the observations of the AG were based on the 'fair rent' taken into account which was fixed for a different purpose.

The SC had in April 2017 directed the reports of the AG pertaining to 23 shops and the Kalyan Mandap.

In his report, the AG had made a comparison of actual rent charged versus fair rent from 1999 to 2014 and indicated that there was differential (apparent loss) of ₹1, 79, 57, 211.

Record 4,198 new cases push state's nCoV tally to 1,55,005

11 more succumbed to the infection, taking Odisha's coronavirus death toll to 637

Bhubaneswar, Sept 14: State registered its highest single-day spike in COVID-19 cases Monday as 4,198 more people tested positive for the infection, an official of Health and Family Welfare (H&FW) department said.



The fresh infections have pushed the state's coronavirus tally to 1,55,005. Meanwhile, 11 more patients succumbed to the infection, taking Odisha's coronavirus death toll to 637, the official said.

Odisha had reported its previous highest single-day spike of 3,996 cases September 11, the official pointed out.

As many as 2,476 new cases were reported from different quarantine centres, while 1,722 people tested positive for the infection during contact tracing.

Khurda district reported the highest number of fresh cases at 758, followed by Cuttack (367) and Puri (310). Ten other districts registered more than 100 fresh infections each, added the official.

Four fresh fatalities were reported in Cuttack, two each in Bolangir and Khurda and one each in Kandhamal, Nayagarh and Mayurbhanj districts, said the official.

As many as 53 COVID-19 patients have so far died in the state due to other ailments.

The state has so far tested over 24.72 lakh samples for COVID-19, including 49,393 Sunday the official said.

Meanwhile, 3,382 persons recovered in the state, Monday, the H&FW department tweeted.

The recoveries include 503 from Khurda, 344 from Cuttack, 262 from Bargarh, 177 from Jagajpur, 175 from Mayurbhanj, 167 from Bhadrak, 156 from Balasore, 146 from Dhenkanal, 112 from Puri and 102 from Jagatsinghpur.

With this, the number of active cases in the state stands at 32,291, while 1,22,024 people have been cured of the disease so far, the H&FW official further said.

Mohanty has been admitted to AIIMS, Bhubaneswar, party sources said, adding that earlier BJP Lok Sabha MP from Bargarh Suresh Pujari, Union Minister Dharmendra Pradhan and Nilagiri MLA Sukanta Kumar Nayak, had tested positive for the infection.

Meanwhile, Chief Minister Naveen Patnaik wished quick recovery of Mohanty. Taking to Twitter, Patnaik said, "Concerned to know that #Odisha BJP President @SamirMohantyBJP ji is tested positive for #COVID19. Spoke to him to inquire about his wellbeing and wished him speedy recovery."

The other Odisha ministers who have earlier tested positive for COVID-19 include Food Supplies and Consumer Welfare Minister Ranendra Pratap Swain and Women and Child Development and Mission Shakti Minister Tukuni Sahu.

OTDC staff fume at 'privatisation' move

Bhubaneswar, Sept 14: Irked over a purported plan to lease out OTDC Panthaniwases in the state, Utkal Prayatn Nigam Employees' Association (UPNEA) Monday criticised the move and demanded regular salary to the employees.

Addressing a press meet at the Panthaniwases here Monday, association president Sibananda Ray said, "Initially there was a plan to lease only 5 Panthaniwases - Dhauli, Gopalpur, Bhadrak, Taptapani and Balasore to the hotel industry, but now there is a clear conspiracy to lease out the 21 profit-making Panthaniwases to various hotel industries."

Working president of OPNEA, Benudhara Patra, alleged that Panthaniwases has been the first choice of stay by the lower middle class and middle class tourists. "However, privatisation of all the 21 Panthaniwases is like backstabbing the employees who are working in these facilities," he added.

"A few days back, we had tried to seek attention of the state government but to no avail. The financial success of the 21 Panthaniwases was ₹31.24 crore in FY 2017-18 and ₹39.39

The future of the employees working at various Panthaniwases would be pushed to uncertainty. OTDC hasn't received any equity share from state government yet despite the profits, said the association, which also demanded regular salary of employees and signing of an MoU with the lessees.

If the demands are not conceded, OTDC employees will opt for mass self-immolation in front of the Chief Minister's residence

Association's general secretary Niranjan Nayak and vice president Dipati Ranjan Kar were also present at the press meet.

OTDC chairperson Shreemayee Mishra, MD Sachin Ram Chandra Yadav and tourism secretary Vishal Dev were unavailable for their comments.

While proceeding to Sambalpur, the inspecting teams intercepted three trucks loaded with tobacco products worth ₹1.10 crore at Jujumara near Sambalpur. The said goods were being transported

from M/s KP Sugandh Ltd and M/s Narayani Trading Company, Sambalpur to Cuttack/Bhubaneswar/Jatni on the strength of waybill No.891114560533 dt.09.09.2020 and 851114746441, 881114744811 dt.10.09.2020.

For the fraudulent transactions effected through the above mentioned three vehicles, orders in MOV-7 have been issued to the consignee of the goods to pay tax and penalty amounting to ₹1.25 crore, u/s 129 of OGST Act.

Witchcraft: 2 get life term for killing woman, minor sons

Baripada, Sept 14: A court in Mayurbhanj district sentenced two men to life imprisonment Monday for killing a woman and her two minor sons over three years ago on the suspicion of their being involved in witchcraft.

Rairangpur additional district and sessions judge AR Pattnaik also slapped a fine of ₹10,000 on each of the two convicted. Failure to pay the penalty would keep them

behind the bars for an additional six months.

The two—Arjun Sinku (27) and Gurucharan Karua (22) had killed Rinki Sinku (35) and her two minor sons Jagannath (10) and Jasamanta (3) with sharp weapons July 18, 2017 in Jhipabandh village in the district as they suspected that she practised witchcraft.

The two were subsequently arrested by the police and booked under Section 302 (murder) of Indian Penal Code.

BPIA passenger movement soars

Bhubaneswar, Sept 14: With the phase-wise resumption of services at Biju Patnaik International Airport (BPIA) being rolled out, the city airport showed gradual increase in passengers post lockdown.

Taking to Twitter, Airport Authority of India (AAI), Monday, stated that the BPIA recently witnessed passenger footfall of 95,500 in August 2020 against just 128 earlier in April. This tremendous jump in the number of people availing the service comes as a good sign due to "travellers' trust" in the services and its "safety precautions", it added.

It can be mentioned here that flight services to and from BPIA were affected when the central government ordered suspension of all domestic and international flights earlier in March owing to outbreak of COVID-19. However, a brief hia-

tus, the city airport saw its first domestic flight landing Bhubaneswar from Delhi on May 25.

"The number of passengers is increasing every day. This is a promising sign for us. Although we haven't resumed all our services we have been operating about 20 flights daily. Earlier due to COVID induced lockdown we had suffered 50% and the passenger traffic had dropped by 75. Passenger movement was observed as 58,953 in June and 65,137 in July," said BPIA Director, V. V. Rao.

Meanwhile, the city airport with its newly resumed services to Surat has now been catering to flights from Hyderabad, Delhi, Mumbai, Kolkata, Bengaluru, Chennai and Jharsuguda.

Moreover, as per sources, against 45 daily flights being functional from the BPIA the authorities have allowed service for 20 until now.

Work on 11 MCCs complete: BMC

Bhubaneswar, Sept 14: After a brief hiatus owing to COVID-19, the civic authority here stated that its proposed project of Micro Composting Centres (MCCs) in the city is back on track with completion of 11 centres.

Observing the inefficient management of large amounts of waste generated in city, the Bhubaneswar Municipal Corporation in August last year had floated tenders for construction of 43 MCC in 67 wards of the city. The civic authority had planned to complete works of about 30 of these MCCs by July this year.

"However, the proposed project was delayed as the pandemic broke out. We have re-shifted our focus on the project and as on Monday, work on 11 MCCs has been completed. Meanwhile, rest 32 MCCs are underway in full swing and will be ready soon," said BMC Deputy Commissioner of Sanitation, Suvendu Sahu.

It can be mentioned here that MCCs are vital component in waste



management and can process up to five tonnes of waste in a day. With the generation of 500 tonnes of waste per day, the BMC has setup these MCCs in two divisions.

While Prasanti Vihar, Patia, Palasuni Niladri Vihar, Hatiasuni Temple, GA plotted area of Bharatpur, Kalinga Nagar are under Division 1, Laxmisagar, Pokhariput, STP near Kalinga Nagar are under Division 2. Moreover, the temporary transit centre near Sainik School will have an additional MCC.

Road under-bridge launched in Angul

Bhubaneswar, Sept 14: East Coast Railway (ECoR) has closed another manned level crossing under its jurisdiction recently after commissioning of a road under-bridge (RUB) between Jarapada and Kerajanga railway stations in Angul district.

"Manned level crossing ST92 between Jarapada and Kerajanga stations in Angul district of Odisha was connecting Paripara and Kerajanga gram panchayats. For smooth rail-road communication and in view of safety of both rail and road users, the RUB has been constructed and commissioned," said ECoR sources.

The road users were facing difficulties as the level crossing gate closes for passage of trains as per the rules.

So, it has been decided to close the manned level crossing Gate No. -ST-92 for public interest, the sources added.

The three-kilometre-long Bahujanga-Dhauidpada high-level bridge on Birupa river and Sakutalapur NH-5 high-level bridge on Sanangenti river under Jaraka Rural Work Project-2 are some of the prime examples of this dilly-dallying. The deadline for completion of the bridges has long gone by. Yet the bridges are still not complete. The foundation stone for the two

bridges were laid in 2013. HL Infrastructure, a construction company, has been awarded with the tender to construct the two bridges in 2013-14 financial year. It had promised to complete the construction of the two bridges by April, 2019. However, a year has gone by and the bridges are yet to be completed.

Similarly, the initial cost for construction of Sakutalapur NH-5 high level bridge was estimated at ₹5.55 crore. Now, it has been pegged at ₹5.70 crore. Locals alleged that the dilly-dallying attitude of the officials in the Works department is causing inordinate delays in the completion of the two projects. They have threatened to stage agitations before the District Collector's office soon unless the construction of the bridges was completed.

Admitting that fund constraint has been a hindrance for the second bridge, Chandikhole Rural Development department sub-divisional engineer Tulasi Patra said the work will start once the funds are released. "We are waiting for fund allotments," he said.

GANJA WEIGHING 6.32 QUINTAL HAS BEEN SEIZED ALONG WITH ₹40L CASH

Birmaharajpur / Jeypore, Sept 14: In a combing operation by Special Task Force (STF) and local police of both Subarnapur and Koraput districts, a huge cache of cannabis was seized, Monday. Six persons in this connection were arrested from both the districts.

In the first case, acting on a tip-off, the Special Task Force (STF) along with local police in Birmaharajpur intercepted a pick-up truck in Subalaya area in Subarnapur district. During the search operation police seized around 4.8 quintals of ganja. As per police records, the cost of the seized contraband in the black market is around ₹30 lakh.

During the seizure, one person managed to flee from the spot while police arrested four accused for their alleged involvement in the smuggling.

The four accused have been identified as Narayan Patra from Kshalapur; Sanjay Meshawa from Rairakhol, Sourav Kumar Barik from Birmaharajpur and Sushil Mishra from Madhya Pradesh.

The cops also seized ₹9.77 lakh from their possession, a Honda City car and a pick-up van. Similarly, two youths from Uttar



Pradesh were arrested by Jeypore Sadar Police for allegedly smuggling 151 kg of ganja.

The accused were Sagar Choudhury and Akash Choudhury from Raya district of Uttar Pradesh. Jeypore police came to know about the illegal smuggling of ganja from a reliable source. For this, the police intercepted a car going towards Raya district from Jalaput late night and found ganja packed in large polythene bags.

Two mobile phones, ₹1,70,000 cash and a car were seized from their possession.

It may be mentioned here that in a recent ganja seizure in Bangalore, the cops there hinted at a possible Odisha link. The seizure was one of the biggest catches with around 1.350 kg of ganja. Though the state police has been keeping an eye on the illegal smuggling of the contraband, the mafia has been able to hoodwink them.

THE PATTERN ON THE WINGS OF THE BUTTERFLY WE ARE TALKING ABOUT HAS THE APPEARANCE OF A SNAKE

Koraput, Sept 14: You would have seen various amazing patterns and colour combinations on the wings of butterflies. Well, the pattern on the wings of this particular type of butterfly will top them all. The pattern on the wings of the butterfly we are talking about has the appearance of a snake.

The butterfly had perched on the wall of a house, owned by Soudamini Behera at Bhawaninagar area in this town.

"We first saw the butterfly Sunday. It was perched on the wall. Its wings bear such patterns that they look like two snakes raising their hoods on both sides. We have never ever seen such a pattern on any butterfly," claimed family members. "The butterfly has been in our house since Sunday. We are taking great care of it so that it can't be preyed on by lizards," they added.

The butterfly is eight inches in length and six inches in width

with its wings stretched. Its colour is a beautiful combination of orange and golden. As the news spread of this particular butterfly started doing the rounds, people from nearby areas have been flocking to the house of Soudamini to have a glimpse.

Attacus atlas, the atlas moth, is a large saturniid moth endemic to the forests of Asia. The species was first described by Carl Linnaeus in his 1758 10th edition of Systema Naturae.

ETIMOLOGY

The atlas moth is one of the largest lepidopterans, with a wingspan measuring up to 24 cm and a wing surface area of about 160 sq cm.

The body is disproportionately small compared to the wings. The underside of the wings are reddish brown with a pattern of black, white, pink, and purple lines and triangular, scale-less windows bordered in black. The undersides of the wings are paler.

The atlas moth has no mouth, and they do not eat

once they have emerged from the cocoon, relying on fat storage for energy. Every flight takes valuable energy and can take days off their already short lives, as it has a very short life span of only one to two weeks. They conserve energy by flying as little as possible. A female will wait for a male to come along and be fertilised, lay eggs and die.

Their habitat is primarily dry tropical forests, secondary

forests, and shrublands across South Asia, East Asia, and Southeast Asia, including Borneo, though one specimen, an adult female, was found in 2012 in Ramsbottom, England after it landed on a windowsill, and presumed to have escaped from a private collection.

Atlas moths are named after either Atlas, the titan of Greek mythology (due to their size), or their map-like wing patterns.

Engineer meets watery grave at Palajhar dam

Baghiapada, Sept 14: A young engineer drowned while taking selfies at Palajhar dam under Baghiapada outpost limits in Boudh district Sunday.

His body was fished out Monday. The deceased has been identified as R Mukundam (22), a native of Tamil Nadu. He was working at a mega lift irrigation project in the district.

According to a source, he along with his two associates had gone to Palajhar dam built across river Salunki to take a bath. The three were clicking selfies there when Mukundam's mobile phone accidentally slipped from his hand and fell into the water.

To retrieve the phone, Mukundam jumped into the water. His friends were



waiting for him near the spot from where Mukundam dived into the water. It was when he did not come out of the water even after long hours that they immediately informed the Boudh fire station.

Fire personnel and an ODRAF team reached the spot and carried out a search operation. They continued searching till the evening but could not find him.

India is the world capital of selfie deaths, accounting for about half of the 259 reported fatalities between 2011 and 2017, according to a study by the US National Library of Medicine

They had to stop the operation due to darkness.

The operation was resumed Monday morning and they eventually stumbled upon the body of the deceased engineer at a place one kilometre from the spot of the occurrence and fished it out.

On being informed, police reached the spot and seized the body for post mortem.

Transforming Africa's Agriculture

Over the next 30 years, Sub-Saharan Africa's population will double to over two billion, and its economies will industrialize. Africa's development will therefore be critical to the world's future stability, prosperity, and health. Given this, the continent should be receiving much more international attention.

The COVID-19 crisis has highlighted a number of global vulnerabilities, including the uncoordinated nature of the world's pandemic response, its inability to support the poorest countries and their populations in managing the economic fallout, and of course the weakness of existing health-care infrastructure. Leaders must now urgently address these weaknesses, alongside other major global challenges, ranging from climate change and rising inequality to technological disruption and global terrorism.

Moreover, fragile agriculture and food systems, particularly in Africa and other low-income regions, have exacerbated the pandemic's impact. Unless addressed, these systems' shortcomings could deepen any crisis in the decades ahead.

The argument for fundamental reforms is partly a moral one. The United Nations World Food Programme warns that the number of people suffering from acute hunger in low and middle-income countries – including in Africa – could almost double this year, to 265 million, as a result of the pandemic. Strengthening Africa's agriculture systems is vital to making the continent more self-reliant and resilient to future shocks. Otherwise, economies will remain stagnant, limiting tax revenues and leaving welfare systems unable to support people through crises such as COVID-19.

But it is also in the enlightened self-interest of all countries – including members of the G20 and OECD – to ensure well-functioning agriculture and food systems in Africa and other poor regions. This is because food and agriculture are central to making the world's health, economic, and security systems fit for the 21st and 22nd centuries.

For starters, vibrant food and agriculture sectors are essential for preventing malnutrition – one of the leading global causes of illness – and strengthening them is important in managing pandemics as well. COVID-19 lockdowns and social-distancing measures failed in less developed countries with large informal economies, mainly because of concerns that such regulations would severely harm people's ability to earn enough to feed their families.

Agriculture is also crucial to successful economic transformations. There can be no global economic stability, green economy, or eradication of mass poverty if African and other developing countries do not industrialize. And as the United States, Europe, and Asia have demonstrated, industrialization first requires an agricultural revolution, which Africa has yet to experience.

Bolstering global security, too, entails transforming agriculture and the food system. Terrorism feeds on the disenfranchisement of rural populations in regions like the Sahel, where people can gain more through illicit activity than through the lawful economy and public services.

Finally, revamping agriculture – particularly in Africa – is a precondition for sustainably feeding a global population that could increase to almost 11 billion by the end of this century. Many African leaders are focusing on reforming agriculture – and making progress. Senegal's development of rice and other subsectors, Ghana's Planting for Food and Jobs program, and the work of Ethiopia's Agricultural Transformation Agency are all excellent examples of strong government leadership in this field.

Given the right focus by governments, policymakers can identify agricultural sectors, which, with the deployment of technology and new practices, can attract investment, in turn spurring employment, economic growth, and tax revenues – thereby initiating a virtuous cycle of development. Investment and reform – both domestically and externally financed – can accelerate change.

A series of upcoming global events provide the world with excellent opportunities to advance this agenda – starting with the African Green Revolution Forum, which has been taking place this week, hosted by the government of Rwanda. This gathering is crucial in highlighting the need for Africa – backed by the international community – to step up its efforts to transform its agriculture and food systems in a way that will allow the world to achieve the targets established by the 2030 Sustainable Development Goals. This year's forum focuses on how to feed Africa's rapidly growing cities and urban centers – potentially the global economy's greatest source of future growth.

I have been taking part in the forum for the third consecutive year, though for the first time remotely. My teams and I have focused on how to scale up investment in Africa's agriculture and agro-processing to transform the sector; increase its resilience to crises like pandemics and climate change, and spur the continent's burgeoning industrialization and technological revolution. Next is the UN General Assembly later this month, the G20 summit in November, and the UN Food Systems Summit next year.

The COVID-19 pandemic is a stark reminder that the inability of many poorer countries' agricultural systems to meet their populations' most basic needs will have huge geopolitical consequences if not tackled urgently. Fortunately, the upcoming global gatherings will allow the world to debate the best way forward so that governments can take rapid and effective decisions. We all have a stake in seizing the opportunity.

The economy shrank by nearly one-fourth during the first three months of this fiscal year. Much of this was due to the harsh lockdown initiated in March. Roughly three-fourth of the economy was practically shut for a month, after which there were aseries of renewed lockdowns with partial relaxations. For this quarter, the economy suffered a triple shock, as demand, supply and finance collapsed. Unemployment rose close to 30 percent in April, rendering nearly 122 million people jobless. In cities, whose workforce consists of 40 percent migrants on an average, the toll on livelihoods was severe. With loss of jobs and income, it soon became a food crisis for many urban households, necessitating emergency measures from state governments. The Central government's initial relief package

was to enhance food security by doubling the rations and extending this up to November.

The big 20-lakh-crore package announced by the Central government in May consisted largely of liquidity support. For instance, micro, small and medium enterprises are eligible to guaranteed loans up to ₹3 lakh crore. Of this amount, roughly half has been sanctioned and loans are being disbursed. It is no wonder that the demand for loans is muted, since small businesses already hit by zero demand are not keen to take on any additional debt burden. But those small businesses which have a cash management mismatch, i.e., they have pending invoices that have not been paid by their customers, are quite willing to take loan support to tide over their crisis. In effect, such small businesses face a problem of illiquidity; not of insolvency.

The situation is similar for all sectors of the economy. RBI has injected liquidity worth nearly ₹8 lakh crore, cumulatively. This is a combination of interest rate cuts, buying up of government bonds from banks (called "open market operations") and buying foreign exchange and releasing cash. The RBI has also given low-cost,

long-term funds to commercial banks as well as non-bank finance companies. This is called a long-term repo operation. Much of this excess liquidity, i.e., cash availability, has not resulted in a loan growth, but instead has probably gone into the stock market. The inflow of foreign funds plus excess liquidity in Indian banking is one reason that the stock market has recovered by more than 50 percent since the steep fall in March. To some extent, we have recovered from at least one of the three shocks in the triple shock, i.e., the financial shock.

While GDP shrinks and the supply and demand challenges remain, the second quarter GDP may show some improvement. But the growth numbers will still be negative. More than half the households, as per a survey, are reporting that their income this year will be lower than of last year. Businesses too are struggling to catch up to pre-Covid revenues. In such a situation, the bank credit to industry will be highly stressed.

The bi-annual financial stability report of the RBI had already warned in its July report that non-performing assets ratio could rise a full 4 percentage points from

March 2020 to March 2021. That is nearly a write-off of ₹4 lakh crore of bank loans. If there was a 'severely stressed scenario', the NPA ratio could be 2 percent higher at 14.7 percent, which means a write-off of an additional ₹2 lakh crore. The banks' risk adjusted capital ratio is adequate to meet these write-offs in the aggregate. Under severe stress, this required capital buffer ratio could decline all the way to 9.4 percent, which is not enough as per Basel norms. With rising bad loans, the banks can make profit, and give a decent return to depositors and shareholders by charging a profitable interest rate on the good quality loans. Hence, despite rate cuts by the RBI, the banks are unable to pass on lower interest costs to "good" borrowers, since the burden of NPAs is rising.

To add to these woes of banks, there has been the loan moratorium to tide over the severe stress caused by the pandemic, the RBI announced a three-month moratorium on 'good' loans starting from March. This moratorium was then extended by another three months to the end of August. As of now, the moratorium matter is in the Supreme Court, and

has been effectively extended till September 28, the date of the next hearing.

The issue is that borrowers want an interest waiver, as well as a waiver on interest on interest, caused by the delay in repayments. It seems unfair to load this burden on bank depositors and shareholders. If indeed the borrowers deserve relief, then it should be given as explicit fiscal relief, i.e. from the Central government's treasury. But, such a partial waiver to borrowers who opted for the moratorium and not others who did not is also problematic.

The larger issue is what to be done about banking health in times of the pandemic. The RBI-constituted KV Kamath committee has submitted a report identifying 26 sectors to which loans will need to be restructured, so that they are not counted as NPAs. The committee has carefully identified sectors affected directly by the pandemic which hence need relief. But those that were already doing badly pre-pandemic need to be dealt with differently. Nearly 72 percent of the banking sector debt has been affected by Covid and will need some restructuring. The recommendations are based on clearly defined parameters and banks have been split into mild, moderate and severely stressed.

Meanwhile, data from August shows that industrial credit demand is not increasing. In fact, in the first quarter, the demand for 13 out of 19 major industry groups had negative growth as per a CARE Ratings report. The other six were barely positive or zero. Banks need healthy growth in credit demand to remain viable, if not profitable. Most of the public sector banks will need a large infusion of equity from the treasury of the Central government, especially on account of rising bad loans. There is simply no easy way to dodge this fiscal bullet.

More of liquidity, cash flow for migrants

ACCORDING TO A SURVEY BY FEDERATION OF CHAMBERS AND COMMERCE AND INDUSTRY (FICCI), THE PRESENT DEVELOPMENTS REVEAL THAT 68 PER CENT COMPANIES WILL SEE HURDLE IN RECOVERY

It is globalisation across the globe. The world has applied the brakes on the economy due to an unprecedented civilizational lockdown. India, termed as the engine of global growth, has taken a big hit and it may take quite a few years for it to regain its strength. All economies in intense relationships having lost over 30 percent of their GDP are now getting more local and regional. Never before has civilization panicked before an epidemic as it has unwisely done now. Let there be a probe whether or not this is a conspiracy to kill Indian economy.

The supposed disease is not lethal, in the Indian context, but the panicky closure of all activities, travel and business has ruined the economy. Rightly, former RBI governor Raghuram Rajan says India's GDP contraction must alarm everyone. He is correct because India, the global growth leader, had started slowing down since August 2019 amid the Sino-US trade war, the thaw in EU economy and fall in global demand. Even with some resumption of activities, the fall in GDP by minus 23.9 percent in June quarter so far may also mean an average contraction of 14.8 percent (Goldman



Sachs) or 11.8 percent (India Ratings) or 10.5 percent (Fitch Ratings) for 2020-21. Most of these estimates indicate a looming deterioration in asset quality in the financial sector. The agencies are expecting positive growth not before 2022. Fitch says India records the sharpest GDP contraction but expects a rebound.

The world stock markets are in tizzy except for tech giants like Apple, Microsoft, Amazon, Facebook and Google which have added \$1 trillion to their market capitalisation. Cornerstone Macro says 100 of the 500 on Standard & Poor's index, are trading at more than 50 percent below their peak. Indian situation is similar as we find that Reliance has added \$10 million.

Some other tech companies have done well. But most others in mid and small segments particularly airlines, real estate, hotels, restaurants are not in demand.

Through 2019, initial public offerings (IPO) dried up as volatility grips the market. Till August 2019, only 11 companies launched IPOs raising ₹10,049 crore compared to 24 public issues raising ₹20,559 crore in 2018. There is an 'X' factor that is being discussed since August 2019 amid the then global growth slowing down, affecting the Indian economy. It is a twin balance sheet problem of high non-performing assets and credit stress in companies.

The job creation growth fell alarmingly since 2018-19, according

to CARE Ratings study of 960 large companies, in farming, crude oil, telecom, iron and steel, mining and hospitality. In the large firms, the job growth was 4.2 percent (5.78 million) against 6.2 percent in 2017-18. The Centre for Monitoring Indian Economy estimated in 2018 that 11 million people lost their jobs – of this, 9.1 million in rural and 1.8 million in urban areas.

Rating agency ICRA has calculated that actual deficit for states would be ₹2.9 lakh crore, ₹57,000 crore more than estimated in 2021. The Centre's shareable taxes at ₹13.4 lakh crore for the current financial year, ICRA says, is 30 percent lower than the budgeted amount of ₹19.1 lakh crore.

The present developments reveal that 68 percent of companies will see hurdle in recovery. The remedy suggested is simple – additional cash transfers to migrant workers, poor and farmers and a temporary halt in GST collection. The companies also want financial liquidity, managing costs, manpower availability and supply chain issue solutions. Though unlock has a positive impact, if the liquidity and transactions in cash do not improve, the hiring and expansions may not happen. **INFA**

Covid guidelines

Sir, In the initial four months, Odisha successfully controlled the spread of coronavirus, but now the spread is more than that of other states. The arrival of migrant labourers from other states might be one reason why the number of infections have seen a sharp rise in recent weeks. Notably, the all India CAGR is 2.09 per cent per day, but for Odisha it's 2.84 per cent. The daily cases per million population is 67 for India, 82 for Odisha and 242 for Khordha (Bhubaneswar included). However, due to better health services in Odisha, daily deaths per million population is at the rate of 0.25 against 0.83 for India. This is time to maintain the maximum alert and see that the spread is halted to the minimum. There is need to observe social distancing norms in more serious ways.

Ladakh standoff

Sir, China never practises what it preaches in relation to agreements on border disputes. Still, there is talk of maintaining and enhancing peace in border areas, as mentioned in the joint statement issued after the meeting between External Affairs Minister S. Jaishankar and his Chinese counterpart Wang Yi. In order to restore peace and tranquility along the LAC, China's words will have to turn into action on the ground, and that will mean progress in resolving border tensions. Even as the Chinese talk about peace, large numbers of PLA soldiers continue to stand in different positions carrying rifles and iron rods. As they talk about peace, the build-up too is constantly increasing. A large number of Chinese tanks and armoured vehicles have been deployed in different areas. Even though both the countries have officially reached a 5-point consensus to attempt de-escalation, neither side is ready to take the first step. The PLA that has strengthened its positions in the areas it has infiltrated is not likely to retreat in the near future. The huge build-up of troops on the ground suggests that there may be localised conflicts between the two troops. Both the countries are sitting on a tinderbox and any misunderstanding can spark conflicts that will prove costly to both. In this context, it is imperative that both Prime Minister Narendra Modi and Chinese President Xi Jinping initiate total de-escalation and disengagement. There must be a broader understanding and agreement on border issues. It must be a give-and-take kind of deal.

“In some of the areas of North 24 Parganas, Siliguri, central Kolkata, Asansol, Durgapur and some other parts of the state the Hindi-speaking population is a de-

termining factor in some of the assembly seats. Although they had voted for us all these years, during 2019 polls they had voted for BJP. We need to win them back,” a senior TMC leader said.

The development comes in the backdrop of Bengali sub-nationalism emerging as a rallying cry in West Bengal ahead of the assembly elections.

Speaking at an online news conference, Trivedi said the Hindi cell, which has been functioning informally since 2011, was given a formal structure to create “an open platform for bringing together all Hindi speaking people of the state.”

He said Mamata Banerjee sees all languages as a bouquet and the state has kept its doors open to people speaking different languages.

Reacting to the development, West Bengal BJP president Dilip Ghosh said the cell had been created with an eye on Hindi-speaking voters.

“It is good that those who have been saying that outsiders will not rule Bengal have understood the importance of Hindi. But the fact is this cell has been created with an eye on elections and TMC is not at all serious about it,” Ghosh said.

Bengal BJP aims at inducting 20 lakh Muslims

Kolkata, Sept 14: The Minority Morcha of the West Bengal BJP has set an ambitious target of inducting 20 lakh Muslims by the end of the year, as part of its efforts to dent the vote share of the ruling TMC in the state, ahead of 2021 Assembly elections.

TMC mocks ‘game plan’

The TMC mocked the BJP’s ‘game plan’ and said minorities stand firmly behind the Mamata Banerjee-led party, as it is the most ‘credible secular force’ in Bengal. “The minorities would never trust a communal force like the BJP. The TMC is the most secular force in the state, which has worked relentlessly for the development of all communities,” the ruling party’s secretary-general, Partha Chatterjee, said.

Assembly constituencies in the state, and the rest from the remaining 174 segments.

State BJP sources said the party had been trying to woo the minorities for quite some time, but its efforts received a setback following last year’s vehement protests over the CAA and the proposed exercise to prepare the National Register of Citizens (NRC) in Bengal.

En bloc minority votes for a particular party can swing the elections. The saffron camp reached its all-time high in Bengal politics last year, when it stunned political pundits by bagging 18 of the 42 Lok Sabha seats in the state, four less than the ruling TMC, and with a staggering vote share of 41 per cent votes.

Kolkata Metro resumes services after 5 months

Kolkata, Sept 14: Metro rail services in Kolkata resumed Monday after a gap of more than five months, a senior official said.

The regular services were suspended March 23 due to the COVID-19 outbreak. Special trains, however, were run for NEET aspirants and their guardians Sunday.

“Services resumed at 8 am and around 12,900 people commuted till 4 pm,” Kolkata Metro Railway General Manager Manoj Joshi told PTI. “The last trains from the originating stations on both sides will commence their journey at 7 pm and complete it by 8 pm,” he said.

Joshi said all safety protocols including social distancing are being followed.

A train is halting at a station for 30 seconds instead of the previous duration of 20 seconds to avoid rush during boarding and deboarding, a Metro Railway spokesperson said.

A total of 110 services are being run on the Noapara-Kavi Subhash

line at an interval of 10 minutes during peak hours, she said.

Also, 72 services are being run on the East-West line between Sector V and Salt Lake Stadium stations, the spokesperson said.

The services will remain suspended Sundays for the sanitisation of rakes and stations, she said.

Commuters can book their tickets online and download the e-passes or use smart cards, the spokesperson said.

The e-passes mention the departure and destination points along with time slots.

Sandeep Tewary, a middle-aged commuter, said he faced difficulty in downloading the e-pass to board a train at Sovabazar metro station.

Young executives like Aparna Maity, however, felt that the no contact ticketing system is ideal in the present situation. Another commuter, Kinshuk Basu, said, “This is a welcome change. Everything was so smooth and the staff was cooperative. I hope this continues in the future. We cannot do without Metro services.”

AASU-AJYCP’s proposed party to be named ‘Asom Jatiyo Parishad’

Guwahati, Sept 14: The political outfit to be floated by Assam’s powerful students’ organisations AASU and the AJYCP will be named the ‘Asom Jatiyo Parishad’.

Convenors of the Assam Advisory Committee (AAC) formed by the All Assam Students’ Union (AASU) and the Asom Jatiyatibadi Yuba Chatra Parishad (AJYCP) made the announcement Monday.

“The name was selected from three suggestions made during a meeting of the committee Sunday,” former Gauhati University professor Dr Krishna Gopal Bhattacharjya, one of the two convenors of the 16-member AAC, told reporters. The new political entity will be guided by the slogan ‘ghore ghore aami’ (we are in each household) to establish relations with each family in the state and not just seek votes during the elections, he said.

Elections to the 126-member Assam Assembly are due early next year. Veteran politician Jagadish Bhuyan has been appointed as the coordinator of the party, he said.

The formation of the party till the booth-level will be completed by October 30, the committee’s other convenor, former professor of Handique Girls’ College, Basanta Deka, said. The party’s constitution has almost been prepared and its state-level committee will be formed by the first week of November, he said.

The logo and the flag of the Asom Jatiyo Parishad, however, will be decided later, Deka said.

Baghjan oil well blowout singes fields, fish & livelihood

Baghjan (Assam), Sept 14: For more than 100 days, the fire raged, a tall blaze of angry orange that killed the fish in ponds and streams, destroyed homes and turned to ash the green farmlands around the Baghjan oil field in Assam’s Tinsukia district.

The fire at an Oil India Ltd well that started with oil and natural gas gushing out uncontrollably May 27 and went up in flames June 9 was controlled Sunday, said reports. But the trauma will take much longer to subside, said residents of the area around the oil field that has 17 oil and five gas wells.

The sight of the flames that coloured the skies saffron and the sound of the blaze have led to people in Baghjan village complaining of disorientation, sleepless nights and confusion.

“It was like hearing 100 helicopters constantly over my head,” said Manoj Hazarika who hasn’t slept properly in weeks.

The tales find wide echo in the village of nearly 500 residents, many who earned their living fishing, tilling their fields, some with betel nut trees, and working in the tea gardens close by. It is a village ruined, said the locals, estimating that several homes have been completely burnt and about 500 hectares of land destroyed. Kajoli Hazarika, whose home is

just about 200 metres from well no 5 which caught fire, added that the area has also been experiencing frequent tremors since the blowout in June.

“When the massive fire burnt a huge amount of oxygen in the periphery, an air vacuum was created. This resulted in sudden air movement and created minor local tremors,” an OIL official explained.

The scientific explanation does little to comfort Kajoli Saikia, who recounts in vivid detail the day it all began. It was 10:30 am May 27, she was going about her usual household chores when a series of “earthquakes” and a strange, viscous rain began. A massive sound followed, forcing the villagers to step out of their homes to figure out what was happening.

“The tin roof of my house, the windows and doors began to shake,” Saikia said.

In a couple of days, the fish in ponds and streams were dead and ashen white, added Prakash Hazarika. He said he has seen cows and goats giving birth to dead calves and kids, fish dying and birds struggling to take flight.

A carcass of a cow at the edge of a wooded area is a sign of the ravages the fire has wrought. The “strange rain” described by locals was oil and natural gas pouring down on the houses, fields and water bodies around the oil field. Thirteen

days later, it turned into an inferno. Dilip Mala, a labourer who was working at a construction site rushed to attend to his pregnant wife Sumitra, when he saw fire engulf the surrounding areas. There was chaos and panic, he said.

Villagers rushed to get hold of whatever belongings they could from their homes and fled. He said he did not think the fire could be controlled but firefighters were able to douse the flames before they could spread further. Two firefighters died in the process due to burns and injuries while on duty.

But the gas well fire continued to spew flames into the air, a tall, narrow blaze that contaminated the waters and fields and changed the micro climate of the area.

“The damage to the ecosystem has been grave and largely irreparable, the ultimate impact of which will be felt in terms of ecological imbalances and lost livelihood opportunities,” said a statement by Wetlands International South Asia, an NGO dedicated to the conservation and sustainable management of wetlands in South Asia region. Hoping to pick up the pieces of

their lives, the villagers have gathered around the deputy commissioner’s office in Tinsukia, about 40 km away.

For more than two weeks, they have been staging a sit-in to demand better shelter and future of their children, and justice for those who have lost their lives. Kajoli Hazarika, for instance, said she has received compensation of ₹20 lakh plus ₹30,000 along with 11 other families whose properties were completely ravaged in the fire.

But that is just not enough for the more than six acres of farmland that has been reduced to ashes. She said she doesn’t know what to do with the money – buy land, make a house or find an alternative livelihood.

The Assam Pollution Control Board had issued a closure notice to the Baghjan Oil field in June on the grounds that OIL had been operating without obtaining prior consent to establish and operate from the Assam Pollution Control Board. Arnab Kishore Bordoloi, an OIL engineer, lost his life due to high voltage electric shock September 9, 2020. Sisodia Covid+ve

Bus driver held

Kakinada (Andhra Pradesh): An Andhra Pradesh State Road Transport Corporation driver has been arrested for battering his wife with a dumb-bell in Indrapalem village in East Godavari district, police said Monday. "Thangedi Srinivas was arrested for the assault on his wife Madhavi on September 4 night. He is currently in remand," a police official said. Police had registered a case under Sections 498A and 324 of the Indian Penal Code, to which they later added Section 307, based on Madhavi's statement. Srinivas, 42, had come home drunk late in the night and picked up a quarrel with his wife over his drinking. "When Madhavi objected, he hit her with a dumb-bell in a fit of rage," police said.

Three killed

Tanuku (Andhra Pradesh): Three Andhra Pradesh government employees, including one working on contract, were killed when a car they were travelling in plunged into an irrigation canal in Tanuku in West Godavari district Monday morning. West Godavari Superintendent of Police K Narayan Naik said that the deceased were identified as Sekhar, a senior assistant in Tanuku municipal office; Katari Srinivas, a water boy in the RTO office; and Dasari Nagasubashini, a cluster coordinator of Velugu project.

Accused flees

Lucknow: In a shocking incident, an accused fled from the police custody when the vehicle he was being taken in, stopped for refuelling at a petrol pump in Uttar Pradesh's Lakhimpur Kheri district. The incident, which happened Sunday, was caught on a CCTV camera at the petrol pump. The CCTV footage showed the accused in a white shirt and brown pants being chased by the police personnel. The accused had been booked under the stringent POCSO Act.

RJD questions Raghuvansh's letters to Nitish

Patna, Sept 14: The Rashtriya Janata Dal (RJD) Monday cast doubts over letters written by its founding member Raghuvansh Prasad Singh, from his hospital bed, barely a couple of days before breathing his last, drawing angry reactions from the ruling NDA in Bihar.

Singh, who died at AIIMS, New Delhi Sunday, had Thursday announced his resignation from the party vide a hand-written addressed to jailed RJD supremo Lalu Prasad and followed it up with a series of communications, the next day, drawing the attention of Chief Minister Nitish Kumar towards a number of issues.

Prime Minister Narendra Modi while paying rich tributes to the departed leader Sunday had also referred to Singh's letter to the Bihar Chief Minister where he raised the issue of development of his erstwhile Lok Sabha seat Vaishali. "I will request Nitish Kumar to execute the development projects he wrote about in the letter. Let's together—the state and the Centre—fulfill his wishes," Modi said.

Nitish Kumar, who is Prasad's arch rival and heads the Janata Dal (United), had Sunday night said at



the assembly premises, where Singh's mortal remains were brought on way to his native village for cremation, "we have started acting on the requests of late Raghuvansh babu. Some issues raised by him fall in the ambit of the Centre and we have referred these to the Union government for appropriate action". Among other things, Singh had sought extension of MGNREGA benefits to the farm sector.

A screenshot of Nitish Kumar's written reply to Singh, penned

while the latter was still alive, was also shared on the official twitter handle of the Chief Minister's Office. RJD MLA Bhai Virendra and MLC Subodh Rai smelt a rat and asserted "no person, admitted to a hospital's Intensive Care Unit, can write a letter". Singh had been admitted to the ICU of AIIMS about a week ago for treatment of complications he had developed after recovering from COVID-19. He was put on ventilator late Friday and died less than 48 hours later.

Bhushan files review plea against conviction



New Delhi, Sept 14: Advocate Prashant Bhushan Monday filed a review petition in the Supreme Court, challenging its verdict convicting him for criminal contempt of court by making derogatory statements against the judiciary through tweets.

September 12, Bhushan had moved a plea filed in the apex court seeking a right of appeal against his conviction, to be heard by a larger and a different bench. The top court had imposed a token penalty of Re 1 on Bhushan, which he deposited in the court Monday. Addressing the media, Bhushan said that paying the fine does not mean he had accepted the verdict and he would file a review plea to contest his conviction. Bhushan has, in his plea, argued that tweet number 2 tends to convey an impression that "the judges who have presided in the Supreme Court in the period of last six years have a particular role in the destruction of Indian democracy and the last four CJs had a more particular role in it."

"This might well be the impression that the tweet in question seeks to convey, but the Court doesn't, in fact, show, or even attempt to show, how the holding of this opinion constitutes contempt of court. This is an error apparent on the face of the judgment," said Bhushan in the 444-page review petition.

August 31, a bench headed by Justice Arun Mishra, who retired September 2, had said: "We, therefore, sentence the contemnor (Bhushan) with a fine of Re 1 to be deposited with the Registry of this Court by September 15, failing which he shall undergo a simple im-

prisonment for a period of three months and further be debarred from practising in this Court for a period of three years."

Bhushan insisted the court erroneously held him guilty of contempt, as the fair criticism of a judge and the judiciary is protected by Article 19 (1)(a) of the Constitution. He argued that contempt proceedings should not have been heard by a bench comprising Justice Mishra. "That on several occasions, Justice Arun Mishra has orally accused the review petitioner of committing contempt of court when he had merely mentioned that it may be inappropriate for a particular judge to hear a particular case in circumstances where conflict of interest was involved," said the review plea. Bhushan urged the apex court to rehear the verdict which held him guilty of contempt and also grant an oral hearing in the open court, as the facts and circumstances of the case so necessitated.

Man digs 5-km canal to bring water to his village

Patna, Sept 14: Reminding once again what a lone determined person can do if he sets out to achieve what he has aimed for, a man in Bihar's Gaya district has dug up a 5-km-long canal in 20 years to bring irrigation water to the fields in his village. The feat of Loungi Bhuiyan, a resident of Kolithwa village on the border of Imanganj and Bankebazar blocks, makes one recall the toil of 'Mountain Man' Dashrath Manjhi, another native of Bihar who cut a road through a hill near his village in 22 years.

Loungi was pained by the migration of youths from his drought-hit Kolithwa village, which was drought-prone as it



did not get to retain sufficient rainwater for irrigation due to its geographical location. The village is around 80 km from Gaya city, surrounded by forest area. Since there were no job avenues except agriculture, a large number of village's youths migrated to bigger cities in search of livelihood. Bhuiya was unhappy that mostly women and children were left

behind in his village. Village headman Vishnupat Bhokta said: "In August 2001, he decided to dig a canal (Paain in local language) from a natural water source in Bagetha Sahwasi forest to the village. The villagers took their cattle generally to that source for watering, which also provided sustenance to the animals living in the forest area. Loungi knew that the water source was enough to irrigate the agricultural land of the villagers. However, it was a great challenge to bring water into the village." "Loungi did a survey of the land and earmarked the canal route. After working relentlessly for 20 years, he managed to dig the canal that is four feet wide and three feet deep," Bhokta said.

105-year-old woman beats Covid

Bangalore, Sept 14: The 105-year-old Kamalamma Lingangouda Hiregoudra has become the centre of attraction in Karnataka's Koppal district after her grandson reportedly cured her of Covid-19 with his Ayurvedic formulas.

Koppal is one of the backward districts of the state and has been a hotspot for coronavirus. Hiregoudra's grandson Srinivas Hyati is an Ayurvedic doctor practising in the state.

As the elderly woman had fever, she had undergone a corona test which came positive but she was reluctant to be hospitalised.

"It was a challenge to treat her at home. However, she had no other health issues and that was a great advantage for us to treat her like any other Covid-19 patient. She was not worried about the virus and cooperated for the treatment in home isolation," Hyati said.

Her family members said she had stopped taking food saying her life was about to end. "But we forced her to consume at least 'ganji' (porridge) and water along with the prescribed medicines that helped her to recover," a family member claimed.

ROUGH PATCH FOR RESTAURANTS LIKELY TO CONTINUE

New Delhi, Sept 14: Only 28 per cent citizens say they have consumed restaurant food in the last 60 days, and most did it by ordering the food at home, according to a survey by Local Circles.

Only 34 per cent citizens are likely to consume restaurant food in the next two months and most of them will order food at home instead of going for a dine out. The survey findings show that the struggle for restaurants will likely continue for longer than initially expected.

There have been reports that many restaurants and cafes have shut down shops as they were unable to recover even their operational costs due to lack of customers. Many others have said that



they are barely hanging on. Restaurants are also seeking permissions from the government to start 'al fresco' or open air dining to ensure social distancing and minimise the risk of the virus spread. It has been three months since

restaurants became operational and although the industry was quite happy with the decision, consumers have largely stayed away from eating out due to the Covid-19 fear.

A recent study by the Centre for Disease Control, USA has said that

adults who tested positive for Covid-19 in July in America were twice as likely to have visited a restaurant or a coffee shop in the last 14 days.

On consuming restaurant food, in response, two per cent said they visited restaurants several times to eat out and three per cent said they visited restaurants just a few times. Another two per cent said they didn't visit a restaurant, but did home delivery of restaurant food several times while 21 per cent said they didn't visit a restaurant, but did home delivery of restaurant food a few times (20 per cent). A total of 72 per cent said they neither visited a restaurant nor did home delivery of restaurant food.

This means that only 28 per cent citizens say they have consumed restaurant food in the last 60 days,

and most did it by ordering the food at home. For the next 60 days, three per cent said they plan to visit restaurants several times to eat out and six per cent said they plan to visit restaurants just a few times to eat out. Three per cent said they had no plans to visit a restaurant, but will do home delivery of restaurant food several times, while 22 per cent said they have no plans to visit a restaurant, but will do home delivery of restaurant food a few times. Sixty-four per cent said they have no plans to visit a restaurant nor do home delivery of restaurant food.

This shows that only 34 per cent citizens are likely to consume restaurant food in the next two months and most of them will order food at home instead of going for a dine out.

New Delhi, Sept 14: India Monday overtook Brazil to register the highest number of COVID-19 recoveries in the world at 37,80,107, according to Johns Hopkins University data.

in terms of the number of recovered coronavirus cases at 37,80,107, followed by Brazil at 37,23,206 cases and the US at 24,51,406 cases.

According to the Union Health Ministry, India's recovery rate has touched 78 per cent reflecting the increasing number of high recoveries per day. "Around 77,512 patients have been discharged in the last 24 hours. The total recovered cases are 37,80,107. The gap between recovered cases and active cases is consistently increasing. This has touched nearly 28 lakh today (27,93,509)," the health ministry said in a statement. The ministry further said that Maharashtra, Karnataka and Andhra Pradesh, Uttar Pradesh

and Tamil Nadu have recorded around 60 per cent of the total recovered COVID-19 cases.

The total number of active coronavirus cases in India stands at 9,86,598 as on date while the number of COVID-19 cases in the country stands at 48,46,427. Deaths have been relatively low compared with the number of infections, but the rate is rising.

DELHI RIOTS KHALID IN 10-DAY POLICE CUSTODY

New Delhi, Sept 14: A Delhi court Monday sent former Jawaharlal Nehru University student Umar Khalid to 10 days police custody in connection with a case related to the violence which broke out in Delhi's northeast area in February this year.



Delhi Police's Special Cell had arrested Khalid on Sunday night under the stringent Unlawful Activities (Prevention) Act, after questioning him for over ten hours. He was produced before Additional Session Judge Amitabh Rawat of Karkardooma court via video-conferencing Monday afternoon. During the course of proceedings, Special Public Prosecutor Amit Prasad sought 10 days police custody to confront Khalid with huge technical data running into 11 lakh pages, "as well as other evidence collected during investigation of present case and also to examine at length about other suspects and various other aspects". According to the remand application, names of some more suspects have also cropped up during the investigation of riots and Khalid is required to be questioned at length about those suspects to obtain their exact particulars for further investigation. "Since technical data and other material are substantial which needs to be confronted, it is necessary that 10 days police custody remand be granted,"

MPs use 'Attendance Register' App

The move is a step forward in digitalising operations at the Parliament

New Delhi, Sept 14: In a first-of-its-kind initiative, all Members of Parliament (MPs) registered their attendance through a mobile application when Lok Sabha assembled Monday for the first day of the Monsoon Session.



The 'Attendance Register' App initiative was adopted by the Parliament this year in view of spurt in coronavirus or Covid-19 cases so that the spread of the disease could be contained during the Session.

"The digitalisation of operations at the Parliament demonstrates India's capable and efficient response to the current pandemic," Lok Sabha Speaker

Om Birla said in a tweet while commenting on use of 'Attendance Register' App. To minimise COVID-19 transmission risks due to multiple handling of papers, the Lok Sabha as well as the Rajya Sabha secretariat this time came up with the App.

The initiative is among various first time measures adopted in the Parliament in this Monsoon Session.

Besides, all parliamentary papers will be available electronically through 'Today's Papers' tab on Members' portal during the session. Members may download and take printouts for their use. Parliamentary papers, not exclusive to the MPs, will also be available on the Lok Sabha website under the tab 'Today's Papers in the Business of the House.' The Monsoon Session will continue till October 1.

UGC-NET exam postponed

wards," said Sadhana Parashar, Senior Director, NTA.

"This is due to some common candidates in both exams and the requests received thereof. The exact schedule of subject-wise and shift-wise details will be uploaded subsequently," she added.

The June 2020 exam along with various other exams had to be postponed due to the COVID-19 pandemic and the resultant lockdown. The new schedule for various exams was released by the NTA in the last week of August.

Is Bikru village haunted by Vikas Dubey's ghost?

Kanpur, Sept 14: As soon as the Sun sets, people scurry back into their homes and lock their houses in Uttar Pradesh's Bikru village that witnessed one of the worst blood-bath in recent history.



There are no informal get-togethers where people sit together and discuss everyday things under the sun, moon or stars.

An eerie silence engulfs Bikru once the Sun goes down.

It has been almost two and a half months since the Bikru massacre took place in which eight policemen were killed. People in the Bikru village though swear they still hear gunshots in the night. "Aaj bhi goliyon ki awaaz sunai deti hai.

Sab jante hain par bolta koi nahin. Kuchh logon ne to Vikas bhaiyya (Vikas Dubey) ko dekha bhi hain (Even today we hear gunshots.

Everyone knows this but no one talks about it. Some people have even seen Vikas Dubey's ghost," says a young man in the village who

does not wish to be named. The locals claim in hushed tones that they have often 'seen' Vikas Dubey sitting on the ruins of his house that was bulldozed by the government soon after the Bikru massacre on the intervening night of July 2 and 3.

A family living near Vikas Dubey's demolished house, claims to have even heard multiple voices.

"On more than one occasions, we have heard people discussing something though it was not very clear. There was even some laughter in between -- very much like what used to happen in the house when Vikas was alive," said a woman.

There are four policemen -- two men and two women -- posted in Bikru village after the massacre. None of them, on record, admit to

having heard gunshots or 'seen' Vikas Dubey. "We have no problem in doing our duty," said one of them and refused to talk further. A local priest says that the claims of local people cannot be dismissed.

"In cases where unnatural deaths have taken place, such incidents happen. In the case of Vikas Dubey, the cremation was not performed properly and the post death rituals were also not done. The same has happened with his five accomplices who were killed in encounters," he explains. The villagers have asked a local priest to hold a puja during the on-going 'Pitra Paksh' period to appease the 'disturbed souls' but the priest has backed off saying that he does not want to get on to the police radar.

Bills for homeopathy, medicine system passed in Parliament

New Delhi, Sept 14: Parliament has given its nod to two bills that propose a medical education system that improve access to quality and affordable medical education by ensuring availability of adequate and high quality homeopathy and Indian system of medicine professionals across the country.

Lok Sabha Monday passed the National Commission for Homeopathy Bill and the National Commission for Indian System of Medicine Bill. Rajya Sabha had passed them earlier, and the lower house' nod to the two proposed legislations mean that they are set to become laws after getting formal approval from President Ram Nath Kovind. Some opposition members protested against the bill, saying the Centre needed to undertake wider consultation. Health Minister Harsh Vardhan said the proposed laws will help in better administration of homeopathy and Indian system of medicines.

The proposed legislations promote equitable and universal healthcare that encourages community health perspective and make services of such medical professionals accessible to all citizens, the Union government has said.

'OUR LAWS, VALUES DON'T RECOGNISE SAME-SEX MARRIAGE'

New Delhi, Sept 14: The Centre Monday told the Delhi High Court that marriage between same sex couples was "not permissible" as it is not recognised by "our laws, legal system, society and our values".

The submission was made before a bench of Chief Justice D N Patel and Justice Prateek Jalan by Solicitor General (SG) Tushar Mehta during hearing of a PIL seeking a declaration that same sex marriages be recognised under the Hindu Marriage Act (HMA) and Special Marriage Act.

Mehta opposed the relief sought in the petition saying "our laws, our legal system, our society and our values do not recognise a marriage, which is a sacrament, between same sex couples".

He said the plea to grant recognition to or permit registration of such marriages was "not permissible" for two reasons -- firstly, the petition was asking the court to legislate and secondly, any relief granted "would run contrary to various statutory provisions".

"Unless court does violence to various laws, this cannot be done," he added. Mehta also said that under the HMA, the various provisions regulating marriages or prohibited relationships talk of husband and wife and therefore, who would be assigned these roles where a same sex couple was concerned. The bench observed that the world over things were changing, but it may or may not be applicable to India.

It, however, questioned the need for a PIL in the instant case, saying the people who claim to be affected are well educated and can themselves approach the court. "Why should we entertain the PIL," it added.

Nashville (US): A gunman killed two people and wounded three others in a series of shootings and carjackings that ended with a high-speed chase as he fled police. He ultimately wrecked the car he stole and killed himself, while his remaining hostage survived, the Tennessee Bureau of Investigation said. The string of crimes began Sunday morning along Interstate 24 near Beechgrove when Dangelo Dorsey, 29, opened fire inside a moving vehicle, killing one person and wounding another, TBI Director David Rausch said in a news release.

Saudi to lift travel curbs in Jan 2021

Riyadh: Saudi Arabia has announced that it will lift travel restrictions from January 2021. In a statement, the Interior Ministry attributed the delay in lifting the restrictions due to the severe Covid-19 situation in some countries. The Health Ministry said it has the right, according to the situation, to impose certain precautionary measures.

US envoy to China to 'step down'

Beijing: The US ambassador to China will step down early next month, ending a three-year tenure marked by a trade war and increasingly bitter relations between the world's two largest economies. Terry Branstad, appointed by President Donald Trump in 2017, confirmed his decision in a phone call with Trump last week, the US Embassy said in a statement on Monday. It did not give a reason for his departure. Word of his departure leaked out earlier in the day when Secretary of State Mike Pompeo thanked Branstad on Twitter for his service.

Pak summons Indian diplomat

Islamabad: Pakistan Monday summoned a senior diplomat from the Indian High Commission here to register its protest over the alleged ceasefire violations by the Indian forces along the Line of Control (LoC). In a statement, the Foreign Office said that due to "indiscriminate and unprovoked firing" in Hot Spring Sector of the LoC Sunday night, three civilians sustained serious injuries. The Indian side was called upon to respect the 2003 Ceasefire Understanding.

Indian troops displaying newfound boldness: Report

Washington, Sept 14: China's failure to push around the Indian troops in the Line of Actual Control (LAC) means that the ability of Chinese President Xi Jinping to intimidate anyone has reduced.

In an opinion article for Newsweek written by Gordon G Chang, a lawyer and commentator, the Chinese President has risked his future with the failed high-profile incursions of the People's Liberation Army (PLA) into more areas of the LAC, the border between India and China.

The writer says that Xi is the "architect" of these aggressive moves into India and the Chinese troops have unexpectedly flopped.

The failures of the Chinese Army at the LAC will have consequences and will give Xi an excuse to pick up the pace of replacing adversaries in the armed forces with loyal elements.

However, these failures motivate Xi, who as chairman of the Chinese

Communist Party's Central Military Commission, is the leader of the PLA, to renew his bid to launch another offensive against Indian positions.

In June, China and India were engaged in a violent face-off in Galwan Valley. Chinese troops killed 20 Indian soldiers in a premeditated move and the clash was the first deadly confrontation between the two countries in 45 years.

While the Chinese side is thought to have suffered 43 casualties in

the Galwan face-off, the number could exceed 60, according to Paskal.

Late last month, for the first time in a half-century, India launched an offensive against China, taking back strategic points the Chinese recently grabbed. The offensive took the Chinese forces aback and they retreated. Chang, the writer, says that China's subsequent efforts to counter India have proved ineffective. For now, Indian troops, in the southernmost of the three areas of Ladakh, are under its control, which was once in Chinese hands.

"India is not giving the invaders the opportunity to improve. Both sides have just accused the other of violating decades-old rules of engagement by firing warning shots. It appears, however, the Chinese are the ones closer to the truth: India's troops are displaying newfound boldness," the author says.

"The game has changed. You can say the Indians are more aggressive or more aggressively defensive, but they are in fact bolder and better," Paskal told Newsweek.

Winds a worry as death toll reaches 35

Oregon (US), Sept 14: Nearly all the dozens of people reported missing after a devastating blaze in southern Oregon have been accounted for, authorities said over the weekend as crews battled wildfires that have killed at least 35 from California to Washington state.

The flames up and down the West Coast have destroyed neighbourhoods, leaving nothing but charred rubble and burned-out cars, forced tens of thousands to flee and cast a shroud of smoke that has given Seattle, San Francisco and Portland, Oregon, some of the worst air quality in the world.

The smoke filled the air with an acrid metallic smell like pennies and spread to nearby states. While making it difficult to breathe, it helped firefighters by blocking the sun and turning the weather cooler as they tried to get a handle on the blazes, which were slowing in some places.

But warnings of low moisture and strong winds that could fan the flames added urgency to the battle. The so-called red flag warnings stretched from hard-hit southern Oregon to Northern California and extended through Monday evening.

Lexi Soulios, her husband and son were afraid they would have to evacuate for a second time because of the weather. They left their small southern Oregon town of Talent last week when they saw a "big, huge flow of dark smoke coming up," then went past roadblocks Friday to pick through the charred ruins



of their home. While they are staying farther south in Ashland, known for the Oregon Shakespeare Festival, she said by text message that the forecast may mean they could be on the move again.

"So this isn't over yet but we just had the car checked so we feel prepared," Lexi Soulios wrote.

Authorities last week reported as many as 50 people could be missing after a wildfire in the Ashland area. But the Jackson County sheriff's office said late Saturday that four people had died in the blaze and that the number of missing was down to one. At least 10 people have been killed in the past week throughout Oregon. Officials have said more people are missing from other fires, and the number of fatalities is likely to rise, though they have not said how high the toll could go as they search. In California, 24 people have died, and one in Washington state. Thousands of homes and other buildings have burned.

Barbara Rose Bettison, 25, left her farm among the trees and fields of Eagle Creek, outside Portland, when a sheriff's deputy knocked on her door Tuesday. They drove away on a road that became an ominous dividing line, with blue skies on one side and the other filled with black and brown smoke.

Johnson faces rebellion over plan to break Brexit treaty

London, Sept 14: British Prime Minister Boris Johnson will try to persuade rebellious lawmakers in his party to vote Monday for a bill that will break international law by breaching parts of the Brexit divorce deal and which has enraged Brussels.

The House of Commons will debate the Internal Market Bill, which the EU has demanded Johnson scrap by the end of September in the latest brinkmanship of a four-year saga since Britain voted narrowly to leave the bloc.

After the debate, in a vote that may come late, lawmakers will decide if the bill should go to the next stage. Johnson's plan to explicitly break



international law has plunged Brexit back into crisis less than four months before Britain is finally due to leave the EU's orbit at the end of a transition period, and put trade talks with the bloc in peril.

EU diplomats and officials said the bloc could take legal action against Britain, though there would be no resolution before the end-of-year deadline for Britain's full exit.

The EU has ramped up preparations for a no-deal Brexit, which

would be chaotic for business, markets and nearly \$1 trillion in annual trade. The government has dismissed an ultimatum from Brussels to scrap the main parts of the bill by the end of this month.

Johnson, who has a majority of 80 in the lower house of parliament, faces a growing revolt from some of his own lawmakers. All of Britain's living former prime ministers have expressed concern about his plan as have many senior figures in his Conservative Party.

"When the queen's minister gives his word, on her behalf, it should be axiomatic that he will keep it, even if the consequences are unpalatable," Johnson's former Attorney General Geoffrey Cox said in The Times newspaper.

Trump's Mideast deals tout 'peace' where there was never war

Jerusalem, Sept 14: For the first time in more than a quarter-century, a US President will host a signing ceremony between Israelis and Arabs at the White House, billing it as an "historic breakthrough" in a region long known for its stubborn conflicts.

But while the optics of Tuesday's event will evoke the groundbreaking agreements that ended decades of war between Israel and neighbouring Egypt and Jordan, and that launched the peace process with the Palestinians, the reality is quite different.

The United Arab Emirates will establish diplomatic relations with Israel, a fellow US ally it has never

gone to war with, formalising ties that go back several years.

The agreement cements an informal alliance against Iran and could pave the way for the UAE to acquire advanced US weapons, while leaving the far more contentious Israeli-Palestinian conflict as intractable as ever.

That hasn't stopped President Donald Trump from referring to the UAE deal, which was announced last month, as heralding a "previously unthinkable regional transformation."

A similar agreement announced Friday with Bahrain, which welcomed a visiting Israeli Cabinet minister as early as 1994, also formalises longstanding ties.

The agreement with Bahrain



has raised the possibility that Saudi Arabia - the ultimate prize in Israel's normalisation drive - could follow suit.

Bahrain's Sunni monarchy is closely allied with Saudi Arabia,

which helped quash a popular uprising among the island nation's Shiite majority in 2011.

Saudi Arabia has quietly acquiesced to the UAE deal, opening its airspace to commercial flights be-

tween Israel and the Emirates.

But it's debatable whether agreements like these, among already friendly countries, do much to advance regional peace.

The region's main conflict pits Israel and the Gulf Arab countries against Iran and its proxies.

In the long term, many believe the biggest threat to Israel's survival as a Jewish-majority and democratic state is the conflict with the Palestinians, who may soon outnumber Jews in the territory between the Mediterranean Sea and the Jordan River.

The Trump administration hopes that as more Arab countries normalise ties with Israel, it will pressure the Palestinians to return to peace negotiations, which ground

to a halt more than a decade ago.

Over the last three years, Trump has cut off aid to the Palestinians, recognised contested Jerusalem as Israel's capital, dropped the longstanding US opposition to Israeli settlements and released a Mideast plan that overwhelmingly favours Israel.

The breakdown of the longstanding Arab consensus that recognition only be granted in return for territorial concessions has meanwhile left the Palestinians arguably more weak, isolated and demoralised than at any point in their history.

But rather than cowering Palestinian leaders into submission, those moves have only made them more defiant.

Foreign labs confirm Navalny poisoned with Novichok

Berlin, Sept 14: Specialist labs in France and Sweden have confirmed Russian opposition leader Alexei Navalny was poisoned with the Soviet-era nerve agent Novichok, the German government said Monday.

A German military laboratory previously confirmed the substance in his samples. German government spokesman Steffen Seibert said that the Hague-based Organization for the Prohibition of Chemical Weapons has also received samples and is taking steps to have those tested at its reference laboratories.

"Independently of the ongoing examinations by the OPCW, three laboratories have now confirmed independently of one another the proof of a nerve agent of the Novichok group as the cause of Mr. Navalny's poisoning," Seibert said in a statement.



He said Germany had asked France and Sweden for an "independent review" of the German findings using new samples from Navalny.

Navalny, the most visible opponent of Russian President Vladimir Putin, was flown to Germany two days after falling ill August 20 on a domestic flight in Russia. Berlin has demanded that Russia investigate the case.

Seibert Monday renewed Germany's demand that "Russia explain itself" on the matter.

Minister of State for Skill Development and Entrepreneurship R K Singh said that to ensure that skilling fulfils the aspiration of the people at local level.

NVIDIA acquires chip maker Arm

San Francisco: In one of the biggest tech deals, graphics giant NVIDIA has confirmed it is acquiring SoftBank-owned UK chip maker Arm for \$40 billion with an aim to create a premier computing company for the age of artificial intelligence (AI). The deal would consolidate NVIDIA's position at the centre of the semiconductor industry. While it is the leader for GPUs, it has little to do with CPU design or mobile hardware where Arm is one of the leaders.

Markets cave in to late selloff

Mumbai: Equity benchmarks failed to hold on to intra-day gains on Monday as cautious investors trimmed exposure to banking and finance counters despite firm global cues. Positive commentary from HCL Tech lifted IT stocks, but it was not enough to offset the weakness in index majors HDFC twins, Reliance Industries and ICICI Bank. The BSE Sensex opened strong and was on course to register its third straight session of gains, but suddenly came under heavy selling pressure in late-afternoon trade.

MSP will stay, farmers to get investment, tech

New Delhi, Sept 14: The Centre Monday introduced three bill in Lok Sabha on farm sector with Union minister Narendra Singh Tomar asserting that they will help farmers get a remunerative price for their produce as well as private investments and technology.

Agriculture Minister Narendra Singh Tomar introduced The Farmers' Produce Trade And Commerce (Promotion And Facilitation) Bill, The Farmers (Empowerment and Protection) Agreement on Price Assurance and Farm Services Bill and The Essential Commodities (Amendment) Bill, which will replace ordinances promulgated by the government earlier.

He said the proposed laws will enable barrier-free trade in agricultural produce, and also empower farmers to engage with investors of their choice. The minister said that these steps are only the latest in a series of measures taken by the government as part of its continuous commitment to championing the cause of welfare of the farmers of India.

Tomar said that almost 86 per cent of farmers have agricultural land of less than two hectares and they are often unable to benefit from minimum support price (MSPs).

He, however, assured the House that the MSP will stay. The Congress and other parties have been op-



posing the legislations, alleging it will undermine the safety net provided to the farmers by the MSP system and will lead to their exploitation by big companies.

Tomar said the bill will help the farmers as they are unable to invest much in their farm and do not attract investments from others.

He also rejected the criticism that it was beyond the remit of the union government to legislate on these issues, saying opposition members should trust the Centre.

The Opposition has alleged that the Centre brought in the legislations without consulting the states under whose domain 'agriculture' and 'mandis' come.

The minister asked the opposition members to study the content of the bills deeply before running

to oppose them. He stressed that farmers will get a lot of benefit from these laws as they can enter into an agreement with private traders for selling their produce.

These agreements will be about the produce and not the farmland, he asserted, rebutting suggestions that farmers may lose ownership of their land. Opposing the bills, the leader of the Congress in Lok Sabha Adhir Ranjan Chowdhury said constitutional provisions are very clear that agriculture is a subject on the State List.

Such a law can only be brought by state governments... Through this bill, the centre will nullify Agricultural Produce Market Committee (APMC) law enacted by various state governments, Chowdhury said.

Bank credit grows by 5.49%, deposits by 10.92%: RBI data

Mumbai, Sept 14: Bank credit grew 5.49 per cent to ₹102.11 lakh crore, while deposits increased 10.92 per cent to ₹141.76 lakh crore in the fortnight ended August 28, according to RBI data.

In the fortnight ended August 30, 2019, banks' advances were at ₹96.80 lakh crore and deposits stood at ₹127.80 lakh crore.

In the previous fortnight ended August 14, 2020, bank credit and deposits had grown by 5.52 per cent and 11.04 per cent to ₹102.19 lakh crore and ₹140.80 lakh crore, respectively.

On a year-on-year (y-o-y) basis, non-food bank credit grew at 6.7 per cent in July as against a growth of 11.4 per cent in the same month last year, according to the data on sectoral deployment of bank credit for July 2020, released recently by RBI.



Growth in loans to industry slowed to 0.8 per cent in July as compared to 6.1 per cent earlier, the data showed.

Advances to agriculture and allied activities registered a growth of 5.4 per cent in the reporting month as against 6.8 per cent growth in the same period last year.

DOMESTIC FUEL DEMAND RISES



75,621 kilo liters of petrol was sold in August, 2020 as against 87,499 kilo liters in the same month of 2019. However, the demand is rising slowly

Bhubaneswar, Sept 14: Domestic petrol and diesel sales, which had dropped significantly due to the nationwide lockdown, has showed some improvement in August, reports say.

In July, petrol demand decreased by 34 per cent in Bhubaneswar. However, it was down by 13.66 per cent in August, showing some positive uptick in fuel sale.

According to Utkal Petroleum Dealers Association, petrol sale was significantly reduced by 85 per cent due to lockdowns in April.

General Secretary of the association Sanjay Lath said, "Petrol sale was 75,621 kilo liter in August, 2020 as against 87,499 kilo liter sale in same month of 2019. Sale is now slowly increasing in the city."

On other hand, diesel sale went down by 16 per cent in same month. Lath said that over 1,46,993 kilo liter of diesel was sold in August while it was 1,76,209 kilo liter in

same month of 2019.

Earlier, the association claimed that they faced severe losses in April for continual lockdowns. Previous report stated that petrol sales dropped by 85 per cent and diesel 80 per cent in April. Sales drop in petrol caused the industry to lose ₹15.51 crore per day. It also faced loss of ₹1162.2 crore in diesel sale in April. Overall, the dealers faced losses of around ₹1627.5 crore in April due to low consumption.

According to the association around 11, 31,600 liter petrol is being sold per day and 33, 22,000 liter diesel in Odisha. The association has targeted to reach its normal sales which are around 28, 29,000 liters of petrol and 83, 5,000 liters of diesel per day in Odisha.

Meanwhile, petrol and diesel prices dropped again in City. Petrol price was lowered by 14 paisa, Monday, falling down its rate to ₹82.33. Similarly, diesel price stood 79.24 after rate was dropped by 17 paisa.

FDI inflow from China decreases

New Delhi, Sept 14: There has been decline in foreign direct inflow from China in the last three years with FDI coming down to USD 163.77 million in 2019-20, Minister of State for Finance Anurag Singh Thakur informed Lok Sabha Monday.

Giving details of the total foreign direct investment (FDI) inflow from Chinese companies in India, he said, it was USD 350.22 million in 2017-18, while it declined to USD 229 million in the following year.

During 2019-20, FDI further came down to USD 163.77 million, he said in a written reply on the first day of the monsoon session.

With regard to outflow from India, he said, it was USD 20.63 million in calendar year 2020 as against USD 27.57 million in the corresponding period last year.

To curb opportunistic takeovers

or acquisitions of Indian companies due to the current COVID-19 pandemic, the government issued Press Note 3 earlier this year, he said.

A non-resident entity can invest in India, subject to the FDI policy except in those sectors/activities which are prohibited.

"However, an entity of a country, which shares land border with India or where the beneficial owner of an investment into India is situated in or is a citizen of any such country, can invest only under the government route, he said quoting the Press Note 3.

Further, he said, a citizen of Pakistan or an entity incorporated in Pakistan can invest, only under the government route, in sectors/activities other than defence, space, atomic energy and sectors/activities prohibited for foreign investment.

Replying to another question, Thakur said, the Department of Expenditure has released the central share of State Disaster Response Fund (SDRF) to the states including Maharashtra in the first week of April 2020 in the view of the pandemic.

Further, to provide additional resources to states to fight against COVID-19 and considering the request of the states for relaxation of the existing Fiscal Responsibility and Budget Management Act (FRBM) limit of 3 per cent of gross state domestic product (GSDP), additional borrowing limit of up to 2 per cent of GSDP has been allowed to states for the year 2020-21, he said.

The company's market valuation went past ₹9 lakh crore in early trade helped by a rally in its share price. The stock of the software services firm gained 2.91 per cent to ₹2,442.80 -- its record high -- on the BSE. On the NSE, it jumped 2.76 per cent to a lifetime high of ₹2,439.80. Helped by the surge in its share price, the company's market valuation rose to ₹9,14,606.25 crore on the BSE in early trade. It is the second most-valuable domestic firm in terms of market capitalisation.



Ashok Leyland rolls out new LCV range

New Delhi: Hinduja Group flagship Ashok Leyland on Monday said it is looking to expand its presence in the light commercial vehicle (LCV) segment across domestic as well as international markets with the launch of first product based on its all-new platform. COVID-19 pandemic. For meeting expenditure towards recapitalisation of Public Sector Banks through issue of Government Securities the government has asked for Parliament's authorisation of ₹20,000 crore, as per a document. In 2019-20, the government proposed to make ₹70,000 crore capital

infusion into the Public Sector Banks (PSBs) to boost credit for a strong impetus to the economy.

However, the government refrained from committing any capital in the Budget 2020-21 for the PSBs, hoping that the lenders will raise funds from the market depending on the requirements.

ByteDance picks Oracle as partner to save TikTok US

New York, Sept 14: Oracle beat Microsoft in the battle for the U.S. arm of TikTok with a deal structured as a partnership rather than an outright sale to try to navigate geopolitical tensions between Beijing and Washington, people familiar with the matter said.

ByteDance, TikTok's Chinese owner, had been in talks to divest the U.S. business of its hugely popular short-video app to Oracle or a consortium led by Microsoft Corp after U.S. President Donald Trump ordered the sale last month and said he might otherwise shut it down.

While TikTok is best known for dancing videos that go viral among

his first major triumph. "I wish we could have two winners today," Thiem said. "I think we both deserved it."

He is the first man to win the American Grand Slam tournament after trailing 2-0 in sets in the final since Pancho Gonzalez did it against Ted Schroeder in 1949 at an event then known as the US Championships and held in Forest Hills.

The event never had been settled by a fifth-set tie-breaker; no major tournament ever had until Novak Djokovic edged Roger Federer that way at Wimbledon in 2019.

"I was a few games away, a few points away," said Zverev, who was trying to give Germany its first male Grand Slam champion since Boris Becker in the 1990s. "I'm 23 years old. I don't think it's my last chance."

Zverev choked up when he mentioned that his parents hadn't been able to travel to New York because they tested positive for COVID-19, although he said they are now healthy.

As Thiem stepped forward to pose for pictures with his shiny new bit of hardware, Zverev remained a few feet behind, one hand clutching his less-impressive silver tray, the other hand on a hip.

The proceedings took four hours and two minutes. And to think: After just one and half hours, Zverev was up by two sets and a break in the third at 2-1.

"The match turned when he broke me for the first time in the third set," Zverev said. "He started playing much better, and I started playing much worse."

Zverev, of all people, should have known what might have seemed like an impossible hill to climb for Thiem was, indeed, achievable. After all, in Thursday's semifinals, it was Zverev who trailed 2-0 in sets against Pablo Carreno Busta before coming back to win.

Thiem began the day 0-3 in Grand Slam finals, but always faced a member of the Big Three - Federer, Djokovic and Rafa Nadal - of men's tennis in those others.

This time, he was the favorite and came out jittery, but eventually worked his way out of

that, while Zverev went from cool and confident to passive and pushed around.

The fifth set was just as back-and-forth as the other four, the mistakes rising with the tension and the history in the offing.

Thiem broke in the opening game when Zverev shanked a pair of forehands. Zverev broke right back - and pierced the silence with a rare cry of "Come on!" - when Thiem double-faulted.

Then it was Zverev's turn to nose ahead, breaking for a 5-3 lead when Thiem sent a down-the-line backhand wide and leaned over, gasping for air.

But with a chance to serve out the biggest win of his nascent career, Zverev faltered, getting broken right back when he pushed a volley into the net.

That began a three-game run for Thiem, who broke to lead 6-5, earning his own chance to serve for it when Zverev netted a backhand, followed by a long forehand.

After having a trainer check on his right leg during the ensuing changeover, Thiem couldn't seal the deal, either, and on they went to the tie-breaker. Zverev double-faulted twice and offered up one second serve at 68 mph, about half the speed he's capable of.

While this was the No.7-ranked Zverev's first Slam final, this was the first one the No.3-ranked Thiem was supposed to win, following losses to 12-time French Open champion Nadal at Roland Garros in 2018 and 2019, then to eight-time Australian Open champion Djokovic at Melbourne Park this February - back before the pandemic upended the world and put tennis on a five-month hiatus.

Instead of wild applause and loud shouts greeting great exchanges, the soundtrack Sunday mainly came from outside the largest court in tennis, courtesy of roaring airplanes, rumbling trains, revving car engines, honking horns and wailing sirens.

There was the occasional polite applause from the dozens of tournament workers allowed in the stands - and, deep into the match, yells from the players' entourages.

But the louder crowd noise heard by TV viewers was fake, added by the broadcaster:

England turn tides on unfortunate Oz

Manchester, Sept 14: Australia batted themselves into a winning position before dramatically collapsing as England won the second ODI by 24 runs to stay alive in the series.

England's decision to bat first at Old Trafford had appeared to backfire with the World Champions limited to 231/9 and Australia reaching 143/2 with 20 overs left Sunday. Australia were making the run chase look easy thanks to a 107-run stand for the third wicket between captain Aaron Finch (73) and Marnus Labuschagne (48). But the tourists then collapsed to 147/6, and 166/8, here before finishing 207 all out in 48.4 overs.

A trio of England pacers - Chris Woakes (3/32), Jofra Archer (3/34) and Sam Curran (3/35) - did the damage. In what has become an unwanted tour tradition for Australia, Archer again claimed opener David Warner (6).

Earlier, no England batsman reached 50, with Morgan (42) and Joe Root (39) leading the scoring. Both men were dismissed by leg-spinner Adam Zampa (3/36). Morgan was dismissed lbw after Finch opted to review the original not out decision, leaving England on 117/5 in the 29th over.

No.9 Tom Curran (37) and No.10 Adil Rashid (35) came to England's rescue, sharing 76 for the ninth wicket in what would prove to be a decisive partnership.

Australia were aiming to wrap up a series victory after beating England by 19 runs in the first ODI last Friday, also in Manchester.

The series finale is at the same venue Wednesday, when England will be hoping to avoid their first ODI series defeat at home since 2015.

There were times in both innings when Morgan's lineup was struggling - reduced to 149/8 in the first innings, then seemingly batted out of contention by Finch and Labuschagne.

The defeat a real punch in the guts of Aussies: Warne

Manchester: The 24-run loss to England in the low-scoring second ODI here must have been a 'real punch in the guts' for Australia, says spin legend Shane Warne. "Australia hadn't played cricket for quite a long time so you sort of excuse them (that collapse) in the first T20, even though it cost them that series," Warne told 'Sky Sports', referring to the first T20 where Australia slumped from 124/2 to 148/6 to lose the game by two runs. "They have been pretty good since then but this will be a real punch in the guts for Australia. They pride themselves on getting over the line in those sorts of games and doing the basics well. 'They didn't do that - they weren't good enough, with Aaron Finch the only batsman to really show any touch. It's 1-1 ahead of the last day of the international summer. Who writes these scripts?' From 149/8, England went on to make 231/9. 'Australia got it a bit wrong. They tried to go for wickets and didn't sum up conditions and think 'hard length at the stumps is tough for the batsmen so it should be the same for the tail'. They got a bit greedy trying to knock them over,' Warne said.

New York, Sept 14: A US Open unlike any other finished unlike any other - with an unprecedented fifth-set tie-breaker as Dominic Thiem became the first man in 71 years to win the final after dropping the opening two sets.

So close to defeat in a nearly empty Arthur Ashe Stadium - fans were banned because of the coronavirus pandemic - Thiem slowly but surely turned things around against a faltering Alexander Zverev and pulled out a 2-6, 4-6, 6-4, 6-3, 7-6(8-6) victory at Flushing Meadows for his first Grand Slam title.

The match ended with both men fighting leg cramps and, clearly, nerves. "Somehow," said Thiem, a 27-year-old from Austria, "the belief today was stronger than the body, and I'm super happy about that."

When a backhand from Zverev landed wide on the third championship point, a weary Thiem dropped to his back way behind the baseline and covered his face with his hands.

When he arose, he was met by Zverev, who walked around the net to clasp hands, then embrace his friend and foe, two sights rarely seen in this era of social distancing.

Thiem then rested his head on the shoulder of the taller Zverev, who himself came within two points of what would have been

Paris, Sept 14: Neymar was among five players sent off in stoppage time as Marseille beat bitter rival Paris Saint-Germain for the first time in nine years. PSG star Neymar got a straight red in Marseille's 1-0 win following an altercation with center half Alvaro Gonzalez Sunday.

Neymar was sent off following a video replay showing he aimed a jab to the back of Gonzalez's head. As he went off, Neymar told officials that he had been racially abused.

With apparent reference to Gonzalez, Neymar later tweeted: "The only regret I have is not hitting the face of this idiot." In a later tweet, Neymar said "It is easy for the VAR (video review) to see

my 'aggression'" and added he was subjected to offensive insults of a racist nature.

Winger Florian Thauvin scored in the 31st minute of a tense game featuring more than a dozen yellow cards and which descended into chaos deep into stoppage time as punches and kicks were exchanged.

It was Marseille's first victory over PSG since a 3-0 home win in November 2011. PSG have now lost three straight games 1-0, including the Champions League final against Bayern Munich August 23 and away to promoted Lens last Thursday.

PSG lost their opening two league games for the first time since the 1984-85 season and Tuchel may find himself under early pressure.

Everton stun Tottenham

London: Everton justified the pre-season optimism as Dominic Calvert-Lewin's header earned them an impressive 1-0 win at Tottenham Hotspur in their Premier League opener Sunday - the Merseyside club's first win over Spurs since 2012. Carlo Ancelotti's side arrived buoyed by the midweek signing of Colombian playmaker James Rodriguez. After an even first half in which Richarlison wasted a great chance for Everton and keeper Jordan Pickford denied Tottenham's debutant Matt Doherty, Everton bossed the second period. Once Calvert-Lewin sent an unstoppable header past Hugo Lloris in the 55th minute, meeting Lucas Digne's free-kick to perfection, Tottenham huffed and puffed but offered little.

Valencia win derby in La Liga

Madrid: Valencia twice came from behind to beat rivals Levante 4-2 in a thrilling city derby Sunday to make a winning start to the new La Liga season. Jose Luis Morales scored twice either side of Gabriel Paulista's goal for Valencia. Maxi Gomez equalised before halftime while Manu Vallejo put Valencia ahead before sealing the points with a second strike in stoppage time.

Bayern offer free virus tests to fans

Munich: Bayern Munich have offered free coronavirus tests to fans with tickets for next week's Super Cup in Hungary. The Hungarian authorities require fans arriving for the traditional European season opener to have a certified negative result from a recent test for the virus before they are allowed into the country. The club says 3,000 Bayern fans with tickets for the game can be tested September 21 and 22 at a parking lot next to the stadium.

Sharma finishes 44th

Vilamoura: Indian golfer Shubhankar Sharma once again allowed his gains to go waste with a bunch of bogeys as he carded an even par 71 in the final round to finish Tied-44th at the Portugal Masters here. The 24-year-old Indian, going through one of the worst patches of his professional career, had four birdies, three of them in four holes between 11th and 14th, but gave them all away with four bogeys, two of which came on 16th and 17th holes. South African George Coetzee displayed superb short game to card his third card of 66 in four days to hold off a strong chasing pack and win the 2020 Portugal Masters by two shots. It was his fifth European Tour title.

OFC rope in Onwu for a 1-year deal

Hamilton claims crash-marred Tuscan GP

Mugello, Sept 13: Lewis Hamilton won a hectic Tuscan Grand Prix Sunday to clinch his 90th Formula One win and move one behind Michael Schumacher's record.

The first F1 race on a Mugello track with super-fast corners usually used by MotoGP riders was incident-packed throughout. Two crashes on the first seven laps saw six drivers go out, and a red flag suspended the race for the first time after the second one.

A second red flag late on following Lance Stroll's heavy crash meant another grid restart - on Lap 46 of 59 - and gave Valtteri Bottas another chance to beat race leader Hamilton if he made a strong start from second.



Hamilton held firm and Renault's Daniel Ricciardo overtook Bottas, who passed him back to finish second but is now 55 points behind Hamilton in the title race.

Bottas pushed hard and got to within 1.1 seconds of Hamilton on the penultimate lap but the British driver clocked a fastest lap on the

Mugello: Lewis Hamilton faces an FIA investigation for wearing a 'political' T-shirt at Sunday's Tuscan Grand Prix. The World Champion sported the slogan, 'Arrest the cops who killed Breonna Taylor', referring to a 26-year-old medical technician in Louisville, Kentucky, who was fatally shot after her boyfriend opened fire on police during a drugs search at their house March 13. Hamilton wore the shirt during the 'taking a knee' ceremony and on the podium as God Save the Queen played to celebrate his 90th career win. The Kentucky Attorney General is still investigating the killing, which has led to riots in America, so Hamilton's intervention is seen by several senior F1 figures as being potentially 'political'. FIA statutes forbid political statements of any kind.
