BrahMos tested from Navy's stealth destroyer

New Delhi: India successfully test fires BrahMos supersonic cruise missile from Indian Navy's stealth destroyer Sunday. "BrahMos, the supersonic cruise missile was successfully test fired today on 18th October 2020 from Indian Navy's indigenously-built stealth destroyer INS Chennai, hitting a target in the Arabian Sea," the Defence Research and Development Organisation (DRDO) said in a statement. The missile hit the target successfully with pin-point accuracy after performing high-level and extremely complex manoeuvres. BrahMos as 'prime strike weapon' will ensure the warship's invincibility by engaging naval surface targets at long ranges, thus making the destroyer another lethal platform of Indian Navy.

SUBARNAREKHA CHANGING COURSE

THE RIVER, OFTEN CALLED THE WOE OF BALIAPAL, PLAYS HAVOC IN THIS COASTAL POCKET, BRINGING MISERIES TO THE LOCAL RESIDENTS FOR DAYS TOGETHER

Baliapal, Oct 18: The Subarnarekha river is called the woe of Baliapal in Balasore. Every monsoon, the river plays havoc in this coastal pocket. bringing miseries to the local residents for days together.

Another problem faced by people of some riparian villages is that the river has been changing its course over the years. They are scared as with every spell of rain the river devours a portion of their habitats.

Erosion of river bank is causing havoc in Chada, Kudamansigh, Manonagar, Rasalpur, Nayabali, Routraypur, Kankadapal, Kulhabada and Kulha villages where residential as well and farm lands have been devoured by the river in the past.

The Subarnarekha poses more danger to Kulhabada and Kulha in Jamkunda panchayat even as stone packing along the banks has collapsed. Large parts of villages are fast disappearing into the river, which biting off chunks of land at an alarming rate on both sides, locals said.

During the past two decades, Subarnarekha has been posing a serious threat to Bhogarai and Jaleswar blocks too. Though at some places, its bank has been reinforced with boulders and metal to prevent erosion, the river has started eating into other areas. they pointed out. This year, the river has eroded two meter along its bank at Kulhabada, while stretches of farmlands already become a part of the river.

Locals lamented that the rate at which the river is eroding into its banks, major villages like Kulha and Kulhabada and farmlands will be gobbled up in a few years.

Locals said that these villages are slowly but steadily losing their land. The villages face the threat of getting washed away completely if no protective measure is taken urgently.

Erosion has also been a problem for other riparian villages like Baunsakhanda, Pantei, Kumbhiragadi, Adanga, Sekhabad, Gobarghata, Mankidia, Gobardhanpur, Baiganbadia, Kirtania, Kantapal, Mohammadpur, Asti, Badhapal, Bishnupur, Ramnagar, Rasulpur, Gopalpur, Pathurighata, Rajpur, Mankidia, Bagada, Talabarei,

Kasaphal, Panta and Parikhi.

Residents of these villages have demanded that stone packing of the river banks has become necessary to protect these villages.

Last year, the Irrigation department had floated a tender worth ₹40 lakh for stone packing. Although the work was taken up, it was stopped after some time for reasons unknown.

"Work is botched up as some parts of the stone packing have already disappeared into the river," the locals said.

They sought to know the reason for which the department has abandoned the stone packing work halfway and pointed out that if stone packing is not carried out immediately, the situation in the riparian villages will worsen.

Heavy rains forecast for next four days

BHUBANESWAR: The Bhubaneswar Meteorological Department Sunday issued warning of heavy rains in different parts of the state for the next four days in the light of development of low pressure area in the sea.

The department predicted that the impact of the low pressure could be felt between October 19 and 22.

"Likely formation of low pressure over East-central Bay of Bengal may result in squally weather (wind speed reaching 40-50 kmph) over central Bay of Bengal during October 19-22, 2020,' the department said in a statement.

It said that Monday might see heavy rainfall at one or two places over the southern districts of Odisha including Malkangiri, Koraput, Rayagada, Gajapati and Ganjam. On the other hand, light to moderate rain is anticipated at many places in south coastal Odisha.

The department, however, has issued warning of heavy to very heavy rainfall Tuesday and issued an Orange Warning accordingly. Talking about Tuesday, the department said, "Heavy to very heavy rainfall very likely to occur at one or two places over the districts of Gajapati and Ganjam."The department said that heavy rainfall is very likely to occur at one or two places over Malkangiri, Koraput, Rayagada and Puri Tuesday.

Macon (US), October, Oct 18: President Donald Trump is fighting to recover from sinking election polls by campaigning with a hardline pitch to America's right wing, claiming that his Democratic opponent Joe Biden would deliver communism and a "flood" of criminal immigrants.

He also seemed to acknowledge things might not go his way in the end. Running against the worst candidate in the history of presidential politics puts pressure on me. Could you imagine if I lose?" Trump mused.

"What am I gonna do?," he continued. "I'm not gonna feel so good. Maybe I'll have to leave the country. I don't know.'

While Trump put on a brave face, the fact that he was

southern states he won four years ago illustrated how much ground he has to make up against Biden in the 18 days left until the election. 'Second wave of Covid not ruled out'

NEW DELHI: The number of new coronavirus cases and deaths has declined in the last three weeks as the spread of the pandemic has stabilised in most of the states, Niti Aayog Member VK Paul said Sunday but did not rule out the possibility of a second wave of infections in the winter season. Paul, who is also the chief of an expert panel coordinating efforts to tackle the pandemic in the country, said that once the Covid-19 vaccine is available, there will be enough resources to deliver as well as make it accessible to citizens. On whether India could see a second wave of coronavirus infections in the winter, Paul said that with the onset of winter, countries across Europe are seeing resurgence of Covid-19 cases. "We cannot rule out (a second coronavirus wave this winter in India). Things can happen and we are still learning about the virus," Paul noted.

To this, the minister responded, "In different pockets across various states, including West Bengal, community transmission is expected to occur, especially in dense areas. However, this is not happening across the country. It is limited to certain districts occurring in limited states.

The admission comes after months of denial. This is the first time that the health minister has acknowledged the community transmission

Earlier this week, Banerjee had urged people of West Bengal to maintain caution ahead of the upcoming Durga Puja season.

"I ask everybody to follow the Covid-19 safety protocols during the festive season. There are instances of community transmission of Covid-19 and also the contagion becoming airborne,' Banerjee was quoted saying. In July, the Ministry of Health and

Family Welfare had released a guidance document which had inadvertently revealed that community transmission happened in India as early as April.

The document was later taken down from the website of the Union Health Ministry.

PLA prepares for possible invasion of Taiwan: Report

Washington, Oct 18: The presence of the People's Liberation Army is increasing in China's southeast coast as it prepares for a possible military invasion of Taiwan, according to the defense observers cited by the South China Morning Post.

According to the sources, Beijing is replacing its old DF-11s and DF-15s and deploying its most advanced hypersonic missile DF-17 in the region.

"The DF-17 hypersonic missile will gradually replace the old DF-11s and DF-15s that were deployed in the southeast region for decades," the source was quoted by SCMP.

"The new missile has a longer range and is able to hit targets more accurately."

Even though Taiwan has never been controlled by China's ruling party, Chinese authorities insist that the self-governing island is an integral part of their territory, with president Xi Jinping refusing to rule out a military force to capture it if necessary.

According to the Canada-based Kanwa Defence Review, satellite images show that both the Marine Corps and Rocket Force bases in Fujian and Guangdong have expanded.

"Every rocket force brigade in Fujian and Guangdong is now fully equipped," the report said.

No. of calls to 104 Helpline dips, query type also changes

THE FREQUENCY OF CALLS HAS COME DOWN TO ALMOST ONE THIRD OF WHAT IT USED TO RECEIVE AT THE BEGINNING OF THE PANDEMIC

Bhubaneswar, Oct 18: After combating Covid-19 for months, the number of calls made to the 104 Helpline in the state by anxious people and patients as well as their caregivers also declined steadily.

Officials entrusted with the task of managing the calls to the Covid Helpline and tracking them claimed that the frequency of calls has come down to almost one third of what it used to receive at the beginning of the pandemic (during March and April this year).

"When Covid-19 had just started spreading in Odisha, we received up to 16,000 calls to 104 Helpline. Eight months down the line, the

numbers have dipped and now we are seeing around 6,000 calls per day," said Sabyasachi Biswal, state head of Ziqitza Healthcare Pvt Ltd, which manages the call centre for the 104 Helpline, told Orissa POST

He said that the before the onset of Covid pandemic in state, the 104 Helpline had 40 employees, which was increased to 150 by the state government when the number of queries increased and the number of cases spiraled in the state.

Helpline executives, who have handled the phone calls during the last eight months, claimed that the types of queries have also changed with time. "In the beginning, people were anxious to know about

tion, medical advice and test refidence to fight the disease," ports, besides registering their grievances on Covid treatment,' said Debi Prasad, a call centre executive from 104 Helpline. call the helpline requesting vehi-

The service provider told this reporter that the team has welltrained staff to answer the queries of the callers. The helpline works around the clock and also comprises 22 doctors and counselors to answer the queries and also pacify panicked patients and their relatives.

"We have counsellors who brief the patients and their caregivers about the line of treatment for people who tests positive to the virus. The counsellors also try to pacify their anxiety and boost their con-

Bhubaneswar. Oct 18: Odisha's novel coronavirus disease (Covid-19) tally mounted to 2,68,364 Sunday as 2,019 more people tested positive for the infection. Fourteen fresh fatalities pushed the state's coronavirus death toll to 1,135, an official of Health and Family Welfare (H&FW) department said.

As many as 1,168 new cases were reported in quarantine centres, while 851 infections were detected during contact tracing, said the official

Khurda district, under which Bhubaneswar falls, reported the highest number of new coronavirus cases at 283, followed by Cuttack (150), Angul (129) and Mayurbhanj (111), added the official.

Four fresh fatalities were reported in Khurda, two each in Cuttack and Jagatsinghpur, and one each in Mayurbhanj, Puri, Dhenkanal, Kandhamal, Bolangir and Sambalpur districts, said the official. Ganjam district has so far reported the highest number of coronavirus fatalities at 225, followed by Khurda (195) and Cuttack

Irregularities alleged in sattu distribution; Vig probe sought

Puri, Oct 18: Poor quality sattu (food supplement) is being provided to pregnant women and Anganwadi children in Puri district, alleged voluntary outfit Sachetan Nagarik Manch at a press conference here Sunday.

The outfit claimed that the authorities concerned are vet to take any step to check irregularities in the sattu distribution despite receiving repeated complaints in this regard.

Members of the outfit sought a Vigilance probe into the irregularities in sattu distribution in the district. They alleged the involvement of a clerical staffer and some other officials of the district administration in the poor quality food supplement distribution among pregnant and lactating women and Anganwadi children.

"We have lodged complaints in this regard with the Governor, Women and Child Development Minister and Vigilance SP, Bhubaneswar, but no step has been taken on the issue. We will be forced to launch an agitation and approach the court if immediate steps are not



taken to initiate a Vigilance probe into the poor sattu issue," said Sachetan Nagarik Manch president Prasanna Dash. Dash claimed that Puri district

has altogether 2,599 Anganwadi centres, including 80 in the Holy City. These Anganwadi centres usually distribute sattu and other food supplements among children up to six years and pregnant and lactating women.

"The authorities concerned are sourcing poor quality sattu from a particular women self-help group (SHG) without inviting any tender for the purpose. A clerical staffer of the district administration collects commission from the SHG and distributes the money among some dishonest officials and politicians," alleged members

Bhubaneswar, Oct 18: While the beauty of birds addresses our aesthetic sensibility and creates love for them, it's important to love them for more than just their pulchritude, experts opined at a webinar conducted in view of ecology conservation. "Everybody should nurture love

for birds as it can go a long way to protect nature and ensure species diversity," said Gargi Mishra, a bird enthusiast and expert. The webinar titled 'Birds of Mahanadi'

is part of the 'Human & Ecology Conversation Series' being organised by Mahanadi River Waterkeeper, Water Initiatives & FES.

Gargi, in conversation with Ranjan Panda of Water Initiative, discussed on the importance of being a bird enthusiast in conservation of rivers and other wetlands and biodiversity.

Keeping in line with the design of this conversation series, Gargi narrated, "Being a city-dweller, I never

thought of being in an intimate relationship with birds. But, as we have planted as much trees as possible in our balcony garden in Delhi, birds started visiting it. We kept food grains and water for the winged guests and they became our regular visitors. "As a baby, my daughter fell in love with them. As she grew up, her love for the species too grew and so did mine," she added.

Scientifically speaking, birds are very important in maintaining the

health of rivers and other wetlands. While they help keep the water clean, they also keep the crop fields healthy by preying on insects that would otherwise have destroyed the crops. "Birds are also scavengers and help our surroundings clean. However, we are exposing them to serious pollution," said Ranjan Panda, an environment activist. Our wetlands are shrinking at an alarming rate and that is not at all a healthy sign, he lamented further.

Gargi added that if we wished to protect this avian diversity, we need to protect their habitats. "Pollution of rivers, water bodies and other areas is posing a great threat to the survival of these species." Besides industrial pollution and urban wastes, micro-plastic pollution is emerging as a huge problem for our birds, warned Gargi. She further said that about 150 bird species have gone extinct just in the last decade and that is no good news. All of us, especially the young generation need to develop the hobby of bird watching so that they can explore their values for our own survival further, added Ranjan.

LIFE CONFINED IN A STRAITJACKET

Tribal families have been struggling over the years sans basic amenities at Marshalguda village in Kalimela block of Malkangiri district

Malkangiri, Oct 18: Seventy-four years have passed since Independence but there are villages in Malkangiri district where development remains a distant dream.

Marshalguda village tucked away amid forests in Pusuguda panchayat under Kalimela block is a case in point. Inhabitants of this village comprising 20 tribal families have been struggling over the years sans basic amenities. For the villagers, the life has been something like being confined in a straitjacket.

The picture of neglect is quite visible from a narrow foot track, that meanders between outcrops and through dense forests upto this remote village. People carrying loads on heads and bicycles trying to negotiate with the narrow foot track between the crags is a routine scene here.

It was learnt that about 16 tribal organisations had staged protests in the past, seeking steps for the development of their areas, life, livelihood, and rights on water, forest and land, but most of them are still living in deprivation.

"Many of our basic problems have not been resolved till date, even though we have been drawing the at-

tention of the state and central governments. We are suffering in the absence of basic facilities like road. drinking water, educational institutions," the villagers lamented.

They alleged that the backwardness is visible everywhere in the village while welfare and social security schemes are out of their bounds

In the monsoon, life is completely paralysed when they have to face miseries caused by two creeks that overflow out into the entire areas. Commuting goes for a toss while patients needing emergency healthcare are carried on cots on slippery and muddy tracks before crossing the two creeks on way to a remote hospital, they pointed out.

"We have to come out of the village to the panchavat office and Malkangiri-Motu road for routine work," they added.

"We have neither a school nor an Anganwadi centre for our kids. About 30 children of our village trek through forests to an Anganwadi centre and a school in another village, about 3 km away. Kids have to get education anyway. It is also risky affair for kids to go to a distant school. The government has not yet thought of set-

ting up a school in the village," they rued.

The village doesn't even have a tube well. Given such a situation. people are bound to consume contaminated water of creeks.

The BDO was not available for comment.

Block chairperson Mala Madhi said. "Earlier. Pusuguda was under Padia block. It was brought under the Kalimela block a few years ago. We will look into the problems of the village and take steps immediately.'

Season of gloom

he season of festivals is a season of joy. This year, Covid-19 pandemic is spreading a shadow over this season - a gloom for the first time in living memory. A total curb on these festivals is unimaginable but public activities will need to be restrained in view of the social distancing norms now prevalent across the world. Other countries, most of them in Europe, have started preparations for a second wave of the virus. Urban centers of France and Italy have already restarted lockdowns while Britain has been toying with ideas of shutdowns.

An Indian government panel has cautioned against any relaxation in safety protocols during the festival season, saying this could result in a major spike. The chill of the winter itself might help the virus spread. A dire warning is that worse comes to worse, it could be some 26 lakh cases in a month's time, while infection figure so far totals at 75 lakh and deaths of 1.14 lakh. The end of the festival season and the chimes of the New Year could also signal the start of a new phase in Covid spike while control through a set of vaccines arriving in the market seems very doubtful. The Russians with their vaccine Sputnik have most probably chosen India as human trial country. The eagerness of the people to take it and the desperation of the Union government, coupled together, may spell disaster for us all.

The season starting from August spread over autumn and winter is thick with some religious spirit while devotion is far away. Principal among them, the Durga Puja and the Navratri, is spread over nine nights normally of high action. This and Kali Puja are more prominent in the eastern part of the country while the Ganesh festival set in August-September has its normal focus on the western region. All these are generally marked by massive and feverish street shows. So is Christmas, by end December, marked by Carol singing, church gatherings and midnight mass. This time, all these must be planned small-scale and it is imperative that safety aspects should triumph over these religious concerns.

This kind of caution may not seem or sound sensible to certain types of people. The US has seen No Maskers agitating against wearing of masks. Resultant high death rates in America was for the whole world to see. President Trump was seen as a champion of No Maskers by his supporters. Similarly, the Governor of Maharashtra, Bhagat Singh Koshyari, writing to Chief Minister Uddhav Thackeray, has expressed cynical surprise that while the leader of the Shiv Sena used to vouch in the name of Hindutva yet, as CM he is unwilling to permit re-opening of temples for prayers across the state. CM Thackeray has brilliantly replied back to the Governor saying he does not require any certificates from anyone about his beliefs and credentials but he is responsible for the well being of the citizens of his state. Like Trump confusing facts and misguiding Americans on how to handle the disease, we also have, amongst us, a constitutional post holder as a Governor who is capable of suggesting wrong actions to the government.

What Amartya studied

n the season of Nobel Prize declarations, what arouses curiosity is of a Mathematics book studied by Amartya Sen, winner of Nobel in Economics in 1998. The official handle for Nobel Prize shared a picture of Lilavati, a treatise on Mathematics in Sanskrit written in Year 1150 by Bhaskara ll in the form of a book named after his daughter. A marvel in lessons, theories, and solving mathematical problems, equations and combinations, the book is often cited as an example of the depths to which knowledge in ancient India was pursued. Little attention is paid to such books by the present generations of the academic community. A reason could also be that not many know Sanskrit, a dead language primarily because of its complexity and difficulty for the ordinary person to grasp it. Its learning requires a humongous amount of time and hard work, which, for the new generation may not prove valuable in enhancing skills and abilities

Sadly in India, researchers, scientists and students of higher studies are rarely encouraged. Education for most Indians culminates in a job where work load is negligible. It may be because of such an environment that people like Amartya Sen and Abhijit Vinayak Banerjee, among the few Nobel Laureates born in India have their academic and research base now in the West. Indian conditions rarely accord the right climate to such brains to make a mark or prove themselves.

resident Donald Trump and his National Security Adviser, Robert C. O'Brien are aching to announce troop withdrawal from Afghanistan as a last-minute sweetener for the American voter, rather like floral touches in an Indian wedding. General Mark A Milley, Chairman of the Joint Chiefs of Staff, is probably looking at life beyond Trump, unless there is a Second Coming. America." The fragility of the agreement is transparent in the pulls and counter-pulls that have obviously gone into the headline. There is unbridgeable distance on Afghan President Ashraf Ghani's role, for instance. The Taliban will not talk to Ghani whom they describe quite brazenly as a US 'toady."

Ghani deludes himself if he imagines he is being 'firm.' He is coming across to the world at large as a leader with a very thick skin. New Delhi wishes to keep appearances. In the trapeze act, South Block does not wish to be seen loosening the clasp of Ghani's hand mid-air. The zero sum game with Pakistan may operate as a factor but, in deference to realism, this is not a defining one.

If New Delhi is seen to be digging in for Ghani, it will only find itself embarrassed down the line because it is clear as daylight that intra Afghan talks will not move unless Ghani steps aside. By visiting Islamabad and New Delhi. Abdullah Abdullah is positioning himself to step in as soon as the opportunity arises. This is not a process that is likely to reach fruition before the end of the year. So, no confetti on election eve.

One of the advantages the US extracts from its position of being a superpower is to keep making mistakes almost willfully without any fear of being called to account. It is almost a forgotten story that in December 2001. NATO helped by Russia, Iran, India and the Northern Alliance headquartered in the Panjshir valley defeated Taliban and Al Qaeda.

Panjshir was also the operational headquarters for the Tajik hero Ahmad Shah Masoud. So strong was Masoud's opposition to the Taliban and Al Qaeda that he travelled extensively to acquaint various international fora of the danger that Al Qaeda and Taliban posed to Afghanistan. His address to the European Parliament in the summer of 2001, months before 9/11 was historic by any yardstick. Complete silence on this speech of Masoud is surprising. His forces had picked up chatter about a possible Al Qaeda action in the

American mainland. He was speak ing in Brussels. On September 9, precisely two days before September 11 (9/11), two Arabs, disguised as journalists, visited him in his hideout near the Tajik border for an interview. Their passports, it was revealed much later, had been forged in Brussels. These 'journalists,' while saying goodbye to Masoud, detonated their vests. All three died instantly Two days later, the twin towers came down in New York. Is there nothing here that deserves investigation?

Maybe not before the US elections, but is the curtain is about to be brought down on US involvement? Whether Trump or Joe Biden win the election, China, Russia. Iran are likely to remain America's adversarial concerns.

A little over a year ago, just when US military involvement in Syria was winding down, one common chatter was about Jabhat al Nusra and its variants being flown to newer theatres of ac tion. Russia's deputy minister of foreign affairs Morgulov Igor Vladimirovich told a high powered conference in New Delhi, with Zalmay Khalilzad in attendance, that militants were being flown from Syria to Northern Afghanistan. The allegation fitted neatly into the thesis that militants, trained to kill, cannot be sent to the slaughterhouse. Ullage

his is most commonly encountered as a technical word of the beverage technologist, the wine merchant or publican, meaning the unfilled space in a barrel or wine bottle. The word comes ultimately from the Latin oculus, an eve, used in a figurative sense by the Romans for the bung hole of a barrel. In the medieval period, this was taken into French as oeil, from which a verb ouiller was created, to fill a barrel up to the bung hole. (When wine ferments in the barrel, there's a slow loss of liquid due to evaporation through the wood. It's important to keep the barrels full, as otherwise undesirable bacteria and yeasts can get in and cause unwanted side fermentations.) In turn, a noun ouillage was created, which was the immediate source of our word, first recorded in Norman English about 1300, at first in the sense of the amount of liquid needed to fill a barrel up to the bung hole. By an obvious extension, ullage came to refer to any amount by which a barrel is unfilled, perhaps because some of the contents have been used. The word has been transferred into the vocabulary of rocket scientists to mean much the same: the unfilled space at the top of liquid fuel tanks, left to permit the fuel to expand with changes in temperature. The space between the top of the propellant load and the top of the tank is known as ullage space.

Ultimo

Itimo means last month. Together with instant (the current month) and proximo (next month) it's an example of an outdated commercial language. Few businessmen would today begin a letter "With reference to yours of the 14th ultimo," or "yours of the 23rd instant," or "Please attend this office for interview on the 11th proximo," but it was once standard and taught in the best books. All three were commonly abbreviated, to ult, inst and prox respectively. Ultimo and proximo are both Latin, shortened forms of ultimomense, in the previous month, and proximomense, in the next month. Many reference works say inst is from Latin instantemense, in the current month. But the Oxford English Dictionary points out that it has always been expanded to the English word instant, in the specialised meaning of current.

Nagpur, Oct 18: The number of road accidents in Maharashtra has come down in the last three years with the help of its 'intelligent traffic management system' and steps taken to check over-speeding, as per the state highway police.

Last year, the state recorded a drop of 8.47 per cent in all road accidents and fatalities also came down by 3.56 per cent, according to statistics of the highway police.

The state recorded 39.878 road accidents in 2016, and the number dropped to 36,056 in 2017, 35,717 in 2018 and 32,925 in 2019, as per the data.

The data showed that 'without injury accidents' also decreased in the state in the last three years.

A total of 6,271 without injury accidents were recorded in the state in 2016 and the figure came down to 3,568 in 2019, a record drop of 43.10 per cent.

The state recorded 11,787 fatal accidents last year as compared to 12,098 in 2018, a drop of 2.57 per cent. The road fatalities also came down from 13.648 in 2018 to 12.788 last year, a decrease of 3.56 per cent.



In 2016, a total of 12,935 people were killed in 11,780 fatal accidents, while 12,511 people were killed in 11,454 fatal accidents in 2017, as per the data.

A senior Maharashtra highway police official told PTI that the drop in number of road accidents was the result of efforts taken by the highway and state police over the years.

The Mumbai-Pune Expressway, and Pune, Solapur, Ahmednagar and Nashik districts have been contributing around 30 per cent of the road accidents in Maharashtra, he said.

"The highway police had introduced the intelligent traffic management system on the Mumbai-

Pune Expressway. As a result, the number fatal accidents reduced on the expressway from 96 in 2018 to 74 last year," he said.

Similarly, fatalities on this expressway also came down to 92 last year as compared to 110 in 2018, he said.

The official further said the number of 'black spots' also reduced to 1,000 from 1,050 with corrective measures taken by the highway police.

"This helped the police in making roads safer for users," he said. 'Black spots' are the spots where

Hyderabad, Oct 18: A fresh spell of overnight incessant rains caused flooding Sunday in parts of the city and left a girl dead, days after it witnessed one of the worst deluges following the heaviest downpour in over a century, police and civic officials said.

The latest rains since Saturday evening led to lakes and other water bodies overflowing and triggering flooding of several low-lying areas, including places affected last week, here and on the outskirts, they said.

The Disaster Response Force personnel, the staff of the Greater Hyderabad Municipal Corporation and police swung into action since Saturday night itself, evacuating the marooned. In a near repeat of scenes witnessed last week, basements of several apartment com-



plexes were flooded by the rain waters and people were seen walking in knee deep water in some areas. A video showed some auto-rick-

shaws getting washed away in a flooded street. The Met office forecast more rains in parts of the state till October 21.

Heavy rains early last week had wreaked havoc in parts of the state, including the city, claiming over 50 lives in incidents such as house collapse and drowning and leaving hundreds of houses in lowlying areas under sheets of water.

However, since Saturday night several parts of the city and neighbouring districts again were battered by torrential rains with Saroornagar in adjoining Rangaraddy district recording the maximum of 16.9 cm while Hyderabad Airport 7.2 cm.

The BJP's three retiring MPs - Civil Aviation and Urban Affairs Minister Hardeep Singh Puri, general secretary Arun Singh and Neeraj Shekhar who

resigned from the SP to join the BJP are looking for being renominated. Adityanath is also keen to send some of his favourites to the Rajya Sabha. The Samajwadi Party will win the lone seat in UP and it has nominated Ram Gopal Yadav, brother of Mulayam Singh Yadav. But the SP will suffer a loss as its strength will come down from eight to five. CBI refuses to bow to Yogi

Vaghela is rumored to have been brought to Delhi for effective implementation of GST in Gujarat. Apart from this, GC Murmu was appointed CAG, PK Priest in Central Electricity Authority, Food Safety & Security Authority (Rita Titotiya). In particular, Modi replaced Rajiv Topane, a retired Gujarat cadre officer at the end of his tenure in the PM's Office, with Hardik Shah as the private secretary.

PAK FAILS TO FULFIL 6 KEY MANDATES OF FATF

New Delhi, Oct 18: Pakistan's failure to fulfil six key obligations of the FATF, including action against two of India's most wanted terrorists Maulana Masood Azhar and Hafiz Saeed, and the sudden disappearance of more than 4,000 terrorists from its official list will most likely lead to its continuation in the 'grey list' of the Global money laundering and terrorist financing watchdog, officials said Sunday. The virtual plenary of the Financial Action Task Force (FATF),

to be held October 21-23, will take the final call on Pakistan's continuation on its grey list after a thorough review of Islamabad's performance in fulfilling the global commitments and standards in the fight against money laundering and terror financing.

The FATF had given Pakistan a total of 27 action plan obligations for completely checking terror financing of which so far it has cleared 21 but has failed in some of the key tasks, an official privy to the developments said. The mandates which Pakistan has failed include action against all UN-designated terror ists like Jaish-e-Mohammed (JeM) chief Azhar, Lashkere-Taiba th (LeT) founder Seed and the outfit's operational commander Zakiur Rehman Lakhvi.

Besides, FATF has strongly noted the fact that there was sudden disappearance of the names of more

for several hours, many people including four from Mizoram, were injured, Lalthlangliana said. **Chandigarh, Oct 18:** Ahead of a two-day special assembly session to counter the Centre's farm laws, Punjab Cabinet on Sunday authorised Chief Minister Amarinder Singh to take any legislative or legal decision he may deem fit to protect farmers' interests.

The decision came after a meeting of the Congress Legislative Party (CLP) in which party MLAs unanimously stressed the need to reject the farm laws outright and not to implement these in the state. Amarinder Singh too called for a frontal attack against the legislations.

After the MLAs' meeting, state Congress chief Sunil Jakhar said the Centre may "dismiss" the Congress government it it wants but they will do everything possible to protect farmers.

According to an official statement, the state Cabinet authorised the CM "to take any legislative/legal

decision he may deem fit to protect interests of farmers". The Cabinet decided that a strategy to counter the "black farm laws" will be finalised ahead of the special session beginning here on Monday.

"This fight will go on. We will fight this till the Supreme Court," the chief minister earlier said at the Congress Legislative Party meeting. Referring to the demand raised by many farmers' unions for sembly, the chief minister said this could not be done earlier as all legal implications had to be examined thoroughly before taking any step.

The new findings, which suggest a more remote fault at the suture zone or the Indus Suture Zone (ISZ) being neo-tectonically active, could call for a serious relook into the existing evolutionary models, using new techniques and a larger geological database.

The findings can also have major implications in terms of earthquake study, prediction and understanding the seismic structure of the mountain chains. The Indus-Tsangpo suture zone marks the limit of the Indian plate where it collided with the Asian plate. A group of scientists from

A group of scientists from Wadia Institute of Himalayan Geology (WIHG), Dehradun, an institute under the Department of Science and Technology, have found that the suture zone which was conventionally thought to be locked is tectonically active. The scientists carried out the mapping of the remote regions of Ladakh that forms the most hinterland part of the Himalaya. The

study was published recently in

the journal 'Technophysics'. "Since we have shown that fault in this area (Ladakh) is also active, the rocks along the fault zones are very weak and fragile. So, in terms of landslides it has much more implications. Seismically, this area is also active, but the activity is very low to moderate. "If there is any major rainfall event along the Indus river fault, it is more prone to landslides," said Koushik Sen, one of the coauthors of the paper.

Air pollution can heighten pandemic risk: Experts

Air pollution may increase transmissibility of the coronavirus making people more vulnerable to the disease and aggravating the nCoV situation

New Delhi, Oct 18: Air pollution may increase transmissibility of the novel coronavirus making people more vulnerable to the disease and aggravating the COVID-19 situation, experts have said, while warning that those who have had the infection in the past may also have to face new challenges.

According to doctors, respiratory illnesses like viral influenza increase with a spike in pollution levels as poor air quality leads to inflammation in the lungs making it more vulnerable for the virus to penetrate. Experts feel the worst-affected would be people in the lower socioeconomic class with no access to masks and also vulnerable to additional risk factors such as chulla smoke.



"Transmission apart, the presentation of COVID-19 like other viral respiratory illnesses will be more severe in high-pollution areas. This will burden hospitals as more patients become symptomatic, requiring admission," Dr Nischal said. According to Dr Neeraj Gupta, a professor in the Department of Pulmonary, Critical care and Sleep medicine at Safdarjung Hospital, mortality has been linked with population density, the proximity of people and heavily industrialized or urbanised areas which have higher pollution levels.

These factors are likely to become more effective during the festive season and winters, particularly in north India where stubble burning is common and this affects air quality severely, he said.

During smog, particulate matters remain suspended in the air near the earth's surface for a longer period making it conducive for the transmission of the virus, he elaborated. Dr Suranjit Chatterjee, senior consultant of Internal Medicine at Apollo Hospitals, said, "We really don't know how this virus is going to behave. But, we need to prepare ourselves for the worst, as pollution level increases and with winter setting in. It will be a dangerous combination."

Doctors warn that even those who have had COVID-19 in the past are not out of the woods. According to Dr Gupta, with the cohort of survivors of COVID-19 increasing, a significant number is noted to be symptomatic - 43 per cent with respiratory complaints- even after two months. These individuals are particularly vulnerable to air pollution, which is known to cause chronic airway irritation and inflammation, affects mucus clearing, impairs immunity and acutely precipitates airway disorders like asthma, COPD, lung fibrosis or even cancer-related conditions.

Dr Vivek Nangia, principal director and head of pulmonology, Max Super Speciality Hospital in Delhi's Saket said that for individuals belonging to the high-risk groups who are at extremes of ages and suffering from chronic disease are advised to stay indoors or at least restrict their movement to bare essential activities outdoors. "While outdoors, wear a mask at all times and stay away from firecrackers during Diwali. Keep in-haler handy and consult a doctor at the earliest.

Jerusalem: Thousands of Israelis demonstrated outside the official residence of Prime Minister Benjamin Netanyahu on Saturday night. resuming the weekly protest against the Israeli leader after emergency restrictions imposed as part of a coronavirus lockdown were lifted. The protests were curtailed last month after Israel imposed new lockdowr measures in response to a new virus outbreak. The emergency regulations blocked Israelis from traveling to Jerusalem to protest and allowed people only to attend smaller demonstrations within one kilometer (half a mile) of their home.

Five injured in **US mall blast**

Harrisonburg: An investigation was underway into the cause of an explosion and large shopping center in Harrisonburg, Virginia, that injured at least five people Saturday morning. Three people were taken to hospitals after the incident that was reported around 8:30 a.m., and two others were treated on the scene for minor injuries, the city said in an update Saturday evening. Gov. Ralph Northam tweeted that state emergency personnel had been deployed to the area.

Bangkok, Oct 18: Thousands of

anti-government protesters took over key intersections in Bangkok on Sunday, defying a ban on protests for the fourth day with chants of "down with dictatorship" and "reform the monarchy.

Prime Minister Prayuth Chanocha, a former junta leader the protesters seek to oust, is concerned about the spreading protests and the government wants to talk, his spokesman said.

Demonstrations have persisted despite the arrest of dozens of protesters and their leaders, the use of water cannon and shutdowns on much of Bangkok's metro rail system in a bid to quell over three months of street action

"Free our friends", the protesters called out as they stood in a rain, a mass of colourful ponchos and umbrellas. Some held up pictures of detained protest leaders. Thai Lawyers for Human Rights said at least 80 protesters had been arrested since Oct. 13 with 27 still being held.

Police have not given an overall



protests, which have spread across the country of 70 million, could be used by troublemakers seeking to instigate violence. "The government wants to talk

to find a way out together,' spokesman Anucha Burapachaisri told Reuters. He did not specify with whom the government hoped to speak. After the arrest of many of the protest leaders, previously unknown figures have emerged to lead crowds which organise by themselves.

The government banned demonstrations in Bangkok Thursday. Across Thailand, demonstrations were being organised in at least 19 other provinces on Sunday. Solidarity protests were also being held or planned in Taiwan, Denmark, Sweden, France, the United States and Canada.

Protesters, who have adopted the fast moving tactics of Hong Kong activists, kept police guessing about where demonstrations would be held with a slew of social media posts

Links have grown between protesters in Thailand and Hong Kong in a so-called Milk Tea Alliance referring to drinks popular in both places. Hong Kong activist Joshua Wong tweeted in support of Thai protesters. "Their determination for #Thailanddemocracy cannot be deterred," he said

Beijing, Oct 18: China has passed a new law restricting sensitive exports to protect national security, allowing Beijing to reciprocate against the US as tensions mount between the sides over trade and technology.

The law, which will apply to all companies in China, was passed on Saturday by the National People's Congress Standing Committee and will take effect on December 1.

Under the law, China can take "reciprocal measures" toward countries or regions that abuse export controls and threaten its national security and interests.

Export controls under the law will apply to civilian, military and nuclear products, as well as goods, technologies and services related to national security. A list of controlled items will be published "in a timely manner" in conjunction with relevant departments, according to the law.

The new law allows Beijing to retaliate against the US, which in recent months has attempted to block

Chinese technology firms such as transaction.

The new law adds to the growing uncertainty of Bytedance's deal to sell its video app TikTok to US firm Oracle Corp. In August, China added technologies including voice recognition, text analysis and content recommendation to its list of regulated exports.

President Donald Trump had earlier ordered Bytedance to sell its US operations of TikTok to an American firm or face a block in the country.

The new export control laws adds to China's growing regulatory toolkit that allows it to take action against countries such as the US

Jio planning to sell 5G smartphones for ₹2,500-3,000 apiece'

New Delhi, Oct 18: Reliance Jio is planning to launch a 5G smartphone for less than ₹5.000 and gradually reduce the price to ₹2,500-3,000 a unit when it scales up the operation, according to a company official. The company will target 20-30 crore mobile phone users who use 2G connection at present.



"Jio wants to bring the device for less than₹5.000. When we scale up the sales, it can be priced in the range of ₹2,500-3,000," a company official said on the condition of anonymity

An email query sent to Reliance Jio did not elicit any response. At present, 5G smartphones are available in India in the price range starting from ₹27,000. Jio was the first company that launched 4G mobile phones in India free for consumers where they were required to pay a refundable deposit of ₹1,500 for a Jio Phone.

At 43rd Annual General meeting, Reliance Industries Chairman and MD Mukesh Ambani had asserted to make India "2G-mukt" (free of 2G connections) and emphasised on the need to accelerate migration of 350 million Indians (currently using 2G feature phone) to an affordable smartphone, at a time when India stands at the

doorsteps of the 5G era. Ambani had also announced ₹33,737 crore investment by Google for a 7.7% stake in Jio Platforms, and said Jio will partner with the US tech giant to build an Android-based smartphone operating system.

Govt may not extend ₹3L cr ECLGS for MSMEs beyond Oct

New Delhi, Oct 18: The government is unlikely to extend the ₹3 lakh crore-Emergency Credit Line Guarantee Scheme (ECLGS) for MSME sector beyond October even though the sanctioned amount so far is only nearly 65% of the target, sources said. The scheme is meant to provide financial support to businesses, primarily Micro, Small and Medium Enterprises (MSMEs), impacted by slowdown triggered by the coronavirus pandemic.

The sources said the objective is to provide support to all those affected and if there are no takers for the scheme, there is no need to extend the scheme even though there is some room left.

On August 1, the government widened the scope of the ₹3 lakh crore-scheme by doubling the upper ceiling of loans outstanding and including certain loans given to professionals like doctors, lawyers and chartered accountants for business purposes under its ambit.

To ensure more companies can benefit from the scheme, it was decided to increase the upper ceiling of loans outstanding as on February 29 for being eligible under the scheme from ₹25 crore to ₹50 crore. The maximum amount of Guaranteed Emergency Credit Line



(GECL) funding under the scheme was correspondingly increased from ₹5 crore to ₹10 crore.

Announced as part of the government's ₹20.97 lakh crore-economic package in the wake of the coronavirus pandemic, the scheme was later tweaked to be made applicable for companies with an annual turnover of ₹250 crore as against the earlier threshold of ₹100 crore.

Banks and Non-Banking Financial Companies (NBFCs) have approved loans worth about ₹1,87,579 lakh crore while disbursement stood at ₹1,36,140 crore as on October

On May 20, the Cabinet approved additional funding of up to ₹3 lakh crore at a concessional rate of 9.25% through ECLGS for MSME sector.

Under the scheme, 100% guarantee coverage will be provided by the National Credit Guarantee Trustee Company (NCGTC) for additional funding of up to ₹3 lakh crore to eligible MSMEs and interested Micro Units Development and Refinance Agency (MUDRA) borrowers in the form of GECL facility.

The scheme will be applicable to all loans sanctioned under GECL facility during the period from the date of announcement of the scheme to October 31 or till the amount of ₹3 lakh crore is sanctioned under GECL, whichever is earlier.

"This finding calls for the need for countercyclical capital buffer for the Indian banks to protect their balance sheet against losses from

with higher Capital-to-Risk (Weighted) Assets Ratio (CRAR) face a lower cost of funds. The procyclical nature of leverage shows that banks lend during economic boom by raising debt funds -- through deposits, borrowings -- rather than using their excess capital.

"Higher CRAR unlocks the bank lending channel and helps in smooth transmission of monetary policy. However, the magnitude of transmission of monetary policy was found to be weak for banks with CRAR higher than a certain threshold level," it added.
