

# **6 UK returnees test +ve for new Covid variant**

New Delhi, Dec 29: Six persons who returned to India from the United Kingdom have tested positive for the new mutated strain of coronavirus, the Union Health Ministry said Tuesday. It said the UK variant genome of

SARS-CoV-2 was detected in three samples in the National Institute of Mental Health and Neuro Sciences Hospital (NIMHANS) Bangalore, two in the Centre for Cellular and Molecular Biology (CCMB) in Hyderabad and

one in the National Institute of Virology (NIV) Pune. All these persons have been kept in single room isolation at designated health care facilities by respective state governments and their close contacts have also been put under quarantine, the ministry said.

"Comprehensive contact tracing has been initiated for co-travellers, family contacts and others. Genome sequencing on other specimens is going on. "The situation is under careful watch and regular advice is being provided to the states for enhanced sur-

### BMC launches move to trace UK returnees

BHUBANESWAR: In the wake of several returnees from the UK going untraceable, the Bhubaneswar Municipal Corporation launched an operation to trace the missing persons. The State Public Health Director Niranjan Mishra said, "A BMC team is tracing the untraced persons in the capital who recently returned here from the UK. Most of the persons who returned from the UK hailed from Bhubaneswar. The returnees from the UK have gone to 18 different districts of the state."



veillance, containment, testing and dispatch of samples to INSACOG labs," the ministry said. The presence of the new UK variant has already been reported by Denmark, the Netherlands, Australia, Italy, Sweden, France, Spain, Switzerland, Germany, Canada, Japan, Lebanon and Singapore, so far.

The ministry said that from November 25 to December 23 mid-

night, about 33,000 passengers dis embarked at various Indian airports from the UK. All these passengers are being tracked and subjected by states and UTs to RT-PCR tests.

So far 114 have been found positive for COVID-19. These positive samples have been sent to 10 INSACOG labs (NIBMG Kolkata, ILS Bhubaneswar, NIV Pune, CCS Pune, CCMB Hyderabad, CDFD Hyderabad, InSTEM Bangalore, NIMHANS Bangalore, IGIB Delhi, NCDC Delhi) for genome sequencing. "A total of 6 samples of 6 UK returnee persons have been found to be positive with the new UK variant genome," the ministry said. The Centre took cognizance of the reports of virus reported from UK and put in place a pro-active and preventive strategy to detect and contain the mutant variant.

This strategy included temporary suspension of all flights coming from UK with effect from the midnight of

Genome sequencing of all Covid+ flyers

NEW DELHI: All international passengers who arrived in India between December 9 and 22 and tested positive for Covid-19 will be subjected to genome sequencing as part of the Centre's strategy to detect the mutated coronavirus strain that has emerged in the United Kingdom recently. Others will be followed up by the state and district surveillance officers and will be tested as per ICMR guidelines, even if they are found asymptomatic between fifth and the 10th day of their arrival. 23rd December till 31st December 2020 and mandatory testing of all UK returnees through RT-PCR test. The samples found positive in RT-PCR test to be genome sequenced by a consortium of 10 government labs.



# Quota for govt school students kicks up row

Bhubaneswar, Dec 29: Politics heated up in the state over the state Cabinet's decision for reservation of seats in medical and engineering colleges for students who pass out from government-run schools.

Questioning the move of the Cabinet, BJP leader Lekhashree

Samantasinghar said, "The state government has failed to ensure basic facilities like providing text books and uniforms to students in the schools. Now, the government should clarify what promoted them to announce this reservation in medical and engineering colleges for students of governmentrun schools in the state." The government is yet to

implement 27 per cent reservation for OBC students and 10 per cent for economically weaker section students in education and the recruitment process, Samantasinghar said. Almost all states provide at least 27 per cent reservation in education and employment sector while the state government is lagging

behind in this direction, she alleged. The BJP demanded that the government convey a special session of the Assembly to pass bills for reservation of seats for OBC and economically weaker section. Senior Congress leader Suresh Routray too criticized the move of the government and said, "The government doesn't have the power to implement it.

The decision of the Cabinet is just an eyewash.' Reacting to this, BJD

spokesperson Elina Dash said, "We are shocked that the BJP is opposing such a historic and pro-student announcement of Chief Minister Naveen Patnaik providing reservation for students studying in government-run schools.'

"We hope this is the personal opinion of Lekhashree and not that of her party BJP," she said. She hoped that entire country including BJP ruled states would follow this decision in some time. The BJP is actually unnerved by the popularity of this decision taken by Naveen Patnaik.

Bhubaneswar. Dec 29: The Centre will tighten the procedures for release of funds to the states and union territories (UTs) under various Central Sponsored Schemes (CSS). The revised norms will come into effect from next financial year (2021-22)The Department of Expenditure

under the Ministry of Finance has sent the draft norms to the state finance department seeking its suggestions and observations. As per the proposed norms, the

state government will have to designate a single nodal agency for implementation of a CSS and the fund will be transferred to a single nodal account in a public sector bank authorized to carry out the state government business.

With an aim to avoid parking of public funds in different bank accounts, the Centre has decided to maintain the fund for a CSS account in one designated bank. Whenever a field level agency requires funds, it can draw the amounts from the nodal account.



"For the seamless management of funds, the main account and all subsidiary accounts will be maintained with the same bank. However, the state governments may choose different PSU banks for opening single nodal accounts of different CSS," the department of expenditure said in the letter.

In the beginning of a financial year, the Centre will release maximum 25 per cent of the amount earmarked for a state for a CSS for the vear in first phase. If any unspent balance of CSS (centre and state share) available with the state government, then the concern ministry will release the first instalment deducting the balance amount.

The second instalment will be released after utilization of 75 per cent of the sanctioned fund. However, this rule will not be applicable, if the Union Cabinet decided to release a specific quantum of fund under a scheme.

Similarly, all implementing of fices will have to refund balance amount of CSS to the state nodal account by April 1, 2021. The amount so refunded will be taken as the opening balance for that scheme and the concerned ministry will release the fund for the next fiscal accordingly

The state governments will have to release its share within 30 days from the release of the central share

Commenting on this, a senior officer of the finance department said, "We have forwarded the draft procedures to all departments for their comment on them. The draft procedure is a welcome step for proper maintenance of the public money. However, the single bank thing may create problem for our state as we don't have enough bank branches across the state.

New Delhi, Dec 29: India is likely to extend the suspension of passenger flights to and from the United Kingdom to check the spread

of the new strain of coronavirus, Aviation Minister Hardeep Singh Puri said Tuesday. The ministry had last week BRITISH AIRWAYS suspended all flights between the two countries

from December 23 to December 31 over the mutated variant of the virus which is more contagious.

"I foresee a slight extension of temporary suspension of India-UK flights," the minister told a press conference here Tuesday. "In a day or two, we will find out if any additional steps need to be taken, or when we can start easing the current temporary suspension," he said

Earlier in the day, the Union Health Ministry said six persons who returned to India from the United Kingdom have tested positive for the new strain of the virus. The presence of the new UK variant has already been reported by

Denmark, the Netherlands, Australia, Italy, Sweden, and other countries.

Meanwhile, Airports Authority of India Chairman Arvind Singh told the press conference the government is planning to hold the next

round of privatisation of airports in the first half of 2021. "As far as the next round of air-

ports' privatisation is concerned, we are at the final stages of obtaining government approvals. Once the approvals are received, I think we will start the process of bidding in the first quarter of 2021," he said. The AAI had in September recommended the Centre now privatise airports at Amritsar, Varanasi, Bhubaneswar, Indore, Raipur and Trichy.

Chennai, Dec 29: Making a U-turn on his political plunge, superstar Rajinikanth Tuesday announced that he will not join politics and start a party as announced earlier. citing his frail health. He had first announced in 2017, after years of speculation, that he would indeed enter politics ahead of the 2021 Assembly elections in Tamil Nadu and field candidates from all 234

seats in the state. The veteran announced earlier this month that he will launch his political party in January and disclose the specifics by December 31. The top star, promising his brand of spiritual politics, had then dra-

matically asserted that he was even ready to risk his life for the sake of people's welfare by making a foray into politics.

Discharged from a Hyderabad hospital on Sunday after being treated for blood pressure fluctuations, the top actor expressed fears over those accompanying him in his possible political journey facing "mental and economic" problems in the due course over his possible health issues. After earlier acknowledging reports of him undergoing renal trans-

plant in 2016, he recalled the hospitalisation for blood pressure fluctuation and said it could affect his kidney. He indicated that he did not want to sound chivalrous by saying he will join politics despite

his severe health concerns and that he did not want to "make a victim of his supporters now.

"Therefore, I inform with regret I am unable to come to politics by floating a political party. Only I know the pain behind making this announcement," the 70 year-old

actor said in a statement. days after declaring he will float his own outfit in January and face the polls. He, however said he will serve people in whatever ways he can without entering electoral politics.

# **Bodies of youth, girl** found hanging

Sakhigopal, Dec 29: In a shocking incident, the bodies of a youth and a girl were found hanging from a tree at Jeepur village of Alagum panchayat under Satyabadi police limits in Puri district Tuesday.

The deceased were identified as Balabhadra Nayak, 24, and Narmada Nayak, 20, of Jeepur Pradhansahi. It is suspected that the duo was in a relationship. But, there is no confirmation whether the incident was a case of suicide or murder.

According to sources, a villager spotted the bodies near an orchard in the morning and informed the incident to the deceased's families.

On being informed, police reached the spot and recovered the bodies. Balabhadra's body was found hanging with a pair of trousers while Narmada's body was hanging with a dupatta. The hands of Balabhadra were found tied with a handkerchief while a bottle of pesticide was found from a nearby place, villagers said.

Family members of the deceased, meanwhile, revealed that they had no idea about the duo's relationship.

"We have sent the bodies to Puri district headquarters hospital for postmortem. The exact reasons for the duo's deaths can be ascertained after receiving the postmortem reports," said Satyabadi IIC Debiprasad Patra.

Bhubaneswar; Dec 29: The Social Security and Empowerment of Persons with Disabilities (SSEPD) department is contemplating to increase the incentive for normal persons tying knot with differently-abled partners.

Earlier, there was a provision of Rs 50.000 incentive for marrying specially-abled, but now the state government is planning to increase it to Rs 2.50 lakh. The proposal has been sent to Finance department for approval. The SSEPD department claimed that this would help the vulnerable section of the society.

"The State Government has been pleased to approve the enhancement of incentive for marriage between persons with disabilities and other persons, irrespective of category of disability, from the existing quantum of 50,000/- to 2,50,000/- so as to bring to the mainstream the persons with disabilities in the society and enable them to lead a normal and dignified life and also to encourage other persons to marry the persons with disability," the SSEPD department said in the proposal.

Earlier, there was an annual budget provision of Rs 2 crore with Rs 50,000 per couple. Now, it would require a budget of Rs 50 crore in five years for the same whereas Rs 10 crore would be required annually for implementation of the scheme. The department said that the plan has been made in order to mainstream persons with disabilities in the society and achieve inclusive development as mandated in United Nations Convention on the Rights of Persons with Disabilities (UNCRPD) and National Policy for the differently-abled.

The department has decided to implement the above scheme out of the State Sector scheme. The scheme is likely to be implemented at state level by Director, SSEPD and at the district levels by District Social Security Officers (DSSOs).

Pradesh Congress Committee (OPCC) President Niranjan Patnaik Tuesday urged Chief Minister Naveen Patnaik to consider opening the Maa Tarini temple in Keonihar. "I would like to draw your at-

While the Ashok Nagar SUH is exclusively built for the elderly, the Chandrashekarpur SUH caters to female refugees only. Meanwhile, Bhimpur SUH has been exclusively made as a de-addiction centre. While two agencies have been deployed to mobilize the urban homeless, the civic authority has also claimed to formulate a dedicated WhatsApp number for resolving issues within hours.

Furthermore, the H&UD department has revealed that a ULB-wise survey will soon be initiated to measure performances of the urban bodies in rehabilitating the urban poor.

# MeT predicts chilly weather as NYD nears

Predicting intense cold-wave situation in next three days, the Met Centre has issued yellow warning for Jharsuguda, Sundargarh, Deogarh, Angul, Boudh and Kandhamal. As per a bulletin issued by the Met Centre, the lowest temperature of 5.5 degrees Celsius was recorded at Phulbani, while Daringbadi in Kandhamal district recorded 6.5 degrees

This economic globalisation is no longer compatible with the polit ical balkanisation that hyper-nationalism underpins.

America's foreign-policy record is not blemish-free. But America can be a catalyst if it actively engages with the world once again - and not with a view only to its own interest this time. Biden and Harris should show vaulting ambition and set their sights high. They need to restore America's status in the world not for its own sake, but to make the world a better place

The State Government has, in a Cabinet meet held 28 Dec 2020, decided to reserve seats in Engineering and Medical courses for students passing out of government schools. This has been done to encourage government school students who are currently dropping out in large numbers. This is a very welcome step. However, improving government schools in Odisha is a long and arduous task. There is a belief that to build a tall and sturdy structure, one needs to dig deep foundation. The government education system in the state is in complete disarray. A lack of physical infrastructure like classrooms, labs, toilets and in many cases playgrounds may not be the only hindrance. The major issue that is noticeable is the non availability of qualified teachers in sufficient numbers. Most schools in rural areas of the state are pitifully understaffed. Many a school has a single teacher teaching multiple subjects in different grades. The involvement of the teaching staff can safely be assumed as nonexistent. Most of the schools that previously had private management were aimed at creating wealth for those who established the institutions. Today, in changed circumstances, government appointed managing committees comprising local residents have not helped improve the standard of education. Most of the members of these committees

are eveing the benefits as they are suppos edly temporary members. To put all the problems related to school education into one nutshell, it must be accepted that primary and secondary education system in the state has been a miserable failure. While government can obviously be blamed for the present situation, it is also important to note that local residents and guardians also play a major role in the decline in the level of education in government schools.

It may be exciting to claim that there

will be reservations in state run engineering and medical colleges for students passing out of these government schools. The ocean of students appearing for Joint Entrance Examination (JEE) may give an impression that the old rut of education is still alive and kicking. This impression may not be completely wrong. However, reality is that a lot of students are now opting for courses such as liberal arts and humanities. No doubt, there still are enough parents forcing their wards to go in for competitive exams to join government service. On the other hand, with prosperity has come a desire to do something independent. As opportunities for jobs are shrinking, the course of education too has to be modified. Students and especially girls need to be academically and emotionally equipped to face modern challenges of society and individual life. Although girls of middle and upper class families perform well in academics, the lower middle class and poor sections of society accept their daughters dropping out early in school. With this female workforce remaining uneducated and untrained, it will become impractical to expect balance in society.

Admittedly, the reach and spread of government primary and secondary schools cannot be matched by private schools. For most of rural India including Orissa, the only choice for schooling is government operated institutions. Therefore, the state government's intention of giving a fillip to the students from these schools may be considered a noble thought. But a thought is not enough. Government schools desperately need simultaneous focus on infrastructure, teaching staff as well as curriculum. This is a very difficult job but not unattainable. The example of the efforts of the Kejriwal government in Delhi is a point to ponder. In its first term, the Aam Aadmi Party government scrutinized and improved Delhi government schools as a core mission. The schools not only got improved infrastructure but also an overhaul of curriculum and teaching staff. Resultantly, many parents are now shifting their wards from private to government schools. Interestingly, this drive of the AAP benefitted Keiriwal politically also and it is said that the improvements in education led to the second time massive win of the party

Orissa also needs focus to be laid on primary and secondary education. Baby steps need to be taken in revamping teachers' training and testing their abilities. Once the human resource improves in quality, other aspects will slowly fall in line. This requires a missionary zeal of few individuals. Finding these individuals to lead this movement is of prime importance.

### Whilom

his adjective is one of four — the others being erstwhile, quondam and umpuhile - with the same meaning: formerly, in the past. All are unfamiliar and un-English in appearance, though whilom is not the least odd. None is common but whilom is rare enough today to the extent that current dictionaries mark it as archaic. This may not be a surprise to the writer of this letter, an expatriate professor of English and Irish Literature in a German university: As a whilom Irishman since 1961, I follow the news rather seriously. (The Irish Times, 18 May 2010) It was once part of the vocabulary of literate English speakers, such as JM Barrie, who wrote in The Little White Bird of 1903: "Whom did I see but the whilom nursery governess sitting on a chair in one of these gardens." He meant that that the lady had once been a governess, but was one no longer. Barrie wrote that at what proved to be the peak of the word's popularity. By the time of this next appearance, it had been rapidly falling away from favour for a couple of decades: His might have been, as his whilom playmate, the Hon. Galahad Threepwood, had made so abundantly clear in Chapters Four, Seven, Eleven, Eighteen, and Twenty-Four of his immortal work, a frivolous youth, but in his late fifties he was taking life extremely seriously. (Heavy Weather, by P G Wodehouse, 1933) The word dates to Old English, at a time when the language was heavily inflected - adjectives, nouns, and verbs taking different endings depending on the job they were doing. Whilom - then spelt hwilom - was the dative plural of hwil, the same word as our modern while. As English progressively lost its inflections, the word became a fossil, with its ending stuck to it permanently; at the same time the meaning shifted to mean something of a former time, a change that was complete by the fifteenth century.

have always loved this time of the year, mostly because it allows me to dream of all the possibilities that the New Year will bring. This is a time to make New Year's resolutions and transform our lives. It's amazing what a difference a few resolutions can make. For example, a few years ago, I was determined to change the shape of my body, so I resolved to "exercise for 90 minutes a day" and "avoid all forms of junk food." After one month, I evaluated my progress and realised that I had spent 90 minutes a day eating junk food and avoided all forms of exercise. My body had indeed changed

What had I done wrong? I had set my goals too high. This is a mistake I've made many times in my life: set high goals and set myself up for failure.

New Year's resolutions can indeed transform our lives, but usually not as dramatically as we'd like to believe. If there's one piece of advice I want everyone to heed, it's this: Don't aim high—aim low. Aiming high is how most people fail. Some people have never exercised in their entire lives, yet they somehow convince themselves that



they're going to run for an hour a day, beginning on Jan. 1. This usually results in a long line at the doctor's office on Jan. 2.

First patient: "Ouch, my foot!" Second patient: "Ouch, my back!" Third patient: "Ouch, my wallet!" Trust me, you are better off running for 10 minutes a day consistently than aiming for something

longer and wishing you had married a doctor. But here's what usually happens to people: they aren't happy with 10 minutes, so they try 20 minutes, then 30, then 40. Before long, their body resists this big change, perhaps through a muscle strain or illness, and they

go from 40 minutes of exercise all the way down to 40 seconds of excuses.

It's important to keep your goals realistic. Remember: small goals help you achieve big goals. If you're hoping to compete in the Hyderabad marathon, don't try to run 26 miles right away. Begin by running 26 laps around your coffee table. If you collapse halfway, don't worry. You can try again tomorrow. Over a period of weeks, perhaps

months, you can turn your small goals into bigger goals. Just say you want to write a 350-page novel in 2021. All you need to do is write one page a day, right? That's about

300 words per day, which is quite achievable. Eventually you may want to increase your daily output from 300 words to 500 words, but don't do it until you've written 300 words a day for at least 21 days. That's three weeks, which is apparently how long it takes for a habit to stick. After three weeks, the "new habit" is now the "new normal." The best part is we become friends easily with new people. But relationships based on technological ties can sometimes put one in trouble if the person is not cautious about the way one conducts with others. The number of honey trap gangs has increased these days. The gangs target men and interestingly, women are enlisted to set the trap. The gangs extort money by threatening men after taking their nude pictures through video calls. In the beginning, the honey trappers send friend requests from profiles of women. Once their friend requests are accepted, they start sending messages to the victims' inboxes. They make friends through obscene conversations. The trust of the victims is gained by exposing nudity through video calls. Meanwhile, the victims also share their nude pictures. Once the victims fall into the trap, the women would vanish from the scene. Then men take over and demand large sums of money by threatening to send the images and videos to family members and friends. With their reputation at stake, the victims don't file police complaints. The police have warned that incidents of honey trap, targeting prominent people have been on the rise. Even if the culprits were tracked down, the chances of retrieving the money were bleak, they say. All honey trap cases exploit basic human weakness. In most cases, the video being played to arouse a victim is either a pre-recorded one or completely fake. There are enough online tools available to stream a fake webcam video. These criminals buy details of potential victims before trapping them. They also target people by hacking their email accounts and accessing personal details. # **No electricity for farmers in Angul**

As over 200 lift irrigation points remain defunct due to short supply of electricity in Angul, farmers continue to suffer

### POST NEWS NETWORK

Angul, Dec 29: Defunct lift irrigation points have left the farming sector in mess in the industrial Angul district. Farmers continue to suffer while no efforts are being made by the concerned departments to set things right in the larger interests of the farmers, a report said.

According to the report, over 200 lift irrigation points are lying unutilized for lack of electricity supply. Farmers in some areas have been

struggling for water.

On the other hand, industrial units in the district allegedly suck water away, making water crunch for the agriculture sector. As a result, the farming sector in the district has taken a beating, the report said.

Angul district has many dams, rivers, underground water sources. Lift irrigation projects are being executed to feed water from these sources to the farmlands. The irrigation points aim to irrigate 22,146 hectares of land in the district.

There are 897 lift irrigation points, but 205 of them have been lying defunct due to the alleged negligence of the departments.

With help of 692 lift irrigation points, 16,488 hectares of farmlands are being irrigated.

It is alleged that lack of power infrastructure is the major reason

Doctors at the district headquarters hospital referred her to the SCB Medical College and Hospital in Cuttack. But, they also proved unsuccessful in taking out the needle.

Her husband Prabhat with little money in hand finds it difficult to take his wife to Cuttack with her health condition remaining critical. He has alleged that the doctors have opened the stitch a number of times to trace the needle but in vain. Moreover, they are yet to issue him discharge certificate referring her to Cuttack. He has become apprehensive of his wife's health with money and time running out of hand.

A doctor at the Khandapada hospital said that steps will be taken after holding consultations with the chief district medical officer. When contacted, CDMO Dr Shakti Mishra said proper steps will be taken to get her treated at Cuttack or Bhubaneswar and ruled out any problem.

launched a ₹4.18 crore water project for the area January 9, 2019, but we do not want underground water through handpumps or overhead water tanks, as such water is unfit for human consumption. The Ganga Jal pipeline should be extended to our villages, which is not too far from here.

Sharma pointed out that high fluoride content in groundwater had reduced its residents to "walking skeletons.

Efforts by various government agencies to treat water have run aground for want of proper mon-

itoring and follow-up action. "Imagine, a whole village full of

physically challenged persons with no hope or light at the end of the tunnel," he quipped.

Last winter, 50-year-old Than Singh, a daily wager, died in agony due to his physical deformities. He had not stirred out of his modest home since 2012, except for a few visits to the doctors. His last day was spent on a cot, as his wife fed him to keep the flame of life flickering.

Than Singh had told IANS a few months before his demise: "Someday, I will hang myself or throw myself before an oncoming truck to end the agony of my existence." He showed a bagfull of medicines which he was forced to consume to remain alive.

Lucknow, Dec 29: The Yogi Adityanath government in Uttar Pradesh has decided to order a Special Task Force (STF) probe into the 'unverified' teachers issue if they do not verify their service books by January 4

At least 16,838 teachers in the state have not verified their serv ice books by the December 17 deadline on the 'Manay Sampada' web site which is an online database of teachers, created for the digitisation of records.

The deadline has now been extended to January 4.

According to an official spokesman, the government will ask the STF to probe the cases of teachers who have not verified their service books

Over 6.1 lakh teachers, appointed in the basic education department. were asked to verify their service books. The process was followed by around 5.9 lakh teachers, which is around 97.2 per cent of the total verifications sought by the department. During this exercise, teachers were required to make corrections, if any, in a Google sheet. They also had to upload their educational documents - from high school to degree level.

The education department has intensified the digitisation process after a 'fake' teacher scam was reported in June this year, in which a full-time science teacher named Anamika Shukla was found working at 25 Kasturba Gandhi Balika Vidyalayas (KGBV) simultaneously for 13 months and taking home approximately ₹1 crore as salary.

A STF probe was then initiated to identify fake teachers in the state and more than 350 primary teachers working on the credentials of other teachers, were arrested

continuity with the western part of Bihar. The area will be the focal point of Buddhist tourism as almost 65 per cent of the tourists coming to Uttar Pradesh prefer to visit Kushinagar and Varanasi.

In a recent presentation made before Chief Minister Yogi Adityanath, it was suggested that places of Buddhist interest be connected to other tourist places in Purvanchal.

Ayodhya, the birthplace of Lord

Ram, and Gorakhpur, the seat of Guru Gorakhnath, are also a big draw for both domestic and international tourists.

It was also said that small fairs and cultural events of Purvanchal, on the lines of Deepotsav and Dev Deepawali, be held to promote tourism. Purvanchal is a very culturally rich region, but it has been beset with lack of basic facilities, proper rural education and employment since the beginning.

The government spokesman said that the Purvanchal Expressway on the one hand, and the development of tourism on the other will end unemployment and the basic problems of the area.

The presentation suggested improvement of the road, rail and air connectivity in the area, promotion of local festivals like 'Saawan Mela', setting up of film shooting destinations in Mirzapur and Sonbhadra and also re-branding of the 'Magh Mela' in Prayagraj.

These graded reading books will increase the students' ability to read and learn. The language of this book has been kept very simple, which will enable the children to learn easily.

Apart from this, the report card of the students studying in primary and upper primary schools of the state will be shared with their parents during the formal meeting with the parents in the school. According to official sources, the Department of Basic Education had recently conducted a Supportive Aptitude Test (SAT) to enhance education skills in the students. In this test, students were given grades from A to E. Separate remedial classes will be run in schools for students, who got grades D and E, officials said. The department of basic education has also introduced a system of realtime monitoring to check the progress of students studying in primary and upper primary schools.

This will identify the average students and conduct separate classes for them, so that they can also compete for top ranks with other students, said the officials.

# Genome sequencing of infected flyers

New Delhi, Dec 29: Samples of all international passengers who arrived in India from December 9 to 22 and tested positive for COVID-19 will be subjected to genome sequencing as part of the Centre's strategy to detect the mutated coronavirus strain that has emerged in the United Kingdom recently.

Others will be followed up by the state and district surveillance officers, and will be tested as per ICMR guidelines, even if asymptomatic, between fifth and 10th day of arrival, according to the Union Health Ministry's guidance document on genomic sequencing

"All the international passen-

gers who have arrived in India during the last 14 days (from December 9 to 22), if symptomatic and tested positive, will be subjected to genome sequencing," the document stated.

The presence of the new UK variant of the coronavirus has already been reported by Denmark. the Netherlands, Australia, Italy, Sweden, France, Spain, Switzerland,

The health ministry has established the Indian SARS-CoV-2 Genomics Consortium (INSACOG) for laboratory and epidemiological surveillance and to expand the

whole genome sequencing of the coronavirus in the country, aiding in the understanding of how the

returnee air passengers through RT-PCR test. Ten regional

laboratories have been identified by the Centre where states will send five per cent of their COVID-19 positive samples for genome sequencing to detect the new coronavirus variant. Standard Operating Procedure (SOP) for

Epidemiological Surveillance and Response in the context of new variant of SARS-CoV-2 has already been issued by the Health Ministry.

The purpose of this initiative is to ensure proper screening of international travellers arriving in India for early detection of new SAR-CoV-2 variant cases. Further, epidemiological surveillance of the passengers, who have arrived in India since November 23, will be conducted in the community through ac-

tive follow up. All these people have been kept in single room isolation at designated health care facilities by respective state governments and their close contacts have also been put under quarantine, the ministry said.

**ITBP** finally gets land to build HQ in Delhi

New Delhi, Dec 29: Almost six decades since it was set up, the Indian government's specialised high-altitude paramilitary force, the ITBP has been allotted land to construct its headquarters in the national capital. The new ITBP HQ building is expected to be constructed by 2023.

Ever since it was raised on October 24, 1962 under the CRPF Act in the wake of the India-China war of 1962, the Indo-Tibetan Border Police Force (ITBP) headquarters was located in various government office structures, but the force was not yet to get its own dedicated land or building so far.

The land, allotted December 24 by the Land and Development Authority under the Ministry of Urban Development, is on Mathura Road, around 2 km from the current ITBP HQ at Block 2, Central Government Offices (CGO) complex in south Delhi's Lodhi Road area which has offices of important government ministries and departments like the National Informatics Centre (NIC), the Directorate of Revenue Intelligence, the headquarters of other central paramilitary forces and the Ministries of Environment and Forests and New and Renewable Energy.

As per the ITBP source the government has allotted the piece of land which is in two parts. "The first part of 3.83 acre will be used to construct the headquarters building while the second piece of land of 4.85 acre will be used to develop greenery. The second part of land will be on temporary basis," the source said. The land has been given on "as is where is" system, the source said.

# MAJOR ORDERS PASSED BY SC IN 2020

### POST NEWS NETWORK

New Delhi, December 29: The year 2020 saw major changes in the functioning of the Supreme Court. Battling the Covid-19 pandemic, the apex court heard thousands of cases in virtual mode and passed significant judgements in 2020

Here are some of the prominent orders passed by the Supreme Court in 2020

### Right to Internet

In the first month of 2020, the Supreme Court, while hearing a batch of petitions on the blackout of Internet services in Jammu and Kashmir, held that right to access Internet is a fundamental right by extension. Therefore, it can be demanded as such before a Constitutional court. Further, every blackout order must specify reasons and has to be reviewed regularly by the authorities concerned, the court had said.

Reservation not a fundamental right

In February 2020, the Supreme Court, in a significant judgement, ruled that reservation is not a fundamental right. The top court held that there is no fundamental right to claim reservation in government jobs. It also held that it is within absolute discretion of a state government to decide whether or not to provide for reservation and also there is no obligation on the states to mandatorily do so. The apex court order came in a batch of petitions seeking reservation for SCs and STs in promotion. Permanent commission to women

In another significant judgment,

the Supreme Court in February granted permanent commission to women in Defence forces. The Supreme Court directed the government to give permanent commission to all serving women officers who have completed 14 vears of service and to also give pension benefits to those who were retired on account of not being granted the commission.

### medical exams

The Supreme Court in April upheld the National Eligibility-cum-Entrance Test (NEET) for admission in graduate and post graduate medical and dental courses in the country. A three-judge bench of the apex court made it clear that NEET will be only the test for admissions in medical courses and institutes cannot hold separate test for the same.

Suo Moto PIL on migrant crisis

Initially refusing to pass any direction to the government with regard to plight of migrant labourers returning to home, the Supreme Court took Suo Moto cognisance in May and passed slew of directions to the Union and state governments. The court asked the state governments to identify migrant workers and transport them to native their states within 15 days. The court also asked the state governments to open help desks to

provide employment to migrant from giving prescriptions to Covidworkers. The court also asked the Union government to provide trains within 24 hours of the demand.

#### Daughters' right to paternal property

The Supreme Court in August ruled that daughters would have equal rights in Hindu Undivided Family (HUF) properties. The apex court held that a daughter is for a life time and held that daughter will remain coparcener (one who shares equally with others in inheritance of an undivided joint family property) throughout life even if the father was not alive at the time of the 2005 amendment to the Hindu Succession Act. 1956. In 2005, an amendment was made in the Hindu Succession Act, 1956 to give daughters the same rights in the coparcenary (parental) property as the sons.

#### AYUSH docs restrained from prescribing for Covid-19

The Supreme Court upheld the order of the Kerala High Court that restrained AYUSH doctors 19 patients.

#### SC exempts factories from paying overtime wages

The Supreme Court quashed a notification of the Gujarat government that exempted factories from paying overtime wages to its workers. The top court held that pandemic cannot be an excuse to junk statutory provisions that ensure dignity and right to proper wages to workers.

#### SC refuses to direct transfer of fund from PM CARES to NDRF

The Supreme Court had refused to direct the transfer of fund collected under PM care to National Disaster Response Fund (NDRF) citing that contributions to the PM Cares fund are voluntary and there was no statutory prohibition on contributions made to the NDRF. "The funds collected in the PM CARES Fund are entirely different funds which are funds of a public charitable trust and there is no occasion for issuing any direction to transfer the said funds to the NDRF.

veto of a \$741 billion defence Bill. Trump last week vetoed the National Defense Authorization Act (NDAA) 2021, which had bipartisan support, arguing it had provisions that would damage national security.

In the Democratic-controlled House, as many as 109 Republicans broke from Trump to vote in support of overriding the veto, delivering a 322-87 defeat to Trump only weeks before he leaves office.

The bill that funds the annual American defence spending now moves to the Republican-controlled Senate, which also needs to override the presidential veto by two-thirds

of votes. Both the House and the Senate, early this month, had voted overwhelmingly to pass the NDAA.

With this overwhelmingly bipartisan vote, the House has upheld our sacred Constitutional responsibility to keep our country and our people safe. The National Defense Authorization Act has been passed on a bipartisan and bicam-



eral manner for sixty years, and it will become law, despite the President's dangerous sabotage efforts," House Speaker Nancy Pelosi said. The vote puts it on track to be the

# Targeted killings of journalists surged in 2020, says Report

Paris, Dec 29: More journalists are being killed outside of war zones, and the overwhelming majority of this year's grim total of at least 50 dead was deliberately targeted, many of them murdered while investigating organized crime, corruption and environmental degradation, Reporters Without Borders said Tuesday.

Its tally of journalists and media workers killed in connection with their work by mid-December was just slightly lower than in 2019, when the press freedom group counted 53 dead, even though many journalists reported less from the field in 2020 because of

the coronavirus pandemic. The group said 68% were kill outside of war zones this year. That confirms a trend noted by the group since 2016, when only four out of 10 deaths were in countries not at war. Targeted killings of journalists surged in 2020, accounting for 84% of deaths, sharply up from 63% in 2019, the group said. It again listed Mexico as the

deadliest country for media workers, counting at least eight journalists killed there in connection with their work in 2020. Among them was Julio Valdivia, a newspaper reporter whose decapitated body was found in September in an area ridden with organized crime

Among six media deaths that the group counted in Iraq was the killing in July of Hisham al-Hashimi, a leading expert on the Islamic State and other armed groups, who was shot dead outside

his Baghdad home. Reporters Without Borders also noted an increase in the killings of investigative journalists, including four who were looking into organized crime groups, 10 who were reporting on corrup

Washington: The overall number of global coronavirus cases has topped 81.2 million, while the deaths have surged to more than 1.77 million according to the Johns Hopkins University. In its latest update Tuesday morning, the University's Center for Systems Science and Engineering (CSSE) revealed that the current global caseload and death toll stood at 81,249,028 and 1,772,912, respectively. The US is the worst-hit country with the world's highest number of cases and deaths at 19,299,960 and 334,830, respectively.

# Pandemic severe, but not necessarily the big one: WHO

Geneva, Dec 29: The novel coronavirus has had a devastating impact around the globe, but the World Health Organization warned Monday that worse pandemics could lie ahead, urging the world to get "serious" about preparedness.

"This is a wakeup call," WHO emergencies chief Michael Ryan told reporters at a briefing marking a year since the UN agency first learned of the new virus spreading in China.

Since then, Covid-19 has killed nearly 1.8 million people around the world, out of over 80 million

infected. "This pandemic has been very se-

vere," Ryan acknowledged. "It has spread around the world extremely quickly and it has affected every corner of this planet, but this is not necessarily the big one.

He stressed that while the virus is "very transmissible, and it kills people... its current case fatality (rate) is reasonably low in comparison to other emerging diseases."

"We need to get ready for something that may even be more severe in the future.'

WHO senior advisor Bruce Aylward also cautioned that while the world had made huge scientific

progress to address the coronavirus crisis, including developing vaccines at record speed, it remained far from prepared to ward off future pandemics.

"We are into second and third waves of this virus and we are still not prepared to deal with and manage those," he told the briefing.

"So while we are better prepared ... we are not fully prepared for this one, let alone the next one."

WHO chief Tedros Adhanom Ghebreyesus meanwhile voiced hope that the Covid-19 pandemic had helped the world become more prepared to tackle future threats.

"In terms of awareness, I think we are now getting it," he said.

One big source of trouble has been the government's "GoTo Travel" campaign, which provides

steep discounts for domestic travel. The programme was launched in the summer, before Suga took office. It was suspended as of Monday, but many Japanese believe it helped spread the virus and should have been halted sooner.

Experts said Suga's insistence on continuing GoTo promotions until recently sent a muddled message at a time when the government is urging people to scale back activity.

# BREXIT ENDS BRITONS' RIGHT TO LIVE AND WORK IN EU

London, Dec 29: So far, the large majority of British and EU citizens have not felt the realities of Brexit. Though the UK left the European Union January 31, it follows the bloc's rules until the end of this year as part of a transition period to the new economic relationship.

That's all set to change.

On January 1, Britain embarks on its new, more distant relationship with the EU after nearly five decades of closer economic, cultural and social integration. The change for Britain's economy and people is the most dramatic since World War II, certainly more so than when the country joined what was then the **European Economic Community**

economic system and it's going to happen instantaneously," said Anand Menon, director of The UK In a Changing Europe think tank and a professor of European politics and foreign affairs at King's College London.

"All of a sudden you wake up in a new world at the start of January." Here are some of the changes to movement that people will start to feel almost overnight.

WHAT'S CHANGING?

Even though the coronavirus pandemic has led to a collapse in the numbers of people traveling between Britain and the EU, the end of freedom of movement from Jan. 1 will represent the most tangible Brexit consequence so far.

Under the divorce deal agreed by the two sides December 24, the roughly 1 million British citizens who are legal residents in the EU will



have broadly the same rights as they have now. The same applies for more than 3 million EU citizens who are in the UK.

But British citizens will no longer have the automatic right to live and

work in the EU, and vice versa People who want to cross the border to work and live will have to follow immigration rules and face other red tape such as ensuring their qualifications are recognized.

The exception is people moving between the UK and Ireland, which have a separate common travel area. For many in the EU, the freedom

to be able to travel, study and live anywhere in the 27-nation bloc is among the most appealing aspects of European integration.

Yet some in Britain and other parts of Western Europe became more skeptical about the freedom of movement after a number of former communist nations in Eastern Europe joined the EU in 2004 and many of their citizens moved to the UK and other wealthier countries to work. Concerns over immigration were a major factor in Britain's 2016 Brexit vote.

On January 1, the consequences of that decision will become apparent for British and European citizens alike

NEW TRAVEL RULES?

Although travelling for holidays will remain visa-free, British people will only be allowed to spend 90 days out of every 180 in the EU. while the UK will allow European citizens to stay for up to six consecutive months.

For retired British citizens who have been used to spending more than three months at their second homes on Spain's sun-soaked Costa del Sol, the change may come as a shock.

British travellers in Europe will also have to have at least six months left on their passports and buy their own travel insurance. Britons will no longer be issued the European Health Insurance Card, which guarantees access to medical care across the bloc, but the UK says it is setting up a replacement system so that UK visitors to the bloc and EU cit-izens visiting Britain still have medical coverage.

### **INDIAN ECONOMY IN DOLDRUMS**

Data released by the Ministry of Statistics and Programme Implementation showed that India's Gross Domestic Product had contracted by 23.9% for the April to June quarter. In gross value added terms, the economy had contracted by 22.8%, showed the data. The numbers quantified what was evident all around: the Indian economy is in doldrums. To make matters worse, it is likely



that the numbers will further worsen when the estimates are revised with better-quality data. Things have never been this bad in recorded history. India has never experienced an economic contraction in at least four decades.

### **BATTERED BEFORE OLYMPICS**

As of July 2019, it was expected that the Tokyo 2020 Olympics and Paralympics would have a positive economic impact on Japan. It was estimated that the economic impact would be approximately 20 trillion Japanese yen in Tokyo Prefecture alone. Increase in demand In Tokyo Prefecture alone, the government expected an increase in general demand of around 14 trillion yen, both as an immediate and long term result of the 2020 Olympics and Paralympics. Economic ripple effect along with this estimate of increase in demand, the government calculated the overall economic ripple effect of around 32 trillion yen as mentioned.

### **RECORD-BREAKING US PLUNGE**

Having endured lakhs of deaths during the raging pandemic, the US economy faces a dim outlook as a resurgent coronavirus intensifies doubts about any sustained recovery. A huge plunge in consumer spending as people stayed home and avoided shopping, traveling or gathering in crowds as the virus raged is estimated to have sent the economy sinking at a roughly 32 per cent annual rate in the April-June quarter. That would be more than triple the previous worst quarterly economic fall, a 10 per cent drop set in 1958. Depressed activity in such areas as business investment and government spending also likely contributed to the worst quarterly contraction on records.

### **ITALY BRACES FOR THE WORST**

Italy is starting to plan for what could happen to its economy if the coronavirus pandemic worsens significantly. In a worst-case scenario, the Italian government sees gross domestic product dropping 10.5% this year and expanding only 1.8% in 2021, according to a draft budget outlook document. The scenario draws on a study by Oxford Economics to factor in the impact of a



renewed virus outbreak on the global economy. Prime Minister Giuseppe Conte's cabinet signed off on the budget outlook. Its baseline scenario forecasts that the economy will expand 5.1% in 2021, which might rise to 6%.

In some sectors, demand came practically to a halt in a matter of days as a result of lockdown measures. Governments' economic responses to the crisis is unprecedented, too: \$10 trillion announced just in the first two months, which is three times more than the response to the 2008–09 financial crisis. Western European countries alone have allocated close to \$4 trillion, an amount almost 30 times larger than today's value of the Marshall Plan. Governments have included all shapes and forms in their stimulus packages: guarantees, loans, value transfers to companies and individuals, deferrals, and equity investments.

Markets see roller-coaster ride

The pandemic plunged most countries into recession in 2020, with per capita income contracting in the largest fraction of countries globally since 1870.9 The World Bank's baseline forecast predicts a 5.2% contraction in global GDP in 2020 - the

deepest global recession in decades. Investors saw a massive spike in the VIX in early March as COVID-19 hit the U.S., prompting markets to tumble. In late March, markets began a historic rebound and recovery that brought the VIX back down - but not down to pre-pandemic levels. In June, the VIX had another spike (though much lower than in March), and again around the U.S. election. Shares in the S&P 500 dropped 31% in March before rebounding to new record highs. Industries that took the hardest hit include travel and leisure and retail. By the end of

2020, markets had rebounded and the S&P 500 had returned more than 12%. The techheavy Nasdaq soared to returns of over 40%.The global coronavirus pandemic has brought one of the greatest human and economic consequences the world has ever seen. Stock markets have rocketed on hopes of a potential breakthrough in the search for a vaccine against Covid-19.

# Heavy toll on tourism industry

Before COVID-19, travel and tourism had become one of the most important sectors in the world economy, accounting for 10 percent of global GDP and more than 320 million jobs worldwide. In 1950, at the dawn of the jet age, just 25 million people took foreign trips. By 2019, that number had reached 1.5 billion, and the travel and tourism sector had grown to almost too-big-to-fail proportions for many economies.

The global pandemic, the first of its scale in a new era of interconnectedness, has put 100 million jobs at risk, many in micro, small, and medium-sized enterprises that employ a high share of women, who represent 54 percent of the tourism workforce, according to the United Nations World Tourism

Stand-in captain Rahane leads India to a splendid victory over Australia to level the series at 1-1 after their embarrassing defeat in the first match

### PRESS TRUST OF INDIA

Melbourne. Dec 29: Hungry for redemption, India recorded a win for the ages under an inspirational Ajinkya Rahane, beating Australia by eight wickets in the second Test to level the four-match series 1-1 here Tuesday.

The target of 70 was never a big one but for a team that was bowled out for its all-time lowest score of 36 only 10 days back, one can't fault them if that played at the back of their minds. Shubman Gill (35 n o) and skipper Rahane (27 n o) knocked off the runs in 15.5 overs to complete the victory.

This was after the quartet comprising Jasprit Bumrah (2/54), debutant Mohammed Siraj (3/37), Ravichandran Ashwin (2/71) and Ravindra Jadeja (2/28) showed maniacal consistency over a period of 100 overs on the flattest of decks, where extra bounce became their go-to weapon.

Indian teams, since the turn of the new millennium, have had some memorable overseas victories but when the backdrop and context of this Test at the iconic MCG is recorded for posterity, Rahane and his magnificent bowling unit will find more than an honourable mention in the pages of history.

The Indian teams of yore used to lose stomach for a good scrap after humiliating defeats but not this one. It stood out for the manner of its comeback in the absence of a genius called Virat Kohli and a magician in Mohammed Shami.

India were also hamstrung by Umesh Yadav's calf muscle injury mid-match which reduced a fivepronged bowling attack to four men. But in the last three and half days, Rahane, first with his hundred and then with solid leadership, showed what Kohli meant when he spoke about 'New India'

Along with skills, it was the mental fortitude that shone through as the team didn't take too much time to bury the ghosts of Adelaide and clear the cobwebs in their minds getting Australia all-out for 195 and 200 in two innings
