Bhubaneswar, March 26: The dawnto-dusk Bharat Bandh called by farmer unions protesting against three farm laws, evoked partial response in Odisha Friday. Protestors blocked roads and squatted on trail tracks at some places in the state while shops and market establishments remained closed, official sources said.

The Samkyukta Kisan Morcha (SKM) called the bandh from 6 am to 6 pm to mark four months of the farmers' agitation at Delhi's three borders -- Singhu, Ghazipur and Tikri. The Congress and Left parties are supporting the bandh in Odisha.

Different farmer outfits like Naba Nirman Kisan Sangathan, the Odisha unit of the All India Krishak Sangharsh Samanyova Samiti and others tried to enforce Bharat bandh across the state demanding repeal of the three new farm laws introduced by the Centre. The strike disrupted normal movement of people and vehicles in the state

Several shops and markets in the state capital remained closed and wore deserted looks although vehicular movements and official functions remained normal during the bandh.

The bandh call was given by the Samyukta Kisan Morcha, the umbrella body of farmer outfits from across the country to raise the issue of the controversial farm laws requesting the government to repeal the laws.

"We tried to impose the bandh in different parts of the state pressing for the repeal of the three controversial farm laws and consideration of our long pending demand. We tried to block the movement of vehicles at Master Canteen, National Highways besides countering train movements to impose the bandh and it was successful, Panigrahi said. The agitation was supported by the Odisha Congress, Samajwadi Party, Communist Party of India-Marxist and Community Party of India besides the support of several farmer outfits. Although the BJD had not directly supported the bandh, the party had already ordered closure of schools, colleges and technical institutions in the light of the bandh call. Instructions had been issued by the state government to government employees to come to offices earlier.

No untoward incident was reported from across the state. The Congress

called by farmers protesting the three agri laws was a "big success", the Samkyukta Kisan Morcha said Friday, and claimed that shutdown was observed in many parts of the country, including Karnataka, Andhra Pradesh, Punjab, Haryana, Bihar and Odisha. However, there was minimal impact in Delhi with no report of disturbance in the metro and road transport services, and major markets of the city remaining open during the day. In a statement, the Morcha alleged that its several leaders and cadres were detained by the police in Karnataka and Gujarat during the 'bandh' that marked four months of the agitation at Delhi's three borders -- Singhu, Ghazipur and Tikri. On Friday, the nationwide shutdown started at 6 am and was in force up to 6 pm across the country.

Bhubaneswar, March 26: Keeping in view the rising number of COVID 19 cases in the state and the country, the state government Friday issued a fresh notification restricting crowds for religious festivals slated in the month of April,.

The order issued by the office of the Special Relief Commissioner (SRC) said that public gathering for such festivals would not be allowed during the month citing the threat from the rising cases of COVID 19.

In April, important festivals like Pana Sankranti, Jhamu 🖌 Yatra, Easter and Good Friday are scheduled which are likely to see congregation of public on these auspicious days of different faiths in the state.

'Danda Yatra' and 'Sriram Navami' and others fall in April and people usually congregate to celebrate the festivals during which it is not possible to adhere to COVID appropriate behaviour and such congregations have a potential to cause spread of the virus,"

Bhubaneswar, March 26: Odisha recorded an average of eight rape cases and four murders every day in 2020, according to the white paper on the state's crime scenario tabled in the Assembly Friday.

software Tata conglomerate. It said, "...All the questions of law are liable to be answered in favour of the appellants Tata Group, the appeals filed by the Tata Group are liable to be allowed and (the appeal by) the SP (Shapoorji Pallonji) Group is liable to be dismissed.'

The bench, which dealt with the SP Group's contention regarding separation, said the valuation of the group's shares depends upon the value of the Tata Sons' stake in listed equities, immovable assets and others. "...At this stage and in this court, we cannot adjudicate

on the fair compensation," it added. 'We will leave it to the parties to take the Article 75 route or any other legally available route in this regard," the bench said. The SP Group had earlier valued its holding in the Tatas at ₹1.75 lakh crore.

However, during the hearing in the matter before the apex court, the Tatas had, on December 8 last year, said the valuation of the 18.37 per cent shares of the SP Group in Tata Sons Private Limited (TSPL) is between ₹70,000 crore and ₹80,000 crore. The SP Group had told the top court that Mistry's removal as the chairman of TSPL at a board meeting held in October 2016 was akin to a "blood sport" and "ambush", in complete violation of the principles of corporate governance and in pervasive violation of the Articles of Association in the process.

ITBP deploys retired combat canines as 'therapy dogs' **CAPFs DEPLOY ABOUT 3,500 DOGS FOR A VARIETY OF ROLES IN THE INTERNAL SECURITY DOMAIN**

New Delhi, March 26: In a novel initiative, border guarding force ITBP has decided to utilise the services of its retired combat canines as 'therapy dogs' to help in the early recuperation of personnel undergoing medical treatment and also

ment care. for their specially-abled children. The challenges of life after retirement for the aged and out-ofservice four-legged soldiers has

been a subject of concern for various central armed police forces (CAPFs) that deploy about 3,500 dogs for a variety of roles in the internal security domain -- ranging from detecting hidden explosives to sniffing out terrorists and drugs

and assault and guard duties. The issue was also discussed during a recently-held national conference on police canines that was

conducted by the newly-created cell for this subject in the Ministry of Home Affairs (MHA).

Dogs, at present, who retire from these central forces are usually handed over to animal NGOs or kept at a retirement home within the organisation for post-retire-

A first batch of five dogs who have been living in their 'retirement home' at the ITBP national training center for dogs and animals at Bhanu near Chandigarh have been inducted for a second innings task of being 'therapy dogs'. Deputy Inspector General (DIG) Sudhakar Natarajan, the veterinary chief of the ITBP, tells PTI that Pooja, Tom, Rambo, Rani and

Gravey, who recently retired from active service, are just over 11-yearsold and have served in various anti-Naxal operations and counter-in-



surgency grids of the country along with their handlers accompanying Indo-Tibetan Border Police (ITBP) patrols

"All five dogs have started visiting ITBP hospitals and have given soothing emotional support to patients, that is a welcome break for them from the dreary hospital monotony.

"Also, these dogs have interacted with children with special needs, and the spark seen in their eyes is to be seen to be believed. An immediate connection between the child and dog was remarkable," Natarajan said about the preliminary find ings of the new move.

A compliance report submitted by the border force to its administrative department - the Union home ministry - on Thursday said that the force plans to visit local schools, where specially-abled children are taught, with these 'therapy dogs' to spread joy. The report said the experiment is being watched and analysed.

"Our veteran K9 (canine) heroes have just been deployed as therapy dogs. The response of patients (ITBP troops under treatment in their hospitals) was very encouraging.

"Many are long-term patients and they expressed unalloyed joy in engaging with these dogs in non-verbal communication, purely from the heart. The long term effects on engagement with therapy dogs are being observed," the report said. DIG Natarajan, the brain behind the move, said the aim of the initiative is to ensure that the canine soldiers who served with sincere dedication in the prime of their age and helped to save numerous lives from potential life threats, are taken care off even in their hey days.

"We are fully committed to looking after our darling veteran hero K9s who have served the nation, and now even in their retired life they are contributing as therapy dogs to give emotional support to patients and special children. "Since our dogs are highly trained and socialised, they are being used as a supportive therapy to manage autism and other spectral disorders in children," he said. The DIG, also a veterinarian,

said specially-abled children "connect with our furry darlings directly at the organic emotional level, that is not the case withhuman-to-human interaction, where expectations are involved".

Lokayukta clean chit to senior bureaucrats

Bhubaneswar, March 26: The Odisha Lokayukta Friday gave clean chit to senior bureaucrats of the state in the alleged high profile Covid-19 PPE kit and other medical equipment purchasing scam in 2020. The three-member bench of Lokayukta declared closure of the case on the basis of the preliminary report submitted by state Vigilance directorate March 16.

Earlier, while hearing petitions filed by Sudarshan Das and another social activist, the Lokayukta had directed the anti-corruption wing of the state to look into the matter. Vigilance department was asked to submit the report by February 15, 2021. Upon failing to submit the report in time, the department sought one month extension.

Vigilance has reportedly denied any irregularities in procurement of personal protective equipment (PPE) kits, masks, nebulisers, and other equipment by the Odisha



State Medical Corporation Limited (OSMCL) when the pandemic was at its peak in 2020.

Meanwhile, both the complainants expressed their dissatisfaction over Lokayukta's decision and informed about moving Orissa High Court against the verdict.

Odisha logs 234 new Covid cases

Bhubaneswar; March 26: Odisha's Covid-19 tally Friday surged to 3.39.694 after 234 more people tested positive for the infection.

The new cases were detected in 23 of the state's 30 districts, with 139 reported from different quarantine centres while the remaining 95 were local contact cases. Nuapada district recorded the highest of 33 new cases followed by Khurda district of which the state capital Bhubaneswar is a part (32), Cuttack (29) and Bargarh (24).

Nuapada district

The state's coronavirus death toll remained at 1,919 as there was no fresh fatality since March 22. This apart, 53 other Covid-19 patients have also died due to comorbidities in the state, he said.

The state currently has 1,313 active Covid-19 cases while 3,36,409 patients have recovered from the highly infectious disease

Odisha has so far conducted over 89.20 lakh sample tests for Covid-19 including 28,662 Thursday while the state's positivity rate stands at 3.81 per cent.

Kendrapara, March 26: Hundreds of workers of Baladevjew Powerloom are yet to get their dues even though 23 years have elapsed since the closure of the government owned textile mill, sources said.

The issue came to fore recently after a delegation of the aggrieved workers, led by labour leader Muralidhar Das, submitted a memorandum in this regard to the district administration.

The saris, towels and other clothes produced by the powerloom were once very much popular in Kendrapara district.

"Kendrapara district has been deprived of any industry after the closure of the powerloom. Over 200 workers are yet to receive their arrears even though the textile mill had been closed around 23 years ago. We have raised the issue with the district administration and the elected representatives several times but to no avail," Das said.

In the meantime, at least 10 workers of the powerloom have passed away while many others are languishing in financial miseries.

Many workers are suffering from old-age ailments and waiting for some assistance from the district administration, sources said. Baladeview Powerloom had

started manufacturing clothes in 1969. However, the state government had decided to close the textile mill in 1998, two years after it

started incurring losses. The closure of the powerloom pushed many into financial miseries. At least, 200 workers of the powerloom have been given VRS since September 30, 2001. However, these workers are vet to get their arrears from September.

Undying resolve: Women with sticks lead as Green Warriors

Nayagarh, March 26: Several studies and reports have found that local communities play a major role in the conservation of forests.

A great reminder of this is the Chipko Movement, where women resisted deforestation in Uttar Pradesh (now Uttarakhand).

A case in point will be the tribal women of Odisha, who have been guarding their forests against smugglers for many decades -- voluntarily. Armed with nothing but a stick, women go into local forests in groups of three to six to drive the timber thieves away. If they catch one, they issue a warning and confiscate the produce being smuggled. When matters escalate, they either bring these thieves to the village meeting and demand a public apology or fine or involve an NGO to initiate police action.

This is thengapali, a practice where every household takes turns to patrol their community forest with a stick (thenga means stick and pali means turn). Thengapali started in Nayagarh district in the early 1970s but became popular in the 1990s when women came forward to

protect forests alongside men. Women are solely responsible for keeping vigil on the forests in at least 300 villages in Navagarh. In the Gunduribadi village of the district. the women-led forest protection committee has rejuvenated at least 500 acres of forest land as smug-

gling of timber and other forest produce has reduced. "We can spot the Giant Indian Squirrel in the Nayagarh belt, which wasn't the case a decade ago. Even the soil moisture retention has improved," said Manas Mishra,

an environment activist who has studied the forest-dwelling communities of the Navagarh-Khorda belt. Thengapali has spread to other districts as well. The presence of women sentinels in smaller pockets of the Mayurbhanj district, such as Punasia, has brought down the menace of smuggling. They provide an extra layer of surveillance to the forests within the Similipal Tiger Reserve in Mayurbhanj. Dhaneswar Mahanta, who works with Vasundhara in the Reserve limits, said, "The forest department deploys two to five guards per forest. On that, these committees send at least three volunteers through the day."

The practice has also crossed over to the bordering state of Jharkhand and has become a case study that is now studied in the schools of Hampshire in England.

According to Y. Giri Rao, executive director of Vasundhara, a non-profit organisation that documents the forest conservation methods in Odisha, natural resources mean a lot more to women than men. "If the forest cover is depleted. the women would have to walk an extra mile to collect fuel for their daily needs, he said.

This dependence encouraged Sudamani Mahakud to take up thengapali at Punasia village. "If I need fuel to cook food. I can take leaves and twigs from the forest. If I need food to eat, the forest can give me greens and tubers. Some trees also have medicinal value. They are a source of food for the cattle as well. What more reasons do I need to protect the forest? I exist because the forest does," explained the 65-year-old, who has been guarding the forests for over two decades.

No sooner did women start protect ing local forests, the conflict with the smugglers reduced. "If a group of men would confront smugglers, there were chances of fights. With women, there would only be verbal exchanges. In most cases, the smugglers belonged to neighbouring villages and so they would avoid confrontation with these women," said Sanjukta Basa, who runs NGO Sangram in the Mayurbhanj district.

The rules of patrolling are decided mutually, factoring in when women can take time off from their domestic duties. If three women go for the 6 am-9 am shift, the second group goes out between 9 am and 12 pm.

This continues till 9 pm or 11 pm. Guidelines to collect the forest produce are also laid down. For instance, a villager can take bamboo only after getting approval from the village committee.

HC gets tough on Punjab, its tainted cops

he Amarinder Singh-led Congress government in Punjab is getting flak from the Punjab and Haryana High Court and the issue has ramifications across the country. The court has directed the state government to explain how and why it has chosen to appoint Punjab Police Service (PPS) officers to IPS-cadre posts of SSPs in the state. The court has held that these appointments are in violation of the IPS cadre rules and has also impleaded the Centre as a party to look into these "apparent violations".

The court noted the instance of PPS officer Rajinder Singh Sohal who was convicted in a criminal case but has been posted as the SSP of Gurdaspur, a post meant for the IPS cadre.

Further, the court has issued a show-cause notice to Additional Chief Secretary (Home) Anurag Aggarwal for "filing of false affidavit" in the matter. Aggarwal may face perjury proceedings if the Court is not satisfied with his response. The court has directed the state government to remove tainted or convicted police officers from duty until the policy is framed on action to be taken against these officers. Future proceedings in the court will be watched with great interest. Watch this space for updates

Bihar struggling to fill shortage of IAS officers

The Nitish Kumar-led NDA government in Bihar is increasingly re-employing retired officers. Its latest appointment is of retired IAS officer

Deepak Kumar as the Principal Secretary to the Chief Minister. Kumar, a 1984-batch officer retired in February and was promptly rehired.

Sources say the government has little choice when it comes to appointments due to the acute paucity

of IAS officers in Bihar. Bihar apparently has only 202 IAS officers against a sanctioned strength of 359 officers. Not surprisingly, the deficit has impacted the quality of administration. It is not unusual for senior officers to be burdened with three or four departments each, apart from their principal task. It is learnt that Nitish Kumar has requested the Centre to allot 54 IAS of-

ficers based on the civil service exam last year. It is reportedly also facilitating appointments to 22 posts from the 2018 batch, 15 posts from the 2019 batch and 16 posts from the 2020 batch under the promotion quota.

Goa chief secretary in the eye of the storm

The Goa government's move to place a serving IAS officer in the State Election Commission (SEC) has backfired badly for not just Chief Minister Pramod Sawant but also the state chief secretary Parimal Rai. The Supreme Court has cancelled the recent appointment of state Law Secretary Chokha Ram Garg as the state election commissioner. In its stinging order, the apex court noted that the move was "a mockery" of constitutional mandate.

The court has further issued directions to all states and UTs to cancel similar appointments and to appoint only "independent persons to this high constitutional office", nipping in the bud any similar approaches that other states may have been contemplating. Sawant's 'innovative' approach is now unlikely to 'inspire' other states from attempting something along similar lines.

While political reactions to the decision have been muted, however, within babu circles in Panjim, it is Chief Secretary Rai who has become the most visible face to take the blame for this harsh indictment by the court.

t feels strange to have known a country since its birth. For much of 1971, Bangladesh (then East Pakistan) was engaged in a war for independence. With US President Richard Nixon standing firmly behind Pakistan as President Yahya Khan's army tried to crush the independence movement by resorting to rape and genocide, millions of Bangladeshi refugees poured into India. I was then an undergraduate in Delhi and joined a team of students to work in the sprawling refugee camps that had sprung up in West Bengal and Odisha. Full-fledged aerial war with Pakistan broke out on December 2. I vividly remember catching

the night train in Kolkata to return to college during a curfew, under orders to keep all the lights off in

> the compartment. This was the high point of Indian Prime Minister Indira Gandhi's career. She had opened India's doors to the refugees and intervened militarily to support Bangladesh, refusing to cave in to US pressure, which included sending the Seventh Fleet into the Bay of Bengal. Khan's army surrendered to an Indian-Bangladeshi allied force on December 16, 1971. Bangladesh had already declared independence on March 26, but it was effectively born that day in December.

At independence, Bangladesh was one of South Asia's poorest countries - poorer than India, and much poorer than Pakistan. Described by then-US National Security Adviser Henry Kissinger as a "basket case," it floundered for several years, a vast archipelago of poverty and deprivation. Things got worse in 1974, when the Nixon administration suddenly cut off food aid to Bangladesh while the country was in the midst of a famine, on the grounds that it was

a half-century of independence, the country has become a case study in economic development that few would have predicted. When its GDP growth rate surpassed Pakistan's in 2006, many dismissed it as a one-off fluke. But Bangladesh has outpaced Pakistan every year since then, and - astonishingly -

is now one of the world's fastestgrowing economies

Bangladesh's GDP per capita now closely rivals India's and significantly exceeds that of Pakistan. Average life expectancy, at 74, is higher than in India (70) and Pakistan (68). The country is a leading global exporter of readymade garments, and other sectors are taking off, too. Bangladesh's pharmaceutical industry, for example, is thriving. With 300 companies (several of which conduct research) the country now meets 97% of domestic demand, and is beginning to export globally

True, Bangladesh still has much poverty and hardship, rising inequality, and an uncertain future trajectory. Climate change and rising sea levels continue to pose significant dangers, and political instability could yet re-emerge and disrupt economic progress.

Nevertheless, Bangladesh's remarkable economic transformation - the World Bank now classifies it as a lower-middle-income economy - deserves praise and can offer important lessons for today's low-income countries.

Bangladesh's rise is a story of both deliberate interventions and

chance. The country owes a large part of its success to progressive NGOs, most notably Fazle Hasan Abed's BRAC and Muhammad Yunus's Grameen Bank. One particular intervention that played a larger role than anyone expected was Grameen Bank's early decision that microfinance credits would go to the senior female member of the household. I have argued elsewhere that this gave women greater voice in the home. which in turn helped divert household expenditure toward child welfare. This is one of the main reasons why Bangladesh has made strong progress on development indicators such as life expectancy and literacy, and in combating malnutrition.

Bangladesh has one of the world's largest microfinance sectors, which has enabled house holds to break out of the debt trap and start their own small businesses. Using a computable general equilibrium model, Selim Raihan, SR Osmani, and MA Baqui Khalily have shown that microfinance did more than just help the households that received money. By bolstering fiscal and monetary policies, it boosted the country's GDP

by 9-12%.

But Bangladesh's success has also had a lot to do with luck. The Indian subcontinent has complex labor laws, notably the Industrial Disputes Act, which predates Indian and Pakistani independence in 1947, and has thwarted the emergence of large manufacturing firms able to realize economies of scale. Pakistan repealed the law in 1958, but for the wrong reasons, to enable big corporations to control workers. Moreover, it did so in a ham-handed way, thereby contributing to labor exploitation and crony capitalism.

Bangladesh, having once been part of Pakistan, was born without the law's baggage. But, unlike Pakistan, the country went on to develop its own labor regulations that were flexible without giving corporations unfettered power. This played an important role in Bangladesh becoming a successful global manufacturing hub.

Finally, a crucial political factor underpins Bangladesh's economic success. Prime Minister Sheikh Hasina has often been criticized, but she has made one essential contribution to the country's upward trajectory. Although Bangladesh's constitution guarantees religious freedom, it has been challenged by fundamen talist groups that renounce what the prominent Bangladeshi commentator Abul Barkat has described as the "liberal and hu manistic origin of Islam in East Bengal." Sheikh Hasina, who is reputed to be innately secular, has kept these destructive forces at bay.

Many countries have succumbed to religious fundamentalism, with disastrous consequences for their economies. Bangladesh is notable for having withstood this danger. Its buoyant, vibrant economy, now with a 50-year track record, is testimony to this success.

Butterscotch

Don't look to me for culinary advice – I can burn boiled eggs. My books ay that butterscotch is indeed a form of caramel, but made with butter and brown sugar, as you describe, plus a touch of vanilla. That's the limit of my expertise. Unfortunately, I can't do that much better with your second query. Nobody seems to know. Some argue that the second part is actually scorched, from the manner of its making. The Collins Dictionary says that it may have been called that because it was first made in Scotland. Neither suggestion is supported by evidence, though the Scottish link seems plausible because Keillers of Dundee was one firm that made butterscotch commercially. The Oxford English Dictionary's first citation (indeed, its only citation) is from 1865. It's not hard to take that back a while: the first example I can find is from The Boy's Autumn Book of 1847. Although that was published in New York it quotes a British itinerant seller of sweets. Wikipedia states that the first maker of butterscotch was Samuel Parkinson of Doncaster, in 1817. The firm did make it during the nineteenth century and Doncaster became famous for it. The Parkinson papers are deposited at the Doncaster Archives, from where Dr Charles Kelham tells me they begin only in 1848, although an article published in The Doncaster Review in September 1896 asserts that "It was on the 11th of May 1817, that the late Mr. Samuel Parkinson commenced the manufacture of butter-scotch." If he did so, it may be unlikely, from the lack of written evidence before 1847, that he called it by that name. Other writers argue that the sweetmeat has no link with Scotland. Charles Earl Funk noted in Horsefeathers in 1958: "All directions for the preparation of this candy after it is properly cooked close with some such statement as: Pour upon oiled paper or well-buttered pan and when slightly cool score with a knife into squares." He points out that one sense of scotch was to score or cut a shallow groove in something.

I made my effort toward the Senate and reached out to many Republican Senators, pursued to get the Bill passed, however success was yet far off and the period of hardship was not over. There was though a glimmer of hope in May. The Senate Foreign Relations Committee's business meeting was called and Tibet was on the agenda. But then the business meeting was adjourned and nothing really happened from May onwards. I came to the US in October 2020 and the environment wasn't conducive.

In November 2020 I met the Democratic staff and Republican staff online and strategised on how we should go about the Bill. I was told that in the second week of December: the business meeting will be called and Tibet will be on the agenda again. The Bill had to pass on the Senate floor first before it could go to the House, which meant a lot of work was to be done and many things accomplished before the Bill could be presented. The Senate version had amend-

ments including the acknowledgment of the Central Tibetan Administration (CTA) as an institution that can reflect the official representative of the Tibetan diaspora all over the world and as the President of CTA. We wanted this major amendment, and as it goes every amendment has to be put to vote. We got the major breakthrough when the Tibet Bill was taken out of all other major Bills. This would mean a lot of focus on the agenda of Tibet.

The Tibet Policy Act Bill 2002 and Tibet Support and Policy Bill of 2020 are actually one. The later is actually the improvement, amendment and addition to the previous Bill. The 2002 Bill addresses the situation inside Tibet as occupied Tibet, gross human rights violations, and the appointment of a special coordinator to help in pursuing dialogue between the envoys of His Holiness the Dalai Lama and the Chinese representatives. The Bill also calls for opening of US office in Lhasa that will help in providing funds, scholarships and other things, this will help the Tibetans to develop an understanding and get a formal education

in developing fields of science which would further strengthen the existence and survival of independent Tibet. In addition to it, the Tibet Support and Policy Bill of 2020 strongly calls for the religious freedom of the Tibetan people. The Chinese government should not interfere in the reincarnation process, if they, sanctions will be imposed on them.

Beijing's stand and the Chinese Foreign Ministry's stand on Tibetans government-in-exile is that of a separatist organisation insisted "no one should support it; no one should meet with their officials". This Bill counters the Chinese stand and acknowledges the CTA and the Tibetan freedom movement thereby sending a message all over the world. I am glad that six million Tibetans inside Tibet will get to hear the positive development and support for Tibet. So, it recognises the Tibet Issue as an international issue.

K'taka bans festivals in public places to curb Covid cases 'No question of hiding Covid numbers'

Bangalore, March 26: In view of the surge in cases in the second Covid-19 wave, Karnataka has banned celebrations of all ensuing festivals in public places to contain the pandemic across the southern state, a top official said Thursday.

"Celebrations of festivals like Holi, Easter, Shab-e-Barat and Ugadi in coming weeks will not be allowed in public places to prevent large gatherings or mass congregations for containing the pandemic," said state chief secretary P Ravi Kumar in an order in Kannada here

According to the state health bulletin, a record 2,523 new cases were reported Wednesday after 4 months, taking the state's Covid tally to 9.78.478, including 18.207 active cases.

As the epicentre of the virus, Bangalore registered 1,623 fresh cases in a day, taking its Covid tally to 4,22,859, including 12,472 active cases till date.

"The city civic administration and police are directed to not allow people to gather in large numbers

Bangalore: Karnataka Health Minister K Sudhakar said Friday all factual data on Covid-19 is being made public. There was no question of hiding numbers and the government has no such intention nor is it possible to hide any details, he said

"We are not hiding any statistics regarding COVID-19. All opposition leaders are welcome to give their valuable suggestions for controlling Covid. They can also figure out any flaws in the system, Sudhakar said. He said the Chief Minister may call an all party meeting to discuss the issue.

"We are free to discuss anything

in public grounds, parks, markets and religious places, as ensuring social distancing will be difficult." said Kumar, as the state executive committee chairman of the state disaster management authority.

Deputy Commissioners in all the remaining 30 districts across the state have also been directed to ensure strict compliance of the order by all the concerned to prevent the virus spread

in this regard," he was quoted as saying by his office in a release. He said the Manipal institute alone had 704 cases and it has been sealed. Stringent measures were being taken to curb spreading. Maharashtra reported 35.000

cases yesterday while over 2,000 were recorded here.People should follow guidelines and youngsters should voluntarily take the elderly at home for vaccination, the min ister said. The idol, according to him, belongs to the Hoysala era -- the dynasty that had ruled the region from 10th century to 14th century and had built monuments such as the Chennakesava temple in Belur and Hoysaleshwara Shiva Temple in Halebeedu in Hassan district. An ASI officer has been dispatched to look into the discovery and he may submit his report by Monday, Bajpai said.

Law and order in UP has improved, says NCRB data



Lucknow, March 26: Despite the opposition campaign against the Yogi Adityanath government on the law-and-order issue, the latest data released by the National Crime Records Bureau (NCRB) states that the crime situation in the state has improved.

The NCRB data says that UP has witnessed a sharp reduction of 45.43 per cent in rape cases and has the lowest figures of crimes against women compared to the 21 major states of the country.

This has played an important role in changing the image and perception of Uttar Pradesh globally and re-establishing its iden-



tity. According to an official release. the state has seen a significant fall in the number of rape cases from 3419 cases in 2016 to 2317 cases in the year 2020.

The UP government has also recorded the highest conviction rate in the cases of crimes against women and cyber-crime in the country, says the report by NCRB. Uttar Pradesh has taken several



steps to check crime against women

which include anti-Romeo squads

been sent behind bars till the year 2019.Despite being the most populous state, UP has also seen reduction in cases of murder.

With a density of 690 persons per square km, Uttar Pradesh has witnessed a sharp decline of 19.80 per cent from the year 2016 to 2020, in cases of murder.

Murder cases registered a reduction of 5.9 per cent in 2017. As many as 28,653 killings were recorded in 2017, down from 30,450 in 2016, the NCRB report said.

ISRO to replicate NASA partnership model in India Allahabad HC shut till April 4 over **Covid resurge**

TO COORDINATE JOINT RESEARCH ACTIVITIES BETWEEN ISRO CENTRES AND IIST, AKIN TO THE CALTECH-JPL MODEL, A DEDICATED FRAMEWORK HAS NOW BEEN PUT INTO PLACE, WITH CAPACITY BUILDING PROGRAMME OFFICE LOCATED AT ISRO HEADQUARTERS

Bangalore, March 26: The ISRO is embarking on a mission of a different kind by taking the Indian Institute of Space Science and Technology (IIST) to a much higher, futuristic research orbit. The Bangalore-headquarteted space agency is striking a partnership with the IIST -- something similar to the JPL- Caltech model in the United States.

JPL (Jet Propulsion Laboratory) is federally funded by US space agency NASA and managed by Caltech (California Institute of Technology).

To coordinate joint research activities between ISRO centres and IIST, akin to the Caltech-JPL model, a dedicated framework has now been put into place, with CBPO (Capacity Building Programme Office) located at ISRO headquarters here as a focal point. An Advanced Space Research Group has been created to identify application-oriented

research projects of importance to ISRO (Indian Space Research Organisation) centres and matching with the interests of IIST faculty.

An Empowered Overseeing Committee has been constituted to review and approve the proposals.

CBPO Director, ΡV Venkitakrishnan said that under the initiative, "very advanced, totally new and futuristic projects" -- nothing that has been done by ISRO -- would be taken up.

"Twenty-eight to 30 projects have been identified", he said.

It's a mix of two-years, 3-5 years, and seven-year projects that would be pursued by IIST faculty.

Thiruvananthapuram-based IIST, an autonomous institution under the Department of Space (DoS) and a 'Deemed to be University', is similar to Caltech, according to him.

Asked about the time-frame by which he expects the partnership to reach the JPL-Caltech level, Venkitakrishnan said: "We are expecting within eight to ten vears. That is our ambition, our

It was noted that NASA's JPL founded by Caltech faculty, is the leading centre for the robotic exploration of the solar system. It also conducts Earth-orbit and astronomy missions.

aim".

JPL's workforce includes a diverse population of scientists, engineers, technologists, developers, communicators, designers, safety experts and business administrators.

Venkitakrishnan said through the Post-doctoral fellowship programme offered by IIST, ISRO wants to attract more and more talent towards space research.

He also said that the Union government has been requested to accord 'Institute of National Importance' status to IIST. Once approved, various ISRO centres would become constituent learning centres, allowing IIST to have a wider off-campus, he said.

A bench headed by Chief Justice S A Bobde refused to hear at this stage the intervention application filed by United Nations special rapporteur in the matter. "We will not hear you today. There is serious objection to it." the bench told the counsel appearing for the UN special rapporteur. "We are closing it for order," said the bench, which also comprised Justices A S Bopanna and V Ramasubramanian, after hearing submissions on the fresh plea During the arguments, advocate Prashant Bhushan, appearing for the petitioner, said Rohingya children were subjected to killing, maiming and sexual exploitation

and Military in Myanmar has failed to respect international humanitarian law. Solicitor General Tushar Mehta, appearing for the Centre, said he is stating the problems which persist in Myanmar.

He said they are not refugees at all and this is the second round of litigation as the top court had earlier dismissed an application filed by the petitioner.

"There was a similar application for Assam earlier. They (petitioners) wanted that no Rohingya be deported, we had said that we will follow the law. They are illegal immigrants. We are always in touch with Myanmar and when they confirm that the individual is their citizen, then only deportation can take place," he said. The bench asked can it be said that the government will deport only when Myanmar accepts. Mehta said yes, the government cannot send an Afghan national to Myanmar. We cannot be the capital for all illegal immigrants," Mehta said. Bhushan referred to a verdict of the International Court of Justice

(ICJ) and argued it has said that Myanmar has not presented any concrete measures aimed specifically at recognising the rights of the Rohingyas to exist as a protected group.

SC junks plea seeking ban on sale of electoral bonds

New Delhi, March 26: The Supreme Court Friday junked the allegations that the Electoral Bonds Scheme was shrouded in anonymity, leading to further anonymity in the financing of political parties by corporate houses, both in India and abroad.

The top court dismissed the pleas filed by two NGOs -- Association for Democratic Reforms and Common Cause -- seeking ban on sale of electoral bonds ahead of the Assembly elections in five states/UT. A bench comprising Chief Justice S.A. Bobde, and justices A.S. Bopanna and V. Ramasubramanian

noted that the main attack of advocate Prashant Bhushan, representing the NGOs, against the Electoral Bonds Scheme was that it allowed the donors of political parties to maintain anonymity which is not healthy for a democracy.

In response, the bench said: "We do not know at this stage as to how far the allegation that under the Scheme, there would be complete anonymity in the financing of political parties by corporate houses, both in India and abroad, is susainable.

The bench noted that if the purchase of the bonds as well as their encashment could happen only through banking channels and if purchase of bonds is allowed only to customers who fulfill the KYC norms, the information about the purchaser will certainly be available with the SBI, which alone is authorised to issue and encash the bonds as per the Scheme.

"Moreover, any expenditure incurred by anyone in purchasing the bonds through banking channels will have to be accounted as an expenditure in his books of accounts.' noted the bench

Under Clause 8(1) of the Electoral Bonds Scheme, 2018, the bonds under the Scheme are made available for purchase for a period of 10 days each in the months of January, April, July and October.



Bhushan also cited various letters written by the Reserve Bank of India as well as the Election Commission to contend that they had serious reservations about the Scheme. "It is true, as seen from the correspondence, that RBI has had

some reservations. But it is not correct to say that the RBI and the Election Commission of India opposed the Electoral Bond Scheme itself." observed the bench.

The top court also added that it is also not correct to say that the RBI was opposed to the Scheme in principle. RBI's objection was to the issue of bonds in scrip form rather than in demat form, it said.

Attorney General KK Venugopal submitted that the Scheme was intended to prevent unaccounted money having a sway in the elections and that under the scheme the donors are obliged to operate only through banking channels.

"This, according to the learned

Attorney General, curbed the menace of black money playing a huge part in the elections. Rakesh Dwivedi, learned senior counsel for the Election Commission of India, supported the Scheme," noted the bench.

The bench said the purchase as well as encashment of the bonds, happening only through banking channels, is always reflected in documents that eventually come to the public domain.

"All that is required is a little more effort to cull out such information from both sides (purchaser of bond and political party) and do some match the following," added the bench.

New Delhi, March 26: As parts of the world open up and hybrid work becomes a reality amid the pandemic, about 62 per cent of employees said working remotely makes them happier, according to a new survey Friday.

About 56 per cent of employees said they are more productive when working remotely and 61 per cent said they can get more done in an eight-hour workday when remote, said the Forrester study commissioned by LogMeIn, a leading provider of Cloud-based solutions GoToMeeting.

However, only five per cent of decision makers surveyed believe remote workers are more productive, and 70 per cent said employees in the office are more trustworthy.

The study showed that nearly three-quarters of workers said the pandemic made them want to work more remotely in the fu-



ture, with 83 per cent of employees saying that they are more likely to stay at their company if they are allowed to work flexibly. About 60 per cent of respondents said they were even willing to accept less pay in a trade for flexibility.

The study was conducted using two online surveys -- one of 582 remote work decision-makers, such as those leading human resource

or IT departments, and a second survey of 427 employees -- each at global organisations of 10-2,500 employees, shows they may not be.The research suggests that companies need to invest in establishing flexible work policies and programmes, and address a sizeable disconnect in trust between decision makers and employees.

However, further experimental validations are being done to prove that it could, indeed, be a potential game-changer for space farming. The authors are looking forwardto more exciting discoveries in collaboration with NASA's JPL.

SINGAPORE: Reeling from the blockage in the Suez Canal, shipping rates for oil product tankers have nearly doubled this week, and several vessels were diverted away from the vital waterway as a giant container ship remained wedged between both banks.

The 400-metre-long Ever Given has been stuck in the canal since Tuesday and efforts are under way to free the vessel although the process may take weeks amid bad weather.

Shoei Kisen, its Japanese owner, denied a news report that it aimed to dislodge it by Saturday night, saying refloating efforts were ongoing. Separately, the Suez Canal Authority said it welcomed a US offer to help. The suspension of traffic through the narrow channel linking Europe and Asia has deepened problems for shipping lines that were already facing disruption and delays in supplying retail goods to consumers.

ENTIRE CREW OF EVER GIVEN IS INDIAN; ALL SAFE

The entire crew of Ever Given, the container ship that is stuck in the Suez Canal since Tuesday blocking traffic in one of the world's busiest waterways, is Indian and is safe, said the company managing the container. In a report, news agency The Associated Press said Bernhard Schulte Shipmanagement, the company that manages the Ever Given, said the ship's 25-member crew is safe and accounted for. More than 30 oil tankers have been waiting at either side of the canal to pass through since Tuesday, shipping data on Refinitiv showed. About two dozen ships could be sighted from the shores of Port Said Friday morning, as the backlog built up along the Egyptian coast.

At least four Long-Range 2 tankers that might have been headed towards Suez from the Atlantic basin are now likely to be evaluating a passage around the Cape of Good Hope, Braemar ACM said. Each LR-2 tanker can carry around 75,000 tonnes of oil.

The impact of the shipping delays on energy markets is likely to be mitigated by demand for crude oil and liquefied natural gas (LNG) being in the low season, analysts said. Several LNG tankers have been diverted, one Singapore-based shipbroker said, adding that sentiment for LNG tanker

SUEZ BLOCKAGE IS HOLDING UP \$9.6BN OF GOODS A DAY

The stranded Ever Given mega-container ship in the Suez Canal is holding up an estimated \$9.6 billion of goods each day, according to shipping data. This works out at \$400m an hour in trade along the waterway which is a vital passageway between east and west. Data from shipping expert Llovd's List values the canal's westbound traffic at roughly \$5.1 billion a day, and eastbound daily traffic at around \$4.5bn. Its blockage is causing huge tailbacks of other ships trying to pass through the Suez Canal. The canal, which separates Africa from the Middle East and Asia, is one of the busiest trade routes in the world, with about 12% of total global trade moving through it. According to Lloyd's List tracking data there are more than 160 vessels waiting at either end of the canal. These include 41 bulk carriers and 24 crude tankers. Along with oil, the sea traffic is largely consumer products such as clothing, furniture manufacturing components and car parts. BIMCO, an international shipping association, says the delays will only continue to grow and affect supplies. "For each day of delay my thought is it will take two days to undo the delays," said Alan Baer, president of logistics provider OL USA.

What is the Suez Canal, and who controls it?

The Suez Canal is a man-made waterway linking the Red and Mediterranean Seas. It belongs to Egypt.

When it opened in 1869, the canal increased the ease of global trade by offering a route that circumvented the need to round the horn of Africa. It's since remained crucial to international trade, including for the oil sector.

In 1956, Israel, Britain, and France invaded Egypt in an attempt to seize control of the strategic waterway after the country nationalized it. Their forces later withdrew. In 2015, Egypt launched a major and costly renovation of the canal. By some estimates, 12% of global trade now passes through it.

How did the vessel get stuck?

Cargo ships cross the narrow passageway one-by-one to avoid mishaps.

On Tuesday, a sandstorm reportedly hit the more than 1,300-foot Ever Given, decreasing visibility and battered the ship with heavy winds. That disruption caused the ship to become wedged sideways across the canal. In the heavy winds, for example, the ship's cargo could have formed a sail-like effect, propelling it off course. The vessel is just at the maximum length permitted for a ship to use the canal, so it also has very little wiggle-room. It is, for comparison,

How has the incident affected international trade?

The longer the Suez Canal remains blocked, or partially blocked, the more painful the financial repercussions are expected to be. Oil prices rose Wednesday due to fears over deepening disruptions in global trade, before falling again.

There's a backlog of some 237 ships left waiting, which could be carrying anything from live animals to natural gas, according to Bloomberg. On Tuesday, after the ordeal began, there were only around 100 ships waiting in line. Wednesday the number rose to

around 185. In the meantime, Egypt has opened up an alternative, though smaller, area of the canal. Lloyd's List, a shipping journal, estimated that each day the canal is closed some \$9 billion worth of goods are affected, the Associated Press reported. Delays at the canal will impact unloading schedules at other ports and docks, which can delay goods en route to producers. suppliers and consumers.

Men forced to rape family members in Ethiopia's Tigray region: UN

New York, March 26: More than 500 rape cases have been reported to five clinics in Ethiopia's Tigray region, the United Nations said on Thursday, warning that the actual numbers might be far higher.

"Women say they have been raped by armed actors, they also told stories of gang rape, rape in front of family members and men being forced to rape their own family members under the threat of violence," Wafaa Said, deputy UN aid coordinator in Ethiopia, said in a briefing to UN member states in New York

She said at least 516 rape cases had been reported by five medical facilities in Mekelle, Adigrat, Wukro, Shire and Axum.

"Given the fact that most health facilities are not functioning and also the stigma associated with rape, it is projected that actual numbers are much higher," she added.

Ethiopia's UN ambassador, Taye Atskeselassie Amde, told Reuters his government took the allegations of sexual violence "very seriously" and had deployed a fact-finding mission. "Ethiopia has a zero-tolerance policy for sexual crimes and anyone found responsible for the despicable acts will be held accountable to the fullest ex-



tent of the law." he said. Dozens of witnesses in Tigray have told Reuters that soldiers from neighbouring Eritrea routinely killed civilians, gang-raped and tortured women and looted households and crops during the conflict. Eritrea's Information Minister Yemane Gebremeskel, responding in general terms to the UN briefing, said Friday that sexual violence and rape "are

an abomination to Eritrean society"

Amazon denies workers 'pee in bottles'

San Francisco, March 26: Amid a mounting evidence of allegedly ill-treating its low-paid workers, Amazon has denied exploitative working conditions at its facilities, including forcing exhausted work ers to 'pee in bottles'

Replying to a tweet from US Representative Mark Pocan (D-WI), the ecommerce behemoth said the company's union-busting tactics allegations are baseless

"Paying workers \$15/hr doesn't make you a 'progressive workplace' when you union-bust & make workers urinate in water bottles," Pocan said in a tweet Thursday.

Amazon replied: "You don't really believe the peeing in bottles thing,

do you? If that were true, nobody would work for us. The truth is that we have over a million incredible employees around the world who are proud of what they do, and have great wages and health care from day one"

'We hope you can enact policies that get other employers to offer what we already do," the company further stated.

Once the Twitter war started, several iournalists and people who have documented such incidents at Amazon facilities began flooding the Web. Journalist James Bloodworth, whose 2018 book titled 'Hired: Six Months Undercover in Low-Wage Britain,' documented his experience of low-paid work for companies including Amazon.



"I was the person who found the pee in the bottle. Trust me, it happened," Bloodworth responded to Amazon tweet.

Lauren Kaori Gurley, a labor reporter with Motherboard tweeted: "As a labour reporter who covers Amazon extensively...I can say Amazon delivery drivers not having a time or place to pee is one of the most universal concerns I hear about

The Intercept published a report

on Thursday citing formal policy documents and emails from Amazon, detailing "more cases of drivers urinating into bottles" and even resorting to "defecating into bags'

'The practice, these documents show, was known to management, which identified it as a recurring infraction but did nothing to ease the pressure that caused it. In some cases, employees even defecated in bags," the report mentioned, detailing company's poor working conditions.

"We've noticed an uptick recently of all kinds of unsanitary garbage being left inside bags: used masks, gloves, bottles of urine," reads anemail from an Amazon logistics manager provided to The Intercept.

EIL said it paid ₹699.99 crore for 3.21 crore shares in NRL while OIL bought 39.84 crore shares for ₹8,675.96 crore. "Chairman and Managing Director OIL, who is presently a nominee director of OIL on the board of the Target Company (NRL) would be designated as Chairman,' it said.

Existing directors nominated by BPCL on the board of NRL would resign and rights of BPCL to appoint directors would be extinguished, it said. BPCL sold shares in NRL at a price of ₹217.75 per share, totalling ₹9,875.96 crore

NRL operates a 3 million tonnes per annum oil refinery in Assam. OIL currently holds 26% stake in NRL while Government of Assam has around 12.35%. Post NRL sale, BPCL would be left with three refineries at Mumbai, Kochi (Kerala) and Bina. The government is selling its entire 52.98% stake in BPCL in the nation's biggest privatisation till date.

Air India may get new buyers in May-June

Speaking at an economic meet, the Union Minister for Civil Aviation, Hardeep Singh Puri said that financial bids for the national carrier will be submitted sometime in May. He said that the timeline for the submission of financial bids was decided in a meeting Thursday.

"Yesterday there was a meeting. They have decided that the finan-



cial bids have to come in within 64 days...the financial bids will be in sometime in May...after that it's a question of taking a decision and handing over the airline," he said. He added that earlier attempts at

privatisation were not successful because the attempts were "half hearted". The airline which did not attracted any buyer for long now has witnessed Tata Sons and SpiceJet's promoter Ajay Singh come up as potential bidders, according to industry sources. Further, reports suggest that Ajay Singh has partnered with Ras Al Khaimah Investment Authority, and Ankur Bhatia, promoter of Delhi-based Bird Group to jointly place the bid for Air India.

DIPAM Secretary Tuhin Kanta Pandey had earlier said that the government has received multiple expressions of interest for the strategic disinvestment of Air India.

lation of Unpublished Price Sensitive Information (UPSI) in various private WhatsApp groups about certain companies, including Bajaj Auto, Bata India, Ambuja Cements, Asian Paints, Wipro and Mindtree, ahead of their official announcements to the stock exchanges

The regulator had penalised Shruti Vishal Vora for releasing UPSI-related to financial results of the six companies through WhatsApp messages prior to official announcements by these companies.

Cold weather depresses US consumer spending

THE ECONOMY IS FORECAST TO GROW BY AS MUCH AS A 7.5% RATE THIS QUARTER AFTER EXPANDING AT A 4.3% PACE IN THE **FOURTH QUARTER**

Washington, March 26: US consumer spending fell by the most in 10 months in February as a cold snap gripped many parts of the country and the boost from a second round of stimulus checks to middle- and lower-income households faded, though the decline is likely temporary.

Consumer spending, which accounts for more than two-thirds of US economic activity, dropped 1.0% last month after rebounding 3.4%



in January, the Commerce Department said on Friday. That was the largest drop since April 2020, when the economy was reeling from the shutdown of nonessential businesses like restaurants to slow the spread of Covid-19 infec-

tions Personal income tumbled 7.1% after surging 10.1% in January. Economists polled by Reuters had

forecast consumer spending would decrease 0.7% in February and income would decline 7.3%.

Unseasonably harsh weather in the second half of February, including severe winter storms in Texas and other parts of the densely populated South region, depressed homebuilding, production at factories, orders and shipments of manufactured goods last month.

But activity is expected to rebound in March amid warmer weather, the White House's \$1.9 trillion pandemic rescue package and increased vaccinations against the coronavirus.

The massive relief package approved this month is sending additional \$1,400 checks to qualified households and extending the government safety net for the unemployed through September 6. The government reported Thursday that first-time applications for unemployed benefits dropped to a onevear low last week. US stocks opened higher. The dollar rose against a basket of other currencies. US Treasury prices were lower. BROAD DECLINE

Last month's decrease in consumer spending occurred across the board, with steep declines in purchases of pharmaceutical products and recreational goods. Spending on goods dropped 3.0% after soaring 8.4% in January.

Spending on services edged up 0.1% after increasing 0.9% in January. Consumers spent more on utilities and health care at hospitals, but cut back on dining out.

With demand soft, inflation retreated last month. But prices are expected to accelerate beginning in March owing to the broader reopening of the economy and the dropping of last year's weak readings from the calculation, as well as very accommodative fiscal and monetary policy.

Federal Reserve Chair Jerome Powell told lawmakers this week that the anticipated rise in inflation over the course of the year, will be "neither particularly large nor persistent.

The personal consumption expenditures (PCE) price index excluding the volatile food and energy component gained 0.1% after rising 0.2% in January. In the 12 months through February, the so-called core PCE price index climbed 1.4% after increasing 1.5% in January. The core PCE price index is the Fed's preferred inflation measure for its 2% target, a flexible average.
