New Delhi, April 2: Scientists have predicted using a mathematical model that the ongoing second-wave of COVID-19 pandemic across the country could peak by mid-April, following which the infections may see a steep decline by the end of May.

During the first wave of COVID-19 infections across India, the mathematical approach, named SUTRA, predicted that the initial surge of infections in August would peak by September and lower in February 2021.

Scientists, including Manindra Agrawal from Indian Institute of Technology (IIT) Kanpur, applied the model to predict the trajectory of the current surge in infections and found that the number of daily new infections is likely to peak in mid-April for this ongoing pandemic wave.

"For the last several days, we have found that there is a reasonable chance that the cases in India could peak some-

INDIA OVERTAKES US IN DAILY COVID CASES

NEW DELHI: India has overtaken the US to become the country with second-highest daily COVID-19 cases in the world. Brazil leads the chart with 91,097 cases recorded in the last 24 hours. India recorded 81.466 new coronavirus cases in the last 24 hours. About 77,718 new cases were reported in the US April 1. India has been witnessing a spike in cases since the last three weeks. India recorded its first coronavirus case January 30 last year and since then, a total of 1,23,03,131 people have been infected. In the US, the first case was found January 22 and has now surged to 30,538,427. respectively. If the total deaths are considered, India is at the fourth position after the US. Brazil and Mexico.

time between 15-20 April. It is a sharp slope, but on the way down, it would likely be equally sharp, coming down very fast and by end of May may see a dramatic reduction," Agrawal said.

"There is some uncertainty in predicting the peak value of daily new infections because of the sharp rise. Currently, it is coming to 1 lakh infections per day, but this can go up or down. But the timing remains the same between April 15-20," he added.

The scientists predict that in the current wave, the first state to peak could be Puniab in a few days, followed

by Maharashtra. However, the IIT Kanpur professor added that the model's prediction of the new peak is sensitive to the daily new infections data.

"Even a little bit of change each day causes the peak numbers to change by several thousand numbers. But the location of the peak has remained on mid-April," he added.

Independent calculations made by scientists, including Gautam Menon from Ashoka University in Harvana, have also predicted that the peak of the ongoing wave of infections could be between mid-April and mid-May.

COLLECTORS ASKED TO BOOST HOSPITAL INFRA

RHURANFSWAR. The state Health Department Friday asked all district Collectors and Commissioners of Urban Local Bodies (ULBs) to boost the infrastructure in government hospitals to cope with the threat increase in the number of COVID patients in the state. The instructions given by the department comes in the wake of con sistent rise of COVID cases in the state. The department has asked the Collectors to put in place all the necessary infrastructure such as beds, oxygen cylinders and others, besides ensuring smooth supply of medicines to COVID patients. "Taking note of the rapid surge of COVID-19 cases in the country and the state, you are requested to take measures immediately to mitigate the pandemic." the communique read.

However, Menon cautioned that such projections of COVID-19 cases should really be trusted only in the short term. "Any excessively precise prediction, of a peak within just a 5-day window, would ignore the many uncertainties associated with the inputs to any such calculation," Menon, who was not involved in the SUTRA modelling, told this news agency. Agrawal noted that the model uses three main parameters to predict the course of the pandemic.

"The first is called Beta, or contact rate, which measures how many people an infected person infects per day. It is related to the R-naught value, which is the number of people an infected person spreads the virus to over the course of their infection," Agrawal explained.

The other two parameters, he explained are 'Reach', which is a measure of exposure level of the population to the pandemic, and 'Epsilon' which is the ratio of detected and undetected cases.

A first kiss, a battle with addiction: Floyd's girlfriend testifies

IN HER TESTIMONY, ROSS SPOKE ABOUT ADDICTION: AS WITH MILLIONS OF OTHER AMERICANS, FLOYD AND SHE STRUGGLED TO QUIT OPIOIDS

Minneapolis, April 2: George Floyd's girlfriend took the witness stand Thursday and described their relationship, from a first kiss to date nights at restaurants, but also spoke about how an addiction to painkillers took hold of their life together.

Courteney Ross, 45, was the first witness who personally knew Floyd to testify at the trial of Derek Chauvin, the former Minneapolis policeman charged with murdering the man she loved by kneeling on his neck during an arrest last May. In her testimony, Ross described how her romance with Floyd began in 2017 when he offered to pray with her. She also spoke about addiction: As with millions of other

Americans, Floyd and Ross struggled to quit opioids.

"It's a classic story of how many people get addicted to opioids," Ross said. "We both suffered from chronic pain: mine was in my neck, his was in his back.

CHAUVIN MURDER TRIAL

The death of Floyd, a 46-year-old Black man, set off protests across the United States and around the world over racial injustice and police brutality against Black people.

Prosecutors wanted the jury to hear Ross' frank account of opioid use to undermine a central plank of Chauvin's defense in a trial seen as a litmus test of accountability in US policing

Chauvin's lawyers argue that



Floyd's death, which the county medical examiner ruled a homicide at the hands of police, was really an overdose from the fentanyl found in his blood at an autopsy.

Prosecutors have said Eric Nelson. Chauvin's lead attorney, has sought to raise the drug use in an effort to muddy Floyd's character and that the theory would be contradicted by medical evidence.

Nelson seemed to acknowledge the sensitivity when he stood up to cross-examine Ross: "I'm sorry to hear about your struggles with opioid addiction," he began. "Thank you for sharing that with the jury.

Before that, Ross, who had pinned a heart-shaped brooch to her black jacket for the occasion, smiled fondly at the memory when asked by prosecutors in the fourth day of witness testimony how she first met Floyd. "It's one of my favorite stories to tell," she said.

'SIS'? YOU OK?

Ross, 45, said she first met Floyd in August 2017 at a Salvation Army homeless shelter, where he worked as a security guard. She was waiting in the lobby to visit the father of her son after closing up the coffee shop where she worked. Floyd approached her.

"Floyd has this great, deep, south-

ern voice, raspy," she said, "and he was, like, 'Sis'? You OK, sis'?

He sensed she felt sad and alone and offered to pray with her. "It was so sweet," Ross said, dabbing a tissue to her eyes. "At the

time I had lost a lot of faith in God." They had their first kiss in the lobby that night and except an oc-

casional break were together until his death, she said.

In his cellphone, Floyd listed Ross, a mother of two, as 'Mama.'

They took walks in the parks and around the lakes of Ross's native Minneapolis, which was still new to the Texas-raised Floyd, and dined out often: "He was a big man," she said, describing his daily weightlifting, "and it look a lot of energy to keep him going."

New helpline number issued to check wildlife crime

Bhubaneswar, April 2: The alarming rise in crime related to wildlife in the state has become a major cause of concern for both the state police and Forest department officials. To rein in the growing menace, the Special Task Force (STF) of state Crime Branch Friday released a mobile phone number (9439263646) urging the citizens to share information related to any crime against wildlife in their locality with the police. The STF has assured financial rewards to the informants and promised not to disclose their names.

'In case of seizure or arrest based on the specific and pinpointed information, the concerned informer would be suitably rewarded," the STF announced in a press note.

Earlier, the STF sleuths succeeded in arresting two wildlife smugglers and seized a leopard skin from their possession in Bolagarh area of Khurda district in intervening night of Thursday and Friday. The accused persons identified as Sudhira Behera and Subhash Chandra Behera are the residents of Nayagarh district.

A case (11/2) has been registered at the STF police station here under various Sections of IPC and Wildlife Protection Act, 1972. The skin seized from accused has been sent to the Wild Life Institute of India at Dehradun for chemical examination.

STF, the specialised wing of state police dealing with organised crime, has seized 12 leopardskins, six elephant tusks and two deer hide during the last one year.

Man kills sis-in-law over property

Cuttack, April 2: A 45-year-old woman was allegedly stabbed to death by her brother-in-law over property dispute at Uparsahi in Sikharpur area under Chauliaganj police limits here in the wee hours of Friday, a police official said.

The victim was identified as Kamakshi Swain. Her husband had died of jaundice a few years back, the official said.

The incident came to the fore around 7:40am when Kamakshi's niece, 10, informed the former's family as well as the Chauliaganj police about the murder.

Chauliaganj police officials reached the spot along with forensic experts and started an investigation.

"We spotted the lifeless woman in a pool of blood. There were multiple deep injuries on her body," a senior police official said.

Meanwhile, the victim's family members alleged that the incident is fallout of a property dispute.

"She [Kamakshi] had a fight with her brother-in-law, Himanshu Mohanty, 42, late Thursday night over some property issue. An enraged Himanshu locked Kamakshi in the kitchen and stabbed her to death. Himanshu had earlier attacked my sister over the same issue. I had suggested Kamakshi to approach the police in this regard, but she declined as the matter was resolved amicably," victim's brother Ajit Bhuyan said.

Himanshu has surrendered before the police. "As per preliminary investigation, the murder is fallout of a land dispute. Forensic experts and police team have been investigating into the case," DCP Prateek Singh said.

The murder weapon, a blood-stained knife, has been recovered from the spot, another police official said.

ECOR SETS NAT'L RECORD **IN FREIGHT LOADING**

Bhubaneswar, April 2: The East Coast Railway (ECoR) has created a record in India for surpassing all previous records in freight loading in financial year 2020-21.

The zonal railway achieved 205 million tonne of freight loading during the period. Last year too, the ECoR had created a record of 202.56 MT loading. The unrest is the outcome of the recent ouster of the Myanmar's democratically elected government by the armed forces of the country and subsequent crackdown on the residents. Many people are already fleeing the country fearing persecution in the hands of the armed forces and arriving in neighbouring countries like India and Bangladesh. As a result, a fear of infiltration by the Myanmar refugees

into Kendrapara district through the water routes of the Bay of Bengal cannot be ruled out due to lack of coastal security measures in place.

Some locals have opined that the district administration should issue a high alert in the territorial waters bordering the district to prevent influx of Myanmar's refugees into the area. It is apprehended that the refugees in the guise of fishermen might come in small boats and infiltrate into the district. Later, the refugees after their arrival might erect shanties in the jungles near the sea and set up their base there.

Berhampur, April 2: The work of Chheligada hydropower project in tribal-dominated R Udaygiri block of Gajapati district has hit a tardy pace, causing widespread resentment among locals. The project assumes importance as this is in a backward region and it will help in electrification of many remote villages, a report said.

According to the report, the work of the main dam has not yet started. It was in 1985 when then Congress government proposed the project and had taken up its survey work. 20 years after this (in 2005), its outlay was pegged at Rs 97 crore. But as the project work gets delayed. its cost has escalated to Rs 706 crore.

The delay is likely to lead to further cost overrun while the time line for completion of the project is uncertain. But the executive engineer of the project has hinted that the project may be completed by 2024.

After completion of the project, 3600 hectares of farmland will get irrigation coverage in Mohana and R Udaygiri blocks in Gajapati dis-Digapahandi and trict. Sanakhemundi blocks of Ganjam district. Moreover, it will generate

about 30 megawatt of electricity every day. This hydropower project is expected to alleviate the power crisis in the region.

Medicinal plants vanishing from Nayagarh forests

Khandapada, April 2: Timber mafia has been plundering valuable trees and plants, especially those containing medicinal qualities in various forests of Nayagarh district. Now, Adhunga plants are in their target.

Adhunga plants are fast vanishing from forests in the district as mafia from outside are cutting these trees with the help of locals. Environmentalists have expressed concern over it, a report said.

The forested landscape was once rich with Adhunga plants. Now, they are found rarely in some areas.

Reports said, these trees have much demand in preparation of some Ayurvedic medicines and some traders from outside have set their sights on these plants. Leaves and branches of Adhunga plants are used for bouquets while its fruits act as a repellant for bugs in houses. Locals said some Ayurvedic practioners from outside have engaged middlemen to collect Adhunga plants

from forests. With the help of local people, these middlemen have been collecting these trees. People came to know of the value of these plants in 2008 when Antaryami Sahu, a retired teacher



of Kantilo area, had opposed cutting of these plants. He visited villages, sensitising people and their representatives about protection of these plants. Thereafter, felling of Adhunga plants had been stopped as the forest department took immediate action to prevent cutting.

After a long gap, plundering of the Adhunga plants has started in some pockets

Antaryami Sahu came to know about the development and visited Kaliapalli village recently. He saw some people cutting down Adhunga plants. On enquiry, it was learnt that a man from outside the state asked the locals to cut down these trees. The middleman has even paid some advance to buy its seeds and bottom

parts. "A kg of raw seeds is sold for Rs 20 while a kg of dry seeds is Rs 35," they added.

Some medicines are prepared from its seeds. When contacted, Khandapada ranger Sridhar Panda said some unscrupulous people cut down these trees and eke out their living by selling it.

'The forest department is aware of the development. About a month ago, forest officials had seized logs of Adhunga trees, which were being shifted in a bus from Gania area. But the persons who were taking the logs could not be caught," he added.

The wait for PESB appointments gets longer

onder why key appointments in the public sector are held up? Here's a clue. The Public Enterprises Selection Board (PESB) has been functioning without a chairperson since September last year when the then chairman Rajiv Kumar was shifted to the Election Commission. Also, the key post of member, one of three, has not been filled for a long time. Curiously, the selection board has seen five chairmen in the past five years and is awaiting a sixth!

This situation has finally come to the notice of the Parliamentary Standing Committee on Personnel, Public Grievances, Law and Justice, which passed adverse comments on the Modi sarkar's failure to fill the top positions in the PESB. Sources say that the parliamentary panel has directed the PESB to report in three months about the number of vacancies and also supply reasons why these posts have not been filled. Moreover, the panel also noted "with anguish" the abysmal number of women in public enterprises. It has sought to know from the PESB whether this is due to the absence of competent women aspirants or the glass-ceiling effect.

Apparently, as many as 135 posts of CMDs and directors have not been filled for more than six months to a year. And with several CMDs set to retire during the year, the number of vacancies is likely to grow unless quick action is not taken.

CVC struggling with delayed action in vigilance cases

Perturbed by the prolonged delays in finalizing disciplinary cases, a parliamentary committee has recommended to the Central Vigilance Commission (CVC) to explore the feasibility of holding the concerned authorities answerable



for inaction or delayed action. The committee has also asked the Department of Personnel and Training (DoPT) to provide funds to the CVC for strengthening its surveillance capabilities and database.

In its report to the panel, the CVC had come down heavily on the Central Board of Direct Taxation (CBDT), the Central Board of Indirect Taxes and Customs (CBIC) and Railways, among others, for delays in pursuing vigilance cases. According to the CVC report, out of the 3,371 cases received in 2020, the commission disposed of 2,717 cases by way of tendering advice. It however indicated that 654 cases may have to be moved forward to 2021 due to the delays in pursuing the cases.

But the Chief Vigilance Commissioner Sanjay Kothari and his team at the CVC received a shot in the arm after the panel decided to advise the government to give adequate funds to the commission to cope with the growing financial frauds.

DoPT directs ministries to speed up cadre reviews

The Modi sarkar is feeling stifled in its efforts to get the cadre controlling authorities of services like IAS, IPS, IFS and others to conduct the exercise which would then allow the government to undertake further administrative reforms, which may include shutting down obsolete services and merger of some cadres for better efficacy.

According to sources, Deepak Khandekar, Secretary, Department of Personnel and Training (DoPT), has directed all cadre controlling authorities to appoint joint secretary-level nodal officers to ensure that the cadre reviews are completed promptly. The government aims to get one round of cadre review for all services completed in five years.

The government's action is clearly prompted by the growing number of vacancies in government services, complaints of delayed promotions from several affected officials. However, the cadre controlling authorities in the various Central ministries and departments have blamed the Covid pandemic for defaulting on the prescribed timeline laid down for the reviews. But the government is no longer willing to accept this plea, as the DoPT's memo indicates. It wants to move ahead with its plans to streamline the cadre structures to satisfy functional requirements and remove existing deficiencies in the system.

WINDS OF CHANGE

ay 2, the date of the results for the Assembly elections in the five states West Bengal, Assam, Kerala, Tamil Nadu and Puducherry, will go down in history for having turned the tide of the political careers of bigwigs, not only Mamata Banerjee or Edapadi Palanisami, but also the Nehru-Gandhi scion Rahul Gandhi. The pollsters have predicted a three-digit figure for BJP, which had mere three seats in the outgoing Assembly The BJP, however, is confident of defeating Mamata, having sweated it out for the last few years to form the government in the one-time Left bastion, now occupied by TMC Even if BJP crosses the 100-seat mark in a 294-member Assembly, it will be a great push for the rightist party in an erstwhile Left bastion, perhaps opening the doors to form a government after the next Assembly polls. The presence of the Left and the Congress is nowhere to be seen, with the contest being limited, between the BJP and the TMC. The campaign in West Bengal

has turned into a fierce battle, where the political rivalry and bitterness are not only reflected in vitriolic speeches and abuses, but the wrath towards one another is also manifested in physical violence and blood on the streets. It's not only the leaders, who can't see eye-to-eye with one another, but the workers have also turned enemies, as never before.

For the Election Commission, it would be a real challenge to contain violence in the polls, which has been wisely stretched into 8 phases, to avoid any untoward incident. Amidst this bedlam, if Mamata Banerjee succeeds to halt the jug-

gernaut of BJP, it will be the biggest-ever win for the lady, who single-handedly has taken up the task to confront the Central government. It's one lady versus the entire Central Cabinet and also the turncoats, who, at the last moment, ditched the Chief Minister. Mamata's victory will catapult her straight to the Centre, where she may be asked to lead the anti-BJP forces. Voices of her leading the campaign will undoubtedly be raised by her party, declaring her to be the person most suited to become the prime ministerial candidate of the secular forces. However, if she loses, it will be difficult for her to make a comeback in the near future, as the formation of a BJP government will mark a new beginning in West Bengal.

Both the Congress and the Left have no role to play in Bengal elections though they are contesting to cut the anti-incumbency vote, thus helping the TMC. The

Congress leadership has so far kept itself away from the campaign, as it doesn't want to be seen hobnobbing with the same Left, against whom it is contesting a fierce battle in Kerala. Moreover, it is aware of the fact that the votes for the Congress-Left combine will only help consolidate votes for the BJP. "We are putting up a token fight in West Bengal, as we don't want BJP to win," stated a senior Congress leader.

For the Congress, however, Kerala is the state, which can herald the revival of Rahul Gandhi's leadership, bringing him back as the Congress president. Pitched against the LDF Government, the Congress, this time, is facing a tough resistance from the incumbent government. The pollsters, too, have predicted a victory for the LDF government, though Kerala has seen the formation of an alternate government, after every five years. Breaking the trend, this time

round, the incumbent government is likely to come back, though no one can blame Rahul Gandhi for not campaigning in Kerala.

In Kerala, it is indeed a tough fight between United Democratic Front (UDF) and the Left Democratic Front (LDF). If, under the leadership of Rahul Gandhi, the Congress can topple the LDF government, it will be a big victory for him. The young leader realises the importance of victory in any of the states and if he manages to win Kerala, the only state where he can turn back the political tide, he will make a mark as a Congress Leader. Both he and his sister Privanka Gandhi are aware that the G-23 rebel group is waiting anxiously to strike, after the elections. If at all they fail to wrest the government from the LDF in Kerala, it will mark the beginning of unrest in the Congress, with the rebels expected to raise the pitch against Rahul Gandhi. For a change, both the brother and the sister are working over-time criss-crossing West Bengal and Assam to ensure the victory of the Congress. However, while in other states, Tamil Nadu and West Bengal, they have no stakes, in Kerala and Assam, they still have the possibility of working wonders. In Puducherry, the Congress is sure to lose, due to the mess created by former Chief Minister V Narayanswamy. Even the Congress legislators ditched him at the last-minute, thus toppling his government. Victory in any one of the five states for the Congress will bring a ray of hope for Rahul Gandhi, who is seen to be struggling hard to make a mark in Indian politics. A win in Kerala or Assam will surely restore the waning confidence of the workers in him, making his task to adorn the post of Congress president much easier. However, if he fails to achieve victory in these crucial Assembly polls, the voices of dissent may bring to an end his political career, finally closing the doors of politics for the Nehru-

The bottom line is clear: Bitcoin is an excessively risky and environmentally undesirable investment. It is not a sensible solution to any emerging-market problem, and it cannot possibly serve as a store of value or reliable medium of exchange. The sooner it and other DLT-based cryptocurrencies are relegated to a footnote in economic history, the better.

Is Moyo right? Let's take her points in turn.

First, it is unclear how buying Bitcoin can mitigate company risk. The only risk Moyo identifies is that of missing out on what could be one of the greatest speculative bubbles of all time. True, a company that missed out on a continued Bitcoin appreciation could face dire consequences - including acquisition by a Bitcoininvested rival. Obviously, investing in Bitcoin is one sure way to avoid missing out on capital gains on Bitcoin. But that hardly makes it a wise investment, especially when one weighs the potential returns against the high risk of material capital losses

Equally far-fetched is the idea that cryptocurrencies could provide solutions to problems often encountered in emerging economies. It is true that, unlike conventional fiat money – which includes central bank digital currencies (CBDCs)-

in some emerging markets than in most advanced economies.

But over-issuance of currency is just one possible threat to emerging-market financial stability, and removing it does not suddenly make Bitcoin a reliable store of value. Quite the contrary: Bitcoin's price volatility since its inception in 2009 has been staggering. On March 29, 2021, its price reached \$57,856 - some distance below its alltime high of \$61,284 on March 13with a market cap close to \$1 trillion. According to a note from JPMorgan on February 17, its threemonth realised volatility at the time was 87%, compared to just 16% for gold. Similarly, a recent study finds that Bitcoin's price volatility is almost ten times higher than that of major fiat currencies (such as the US dollar against the euro and the yen).

Moyo also suggests that Bitcoin could facilitate remittances to low- and middle-income countries. But this ignores the fact that Bitcoin transactions are notoriously inefficient. Because its block size is capped at one megabyte and the block-discovery process takes approximately ten minutes per block, only seven

transaction messages per second. By design, Bitcoin is simply too inefficient ever to become an effective medium of payment.

Similarly, the fact that Bitcoin's supply is fixed at 21 million units is more of a drawback than a selling point. A proper currency should be able to undergo a massive expansion in supply when circumstances demand it, such as in the case of a financial crisis or a shock to aggregate demand. There can be no lender of last resort or market maker of last resort capable of systemic rescue operations with Bitcoin and other decentralized cryptocurrencies.

Finally, is Bitcoin really the vanguard of a new digital-currency infrastructure that wise investors cannot afford to ignore? No, because the CBDCs under development in China and elsewhere have nothing in common with Bitcoin and other decentralized private cryptocurrencies. There is no blockchain or other distributed ledger technology (DLT) involved, nor is proof of work required to establish the validity of a transaction. Rather, CBDCs function as

straightforward digital versions of conventional bank accounts.

Sir, Apropos, "Vaccination for 45+ begins today', Orissa Post, April 1. As the vaccination drive opens for all above 45, it calls for a reinforcement of the infrastructural facilities necessary to cater to the huge mass of beneficiaries now eligible for the jabs along with the 60-plus, who would turn up to the vaccination centres duly for their second shot as their four-to-eight week period between the two doses closes in. With COVID positivity rising among the younger population, the government would do well to include people above 18, especially who are willing to take jab. Making the largest number immunogenic to the virus is crucial to break the chain of transmission. At the same time, the authorities need to stay focused on and constantly review the efforts to check the spread of the rapidly escalating cases of COVID-19 infections and deaths. Driven largely by the highly transmissible UK variant of the coronavirus that has struck the country, the surge has given rise to a grave situation. Any laxity or complacency in following the COVID-appropriate behaviour at both the individual and institutional (both government and private) levels is fraught with serious repercussions. Irresponsible actions have the potential to spin our hardpressed health system out of control. Ramping up sampling and testing of random people in crowded places and contacts of COVID patients is urgently needed to contain the virus. Only then can we avoid another lockdown.

Barabanki (UP), April 2: A case has been registered here after the documents of an Uttar Pradesh registration number ambulance. used to transport gangster-turned politician Mukhtar Ansari to a Mohali court, were found to be fake.

"After an initial probe, the name and address given for the registration of the ambulance were found to be false. An FIR in this regard has been registered by an additional road transport officer against Dr Alka Rai, whose name was given for



the registration of the ambulance," a senior police official said.

Superintendent of Police, Yamuna The FIR was registered under Prasad said acting on media rerelevant sections of the Indian ports that Ansari was produced in Penal Code, including 420 (forgery), a court in Punjab on an ambulance with the registration number of 471 (fraudulently or dishonestly Barabanki, police teams probed using documents as genuine), 467 (forgery of valuable security) and the matter and found that docu-

ments such as PAN, electoral photo id card and others were fake. 'The address on which these documents were made was also found to be wrong," he said.

The Supreme Court had recently directed the Punjab government to hand over the custody of Ansari to the Uttar Pradesh Police, saying it was being denied on trivial grounds under the guise of medical issues.

The apex court had also said that a convict or an undertrial prisoner, who disobeys the law of the land, cannot oppose his transfer from one prison to another and courts are not to be a helpless bystander when the rule of law is being challenged with impunity.

India pitches for early disengagement

New Delhi, April 2: India Friday hoped that China will work with it to ensure disengagement of troops in remaining areas of eastern Ladakh at the earliest, and asserted that de-escalation of tension alone will lead to restoration of peace and tranquility in border areas and provide conditions for progress of bilateral ties.

At a media briefing, Spokesperson in the Ministry of External Affairs Arindam Bagchi said the two sides continue to remain in touch through military and diplomatic channels on the issue. He also referred to External Affairs Minister S Jaishankar's comments that a prolongation of the situation is in neither side's interest.

We, therefore, hope that the Chinese side will work with us to ensure that disengagement in the remaining areas is completed at the earliest," he added.

This, he said, would allow both sides to consider de-escalation of forces in eastern Ladakh as that

alone will lead to the restoration of peace and tranquility and provide conditions for progress of the bilateral relationship. Bagchi also said that there was a consensus that the two sides should now quickly resolve the remaining issues in the region.

"The disengagement in Pangong Lake area was a significant step forward and it has provided a good basis for resolution of other remaining issues along the Line of Actual Control in western sector," he said. Bagchi said the two sides had detailed exchange of views on the remaining issues both at the the senior commanders' meeting and the discussions held under the framework of Working Mechanism for Consultation and Coordination

(WMCC) on border affairs. Following the disengagement in the Pangong lake area, India and China held the 10th round of military talks, the WMCC meeting besides a telephonic conversation between the foreign ministers of the two countries.

The border standoff between the Indian and Chinese militaries erupted on May 5 last year following a violent clash in the Pangong lake areas and both sides gradually enhanced their deployment by rushing in tens of thousands of soldiers as well as heavy weaponry.

As a result of a series of military and diplomatic talks, the two sides completed withdrawal of troops and weapons from the North and South banks of Pangong lake in February in line with an agreement on disengagement.

In the subsequent military talks on February 20, India insisted on resolution of outstanding issues including in Depsang, Hot Springs and Gogra. India has been insisting that peace and tranquility along the border is essential for overall ties between the two countries.

Last week, Army Chief Gen MM Naravane said that the threat to India has only "abated" following the disengagement in Pangong lake areas but it has not gone away altogether.

DNA test gives clean chit to rape accused

THIS YOUNG MAN WAS FALSELY BOOKED FOR RAPE AND SPENT 26 MONTHS IN JAIL BEFORE THE DNA TEST ON THE SURVIVOR'S CHILD PROVED THAT HE WAS NOT THE BIOLOGICAL FATHER

Aligarh (Uttar Pradesh), April 2: This young man was falsely booked for rape and spent 26 months in jail before the DNA test on the survivor's child proved that he was not the biological father.

Amit Kumar, 24, was accused of raping and impregnating a minor girl at his Dattawali village in Aligarh.

Amit, who was working in Faridabad, had come to his village to attend the marriage of his elder brother in July 2018.

Seven months later, he was summoned by the police in February 2019 and accused of raping the girl. His mother and sister-in-law had already been detained. Amit rushed back and was arrested.



Amit's father, Sajjan Singh, told Amit was charged with rape and reporters that he had a dispute with under sections of the POCSO Act while his elder brother, Chandra the survivor's father over a piece of land and the case was set up to set-Shekhar, was charged with voluntarily causing hurt. With his younger tle scores.

brother Sunil and a distant relative Teekshan Pal, he was also booked for criminal intimidation and house trespass at the Barla police station

Chandrashekhar got bail, and Sunil and Teekshan's names were later removed from the charge sheet because there was not enough evidence against them.

Amit was lodged in the Aligarh district jail. Amit's lawyer Hariom Varshney said they pleaded before the court for a DNA test of the survivor's child to ascertain whether Amit was guilty of having raped her which led to pregnancy.

The survivor came with the child at the hospital in the fifth attempt and the samples of Amit and the child were taken in March last year. The report came last month which stated that Amit was not the biological father of the child.

"It is apparent that the FIR was lodged after considerable delay, that too, when pregnancy was detected. The victim alleged that the same was a result of rape committed by Amit but DNA report submitted in sealed envelope and opened before this Court reveals that applicant is not the biological father. The bail has finally been granted by the Allahabad High Court," Varshney said. Aligarh SSP Kalanidhi Naithani, meanwhile, said the police would seek legal opinion from the joint director of prosecution after going over the case diary.

Amit's counsel said that his next step will be to apply for his client's discharge from all charges under which he was booked.

No ban on export of Covid vax: MEA

India is one of the world's biggest drugmakers, an increasing number of countries have already approached it for procuring anti-coronavirus vaccines

New Delhi. April 2: Asserting that India has not imposed any export ban on anti-coronavirus vaccines, the Ministry of External Affairs on Friday said the country has taken the lead in sending vaccines abroad with over 640 lakh doses supplied to more than 80 countries till now.

Ministry of External Affairs Spokesperson Arindam Bagchi also said the ministry's 'Vaccine Maitree' initiative to supply vaccines abroad has been "very successful and very well liked" by our partners across the world.

"As on date, under the 'Vaccine Maitree' initiative, we have supplied a total of about 644 lakh doses to the global community and of these, 104 lakh doses have been supplied as a grant, 357 lakh doses on a commercial basis and 182 lakh doses through the COVAX initiative," Bagchi said at an online media briefing. With regard to the demand for made-in-India vaccines, many countries across the world have been requesting for their supply, he said. "I don't have an exact number for what is the demand (for the vaccines) because it is a request based on the requirement of countries," Bagchi said. The Vaccine Maitree' initiative has been extremely successful and very well liked by our partners across the world and "we are continuing to try to supply to the extent possible given our domestic requirements", Bagchi said.

Asked about reports that Nepal has approached India to procure 5 million more vaccine doses but has not got any response, he said India has taken the lead on sending vaccines abroad.

"No country has shared with the world the number of vaccines that India has while vaccinating its own population. Till now, we have supplied vaccines to more than 80 countries across in the world and we have already stated that our external supplies would be done keeping in mind our domestic requirements," the MEA spokesperson said.

"At this time, I hope our partners understand that vaccines are primarily purposed for domestic consumption. I want to emphasise that we have not imposed any export ban on vaccines," Bagchi asserted.

Taking note of the present situation due to the continuous deterioration of the Covid scenario over the fortnight, the Cabinet Secretary pointed out that the current Covid case growth rate of 6.8 per cent in March 2021 has surpassed the previous record of 5.5 per cent (June 2020).

Shared all data with WHO to probe Covid origins: China

New Delhi, April 2: China said that it has shared all data and analyses with the experts of the World Health Organization (WHO) tracing the origin of Covid-19, and it is ready to continue working with global experts to jointly study and analyse the data.

The joint study group of WHO and China to trace the origin of Covid-19 released a report two days ago, in which it flagged that more data will be made available to the investigators by Beijing.

A day after the report was released, India had demanded a comprehensive and expert-led mechanism to expeditiously investigate the origin of coronavirus. The US, the UK and several other countries

have also voiced their concerns over the findings. Reacting to India's demand, China said that they had twice invited WHO experts for the study of the origin of Covid-19 and offered necessary facilitation for the team's work, fully demonstrating its openness, transparency and responsible attitude. China further said that the joint study group tracing the origin of Covid-19 has unanimously agreed that the allegation of a 'lab leak' is extremely unlikely.

Liquor shops in Chhindwara open amid lockdown

They both are taking on DMK's Nagathiyagarajan and BJP's VMCS Manoharan. Interestingly, the BJP candidate and the independent VMCS Rajaganapathy are brothers. If any of the independents go on to win the elections, they might play a crucial role in the formation of the next government in the Union Territory.

US, Iran may give another shot to N-deal

Brussels, April 2: Iran and the major powers in the agreement to keep Tehran from developing nuclear weapons said Friday they were ready to welcome the return of the United States to the deal.

The chair of the group including the European Union, China, France, Germany, Russia, Britain and Iran said that the participants "emphasized their commitment to preserve the JCPOA and discussed modalities to ensure the return to its full and effective implementation," according to a statement after their virtual meeting, referring to the acronym for the accord

– the Joint Comprehensive Plan of Action. The group said they would re-

sume further talks next week in Vienna on the 2015 agreement, "in order to clearly identify sanctions lifting and nuclear implementation measures.

The statement also said that the group's coordinator "will also intensify separate contacts in Vienna" with all participants of the nuclear agreement and the United States

In Tehran, state television quoted Abbas Araghchi, Iran's nuclear negotiator in the Friday virtual meeting said that any "return by

the U.S. to the nuclear deal does not require any negotiation and the path is quite clear.' The US can return to the deal

and stop breaching the law in the same way it withdrew from the deal and imposed illegal sanctions on Iran," Araghchi was quoted

saying Washington pulled out of the deal unilaterally in 2018 under President Donald Trump, but successor Joe Biden has indicated that the US would be willing to rejoin. But there are some complica-

tions. Iran has been steadily violating the restrictions of the deal, like the amount of enriched uranium it can stockpile and the purity to which it can enrich it. Tehran's moves have been calculated to put pressure on the other nations in the deal-Russia, China, France, Germany and Britain—to do more to offset crippling sanctions reimposed under Trump.

Iran has said that before it resumes compliance with the deal, the U.S. needs to return to its own obligations under the deal by dropping the sanctions. The International Atomic Energy

Agency has said that over the past two years, Iran has accumulated a lot of nuclear material and new capacities, and used the time for "honing their skills in these areas."

During their stay, all passengers linked to the red list are required to take a coronavirus test on or before day 2 and on or after day 8, and are not allowed to shorten their compulsory 10-day quarantine period on receipt of a negative test result

Brussels, April 2: The European Union is struggling to show complete coronavirus vaccination solidarity among member nations, after a week of negotiations over the distribution of extra doses exposed fissures Friday. Five EU nations that struggled most to get their vaccination drive going were given extra doses from an alliance of 19 other countries. Three nations weren't part of the deal, however, showing the difficulties of compromise politics when COVID-19

cases are surging again. At an EU summit last week, Austrian Chancellor Sebastian Kurz criticized the allocation of shots in the 27-nation bloc, saying



that some countries were receiving more than their fair share at the cost of others. EU leaders failed to agree on a correction mechanism, leaving it to their EU ambassadors.

Late Thursday, a deal was reached on how to distribute an early batch of 10 million Pfizer-BioNTech doses

with Bulgaria, Croatia, Estonia, Latvia and Slovakia receiving a proportionally large number of doses. Austria, along with the Czech Republic and Slovenia, didn't get additional shots.

'We are grateful for the remarkable efforts" and solidarity of fellow EU member states, Latvian Prime Minister Krisjanis Karins said.

He said the extra shots "will bring us closer to our common goal a collective immunity across the EU." AstraZeneca shots are cheaper and easier to handle than vaccines from Pfizer-BioNTech or Moderna. Overall, the EU continues to lag well behind nations like the United Kingdom and United States when it comes to vaccinations.

Moscow, April 2: Russia has issued tenders to buy anti-riot kits and protective police gear, state procurement documents showed, ahead of a protest that allies of jailed Kremlin critic Alexei Navalny hope will be the largest in modern Russian history.

Navalny, 44, was jailed in February on charges he said were fabricated. He declared a hunger strike Wednesday in a bid to force the prison holding him to provide proper medical care for what he said was acute pain in his back and legs.

His allies, who staged three demonstrations in the winter to demand his release, said they would announce a date for a new nationwide street protest once 500,000 people had registered to attend.

tered so far. The authorities have called such street protests illegal and have pledged to break them up.

An Interior Ministry tender, published on Russia's state procurement online portal March 30, requested the provision of more than 2,000 police anti-riot kits worth some 239 million roubles (\$3.15 million). Each kit includes body armor, a helmet and leg protectors.

The ministry also issued tenders for the purchase of 1,625 protective kits, 200 helmets and more than 400 bulletproof vests

The Hague, April 2: Dutch caretaker Prime Minister Mark Rutte Friday narrowly survived a noconfidence vote called after he was accused of misinforming Parliament and actively seeking to move an inconvenient lawmaker to another position.

The premier's credibility was however seriously damaged as parliament passed a motion of disapproval, saying he had not told the truth about remarks made during coalition talks, reports dpa news agency.

At a special session Thursday, almost all parliamentary groups voiced severe criticism of the right-wing liberal premier after he gave the impression that he wanted to sideline an inconvenient critic and several opposition parties called for a vote of confidence.

After a long and turbulent debate over Rutte's controversial statements during government formation talks, the opposition ultimately lacked a majority for a vote of no-confidence in the early hours of Friday in The Hague.

Rutte was expected to continue efforts to form his fourth coalition government after parliamentary elections in mid-March handed his centre-right People's Party for Freedom and Democracy (VVD) a majority.

A first round of coalition talks was unexpectedly broken off last week after a confidential memo became public.

The note, which became public Thursday, mentioned re-positioning Pieter Omtzigt, a lawmaker known for often asking pointed or inconvenient questions to the government.

Before the note became public, Rutte had claimed that the lawmaker had not been a topic of conversation.

Once the note appeared to contradict him, the premier told parliament that he had forgotten this remark. saying he had never in-tended to move the Christian Democratic lawmaker.

China wildlife crackdown needs 'more teeth'

Shanghai, April 2: China and its neighbours must not only crack down on wildlife trade but also shut legal loopholes that allow diseaseprone species to be farmed, experts said after an investigation team concluded that COVID-19 most likely originated in animals.

A World Health Organizationled study, published Tuesday, said it was "likely to very likely" that SARS-CoV-2, the virus that caused the global pandemic, was introduced to humans from bats via an intermediary species, with wildlife

farming playing a crucial role. Tong Yigang, a Chinese animal disease expert involved in the joint study, said the findings vindicated Beiiing's decision last year to ban trade in wildlife for human consumption.

But the report also drew attention to the wildlife farms still allowed to operate legally, serving the traditional Chinese medicine (TCM) industry and the fur trade - and creating more spillover risks.

"With farms you have a large pool of animals that are more or less genetically homogeneous, where a virus can easily evolve," said Christian Walzer, chief veterinarian at New York's Wildlife

Preservation Society. China tested thousands of animal samples to trace the coronavirus's origins, but the study said more investigations were required. It also recommended surveys at mink and raccoon dog farms, which China still allows even though they are infection-prone.

'Cramming millions of animals together in these abusive industries creates a perfect petri dish for pandemics, and unless we ban farming for fur ... we will continue to play Russian roulette with global public safety," warned Peter Li, China expert at Humane Society International.

Regulatory gaps, lax enforcement and transnational trafficking gangs have allowed the wildlife trade to continue, experts said. Pangolins, an endangered mammal identified as a potential intermediary species for



SARS-CoV-2, remain a major prize. Pangolin scales were an officially recognised TCM ingredient - used to treat conditions like arthritis until last year. Though China has since cracked down, activists complain that punishments remain uneven: in a recent case, traffickers caught on the island province of Hainan were given only relatively small fines

operation. A special economic zone in the border district of Mong La in Myanmar, owned by Chinese businesses, has long been a source of pangolin scales delivered into China.

'There's no real government control there in Mong La," said Chris Shepherd, executive director of the Monitor Conservation Research Society, who studies illegal wildlife trafficking. "There's no enforcement of any kind."

"In many places, wildlife trading isn't seen as a priority or even as something that is necessarily wrong, and we are suffering a pandemic because of it.

are not responsible for these: they are driving it," said Amanda Whitfort, an animal welfare law specialist at Hong Kong University.

State refiners told to review import contracts with Saudi

Govt tells four state-owned refiners to use collective bargaining power to get favourable terms with the Middle East country

New Delhi, April 2: Amid tensions with Saudi Arabia over oil production cuts, India has asked its state refiners to review contracts they enter into for buying crude oil from the Middle East nation and negotiate more favourable terms, a top official said.

Keen to break producers' cartel dictating pricing and contractual terms, the government has told Indian Oil Corporation (IOC), Bharat Petroleum Corporation Ltd (BPCL) and Hindustan Petroleum Corporation Ltd (HPCL) to look for oil supplies from outside the Middle East region and use collective bargaining power to get

favourable terms. India imports 85 per cent of its oil needs and is often vulnerable to global supply and price shocks. When oil prices started to rise in February, it wanted Saudi Arabia to relax output controls but the Kindgom ignored its calls. This has led to India now pressing for diversification of the supply base. 'Traditionally, Saudi Arabia and

other OPEC producers have been our mainstay suppliers of crude oil. But their terms have often been loaded against the buver." the official with direct knowledge of the discussions said. For one, Indian firms buy two-thirds of their purchases on term or fixed annual contracts. These term contracts provide assured supplies of the contracted quantity but

the pricing and other terms favour

only the supplier, he said.



'While buyers have an obligation to lift all of the contracted quantity, Saudi and other producers have the option to reduce supplies in case OPEC decides to keep production artificially lower to boost prices. Why should the consumer have to pay for decisions of OPEC? If we commit to offtake, they should also supply no matter what," he said. More importantly, the buyer has to indicate at least six weeks in advance of their intention to lift quantity out of the annual term contract in any month and has to pay an average official price announced by the producer.

"In an ideal market, the pricing should be of the day when the loading is taking place. That way we can get the advantage of any drop in international oil rates. But that is not the case. They insist on selling at their official selling price only, the official said. To begin with,

Indian refiners will look to reduce the quantity they buy through term contracts and instead buy more from the spot or current market. Buying from the spot market would ensure that India can take advantage of any fall in prices on any day and book quantities. "It's like stock market. You would want to buy shares on a day or time when the prices are low. So is the case with crude oil - we would want to buy when we see there is a drop. Term contracts devoid us of that flexibility," he said. Indian refiners have raised spot purchases from 20 per cent a decade back to 30-35 per cent of the total oil bought now.

"We want pricing flexibility as well as the certainty of supply even during times when production falls due to any reason." he said adding state owned refineries have been asked to coordinate buying and explore joint strategy with private refiners.

has already received clearance from regulators such as CCI, SEBI and bourses, and the scheme of arrangement is now awaiting the nod from the NCLT and shareholders.

Though the Supreme Court has granted a go-ahead to the National Company Law Tribunal (NCLT) for its proceedings but has asked it not to pass any final order sanctioning the scheme. The NCLT has reserved its order over the scheme of arrangement in which all the Future Group's retail assets would be consolidated under Future Enterprises Ltd and then would be transferred to RRVL through sale.

Last month, a Single Member Bench of the Delhi High Court had directed the Future Group to stay the deal. However, this was challenged by the Future Group before the Division Bench of the Delhi High Court, which stayed the order of the Single Member bench.

Amazon and Future have been locked in a bitter legal tussle after the US e-commerce giant dragged Future Group to arbitration at Singapore International Arbitration Centre (SIAC), arguing that the latter had violated their contract by entering into the deal with rival Reliance.

Amazon had invested in Future Coupons in August 2019 with an option of buying into the flagship-Future Retail after a period of three to 10 years.

Miami, April 2: In her first match at this year's Miami Open, Ash Barty was one point from elimination. Now she's one win from becoming a repeat champion. The top-ranked Barty returned to the final by beating No.5-seeded Elina Svitolina 6-3, 6-3 Thursday.

Barty has gained momentum after starting the tournament by saving a match point against qualifier Kristina Kucova. That was Barty's first match outside her native Australia since February 2020. "Whenever you come back from

a match point, it's a little bit of a strange feeling," she said. "You have to be more open with what the possibilities the rest of the tournament could be, and keep going out there and keep fighting, knowing you could have just as easily been out of the tournament.

Barty, who is assured of retaining her No. 1 ranking next week, will play for the title Saturday against the winner of the second semifinal between No.8 Bianca Andreescu and No.23 Maria Sakkari.

On the men's side, unseeded 20year-old Sebastian Korda's breakthrough run ended with a quar-

terfinal loss to No.4 Andrey Rubley, 7-5, 7-6(9-7). Korda, slowed in the second set by a left thigh injury, was the youngest American to make the men's quarterfinals in Miami since Robbie Ginepri in 2003.

While Korda departed, his sisters, Jessica and Nelly, were in contention at the LPGA's ANA Inspiration in California after breaking par in the first round Thursday.

Rublev and Hubert Hurkacz of Poland will play in their first semifinal at a top-level ATP event when they meet Friday night. Hurkacz advanced by rallying past No.2-seeded Stefanos Tsitsipas 2-6, 6-3, 6-4. Hurkacz, seeded 26th, has won three in a row when facing a top-five opponent, but he beat Tsitsipas for only the second time in their eight meetings.

"I just try to like keep building my game and improving," Hurkacz said. "Not all the time are you going to have the results that you want, but if you stay positive and improve your game, the results will eventually come.

They're coming for Barty after she was locked down for a year in Australia because of the coronavirus pandemic, which forced the

cancellation of the 2020 Miami Open. Barty won the event in 2019, and said her run to that title was different from this year's matches in Miami.

"Chalk and cheese," the Aussie said. "The conditions have been different here this week. It has been a lot warmer and physically very demanding.'

Barty had been 1-5 previously against Svitolina, but took charge with two early breaks and used her strong serve and deep slices to keep the Ukrainian on the defensive.

Midway through the second set, Svitolina made a rare trip to the net, and Barty responded with a perfect lob winner that drew an appreciative pat of the racket strings from her opponent. On match point, Barty closed out the victory with a forehand winner and a fist pump.

Hurkacz's upset win further scrambled the men's draw. Novak Djokovic, Rafa Nadal and Roger Federer skipped the tournament, and No.1-seeded Daniil Medvedev lost in the quarterfinals Wednesday night to No. 7 Robert Bautista Agut.

Bautista Agut will face No.21 Jannik Sinner in the first semifinal Friday, and a first-time ATP Masters 1000 champion will be crowned Sunday.

"Maybe I feel extra pressure, because I'm the one left who's in the top 10," Rublev said. "But everyone can win now. All of them are playing good tennis.

Hurkacz was serving at 0-2, 15-40 in the second set when he began his comeback. He steadied his baseline game, while Tsitsipas became increasingly erratic and frustrated as the match progressed.

"I was very stressed these two weeks," Tsitsipas said. "I felt like it was my opportunity. It's a very disappointing loss. Everything was under control. And suddenly, I don't know, self-explosion.3

Hurkacz hit 15 aces and saved 10 of the 13 break points he faced. He'll climb in next week's rankings to at least 27th, a career high.

Mumbai, April 2: Former India captain and batting icon Sachin Tendulkar has been hospitalised as a precautionary measure, six days after he tested positive for COVID-19.

The 47-year-old took to twitter to announce the development Friday. "Thank you for your wishes and pravers. As a matter of abundant precaution under medical advice, I have been hospitalised. I hope to be back home in a few days. Take care and stay safe everyone," Tendulkar wrote.

Tendulkar had tested positive for the dreaded infection March 27 and was in home isolation ever since. "He is doing fine and has been admitted for normal (course of) treatment," a source close to Tendulkar told this agency.

The batting great, who was part of India's historic World Cup win in 2011, also wished his teammates on the 10th anniversary of the victory. "Wishing all Indians & my teammates on the 10th anniversary of our World Cup win," he tweeted.

Besides Tendulkar, former India all-rounder Irfan Pathan, his elder

STRENGTHS

In Eoin Morgan, his first stint as full-time KKR captain, the Purple Brigade have got one of the most astute brains of the white-ball format.

The English World Cup-winning skipper, who took over the role after seven games last season, was one of the brightspots for the team in 2020.

The left-hander struck 418 runs in 14 innings at an average of 41.80 and also hit the most sixes (24), giving impetus in the death overs with his cameos

KKR have made some smart additions to their squad in the miniauction, apart from retaining their core of the side - 17 players - despite a disappointing season.

By bringing back Bangladesh star all-rounder Shakib-Al-Hasan and signing 2016 IPL Final manof-the-match Ben Cutting, they have got the much-needed backups for the Windies duo of Narine and Russell, who failed to fire last season.

Then there are the seasoned duo of Shakib and veteran Indian off-spinner Harbhajan Singh who too will look to make most of the limited opportunities that come their way on slow tracks on offer in Delhi and Chennai.

KKR have two interesting uncapped new signings in Venkatesh Iyer and Vaibhav Arora, who too will look to grab their opportuni-
