Covid drugs

Bhubaneswar, June 14: Following a hue and cry over the seizure of a huge quantity of fake anti-Covid drugs in various parts of Odisha, Chief Minister Naveen Patnaik Monday asked the Crime Branch to investigate the case.

Hinting toward strong action against those involved in the illegal practice, Health and Family Welfare Minister Naba Das had Sunday said counterfeiting business will not be tolerated.

The state drugs controller officials have seized huge quantities of spurious anti-Covid drugs during raids in Cuttack, Bolangir, Jharsuguda, Sambalpur, Bhubaneswar, Kalahandi and Rourkela. So far 10 varieties of fake drugs have been seized during the raids.

After getting information from the Food and Drug Administration, Maharashtra about spurious Favipiravir tablets (Favimax-400), the state officials swung into action. Max Relief Health Care, a non-existing drug manufacturer from Solan in Himachal Pradesh, had sold the drugs to a Cuttackbased pharmaceutical wholesaler.

The first raid was recently conducted on the premises of Medilloyd Medicament Private Limited, Cuttack that had purchased the drugs.

During the raid, the officials found that the firm had purchased 58,000 tablets of 'Favimax-400' from Max Relief Health Care, Gautam Budh Nagar, Uttar Pradesh. The UP firm is also a non-existing one. Since then the officials have been continuously raiding various drug stores across the state.

Bhubaneswar. June 14: In view of the poor presence of private hospitals, the state government Monday urged the Centre to allocate Covid-19 vaccines to Odisha in the ratio of 95:5 for government and private hospitals instead of 75:25 fixed by the later.

The Centre has revised its guidelines for implementation of Covid vaccination programme, which will come into effect from June 21 across the country. As per the fresh guidelines, 25 per cent of monthly production of vaccines by domestic manufacturers will be directly procured by private hospitals while the Union government will procure 75 per cent of the vaccines and supply to states.

In a letter to Union Health Secretary Rajesh Bhushan, Additional Chief Secretary (Health) PK Mohapatra said only four private hospitals in Odisha have been able to procure vaccines directly from manufacturers so far "The presence of private hospitals in Odisha is very low and limited to only about 5 per cent of the total

FREE EDU FOR KIDS ORPHANED BY VIRUS

BHUBANESWAR: The state government has decided to provide free education to children orphaned due to Covid-19 pandemic in the state. Speaking to reporters here, advisor to Women and Child Development department, Sulata Deo said, "The children, who are orphaned due to Covid will get free education from Odisha government. The government will bear the cost of their higher education including admission into engineering and medical colleges." If the children join private educational institutions, the government has the Green Passage scheme, under which financial aid will be provided to such kids, she said. Green Passage scheme was launched in May 2016. Under this, the state government is bearing the cost of admission tuition examination and laboratories for homeless children. At present orphan children are being provided with ₹2,000 monthly allowance. Plans are afoot to extend the benefit to children who lost their parents to Covid-19, Deo said.

Moreover, Mohapatra has urged the Centre to provide the vaccine allocation for private hospitals to the state government for subsequent mobilisation and allocation to private hospitals.

Last Monday, Prime Minister Narendra Modi had announced that the Centre will provide free vaccines to all people above 18 years of age from June 21. At that time, he had set the new rules of vaccine allocation.

Delta Plus: New Covid variant

New Delhi, June 14: The highly transmissible Delta variant of SARS-CoV-2 has mutated further to form the 'Delta Plus' or 'AY.1' variant but there is no immediate cause for concern in India as its incidence in the country is still low, scientists said.

The new Delta Plus variant has been formed due to a mutation in the Delta or B.1.617.2 variant, first identified in India and one of the drivers of the deadly second wave. Though there is no indication yet of the severity of the disease due to the new variant, Delta Plus is resistant to the monoclonal antibody cocktail treatment for COVID-19 recently authorised in India.

"One of the emerging variants is B.1.617.2.1 also known as AY.1 characterised by the acquisition of K417N mutation," Vinod Scaria, clinician and scientist at Delhi's CSIR-Institute of Genomics and Integrative Biology, tweeted Sunday.

The mutation, he said, is in the spike protein of SARS-COV-2, which helps the virus enter and infect the human cells. According to Public Health England, 63 genomes

new K417N mutation have been identified so far on the global science initiative GI-SAID. In its latest report on coronavirus variants, updated till last Friday, the health agency said Delta Plus was present in six genomes from India as of June 7. "The variant frequency for K417N is not much in India at this point in time. The sequences are mostly from Europe, Asia and America," Scaria wrote on Twitter. The earliest sequence of this genome was found in Europe in late

or severity of a disease. "How transmissible this new variant is will be a crucial factor to determine its 🗎 rapid spread or otherwise," Bal told PTI.

Pulmonologist and medical researcher Anurag Agrawal concurred. "There is no cause of concern dueto the new variant in India as of now," Agrawal said.

Monsoon covers two-thirds of India earlier than usual

NEARLY HALF OF THE COUNTRY'S FARMLAND GETS NO IRRIGATION AND IS DEPENDENT ON THE ANNUAL RAINS FROM JUNE TO SEPTEMBER

Mumbai, June 14: India's annual monsoon rains have covered twothirds of the country nearly a fortnight ahead of the normal schedule, a weather department official said Monday, adding that conditions are favourable for further advancement into the north-western parts this week. The early arrival of monsoon rains

in central and northern India will help farmers accelerate sowing of summer-sown crops such as paddy rice, cotton, soybean and pulses, and may boost crop yields too.

"Monsoon has already covered some parts of Punjab. Usually, it enters Punjab in the last week of June,"



said an official at the India Meteorological Department (IMD), who declined to be named. Monsoon arrived in the southern state of Kerala June 3 against the usual June 1, but has advanced quickly since.

Since the start of the season, the monsoon has delivered 25 per cent more-than-normal rainfall, boosted by higher rainfall in the central India region, data compiled by IMD showed.

Monsoon is crucial for India's \$2.7trillion economy, as it delivers nearly 70 per cent of the rain needed by farms, besides replenishing reservoirs and aquifers.

Sowing of summer-sown crops such as cotton, rice, soybean, corn and pulses has already started in southern and western states, and could start in central and northern India this week, said a Mumbai-based dealer with a global trading firm.

"Farmers are interested in rice and oilseeds due to higher prices. We might see higher area under soybean and paddy," the dealer said.

India is the world's biggest exporter of rice and top importer of edible oils such as palm oil, soyoil and sunflower oil.

Nearly half of India's farmland gets no irrigation and is dependent on the annual rains from June to September. Farming accounts for nearly 15 per cent of the economy but sustains more than half of a population of 1.3 billion.

Viral load in fresh **nCoV cases down**

Bhubaneswar, June 14: The viral load in the fresh Covid-19 infections has come down substantially as compared to the cases reported during peak period of the pandemic, said Institute of Life Sciences (ILS) director Ajay Parida here Monday.

Parida said that the CT (cycle threshold) value in the RT-PCR test reports was ranging from 14 to 15 while it has now increased up to 28. The lower the CT value, the higher is the viral load and the higher the CT value the lower is the viral load.

Parida said that not only children but also people from other age groups may get infected in the possible third wave of the Covid-19. However, there is no concrete information shared by any nation and international medical research organisation till now about the third wave, he added.

12-yr-old girl rescued from ex-Collector's house in City

Bhubaneswar, June 14: Childline officials here Monday rescued a 12-year-old girl engaged as a housemaid from the residence of a retired Collector at IRC Village under Nayapalli police limits.

According to sources, the girl was trafficked from Berhampur in Ganjam district to the Capital city in November 2020. She was studying in Class VI when some alleged middlemen brought the girl to the city last year. Sources also revealed that victim's father is a rickshaw puller in Ganjam.

The family living in abject poverty allowed the minor girl to work as a housemaid in Bhubaneswar, sources claimed.

Bhubaneswar, June 14: Odisha Monday reported 4, 339 new Covid-19 cases, taking the tally to 8, 56, 121. while 44 fresh fatalities due to the infection pushed the coastal state's toll to 3,346, a Health department official said.

Of the new infections, 2,475 were detected at quarantine centres, while the rest 1,864 are local contact cases

Khurda district, where state capital Bhubaneswar is located, reported the highest 700 new cases. followed by Cuttack (480), Balasore (296) and Puri (255).

Health and Family Welfare department sources said that out of 44 deaths registered in the past 24 hours in 18 districts, Khurda accounted for a maximum of five deaths followed by three each in nine districts, two each in three districts and one each in six districts.

This apart, 53 Covid-19 patients have died due to comorbidities. The state tested 68,535 samples

Sunday. Odisha has so far administered as many as 88,71,397 doses of Covid-19 vaccines.

The average total positivity rate in the state stands at 6.3 per cent. As many as 13 districts in the state

have a TPR of less than 5 per cent while nine districts have between 5 to 10 per cent and eight districts

Small traders' festive biz takes a beating

Bhubaneswar, June 14: Small traders in the Capital city bore the brunt of Covid-induced lockdowns for the second straight year causing much losses to their businesses during Raja festival.

The three-day festival which celebrates womanhood brings huge demand for sarees, bangles, bindis, flowers and other such stationery items used by young women. However, with the state government providing no relaxation in lockdowns, businesses dealing with such commodities have taken a huge beating.

Kesinga, June 14: Over three weeks have passed since a blast at a stone quarry in Kesinga block of Kalahandi district caused damage to properties of a construction company named DD Builderworth around ₹10,00,000. But no action has been taken against the contractor so far despite written complaint lodged against him.

It was May 20 and lockdown restrictions were in place in the locality. So, the area near the Laterite stone quarry at Rakundabandh village under Kesinga block was devoid of any activities. Taking advantage of this, a contractor, identified as Rahas Sahu, allegedly conducted a heavy blasting.

The intensity was so huge that boulders were seen flying in all directions. Some of these boulders fell on DD Builder's office room, which was 200 metres away from the blasting site. They damaged CCTV cameras, computers, printers, electrical equipment and a machine to weigh stones at the office.

Following the incident, Tribhuban Chhatriya, senior staff of DD Builder, lodged a written complaint at Karlapada outpost.

'The matter has been taken up with the district Collector, Sub-Collector, tehsildar and revenue inspector (RI) requesting action against the contractor. But to no avail," said Chhatriya.

Rainwater harvesting provides livelihood to returnees

Sundargarh, June 14: The implementation of roof-top rainwater harvesting project has helped in increasing the groundwater level as well as in providing livelihood to the migrants returning to the district following the Covid-induced lockdowns and shutdowns in their workplace outside the state, a report said. The district administration is

implementing the roof-top rainwater harvesting project in all 17 blocks on a priority basis with the funds available from the district mineral foundation (DMF). Voluntary outfits have been assigned the responsibility to implement the project at the field level with the involvement of local residents. Migrants who have returned to the state due to Covid-19 pandemic are being provided with livelihood by engaging them in these projects.

The promptitude shown by the

district administration has helped in making 651 projects functional by May this year while work is underway on 385 projects.

Reports said that the district administration plans to include all government offices, government staff quarters, hospitals, schools, colleges and hostel buildings in the project. A draft plan has been prepared for the project wherein a pipe will be linked to the ground from the roof-top wherever the project is being implemented.

Experts said that climate change has led to erratic monsoon in the

state and whatever rain is received flows into the rivers and seas due to lack of conservation. This has led to water crisis and the roof-top rainwater harvesting can go long way in raising the groundwater level in the state.

The rainwater will flow through these pipes and fall into a pit con-

structed in the ground thereby seeping into the soil and help in increase groundwater level in the district. This will ultimately help in more water flow to the wells, ponds, tube wells and bore wells situated close to the pit.

This will help in removing the water scarcity for daily use among

the people. In addition, it will also help in removing the water scarcity during summer season in remote and tribal dominated block like Sundargarh district, Collector Nikhil Pawan Kalyan said.

The district administration has also fixed the criteria for construction of the pits. A single pit is constructed near the buildings whose roofs are about 1,500 sq. ft. or less, while two pits are constructed where the roofs are more than 1,500 sq. ft.

A villager, Hemant Pradhan, of Barangakachhar village under Bargaon block said that he had migrated outside the state due to lack of enough livelihood options in the district but returned home after he lost his job due to Covid-19 pandemic. Exit Netanyahu

THE MOTHER

T srael's longest-serving Prime Minister Benjamin Netanyahu, mired in controversies ranging from financial fraud to communal polarisation for his own political survival, has been ousted from office June 13 by a loose coalition of rivals from across the political spectrum. The lowest common denominator of the coalition is the constituents' wish to end Netanyahu's 12-year rule. The Opposition leader, Yair Lapid, a centrist and former TV news anchor, won a confidence vote in the Knesset, Israel's parliament, by a wafer thin majority of 60-59 seats to clinch the issue. Interestingly, the Israeli voter, though heavily polarized, never looked for an alternative during the campaign..

Lapid will not, however, become Prime Minister immediately, but his former foe and far-right advocate for the settler movement in the Palestinian territories, Naftali Bennett, has been sworn in as the country's new PM. Under the power-sharing arrangement, Lapid's term will come two years later when Bennett is to hand over power to him for the rest of the four-year term. The big question, of course, remains whether the new government will last till then.

Questions are being asked about the durability of the fragile coalition government for two reasons. First, there is virtually no cohesion among the partners of the coalition which is a medley of ideologically opposed politicians from hardline Jewish religious nationalists to centrists, Leftists and a small Arab Islamist group. Secondly, Netanyahu has made it clear during his speech in the Knesset while stepping down that his efforts from now on will be to topple the government terming it as 'dangerous'.

Netanyahu incurred the wrath of many of his own people for his hawkish, right-wing policies geared towards dividing the people on communal lines.

The general perception is that he exacerbated the division so as to hang on to power. Bennett, who succeeds him, shares his same right wing policies. He was not only his ally, but also his chief of staff. But, there is a difference. Bennett is considered pragmatic and he is not averse to granting rights to the Palestinians. But, in the same breath, he has ruled out a Palestinian state. He wants Israel to maintain ultimate control over all the lands it occupies.

The immediate gain of the new development is that it ends a political deadlock that has seen four snap elections since 2019. During that time, Netanyahu skillfully managed to keep his rivals bickering and divided while he clung to power, even after he had been indicted in three criminal corruption cases on charges he denies.

Over the past few years Netanyahu made enemies of his friends for his egocentrism, personal and public paranoia and avarice. He is himself to blame for the unification of opposition forces cutting across the political spectrum. The 11-day-long war last month, between Israel and the Hamas in Gaza, that left a trail of death and destruction with the loss of about 250 lives, including scores of children, was totally unwarranted. It was the result of Netanyahu's unnecessary support to right wing elements which deliberately confronted the Arabs in Israel when they were observing Ramadan. No wonder, anti-Netanyahu protesters, who held rallies outside the Prime Minister's residence in Jerusalem for months calling for his ouster, gathered June 12 night with a black banner stretched across a wall that read: "Bye Bye, Bibi, Bye bye." After the new government was voted in, thousands of Israelis waving the blue and white David star flag cheered and danced in central Tel Aviv. This summed the mood of a majority of the people in Israel who are tired of Netanyahu's electoral manipulations. They want the new government to act to improve the economy that is faltering due to the pandemic.

It may be noted that the new coalition has put in public domain its agreements that deliberately skirt contentious issues such as the Israel-Palestine conflict, and concentrate on issues of daily bread and butter. They show the new government would focus mostly on issues such as passing a state Budget and building new hospitals, rather than risk an internal fight. Bennett is unlikely to use, any time soon, his executive powers as PM to further solidify the occupation.

The new trajectory is dictated by the nature of the coalition which is an unlikely assortment of eight parties, including the anti-occupation and dovish Meretz, hawkish figures on the right such as Avigdor Lieberman and Arab Islamist members of parliament belonging to the United Arab List. The latter, made up of Palestinian citizens of Israel, will become the first party from the country's sizeable Arab minority ever to join a government. Its leader, Mansour Abbas, is seen as a realist. He has claimed to have secured guarantees from hard-right coalition partners for greater rights for Palestinian citizens of Israel, including non-discriminatory housing policies, as well as several billions of pounds for infrastructure in Arab areas. Predictably, other Arab politicians in Israel have accused Abbas of abandoning his principles The Hamas and their supporter, Iran, don't find reasons to expect any fundamental change of policies from the new government. But, given the tension that reached feverish pitch in the past few weeks, the experiment may act as a welcome move to cool down tempers and tone down hawkish rhetoric. If it succeeds, it may have some lessons to offer to other countries in the world currently bearing the brunt of communal polarization.

TAX DEAL FOR THE RICH

istoric, game-changing, revolutionary: such has been the widespread reaction to the recent agreement by G7 Finance Ministers on a global minimum effective tax rate of "at least" 15% for large multinational firms. The ministers also agreed on a new formula for apportioning a share of tax revenues from these companies among countries.

But whatever global tax deal eventually emerges should reflect the interests of the world – including the developing countries – and not just those of seven large, developed economies. The developing world relies more heavily on corporate tax revenue and has thus been hit harder by multinationals' tax avoidance, which results in global revenue losses of at least \$240 billion each year.

Many developing economies and low-income countries in particular - are not even taking part in the negotiations on the wider OECD/G20 Inclusive Framework on Base Erosion and Profit Shifting. Those participating have been represented by the Intergovernmental Group of Twenty-Four and the African Tax Administration Forum (ATAF), which coordinate the positions of members that are active in the negotiations. Some G24 members, including Argentina, Brazil, India, Mexico, and South Africa, are also in the G20.

The first concern regarding the G7 deal is that the proposed minimum tax rate of 15% is low, close to the rates in tax havens like Switzerland and Ireland. This reflects a preference by several G7 countries to protect their own multinationals rather than follow the lead of US President Joe Biden's administration, which had initially called for a global minimum rate of 21%.

Moreover, under the current proposal, the majority of the additional tax revenues will go to multinationals' home countries, not to the so-called source countries where these firms generate profits. Unsurprisingly, G24 members want source countries to have priority in applying the minimum tax, particularly in respect of payment of services and capital gains, in order to protect their tax base. Giving priority to global corporations' home countries will reinforce rather than alleviate the unfairness already built into the current international tax system.

How much revenue the minimum tax generates will depend on the rate. A recent study by the EU Tax Observatory estimates that a 21% minimum rate would generate an additional 100 billion (\$122 billion) of corporate income tax revenues in 2021 for the 27 European Union countries, while a 15% levy would yield half that amount. The difference is even starker for developing countries. With a 15% tax rate, South Africa and Brazil stand to gain an additional 600 million and 900 million, respectively, compared to 2 bil-

lion and 3.4 billion at a 21% rate. The Covid-19 crisis has laid bare systemic inequities that will have to be addressed if we are ever going to build more sustainable, resilient, and inclusive societies.

As most African countries have corporate tax rates of 25-35%, a global rate of around 15% is simply too low and thus unlikely to lead to a significant reduction in profitshifting from the region. G7 and G20 countries must demonstrate global leadership by unilaterally committing to introducing a much higher minimum tax rate than whatever is finally agreed. This should be at least 21%, as the US proposed, or, even better, 25%.

The second part of the G7 agreement introduces a formula to apportion multinational companies' global profits for tax purposes. But the proposal would apply only to the largest firms with global profit margins of at least 10%. And at least 20% of their so-called "residual" profit exceeding this threshold

would be subject to tax in the countries where it is generated. Although this new rule would affect US tech giants like Apple, Facebook, and Google, it may end up being applied to only a tiny fraction of the global profits of 100 or so of the largest multinationals. This means that the measure will generate little additional revenue, perhaps less than \$10 bil-

lion globally per year. The G24 has demanded a bigger reallocation of global profits, with the reallocation percentage ranging from 30% up to 50% for the most profitable firms. Likewise, the ATAF has asked for the rules to apply to all multinationals with annual revenues above 250 million much lower than the G7 proposed threshold of \$10 billion, and argues that a percentage of all global profits, whether routine or residual, should be apportioned to the countries where these companies do business.

In fact, it is not possible to distinguish conceptually between the "routine" and "residual" profits of a multinational, as all profits are essentially the result of the firm's global activities. A simpler solution would be to allocate global profits among countries on a formulaic basis, according to the key

factors that generate profit, namely employment, sales, and assets.

Such a rule would help to establish a more level playing field, reduce distortions, limit opportunities for tax avoidance, and provide certainty to multinationals and investors. Instead, the G7's proposed distinction – between routine and residual profits – reflects a political agreement to avoid a far-reaching global reallocation of taxation and revenues.

The global tax negotiations seem to mirror the ongoing COVID-19 vaccine discussions at the World Trade Organization, where EU leaders are blocking the temporary exception to intellectual-property rights demanded by developing countries and supported by the US. In both cases, global leadership requires going beyond na tional interests to ensure that all countries have sufficient resources to develop more equitable and resilient post-pandemic economies. This will require addressing the developing world's demands in a way that is not only historic, but also fair.

Suddenly, American hip-hop and Hollywood seem so 2020. If the pandemic left India locked in for most of the past year, a new wave of imported entertainment seems to have taken over 'desi' mind space during this time. In an age when the internet and OTT increasingly dominate viewing and listening patterns, India says hello to Hallyu. The K-craze is trending. Hallyu is a term that the Chinese

gave to the world and, translated, it means the 'Korean Wave'. Put simply, it refers to Korean pop culture, which has been manifesting itself all over the globe including India over the past few years. The last one year has only consolidated the fact that K-culture is here to stay. Yes, we are talking BTS and "Minari", but also much more. What broadly started as a fad of following K-pop and K-movie is burgeoning into fan culture, especially among the nation's urban youth. After music and films, K-drama has already found inroads into Indian living rooms. Don't be surprised if K-beauty and K-food get essential makeovers and reach the larger Indian market. While the current wave is cer-

tainly the first consolidated attempt for a possible Korean culture influx here, the nation's impact on the Indian psyche has been a gradual process. Korean films have been around for decades – Sanjay Gupta, after all, had rehashed the fabulous "Oldboy" (2003) as "Zinda" by 2006. Closer in time, pop star Psy's "Gangnam Style" had India grooving along with the world in 2012.

This kind of influx, though, did not mark a defining influence on the Indian mindset. An "Oldboy" was a rage, but only as much as numerous other foreign films that were finding space in the DVD shelf of the discernible movie addict, at a time when India was beginning to gain wider access to world cinema at large. Psy's global hit came and went, and was not powerful enough to create or sustain a wave.

What BTS have managed to do is reorient listening habits of the Indian music lover with an ear for foreign whiffs. Between "Dynamite" last year and "Butter" last month, the band has seen a noticeable jump in fan count. The number of Indian fans that have joined ARMY (as the band's ever-growing fan

t- base is known) is swelling, a fact validated by the monstrous hits that
"Butter" has garnered in India
since release May 21.

The success of BTS has prompted another band to look for an Indian entry. The K-pop boy band Tomorrow X Together, popularly known as TXT, released the music video of their first English song "Magic" June 11.

Notably, bands like BTS and TXT are singing in English now, with an obvious eve at the lucrative Englishspeaking global market of which India with a billion and quarter-plus population is a massive chunk. It is also the reason Amazon Prime have been quick to play up hosting recent Korean cinema winners such as the 2020 Best Film Oscar winner "Parasite" and this year's Oscar contender "Minari". If the advent of digital platforms has facilitated the entry of world cinema into average Indian laptops and cellphones, film catalogues of OTT sites including Netflix and Amazon Prime have been seeing a good number of views on even slightly older K-movies such as "Train To Busan", "Burning", "Forgotten", "The Host", "The Drug King", "Psychokinesis", "Dawning Rage", and "The Chase" among others.

The scene has been equally bright in India for K-drama, with Korean shows such as "Start-Up", "Kingdom", "Full House", "The King: Eternal Monarch", and "Boys Over Flowers" finding instant connect with the Indian audience.

The real test, more than OTT, must have been foraying Indian television where K-soap (the 'desi' Ekta Kapoor variety we mean) defined TV formula for over a decade.

In the era of social media networking and aggressive dissemination on the net, inflow of creative content from one country to another is natural. India. a nation that is forever thirsting for entertainment, has always welcomed every imported culture even before the net and social media made access to foreign content easy. The rising popularity of Korean power brands such as Samsung, Hyundai and LG since the opening up of the Indian economy in the late nineties, coupled by the impact of the United States' current interest in Korean culture thanks to inclusivity, has also played indirect roles in influencing India's rising interest in Hallyu.

Delhi sets up vax centre for people travelling abroad

New Delhi, June 14: Delhi Deputy Chief Minister Manish Sisodia Monday inaugurated a special Covid-19 vaccination centre at a city school for students, athletes and people who have to travel abroad for work

People who come under the above categories will be able to get their second vaccine dose at the camp under special provisions after a gap of 28-84 days from the date of their first shot, Sisodia said.

The centre has been set up at the Navyug School situated on Mandir Marg.

Sisodia said the purpose of the special vaccination centre was to wish good luck" to those who would be travelling abroad under the specified categories.

"These days, our children are going abroad for further studies, or have attained jobs outside the country or are participating in international sports events. We have opened this special vaccination centre for all these citizens who are leaving for abroad and need to be vaccinated at the earliest, without any hassle," he said at the inauguration.

'20% of Delhi's 18-44 population vaccinated'

New Delhi: 20% of people in the 18-44 age group in Delhi have been vaccinated against COVID-19 despite the inoculation centres for this category remaining closed for several days due to the non-availabilitv of doses, AAP MLA Atishi said Monday, She, however, said the city is again facing a shortage of vaccines and some of the inoculation centres for the 18-44 age group will be shut on Tuesday.

"So far, 20 per cent of Delhi's young population has been vaccinated (one dose) despite the inoculation centres remaining closed for many days due to the shortage of doses," Atishi said during an online briefing.

According to government data, 13,66,731 first doses and 99,046 second doses have been administered to people in the 18-44 age group in Delhi. Delhi started the vaccination drive for this age group on May 3. Around 92 lakh people are eligible for vaccination in this category.

Kolkata: Though there has been a sharp fall in the number of fresh Covid cases in West Bengal, the state government on Monday decided to extend the lockdown for another 15 days till July 1, with some relaxations to give a boost to economic activities. The state government will review the situation in another four days before taking further decisions. A notification issued by the state home department said that all intrastate local trains and buses, Metro rail, and inland water transport shall remain closed, except for special trains for the movement of emergency and essential service providers. Movement of private vehicles, taxis and auto-rickshaws will be prohibited except to and from hospitals, nursing homes, diagnostic centres, clinics, airports, terminal points and media houses. All schools, colleges, universities, polytechnics, Anganwadi centres and other educational institutions shall continue to remain closed. All social, cultural, academic and entertainment related gatherings shall continue

AIIMS Delhi to begin Covaxin trials on children aged 6-12

New Delhi, June 14: The All India Institute of Medical Sciences (AIIMS) is learnt to have started screening of children aged 6-12 years for the clinical trials of India's first indigenously developed Covid-19 vaccine, Bharat Biotech's Covaxin.

Sources said that the recruitment and clinical trials of the children aged 6-12 years will start from Tuesday. The trial on children aged 6-12 has already started at AIIMS Patna.

Participants would be given the vaccine after their screening report comes. The trial would ensure if the Bharat Biotech jab is suitable for children. Delhi AIIMS has decided to start the trial drive after the recruitment and clinical trial for single-dose Covaxin for 12-18

age group is over.

After the recruitment of 6-12 year-old children, AIIMS Delhi will be conducting trials for the age group 2-6 years of children. The trials are taking place at 525 centres.

The screening of children for the trial of single-dose Covaxin among those aged between 2 and 18 years started at the AIIMS in New Delhi on June 7 after India's drug regulator had granted permission for conducting the Phase 2 and 3 clinical trials of Covaxin in the age group 2 to 18 years May 12.

AIIMS Patna, Mysore Medical College and Research Institute in Karnataka have also been selected to conduct clinical trials on children. Covaxin is being used on adults in India's ongoing Covid-19 vaccination drive since January 16 this year.

New Delhi, June 14: Bracing for a possible third wave of coronavirus, several private hospitals in Delhi have started installing their own oxygen generation plants to avoid a repeat of the oxygen crisis the city witnessed during the second wave.

These include Jaipur Golden Hospital and Batra Hospital, where patients had died due to oxygen shortage during the peak of the second wave of the pandemic.

Recently, the Directorate General of Health Services had asked all private hospitals having 100 or more beds to install their own Pressure Swing Absorption (PSA) oxygen



'With the installation of oxygen generation plants at most hospitals, the load on vendors supplying liquid medical oxygen will reduce and these will be able to cater to smaller hospitals," he said.

70,421 **fresh cases**

Ishrat case: Passports returned to kin of man after 17 years

Ahmedabad, June 14: Days after a CBI court here in Gujarat allowed their applications, the wife and two children of Javed Sheikh, one of the four persons killed in the 2004 Ishrat Jahan alleged fake encounter case, Monday got back their passports which were seized by the police 17 years ago, their lawver said.

Å court of special CBI judge VR Raval had June 9 allowed the applications of Sheikh's wife Sajida, his son Siddique and daughter Jainab, seeking their passports from the possession of the Ahmedabad city crime branch. The court had allowed their pleas on conditions that it will have to be informed about their visit to a foreign country as well as the details of their stay, and they cannot stay overseas for more than three months.

Their passports were in the possession of the city crime branch after they were seized along with other documents by the Pune police from their residence in 2004 and handed over to them soon after an "encounter" by the police in which Ishrat Jahan, a Mumbai woman, and three others - Javed Sheikh alias Pragnesh Pillai, Zeeshan Johar, and Amjad Ali Rana - were killed on Ahmedabad outskirts June 15, 2004.

The police had then claimed the four were terrorists who were planning to kill the then Gujarat Chief Minister Narendra Modi.

New Delhi, June 14: A 60-year-old woman and a 17-year-old minor girl from West Bengal have moved the Supreme Court alleging horrific gang-rape by Trinamool Congress workers, for their families supporting the BJP in recently-held Assembly election and sought an SIT probe into all incidents of postpoll violence.

The 60-year-old woman alleged_ that she was raped in front of her 6-year-old grandson by Trinamool workers on the intervening night of May 4-5 and termed it "a glaring living example of the nature of post-poll violence unleashed throughout the state against familv members of those who opposed the ruling party" The woman said May 3, after declaration of poll results, a mob of 100-200 people, which mainly comprised of Trinamool supporters, surrounded her and asked the family to leave the house. "Despite the BJP having emerged victorious in the assembly constituency (Khejuri), workers of the ruling party in the state got infuriated and started burning down houses of BJP supporters, hurling bombs, even inflicting physical torture, and looting jewellery and other valuables," said the woman's application. The woman said that "while history is replete with gruesome instances where rape was employed as a strategy to terrorise the enemy civilian population and to demoralise enemy troops, but never have such cruel crimes been committed against a woman citizen for her or her family's participation in the democratic process"

Climate-based solutions for eliminating malaria in India

New Delhi, June 14: The India Meteorological Department (IMD) and the Indian Council of Medical Research (ICMR) Monday partnered with Malaria No More, a non-governmental organisation, to launch an expert committee that will explore and advance climatebased solutions for eliminating malaria in India.

The India Interagency Expert Committee on Malaria and Climate (IEC) will consist of leading experts and researchers from health, climate and technology fields who



will help define and operationalise sophisticated climate-based malaria prediction tools that will be tailored to the Indian context to further propel progress toward the country's goal of eliminating malaria by 2030.

"We are excited to identify a new, multidisciplinary application for our high-quality climate data services. Malaria is one of India's most pressing health concerns. By combining meteorological information with the information from the health sector, we can examine microtrends and predict malaria patterns, and accelerate our national progress towards its elimination.

The Interagency Expert Committee announced today will function as a highly effective platform to accomplish this objective,' said Mrutyunjay Mohapatra, Director General of Meteorology, IMD, Government of India, in a statement.

Year after actor SSR's death, CBI probe continues

New Delhi, June 14: The CBI probe into actor Sushant Singh Rajput's death is still continuing, even after the AIIMS medical board's report last year that had said it was a case of suicide.

Asked about the developments, Central Bureau of Investigation (CBI) officials said the probe is continuing and all angles are being looked into. The central agency that took over the probe from the Bihar police, which had registered a case of abetment to suicide on a complaint from the Patna-based father of Rajput, had formed a special investigation team (SIT) but failed to make much headway into

the case except recording state-

ments and receiving the forensic re-

ports from the AIIMS panel led by Sudhir Gupta, the head of the institute's forensics department.

In its conclusive medico-legal opinion to the CBI, the six-member team of forensic doctors had dismissed the claims of "poisoning and strangling" made in the case of Rajput's death. "It is a case of hanging and death by suicide. We have submitted our conclusive report to the CBI," Gupta, the chairman of the forensic medical board, had said in September last year.

After the report was published, Vikas Singh, the lawyer of Rajput's father KK Singh, had said, "We are highly perturbed with the AIIMS report. We are going to request the CBI director to constitute a fresh forensic team." "How could the

by the Cooper hospital, wherein the time of death was also not mentioned?" he had asked.

The CBI did not take the advice of Singh, a noted criminal lawyer, to constitute a fresh board. Asked if he was satisfied about the progress of the CBI probe, Singh told PTI over the phone, "No, I am not satisfied." Last year, after the conclusion of the forensic panel that it was a case of suicide emerged, the agency had issued a statement saying its probe was continuing.

'Certain media reports attrib uted to the CBI investigation are speculative and not based on facts. It is reiterated that as a matter of policy, the CBI does not share the details of an ongoing investigation. A CBI spokesperson or any team member has not shared any details of the investigation with the media. The details being reported and attributed to the CBI are not credible," the agency had said. Rajput (34) was found hanging from the ceiling of his apartment in suburban Bandra in Mumbai June 14 last year.

The CBI had recorded the statements of Rhea Chakraborty, the rumoured girlfriend of Rajput, and others in his close circle, and collected the actor's medical records, but is yet to arrive at a conclusion.

It had also sent a questionnaire to the forensic panel to seek clarifications on its findings but failed to conclude its investigation into the matter. New Delhi, June 14: Five of the six Lok Janshakti Party MPs in Lok Sabha have joined hands against their leader Chirag Paswan and elected Pashupati Kumar Paras, the youngest brother of Paswan's late father and party founder Ram Vilas Paswan, in his place, causing a big churn in Bihar politics.

Paras Monday lauded Bihar Chief Minister Nitish Kumar as a good leader and "vikas purush" (development-oriented man), highlighting the deep fault lines within the party as his nephew has been a strong critic of the supreme JD(U) leader.

"I have not broken the party but saved it," Paras, the MP from Hajipur, told reporters. He asserted that 99 per cent of LJP workers were unhappy with the turn of events in Bihar as Paswan led his party against the JD (U) and it fared poorly in the 2020 assembly polls.

The LJP has been on the brink of collapse, he said in reference to its poor show in the polls, and lashed out at "anti-social" elements in the party, an apparent pointer to a close aide of Paswan whose proximity to him has not gone down well with many party leaders. Paras said his group will continue to be



that Paswan can remain in the organisation. The group of five MPs has con-

veyed their decision of electing Paras as the LJP's leader in Lok Sabha to the Speaker. The five MPs had met Speaker Om Birla Sunday night to inform him about their decision to replace Paswan with Paras as their leader. Sources in the Speaker's office

said that their request is under

consideration There has been no comment from Paswan on the issue. Soon after Paras spoke to reporters, Paswan drove to his uncle's residence in the national capital to meet him. Paswan's cousin and MP Prince Raj also stavs there.

Paswan, who has not been keeping well for some time, waited for over 20 minutes in his car before he was let into the house and then left after spending more than an hour inside. He left without saying

a word to waiting media persons. It is believed that neither of the two rebel MPs met him. A household help said the two were not at home when the LJP chief arrived.

Paras had long been unhappy with Paswan's style of functioning and was joined by other MPs, including Chandan Singh, Veena Devi and Mehboob Ali Kaiser, as they believed that his campaign against Nitish Kumar had left them at a disadvantage in the state's politics. Kaiser has been elected the party's deputy leader. The group is also likely to stake claim in the Election Commission to represent the real LJP with its president now left isolated at the top after taking on the mantle following his father's death last year. It may move to oust Paswan from the top party post in the coming days. Sources close to him have blamed the JD(U) for the split, saying the party had long been working to isolate the LJP president after his decision to go all out against Chief Minister Kumar in the 2020 assembly polls.

The JD(U), which was for the first time reduced to the status of a junior partner to the BJP after it lost more than 35 seats due to the presence of LJP candidates, has been seething and had worked to woo over a number of LJP's or-

ganisational leaders to its fold. The lone LJP MLA joined the JD(U). Paras denied the charge that

Kumar's party had a role in the split. The BJP, which has its share of pro-Paswan voices as well as his critics, maintained a silence over the matter, with some party leaders noting that it was an internal matter of the party.

Though he had left the ruling NDA in Bihar to fight independently in the assembly polls, he has maintained a strong pro-BJP and pro-Prime Minister Narendra Modi stand. With buzz growing about a reshuffle in the Union cabinet, political watchers believe that the development is aimed at thwarting Paswan's chances to join the government but it remains to be seen as to how the saffron party sees the implosion in the LJP. As such, the equation between

the BJP and the JD(U) has been far from smooth despite both parties sharing power in Bihar, and Kumar has been taking various measures to bolster his party's strength after suffering a setback in the assembly polls. Paras is seen as more pro-Nitish Kumar than pro-BJP, and Paswan's complete marginalisation is not something many BJP leaders will wish even though a section of the party has been miffed with his conduct, sources said.

AIADMK expels 17 leaders for having spoken to Sasikala

Chennai, June 14: The AIADMK meeting held at the party headquarters here expelled 17 leaders including party spokesman V Pugazhendi for having contacted former interim general secretary VK Sasikala.

The meeting also passed a resolution against Sasikala, castigating her for "reaching out" to certain party leaders. The resolution also accused her of trying to capture the party and staging a drama by speaking to certain leaders and then selectively leaking parts of the conversations.

Sasikala had tried to enter Tamil Nadu politics with a bang after she was released from Bangalore Central prison after serving four

Former Minister M Anandan and former **Member of Parliament** Chinnaswamy were among the other senior leaders who were expelled from the party

years' imprisonment in a case related to disproportionate assets.

She had arrived in Tamil Nadu on February 7, 2021, in a convoy of 1000 vehicles from Bengaluru and had received a huge reception along the way taking a full day for a 350 km drive - generally covered in 6 to 7 hours. After a few days of dabbling in state politics, Sasikala suddenly announced that she was withdrawing from active politics much to the surprise of political observers and party sympathizers.

However after the assembly election results came and AIADMK lost the polls, Sasikala started resuming her meddling in the party and selectively leaked her telephonic conversations with several senior, middle and lower-level leaders and cadres of the AIADMK across the state. She has publicly announced through these chats that she was very much in the reckoning for active politics. AIAMDK leaders Edappadi K Palaniswami and O Panneerselvam had openly denounced her statements and had strongly warned party leaders and cadres that if there was any truck with her they would be expelled from the party.

'Single dose of nCoV vax sufficient for those already infected'

Hyderabad, June 14: A single dose of vaccine is sufficient for those already infected by Covid-19, revealed a study by Hyderabad's AIG Hospitals.

The hospital announced Monday that it conducted a study on 260 healthcare workers who got vaccinated between January 16 and February 5 to assess the immunological memory response in all those patients. All patients were given the Covishield vaccine.

Two significant observations came out of the study, which has been published in the International Journal of Infectious Diseases, a peer-reviewed journal.

The previously infected group (people who got infected with Covid-19) showed a greater antibody response to a single dose of vaccine compared with those who had no prior infection.

It also revealed that Memory Tcell responses elicited by a single dose of vaccine were significantly higher in the previously infected group compared with those who had no prior infection.

It was concluded that higher memory T and B-cell responses in addition to higher antibody response with a single dose of vaccine given at 3-6 months after recovery from Covid-19 may be considered at par with two doses of vaccine for individuals already



infected with Covid-19.

The results show that people who got infected with COVID-19 need not take two doses of vaccine yet with a single dose can develop robust antibody and memory cell response at par with two-doses for those who didn't get the infection. This will significantly help at a time when there's a shortage of vaccine in the country and more people can be covered using the saved doses," said Dr. D Nageshwar Reddy, Chairman, AIG Hospitals, and one of the co-authors in the study.

'Once we attain the requisite number of people vaccinated for achieving herd immunity, these patients who got infected and received only one dose can take the second dose of the vaccine. At this point, all our strategies should be directed at the widespread distribution of available vaccines and to include the maximum number of people at least with a single dose, he added

During the second Covid wave when cases were growing exponentially; the vaccination rate took a downturn. As of April 27, when the growth rate of active infection was 5%, the growth of vaccinated people was just 1.4 per cent.

"We need to modify vaccination strategy based on scientific evidence and with the objective that a larger set of the population canbe covered in the shortest duration," he said.

Department of Energy There is no reaction yet in Beijing by the Chinese government or officials on this report, it said.

The media report said despite the alarming notification from Framatome, the French company, the Biden administration believes

the facility is not yet at a "crisis level'

While US officials have deemed the situation does not currently pose a severe safety threat to workers at the plant or Chinese public. it is unusual that a foreign company would unilaterally reach out to the American government for help when its Chinese state-owned partner is yet to acknowledge a problem exists.

The scenario could put the US in a complicated situation should the leak continue or become more severe without being fixed, the report said. However, concern was significant enough that the US National Security Council held

multiple meetings to discuss the situation, it said.

The Biden administration has discussed the situation with the French government and their own experts at the Department of Energy, the report said, adding that the US has also been in contact with the Chinese government.

China's nuclear power generation was in news last month as the Chinese President Xi Jinping and his Russian counterpart Vladimir Putin attended via virtual ground-breaking ceremony of the biggest nuclear energy project to build four nuclear power plants in China by Russia costing about USD 3 billion.

A Justice Ministry spokeswoman confirmed Monday that authorities have written to Telegram's operators in the United Arab Emirates over its failure to provide a channel for raising complaints and a contact person in Germany.

The company now has the opportunity to respond," the spokeswoman, Rabea Boennighausen, told reporters in Berlin.

Der Spiegel reported that the company could face fines of up to 5.5 million euros (USD 6.7 million) if it doesn't comply with the requirements.

Telegram couldn't immediately be reached for comment.

Washington, June 14: Novavax Inc Monday reported late-stage data from its US-based clinical trial showing its vaccine is more than 90% effective against Covid-19 across

a variety of variants of the virus. The study of nearly 30.000 volunteers in the United States and Mexico puts Novavax on track to file for emergency authorisation in the United States and elsewhere in the third quarter of 2021, the

company said. Novavax's protein-based Covid-19 vaccine candidate was more than 93% effective against the predominant variants of Covid-19 that have been of concern among scientists and public health officials, Novavax said.

Protein-based vaccines are a conventional approach that use purified pieces of the virus to spur an immune response and vaccines against whooping cough and shingles employ this approach. During the trial, the B.1.1.7 variant first discovered in the United Kingdom became the most common variant in the United States, it said. Novavax also detected variants of Covid-19 first found in Brazil, South Africa and India among its

trial participants, Novavax's head of research and development, Dr Gregory Glenn, told Reuters. The vaccine was 91% effective

among volunteers at high risk of severe infection and 100% effective in preventing moderate and severe cases of Covid-19. It was roughly 70% effective against Covid-19 variants that Novavax was unable to identify, Glenn said. "Practically speaking, it's very im-

portant that the vaccine can protect against a virus that is wildly swinging around" in terms of new variants, Glenn said.

Novavax said the vaccine was generally well tolerated among participants. Side effects included headache, fatigue and muscle pain and were generally mild. A small number of participants experienced side effects described as severe.

Novavax remains on track to produce 100 million doses per month by the end of the third quarter of 2021 and 150 million doses per month in the fourth quarter of

2021, the company said The Maryland-based company has repeatedly pushed back production forecasts and has struggled to access raw materials and

Islamabad, June 14: In a rare agreement between two arch-rivals India and Pakistan, which have a history of long-time rivalry with disputes on every front from sea to land, exporters from both sides of the border have mutually agreed to share the ownership of the region's prized Basmati rice, a solution considered the most workable to reach the European markets.

There has to be a joint ownership, which is a logical solution to the dispute, said Faizan Ali Ghouri, a Pakistani rice exporter.

The fight between India and Pakistan over the claim of the origin of Basmati rice has a long history, as this variety is produced largely on both sides of the border.

India has filed a claim in the European Union (EU) seeking a geographical indication (GI) tag



for Basmati rice. Pakistan, on the other hand, has opposed India's claim and has filed a request for a protected GI tag.

There is no logic in both countries' claim for the sole exclusivity of Basmati rice. Although its ori gin is Pakistani Punjab, it is grown in both sides of the border. Therefore, a joint ownership is the only viable solution to the longstanding dispute, said Ghouri.

The EU buyers also prefer joint ownership of the rice variety as they want to keep both New Delhi and Islamabad on board in terms

of commodity exports, he added.

Ghouri's views were seconded by Ashok Sethi, the director of Punjab Rice Millers Export Association in India, who also suggested that both the countries should jointly protect the Basmati heritage.

India and Pakistan are the only two countries which produce Basmati in the world. Both should jointly work together to save the heritage and protect the GI regime of the rice, said Sethi.

It is pertinent to mention that EU had recognised Basmati as a joint product of India and Pakistan in 2006

Both Pakistan and India make good money from their respective exports of Basmati rice. Pakistan annually earns \$2.2 billion, while India makes about \$6.8 billion from Basmati exports.

Both countries export Basmati rice. India, in its application to the EU, has never stated that it is the only Basmati producer in the world, insisted Vijay Sethi, a New Delhibased exporter.

While both sides still have their own historical details on the origin of Basmati, it is rare to see two arch-rivals, who are not ready to come to the table for talks until their demands are met, come down to a mutual agreement.

Pakistan demands India to reverse its August 5, 2019 decision that changed the special status of the erstwhile state of Jammu and Kashmir and bifurcated it into two Union Territories by abrogating Articles 370 and 35A, as a benchmark to make way for dialogue ২ and address other issues between the two countries.

India, on the other hand, demands Pakistan to stop cross-border terrorism and take decisive action against terror elements,which it claims, enjoy the support of the establishment.

New Delhi, June 14: Shares of Adani Group companies witnessed a massive drubbing in morning trade Monday, tumbling up to 25 per cent, amid reports that the National Securities Depository Ltd (NSDL) has frozen certain FPIs accounts that have holding in some of these firms.

Billionaire Gautam Adani's group Monday said accounts of three Mauritius-based funds that own the port-to-energy conglomerate's stocks were not frozen and any reports suggesting the contrary were "blatantly erroneous and misleading".

Shares of Adani group companies plunged Monday after reports that the National Securities Depository Ltd (NSDL) froze the accounts of the three foreign funds that are among the top stakeholders in the firms. While Adani group said all the accounts of its top shareholder funds were active, NSDL in an email to the group also confirmed their 'active' status.

Adani Enterprises closed the day 6.26 per cent lower at ₹1,501.25 and Adani Ports and Special Economic Zone tumbled 8.36 per cent to close at ₹768.70 on the BSE. During the morning trade, Adani Enterprises had tanked 24.99 per

UN TRADE FORUM 2021 World has to decouple trade policy, green goals'

New Delhi, June 14: Hoping that the developed countries will not use the inter-play of trade and climate challenge "too much". Commerce and Industry Minister Piyush Goyal Monday said the world should decouple trade policy and its green goals.

He also hoped that credit rating agencies and bodies like the IMF "which kind of dictate" the financial architecture of the world do not land up being unfairly harsh on the developing and less-developed countries as this is a time to become compassionate, more liberal and supportive to these nations.

'I think a little longer rope needs to be given even to earlier agreements or earlier commitments so that these countries (developing and less developed) have space to bring their economies back on track," Goyal said at the UN Trade Forum 2021.

Let the trade policy look for more inclusive growth all over the world and all the countries need to work towards climate justice and sustainable lifestyle.

We do hope that the developed world will not use the inter-play of trade and climate challenge too much because I think trade should allow all countries to prosper.

"It should not create trade barriers which will ultimately become a hindrance to taking prosperity to the poorer, lesser developed countries," he said.

Goyal added: "I do believe that we have to decouple trade policy and

Rather, he said, the UN and the other multilateral agencies like the UNFCCC (United Nations Framework Convention on Climate Change) should focus on getting the world together to fulfil their commitments around climate change.

The minister added that there should be differentiated responsibilities when it comes to the developing world or the less-developed countries, as they have to fulfil their commitments which they made in Paris particularly relating to capital, and technology

Further, Goyal said the world should learn lesson from the 2008 economic crisis and the developed world should not land up in "over adventurism" in terms of fiscal proliferation.

Talking about healthcare, he said that under the Ayushman Bharat scheme, 500 million people have access to medical facilities free of charge and "we are going to expand it to 100 per cent coverage so that every citizen in India and every resident gets access to healthcare".

The government is investing in upgrading healthcare facilities and expanding them, he added.

London, June 14: Cloudtail India Pvt Ltd - the online retailing joint venture of Infosys co-founder NR Narayana Murthy's firm and Amazon.Com - faced a 5.5 million pounds demand, including interest and penalties, from tax authorities after it paid "meagre" taxes over the past four years, a media report said on Monday.

Amazon reportedly developed independent sellers such as Cloudtail, as 'special merchant' which enjoyed over 35 per cent of total sales on the platform until 2019.

While Murthy's Catamaran Ventures indirectly holds 76 per cent in Cloudtail and Amazon the remaining 24 per cent, the firm's two top posts - chief executive and finance director - were with the US retailer: Cloudtail's holding company, Prione is also run by a former Amazon manager, the report in 'The Guardian' newspaper said.

It said that it is not known precisely what the tax dispute is about and the company said that it was contesting the bill, adding that since the "matter is sub judice, we are unable to comment any further".

The office of UK Chancellor of the Exchequer Rishi Sunak, who is son-in-law of Murthy, was forced to comment. The revelations come just days after Sunak led the G7 finance ministers' charge to agree toa global deal designed to make tech companies pay more tax.

Less affluent most sceptical about economic outlook: Study

New Delhi, June 14: Consumer anxiety is at the highest levels since the outbreak of coronavirus pandemic in India with the less affluent most sceptical about economic outlook while a majority of consumers think their income in the next six months will be lower than the pre-Covid levels, says a lat-

est study. As per the Covid-19 consumer sentiment research by global management consulting firm Boston Consulting group (BCG) conducted between May 23 and May 28, 2021, covering around 4,000 respondents across metros, tier I, II, III, IV and rural India, 51 per cent of consumers expected their spends over the next six months to be lower.

In the last round of survey con-

ducted from July 20 to August 2, 2020, the figure stood at 40 per cent.

As many as 83 per cent of the respondents agreed that coronavirus posed a high level of threat to their jobs or businesses, while another 86 per cent felt that there would be an economic recession due to the pandemic.

In terms of income outlook, 58 per cent of the respondents expected a decline in income in the next six months, the study said adding the decline in income sentiment is the steepest among less affluent/small towns.

It found that 76 per cent of respondents in the 'struggler/next billion' category expected income lower than the pre-Covid level, while the same was also true for 60 per cent in the 'aspirer' segment. > more in urban/affluent India, the study said. Consumer spending sentiment for essentials, health, at-home entertainment has remained stable or showed minor decline. On the other hand, the expected cutbacks on travel, out of home entertainment and vehicle

Commenting on the findings, BCG India Managing Director and Partner Nimisha Jain said. "There is an impending sense of uncertainty, however, we have observed certain positive messages too." The spending sentiment has not been impacted similarly across categories. Essentials. health, in-home entertainment continue to be winners. Some of the discretionary categories, however, have been negatively impacted, she added.

The teams will meet in the group stage of a European Championship or World Cup for the first time Tuesday when they open their Euro 2020 campaigns in Munich. Their last match at a major tournament came in the Euro 2016

semifinals. Antoine Griezmann scored twice for France in the 2-0 victory over then-World Cup champion Germany in Marseille.

Germany has never really recovered, and though the French lost to Portugal in the final five years ago, they went on to win the World Cup two years later.

Remarkably, no player in Germany's current squad has ever scored in a Euro match. Thomas Muller, who has played 11 tournament games, missed a penalty in the 2016 quarterfinal shootout win over Italy. German hopes this time are pinned on a good start in Munich to set the team up for success in Joachim Loew's last tournament as coach after 15 years in charge.

Loew — or 'Jogi', as he's affectionately known — decided to step down after the tournament to let someone else lead the shakeup he started after Germany's failed World Cup campaign in 2018. His former assistant, Hansi Flick, will oversee qualifying for next year's World Cup in Qatar.

Loew recalled the experienced Müller and Mats Hummels for this year's competition and their return appears to have had the

"The losing team will get USD 800,000 (₹6 crore approximately) for finishing second in the nineteam competition, which was played over a near two-year cycle, adding context to Test cricket and to crown the first official World

Champions in the longest format of the game," the statement read further.

The governing body said that the team finishing third among the nine competition nations will get USD 450,000 cheque, while the prize money for the fourthplaced team will be USD 350,000. "The one that finishes fifth gets USD 200,000 while the remaining four teams will get USD 100,000 each," it said.

The inaugural World Test Championships saw nine teams competing over a near two-year cycle to add context to Test cricket. The team claiming the inaugural World Champions title in the

longest format of the game will get the Test Mace, which was previously given to teams topping the ICC Men's Test Team Rankings. "In case the final ends in a draw

or a tie, the finalists will split the prize money for the first and second places and share possession of the Mace during the time they remain champions," the ICC said.

Glasgow, June 14: Patrik Schick struck twice to help Czech Republic off to a winning start at the UEFA Euro 2020 as they defeated Scotland here, Monday.

Schick put the Czechs ahead in the 42nd minute with a powerful header after muscling himself between two Scotland defenders following a cross from Vladimir Coufal.

However, it was his second goal that will be talked about for years to come. Scotland lost possession when a shot was blocked and the ball fell to Schick. The Bayern Leverkusen forward looked up and spotted opposing goalkeeper David Marshall way off his line before hitting a long, curling shot that bounced into goal. Marshall gave chase, but he could only watch the ball sail into the goal before he ended up tangled in net.

UEFA said it was the longest distance for a goal in the tournament at 49.7 meters. The previous record of 38.6 meters came from Germany midfielder Torsten Frings at Euro 2004.

Brazil begin Copa with win

Sao Paulo, June 14: Brazil kicked off a Copa America tournament that has been opposed by some members of its own team with a 3-0 win over Venezuela here.

Marquinhos, Neymar and Gabriel Barbosa scored in the opener at Mane Garrincha stadium in Brasilia on Sunday, less than a day after several Venezuelan players tested positive for COVID-19.

South American football's governing body, CONMEBOL, chose Brazil as host less than two weeks ago, despite its alarming COVID-19 figures, after Argentina and

Colombia were dropped as co-hosts. Despite his opposition to staging the tournament in his home country, Brazil captain Casemiro said the defending champions intended to retain their trophy.

Venezuela summoned 15 new players at short notice after eight squad members tested positive for COVID-19 on Saturday, and the disruption showed on the field. The Selecao wasted opportunities but faced little resistance from Venezuela. Brazil opened the scoring in the

23rd minute after a corner kick ended with Marquinhos striking from close range. For the second, Everton Ribeiro found Danilo on

the right edge of the box, and the Brazilian was pushed to the ground.

Neymar calmly scored from the spot in the 63rd to make it 2-0. He looked to the right of Venezuelan goalkeeper Joel Graterol, but took his shot to the left. The PSG superstar dribbled past Graterol and crossed for Barbosa to chest the ball into the empty net in the 89th.

Brazil and Colombia lead with three points each, but the defending champion is ahead by goal difference after Colombia's 1-0 win against Ecuador. Brazil's second match will be against Peru Thursday. Venezuela will face Colombia on the same day at the Olimpico stadium in Goiania

COLOMBIA VICTORIOUS

A surprising choreographed move gave Colombia a 1-0 win against Ecuador in its first match of Copa America. Edwin Cardona scored the winner at the Arena Pantanal in Cuiaba in the 42nd minute of a tense game Sunday.

The decisive moment started when midfielder Cardona took a free-kick close to the edge of the Ecuadorian penalty box. Instead of shooting, he exchanged three short passes with Juan Guillermo Cuadrado, who moved the ball forward to where Miguel Boria was waiting.

Borja headed the ball back to Cardona, who had run toward goalkeeper Pedro Ortiz and who scored with a right-foot shot as the Ecuadorian defenders watched on. video review.
