A prominent member of G23, which had sought an organisational overhaul in the Congress, Sibal's tenure as Congress' Rajya Sabha MP ends in July.

### **TERROR FUNDING** LIFE TERM FOR **YASIN MALIK**

New Delhi, May 25: A Delhi court Wednesday awarded life imprisonment to Yasin Malik, one of the foremost separatist leaders of Jammu and Kashmir, in a terror funding case, saying the crimes were intended to strike at the "heart of the idea of India" and intended to forcefully secede J&K from Union of India.

Special Judge Praveen Singh awarded varying jail terms to Malik for offences under the stringent anti-terror law--Unlawful Activities Prevention Act (UAPA) and the IPC, rejecting the NIA's plea for capital punishment. He said the crimes for which Malik was convicted were of very serious nature. "These crimes were intended to strike at the heart of the idea of India and intended to forcefully secede J&K from UOI. The crime becomes more serious as it was committed with the assistance of foreign powers and designated terrorists



The seriousness of crime is further increased by the fact that it was committed behind the smokescreen of an alleged peaceful political movement," the judge said.

The judge said the manner which the crimes were committed was in the form of conspiracy whereby there was an attempted insurrection by instigating, stone pelting and arson, and a very largescale violence led to shutting of the government machinery. P9

## 21 killed in Texas school shootout

US President Joe Biden accuses the gun lobby of blocking enactment of tougher firearm safety laws

#### AGENCIES

Houston, May 25: In one of the worst school shootings in American history, an 18-year-old gunman in body armour massacred at least 21 people, including 19 children and two adults at an elementary school in Texas state, with an emotional President Joe Biden urging lawmakers to "turn this pain into action" to control the powerful gun lobby.

The youth opened fire at Robb Elementary School in Uvalde town. Texas. 134 km from San Antonio, at about 11:30am Tuesday before he was killed by law enforcement, officials said.

Investigators say the suspect was armed with a handgun, an AR-15 semi-automatic rifle and high-capacity magazines.

Texas Governor Greg Abbott identified the killer as Salvador Ramos, a resident of the area where the school was located. The shooter's motive remains unclear. The teenager is suspected of shooting his grandmother at the start of the rampage, US media reports said.

'He shot and killed horrifically, incomprehensibly, Fourteen students and a teacher were killed," Abbott said. Later the toll was raised to 19 children and two adults dead. Two law enforcement officers were shot but are expected to recover, Abbott said. Names of the deceased and other details were yet to be re-

leased. According to the school website, its students are aged between 5 years and 11 years. Chief of Police, Uvalde, Pete

Arredondo said the "mass casualty event occurred at Robb Elementary School at about 11:32 this morning." He said the killer acted as a lone wolf - who was shot dead in a police exchange.

The deceased children are in the second, third and fourth grades - aged between 7 years and 10 years, he said.

In a prime-time address Tuesday, a visibly emotional Biden asked what it would take to convince fellow lawmakers that "it's time to act." A Democrat, Biden accused the gun lobby of blocking enactment of tougher firearm

safety laws. President Biden again tried to comfort a nation grieving after a mass shooting, urging action to counter powerful gunmakers and repeatedly questioning why the country he leads lacks "the backbone" to stem the bloodshed.

"How many scores of little children who witnessed what happened — seen their friends die as if they're on a battlefield, for god's sake," said Biden. "To lose a child is like having a piece of vour soul ripped away. There's a hollowness in your chest." Turning to the issue of gun control legislation, Biden implored lawmakers to "turn this pain into action".

As per sources, the BSCL will spend ₹20 crore under Smart City Mission for the project which will cater to providing water at residential units which may be used for drinking and cooking purposes without additional filtering or boiling. Initially, the scheme will be introduced in Saheed Nagar, Satya Nagar, Kharvela Nagar, Bapuji Nagar and Ashok Nagar.

"Water safety and cleanliness are essential not just for human health, but are also needed for developing resilient communities by reducing absenteeism from school and work, ensuring a safe environment, and cutting healthcare costs. With an emphasis on urban poor, this will be a fair, sustainable, and people-centered service delivery," said Sanjay Kumar Singh, BSCL CEO.

While ₹20 crore would be provided by BSCL, the remaining will be provided by the state government.

Sagar, May 25: A sub-postmaster in Madhya Pradesh's Sagar district allegedly spent depositors' money to the tune of ₹1.25 crore on IPL betting, an official said Wednesday.

The accused, Vishal Ahirwar, 36, was arrested May 20 after matter came to light earlier this month when some people contacted the sub-post office, located in a railway premises here, on the completion of their fixed deposit (FD) terms, GRP police station in-charge Ajay Dhurve said.

The depositors were shocked when the post office employees



told them that their FD numbers and account numbers did not exist in the records and there were no FDs in their names, he said.

When the depositors repeatedly visited the sub-post office for next few days to enquire about their investments, they were told that the

sub-post master had allegedly put their money into an IPL betting racket app offering to multiply it fast, the official said.

Ahirwar was then suspended, following which the depositors complained to police against him. Based on the complaints of the depositors, the police arrested Ahirwar May 20, the GRP official said. During questioning, Ahirwar told the police that he had invested the depositors' money in the IPL betting racket app that promised quick and rich dividends, the official said.

The husband of a woman, Varsha, had deposited ₹9 lakh in the post office. However, she lost her husband and father-in-law during Covid-19 crisis, another official said. An elderly woman, Kishori Bai, had deposited ₹5 lakh in the post office for arranging funds for the marriage of her four daughters, but she is now left with nothing, he said.

Another senior citizen, Parmanand Sahu, who had deposited his retirement benefit amount in the post office considering it as the safest investment option, is now running from pillar to post to recover the money, the official said.

Following Ahirwar's questioning, names of 20 victims have so far come to light who have been allegedly duped of about ₹1.25 crore, Dhurve said.

A case has been registered against Ahirwar under Indian Penal Code Sections 420 (cheating) and 408 (criminal breach of trust by clerk or servant), the official said.

### Mercury touches 44°C in Deogarh

Bhubaneswar, May 25: The maximum temperature shot up to 44 degrees Celsius in Deogarh town of western Odisha Wednesday even as moderate to heavy rain battered the southern region of the state, the Met office said.

The maximum temperature rose by around 2-5 degrees Celsius at some places, and only five weather stations recorded a mercury level of over 40 degrees Celsius, the Bhubaneswar Meteorological Centre said.

Ramanaguda town in Rayagada district received 65 mm of rainfall, the highest in the state, followed by 50 mm in Koraput. Moderate rain occurred in

Altogether 1,108 and 907 persons had died in hit-and-run accidents in the state in 2019 and 2020, respectively. Besides, 1,250 and 902 persons had sustained grievous injuries in hit-and-run cases across the state in 2019 and 2020.

The BJD spokesperson asserted that the plan was prepared and public opinion elicited. Thereafter, the plan was recommended by the Srimandir Managing Committee. The Srimandir Parikrama Plan was then taken to the Odisha Legislative Assembly, where it was passed unanimously by all MLAs

without any opposition, it said. He also said, "The ASI gave certain suggestions which were duly incorporated and modifications done (to the plan) accordingly."

he incident took place at 12:10am near Durgaprasad village in Ganjam and 15 people among the injured are in serious condition, the police said Wednesday. The bus, carrying 77 people, about 65 of them tourists from West Bengal's Howrah and Hooghly, was moving towards Visakhapatnam in Andhra Pradesh from Daringibandi in Kandhamal district when the mishap took place. Ganiam SP Brijesh Rai said.

Police and firefighters from nearby Bhanjangar rushed to the spot and rescued the bus passengers, 40 of who were injured.

Police suspect that the bus rolled down the road while negotiating a curve in the hilly terrain after the driver lost control over the vehicle. The bodies of the six tourists

who died in the mishap were re-

trieved after breaking the win-

dow panes of the bus, Bhanjanagar SDPO SS Mishra said.

The deceased were identified as Supiya Denre, 33, Sanjeet Patra, 33, Rima Denre, 22, her mother Mausumi Denre and Barnali Manna, 34, from Sultanpur in Howrah district and Swapan Gushait, 44, the cook from Gopalpur in Hooghly, police said.

CM Naveen Patnaik has expressed grief over the accident and wished speedy recovery of the injured.

Notably, two people had died when a bus carrying migrant workers from Surat faced an accident at Kalinga Ghati May 2, 2021.

Similarly, December 16, 2021, a tourist bus from West Bengal had also faced an accident there. As many as 15 tourists were injured while three of them were critical. Then, the minister had assured that the drivers would be sensitized about needs for cautious driving on this route.

### Democracy's Last Hope

macabre political thriller recently unfolded in the Philippine province of Palawan, an island known mostly for its rich biodiversity and pristine beaches. On May 9, Joel T. Reyes, the alleged mastermind of the 2011 murder of well-known radio broadcaster Gerry Ortega, ran again for governor. Had Reves won, the possibilities for Ortega's family to obtain justice for the killing would have dwindled. Fortunately for them, he lost.

Although episodes like the Ortega murder might seem extreme, they are more common than many realise. Powerful authoritarian subnational elites such as Reyes, supported by a political milieu that often guarantees them impunity, pose the deadliest threat to journalists.

Ortega was fatally shot after he publicly accused Reyes, Palawan's governor from 2002 to 2011, of embezzlement. All members of the hit squad were soon arrested and subsequently confessed to the killing. But, despite strong evidence that Reyes ordered the murder, prosecutors refrained from indicting him.

The middleman in the scheme, Rodolfo Edrad, implicated Reyes as the mastermind and was placed under witness protection. However, prosecutors found Edrad's testimony to be uncorroborated. Prosecutors decided that text messages sent by Reyes to Edrad shortly before and after the murder - including one that read, "Hopefully, upon my return, the problem is over" - could not be used as evidence because they were "filed out of time."

A decade-long legal battle between Ortega's family and Reyes ensued. A newly appointed prosecutorial team accepted the text message as evidence and resumed the case, after which Reyes fled to Vietnam. Although a court of appeals later ruled that the second prosecutorial panel was illegitimate, a new bench of that same court ordered in 2019 that the trial should proceed.

But the warrant for Reyes' arrest, filed in 2021, was temporarily lifted, enabling him to campaign openly for the governorship. Meanwhile, Ortega's family, their lawyers, and the Office of the Solicitor General have formally requested the Supreme Court to order Reyes' immediate arrest - a step supported by global press-freedom organisations.

Whether Reyes is prosecuted soon has important implications for press freedom in the Philippines. The country currently ranks 147th in Reporters Without Borders' World Press Freedom Index, not least because of the lack of safety for journalists. Widespread impunity or partial impunity for their killings is a security concern for all journalists in the Philippines.

Organisations like the Committee to Protect Journalists have expressed concern about the potential effect on press freedom of Ferdinand "Bongbong" Marcos, Jr.'s recent presidential electoral victory. But for many journalists, especially in large, decentralised countries such as the Philippines, who holds power at the regional and local level matters just as much - or even more. In young democracies with relatively weak institutions, authoritarian subnational leaders can rule in ways some national-level autocrats can only dream of. Clientelism and patronage give them the means to win elections and sometimes plunder public resources.

This phenomenon has been evident for decades in the Philippines, where, to take just one example, the Osmeña family has enjoyed dynastic preeminence in Cebu province. But it occurs in other countries, too. In Mexico, the Institutional Revolutionary Party (PRI) had ruled the state of Veracruz for almost a century when Javier Duarte, the governor from 2010-16, became the party's poster child for corruption after embezzling millions of dollars in public money.

In such contexts, journalists like Ortega are

from 7.68 per cent in March. In April, prices of cereals and products touched a 21-month high of 5.96 per cent, largely reflecting the failure of procurement and unregulated wheat exports. The prices of vegetables and spices surged to a 17-month high of 15.41 per cent, 10.56 per cent respectively. Evidently, the poor who spend a larger part of their income on these goods get severely affected.

The persistence of high and rising oil and coal prices have contributed to the economy-wide effect of inflationary pressures. The escalation of international crude oil prices undoubtedly is the primary factor responsible for fuel inflation, but the government of India's escalation of taxes in the petroleum sector is equally responsible. The taxes on petrol and diesel were increased 12 times since 2014. As a result, the tax on petrol rose nearly three times from ₹9.4 to ₹26.77 and the tax on diesel nearly nine times from ₹3.56 to ₹31.47. There is no parallel in Indian financial history of such a cold blooded and astounding hike in the tax rate for any commodity.

The result has been that the revenue from petroleum sector increased from ₹1.72 lakh crore in 2014-15 to ₹4.55 lakh crore in 2020-21 and to ₹4.16 lakh crore in 2021-22. The total sum of the revenue of the Modi government from petroleum taxes during its 8year period is ₹26.52 lakh crore. The total number of households in India would be around the same number which implies that on an average an Indian household paid ₹1 lakh as petroleum tax. It has been a clear case of looting the poor.

Fortunately for the NDA regime,

its ascendancy coincided with the decline in the international prices of crude oil. The tax escalation was calibrated to ensure that the gains of lower crude oil prices were not passed on to consumers and mopped up as additional tax revenue. The protests were muted because there was no increase in the retail prices. Even during the height of the pandemic, taxes were raised ruthlessly.

But at a time when the international crude oil prices began to firm up, the Central government refused to reduce the tax until the danger of inflation getting out of hand appeared on the horizon. In November 2021 and now this May 2022, the government reduced taxes on petrol and diesel cumulatively by ₹13 and ₹16 respectively. Yet, this is only a partial reduction of the huge increases that have been heaped on the nation during the period of the Modi government. The government is unwilling to roll back the entire hike in taxes on petroleum effected from 2014. The Modi government is clinging on to an effective additional tax of ₹12.27 for petrol and ₹10.47 for diesel, which have been added since it came to power.

There is yet another factor that is pushing up the cost of inputs the depreciation of the Indian rupee. From ₹64 to a dollar the exchange rate has come down to nearly ₹78 to a dollar. This means that to import the same units of commodities or services purchased at ₹64 in 2014, the importers would now have to cough up ₹78.

The Wholesale Price Index (WPI) has been continually much above the CPI and in April 2022 it climbed to a 30-year high of 15.08 per cent

due to an across-the-board rise in prices in all segments. The high and persistent input prices may be absorbed by the manufacturers in the short-run at the expense of their profits but in the medium term it would be passed on to the retail prices. Therefore, the worst is yet to come.

The ultimate buyers, the consumers, would have to transfer a substantial portion of their income to the sellers - the traders and manufacturers. Inflation is a process of transferring income from the buyers to the sellers. It is very unlikely that the primary producers whose markets are controlled by the former would benefit from the commodity boom. And the government also stands to benefit as our brief discussion on oil prices has shown. But the people and the country stand to lose.

A recent Oxfam report 'Profiteering from Pain' has concluded that every 30 hours, one billionaire is born while nearly one million people crash into extreme poverty. The system is so rigged, that whether it be COVID recession or post-COVID inflation, the rich gain and the poor lose.

The major counter inflation intervention has been to raise the interest rate by 0.4 percentage point and mandatory cash reserve ratio of banks by 0.5 percentage points. It is evident that the policies pursued during the last two years will be reversed in the coming months and the monetary policy will retreat to the pre-COVID moorings.

The above approach assumes that excess demand is a major factor in triggering inflation. But more important are the supply side constraints pushing up the cost. It is more a cost push inflation than the classic demand-pull inflation. The attempt to squeeze the demand would have serious adverse consequences for growth. It can undermine the recovery.

Therefore, more resolute action is required on the supply side. The entire additional taxes imposed on petroleum products will have to be rolled back. Cereal procurement must be speeded up and the PDS strengthened. The oligopolistic pricing by business house cartels must be curtailed and competition promoted. It may be noted that Kerala and Tamil Nadu, which have a more robust PDS, have relatively much lower retail prices than rest of the country.

behest of such elites is a grimmer point on the continuum of repression.

Without access to accurate, objective information, there can be no free and fair local elections. The fact that democracy is the only game in town at the national level is scant reassurance for those living in a state or province ruled by a local autocrat. In Veracruz under Duarte's administration, for example, 18 journalists were murdered with nearly complete impunity, and state prosecutors have been accused of torturing a local sex worker into falsely confessing to the murder of journalist Regina Martínez Pérez.

Unsurprisingly, both executive and judicial institutions are weak in such settings - how else could these local authoritarian rulers emerge? In the Ortega case in the Philippines, allegations of bribery within the judiciary are rife.

While it is difficult to uncover how and by whom a journalist has been murdered, assessing the exact intentions of local authorities during an investigation can be even tougher. One possible solution is to establish independent prosecutorial bodies to investigate murders of journalists and monitor local implementation of the United Nations guidelines for prosecutors on cases of crimes against journalists. But such efforts require political will from central governments.

Another way to combat impunity for the murder of journalists is through increased efforts to investigate cold cases. The project A Safer World for the Truth - a collaboration between Free Press Unlimited, the Committee to Protect Journalists, and Reporters Without Borders - is currently conducting such investigations. New findings can sometimes lead to these cases being reopened. For example, an investigation into the murder Pakistani journalist Žubair Mujahid resulted in the family - together with lawyers - filing a petition at the High Court of Sindh to reopen the investigation.

National leaders who attack independent media - such as former US President Donald Trump, Brazilian President Jair Bolsonaro, and Russian President Vladimir Putin - attract most of the attention. But, as at-risk journalists everywhere will confirm, the local struggle for press freedom and democracy matters just as much

#### Syzygy

f you look up at the sky and see the full moon, you're witnessing an example of syzygy. From our point of view the sun is then on the opposite side of the sky to the moon, and so is said to be in opposition to it. The three are also in syzygy at new moon, this time with the moon and the sun apparently next to each other in the sky - a state called conjunction. Halfway between these states, when the moon is half full, the sun and moon are in quadrature. Spring tides form during syzygy (full and new moon), whereas neap tides form during quadrature (the waxing and waning phases of the moon). -- Science, 5 Jul. 1996. **GOVERNMENT'S INITIATIVE TO SET UP 75 DBUs IN AS** MANY DISTRICTS **IS A MAJOR STEP TO BRING MORE PEOPLE INTO BANKING SYSTEM** 

ndia is accelerating fast on the areas. There are as many as 6,40,000 highway of digital economy and currently boasts of a superior ecosystem which has encouraged a thousand innovations across the spectrum. We have already hit a century when it comes to unicorns in startups with a total valuation of \$332.7 billion. It is now said that one out of every 10 unicorns globally has been born here.

In this backdrop it comes as no surprise if digital lending is also attracting the attention of both banks and policymakers. While we celebrate our success in the field of IT, the bedrock of a country's success lies if the fruits of development reach out to the last person.

The government's initiative to set up 75 Digital Banking Units (DBUs) in as many districts is indeed a major step to bring more people into the fold of the modern economy. Even today, 65 per cent of our country's populace live in rural villages in our country and a sizable population of these villages is still out of ambit of formal credit for various reasons. We have some 53,000-odd bank branches in villages. So on an average one bank branch is serving some 12 villages. But this is not uniform. In some states and in underdeveloped areas one bank branch is serving 20 or even more villages.

Changing the way banking is done

Across most states, and especially in eastern India -- Bengal, Bihar and Odisha - the share of the number of accounts held by small and marginal farmers is disproportionately low when compared to their actual numbers. This again does not include landless farmers, oral lessees and sharecroppers. Most people in rural areas are still not comfortable visiting a bank branch and use the help of agents/middlemen. But they have comfort with a friendly branch manager of a bank who can un-

derstand their language and requirements. These new 75 DBUs will play a major part in breaking those barriers and make customers 'aatmanirbhar' to handle their banking needs and seek more services from their lenders. This initiative has the potential to break the chain where a lot of people in rural India continue to be largely dependent on informal sources of credit.

The focus of DBUs will be on educating customers and engaging prospective customers on a digital journey. Emphasis will also be on cyber security awareness and safeguards. A customer redressal mechanism will also be put in place to redress the grievances of customers of the command area. This indeed is a bold move to facilitate digitisation in rural areas. There are 775 districts in the country and this experiment which is being carried out in some 10 per cent of districts can be extended to more districts in future.

Bringing the postal offices, which is another budget announcement. under core banking solution will go a long way in enhancing the reach of rural populace to formal banking and formal credit network. The existing 53,000 bank branches and let us say another one lakh postal bank branches in rural areas will bring down the number of villages per bank branch from existing 12 to maybe 4/5. The business correspondents can continue to play their 'Bank Mitra' roles side by side. The transfer payment story has been quite a success from a modest beginning in 2016 to now when NPCI aims at 1 billion transactions a day in the next 3-5 vears. In a similar fashion these DBUs can usher in the next generation reforms in India's banking sector.

## EC tightens noose on parties flouting rules



New Delhi, May 25: Tightening the noose around unrecognised registered political parties for flouting rules, including those related to filing of contribution reports and indulging in "serious" financial impropriety, the Election Commission Wednesday said it has initiated graded action against more than 2,100 such parties.

Sixty-six such parties claimed IT exemption in FY20 without complying with statutory requirements under the Representation of the People Act and 2,174 have not submitted contribution reports, the EC said.

"Action to be initiated against those receiving donations without due statutory compliances. Action initiated against three registered unrecognised political parties (RUPPs) reported to be involved in serious financial impropriety. Eighty-seven non-existent RUPPs shall be deleted from the list and benefits under the Symbols Order (1968) withdrawn," the poll panel said in a statement.

Soon after Kumar had taken over as the financial services secretary, one of the first major decisions he took was to ask banks to flag shell companies deregistered by the Registrars of Companies and take appropriate action. Over 2.26 lakh shell companies were deregistered in 2017-18. Subsequently, banks were also asked



to ring-fence the cash flow of corporate borrowers and to ensure that their earnings are not diverted for other purposes to protect the interest of depositors.

The poll watchdog pointed out that out of 2354 RUPPs, over 92 per cent did not file their contribution report in 2019, 199 RUPPs claimed ₹445 crore as IT exemption in 2018-19 and 219 RUPPs claimed ₹608 crore IT ex-

emption in 2019-20. Out of these, 66 have claimed income tax exemption without submitting contribution reports in Form 24A as mandated under section 29C of the Representation of the People Act.

It said 87 RUPPs have been found to be not in existence. In the 2019 Lok Sabha elections, out of 2354 RUPPs only 623 contested polls -- 70 per cent did not contest elections, it said. EC said it has "noted with serious

### Assam floods: Toll rises to 28

## **Eerie silence grips Bengal village** as news trickles in from Odisha

Udaynaryanpur (WB), May 25: Families of small farmers and factory workers had scrimped and saved for several years to pay for a tour of their dreams in Odisha and Andhra Pradesh.

But fate willed otherwise. The bus that took them on their holiday turned turtle in the intervening night of Tuesday and Wednesday at a spot near the border between Ganjam and Kandhamal districts of Odisha as it was travelling to the port city of Vizag, leaving six dead and 40 injured.

The bodies of the villagers who were claimed by the accident are expected to arrive here Thursday Most of those injured will stay back in government hospitals in Ganjam for their treatment. Fifteen of them are in serious condition

As reports of the mishap reached the village and TV news channels flashed visuals of the accident an eerie silence descended on Sultanpur, which is located Udaynaryan gram panchayat area in Howrah district. The only sound heard were the cries of close relatives lamenting the dead. Kitchens throughout the village remained shut.

Villagers told PTI that a tourist bus with 60 villagers had left Sultanpur for Darringbadi in Odisha's Phulbani district May 23. On May 24 they had left Daringbadi, a hill station in Kandhamal district of Odisha, for the sandy beaches of Vishakhapatnam after dinner.

Mangled remains of a tourist bus from West Bengal after it overturned and rolled down off the road at Kalinga Ghat in Ganjam district, Wednesday

Bikash Denre, who was among the tourists in the ill fated bus, said over phone from Bhanjanagar in Odisha that the vehicle had hit a lamp post at around 1 am and overturned

Denre said he was seated just two rows behind the driver. Most of the people in the bus were sleeping as it was night time.

Local people arrived after some time as did the police to begin the process of extracting the dead and injured

The accident has dealt a severe blow to a family, which lost the lady of the house. Mausumi Denre, and her 22-year-old daughter Rima, who was to get married in six months' time. Their house lies

empty and forlorn as the father and younger daughter who survived are in Ganjam undergoing treatment The couple's elder daughter,

who is married, did not undertake the trip, said a relative. The accident has also taken away the life of 34-year old Barnali Manna. Her sister-in-law Kabita Manna wept as she recollected their last meeting before Barnali

left with her three-year-old daughter and husband for the trip. "Didi's death is undoubtedly a tragedy. But what is worse is the news that the child will lose a leg due to the accident. I am very sad,

she said with tears in her eyes. Locals said that the families who went for the tour would pay monthly subscription to a local travel club to organise their travel. A big one like this one would take place after several years as they needed to accumulate more money to fund it.

The principal secretary in the state disaster management department, the block development officer and other state government officers have left for the spot. Udaynarayanpur MLA Samir Panja, who was asked to go, was later instructed to stay back and look after grieving families.

### Efforts on to restore peace in MP's riot-hit Khargone

Bhopal, May 25: One-and-a-half months after communal violence broke out in Madhya Pradesh's Khargone district that left one dead and many injured, efforts to restore peace and harmony in the riot-hit area by the district administration and the police continue.

Although, no incident was reported after April 10, the district administration and police have kept a close watch in this area. Section 144 was re-imposed May 12 in the district as a preventive measure and will remain till July 10, as per the earlier notification of the district administration

"Section 144 has been re-imposed in Khargone district as a preventive measure and no processions, Jagarans, and shobha yatras will be allowed in the district till July 10." said an order issued by the district administration May 12.

In a step to restore peace and harmony between the two communities living together for the past several decades, newly appointed Collector Kumar Purushottam and the Superintend of Police (SP) Dharamveer Yadav

reached out to people in their locality. The officials met the residents to rebuild trust among the people.

The officials had detailed conversations with the residents, ensuring them that no such incident would be repeated and the culprits will be given strict punishment. This visit was held Monday night when the Collector and the SP went to Bhatwadi lo-

cality of Khargone city. 'We have come here to assure that we will not let any violence happen now. You (residents) need not be worried and help us bring peace and harmony in your locality. Those who have done this will be taught a tough lesson," said Purushottam, during an interaction with the locals.

In an administrative reshuffle May 15, previous Khargone SP Siddharth Choudhary and Collector Anugraha P were transferred. Choudhary has been transferred to police headquarters, Bhopal as AIG, while Anugraha P is now

## Held in Nepal, Bengal photographer waits for relief

The photographer, who identifies himself as a contributor of National

*Geographic on his* Linkedin page, has been waiting for assistance from India since his arrest in November on charges of carrying photocopies of US Dollars

Kolkata, May 25: A trip to Nepal turned into a nightmare for a photographer from West Bengal as he ended up in prison for allegedly carrying jpeg image printouts of USD 100 notes, which he would have needed there for shooting a short film.

Alone and helpless in Nepal, Durlav Roy Chowdhury (24), a resident of Salkia in West Bengal's Howrah district, had been waiting for assistance from India since November.

Speaking to PTI over phone from ward number 2 of Jhapa Karagaar in Nepal, Roy Chowdhury said that court hearing of his case is scheduled May 25, and he is hoping to get reprieve as he has not done anything illegal.

Eshor Raj Poudel, the consul general of Nepal in Kolkata, when approached by PTI, said he had no information about the case.

"I will explore this and talk to the authorities and the district magistrate of Jhapa. As this is a legal matter, we need to see the evidence. But I can give assurance that all support would be rendered to the family of the man under trial," Poudel stated.

The photographer, who identifies himself as a contributor of National Geographic on his Linkedin page, claimed that he was being denied basic facilities in the jail.

He also said that he was subjected to torture for 20 days since his arrest November 24 before being produced before a court which then sent him to judicial custody.

"I started my journey last November. At every checkpoint, I had showed security personnel the printouts of the USD bills that I had with me for the shoot. They allowed me to get through. At the Chandragadi Airport, however, authorities sent me to an office and I was subsequently detained,"

"I have been treated like an animal by Nepalese Police. They didn't allow me to call my mother in India for weeks or share my ordeal with anyone else. For the first few weeks, I was not given my inhaler. My health deteriorated and

The 24-year-old also rued that language has been a major barrier. He claimed that the Indian Embassy in Nepal has been of little help to him.

"I keep calling the Indian Embassy here every day but the officials there maintain they won't be able to do much for me. The only thing they helped me with is a lawyer," the photographer stated.

His mother, Tripti Roy Chowdhury, a cancer patient, said she had been running from pillar to post to secure freedom for his son over the past few months. She said that she came to know about her son's imprisonment only in January.

She said that her attempts to reach out to Chief Minister Mamata Banerjee yielded no result thus far.

Roy Chowdhury's mother, who is also in Nepal at present for the court hearing, said she would appeal to the judge for the release of her son, who is suffering in jail for no valid reason.

"I also want plead to the chief minister for help. I'm a cancer patient and have no one to turn to other than my son. I believe the-CM will sympathise with my situation," she added.

New Delhi, May 25: From a Pakistan-trained militant to one of the prominent separatist faces in Kashmir, life has come a full circle for chief of the banned Jammu and Kashmir Liberation Front (JKLF) Yasin Malik who was in limelight for varied reasons over the past three decades of turmoil in the erstwhile restive border state.

Having renounced the path of violence and donned the political cloak in 1994, Malik, who is married to a Pakistani artist and has a 10-year-old daughter, had announced Gandhian way of protest after his release and was perceived to be a moderate voice in the separatist camp. Born April 3, 1966 in Maisuma locality in the heart of Srinagar, Malik is also facing trial in the much-publicized abduction case of Rubaiva Saveed, daughter of the then Union home minister Mufti Mohammad Saveed in 1989. and an attack by JKLF militants on IAF personnel in Srinagar that left four dead and many others injured in 1990.

Malik started his anti-national activities at a very young age in 1980s when he formed Tala party which was involved in an attempt to disrupt the 1983 cricket match between India and West Indies in the Sher-e-Kashmir Stadium in



Srinagar besides staging a protest against the hanging of JKLF founder Mohammad Maqbool Bhat in Delhi's Tihar Jail February 11, 1984. After undergoing detention for months together on different occasions, Malik's activities increased after his Tala party was renamed as Islamic Students League (ISL) that campaigned vigorously for Muslim United Front (MUF) candidates in the 1987 assembly elections

The MUF candidates including Mohammad Yousuf Shah lost the elections amid allegations of mass rigging. Shah alias Syed Sallahuddin is now the supreme commander of banned Hizbul Mujahideen based in Pakistan-occupied Kashmir (PoK).

rested for several months in the aftermath of the elections without a formal charge.

After his release, Malik was among the first batch of youths who crossed the Line of Control (LoC) into PoK for arms training in 1988 to join JKLF.

Malik along with Hameed Sheikh, Ashfaq Wani and Javed Mir formed the core group of the JKLF. While Wani died in a gunfight with security forces in March 1990, Malik was captured in an injured condition in August 1990 and remained imprisoned till May 1994. Sheikh and six other JKLF militants were killed at Ali Kadal in downtown Srinagar November 19, 1992, while Mir is now heading a separate faction of JKLF.

After his release on bail in May 1994, Malik declared an indefinite unilateral ceasefire to follow non-violent struggle for socalled "independence" of Jammu and Kashmir from both India and Pakistan. Pakistan-based JKLF founder Amanullah Khan removed Malik as the president of the party in 1995.

He joined as a member of the powerful executive body of Hurrivat Conference, an amalgam of various separatist organ isations, which was formed in 1993 but adopted a neutral stance when the conglomerate split between hardliners and moderates in September 2003. He married Mushaal Hussein Mullick, an alumnus of the London School of Economics (LSE), in 2009 and the couple has a 10-year-old daughter. Razia Sultana, who lives with her mother in Pakistan.

### Kerala court cancels bail of P C George



Thiruvananthapuram/Kochi, May 25: Six-time former Congress legislator PC George, whose bail in an alleged hate speech case was cancelled by a court in the state capital Thiruvananthapuram Wednesday, was taken into cus tody by the Kerala police.

George, along with his son Shaun George had arrived before the Palarivattom police. He had another similar case for which he was to appear before the police as a lower court which granted him bail May 1 had cancelled it. Top state BJP leaders, including state party president K Surendran, met the former inside the jail. Speaking to the media, Surendran said it was unfair that there are different laws for different people. "While the police was quick to arrest George for a hate speech, this yardstick is not seen when the same crime is being committed by others (Muslim leaders), no arrest is made. This is a clear cut case of different treatment and George has been a victim of this. We want to ask why are the police not arresting other people for the same crime," he added.

## **CHINESE VISA CASE** ED registers case against Karti, others

New Delhi, May 25: The ED has registered a money laundering case against Congress MP Karti Chidambaram and Chidambaram family and arrested Bhaskararaman last week, even as Karti Chidambaram is expected to depose before it for questioning

This is the third money laundering case against Karti Chidambaram with the INX Media and Aircel-Maxis cases being probed by the Enforcement Directorate (ED) for some years now.

The ED will probe the possible "proceeds of crime" that could have been generated due to the alleged illegal activity in the visa case, they said.

The accused involved in the case will be questioned as part of the investigation, officials said. Fifty-year-old Karti Chidambaram, the Congress MP from the Sivaganga constituency in Tamil Nadu, has denied all allegations.

The case was registered under Indian Penal Code sections 120-B (criminal conspiracy) and 477A (falsification of accounts) and sections 8 and 9 of the Prevention of Corruption Act.

While SpiceJet's IT team has to a large extent contained and rectified the situation, this has had a cascading effect on its flights leading to delays, it said.

'Some flights to airports where there are restrictions on night operations have been cancelled. SpiceJet is in touch with experts and cyber crime authorities on the issue," it added.

Earlier in the day, the airline had said that the ransomware attack slowed down morning flight departures but the airline's IT team rectified the situation and flights were operating normally.

### Retirees tap savings, eat less as living costs soar

New Delhi, May 25: In India, mea gre state pensions mean only a minority of retirees can afford proper healthcare with nearly 15 million of those aged 60 and above - around 10% of the total - nearly homeless

Food items, which account for nearly half of the consumer price index, have jumped, with wheat, edible oil, vegetables, fruits, meat and tea up by between 10% and 25% in a year. Cooking gas and petrol prices climbed more than 40%. "Inflation is the biggest blow to older people," said Anupama Datta, director at the HelpAge India charity, which estimates that nearly 90 million of 138 million people aged 60 years or more are working in order to earn enough to live on.

India's central bank warns elevated inflation will persist at least until September

#### **DIPPING INTO SAVINGS**

Many Indian pensioners rely on savings built over decades for their retirement. There are no official estimates but pensioners' associations said many they represent are now forced to draw more from those accounts than pre-



viously. India's gross savings rate is estimated to have fallen to below 30% of GDP in the fiscal year ended March. from over 32% before the pandemic. Economists do not expect that to change next year. Average interest rates on long-term deposits have also fallen to 6% from 8.5% over the past three years, taking it below headline inflation. Some pensioners have

switched to riskier investments, including equities and mutual funds, but after two good years of returns even stocks are now struggling with the benchmark index (.NSEI) down over 6% this year.

STATE PENSIONS ARE TINY

India's ruling Bharatiya Janata Party (BJP) conceded that the elderly have been particularly hard hit by inflation. Gopal Krishna Agarwal, the BJP's economic affairs spokesman, said the government was doing all it could to protect them, including through food and healthcare support.

Over the weekend the government announced tax changes and subsidies that will lower prices of gasoline, diesel and cooking gas. But it is not clear how much relief that will bring. State pensions are just 200 Indian rupees (\$2.58) a month, although some states provide up to between 1,000-2,000 rupees monthly.

#### CARE CRUNCH

Unlike advanced economies, India has very few aged-care homes. Most retirees depend on families for support. putting extra strain on children whose livelihoods have been impacted by the pandemic and now inflation.

There were just 1,100 old age homes across the country catering to about 1.00.000 people before Covid-19 struck. according to a study by Tata Trusts, the charitable arm of the Tata Group conglomerate. Largely run on private donations, they face their own challenges as costs soar. Increases in food, medicine and energy costs mean these homes have less to spend on vegetables, fruit, drugs and care providers.

Austin, May 25: Once again, one of America's deadliest mass shootings happened in Texas.

A mass shooting that left 21 school children dead in the deeply pro-gun state of Texas Tuesday increased pressure on US politicians to take action over the ubiquity of firearms -- but also brought the grim expectation of little or no change

It was the eighth mass shooting this year, according to the Everytown gun control group, and came 10 days after another 18-yearold murdered 10 African Americans at a supermarket in New York.

Nearly 10 years after a man slaughtered 20 children and six others in an attack on the Sandy Hook elementary school in Newtown, Connecticut, and four vears after 17 were killed at a Florida high school, restrictions on gun purchases and ownership have not significantly changed.

Tuesday it was closing the escape clause to the drastic financial sanctions imposed on Moscow after it sent troops to Ukraine, pushing Russia closer to default. 'Noting that the refusal to ex-

tend this licence makes it impossible to continue servicing government foreign debt in US dollars, payments will be carried out in Russia's currency," the finance ministry said in a statement on Telegram.

The ministry added that there would be a "possibility to later convert them (payments) into the original currency" using a Russian financial institution as the paying agent.

Russian Finance Minister Anton Siluanov said in the statement that the current situation was "artificially created by an unfriendly country." He said that it "primarily hurts the rights of foreign investors in Russian debt instruments'

Siluanov stressed the situation has "nothing in common" with 1998, when Russia defaulted on domestic ruble-denominated debt

**Russia parliament** scraps age limit for army recruits Russia's parliament approved a law Wednesday in double-

quick time removing the upper age limit for contractual service in the military, amid heavy casualties in Ukraine. Lawmakers in the State Duma lower house approved the bill in three readings in a single session, with the upper house, the Federation Council, giving its assent shortly after. The bill now needs only the signature of President Vladimir Putin to become law. State Duma speaker Vvacheslav Volodin said: "Today, especially, we need to strengthen the armed forces and help the Ministry of Defence. Our Supreme Commander is doing everything to ensure that our armed forces win, and we need to help.' Currently, only Russians aged 18-40 and foreigners aged 18-30 can enlist as professional soldiers in the Russian military.

reached between the federal government and PTI. She said news of negotiations and an agreement between the government and PTI is "baseless"

Political tensions are at an alltime high in Pakistan with all eyes on Islamabad as the city braced

itself for the arrival of PTI workers and leaders heading towards the federal capital for the party's Azadi March despite the government's instructions not to.

So far, the day has been filled with political drama. Lahore turned into a battleground as multiple scuffles took place between the police and PTI marchers as the latter tried to wriggle out of the barricades placed on their way, Geo News reported.

PTI Chairman Imran Khan is leading the march, which he has said will be the "biggest" in Pakistan's political history, while Interior Minister Rana Sanaullah will address the public shortly over the ongoing situation.

In order to restrain Lahore's rally from entering Islamabad, the police tried to arrest former energy minister and senior PTI leader-Hammad Azhar; however, party workers managed to save him.

**GST** rate rationalisation

New Delhi, May 25: The current price situation leaves hardly any scope for rationalisation of GST rates on goods and services, sources said Wednesday.

Goods and services are taxed in four slabs of 5 per cent, 12 per cent, 18 per cent and 28 per cent under the GST regime. It was being considered to reduce these tax slabs possibly to three, an exercise which would have involved raising taxes on some items and a reduction in others. Besides, gold and gold jew-

ellery attract a 3 per cent tax. But with the inflation rate ruling at an all-time high, there is hardly any scope for GST rate ra-

tionalisation, sources said. Sources further said that while the economy was recovering from the impact of Covid in 2021, geopolitical tension this year would again have bearing on it.

"The Council in the past was not unmindful of the then prevailing situation," sources said.

Under GST, essential items are either exempted or taxed at the lowest slab, while luxury and demerit items attract the highest slab. Luxury and sin goods attract cess on top of the highest 28 per cent slab. This cess collection is used to compensate states for the revenue loss due to the GST rollout.

The GST council last year set up a panel of state ministers, headed by Karnataka Chief Minister Basavaraj Bommai, to suggest ways to augment revenue by rationalising tax rates and correcting anomalies in tax rates.

At the time of GST implementation July 1, 2017, the Centre had agreed to compensate states for 5 years till June 2022, and protect their revenue at 14 per cent per annum over the base year revenue of 2015-16.

The GST Council over the years has often succumbed to the demands of the trade and industry and lowered tax rates. For example, the number of goods attracting the highest 28 per cent tax came down from 228 to less than 35.

Sources further said that with the implementation of GST in 2017, around 18 cesses were abolished. The collection from these cesses in 2016-17 was ₹56,641 crore.

With the implementation of GST, these cesses were subsumed into GST and the collections are shared with the states as per the devolution formula. The only major cesses that remain are the GST compensation cess, health and education cess and cess for central road and infrastructure fund. The collection from these cesses has helped fund various government schemes

and development activities. The collection from road and infrastructure cess was over ₹2.03 lakh crore in 2021-21, while for the current fiscal the budget estimate is over ₹1.38 lakh crore.

The collection from GST compensation cess last fiscal was ₹1.05 lakh crore, while the budget has pegged it at ₹1.20 lakh crore in the current fiscal.

Collection from health and education cess was ₹47,307 crore last fiscal, and is budgeted to rise to ₹53.846 crore this fiscal.

India have a goal difference of minus three as against Pakistan's plus 13. If Pakistan lose to Japan, India will have to beat Indonesia by a huge margin to go past their western neighbours in goal difference and advance further in the tournament.

Inexperience was the major reason behind India's below-par performances as the young players, mainly drafted from the last Junior World Cup squad, are finding it difficult to get a measure of the level of international hockey. In the two matches so far, the Indians lacked cohesion in the three departments - defence, midfield and forwardline.

The Indians lacked a quality playmaker in the midfield, which was evident from their constant efforts of building attacks from the centre instead of using both the flanks more frequently.

The forwardline has been wasteful with the likes of Tokyo Olympian Simranjeet Singh and

youngster Uttam Singh not having the best of outings.

The lanky and strongly built Pawan Rajbhar is the only player who have impressed with his commitment and stick work in the two matches, creating chances and also scoring a goal.

Penalty corner conversion is another area where the Indians are struggling as they lack a quality drag-flicker in the side after veteran Rupinder Pal Singh pulled out at the last minute due to a wrist injury.

## HI placed under CoA for Sports Code violation

New Delhi, May 25: The Delhi High Court Wednesday placed Hockey India under a three-member Committee of Administrators (CoA) after observing that the federation has violated the National Sports Code.

The Court ruling came on a petition filed by former India player Aslam Sher Khan, who had challenged Indian Olympic Association (IOA) President Narinder Batra's appointment as life member of Hockey India.

The High Court held that HI's appointment of Batra as its life member and Elena Norman as CEO were illegal and thus the administrative setup of Hockey India was erroneous or illegal.

Now in a space of seven days, two national federations have been put under CoA as the Supreme Court, May 18, had appointed a threemember committee to manage the affairs of the All India Football Federation (AIFF) for violation of Sports Code

Making a reference to the Apex Court ruling, the HC constituted a

committee, which will be headed by former Supreme Court judge AR Dave and will have former Chief Election Commissioner SY Quraishi and ex-Indian hockey team cap-

tain Zafar Jobal as members. "It would be in the public interest that its affairs be put in the hands of a Committee of Administrators (CoA) as has been directed by the Supreme Court on 18th May 2022, in the case of another NSF in All India Football

Federation," the HC said. "The administrative setup of R-2 (Hockey India) is, erroneously or illegally constituted because of the Life President and Life Members," the HC bench of Justices Najmi Wajiri and Swarana Kanta

Sharma said in its order. "The Government of India can-

not grant recognition to a NSF whose constitution is not in consonance with the Sports Code. The posts of Life President, Life Member in the NSF are illegal so is the post of CEO in the Managing Committee.

These posts are struck-down." A Hockey India source said the sports body has called an emer-

gency meeting May 30. "We are yet to read the full judgement but we have already called an emergency meeting May 30 in New Delhi to decide our future course of action. So we won't comment anything further on the issue." the source said.

The HC said all such references in Constitution/Memorandum of Association of Hockey India will have to be removed.

The development comes weeks after the CBI had registered a preliminary enquiry against Batra for alleged misuse of Rs 35 lakh of Hockey India funds. It was alleged in a complaint that Rs 35 lakh of Hockey India funds was used for personal benefits of Batra.

The HC empowered the CoA to recover whatever amount of money Batra owes to HI from the sports administrator, while asking the panel to bring in accountability.

As far as HI chief executive officer Elena is concerned, the court ruled that recovery of money "against the current CEO would not be warranted" as she is not an office bearer with voting rights and has assisted the federation only as an administrator.

The court also said the CoA would be at a liberty to make all appropriate arrangements, for the governance of Hockey India until fresh elections are held in terms of the Sports Code conforming constitution.

Besides, it has also been asked to "facilitate the holding of elections and the handing over of the af-

#### **BATRA REMOVED** AS IOA PRESIDENT

NEW DELHI: Veteran sports administrator Narinder Batra was Wednesday removed as IOA President after the Delhi High Court struck down the position of 'Life Member' in Hockey India, courtesy which he had contested and won the apex body elections back in 2017. Indian Olympic Association (IOA) senior vice president Anil Khanna took over as acting chief. Batra had filed his nomination for the IOA president's post as a representative (Life Member) of Hockey India. The Delhi HC ruled that the position of Life Member and Life President were 'illegal' since they were not in consonance with the National Sports Code and installed a three-member Committee of Administrators (CoA) to run the dayto-day affairs of Hockey India.
