## PK MOHANTY TO BE ACTING CHIEF OF LOKPAL

New Delhi: The President has named Justice Pradip Kumar Mohanty, Judicial Member of the Lokpal, to be the acting Chairperson of the Lokpal due to the vacancy created by the completion of the tenure of Justice Pinaki Chandra Ghose. Mohanty will head the Lokpal with effect from the date of occurrence of the vacancy i.e. May 28, till the appointment of a new Chairperson, a notification issued Friday said. Mohanty, who was born June 10, 1955, has previously served as Chancellor of both the National Law University Odisha at Cuttack, and the National University of Study and Research in Law at Ranchi before being appointed as the Judicial Member of the Lokpal March 27, 2019.

## NCB clean chit to Aryan

New Delhi/ Mumbai, May 27: The Narcotics Control Bureau (NCB) Friday gave a clean chit to Aryan Khan, son of superstar Shah Rukh Khan, in last year's 'drugs on cruise' case in which he was arrested and spent 22 days in jail.



NCB officials said Aryan Khan and five others were not named in the agency's chargesheet due to "lack of sufficient evidence." The NCB SIT found "grave irregularities" and gaps in the probe, the officials said, adding the agency's first team that arrested Aryan did not follow rules like mandatory medical test of accused, video recording of the raids and corroborative evidence for WhatsApp chats.

Delhi that there were "short-comings" in the investigation and WhatsApp chat of accused had no "physical corroborative evidence" as re-

quired to prove the charges in the court.

The NCB Friday filed a nearly 6,000-page chargesheet before a Mumbai court against 14 accused in the case, but did not charge six, including Aryan Khan, due to lack of sufficient evidence.

"We have filed the charge sheet on the basis of whatever was found by our special investigation team on the last date of filing the charge sheet," Pradhan said.

## 'Shoddy' probe: Wankhede faces action

New Delhi: The government has ordered action against former NCB officer Sameer Wankhede for his alleged 'shoddy' work while probing a 'drugs-on-cruise' case in which film star Shah Rukh Khan's son Aryan was arrested last year, official sources said Friday. Appropriate action is also being initiated against Wankhede for allegedly providing a fake caste certificate, they added. Wankhede is an Indian Revenue Service officer and the finance ministry is the nodal authority to take the action against him.

## Don't comment on each other: HC to Anubhav, Varsha

Cuttack, May 27: The Orissa High Court Friday ordered Kendrapara MP Anubhav Mohanty to refrain from making any video or comment against his wife Varsha Priyadarshini in any media during the pendency of their divorce proceedings.

The vacation bench of Justices Bibhu Prasad Routray and Mruganka Sekhar Sahoo passed the order while hearing a plea filed by Varsha, alleging that her husband is maligning her image by making a series of videos and releasing them on YouTube. The bench also passed a similar direction against Varsha, it was learnt. Anubhav had filed the divorce petition in the Family Court, Patiala House, Delhi in 2020. The Supreme Court transferred the petition to the Family Court here March 5, 2021.

## High-security plates must for old vehicles

All vehicles registered before April, 2019 will have to fix the HSRP at nearest dealer

Bhubaneswar, May 27: The Odisha government has made affixation of high-security registration plates (HSRPs) mandatory for all classes of vehicles which were registered prior to April 1, 2019.

The HSRP has already been made mandatory for all new vehicles registered on or after April 1, 2019, in the state. Odisha Transport Commissioner Arun Bothra has issued an order for this purpose in accordance with Rule 50 of the Central Motor Vehicles Rules, 1989.

Vehicle owners have been given three months' time to fix the HSRP on old vehicles before enforcement is undertaken by the transport department and police officials.

Different deadlines have been set for vehicles as per their registration number. As per the order, August 31, 2022 is the deadline for the vehicles carrying an Odisha registration mark and registration number ending with 1 and 2, while September 31, October 31 and November 30 are the deadlines for the Odisha registration vehicles with numbers ending with 3 and 4, 5 and 6, and 7 and 8, respectively. Similarly, vehicle owners with an Odisha registration mark and registration number ending with 9 and 0 will have to affix the HSRP by December 31, 2022.

To avoid a last minute rush, Bothra advised vehicle owners to affix HSRP on their vehicles as soon as possible but not later than the above schedule. If the vehicle owners fail to replace the existing number plates with HSRP before the deadlines, e-challans will be issued

## International Booker for Geetanjali Shree

London, May 27: Author Geetanjali Shree's Hindi novel 'Tomb of Sand' has become the first book in any Indian language to win the prestigious International Booker Prize.

At a ceremony in London Thursday, the New Delhi-based writer said she was "completely overwhelmed" with the "bolt from the blue" as she accepted her prize, worth GBP 50,000 and shared with the book's English translator, Daisy

Rockwell. "Tomb of Sand", originally 'Ret Samadhi', is set in northern India and follows an 80-year-old woman in a tale the Booker judges dubbed a "joyous cacophony" and an "irresistible novel."

"I never dreamt of the Booker, I never thought I could. What a huge recognition, I'm amazed, delighted, honoured and humbled," said Shree, in her acceptance speech.

"There is a melancholy satisfaction in the award going to it. 'Ret Samadhi/Tomb of Sand' is an elegy for the world we inhabit, a lasting energy that retains hope in the face of impending doom. The Booker will surely take it to many more people than it would have reached otherwise, that should do the book no harm," she said.

Reflecting upon becoming the first Hindi work of fiction to make the Booker cut, she said it feels good to be the means of that happening.

## Prithviraj is now Samrat Prithviraj

**Mumbai:** The Akshay Kumar-led period drama *Prithviraj* will now be titled *Samrat Prithviraj*, Yash Raj Films (YRF) announced Friday following multiple discussions with the Shree Rajput Karni Sena that had objected to the earlier name on grounds that it was disrespectful.

YRF's decision comes a day after the Karni Sena wrote to it demanding a title change. The group - its protests had led to a name change for Sanjay Leela's Bhansali's 2018 period film *Padmavat* - wanted the title of the film on the legendary warrior king to reflect his status as Samrat (emperor).

"As per the multiple rounds of discussions between us, and to peacefully and amicably resolve the raised grievance, we will change the title of the film to *Samrat Prithviraj*," the production house said in its response to Karni Sena national president Mahipalsingh Makrana.

The banner went on to thank the Karni Sena and its members for understanding its 'good intentions' on the depiction of the great warrior in the film, directed by Chandraprakash Dwivedi



and featuring Kumar as the Rajput king. YRF added that the team never intended to hurt anyone's sentiments and wished to celebrate the bravery of Samrat Prithviraj Chauhan.

The film also stars Sanjay Dutt, Sonu Sood and marks the screen debut of Miss World 2017 Manushi Chhillar, who plays the role of Sanyogita. The film is scheduled to be released theatrically on June 3.



Built with an expenditure of Rs 35.42 crore, the facility will help reduce traffic issues and provide safe parking of vehicles to those visiting the zoo. The three-storey facility can accommodate 583 four-wheelers and more than 2,000 two-wheelers, it was learnt.

Later in the evening, Naveen launched the 'Made in Odisha' Covid-19 Rapid Antigen Test (RAT) kit on the premises of IMGEX India in Infocity area here.

The kit has been developed by IMGEX India in collaboration with ICMR-RMRC, Bhubaneswar, it was learnt.

# Sex detection racket busted; 13 arrested

**Berhampur, May 27:** Thirteen people were arrested as a major racket of foetus sex determination, which was being done in connivance with some private nursing homes, was busted in Ganjam district, police said Friday.

A police team raided a clinic at Anand Nagar in Berhampur city, around 160 km south of Bhubaneswar, Thursday following inputs about the sex detection test, which is banned in India.

The main suspect, Durga Prasad Nayak, who runs the clinic at his residence, was found conducting tests using ultrasound machine. Eleven pregnant women were present at the first floor of the house for tests, a police officer said.

The 41-year-old was running the centre to determine the sex of the foetus in connivance with some of the nursing homes in the city for the past three years, according to police.

Those arrested include the employees of various nursing homes in the city who allegedly took the pregnant women to the centre, Superintendent of Police Saravana Vivek M said.

A noted public health activist was also among those nabbed. Two other suspects used to pick up the patients from different clinics, the SP said.

They have been booked under the IPC and the Pre-natal Diagnostic Techniques Act. An investigation is on to nab others who were involved in the racket, the officer said.

# Will take up Puri issue with CM, says Swamy

**Puri, May 27:** BJP leader and MP Subramanian Swamy Friday said he will take up Puri Heritage Corridor issue with Chief Minister Naveen Patnaik.

"There is a need to end the controversy. I will do whatever is possible," Swamy told reporters after meeting Swami Nischalanand Saraswati of Govardhana Peeth in Puri earlier in the day.

"Temples hold importance in our lives. Even kings used to visit temples and share their views on issues relating to them," the BJP leader said.

The meeting between Swamy and the Shankaracharya was held barely two days after the Govardhan Peeth seer drew the attention of Prime Minister Narendra Modi and Chief Minister Naveen Patnaik through the media on the issue.

Swamy said the government could intervene in temple activities if there is any financial irregularity. The Puri seer had expressed displeasure over the ongoing heritage corridor project work. He had urged the prime minister Narendra Modi and chief minister Naveen Patnaik to save Puri 'dham' (holy place) and not allow the 'tapohoomi' (place of meditation) to turn into a 'bhogbhoomi' (place of pleasure and amusement).

The seer had expressed concern over destruction of heritage buildings, mostly ancient mutts in the name of development and alleged that Puri is being changed drastically in the name of development.

After the meeting, Shankaracharya said he will not sit



silent if the government allows projects against the spiritual ideals of Puri dham.

Meanwhile, BJD lawmaker Bhagirathi Sethi said that there is no harm in demolishing mutts to clear roads to Jagannath temple, which is visited by lakhs of devotees every year.

BJP general secretary Prithwiraj Harichandan said the state government has insulted the devotees of Lord Jagannath by demolishing mutts, which were closely linked with different rituals of the 12th century shrine.

The heritage corridor project, which aims to transform the pilgrim city into an international place of heritage, ran into controversy when government agencies dug huge pits within 100 metres from the temple boundary categorised as protected zone allegedly without prior permission from Archaeological Survey of India (ASI).

The government was also accused of starting work without conducting the ground penetrating radar survey to trace archaeological treasures buried underground and the impact assessment study. A case on the matter is pending in Orissa High Court.

According to Medical Oncology/Haematology department head Prabodh Das, the facility will help provide comprehensive care to those with cancer and haematological disorders. "Most of these patients need dedicated critical care which cannot be provided in a combined ICU setting. Hence, the need for a medical oncology/haematology ICU was very essential," said Das.

# VSSUT asst prof gets 'death threats', files plaint

work in his personal chamber at VSSUT March 4. The caller disconnected the call within a few seconds.

The unknown person once again called up Nayak on the same day. But, he disconnected the call without saying anything, sources said.

During the third call, the caller reportedly identified himself as the elder brother of SK Swain, who is now pursuing PhD under Nayak's guidance. Swain is a resident of Khandagiri area in the capital city, Nayak said in his complaint.

"The caller asked me to show undue favour to Swain and clear his PhD degree at the earliest. As it was the midnight, I politely asked caller to contact me on the next morning. Suddenly, he started hurling vulgar languages towards me and sought Rs 10 lakh within two days. The caller also threatened me of dire consequences if I dare to report this matter to police," Nayak said in his complaint.

Nayak has been facing severe mental tension since the incident. He reportedly fell down in the toilet and sustained injuries in his leg, sources said.

"Swain is a resident of the capital city. So, I have lodged a complaint with the Cyber and Economic Offence police station in Bhubaneswar. The Commissionerate Police have not taken any action in this matter," Nayak said.

According to sources in police, Rajesh's family member used to receive and dispose of the booty looted by the gang. They would also distribute the money among the members. There are around 20 cases pending against Rajesh at different police stations in City.

## Minister: Mulling to make IMA centre of excellence

Panda also said that mathematics teachers working in 5T transformed schools will undergo orientation and refresher courses in IMA in a view to upgrade them in teaching and research.

Speaking that ISRO has been intimated to conduct "Space on Wheel" programme at the institute,



the minister highlighted various programmes undertaken by the Science and Technology department for the promotion and development of mathematics and science subjects.

He also suggested the institute to provide consultations to user industries and to render technical advice to government and other institutions.

Director of IMA Yasobanta Jena presided over the programme and suggested Autonomous Governance Structure (Deemed to be University/State University Status) of the Institute, creation of new courses like computer Science, physical science.

## More nations must urgently adopt early warning systems: UN forum

In the recent Global Assessment Report, the early warning systems were cited as a critical defence against disasters such as floods, droughts and volcanic eruptions, as the systems predicted 560 disasters or 1.5 disasters a day by 2030, based on the current trajectory



More countries must "Think Resilience", and urgently adopt and improve early warning systems to reduce risks from an increasing number of disasters across the world, a UN forum has concluded.

Some 184 countries gathered in Bali to review efforts to protect communities from a rising number of climate hazards and other catastrophes around the world.

The 2022 Global Platform for Disaster Risk Reduction heard only 95 countries report having multi-hazard early warning systems that give governments, agen-

cies and the general public notice of an impending disaster, with particularly low coverage in Africa, Least Developed Countries and Small Island Developing Countries.

Early warning systems were cited as a critical defence against disasters such as floods, droughts and volcanic eruptions in the recent Global Assessment Report, which predicted 560 disasters or 1.5 disasters a day by 2030 based on the current trajectory.

It comes after UN Secretary-General Antonio Guterres called for warning systems to cover every person on planet within five years.

"Early warning systems should be inclusive of communities most at risk with adequate institutional, financial and human capacity to act on early warnings," said the Co-Chairs' Summary, known as the Bali Agenda for Resilience.

"A core recommendation is to apply a "Think Resilience" approach

to all investments and decision making, integrating disaster risk reduction with the whole of government and whole of society."

The Bali Agenda for Resilience came ahead of the International Day for Disaster Risk Reduction on October 13 dedicated to early warning systems, and was pre-

sented at the end of the three-day Global Platform.

The meeting, which was the first international UN disaster forum since the start of the Covid-19 pandemic, was also taking place as the Midterm Review of the UN's Sendai Framework for Disaster Risk Reduction got underway.

In light of the pandemic, the Bali Agenda highlighted the need to reassess the way risk is governed and policy is designed as well as the types of institutional arrangements that need to be put in place at the global, regional, and national levels.

"Current approaches to recovery and reconstruction are not sufficiently effective in protecting development gains nor in building back better, greener and more equitably," the summary said.

"Transformative lessons learned from the Covid-19 pandemic must be applied before the window of opportunity closes."

Delegates also shared progress since the last Global Platform in

2019, with a 33 per cent increase in the number of countries now developing disaster risk reduction strategies and reporting through the Sendai Framework Monitor, which measures progress towards global targets.

"While there has been some progress, such as in the development of new financing mechanisms, and better linkages with climate action, the data still points towards insufficient investment and progress in disaster risk reduction in most countries, especially in investing in prevention," said the Bali Agenda for Resilience.

"Less than half of the countries reporting against Sendai Framework targets indicate having fit-for-purpose, accessible and actionable disaster risk information."

The Bali Agenda for Resilience will be carried through to COP-27, the G-20 and the Midterm Review of the Sendai Framework.

# 4 get 20-year jail for gangraping woman

Left behind by her husband by mistake, the woman was gangraped by four persons near Kamarei forest in Angul district



The convicts were identified as Pilu Behera of Kamarei; Dibyanjan Barik, Sujit Behera of Chhendipada and Nilam Sahu of Thakurgada. The court also imposed a penalty of ₹50,000 each. In default, the convicts would undergo an additional jail term of two years each.

Another accused Pradip Pradhan of Katada was acquitted for want of evidence against him. According to the case diary, a

couple from Sambalpur was going in a car to Cuttack May 3, 2018.

At around 10 pm, as they were nearing Nakchi village in Angul district, the woman asked her husband to stop the car so that she could relieve herself on the roadside. She returned to the car to collect water bottle in the back seat of the car. After taking the bottle she shut the door of the car. Thinking that his wife had returned to the car, the husband drove away.

The accused found the woman, took her to a forest and gangraped her. After driving for some 15 km, the husband realised that his wife was not there in the car following which he drove back to Nakchi but could not locate her. Later, he lodged a missing complaint at the Handapa police station. Police had rescued the woman from Paradip area.

#### Man kills mother with wooden plank

**Phulbani:** In a horrendous incident, a man Friday bludgeoned his 60-year-old widowed mother to death over a petty issue in Phulbani under Town police limits in Kandhamal district. The accused was identified as Jitendra Kanhar, 31. The deceased woman has been identified as Kasturi Kanhar. According to reports, a verbal duel ensued between Kasturi and Jitendra over some family issues. Infuriated, Jitendra hit her mother's head with a wooden plank. Kasturi was rescued from a pool of blood and rushed to Phulbani district headquarters hospital (DHH). However, she succumbed to the injuries during treatment. A complaint has been lodged with Phulbani police who detained the accused while the exact cause of the murder is yet to be ascertained.

#### Illegal toll gate to be removed

**Bargarh:** A toll gate on Barahagoda-Nandatikara RD road in Bargarh district will be removed. A decision to this effect was taken by the district administration at meeting here, Friday, after receiving allegations of illegal collection of toll from four-wheelers. The toll gate is being operated by Ashoka Buildcon, a private agency. The administration has made it clear that if the toll gate is not removed with immediate effect, legal action will be taken against the operator. The Highway Users' Forum May 5 had approached the district administration alleging that collection of toll at the plaza is illegal and demanded removal of the toll gate. The Collector has directed Ashoka Buildcon to remove the gate. But it is not stated why this plaza operator was allowed to collect toll from people.

## Sal trees felled for nursery

**Keonjhar, May 27:** Alleged felling of hundreds of precious sal trees for construction of sheds in a forest nursery under Kanjipani forest section of Bhuyan Juangpal forest range in Keonjhar forest division has sparked resentment among nature lovers and locals. The chopped-off trees will be used for construction of sheds in the nursery where saplings will be grown for afforestation programmes. Locals and nature lovers have questioned the wisdom behind cutting down of sal trees and using them for growing saplings.

The state government and Centre are spending crores in afforestation programmes and in protection of existing forests through various schemes. It is alleged that the forest officials chose to cut hundreds of sal trees despite having funds to purchase bamboo for the nursery. Reports said the nursery has been established under corporate social responsibility (CSR) initiative and over 88,000 saplings have been grown by spending around ₹11.95 lakh under the programme. The saplings grown in the nursery will be used in the afforestation

programme for 2023-24 financial year. The sal trunks will be used in construction of sheds to provide cover to the saplings from sun and rain. Locals alleged that the loss of greenery is hard to recover and might take long years to replenish if plantation programme is undertaken in the area. They said when forest officials are arresting a common man for cutting trees in the forest will the same rule apply to them? Environmentalists have urged Keonjhar DFO Dhanraj HD to conduct a probe and take stringent action against the accused forest officials for cutting down such large number of trees. When contacted, the DFO ruled out use of sal trees in construction of sheds. He said the trees used in shed construction are of another variety and are often cleared as they hinder the growth of other trees and plants.

## Newlywed bride turns out to be man

**Basudevpur, May 27:** Falling in love on Facebook has proved costly for a young man after the newlywed bride turned out to be a man at the reception party, just a few hours after their marriage.

to get married. May 24, Alok along with his family reached Kendrapara for the marriage. Later, Alok took the newlywed bride to his uncle's house at Kasia under Basudevpur police limits.

To welcome the newlywed bride, Alok's relatives hosted a reception party in the evening. However, a few moments after, Alok and his family members went into shock after

a local, who had come to attend the reception party, identified the bride as 'Meghna' and not 'Meghna'.

The bride turned out to be a man who had disguised himself as Meghna using duplicate hair and make-up. The villagers then thrashed and stripped the 'bride'. After finding the 'bride' to be a man, the angry villagers cut off his long hair and called the police. A police team later rescued Meghna and handed him over to his family members. Alok and his family members got the shock of their lives after finding out the truth.

On the other hand, the reason for Meghna's bizarre step is yet to be known. Reports said that this isn't the first case. Meghna for some reason dresses like a girl and lures men into relationships using social media platforms.

## 1 falls to death in theft attempt

## 15 more Nayagarh villages under PMAGY

**Nayagarh, May 27:** Fifteen more villages in Nayagarh district have been included in Pradhan Mantri Adarsh Gram Yojana (PMAGY) under which ₹6 crore has been sanctioned for carrying out a slew of development initiatives, as per a report.

Reports said the administration has identified 15 villages while three other villages have already been included in the scheme. Bolabani under Sadar block and Surkabadi under Nuagaon block have been declared as Pradhan Mantri Adarsh Gram while Chadeimara under Nuagaon block is yet to be declared as a model village under the scheme.

As per guidelines, the state and Union governments provide ₹40 lakh to develop various modern facilities in selected villages. A district-level committee of the scheduled caste and scheduled tribe welfare department held a meeting recently and approved a grant of ₹6 crore for 15 villages.

As per guidelines of PMAGY, the villages having a population more than 500 (as per the 2011 census)

and about 50 per cent of their population belonging to the scheduled tribes will be eligible for this scheme.

Once included in the scheme, these villages will be provided with facilities like drinking water, provision of sanitation, education, social security, road connectivity, electricity and renewable energy, telecommunication, agriculture, livelihood cre-

ation and skill development centres. The state government provides ₹20 lakh as its matching grant while the Centre allocates an equal amount.

After the villages are developed with 10 basic facilities, they are declared as PMA Gram. Village-level committees have been formed to utilise the funds to carry out development projects under the su-

pervision of sarpanchs, ward members and officials of the lines departments. Meanwhile, the Scheduled Caste and Scheduled Tribe Welfare department has got a list of villages that would be included under the scheme.

In the first phase, three villages of the district were included in the scheme while two of them were declared model villages.

In the second phase, 15 more villages were included in PMAGY. The villages are Laxmanpur, Guanda, Pathadwar, Gadiasahi, Bijaynagar, Roupadapatana, Ostia, Chhadamula, Chhamundia, Patanda, Kandapada, Ambapada, Nandighosepur, Burupaju and Pathuria. A number of projects have been approved and an outlay of ₹6 crore has been sanctioned.

Collector Poma Tudu has underscored the need for expediting the works and making provision of garbage pits in all these villages.

Officials of line departments are on their toes to start the groundwork. As per provision, central teams may make surprise visits to the villages to take stock of ongoing developmental works.

# PANDEMIC LESSONS



**In the US public procurement is now an important component of innovation policy and a key driver of financing. The US government spends an estimated \$50 billion annually on innovation-based procurement, equal to nearly one-third of federal spending on research and development**

While the COVID-19 crisis brought much suffering and many socioeconomic burdens, it has also shown how targeted cooperation between the state and business can speed innovation. Addressing the climate crisis calls for similarly creative collaboration. In both the cases, accelerating innovation and experimenting with local solutions is necessary but not sufficient. Essential technologies – whether vaccines or renewables – must be diffused globally. The first COVID-19 vaccines were granted emergency-use authorizations in the United States and the European Union less than a year after the pandemic began. Established innovation systems and adequate manufacturing capacity were important factors. Without longstanding cooperation between private and public institutions, and government promotion and funding of research, rapid COVID-19 vaccine development would not have been possible. For example, the vaccine developers BioNTech and Moderna are university spin-offs that received substantial public funding during important phases of their development. BioNTech, which grew out of the Johannes Gutenberg University Mainz, received about €17 million (\$18.2 million) in research and start-up funding from the German Federal Ministry of Education and Research (BMBF) even before the COVID-19 pandemic. Moderna, founded in 2010 by a group of Harvard professors, secured \$25 million in funding from the US government's Defense Advanced Research Projects Agency (DARPA). Equally important were research institutions such as the University of Oxford in the United Kingdom and bodies like the National Institutes of Health (NIH) in the US, both of which were directly and indirectly involved in different stages of COVID-19 vaccine development. Research institutions in some middle-income countries, such as Fiocruz in Brazil, also played a significant role. Building on this existing capacity, governments then provided targeted support to accelerate vaccine development and de-risk investments in alternative vaccine platforms. First, government funding agencies provided grants. For the development of the joint BioNTech-Pfizer vaccine, Germany's BMBF provided €375 million in milestone-based funding, of which nearly €240 million was disbursed in 2020. This corresponds to about 25% of the two firms' development costs up to the time the vaccine was approved. Moderna, meanwhile, received nearly \$1 billion in US government funding for vaccine development in 2020, and worked closely with the NIH to conduct clinical trials. Shortly before that, Moderna received \$1 million from the Coalition for Epidemic Preparedness Innovations, a public-private initiative established in 2017 to promote vaccine development to combat epidemics. CEPI also provided over \$500 million of funding to different organizations in 2020 for COVID-19 vaccine development. Over 90% of the funding was public, with more than 40% coming from the UK and Germany. In addition, government advance-purchase agreements ensured that the necessary production facilities could be built in parallel. In the event that a developer secured regulatory approval for its COVID-19 vaccine, these contracts provided a procurement guarantee for an agreed number of doses. Complementing the parallel promotion of supply and demand, jurisdictions accelerated their approval processes for vaccine licensing. Public authorities reviewed available data immediately after each clinical trial phase rather than after completion of the overall trial, as is usually the case. They also supported the preparation and implementation of independent control studies. So, what is the significance for the effort to combat climate change? Tackling the climate crisis also will require the rapid acceleration of innovation and the associated scaling of production capacities within the framework of a mission-oriented innovation policy. Demand-side funding in the form of advance-purchase agreements could be applied to climate-related innovation, too. In the US, for example, public procurement is now an important component of innovation policy and a key driver of financing. The US government spends an estimated \$50 billion annually on innovation-based procurement, equal to nearly one-third of federal spending on research and development.

Other important building blocks include mission-oriented innovation agencies such as DARPA, the Advanced Research Projects Agency - Energy (ARPA-E), and the Biomedical Advanced Research and Development Authority (BARDA). US President Joe Biden plans to establish a new agency to promote climate innovation. At the state level, agencies like NY-SERDA (the New York State Energy Research and Development Authority) are experimenting with models to crowd in investments in innovative projects to support the green transition. The dovetailing of R&D funding and public procurement has been central to US innovation agencies' success, including with COVID-19 vaccines, and this model should also be incorporated in the coming years into the European Green Deal and associated sustainable-recovery programs. But policymakers must develop new approaches to achieve an appropriate distribution of costs and benefits between private and public actors. As with COVID-19 vaccines, the diffusion of new climate technologies and place-based innovations is still not sufficient, and they remain concentrated in a few countries. The rich world is asking low- and middle-income countries to play their part in mitigation and adaptation, but transfers of technology and financial resources – including debt relief and restructuring – currently fall well short of what is needed. Confronting today's mounting climate challenges – like developing safe and effective COVID-19 vaccines – requires innovative forms of cooperation between the public and private sectors, as well as between countries, designed to channel resources toward a new sustainable technological and economic paradigm. Shaping markets and industries via the right policy mix of targeted government financing and procurement promises to open new windows of opportunity and accelerate the green transition. *The author is Associate Professor of Industrial Economics and Head of Research at the UCL Institute for Innovation and Public Purpose*

## Rising Rivalry

Inter-service tensions have always existed in babudom but remain low-key. The oldest fault line is the perception that the government favours the IAS more than the other all-India services, especially in terms of powers and promotions etc. In recent months though, there was a growing awareness that the Modi sarkar was actively placing officers from the IPS, IFS and IRS services in posts traditionally held by the IAS.

However, seeing the reaction of non-IAS service officers to the recent promotion and empanelling of 25 IAS officers of the 1996 batch and two IPS officers of the 1994 batch to the rank of additional secretary, and the posting of a 1990-batch IPS officer to an equivalent designation, it seems that the rivalry has risen a notch or two.

The move, sources say, has created a gap of six years between parallel ranks in the IAS and IPS, and IPS officers are upset at this 'unprecedented' order. According to a source, the order of appointment mentions two unusual decisions by the appointments committee. It has reportedly promoted two IPS officers Shyam Bhagat Negi (HP cadre) as additional secretary in the Cabinet Secretariat and Vijay Bhatia (UP cadre) as Joint Secretary Personnel in the Ministry of External Affairs (MEA).

Being a 1990-batch IPS officer, Negi has been appointed to the same position as two dozen IAS officers of the 1996 batch. Meanwhile, Bhatia who is a batch senior to Negi has been appointed to a junior rank. Also, it is being pointed out that there is only one IPS officer of the 1989 batch of Additional Director General of Police rank, posted as additional secretary. The real issue apparently is that while the government has promoted 1996-batch IAS officers as additional secretaries, in the IPS cadre it has promoted the 1990-91 batches to the same post. Seniority apparently has meant little.

Still, no one is willing to step out and speak publicly on the issue, not even the IAS and IPS associations. But these inter-service tensions must be resolved at the earliest.

### DANICS babus face disciplinary action

The fallout of the fierce political rivalry between the AAP-led Delhi government and the BJP-ruled Centre often is felt by the babus in both governments. Split between loyalty to the government they serve and the rule book, it is babus who often pay the price.

Six DANICS cadre officers working with the Delhi government now face disciplinary action for failing to accept their transfer to the Lakshadweep administration and not joining duty immediately. This, after the Central Administrative Tribunal (CAT) bench headed by chairperson Manjula Dass, turned down their plea challenging their transfer.

In November last year, the Ministry of Home Affairs (MHA) issued transfer orders to DANICS officers Sandeep Kumar Mishra, Sravan Bagaria, Shailendra Singh Parihar, Singare Ramchandra Mahadev, Nitin Kumar Jindal and Rakesh Kumar to Lakshadweep, but the babus immediately moved the CAT in the hope of overturning the order. They were served with a reminder earlier in February but this too was ignored. That has not worked. The CAT bench has now noted that there is 'no merit' in their application challenging the transfer. It has ordered the babus to immediately report to the Lakshadweep administration. If they fail to join, the order states that 'disciplinary action as per rules' will be initiated against them without further notice.

The unwholesome tendency of babus not reporting to the place of transfer and resorting to litigation has been viewed seriously even by the Supreme Court. The CAT order, therefore, is not surprising. The babus will have to obey or find themselves in the dock.

### More changes in PMO

Prime Minister Narendra Modi is continuing to rebuild his team at the Prime Minister's Office (PMO). Close on the heels of the appointment of former Petroleum Secretary Tarun Kapoor as Advisor to the PM and the induction of two additional secretaries Atish Chandra and Hari Ranjan Rao, 2004-batch IAS officer Vivek Kumar has been named Private Secretary to the Prime Minister.

Sources say that Kumar, who was earlier a director in PMO, has been appointed at the Joint Secretary level. Most likely, this has been done to rectify the imbalance caused by having five additional secretaries as opposed to four joint secretaries. With Kumar upgraded to the joint secretary level, the balance has been restored. He will join Hardik Satishchandra Shah who is also a Private Secretary to the PM.

# Nat'l base for minimum wage must

**THERE IS A NEED FOR A GENUINE TRANSFORMATION THAT WOULD WITNESS PROPER WAGES AND ADEQUATE EMPLOYMENT OPPORTUNITIES FOR THE WORKING CLASS**

A recent study commissioned by the Economic Advisory Council (EAC) has backed universal basic income to reduce the income gaps as well as devising an urban MGNREGA to rehabilitate surplus labour. While such a policy may help in gearing employment, it is essential to point out here that even in the MGNREGA, there is a lot of disparity as states pay different wages to beneficiaries. Undeniably, the need for a national minimum wage in the country is an essential necessity. But there have been no efforts in enforcing such a wage policy. There is need for the government to formulate and enforce a minimum wage across the country to minimise labour exploitation at a time when prices of petrol, diesel and other essentials keep rising.

In the last Parliament session, RJD Rajya Sabha member Manoj Jha, raised the issue of revising the minimum wage and referred to the expert committee headed by labour economist, Anoop Satpathy. The 2018 report had recommended fixing the need-based national minimum wage for India at ₹375 per day or ₹9,750 per month. Plus, it recommended the introduction of an additional house rent allowance (city compensatory allowance) for urban workers over and above the National Minimum Wage.

Regrettably, the Centre did not act on the report and instead announced formation of another expert group for consideration of minimum wage. The Satpathy committee had worked out an evidence based formula of a balanced diet of 2400 calories, 50 grams of protein and 30 grams of fat per day per person. It had added some expenditure towards clothing, education and housing and multiplied the cost by 3.6 to include the spouse, two children and elderly parents. Currently, the minimum wage notified by most of the States is ₹200-odd per day. Meanwhile, the Centre increased wage rates under the Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) by 5 to 7%, but the revised accounts still fall short of the minimum wages that had been notified by the states for similar unskilled work. Sikkim has the highest daily payment of ₹333 under the MGNREGA for 2022-23. But MGNREGA

workers in Madhya Pradesh and Chhattisgarh will receive a daily wage of ₹204, the lowest among states, up from ₹198, while workers in West Bengal will get ₹223 for a day's work, a hike of ₹10. The amount varies, based on difficulty of terrain and working conditions. Nikhil Dey of Mazdoor Kisan Shakti Sangathan in Rajasthan said the minimum NREGA wages remaining lower than the states' payouts amounted to denial of basic standards of living to those opting for the national job scheme. Though an expert committee under Mahendra Dev had in 2014 recommended that MGNREGA rates cannot be lower than the states' minimum wage for agricultural workers, the Centre is not implementing the report. Moreover, the government claims it is doing all it can to ensure better wages and working conditions for the labour class. But the Opposition hits out saying "Modi is doing everything for his capitalist friends; they are earning ₹1,000 crore daily. But he is not interested in creating jobs because he knows he can win by misleading people on emotive issues". While we talk of economic

growth, there is a need for formulating a policy based on wages and employment. The current situation has seen a thrust of our politicians and planners geared towards increasing incomes of the business class and the rich. In pursuing this policy, instead of effective public-private participation, the policy followed by the government is to play into the hands of the private sector by handing them over profitable public sector units. Understanding of developmental economics is vital for formulating a policy for increasing wages and employment that obviously benefits the lowest segments of society. Unfortunately, the policy makers have for years been either ignorant or prefer to remain indifferent to the needs and demands of the masses. Thus there is a need for a genuine transformation that would witness proper wages and adequate employment opportunities for the working class. Though the economy has been steadily recovering, a change would mean steady increase in wages commensurate with price increase and slow but steady rise in employment.

### New Delhi, May 27: Seven soldiers were killed and 19 injured in Ladakh's Tuktuk sector Friday when their vehicle skidded off the road and fell into the Shyok river, Army officials said.

The accident took place at around 9 am at a place located about 25 km from Thoise, they said, adding that the injured have been shifted to the Command Hospital in Chandimandir in Haryana's Panchkula district. My thoughts are with the bereaved families. I hope those injured recover at the earliest. All possible assistance is being given to the affected," Modi said in a tweet. "Deeply saddened by the loss of lives of our brave Indian Army personnel due to a bus tragedy in Ladakh. We will never forget their exemplary service to our nation. My condolences to the bereaved families and prayers for the speedy recovery of the injured," he tweeted.

## India's first semi-high speed freight train may chug by year end

Replicating the concept of Vande Bharat trains, the 16-coach 'Gati Shakti' train can clock 160 kmph and will be manufactured at the Integral Coach Factory in Chennai

**Chennai, May 27:** India's first semi-high speed freight train is likely to hit the tracks by December, officials said Friday. Replicating the concept of Vande Bharat trains, the 16-coach 'Gati Shakti' train can clock 160 kmph and will be manufactured at the Integral Coach Factory (ICF) in Chennai. In order to implement the PM Gati Shakti initiative in a focused manner, the Railways has created a separate directorate at the Railway Board with its branches at Khurda, Bilaspur, Delhi and Bengaluru divisions to expedite the

ambitious scheme. "The design work for these trains has already started. We have also given the order for material...By December this year, we will be able to manufacture two of these trains," ICF General Manager A K Agarwal said, adding that an overall target of 25 such trains has been set. The final number of trains will depend on how the initial ones are received by the market, he added. The Railways is planning to target the e-commerce and courier parcel segment through these trains, officials said. Each train will also have refrigerated wagons in the rear end and in the front to carry

perishables like milk products, fish, fruit and vegetables. Electricity connection for these wagons will be provided from the coach. The rest of the coaches will have rollers for moving the container. Each coach will have two wide doors for loading and unloading the containers. According to the Indian Brand Equity Foundation, with a turnover of USD 50 billion in 2020, India has become the eighth largest market for e-commerce. "India's e-commerce market is expected to reach USD 111 billion by 2024 and USD 200 billion by 2026 and expected to reach USD 350 billion by 2030," the



official said, adding that Indian Railways plans to capture the small size parcel shipments by running dedicated high speed freight trains. The Indian Railways is aiming to increase its share in freight

## 1989 abduction case: CBI summons Rubaiya Sayeed

**Jammu, May 27:** A special CBI court here has summoned Rubaiya Sayeed, daughter of former Jammu and Kashmir chief minister Mufti Mohammed Sayeed, July 15 in a case related to her kidnapping in 1989, officials said Friday. This is the first time Rubaiya Sayeed has been asked to appear in the case relating to her abduction on December 8, 1989. She was freed from captivity five days later on December 13 after the then V P Singh government, supported by the BJP at the Centre, released five terrorists from the Jammu and Kashmir Liberation Front (JKLF) in her exchange. Rubaiya Sayeed, who stays in Chennai, is listed as a prosecution witness by the CBI which took over the investigation in early 1990. Yasin Malik, chief of the banned JKLF who has recently been sentenced to life imprisonment in a terror funding case, is an accused in the case. The case had gone into virtual

cold storage and was revived after Malik was picked up by the National Investigation Agency in 2019 on charges of terror funding. In January last year, the CBI, with help from Special Public Prosecutors Monika Kohli and SK Bhat, framed charges against 10 people, including Malik, in the Rubaiya kidnapping case that turned out to be a turning point in the Valley's volatile history. The release of the five JKLF members was seen as a morale booster for terror groups, which had started raising their heads at the time. The CBI moved an application summoning Rubaiya Sayeed as she was listed as a prosecution witness. This was agreed to by the special court that has now ordered her to appear before it on July 15, the officials said. Rubaiya Sayeed was kidnapped by members of JKLF members from Srinagar to ensure the release of their associates lodged in different jails. Other charged in the case are Ali Mohammed Mir, Mohammed Zaman Mir, Iqbal Ahmad Gandroo, Javed Ahmad Mir, Mohammed Rafiq Pahloo, Manzoor Ahmed Sofi, Wajahat Bashir, Mehraj-ud-Din Sheikh and Showkat Ahmad Bakshi. During the investigation, accused Ali Mohammad Mir, Zaman Mir and Iqbal Gandroo voluntarily confessed before a magistrate about his role in the Rubaiya kidnapping. Besides, four others made confessional statements before CBI's Superintendent of Police. "Since the accused persons besides admitting of their own guilt have also narrated about the participation of other accused persons namely Malik, Javed Ahmed Mir and Mehraj-U-Din Sheikh, which can also be used against them as one of the pieces of evidence," the court had said in January last year. The 10 are among the two dozen accused named by the CBI in its chargesheet filed before the court. Among the others, top JKLF commanders Mohammad Rafiq Dar and Mushtaq Ahmad Lone are dead and 12 are absconding. These are Halima, Javed Iqbal Mir, Mohammad Yaqub Pandit, Riyaz Ahmad Bhat, Khursheed Ahmad Dar, Basharat Rehman Noori, Tariq Ashraf, Shafat Ahmad Shangleo, Manzoor Ahmad, Gulam Mohammad Taploo, Abdul Majeed Bhat and Nissar Ahmad Bhat.

## OP Chautala gets 4-yr jail term in DA case

**New Delhi, May 27:** A Delhi court Friday awarded a four-year jail term to former Haryana Chief Minister Om Prakash Chautala in disproportionate assets (DA) case. Special Judge Vikas Dhull also imposed a fine of ₹50 lakh on the convict in the case of acquiring disproportionate assets from 1993 to 2006. The judge also directed the authorities concerned to confiscate four of his properties. The court had last week convicted Chautala and said the accused had failed to satisfactorily account for such dis-proportionality by proving his source of income or means by way of which, he acquired assets during this period.



The CBI had filed the case in 2005, and a charge sheet was filed on March 26, 2010, accusing him of amassing assets disproportionate to his legitimate income, between 1993 and 2006. According to the CBI's FIR Om Prakash Chautala, while functioning as Chief Minister of Haryana during the period from July 24, 1999, to March 5, 2005, in collusion with his family members and others, accumulated assets, immovable and movable, disproportionate to his known lawful sources of income, in his name, in the names of his family members. The disproportionate assets were calculated to be ₹6.09 crore, 189.11 per cent of his known sources of income.

## ED summons Farooq Abdullah

**New Delhi, May 27:** The Enforcement Directorate has summoned Lok Sabha MP Farooq Abdullah on May 31 at its Srinagar office in connection with a money laundering case linked to alleged financial irregularities in the Jammu and Kashmir Cricket Association, officials said on Friday. Abdullah (84), a three-time chief minister of the erstwhile Jammu and Kashmir state, had recorded his statement in the same case in 2019, they said. Political parties in the valley said the summons were "common to all opposition" leaders in the country.

Reacting to the development, Abdullah's party, the National Conference (NC), said the veteran leader would continue to cooperate with the authorities like he has done in the past. "ED summons to JKNC President Dr Farooq Abdullah nothing new; this is common for all opposition parties in India. He has continued to maintain his innocence in the matter and has cooperated with the investigative agencies and will do so in this case as well," the NC posted on Twitter. PDP president Mehbooba Mufti said there was nothing to react to this as it was crystal clear that the voice of the opposition was being muzzled with the help of central probe agencies like the CBI and the ED. The ED had questioned Abdullah in connection with the multi-crore Jammu and Kashmir Cricket Association scam case earlier as well.

## Monsoon likely to reach Kerala in 2-3 days

**MOST PARTS OF NORTHWEST AND CENTRAL INDIA ARE LIKELY TO EXPERIENCE A GRADUAL INCREASE IN THE MAXIMUM TEMPERATURES OVER THE NEXT THREE DAYS**

**New Delhi, May 27:** The southwest monsoon is expected to reach Kerala during the next two to three days, marking a sluggish start to the seasonal rains that are the lifeline of India's agri-based economy.

Earlier, the India Meteorological Department (IMD) had forecast the onset over Kerala on Friday (May 27) with help from the remnants of Cyclone Asani, that struck the Bay of Bengal a fortnight ago. The forecast had a model error of four days.

However, the influence of the remnant weather systems, that lingered over the southern peninsula, petered out, dashing the forecast of early onset over Kerala and a swift progress towards the north, the IMD said.

"As per the latest meteorological indications, westerly winds have strengthened in the lower levels over the south Arabian Sea and deepened. As per satellite imagery,

there is an increase in cloudiness over Kerala coast and adjoining southeast Arabian Sea. Hence, conditions are becoming favourable for monsoon onset over Kerala during the next 2-3 days," the IMD said.

The weather office declares the onset of monsoon over Kerala if 60 per cent of 14 weather stations in Kerala and Lakshadweep receive 2.5 mm or more rainfall for two consecutive days, aided by favourable windfield and outgo-

ing longwave radiation.

The IMD had declared the onset of monsoon over Andaman and Nicobar Islands May 16.

"The monsoon has now reached the latitude of Kerala. However, the distribution of rainfall in the state is still not proper for the declaration of the onset," Akshay Deoras, a monsoon researcher with Britain-based University of Reading, said on Twitter.

"Forecasts continue to suggest that the onset could happen some-

time between 30 May and 2 June, and it will not be robust," he said.

The IMD has forecast widespread light/moderate rainfall with thunderstorm/lightning over Kerala and Lakshadweep and isolated to scattered rainfall over Andhra Pradesh, Telangana, Karnataka and Tamil Nadu, Puducherry and Karaikal during the next five days under the influence of westerly winds blowing from the Arabian Sea.

The weather office has forecast scattered light/moderate rainfall with isolated thunderstorms over Jammu and Kashmir and Himachal Pradesh during the next four days.

It also said isolated rainfall over Uttarakhand, north Punjab, north Haryana, Uttar Pradesh and East Rajasthan was likely during the next two to three days.

According to the IMD, most parts of northwest and central India are likely to experience a gradual increase in the maximum temperatures by two to three degrees Celsius over the next three days.

## Delhi HC: Penalty for mosquito breeding might go up to ₹50K

**New Delhi, May 27:** The Delhi High Court has asked the Delhi government to examine imposing on-the-spot fines to create deterrence in the minds of the people concerning allowing mosquito breeding in their premises and increasing the quantum of fine imposed upon erring institutions from ₹5,000 to ₹50,000.

A bench headed by Acting Chief Justice Vipin Sanghi, which was hearing its suo motu case concerning large-scale mosquito breeding in the city, asked the city government to examine these aspects at the highest level and state its stand. The court observed that the efficacy of the system of imposition of fines as a deterrent would be completely lost if fines are not imposed on the spot and mere challenging the violators would only lead to the explosion of such cases in the courts. It further noted that while the municipal Corporations had proposed en-

hancement of fine from ₹500 to ₹50,000 and imposition of on the spot fines, the Delhi government counsel informed that the proposal to increase the fine from ₹500 to ₹5,000 was under process and that there was no spot fine.

"In our view, the GNCTD should seriously examine the proposal for imposition of fines - on the spot, if a deterrence has to be created in the minds of the people to not allow mosquito breeding in their premises. We are also of the view that where institutions are found guilty of such conduct, the quantum of fine should not be limited to merely ₹5,000/-, and should be fixed at ₹50,000/- . The GNCTD shall examine these aspects at the highest level and respond on the next date," said the bench also comprising Justice Jasmeet Singh in its order dated May 20.

"Mr. (Rajat) Aneja (the amicus

curiae) submits, and we entirely agree with him, that the efficacy of the system of imposition of fines as a deterrent would be completely lost, if fines are not imposed on the spot. We may also notice that mere challenging the violators and those found guilty of allowing mosquito breeding in their premises, would only lead to the explosion of such cases in the Courts and adding to the already existing heavy burdens that the subordinate Courts have to deal with," it said.

In March, the high court had expressed displeasure over no action being taken by the Delhi government over the aspect of amending the law and increasing the penalty so that it acts as a deterrent against the breeding of mosquitoes which cause vector-borne diseases, saying its request fell on deaf ears.

## A day after arrest, PC George gets bail

**Kochi/Thiruvananthapuram, May 27:** A day after being sent to the Central jail in Thiruvananthapuram, seven-time former MLA PC George Friday secured bail from the Kerala High Court in connection with an alleged hate speech made early this month.

A local court in Thiruvananthapuram had Thursday sent him to 14 days judicial custody.

While granting bail, the high court asked George not to repeat the mistake and also cooperate with the probes in the two separate cases of the same nature - one made in the capital city May 1 and a few days later at an election rally in Kochi.

On May 1, he was first arrested from his house at Poonjar in Kottayam district and brought to the state capital and released on bail the same day.

A few days later after getting bail, during an election rally in Thrikkakara in Kochi, George again resorted to a hate speech, attacking the minority community. Soon, a fresh case was registered and again he approached the court for bail and Wednesday when he was travelling to Kochi to present himself before the police in connection with the matter, it was learnt that his bail given May 1 has been cancelled by a court in the state capital.

**Thiruvananthapuram, May 27:** Every year, one sees a large number of Kerala government staff retiring May 31 and this year is no different as of the 20,719 staff who are to superannuate at the age of 56 in 2022, a record 10,207 will bow out Tuesday.

According to sources, the primary reason for the 'May phenomenon' is earlier, the official date of birth used to be the day a child was admitted to a school in the new academic year, which begins in June.

"When a child was admitted to the school, the date of birth was what the parents would say. No body would ask for official cer-

tificate of birth.

Unlike today, most of the births used to take place at homes. Now, births take place in the hospital and are immediately registered with the local body which provides a birth certificate," the source said. All along, the date of birth was

taken as what appeared in the Class X examination mark-sheet, but a birth certificate from the local body is a must during school admission.

Incidentally, all those who are retiring or nearing the superannuation or have already retired in the recent years have all their official date of birth as per school records.

"Since I was very naughty and a handful, I was admitted to school a year early. I was only four but my parents told the school that I was five years. In the bargain, I lost one productive year as even though I am 65 as per records, I am only 64," said a businessman.

But with a large number of government staff retiring May 31, the already cash-trapped state will have over-burned as with over 10,000 government staff retiring, a staggering sum is required to pay of end of service benefits.

A college principal who retires in Kerala after close to three decades of service after commutation of pension, will get around ₹1 crore as end of service benefits and not to mention a monthly pension of above ₹60,000.

## Inspired by movie, 3 men steal over 40 luxury cars, arrested

**New Delhi, May 27:** Inspired by Hollywood flick 'The Fast and the Furious' three men stole over 40 luxury cars using hi-tech tools, including scanners and GPS jammer, police said Friday after arresting them.

The accused have been identified as Manish Rao (42) and Jagdeep Sharma (43), both residents of Uttam Nagar here, and Aas Mohammad (40), a native of Meerut in Uttar Pradesh, they said.

Rao and Sharma were nabbed when they came to strike a deal for a stolen car. The car was found stolen from the Paschim Vihar area, Deputy Commissioner of Police (southwest) Manoj C said.

Various instruments, including sensor kit, magnet, LNT keys and eight remote car keys were recovered during the search of the stolen vehicle, they said.

Mohammad, who was the main supplier of these stolen cars, was also arrested, police said, adding that he used to sell these vehicles in Rajasthan.

The accused were inspired by Hollywood movie 'The Fast & the Furious' and used scanners to unlock the cars within minutes and jammer to disable the GPS if it was installed in the car, the DCP said. The trio are members of the infamous 'Ravi Uttam Nagar gang' police said.

The three accused disclosed that they along with their leader Ravi have stolen over 40 cars since April from various areas of the city, including Uttam Nagar, Tilak Nagar, Subash Nagar, Pashim Vihar, Munirka, Dwarka among others and sold them in Rajasthan and Meerut, the DCP said.

After stealing the car, they parked it outside societies, near hospitals and other such places where CCTV camera was not installed, police said.

## Electric cycle buyers in Delhi to get incentives

**New Delhi, May 27:** The Delhi government has brought in a scheme under which financial incentive will be provided to those buying electric cycles.

The demand incentive shall be applicable for the first 10,000 e-cycles, both passenger and cargo, it said.

According to the scheme guidelines, e-cycle buyers will get a purchase incentive of 25 per cent of the price with a cap of maximum ₹5,500 a piece. An additional incentive of ₹2,000 will be given to the first 1,000 individual owners of e-cycles.

E-cargo cycles will be eligible for a purchase incentive of 33 per cent of the price (not exceeding ₹15,000 per vehicle).

"The applicable demand incentives shall be available for buyers (individuals and businesses) in the form of reimbursement which will be credited to the accounts of owners by the Transport Department, based on claims made by the buyer through the OEM (Original Equipment Manufacturer) or dealer after the purchase of the

e-cycles," it said.

The application for incentive shall be made through an online platform by the OEM or dealer on behalf of the buyer and shall be credited within seven working days to the bank account of the buyer.

The demand incentives shall be payable to individual beneficiaries as well as businesses with a valid GST registration.

E-cargo cycles will also be eligible for a scrapping incentive of up to ₹3000 per e-cycle under the Delhi Electric Vehicle Policy, against scrapping of old ICE (internal combustion engine) vehicles.

The scrapping incentive will be given in case of the ICE vehicle being scrapped through someone authorised by the Transport Department and shall be subject to a matching contribution made by the OEM or dealer at the time of sale of the e-cycle(s).

As for the OEMs intending to seek approval of their e-cycles under the policy, they will be required to register themselves with the EV Cell of the Transport Department.

## Beer fly off shelves in Delhi as summer approaches peak

**New Delhi, May 27:** Beer lovers in the national capital are having a tough time scoring their favourite brands which face a supply crunch due to 'restrictions' from bottlers in neighbouring states amid high demand due to an unusually hot summer.

Since the implementation of new Excise Policy 2021-22 by Delhi government last November, private retail vends have been making attractive offers to the consumers which has led to an increase in demand for all kinds of alcoholic beverages, including beer, officials said.

There are several factors that have fuelled shortage of beer in Delhi, one of which is an early onset of summer, said Vinod Giri,

director general of Indian Alcoholic Beverage Companies.

Another key reason for shortage is that the manufacturers have been asked to first fulfil the local demand in the neighbouring states like and Rajasthan, Haryana, and Punjab where they are located, before supplying it to Delhi and other places, he said.

"The demand for beer rises during summer in northern parts of the country. In such a situation, supply to Delhi, which has no manufacturing facility, is affected since manufacturers in major supplier states have to meet the local demand too," said the officer.

Giri said that the demand for beer shot up by 30 per cent in March, which recorded several days of heatwave and ended up

cases," he said. Many beer lovers complained that they were finding it difficult to have their usual brands at the liquor vends in the city. "The usual brands of beer have gone off the shelf. Men at liquor shops ask you to try new brands which I have never tasted. Due to shortage, you make do with whatever is available, whether it's a can of beer or a bottle," said a man outside a liquor shop in Naraina area of the city.

Usually, the annual sale of beer in Delhi is around 315-320 million cases, out of which about 40 per cent gets sold during the summer months, he said. But with an increased demand, the annual sale of beer this year is expected to go up to 330-340 million cases, he added.

**Why is PM silent on drugs haul from Gujarat, asks Cong**

**New Delhi, May 27:** Prime Minister Narendra Modi's home state of Gujarat has become the "gateway of drugs" to the country under his watch, the Congress alleged Friday, questioning the "silence" of the PM and Home Minister Amit Shah and demanding answers agencies tasked to control narcotics smuggling.

Congress spokesperson Pawan Khhera said there has been a series of recoveries of drug consignments starting from July, 2017 right up to this week from several ports including Mundra and Pupavav in the state.

Just on Thursday, 52 kilograms of cocaine, worth Rs 500 crore, was recovered from Mundra Port that had come from Iran, he alleged. When under "pressure from the Congress Party", the Mundra port had announced they will not handle cargos from Iran, Pakistan and Afghanistan, then how the latest consignment of cocaine was recovered from there, he asked.

"The Congress Party has questioned the government over the last eight months on why all these recoveries are taking place in Gujarat alone? Why is Gujarat becoming the gateway of drugs to India," he asked.

Congress spokesperson Pawan Khhera said there has been a series of recoveries of drug consignments starting from July, 2017 right up to this week from several ports including Mundra and Pupavav

Khhera said the Congress had to question the government on the post of Narcotics Control Bureau head lying vacant for 18 months, before the appointment was made under "pressure" from the opposition party.

He alleged Gujarat has become a "gateway of drugs" to the country under the watch of PM Modi and Home Minister Shah. "You have the prime minister from Gujarat. You have the home minister from Gujarat. Why are they silent?"

"This is a prime minister who talks more and does less. On this particular issue, (he has said) not a word. Why this silence?" **UP MLAs fumble with tablets**

**Lucknow, May 27:** The e-Vidhan that has made the Uttar Pradesh state Assembly go paperless, is proving cumbersome for the legislators, many of whom are not tech-savvy.

While the BJP MLAs and ministers are going an extra mile to learn how to operate the tablets installed on their seats and some are even taking classes from their children or others to learn the functioning of the device, opposition members are vocal about their reservations of the new system.

"The Vidhan Sabha officials should have implemented the new system in a phased manner and allowed the house to function in a hybrid mode for some time. We are left grappling with the tablet and tend to miss out on the proceedings," said a SP MLA. Another SP MLA said that the government wanted to leave the opposition grappling with the new system so that focus could be diverted from other important issues. Several MLAs can be seen peering into blank tablets and some SP MLAs managed to fix their party logo on their screens.

A BJP MLA, who spoke on condition of anonymity, said that a minimum training of one week was required to make the legislators familiar with operating the tablets. Suheldev Bhartiya Samaj Party (SBSP) leader Om Prakash Rajbhar was seen peering into a pamphlet to learn how to operate the device on occasions more than one. Senior ministers like Suresh Khanna and Surya Pratap Shahi were also seen seeking help from NIC techies while others were inquiring from each other.

"Walking on the path of minimum government and maximum governance, priority was given to ease of living and ease of doing business," Modi said.

During the earlier governments, technology was considered a part of the problem and efforts were made to label it "anti-poor", the prime minister said. "Due to this, there was an environment of indifference towards the use of technology in governance before 2014.

The poor, the deprived, the middle class suffered the most," he said. "Promotion of drone technology is another medium of advancing our commitment to good governance and ease of living. In the form of drones, we have a smart tool that is going to be part and parcel of people's lives," Modi said.

**Deaths during 'Char Dham' yatra worrying: Experts**

**Dehradun, May 27:** Resumption of 'Char Dham yatra' after a gap of two Covid-marred years is a welcome development for thousands of people whose livelihoods depend on it, but the death of 78 pilgrims on way to the Himalayan temples in less than a month is causing concern.

Though the death of pilgrims on way to the high altitude shrines in Uttarakhand due to cardiac problems is something which happens

every year, the toll is unusually high this season after the yatra commenced on May 3 with the opening of the Yamunotri and Gangotri temples.

A look at the data of pilgrim deaths in previous years shows that over 90 Char Dham devotees died in 2019, 102 in 2018 and 112 in 2017 during the entire season which lasts nearly six months from April-May to October-November every year.

Pradeep Bhardwaj, who heads Six Sigma Healthcare that provides free medical facilities in Kedarnath, attributed the high number of deaths to a combination of factors, including absence of an acclimatisation mechanism, weak immunity of pilgrims most of whom have Covid history, precarious weather and inadequate arrangements considering the heavy rush of pilgrims.



"As most of the pilgrims are not used to such high altitudes they should be given a break in their journey at lower heights to help them acclimatise themselves with the kind of weather they are going to confront in higher altitudes. "They are not able to cope with the abrupt

climatic change that they experience after coming from lower altitudes to the Himalayan temples located averagely at a height of 10,000 to 12,000 ft," Bhardwaj, a qualified doctor said.

### Scribe killing: Al Jazeera to go to ICC

**Jerusalem:** The Al Jazeera news network says it will submit a case file to the International Criminal Court on the killing of reporter Shireen Abu Akleh, who was shot dead earlier this month during an Israeli raid in the occupied West Bank. The Qatar-based network and the Palestinian Authority have accused Israeli soldiers of deliberately killing her.

### SL envoy meets Sitharaman

**New Delhi:** Sri Lankan High Commissioner Milinda Moragoda Friday met Finance Minister Nirmala Sitharaman and explored the possibility of India increasing its financial assistance to the island nation to help it deal with its severe economic crisis. In the meeting, Moragoda reiterated that Sri Lanka would require "bridging finance" until the economic adjustment programme with the IMF could be negotiated and finalised, according to the Sri Lankan High Commission. Moragoda briefed Sitharaman on the present developments in Sri Lanka.

### Quake hits Indonesia

**Jakarta:** A strong 6.5-magnitude earthquake struck off Indonesia's eastern province of Maluku on Friday, but there was no initial report of damage or casualties, disaster officials said. The country's meteorology, climatology and geophysics agency did not issue a warning for a tsunami as the jolts did not potentially trigger giant waves. *Xinhua* news reported. The quake struck at 9.36 a.m., with the epicentre at 85 km southwest of Maluku Barat Daya district with a depth of 104 km, the agency said. The tremors were also felt in the nearby province of East Nusa Tenggara and the neighbouring country of Timor Leste.

### 50 civilians killed

**Ouagadougou:** At least 50 civilians in Burkina Faso's Madojari region were killed during an armed attack, according to an official statement. Residents from the Madojari town who were trying to reach Nadiagou, in the town of Pama, were targeted by unidentified armed men, *Xinhua* news agency quoted the statement from the regional government as saying. On May 14, an attack on civilians in the same area left 17 dead and seven injured. On May 19, another attack against the military detachment of Madojari left 11 soldiers killed and 20 others injured.

# G-7 pledges put coal on notice, could boost climate assistance

**Berlin, May 27:** Officials from the Group of Seven wealthy nations announced Friday that they will aim to largely end greenhouse gas emissions from their power sectors by 2035, making it highly unlikely that those countries will burn coal for electricity beyond that date.

Ministers from the G-7 countries meeting in Berlin also announced a target to have a "highly decarbonised road sector by 2030," meaning that electric vehicles would dominate new car sales by the end of the decade.

And in a move aimed at ending the recurring conflict between rich and poor nations during international climate talks, the G-7 recognized for the first time the need to provide developing countries with additional financial aid to cope with the loss and damage caused by global warming.

The agreements, which will be put to leaders next month at the G-7 summit in Elmau, Germany, were largely welcomed by climate activists. "The 2035 target for power sector decarbonisation is a real breakthrough. In practice, this means countries need to phase out coal by 2030 at the latest," said Luca Bergamaschi, director of Rome-based campaign group ECCO. Coal is a heavily polluting fossil



fuel that's responsible for a fifth of global greenhouse gas emissions caused by humans. While there are ways to reduce emissions of carbon dioxide from the burning of coal, experts say it is almost impossible to reduce it to zero, meaning it will likely have to be the first fossil fuel to be phased out.

G-7 members Britain, France and Italy have already set themselves deadlines to stop burning coal for electricity in the next few years. Germany and Canada are aiming for 2030; Japan wants more time; while the Biden administration has set a target of ending fossil fuel use for electricity generation in the United States by 2035.

A common target would put pressure on other major polluters to follow suit and build on the compromise deal reached at last year's UN

climate summit, where nations committed merely to "phase down" rather than "phase out" coal — with no fixed date.

US climate envoy John Kerry called the agreements reached in Berlin "very comprehensive and forward-leaning."

"I think it will help lay the groundwork for what has to happen at the G-20," he told The Associated Press, referring to a meeting later this year of the broader Group of 20 leading and emerging economies, who are responsible for 80 per cent of global emissions.

Getting all G-20 countries to sign on to the ambitious targets set by some of the most advanced economies will be difficult, as countries such as China, India and Indonesia remain heavily reliant on coal.

## 'Monkeypox can be contained if we act now'

**Geneva, May 27:** Countries should take quick steps to contain the spread of monkeypox and share data about their vaccine stockpiles, a senior World Health Organization official said on Friday.

"We think that if we put in place the right measures now we probably can contain this easily," Sylvie Briand, WHO director for Global Infectious Hazard Preparedness, told the U.N. agency's annual assembly. Monkeypox is a usually mild viral infection that is endemic in parts of west and central Africa. It spreads chiefly through close contact and until the recent outbreak, was rarely seen in other parts of the world, which is why the



recent emergence of cases in Europe, the United States and other areas has raised alarms.

So far, there are about 300 confirmed or suspected cases in around 20 countries where the virus was not previously circulating.

"For us, we think that the key priority currently is trying to contain this transmission in non-en-

## Russia squeezes Ukrainian strongholds in east

# Police response, readiness on focus

**Uvalde, Texas, May 27:** The police response to Tuesday's Texas school massacre came under increasing scrutiny Friday, a day after authorities acknowledged more than an hour passed after the gunman entered the building and killed 19 children and two teachers inside their classroom while barricading himself inside.

Even as the shooting - the deadliest US school attack in nearly a decade - intensified the long-standing national debate over gun laws, the country's leading gun rights advocacy group, opened its annual meeting Friday in Houston. Prominent Republicans, including former President Donald Trump and US Senator Ted Cruz of Texas, were expected to address the convention.

Republican Texas Governor Greg Abbott, who had also been scheduled to speak, will instead provide recorded remarks and head to Uvalde, the site of the shooting, for an afternoon news conference with other officials, according to news outlets.

President Joe Biden, a Democrat who has urged Congress to approve new gun restrictions, will visit Uvalde Sunday.

Authorities Thursday provided fresh details about the assault carried out by 18-year-old Salvador Ramos at Robb Elementary School in Uvalde, a community of 16,000

people about 80 miles (130 km) west of San Antonio.

The new timeline, which differed sharply from some previous official accounts of the shooting, fueled new questions about whether police had an opportunity to intervene sooner.

Videos emerged earlier Thursday showing desperate parents outside the school during the attack pleading with officers to storm the building, with some having to be restrained.

At a Thursday news briefing, Texas Department of Public Safety spokesperson Victor Escalon said preliminary reports that Ramos had encountered a school police officer after crashing his pickup truck near the building were wrong. Instead, Ramos scaled a fence and entered through an unlocked door around 11:40 a.m. (1640 GMT), 12 minutes after the crash.

The door, which is normally locked, may have been left open to accommodate parents who were attending an awards day, according to Miguel Cerrillo, the father of a third-grader at the school.

Two responding officers entered the school four minutes later but took cover after Ramos fired multiple rounds at them, Escalon said.

The interval before agents stormed in appeared to be at odds with an approach adopted by law enforcement agencies to confront "active shooters" at schools immediately to stop bloodshed.

## Iran seizes 2 Greek tankers in Persian Gulf

**Dubai:** Iran's paramilitary Revolutionary Guard seized two Greek oil tankers Friday in the Persian Gulf, just after Athens assisted the US in seizing an Iranian oil tanker over alleged sanctions violations in the Mediterranean Sea. The Guard's announcement comes as tensions remain high between Iran and the West over stalled negotiations regarding its rapidly advancing nuclear program. And while the Persian Gulf has seen a series of attacks since former President Donald Trump unilaterally withdrew America from the accord in 2018, there has not been a major incident at sea in months. The Guard issued a statement on its website, accusing the unnamed tankers of unspecified violations.

# Baby formula shortage highlights racial disparities

**Columbia (US), May 27:** As parents across the US struggle to find formula to feed their children, the pain is particularly acute among Black and Hispanic women.

Black women have historically faced obstacles to breastfeeding, including a lack of lactation support in the hospital, more pressure to formula feed and cultural roadblocks.

It's one of many inequalities for Black mothers: They are far more likely to die from pregnancy complications, and less likely to have their concerns about pain taken se-

riously by doctors.

Low-income families buy the majority of formula in the US, and face a particular struggle: Experts fear small neighbourhood grocery stores that serve these vulnerable populations are not replenishing as much as larger retail stores, leaving some of these families without the resources or means to hunt for formula.

The Centres for Disease Control and Prevention estimates that 20 per cent of Black women and 23 per cent of Hispanic women exclusively breastfeed through six months, compared to 29 per cent of white women. The overall rate



stands at 26 per cent. Hospitals that encourage breastfeeding and overall lactation support are less prevalent in Black neighbourhoods, according to the CDC. The Association of Women's

Health, Obstetric and Neonatal Nurses also says Hispanic and Black women classified as low wage workers have less access to lactation support in their workplaces.

The racial disparities reach far back in America's history. The demands of slave labour prevented mothers from nursing their children, and slave owners separated mothers from their own babies to have them serve as wet nurses, breastfeeding other women's children. In the 1950s, racially targeted commercials falsely advertised formula as a superior source of nutrition for infants. And studies continue to show that the babies

of Black mothers are more likely to be introduced to formula in the hospital than the babies of white mothers, which happened to Isidoro after her emergency cesarean section.

Physicians say introducing formula means the baby will require fewer feedings from the mother, decreasing the milk supply as the breast is not stimulated enough to produce. Andrea Freeman, author of the book "Skimmed: Breastfeeding, Race and Injustice", said these mothers still aren't getting the support they need when it comes to having the choice of whether to breastfeed or use for-

mula. They also may have jobs that do not accommodate the time and space needed for breastfeeding or pumping milk, Freeman said.

"Nobody's taking responsibility for the fact that they've steered families of colour toward formula for so many years and made people rely on it and taken away choice. And then when it falls apart, there's not really any recognition or accountability," Freeman said.

Breastfeeding practices are often influenced by previous generations, with some studies suggesting better outcomes for mothers who were breastfed when they were babies.

**Mumbai, May 27:** Reserve Bank of India (RBI) Friday pitched for structural reforms for sustained economic growth amid rising inflationary pressure, and asked banks to remain watchful of possible slippages in restructured loans.

In its annual report, RBI also said the number of ₹2,000 denomination notes fell to 1.6 per cent of the total currencies in circulation as March 2022 from 2 per cent in the year-ago period.

The central bank stressed that the future path of growth would be conditioned by addressing supply-side bottlenecks, calibrating monetary policy to bring down inflation and boosting capital spending.

"Undertaking structural reforms to improve India's medium-term growth potential holds the key to secure sustained, balanced and inclusive growth, especially by helping workers adapt to the after-effects

of the pandemic by reskilling and enabling them to adopt new technologies for raising productivity," it said in the chapter on 'Assessment and Prospects'.

"The immediate impact of geopolitical aftershocks is on inflation, with close to three-fourths of the consumer price index at risk. The elevation in international prices of crude, metals and fertilisers has translated into a term of trade shock that has widened trade and current account deficits," the report said.

On bank credit, the report said the advances to commercial sector improved, aggregate deposits moderated with the ebbing of precautionary savings. The bank credit growth picked up, especially since August 2021, and it was broad-based.

The banks, RBI said, would need to support growth while being watchful of the credit behaviour of entities whose loans were restructured during the pandemic

## RBI warns of high WPI fuelling CPI

**Mumbai:** Sounding a note of caution, the Reserve Bank said Friday said there is a risk of high wholesale price inflation (WPI) putting pressure on the retail inflation, albeit with a lag. "The substantial wedge between wholesale and retail price inflation amidst a sharp rise in manufactured products' inflation poses the risk of a possible pass through of input cost pressures to retail inflation with a lag, although slack in the economy is muting the pass-through," the central bank noted. To control spiralling prices, the government had recently cut excise duty on petrol and diesel and also waived import duty on some raw materials used in the steel and plastic industry. Besides, export duty was hiked on iron ore and iron pellets. A rise in price across all items from fuel to vegetables and cooking oil pushed WPI or wholesale price inflation to a record high of 15.08 per cent in April and retail inflation to a nearly eight-year high of 7.79 per cent. High inflation prompted the Reserve Bank to hold an unscheduled meeting to raise the benchmark interest rate by 40 basis points to 4.40 per cent earlier this month.

# India Cements to monetise land; price up by ₹55/bag

**Chennai, May 27:** Cement maker The India Cements Ltd has drawn up plans to increase the price of cement sold per bag by ₹55 which would be implemented in phases from June, a top official said Friday.

The city-headquartered company also planned to 'monetise its assets' by selling some portion of 26,000 sq ft land owned by the company, which would be used for repayment of debts and for taking up improvements at its manufacturing facilities, India Cements Vice Chairman N Srinivasan said.

"I am increasing the price of cement per bag by ₹20 June 1, by another ₹15 on the 15th of June and another ₹20 on the first of July," he told reporters.

The increase in cement per bag should cover the cost increases the company was facing and the company's profit and loss account should look better, he said.

Asked about some cement makers planning to cut retail price of cement per bag, Srinivasan also the Managing Director said, "Please do not compare me with others. See, I have a job to do, my job is chief executive of a cement company. All costs have gone up and I have to do something (to increase the price), otherwise I will lose more money."

To a query on the increase in the cement price would affect sales, he said it would not affect the sales and as India Cements has a "very good brand pull."

"It is for two reasons (why it will not affect sales) - one - I give the best

quality (of cement) and second - people say I am good manufacturer, I have been there for 75 years and my testimonial is stronger, my brand pull is very good," he said.

On the plan to monetise its assets, he said, "what we plan to do is that surplus land we will monetise and use that for two reasons - do our repayments and also to make some improvements in the plants so that my costs go down substantially."

"I will monetise to an extent. I have to do my repayments. Last year, I repaid ₹551 crore, this year about ₹500 crore has to be repaid. I will refinance or repay," he said.

# ₹1,000cr of oil firms stuck in Russia

Oil India Ltd Friday reported its highest-ever quarterly net profit in the three months to March as it got nearly \$100 per barrel price for oil produced and sold

**New Delhi, May 27:** As much as 8 billion rubles (about ₹1,000 crore) of dividend income belonging to Indian oil firms is stuck in Russia after the Putin administration clamped down on dollar repatriation, officials said Friday.

Indian state oil firms have invested \$5.46 billion in buying stakes in four different assets in Russia. These include a 49.9 per cent stake in Vankorneft oil and gas field



and another 29.9 per cent in TAAS-Yuryakh Neftegazodobycha fields. They get dividends on profits made by the operating consortium from selling oil and gas produced from the fields. "We had been regularly getting our dividend income from the projects but since the war in Ukraine led to volatility in foreign exchange rates, the Russian government has

put restrictions on repatriation of dollars from that country," said Harish Madhav, Director (Finance), Oil India Ltd, which is one of the partners in the fields.

The dividend from TAAS was paid on a quarterly basis while Vankorneft's earnings were paid half-yearly.

"About 8 billion rubles of dividend income belonging to the Indian con-

sortium is left (in Russia)," he said. "It is not a very large sum of money"

All dividend income prior to the Ukraine war was repatriated but the one that accrued after that is stuck, he said, adding the situation was not alarming and the Indian firms are confident of getting the money once the conflict ends.

ONGC Videsh Ltd (OVL), the overseas arm of state-owned Oil and Natural Gas Corporation (ONGC), holds 26 per cent stake in Suzunskoye, Tagulskoye and Lodochnoye fields - collectively known as the Vankor cluster in the north-eastern part of the West Siberia.

Indian Oil Corp (IOC), Oil India Ltd (OIL) and Bharat PetroResources Ltd (a unit of Bharat Petroleum Corp Ltd or BPCL) hold another 23.9 per cent. Russia's Rosneft is the operator with 50.1 per cent interest.

**New Delhi, May 27:** Mobility giant Ola Electric is scouting for

land to set up its cell and electric car factories and is in talks with multiple states, sources said.

Ola Electric needs 1,000 acres of land to set up its cell gigafactory and electric car factory which is expected to attract an investment of ₹10,000 crore. Some states are already vying, sources aware of the matter said.

The firm already has 500 acre in Krishnagiri in Tamil Nadu where it has built its Futurefactory, the world's largest two-wheeler factory.

Ola's current plans for additional 1,000 acre of land are for a separate four-wheeler factory for its much-anticipated car factory and for its proposed cell gigafactory that will supply cells for its 2-wheeler and 4-wheeler product range.



In December 2020, Ola started the production of its electric scooters in Tamil Nadu.

Ola Electric was one of the 10 companies that submitted a bid under the Advanced Chemistry Cell Battery Storage Programme

in India under the production-linked (PLI) incentive scheme for battery manufacturing capabilities with a budget outlay of ₹18,100 crore. It is the only Indian auto and EV company that has been selected by the government

Since its first delivery December 15 last year, Ola Electric has become India's No 1 electric 2W maker

Ola Electric's four-wheeler ambitions are taking a serious shape with some concept designs almost ready

under PLI.

While its cell PLI bid was for the maximum allowed bid capacity of 20 GWh, founder and CEO Bhavish Aggarwal had blogged about the company's plans to set up an even larger 50 GWh gigafactory to support its own 2W (two-wheeler) and 4W (four-wheeler) plans.

Aggarwal has already made public his intention for Ola to launch its first electric car in the next 2-3 years to be produced at a new 4W

factory to be built, separate from the existing Futurefactory for 2Ws.

A new entrant into the domestic EV 2W segment, Ola has now emerged to be the market leader, disrupting the industry with its dealer-less D2C (direct to customer) model of delivery and service.

The company recently introduced a new software upgrade MoveOS2 for the S1 Pro, with features such as the new Eco Mode that increases its range.

# BUTTLER, PRASIDH SEND ROYALS INTO IPL FINAL

**Ahmedabad, May 27:** Jos Buttler (106 n.o, 60b, 10x4, 6x6) extended his dream run this season with a record-equalling fourth hundred as Rajasthan Royals produced a ruthless performance to beat Royal Challengers Bangalore by seven wickets here Friday and reach their first IPL final since the inaugural edition in 2008.

Pacer Prasad Krishna (3/22) came back strongly from the hammering he received in the last game to help Rajasthan restrict RCB to 157/8 in Qualifier 2 despite a stellar knock from Rajat Patidar (58, 42b, 4x4, 3x6).

Buttler, the leading run getter of the tournament by a fair distance, then toyed with the RCB attack to ensure the Royals romped to victory in 18.1 overs. It was only fitting that Buttler hit the winning runs as he clobbered Harshal Patel for his sixth maximum.

With his special innings, Buttler matched Virat Kohli for most hundreds in a single season. Kohli had achieved that feat in 2016.

Royals take on IPL debutants Gujarat Titans in the final here Sunday and would be looking to emulate the special feat of the 2008 batch which lifted the title under the inspirational leadership of the late Shane Warne 14 seasons ago.

The pitch offered extra bounce but after Buttler provided a flying start in the company of Yashasvi Jaiswal (21), the Royals had the game in the bag. RCB, who had raised hopes for a long awaited title with a resurgent run, committed too many errors after Royals put them in to bat.

After a below-par batting effort, their bowlers ran out of ideas against a marauding Buttler. Mohammad Siraj ended a forgettable IPL campaign on a dismal note. He leaked 31 runs in his first two overs, allowing the Royals to run away with game.

Buttler crossed the 800-run mark this season and dispatched bowlers to all corners in his match-winning effort. Jaiswal too played his part as the Royals raced to 67/1 in the powerplay.

Earlier, Patidar extended his stellar run in the IPL but his effort was the lone bright spot of the RCB innings as the other batters struggled on a tricky pitch. Royals gained the upper hand by taking five wickets in the last five overs that went for only 34 runs.

After smashing a sensational hundred in the Eliminator, Patidar played with supreme confidence after high-profile openers Kohli (7) and Faf du Plessis (25) failed to come up with impactful knocks.

Royals pace duo of Trent Boult (1/28) and Krishna were impressive throughout the innings. While Boult got his inswingers going in the powerplay, Krishna, who had a horror night against Gujarat Titans in the Qualifier 1, got the ball to rise sharply from good length.

Kohli started with a spectacular six off Boult, a whip over deep square leg, before falling to a loose shot off Krishna. Patidar joined Du Plessis in the middle and again played as if he was batting on a different surface. He was dropped by Riyan Parag at backward point early in the innings after he collected two

fours off Krishna in the same over.

He also went after the star spinners Ravichandran Ashwin and Yuzvendra Chahal in the middle overs and brought up his fifty with a clean strike over long-off.

Glenn Maxwell hit a six each against Ashwin and Chahal before Boult outsmarted him. Royals bowlers were able to stifle RCB in the death overs. Krishna lifted his game in the slog overs as well to dismiss the in-form Dinesh Karthik and Wanindu Hasaranga off successive balls.

# India eye revenge against Japan

**Jakarta, May 27:** Having risen like a proverbial phoenix from the ashes, a rejuvenated Indian men's hockey team would like to put up a much-improved performance when it takes on Japan in its first 'Super 4' match of the Asia Cup here Saturday.

Despite facing a below-par Indonesia in its final group league game, the young side coached by Sardar Singh must be lauded for being able to score a whopping 16 goals in just an hour.

It was one more than what India required to put a final nail in Pakistan's coffin as far as harbouring World Cup qualification hopes were concerned. Both India and Pakistan finished on four points each in Pool A behind Japan but the defending champions qualified for the next round due to better goal difference (+1).

But it was not a smooth sailing for India in the first two matches. Having already qualified for next year's World Cup by virtue of being the hosts, India fielded an inexperienced team with as many as 12 debutants for the tournament to gain much-needed experience.

The young boys did not have the best of starts drawing 1-1 with Pakistan before losing 2-5 to Japan, which pushed them on the brink of elimination.

But the Indians were in no mood to bow out without a fight even as they stood at the point of no return. They staged a dramatic turnaround to keep alive their hopes of title defence. They were also aided by Japan, who beat Pakistan 3-2 in their final match.

Their first goal achieved, the



Indians would like to start afresh in the Super 4 stage, where Japan, South Korea and Malaysia are the other three teams.

Revenge would be high on India's agenda having lost to the Japanese in the pool stages. But it would be easier said than done as the nimble-footed Japanese rely mostly on counter attacks to surprise their opponents, a ploy they used to perfection against India in their last outing.

One of the perennial areas of concern for India is poor percentage of penalty corner conversions as this team doesn't have a desig-

ated drag-flicker like Rupinderpal Singh or Amit Rohidas. In fact, even against minnows Indonesia, India failed to convert even half of the 20 plus short corners that they earned.

The Indian defence, led by Lakra, will have to be at its best to stop the speedy Japanese, while the midfield will have to bind the team together to create chances upfront.

Dipsan Tirkey, who scored four goals against Indonesia, has been brilliant with penalty corner conversions but it is an area of concern as India could utilise just nine out

of the 22 short corners they earned in their last game.

Young Uttam Singh needs to be more accurate with his finishing inside the opposition circle, but Pawan Rajbhar has the been star for India so far. He not only created chances with his strong runs but also scored goals.

But to get the better of Japan, the Indians will have to produce a more disciplined performance, which was lacking in the first encounter between the two teams. In other Super 4 stage match, South Korea will take on Malaysia.

# MSD'S WC-WINNING SIX 'INSPIRED' KIRAN

**Pune, May 27:** MS Dhoni's World Cup winning six resides in India's collective consciousness and it was a shot that changed a lot of lives, including that of little-known Solapur athlete Kiran Navgire.

And so, athletics' loss became cricket's gain as the former Maharashtra state level athlete decided that there is no fun if she can't tonk the ball like her "idol".

Eleven years later, at 28, Navgire, who plays domestic cricket for Nagaland, has found instant star-

dom, with some of the most powerful blows that one has ever seen from an Indian batter.

In her very second big stage game in the Women's T20 Challenger, the right-handed Navgire hit the fastest fifty for her team Velocity and her 34-ball-69 will certainly be remembered for a long time, especially the five sixes.

"I really feel good when I hit sixes and whenever I practise in the nets. I practice hitting sixes. I follow Dhoni sir and I love finishing like him, hitting big sixes," Navgire

told her teammate Yastika Bhatia during an interaction for bcci.Tv.

For her, Dhoni's unbeaten 91 against Sri Lanka made her set new goals as she concentrated more on athletics, kho-kho, kabaddi during her formative years while helping out her father in family farm in Solapur district's Mire village.

"I watched the 2011 World Cup final and Dhoni sir's winning sixer is something that impressed me and remained imprinted in my head. That six inspired me and I always feel that in every match, I can hit a six like that," said the stockily built Navgire, who was a state level shot-putter.

Thursday, Velocity skipper Deepti Sharma sent her up the order at No.3 and Navgire didn't disappoint anyone, taking international bowlers like Poonam Yadav, Salma Khatun and Rajeshwari Gayakwad to the cleaners.

"I don't like playing dot balls and want to score something off every ball and hence I got a good score," her answers were as uncomplicated as her lofted hits.

"In domestic cricket, I hadn't batted up the order but I had a good season there and had some good scores. My game revolves around my power hitting ability and if it's in my arc, I send it out of the park and if there are good balls, I like to rotate strikes playing singles and doubles," Navgire said.

She admitted that she was a bit nervous at the start but coach Devika Palshikar's sound advice did help a lot. "Initially, I was a bit nervous but then everything settled down. The captain (Deepti) and teammates gave me lot of confidence. Coach Devika ma'am said 'you don't need to look at the bowler but at the ball and I did just that,'" she added.

# Praggnanandhaa goes down to Ding Liren in tie-break

**Chennai, May 27:** Young Indian Grandmaster R Praggnanandhaa went down fighting to World No.2 Ding Liren in the tie-break of the Meltwater Champions Chess Tour Chess Masters 2022 online tournament final early Friday.

The 16-year-old from Chennai fought back to win the second set after having lost the opener, but then lost the two-game blitz tie-breaker. The Indian GM, who had lost the first set 1.5-2.5, hit back to win the second 2.5-1.5 and force the blitz tie-break.

The 29-year-old Liren used his experience to trump Praggnanandhaa in the second of the tie-break games. After the first blitz game ended in stalemate, the Chinese player won the next in 49 moves to dash the Indian teenager's hopes.

Earlier in the second set which he needed to win to force a tie-break, Praggnanandhaa got the all-important victory in the second game in 79 moves. The next game saw the two dish out a 106-move draw before another stalemate meant the title would be decided by the tie-breaker.

The Indian GM had defeated the highly-rated Dutchman Anish Giri in the semifinal to become the first Indian player to reach the final of a Meltwater Champions Chess Tour event. He also had beaten World No.1 Magnus Carlsen for a second time during the preliminary phase.

# Ligue 1 scold La Liga for attacking PSG, Mbappe

**Paris, May 27:** The French league has written to Spanish competition president Javier Tebas complaining about his attacks on Paris Saint-Germain's finances after Kylian Mbappe chose to stay with the team rather than join Real Madrid.

After Mbappe signed a new three-year contract at Qatari-owned PSG, Tebas said the Spanish league would file complaints to UEFA, the European Union and French administrative and fiscal authorities because it believes the "scandalous" agreement attacks the economic stability of the sport.

"We want to express in the strongest possible terms our disapproval, and also our incomprehension, of your latest attacks against Ligue 1 and one of our clubs," French league chairman Vincent Labrune said in a letter to Tebas Wednesday that was obtained by this agency.

"The fact that you publicly and repeatedly take this position against Ligue 1 on this topic and denigrate our league and our clubs is both un-

acceptable and manifestly false." Tebas has long questioned the reliance of PSG on Qatari sponsorships, which he said are of "doubtful valuation," and doubted how the club could comply with rules given heavy losses.

Labrune wrote, "Your attacks on Ligue 1 and one of our clubs Paris Saint-Germain and one of our players Kylian Mbappe are based around your own interpretation of financial unsustainability and competitive imbalance, which you repeatedly attribute to Ligue 1 and one of our clubs."

Labrune pointed out that the European Court of Justice ruled Real Madrid and Barcelona benefitted from illegal state aid and how Spanish top division clubs have spent almost a third more on players than the French league in the last 10 years.

Labrune highlighted how Tebas in his role as a UEFA executive committee member helped to create new European financial sustainability rules. The replacement for Financial Fair Play has no rules blocking funding of clubs from sovereign wealth funds like Qatar.

# Halep experiences panic attack during French Open match

**Paris, May 27:** Two-time Grand Slam champion Simona Halep said she had a panic attack while leading her second-round match that she eventually lost at the French Open.

The 2018 Roland Garros winner said she "lost it" and couldn't regain focus while playing 19-year-old Qinwen Zheng, who won 2-6, 6-2, 6-1 at Court Simonne-Mathieu.

"I had a break in the second set, but then something happened. I just lost it," the 30-year-old Romanian said in her post-match press conference. "It was just a panic attack. It happened. I didn't know how to handle it because I don't have it often."

Halep said she likely put too much pressure on herself. She also said she was assured by doctors that she's OK physically.

# Pramod, Tarun, Manasi, Parul enter quarterfinals

Bhagat, the highest-ranked player in Men's Standing Lower (SL3) category, lived up to his billing as he topped the group stage with three wins as the group stage matches ended late Thursday.

The Odisha-born player is also through to the last-8 stage of the mixed doubles along with Manisha Ramadass, who is expected to advance in her women's singles SU5 and women's doubles SL3-SU5 with

Meanwhile, Tokyo 2020 bronze medalist Manoj Sarkar and Nitesh Kumar, placed in the lower half of the draw in men's singles SL3, and promising Hardik Makkar and Chirag Baretha (both in men's singles SU5) are also through to the quarterfinals.

In men's SL4, Tarun Dhillon will play Korea's Cho Nadan in the quarterfinals and is expected to be challenged by Thailand's Siripong Teamarrom in the semifinals. A summit clash between Dhillon and Indonesian Fredy Setiawan looks likely. Dhillon is also through to the last-8 stage of men's doubles SL3-SL4 and mixed

doubles SL3-SU5 events.

Among other names, top seeds Malaysian Cheah Liek Hou (MS SU5), Hong Kong's Chu Man Kai (MS SH6), Japan's Daiki Kajiwara, and Hong Kong's Chan Ho Yuen (MS WH2), Indonesians Setiawan (MS SL4) and Suryo Nugroho (MS SU5) all topped their groups and advanced to the quarterfinals.

In the women's events, India's reigning world champion Manasi Joshi, and Parul Parmar (women's singles SL3) advanced as did Nithya Sre Sumathy Sivan, who should make it to the finals of women's singles SH6.

Promising Manisha Ramadass continued her good run and is through to the women's singles quarterfinals SU5. She is expected to face Denmark's Cathrine Rosengren in the semifinals.
