

CAKEWALK FOR MURMU

Odisha's Droupadi creates history by becoming the youngest President-elect and the first tribal woman to become the first citizen of India as she defeats Opposition candidate Yashwant Sinha quite comprehensively

New Delhi, July 21: Droupadi Murmu scripted history Thursday by becoming India's first tribal President-elect in the one-sided contest, defeating Opposition candidate Yashwant Sinha comprehensively. Murmu, 64, won by an overwhelming margin against Sinha after receiving over 64 per cent valid votes in a day-long counting of ballots of MPs and MLAs comprising the Electoral College. She will succeed Ram Nath Kovind to become India's 15th President and take oath July 25.

After the end of the counting process that continued for more than 10 hours, returning officer PC Mody declared Murmu as the winner and said that she got 6,76,803 votes against Sinha's 3,80,177 votes.

Murmu will be the first president to be born after independence and is the youngest to occupy the top post. She will be the second woman to become the President after Pratibha Patil.

Murmu's victory was sealed after the third round when the Returning Officer announced that she had already received over 53 per cent of the total valid votes even as ballots from 10 states and Union Territories were still being counted.

Conceding defeat after the third round of counting, Sinha congratulated Murmu and said every Indian hopes that as the 15th President she will function as the 'custodian of the Constitution' without fear or favour.

In a statement, Sinha thanked the leaders of the Opposition parties for choosing him as their consensus candidate in this election. "I also thank all members of the Electoral College who voted for me," he said. "I have performed my duty conscientiously out of my

love for my country. The issues I had raised during my campaign remain pertinent," he added.

Meanwhile sources in the Election Commission said that a total of 146 MLAs of the Odisha Assembly voted in the Presidential polls out of which 137 voted for Murmu while nine voted for Sinha.

A total of 53 votes were declared invalid, out of which 15 were of MPs and the remaining were of MLAs from different states. Five votes each from Madhya Pradesh and Punjab were cancelled while Karnataka, Delhi, West Bengal and Maharashtra registered four cancellations each. Three votes from the Uttar Pradesh Assembly were also declared invalid.

Immediately after the announcement of the NDA presidential nominee crossing the half-way mark, Prime Minister Narendra Modi and BJP president JP Nadda visited Murmu at her residence here to congratulate her.

"India scripts history. At a time when 1.3 billion Indians are marking Azadi Ka Amrit Mahotsav, a daughter of India hailing from a

tribal community born in a remote part of eastern India has been elected our President!," Modi tweeted

"Droupadi Murmu Ji's life, her early struggles, her rich service and her exemplary success motivates each and every Indian. She has emerged as a ray of hope for our citizens, especially the poor, marginalised and the downtrodden," Modi said in another tweet.

Being a tribal also helped Murmu get the support of a number of independent parties including BJD, YSRCP, AIADMK, TDP, BSP, JDS and SAD, besides Opposition's JMM, Shiv Sena and Suheldev Bharatiya Samaj Party in her victory run.

MLAs demand hike in LAD fund

Bhubaneswar, July 21: Cutting across party lines, legislators from BJD, BJP and the Congress demanded Thursday in the Assembly for enhancement of the MLA Local Area Development (LAD) fund.

Currently the MLA LAD fund stands at ₹3 crore of which ₹2 crore is provided for overall development while ₹50 lakh is utilised for road construction and the remaining ₹50 lakh for education-related infra development.

Raising the issue during Question Hour, BJD MLA from Bhadrak, Sanjib Kumar Mallick said the development and renovation work of big temples in the state are being carried out. However, the MLA LAD fund is not sufficient enough for the development of small tem-



ples in rural pockets of Odisha. He said that ₹3 crore is inadequate to meet the requirement of the people as costs of all materials have increased substantially.

BJP chief whip Mohan Charan Majhi said as the MLA LAD fund is ₹5 crore or more in the neighbouring states, it should be hiked to ₹10 crore in Odisha. Majhi also said that funds should be provided

to 'Saraswati Sishu Vidya Mandir' from the MLA LAD fund.

Similarly Congress MLA Santosh Singh Saluja said the budget for road construction, Covid-19 and higher education should be raised and the general expenditure should be hiked to ₹3 crore.

Saluja demanded that instead of allocating ₹50 lakh for road construction and ₹50 lakh for educa-

tion-related infrastructure development, the amount of the MLA LAD fund should be increased to ₹3 crore from the ₹2 crore at present.

Responding to the issue, Planning and Convergence Minister Rajendra Dholakia said that currently, there is no proposal to enhance the MLA LAD fund and it will be taken into consideration at the right time.

The fund was increased threefold to ₹3 crore from the previous ₹1 crore in the financial year 2020-21. The MLA LAD fund currently is ₹5 crore in Maharashtra, UP and Telangana while it is ₹4 crore in Chhattisgarh and Jharkhand.

Speaker Bikram Keshari Arukha directed Dholakia to hold discussions with the concerned officials and apprise the House if the size of the fund could be raised to ₹3 crore.

ADANI UNLOCKS GATES, NOW WORLD'S 4TH RICHEST

New Delhi, July 21: Industrialist Gautam Adani has left behind Microsoft co-founder Bill Gates to become the world's fourth richest person, according to the 'Forbes' Real-Time Billionaires' list. The 60-year-old business tycoon's net worth reached \$115.5 billion Thursday eclipsing Gates whose fortunes stands at \$104.6 billion. Mukesh Ambani is 10th in the list with net worth of \$90 billion. 'Tesla' and 'SpaceX' founder Elon Musk continues to top the list with \$235.8 billion.

The Adani Group chairman is famous for turning a small commodities trading business into a conglomerate spanning ports, mines and green energy.

"Some of Adani Group's listed

stocks increased more than 600 per cent in the last two years as it has invested a lot in green energy and infrastructure," a 'Bloomberg' report recently said. In the same report, it said that Adani had replaced Ambani as India's richest person.

"In barely three years, Adani has gained control of seven airports and almost a quarter of India's air traffic. His group is India's largest airport operator, power generator and city gas retailer in the non-state sector," the report said.

Earlier in the day Adani told the media that his group has bagged the tender for the privatisation of a port in Israel in partnership with 'Gadot'. The Port of Haifa is the largest of Israel's three major international seaports.

210 aircraft staff fail breath analyser test, suspended

IN THE RECENT PAST, TECHNICAL SNAGS AND EMERGENCY LANDINGS BY AIRCRAFT HAVE RAISED QUESTIONS ON SAFETY OF PASSENGERS

New Delhi, July 21: At a time when safety of fliers has become a cause for concern with flights being grounded on a regular basis or are being forced to make emergency landings due to technical snags mid-air; another interesting fact has come to light. This will certainly cause apprehensions among passengers who travel via air.

A total of 60 pilots and 150 cabin crew members have tested positive following the breath analyser (BA) tests in the last two-and-a-half-years. Breath Analyser tests are conducted to ensure aviation safety

is not compromised due to the consumption of alcohol by pilots and cabin crews.

During the period from January 1, 2020 to June 30, 2022, as per the provision of Civil Aviation Requirements (CAR) Section-5, Series-F, Part-III, no license has been cancelled. However, a total of 210 pilots and crew members have been suspended.

According to reply made Thursday in the Parliament, there is a systematic safety oversight process in place for monitoring the compliance of Rules and Civil Aviation Requirements by the airlines. "This is a continuing process



and includes surveillance, spot checks and regulatory audits embodied in Annual Surveillance Plan (ASP) of DGCA. The findings

of safety oversight exercises are followed up with the concerned operator for compliance and the observations are closed only after

due verification," said the reply.

The compliance of the action taken by the operator is verified during the next audit and surveillance. In case of any violations or non-compliance to regulations detected during audit and surveillance, enforcement action including financial penalty is imposed by the DGCA.

DGCA in its guidelines had earlier said that airlines must ensure that 50 per cent of their cockpit and cabin-crew members are subjected to pre-flight alcohol tests on a daily basis. While conducting the tests, a large number of pilots and cabin crew has been found on the wrong side of the rule.

As per DGCA advisory, even 12 hours after a bout of drink, when blood alcohol level remained zero, there could be a decrease in performance. "Alcohol present in body even in small quantities jeopardises flight safety on several counts and is likely to adversely affect an aviator well into the hangover period," informed a DGCA official.

It should also be stated here that a few days back, Civil Aviation Minister Jyotiraditya Scindia had met the heads of various private airline companies and stressed on the need for passenger safety. He had said that no compromise can be made on the safety issue.


The *Chocolate* actress claims to be 'targeted' and 'harassed' by old mafia, political circuit, and anti-national criminal elements.



ORANGE ALERT OF VERY HEAVY RAIN IN 7 DISTRICTS

Bhubaneswar, July 21: Odisha is staring at another spell of intense rain as the Met office Thursday warned of very heavy showers over the next three days.

The Bhubaneswar Meteorological Centre issued an orange warning of heavy to very heavy rain at a few places in Boudh, Bolangir, Bargarh, Gajapati, Ganjam, Kandhamal and Kalahandi districts Friday.

It predicted downpour Saturday at some areas of Jagatsinghpur, Puri, Khurda, Nayagarh, Angul and Subarnapur.

Heavy to very heavy rain is also likely to occur in Sambalpur Deogarh, Bargarh, Jharsuguda and Sundargarh on Sunday, according to a bulletin.

Rainfall between 115.6-204.5 mm in a day is categorised as 'very heavy'. It may trigger landslides



or mudslides in vulnerable hilly areas, temporary waterlogging of low-lying areas, and some damage to roads and vulnerable houses, according to the weather office.

A yellow warning of heavy rain has also been issued for some places in Koraput, Nabarangpur, Rayagada, Nuapada and Cuttack districts on Friday.

Downpour over the next three days is expected in some parts of Malkangiri, Kendrapara, Jajpur, Dhenkanal, Keonjhar and Mayurbhanj.

Dismal show by Odisha in Innovation Index 2021

New Delhi, July 21: Odisha has ranked 16th among the 17 major states in the NITI Aayog's India Innovation Index 2021. The index revealed that the state has failed miserably in the field of innovation. This apart, the flow of foreign direct investment (FDI) to Odisha is very low.

The Innovation Index 2021 stated that the FDI in Odisha was just 0.07 per cent of the state's GDP. Besides, the state spends a meagre amount on research and development, which is very important for innovation.

The index also highlighted a dismal show by Odisha in the parameter of knowledge intensive employment.

However, the state scored comparatively better in the fields of human capital and business environment.

Karnataka, Telangana and Haryana have been ranked as the top three states among 17 major states in the Innovation Index. The index, released by Niti Aayog's Vice Chairman Suman Bery in the presence of Chief Executive Officer Parameswaran Iyer Thursday, has been developed on the lines of the Global Innovation Index.

States and Union Territories were divided into '17 Major States', '10 North-East and Hill States', and '9 Union Territories and City States', for effectively comparing their performance.



Chhattisgarh, Odisha and Bihar have been ranked at the bottom of the index among major states. Karnataka topped the index for the third year in a row.

Among Union Territories, Chandigarh topped the chart, while in the North-East and Hill States category Manipur occupied the top spot. "Among the 17 major states, Karnataka, with a score of 18.01, is the top performer, followed by Telangana and Haryana. Chhattisgarh has scored the least, 10.97. And the average score for the major states' category is 14.02," said the index.

According to the index, Karnataka's high score can be attributed to its peak performance in attracting FDI and a large number of venture capital deals.

Uttar Pradesh and Haryana have registered significant gains in promoting an innovative business environment with a large base of internet subscribers and a safe ecosystem for further investment in the region, it added.

The average score of North-East and Hill States' category was 14.41, the index

said, adding that Manipur with a score of 19.37 was at the top and Nagaland with a score of 11 was at the bottom.

While Manipur scored best in the knowledge workers and safety and legal environment pillars, Uttarakhand had the second highest score due to the state government's high R&D investment.

The average innovation score of the 9 Union Territories and City States was 15.74, higher than the national average.

Speaking at the event, Niti Aayog CEO Parameswaran Iyer said he would like to reaffirm the Aayog's continued commitment to monitoring the state of innovation in India through the India Innovation Index. "We strive to improve the innovation ecosystem across the nation in partnership with states and other stakeholders," he said.

Niti Aayog member V K Saraswat said innovation is the key to sustainable and inclusive growth. "It can help us solve the biggest challenges of our times, bringing millions out of poverty, generating livelihood opportunities, and paving the way for an Aatmanirbhar Bharat," he added.

The first and second editions of India Innovation Index were launched in October 2019 and January 2021, respectively. According to an official statement, the third edition strengthens the scope of innovation analysis in the country by drawing on the framework of the Global Innovation Index (GI).

Odisha logs 1,196 new Covid cases

Bhubaneswar, July 21: Odisha's COVID-19 tally rose to 13,03,191 Thursday as 1,196 more people, including 169 children, tested positive for the infection, 74 more than the previous day, a health bulletin said.

With the fresh infections, the state registered the highest single-day spike since February 12, when 1,539 cases were recorded.

The daily positivity rate was at 5.18 per cent as 23,078 samples were tested for COVID-19.

Khurda district, where the state capital Bhubaneswar is located, reported the highest number of fresh cases at 312, followed by Sundargarh (174) and Cuttack (109).

The number of active cases climbed to 7,093, of which 2,218 are in Khurda.

The toll remained unchanged at 9,130 as no fresh fatality was recorded. Fifty-three other patients have died due to comorbidities so far.

A total of 12,86,915 people have recovered from the disease thus far, including 804 in the last 24 hours, it added.

2 held for OTDC fund bungling

Bhubaneswar, July 21: The twin city Commissionerate Police has arrested two employees of Odisha Tourism Development Corporation (OTDC) on charges of misappropriating ₹17.47 lakh of the corporation's Nimantran restaurant, an official said Thursday.

Saheed Nagar police identified the accused as Ardhendu Sekhar Mohanty of Tirtol in Jagatsinghpur, a manager at Nimantran restaurant, and Sunil Kumar Ghadei of Kantilo in Nayagath, an assistant manager at the restaurant.

The fraud came to the fore after OTDC divisional manager Prasant Panda approached the Saheed Nagar police July 19 alleging ₹17.47 lakh fraud by the duo.

"Ardhendu and Sunil used to

divert at least 50 per cent of the restaurant's daily earning to their personal account and deposited the rest amount in the restaurant's bank account," said a senior police officer.

The issue came to the light when a restaurant worker approached Panda for ₹5 lakh to buy grocery. Upon reaching the bank to withdraw money, Panda was taken aback to find that the bank account has only ₹320 despite a handsome daily earning. Following verification, Panda claimed to have stumbled upon the fraud by the duo, said the police official quoting the case (328/22) registered on the basis of Panda's complaint.

"The two were arrested and produced before a local court that sent them to judicial custody. Ardhendu had lost around ₹10 lakh to online gambling," said the official.

In 12 years, compensation paid in only 18% cases: RTI

Bhubaneswar, July 21: Five circles — Balasore, Bhadrak, Baripada, Jajpur and Keonjhar, which come under the TP Northern Odisha Distribution Limited (TPNODL), have witnessed at least 588 electrical accidents between 2010 and May 2022. However, compensation has been provided in only 18 per cent of the cases.

This was revealed by TPNODL, which took over the management and operations from North Eastern Electricity Supply Company of Odisha (NESCO) in April 2021, while responding to an RTI query filed by rights activist Biswapriya Kanungo.

"As many as 333 humans and 280 animals died while at least 159

persons suffered critical injuries in 588 electrical accidents, especially involving dangling wires and charged poles, between 2010 and May 2022," TPNODL's CIOcum-Manager (Legal) said, adding that compensation has been given in 103 cases, around 18 per cent, during the period.

In most of the cases, compensation has been received following intervention of the courts or rights body like OHRC and NHRC, Kanungo said.

The Energy department, however, was clueless about inspection of transformers, poles and wires in the Capital city of Bhubaneswar undertaken by the electrical inspectors.

"The Energy department's clue-

lessness on inspections shows how indifferent the state government as well as the power distributing companies are towards the safety of public in general," the rights activist pointed out.

According to the state government's policy on compensation to victims of electrical accidents, in case of death due to electrocution, the next of kin of the deceased will be entitled to get an ex-gratia of Rs 4 lakh whereas persons with 60 per cent and 40 per cent to 60 per cent disability will get a compensation of Rs 2 lakh and Rs 59,100 respectively.

Similarly, a compensation of Rs 30,000 for death of cow and buffalo, Rs 25,000 for draught animals including bullocks, camel and horse and Rs 50 per poultry bird will be paid, it was learnt.

9-yr-old hostel inmate's death sparks row

Dasamantpur: A nine-year-old hostel inmate of an upper primary school here died due to alleged negligence of school and hostel authorities at Lulla panchayat under this block in Koraput district, Thursday. The deceased was identified as Krushna Naik, 9, son of Manik Naik of Maligaon village under Chandragiri panchayat of Kashipur block in Rayagada district. Krushna was suffering from fever for the last eight days and an ANM Haribala Nayak gave him some medicines instead of taking him to a hospital. Later, the school authorities informed the family members who reached the school and were rushing him to Dasamantpur health centre when he succumbed on the way.

High BP may double Omicron risk, even after booster dose

Having high blood pressure more than doubled a person's risk for hospitalisation from an Omicron-variant -- despite full vaccination, including a booster dose of the Covid vaccines, according to new research.

The findings showed that individuals with high BP were 2.6 times more likely to require hospital care for severe Covid illness, even when the person had no other serious chronic health condition, the researchers noted in the paper published in the journal Hypertension.

Further, older age, high BP, chronic kidney disease, heart at-

tack, heart failure and the time between the last vaccination and Covid infection were all associated with greater risks of hospitalisation.

"Our data found that it is not just older adults with other underlying health conditions who are vulnerable," said lead author Joseph E. Ebinger, Assistant Professor of cardiology at the Centre's Smidt Heart Institute.

"Breakthrough Omicron infection severe enough to cause hospitalisation can happen to an adult of any age, especially if a person has high blood pressure, even if they have no other major chronic disease. The peo-



ple who are most at risk are not necessarily who we think they are. They are not the sickest of the sick, and this was a surprising finding," he added.

Researchers conducted a retrospective cohort study of 912 adults who had received at least three doses of an mRNA Covid vaccine (either the Pfizer-BioNTech or Moderna) and were treated for Covid-19 during an Omicron surge, between December 2021 and April 2022.

The analysis found that of the 912 adults who received three doses of an mRNA Covid vaccine, nearly 16 per cent required hospitalisation. Of the 145 patients hospitalised, 125

of them (86.2 per cent) had high BP.

"We need to raise awareness and understanding that receiving three doses of a vaccine may not prevent severe Covid-19 in everyone, especially among people with high blood pressure. We also need more research to understand why there is this link between high blood pressure and an excess risk for more severe Covid-19 illness," Ebinger said.

Researchers said further study is warranted on how to reduce risks for serious Covid infection, whether through more tailored vaccine regimens, new therapeutics or a combination approach.

Why Lanka Imploded

As Sri Lanka's economy unravels before our eyes, one must ask how this could happen in a country that is historically known for its high standard of living and stable economy. Sri Lanka's achievements go back decades, giving it a per capita GDP that is 70% higher than India's, and a life expectancy at birth of 77 years, compared to 73, 70, and 67, in Bangladesh, India, and Pakistan, respectively.

But now, Sri Lanka's economy is in free fall. The proximate causes of the crisis are clear enough. Problems stemming from international factors such as COVID-19 and Russia's war in Ukraine were exacerbated by Sri Lanka's own policy mistakes. In 2019, President Gotabaya Rajapaksa (who has now fled the country) announced a round of mindless tax cuts, depriving the state of sorely needed revenue. Then, in 2021, his government abruptly banned imports of chemical fertilizer and pesticides. While the aim of the policy was to stall foreign-exchange outflows, the main result was a dramatic reduction in domestic food production, leading to acute food shortages this year.

The coup de grâce was the government's ongoing effort to keep the Sri Lankan rupee artificially strong. Technically, Sri Lanka uses a "soft peg": Rather than being fixed by government diktat, the rupee-to-dollar exchange rate is allowed to float, albeit with occasional interventions by the central bank (buying and selling dollars) to prevent excessive fluctuations.

But charting the rupee-to-dollar exchange rate shows that the country's soft peg is a misnomer: For years, the exchange rate remained flat, roughly between 175 to 200 rupees to the dollar because, as economist Noah Smith explains, the Sri Lankan central bank was regularly selling dollars to prop up the rupee's value. Eventually, this longstanding intervention ended the only way that it could: starting around April of this year, the rupee began depreciating sharply. Within months, the exchange rate had fallen to 350 rupees to the dollar, and the central bank's dollar reserves had all but vanished.

Sri Lanka defaulted on its foreign debt in May. We now know that, rather than turning to the International Monetary Fund, whose rescue programmes are conditional on tough policy reforms, it approached China for a fresh loan when its coffers were approaching empty. But this merely increased its debt by another \$3 billion and ensured that its inevitable crisis would be even bigger when it eventually arrived.

China's strategy vis-à-vis Sri Lanka (and other developing countries, like Ethiopia) echoes the approach taken both by earlier colonial powers and by rural moneylenders in developing countries. As Amit Bhaduri showed in a classic 1977 paper in the Cambridge Journal of Economics, rural informal moneylenders typically do not worry about the borrower defaulting; rather, they worry about the borrower not defaulting, because then they cannot turn a bigger profit by confiscating his collateral (usually his land).

Consider Hambantota Port, the pet project of Mahinda Rajapaksa, Sri Lanka's president between 2005 and 2015 (and Gotabaya Rajapaksa's brother). Funded largely with Chinese money, the port opened in 2010 on Mahinda's birthday. But when Sri Lanka later failed to repay the debt, this "gift" became collateral to be confiscated. China now has a 99-year lease on the port.

How did a country with a longstanding reputation for maturity make so many mistakes? The short answer is that Sri Lanka's politics sowed the seeds for today's economic crisis. The Rajapaksa-led government became increasingly authoritarian after defeating the Liberation Tigers of Tamil Eelam and ending Sri Lanka's decades-long civil war in 2009. It eroded the country's democratic institutions, persecuted minorities, and waved away accusations of war crimes.

Although authoritarianism typically ends up destroying an economy, some authoritarian governments have managed to deliver economic growth and stability. For a short while, it seemed possible that the Rajapaksa government could fall into this category. But as it embraced populism, it soon became clear that crony capitalism would be Sri Lanka's fate.

When the Rajapaksa government returned to power in 2019, it was riding a wave of support that it sought to sustain with ill-advised economic handouts. But the public's patience can be bought for only so long. Eventually, unsustainable policies run into a wall.

If not for its hubris, the latest Rajapaksa government could have corrected course. When it came to power and immediately announced big tax cuts, it met with strong, sensible criticism. On October 30, 2019, for example, former Finance Minister Mangala Samaraweera warned, on Twitter, that, "Gota's tax plan wants to set Sri Lanka on an express train to bankruptcy." But Rajapaksa doubled down. When the government suddenly banned chemical-fertilizer imports, the implications of the policy were all too predictable.

Where it will end is unclear. Even if the Rajapaksas do not regain control by proxy, there are other risks. The IMF cannot offer a rescue programme until there is a viable government with which to negotiate. But both the Fund and the Paris Club of sovereign creditors also will need to be proactive, suspending some of their bureaucratic rules to help Sri Lanka through this acute phase of the crisis. Failing that, a spiraling humanitarian disaster is the likeliest outcome.

FOCUS INDIA'S FOREIGN POLICY

INCREASE IN HORIZONTAL CONSULTATION WOULD DIMINISH THE CENTRALISED DECISION MAKING AND HIERARCHICAL NATURE OF THE MEA

All policies of all governments anywhere in the world require periodic review and evaluation. Foreign policy, in particular, needs regular review and re-evaluation in the context of ever-changing, dynamics in the external environment of any country. In this piece, we attempt to briefly examine the capacities and the constraints of India's foreign policy. This has been necessitated by two strategies currently pursued by the present regime. They could be contradictory and complementary at the same time. They also draw the lineage from the previous regimes.

The strategies in reference are strategic autonomy and multi-alignment. India's approach to and understanding of the concept of strategic autonomy is captured in External Affairs Minister S Jaishankar's presentation in the Raisina Dialogues (2021). He explained, "We have to be confident in who we are. It is better to engage with the world as to who we are rather than pleasing the world by being a pale imitation of what they are, the idea that we need to get approval from other quarters has to be put behind."

As said before, this is not an entirely new concept. But the government supporters will contend that the country was done with the Congress style of limiting its strategic moves, for fear of attracting Western displeasure or disapproval. Today, India is confident enough to secure her aims and interests without worrying too much about what others thought.

On the second strategy, in this dynamic world of multiple and changing alliances, India's strategy of making partnership is articulated by Jaishankar in his book, *The India Way: Strategies for an Uncertain World* (2020). He argues that India should spread its risks and not place all its eggs in one basket. The essence of Jaishankar's argument is that with the changing global balance of power and faced with major security and economic challenges, India would have to advance its national interests by identifying and exploiting opportunities wherever they exist in the global community.

Yet, the third strategy, or rather an aspiration is, India becoming a

great power. This is self-consciously expressed at times by top leadership and is endorsed or encouraged by world leaders. Citing some statements, PM Modi immediately after taking over the office in 2014 expressed his government's intention as, "India taking a leading role" in global affairs.

Unarguably, India is being recognised as a rising power. Jim O'Neil, the former head of Goldman Sachs, famously coined the term BRICS to refer to four rising powers — Brazil, Russia, India and China. India could well become a permanent member of the UNSC. Every major power has endorsed India's candidature for this position alongside the current P-5. India's trajectory towards becoming a big power consists of the following capacities: India's GDP in nominal terms is about 2.7 trillion USD, making it the sixth biggest economy in the world. There are some projections that suggest in purchasing power parity terms, India could be the second largest economy after China by 2050. If India achieves the 5 trillion USD target in near future, it could jump to third position in economic capacity.

India's military consists of 1.5 million active personnel, the third largest after China and the US. India is a major nuclear power with 130-140 nuclear weapons which can be placed on a range of delivery systems including Intermediate Range Ballistic Missiles.

The question to ask is, does

India have the capacity commensurate with its rising power aspirations and to maintain the two strategies mentioned above. From the economy and military potential, the aspiration sounds credible. But on a reality check, it is a tall order especially when India is compared and faced with China. Curiously, the constraints lie in actualising the capacities.

Let us talk a bit about the structural capacity of Indian foreign policy in carrying out the strategies and the big-power objective. A detailed discussion, a 'grand capacity analysis' is beyond the scope of this piece. The limited objective is to briefly and critically look at the foreign policy capacity from a structural point of view. Former Foreign Secretary and the National Security Advisor, Shivshankar Menon had said, "India has serious capacity issues in the implementation of foreign policy and lacks the institutional depth to see a policy through."

Studies done to assess India's foreign policy capacity suggest that the MEA has strengths in terms of individual level competences of its officers, but suffers from organisational and systemic weaknesses. The experts helpfully comment that these weaknesses can be alleviated by reducing the hierarchical nature of the leadership in South Block, decreasing the centralisation of decision-making, enlarging the power of the policy-planning unit by seeking support from outside the MEA.

Furthermore, the MEA needs to develop stronger and more active ties to other ministries, especially the Economic Affairs, the Ministry of Home Affairs, and above all, the Defence Ministry.

More importantly, the MEA should not remain an exclusive and elite club. It needs to improve communication with the other two sectors, business and civil society — both at home and abroad. Thus, the increase in such horizontal consultation would diminish the centralised decision making and hierarchical nature of the MEA.

Another pressing reform suggested by experts is to increase the recruitment to the MEA. Through the IFS, only about 30 or so are offered the service out of half-a-million candidates applying for examination. This is far too less. The suggestion is to recruit on the model of the private sector, like many developed countries do, from the top undergraduate and graduate programme through a rigorous process of interviews and group discussion. Understandably, while many small or big reforms are needed, what is pressing at any time is the need to increase policy capacity. This is not necessarily based on numbers. It is about competencies at least three levels — individual officials, government organisations and the resources existing in the country. The gap between conceptualisation of policy and its implementation can be bridged by increasing the organisational and systemic capacities in order to absorb and reflect the individual competences existing in the ministry.

In parenthesis, may we add that India's democracy and demography should drive India's foreign policy in making strategic alliances, be it multi-alignment or with single power bloc. This is the choice India has to make. Taiwan would have been invaded by now if it was not aligned with the United States. No NATO member has been attacked so far. This should give some indication, as normally has not been restored with China on border despite 17 rounds of negotiations. Something to think about!

Are Indians giving up on marriage?

THE PERCENTAGE SHARE OF THE YOUTH WHO ARE NEVER MARRIED HAS SHOWN AN INCREASING TREND

According to a recent report of the Ministry of Statistics and Programme Implementation, the proportion of unmarried youths is on the rise in the country with Jammu and Kashmir topping the list. Its findings say, "The percentage share of the youth population (15-29 years) who are 'never married' has shown an increasing trend in the male population from 20.8 per cent in 2011 to 26.1 per cent in 2019 and a similar trend has been observed in the case of the female population."

Another government report which was published in 2019 states that Jammu & Kashmir (29.1%), Punjab (25%), Uttar Pradesh (26.7%) and Delhi (26.5%) record the highest share of youngsters not getting married. On the other hand, the same report reveals that Kerala (18.3%), Himachal Pradesh (20.8%) and Tamil Nadu (20.2%) and Andhra Pradesh (20.7%) have the lowest percentage share. In the case of adolescent women within the age bracket of 15-19 years; 11.9 per cent have been married (by the age of 15) during 2005-06. And this was only 1.7 per cent in 2019-21.

Apparently, the age bar at the marriage seems to have increased

over the passage of time. It is noteworthy to mention that, "a significant reduction has been observed in the level of age at first marriage for women in the 25-29 years age cohort as only 52.8 per cent of women have been first married by the age of 20 years during 2019-2021 as compared to 72.4 per cent in 2005-06." "Males in the age bracket of 25-29 were first getting married at the 25 years of age during the year 2019-21."

The recent survey report has not detailed any factor(s) to understand the burgeoning percentage of unmarried youth but the government officials have attributed this to "lifestyle and influence of celebrities." However, it has been found out from the survey that the cases of child marriages are getting reduced over the years. The population pyramid also will undergo a change due to the declining fertility rates and increasing life expectancy. The youth under 15 years are presumably going to decline and the responsibility of the country is going to increase towards aged people, the report further stated.

The following reasons can be taken into consideration to understand the increasing propor-

tion of 'unmarried youth' in our country.

First and foremost could be economic instability which is haunting most of the youth. And this specific issue got more aggravated because of the pandemic. Those with less than ₹10,000 monthly income are completely unwilling to get married. In the case of affluent households, only 20 per cent of people are reluctant for marriage, according to a survey done in 2020 (Mar-April).

Marital preference comes in the second position. In the era of online dating and social networking platforms the frustration felt at not being able to find a match can be daunting. Fritzi-Marie Titzmann, in her book 'Changing Patterns of Matchmaking in India' has also mentioned that "the upcoming matrimonial media allows youth a much wider range of choices now."

In the Indian context, how can we ignore the significant role of caste and class? Among youth those who are willing to get married want a life partner from a similar income background, class, status and educational bracket.

Then comes the "shift in the attitude" on the significance of mar-

riage. The youth with higher education don't aspire to get married early. These days becoming a single father/mother is a luxury. People consider this lifestyle as woke and modern. The best of the best couples committed for years together are thinking of getting separated in no time. And this might be connected with the issues pertaining to emotional and physical compatibility.

In considering or choosing a life partner a higher percentage of young men give primacy to looks and education. On the other hand, young women prefer men who are handsomely paid. Hence most of the couples get entangled within the circle of expectation and reality and at the end it paves the way for nothing productive. To conclude, the 21st century generation easily defines what should be the 'marriageable age' for them. As of now our country still continues to be very young. And the way the young choose to marry or build families will have a far reaching impact on tomorrow's economy.

Institutional ranking

Sir, Institutional ranking is a common practice to assess the overall quality of centres of excellence through different yardsticks. In India, the National Institutional Ranking Framework (NIRF) put in place in September, 2015, ranks institutions through a pre-determined methodology. Total sum of marks given to each of the five predetermined parameters determine the final rankings. Faculty : student ratio, total budget and utilisation, entrepreneurship, combined percentage for placement, percentage of students from other states and countries, median salary, regional diversity, percentage of women, peer perception are inherent in these broad headings. Rankings are accorded to institutions in different educational streams. Also, overall rankings of colleges and universities are in place in NIRF Indian Institutes of Technology (IIT) and the Indian Institutes of Management (IIM) spread across the country, and the Indian Institute of Science (IISc), to name a few, are centres of excellence that have kept pace with the changing times. No educational institution is without blemishes though there are some centres that can consistently hold their head high. The 2022 rankings are no different than the earlier ones. SC to await Varanasi court decision

New Delhi, July 21: The Supreme Court Thursday said that it will await the Varanasi district judge's decision on the Gyanvapi mosque committee's application raising objections to the maintainability of the civil suit filed by Hindu devotees.

The top court also refused to entertain two writ petitions that sought its permission to worship the 'Shivling', which is claimed to be found in the Gyanvapi mosque premises during a court-ordered survey and carbon dating of the 'Shivling' to ascertain its age.

A bench of Justices DY Chandrachud, Surya Kant, and PS Narasimha said that it is posting for October 20 hearing on the appeal of the Gyanvapi mosque committee's plea against the Allahabad High Court order upholding the appointment of a court commissioner to survey the site. The bench said that it has been apprised of the fact that proceedings before the District Judge are still underway and it would be appropriate if the appeal of the mosque committee is kept

pending till the outcome of the application filed under Order 7 Rule 11 questioning the maintainability of the suit. "The Court has been apprised of the fact that the application under Order VII Rule 11 of the Code of Civil Procedure 1908 is being argued before the District Judge, Varanasi, and the proceedings on the application are pending. In the above situation, further hearing of these proceedings shall await the outcome of the proceedings before the District Judge. List the Special Leave Petition October 20, 2022", the bench said.

During the hearing, the bench told senior advocate Huzefa Ahmadi appearing for the Committee of Management of Anujman Intezamia Masjid, Varanasi, that it will keep the proceedings on the appeal filed by it pending till the District Judge adjudicate upon the objections filed by the mosque committee on the maintainability of the suit under Order 7 Rule 11 of CPC. It said, "You see everything depends on the application under Order 7 Rule 11 of CPC which has been filed before the district judge, Varanasi. If the district judge up-

holds the objections then nothing remains but if it rejects the objections then parties can avail the remedies provided under the law. As regard to the commission's report, you can very well raise it before the court that it should not be read in evidence".

Ahmadi accepted that there is a remedy under law but said that the High Court order upholding the appointment of a court commissioner cannot be passed.

"It is like a fruit from a poisonous tree. The order of commission survey was ex-facie beyond juris-

Senior advocate CS Vaidyanathan objected to the submission of Ahmadi and said that he is arguing on a civil suit and not a PIL, and he should focus his arguments on the subject matter of the suit.

Justice Surya Kant said that the court can direct the trial court to not rely on the commission report while deciding their objections.

Ahmadi said that the order of the High Court upholding the appointment of a court commissioner should be set aside. The bench then posted the matter for further hearing on October 20 and said that it would await the outcome of the proceedings before the district judge on the application filed by the mosque committee challenging the maintainability of the civil suit filed by Hindu devotees.

On May 20, the top court transferred the civil suit filed by Hindu devotees on Gyanvapi mosque from civil judge (senior division) to district judge, Varanasi saying looking at the "complexities" and "sensitivity" of the issue, it is better if a senior judicial officer having an experience of over 25-30 years handles this case.

SCHOOL BUS CATCHES FIRE

Narrow escape for 21 children

New Delhi, Jul 21: Twenty one children had a narrow escape after their school bus caught fire in northwest Delhi's Rohini Thursday, officials said.

According to fire officials, they received information about the incident at 2.14 pm following which three fire tenders were rushed to the spot. Delhi Fire Services director Atul Garg said the vehicle caught fire near a dispensary at Sai Baba Mandir T-point in Rohini Sector 7.

"The bus (tempo traveller) of Bal Bharati Public School carrying 21 children caught fire. All the kids and the driver escaped unhurt," he said. Police said that there was a fire in a bus at Rohini Sector 7 which comes under North Rohini police station.

"During inquiry, it was found that the mini bus was ferrying 21 students of Bal Bharati Public School, who were evacuated safe by its driver Sanjay Solanki, a resident of Pooth village," Deputy Commissioner of Police (Rohini) Pranav Tayal said. There was no casualty in the incident, the DCP said.

The bus driver said he noticed some foul smell coming from the engine of the bus. "Around 2.15 pm, when we reached Rohini Sector 7, I noticed that some foul smell was coming from the engine of the bus. I immediately took all the kids from the bus. After the children got down from the vehicle, it caught fire."

"One of my known persons was coming with his bus and I asked him to drop all the kids to their homes. I was alone today as the helper of the bus was unwell. All the students are safe and sound. The school authorities have asked me to meet them tomorrow morning," Solanki said.

K'taka: College students hold lip-lock challenge

Dakshina Kannada, July 21: The video of students of a reputed college kissing in the presence of other students at a private residence has gone viral on social media stirring a hornet's nest in Mangalore city in the coastal district of Dakshina Kannada in Karnataka.

N Shashikumar, Mangalore Commissioner of Police, stated Thursday that the incident had taken place 6 months ago in a flat in Mangalore. The students were playing a truth and dare game during the lip-lock competition.

One of the boys who was present had put the video on WhatsApp a week ago. It came to the notice of the school administration and the



authorities warned the students and suspended them, he said.

747 websites, 94 YT channels blocked in '21-22

'Can't deny abortion if woman is unmarried'

New Delhi, July 21: In a significant decision, the Supreme Court Thursday allowed the examination of a 24-week pregnant unmarried woman by an AIIMS medical board to determine whether the pregnancy can be safely terminated without endangering her life.

A bench headed by Justice DY Chandrachud said letting an unmarried woman suffer an unwanted pregnancy will be contrary to the object and spirit of the Medical Termination of Pregnancy (MTP) Act.

The top court asked the director AIIMS to constitute a medical board in terms of provisions of the MTP Act and in the event the board concludes that the foetus can be aborted without any danger to the life of petitioner, then AIIMS should carry out the abortion. The woman challenged Rule 3B of the Medical Termination of Pregnancy Rules, 2003, which allows only some categories of women to seek termination of pregnancy between 20 and 24 weeks.

The top court observed that it would be a restrictive interpretation of the MTP Act and Rules, to limit right of abortion of pregnancy exceeding 20 weeks only to married women. The bench said the petitioner should not be denied the benefit merely on the ground that she is an unmarried woman.

The bench said prima facie, quite apart from the issue of constitu-

Migrants play vital role in nation building: SC

New Delhi, July 21: Migrants play a very vital role in building the nation and their rights cannot be ignored at all, the Supreme Court said Thursday while asking the Centre to devise a mechanism so that they receive food grains without ration cards.

The top court said the welfare schemes devised by the Centre should reach a maximum number of workers and the state governments will have to cooperate and assist the Union of India.

"As far as our country is concerned, two people are very important. First is the farmer i.e the agriculturist and the second is migrant workers. Migrants also play a very important role in building the nation. Their rights cannot be ignored at all."



"Therefore you have to reach them. They may be illiterate and may not know how to avail benefits of government schemes. Concerned states will have to ensure benefits of the scheme reaches them," a bench of Justices M R Shah and B V Nagarathna said.

Additional Solicitor General Aishwarya Bhati, appearing for



GUJ GOVT CRACKS DOWN ON LOCAL OFFICIALS

Chhotaudepur (Gujarat), July 21: In a shocking incident, four school-going children were issued job cards, and bank accounts were opened in their names, under the Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) in Gujarat's Chhotaudepur district.

As the district administration learned about this, the District Development Officer has dismissed



the Gram Rozgar Sevak (GRS), issued notice to village sarpanch, and village's executive wing head Talati, of Kukarda village.

District Development Officer Ganga Singh told to IANS that GRS Lalji Dungarbhil had issued four job cards in the names of school children, a departmental inquiry was conducted and now he has been dismissed from service.

"Notices were issued to the village Sarpanch and Talati and both asked to give explanation... if they fail to give satisfactory explanation, action will be taken against them."

Talking to IANS, Ambalal, the husband of Kukarda village's sarpanch Gaunaben Ambalal Dungarbhil, said: "My wife is illiterate, so she signed the employment list prepared by GRS Lalji without verification.... Lalji

did not show the jobs cards with photos though she had so demanded, while signing documents... it is not her fault."

"I have learned from other villages about three job cards issued in the name of school going children, a boy studying in class X and two girl students studying in class IX, and their bank accounts were opened with Bank of Baroda's Tanakha village branch. At the most they were paid for a 25 to 26 days job."

After withdrawing the money, Lalji had even bought school stationery for children from the payment, and there is a possibility that children's parents might be involved in it, he alleged.

Thiruvananthapuram, July 21: A bus stop bench reduced to three separate seats as an alleged moral policing measure to prevent girls and boys from sitting together prompted students of both sexes from a nearby engineering college to sit on each other's laps and post pictures of the same online, resulting in the city mayor Thursday promising a modern gender neutral waiting facility there.

Thiruvananthapuram city Mayor Arya S Rajendran visited the area Thursday after the photographs posted on social media by the students of College of Engineering Trivandrum (CET) went viral.

However, the residents denied that the seats were deliberately separated into three to dissuade the students. The bench was converted into three seats as part of renovating the dilapidated structure

and keeping in mind Covid-19 guidelines to maintain social distancing, they claimed.

After visiting the area, the Mayor, in a Facebook post, said the manner in which the bench was cut into three seats was not only "inappropriate", but also "unbecoming of a progressive society" like that of Kerala.

She said that there is no ban on girls and boys sitting together in our state and those who still believe there should be such a prohibition are still living in ancient times. "One can only sympathise with those who do not understand that times have changed," she added.

Engineering students from CET, who were present when the mayor visited, told scribes that this was not the first time they were faced with such a situation.

They face moral policing on a regular basis whenever they are walking around in that area with a



friend of the opposite sex.

"We have been suffering this for a long time and therefore, we decided it was about time we reacted to it. We, of course, never expected the photographs to go viral. We were just attempting to ensure that such moral policing does not occur in future," they said.

They should understand there is nothing wrong with a boy and girl sitting together, the students said.

The residents of the area, on the other hand, said that none of them approve of the girls and boys sitting together at the bus stand starting from early morning hours to even late at night.

"This is a bus shelter we built for

people to wait for the bus. If they want to sit together, let them do so inside the college campus. We do not approve of their behaviour," some of the local residents told reporters.

Appreciating the stand taken by the CET students, Rajendran said a responsive generation is the hope for the future and the local authorities were with the students in the matter.

She further said the bus stand was dilapidated, unauthorised and lacking clearance from the Public Works Department and therefore, a new gender neutral one with modern facilities will be built there by the municipality.

Droupadi Murmu: From councillor to first tribal Prez-elect

New Delhi, July 21: President-elect Droupadi Murmu. The arc of triumph forged through personal tragedy is complete for the unassuming politician who started public life as a councillor in Odisha and will be written into history as India's first tribal president and the second woman in the post.

At 64, the woman who will be India's 15th president, taking over from Ram Nath Kovind, will also be the youngest and India's first President to be born after Independence. She will be sworn in on July 25.

The low-profile politician is believed to be deeply spiritual and a keen practitioner of the meditation techniques of the Brahma Kumaris, a movement she embraced after she lost her husband,

two sons, mother and brother in the just six years between 2009-2015.

"She is deeply spiritual and soft-spoken person," said Basant Kumar Panda, BJP leader and Lok Sabha member from Kalahandi. In an interview in February 2016 to Doordarshan, Murmu gave a glimpse into the tumultuous period of her life when she lost her son in 2009.

"I was devastated and suffered from depression. I spent sleepless nights after my son's death. It was when I visited Brahma Kumaris, I realised I had to move on and live for my two sons and daughter," Murmu had said.

In the month since she was nominated as the NDA's presidential candidate June 21, she has made no public statement.

The victory run seemed certain and her numbers were boosted

with support from a section of opposition parties such as the BJD, Shiv Sena, Jharkhand Mukti Morcha, YSR Congress, BSP, TDP. Some of these parties had earlier supported the candidature of the joint opposition candidate Yashwant Sinha.

Murmu travelled throughout the

country campaigning for the presidential election and was received warmly across state capitals.

Her first steps in politics were taken in Rairangpur where she was elected as BJP councillor in the Rairangpur Notified Area Council in 1997 and rose to being a minister in Odisha's BJD-BJP coalition government from 2000 to 2004. In 2015, she was appointed governor of Jharkhand and stayed in the post till 2021.

Murmu had contested the 2014 assembly election from Rairangpur, but lost to the BJD candidate. After completing her tenure as Jharkhand governor, Murmu de-

voted her time to meditation and social work in Rairangpur.

"I am surprised as well as delighted. As a tribal woman from remote Mayurbhanj district, I had not thought about becoming the candidate for the top post," Murmu had said after her selection as the presidential candidate.

The hurdles were several and the achievements many. Belonging to Mayurbhanj, one of the most remote and underdeveloped districts of the country, Murmu earned her Bachelor's degree in Arts from Bhubaneswar's Ramadevi Women's College in Bhubaneswar and served as a junior assistant in the irrigation and power department in the Odisha government. She also served as an honorary assistant teacher in the Shri Aurobindo Integral Education Centre in Rairangpur.

Murmu was awarded the Best Nilkanth Award for the Best MLA of the year in 2007 by the Odisha Legislative assembly.

She has diverse administrative experience having handled ministries such as transport, commerce, fisheries and animal husbandry in the Odisha government.

In the BJP, Murmu was vice president and later president of the Scheduled Tribe Morcha in Odisha. She was elected the district president of Mayurbhanj (West) unit of the BJP in 2010 and re-elected in 2013. She was also named member of the BJP National Executive (ST Morcha) the same year. She held the post of district president till April 2015 when she was appointed as the Governor of Jharkhand. Murmu's daughter Itishree works in a bank in Odisha.

Congress stages protest against ED across country

New Delhi, July 21: The Enforcement Directorate Thursday questioned Congress chief Sonia Gandhi for over two hours in a money laundering case related to the National Herald newspaper. The day was a show of strength for the party with street protests and leaders courting arrest across the country.

She has been summoned again July 25.

Thursday's session of questioning the 75-year-old, who is recovering from Covid, ended on her request after two hours and 15 minutes, officials said. However, Congress leader Jairam Ramesh said the ED told Sonia Gandhi that they had no further questions and she could leave.

Sonia Gandhi said she would be willing to respond to any other questions they might have and was ready to stay on till 8 pm or 9 pm if necessary, Ramesh tweeted.

She also said she was a Covid patient and needed to take her medicines so she should be informed about what time she should appear next. Sonia Gandhi replied to about 27 top 28 questions Thursday. Following this, she told the officials that she needs to take her medicines at home owing to her recent Covid recovery and the agency allowed ending the day's session.

According to sources, while the Congress chief was leaving, the ED asked her to depose July 26 but she suggested that she can come July 25, to which both sides agreed.

According to Ramesh, the ED said it had nothing to ask of her either Thursday or Friday. After which Sonia Gandhi said she was willing to appear Monday, Ramesh added. The questioning was conducted keeping in mind Covid protocol with everyone participating equipped with a Covid-negative certificate. An ambulance and two doctors from AIIMS were also stationed inside the ED office premises. Sonia Gandhi was ques-

tioned by the same assistant director-level investigation officer who interrogated her son Rahul Gandhi in the case related to alleged financial irregularities in the Congress-promoted Young Indian Private Limited, which owns National Herald. A woman officer was part of the questioning team.

The questioning began around 12:30 pm. Sonia Gandhi left the ED office along with her daughter around 2.30 pm. It is understood that Sonia Gandhi has been responding to ED's questions quickly compared to her son Rahul's sessions that went on for over 50 hours in five days.

The summons to the Congress chief took political centrestage in Parliament, where opposition leaders raised the issue, and on the streets with party workers staging massive protests.

CHINESE VILLAGE IN DOKLAM PLATEAU

India keeping a close vigil: MEA

New Delhi, July 21: India Thursday said it keeps a constant watch on all developments having bearing on national security, three days after new satellite images indicated the construction of a Chinese village east of the Doklam plateau on the Bhutanese side.

External Affairs Ministry spokesperson Arindam Bagchi, responding to questions at a media briefing on the images, also said that India takes all necessary measures to safeguard its security interests.

"I do not want to get into commenting on media reports. Let me make a broader point, particularly in the context of Doklam that please be assured that the government keeps a constant watch on all developments having a bearing on India's security and takes all necessary measures to safeguard the same," he said.

The images of the village emerged on Tuesday that showed the new settlement is fully inhabited with cars parked at the doorstep of virtually every home.

The Doklam plateau is considered an important area for India's strategic interest.

The Indian and Chinese armies were locked in a 73-day stand-off at the Doklam tri-junction after China tried to extend

a road in the area that Bhutan claimed belonged to it.

China has been ramping up border infrastructure in several sensitive locations including along the Line of Actual Control (LAC) in eastern Ladakh where the Chinese PLA has been locked in an over two-year standoff with the Indian Army.

In October last year, Bhutan and China signed an agreement on a "three-step roadmap" to expedite negotiations to resolve their festering boundary dispute.

Bhutan shares an over 400-km-long border with China and the two countries have held over 24 rounds of boundary talks in a bid to resolve the dispute. The two countries also held 10 rounds of negotiations at the 'Expert Group' level.

The Doklam tri-junction is considered important from the point of view of India's security interests. The India-China stand-off in the Doklam plateau in 2017 even triggered fears of a war between the two nuclear-armed neighbours. Bhutan said the area belonged to it and India supported the Bhutanese claim.

India had strongly opposed the construction of the road at the Doklam tri-junction as it would have impacted its overall security interests. The India-China face-off was resolved following several rounds of talks.

LS adjourned for the day

New Delhi: Lok Sabha proceedings were adjourned for the day Thursday following a request from the government that the Indian Antarctic Bill, 2022 be taken up for consideration when Opposition members are also present in the House. India's ties with Arab countries not affected

New Delhi, July 21: India's friendly relations with the Arab countries were not affected in view of the controversial comments made against Prophet Mohammad, the government informed the Rajya Sabha Thursday.

Minister of State for External Affairs V Muraleedharan also said that India continues to attach high priority to further strengthen relations with the Arab world and that it understands the outlook and views of New Delhi on the issue.

He was responding to questions on whether "hate speeches and defamatory" comments made by spokespersons of political parties in India have affected its relations with Arab countries and the government's response to the statement made against the Prophet.

"No. India shares historic and friendly relations with Arab countries which have strengthened significantly in the past few years in different domains, including political, trade and investment, defence, security, sci-

ence and technology, culture and people-to-people ties," Muraleedharan said.

He further added: "With regard to recent remarks the relevant political organisation has clarified its position. This has been duly recognised by Arab governments."

Last month, the BJP suspended its national spokesperson Nupur Sharma and expelled from the party its Delhi unit media head Naveen Jindal for allegedly making derogatory comments against

the Prophet.

To a separate question, Muraleedharan said Qatar, Kuwait, Pakistan, Iran, Indonesia, Malaysia and Azerbaijan summoned the Indian ambassadors in connection with the remarks on the Prophet.

"Our ambassadors conveyed that the remarks were made by individuals and do not, in any manner, reflect the view of the government of India. In line with our civilizational heritage and cultural traditions, India accords highest respect to all religions," the minister said.

Blantyre (Malawi), July 21: As the World Health Organisation announces the next step in its rollout of the world's first authorised malaria vaccine in three African countries, concerns about its value have come from an unlikely source: the Bill and Melinda Gates Foundation, arguably the vaccine's biggest backer. WHO endorsed the vaccine last fall as a "historic" breakthrough in the fight against malaria, but the Gates Foundation told The Associated Press this week it will no longer financially support the shot.

Russia resumes gas flows to Europe

London/Kyiv, July 21: Russian gas began flowing to Europe via a major pipeline Thursday after a 10-day pause but fears of broader supply cuts remained and Russian forces in Ukraine were seen eyeing the capture of the country's second biggest power plant.

Russian troops shelled cities across eastern and southern Ukraine, Ukrainian officials said, and hit two schools as Moscow's forces carried out limited ground operations in preparation for what is seen as a wider offensive. Reuters was unable to immediately verify Ukrainian assertions about Russian shelling, which they say has been intense for several weeks, and it was not immediately clear if anyone had been hurt in the strikes on the schools.

The resumption of gas flows via the Nord Stream 1 pipeline to Germany ended a nerve-jangling 10 days for Europe in which politicians expressed concern Russia might not restart them at a time when alternative energy supplies are tight and prices high. The pipeline has traditionally carried more than one third of Russia's gas exports to Europe but was operating at only 40% of its capacity after Kremlin-controlled Gazprom cut gas exports in a row over the repair of a turbine. "In view of the missing 60% (capacity) and the political instability, there is no reason yet to give the all-clear," Klaus Mueller, president of Germany's network regulator, wrote on Twitter. Power outage stops Ranil's oath ceremony



Colombo, July 21: A power outage in the Sri Lankan Parliament complex stopped the live broadcast of President Ranil Wickremesinghe's swearing-in ceremony, forcing authorities to launch an investigation by the Criminal Investigations Department into the incident, a media report said Thursday. Veteran politician Ranil Wickremesinghe was Thursday sworn in as Sri Lanka's eighth President and will face the tough task of leading the country out of its unprecedented economic crisis and restoring order after months of mass anti-government protests.

Wickremesinghe, 73, was sworn in as the 8th Executive President of Sri Lanka at the Parliament complex before Chief Justice Jayantha Jayasuriya. The Criminal Investigations Department will investigate the power outage that took place Thursday in the Parliament complex when the swearing-in ceremony of the newly elected President Wickremesinghe was proceeding, the Colombo Page web portal reported. The swearing-in ceremony of Wickramasinghe as the 8th



Executive President was scheduled to be telecast live by state-run Rupavahini and broadcast simultaneously by other television channels. However, the live broadcast stopped after the President entered the Parliament complex on the red carpet, the report added. It was later reported that the live broadcast was stopped due to a power outage in the Parliament complex. In the event of a power outage in the Parliament complex, the generators are usually switched on automatically within two minutes and it is reported that the power was out for about 10 minutes at the time of the swearing-in of the President. Due to this reason, TV channels could not telecast the swearing-in ceremony.



appears as a blob of red with white in its center, as part of a wider image of the distant cosmos called a "deep field." Mr Naidu and colleagues — a team totaling 25 astronomers from across the world — have submitted their findings to a scientific journal. For now, the research is posted on a "preprint" server, so it comes with the caveat that it has yet to be peer-reviewed — but it has already set the global astronomy community abuzz. "Astronomy records are crumbling already, and more are shaky," tweeted NASA's chief scientist Thomas Zurbuchen. "Yes, I tend

to only cheer once science results clear peer review. But, this looks very promising," he added. Mr Naidu said another team of astronomers led by Marco Castellano that worked on the same data has achieved similar conclusions, "so that gives us confidence." Work to be done One of the great promises of Webb is its ability to find the earliest galaxies that formed after the Big Bang, 13.8 billion years ago. Because these are so distant from Earth, by the time their light reaches us, it has been stretched by the expansion of the universe and shifted to the infrared region of the light spectrum, which Webb is equipped to detect with unprecedented clarity.

Mr Naidu and colleagues combed through this infrared data of the distant universe, searching for a tell-tale signature of extremely distant galaxies. Below a particular threshold of infrared wavelength, all photons — packets of energy — are absorbed by the neutral hydrogen of the universe that lies between the object and the observer. By using data collected through different infrared filters pointed at the same region of space, they were able to detect where these drop-offs in photons occurred, from which they inferred the presence of these most distant galaxies. "We searched all the early data for galaxies with this very striking signature, and these were the two systems that had by far the most compelling signature," said Mr Naidu. One of these is GLASS-z13, while the other, not as ancient, is GLASS-z11. "There's strong evidence, but there's still work to be done," said Mr Naidu.

Gold prices hit over 1-year low

New Delhi: Gold prices touched a more than one-year low Thursday, as the prospect of aggressive policy tightening by major central banks weighed on the non-interest-bearing metal's appeal, while investors awaited European Central Bank's policy announcement. Spot gold fell 0.8% to \$1,682.67 per ounce by 0920 GMT, after hitting its lowest level since March 2021. US gold futures fell 1.1% to \$1,681.00. The ECB was earlier signalling a 25-basis-point interest rate hike at its policy meet Thursday.

IndusInd shares jump over 8%

New Delhi: Shares of IndusInd Bank climbed 8 per cent Thursday after the company reported a 60.5 per cent jump in net profit for the June quarter. The stock jumped 7.88 per cent to settle at ₹948.15 apiece on the BSE. During the day, it advanced 9.36 per cent to ₹961.20. On the NSE, it rallied 8.09 per cent to settle at ₹950.50 apiece. The company's market valuation advanced by ₹5,368.36 crore to ₹73,491.36 crore on the BSE. It was the biggest gainer on both the BSE Sensex and NSE Nifty.

China fines Didi \$1.2bn post probe

Beijing: China has fined ride-hailing giant Didi 8.026 billion yuan (\$1.2 billion) for breaking its cyber security laws, the media reported. On Thursday, the Cyberspace Administration of China (CAC) said that it had found "conclusive evidence" against the company, the BBC reported. The regulator announced that it had started an investigation into Didi just days after the firm launched its shares in the US last year.

Reliance, Valentino sign agreement

Milan: Italian fashion house Valentino will open its first mono-brand stores in India after signing a distribution agreement with the country's biggest retailer Reliance, the companies said in a joint statement Thursday. Though small for a country of its size, India's luxury market is set to be one of the fastest growing in the industry. It will nearly double in size to almost \$5 billion within five years, Euromonitor estimates. New Delhi, July 21: Asian Development Bank (ADB) Thursday trimmed India's economic growth forecast for current fiscal year to 7.2 per cent from 7.5 per cent as pandemic and war impact is weighing down alongside inflationary pressures.

"India has been hit by the omicron Covid-19 variant and the economic impact of the war in Ukraine. Consequently, GDP growth for FY2021 is revised down from 8.9 per cent to 8.7 per cent and from 7.5 per cent to 7.2 per cent for FY2022 (fiscal to be ending in March 2023).

"Although consumer confidence continues to improve, higher-than-expected inflation will erode consumer purchasing power," ADB said in its supplement to the Asian Development Outlook (ADO) for 2022 released Thursday.

India Inc inks 1,149 deals worth over \$104bn in H1

Mergers and acquisitions deal values recorded an over two times increase over H1 2021

New Delhi, July 21: India Inc signed 1,149 deals valued at \$104.3 billion in the first half of this year, amid global uncertainties, and the country saw \$6 billion from 17 IPOs - the highest values raised in the first six months, a report showed Thursday.

The figures represent a significant 34 per cent increase in the overall deal volumes, while deal values more than doubled (with a 143 per cent increase) from the same period last year, according to the Grant Thornton Bharat Dealtracker report.

Driven by HDFC Bank and HDFC Ltd's \$40 billion merger, LTI and Mindtree merger (\$17.7 billion) and Adani Group-Holcim Ltd's \$10.5 billion deal. These three deals alone accounted for 86 per cent of the total M&A deal values in H1 2022.

While private equity deal activity continued to dominate total deal volumes with 3/4th share, deal values were driven by mergers and acquisitions with 76 per cent of the total deal values in H1 2022.

The M&A space witnessed a significant increase in the first half, witnessing 284 deals while representing a 27 per cent growth over H1 2021. The banking and financial sector had the highest contribution of 53 per cent in terms of over-

That speculation overlooks the reality that the two-time former World Cup winners have been consistently poor in the 50 overs-per-side format for several years.



PAK PACE GREAT AKRAM WANTS ODIs SCRAPPED

London: Pakistan pace bowling legend Wasim Akram feels ODI cricket has become "run-of-the-mill" stuff now and wants the administrators of the game to scrap the format for good. Akram's comments came close on the heels of England all-rounder Ben Stokes' sudden retirement from ODIs, which has triggered a serious debate over the existence of 50-over cricket. "I think so (ODIs should be scrapped). In England you have full houses. In India, Pakistan especially, Sri Lanka, Bangladesh, South Africa, one-day cricket you are not going to fill the stadiums," he said in Vaughany and Tuffers Cricket Club podcast. Akram said the 50-over game has no future in front of the ever-growing T20 format. "T20 is kind of easier, four hours the game is over. The leagues all around the world, there is a lot more money - I suppose this is part and parcel of the modern cricket. T20 or Test cricket. One-day cricket is kind of dying." For Akram, Test cricket remains the pinnacle of the game for a player. "There's a battle within the battle in Test cricket. I always preferred Test matches. One-day used to be fun but Test matches were where you were recognised as a player ... where people still pick you for the world XIs," he said.

FIH delegation to visit India Aug 15

NEW DELHI: A three-member FIH delegation, led by newly-appointed acting president Seif Ahmed, is expected to visit India August 15 for an emergency meeting to assess progress made with regards to adoption of a new Constitution, which is a must to salvage the World Cup, the country is scheduled to host in 2023. "Asia Cup will be in UAE, as it is the only place where there won't be rains," Ganguly told reporters. Sri Lanka Cricket Wednesday had informed the Asian Cricket Council that the board will not be in a position to host the upcoming edition of the Asia Cup T20 because of the economic and political crisis in the country.

Rahul tests Covid +ve

MUMBAI: Star India batter KL Rahul Thursday tested positive for Covid-19, which is likely to rule him out of the upcoming five-match T20 series against the West Indies, starting July 29 at Tarouba. BCCI president Sourav Ganguly informed about Rahul after the Board's Apex Council meeting here. Rahul Thursday itself had addressed the candidates, who attended the Level-3 coach certification course at National Cricket Academy in Bangalore. Rahul, who underwent a hernia operation in Germany recently, was rested for the ODI series against the West Indies starting Friday at Port of Spain.

Stay or go? Ronaldo's future uncertain at Manchester United

Manchester, July 21: The weekly social media posts published by Cristiano Ronaldo this off-season typically have shown the soccer superstar half-dressed, muscles bulging, either working out or promoting one of his

many brands. Remaining relevant and highly visible is clearly so important to the player who, along with Lionel Messi, is the greatest of his generation. That also extends to the final years of his career on the field, too.

It's why, for the 37-year-old Ronaldo, playing for Manchester United — still one of the world's most famous sports teams, de-

spite their recent trophy drought — just isn't enough. He wants to be competing on the biggest stage, winning the biggest trophies while he can.

Hence the current standoff with United, which is becoming more damaging and disruptive as the days go by and the new season looms.

Publicly, Ronaldo has not yet returned to preseason training with the English club because of what has been described as "personal reasons." The expectation, recently hired United manager Erik ten Hag repeats on an almost-daily basis, is that Ronaldo will be back before the Premier League begins and be a key

member of the squad. The reality, it seems, is dif-

ferent. Ronaldo reportedly wants out after just one season back at Old Trafford, with United no longer in the Champions League or in shape to compete with the best teams in England like Manchester City and Liverpool. United finished sixth last season, 35 points behind first-place City. So, while the rest of the United squad has been on tour in Thailand and Australia, getting match-sharp and acquainted with ten Hag and his methods, Ronaldo has been back home in Portugal with his family while his agent, Jorge Mendes, shops around seeking a new club for his most famous client.

Currently, there is no buyer. And the Premier League season starts in about two weeks.

"I don't know what Cristiano said to the club and to the manager," said United midfielder Bruno Fernandes, who also plays alongside Ronaldo for Portugal. "I don't know what's going on in his head, if he wants to leave. I did-

n't ask them that. "From everything we know," Fernandes added, "he had some family problems so we have to respect his space, give him some space and that's it. The only thing I asked Cristiano when he didn't turn up was if everything was OK with the family. He told me what was going on, that's it and nothing more."

Bayern Munich is another team to have reportedly turned down the chance to sign Ronaldo. There has been no desire from Real Madrid or Juventus to go back in for him, either.

Ronaldo's wage demands are likely ruling out most of the other clubs competing in this season's Champions League, a competition in which he is the record scorer with 141 goals — 16 more than Messi — and for which he lives.

It leaves Ronaldo in an awkward spot. Still one of the greatest scorers in soccer but a player unwanted by the best teams.
