### Cong show-cause notice to Moqim

### New York reports 1st polio case in a decade

**New York:** An unvaccinated young adult from New York recently contracted polio, the first US case in nearly a decade, health officials said Thursday. Officials said the patient, who lives in Rockland County, had developed paralysis. The person developed symptoms a month ago and did not recently travel outside the country, county health officials said. The last such case was in 2013, when a 7-month-old who had recently moved to the US from India was diagnosed in San Antonio, Texas, according to the federal health officials.

# CBSE pass percentage dips

Pass percentage of Class X students dips by 4.64, even as the number of students scoring above 90% and 95% witnesses a jump

**New Delhi, July 22:** Girls outperformed boys in Central Board of Secondary Education (CBSE) Class X and XII exams, the results of which were declared Friday. However, the pass percentage for both the classes has witnessed a decline.

As per CBSE sources, the pass percentage of the Class X students dipped by 4.64, even as the number of students scoring above 90 per cent and 95 per cent witnessed a jump as against last year's figure.

Likewise, girls also outshone boys in Class XII CBSE exam even as the overall pass percentage dipped from last year's 99.37 per cent to 92.71 per cent, officials said Friday.

The CBSE had recorded the highest-ever pass percentage of 99.04 in Class X exam last year. However, the results last year were announced on the basis of an alternative assessment scheme as the exams could not be conducted due to

Covid-19.

The pass percentage for Class X this year stands at 94.4, which is 4.64 per cent lower than last year's 99.04. The difference between the pass percentage of girls and boys was 3.7 last year.

While the pass percentage of girls stood at 95.21, that of boys and transgender candidates was 93.8 and 90 respectively.

Over 21.09 lakh regular candidates had registered for the Class X exam this year, of whom 20.93 lakh

had appeared in it.

The number of candidates scoring above 95 per cent has increased by over 7,000, with 64,908 students

falling in the bracket. Similarly, the number of students scoring between 90 and 95 per cent has gone up by over 36,000 from last year's 2,00,962. A total of 2,36,983 candidates have scored between 90 and 95 per cent this year. The number of children with special needs scoring above 95 per cent is 63, while 290 students in the category have scored above 90 per cent. In the CBSE-affiliated schools abroad, 97.29 per cent students have passed Class X. **CONTD...P4**

### SHREYA SHINES WITH 100% SCORE IN CLASS X



**BHUBANESWAR:** Shreya Pattnaik of Mother's Public School here secured 100 per cent marks in all subjects in Class X exam as the results of CBSE Class X and XII annual examinations were declared Friday. Shreya said she was expecting good marks but she was surprised to see 100 per cent in every subject. The topper said she had focused on self study with the help of parents. "After school hours, I used to spend three-four hours on self study. More than quantity, I believe in quality study." Shreya aims at pursuing medical studies. Meanwhile, CBSE's Bhubaneswar region's pass percentage stood at 90.37 per cent for Class XII and 96.46 per cent for Class X.

### Dinesh Gunawardena Sri Lanka's new PM

**Colombo, July 22:** Dinesh Gunawardena, a hard-core leftist leader whose family has a connection with India, became Sri Lanka's Prime Minister by a quirk of fate at a time when the country is grappling with unprecedented economic and political turmoil.

A stalwart of Sri Lankan politics, Gunawardena was appointed as the Prime Minister Friday, a day after Ranil Wickremesinghe was elevated to President's post.

Gunawardena, 73, earlier served as the foreign minister and education minister. He was appointed as Home Minister in April by then President Gotabaya Rajapaksa.

A schoolmate of President Wickremesinghe, Gunawardena, has held various Cabinet posts in the past. Born in 1949, Gunawardena is the leader of the Trotskyist majority nationalist Mahajana Eksath Peramuna (MEP), a constituent party of the ruling Sri Lanka Podujana Peramuna party.

# Oppn bats for scribes' entry into Assembly

**Bhubaneswar, July 22:** Opposition members Friday created a ruckus in the Assembly demanding entry of journalists into the press gallery of the House.

Raising the issue during question hour, the opposition MLAs demanded the lifting of the restrictions imposed on mediapersons and allowed all MLAs to sit inside the House.

The Question Hour of the Assembly was completely washed out as Congress and BJP trooped into the well of the House, shouted slogans and disrupted the proceedings of the business of the house. Unable to run the business, Speaker BK Arukha convened an all-party meeting adjourning the House till 11:30am. As mediapersons are not allowed to the press gallery, they are unable to report the proceedings correctly, said BJP chief whip Mohan Charan Majhi.

"When the Rath Yatra was conducted with the participation of lakhs of people and the Parliament started functioning normally, why the journalists will not be allowed into the press gallery?" he asked. Majhi said some of the members are being treated as second-class citizens as they were asked to sit in galleries and demean their dignity.

Congress member Tara Prasad Bahinipati demanded the Speaker to allow mediapersons to sit in the press gallery to cover the

proceedings. He also urged the Speaker to allow other members to sit in the House like during the pre-Covid period.

His party colleague, Jayanarayan Mishra said except for Odisha, the Assemblies in other states are functioning normally and wanted the Speaker to initiate steps for the normal functioning of the Assembly.

Congress MLA Santosh Singh Saluja said the Parliament is functioning normally even though its strength is three times more than the Odisha Assembly. He urged the Speaker to give a ruling to allow the mediapersons to the press gallery.

Congress MLA Suresh Chandra Routray said it is very unfortunate that the statement of senior BJD member Prafulla Samal during the debate for demand for grants Thursday was disrupted due to a technical snag.

Laxman Munda of CPI (M) also demanded the Speaker to ensure that the MLAs sitting in the gallery come to the House and allow the mediapersons to the press gallery.

Keeping the safety of members in view of Covid-19 pandemic, the seating arrangements of MLAs and journalists were taken up at the all-party meeting, said the Speaker.

With only a few days are left for the current session to end, a decision on lifting the restriction on media will be taken in the next session, considering the situation prevailing then, he added.

# Suriya, Devgn share Best Actor award

Devgn shared the Best Actor award with Suriya, who got it for "Soorarai Pottru". The film, inspired by the life of Air Deccan

founder Capt GR Gopinath, also won Aparna Balamurali the Best Actress prize.

The Bollywood star, who has previously won the National Film Award for Best Actor for his performances in "Zakhm" (1998) and "The Legend of Bhagat Singh" (2002), said he was elated to receive the honour for the third time.

"Soorarai Pottru" also won Best Screenplay for Shalini Usha Nair and director Sudha Kongara as well as Best Music Direction (Background Score) for GV Prakash Kumar.

The late Malayalam filmmaker Sachidanandan KR was posthumously named Best Director for "Ayyappanum Koshiyum", which also won Best Supporting Actor for Biju Menon, Best Action Direction (Stunt Choreography) and Best Playback Female Singer for Nanchamma. **CONTD...P4**

## I've been noticed for my debut movie: Manushi







# CBSE RESULTS Euphoria as City students come out with flying colours

Several schools in the Capital city registered 100 per cent results in the Class X and XII examinations

**Bhubaneswar, July 22:** Students of many schools in the capital city here came out with flying colours in the Central Board of Secondary Education (CBSE) Class X and XII examinations, whose results were declared Friday.

Mother's Public School's Shreya Pattnaik topped the CBSE Class X examination in Odisha by securing full 500 marks. On the other hand, Karan Pattanaik and Amlaan Akshay Anshu Sahoo topped the Class XII Science stream with 98.80 per cent while Prateek Pratyush Dash topped the Commerce stream with 97.40 per cent in the school. The school registered 100 per cent pass in the examinations.

At SAI International School, Suhana Jena is the Class X school topper with 99.8 per cent, followed by Adyasha Syam with 99.4 per cent and Janisha Karan with 99.2 per cent.

In Class XII, Subhrasikha Pradhan, Kashish Agrawalla and Khushi Agrawalla are the school toppers with 98.8 per cent in Commerce stream, followed by Abhipsha Padhi and Sandhya Priyadarshini Pattanaik with 98.6 per cent in Science stream.

The school also registered 100 per cent pass percentage.

In Class XII, Shristi Agarwal topped the Commerce stream with 99.2 per cent while Manisha Sahoo topped the science stream with 99 per cent. ODM Public School too registered a full pass percentage.

With 499 marks (99.8 per cent) in Class X exam, Amrit Kumar Ghoshal is the topper in Buxi Jagabandhu English Medium School.

In Class XII, Rajesh Kumar Jena topped the Science stream with 97.8 per cent, while Rakshita Patnaik topped the Commerce stream after securing 95 per cent.

At DAV Public School, Unit-VIII, Bhoomika Das, Sai Shreyansh Panda and Swayam Prakash Pani were the school toppers by securing 499 marks (99.8 per cent) in Class X exam. In Class XII, Soumya Subhrakanti Swain topped the Science stream with 98.40 per cent, while K Rohit 97.80 per cent in Commerce stream.

The students of ST. Xavier's High School did well in the CBSE Class X examination with Tuhin Samantaray scoring 98.8 per cent.

The school also performed well in the Class XII examination. Barennya Mohapatra secured 97.8 per cent in the exam, school sources said.

# Reforms led to fall in power sector losses: Deb

The aggregate technical and commercial losses in power sector have come down to 26 per cent in 2022 from 57 per cent in 2000, claimed Energy Minister Pratap Keshari Deb

**Bhubaneswar, July 22:** The aggregate technical and commercial (AT&C) losses in power sector have come down to 26 per cent in 2022 from 57 per cent in 2000 in Odisha due to the introduction of reform measures, said Energy Minister Pratap Keshari Deb in the Assembly Friday.

In a written reply to a query of Gopalpur MLA Pradeep Panigrahy, Deb said Odisha is the first state in the country to implement power sector reforms with the enactment of the Orissa Electricity Reform Act, 1995.

Odisha is now a power surplus state due to the reform measures introduced by the state government. Around 2,000 MW power generation capacity has been added in the last two decades in the form of 1,320 MW thermal capacity by OPGC, 560 MW of renewable energy capacity and 109 MW of small hydro-power capacity, he said.

transmission system availability which is one of the best in the country, said the Energy Minister.

He further informed that around 97 per cent households in the state have been electrified under various schemes launched by the Centre and state government.

Odisha has one of the lowest power purchase cost with no retail tariff hike from the financial year 2002 to 2010. The retail tariff has been increased by Rs 2 in last 20 years and by only 80 paise in last 8 years. Industrial tariff in the state is also amongst the lowest in the country, Deb claimed.

Stating that the state government is prioritising the use of renewable energy, the Energy Minister claimed that Odisha has been able to meet 98 per cent of the RPO target in FY 2021-22.

"Odisha has set examples in the restoration of power supply in quickest possible time following cyclonic storms like Phailin, Hudhud, Fani, Amphan and Yaas," he said.

## Export turnover more than doubled in last 5 yrs: Govt

**Bhubaneswar, July 22:** State's export turnover has more than doubled during the last five financial years, MSME Minister Pratap Keshari Deb told the state Assembly, Friday.

Replying to an unstarred question of BJD legislator Dhruba Charan Sahoo, the Minister said the total export turnover from Odisha was Rs 52,677.09 crore in the financial year 2017-18, which was increased to Rs 1,27,197.66 crore during 2021-22.

Barring the financial year 2018-19, the export from the state recorded a positive growth on each passing year, he said.

The total export from the state stood at Rs 48,119.60 crore in 2018-19, which was increased by 7.53 per cent to Rs 51,742.32 crore in 2019-20 and again by 55.42 per cent in

2020-21 to Rs 80,419.33 crore. Further, the export turnover from Odisha witnessed a growth of 58.17 per cent during the last financial year.

As per the reply, metallurgical, minerals, engineering/chemical allied, marine and software products are the major contributors to the state's export turnover.

Odisha has exported metallurgical products worth Rs 86,726.64 crore, minerals of Rs 19,374.27 crore, engineering/chemical allied products of Rs 15,496.37 crore and Rs 4,462.08 crore marine products during the last year.

To enhance exportation from Odisha, the state government has been implementing the Odisha Export Policy-2014 and also drafted required amendments to the policy, which is under examination now, said the minister.

At least 146 children were among the fresh patients, it said. The death toll remained at 9,130, as no new fatality due to the infection was reported in the last 24 hours, the bulletin said.

Khurda district, which comprises the state capital Bhubaneswar, registered the highest number of new infections at 252, followed by Sundargarh (194), Sambalpur (111) and Cuttack (104).

Odisha now has 7,245 active cases, while 12,87,941 people have recovered from the disease, including 1,026 in the last 24 hours, the bulletin said.

Fifty-three other Covid-19 patients have died due to comorbidities so far, it said.

The test positivity rate was 5.15 per cent as the new cases were

detected from 22,873 sample tests, the bulletin added.

Notably, the Bhubaneswar Municipal Corporation (BMC), Cuttack Municipal Corporation (CMC), Berhampur Municipal Corporation (BeMC) and a few other civic bodies have made wearing of masks mandatory for residents and visitors under their jurisdictions in the wake of the recent surge in Covid-19 cases in the state. The civic bodies also asked the people to maintain social distance at public places.

This apart, authorities of shopping malls and shopkeepers have been asked to ensure strict adherence to Covid-appropriate behaviour on their premises. Government as well as private offices have also been asked to follow all precautionary measures to check the spread of Covid-19.

The civic authorities in Bhubaneswar have recently opened vaccination centres at three shopping malls to administer free precaution dose of Covid-19 vaccines to the eligible people.

**WB arm to aid Odisha in asset monetisation**

**Bhubaneswar, July 22:** The state government and an organisation of World Bank (WB) have joined hands for implementation of asset monetisation and recycling programme, an official release said Friday.

It is part of a wider World Bank technical assistance to support Odisha in monetising existing public sector assets and enhance the state's economic growth, it said.

A memorandum of understanding was signed between the state Industries department and the International Finance Corporation (IFC), an organisation of World Bank, in Bhubaneswar Friday.

The programme will facilitate the monetisation process in the

state by unlocking the value from large-scale public investment in the brownfield infrastructure assets and bringing in sector efficiencies, Industrial Promotion and Investment Corporation of Odisha (IPICOL) said.

The IFC will support the state in screening and developing a prioritised list of monetisable brownfield state-owned assets for select sectors. The list will be screened further to identify bankable pilot projects that may be taken to market for attracting private sector investments, the state agency said.

Power transmission, energy generation, including renewable and large hydroelectric ones, highways and transport-related land infrastructure assets, warehousing are among the pilot projects.

**State's health budget doubled in 3 years: CM**

**Bhubaneswar, July 22:** Chief Minister Naveen Patnaik said Friday that the state health budget doubled in the past three years as his government was committed to provide universal access to quality medical services.

The budget provision during the 2019-20 financial year was more than Rs 6,800 crore and it rose to over Rs 12,000 crore this fiscal, Patnaik said.

"This is more than six per cent of the state plan," Patnaik said during a virtual interaction with new medical officers in the Lok Seva Bhavan here. He underlined that the objective was to provide quality, universal access and affordable healthcare by bringing down expenses. At least 358 allopathic and 116 homoeopathic medical officers as well as 36 homoeopathic lecturers joined the Health department.

**India's preventive healthcare sector to reach \$197bn by 2025: Report**

India's preventive healthcare sector, which includes fitness and wellness, foods and supplements, early diagnostics and health tracking among others, is projected to reach \$197 billion by 2025, accounting for approximately 36 per cent of the overall healthcare industry, said a report Thursday.

According to the report by strategy consulting firm Redseer Strategy Consultants in collaboration with Chiratae Ventures and Amazon Web Services (AWS), India has traditionally focused on curative care as opposed to preventive care. However, since the Covid-19 pandemic, preventive care has increased in importance across India, growing at a Compound Annual Growth Rate (CAGR) of 22 per cent during 2022-25, as compared to 15 per cent for the curative sector.

A survey conducted with over more than 1,000 individuals reveals that at least 40 per cent of the respondents were highly inclined towards preventive health. Another survey conducted with a group of over 300 health-conscious individuals (HCIs) showed that they actively track different aspects of their health such as lifestyle,



physical wellness, and more, to maintain and prolong wellness.

Further, the report revealed that these HCIs spend on an average between Rs 4,000 and Rs 10,000 on various preventive healthcare practices annually and are also willing to pay up to 50 per cent more in the future.

"India is looking to effectively deliver quality healthcare to a bil-

lion people through rapidly evolving technology that can provide affordable, accessible and personalised healthcare," said Sudhir Sethi, founder and chairman Chiratae Ventures.

More than 40 preventive healthcare technology (HealthTech) startups have raised approximately \$1 billion in funding over the last three years to tap the preventive

health opportunity across segments such as nutrition management, condition management, lifestyle monitoring, health checkups, and mental and physical wellness.

They are leveraging cloud computing to build and scale their applications, which generate, digitise and analyse vast amounts of health data using advanced technologies such as Internet of Things (IoT), data

They mixed it up with flattened rice and consumed it. Minutes later, all the four started vomiting continuously and were admitted to the district headquarters hospital.

## Unexpected Moves

Himachal Pradesh, which is going to the polls shortly, has got a new chief secretary. Ram Dass Dhiman, a 1988-batch IAS officer, got the coveted post after the incumbent Ram Subhag Singh surprised many by quitting and applying for another sought-after post of state Chief Information Commissioner. But apparently, for insiders and those in the know, Singh had started showing interest in vying for the new post almost a year ago giving ample time to Chief Minister Jai Ram Thakur to find his replacement. Since Subhag had become the chief secretary in August last year, it is apparent that he began planning his move almost immediately after taking over as chief secretary!

Meanwhile, the search for his successor has been a convoluted one. Dhiman has been chosen over three IAS officers including, interestingly, Subhag's wife Nisha Singh! The other superseded officers are Ali Raza Rizvi and Sanjay Gupta. The supersession is awkward especially given the superb track record of those overlooked.

In the wake of Dhiman's appointment, Nisha Singh has now been named as the principal advisor (training) while Sanjay Gupta has been appointed as the principal advisor (redressal of public grievances). Subhag has still a year of service remaining and will bide his time as the principal advisor (administrative reforms) while he waits for his wish to become the state's new chief information commissioner to fructify.

### Promotions spark off IPS row in Haryana

The promotion of several IPS officers in Haryana has triggered a row over the "legal aspects" of the order.

DKB has learnt that a DIG-level IPS officer Hamid Akhtar, who is among those who have been promoted, has asked the state government to modify his promotion order and give it effect nearly six months prior to the order's issuance date. He reportedly sent a representation to the ADGP Crime Branch OP Singh two weeks ago requesting him to raise the issue with the state Director General of Police (DGP) PK Agrawal, who is the final authority on the matter.

Those in the know say that Akhtar's request is not without precedent. Apparently, it is similar to the request of a few other IPS officers who were promoted in 2015, 2017 and 2018 with "immediate effect" while other IPS officers were promoted with "retrospective effect." Akhtar was promoted to DIG with effect from May 26 this year, but according to him, he should have been promoted with effect from January 1 this year. Watch this space for updates.

### Quiet change of guard at Niti Aayog

It's more than a Second Coming for Parmeshwar Iyer, the former IAS officer who has quietly taken charge as the new CEO of Niti Aayog, the government's premier public policy think tank. He has replaced Amitabh Kant who completed his extended tenure last month and has now moved on to steer the G20 deliberations as India's sherpa.

Iyer, many will recall, is a former IAS officer who has over 25 years of experience in the water and sanitation sector in both the public and private sectors. The 1981-batch officer from the Uttar Pradesh cadre served as Secretary in the Department of Drinking Water and Sanitation and also worked as a water and sanitation specialist for the World Bank after retiring from the IAS in 2009. In 2016, Prime Minister Narendra Modi summoned him out of retirement to spearhead the flagship Swachh Bharat Mission, which successfully delivered access to safe sanitation to 550 million people.

As CEO of Niti Aayog, Iyer who has rich experience in policymaking will now lead the Aayog's efforts to catalyze economic development and foster cooperative federalism through the involvement of state governments of India in the economic policymaking process using a bottom-up approach.

Will Iyer's low-key approach be as effective as his predecessor's, who had built a larger-than-life image of the bureaucrat as a celeb thinker? We'll wait and see.

### Unitasker

A unitasker is a tool or device that does only one thing. Before it meant that, it was a dismissive term for a person who does one job at a time before moving to the next, the opposite of a multitasker. It's one of those slow-burn words that seems to be creeping up on us in a variety of fields, becoming accepted because it's a useful term of abuse to describe those gadgets we buy because they seem like a good idea at the time. This is despite experience teaching us that their advantages don't justify their cost or the space they take up or that a general-purpose item could do the job as well. It's used in particular for specialist kitchen gadgets (electric gravy boat warmers, strawberry slicers, watermelon knives) and odd computing contraptions (USB foot warmers). Unitasker has been popularised by the American TV chef Alton Brown and the website unclutterer.com. Not all unitaskers are bad, of course; some of them are invaluable and their limitations are a strength, not a weakness. What's wrong with a fire extinguisher? It does one job well. (OK, you can use it to prop the door open or brain a burglar, but we're talking about intended uses here.) And one person's useless unitasker is another's onion-ring holder or USB fragrance oil burner. While I'm skeptical of tools intended for only one purpose, I like the Kindle because it's a unitasker. You can't really use it for the Web or Twitter or e-mail: It's for reading and that's it (Macworld, Dec. 2010).

### Unobtainium

The name, often also spelled as unobtainum, combines unobtainable with the -ium suffix that marks the names of chemical elements. It goes back several decades. This is how it was defined in one of its earliest appearances: A substance having the exact high test properties required for a piece of hardware or other item of use, but not obtainable whether because it theoretically cannot exist or because technology is insufficiently advanced to produce it. -- Interim Glossary, Aero-Space Terms, by Woodford Hefflin, Feb. 1958. The word had obviously been around for a while in aeronautics circles. The first known reference is in a newspaper in Michigan in February 1956, but it came to wider notice as the result of this syndicated news article 18 months later: A officer at Wright-Patterson Air Force Base has disclosed specifications of the ultimate material sought by the Air Force. He is Maj. Gen. William O. Senter, chief of procurement and production, who describes it this way: It must be practically weightless, infinitely strong, resist any degree of heat, mill, machine, cast, and stand forging with great ease and be available at negligible cost. "We haven't found this material yet," Gen. Senter says, "but we do have a name for it. We call it 'unobtainium.'" -- The Zanesville Signal (Ohio), 9 Nov. 1957.

# A DANGEROUS DESCENT

## FOCUS AMERICA

The mass shootings that regularly disrupt American life should not be viewed simply as random acts. They reflect a steady unraveling of the sovereign authority of the state. Sovereignty, as the ultimate claim to authority, insists on at least two precepts: indivisibility and a monopoly on the legitimate exercise of force. Only the state, through its police power, is permitted to use violence in the state's defense (whether from foreign attack or from domestic terror and criminality).

**A LOSS OF FAITH IN STATE POLICE POWER IS DANGEROUS, NOT LEAST BECAUSE IT INVITES SELF-RELIANCE IN RESPONSE TO PERCEIVED INSECURITY OR INJUSTICE**

A loss of faith in state police power is dangerous, not least because it invites self-reliance in response to perceived insecurity or injustice. When the state is no longer trusted to provide security and justice – to preserve the fabric of society – self-reliance represents a potential rival to the state's sovereignty.

Historically, the emergence of fascist political movements has been associated with a parallel rise of private militias: Mussolini's Blackshirts, Hitler's Brownshirts, the Brazilian Greenshirts, and Irish fascist leader Eoin O'Duffy's Blueshirts.

In the United States today, isolated acts of domestic terror coexist alongside more organised forms of violence. Between the January 6, 2021, insurrection at the US Capitol, the surge of gun sales to an already weapons-saturated public, and the growth and normalisation of extreme right-wing political organisations and militias, there is ample evidence of an accelerating breakdown of shared belief in state sovereignty.

Right-wing "deep state" conspiracy theories and the Republican Party's lies about election rigging reflect a common purpose: to challenge the legitimacy of the state. As that challenge spreads through traditional and social media, non-state sources of violence become increasingly acceptable. Violence is simultaneously condemned and romanticised. Again, this is a familiar pattern in the rise of fascism.

Pervasive violence is self-reinforcing. It demonstrates that the old sovereignty is dead or dying,

and thus no longer capable of preserving the indivisibility of sovereign power or maintaining its monopoly on the legitimate use of force. From that premise, it follows that a viable counterforce must enter the fray. As Donald Trump put it January 6, "If you don't fight like hell, you won't have a country anymore."

Flooding the market with guns – like flooding the marketplace of ideas with "shit" (as former Trump adviser Steve Bannon has advocated) – amplifies social instability. As confusion and fear grow, the forces of reaction gain strength. Those in fear might not be willing to exercise violence themselves, but they will increasingly embrace those who are willing to do so on their behalf.

The best way to shield liberal democracy against this growing threat is to mobilise the institutions that still function: the press, peaceful assembly, and the electoral process. But this must happen quickly, because all three are increasingly at risk. Facebook, Twitter, and TikTok are now our dominant sources of news; but, owing to their "attention economy" business models, profit has priority over truth. Because lies

spread faster and hold attention longer than facts, they ultimately are worth more to companies that depend on users' attention time for advertising.

Meanwhile, the right of public assembly is being threatened by new state laws that open the door to committing violence against peaceful protesters. In Oklahoma, for example, drivers who strike – or even kill – someone with their car will no longer be held liable if they are "fleeing from a riot ... under a reasonable belief that fleeing was necessary to protect the motor vehicle operator from serious injury or death." The same measure also creates new penalties for protesters who obstruct streets or vehicle traffic, including fines of up to \$5,000 and as much as a year in jail.

Similarly, in Florida and Iowa, people who drive into crowds of protesters may claim civil immunity if they say they were acting in self-defence. The danger posed by such laws should be obvious. An analysis by Ari Weil of the Chicago Project on Security and Threats shows that in 2020, following the murder of George Floyd by a Minneapolis police officer, there were 72 incidents of cars

being driven into protesters across 52 cities in the space of just one month.

Lastly, the electoral process is being threatened by state laws that could empower (Republican-led) state legislatures to ignore presidential election outcomes by substituting their own Electoral College electors in place of the ones chosen by the state's voters. Ominously, the US Supreme Court recently gestured toward endorsing a fringe legal doctrine that would immunise state legislatures from state or federal judicial review – meaning that there would be no lawful means of blocking legislatively substituted Electoral College votes.

Given these mounting threats, the defence of core democratic institutions – a free press, the right to peaceful assembly, and free and fair elections – will require not only increased collective engagement but also real courage.

It will take the kind of courage shown by former slaves in the face of Jim Crow and the rise of the Ku Klux Klan after the Civil War. It will take the kind of courage shown by 1960s activists who battled entrenched segregationists for civil rights. And it will take the kind of courage shown by women who fought to win the vote, and who now must fight anew for the right to make their own reproductive choices.

The stakes this time may be as high as they have ever been, but the essential lesson remains the same. In a free republic, fundamental rights must be earned anew whenever the sovereign authority of the state – embodying the core values that bind Americans together – is threatened. The violence erupting across America today presses against the guardrails of civil discourse and the rule of law, testing whether the struggle for shared identity – the country's founding ideal of E Pluribus Unum ("Out of Many, One") – can peacefully continue.

# Extending our understanding of universe

**THE JWST IS DESIGNED TO PEEK INTO THE INFRARED REGION OF THE SPECTRUM UNLIKE ITS PREDECESSOR, THE HUBBLE SPACE TELESCOPE**

With the release of the first images of the James Webb Space Telescope (JWST) 12 July by NASA, we are now moving closer to our understanding of how our universe formed and took shape. The stunning images will take us back in time to several billion years and show the most distant galaxies which were formed at the early stage of the universe just after the Big Bang and try to answer some of the fundamental questions that have baffled mankind like who we are and how we got here!

It is believed that our universe formed from the explosion of a hot super dense body that existed as a 'singularity' some 13.8 billion years ago. Space and time had no meaning then. After its initial expansion, the universe cooled sufficiently to allow the formation of subatomic particles, and later atoms. Giant clouds of these primordial elements, mostly hydrogen, later coalesced due to gravity, forming early stars and galaxies, the descendants of which are visible today. Now, these galaxies have moved very far and have cooled substantially so that they hardly emit any radiation to be detected by our instruments. However, they do emit very

weak infrared radiations characteristic of their extremely low temperatures. The JWST hopes to capture some of these radiations to show these distant and coldest galaxies with unprecedented detail.

The JWST is designed to peek into the universe in the infrared region of the spectrum unlike its predecessor, the Hubble Space Telescope (HST) launched by NASA in 1990 that sees the universe mostly with ultraviolet and visible wavelengths. By studying infrared light, JWST can penetrate the clouds of dust that obscure newborn stars and can peer farther into the cosmos than ever before. Galaxies that lie very far from Earth can be seen only at the infrared wavelengths, because the expansion of the universe has shifted their light beyond the visible part of the electromagnetic spectrum into the infrared region due to an effect called the cosmological Red Shift.

JWST's primary mirror consists of 18 hexagonal segments made of gold-plated beryllium, which create a 21-ft diameter mirror, compared with Hubble's 7-ft mirror. This gives JWST a light-collecting area of about 25 square meters, about six

times that of the Hubble and that's why it could see objects 100 times fainter than Hubble. This makes JWST the most powerful telescope ever built by humanity. The telescope is placed at the second Lagrange point in space some 1.5 million km away from the Earth covered with sun shield sails in order to protect itself from the interference of the infrared radiations emitted by its own instruments.

JWST is the culmination of 20 years of international collaborative effort of NASA with European Space Agency (ESA) and Canadian Space Agency (CSA) and built at a cost of \$1000 crore. It was launched to space 25 December, 2021 from an ESA launch site in Kourou, French Guiana aboard an Ariane 5 rocket. According to NASA, the JWST project involved over 300 universities, organisations and companies across 29 US states and 14 countries. Although its initial life span is about 5.5 years, it is expected to operate for at least 20 years in space.

JWST has delivered the deepest and sharpest infrared images of the distant universe to date. Webb's first deep field image was a galaxy cluster formed 4.6 billion years ago, named SMACS 0723, taken in a

grain size expanse of the sky looked from our arm's length. It is found to be teeming with young and old galaxies. The second image was a hot puffy planet, named WASP-96b, outside our Solar System that reveals the clear signature of water, along with evidence of haze and clouds that previous studies could not detect. The third image was a planetary nebula, called the Southern Ring nebula that surrounds a dying star some 2000 light years away from us. The fourth image shows some interacting galaxies, called the Stephan's Quintet that would allow scientists to know how stars were formed from vast clouds of dust and gas. The final image was the Carina nebula that unveils the earliest, rapid phases of star formation that were previously hidden from us.

The journey has just begun. As more images pour in, we hope to understand our universe deeper and better than ever before. And then, we will be, probably, able to read the mind of God: the nature of His mysterious and elusive creation.

### 8 held for offering 'namaz' in public

They were arrested under Section 151 of the Criminal Procedure Code (design to commit any cognisable offence) and produced before the SDM's court. The court gave them a warning and granted them bail, he said.

### Tailor killing: NIA arrests 8th accused

New Delhi: The National Investigation Agency (NIA) has arrested the eighth accused in the case of the horrific killing of Udaipur tailor Kanhaiyya Lal Teli, allegedly over his support to a now suspended BJP spokesperson's remarks on the Prophet, an official said. The accused, identified as Mohammed Javed, 19, was arrested Thursday. He had allegedly played a key role in the conspiracy of killing Kanhaiyya Lal June 28 by conducting recce and passing on the information about presence of the victim at his shop to the main killer accused Riyaz, officials said.

### Flying articles banned in Delhi

New Delhi: In a bid to avoid terror strikes and aby untoward incidents, Delhi Police Commissioner Rakesh Asthana on Friday prohibited flying of various sub-conventional aerial platforms like para-gliders, UAVs, hot air balloons, or para-jumping over the jurisdiction of the national capital's territory.

# ED attaches Nirav's property worth ₹253 crore

New Delhi, July 22: The Enforcement Directorate (ED) Friday said it has attached proceeds of crime in the form of movable properties i.e. gems and jewellery and bank accounts amounting to \$30.98 million and HKD 5.75 million, equivalent to Rs 253.62 crore in the case of the Nirav Modi group of companies in Hong Kong, SAR, China.

"On the basis of FIR under Section 420, 467, 471 and 120-B of the Indian Penal Code, 1860 and Section 13 of Prevention of Corruption Act, 1988 registered by CBI, BS & FC Branch, Mumbai, ED had initiated investigation by recording ECIR under Prevention of Money Laundering Act, 2002A in the case of PNB Bank Fraud of Rs 6498.20 crore," the official said.

During the course of the PMLA investigation, some assets of the Modi group of companies in Hong Kong were identified in the form of gems and jewellery lying in private vaults and bank balances in accounts maintained in Hong Kong, which is provisionally attached vide instant attachment order of Rs 253.62 Crore under Section 5 of PMLA, 2002.

Previously the ED had attached movable and immovable assets of Nirav Modi and associates to the tune of Rs 2396.45 crore in India and abroad. With the present attach-

ment, the total attachment of assets of Rs 2650.07 crore has been effected in the case against Nirav Modi by the ED.

Furthermore, movable and immovable assets of Modi and his associates amounting to Rs 1389 crore, have been confiscated under provisions of the Fugitive Economic Offenders Act, 2018 by the Special Court (FEOA), Mumbai.

The official said that the process of physical handing over of the confiscated assets is in progress and part of the confiscated assets has already been physically handed over to the victim banks.

"Earlier in this case, 2 Prosecution Complaints under PMLA, 2002 have already been filed by the Directorate against Nirav Modi and associated entities before Special Court (PMLA). Simultaneously, the extradition proceedings against fugitive, Nirav Modi is at final stage in London, UK," said the official.



# Azam Khan case: SC criticises HCs

New Delhi, July 22: The Supreme Court Friday criticised the new trend where high courts have made irrelevant observations, not connected with a case before them, and going overboard by imposing pointless conditions in bail matters.

A bench, headed by Justice AM Khanwilkar, said it is disturbed by such orders passed by high courts and cited directions passed by a separate bench setting aside an order, similar in nature.

The bench, also comprising Justice JB Pardiwala, set aside the Allahabad High Court's bail condition to seal the premises of Mohammad Ali Jauhar University at Rampur while granting bail to

Samajwadi Party leader Azam Khan. He is one of the members of the board of trustees of the university. Expressing disappointment with the new trend, the top court said the high courts are exceeding their authority to delve into issues which are not relevant to the determination of the bail plea.

The top court noted that if sealing proceedings were to take place, then it should have been independent of the observations made by the high court.

Only July 18, the Supreme Court stayed all proceedings and adverse remarks, calling for B summary reports and service records, against the Karnataka ACB by a Karnataka High Court judge. A bench headed by Chief Justice NV.Ramana said

# ED seizes huge cash during raids

Kolkata, July 22: Officials of the Enforcement Directorate (ED) probing the recruitment irregularities in the West Bengal School Service Commission (WBSSC) and West Bengal Board of Primary Education (WBBPE) have recovered huge amount of cash and several mobile phones from the house of a close aide of former state Education Minister and Trinamool Congress Secretary General Partha Chatterjee, who is currently the Commerce and Industries Minister in West Bengal.

The cash seized from the residence of Arpita Mukherjee, known to be a close aide of Chatterjee, amounts to around Rs 20 crore.

The ED sleuths have also recovered 20 mobile phones from the posh residence of Mukherjee at the Diamond City complex in Tollygunge.

The officials believe that these mobile phones will provide crucial links to the teachers' recruitment scam in WBSSC and WBBPE. The ED has also released a statement to a section of the media

claiming that it was conducting search operations at various places in connection with the teachers' recruitment scam during which huge amount of cash was seized. The ED sleuths called some bank officials for counting purposes who arrived at Mukherjee's residence with currency counting machines. ED sources said that the residence of Mukherjee was not there in the initial list of 13 places, where the agency had been conducting raids

since Friday morning.

However, Mukherjee's name surfaced during the course of the raids following which the ED sleuths, escorted by Central Reserve Police Force (CRPF) personnel, reached her residence and launched a search and seizure operation.

The ED sleuths are currently grilling Mukherjee to unearth the source of the cash as well the purpose for which so many mobile phones were used.

# TOP COURT JUNKS PLEA TO INCREASE SMOKING AGE

New Delhi, July 22: The Supreme Court Friday junked a plea seeking a direction to increase the smoking age from 18 to 21, and ban the sale of loose cigarettes.

A bench comprising Justices S K Kaul and Sudhanshu Dhulia rejected the plea filed by two advocates. "If you want publicity, argue a good case...Don't file publicity interest litigation," the bench said while dismissing the plea.

The apex court was hearing a public interest litigation filed by advocates Shubham Awasthi and Sapta Rishi Mishra seeking guide-

lines to control smoking.

The plea also sought directions to remove smoking zones from commercial places besides banning sale of loose cigarettes near educational and healthcare institutions and also places of worship.

# RS WITNESSES REPEATED DISRUPTIONS

New Delhi, July 22: Rajya Sabha proceedings were adjourned twice in the pre-lunch period Friday amid protests by the Opposition on price rise and other issues.

When the House reassembled at 12 after a brief adjournment, Rajya Sabha Deputy Chairman Harivansh Narayan Singh conducted the Question Hour amid protest by opposition parties for almost an hour.

Minister of State for Agriculture and Farmer Welfare Kailash Choudhary, Minister for Communication Ashwini Vaishnav, Minister of State for Commerce and Industry Anupriya Patel and Union Minister for Consumer Affairs, Food & Public Distribution Piyush Goyal replied to the questions amid protests by opposition members, who had trooped inside the well.



The Deputy Chairman urged the protesting members to return to their respective seats. Goyal said the government is ready for discussion on the issue. However, the opposition is not ready for this and is obstructing the House.

The minister, who was replying to questions related to wheat purchase, said the entire world is discussing food security and India is the only country which has balance. "Even in such conditions, our opposition is not ready for discussion. The majority of us want a discussion. Even the government wants discussion on this," said Goyal.

Leader of the Opposition Mallikarjun Kharge sought a discussion under Rule 267 for suspension of business to discuss the issue of price rise of essential commodities.

# Over 16cr women globally have unmet contraceptive needs: Study

THE RESEARCHERS USED MODELLING TO PRODUCE NATIONAL ESTIMATES OF VARIOUS FAMILY PLANNING INDICATORS

New Delhi, July 22: Over 16 crore women and adolescents with need to prevent pregnancy remained without contraception in 2019, despite major increases in use at a global level since 1970, according to a study published in The Lancet journal.

Expanding access to contraception is linked to women's social and economic empowerment and better health outcomes and is a key goal of international initia-

tives, and a Sustainable Development Goal (SDG) indicator, the researchers said. Contraception use is also associated with reductions in maternal and neonatal mortality by preventing unintended pregnancies, they said.

Based on data from 1,162 self-reported representative surveys on women's contraceptive use, the researchers used modelling to produce national estimates of various family planning indicators.

Women were defined as needing contraception when they were married or if unmarried, sexually active, able to get pregnant and not wanting a child within two years, or if they were pregnant or had just given birth but would have preferred to delay or prevent their pregnancy.

The researchers noted that worldwide, the share of women of reproductive age using modern contraception increased from 28 per cent in 1970 to 48 per cent in 2019.

Demand met rose from 55 per cent in 1970 to 79 per cent in 2019.

Despite the major increases, 163 million (over 16 crore) women who were not currently using contraception were considered to have need in 2019, out of 1.2 billion (over 100 crore) women who needed contraception in total, they said.

"Although we have observed excellent strides in contraceptive

availability since the 1970s at a global level, there is still a long way to go to ensure that every woman and adolescent girl can benefit from the economic and social empowerment contraceptives can offer," said Annie Haakenstad, from Institute for Health Metrics and Evaluation (IHME), University of Washington, US.

"Our results indicate that where

a woman lives in the world and their age still significantly impacts their use of contraception," Haakenstad said. In 2019, the availability of contraceptives still differed significantly between regions and across different countries.

Southeast Asia, East Asia and Oceania had the highest use of modern contraceptives (65 per cent) and demand satisfied (90 per cent), whereas sub-Saharan Africa had the lowest use of modern contraceptives (24 per cent) and demand satisfied (52 per cent). Between countries, levels of modern contraceptive use ranged from 2 per cent in South Sudan to 88 per cent in Norway. Unmet need was highest in South Sudan (35 per cent), Central African Republic (29 per cent) and Vanuatu (28 per cent) in 2019. "The higher unmet need among partnered adolescent women represents a risk for unintended pregnancies, affecting the subsequent socioeconomic empowerment of these groups," said

Manas Ranjan Pradhan, from International Institute for Population Sciences, Mumbai.

"The sociodemographic index influences the mCPR (modern contraceptive prevalence rate) and demand satisfaction among adolescents, probably due to vast inequalities on the basis of socioeconomic status and access to health-care services," said Ranjan, who was not involved in the study. The Family Planning 2020 Initiative (FP2020) set a goal of increasing the number of women using modern contraception by 120 million between 2012 and 2020 in 69 priority countries, the researchers said.

The study estimated that the number of women using contraception increased by 69 million (6.9 crore) between 2012 and 2019 in these countries, leaving the initiative 51 million (5.1 crore) short of reaching its goal if these levels remained unchanged in 2020, they said.



# LG recommends CBI probe into Delhi's excise policy

CM Arvind Kejriwal claims his deputy Manish Sisodia to be arrested in 'fake' case

New Delhi, July 22: Manish Sisodia is a "hardcore honest" man, Delhi Chief Minister Arvind Kejriwal said Friday, fearing that his deputy will be framed in a "completely fake case" by the CBI and arrested in a few days.

His remarks came after Delhi Lieutenant Governor (LG) VK Saxena recommended a probe by the Central Bureau of Investigation (CBI) into the Delhi Excise Policy, 2021-22 over alleged violations of rules and procedural lapses.

Sisodia heads the excise department of the Delhi government.

At an online press briefing, Kejriwal said he has known Sisodia for 22 years. "I came to know that a case has been sent to the CBI against Manish Sisodia and the agency is going to arrest him in a few days. It is a completely fake case. There is not even an iota of truth in this case," the national convener of the Aam Aadmi Party (AAP) said.

# Lip-lock challenge: 8 students booked under POCSO act

# Kerala reports 3rd case of monkeypox

Health Minister Veena George said the Malappuram native arrived in the southern state July 6 and had fever since July 13.

He was undergoing treatment at the Manjeri Medical College there and his health condition is stable, she said.

The minister also said all those who were in close contact with the patient are being closely monitored and their health condition is also stable.

However, George made it clear that there was no need to panic over the disease as testing and surveillance have been intensified across the state.

## '95% cases transmitted through sexual activity'

**SYDNEY:** Sexual closeness is the most likely route of transmission in 95 per cent of monkeypox cases, according to a global case study series from across 16 countries. However, the virus can be transmitted by any close physical contact through large respiratory droplets and potentially through clothing and other surfaces, said researchers at Queen Mary University of London. In the study, the team reported 528 infections diagnosed between April 27 and June 24, 2022, at 43 sites in 16 countries. The findings, published in the New England Journal of Medicine (NEJM), showed 95 per cent of the persons presented with a rash (with 64 per cent having less than 10 lesions), 73 per cent had anogenital lesions, and 41 per cent had mucosal lesions (with 54 having a single genital lesion).



## 1,134 Indians in Nepal jails

**New Delhi, July 22:** There are a total of 1,134 Indian prisoners, including undertrials, in Nepal jails, the Parliament was told Friday.

Minister of State of External Affairs V. Muraleedharan told the Lok Sabha in a written reply that the government attaches the highest priority to the safety, security and well-being of Indians in foreign countries, including those in the foreign jails.

"As soon as the information about the detention/arrest of an Indian national is received by Embassy of India in Nepal, it immediately gets in touch with the concerned local authorities to get con-

sular access to the detained/arrested Indian national to ascertain the facts of the case, confirm his Indian nationality, and ensure his welfare. Apart from extending them all possible consular assistance, legal assistance to imprisoned Indians is being provided by the Embassy in deserving cases on a means tested basis."

"Cases are also raised with the Ministry of Foreign Affairs, Government of Nepal for taking up the matter with concerned authorities of Government of Nepal. The issue of repatriation of Indian nationals in Nepalese prisons is regularly pursued by Embassy with the local authorities concerned," he said.

### Rains break 20-yr record in Lahore

Islamabad: Heavy rain lashed Lahore for almost seven hours, wreaking havoc and disrupting civic services in Pakistan's second largest city. ### SKorea to lift ban on NKorea TV

Seoul: South Korea plans to lift its decades-long ban on public access to North Korean television, newspapers and other media as part of its efforts to promote mutual understanding between the rivals, officials said Friday, despite animosities over the North's recent missile tests. Divided along the world's most heavily fortified border since 1948, the two Koreas prohibit their citizens from visiting each other's territory and exchanging phone calls, emails and letters, and they block access to each other's websites and TV stations.

### Deadly police raid claims 18 in Brazil

Rio De Janeiro: At least 18 people died Thursday during a major police raid in a dense warren of Rio de Janeiro slums, state military police said, in the latest bloody confrontation in Brazil's second-largest city. Tactical teams from Rio de Janeiro's civil and military police raided the Alemao complex to take down an alleged criminal organization. The group was suspected of involvement in cargo theft and bank robberies and was planning incursions into rival slums.

Colombo, July 22: Sri Lanka's newly-elected President Ranil Wickremesinghe Friday appointed Dinesh Gunawardena, a loyalist of the Rajapaksa family, as the Prime Minister in a bid to restore political stability and mitigate the worst economic crisis that has virtually bankrupted the country. The formation of the new government by Wickremesinghe took place hours after Sri Lankan troops and police armed with assault rifles and batons forcibly removed anti-government protesters camped outside the presidential office here in a pre-dawn raid.

Social media posts showed officers dressed in riot gear pulling down protest tents and arresting several demonstrators. Banners that were hung from top of the secretariat have also been removed. Sri Lanka has seen months of mass unrest over an economic crisis and many blame the former government led by ousted president Gotabaya Rajapaksa for mishandling the island nation's finances. The forcible removal of protesters, criticised by the Opposition as well as by several Western envoys here, is seen as a signal that President Wickremesinghe, 73, will crack down on anti-government demonstrators who forced the ouster of his predecessor Rajapaksa. Wickremesinghe, who was appointed acting President by Rajapaksa was officially sworn in

as the country's President Wednesday after he was elected by Parliament July 20. The 18-member Cabinet was sworn in on President Wickremesinghe's first day in office. Ali Sabry, who earlier headed the finance ministry, was appointed as the foreign minister. He has been chosen to be the foreign minister for his articulate skills and his ability to deal with the international partners, including the International Monetary Fund, analysts said. Prime Minister Gunawardena, 73, has been given an additional portfolio of Public Administration, Home Affairs, Provincial Councils and Local Government. The rest of the ministers were retained with their same portfolios while

# Sunak faces UK media scrutiny

London, July 22: Rishi Sunak's personal wealth as a perceived barrier in his path to connecting with the wider British electorate suffering from post-pandemic economic turmoil is in focus among sections of the UK media Friday. The 42-year-old former Chancellor, who is now facing off Foreign Secretary Liz Truss in the last stretch of the campaign to replace Boris Johnson as Conservative Party leader and British Prime Minister, has faced down similar jibes related to a so-called "privileged" upbringing and wife Akshata Murty's family wealth associated with her Infosys shares. On Thursday, 'Channel 4 News' aired an investigation entitled 'Rishi Sunak: Inside the Tory Leadership candidate's fortune', which questioned the Sunak camp's references to his "humble" and "modest" background and has been picked up by other publications Friday.

"I think financially it was quite a huge commitment for us because the fees at Winchester [College] are double what you would pay if you went to the local school in Southampton. So, it was quite a large financial commitment," the report quoted Sunak's father, Yashvir, from a BBC interview from 2000. However, while the channel highlights the Sunak's camp's claims of him being a scholarship student to the prestigious private school, the former finance minister himself has declared that his time at Winchester was the outcome of his family's hard work and sacrifice. The Channel 4 investigation also dug out land registry information to reveal that the prime ministerial hopeful started his property portfolio at the age of 21 with an interest-free loan from his parents to buy a GBP 210,000 one-bedroom flat in central London, which is today worth around GBP 750,000. It goes on to detail his American life, starting with a job at Goldman Sachs and then as a partner at an investment bank that was ultimately owned by a firm in the Cayman Islands, an offshore tax haven. Channel 4 said that Sunak did not deny that he received assets in tax havens and any assets he had were subject to US tax, which was paid in full. "There's no suggestion Mr Sunak did anything illegal," the Channel 4 report goes on to say.

# Heatwave bakes US: Over 100mn under alerts

Washington, July 22: A relentless US heatwave that has triggered health alerts for more than 100 million people is set to intensify this weekend, with temperatures and humidity forecast to surge to suffocating highs in many parts of the country. The devastating heat - which has also hit Europe, causing hundreds of deaths there - highlights the direct threat climate change poses to even the wealthiest countries on the planet. "So far this week, 60 daily high temperature records have been tied/broken as dangerous heat enveloped much of the Nation," the National Weather Service (NWS) said in a tweet Thursday morning. "More records are likely to be set over the next week," it added. Temperatures in large parts of the southwest United States have

soared over 100 degrees Fahrenheit (38 degrees Celsius), topping 110 degrees in some areas. Similar levels were recorded across the US south, where humidity com-



pounded the discomfort. "Stay hydrated, limit sun exposure, and check on seniors, neighbors & pets," Washington Mayor Muriel Bowser said on Twitter.

Philadelphia's Department of Public Health warned in a statement that "during hot weather, NEVER leave children and pets unattended in vehicles under any circumstances." More heat to come While the oppressive heat is expected to subside in the US south and east next week, a high pressure system over the Pacific northwest is expected to push temperatures 10-15 degrees above normal levels. Temperatures have also soared in Europe, setting a new all-time record in Britain, where the national weather service clocked 104.5 degrees in eastern England, surpassing the previous high set in 2019.

# Beloved monarch butterflies now listed as endangered

In the past decade, tiger populations have increased in Nepal, northern China and perhaps in India, while tigers have disappeared entirely from Cambodia, Laos and Vietnam. They remain designated as endangered

Washington, July 22: The monarch butterfly fluttered a step closer to extinction Thursday, as scientists put the iconic orange-and-black insect on the endangered list because of its fast dwindling numbers. "It's just a devastating decline," said Stuart Pimm, an ecologist at Duke University who was not involved in the new listing. "This is one of the most recognizable butterflies in the world."

The International Union for the Conservation of Nature added the migrating monarch butterfly for the first time to its "red list" of threatened species and categorized it as "endangered" - two steps from extinct. The group estimates that the population of monarch butterflies in North America has declined between 22% and 72% over 10 years, depending on the measurement method. "What we're worried about is the rate of decline," said Nick Haddad, a conservation biologist




at Michigan State University. "It's very easy to imagine how very quickly this butterfly could become even more imperiled." Haddad, who was not directly involved in the listing, estimates that the population of monarch butterflies he studies in the eastern

terflies migrate to the north, breeding multiple generations along the way for thousands of miles. The offspring that reach southern Canada then begin the trip back to Mexico at the end of summer. "It's a true spectacle and incites such awe," said Anna Walker, a conservation biologist at New Mexico BioPark Society, who was involved in determining the new listing. A smaller group spends winters in coastal California, then disperses in spring and summer across several states west of the Rocky Mountains. This population has seen an even more precipitous decline than the eastern monarchs, although there was a small bounce back last winter. Emma Pelton of the nonprofit Xerces Society, which monitors

## Forex reserves drop \$7.541bn to \$572.712 bn

Mumbai, July 22: The country's foreign exchange reserves declined by \$7.541 billion to \$572.712 billion in the week ended July 15 as the Reserve Bank continued to intervene in the market to curb the fall of the rupee.

In the previous week ended July 8, the reserves shrank by \$8.062 billion to \$580.252 billion, the Reserve Bank of India (RBI) data showed Friday.

On Friday, the rupee fell by 5 paise to close at 79.90 against the US dollar. It had touched an all-time intra-day low of 80.06 against the US dollar Thursday.

During the reporting week ended July 15, the fall in the reserves was on account of a decline in the Foreign Currency Assets (FCAs), a major component of the overall reserves, and also in the gold reserves, the central bank said. FCAs fell by \$6.527 billion to \$511.562 billion in the reporting week, according to the Weekly Statistical Supplement released by RBI.


Expressed in dollar terms, FCAs include the effect of appreciation or depreciation of non-US units like the euro, pound and yen held in the foreign exchange reserves.

Gold reserves decreased by \$830 million to \$38.356 billion in the reporting week. The Special Drawing Rights (SDRs) with the International Monetary Fund (IMF) declined by \$155 million to \$17.857 billion, RBI said. The country's reserve position with the IMF decreased by \$29 million to \$4.937 billion in the reporting week.

Mumbai, July 22: India's central bank has zero tolerance for volatile and bumpy movements in the rupee and will continue to engage with the foreign exchange market to ensure the rupee finds its appropriate level, its chief Shaktikanta Das said Friday.

The rupee has been hitting a series of record lows in recent weeks and broke past the psychological 80 per dollar mark earlier this week, prompting heavy dollar selling intervention from the Reserve Bank of India (RBI).

"We have no particular level of rupee in mind but we would like to ensure orderly evolution," Das said at a banking conference in Mumbai organised by the Bank of Baroda. "We have zero tolerance for high volatility and bumpy movements."

Das said the rupee's movements have been relatively smooth and orderly due to the RBI's actions in the foreign exchange market. By ensuring there are no sudden and

volatile shifts, the RBI was keeping expectations anchored and the foreign exchange market functioning in a stable and liquid manner, he added.

"We will continue to engage with the forex market and ensure that rupee finds its level in line with its fundamentals". He said the central bank has been supplying dollars since there is a genuine shortage of dollars in the market.

Das also said the central bank has built its foreign exchange reserves for situations like these, noting that India has a substantial amount of foreign exchange reserves to handle the current crisis and there is no need to panic.

More broadly, the governor said India's economy remains well placed and all high-frequency indicators have been pointing towards a steady revival. However, on inflation he said that while it appears to have peaked, the situation remains volatile and the RBI was constantly reviewing it.

### Twitter posts loss of \$270 million

London: Twitter reported a quarterly loss Friday as revenue slipped even as its number of users climbed. The social media company's latest quarterly earnings figures offered a glimpse into how the social media business has performed during a months-long negotiation with billionaire and Tesla CEO Elon Musk over whether he will take over the company. The company lost \$270 million in the April-June period after revenue slipped 1 per cent to \$1.18 billion, reflecting advertising industry headwinds, as well as "uncertainty" over Musk's acquisition bid.

### Reliance Jio Q1 profit rises 24%

New Delhi: India's largest telecom operator Reliance Jio Infocomm Friday reported a nearly 24 per cent year-on-year rise in its standalone net profit to ₹4,335 crore for the June 2022 quarter. Billionaire Mukesh Ambani-led Reliance Jio clocked revenue from operations of ₹21,873 crore in the just-ended quarter, which was 21.5 per cent higher than the year-ago period, according to a filing. Jio's Q1 scorecard comes at a time when the telecom market is poised for the advent of 5G services, which will usher in ultra-high speeds (about 10 times faster than 4G) and bring new-age services and business models.

### Tata bags order for 1,500 e-buses

New Delhi: Tata Motors Friday said it has bagged an order for 1,500 electric buses from Delhi Transport Corporation (DTC) as part of a tender by Convergence Energy Services Ltd. The auto major will supply, operate and maintain air-conditioned, low-floor, 12-metre fully-built electric buses for 12 years, as per the contract, it said in a statement. The Mumbai-based company has already supplied more than 650 electric buses across multiple cities in India, which have cumulatively clocked more than 39 million kilometres.

### Russia's central bank slashes rate

Moscow: The Russian central bank slashed its key interest rate Friday just a month after dropping it to where it was before sending troops into Ukraine, saying inflation is still easing partly as consumer demand falls. The bank lowered its key rate by 1.5 percentage points, to 8 per cent. It said inflation expectations have "significantly decreased," reaching spring 2021 levels, while a decline in business activity was slower in June.

were filed by the extended due date of December 31, 2021.

"eople thought the routine now is that dates will be extended. So they were a little slow in filling the returns initially but now on a daily basis, we are getting between 15 lakhs to 18 lakh returns. This will slightly go up to 25 lakh to 30 lakh returns," he told PTI. Typically, return filers wait till the last day to file returns.

"Last time 9-10 per cent filed on last day. Last time, we had over 50



lakh (filing returns on the last date). This time, I have told my people to be ready for 1 crore (returns being filed on the last day)," he said.

## Kuber, WazirX block deposits via UPI system, stir alarm

New Delhi, July 22: Big Indian crypto exchanges CoinSwitch Kuber and WazirX have disabled rupee deposits for the purchase of cryptocurrency using a widely-used state-backed transfer system, spurring users to voice concern on social media.

India has spent years on a law to ban or regulate cryptocurrencies, with its central bank backing a ban over their threat to financial stability, but a recent decision to tax income from them suggests acceptance by authorities.

The decision follows a one-line statement last week by the National Payments Corporation of India saying, it was not aware of any crypto exchange using its United Payments Interface (UPI) framework, which eases bank transfers.

CoinSwitch's app was not allowing users to load deposits, while rival exchange WazirX said on Twitter, "UPI is not available," adding that it had no estimated time to fix the issue with UPI deposits.

"You have closed the INR deposit without any information. At least let us know how long it will be closed," a Twitter user, Avijit Debnath, asked CoinSwitch. An industry source with direct knowledge of the matter said the decision by CoinSwitch to halt UPI deposits resulted from "regulatory uncertainty" after the NPCI statement.

## Europe's banks brace for bumpy ride after cheap money decade

The others in the A+ segment are Rohan Pandit, Nikhil Patwardhan, Sadashiv Iyer, Ulhas Gandhe and Navdeep Singh Sidhu.

Twenty umpires including C Shamsuddin form the A Group, 60 are in Group B, 46 in Group C and 11 in Group D which falls in the 60-65 age bracket.

The complete list was tabled at the Apex Council meeting Thursday following the work done by former international umpires K Hariharan, Sudhir Asnani and Amiesh Saheba, and members of BCCI umpires' sub-committee.

Umpires in 'A+' and 'A' category are paid Rs 40,000 a day for a first-class game while Rs 30,000 a day are paid in the 'B' and 'C' category.

## A FIRST FOR PAUL

However, the other two Indians in the fray – P Chithravel and Abdulla Aboobacker – missed the cut. Tokyo 2020 champion Pedro Pichardo topped the qualifying with a 17.16-metre attempt.

Eugene, July 22: Olympic champion Neeraj Chopra qualified for his maiden World Championships final with a stunning first attempt throw of 88.39m as India cherished a historic day at the event with two of their javelin throwers making it to the medal round, here Thursday. The final comes off Sunday.

The 24-year-old Indian superstar, hot favourite for a medal, opened the Group A qualification round by sending his spear to 88.39m for his third career-best throw. Chopra finished second best overall behind defending cham-

pion Anderson Peters of Grenada, who topped Group B with his opening round effort of 89.91m.

"It was a good start. I'll give my 100 per cent in the final, but then every day is different. I'll just give my best. We don't know who can throw far on any given day," Chopra said after his qualification. "There are so many throwers in good shape now. Five-six throwers have thrown personal bests this year. They are all in excellent shape," added the Olympic gold medallist.

Chopra's qualification round lasted a few minutes as he did not need to take the remaining two throws after breaching the auto-

matic qualification mark in his first attempt. A competitor gets three throws in the qualification round.

Another Indian in the fray, Rohit Yadav also made it to the finals after finishing sixth in Group B qualification round and 11th overall with his first round throw of 80.42m. His second throw was a foul and he managed a modest 77.32m in his last attempt. Yadav's best throw of the season has been 82.54m.

Chopra, who has a personal best of 89.94m, had competed in the 2017 London World Championships with the hope of at least making it to the finals but managed only 82.26m to fall short of the auto-

matic qualification mark of 83m. He had also missed the 2019 World Championships in Doha as he was recovering from an elbow surgery.

Tokyo Olympics silver medalist Jakub Vadlejch of Czech Republic also qualified for the finals with a first round throw of 85.23m. He was the second automatic qualifier from Group A, along with Chopra, and fourth overall.

Chopra has beaten Peters twice this season while the 24-year-old Grenadian prevailed over the Indian once – at the Diamond League Meeting in Stockholm on June 30 – in their three meetings this season before this World Championships.

### Lingard quits Man U

Nottingham: Nottingham Forest pulled off their biggest signing since clinching a return to the Premier League by bringing in Jesse Lingard on a free transfer. The England midfielder was available after ending his 22-year association with Manchester United during the off season. Lingard's move to Forest was announced late Thursday. He is the 11th signing made by the promoted club as they prepare for a first season in the Premier League since 1999. The value of Lingard's deal was not disclosed. The 29-year-old Lingard spent the second half of the 2020-21 season on loan at West Ham, scoring nine goals in 16 starts.

### Indian campaign ends

Taipei: The Indian campaign ended at the Taipei Open badminton tournament after Parupalli Kashyap and Tanisha Crasto lost in the quarterfinals of the singles and doubles competitions respectively, here Friday. Third seed Kashyap's run ended with a 12-21, 21-12, 17-21 loss to Soong Joo Ven of Malaysia in a 55-minute match. Tanisha also had a disappointing day. Tanisha and Ishaan Bhatnagar, seeded sixth, lost 19-21, 12-21 to Malaysia's Hoo Pang and Toh Ee Wei in mixed doubles. Then she and Shruti Mishra lost to Hong Kong's Ng Tsz Yau and Tsang Hiu Yan 16-21, 22-20, 18-21 in the women's doubles.

### Nagal recalled

New Delhi: Sumit Nagal made a comeback to the Indian Davis Cup team for the away World Group I tie against Norway while doubles specialist Divij Sharan was dropped after falling behind in the pecking order. Expectedly, India's No.1 singles player Ramkumar Ramanathan (ranked 196), Prajesh Gunneswaran (295), Sasikumara Mukund (431), Yuki Bhambri (571) and doubles exponent Rohan Bopanna (21) have been named in the team as the Nandan Bal-led selection committee picked four specialist singles players. The tie will be played September 16 and 17. Nagal, who underwent a hip surgery in November 2021, began competing on the circuit from April this year.

# Hold elections or face ban: IOC warns IOA

Mumbai, July 22: The Indian Olympic Association (IOA) faces another ban over governance-related issues if it fails to hold elections in the 'coming weeks', the International Olympic Committee (IOC) has said. The IOA elections were due last December but have been held up by a court case seeking to change its constitution in line with rules stipulated by the national sports code.

A source informed Friday that a letter has been sent to the IOA's executive council by the IOC. In the letter it has been said that the 'IOC and Olympic Council of Asia were following developments with great concern'. "It is very unfortunate to note that multiple legal proceedings have been initiated, which have only caused delays and created unnecessary complications so far," the letter said. It urged the IOA to resolve the situation and confirm the election date 'without any further delay'.

The letter further stated that if the IOA failed to organise the elections in the coming weeks, the IOC would have no other option but to

consider protective measures, 'including a suspension or ban'.

A suspension would cut off IOC funding, block Indian officials from attending Olympic meetings and leave the country's athletes unable to compete under the India flag at the Olympics. More importantly, this city will not be able to host the 2023 IOC session. If the IOC session happens it will be the first time that it will be conducted in India since 1983. The IOA did not immediately respond to requests for comment with most officials refusing to make observations as the case is sub-judice.

The IOA was previously banned at the end of 2012 after elections saw a corruption-tainted official voted in as secretary-general. India returned to the Olympic fold two years later during the 2014 Sochi Winter Games after voting in a new set of officials.

It is not only the IOA which is under the scanner India's hosting rights of the men's hockey World Cup in January is also under cloud with the FIH deciding to send a delegation to assess the current situation in the wake of Narinder Batra's resignation as the body's head.

Gill hooked Alzarri Joseph for a six before he delighted the crowd with a perfectly placed punch off the back-foot for a boundary. He was equally attractive playing the cover drives when the ball was pitched up. It took a brilliant direct hit from Pooran to dismiss Gill. It was Gill's maiden ODI half cen-

India open their campaign against mighty Australia, July 29. An eight-member support staff was also named with three reserve players.

However, it is not the players and support staff who are facing visa problems. India's Chef de Mission Rajesh Bhandari finally got his visa Friday after a long wait.

# INDIA OPEN THEIR CRICKET CAMPAIGN AGAINST NEMESIS AUSTRALIA WOMEN IN BLUE EYE GOLD AT CWG

Bangalore, July 22: Nemesis Australia await India in their Commonwealth Games (CWG) opener but senior batter Smriti Mandhana is in no mood to lose sleep over that and make their rivals 'feel good about it'. Days before women's cricket makes its debut at the multi-sport event, Mandhana refused to call the five-time T20 World Champions a 'big' team.

The Harmanpreet Kaur-led side will open their campaign July 29 against Australia, and Mandhana said they have their plans in place for each opposition.

We have seen many times on TV when the Indian flag goes high and we hear the National Anthem, we know the kind

"Definitely we are aiming for the gold. I don't think we will just look for a podium finish and feel satisfied about it, we want more than that" added the opener.

However, Hamilton is without a win 12 races into this season. And Hamilton after three successive podium finishes in the last three races is hoping to turn the tide and make his 300th on the racing track memorable.

"It's been really positive to have some consistency come back in. We're constantly adding perfor-

ance, we're constantly progressing and there's a lot to come," Hamilton said Friday here. "In the last race (in Austria) we were only a few tenths (of a second) off the lead guys in qualifying," he added. Hamilton selected his first F1 win in 2007, his first title in 2008, and winning on his home track at Silverstone as standout memories.
