gered a massive controversy Saturday, forcing Chief Minister Eknath Shinde to state that he disagreed with the Governor.

As the comments drew widespread condemnation, Koshyari said Saturday that the statement was misconstrued, and asked political parties not to create a controversy," he said.

Shiv Sena president Uddhav Thackeray demanded an apology from Koshyari. The former chief minister, whose relations with Koshyari were often strained while in office, accused the governor of "dividing" Hindus living in Mumbai and Thane.

Holding a press conference, Thackeray said, "The hatred that the Governor harbours in his mind against the Marathi people has inadvertently come out. Time has come to decide whether to send Koshyari back home or to jail...In the last three years, he has insulted Marathi-speaking people despite staying in Maharashtra. Now with these comments, he has brought disrespect to the governor's post," the Sena president said.

Chief Minister Shinde, leader of the rebel Shiv Sena faction, said he disagreed with Koshyari's remarks. Talking to reporters at Malegaon, Shinde said, "We don't agree with Koshyari's remarks.

The ED said this was a "ponzi scam case of fraudulent collection of deposits from the gullible public in guise of issuance of preferential shares by enrolling the depositors as members of cooperative societies" "These companies were neither registered as non-banking finance company (NBFC) with the RBI nor listed at the National Stock Exchange and as such were not authorised to collect such public deposits," the agency said. Meanwhile, Biswal's wife, Laxmi Bilasini denied having any knowledge about the properties owned by the Noida-based firm that were attached by the ED. She even claimed that the letter received from ED Friday only mentions about the ₹25 lakh cash provided by the Seashore group.

Bhubaneswar, July 30: The state government Saturday said a master plan is being prepared to develop the Dhauli Hill where a peace pagoda is located on the outskirts

of the Capital city. This was stated by Tourism Minister Ashwini Kumar Patra while replying to a question of Congress MLA Suresh Kumar Routray in the Assembly, Saturday. Routray expressed concern over the state government's lack of interest to develop Dhauli, Bindu Sagar and Kedar Gouri tanks in City, which have both historical significance and tourism potential. He

thanked the state government for initiating infrastructure development projects in Puri, Sambalpur, Cuttack and important religious places.

"A master plan is being prepared for development of Dhauli Hill tourist destination and it will be executed soon," Patra said, adding that these tourist destinations will get makeover soon. Dhauli Hill, located about 8 km

from the Capital city, is best known as the site of Dhauli Shanti Stupa



or the Peace Pagoda.

The structure was built by the Japan Buddha Sangha and the Kalinga Nippon Buddha Sangha in 1972. It commemorates the mission of peace that emperor Ashoka had achieved after the Kalinga War on the banks of the river Daya.

The minister said that the state government has been using outdoor branding, digital marketing, radio, social media and newsletter for the publicity of Odisha's tourist destinations.

These apart, small documentaries are also being telecast at national and regional levels, he said. Enforcement Directorate (ED) has attached assets worth over ₹3.92 crore of former BJD MLA Pravat Biswal and a media company in a money laundering case against Seashore Group of companies accused of perpetrating an alleged ponzi fraud, officials said Saturday.

The central agency, in a statement, said a provisional order under Prevention of Money Laundering Act (PMLA) was issued to attach ₹25 lakh bank deposits of Biswal, a three-time former MLA from Cuttack-Choudwar Assembly seat, held at the SBI Cuttack branch.

Biswal was arrested by the CBI in this case in 2017 but was later granted bail. The agency also attached an immovable property belonging to Media Guru Consultants Pvt. Ltd in Noida, Uttar Pradesh.

The total value of the attached assets is ₹3,92,20,000, the Enforcement Directorate (ED) said.

CJI NV RAMANA URGES THE JUDICIARY TO SPEED UP THE RELEASE OF UNDERTRIALS LANGUISHING IN JAILS. AWAITING LEGAL AID

New Delhi, July 30: Chief Justice of India NV Ramana Saturday termed access to justice "a tool for social emancipation" and said only a small percentage of the population can approach courts while the majority suffers in silence, lacking awareness and necessary means.

Technology has emerged as a great enabler. the Chief Justice of India (CJI) said and urged the judiciary "to use modern technological tools to enhance the pace of justice delivery".

Justice Ramana was addressing the first All India District Legal Services Authorities Meet here in

which Prime Minister Narendra Modi urged the judiciary to speed up the release of undertrials languishing in jails, awaiting legal aid.

"Justice: Social, Economic and Political-that is the vision of justice which our Preamble promises to every Indian. The reality is, today, only a small percentage of our population can approach the justice delivery system, when in need. A majority of the people suffer in silence, lacking awareness and necessary means," he said.

'Modern India was built around the goal of removing the disparities in society. Project democracy is about providing a space for the



participation of all. Participation will not be possible without social emancipation. Access to justice is a tool for social emancipation,' the CJI said

Echoing the Prime Minister's views on providing legal aid and ensuring the release of undertrial prisoners, he said one of the most important aspects which calls for active consideration and intervention of the legal services authorities in the country is the condition of undertrials.

The Prime Minister and the Attorney General have also rightly flagged this issue in the recently held conference of Chief Ministers and Chief Justices. I am happy to

note that NALSA (National Legal Services Authority) is actively collaborating with all stakeholders in securing the much-deserved relief for undertrials.

Justice Ramana said India, the second most populous country in the world with an average age of 29 years, has a large workforce.

"However, skilled workers are estimated to be only three per cent of our total workforce. We need to harness the full potential of the youthful demographic profile of our country. With the western world increasingly falling short of skilled human resources, it is India's turn to fill the gap, globally," he said. The CJI termed the district judiciary the backbone of the justice delivery system of the world's largest democracy. They are the first point of contact for much of the population and its strengthening is "the need of the hour". he said.

Justice Ramana hailed the services provided by NALSA following its inception 27 years ago and said, "The fact that it is aimed at offering free legal aid to 70 per cent of our population, makes NALSA the largest legal aid provider in the world.'

The CJI also stressed the need for strengthening alternate dispute redressal (ADR) mechanisms like Lok Adalat. mediation and arbitration centres.

Assembly passes Appropriation Bill

he state Assembly Saturday passed the Odisha Appropriation Bill 2022 allowing the state government to spend Rs 2 lakh crore from its consolidated fund during the financial year 2022-23. Speaking on the debate on the Bill, Finance Minister Niranjan Pujari said Rs 89,590 crore has been allocated as administrative expenditure, Rs 1 lakh crore as programme expenditure, Rs 3,210 crore as disaster response fund and Rs 7,200 crore towards transfers from the state. The total programme expenditure outlay for the financial year 2022-23 estimated at Rs 1 lakh crore, which is 33 per cent more than the allocation of 2021-22, he said. Similarly, he said, the capital outlay in 2022-23 is Rs 38,732 crore, which is about 5.4 per cent of GSDP and 56 per cent increase over the previous year. Stating the state government is committed to ensure affordable quality healthcare service for all; Pujari said the allocation to the public health sector has been increased substantially during the past few years. A total sum of Rs 12,624 crore has been proposed for public health care, which is an increase of about 25 per cent over previous year's provision. Similarly, an allocation of Rs 27,324 crore has been made for the education and skill development sector and Rs 21,166 crore for agriculture & allied activities, said the Finance Minister. An outlay of Rs 1.325 crore has been made under ABADHA scheme. while Rs 200 crore has been allocated for EKAMRA and SAMALEI schemes each, he pointed out. Moreover, the government has allocated Rs 14,454 crore during the year 2022-23 for construction and improvement of roads in the state. The Fifteenth Finance Commission and Odisha FRBM Act, 2005 prescribe for limiting the debt to GSDP ratio within 25%. The current debt level of Odisha is 15.2 per cent, which is within the stipulated debt limit, said Pujari.

Monkeypox strain in India different from Europe: ICMR-NIV study

New Delhi, July 30: A team of Indian scientists have found that the monkeypox virus strain circulating in the country is different from the strain that caused 'superspreader events' in Europe, leading to a global outbreak of the disease.

The team from Indian Council of Medical Research-National Institute of Virology (ICMR-NIV), Pune, conducted genetic sequencing of two monkeypox cases from Kerala.

The data showed that the virus strain present in the country is A.2 that was recently imported to India from the Middle East. It was earlier present in Thailand and the US during the 2021 outbreak. However, the strain that caused superspreader events in Europe was due to B.1.

"The present sustained human-human transmission of the monkeypox virus is believed to have happened via superspreader events in Europe with 16,000+ cases now spread across 70+ countries. This largely is represented as the B.1 lineage of the virus and encompass the predominant lineage for genomes in 2022," Vinod Scaria, scientist at CSIR-



Institute of Genomics and Integrative Biology (IGIB), tweeted.

He noted that A.2 is in contrast to the majority of the genomes across the world which belongs to B.1 lineage; and the A.2 cluster, seen in India, is "not suggestive of a superspreader event".

"This would mean" that the cases in the country "are not possibly linked to the European superspreader events", Scaria wrote.

'We might be looking at a distinct cluster of human-human transmission and possibly unrecognised for years.

Climate change bringing worse storms, floods: Scientists

owerful storm systems triggered flash flooding across the US in late July, inundating St. Louis neighbourhoods with record rainfall and setting off mudslides in eastern Kentucky, where at least 16 people died in flooding. Another deluge in Nevada flooded the Las Vegas strip.

The impact of climate change on extreme water-related events like this is becoming increasingly evident. The storms in the US followed extreme flooding this summer in India and Australia and last year in Western Europe. Studies by scientists around

the world show that the water cycle has been intensifying and will continue to intensify as the planet warms. An international climate assessment I coauthored in 2021 for the Intergovernmental Panel on Climate Change lays out the details.

It documented an increase in both wet extremes, including more intense rainfall over most regions,

and dry extremes, including drying in the Mediterranean, southwestern Australia, southwestern South America, South Africa and western North America. It also shows that both wet and dry extremes will continue to increase with future warming.

Water cycles through the environment move between the atmosphere, ocean, land and reservoirs of frozen water. It might fall as rain or snow, seep into the ground, run into a waterway, join the ocean, freeze or evaporate back into the atmosphere. Plants also take up water from the ground and release it through transpiration from their leaves. In recent decades, there has been an overall increase in the rates of precipitation and evaporation.

A number of factors are intensifying the water cycle, but one of the most important is that warming temperatures raise the upper limit on the amount of moisture in the air. That increases the potential for more rain.



Water cycles through the environment move between the atmosphere, ocean, land and reservoirs of frozen water. In recent decades, there has been an overall increase in the rates of precipitation and evaporation.

This aspect of climate change is confirmed across all of our lines of evidence discussed in the IPCC report. It is expected from basic physics, projected by computer models, and it already shows up in the observational data as a gen-

eral increase of rainfall intensity with warming temperatures.

Understanding this and other changes in the water cycle is important for more than preparing for disasters. Water is an essential resource for all ecosystems and

human societies, and particularly agriculture.

An intensifying water cycle means that both wet and dry extremes and the general variability of the water cycle will increase, although not uniformly around the globe.

Rainfall intensity is expected to increase for most land areas, but the largest increases in dryness are expected in the Mediterranean, southwestern South America and western North America.

Globally, daily extreme precipitation events will likely intensify by about 7 per cent for every 1 degree Celsius (1.8 degrees Fahrenheit) that global temperatures rise.

Many other important aspects of the water cycle will also change in addition to the extremes as global temperatures increase, the report shows, including reductions in mountain glaciers, decreasing duration of seasonal snow cover, earlier snowmelt and contrasting changes in monsoon rains across different regions, which will impact the water resources of billions of people.

One common theme across these aspects of the water cycle is that higher greenhouse gas emissions lead to bigger impacts.

The IPCC does not make policy recommendations. Instead, it provides the scientific information needed to carefully evaluate policy choices. The results show what the implications of different choices are likely to be.

One thing the scientific evidence in the report clearly tells world leaders is that limiting global warming to the Paris Agreement target of 1.5 C (2.7 F) will require immediate, rapid and large-scale reductions in greenhouse gas emissions.

Regardless of any specific target, it is clear that the severity of climate change impacts is closely linked to greenhouse gas emissions: Reducing emissions will reduce impacts. Every fraction of a degree matters.

Report said, Rupesh had cold, cough and fever Monday. Later, a local ASHA worker Shanti Gond visited the house of Sukadev and advised him to get his son checked up by a doctor at a local hospital. However, the family members instead of taking the baby to the doctor chose to treat him at home through traditional healing. They called a woman traditional healer to their house, who branded Rupesh with hot iron, Wednesday. In the meantime, the ASHA worker arrived at their house and immediately called a 108-ambulance.

The child' heath condition deteriorated due to branding as she rushed him to Hatabharandi community health centre (CHC) in the afternoon.

The doctors admitted the child for treatment stating that he would stay in the hospital till he recovers. However, the family members who were averse to modern treatment repeatedly requested the doctor to discharge the baby which was rejected by the latter. Meanwhile, the family members allegedly took the child away with them without informing anyone, Thursday.

The doctor at the CHC also lodged a written complaint at Kundei police station in this regard. The ASHA worker again rushed to Sukadev's house where she found the child being branded with hot iron. She tried to explain the ill-effects of branding but the family members refused to listen to her. The branding led to serious burn injuries and finally he succumbed in the wee hours of Friday.

On being informed, Raighar ICDS officer(in-charge) Geetanjali Mishra, supervisor Bhabani Pujari, Anganwadi worker Faral Biswas and ward member Aaiti Gond called upon the victim's family and interacted with them on the issue

When contacted, Kundei police said that they have no information about the child's death

Rehab of 247 left-out families soon

Rajnagar, July 30: The administration will rehabilitate 247 more families from the erosion-hit Satabhaya panchayat under Rajnagar block in Kendrapara at Bagapatia, which is 12 km away from the sea.

Around 247 sea-erosion hit families who have been still residing at Satabhaya panchayat are now a relieved lot. They would be shifted to the rehabilitation colony in Bagapatia soon. Notably, Satabhaya village is on the verge of extinction owing to rapid coastal erosion induced by climate change

The administration relocated 571 families of Satabhaya panchayat at Bagapatia by making a colony since 2013. These families have lost their land, homes and livelihood. With their shifting, they escaped the fury of the

The rehabilitated families, however, lamented that no viable livelihood sources have been created for them till date. However, 247 families had been left out.

Questions relating to provision of the rehabilitation, land, houses, drinking water, roads, drainage and livelithe left-out families were raised by Rajnagar MLA Dhruba Charan Sahoo in the Assembly recently.

In reply, Revenue and Disaster Management Minister Pramila Mallik said that 571 families of Satabhava panchayat, who used to face impacts of climate change, have been rehabilitated. So far, 17,049 people have been relocated at Bagapatia colony while 247 families are to be shifted soon. Steps are being taken for their relocation, Mallik said. She also said that 571 families have

been provided with houses under Biju Pucca Ghar Yojana while a High school and a nodal school have been set up in the colony. Besides, Bharat Nirman Rajiv Gandhi Seva Kendra, four Anganwadi centres have been set up while 32 tube wells were installed, he informed, adding that a pond has been excavated and piped water is being supplied to all the houses in the colony.

As many as 19 roads have been laid and multi-purpose cyclone shelter was built. Quarters for the panchayat executive officer. a community centre. a rural library a Mission Shakti Gruha. market complexes at three places and two culverts have been built.

BUSINESS FOR COMMON GOOD

n an age mediated by advanced technology, it is easy to forget that human beings - and life itself – depend entirely on fragile planetary conditions. In all of these laws, the balance of power is in favour of the State. The individual, who is much weaker than government, is presumed to be equal or even more powerful. This is of course not the case in reality, which is why the jailing of people like political opponents and dissenters and activists is wrong before they have been convicted.

India has never settled into one particular trajectory and our history shows that we have always flirted with being a police State though our Constitution points us the other way. We have taken on and let go of laws that restrict liberty and give all but absolute control over individuals' lives to the State. We take them on because of some fear and the desire of the State for control; we let them go (like we did TADA and POTA) because we realise that the State misuses this absolute authority. Our inability as a nation to also punish the government and its officials who misbehave and misuse the draconian laws is the reason why they keep coming back. When we know that the conviction ratio of the Enforcement Directorate is less than 1 per cent of the cases that it prosecutes, when we know that the ED has been misused against opponents of the government and that 'raids' by the ED are today more than 25 times as they were before 2014, why are we giving the ED more powers? One answer is that many people want the State to have all but unlimited control. This is an attitude that manifests itself in individuals in the judiciary, who are willing and able to put the rights of the government above those of the people. I have little doubt that in time, just as we have done away with other draconian laws, the ones we have gifted ourselves since 2014 will also go. Liberal democracies such as the one our Constitution tells us we are, naturally move towards greater freedom for the individual and more restriction on the State's ability to harm individuals. Our challenge is to make sure that even in desperate times such as the one we are going through now, there is sufficient pushback against this encroachment on our rights and liberties. We must arrive at the place where we are not only not a police State but are also not at all inclined towards becoming one.

Venery

It refers to hunting or the chase. Let us leave unexplored the other meaning, which the Oxford English Dictionary defines as "The practice or pursuit of sexual pleasure". At times it may seem to its participants to resemble a hunt, but that sense isn't connected etymologically: it comes from Venus, the Roman goddess of beauty and love. Our sense is from Old French venerie, which comes from Latin venari, to hunt. The monk in Chaucer's Canterbury Tales describes himself as "An outrider, that loved venery", by which he meant he loved hunting, though Chaucer's tales are so bawdy that incautious readers might assume the other sense. Venery refers to hunting game animals such as wild boar, hares, wolves, bears and especially - deer. A close relative to venery is venison, nowadays always meat from a deer but in earlier times the flesh of any hunted animal. Venery dates from medieval England and is closely connected with the royal forests established by the Norman kings and nobles after the Conquest of 1066 (despite the name, the royal forests included fields and open ground as well as woods). The beasts of venery were those that were considered most noble to hunt. There were animals of a lower order, too, the beasts of the chase, which included the fox, as well as beasts of the warren, such as the rabbit and the pheasant. This led to the expression terms of venery, collective nouns for types of game and other wild animals, such as cete of badgers, murder of crows, parliament of rooks and paddling of ducks.

States to eradicate poverty in all its forms. But the situation at the subnational level is not very encouraging. We are witnessing high multidimensional poverty in Odisha despite being one of the most politically stable and socially peaceful states. Recently, Odisha has also been ranked as the No. 1 performing state in the country by the Ministry of Food & Public Distribution in their State Ranking Index for NFSA 2022 report. In the past, several states have picked up a few lessons from Odisha to manage natural disasters but still were unable to come up to the standards set by Odisha. Odisha also has the distinction of being the first Indian state to become an official sponsor of the national hockey team. Now it has one more feather on its cap for having the distinction of the home state of the first tribal woman President of our country.

But when we shift our focus to the poverty levels, we get a different picture. Odisha is still one of the economically backward states of the country. As per the Niti Aayog's Multidimensional Poverty Index (MPI), Odisha is among the top-10 states with a large per cent of pop-

MPI shifts the focus from income or consumption expenditure to deprivation in health, education and living standards for measuring poverty. Across the above three dimensions it covers nutrition, child and adolescent mortality, maternal care, years of schooling, school attendance, cooking fuel sanitation, drinking water, electricity, housing, bank accounts and assets. People are classified as multidimensionally poor if they are deprived in one third or more of the ten indicators. Those who are deprived in one half or more of the indicators are considered living in extreme multidimensional poverty.

Unfortunately, Odisha is not doing well on the MPI front. According to the 2021 MPI report, more than 1.4 crore people are multidimensionally poor in Odisha. In other words, every third person in Odisha is poor, according to the Niti Aayog. However, we may continue to be happy with our performance if we compare it with states such as Bihar, Jharkhand, UP, MP, Chhattisgarh, and Assam. These are some states where the MPI is in the range of 30-50%. Bihar is at the top of the table with been placed at 17th position among 18 big states with an equity score of minus 1.462. The equity pillar analyses the inclusiveness in terms of the welfare of a society that depends primarily on establishing that all people feel that they have a say in the governance. It is necessary to understand the reasons for such poor performance on equity front despite the presence of a very popular and people-friendly person as the head of the state.

The negative equity score of Odisha is a signal that everything is not fine and there are miles to negotiate before it can be called an empowered state as envisioned by the 5T Charter. It is time for the people in power to revisit, re-examine, and revamp the charter and ensure that each component of the 5T model: teamwork, technology, transparency, transformation, and time limit, is used to strengthen different aspects of governance. Let us work towards making Odisha one of the top states having high equity index and low multidimensional poverty index. Let no one be left behind in this journey.

Hence it is important to recognise that we all depend on healthy wetlands for our water security.

New Delhi, July 30: Convicted Kashmiri separatist Yasin Malik was discharged after remaining admitted at the Ram Manohar Lohia Hospital here for four days and has returned to Tihar Jail. "He (Malik) came back to Tihar

on Friday," Director General (Prisons), Sandeep Goyal, said. Malik was hospitalised by the prison authorities after his health deteriorated on July 26 following his ongoing hunger strike

After returning to his cell, Malik has decided to continue with his hunger strike and is still not having any food. "He is still on intravenous fluids," the top prison official said. The jailed separatist leader, who is currently lodged at Jail No. 7 of the Tihar Prison, went

on the hunger strike on July 22. When asked the reason behind his hunger strike, the official refrained from divulging any details. However, prison sources said that the Kashmiri separatist is protesting against the agencies that are investigating his cases



Malik was arrested immediately after the February 2019 terror strike by Jaish-e-Mohammad and has been in Delhi's Tihar Jail for over two years. The killing of the 40 CRPF personnel in a bomb blast on February 14, 2019, ahead of the Lok Sabha elections, came as a turning point. Within days, Malik was lifted from his Srinagar residence

His JKLF, along with Jamaat-e-Islami, was banned. The country's premeir probe agencies got two high profile cases - Rubaiya Sayeed's kidnapping on December 8, 1989 and the assassination of four Indian Air Force (IAF) personnel on January 25. 1990 -- revived against Malik after a freeze of 10 long years. Malik was convicted in connection with a 2017 terror funding case and sentenced to life imprisonment on May 25 by the National Investigation Agency special court in Delhi in which he pleaded guilty

Kolkata, July 30: The TMC is likely to go in for a major organisational overhaul as well as a reshuffle of the state cabinet following the arrest of now-suspended senior party leader Partha Chatterjee in a multi-crore school jobs scam.

Sources said the reshuffle will also aim at an image makeover for the party hit by school jobs scam probe. Chatterjee, the former virtual number two both in the TMC and the government, was stripped of all ministerial responsibilities and suspended from the party following his arrest last week and the recovery of around Rs 50 crore from flats of his associate Arpita Mukheriee.

On Thursday, Chief Minister and TMC supremo Mamata Banerjee had indicated that a cabinet reshuffle will take place shortly. "Partha Da has been relieved of his ministerial responsibilities. For the time being, I will keep his ministries till a cabinet reshuffle takes place," Banerjee had said.

According to senior TMC leaders privy to the development, overhauling the cabinet was being planned for quite some time, but Chatterjee's arrest hastened the process. "The idea is modeled on Kamaraj Plan of the 1960s when several top Congress ministers had resigned to work for the party. Our

plan was mooted last year after TMC returned to power for the third consecutive term.

"Now, only time will tell whether there will be a wholesale reshuffle or only a few key ministries will be changed," a senior TMC leader said on condition of anonymity. Chatteriee was in charge of five key ministries, including industry, commerce and enterprises and parliamentary affairs.

The TMC leader also pointed

out that the organisational overhaul may reflect the policy of 'one person, one post' call given by leaders close to TMC national general secretary Abhishek Banerjee. "The party organisation will also undergo major changes. The policy of 'one person, one post' will be strictly followed. Some posts such as secretary general, which Partha Chatteriee held, might be abolished. These changes will be implemented with an eye on next

year's panchayat polls and 2024 Lok Sabha elections," he said.

Apart from being secretary general, Chatterjee held the post of party's national vice-president, a member of TMC's national working committee, and chairman of its disciplinary committee, editorship of party's newspaper 'Jago Bangla

This is not the first time that graft allegations have hit the TMC in the last 12 years of its rule in West Bengal. Earlier, four MPs and ministers each of the party were arrested for alleged involvement in Saradha and Narada scams. However, the party had then termed it political vendetta, unlike Chatterjee's case when the party shunted him out.

TMC's national spokesperson Sukhendu Sekhar Ray, when contacted said, "As soon as we came to know about it, we took action against him. This itself says that the party in no way supports corruption." Another party spokesperson Krishanu Mitra said "one or two bad eggs" will not be able to halt Mamata Banerjee's vision of replacing slogans with actions.

"The party supremo has devised a political culture to seek out leaders of merit and character and turn politics meritocratic," he said. Political analyst Maidul Islam feels the overhaul both in the ministry and in the party is the best possible way for an image makeover.

Over 30,000 kg drugs destroyed

New Delhi, July 30: Over 30,000 kg of drugs were incinerated in four locations across India Saturday in the virtual presence of Union Home Minister Amit Shah.

Shah was present at a conference in Chandigarh from where he watched virtually the incineration of the seized drugs in Delhi, Chennai, Guwahati and Kolkata. The home minister said following a call of Prime Minister Narendra Modi to celebrate 'Azadi Amrit Mahotsav', a pledge had been taken

to destroy about 75,000 kg of drugs. "Glad to share that till today, we have already incinerated 82,000 kg of drugs and will reach the 1 lakh kg mark by August 15," he said.

The Narcotics Control Bureau (NCB) had started the drug disposal campaign from June 1 and over 51,217 kg of narcotics has been disposed by it in 11 states till July 29, an official said. After the the total quantity will reach around 81,686 kg surpassing the NCB's target, which is a big achievement in the fight towards a drugs-free India, the official said.

On Saturday, 19,320 kg of drugs were destroyed in Delhi, 1,309 kg in Chennai, 6,761 kg in Guwahati and 3,077 kg in Kolkata. Shah said at the conference in Chandigarh that the central government has adopted a zero-tolerance policy towards narcotics and it was showing results.

He said this is necessary to achieve the objective of a healthy society and prosperous nation. Shah said it was also important from the security point of view as "the dirty money" which is generated from the drug trade is used in activities against the country. "A man named Sandeep Kumar Pathak from Sadabad in Hathras district has filed the complaint against the writer. In the complaint, he has blamed Geetanjali Shree for alleged objectionable comments on Lord Shiva and mother Parvati." he said.

Spokesperson of the event Rambharat Upadhyay said that in his complaint, Pathak mentioned that the comments have "hurt the sentiments of Hindus". In May, Shree became the first Indian author to win the International Booker Prize for her novel "Ret Samadhi", which was translated into English as "Tomb of Sand" American translator bv Daisy Rockwell.

Set in north India, "Tomb of Sand" is the tale of 80-year-old Ma,

who insists on travelling to Pakistan, simultaneously confronting the unresolved trauma of her teenage experiences of Partition, and re-evaluating what it means to be a mother, a daughter, a woman and a feminist.

Upadhyay also said Pathak had tweeted requesting Uttar Pradesh Chief Minister Yogi Adityanath and the DGP for an FIR against Shree. Shukla said people are disappointed over the cancellation of the event.

Three arrested

Gadchiroli Superintendent of Police (SP), Ankit Goel said that the suspected Maoists were arrested when a police team patrolling in the area saw them putting up pro-Maoist banners at Kamalapur, provoking the tribal population to protest against the state government and the police for - what they claimed to be "anti-people" policies.

Need to fight religious animosity together, says Doval

New Delhi, July 30: National Security Advisor (NSA) Ajit Doval Saturday said some people try to create animosity in the name of religion and ideology, which affects the entire country and everyone, especially religious leaders, will have to work together to counter this. Doval also said efforts are re-

quired to clear misunderstandings and make all the religious bodies in the country feel that they are an integral part of it. The NSA made these remarks in the presence of religious leaders at an interfaith conference organised by the All India Sufi Sajjadanashin Council (AISSC) at the Constitution Club here.

"Some people try to create animosity in the name of religion, which adversely affects the entire country and also has ramifications internationally. We cannot be a mute spectator to this. To counter religious animosity, we have to work together and make every religious body feel a part of India. In this, we sail and sink together," he said.

At the conference, religious leaders under the aegis of AISSC passed a resolution to "ban organisations like the Popular Front of India (PFI)" and other such fronts that have been "indulging in anti-national activities

The resolution also said targeting any god, goddess or prophet during discussions or debate by anyone should be condemned and dealt with in accordance with law. Doval said there is a need to reach out to everyone, include them in the fight against radical forces and tell them that there is no place for hatred and agitation against any religion in India.

"There is a need to create an emotion that we will not let the unity of the country be compro-



mised. We have to inculcate a belief in everyone's heart that each Indian is safe here. We have to be organised, we have to raise our voice and rectify the mistakes," he said.

Doval told the religious leaders that they have to play a major role in improving the atmosphere in the country."Every religion has contributed to the growth of the country. We have to think what kind of India we will give to our future generations. You (religious leaders) have bigger responsibilities to shoulder," he said.

The aim of the conference was

to have discussions among the representatives of different faiths about the "growing religious intolerance" in India. The resolution passed by the conference proposed to create a new body, inclusive of all faiths, to spread the message of peace, harmony and fight against radical forces.

"Organisations like the PFI and 🗎 any other such fronts, who have been indulging in anti-national activities, pursuing a divisive agenda and creating discord amongst our citizens, must be banned and action should be initiated against them as per the law of the land,' the resolution read.





Gujarat court speaks of 'ulterior motives' of Teesta, Sreekumar

Ahmedabad, July 30: A sessions court here Saturday rejected the bail applications of activist Teesta Setalvad and former Director General of Police RB Sreekumar, arrested for allegedly fabricating documents to frame innocent people' in 2002 riots cases.

The accused apparently aimed to "destabilize" the Gujarat government and defame the state for their ulterior motives, additional principal judge DD Thakkar said while denv ing them relief. Former IPS officer Sanjiv Bhatt, a third accused in the case, had not applied for bail Bhatt was already in jail in another case when he was arrested. "It appears that the accused aimed to destabilise the government and tarnish the image of Gujarat within the country and abroad by using false documents to accuse the then government of having sponsored post-Godhra riots," the sessions court said in the order.

"It appears that the two accused were actively interested in defaming the state of Gujarat for their ulterior motives as well as political aspirations," and they did so for obtaining "personal goal and monetary benefit from one political faction as well as other countries," the court said. Setalvad and Sreekumar were arrested by the Ahmedabad city crime branch in June after an FIR was registered against them under

IPC sections 468 (forgery for cheating) and 194 (fabricating false evidence with intent to procure conviction for capital offences).

The arrests followed within a couple of days after the Supreme Court June 24 dismissed a petition filed by Zakia Jafri, whose husband and former Congress MP Ehsan Jafri had been killed during the 2002 Gujarat riots. Setalvad had helped Zakia Jafri pursue her legal battle. Both Setalvad and Sreekumar denied the allegations by Gujarat police in the present case. While opposing bail, the SIT probing the case cited a witness' statement to allege that the accused were part of a conspiracy carried out at the behest of late Congress leader Ahmed Patel to destabilise the Gujarat government led by then CM Narendra Modi.

At Patel's behest, Setalvad received Rs 30 lakh after the post-Godhra riots in 2002, it claimed. Setalvad used to meet the leaders of a "prominent national party in power at that time in Delhi to implicate names of senior leaders of the BJP government in riot cases," the SIT further alleged.

Sreekumar was a "disgruntled government officer" who "abused the process for damning the elected representatives, bureaucracy and police administration of the whole state of Gujarat for ulterior purposes," the SIT claimed.

Lumpy skin disease spreads in several Gujarat districts

Gandhinagar, July 30: Amid the alarming spread of Lumpy Skin Disease (LSD), a viral infection affecting cattle in the state, the Gujarat government has declared 15 districts as 'controlled areas'.

A notification issued by Deputy Secretary (Animal Husbandry) Dr KN Trivedi said that now cattle cannot be transported out of these districts.

"The Government of Gujarat, hereby declares districts Amreli, Banaskantha, Bhavnagar, Botad, Dev-Bhumi Dwarka, Gir-Somnath, Jamnagar, Junagadh, Kutch, Morbi, Porbandar, Rajkot, Surendranagar, and Patan as "Controlled Areas" in respect of "Lumpy Skin Disease", as it is scheduled disease for cattle,"

The state government has directed all these district administrations to prohibit the movement of cattle from the place where they are kept to any other places within and outside the said districts.

District authorities will ensure that no live cattle trade, fair, exhibition, games and gathering in these districts should take place. This is to be enforced till the disease is brought under control.

The Gujarat government has adequate stock of goat pox vaccine to inoculate bovine animals infected with lumpy virus, Director of the Animal and Husbandry department Dr Falguni Thakar said Friday "Lumpy virus has roots from capripox virus seen in goats. So the vaccine administered to goats is now administered to bovine animals infected with lumpy virus. The animal husbandry field offices have 7,07,496 doses of the vaccine.' Refuting rumours about shortage of vaccines in the state, the director said that she too has heard the audio clips between two veterinary doctors of the city. Both the doctors, she said, are on contract at the Jamnagar Municipal Corporation.

Chennai, July 30: It was in Salem district of Tamil Nadu in 1937 that the Congress government of C. Rajagopalachari imposed prohibition, a first in the country. It was extended across the state in 1948 immediately after Independence.

This prohibition in Tamil Nadu continued with Kamaraj at the helm of affairs in the state.

The Madras Abkari Act was introduced in 1886 that placed strict regulations and banned the sale of local liquor. This British policy helped the sale of foreign liquor instead of 'desi' beverages.

The DMK government led by party ideologue M. Karunanidhi, lifted the ban in 1971 citing revenue loss without a nationwide ban, and allowed the sale of arrack and toddy — the 'desi drinks'. However, Karunanidhi had to stop the sale of toddy and arrack in 1974.

The ban on arrack and toddy led to the manufacturing of spurious drinks and methanol, the industrial alcohol, was widely used leading to several deaths in the state in 1975-76. The sale of liquor and toddy was later reintroduced in the state by matinee idol turned chief minister, MG Ramachandran (MGR) when he was catapulted to power as an AIADMK leader in 1981.

MGR even reduced the age for securing a liquor permit for foreign liquor consumption from 45 years to 30 years. In 1981 finance minister VR Nedunchezhiyan further reduced the age to 25.

In 1983, the state government under MGR, set up the Tamil Nadu

State Marketing Corporation a (Tasmac), and the sale of Indian Made Foreign Liquor (IMFL) and arrack were brought under it. Six years after the sale of arrack and toddy began, the MGR government banned local drinks t January 1, 1987.

Politicians of all hues while in power in Tamil Nadu justify the sale of liquor saying that the revenue generated through huge taxation on liquor is being used to support social welfare schemes that have led to a robust social index for the state.

Gandhian activist M Idiyanarayanan told IANS: "It is a wrong theory that you sell liquor, make money by charging the tipplers heavily and use this money for welfare schemes."

"Welfare is a state subject and the money for that must not be generated through liquor; instead, policymakers must look to other avenues for raising money. Liquor is evil and the government must refrain from generating funds through liquor sales, creating disharmony in the society."

With Tasmac enjoying a monopoly and arrack banned in the state, hooch deaths have now reduced considerably except for the odd one or two cases across the state.

Dr R Padmanabhan, Director, Socio-Economic Development Foundation, a think tank based out of Madurai, told IANS: "The government data available shows a significant increase in the number of people consuming alcohol,

and the age limit has all gone for a toss. Whoever has money can walk into a Tasmac shop and buy alcohol."

"According to a study, 47.4 per cent of rural men and 46 per cent of their urban counterparts consume alcohol and this is not a welcome trend for society and the political leadership who are pitching for a trillion-dollar economy."

Padmanabhan added that there was clear evidence of the correlation between increased consumption of alcohol and domestic violence, sexual abuse, crimes, broken families, suicides and less productivity.

He said the way forward lies in the middle path deploying a multipronged approach.

The state government is also mulling reducing the number of Tasmac outlets and instead increasing taxes at the elite outlets of the corporation.

Sources in the government told IANS that it was planning to bring in an Aadhaar linked cap on the quantity of alcohol sold to one person.

Boosting the export market is also another idea that the policymakers are contemplating so that the revenue is brought in without much damage to the physical and mental health of the people of the state.

With the Tamil Nadu government raising Rs 33,811.15 crore through the sale of liquor in 2020-21, a move to stop the sale or even reduce the sale of liquor is financially not feasible. Taking questions after his address at the conclave, Stalin dubbed as "autocratic behaviour" arrest of journalists and central agencies "targeting" Opposition leaders.

"It is wrong to snatch away the rights provided by the Constitution, created after independence which was ensured after much struggle. My opinion is that this is a betrayal of the freedom fighters," he said.

On the "one country, one language" issue, concerning Hindi and the protests against the same in Tamil Nadu and Kerala recently, Stalin said India was a country where many languages were spoken. One language cannot become the national language or official language. "If it so happens, others languages will be destroyed gradually," he said. Well. Thevarina Kootamaippu coordinator, M. Alagarasamy while speaking to IANS said: "Thevar community has been a traditional support base for the AIADMK and our enemies are trying to finish off by using our own people who had aligned with other caste leaders. The expulsion of OPS from the AIADMK and how he was insulted in the June 23 general council meeting has pained the Thevar community. Let OPS and V.K. Sasikala join together and take over the party."

The community leaders also urged the leaders to commence their campaign from South Tamil Nadu where the community is strong and spread it from Nagapattinam to Tirunelveli and from Coimbatore to Vellore.

Chandigarh, July 30: Facing humiliation at the hands of a minister in the AAP government, one of country's top orthopaedic surgeons and Vice-Chancellor of Baba Farid University of Health Sciences Raj Bahadur, sent his resignation to Punjab Chief Minister Bhagwant Mann Saturday.

Raj Bahadur resigned citing humiliation by Health Minister Chetan Singh Jouramajra during an inspection to Guru Gobind Singh Medical College and Hospital in Faridkot on Friday. Some other medical officers also resigned in protest.

The newly-inducted minister was caught in a row when he asked Raj Bahadur to lie on a "dirty" patient's bed during the visit. A video of the minister "forcibly asking the Vice-Chancellor to lie on the bed" has gone viral on social media. The minister can be heard speaking "rudely" with the Vice-

Chancellor over the lack of cleanliness in the medical college, despite explanation by decorated Bahadur. who was on his third extension as the Vice-Chancellor, that they were trying to give proper facilities to patients with all available resources. At this, the minister got him to lie on the patient bed in the dermatology department.

Infuriated by the misbehaviour meted out to Bahadur, O.P. Chaudhary, secretary to the vicechancellor, also submitted his resignation. The incident has triggered anger

among the medical fraternity who were demanding an apology from the health minister for his 'unrulv' behaviour.

In a joint statement, senior vicepresident of the Indian Doctors for Peace and Development, Arun Mitra, and Punjab Medical Council former president G.S. Grewal said: "The ills in the healthcare system are because of poor funding by the government and not because of the vice-chancellor.

"The allocation to health in the recent budget is only 3.03 per cent

instead of the required 11 per cent.

With this meagre amount, one can

only expect torn sheets and mat-



tresses on hospital beds!" They said Bahadur is "a surgeon par excellence who has worked with dedication with no finger to be pointed towards him". Condemning the incident, the

Indian Ortho Association has demanded an inquiry into the episode. Joining the issue, Congress legislator Pragat Singh said the Chief Minister should immediately dismiss his Health minister for publicly humiliating one of "our med-

ical luminaries" "The theatrics of @AAPPunjab HM heavily cost Punjab. Principal Govt Medical College Amritsar Dr. Rajiv Devgan and now VC Baba Farid University Dr. Raj Bahadur has resigned. TEACHER HELD IN ASSAM OVER TERROR LINKS

Guwahati, July 30: Another madrasa teacher was detained by the Assam police Saturday in connection with the terror links with Al-Qaeda in the Indian Subcontinent (AQIS) and the Ansarullah Bangla Team (ABT) module.

Moriagaon Superintendent of Police Aparna Natarajan said that all the three individuals were brought only for questioning. The police are conducting an investigation to collect more evidence in connection with the case. There were reports that the case was handed over to National Investigation Agency. Natarajan, however, denied this, saying only Assam Police are investigating the matter.

BJP LEADER'S MURDER ABVP activists baton-charged

Bangalore, July 30: Akhil Bharatiya Vidyarthi Parishad (ABVP) activists were batoncharged and driven away when they barged into the residence of Karnataka Home Minister Araga Jnanendra here Saturday seeking "justice" for a BJP youth wing leader, who was murdered in Dakshina Kannada district.

Ansari is the MLA of Jamtara, while Kachchap is the legislator of Khijri in Ranchi district, and Kongari is the MLA of Kolebira in Simdega district.

Jharkhand Congress's spokesperson Rajiv Ranjan Prasad said the party will comment only after getting the details of the incident.

At present, the health condition of two other persons, who had also tested positive for the infection, remains satisfactory, the minister said, adding prevention and surveillance measures would be continued with the same vigour.

The Kollam native, who had returned to Kerala from abroad and was hospitalised after showing symptoms of monkeypox, tested positive for the disease on July 14.

According to WHO, monkeypox is a viral zoonosis (a virus transmitted to humans from animals), with symptoms similar to those seen in the past in smallpox patients, although it is clinically less severe.

With the eradication of smallpox in 1980 and subsequent cessation of smallpox vaccination, monkeypox has emerged as the most important orthopoxvirus for public health.

Zurich, July 30: The head of the Swiss agency that implements economic sanctions expects the neutral country to adopt any punitive measures the European Union launches against China if it invades Taiwan, she said in a news paper interview.

China has been stepping up military activity around Taiwan seeking to pressure the democratically elected government there to accept Chinese sovereignty. Taiwan's government says only the island's 23 million people can decide their future, and while it wants peace, it will defend itself if attacked.

Asked by the Neue Zuercher Zeitung paper if Switzerland would adopt EU sanctions against China in that case, State Secretariat for Economic Affairs (SECO) Director Marie-Gabrielle Ineichen-Fleisch said: "I strongly believe that we would adopt such sanctions. However, sanctions in the case of China would be far more drastic (than sanctions against Russia) because the economic relations are much more important. Therefore, there would probably be greater discussions in the EU and the United States as well as in Switzerland than there were in Russia. But I hope it will never

come to that. Ineichen-Fleisch defended Switzerland's record on adopting EU sanctions against Russian individuals and companies over Russia's invasion of Ukraine in February, which Moscow describes

as a "special military operation". Pressure has mounted on Switzerland -- a popular destination for Moscow's elite and a holding place for Russian wealth -- to more quickly identify and freeze assets of hundreds of sanctioned Russians.

As of this month Switzerland has frozen 6.7 billion Swiss francs (\$7.04 billion) worth of Russian financial assets and 15 properties, and Ineichen-Fleisch said this figure was unlikely to change much.

"We at SECO have no indication that there are many assets of sanctioned persons that have not

yet been found," she said.

'Year-on-year inflation for the month stood at 6.16 per cent compared to 6.97 per cent for the previous month (May 2022) and 5.57 per cent during the corresponding month (June 2021) a year before, a labour ministry statement said.

It said the food inflation stood at 6.73 per cent in June against 7.92 per cent in the previous month and 5.61 per cent in June 2021.

The all-India CPI-IW (consumer price index for industrial workers) for June 2022 increased by 0.2 points and stood at 129.2 points. CPI-IW was 129 points in May 2022.

Yes Bank manages \$1.1 bn commitment from Carlyle, Advent

Mumbai, July 30: After trials and tribulations on fundraising that lasted well over three years, Yes Bank Friday announced that private equity funds Carlyle and Advent International will be investing \$1.115 billion (around Rs 8,900 crore) to fuel its future growth.

Both the global PE funds will be acquiring a 10 per cent stake each in the private sector lender, which had to be bailed out in a RBI and government-led reconstruction scheme for want of capital buffers and after the then management failed to sell the bank's story to investors.

In a statement, the bank said \$640 million or Rs 5,100 crore has been raised by issuing equity shares and \$475 million or Rs 3,800 crore through equity share warrants. As part of the capital raise, which is the second biggest for any private sector lender, the bank will issue 370 crore equity shares on a preferential basis at a price of Rs 13.78 per share, and 257 crore warrants convertible into equity shares at a price of Rs 14.82 per warrant.

The Yes Bank scrip closed 2.47 per cent up at Rs 14.94 apiece on the BSE, as against gains of 1.25 per cent on the benchmark Sensex.

The announcement comes within a fortnight of the bank disclosing J C Flowers Asset Reconstruction Company to be the base bidder for resolving Rs 48,000 crore of dud assets it carries on its books, transferring which will get its gross non-performing assets ratio down to under 2 per cent from the present 14 per cent.

Washington, July 30: Cryptocurrencies have been hard hit by fears interest rate hikes will end the era of cheap money, with the world's largest digital asset, bitcoin, down more than 56% from this year's high. Several crypto companies have filed for bankruptcy or have been forced to look for emergency capital infusions.

Three Arrows Capital Singapore-based crypto hedge

fund Three Arrows Capital (3AC) filed for Chapter 15 bankruptcy Julv 1. Once a formidable player in the

digital asset space, the downfall of 3AC appeared to stem from the

firm's bet on the Terra ecosystem, which was behind failed stablecoin terraUSD. That token lost nearly all of its value in May, shaving almost half a trillion dollars off the crypto market.

High-leveraged, 3AC was unable to meet margin calls from counterparties it had borrowed from. Consequently, crypto lenders BlockFi and Genesis Trading liquidated their positions with the firm. According to court filings, 3AC's creditors claim they are owed more than \$2.8 billion.

Celsius Network New Jersey-based crypto lender Celsius suspended withdrawals June 12 and a month later filed for Chapter 11 bankruptcy, listing a



\$1.19 billion deficit on its balance sheet. It had been valued at \$3.25 billion in a funding round in October.

Celsius stumbled on complex investments in the wholesale digital asset market. The company had attracted retail investors by promising annual returns as high as 18.6%, but struggled to meet redemptions as crypto prices slumped. In its first bankruptcy hearing,

Celsius lawyers said that its bitcoin mining operations could provide a way for the company to repay customers.

Voyager

Crypto lender Voyager Digital, also based in New Jersey, had been a rising crypto star, reaching a \$3.74 billion market cap last year. But the collapse of 3AC dealt a major blow to Voyager, which was heavily exposed to the hedge fund. Vovager has filed claims of more than \$650 million against 3AC.

Voyager filed for Chapter 11

bankruptcy July 6, reporting that it had \$110 million worth of cash and crypto assets on hand. Since then, the US Federal Deposit Insurance Corp has confirmed that it is probing Voyager's marketing of deposit accounts for cryptocurrency purchases, which the company had advertised as being FDIC-insured.

Crypto exchange FTX and Alameda Research, both founded by billionaire Sam Bankman-Fried, offered to purchase all of Vovager's digital assets and loans, except its loans to 3AC, and enable Voyager customers to withdraw their assets from an FTX account. However, Vovager rebuffed that offer in a court filing as a "low-ball bid."

Vauld Singapore-based crypto lender Vauld July 8 filed with a Singapore court for protection against its creditors, after suspending withdrawals days earlier. The company owes \$402 million to its creditors,

according to a report from The Block. Vauld is backed by billionaire investor Peter Thiel's Valar Ventures, Pantera Capital and Coinbase Ventures.

In a July 11 blog post, Vauld said it is discussing a possible sale to London-based crypto lender Nexo while at the same time exploring potential restructuring options.

BlockFi

Facing an increase in withdrawals and a hit from 3AC, crypto lender BlockFi signed a deal July 1 with FTX that provides BlockFi with a \$400 million revolving credit facility, and includes an option that enables FTX to buy the company for up to \$240 million.

BlockFi was hard hit by the crypto crash, and implemented multiple cost-cutting measures in June, including slashing its headcount by 20% and cutting executive compensation. The company wasvalued at \$3 billion in a funding round last year.

The clipping was from the U-20 World Athletics Championship in Tampere, Finland in 2018 when the athlete from Assam became the first Indian to win the championship.

Sehwag was one of the victims of the misleading video as he wrongly tweeted that the sprint star has won gold in 400m event at the CWG, only to delete it after the goof-up was brought to his notice.

The cricketer's now-deleted tweet read: "What a win! Indian athletes have totally arrived. Many congratulations to Hima Das on winning gold in the 400m at the Commonwealth Games, Fakr Hai,"

The track and field competitions are scheduled to take place at the Alexander Stadium from August 2. Hima is scheduled to contest in the 200m race, which will take place August 4. The semifinals and final of the event will take place August 5 and 6 respectively.

"I wanted to clarify a couple of things about my health and fitness. My surgery in June was successful and I had begun my training with hope of returning to national duty for the tour of West

Indies. Unfortunately as I was returning to full fitness, I tested positive for Covid-19," he tweeted. He expressed hope of coming back for Asia Cup in UAE.

Off-spinner Washington Sundar is back in the squad along with seamer Deepak Chahar after successful completion of his rehabilitation following hamstring and back injuries. Chahar has not played competitive cricket for five

months now and also missed the 2022 IPL season. "KL Rahul has recovered from COVID-19 but his hamstring injury seems to have resurfaced. He was supposed to be picked for Zimbabwe but now one can't put a date on his comeback," a senior BCCI source privy to development told PTI Saturday.

Meanwhile, Virat Kohli, skip-



per Rohit Sharma, Rishabh Pant, Mohammed Shami, Jasprit Bumrah and Hardik Pandya have all been rested from the tour as ODIs aren't top priority for the side with less than three months left for the World T20.
