#### **Retail inflation falls** to 6.77% in October

New Delhi: Retail inflation dropped to 6.77 per cent in October from 7.41 per cent in the preceding month, mainly due to easing prices in the food basket, though it remained above Reserve Bank's comfort level for the 10th month in a row, according to the government data released Monday. The Consumer Price Index (CPI) based retail inflation has remained above the 6 per cent target since January this year. Another set of data released earlier in the day revealed that the wholesale price index (WPI)based inflation dipped to a 19-month low of 8.39 per cent in October on easing prices of food, fuel and manufactured items.

#### Mamata apologises for minister's slur on Prez



## Forced religious conversion danger to nat'l security: SC

*Terming it as a "very serious" issue, the top court says there* is freedom of religion, but no freedom on forced conversion

New Delhi, Nov 14: Forced religious conversion may pose a danger to national security and impinge on religious freedom of citizens, the Supreme Court said Monday, and asked the Centre to step in and make sincere efforts to tackle the very serious issue.

The court warned a very difficult situation will emerge if proselytisation through deception, allurement and intimidation is not stopped.

The issue with respect to the alleged conversion of religion, if it is found to be correct and true, is a very serious issue which may ultimately affect the security of the nation as well as the freedom of religion and conscience

of the citizens. Therefore, it is better that the Union government may make their stand clear and file counter on what steps can be taken by Union and/or others to curb such forced conversion maybe by force, allurement or fraudulent means, a bench of Justices MR Shah and Hima Kohli said.

The court asked Solicitor General Tushar Mehta to enumerate measures to curb the practice.

"This is a very serious matter. Sincere efforts are to be made by

the Centre to stop forced conversions. Otherwise very difficult situation will come. Tell us what action do you propose....You have to step in." the bench observed

Mehta submitted before the top court that the issue was debated even in the Constituent Assembly.

There were two Acts. One was by the Odisha government and other one by Madhya Pradesh dealing with regulation of any forcible conversion by deceit, falsehood or fraud, money. These

issues came before this court for consideration and the top court upheld the validity, Mehta said.

The solicitor general said forced religious conversions are rampant in tribal areas. Many a time

> the victims are not aware they are the subject matter of criminal offence and would say they are being helped,

Mehta said. The top court observed there may be freedom of religion but there cannot be freedom of religion by forced conversion

"Antecedents of petitioner are very dubious. I didn't know about it when I took the case. I found it later. Please appoint an amicus curiae in the matter as the case in may use this case as a weapon to blackmail," Bhushan submitted in the court.

Additional solicitor general Aishwarya Bhati submitted that the Union government want to place a status report.

On being asked about CBI's status report. ASG Bhati submitted that some aspects of the case are being investigated by CBI while some aspects by ED and sought

#### Man murders live-in partner, chops her body into 35 pieces, dumps across Delhi



New Delhi/Mumbai, Nov 14: A 28-year-old man allegedly strangled his live-in partner and sawed her body into 35 pieces which he kept in a 300-litre fridge for almost three weeks at his residence in South Delhi's Mehrauli before dumping them across the city over several days, police said Monday.

In a harrowing tale of betrayal and subterfuge, the accused, a trained chef, evaded detection for six months, continued to live in the house they shared and was only arrested early Saturday after details of the killing and its grisly aftermath came to light during his interrogation.

Accused Aaftab Amin Poonawala told the police during the investigation that he killed Shraddha Walkar after a quarrel over marriage and the idea of chopping her body into pieces was inspired by 'Dexter', an American crime TV series.

He not only bought the fridge to preserve the body parts but also stocked incense sticks and room fresheners to suppress the foul smell emanating from the corpse.

Stepping out past midnight with body parts packed in poly bags, the accused meticulously planned which ones to dispose of first depending upon which part starts decomposing at the earliest, the police said.

According to police officials, 13 body parts were found after the accused pinpointed the areas where he had thrown them, but only after their forensic examination, it can be confirmed if they belong to the victim. They are yet to find the

murder weapon. For the next few weeks after the murder, Poonawala allegedly interacted with the woman's friends using her social media accounts so as to not arouse any suspicion. Walkar was not talking to her family as they had objected to their relationship.

Moving on with his life as if nothing happened, the accusedcontinued to live in the same place where they had shifted in May.

## World population to hit 'eight billion' milestone today

In an editorial penned ahead of the momentus day, UN chief Guterres warns that as our human family grows larger, it is also growing more divided

San Francisco, Nov 14: Today, November 15, is predicted to be the day that the global population hits eight billion, a milestone in human development. The United Nation's World Population Prospects 2022 report also says that India is on course to surpass China as the world's most populous country in 2023.

This unprecedented growth is due to the gradual increase in human lifespan owing to improvements in public health, nutrition, personal hygiene and medicine. It is also the result of high and persistent levels of fertility in some

countries. Currently, the global population is growing at its slowest rate since 1950, having fallen under 1 per cent in 2020.

The UN further says that while it took the global population 12 years to grow from 7 to 8 billion, it will take approximately 15 years—until 2037—for it to reach 9 billion, a sign that the overall growth rate of the global population is slowing. The population is





predicted to peak at around 10.4 billion in the 2080s and to remain there until 2100. "It is a reminder of our shared responsibility to care for our planet and a moment to reflect on where we still fall short of our commitments to one another," said UN Secretary General Antonio Guterres.

A majority of the projected population growth up to 2050 will take place in eight countries: the Democratic Republic of the Congo, Egypt, Ethiopia, India, Nigeria, Pakistan, the Philippines, and Tanzania, according to the report.

"The relationship between population growth and sustainable development is complex and multidimensional," said Liu Zhenmin, UN Under-Secretary-General for Economic and Social Affairs.

'Rapid population growth makes eradicating poverty, combating hunger and malnutrition, and increasing the coverage of health and education systems more difficult," he added. Global life expectancy at birth reached 72.8 years in 2019, an improvement of almost 9 years since 1990, said the report. By 2050, it is projected that global life expectancy will be 77.2 vears. However, in 2021, the leastdeveloped countries lagged behind the global average by 7 years.

## Resume work or lose licence, lawyers told

The apex court puts all the bar associations concerned and their office bearers on notice and says that non-compliance of the court's order will invite contempt of court proceedings

New Delhi, Nov 14: Expressing anguish over frequent agitations by several district bar associations in Odisha, the Supreme Court Monday warned the protesting advocates to withdraw the strike by Wednesday else their licences may be suspended.

The Supreme Court noted that access to justice is the very foundation of the legal system and the legal fraternity is instrumental in people's access to justice at large. When the very instruments abstain from court proceedings, the casualty is the access to justice to com-

mon people. The conduct of many associations and lawyers (in Odisha) has been far from satisfactory. We will not countenance this," the

apex court said. A two-judge bench of Justices Sanjay Kishan Kaul and Abhay S Oka refused the request of Central Action Committee of All Bar Associations of Western Odisha to put the suspension order of office bearers of five bar associations in abeyance and grant it time to respond on the issue. The bench said that even if it has to suspended 100-300 advocates, it will do so. "We won't tolerate this. We will take away your source of income if you continue the strike. The litigants are suffering because of these agitations. This is completely unacceptable," Justice Kaul said.

The apex court put all concerned bar associations and their office bearers on notice and held that non-compliance of the court's order will invite contempt of court proceedings. "We expect full working by all bar associations by day after tomorrow, failing which, the Bar Council of India (BCI) is expected to take action for suspension and cancellation of the licences of lawyers," the court said.

During the hearing, the bench was apprised about an order passed by the BCI Sunday suspending the presidents, vice presidents, secretaries and members of executive committees of five bar associa tions in the state for encouraging the abstention of work. The BCI suspended the office bearers of Sambalbur District Bar Association. Baramba Bar Association in Cuttack district, Tangi Bar Association in Khurda district, Talcher Bar Association and Pallahara Bar Association in Angul.

The bench said that while it appreciates the steps taken by the chairman of BCI in pursuance of the duties he has, further action would be required by the BCI if they do not fall in line. The Bar Council of Odisha chairman and advocate general Ashok Parija informed that 20 associations have been agitating.

Significantly, the apex court order came on an application filed by the Registrar General of Orissa HC through advocate Sibo Sankar Mishra stating that members of the bar associations of several districts have abstained regular court proceedings for seeking establishment of permanent bench of Orissa HC in western Odisha and for several other reasons.

A total of seven premises in the state were searched, the ED said in a statement. Meanwhile, ED sleuths Sunday grilled the lady blackmailer's father, Surendra Nag, at its office in Navapalli here. The sleuths tried to ascertain the details as to how Surendra managed to construct the three-storey building on a government property at Kesinga in Kalahandi. The sleuths also asked him as to how much money he received from Archana during the last five years, details of the persons having links with Archana and when she came in contact with Jagabndhu.

But Khurda district tops the state with high diabetes cases. Sources informed that Khurda district has the maximum

rural populace affected by diabetes in the state followed by Sambalpur and Kandhamal. Cuttack also figured in the high-burden list, revealed the data. Though proportionately more males are affected by diabetes than females, Keonjhar and Jharsuguda are two exceptions noticed in the state, data revealed. About half-a-dozen districts in state have diabetes affected population more than the state average, sources informed.

Diabetes mellitus is arguably one of the "biggest known killers of humankind" and this menace can only be addressed through right education and through "access to diabetes education", which is the theme for this year's World Diabetes Day, say healthcare professionals.

Jajpur, Nov 14: Delay in acquisition of forest land has hit six important projects in the state, sources said Monday. Some of these projects have failed to take off, while others have been stalled mid-way. This has happened due to the delay in conversion of forest land into nonforest plots.

Among the projects are Khurda Road-Bolangir rail route, the double-laning of the Sambalpur-Talcher railway tracks, Anandpur barrage, operations of Utkal Coal mines, construction of a cement plant by Dalmia Bharat Group in Malkangiri district and a bauxite mining project at Pottangi in Koraput district.

Expressing concerns over the delay, Special Secretary of Environment, Forest and Climate Change department, Deben Kumar Pradhan has asked through a letter dated November 7, 2022, the principal chief conservator of forests (PCCF), head of forest force (HOFF) and principal chief con-

In Nayagarh district, 292.28 hectares of forest land spread over 143km is awaiting clearance from the Wildlife department. The proposal has been submitted with Boudh and Nayagarh divisional forest officers (DFOs), February 19, 2020.

hectares of forest land.

Similarly, 23.2 hectares of forest land conversion for Sambalpur-Talcher rail route expansion is in stage-1 and awaiting clearance.

Conversion of 79.793 hectares of forest land for Anandapur barrage project in Keonjhar district has failed to make any progress. The project is scheduled for completion by March 31, 2024. The work for the barrage project was taken up on the Baitarani river in 2005-06 for which funds worth ₹2,864.36 crore were sanctioned by both the Centre and the Odisha government. However, the authorities have spent only ₹1,715.93 so far on the project so far.

The headwork of the project has been completed while 73 per cent of the main canal and only five per cent of the distribution system have been done. The project when completed will help in irrigating over 56,720 hectares of land and help in control of floods in many parts of Jajpur district.

In the case of Utkal Coal Mines in Angul district, conversion of 13 hectares of forest land is in stage-1 and 156.18 hectares in stage-2 and awaiting clearances. Similarly, Dalmia Cements awaits clearance of 462.25 hectares of forest land in Malkangiri district. The clearance of 697.979 hectares of forest land for the Pottangi Bauxite Mines in Koraput district is in stage-1.

nounced her dead on arrival.

#### 5-year RI for man over murder attempt on wife

## 'Millets Mission' changing lives of Sundargarh farmers

Sundargarh, Nov 14: Rupbahal, a nondescript village under Tangarpali panchayat and block of Sundargarh district has shot to limelight by achieving outstanding success in millet cultivation with the help of Odisha Millets Mission and voluntary outfit 'Sevak'.

This project has helped a large number of farmers become self-reliant. Moreover, two siblings, Gobind Rohidas and Shatrughna Rohidas, who were instrumental in involving the farmers in millet cultivation are earning in lakhs. The siblings through their success story have become an example for others to emulate. This has brought a turnaround in the lives of the Rohidas siblings and scores of other farmers in the panchayat.

Two years back, the Rohidas brothers used to earn their livelihood only from naddy cultivation. The Odisha government realising the importance of millets in nutrition programme launched millet

cultivation in the area through Odisha Millets Mission with financial assistance from the district mineral foundation (DMF). 'Sevak' was selected as a partner to help in cultivation in Tangarpalli block. Sevak's block coordinator Thanasundar Gandha, assistant block coordinator Amiya Ranjan Lenka, community worker Akash Choudhury launched the programme. Their efforts and regular guidance soon paid off as 793 farmers took up

in the 2021-22 Kharif season.

Gobind reaped a harvest of 33 quintals by taking up millet cultivation on 3.5 acres of land while his brother Shatrughna harvested 29 quintals of millet on three acres. Gobind earned ₹1.17 lakh by selling 31 quintals of millet while Shatrughna earned ₹1,01,979 from sale of 27 quintals.

Initially, paddy cultivation was the main source of earning for the siblings. However, they were always at the mercy of nature. Now their lives have changed since they took up millet cultivation.

The siblings, motivated by the 'Sevak' officials, have also taken up cultivation of vegetables like tomatoes, beans, cucumbers, cabbage, cauliflower and tuber crops like potatoes and onions along with millet and paddy farming. They are selling these vegetables in markets and earning around rupees eight lakh to

₹10 lakh annually. When contacted, the siblings said they were earning a meagre amount from paddy cultivation on over 15 acres of land. As a result they had work as daily wagers for a substantial period of the year. However, now they are well off after venturing into millet cultivation. Both Gobind and Shatrughna thanked officials of 'Sevak', Odisha Millets Mission and Agriculture department.

'Sevak' chairman Amiya Kanta Nayak said that the efforts put in by the siblings and the zeal to do something new have helped them become self-reliant and role models for other farmers. Other villagers have termed the two siblings as 'gold diggers' for their success.

### Blue Wave

The political outlook of the US now looks considerably different from what it was just a week ago before the midterm elections were held. Going by past records, pollsters were then predicting a rout of the Democrats and a surge of the red wave, meaning a near-certain return of Trumpism or the Right-wing politics of the Republicans. The voters however have spoken their mind differently. They have not given a decisive mandate either to the Democrats or the Republicans. But, they have stopped the red wave and dashed the ambitions of former President Donald Trump and his rabid followers to take control of the House and the Senate and crip-

Now, in a seemingly historic turn of events, the Democrats are feeling more secure about where they stand, while Republicans struggle to regain their balance. The Democrats have retained control of the Senate, after winning a close race in the state of Nevada. The tally shows the Democrats have bagged 50 seats and the Republicans 49. Even if the latter wins the last remaining seat, there would be a tie in which case Vice President Kamala Harris would put her casting vote to help the Democrats pass whatever legislations they seek to enact. Even in the House the Republicans may marginally go ahead of the Democrats as most of the candidates Trump publicly endorsed have lost. Midterm elections in the US have traditionally gone against the ruling dispensation since 1930. But, the outcome this year has become stunning, indeed, with the Democrats reversing the historical trend.

The question that is uppermost in the minds of the people is how the impossible has been made possible by Joe Biden who is considered old and ineffective. Some Trump loyalists also claimed he was suffering from dementia and yet this success has bewildered most American political analysts. A combination of factors could be responsible for the late surge of the blue wave, for the Democrats' better than expected performance. But, two factors may have primarily influenced the outcome - the threat to democracy that a return of the Republicans was perceived to pose and the recent Supreme Court ruling overturning the Roe Vs Wade verdict that had accorded constitutional right to abortion half a century ago.

During the run-up to the midterms President Biden made the threat to democracy issue under the Republicans headed by Trump as the main electoral plank for the Democrats. But, the issue of abortion rendered illegal by the Supreme Court ruling seems to have become the single major factor for the defeat of Republican candidates as women voters rallied behind the Democrats who supported the right to abortion. In fact, Biden had predicted American women would revolt and things seem to have happened as predicted by him. This caused a setback to the Republican's hope of a 'red wave' which, they felt, was fuelled by widespread economic distress. The Democrats defied historical expectations for defeat of the party in power in the first major election of the post-Roe era. It is not without reason that a jubilant Biden told a crowd of supporters at the Howard Theatre in Washington: "Women in America made their voices heard, man.'

As a clear picture of the results emerges, it becomes evident that abortion proved a defining issue. Fury over the loss of federal abortion protections galvanised women and young people who gifted unexpected victories to the Democrats in the hope of new protections for reproductive rights. It is foolhardy for the Republicans to hope for a favourable outcome in midterm polls when the country's nearly half of the people have their body autonomy put under threat. This is the main reason for young people and women showing up to exercise their franchise. In fact, newly registered women comprised more than two-thirds of the fresh voters.

Exit polls conducted by news networks by Edison Research showed that abortion was the top issue for many Americans, especially people under the age of 30. About 60% of voters said they were dissatisfied or angry with the Supreme Court's decision to overturn Roe. In every state where an abortion-related measure was on the ballot, voters chose either to enshrine protections or reject new limits. And it was a decisive issue in battleground states like Michigan and Pennsylvania, where the future of abortion ac-

American voters, especially women, many of whom were in the forefront of the 'Me Too' movement against sexual abuses, have once again proved that they will revolt when there is denial of women's biological freedom. These elections, once again, proved the US to be an extremely mature and aware democracy

#### Corpus

xford Dictionaries have been making proud announcements recently about their research resource, the Oxford English Corpus (OEC). A corpus is a collection of written material in machine-readable form that has been put together for linguistic research. The word is the Latin for body and is the source of several other English words, such as corpse, corporeal, corpulent, corpuscle, corps, and corporal. Corporate, of a business or firm, has the same origin, so body corporate is etymologically speaking a tautology. Crime writers are fond of corpus delicti, for the facts and circumstances surrounding a crime (literally, it means "body of offence"). And there are many medical terms for bits of the body that include it, such as corpus callosum and corpus luteum. English writers have been using corpus for a body of writing since the early eighteenth century (the first known usage was in Chambers Cyclopaedia in 1727); linguists only started to use it in this specialised sense in the 1950s. The OEC began in 2000 and by April this year had grown to contain more than a billion (a thousand million) words — not all different, of course: the humble word the alone appears about 50 million times. It represents every type of English, from literary novels, specialist journals, newspapers and magazines to the text of Hansard and the contents of chatrooms, e-mails, and weblogs. All the material has been trawled from the World Wide Web using a custom-built web crawler (similar to those that search engines like Google use to index the Web), so there are probably some World Wide Words pages in it somewhere. The OEC also includes every regional variety of the language, not only the major ones of the UK and US that make up about 80% of the total, but also material from the Caribbean, India, Singapore, Hong Kong, and South Africa. One of its more valuable features is that researchers can discover which words most often appear together, for which the dictionary makers' term is collocation. When, for example, the corpus is examined for verbs which are most often used with man or boy but not woman or girl, they discover that men assault, hijack, crouch, kidnap, rob, grin, shoot, dig, stagger, leap, invent, or brandish. But they don't consent, faint, sob, cohabit, undress, clutch, scorn, or gossip because, according to the corpus, that's what women do. Eccentric usually appears with words like endearingly, old, and millionaire, suggesting that only elderly, wealthy people can be eccentric, the rest of us just being plain crazy. The word vivacious most often appears with beautiful, young, blonde, outgoing, and intelligent and the corpus evidence makes clear that women may be vivacious but men may not. Evidence like this helps to tie down what we really mean by words; for example, vivacious is now defined in the Oxford Dictionary of English as "(especially of a woman) attractively lively and animated".



early four years ago, in January 2019 the Parliament passed the 103rd Constitutional amendment carving out a new category of reserved quota for government jobs and for admission to educational institutions. This was a new 10% quota for those persons from the economically weaker section (EWS). Upon its passage, there were a slew of petitions challenging the constitutionality of this amendment. The fact is that this rather momentous amendment was passed in Parliament without much debate because the BJP which is the ruling party has an absolute majority in the Lok Sabha. One of the few objections against the amendment was made in a spirited speech by Kanimozhi, MP from Tamil Nadu. But largely the amendment passed without much discussion. The Supreme Court this past week in its verdict upheld the constitutionality of the EWS quota and all petitions challenging it were dismissed. The verdict of the fivemember bench was unanimous in affirming that the economic criteria can be used as a basis for reservation (something that the petitioners had challenged). The bench was also unanimous in its implied conclusion that because of this new category, now the aggregate total share of constitutionally mandated reservation (SCs, STs, OBCs, and now EWS) would exceed 50%, and this was not per se against the Constitution. This too had been one of the contentions of the petitioners. The only issue on which the bench was split 3:2 was whether the SC, ST and OBC groups could be excluded from the newly created category of EWS. The majority view is that their exclusion was ok.

This amendment and the stamp of validity on it provided by the highest court in the country have many consequences, some of which will be discussed below. Has the judgement dealt a blow to the doctrine of protecting the basic structure of the Constitution (something that followed from the landmark 1973 case in the Supreme Court)? This famous judgement

did not define explicitly what is meant by the basic structure. It also did not prohibit the power of the Parliament to pass amendments to the Constitution. But it did say that you cannot pass amendments of such extreme nature, that they distort the very basic principles of our Constitution. Parliament is supreme, but the spirit of the Constitution is more supreme. By creating a new category based on economic criteria, to whom special treatment will be accorded (reservation), have we violated the right to equality (Article 14)? Or by excluding SC, ST and OBC groups from this new category, have be breached the principle of non-discrimination (Article 14 and 15)? These are questions for scholars of jurisprudence to explore. Much has already been written and more will follow. One rather penetrating analysis is by Ayan Gupta which can be read at the blog indconlawphil.wordpress.com. So, it is quite possible that in the days to come a review of the decision of the apex court may be undertaken by a larger bench.

But for now, let us examine other aspects of the amendment and the judgement. Firstly, it is clear that the amendment itself was politically motivated. The word 'quotas' has radioactive resonance in Indian polity, and there

is an impression that the amendment was passed to benefit a vote bank of upper-caste voters. But now even Muslims and Christians have also become eligible for EWS quota. Secondly, the quotas in our Constitution were meant to correct longstanding and historical injustice based on caste. They are meant to help those who have suffered from social backwardness for generations.

How can economic backwardness be put in the same category as social backwardness stemming from historical injustice and social backwardness? A person's economic status is fluid, and can change with effort or luck or both. Even a person's religion can be a matter of choice. But caste is an unchangeable marker from birth. So, overcoming caste-based discrimination is not in the same league as economic deprivation. Thirdly, the cutoff decided for eligibility for the EWS quota is an annual income of ₹8 lakh, which seems like a very generous threshold. It is far above the poverty line. By one estimate, more than 95% of the households in India will fall under this limit. So, is it a remedy to give quota- based opportunities to the poor, or is it meant for everybody? Fourthly, if indeed the EWS quota is meant to help those from poor households

then let us look at the profile of those below the poverty line. As per the government's Sinho Commission, nearly 82% of the people below the poverty line comprised of SCs, STs and OBCs. Poverty and social backwardness have a high correlation. But those very categories have been denied opportunities in the EWS quota. It is on this point that there was dissent by two of the judges as a matter of constitutional principle.

But even from a pragmatic view about poverty, does this not seem questionable as a policy designed to help the poor? It is like saying that we will launch an anti-poverty programme, but those people from rural areas, and from agriculture will be excluded since they are covered by other subsidies. Fifth, the status of economic back wardness is fluid. It should be ad dressed by affirmative action and not quotas. For instance, providing education loans to students from poor households is better than a quota system for the poor. Sixth, one implication is the scramble for income certificates that this EWS policy will unleash. In an economy where 92% people work either in the unorganised, unregistered or informal sector, getting authentic income data is notoriously difficult. Only about 5% of the population pays income tax. So where can we get authentic income data, based on which this EWS policy is going to be implemented? Are we opening the gates for more corruption, rent seeking or fake certificates, and more litigation?

Lastly it is clear, that the EWS reservation has great political resonance because of the scarcity of well-paying, stable and high-quality jobs. Most of the jobs are going to be created in the private sector anyway, wherein these quotas don't apply. Hence the surest way ahead to correct for social or economic injustice is high, sustained, inclusive growth of the economy, jobs and livelihoods. That as always is the real core agenda.

## A child killer meets its match

of the last few years in isola-√tion to avoid getting sick. And now we are learning that this widespread disappearing act produced some unexpected side effects. In particular, infections from oncecommon illnesses – like influenza and Respiratory Syncytial Virus (RSV) – plummeted.

But now, as much of the world has returned to its normal prepandemic rhythms, that brief respite is over. RSV, a dangerous infection that kills more than 100,000 young children each year, has returned with a vengeance. Several countries, including South Africa and Australia, have recorded major RSV outbreaks, and hospitals in the United States are filled with

habies who are struggling to breathe. The alarming uptick in RSV cases bodes ill for the winter months in the northern hemisphere, especially with an expected bad flu season. Yet while RSV can result in serious illness, like pneumonia, for very young children everywhere, it is rarely fatal in high-income countries like the US. Over 97% of deaths due to RSV occur in low- and middle-income countries -a glaring disparity that has made the disease one of the leading killers

wike many others. I spent much of newborns and young children of reach, this common childhood pends on whether a vaccine is acin these countries.

Fortunately, new technological

developments on the horizon may soon mitigate the threat posed by RSV. Promising advances in maternal immunisation - vaccinating pregnant women to confer lifesaving protection on their babies – have the potential to save thousands of lives each year, and an effective RSV vaccine is finally in sight. Maternal immunisation has been safely and effectively used for decades to protect newborns from other infectious diseases, including whooping cough and tetanus. If approved, this would be the first vaccine ever to protect children against RSV.

Although most RSV infections are mild, the virus can be much more severe in the youngest patients and can lead to pneumonia, which kills more children than any other infectious disease. Moreover, there are no drugs to treat RSV. For severe cases, medical oxygen is administered in a hospital to help babies breathe until the infection clears. But that, of course, assumes that they can get to a hospital with oxygen. For infants in parts of lower-income countries where hospital care or oxygen is out

illness can quickly become deadly. It is in these settings that an RSV vaccine has the greatest potential to save lives and spare families from crushing grief.

The Bill & Melinda Gates Foundation has supported efforts to advance the field of maternal immunisation for 15 years, funding research and development for maternal vaccines against influenza, whooping cough, other newborn bloodstream infections, and RSV and Group B Streptococcus (GBS). Our most recent investment in maternal RSV vaccines is focused on improving affordability and access for lower-income countries. This is crucial for giving infants in these countries the best chance at life.

While the vaccine is still in development, I am hopeful that, if it is successful and gains regulatory approval, it will start to be rolled out - through Gavi, the Vaccine Alliance - in low- and middle-income countries as early as 2024. Quick and equitable access to this lifesaving vaccine in countries where RSV remains a major killer will have a real impact on reducing childhood illness and death around the world.

Yes, a successful rollout also de-

ceptable and taken up by local communities. But as matters stand. I am optimistic that it will be. Research has shown that pregnant mothers are more likely to receive a vaccine to protect their babies before birth than they are to protect themselves. Moreover, studies have found that if you can protect against RSV in the first few months of life, you can likely protect against other future respiratory infections, including pneumonia.

RSV is not a new problem. Paediatricians and many parents have long dreaded this illness, and for good reason. But we are on the cusp of finally developing and deploying the tools we need to protect infants when - and where - they are most vulnerable. We should all continue working toward a future where children - regardless of where they are born - can grow up to live full, healthy lives, safe from the dangers of RSV and childhood pneumonia. By ensuring equal access to these lifesaving vaccines, we can make that future a reality.

#### Coal's here to stay

Also, the selective singling out of sources of emissions, for either labelling them more harmful, or labelling them "green and sustainable" even when they are sources of greenhouse gases, has no basis in the best available science. But, like it did in COP26 in Glasgow, India must stand its ground on coal and push for more immediate needs of the developing world: Climate finance and green tech at affordable costs from rich nations. Valsan told reporters after finishing the Ironman 70.3 race in Panaji Sunday while competing with more than 1,400 other participants.

The 2012 batch IPS officer com-

pleted the race in 8 hours, 3 minutes and 53 seconds, within the stipulated time, the organisers said. Valsan said he was last year diagnosed with non-Hodgkin's lymphoma, a cancer that generally develops in the lympathic system.

The police officer said he did not give up and fought against the disease and was declared "all-clear" in February this year. "I am fine now," he said. Valsan said this was the first time he participated in the Ironman race. In 2014, he had participated in a half-marathon in Delhi, he added. There were a total of 1,450 participants in the Ironman triathlon, which included 1.9 km of open sea swimming, 90 km of cycling and 21 km of run.

Nihal Baig, an alumnus of the Indian Institute of Technology Bombay, won the race, while defending champion Bisworjit Saikhom of the Indian Army stood second, as per the results declared by the organisers.

## Over 5 lakh people had missed TB diagnosis in 20 due to Covid: Study

New Delhi, Nov 14: Over five lakh people in India are estimated to have had a missed or delayed tuberculosis diagnosis in 2020 due to the disruptions caused by the Covid-19 pandemic, according to a study.

The study, published in the journal BMC Medicine, shows that children may be disproportionately affected in over half of countries analysed, those aged 65 or over in more than two thirds of countries, with sex being a risk factor in almost half of countries.

The team, including researchers from the London School of Hygiene & Tropical Medicine (LSHTM), UK, noted that vulnerable populations in high-burden countries worldwide must be prioritised in efforts to reduce the impact of the Covid-19 pandemic on tuberculosis (TB) care. For India, they found that 50,454 children (less than 15 years old), 425,326 (over 4.2 lakh) adults aged 15-64 years, and 52,970 people above 65 years of age had a missed or delayed diagnosis. This included 309,477 (over 3 lakh) men and 170,514 (over 1.7 lakh) women above



15 years of age. "We found strong evidence that the risk of being missed

or delayed was higher for both children and the elderly than adults; 45 per cent higher for children and 12 per cent higher for the elderly," study joint lead author Finn McQuaid, from LSHTM, told PTI.

"Our results show that in many countries those who already faced the most difficulty in obtaining TB diagnosis and care have suffered worsening access as a result of the pandemic," McQuaid said. The researchers modelled trends in TB case reporting to the World Health

Researchers found that over 1.5 million people in 45 high-burden countries had a missed or delayed tuberculosis diagnosis in the first year of the pandemic

Organisation (WHO) for 45 high-burden countries between 2013 and 2019. Predictions for 2020 using these models were then compared to actual observations in the same year. As many as 195,449 (nearly two lakh) children below the age of 15 years, 1,126,133 (over 11.2 lakh) adults aged 15 to 64 years old and 235,402 (2.3 lakh) older individuals aged 65 years or older had a missed or delayed diagnosis of TB in 2020, they said.

These figures include 511,546 (5.1 lakh) women and 863.916 (8.6 lakh) men, they said Although the study found no evidence for systemic disparity in risk by age or sex on a global scale. when broken down by

country, setting-specific inequalities were revealed. For example, in over half of countries (57.1 per cent) analysed, children were at a greater risk of having their TB diagnosis delayed or missed due to Covid-19 than adults, the researchers said.

Ocean Studies, overlooking the UGC Regulations, 2018, cannot be sustained under law. We are also of the view that the search-cum-selection committee constituted is also in violation of the UGC

Regulations, 2018," it said. As a result, the court quashed the 2020 notification issued by the Governor appointing the selection committee, its 2021 resolution recommending only one name and 2021 order of the Chancellor appointing John as VC for a period of five years or till he attains the age of 65, whichever is earlier.

The Bench directed the Chancellor to constitute a selection committee for recommendation of a panel of names in accordance with the UGC regulations at the earliest.

At the same time, the court said the contentions that John lacked the requisite years of service for appointment as VC were not legally

The verdict was welcomed by the BJP and the Congress. Both said the judgement hit the government hard

But, the CPI(M) said the verdict would be legally examined and appropriate steps taken after that.

State Finance Minister KN Balagopal also speculated that the

order might have been specific to the procedure followed in appointment of the VC of KUFOS and may not be applicable to every

Kerala Pradesh Congress Committee president K Sudhakaran said the verdict was a setback to the LDF government which had allegedly appointed their favourites to key positions in the varsities.

He said in a statement that there needs to be a thorough investigation into all such appointments.

Leader of Opposition in the State Assembly V D Satheesan alleged that the Kerala Chief Minister Pinarayi Vijayan and Khan were to blame for the appointments.

"They both created this problem. The Opposition stand that appointments were in violation of UGC norms has been endorsed by both the Supreme Court and the Kerala High Court," he said.

Satheesan, speaking to reporters in Thiruvananthapuram, further said all the VCs to whom showcause notices were sent should resign and re-apply for the post.

This way only the deserving and competent candidates would be selected, he said.

BJP state president K Surendran said it was an indication that the Governor's stand was correct and that of the ruling Left wrong.

Bangalore, Nov 14: Karnataka Chief Minister Basavaraj Bommai Monday defended the government's move to paint the thousands of school classrooms to be constructed under 'Viveka' scheme in saffron

The Karnataka government has proposed construction of 7,601 classrooms across the state under the new government classrooms scheme named after Swami Vivekananda.

mer Chief Minister Siddaramaiah said: "Regarding this saffronisation, it should be noted that it is not BJP money but public money. Have people asked for saffronisation or have they got the mandate to do so? Have they got a mandate for tampering with history?"

Bommai launched the scheme on Children's Day by laying the foundation stone at Government Higher Primary School at Madiyal in Kalaburgi district.

Asked to comment about the move of colour coding such classrooms with saffron that has sparked a controversy, the Chief Minister



said, "Why do people turn red with the very name of saffron? What's wrong to have saffron colour? There's saffron colour in the (national) tricolour. Swami Vivekananda himself used to wear a saffron robe.

"They (Congress) aren't interested in comprehensive development of education," Bommai

charged. He said there is a tendency to cre-

ate controversy on any progressive changes made.

'Viveka' means wisdom. We named the schools after Swami Vivekananda so that children draw inspiration from him and a good atmosphere will be created in schools," the Chief Minister opined.

Asked if "saffronisation of education is happening", he said: "Definitely not" School Education Minister B C

Nagesh said if architects recommend to the government that saffron colour looks good on such classrooms, it will be done.

"We have left the decision to ar-

chitects. The government does not decide on what kind of paint, window, door and steps. We will take a decision on what they (architects) say," Nagesh said.

"Some people have an allergy towards (saffron) colour," he said.

Taking a dig at the Congress, the Minister said: "I want to ask them, there is saffron colour in their flag. Why did you keep it? Remove it "Nagesh said

Meanwhile, the Chief Minister said the state government will build 8,000 school rooms in the state of which 2.000 will be the 'Kalyana Karnataka' region (erstwhile Hyderabad-Karnataka region) alone while 6,000 will be in the rest of Karnataka.

"If this can be done for three years continuously, it will bring a major reform in the state. This will address the shortage of classrooms from primary schools in the state," Bommai said.

He said that he has released Rs 250 crore for the construction of toilets in all the schools by August 15, 2023

## Islamic institute in Kerala sets example by teaching Sanskrit

Thrissur, Nov 14: Students in long white robes and white headdresses in an Islamic institution unwaveringly reciting 'slokas' and 'mantras' in Sanskrit under the watchful gaze of their Hindu gurus, is what sets apart a Muslim educational organisation in Thrissur

district of central Kerala. "Gurur brahma gurur vishnu, Gurur devo maheshwara, Gurur saakshaat param brahma. Tasmai shri gurave namaha," one such student recites on being asked to do so in Sanskrit by his professor.

"Uttamam (excellent)," the professor responds in Sanskrit, as another student finishes reciting a different 'sloka' asked of him.

All conversations between the student and the professor in the class are in Sanskrit.

The objective behind teaching Sanskrit, Upanishads, Puranas, is to inculcate in the students knowledge and awareness about other religions, Onampilly Muhammad Faizy, the principal of the Academy of Sharia and Advanced Studies (ASAS) run by Malik Deenar Islamic Complex (MIC), said.

Another reason, and the main one, for teaching Sanskrit to the students at MIC ASAS was Faizy's own academic background as he had studied Shankara philosophy.

"Therefore, I felt that students should know about other religions and their customs and practices. But an in-depth study of Sanskrit as well as the Upanishads, shastras, Vedanta would not be possible during the eight-year study period," he

"Instead, the idea is to provide basic knowledge about these and create an awareness in them about another religions," Faizy said.



Important portions of the Bhagavad Gita, Upanishads, Mahabharata, Ramayana are selectively taught in Sanskrit to the students over a period of eight years after they pass out of Class

10, he said The selective teaching of these texts is because the institution is primarily a Sharia college where other languages, like Urdu and English are also taught besides a degree course in Arts as it is affiliated to the Calicut University.

"The academic workload is huge. Therefore, we take in students who can handle it and also maintain strict standards. There is an entrance exam for admitting students," he said.

Some of the students recently told the media that initially it was tough to learn Sanskrit, just like Arabic but by continuously studying and practising, it becomes easier over

"It is a tough task initially. Just like Arabic. But if we study it continuously, repeatedly practice it, just like with Arabic, it becomes easier over a period of time. The regular classes and the tests also help us to learn it." one of the students

Another student said he was excited to learn Sanskrit and hear the

Just like his classmate, he too was of the view that like Arabic, "if you put in the effort, it becomes easier to learn."

While there has been no objection from parents of the students or anyone else, a major challenge has been finding good faculty to teach Sanskrit, the Bhagavad Gita, Upanishads, properly to the stu-

"That is why we were able to start teaching Sanskrit just seven years ago and it is also the reason that it is being taught only at this branch -- one of seven," principal Faizy said.

We have an excellent faculty here who have devised a good curriculum for the students, he noted.

The response from the side of the students too has been encouraging as they have shown an interest in learning Sanskrit, the principal added.

One of the faculty, professor KK Yatheendran, told media when he was invited to teach there, Faizy "was concerned whether I would have reservations about teaching in an Arabic institution as I was a

"I said there is no Hindu or Muslim issue here. I am coming there ready to teach. So, I have no such reservations," he told the media.

Dr Ramesh, who also teaches Sanskrit at MIC ASAS, said that the students there have never heard of Sanskrit before coming there.

'They have not even learnt it in school. But as we move from one phase to another, the students are able to speak a little in Sanskrit, learn 'padams' and are able to understand some 'slokas' also," according to him.

The visuals of the Sanskrit classes are posted on the institute's Facebook page.

At a time when political parties in Kerala are at loggerheads over alleged saffronisation of higher education institutions or them becoming centres of communism, this Islamic institution is setting an example by teaching its students Sanskrit and the Bhagavad Gita along with Arabic and the

Hafiz Aboobacker, one of the coordinators at the institute, told a media channel that it was important to learn about Islam, but knowledge about other religions was also important and that is also a reason for including Sanskrit in the syl-



AIADMK interim general secretary and Leader of Opposition K Palaniswami Sunday demanded that the government provide ₹30,000 per acre as compensation to farmers.

Stalin said the Opposition parties would come up with claims to criticise the government and gain political mileage, and he was not worried about it.

The exercise to estimate damage to standing crops and compensation would be based on people's expectations, he said. The Chief Minister gave away assistance, which includes ₹4,100 in cash for partial damage to hutments and a bag of 10-kg rice and clothes to the affected people. He was accompanied by his senior Cabinet colleagues and officials briefed him on the initiatives being pursued in rain-hit areas to restore normalcy.

## **India may see faster progress** on climate goals, says report

New Delhi, Nov 14: At least three of the four top emitters of greenhouse gases -- China, the EU and India -- are expected to see faster progress towards a clean energy economy than they have set out in national plans or NDCs, according to a new analysis released Monday.

The report, "Big Four: Are major emitters downplaying their climate and clean energy progress?", by the UK-based Energy and Climate Intelligence Unit, suggests interconnected global crises and market mechanisms are driving the shift towards electric vehicles, low-carbon heating and renewables around the world, in particular in those four countries.

Rapid price reductions, which make wind and solar power vastly cheaper than fossil fuel alternatives, concerns over energy security and access, and in Europe, the support for Ukraine, are driving this momentum, while EV sales are accelerating with major markets reaching tipping points.

In the three countries, these forces are strong enough that they may well be on track to outstrip their emissions targets under the Paris Agreement, which indicates a more positive picture for limiting global warming to 1.5 degree Celsius, the report said.

In India, the authors noted, the rollout of renewable energy, particularly solar, is accelerating rapidly and will transform India's

electricity sector this decade. In August, India released its updated nationally determined contributions and now stands committed to reducing emissions intensity of its GDP by 45 per cent by 2030, from the 2005 level, and achiev-

According to "Global **Carbon Budget Report** 2022", the top four CO2 emitters in 2021 were China (31 per cent), the US (14 per cent), the European Union (8 per cent) and India (7 per cent)

ing about 50 per cent cumulative electric power installed capacity from non-fossil fuel-based energy

resources by 2030. These NDCs are, however, contingent on delivery of finance and

technology transfer. NDCs are national plans to limit global temperature rise to well below 2 degrees Celsius, preferably to 1.5 degrees Celsius, as advocated in the Paris Agreement.

"Coal generation will become an increasingly unprofitable backup for wind and solar, a function that will itself inevitably fall away as storage takes off," the report said. Citing the draft National Electricity Plan, it said the total generating capacity of India's coalfired power plants doubled between 2007 and 2017 and the Central Electricity Authority sees coalfired capacity increasing by less than 20 percent over the next decade.

"Over the same period, the capacity of renewable generation is set to soar by 250 per cent," according to the report.

"This picture is reinforced by the plans of some leading companies. The giant Adani conglomerate plans to put 70 per cent of its capital investment this decade into the energy transition, including renewables and green hydrogen – a total of \$50-70 bn (billion). Reliance Industries will invest \$80 bn in renewable energy projects in

Gujarat alone" the report read. Financing India's decarbonisation transition is also helped by a significant partnership with Germany, signed earlier in 2022, that could unlock up to \$10.5 billion in assistance through to 2030 to boost clean energy resources.

It has been contended that Oreva Group has no expertise or knowledge in repairs, maintenance or renovation and therefore sub-contracted the work to a little know contractor Devprakash solutions for ₹2 crore.

This sub-contractor only replaced the wooden deck with aluminium ones and did not touch upon the weak and corroded suspension cables.

Neither the municipality nor the Oreva group sought any technical advice or approval regarding the structural design nor was any fitness certificate issued before re-opening it for the public. Though the High Court rejected



Toronto, Nov 14: The Canadian Armed Forces (CAF) have announced that permanent residents. which includes a large number of Indians, will now be allowed to enlist, as the military struggles with low recruitment levels, according to a media report.

The move also comes five years after the Royal Canadian Mounted Police (RCMP) announced that they're changing their "outdated recruitment process", means allowing permanent residents who have lived in Canada for 10 years to apply, CTV News reported.

Mumbai, Nov 14: The L&T Group Monday announced operationalisation of the merger of Mindtree with LTI (Larsen & Toubro Infotech), creating the country's sixth largest software firm with a revenue of \$5.25 billion this vear, and the new entity, LTI-Mindtree, will begin trading from November 24.

Announcing the merger with immediate effect, group chairman AM Naik said that LTI-Mindtree will be the fifth largest software company in terms of market capitalisation (Rs 1.53 lakh crore of Monday closing).

It will have 90,000 employees on its rolls, taking the overall headcount of the software businesses to 1.2 lakh, which includes that of LTTS, spread across in over 30 countries across five continents.

The new company will be headquartered in Mumbai, and will be independent of L&T, which will also mean that the head of the new entity will not be on the board of L&T, said Naik, who is the chairman of the new entity while L&T chief executive SN Subrahmanyan will be vice-chairman.

Naik also said, L&T will continue to hold 68.73 per cent in the

merged entity. At the current market value Monday closing, the new entity will have an mean of ₹1,52,672.23 crore, placing it much ahead of Tech Mahindra and closer to Wipro. Of the current mcap, LTI's share is ₹90,527.45 crore, after closing over 2 per cent up at ₹5,161.20 on the BSE, and that of Mindtree is ₹62,144.78 crore, after gaining nearly 3 per cent at ₹3,766.35.

As against this, the industry leader TCS commands a market value of ₹12.2 lakh crore, followed by Infosys at ₹6.66 lakh crore, HCL (Rs 2.98 lakh crore) and Wipro (Rs 2.17 lakh crore) and Tech Mahindra at a low ₹1.03 lakh crore.

Under the merger scheme. wherein Mindtree will cease to exist, a Mindtree shareholder will get 73 LTI shares for every 100 share he/she owns and the record date for share allocation is November 24, said Naik,

New Delhi, Nov 14: India's annual retail inflation eased to a three-month low of 6.77% in October, helped by a slower rise in food prices and a higher base effect, strengthening bets of smaller rate hikes by the country's central bank at its meeting next month.

The October reading was higher than the central bank's tolerance limit of 6%, data released by the National Statistics Office Monday showed. The annual retail inflation was 7.41% in September.

Food prices, which account for nearly 40% of the CPI basket, rose 7.01% in October, compared with 8.60% in September.

Month-on-month retail inflation rose 0.80% in October, compared with the previous month, while retail food inflation rose 1.08% reflecting inflationary pressures in the economy.

Some economists said that although inflation had peaked in

India, the world's leading vegetable oil buyer, had imported 131.3 lakh tonne of edible oils in the 2020-21 oil year (November-October) for ₹1.17 lakh crore in the previous year, according to the Solvent Extractors Association of India (SEA).

Import gradually increased during the first two quarters and it slowed down in the third quarter. However, it again increased in the fourth quarter due to the lifting of a ban on palm oil by Indonesia and a sharp decline in international prices which boosted buying from India, it said

In March-April for a brief period, palm oil was as expensive as soft oils. Its availability was further affected in May-June by Indonesia's decision to ban exports. As expected, India's palm oil buying plunged and



import of soft oil rose, it said.

As a result, there was a decrease in palm oil import at 79.15 lakh tonne during the 2021-22 oil year, when compared with 83.21 lakh tonne in the previous year, while soft oil import rose to 61.15 lakh tonne this year, from 48.12 lakh tonne in the previous year, it said in a statement.

Among palm oil products, SEA said import of RBD palmolein saw more than two times jump to 18.41 lakh tonne in 2021-22, as against 6.86 lakh tonne in the previous year.

Whereas, import of crude palm oil (CPO) declined 20 per cent to 59.94 lakh tonne as against 74.91 lakh tonne, while that of crude palm kernel oil (CPKO) dropped to 80,000 tonne from 1,43,000 tonne in the

said period Among soft oils, the import of soyabean oil increased sharply to 41.71 lakh tonne this year from 28.66 lakh tonne in 2020-21, in the absence of lesser supply of Sunflower oil in the previous year, SEA said in a statement.

Similarly, the import of sunflower oil rose marginally to 19.44 lakh tonne this year from 18.94 lakh tonnes in the previous year.

As November 1, there was an opening stock of 24.55 lakh tonne of edible oils in the country. India needs about 19 lakh tonne of edible oils per month and currently operates at 40 days stock which is the highest inventory held by India.

The 5G smartphone share reached 36 per cent of total smartphones during the reported quarter with 16 million units at a slightly higher average selling price of \$393, about ₹32,000, apiece compared to \$377, about ₹30,600, in the previous

Despite the festival season beginning earlier than usual, the unrelenting rise in prices pulled down shipments in the world's secondbiggest smartphone market, IDC said.

The average selling price jumped 15% year-over-year, and 6% from the previous quarter, to a record \$226, IDC said. "The average selling price has grown consistently for the past eight quarters in a row due to increasing costs and growing 5G ship-

Now Amazon to lay

New Delhi, Nov 14: Amazon.com Inc is planning to lay off about 10,000 employees in corporate and technology jobs starting as soon as this week, the New York Times reported Monday.

The job cuts will focus on the ecommerce giant's devices unit. which houses voice-assistant Alexa. as well as its retail division and human resources, according to the report, which also said the total number of layoffs remains fluid.

The unit that houses Alexa had posted an operating loss of more than \$5 billion a year, with Amazon mulling if it should focus on adding new capabilities when customers use the device for only a few functions.

The lavoffs represent about 3% of its corporate staff, the Times reported. Amazon had recently said it would freeze hiring to corporate workforce for the next few months.

Amazon is the latest US company to make deep cuts to its employee base to brace for a potential economic downturn.

Last week, Facebook-parent Meta Platforms said it would cut more than 11,000 jobs, or 13% of its workforce, to rein in costs. Other firms include Elon Musk-owned Twitter Inc, Microsoft Corp and Snap Inc.

New Delhi, Nov 14: Cryptocurrency markets worldwide have been battered with billions of dollars being wiped out but India managed to stay relatively unscathed thanks to a cautious approach of the government and the RBI.

While the Reserve Bank of India (RBI) has refused to recognise cryptocurrencies and repeatedly issued warnings against trading in them, the government fired the tax bullet to wean off demand.

Net result - Indian investors have

been largely spared from the crypto

meltdown that has taken the total

market value of cryptocurrencies below \$1 trillion in just a year from \$3 trillion in 2021 and sent Bahamasbased crypto exchange FTX into bankruptcy after a rush of customer withdrawals.

In India, the RBI has been resolutely opposing virtual currency from day one while the government initially was toying with the idea of regulating such instruments by bringing a law.

However, the government after a lot of deliberation came to the conclusion that global consensus is required in respect of virtual currencies as these are borderless and risks involved are far too high.

Also, to keep a tab on the money trail, a 1 per cent TDS has been brought in on payments over ₹10.000 towards virtual dig ital currencies

Even at present gains from crypto are chargeable to income tax, but the Budget 2022-23 announcement of 30 per cent tax has brought in clarity with regard to the rate at which the tax has to be paid.

Industry experts said the high rate of tax and increased compliance requirement due to TDS has dampened investor mood and crypto exchanges have seen a decline in trade volume.





## Time to change things: Kumble

New Delhi, Nov 14: Former India captain and coach Anil Kumble feels having totally different squads in limited overs and Test format is the way forward for the country in international cricket.

England's roaring success in ODIs and T20Is has ignited the debate for different teams and coaches in white and red ball cricket.

"Definitely, you need separate teams. You need, certainly, T20 specialists. I think what this English team has shown and even the last (T20) World Cup champions Australia have shown is that you need to invest in a lot of allrounders. Look at the batting order," Kumble told 'ESPNcricinfo'.

"Today Liam Livingstone is batting at No.7. No other team has a No.7 of the quality of Livingstone. (Marcus) Stoinis walks in at No.6 (for Australia). That's the kind of team you have to build. That's something that you need to invest

"I'm not really sure whether you need a different captain or a different coach. It all depends on what team you are going to pick and then choose how you want to build the support and the leadership

Former Australia all-rounder Tom Moody said splitting coaches should be seriously considered by international teams. England have Brendon McCullum as their Test coach and Matthew Mott as their white-ball coach.

"I think there is no doubt that moving forward, whether it be player or support management, there needs to be a serious look into that separation.

"It seems England have quite a considerable difference between their red-ball squad and their whiteball squad. They've created a depth of quality," Moody told the cricket website after England won their second T20 World Cup title.

"With regards to England being the best white-ball team (of all time), I don't think they're there yet. If they had won in the UAE at the last T20 World Cup, you could base an argument, but they weren't there in that one. So they've missed

I was bowling a bit more slow today and got the big leggies (leg breaks) going my way. Normally I bowl a bit quicker and bit shorter. That was my game plan for me and that's the way I bowl," Adil explained his strategy.

While Shadab and Livingstone (when he bowls leg spin) are much quicker through the air, Rashid believes in taking the opposite route. "Shadab and Liam bowl it a bit quicker and everyone has got their own way. For me, slower I bowl better it is.

The England team's massive transformation over the last seven years has been discussed to death but Rashid believes that they have not only tried to win games of cricket but also entertain the viewing public.

"For past seven to eight years, we have taken the approach of being positive. Being fearless with bat and ball, trying to entertain but also being true to ourselves. Two World Cups and it's working well for us," said Rashid.

The Olympic cap is triangular in shape, and comes complete with friendly smile, blue eyes, tricolor ribbon and big colored sneakers. The Paralympic version features a prosthetic leg that goes to the knee.
