The deaths of eight police personnel could have been 'avenged' by upholding the law and holding Dubey accountable in court

Kanpur, July 10: Hours after Uttar Pradesh police Friday gunned down gangster Vikas Dubey, accounts about the extra-judicial killing and videos of the moments leading up to it raise serious questions about the credibility of the official version of events.

Police claim he was trying to flee after the car carrying him from Ujjain overturned on an isolated stretch of the highway on the outskirts of the

CAR TRIED TO AVOID CATTLE, FLIPPED: STF

ours after gangster Vikas Dubey was shot dead in what the Uttar Pradesh police said an escape attempt after an accident, the Special Task Force gave its version of the incident that has raised several questions. Vikas Dubey, wanted for the murder of eight policemen a week ago, was being taken to his hometown Kanpur when the car he was in overturned on the wet highway, the UP Special Task Force (STF) said. The car flipped when the driver, "tired after a long journey" swerved to avoid a herd of cattle that had suddenly appeared on the road, said the STF statement. Five policemen were seriously injured and dazed by the accident. "The brazen criminal Vikas Dubey took advantage of the situation and snatched a gun from inspector Ramakant Pachauri and ran towards the kachcha road," the STF said.

Police said the gangster snatched a pistol from one of the policemen injured in the accident and was shot when he opened fire while trying to flee, an account being questioned by opposition parties. Six policemen, including two from the Special Task Force, were hurt in the accident and the exchange of fire around 6 am, an official said.

Dubey was the sixth man to die in a police encounter after the ambush he allegedly masterminded in Kanpur's Bikru village past midnight July 2, killing eight policemen who had come to arrest him.

Madhya Pradesh police arrested Vikas Dubey outside the Mahakal temple in Ujjain Thursday morning. He was handed over to an Uttar Pradesh police team late in the evening. Kanpur Range Inspector General Mohit Agarwal said Dubey fled from the car with an injured policeman's pistol.

He was chased and surrounded by policemen and was asked to surrender. When he started firing with an "intention to kill", police opened fire in self-defence, Kanpur police said.

A press release said he was immediately taken to a hospital, where he died during treatment. Ganesh Shankar Vidhyarthi Medical College principal Dr R B Kamal said he was brought dead to the hospital. "Dubey sustained four bullet injuries, three in the chest and one in the hand," he told.

Opposition parties targeted the BJP government after the encounter. Bahujan Samaj Party chief Mayawati demanded a Supreme Court-monitored probe into the encounter as well as the ambush in which eight policemen died last week. Congress general secretary Priyanka Gandhi Vadra said the crim-

Another record daily spike in state

Bhubaneswar, July 10: Odisha Friday registered its highest singleday spike of 755 COVID-19 cases, taking the tally to 11,956, while the death toll mounted to 56 with four more patients succumbing to the infectious disease, a health department

official said Detection of 755 more positive

cases is a record in Odisha since the first case was detected in the state March 15, the official said. While 508 of the new cases were reported from different quarantine centres, remaining 247 are local contacts. Contact tracing and follow-up action is underway, he said.

In a statement, the department said. Regret to inform the demise of 4 COVID positive patients while under treatment in hospital.

Two other COVID patients died due to other causes. The number of COVID-19 positive patients succumbing to other diseases increased to 17, the official said

With this, the number of COVID 19 fatalities in Odisha mounted to 56 while the states hotspot Ganjam district accounted for 34 deaths.

India's SMEs plan does little to save them

Mumbai, July 10: India re-opened for business in June after months of lockdown but for thousands of small entrepreneurs in the country, the blow has been devastating.

Businesses from textiles to sports goods and furniture are shuttered or working at a bare minimum. and cows roam streets that would be normally packed with workers and vehicles.

Prime Minister Narendra Modi's programme to help small businesses back on their feet through \$40 billion of government-guaranteed loans is too little and may not be enough to save the many companies that form the backbone of India's economy, nearly three dozen entrepreneurs Reuters spoke to across the country said.



Some said their business was so hamstrung by the pandemic that taking on new debt made little sense. They would rather the government had helped them by cutting the goods and service tax or waive off the interest on loans.

"It would be better for me to close the unit than to run from pillar to post to get a loan," said Ashok, who did not want to give his full name.

The Finance Ministry, which has made the loan support scheme the centerpiece of the rescue effort. did not respond to a Reuters request for comment on the problems


Nearly 35% of the 650 million small businesses across the country could shut down soon in the absence of government support, the Consortium of Indian Associations said in a letter to Modi's office seen by Reuters. "We have not got a single rupee

relief from the government," said Sanjeev Rastogi, a garment manufacturer in Meerut who is running his factories at 25% of the production capacity.

Rastogi has incurred a loss of 3.5 million rupees in the last two months and believes he may have to close down his business in the next three months.

recalled. Farah says the song holds a special place in her heart.





SCB to be state's plasma therapy hub

Bhubaneswar, July 10: With a sharp hike in COVID-19 cases in the state, the government is taking expeditious steps to develop SCB Medical College and Hospital as a hub for plasma therapy.

Speaking to reporters here, Institute of Life Sciences (ILS) director Ajay Kumar Parida Friday said plasma therapy treatment will start at four hospitals in the state very soon.

Within next 10 to 12 days, Chief Minister Naveen Patnaik will inaugurate four such facilities at SCB Medical College and Hospital, KIMS, SUM Hospital and Ashwini Hospital, he said, adding, preparations are underway to make SCB a hub of plasma therapy.

The government has also decided to enhance the Covid testing rate in the state, the director said after attending a meeting held under the chairmanship of additional chief secretary (ACS) PK Mohapatra.

The ILS director said at present, more than 5,000 RT-PCR tests are being conducted per day and the target has been set to ramp up the testing capacity to 6,000 per day.

'Keeping in view the rising number of COVID cases, the discussions hovered over how the testing capacity can be ramped up. Last week, 5,600 to 5,700 tests were conducted per day and in order to bridge the gap, it has been decided to increase the tests to 6000 per day," he said.

The government has also decided to conduct 2,000 antigen tests in the state per day. In this regard, the state government would procure 1 lakh rapid antigen test kits. It has so far received 30,000 antigen test kits



Govt put on notice over animal cruelty

New Delhi, July 10: The Supreme Court Friday issued notice to the Centre and 12 states including Odisha to declare 'illegal and unconstitutional' the barbaric practices like stuffing crackers in food items and chalked off sticks to ward off wild animals. The court said this while hearing a petition seeking directions to the authori-

A three-judge bench headed by Chief Justice SA Bobde and comprising Justices RS Subhash Reddy and AS Bopanna issued the notices while taking up the petition filed by Shubham Awasthi.

The petitioner sought a direction to the Union government to bring in necessary amendments to the Prevention of Cruelty to Animals Act, 1960 to enhance punishment for causing cruelty against

Awasti also stated that the governments should fill the vacancies in forest forces and upgrade the forest forces with modern equipment for effective management and propagation of necessary awareness pertaining to human-animal conflicts.

It was prayed that the Centre should issue guidelines to all the states for animal census to understand the need of the wildlife and take appropriate measures to protect them. The petitioner pleaded with the court to direct the Union government and states to issue

The petitioner sought a direction to the **Centre for necessary**

amendments to the **Prevention of Cruelty** to Animals Act, 1960 guidelines for tracking of elephants

in order to save them from the threat of extinction and cruelty against them.

The petitioner contended that the cruelty with which elephants are treated nowadays is a far cry from what it was like in ancient India. Citing the barbaric incident of Kerala, where an elephant ate a pineapple filled with crackers in Palakkad, the petitioner contended that it was quite common for locals to use fruits filled with crackers to ward off wild boars and other animals which may de-

stroy standing crops. The petitioner urged the court to direct the Centre for scientific/alternative measures to ward off wild animals which may pose threat to standing crops and human settlements.

1,129 minor mineral sources pinned down for exploration

Bhubaneswar, July 10: In its bid to meet the rising demand of minor minerals like sand and stone, the state government has identified 1,129 new sairat sources that will be explored soon.

This was informed at a meeting in Lok Seva Bhawan under the chairmanship of Chief Secretary Asit Tripathy. Revenue & Disaster Management

Secretary Bishnupada Sethi said within last couple of months 1,129 new sairat sources have been identified in different districts. With this, the total number of minor mineral sairats has increased to 4,965 in the state.

As per earlier decisions of the government, the directorate of minor minerals has been made functional within a very short period of time. "Enhancement of legally operational sources will have triple benefit of ensuring supply of material for construction sector which



is labour intensive, containing the theft of minor minerals and increasing the collection of revenues," Tripathy said.

He sought identifying the sand rich riverbeds on the banks of major rivers like the Mahanadi, the Baitarani, the Bramhani, the Rusikulya and the Subarnarekha in cooperation with the departments of water resources, forest & environment and prepare scientific plans for sand mining.

It was decided at the meeting to allow inter-state transportation of sands through a competitive bidding

sought to strengthen enforcement activities for checking the theft of minor minerals. District Collectors and SPs were directed to utilize the services of Odisha Industrial Security Force (OISF) and sharpen the squad activities for the containment of illegal lifting of minerals.

Available data show, in the first phase, ten sections of OISF have been provided 10 locations in 8 minor mineral rich districts. The places include Cuttack Sadar, Baranga, Jaleswar, Anandapur, Chhatrapur, Bhanjanagar, Dharmasala, Tangi and Ranapur. Besides, one section has been deployed for Jharsuguda, Lakahanpur,

Brajarajnagar on a rotation basis. Director Minor Minerals Bibhuti Bhusan Das said revenues to the tune of around Rs 37.11 crore have been collected in April and May this fiscal from minor minerals. Tripathy directed scaling up of annual revenue generation to Rs 1,000 crore from minor minerals.

Odia scientist invents 'organic energy' from wastes

Cuttack, July 10: An Odia scientist and his team invented organic sources of energy by using waste materials like bio-oil, biochar and pyrogas.

The researchers working under the leadership of Sanjeev Kumar Karmi are working at Sardar Patel Renewable Energy Research Institute (SPRERI) in Gujarat. All the three sources of energy have been invented following a single methodology. The findings of the team could be epoch-making as well as major sources of energy

"Our team had been conducting research over last three years and the inventions will be presented

before the government very soon. The whole world is under pressure due to rising energy prices. Then one has also to consider the effects of pollution and climate change. So the SPRERI team decided to find solutions to these perennial problems," said the young scientist.

The Indian Council of Agricultural Research (ICAR) has borne the expenses of this project. According to the unique research methodology, argon and nitrogen gases are exposed to organic wastes through a pyrolysis process to create the three organic sources of energy - bio-oil which is a substitute of petrol and diesel, pyrogas which is mostly used in spice industries and biochar which is widely used in agricultural sector, Sanjeev added.



Sanjeev said that up to 15 kg of organic wastes can be processed through pyrolysis in an hour, which could simultaneously produce about 40 per cent of bio-oil, 25 per cent to

30 per cent of biochar and 20 per cent of pyrogas. The team has plans to improvise the pyrolysis process in future days.

India could turn out to be a major energy-rich and self-reliant country in the world by adopting this methodology. Simultaneous production of the three organic sources of energy will bring in energy security in the world, the research team opined. Sanjeev belongs to Tebhapadar

Covid spread alarming; toll climbs to 56

Bhubaneswar, July 10: The state Friday registered its highest singleday spike of 755 Covid-19 cases, taking the tally to 11,956, while the death toll mounted to 56 with four more patients succumbing to the infectious disease, a Health department official said.

Detection of 755 more positive cases is a record in Odisha since the first case was detected in the state March 15, the official said.

While 508 of the new cases were reported from different quarantine centres, remaining 247 are local contacts. Contact tracing and followup action is underway, he said.

In a statement, the department said, "Regret to inform the demise of four Covid positive patients while under treatment in hospital."

Two other Covid patients died due to other reasons. The number of Covid-19 positive patients succumbing to other diseases increased to 17, the official said

The patients who died of non-Covid reasons were identified as a 57-year-old man belonging to Sundargarh district, who died due to lung cancer, and a 70-year-old man of Bhadrak district. He also died of cancer of the bladder, the official said.

With this, the number of fatalities due to the deadly virus in Odisha mounted to 56 while the state's hotspot Ganiam district accounted for 34 deaths, the official said.

Ganjam was followed by Khurda (eight), Cuttack (five) and one each





Bhubaneswar, July 10: A delegation of state Bharatiya Janata Party (BJP) Friday approached the Odisha Human Rights Commission (OHRC) seeking justice for a migrant couple who died at an isolation ward of a Covid hospital in Jagatsinghpur earlier this month.

The delegation, led by former Jagatsinghpur MP and BJP's state unit Scheduled Caste Morcha president-Bibbu Prasad Tarai, informed the commission that a woman migrant worker, who returned home amid the coronavirus pandemic to Jagatsinghpur, was found dead a few hours after her husband died in an isolation ward of a Covid hospital in the district.

The couple—Nirlipta Bhola and his wife Subhadra Swain of Katijanga village under Erasama police limits in Jagatsinghpur was sent to the quarantine centre in the coastal district after they returned from Telangana June 30. It was July 1 afternoon when Swain rushed Bhola to a Covid hospital after he complained of uneasiness.

"Swain requested the doctors to attend a choking Bhola, but to no avail. Later, the duo was allotted a room at the isolation ward of the Covid hospital. Things, however, turned upside down when Bhola died at the isolation ward the day after—July 2. Unable to reconcile with her husband's death, Swain slit her wrist and hanged herself at the isolation ward," said the petition.

The petition further said that before resorting to the extreme step, Swain left behind a heart wrenching audio clip that took social media by storm.

"In the audio, the hapless lady not only lamented her loss but also held the doctors responsible for

the same," said the petition. The delegation urged the commission to intervene in the issue and take action against those found guilty. "This apart, the commission should direct the state government to facilitate a compensation of Rs 30 lakh to the bereaved family," the petitioner urged the commissioner.

9 LAKH SAL TREES TO BE AXED IN JODA

Keonjhar, July 10: About nine lakh sal trees in the jungle near Gandhalpada village of Guali panchayat under Joda block in Keonjhar district will be felled as the jungle area has been identified for iron ore excavation.

One of the nine green field mineral blocks, this area has the highest deposit of 314.37 MT iron ores. If operation starts, 241.558 hectares of area will be excavated. Of the total mines area, sal jungle stands on 181.461 hectares.

This area comes under Joda mining area and is roughly 1 km from Sundargarh border. While seven new mines are located in this area, the mining of iron ores is getting delayed due to vehement protests by local residents.

Meanwhile, the government is learnt to be mulling on a fresh auction. This month these mines will

reportedly go under the hammer. Once these mines are leased out, the mining activities will have detrimental effect on the jungle.

According to some environmentalists, the mines will not only see the sal trees being felled but cause extensive damage to the flora and fauna. This apart, the forest dwellers, who live on minor forest produces, will also lose their ageold sources of earning.

The forest department sources said the trees that have a girth of 30 cm are considered trees. Others with less than 30 cm girth are not taken into account.

Environmentalist and president, Keonjhar Citizen Forum, Kiran Shankar Sahu said a tree takes a

As OMC expands dumping yard, Kaliapani locals fume

Jajpur, July 10: Residents of Hatasahi village of Kaliapani panchayat under Sukinda block in Jajpur district are facing serious problems due to the location of a dumping yard belonging to the Odisha Mining Corporation (OMC). The dumping yard, which is approximately 30 metres away from the village, is also expanding thereby reducing the distance between it and the village.

"OMC authorities of the South Kaliapani unit are expanding the dumping yard area, thereby encroaching into village land. They are also carrying out mining activities close to the village. Frequent blasts at the mining site are damaging our houses," residents of Hatasahi village said.

"The collusion between influential people with the management of the South Kaliapani mines and



OMC authorities has added to the woes of local residents. Neither the OMC authorities nor the district administration is doing anything to help the displaced people," the villagers added.

Residents of Hatasahi village have been staying there for more than 60 years now. They have received threats whenever they have protested against the mining activities. The villagers said that they have been paying taxes to the revenue department for their respective land areas. Yet their woes continue to increase.

Social activist Parbati Patra and more than 200 villagers of Hatasahi have already written July 1 to the National Human Rights Commission (NHRC) seeking rehabilitation and adequate compensation for the displaced. The NHRC has filed a case (No-1730/18/24/2020) in this connection and asked the managing director of OMC to submit a reply within four weeks. The distance of the mining site is said to be approximately 70 to 80 metres away from Hatasahi village. Frequent tremors in the area due to blasts have led to cracks developing in houses. Pollution due to the mining activities is also causing respiratory problems to the villagers.

Seconding him, Ganga Kumar, another florist, said, "Before lockdown, our hands were full of orders. for 21st day ceremonies, sacred thread ceremonies, marriage functions and meetings. But after March when Covid restrictions were enforced, we are in trouble."

He added, "Restrictions are still

there for ceremonies, festivals and meetings. People observe their family functions with limited guests. We used to bring the flowers from Kolkata, but now due to COVID-19 situation, that is a problem also."

The florists at one point of time failed to meet the requirements of customers with locally grown flowers. Then the idea of using paper flowers and festoons struck them. Now all the 10 florists here are using these brightly coloured paper

flowers, they claimed. Earlier, the florists would charge Rs 4,000 to Rs 5,000 for decorating a groom's car and for pandals and gates charges varied between Rs 5. 000 and Rs 10.000.

Others said,"Now we may not earn as much by using paper flowers. But even then something is better than nothing. Many areiobless. We are lucky by earning something at this crisis times,'

The DFO stated that the two were suspended for delay in knowing the death of the calf and dereliction of duty. Though the cause of death is


the calf is yet to be ascertained.

Keonjhar, July 10: Come rainy season, busy street sides and markets witness local residents of Keonjhar's forest selling varieties of freshly grown mushrooms. This rainy season is no different either.

Mushroom growth accelerates during the rainy season and to top it all forest dwellers have great knowledge of the locally grown varieties of mushrooms. They have acquired the skills to instantly identify which one is fit for consumption and which ones are poisonous.

During this rainy season it has been a routine for them to go to the jungles in groups carrying bamboo baskets to collect mushrooms early in the morning

According to them, mushrooms like 'Rutuka', 'Bihuduni', 'Bali Chhatu' and 'Kuta Chhatu' are the most delicious ones. This is the reason why these varieties of mushrooms are always in demand. However, mushrooms like 'Picha', 'Manda', 'Patura', 'Mahamuni', 'Bhanu', 'Angaru' etc are also available in markets. As their demand is comparatively less, their price



is also less as compared to the above mentioned types of mush-

These days, they can be found on any given day selling these varieties of mushrooms in markets and by the roadside

While talking to **Orissa POST**, Raimani Naik, a forest dweller, says earlier they used to get huge quantities of varieties of mushrooms from backyards, farmlands and jungles. "Now we are no longer getting them in nearby areas. To collect them, we have to go into the interiors of jungles. Sometimes we come face to face with wild animals. Yet, we collect and sell them in nearby markets. If they are cooked properly, its curry is as tasty as mutton curry," she claims.

However, they allege they are not getting a fair price for their mushrooms. Traders do buy these mushrooms from them and sell them to people in an exorbitant price. Mushrooms from here are transported to other districts and even to places out of the state.

According to Harekrushna Mahanta, an ayruvedic practitioner, mushroom is good for health. Vegetarians prefer it over any alternatives. But there are some poisonous mushrooms as well. So we have to be careful while buying them. During these days, incidents of people dying after consuming some sorts of poisonous mushrooms are common.

Echoing the same, educationist Anil Kumar Das said that the quantity of naturally grown mushrooms has drastically come down over the years due to so many reasons including deforestation and climate change. To meet the demand, nowadays mushrooms are being cultivated. Straw mushroom and button mushroom are the most common ones. But they are nowhere near the taste that naturally grown mushrooms offer. This is the reason why visitors to this district make it a mental note to buy some of these mushrooms to their houses, he added.

Elusive Medical Commission

he National Medical Commission (NMC) was created last year to replace the previous scam-tainted Medical Council of India (MCI) for the development and regulation of all aspects of medical education, profession and institutions. Yet, despite the urgency displayed in creating the new regulator, the government has still not issued a notification on the appointment of the chairman of the commission.

Six months ago, the government named Prof S.C. Sharma of AIIMS as the chairman of the new commission for three years. It has yet to issue the notification of his appointment. This inordinate delay has set off whispers in the babu corridors about the government's intentions.

According to sources, the delay is caused by the fact that the commission itself is yet to be constituted, since the selection committee recommendations for the other posts are still under consideration of the Health Ministry. So, according to them, the chairman's appointment can only be notified once the commission is constituted.

Under the National Medical Commission Act, 2019, the commission will have a chairperson, 10 ex-officio members and 22 part-time members. Besides, Prof Sharma, the only person appointed so far is R.K. Vats, the secretarygeneral of the board of governors of the Medical Council of India. He too was appointed as secretary of the commission for a tenure of three years.

Sebi succession saga

With Securities and Exchange Board of India (Sebi) chairman Ajay Tyagi's term ending next month, the race to find his successor has heated

up. The tenure of Tyagi, a 1984batch IAS officer of Himachal Pradesh cadre, was set to end in February but he was given a sixmonth extension to ensure continuity at the regulator due to the ongoing Covid-19 pandemic.



According to sources, several names are being floated as probable successors to Tyagi. Among them are Insolvency and Bankruptcy Board of India (IBBI) chairman Madhusudan Sahoo and Madhabi Puri Buch, who is whole-time member of Sebi. Also being mentioned are former corporate affairs secretary Injeti Srinivas and a few officials in the Finance and Corporate Affairs

Apparently, the government had already narrowed down some of the probable candidates in February before it decided to give an extension to Tyagi. Will the list be revised now? Will it include only bureaucrats? We'll have to

Mumbai police chief Parambir Singh recently transferred 10 deputy commissioners of police apparently without Chief Minister Uddhav Thackeray's knowledge. On learning about the move, Thackeray promptly ordered the state Home Department to cancel the transfer orders. The CM's office claims that it was wrong of Parambir to shift such a large number of DCPs without the CM's knowledge. Later, it turned out that Parambir had briefed Home Minister Anil Deshmukh on the transfers, who failed to inform Thackeray. Thackeray's alliance partner Nationalist Congress Party chief Sharad Pawar had to step in to mollify the irate chief minister.

According to sources, during a meeting with the chief minister in the presence of NCP chief Sharad Pawar, Deshmukh argued that it was well within the powers of the Mumbai police commissioner to transfer officers without informing the CM. But the CM's office has taken the view that it not the rulebook but convention that is more important, which means that the transfers $\,$ should have been discussed with Thackeray before the announcement.

Does this imply that there are cracks in the Shiv Sena-NCP-Congress alliance government in Maharashtra, in which the partners do not see eye to eye anymore on important issues of governance?

■ Subfusc

his word is almost unknown in the USA but may be found in literary writing in Britain. It was spotlit by news in March 2006 that a poll of undergraduates in Oxford had overwhelmingly rejected proposals by the University authorities that they should no longer wear subfusc during examinations. The word emerged in the early years of the 18th Century. It means something dull, dark or gloomy and is related to the older fusk, long obsolete, for a dark brown or dusky colour. That's from Latin fuscus, dusky, which has also given us the rare adjective fuscous for a dark and sombre colour as well as the more common obfuscate, to render obscure, unclear, or unintelligible. Subfusc was taken directly from the Latin subfuscus; in this case the sub- prefix means "of the approximate colour" (two other examples are subalbidus, whitish, and subviridis, greenish). Around the middle of the 19th Century, the word began to be applied to the formal costume of Oxford undergraduates and later to that of students at other universities. Since the first example in the Oxford English Dictionary's entry is from the comic novel of Oxford life, Verdant Green by Cuthbert Bede, we may guess that its first application was intended to be humorous. But it has long since become standard, and appears in the current Oxford University regulations set down in 2002 by the Vice-Chancellor: "All members of the University are required to wear academic dress with subfusc clothing ... when attending any university examination." For men this is a dark suit and socks, black shoes, a white bow tie, and plain white shirt and collar; for women, a dark skirt or trousers, a white blouse, black tie, black stockings and shoes. To these have to be added a student gown and a mortarboard cap, though the latter may be carried rather than worn.

The government sells bonds and borrows money both in the monetary and debt policies; but, in the monetary policy, it is linked to printing of notes by the RBI while in debt policy there is no such linkage.

The burden falls on the people immediately if the fiscal approach is adopted. If, for example, the government increases the rate of GST from 18 per cent to 24 per cent, vou and me—the consumers will have to right away pay more for the mobile phone that we buy. In comparison the benefits from the expenditures can accrue today or in future. If the government uses the money to increase expenditures on MNREGA, for providing food subsidies or for providing assistance to small businesses to pay the employer's share of the provident fund, then the benefits will accrue immediately. The money will enter the pockets of the people here and now. On the other hand, if the same money is used to make bullet train, national waterway or sending a space mission to Mars. then the benefit will accrue after 3,5 or 10 years because it will take time for such projects to be implemented. Therefore, under fis-

cal policy, the burden is borne immediately while the benefits accrue in part in the present; and in part in the future depending upon the nature of the expenditures. For this reason we are today reaping the benefits of the investments made by earlier generations in Indian Space Research Organisation, national highways, IITs and such projects.

The burden of monetary policy of the RBI printing notes falls in the future. Let us say there is currency of ₹100 crore in circulation in the economy and there are goods of ₹100 crore available for purchase in the economy. Now, let us say, the Reserve Bank printed an additional ₹10 crore of notes and the government got that money through the commercial banks. Now, the goods available in the market are of the same value as previously, namely ₹100 crore, but the notes in circulation have increased to ₹110 crore.

Naturally, a pen that was previously selling for ₹10 would now be sold for ₹11 because more number of notes are chasing the same amount of goods. However, it takes some time for the increase in price to take place. The money will be borrowed by the government, and an allocation will be made to, say, the Surface Transport Ministry. The ministry will call for tenders and issue them, the contractor will build the highway and raise the bill and the money will enter the economy at that time. Therefore, the burden of monetary policy would fall in the future; while the benefits will accrue either at present if the money is spent on MNREGA or accrue in the future if the money is spent on making highways.

The burden of the debt policy also falls in the future. The interest paid on the money borrowed today is paid in the future just as a taxi owner borrows money today, buys the taxi and pays the interest on the loan later. Likewise, if the government borrows ₹10 crore today the interest of ₹1 crore on the loan would have to be paid at the end of the year or after the moratorium. The commercial banks regularly provide a period of a few years before the interest payments are made. The International Monetary Fund and World Bank do the same. The burden of debt therefore falls in the future but the benefits accrue at present or in the future depending upon whether the money is used to pay for MN-REGA or to make highways.

It is clear that the fiscal policy involves imposition of the burden on the people at present, while the burden of the monetary and fiscal policies falls in the future. The benefits, in all three cases, accrue at present or in the future depending upon the nature of expenditures. Let us assume for a moment, that the expenditures are made such that 50 per cent benefits accrue at present and 50 per cent accrue in the future. If these expenditures are made with fiscal policy, then 100 per cent burden falls in the present while 50 per cent benefits accrue in the future. present wealth to future as was done, say, by the establishment of the Indian Space Research Organisation by past generations while the benefits are accruing to us. In contrast, if these expenditures are made with monetary or debt policy, then 100 per cent burden falls in the future while 50 per cent benefits accrue in the present. Thus, this leads to transfer of wealth from future to present as was done, say, by the government borrowing from the International

This is the reason that the government likes monetary policy The politicians can reap the benefits of providing subsidised food grains to the people today while the burden will fall on the future generations. On the other hand, following fiscal policy involves bearing the burden today for the benefit of future generations like the head of the family investing in the education of the children.

Monetary Fund in the 1990s.

The second aspect is that monetary policy evades scrutiny. The fiscal policy immediately leads to people asking why they have to pay higher tax. They want answers. They try to scrutinise the corruption and waste in the government expenditures. They want the government to put its own house in order before imposing more taxes. The debt policy leads to lenders scrutinising the finances of the government such as is done by the rating agencies.

Thus, if the government wants to sell bonds on the international money market, the lenders ask questions about the high salaries paid to government servants. But monetary policy of printing notes by the RBI and borrowing by the government involves no scrutiny whatsoever. No wonder, the government likes it. Whatever the costs of the pandemic, we must bear them ourselves and not encroach upon the welfare of our future generations. We should avoid monetary and debt; and follow fiscal policy.

Beyond Ladakh, issues to tackle with China

has begun. China is stepping back from three contentious areas; Galwan, Hot Springs and Gogra. Everyone at home and abroad is cautioning New Delhi to carefully monitor the withdrawal; never to take the Chinese on their word, which they often go back on. Frankly, it is not yet clear where the Chinese had come to on the Indian side of LAC, and how far they are

withdrawing. Critics argue that New Delhi lost ground in Galwan negotiations. On Chinese aggression in East Ladakh, Modi does a Nehru. New Delhi has given in too soon in pursuit of a quick de-escalation. Modi will be mentioned by historians as the first Prime Minister to

lose to the Chinese without a fight. Evidently, according to hardliners, China encroached Despangyjunction and Galwan's pp-14. By agreeing to a buffer zone on the Indian side of LAC, and to Indian patrolling to the west of the confluence of Galwan and Shyok rivers, India will practically stay out of Galwan valley. This confirms the new claim Beijing makes on the entire valley. The pro-government media began chest-thumping on

he disengagement in Ladakh the withdrawal. They bloviate that New Delhi pushed the Chinese back beyond Indian territory without firing a bullet. It is the biggest victory led by the Prime Minister from the front. His saber-rattling speech to our soldiers at Nimbu, Ladakh not only echoed in Beijing but empowered smaller countries like Bhutan and Myanmar to stare back at the dictator Xi Jinping.

Fact is, Ladakh is the tip of the iceberg of China's insidious hegemonic designs. It is claiming territory from almost all of its neighbours, having illegally annexed countries like Tibet and Xinxiang. It occupies about 53,000 sqkm of Indian territory. Our aim should be to retrieve our land, liberate Tibet, and recreate the buffer (Tibet) between India and China. Only then, we should celebrate.

I know it is a tall order, but not an impossible task. It may sound absurd too and it did to some panelists. Recall what the wisest man of the world had said; "Only those who attempt the absurd can achieve the impossible." In any case, the Chinese empire would fall like the Soviet one did. Whether India works towards the disintegration of Chinese empire or not, it is inevitable. But it is in India's interest that New

break-up. Modi has experienced, if not committed, a mistake twice, Doklam and Ladakh, in his six-year tenure at the helm. If he continues with China as business-as-usual, the tragedy is waiting to happen. Look at the most recent experience under Modi. After Doklam standoff. he hit top gear in making up with China. His informal summits in Wuhan and Mahabalipuram, deepening business ties, heavy imports from China, making our economy China-dependent, were all exam ples of short-sighted approach. Modi's foreign policy suffers from two perceptional flaws. One, Pakistan is Indian's enemy number one. Fighting Pakistan on terrorism and saving Kashmir has been the raison d'être of our foreign policy. Instead, it should have been China.

Delhi aids the process of China's

The second flaw is Modi's as sertion of India's strategic autonomy and the Indian PM being one of the world leaders. This is a hangover of Nehruvian aspirations. One can be reckoned as world leader when the country(s) he leads is economically strong, politically credible and socially stable. India can boast of democracy and pluralism, but not of economy.

Nehru followed a nebulous nonaligned policy which collapsed when we signed the Peace and Security Treaty with Soviets in 1971. He trusted the Chinese and depended on the Soviets. Modi did no different. When the bulk of our trade is with Americans, and we share democratic polities with Europe, Australia, USA, South Korea, Japan and Israel who promise to stand by us in defense of our democracy we walk into both Soviet and Chinese entrapment. Another imprudent strategy is to massively buy weapons from Soviets which they sell to Chinese as well. Why is this contradiction or compulsion?

Honestly, New Delhi should pitch its tent high: make necessary formal strategic alliances to take on China to a logical and satisfactory end, which is the retrieval of our land including Aksai Chin and Shaksgam. These recurrent skirmishes on LAC and Chinese's atrocious claim on Arunachal Pradesh would cease only when Jinping's China is made to bite dust like Hitler was. India cannot do it alone, however much weaponry it accumulates.

JEE-Main exam

Sir, The news that the National Testing Agency (NTA) has decided to take a review of the January cycle of the JEE(Main) exam after the schools re-opened may be relevant but this new introduction of exams twice a year is not appropriate. The JEE(Main) was first conducted "twice a year" after its introduction in 2019 and raised a controversy in respect of "percentile" and 'ranking' by conducting the two examinations the same year with a minimum gap of three and a half months. Punjab farmers to protest Alwar back in news for wrong reasons **Union govt's Ordinances**

Chandigarh, July 10: Fearing the discontinuation of the MSP regime, a Punjab farmers' outfit will stage a statewide protest July 20 against the recently introduced three Union government ordinances.

BKU (Rajewal) president Balbir Singh claimed that the legislations are not in the interest of the farming community as the minimum support price (MSP) regime will be dismantled after a period of time. The Centre had recently introduced the Farmers' Produce Trade and Commerce (Promotion and Facilitation) Ordinance; Farmers (Empowerment and Protection) Agreement on Price Assurance and Farm Services Ordinance: and the Commodities (Amendment) Ordinance, which is being opposed by them.

Rajewal, whose outfit has given the call for the protest, said the companies, which have been "allowed to procure crop from farmers without paying any tax", will "exploit" growers in the absence of any "foolproof" dispute redressal mechanism."Grain markets where farmers at present sell their crops



at MSP will cease to exist after one or two years," he claimed. Rajewal said farmers were also against the fuel price hike. "It has been difficult to bear the cost of diesel at a time when the sowing of paddy is going on in the state," he said.

He said that farmers will also oppose the proposed Electricity (Åmendment) Bill, 2020 as it may adversely hit free power to different sections of society.

"We will submit memorandums to the district authorities during a three-hour-long protest starting at 10 am on July 20," Rajewal said here Thursday.

"We will be following social distancing norms during the protest in the wake of the coronavirus pandemic." he added.

Earlier, accusing the Akalis of "selling Punjab's interests" by agreeing to what he dubbed the "antifarm ordinances" brought forth by the Centre, Chief Minister Amarinder Singh had said that he would take his fight against these steps to the Union government.

Singh said he would soon write to Prime Minister Narendra Modi to seek an appointment for a meeting with an all-party delegation from all Punjab parties, except the BJP. "No matter what (Akali Dal leader) Sukhbir Badal or the BJP say, once these ordinances are passed, the Centre's next step would be to end the MSP regime and dismantle the Food Corporation of India," warned the Chief Minister, pointing to the recommendations of the Shanta Kumar committee on the matter.

Underlining the need to save Punjab and protect its interests, the Chief Minister said the ordinances were 100 per cent against Punjab and anti-farmers, as agreed to by all political parties in the state, except the BJP and the Akalis. INDO-ASIAN NEWS SERVICE

Sanitising device to disinfect packed food items, currency

Chandigarh, July 10: A timer-fitted sanitising device, which uses UV radiation to kill microbial pathogens, has been developed by the Dr BR Ambedkar National Institute of Technology in Jalandhar to disinfect a variety of articles including packed food and currency.

The portable box-shaped gadget is fitted with ultra-violet lights on the top and at the hottom

It can sanitise packed food items and disinfect currency notes and credit cards besides sanitising papers, files. used masks and gloves, keys etc, the NIT said in a statement.

"Its UV radiation kills microbial pathogens like virus, bacteria or fungus deposited on the surface of any article when they were kept inside its drawer for sanitising," it said

"UV-C radiation technology is a known disinfectant for air, water and surfaces that can help mitigate the risk of acquiring an infection. All bac-

teria and viruses tested to respond to UV-C disinfection. At present UV light is used in many food industry applications as it is completely safe, low maintenance and does not require the use of any chemicals or pesticides," the statement said.

Designed by Director, NIT, Dr LK Awasthi and Associate Professor, Department Instrumentation and

Control Engineering, Dr Kuldeep Singh Nagla, the device, is "completely safe for adults and children" Awasthi said although there are

some other such UV gadgets available in the market but this compatible sanitiser has some additional features which makes it more human

Nagla said the device is safe for the users because there is no exposure to them. "When the drawer is opened, the UV light automatically gets switched off. The perforated, acrylic sheets and lights are fitted in such a manner that items kept in it get disinfected from all

"Besides being safe for use in homes and offices, it can be helpful for bankers too. They can protect themselves from viruses while handling currency notes which can also be carriers of various infections," he said. He said the user can set the timer as per the item and

"For example, in banks, a cashier can place the currency notes and can set the timer for 120 seconds, the device will be automatically switched off after two minutes. Similarly, in case of packed food items, bottles etc. it can be set up to 300 seconds and sometimes above too," he said. An in-built fan regulates the temperature for safety.

Dr Awasthi said the product has already been sent for patent and the NIT is tying up with a private company for commercial production of the



Billionaire Punjabi charters repatriation mission in UAE

Chandigarh, July 10: No flight of fancy this! A billionaire Punjabi in Dubai has taken charity to new heights by virtually launching chartered flights to bring distressed compatriots back.

Philanthropist Surinder Pal Singh Oberoi is now a messiah for workers and tourists who have been stuck in the UAE due to COVID-19 travel restrictions. This week a first batch of 177 people returned to Chandigarh and reunited with their families. Three more flights have been lined up this month; four in August.

"We are arranging free charter flights mainly to repatriate low-income workers who have lost their jobs and they ran out of money," Oberoi, 64, a Dubaibased industrialist from a small town in Punjab, told IANS here Friday. He said the stranded Indians include tourists who came out on a shoestring budget and the money is running out. 'We are giving priority to pregnant women, old, sick and families," he said.

The next scheduled chartered flights of SpiceJet, each carrying 177 passengers, are July 13, 19 and 25.

A flight costs Rs 40-42 lakh and is being paid by Oberoimanaged Sarbat Da Bhala Charitable Trust. Oberoi, who went to Dubai in

1977 as a mechanic, is well

known for charity work. His trust saved more than 80 people convicted of various cases for philanthropist The Sarbat Da Bhala Trust,

crimes in the United Arab Emirates. It rescued a woman from Punjab who was sold as a domestic help in Oman.

In 2013, the trust had paid millions of dirhams as "blood money" to secure the release of 17 Indians who were on death row for killing a Pakistani man in the UAE. "With the grace of God my business is growing. I am giving back 98 per cent of my income to society by getting into social work and the rest two per cent is enough for me and my family to sustain a decent life," an elated Oberoi, who owns seven companies in Dubai, told IANS. Emotionally bonded with his roots, he said 75-80 per cent of the people who are coming in these specially arranged flights are those who are struggling to survive after being rendered homeless and penniless.

"For them, we have made arrangements to put stay in our shelter homes till they are repatriated," he said. Oberoi, the Chairman of the Apex Group of Companies who came to Dubai at the age of 20 in 1977 on a job visa and launched his own business in 1993, urged wealthy Indians in the UAE to help stranded people. He said

it is the spirit of the UAE that has encouraged him to be a

which does not raise any charity, is ensuring free food distribution to 60,000 families per month in Punjab and neighbouring states who have been affected amid the lockdown that came into effect March 23.

The supply of ration kits to sustain at least five members in a family will continue till September, trust spokesperson Manpreet Sandhu said.

He said the trust provided funds to the tune of Rs 20 crore to the local authorities, the Border Security Force (BSF) and various government de partments to his home state to fight Covid-19. Vijay Ojha, also associated with the research centre, said, "Last time, we had supplied these cow dung made rakhis to places like Ujjain, Varanasi, Delhi and Jaipur. This year, we have already started receiving big orders from different places. We have 25 different types of rakhis," he said.

Besides Bharatpur and Banswara, a women self-help group is being trained in Ajmer to make rakhis using Indian raw materials.

New Delhi, July 10: Chief Justice SA Bobde Friday, citing migrant workers' case, said it is not for the apex court to take up every matter at the very first instance, especially in the backdrop that facts associated with the matter differ from one state to another.

The Chief Justice said, "People and lawyers' have expressed disappointment that the Supreme Court did not urgently entertain various matters such as migrant workers case etc." He added that the lawyers'

and people should know when facts differ from one state to another then under these circumstances it should not be the apex court that can hear the matter.

The Chief Justice termed it odd that the apex court has to explain this process to the lawyers instead of them being well aware about this process and how it works. The Chief Justice indicated that these matters are fact-intensive which may vary from one state to another and maybe in districts in some cases.

"We find it very odd that we have to say it as a bench that it is for a



jurisdictional court to look into these facts and decide at the first instance," said the bench also comprising Justices AS Bopanna and R Subhash Reddy.

The CJI said the parties should

move the apex court in the second instance which would provide benefit to the bench at the top court to see the HC judgment.

It seems that the comments by the Chief Justice was made to address the criticism of the apex court in the delay in taking up various issues connected to the migrant workers which included transportation to their native places, food and shelter in the backdrop of the coronavirus pandemic.

Later the apex court took suo moto cognisance of the matter and issued a slew of directions.

From Friday to Friday: The Vikas Dubey story

Lucknow, July 10: Vikas Dubey was a relatively unknown name in Uttar Pradesh and its underworld till Friday, July 3.

As the sun dawned Friday, Dubey had become the most dreaded name

He and his accomplices had shot dead eight police personnel in Bikru village under Chaubeypur police circle in cold blood. The police team had gone to Vikas Dubey's house in the wee hours of Friday to arrest him in a case of attempted murder. Dubey, who had been tipped off about the police raid by some moles in the police force, was prepared with his gang and opened fire on unsuspecting police personnel.

He fled the scene with his accomplices, leaving behind a trail of blood, rage and horror.

The incident, first of its kind in Uttar Pradesh, led to nationwide outrage and cast aspersions on the Yogi Adityanath government and the state police force. The Kanpur police shot dead two suspects, Prem Prakash Pandey and Atul Dubey, within four hours of the incident.

In another knee-jerk reaction, the police demolished Dubev's house in Bikru village a day after the massacre and trampled over his two vehicles and two tractors with an earthmover.

The action made political leaders like former Union Minister Salman Khurshid question the legality of the action and the action on his family earned him support from the Brahmin community.

Station officer Vinay Tiwari and inspector KK Sharma were suspended after their call detail records confirmed their conversation with the gangster. The two were arrested Wednesday. As investigations progressed, the political connections of Vikas Dubey grabbed headlines. His photographs with top political leaders across the political spectrum added to the discomfiture of the people in power and in the opposition.

Investigations revealed that Vikas had amassed wealth and property through deals in real estate, liquor business and contracts.

Political parties indulged in mud-

slinging and played the blame game as the STF hunted down and killed his lieutenant Amar Dubey Wednesday in Hamirpur and Bauan Dubey in Etawah, Prabhat Mishra. who was arrested from Faridabad on Wednesday, was shot dead in an encounter on Thursday - ironically, at the same spot where Vikas Dubey would later be felled Friday.

Vikas Dubey, meanwhile, remained elusive for the police. Fifty teams of state police and Special Task Force raided all his hideouts and picked up his relatives in an attempt to mount pressure on the gangster. The borders of the state were sealed and frantic searches were carried out on the highways while Vikas remained holed up in a relative's house in Kanpur itself for two days. He then managed to reach Faridabad where he was caught in a CCTV camera at a hotel. The police reached after he had left.

Every move of Vikas Dubey was hungrily lapped up by the media, turning the gangster into a muchdreaded don almost overnight.

Even as the police continued its attempts to arrest the gangster, Vikas quietly slipped into Madhya Pradesh and then to Ujjain. On Thursday morning, he went to the famous Mahakaal temple where he revealed his identity and got himself arrested.

The Madhya Pradesh police claimed the credit for his arrest and Vikas was handed over to the UP STF on Thursday night.

He had reached Kanpur Friday morning when the SUV he was being brought in overturned and he was killed while trying to flee.

When he died, Vikas Dubey had completed his journey form a nonentity to a much-dreaded gangster -- all in a week, from Friday

Mumbai, July 10: India reported a record 26,506 new coronavirus cases on Friday as authorities reimposed lockdowns in its most populous state and in an industrial hub, home to automakers, drug factories and brewers.

The new cases pushed India's tally to nearly 800,000 cases, the world's third-biggest outbreak behind only the United States and Brazil in confirmed infections.

There have been more than 21,000 deaths in India since the first case was detected there in January, Union Health Ministry data showed Friday. New Delhi, along with Maharashtraand Tamil Nadu accounts for about 60% of its cases.

The Centre, anxious to jumpstart an economy crippled by the epidemic and put millions of people back to work, in early June eased an initial lockdown of the 1.3 billion population imposed in March. But rising new flare-ups of the virus has been forcing some major industrial towns and states to impose localised restrictions.

A nine-day curfew was imposed in Aurangabad, an industrial town in Maharashtra, to contain a spike in infections that has affected operations of automakers such as Bajaj Auto.

New Delhi, July 10: In the midst of India's tense border standoff with China. US aerospace major Boeing delivered the final five of the 22 Apache attack helicopters to the Indian Air Force last month, and the fleet has now been part of the assets deployed in key air bases along the Line of Actual Control, officials said Friday.

Boeing said it completed delivery of all 22 Apache and 15 Chinook military helicopters to the IAF and is fully committed to meet their operational needs of the Indian armed forces. The AH-64E Apache is one of the world's most advanced multirole combat helicopters, and is flown by the US Army. The Chinook is a multi-role, vertical-lift platform, primarily used for transporting troops artillery, equipment and fuel.

India finalised a multi-billion dollar contract with Boeing to procure 22 Apache helicopters and 15 Chinooks for the IAF in September 2015.

Both the Apache and Chinook helicopters have been pressed into service as part of the IAF"s deployment along the LAC in view of the bitter standoff with China in



eastern Ladakh, officials said. "With this delivery of military

helicopters, we continue to nurture this partnership and are fully committed to working closely with India's defence forces to deliver the right value and capabilities to meet their operational needs," said Surendra Ahuja, Managing Director, Boeing Defence India.

India is one of 17 nations to select the Apache and has the most advanced variant, the AH-64E Apache.

Paswan said the ministry is trying to include all remaining States/UTs onboard of ONORC by January 2021. He


said that earlier many States/UTs highlighted the challenges related to slow network connec-

Scientists worry dengue outbreak may aggravate nCoV crisis

SCIENTISTS WARN THAT COVID-19 AND THE MOSQUITO-BORNE DISEASE HAVE OVERLAPPING SYMPTOMS AND WORRY THE COUNTRY'S HEALTHCARE INFRASTRUCTURE WON'T BE ABLE TO COPE WITH THIS DOUBLE WHAMMY

New Delhi, July 10: As dengue season sets in across large parts of India with the onset of the monsoon, scientists warn that COVID-19 and the mosquito-borne disease have overlapping symptoms and worry the country's healthcare infrastructure won't be able to cope with this double whammy.

The impact of a 'dengue-COVID-19' season would entail two different diagnostic tests and extract a huge toll on patients too, each disease making the other more complicated to deal with and perhaps

While the number of COVID-19 cases races towards the 8,00,000 mark with 7,93,802 cases on Friday

and 21,604 fatalities, the incidence of dengue is also high.

Based on 2016-2019 data, virologist Shahid Jameel estimated that India gets about 100,000 to 200,000 confirmed cases of dengue each year.

According to the National Vector Borne Disease Control Programme (NVBDCP), 1,36,422 dengue cases were diagnosed in 2019 and an estimated 132 people died.

'The virus is endemic and present around the year in southern India, and in monsoon and early winter in northern India," Jameel CEO at DBT/Wellcome Trust India Alliance, a public charity that invests in building biomedical sciences and health research framework. told this news agency

Both COVID-19 and have symp-

toms such as high fever, headache and body pain.

The dengue season may aggravate the COVID-19 situation as both viruses may supplement each other, warned Dhrubjyoti Chattopadhyay, virologist and vice chancellor of the Amity University in Kolkata.

"This situation is not yet well studied. But the information available from South America is dangerous and found to create a major challenge to their medical infrastructure," he said.

"The effect will be very critical. As major symptoms are overlapping, simultaneous infection will be much more fatal. Weakened immune systems will help the other to be more fatal.'

Once the dengue season starts,





added virologist Upasana Ray, the infection spreads aggressively due to high prevalence of its mosquito vector, aedes aegypti.

"Each season, we experience heavy loads in the hospital wards due to dengue outbreak and those times it gets almost unmanageable.

So, have we thought about what will happen when we have two menaces to handle together? Both of them have overlapping symptoms. Are we geared to distinguish if a person has dengue or COVID 19?" asked

the senior scientist, CSIR-IICB,

Kolkata.

The challenges are many. Almost each patient with a threeday fever would need to undergo a test for dengue and another for the SARS-CoV-2 virus which causes COVID-19.

"Considering the current numbers of COVID-19 patients, will our hospitals have beds available for dengue patients? Or will only severe dengue cases be handled at hospi-

tals?" she asked. Explaining how the viruses manifest in the human body, Jameel said the dengue virus enters via a mosquito bite through the subcutaneous layer of the skin from where it reaches the lymph nodes that are rich in types of blood cells called-

monocytes, macrophages and dendritic cells.



Panel proposes new regulator for non-personal data: Report

New Delhi, July 10: India should set up a data regulator and require companies to disclose how they collect and store data devoid of personal details or which has been anonymised, a panel tasked to draw up such regulations has said in a draft report seen by Reuters.

As India moves to tighten policies on its citizens' data held and processed by companies such as Facebook, Google and Amazon, it set up the panel last year to make recommendations on the regulation of "non-personal data".

The panel is in the final stages of deliberation on the report before it is submitted to India's information technology ministry, a person familiar with the discussions said.

A company collecting data bevond a vet unspecified threshold should register as a "data business" in India, the report said, with government bodies also subject to the need to disclose what information they collect and store, and how they use it.

The panel consulted companies such as Amazon, Microsoft and Uber, as well as some international experts, in drawing up the report, it said.

Regulation of non-personal data is just one of several areas for which India looks to hammer out policy, which will affect tech giants in a regulatory trend gathering momentum worldwide as nations step up efforts to control data.

India has drafted an e-commerce policy that also calls for a new regulator, while a separate privacy bill under review has upset tech companies.

Some data held by the private sector could be drawn on if needed to make policy and back wider social objectives such as healthcare, the panel said.

Asked about whether he thought it would be proper to hold elections in time in view of the rising cases of the infection, he had said, "I

think it would not be proper. The situation in the state is scary and the people have been left to fend for themselves in the face of the raging pandemic."

He also criticised the JD(U)-BJP combine for routinely holding virtual rallies whereby leaders of these parties have been interacting with workers across the state.

Both the BJP and the JD(U) have asserted that they are ready for the polls and have been holding organisational meetings.

India to resume patrols in Ladakh

New Delhi, July 10: India will seek to patrol the portion of the Fingers Region along the Pangong Lake in Ladakh which it was prevented from doing after a largescale Chinese incursion in the area once tensions between the two countries subside, government sources said. "Patrolling has been stopped for [the] time being but would be restored as things cool off. We will physically verify each of our points.'

India has traditionally claimed rights to patrol all eight spurs (referred to as fingers) in the disputed region and believes that the Line of Actual Control or LAC here rests at Finger 8. China, for its part, believes that the LAC lies at Finger 4 beyond which the territory belongs to them. In May this year, several Indian soldiers were injured in violent clashes here after Chinese forces prevented Indian soldiers from moving in the direction of Finger 8.

But with the process of disen-

gagement proceeding successfully, there is hope that China will vacate the region between Finger 4 and Finger 8. Satellite pictures indicate that there are more than 186 Chinese tents and shelters which have been set up across the disputed region since the tensions began. So far, there has been a marginal thinning out of forces in the Finger 4 region by China though they continue to occupy the ridge-lines between Finger 4 and Finger 8.

At least 186 Chinese pre-fabricated huts, shelters and tents were visible between 'Finger 4' and 'Finger 6'. Click here for a high resolution image

At the moment, Chinese and Indian forces have mutually withdrawn 2 kilometres each in the Galwan Valley, Hot Springs and Gogra. Crucial talks at the Joint Secretary level of the Working Mechanism for Consultation and Coordination will continue talks towards an eventual restoration of the status quo across Ladakh before reports of Chinese incursions in five regions came in during the month

Chaurai, in his death. He suspected that his son had died only because of black magic practiced by her.



The next morning, he walked to the nearest police station while clutching the severed head in one hand and the weapon in the other, and surrendered before the police, "This woman had killed my young son by practicing witchcraft but I have avenged his death Please arrest me," the accused told the policemen present at the station

Witnesses said the policemen on duty were terrified by what they saw before they mustered the courage and took him into custody. Based on the information provided by him, the police rushed to the scene of the crime and recovered the body of the woman.

The accused told the police that the woman had told his son he would die in the evening and her words proved true. He didn't perform his son's last rites and kent his body at home until he took revenge for his death.

Why COVID cases in India are rising to multiple peaks

New Delhi, July 10: In just three weeks, India went from the world's sixth to the third-worst hit country by the coronavirus pandemic, according to a tally by Johns Hopkins University. India's fragile health system was bolstered during a stringent months-long lockdown but could still be overwhelmed by an exponential rise in infections.

Here is where India stands in its battle against the virus:

Multiple peaks

India has tallied 793,802 infections and more than 21,600 deaths, with cases doubling every three weeks. It's testing more than 250,000 samples daily after months of sluggishness, but experts say this is insufficient for a country of nearly 1.4 billion people.

The Health Ministry said Thursday that India was doing "relatively well" managing COVID-19, pointing to 13 deaths per 1 million people, compared to about 400 in the United States and 320 in Brazil. But knowing the actual toll in India

is "absolutely impossible" because there is no reporting mechanism in most places for any kind of death, said Dr Jayaprakash Muliyil, an epidemiologist at the Christian Medical College in Vellore who has been advising the government.

Official data shows 43% of the people who have died from the coronavirus were between the ages of 30 and 60, but research globally indicates that the disease is particularly fatal to the elderly, suggesting to Muliyil that many virus deaths among older Indians "don't get picked up" or counted in the virus fatality numbers.

'NO COORDINATION

In India, public health is managed at a state level, and some have managed better than others. The southern state of Kerala, where India's first three virus cases were reported, has been held up as a model. It isolated patients early, traced and quarantined contacts and tested aggressively. By contrast, Delhi, the state that includes the national capital, has been sharply criticized for failing to anticipate a surge of cases in recent weeks as lockdown measures eased. Patients have died after being turned away from COVIDdesignated hospitals that said thev were at capacity. It led the Home Ministry to intervene and allocate 500 railway cars as makeshift hospital wards.

But as the capital rushes to conjure new beds, officials admit that they're worried about the lack of trained and experienced health care workers. According to Jishnu Das, a professor of economics at Georgetown University, there is "no central coordination" to move health care staff from one state to another, exposing India's relative inability to use data to guide policy decisions.

"The one big thing that we're learning from this pandemic is it takes any cracks in our systems and it drives a chisel to them. So, it's no longer a crack, it's a huge chasm,"

Das said. **ROLE IN GLOBAL FIGHT**

India has seven vaccines in various stages of clinical trial, including one by Bharat Biotech that the Indian Council on Medical Research pledged would have results from human trials by August 15, the country's Independence Day. The top medical research body quickly backtracked, but regardless of whether India comes out on top in the global race for a vaccine, the country will play a critical role in the world's inoculation against COVID-19.

The Serum Institute of India in the central Indian city of Pune is the world's largest vaccine manufacturer. India makes about 1,000 ventilators and 600,000 personal protective equipment kits per day, according to government thinktank Niti Aayog, making it the second largest kit maker in the world



UK relaxes quarantine rules

London: Travellers arriving in the UK from dozens of countries will no longer have to self-isolate for two weeks starting from Friday onwards. The rules were being relaxed for arrivals from 75 countries and British overseas territories. From Friday morning, people arriving in the UK from France, Italy, Belgium, Germany and dozens of other countries will no longer have to spend 14 days in quarantine. But people who arrived from those countries at an earlier point in the last two weeks will still be expected to complete their period of isolation, the government said. Daniel Navarro, 27, of Fond du Lac, told investigators he had been harassed by co-workers and neighbors, and poisoned, drugged and verbally attacked by white people because of his race, authorities said.

China vows action against **US sanctions over Xinjiang**

Washington/Beijing, July 10: The US has imposed sanctions and visa restrictions on three senior Chinese officials, including the regional boss of the ruling communist party, for alleged human rights abuses targeting Uyghurs, ethnic Kazakhs, and members of other minority groups in the restive Muslim-majority Xinjiang province.

China is accused of mass detentions, religious persecution and forced sterilisation of Uyghurs and others in the resource-rich northwestern province. Authorities there are thought to have detained about a million people in re-education camps in recent years for "vocational training" to counter radicalism and separatism in Xinjiang.

The three senior officials named by US Secretary of State Mike Pompeo in a statement were: Chen Quanguo, the communist party secretary of the Xinjiang Uyghur Autonomous Region and a member of the powerful Politburo; Zhu Hailun, party secretary of the Xinjiang political and legal committee; and Wang Mingshan, party secretary of the Xinjiang public

US BANS PIA FLIGHTS

Islamabad, July 10: The US has imposed a ban on Pakistan International Airlines flights for at least six months, citing dubious pilots' licenses, according to a media report Friday.

Tuesday, the European Union Aviation Safety Agency (EASA) ordered its 32 member states to bar Pakistani pilots from working, following reports of fake licenses being issued to

The decision has been taken after 262 Pakistani pilots were grounded, whose licences the Aviation Minister Ghulam Sarwar Khan had termed "dubious" in the National Assembly.

The Express Tribune reported quoting sources that the US authorities have notified the national carrier of the ban through an email.

They added that the special flight licences obtained by the PIA had also been revoked. The US officials said that the ban had been imposed because of the recent issue of suspected pilots' licences in PIA.

PIA was allowed to operate 12 direct special flights to the United States of which the airline had operated seven flights. The paper reported that the permission for the remaining five flights had now been revoked, according to the sources.

It said that the move is a flagrant attempt to hold international students hostage in order to force schools to reopen even as COVID-19 cases are rising.

"The ICE's announcement of their plans to force out or deport international students who remain at US colleges and universities and who are taking a full online course load is cruel and unconscionable. "These students are already in the United States, are established members of educational communities, and have been determined through the visa screening process to pose no danger to the United States,' the senators wrote.

In the 2018-2019 academic year, there were over a million international students in the US. "We call out this policy for what it is: a cruel, senseless, and xenophobic attempt to use non-citizens as political pawns in order to financially coerce colleges and universities to reopen campuses this fall, despite what is best for_ public health. "This policy is dangerous to the health and wellbeing of numerous communities," they said.

Pasteurising breast milk inactivates Covid: Study

Toronto, July 10: Pasteurising breast milk at 62.5 degrees Celsius for 30 minutes inactivates the SARS-CoV-2 virus that causes COVID-19, making it safe for consumption by babies, a study claims.

According to the research published in the Canadian Medical Association Journal, current advice for women with COVID-19 is to continue to breastfeed their own infants. In Canada, it is standard care to provide pasteurised breast milk to verylow-birth-weight babies in hospital until their own mother's milk supply is adequate, the researchers said.

"In the event that a woman who is COVID-19-positive donates human milk that contains SARS-CoV-2, whether by transmission through the mammary gland or by contamination through respiratory droplets, skin, breast pumps and milk containers, this method of pasteurisation renders milk safe for consumption," said Sharon Unger, a professor at the University of Toronto in Canada.

The Holder method, a technique used to pasteurise milk in all Canadian milk banks at 62.5 degrees Celsius for 30 minutes. is effective at neutralising viruses such as HIV, hepatitis and others that are known to be transmitted through human milk, the researchers said.

In the latest study, the researchers spiked human breast milk with a viral load of SARS-CoV-2 and tested samples that either sat at room temperature for 30 minutes or were warmed to 62.5 degrees Celsius for 30 minutes.

DEADLIER THAN CORONA?

China warns of 'unknown pneumonia'

Beijing, July 10: China has warned its citizens living in Kazakhstan of a local "unknown pneumonia" which, it said, has a "much higher" fatality rate than the COVID-19 disease, prompting the Central Asian country to dismiss it as "fake news."

The "unknown pneumonia in Kazakhstan caused 1,772 deaths in the first six months of the year, including 628 people in June alone", the Chinese embassy in the central Asian country said in a statement on its WeChat platform on Thursday, adding that the fatalities also included Chinese citizens.

However, Kazakhstan has dismissed as "fake news" the warning put out by the Chinese embassy. 'The fatality rate of the disease is much higher than COVID-19," staterun Global Times quoted the embassy's statement on Friday.

Many organisations including



Kazakhstan's health department are studying the "virus of this pneumonia", the embassy said. There has not been any indication whether this disease is related to the COVID-19. Some Chinese experts said that measures should be taken to prevent the pneumonia from spreading into China.

Reacting to this, Kazakhstan's health ministry termed the Chinese embassy statement as "fake news." "The information published by some Chinese media regarding a new kind of pneumonia in Kazakhstan

is incorrect," Hong Kong-based South China Morning Post quoted the ministry as saying.

It said its tallies of bacterial, fungal and viral pneumonia infections, which also included cases of unclear causes, were in line with World Health Organisation guide-"The information published by some Chinese media regarding a new kind of pneumonia in Kazakhstan is incorrect," the

ministry said. Chinese Foreign Ministry spokesman Zhao Lijian told a media briefing here that, "We would like to get more information. China hopes to work with Kazakhstan to fight the epidemic and safeguard the public health," he said. Kazakhstan borders China's northwest Xinjiang Uygur Autonomous Region.

The embassy is reminding the Chinese citizens in Kazakhstan to raise their awareness of measures to prevent the spread of the virus.

Notre Dame Cathedral will be restored to original design

Paris, July 10: Notre Dame Cathedral will be rebuilt just the way it stood before last year's devastat-

No swimming pool or organic garden on the roof of the medieval Paris monument, or contemporary glass spire, or other modern twists. And to stay historically accurate, it will again be built with potentially

That's the verdict reached by French President Emmanuel Macron, the cathedral's presentday architects and the general in charge of the colossal reconstruction project for one of the world's most treasured landmarks.

Macron, who wants Notre Dame reopened in time for the 2024

Olympics, had initially pushed for a contemporary touch atop the cathedral, prompting eye-catching proposals from architects around the world.

But Macron came around to the traditionalists' argument, and approved reconstruction plans for the 12th century monument that were presented Thursday, according to a statement from state agency overseeing the



project. The plan includes recreating the 19th-century spire by Viollet

Le Duc that collapsed in the fire, and "favors fidelity to the monument's form and a restoration of the cathedral in its latest state," the statement

That means the state Notre Dame was in the afternoon of April 15, 2019, before fire broke out beneath its roof, toppling its spire, consuming the roof and threatening the rosewindowed twin towers that keep the cathedral upright.

More than a year later, the structure remains unstable. It took nearly a year to clear out dangerous lead residue released in the fire and to get to the point where workers could start removing scaffolding that had been in place before the fire for a previous renovation effort. Actual reconstruction won't start until next year.

The reconstruction plan presented Thursday says it will replicate original materials "to guarantee the authenticity, harmony and coherence of this masterpiece of Gothic art." Those materials originally include tons of lead, which is raising concerns among health and environmental groups.

Room for more fiscal support in India in near term: IMF

Washington, July 10: A top IMF official has said that there is room for more fiscal support in India in the near term, particularly for vulnerable households and SMEs, given the severity of the country's economic situation due to the COVID-19 pandemic.

Vitor Gaspar, Director of the International Monetary Fund's Fiscal Affairs Department, told PTI that a complete and successful implementation of the existing support measures (in particular, food provision to households) is of paramount importance.

"Given the severity of the economic situation, in the near-term there is room for more fiscal support, particularly for vulnerable house holds and SMEs (Small and Medium-Sized Enterprises)," he said.

Over the medium-term, India will continue to have a very limited fiscal space, and a credible and well-communicated consolidation plan will be urgently needed once the coronavirus pandemic subsides, Gasper said.

The economic impact of the COVID-19 in India has been substantial and broad-based, he said, adding that high frequency indicators point to a sharp decline in economic activity, as reflected in the industrial production, business sentiment (in the purchasing managers index), vehicle sales and trade.

In the June World Economic Outlook (WEO), growth in fiscal

year 20/21 was revised down to 4.5 per cent, he said.

The downward revision compared with the April WEO was driven primarily by the continued rise in the number of COVID-19 cases in India.

"This led the International

Monetary Fund to make specific two adjustments. First, the assumed length of the partial lockdown was extended somewhat. Second, and more important, we made more conservative assumptions about the speed of recovery given that the health crisis has not yet been contained, Gasper said in response

to a question.

He said that the near-term growth outlook in India continues to be clouded by the global and domestic slowdown and uncertainties relating to the evolution of the coronavirus pandemic.

Auction of 11 mineral blocks put on hold

New Delhi, July 10: The government has put on hold the auction of 11 mineral blocks, including two gold mines, besides keeping in abeyance sale of four blocks. The blocks on hold for auction are in Madhya Pradesh, while the mines kept in abevance are in Jharkhand, according to a document of the mines ministry.

However, the mines ministry did not specify the reasons for putting the sale of blocks on hold and in abeyance. Among the blocks put on hold for auction, two are gold mines, five limestone, three basemetal and one bauxite block, the document said. Of the mines kept in abevance. two are bauxite blocks and one each of limestone and dolomite.

The notice inviting tenders of all 15 blocks was issued in January 2020. One mineral block was auctioned

last month, while four more mines were put on sale this month.

All the five blocks in Gujarat and Karnataka have reserves of 667.2 million tonnes. The Centre had recently asked states having mineral resources to identify at least five new mining projects for auction with pre-embedded clearance on a pilot basis, with a view to expediting the sale process as well as operationalisation of the blocks.

Cinema exhibition industry suffers ₹5K cr loss

New Delhi/Mumbai, July 10: The COVID-19 triggered restrictions on cinema exhibition industry has not only disheartened movie goers, but axed several thousand jobs and cost the industry an estimated ₹5,000 crore in revenue. The sector has been one of the hardest hit due to COVID-19 pandemic and the subsequent restrictions implemented to curb its spread.

Presently, cinemas and multiplexes continue to remain in the



list of prohibited activities under the Centre's Unlock 2.0 guidelines.

In an interview to IANS, movie exhibition major Inox Leisure's Chief Executive Alok Tandon said, The industry on an average collects about ₹1,000 crore a month of 'Box Office' and on an average generates about ₹500 crore a month of ancillary revenues.

"Keeping in mind that the lockdown has been effective for more than 100 days now, which is about 3.5 months, the cinema exhibition industry would have accumulated losses worth ₹5,000 crore so far."

According to Tandon, associated businesses such as pre and postproduction, make-up artistes, graphics, film set fabrication, film crew, events, marketing, F&B services have all been impacted due to the

> "With the production and exhibition of movies coming to a halt, the industry was bound to witness some job osses," he said without divulging any estimates.

As per industry data, the multiplex industry in India employs more than 200,000 people directly and accounts for nearly 60 per cent of revenues of the film business.

On the way forward, Tandon elaborated that the industry expects to regain business momentum and sentiment post resumption of operations.

"We believe it will be a matter of

a couple of blockbusters, and we will be back to our usual operational numbers," he said.

"We are rightfully relying on the unshakeable passion of the Indian movie lovers, who are yearning to step out and spend time enjoying the giant screen experience.

Furthermore, he cited that industry has sent representation to the Centre for immediate re-commencement of operations and a support package.

We have requested for financial support in the form of salary subsidies during the lockdown period, interest-free loans for three years. exemptions from various taxes and duties, like 'GST, Show tax, LBETs and Property taxes' for a period of one year from the date of operations, waiver on electricity minimum demand charges for one year and auto renewal of licenses and permits for the next one year," he said.

Manchester United become the first team in the Premier League to win four successive matches by a margin of three or more goals after seeing off Aston Villa 3-0

Birmingham, July 10: Bruno Fernandes converted a contentiously awarded penalty to set Manchester United on their way to a 3-0 win over Aston Villa that featured a first goal of the season by Paul Pogba and another impressive strike by teenager Mason Greenwood.

With this victory, Ole Gunnar Solskjaer's side became the first in the division's history to win four successive matches by a margin of three goals or more as they extended their unbeaten run to 17 games in all competitions.

United eased to a fourth straight Premier League win Thursday but

only after going ahead in controversial circumstances in the 27th minute, with the visitors earning a penalty for a trip on Fernandes even though the playmaker appeared to commit a foul himself on Villa defender Ezri Konsa.

Fernandes sent goalkeeper Pepe Reina the wrong way for his seventh goal since joining from Sporting Lisbon in January and he also set up Pogba for United's third goal in the 58th minute with a pinpoint pass from a corner.

 $Pogba\ did\ the\ rest, curling\ home$ from the edge of the area for his first goal in any competition in an injuryplagued season for the Frenchman. The goal was Pogba's first Premier League goal in 15 months.

Greenwood scored in between, his fourth goal in the last three games, and it was another demonstration of the 18-year-old forward's ability to score off either foot.

This time it was with his right, as he collected Anthony Martial's short nass at the end of a quick counterattack and smashed in a rising finish from the edge of the area.

United stayed in fifth place but moved to within a point of fourthplace Leicester with four games remaining. A fifth-place finish will be enough to qualify automatically for the Champions League this season unless second-place Manchester City manages to get

their two-year European ban overturned in the courts.

United will play Leicester in the final round of the season July 26. In this form, it is hard to imagine them not finishing in the top four.

Villa dropped to next-to-last place Thursday and is four points from safety as the team looks to avoid relegation after just one season back in the top flight.

The impact January signing Bruno has had on United is clear to see and this was another awesome display from the playmaker. He has now had 28 goal involvements in 27 league goals this season with Sporting CP and United, scoring 15 and providing 13 assists.





They will be followed by the Russian GP at the Sochi Autodrom September 27. It brings the number of races this season to 10, all in Europe, with F1 still hopeful of holding 15-18 races and finishing the season in December with races in Bahrain and Abu Dhabi. Mugello has never staged an F1 race but has hosted F2 and MotoGP races, as well as previously being a Ferrari test track. Ferrari driver Sebastian Vettel did a test drive there last month.
