New Delhi, July 9: The Union Health Ministry Thursday said that there is no community transmission of COVID-19 in the country but a "localised outbreak" in some geographical areas.

"After the GoM meeting today (Thursday), Health Minister Harsh Vardhan said that India has not arrived at the community transmission stage. There is a localised outbreak in some geographical areas. 49 districts alone account for 80 per cent of COVID-19 cases. In such a situation, the question of community transmission does not arise," Rajesh Bhushan, Officer on Special in the Health Ministry, said at a press conference.

The WHO has not issued any standard definition of community transmission or localised outbreak but has given the right to member states to assess the situation and report accordingly on it, he added.

The Health Ministry also painted a bright picture of its handling of the coronavirus cases, asserting that India's deaths and cases per million in the country are amongst the lowest in



He emphasised that despite being the second most populated country in the world, India has managed the pandemic relatively well.

Bhushan said that the gap between the active and recovered cases is widening progressively day by day.

"People who have recovered are twice the active ones. The caseload tells us that at the end of the day, we have managed the situation and our health infrastructure is not creaking because of the pressure," he added.



According to the ministry's daily bulletin, out of total 7,67,296 cases, 4,76,377 have recovered while 2,69,789 remain active in the country. With more COVID-19 patients recovering, the gap between the number of recovered cases and active cases has increased by two lakh.

Besides this, he said that the recovery rate now stands at 62.09 per cent and is increasing. The rate of increase of recovery is appreciable, the official added.

Bhushan, however, warned that the people between the age of 45-75 are most affected by the deadly disease and asked the Central and state government to

State reports highest single-day spike

BHUBANESWAR: Odisha Thursday reported its highest single-day spike of 577 COVID-19 cases, taking the tally in the state to 11,201, while four more deaths pushed the toll to 52, a health department official said. Ganjam district reported three deaths and Bhadrak one, he said. "Regret to inform the demise of four COVID positive patients while under treatment in hospitals," the health department said in a statement, "Two other COVID-19 patients have died due to other ailments, taking the number of such deaths in the state to 15," the statement said. Of the 52 deaths reported in the state so far, Ganjam was the worsthit district with 30 fatalities, followed by eight in Khurda, five in Cuttack and one each in Sundergarh, Rayagada, Puri, Kendrapara, Jajpur, Gajapati, Bargarh, Angul and Bhadrak districts.

Chinese troops pull back from Gogra post

New Delhi, July 9: China's People's Liberation Army (PLA) Thursday completed moving back its troops from the face-off sites in Gogra and Hot Springs in eastern Ladakh in line with the understanding reached with the Indian Army and the two sides are set to hold highlevel military talks to further de-escalate tension in the region, people familiar with the development said.

They said both sides have completed creation of a buffer zone of three kilometres in the three friction points of Galwan Valley, Gogra and Hot Springs as part of a temporary measure aimed at reducing the possibility of any confrontation.

On Thursday, the PLA has totally pulled back its troops from Gogra (patrolling point 17), and with this, both sides have implemented the first phase of disengagement to avoid any friction, the people cited above said.

They said the entire focus now shifts to Pangong Tso area where there has been thinning out of troops from Finger area 4. India has been insisting that China must withdraw its forces from areas between Finger 4 and 8



They said the fourth round of corps commander-level talks between the two sides is likely to take place in the next two-three days.

The two armies will also carry out a joint verification in the next few days to assess the implementation of the disengagement process.

The formal disengagement process began Monday morning after a nearly two-hour telephonic conversation between National Security Advisor Ajit Doval and Chinese Foreign Minister Wang Yi Sunday. In the talks, the two sides agreed on an expeditious withdrawal of troops from all the standoff points to bring back peace and tranquillity in the region. Doval and Wang are Special Representatives for the boundary talks. Following the talks, a mutual disengagement process began in Galwan Valley, Hot Springs, Gogra and Finger areas in

Nepal's Communist party faces split

OLI, PRACHANDA TALKS FAIL TO YIELD POSITIVE OUTCOME

Kathmandu, July 9: Nepal's ruling communist party has failed to address the intra-party rifts as Prime Minister KP Sharma Oli and NCP executive chairman Pushpa Kamal Dahal 'Prachanda' have failed to reach a consensus despite holding over half-a-dozen meetings in a week, a media report said Thursday.

On Wednesday, a crucial meeting of the NCP's 45-member Standing Committee was postponed till Friday. The meeting was deferred for the fourth consecutive time in a bid to provide enough time for the two chairmen of the party to sort out their differences amidst the height-

ened intra-party rift. The political future of 68-year-old Oil is expected to be decided Friday during the Standing Committee meeting, amidst the growing involvement of Hou Yanqui, the Chinese ambassador to Nepal, to save his chair.

The Prachanda faction, backed

by senior leaders and former Prime Ministers Madhav Kumar Nepal and Jhalanath Khanal, has been demanding Oli's resignation, saying his recent anti-India remarks were "neither politically correct

nor diplomatically appropriate." The differences between the two factions of the Nepal Communist Party - one led by Oli and the other by 'Prachanda' on the issue of powersharing – has recently intensified after the Prime minister unilaterally decided to prorogue the Budget session of Parliament and over to the government's lackluster response to the COVID-19 pandemic.

UP COP KILLER VIKAS DUBEY ARRESTED



Bhopal/Lucknow, July 9: Alleged gangster Vikas Dubey was arrested outside a temple in the pilgrimage city of Ujjain Thursday after purchasing prasad and an entry ticket to the shrine, ending a six-day manhunt for the man accused of masterminding a deadly ambush on a police party outside his home in Kanpur. MP Home Minister Narottam

Mishra said two of Dubey's associates were also arrested.

"We have arrested Dubey and he is in our custody," Mishra said. "Dubey arrived at the (Mahakal) temple in his car. A police constable identified him first, after which three others (security personnel) were alerted and he was taken aside for questioning and later arrested," Mishra said.

However, temple sources gave a slightly different account. They said Dubey reached the temple gate in the morning and purchased ₹250 ticket from a counter near the police post. When he went to a nearby shop to buy prasad for the deity, the shop owner identified him and alerted police, they added.

It is not clear if he was arrestedimmediately, before he could enter the temple, or later.

IN ECHO OF China's schools in book-cleansing drive

AS SCHOOLS REOPEN IN CHINA AFTER THE COVID-19 OUTBREAK, THEY HAVE THROWN THEMSELVES INTO A NATIONWIDE EXERCISE TO REMOVE BOOKS DEEMED POLITICALLY INCORRECT

Beijing, July 9: As schools reopened in China after the COVID-19 outbreak, they have thrown themselves into a nationwide exercise to remove books deemed politically incorrect, deepening Chinese President Xi Jinping's push to instil patriotism and ideological purity in the education system.

A directive from the Ministry of Education last October called on elementary and middle schools to clear out books from their libraries including "illegal" and "inappropriate" works. Now teachers have removed books from schools in at least 30 of mainland China's 33 provinces and municipalities, according to a review of social media posts, publicly available school and local government documents, and interviews with teachers.

From western Gansu province to Shanghai, the review of publicly announced measures pointed to books being cleared by the hundreds of thousands.

Censorship in China has been intensifying under Xi, but analysts say this is the first national campaign aimed at libraries in decades. It comes as government employees in Hong Kong last week removed books by pro-democracy activists from public libraries to see whether they vi-

olate a new national security law. "This is the first movement targeted at libraries since the Cultural Revolution," said Wu Qiang, a political analyst based in Beijing and former political science lecturer at Tsinghua University. In the late 1960s, zealous



teenagers driven by Mao Zedong carried out a nationwide campaign targeting libraries and destroying or burning what they could get their hands on, as part of a wider de-

struction of traditional culture. This campaign is more selective,

and directed from the top, with schools putting groups of teachers in charge of interpreting the order. The books removed have mainly been out-of-date, shabby or pirated texts, but the drive has also covered those which, while they may

COVID-19 EFFECT

Women's career dreams hit hard as pandemic rages

BHUBANESWAR: It has been a month since Priyanka Samal, 21, who worked with a city-based coaching institute, was told that her services were no more required. Despite that she expected a call from the authorities asking her to rejoin given past performances. But that didn't happen. Now, after exhausting whatever little she had saved, Priyanka had no choice but to pack her bags at a working women's hostel in Nayapalli which had been her second home since she landed in the city. She is getting ready for a return to her village in Jagatsinghpur district.

"Even after cyclone Fani hit the city last year, I stayed back despite a week-long power and water supply crisis." Priyanka recalls.

'Covid is far worse than the deadliest of cyclones. It has shattered dreams." Privanka says as she wayes her hands at a fellow inmate leaving for office

Globally, COVID-19 has claimed over half a million lives and hammered livelihoods of countless people but its side effects have crushed hopes of men and women from different age groups. The situation, particularly for career women in the Twin City - Cuttack and Bhubaneswar - is no different, either. Priyanka is only one of them.

While those living in their own houses or with family in these cities are considered fortunate, others, managing in rented accommodations or hostels have been the worst hit.

"Situation was never so grim before. For years, the office which you thought, was part of your life, is not the same any more. You could be asked to take a walk any moment," puts, activist, Madhumita

Working from her rented accommodation in Bhubaneswar's Patia area, Nisha Mukherjee, 28, a senior programmer with a software major, echoes Samal's words. "There is uncertainty everywhere. I know I am safe today, but can't guarantee about tomorrow," thinks Nisha

Uncertainty apart, there are other issues, that worry the women professionals, as well.

Take the case of Aditi Mishra Post her diploma in interior designing, Aditi used to commute between home (in Cuttack) and office in Bhubaneswar's Jayadev Vihar locality, in public transport. With the bus services yet to be streamlined due to lack of passengers, she is now entirely dependent on her diabetic father's bike for her home-office-home journey. On June 1, the day In private sector, annual performance appraisals are done during March and the employees enjoy the increment in April's salary. her office reopened, Aditi had to wait for over an hour to board a bus at Link Road Square but in vain. Finally, she requested her dad to drop her at office.

With her mother suffering from spondylitis and thyroid disorders, Aditi often feels guilty to burden her father. However, she can't afford to quit her job as she realises the financial need of the family. But she has managed to halve her father's workload. Her dad now drops and picks her from office for the first three days of a week. For the other three days, she takes help of her uncle. For that, she shifts herself to her ancestral village in Pipili where her uncle lives.

Often criticised and branded selfish by other members in the joint family, Aditi says she also wants to give up job fearing infection. "But I don't know what to do, I'm at the crossroads," she adds.

There are others who don't face such issues. Like Susmita Rout, 32, a relationship manager of a leading private bank in Cuttack. "Fortunately, none of us have been fired so far." Susmita says. However. she concedes that achieving the monthly target set by her bank is literally not possible during Covid times. "Therefore, people like me are on tenterhooks," she adds.

The condition is such that even those offered a choice of whether or not to continue with a 25-30 per cent pay cut, think they are blessed. "There is absolutely no option. So, when I was asked if it's okay for me to work at 30 per cent lesser salary till next December, I politely replied in the affirmative," admits, Anita Patnaik, 37, an architect working with a city-based firm.

'We can't be unhappy or grudgy," puts 29-year-old Malini De, a staff nurse from Mayurbhanj district employed with a leading corporate hospital in Bhubaneswar. In Covid times, with lesser inflow of patients, the mandatory one day off that she availed after four consecutive night shifts, has become a thing of the past. "May be things will change for the better in future," she hopes

Perhaps, the longing for a better future, seems to have provided the succor to Padmini Mishra, 22, a project associate with an NGO, working at AIIMS, Bhubaneswar, to carry on against, what she describes as an 'emotionally back breaking'

She stays in a hostel which is nearly six km from her workplace and certainly not a walking distance. But she often had to walk about 12 km (to and fro) a day to reach office during the lockdown period. Needless to say, it is physically taxing for any human being. But what made her nervous were the lewd remarks and ugly gestures of

On one occasion, she even couldn't be with her parents who were hospitalised following a road mishap. Reason: With public transport off roads, had she hired a car, it would have warranted her to stay in a quarantine facility. This apart, she was yet to complete the mandatory one year probation period and asking for extra leave during a pandemic that too from hospital duty would possibly cost the job, says





State's tax collection dips 23%

CHIEF SECY DIRECTS OFFICIALS TO CONTINUE

Bhubaneswar, July 9: The state's revenue collection from both tax and non-tax sources has fallen by 22.94 per cent till June of financial vear (FY) 2020-21 as compared to the corresponding period of the previous FY due to Covid.

This was revealed at the all-secretary level meeting held under the chairmanship of Chief Secretary Asit Tripathy here through videoconferencing. The monthly meeting could not be held during the last three months due to the pandemic.

Finance secretary Ashok Meena presented the state's fiscal status before the meeting. The total revenue collection from both own-tax and non-tax sources during April, May and June of FY 2020-21 was ₹8,204 crore whereas it stood at ₹10,645 crore during first three months of

State's own tax collection has decreased by 35 per cent up to June. However, the non-tax revenue till June has increased by around

The total non-tax revenue in first quarter of FY 2019-20 was ₹3,506 crore which rose to ₹3,609 crore till

The programme expenditure of the state government during the period has also reduced by 5.06 per cent as compared to the previous FY. The total programme expenditure up to June of the current fiscal was ₹8,923 crore against the last FY's

The social sector spending has increased considerably. The state has spent ₹5,281 crore in first three months of FY 2020-21 whereas the last years' expenditure was ₹4.225crore.

Similarly, current FY's first quarter expenditure on food security programmes has increased to ₹1,607 crore from ₹305 crore.

Lauding the performance of the departments in delivery of online services under 5T charter, the Chief Secretary directed the departments associated with Covid management to be more sharp and vigilant on containment of Covid. The district observers, CDMOs and collectors of the hotspot districts were directed to ensure supply of life saving drugs in their respective hospitals.

Covid fee on liquor slashed

Bhubaneswar, July 9: In order to rationalise the rate of alcoholic beverages in Odisha comparing to neighboring states, the state government Thursday reduced the special

Covid fee imposed on the

liquor by 35 per cent.

The special Covid fee on alcoholic beverages has been reduced from 50 per cent to 15 per cent with effect from Friday, official sources in the Excise department.

The MRP of liquor in the neighbouring states is less than the prevailing rate in Odisha. Therefore, there were chances that no non-duty paid liquor from outside the state would enter Odisha due to the price differential. Keeping this in mind, the government has revised the special Covid fees of the alcoholic beverages, the source said.

Bhubaneswar, July 9: The autopsy report of social activist and motivational speaker Aditya Dash, Thursday, revealed that severe traumatic brain injury caused his death. Sources said that he sustained severe head injury due to the collision with the speeding train.

In another development, the members of Aditya's organisation 'People for Seva' have lodged a complaint with the GRP late Wednesday night alleging that the activist's death was not suicide but a planned murder.

Police have also started investigation into the murder angle by registering a case (81/20) under sections 302 and 34 of the IPC.

Meanwhile, the cops seized a hand-written suicide note from Aditya's diary Wednesday. Dash was found dead on the tracks near Lingaraj Road railway station here July 7.

Aadhaar must to avail Banishree scholarship

Bhubaneswar, July 9: The State Social Security and Empowerment of Persons with Disabilities (SSEPD) department has issued a notification asking students receiving Banishree Scholarship to obtain Aadhaar cards by July 31 and inform the government on the same.

Neutralised Reds carried ₹34L bounty

Bhubaneswar, July 9: Odisha Police Thursday said the five Maoists who were gunned down in two back-to-back police encounters July 5 and July 6 together carried a huge reward of Rs 34 lakhs on their heads.

The two encounters were the first incidents in state where rebels carrying such high rewards on them have been shot down, said the Odisha Police in a press statement

"There have been instances of more than five Maoists being killed on a single day in the past, but deaths of the Maoists carrying Rs 34 lakh reward on a single day is so far the highest in state. A few years ago, some Maoists carrying a reward of Rs 25 lakh were killed on Angul-



Deogarh border," a senior police official said.

Among the deceased Maoists, Sukru Kosa Sodhi was a senior state committee member of the banned CPI(Maoist) outfit carrying a reward of Rs 20 lakh, a divisional committee member carrying a Rs 5 lakh reward, two area commander members carrying Rs 4

lakh reward each and a party mem-

ber carrying a Rs 1 lakh reward. Interestingly, the reward of Rs 34 lakh total will be handed over to the Kandhamal Police for carrying out the encounter. At least six Maoists have been killed in Odisha this year. Prior to the five Maosists being killed in the last two encounters, another Maoist was gunned down in Swabhiman Anchal area in Malkangiri district.

The Odisha Police, meanwhile, called upon the Maoists to surrender before the government and accept the rehabilitation scheme.

It also claimed that successful operations against the Left-wing extremists will lead to the implementation of government schemes in remote areas of Kandhamal.

The police also claimed that the number of districts affected by the Left-Wing Extremism (LWE) in Odisha has come down to 10 in recent days. Earlier, as many as 20 districts in state were suffering from the Maoist menace.

Overcoming barriers in developing nCoV vaccine

vaccine against COVID-19 has openly shown how important the procedure is in preventing devastating outbreaks of various diseases. So far, 40 nations and donors have pledged \$8 billion to fund research and development of a safe and effective vaccine or treatment for the novel coronavirus.

Actually, vaccines have been around for a long time now. The

he race to develop a ity (case count), it is nowhere near average annual highs seen in the 20th century when about half a million people were infected. Its prevalence has fallen by more than 99 per cent due to vaccinations, along with a whole host of other diseases such as pertussis (whooping cough), mumps, rubella, polio and diphtheria.

In fact, immunisation programmes across the world have helped people protect against some



first one is usually credited to Edward Jenner, an English doctor who injected pus from a cowpox pustule into an incision on the arm of an eight-year-old May 14, 1796. Subsequently, the boy proved to be immune to smallpox, one of the deadliest diseases at that time.

Data available from the Centre for Disease Control and Prevention has shown the importance of effective vaccination in eradicating major diseases in the United States. For instance, on an average, smallpox was responsible for 29,000 cases annually in the 20th century and not a single case was recorded in 2019 - a 100 per cent decrease. Although the measles resurged to some extent in recent years owing to anti-vaccine decision making and its morbidof the deadliest diseases. Even the World Health Organisation (WHO) acknowledges that vaccination has played a vital role in human health, thereby saving millions of lives every year. The WHO says vaccination currently saves 2-3 million lives every year, but another 1.5 million deaths could be avoided if more people were vaccinated.

As the world now reels under Covid-19 pandemic, we have once again been reminded of the importance of immunisation. However, it is neither simple nor cheap to develop a vaccine against the novel coronavirus and make it universally available. The barriers to universal immunisation are formidable, especially in less developed areas.

The race for Covid-19 vaccine



urrently, more than 100 Covid-19 vaccines are in different stages of development across the world. While a European pharmaceutical company has claimed that the vaccine being developed by it would be ready for production worldwide as early as September, many others are in different stages of trials.

China, where the Covid-19 outbreak was first reported in Wuhan city, has five vaccines that are being tested on humans. According to a Chinese government body, at least one of these may be ready for mass immunisation by the end of this year. The Indian government has also announced that its first indigenously developed Covid-19 vaccine will soon go for human trials.

Latest available data shows that 91 vaccines are in the exploratory stage (discovery and research), 28 in the preclinical stage and five are in Phase I state.

5 stages of vaccine development Tor the uninitiated, five stages are involved in developing an are


effective vaccine. According to a modest estimate, it requires 10 years and \$5 million to develop an effective and universal vaccine. For instance, the exploratory stage (discovery and research) takes anything between 2 and 5 years. Currently, 100 potential vaccines worldwide are in this stage. Another two years are spent in the next stage (pre-clinical). At present, 20 potential vaccines are in this stage globally.

The third phase - clinical development of a vaccine involves Phase I, Phase II and Phase II. Phase I involves about 1 to 2 years and in this phase, scientists mainly concentrate on finding whether the potential vaccine is safe for use. Currently, 10 potential vaccines are in this stage. Another 2-3 years are spent in Phase II when scientists try to ascertain whether the potential vaccine would trigger an immune response. As of date, five potential vaccines are in this phase. In Phase III, scientists work to determine whether the potential vaccine has the ability to protect people against the disease. This phase lasts for anything between

The successful completion of these three phases is followed by regulatory review and approval that takes anything between 1 and 2 years. Currently, only one potential vaccine is in this stage.

The next step involves manufacturing and delivery. In fact, manufacturing vaccine is a specialised job and it requires special facilities. Moreover, manufacturing vaccines is a quite expensive process. This process commences after the end of Phase II clinical trials and involves making several thousand doses that are required for Phase III trials. Dr Jerome Kim, Director-


General of the International Vaccine Institute, has described the speed with which scientists as well as pharmaceutical companies have responded to deal with the coronavirus pandemic as "unprecedented". However, this does not mean that success is at hand. Dr Kim says that vaccine development is usually characterised by high failure rate – it is as high as 93 per cent between animal studies and product


According to WHO, there are several complex reasons why people resist vaccination. Some of the underlying

factors include the absence of confidence, difficulty in accessing vaccines and, to some extent, even complacence. A survey undertaken by Gallup poll reveals that people in France are most resistant to vaccines, as they have little trust in immunisation. This makes it all the more important to help healthcare workers to provide correct information regarding vaccines. Only this can help to counter the antivaccination movement.

Why vaccines are not universal

lthough many vaccines have been developed since 1796 when the English doctor Edward Jenner, considered the founder of vaccinology in the West, invented a method to protect against smallpox, none of them have become available to all. According to the Médecins Sans Frontières (MSF), a humanitarian medical or-

ganisation, aside from the high cost of vaccines, problems related to delivering them to the remotest corners of the world and storing them properly have prevented many needy from being immunised. In addition, the conflict zones in the world make it difficult for health organisations and volunteers to undertake vaccination programmes in those affected areas. What is worse, this is the reason why even when disease out-



breaks, it is not possible to treat the patients. As a result, roughly 3 million children die every vear of vaccine-preventable diseases and a significant number of these children live in developing countries, reports the US National Center for Biotechnology Information (NCBI). Interestingly, even Doctors Without Borders is accusing the World Health Organisation of restricting the availability of Ebola vaccine in the Democratic Republic of Congo. They accuse the WHO of rationing vaccines and calling for an independent committee to ensure "more transparent management" of the situation.

590 homoeopathic hospitals locked up

Nayagarh, July 9: Nearly 590 homeopathic hospitals in Odisha have shut down over the past three months after the state government sent homeopathic doctors, who are working under Ayush directorate, on COVID-19 duty.

This has rendered the patients in rural areas helpless. It is alleged that even as Ayush doctors have been engaged at different public health centres (PHCs) and community health centres (CHCs) across the state, it is improper to assign COVID-19 duty to rural doctors.

There are 590 homeopathic and 620 ayurvedic hospitals in the state, 95 per cent of which are located in rural areas. The Ayush doctors



were looking after healthcare of rural patients

As per orders of the state government, they all joined COVID-19 duty at different district headquarters hospitals (DHHs) in the state April 7. Following which, a total of 1,210 homeopathic and ayurvedic hospitals were shut down.

A downfall of healthcare facilities was brought to the knowledge of the Director of Homeopathic Medicine (DHM) by homeopathic doctors. On the other hand, Ayurvedic doctors resorted to the court of law vide case (No.-WPC11587/2020) and got relief following Orissa High Court's verdict

June 30. Acting on the court's directive, several ayurvedic doctors have returned to their respective places. In the meanwhile, homeopathic doctors have resorted to the court of law, next date of hearing of which has been scheduled for July 13.

Some homeopathic doctors namely Sura Pradhan of Dasapalla, Sudam Pradhan of Gania and Madhab Sahoo of Nuagaon areas said, "The state government should assign COVID-19 duty to homeopathic doctors working at PHCs and CHCs instead and not assign COVID-19 duty to doctors working in rural areas.

The state government should be proactive and take immediate steps in this regard, the doctors added.

Lady teacher hacked in Jajpur

Jajpur, July 9: A lady teacher was hacked to death by a miscreant in broad daylight at Khandahata Square under Jajpur Road police limits Thursday afternoon. Another teacher accompanying her was also injuried The deceased was identified as Jogmaya Jena. The injured teacher, identified as Mohani Jena, was rescued by police and rushed to SCB Medical College and Hospital in Cuttack. The two teachers were returning from Daniabar school at 2 pm when the miscreant wielding a sharp weapon attacked Jogmaya.

They shouted for help and the accused fled. A case was lodged in this regard.

Bimlagarh-Talcher rail route hits land hurdle

Rourkela, July 9: Fate of the Talcher-Bimlagarh rail route project looks doomed due to delay in land acquisition, a report said.

As a result, the rail route project, scheduled to get completed by December 2022 is moving at a snail's pace. The way the project work is moving has sparked uncertainty over its completion in near future.

This has disappointed the residents who were expecting that the construction of the rail route would bring in development in remote regions of Sundargarh, Angul and Deogarh districts.

Notably, the project received government sanction 17 years back but it is yet to get completed. This has happened as the administration has failed to expedite the acquisition of private, government and forest land for the project.

Moreover, the project has been held up due to various reasons in Angul, Deogarh and Sundargarh districts. The respective district administrations have failed to relocate the electricity poles and water supply pipelines on and near the project site. This apart, construction of bridges and culverts for the rail route is equally disappointing. Sources said initially it was expected that the project work would move faster from the Bimlagarh end of Sundargarh district. However, the slow pace of work has frustrated all hopes of its early completion. Surprisingly, work from the Talcher end has failed to make progress despite sanction of funds by the Union government.

Land acquisition in Talcher is also plagued by similar problems. The district administration in



Angul is yet to settle the problems plaguing the acquisition of private land and construction of railway over-bridge for which the proj ect has got delayed.

The inception of the project dates back to 60s when various outfits and public representatives demanded construction of a rail route from Talcher to Bimlagarh in Sundargarh district as it would foster the relation between the Western Odisha and East Odisha by effectively connecting the two regions. Moreover, the railways department would also earn more revenue once the project gets completed and train starts plying on the route. This apart, the rail route would also prove beneficial for development of mines and industries in the state.

Meanwhile, Sundargarh MP Jual Oram has submitted a memorandum to the Centre and drawn the attention of railway minister in the Lok Sabha, February 2020 demanding fast completion of the project. Oram had also written to the Chief Minister in this regard, March 2017. Recently, Oram met the state revenue minister Sudam Marandi and urged him to intervene in the project. Meanwhile, the railways department has received environmental clearance for acquisition of 439 acre of land but the matter is caught in legal hurdles. This has impacted the handover of-421 acre of land acquired by the state government.

Barbil in throes of community transmission

Social collateral

he state government has rolled out a credit plan for the state's landless farmers. Christened as Balaram, a sibling of Lord KALIA, the scheme is touted to be a one of its kind in the country. On its face, the product looks novel, for this all cash loans will be collateral free. Loans will be disbursed to five-member groups named Joint Liability Groups (JLG) who will act as 'social collateral' against the loans disbursed to members. In a way, each member of the group will be accountable if one of their co-members defaults on loan repayment. Each bank has been given a disbursal target based on the number of branches they operate in the state. Each lender has a target to disburse loans to at least 10 JLGs in a year. The government has identified 7 lakh farmers to benefit from the scheme to be spread over two years. Banks and primary agricultural credit cooperative societies (PACs) have been asked to extend the loans to farmers. That there are 7,000 banking outlets in Odisha, each banking unit will extend finance to 10 JLGs. Every JLG will have five members and they will get Rs 1.6 lakh each. The target is to cover around seven lakh landless cultivators through 1.40 lakh JLGs in two years. A corpus of Rs 1,040 crore has been earmarked for this purpose. The National Bank for Agriculture and Rural Development (NABARD) will underwrite the scheme in the state. The Institute of Management of Agricultural Extension (IMAGE) and the Agricultural Technology Management Agency (ATMA) will be the nodal agencies at the state and the district levels respectively for implementation of the scheme. Balaram is different from KALIA in the sense that the former is crop loans while the disbursals under the latter were simple freebies. While, KALIA had benefited people with land parcels, Balaram aims at benefitting landless farmers who were not able to avail farm credit earlier. To ensure its seamless implementation at the field level, the government has roped in village agriculture workers (VLWs). Also, the government has instituted an incentive mechanism for effective execution of the scheme.

The timing and the nature of the scheme could not have come at a better time. At present, farmhands in villages are a harried lot due to COVID-19. A huge influx of migrant workers to rural areas has increased the density of workers in rural pockets. What they need is availability of cheap loans to them. It would help them if the government allows these workers to use this money for smalltime entrepreneurial adventures based on their skills and experiences. Agriculture is a priority sector lending for banks and Balaram will help banks to meet their target under the priority sector lending. However, it is common knowledge that commercial banks show little interest in providing loans to farmers, let alone landless farmers. That is why there are skeptics on the success of this scheme. Banks may not be too keen to take exposure unless the government brings in more clarity on how this social collateral mechanism will work at the ground level. It would be better if the government could stand guarantee for such loans. This would have given the much needed assurance to banks on the security of these loans. In the absence of this, it is still anybody's guess how Balaram will work. Since Balaram is normal crop loans, banks need constant follow-up and monitoring to disburse such credit to the beneficiaries. Officers at the state level and at the district level must not only be roped in but brought under an incentive scheme linked to targets for eventual success of this scheme.

illiam Venator brought this word, meaning foolish babbling, back from oblivion in his self-published 2003 satire, Wither This Land, which told of political upheavals following the opposition by saboteurs to fox hunting in Britain: "The day had proceeded well at Stanthorpe but Downing Street was fuming, Cramp, caught unawares, had given an excellent stultiloguy, much to the press's amusement, on the need for "action, containment for flaunting the law, overweening disapproval, community and tolerance needed." It's a pity it's so rare, as there are quite a number of current political figures to whom it could be applied (no names, no pack drill). The only other modern writer who has used, it seems, it is John Steinbeck. It appears in his fictional portrayal of the life of the buccaneer Henry Morgan, Cup of Gold (1929): "In all the mad incongruity, the turgid stultiloquy of life, I felt, at last, securely anchored to myself."We might instead prefer the even rarer stultiloquence, whose adjectival form is in Christopher Fry's The Lady's Not For Burning, in which Justice Tappercoom says "The whole thing's a lot of amphigourious, stultiloquential fiddle-faddle." Both are from Latin stultiloquus, speaking foolishly, which come in turn from stultus, foolish, plus loquus, that speaks.

Stylite

One of the most remarkable examples of religious self-denial, the stylites were a group of early Christian ascetics who spent long periods of time sitting or standing on top of narrow pillars. The word comes from the Greek stylos for a column. The best known of these pillar hermits, pillar saints or pillar monks was the first, St Simeon Stylites, who sat for thirty years from AD423 onwards on top of a column some 40 cubits high (a cubit was an ancient measure of length, approximately the length of a forearm, say 18 inches or 44 cm). He was followed by several others, including his disciple St Daniel Stylites and Simeon the Younger. The stylite sometimes allowed himself a roof or a small hut for protection against the weather, but was otherwise exposed. Many remained standing day and night, only prevented from falling by a guard rail; some even stood on one leg. The record for stylitic behaviour is probably held by the 6th-Century St Alypius, who is reputed to have remained on his pillar for 67 years without a break, for the last 14 of them lying down because his feet could no longer support him. The practice died out shortly after the turn of the last millennium.

RECENT AGGRESSIVE BEHAVIOUR TOWARDS INDIA MIMICS THAT OF CHINA'S **FORMER IMPERIAL MASTERS - AND WILL LIKELY HAVE SIMILAR CONSEQUENCES**

√he standoff between Chinese and Indian forces along the disputed Himalayan border resulted in the first troop casualties there in decades, with some Indian soldiers killed in particularly brutal fashion. Moreover, the intensity of China's multiple cross-border incursions suggests approval from the highest levels of the Chinese

Chinese forces have occupied at least 60 sq km (23.2 sq miles) of territory that India claims as its own. Prime Minister Narendra Modi's government has downplayed this uncomfortable real ity, perhaps out of concern that publicly acknowledging the truth would inflame domestic public opinion and fuel a highly undesirable escalation of tensions. A less benign interpretation, however. is that the government is embarrassed, because its claim to be more muscular than its predecessor in confronting external aggression has been proven hollow.

But China's recent saber-rattling may paradoxically benefit India by jolting it out of one of its periodic stupors. After its disastrous 1962 war with China, for example. India undertook a sweeping modernization of its military and subsequently won a decisive victory in the 1971 Indo-Pakistani War.Similarly, after its own misguided economic policies raised the specter of mass starvation in 1966-67, India launched the "Green Revolution," and today has nearly 100 million tons of grain stocks. And, following its massive balance-of-payments crisis in 1989-91. India initiated a historic economic liberalization programme that ushered in a quarter-century of unprecedentedly rapid growth.

In each case, a crisis served as a kick in the pants. China has now delivered another. The Communist Party of China has been adept at leveraging the country's humiliation at the hands of foreign powers in the 19thCentury to drive domestic change while preserving its own political monopoly. But the CPC's recent aggressive behaviour towards India mimics that of China's former imperial masters - and will likely have sim-

ilar consequences.

First, China's show of force will set back its relations with India by decades. Since the turn of the century, Indian policymakers have wrung their hands over how to handle China's extraordinary rise. They are well aware of how China has sought to stymie India, whether by offering neighbouring Pakistan carte blanche regarding cross-border terrorism, blocking India in different international fora, or making strategic inroads in its neighborhood. But Indian governments, recognizing their country's weakness, have been loath to poke the dragon with which it shares a border more than 4,000-

India will now be less inhibited about deepening ties with the other three members of the socalled "Quad" (Australia, Japan, and the United States) and more forcefully embracing the "Indo-Pacific" concept. Furthermore, it will be increasingly wary of participating in Chinese-led multilateral fora, and, where possible, will seek to hinder China's efforts to establish

a Sinosphere.

Second, it has become abundantly clear that India's military inferiority to China reflects a widening economic gap. The previous Indian government, under Prime Minister Manmohan Singh, raised the economy to new heights in its first term, and lowered it to new depths in its second. But, under Modi, India's economy has been spinning its wheels, and reform has now become an existential necessity for national security.

Third. India will now accelerate military changes. Although Modi's government loves to talk tough, military expenditures have declined from 2.9 per cent of the GDP in 2009 to 2.4 per cent last year.

Moreover, the government's populist policy of sharply raising army pensions has meant that India's defense budget this year allocated more money to military retirement benefits than to army salaries. Indeed, defense pensions as a share of non-pension defense spending has quadrupled, from less than 10 per cent in the late 1980s to over 40 per cent this year.

And with salaries and pensions ac counting for nearly three-fifths of Indian defense spending, there is little left to invest in modernization. Whereas China spends more than two-fifths of its defense budget on modernization, and Pakistan more than one-third, the share in India's case is barely one-quarter.

Finally, while Modi's ruling party has polarised Indian society around religion, China has now inadvertently supplied the glue to bind Indians together - if only in shared hostility. Chinese President Xi Jinping seems to have a unique ability in that regard. For example, Australians' trust in China has fallen to its lowest ever level Australia, as much as any Western country, had previously sought strong ties with China. But when the Australian government called earlier this year for an independent inquiry into the origins of Covid-19, China retaliated by blocking Australian imports, underscoring the degree to which it is now using economic coercion against its critics.

Likewise, a Pew Research Center survey in March found that a record 66 per cent of Americans had an unfavorable view of China. And China's aggressive stance toward Hong Kong ensured that incumbent Taiwanese President Tsai Ing-wen comfortably won reelection in January, after the opposition Kuomintang had seemed poised to win on a platform of closer economic links with China

Of course, India being India, there will be no seismic changes But the country's foreign policy and the direction of its economic and military reforms will increasingly reflect the challenge posed by China, which Indians now regard as their principal enemy. Ironically, as India seeks to escape China's shadow, it will have its powerful neighbour to thank for finally triggering changes that should have happened long ago.

Women as worst sufferers in lockdown

survey conducted by the Tamil Nadu Women's Collective in 62 villages in 18 districts in the state found that 81 per cent of families reported some kind of domestic violence during the lockdown period. Of these families, 25 per cent were also facing acute hunger. Stories of conflicts in families and also abuse of children and the elderly appear in newspapers, adding substantially to the global trend in an increase of domestic conflict under healthcare restrictions on movements. Complaints made to the National Commission for Women (NCW) and some NGOs working for women have increased manifold

Life at home is no more the same as in pre-pandemic days. Household members compelled to stay at home experience among themselves more conversation, more interaction, and more sharing. The consequence in many cases is not better understanding and bonding, but enormous increase in verbal and physical clashes. "Stay at home, stay safe" seems to have become a self-contradictory dictum wherever home life is full of domestic conflicts of varied types and on different scale.



The new wave of domestic violence is making news as a "gift" of lockdown meant to drive away Covid-19 infection. Neither the workplace nor the home seems to be a safe place for women. The NCW has registered an increase by at least 2.5 times of domestic violence complaints since the nationwide lock down. Between March 25 and May 31, it received 1,477 complaints whereas in these months last year, only 607 complaints were received.

In India, domestic violence is silenced by victims themselves and their supporters who accept them as part of ordinary family life. A study by UNICEF shows that children are exposed to at least 30 different forms of physical, verbal, and emotional violence and abuse in their homes and that the burden of

household chores, and day-to-day restrictions are imposed solely on girls. UNICEF has cautioned that if early childhood development is not prioritized in Covid-19 responses, young children would face disproportionate risk and irreparable loss. A girl child suffers more than a boy inside the house.

Three months ago, UN Secretary-General called for a domestic violence "ceasefire" amid a "horrifying global surge." He stated that. "for many women and girls, the threat looms largest where they should be safest...in their homes" and asserted that, "...lockdown and quarantines are essential to suppressing Covid-19. But, they can trap women with abusive partners" This is what many do not want to admit or speak about.

Lockdown certainly has no inbuilt condition to promote domestic violence. It has only aggravated the reality. If reports and statistics suggest a link between lockdown and domestic violence, lockdown is often blamed for restricting movements and normal activities which create psychological problems. But. the malady lies in gender relations prevalent in a society which includes sharing of work and responsibility in the household, mutual respect and regard among the members, acknowledgement of each one's role and contributions in running and managing the household. Understanding and accommodating oneself to economic and other conditions of the family are missing in many families. That home is a joint enterprise is hardly acknowledged.

The UN Entity for Gender Equality and Empowerment of Women has already noted that domestic violence is one of the greatest human rights violations. Several nations have initiated action to deal with this problem as a social-psychological one. The Commonwealth Secretariat is working in collaboration with partner organisations to check growth of domestic violence during the pandemic.

As national and international efforts to contain domestic violence amidst Covid-19 are on, India should also activate its machineries to implement legal rights and protection for women already in place.



Palampur, July 9: State-run Chaudhary Sarwan Kumar Himachal Pradesh Krishi Vishvavidyalaya here in the picturesque Kangra Valley has developed immune boosting herbal tea to combat Covid-19, scientists said Thursday.

The tea contains scientifically proven antioxidant properties to help boost immunity against fungal, bacterial and viral diseases, Vice Chancellor Ashok Kumar Sarial told IANS.

The proposed value added tea bags are expected to help improve the immunity to a great deal and also to expand the scope of revenue generation to the university, he said.

University's Department of Tea Husbandry and Technology has about 44 hectares of tea orchards spread over three farms.

A tea processing unit has been operating in the department to manufacture organically certified and FSSAI licensed orthodox made tea – green and black – up to 40,000 kg per year. In a first-of-its-kind, the department is preparing medicinal and herbal-based value-added organic tea bags, department head Jai Dev Sharma told IANS.

To start with, four variants of organic tea – green tea with tulsi, green tea with lemon honey, orthodox tea with mint, tulsi and rose and orthodox black tea with rose have been launched.

Priced Rs 225 with a pack of 25 tea bags, the tea variants are launched under the brand name Dhauladhar

A BRIEF HISTORY

Tea cultivation was introduced in and around the Palampur foothills in the Kangra Valley in the mid-19th century. The Camellia tea, planted by the British in 1849, grew so popular that tea from Kangra won a gold medal at an exhibition in London in 1886 for its superb flavour and quality. The first commercial tea plantation was established as 'Hailey Nagar tea Estate' at Holta, near Palampur, in 1852 at an elevation of 1,291 metre above mean sea level.

It encouraged many private entrepreneurs and by the end of 1880 about 4,000 hectares was brought under the tea cultivation - extending from Jogindernagar in Mandi district to Shahpur in Kangra district.

The quality of tea grown under this region appeared to be of excellent



quality as evidenced by the gold and silver medals won in Amsterdam and London markets from 1886 to

The industry in the region progressed well till 1905, when the great earthquake ruined many establishments. The panic stricken Britons sold their plantations to the local buyers who could not maintain the same profitably due to the lack of technical knowhow.

THE ENTRY OF TOURISTS IN HIMACHAL PRADESH WAS BANNED IN MARCH TO CHECK **SPREAD OF CORONAVIRUS**

Shimla, July 9: Amidst mounting resentment among hoteliers, panchayats and beopar mandals against the state's decision to throw open its doors for tourists; the High Court has issued a notice to the government on a petition filed by local Neelam Sharma.

Sharma has sought withdrawal of the July 2 government order. stating that allowing tourists could pose a risk to the safety of locals. A Division Bench comprising Chief Justice L Narayana Swamy and Justice Anoop Chitkara directed the Chief Secretary and secretaries of revenue and tourism departments to file their replies by July 20. Some panchayats in Manali have threatened to prevent tourists' entry.

The state government has allowed reopening of hotels and restaurants but the hoteliers and other tourism sector stakeholders in Palampur, Baijnath, Bir-Billing, Gopalpur and Chamunda in Kangra district are not willing to restart their operations. They have refused hundreds of bookings in the past five days.

Like in other parts of the state, most of the hoteliers in Kangra have decided to keep their businesses, including home stay facilities, closed till September. The prime concern behind the decision is the safety of local people. They fear that the arrival of tourists from other states can lead to the spread of Covid-19. Besides, most of the panchayats and municipals councils are opposing the opening of hotels in Kangra where the number of Covid-19 cases has doubled in the past fortnight.

In the past five days, over 3,750 tourists crossed the Mehatpur inter-state border but most of them

failed to get accommodation in hotels and had to return. Vinay Sharma, president of the Palampur Hotels' and Restaurants Association, said, "We are not considering restarting commercial operations till normalcy returns. It will be risky to open hotels when coronavirus cases are rising in the adjoining states of Haryana and Punjab. The safety of tourists and local people is our priority. The Covid-19 cases are still on the rise in Maharashtra and Gujarat from where tourists come to the

state during the winter.' Anyone coming to the state is required to undergo a 14-day home quarantine. Those coming from abroad are required to be sent to seven-day institutional quarantine and seven-day home quarantine. There is strict monitoring by health officials and the police too.




"A militant fired at a close range at them, the three took bullets in vital part, in the head, they were

New Delhi, July 9: The Centre has informed the Supreme Court that there are several funds which were either established earlier or now for carrying out various relief works, and PM-CARES is one such fund with voluntary dona-

The affidavit filed by the Ministry of Home Affairs said "It is submitted there exists a fund stipulated under section of the DMA (Disaster Management Act) which is called NDR fund. However, mere existence of a statutory fund would not prohibit in creation of a different fund like PM-CARES fund which provides for voluntary donations."

The Centre contended that the petition seeking a direction that the funds received by PM-CARES to be credited to NDRF (National Disaster Response Fund) is neither maintainable on merits nor is main-



tainable under Article 32 as all funds other than the funds stipulated under section 46 of Disaster Management Act, 2005 are separate, different and distinct, created separately under separate provisions. On June 17, the apex court issued notice to the Centre on a PIL seeking to transfer funds from PM-CARES to National Disaster Response Fund (NDRF).

A bench comprising Justices Ashok Bhushan, Sanjay Kishan Kaul and M R Shah asked the Centre to file a response within four weeks. Centre for Public Interest Litigation (CPIL), in the plea claimed that in the backdrop of Covid-19 pandemic, NDRF is not being utilised by the authorities, and establishing the PM-CARES fund is outside the scope of the Disaster Management Act.

The petitioner argued that the entire funds collected in PM-CARES till date may be directed to be transferred to the NDRF. "Centre may be directed to utilise National Disaster Response Fund (NDRF) for the purpose of providing assistance in the fight against Covid-19 pandemic in compliance with Section 46 of the DM Act, all the contributions/grants from individuals and institutions shall be credited to the NDRF in terms of Section 46(1)(b) rather than to PM-CARES fund and all the funds collected in the PM-Cares till date may be directed to be transferred to the NDRF", said the PIL.

China's Galwan claim

New Delhi, July 9: India has once again rejected China's claim over Galwan Valley in eastern Ladakh even as both sides are expected to hold another round of diplomatic talks on the border row Friday to thrash out modalities for further de-escalation of tension along the Line of Actual Control.

External Affairs Ministry Spokesperson Anurag Srivastava said India remained convinced of the need for maintenance of peace and tranquility in the border areas and resolution of differences through dialogue, but at the same time asserted that the country is committed to ensuring its sovereignty and territorial integrity.

At an online media briefing, he said the Line of Actual Control (LAC) must be strictly respected and observed as it is the basis for peace and tranquility in border areas. Srivastava said National Security Advisor Ajit Doval categorically conveyed to Chinese Foreign Minister Wang Yi on Sunday India's position on the recent developments along the LAC including in the Galwan valley area.

Doval and Wang, the special representatives for border talks, held a telephonic conversation following which armies of the two countries began disengagement of troops from friction points in eastern Ladakh.

"The NSA emphasised in this context that the Indian troops had always taken a very responsible approach towards border management and at the same time, our forces were deeply committed to ensuring India's sovereignty and security," Srivastava said. In the meantime, people familiar with the development said the two sides will hold another online meeting Friday on the border row.

Rising temperature a challenge for meeting climate goals

New Delhi, July 9: The annual mean global temperature is likely to be at least one degree Celsius above the levels it was before the industrial era in each of the ensuing five years and there is a chance that it may exceed 1.5 degrees in at least one year, according to an analysis published by the World Meteorological Organization.

The new assessment, carried out by the UK's Met Office for the World Meteorological Organization, showed that the earth's average temperature is already over one degree Celsius above the pre-industrial period, which spans 18501900. The last five years have been the warmest years on record.

According to WMO Secretary-General Petteri Taalas, the analysis underlines the enormous challenge in meeting the 2015 Paris Agreement on Climate Change target of keeping the global temperature rise in this century below two degrees Celsius.

The prediction showed that there is a 70 per cent chance that one or more months during the next five years will be at least 1.5 degrees warmer than pre-industrial levels. There is, however, a 20 per cent chance that one of the next five years will be at least 1.5 degrees warmer than pre-indus-



trial levels, with the chances increasing over time.

In 2020, the Arctic is likely to

Africa and Australia, where bushfires last year razed millions of acres, will be dryer than usual through 2024. Over 2020-2024, sea-level pressure anomalies suggest that the northern North Atlantic region could have stronger westerly winds leading to more storms in western Europe. By the next five years, almost all regions, except parts of the southern oceans, are likely to be warmer than the recent past, the predictions showed. The assessment takes into account natural variations as well as human influence on the climate to forecast temperature, rainfall, and wind patterns over have warmed by more than twice as much as the global mean, pre-

the next five years. It, however, does not take into consideration changes in emissions of greenhouse gases and aerosols as a result of the coronavirus lockdown. "Due to the very long lifetime of CO2 in the atmosphere, the impact of the drop in emissions this year is not expected to lead to a reduction of CO2 atmospheric concentrations which are driving global temperature increases," said Professor Taalas.

He added that even though COVID-19 caused a severe international health and economic crisis, failure to tackle climate change may threaten human wellbeing, ecosystems, and economies for centuries and hence governments should use the opportunity to embrace climate action.

New Delhi, July 9: The Supreme Court Thursday pulled up the Maharashtra government on the migrant workers issue and refused to accept its claim that there was no problem in the state on this front, saying it is its duty to find out the lapses and act on them.

A bench of Justices Ashok Bhushan, S K Kaul and M R Shah asked the state to file a fresh affidavit listing the steps taken to mitigate the problems of migrant workers wanting to return to their native places amid the COVID-19 crisis. It is not an adversarial litigation, the bench said, posting the matter for further hearing on July 17.

During the hearing of the case taken up suo motu (on its own) by the top court on the miseries of migrant workers during the COVID-19 lockdown, the bench said: "What is happening in Maharashtra? Large number of migrant workers are still in the state.

Solicitor General Tushar Mehta, appearing for the state, said that the latest affidavit has been filed on July 6 in compliance with the apex court's order. He said that a list was provided to the Centre with regard to migrant workers, who have been sent to their native places by the state.

Mehta said the crux of the affi-

Though no Congress leader has openly said anything so far, the party has become active in Bihar after the virtual meeting of the leaders with former Congress President Rahul Gandhi. The party seems to be working on the principle of 'Ekla Chalo Re' (walk alone) or moving towards the strategy to contest the elections on its own.

The party's Bihar in-charge, Shakti Singh Gohil, met with party leaders in Patna on Wednesday and discussed the strategy with the members of the election campaign committee. Besides, several senior Congress leaders, including Gohil and Campaign Committee Chairman

and Rajya Sabha MP Akhilesh Singh, met Rashtriya Janata Dal (RJD) leader Tejashwi Yadav and former Chief Minister Rabri Devi late on Wednesday evening.

Congress sources said that the party hoped a joint meeting will be called to discuss election strategy within the first fortnight of July, but it has not happened yet.

Till now, neither the Congress has been given any indication regarding the meeting, nor has any official information been given about the meeting in near future. Most of the Congressmen are unhappy with this attitude of the RJD, the sources added.

A Congress leader, on the condition of anonymity, said that the party does not want a repeat of the situation which had arisen due to the delay in seat-sharing in the Lok Sabha elections in 2019. The Congress sources said that the party wants consensus on all issues with its allies.

Sources further said that the resentment with the RJD was palpable even in the Congress Election Committee meeting. Most of the Congress members accused the RJD of cheating when it came to seat sharing at the time of elections.

Akhilesh Singh said that all parties are busy making their own strategies, and the Congress is also doing the same. He said it is too early to say anything. However, he also said that the Grand Alliance is united and everything will be decided in a fortnight's time.

Meanwhile, Lallan Kumar, a member of the Election Campaign Committee, and former President of Bihar Pradesh Youth Congress, said, "The Congress is in favour of jointly contesting the elections to remove the BJP-JDU government in Bihar."

He said there is democracy in the Congress and all the people speak openly at the party forum. The same happened at the meeting with Rahul Gandhi, where everyone put forward their views.

He also said that the party has already started preparing for the elections following instructions by the Congress high command.

CBSE SYLLABUS ROW

False narrative: HRD minister

New Delhi, July 9: Union HRD Minister Ramesh Pokhriyal 'Nishank' Thursday said there has been an "uninformed commentary" on the exclusion of certain topics from the CBSE syllabus to portray a false narrative.

The comments by the minister came following a controversy over the reduction of syllabus by the CBSE due to the COVID-19 situation. with the Opposition alleging that chapters on India's democracy and plurality are being "dropped" to propagate a particular ideology.

"There has been a lot of uninformed commentary on the exclusion of some topics from the CBSE syllabus. The problem with these comments is that they resort to sensationalism by connecting topics selectively to portray a false

"While it is easy to misconstrue exclusion of three to four topics like nationalism, local government, federalism, etc and build a concocted narrative, a wider perusal of different subjects will show that

this exclusion is happening across subjects," Nishank said in a series

The minister reiterated that the exclusions from the syllabus are a one-time measure taken in view of the COVID-19 pandemic. "As the CBSE has clarified, schools have been advised to follow the NCERT Alternate Academic Calendar, and all the topics mentioned have been covered under the same. The exclusions are merely a one-time measure for exams, due to the

COVID-19 pandemic. "The only aim is to relax the stress on students by reducing the syllabus by 30 per cent. This exercise has been carried out following the advice and recommendations of various experts and considering the suggestions received from educationists through our Syllabus For Students 2020 campaign," he said.

POLLUTION INCREASES RISK OF COVID DEATHS: STUDY

Bangalore, July 9: Air pollution in Bangalore is linked to the loss of an estimated 6,300 lives in the first half of 2020 and 3.7 per cent decline in the city's annual GDP despite strictly enforcing COVID-19 related lockdown, a study has revealed.

According to a new online tool by IQAir AirVisual and Greenpeace-Southeast Asia, research shows that long-term air pollution exposure increases the risk of severe COVID-19 infections and death.

"Air pollution in Bengaluru is linked to the loss of an estimated 6,300 lives in the first half of 2020 despite a strict COVID-related lockdown," the two organisations claimed in a statement.

It is also revealed that air pol-



lution took a major toll on the city's economy at a cost of approximately ₹6,973 crore over the last six months, an equivalent of 3.7% of Bengaluru's total annual GDP, the statement said.

The study claimed that the health damage from air pollution is expected to cost 1-5.8% of cities GDP in the major metropolitan cities of the world in the first half of this year. Of all the 28 cities studied, Delhi bears the highest economic cost of air pollution as a percentage of GDP due to the impacts of PM2.5 and NO2 pollution.

70 fall sick after consuming beef

Visakhapatnam, July 9: At least 70 people in an Andhra Pradesh village have reported sick of whom six at least are battling for their lives after allegedly consuming cooked beef from a cow that went missing and was later discovered dead.

The incident occurred Wednesday night in Magatapalem village. Around 70 members of a tribal community, who fell sick, are being treated at the public health centre while the critically ill have been admitted to the Paderu district hospital.

According to locals, a villager's cow missing on Monday. It was found dead the next day. The dead cow was brought to the village and its flesh was cooked and consumed by the villagers. Some villagers had also allegedly stored the flesh and consumed it on Wednesday too. Many people, who consumed the beef, began to experience food poisoning symptoms such as vomiting and diarrhoea.

The district authorities were alerted of the situation later, shifted the sick to the local hospital on Wednesday night. MLA K. Bhagyalakshmi visited the hospital to inquire about their health.

curity risks. The list not only have Chinese apps that have already been banned by the government like TikTok but also carries US-based platforms like Facebook, Instagram, Snapchat, Zoom, Truecaller, Reddit and more. The 89 apps have social media accounts, content sharing apps, short video making apps, e-commerce and dating sites like songs.pk, WeChat, Hike, Likee, Shareit, PUBG and Tinder, etc.

Engineer develops device to ensure social distancing

New Delhi, July 9: Amid the coronavirus pandemic, a Southern Railway Signal Telecommunication engineer has developed a device to remind people to maintain at least a three

metre distance from each other. The device can fit into a pocket or a small purse, can be attached with ID cards and can also be used along with a wristwatch. It weighs around 30 grams and uses radio frequency to detect the presence of human beings if they are wearing the same device.

"It is designed with special consideration to the safety of on-duty

IRSSE, Senior Divisional Signal and Telecommunication Engineer, Southern Railway, Trivandrum Division, who coordinated the development of the device by his Junior Engineer, R Nidheej.

"If two or more people wearing Social Distancing Ensuring Device happen to come within a distance of 2-3 metres, it would warn them with an alarm sound. It would continue to produce the alarm sound until they keep a range above 3 meters between them. Thus, the device will help us in ensuring social distancing," he explained.

While social distancing norms are one of the most essential methods to control the pandemic, it is often forgotten in daily life, the official said,

emphasising on the need for such a device. The device can be recharged with the help of a charger. Once it is charged, it will be active for more

than twelve hours.

"We have developed a prototype and it has been tested successfully. We are also ready to transfer the technology to other zonal railways or railways workshops for making it on a large scale," Dinesh said.

The device is the latest innovation from Nidheej, who has also developed a robot, RailMitra, which has the ability to distribute essentials like medicines, food and water to COVID-19 patients and will collect used plates, bottles, masks, from them to avoid spread of the disease among caregivers

RailMitra can also be used for disinfecting floors with the help of UV lights and by using its targeted spraying system. It is also provided with an IP camera through which communication can be established remotely with a patient. The technology has been transferred to S&T Workshop at Podanur and they are making it for Railway Hospitals. Nidheej also developed a sanitiser dispenser which uses ultrasound sensors and microcontrollers to dispense sanitiser automatically for 0.75 second when someone places his or her hands under it.

This sanitiser dispensing device can be recharged with the help of a mobile phone charger. Once it is charged, it will be active for more than one week. Also Signal & Telecommunication Department of Trivandrum Division has developed a contactless body temperature measurement device which can be used for measuring bodytemperature without making any physical contact.



WHO sets up panel to review handling of pandemic

Geneva/Zurich, July 9: The World Health Organisation (WHO) said Thursday it was setting up an independent panel to review its handling of the COVID-19 pandemic and the response by governments worldwide.

The announcement follows strong criticism by U.S. President Donald Trump's administration, which accused the WHO of being "Chinacentric", and U.S. formal notification on Tuesday that it was withdrawing from the U.N. agency in a year's time.

Tokyo, July 9: Flooding and mudslides have stranded hundreds of people in scenic hot springs and hiking areas in central Japan, while rescue workers searched Thursday for more people missing in rain-related disasters that have already killed more than 60 people.

Parts of Nagano and Gifu, including areas known for scenic mountain trails and hot springs. have been flooded by massive downpours that have lasted for nearly a week.

More than 300 people, including hotel employees and visitors, were trapped in Kamikochi, as floods and mudslides hit a main road connecting the town to Matsumoto, another tourist destination in Nagano. All of the stranded people were safe, prefectural officials said. In neighboring Gifu, hundreds were also isolated in the hot spring towns of Gero and Ontake.

SC rulings keep Trump financial records private for now

Washington, July 9: The Supreme Court issued a mixed verdict Thursday on demands for President Donald Trump's financial records that will keep his tax returns, banking and other documents out of the public eye for the time being.

By 7-2 votes, the justices upheld the Manhattan district attorney's demand for Trump's tax returns, but kept a hold on Trump's financial records that Congress has been seeking for more than a year. But Trump, who has strenuously sought to keep his financial records private, didn't immediately regard the outcome as a victory.

"The Supreme Court sends case back to Lower Court, arguments to continue. This is all a political prosecution." Trump wrote in a series of angry tweets that followed the court rulings.

The justices rejected arguments by Trump's lawyers and the Justice Department that the president is immune from investigation while he holds office or that a prosecutor must show a greater need than normal to obtain the records. The tax returns are being sought as part of a grand-jury investigation. Because the grand jury process is confidential, the rulings make

the President, however, implicate special concerns regarding the separation of powers.

Canberra, July 9: Australia has suspended its extradition treaty with Hong Kong in response to fears over a new national security law imposed by China, Prime Minister Scott Morrison said on Addressing the media here,

Morrison said that the new law, which came into effect on June 30. undermined "Hong Kong's own basic law" and the territory's current level of autonomy from Beijing, the BBC reported.

Australia planned to extend visas for Hong Kong residents and encourage businesses there to relocate, he said, adding his government, along with others had been "very consistent in expressing our concerns about the imposition of the national security law on Hong Kong". Previously, Australia and Hong Kong could both seek the extradition of any person within their jurisdiction who was wanted for prosecution or a criminal sentence.

This process has happened just twice in the past 10 years, said the BBC report. As the extent of the law's reach was still uncertain, critics have said it could also lead to foreign nationals being arbitrarily detained in Hong Kong. This has led Australia and other nations to issue new warnings to their citizens in Hong Kong. "You may be at increased risk of detention on vaguely defined national security grounds. You could break the law without intending to. If you're concerned about the new law, reconsider your need to remain in Hong Kong," said Australia's Department of Foreign Affairs and Trade.

Meanwhile, China criticised Australia's move as "gross interference" in its domestic affairs.

"We urge the Australian side to immediately stop meddling... Otherwise it will lead to nothing but lifting a rock only to hit its own feet," the BBC quoted a statement by the Chinese embassy in Australia as saying Thursday.

Also Thursday, New Zealand's government said that it would review the country's relationship with Hong Kong. Foreign Minister Winston Peters said New Zealand was "deeply concerned" about the national security law.

Since the law that targets acts of secession, subversion, terrorism and collusion with foreign forces, with punishments of up to life in prison for the most serious offences, was enacted last week. Canada has also suspended its extradition treaty. while the UK has offered citizenship options to Hong Kong residents.

Covid brain complications increase across the globe

London, July 9: Cases of brain complications linked to COVID-19, like strokes, delirium, and other neurological complications are reported from most countries where there have been large outbreaks of the disease, a new study says

According to the scientists, including those from the University of Liverpool in the UK, COVID-19 has been associated mostly with problems like difficulty breathing, fever, and cough.

However, in a review of studies, published in The Lancet Neurology, the researchers said other problems such as confusion, stroke, inflammation of the brain,



spinal cord, and nerve disease can also occur in COVID-19 patients. In the study, the researchers assessed patients hospitalised in the UK for COVID-19, and found a range of neurological and psychiatric complications that may be linked to the disease.

According to the scientists, one of the complications found to be linked to COVID-19 is encephalitis - an inflammation and swelling of the brain.

New US visa regulations to cause difficulties for Indians

Washington, July 9: The new visa regulations requiring international students in the US with an F-1 visa to take at least one in-person course or face the prospect of deportation is likely to "cause uncertainties and difficulties" for some students, the Indian Embassy here has said.

"These new modifications at a time when many of the US universities and colleges are yet to announce their plans for the new academic year are likely to cause uncertainties and difficulties for some Indian students wishing to pursue their studies in the US," said a spokesperson of the Indian Embassy.

Responding to media queries, the spokesperson said the Indian



government has taken up the matter with concerned US officials. At the India-US Foreign Office Consultations held on July 7, Foreign Secretary Harsh Vardhan Shringla conveyed India's concerns on the matter to Under Secretary of State for Political Affairs David Hale.

According to a recent report of Student and Exchange Visitor Program (SEVP), there were 1,94,556 Indian students enrolled in various academic institutions of the US in January this year. Of these 1,26,132 were males and 68,405 were females. Noting that partnership in higher education is a key component. of the strong people-to-people ties between India and the US, the spokesperson said in the last two decades Indian students in American universities and colleges have been the harbingers of a strong partnership between technology and innovation sectors between the two countries.

The spokesperson hoped that the US authorities would provide adequate flexibility in their visa rule, keeping in mind the extraordinary circumstances created by the COVID-19 pandemic for the Indian students community.

25 years on, Srebrenica dead still being identified, buried

Over 8,000 Bosnian Muslims perished in 10 days of slaughter after the town was overrun by Bosnian Serb forces in the closing months of the country's 1992-95 fratricidal war

Srebrenica, Bosnia-Herzegovina, July 9: A quarter of a century after they were killed in Europe's worst massacre since World War II, eight Bosnian men and boys will be laid to rest Saturday in a cemetery just outside of Srebrenica — their marble gravestones joining thousands more, each with the same month and vear of death

Over 8,000 Bosnian Muslims perished in 10 days of slaughter after the town was overrun by Bosnian Serb forces in the closing months of the country's 1992-95 fratricidal war. Their executioners tried to ensure they would never get the sort of memorial Srebrenica holds every year. Their bodies were plowed into hastily made mass graves and then later dug up with bulldozers and scattered among other burial sites to hide the evidence of the crime.

But, since 1996, Bosnian and international scientists have slowly unlocked what was once described as the "biggest forensic puzzle anywhere in the world," unearthing the bones from those gruesome death pits and connecting them with the names of the people they belonged to. When the remains are identi-

fied, they are returned to their relatives and reburied in the Potocari memorial cemetery. And each year on July 11, the anniversary of the day the killing began in 1995, relatives gather for a funeral of the recently identified. Most of the dead were men and boys, so most of the mourners are women — mothers and sisters, daughters and wives. Massacre survivor Fazila Efendic

will attend the collective funeral

this year to witness her sisters in

grief bury a handful of bones, as she

Having a grave to visit will bring them some relief, Efendic says. Her husband, Hamed, and her only son, Fejzo, were killed in the massacre.

For years, every time a new mass grave was found, she rushed to the site hoping to see something she would recognize as having belonged

to her loved ones. "There are no words to describe

the sorrow you feel when you are looking for (your loved ones) bone by bone," Efendic said. "I visited every newfound mass grave; I've seen the inside of every one of them.'

All of Hamed's remains were

found in two mass graves, one unearthed in 1998 and the other in 2000. Fejzo — or rather two of his leg bones — was found in another one several years later. Efendic buried her husband at Potocari after his remains were found but waited years before finally deciding to do the same with Fejzo's partial remains.



That the massacre survivors are able to visit their dead at all is a testament to the forensic scientists at the International Commission on Missing Persons. Set up in 1996 at the urging of then-U.S. President Bill Clinton, the commission designed a DNA-based system to find and identify the remains of some 40,000 people — the vast majority of them from Bosnia — who had been reported as missing as a result of the 1990s conflicts in the former Yugoslavia.

In 2014, the commission became a permanent global body, expanded its mission to other conflicts and natural disasters, and moved its headquarters to The Hague. But not before helping to identify more than 70% of all the missing victims of the 1990s Balkan wars, including close to 7,000 of those killed in Srebrenica.

Damir Marjanovic, an early member of the then Bosnia-based commission, said the team's work has greatly increased scientists' abil-ity to pull DNA profiles from skeletal remains



Chinese banks prepare contingency plans

Beijing/Hong Kong/Shanghai, **July 9:** Chinese state lenders are revamping contingency plans in anticipation of US legislation that could penalise banks for serving officials who implement the new national security law for Hong Kong, sources at five state financial institutions said.


In worst-case scenarios under consideration by the Bank of China and Industrial and Commercial Bank of China, the lenders are looking at the possibility of being cut off from US dollars or losing access to US dollar settlements, two sources said.

The dollar is the dominant global currency for international payments and central bank reserves.

"We are hoping for the best, but preparing for the worst. You never know how things will turn out," one of the sources said.

Reflecting concern over the erosion of the former British colony's autonomy, the US House and Senate unanimously passed the bill last week. It has yet to be signed into law by President Donald Trump.

The bill calls for sanctions on Chinese officials and others who help violate Hong Kong's autonomy and on financial institutions that do business with them. But it does not spell out what the sanctions



"There are sanctions in this bill which could be interpreted to prevent a bank from clearing some dollar transactions via US institutions, but unlike other congressional sanctions bills there are not specific provisions mandating it," said Nick Turner, a lawyer specialising in sanctions and antimoney laundering at Steptoe & Johnson in Hong Kong.

He said it remained to be seen whether the law would be used in such a way.

In a milder scenario being looked at by the Agricultural Bank of China, lenders would need to find ways to address the problem of clients blacklisted by the United States, especially those who might face a sudden loss of liquidity, a third source said.

The sources all declined to be named as the planning is confidential. Bank of China, ICBC and AgBank did not immediately respond to Reuters requests for comment.

VEDANTA'S INITIATIVES HELP KALAHANDI TH

A REPORT CLAIMED THAT VEDANTA'S PLANT IN THE DISTRICT CREATED 5,000 JOBS IN ALUMINIUM AND VALUE CHAIN INDUSTRIES

Bhubaneswar, July 9: An NGO PRAHAR (Public Response Against Helplessness and Action for Redressal), Wednesday called for a comprehensive national strategy targetting accelerated industrial growth in remote regions of India to bring relief to workforce which has receded there because of the COVID-19 pandemic. The NGO highlighted during a webinar PRAHAR made a comprehen-

sive research on Lanjigarh of the 'Odisha case study' by Sattva Consulting, an independent social impact strategy consulting and implementation firm.

Abhay Raj Mishra, President and National Convenor, PRAHAR said. "We conducted a ground-research in Kalahandi district which revealed significant socio-economic transformation in the region after Vedanta commissioned its alumina refinery and captive power plant in Lanjigarh in 2003.

Till the year 2000, the Kalahandi district (part of KBK) used to be one of the most poverty-stricken regions of Odisha as well as the country. With support from the government things started to change after the Vedanta plant was commissioned in the district in 2003,' Mishra added.

PRAHAR's report claimed that Vedanta's plant created 5,000 jobs in aluminium and value chain in-

lion in revenue and \$4 trillion in market capitalisation. "We wanted to capture this incredible feat that our community is achieving with increasing numbers," said Indiaspora founder MR Rangaswami, a Silicon Valley-based

The stereotype of the Indian CEO $\,$ is someone who represents the tech sector, but this list of 58 CEOs dispels that myth, he said, adding that these leaders represent many different sectors, including banking, electronics, consumer goods, and consulting. The list of Indian-ori-

Catalan derby sees two sent offs as Barcelona keep title hopes alive, while the loss relegates Espanyol for the first time in nearly three decades

Barcelona, July 9: It must be strange feeling for the Catalans Wednesday night as they would be thinking what should they do as one of their teams keeping pace for the title while the other has been assured of relegation. It's like one gets a good news and a bad news in the

Barcelona kept their title hopes alive with a 1-0 win in the Catalan derby against Espanyol in the Spanish league (La Liga), sealing the rival's relegation for the first time in nearly three decades.

Luis Suarez scored the winning goal early in the second half on Wednesday to move Barcelona within a point of leader Real Madrid and send Espanyol to the second division after 26

straight seasons in the top flight. Real Madrid can reclaim a fourpoint lead with three rounds left with a home win against relegationthreatened Alaves Friday. Madrid, seeking their first league title in three years, has a perfect record since the league resumed following

the coronavirus break. 'We knew it would be a difficult match because of Espanyol's situation," Suarez said. "We are going to keep trying to win our matches and see if Madrid falters.

Only a win in the city could have kept last-place Espanyol with a chance of staying in the top tier. The club owned by Chinese businessman Chen Yansheng hasn't played in the second division since the 1993-1994 season. It had been among the teams with most consecutive seasons in the top flight. along with Barcelona, Real Madrid and Athletic Bilbao.

"We have to apologise to our fans for what we have made them go through," Espanyol captain Javi Lopez said. "This is a difficult moment. Nothing went right for us this season. We are committed to coming back stronger."

It was the sixth straight loss for Espanyol, and their 11th consecutive league defeat away to Barcelona at the Camp Nou. They have 24 points from 35 matches — 11 points

Two minutes later and Brighton were caught out again by Liverpool's pressing, this time Salah setting up Jordan Henderson who finished with a perfect drive. Graham Potter's 15th-placed team

pulled a goal back on the stroke of halftime with Leandro Trossard sweeping home a first-time shot after a pinpoint cross from Tariq Lamptev. Brighton, who recovered well

NZ refutes IPL reports, terms it rumours

Wellington, July 9: New Zealand Cricket (NZC) has refuted reports that it has offered to host the now-postponed Indian Premier League this year, terming them as 'inaccurate' while affirming its commitment to the Future Tours

NZC spokesperson Richard Boock said the cricket board has not expressed its interest to host the IPL, which was to be held in March this year but was postponed indefinitely because of the COVID-19 pandemic.

'This rumour is inaccurate. New Zealand would not be in a position to host the IPL - even if we were asked, which we haven't been.

The dates, and OFFERING NZC's commit-**TO HOST** ment to honouring its **IPL 2020 Future Tours**

programme, means the timing would not allow this to happen,' Boock told PTI

Boock's statement came after a BCCI official stated that New Zealand have also joined along with UAE and Sri Lanka the race to host this year's IPL if it is shifted out of India because of the pandemic.

The BCCI is eyeing the September-November window to host the event in place of the World T20 in Australia, which is certain to be postponed because of the growing cases of the deadly virus.

Only once in the 12-year history of the IPL has the entire tournament been shifted out of India. In 2009, it was held in South Africa as the dates clashed with the general elections in the country.

Asia Cup delayed until June 2021

New Delhi: The Asian Cricket Council (ACC) Thursday postponed the Asia Cup tournament, scheduled for September this year, until June 2021 owing to an upsurge in COVID-19 cases in the region. The decision further clears the way for the IPL, which the organisers are trying to hold from September to November. Pakistan was to originally host the Asia Cup this time but due to security reasons, the tournament was supposed to be played in Sri Lanka after the country's board expressed its willingness to organise the same.

Shami wary of rhythm in lockdown

New Delhi, July 9: The COVID-19 lockdown is a double-edged sword for India's craftiest pacer Mohammed Shami. While it gives an exhausted body enough time to 'heal' and get stronger, he fears the prolonged break can also have ruinous implications on rhythm.

In an exclusive interview with PTI, the 29-year-old Shami said that he certainly enjoys an 'advantage' over other Indian players living in metros, having constantly trained inside his sprawling ancestral home in Sahaspur, which comprises a mini-cricket ground with full facility for net practice.

'There are two ways to look at it. The Indian team always has a packed schedule and it was a good break which allowed a tired body to heal," Shami said.

'While on one side, you gain physically become fitter and stronger with a lot of training but not playing the sport means that at the same time the rhythm is not there. Obviously, it's something where you will find the difference. So there are pros and cons and it's about managing your body," added the

man with 180 wickets from 49 Tests. As and when the BCCI starts a camp. Shami believed that he will have an advantage. "Obviously I will have an advantage as I have been training quite regularly. This is different from an injury-induced break. I have been in good rhythm, and luckily, I don't feel any stiffness

while bowling full tilt. 'This is a phase when you always know that you are there and it's a matter of time to get that rhvthm back. It bolsters your confidence." While he has started bowling full tilt at the nets with his brother facing him, Shami said he still can't gauge how an old red ball will behave without the application of saliva.

Did you try with an old ball at the nets? "No, I haven't," said the man with maximum variations among the current group of fast bowlers. "If you don't get proper conditions, you can't try bowling with old ball. I will tell you why...," he said before going on to elaborate.

"In the nets, the old ball that you use is the one that's kept in a box for a few days, it will behave differently from a ball that's getting old after continuous use in a match

asking me this question (whether the ball will be reversing or not without saliva), but honestly, I have no answer. Because, it's a habit and a theory we have all believed and practised since our starting years. So. once we start trying, we will **know better** MOHAMMED SHAMI



situation. Because a ball that gets old in a match situation is maintained throughout the course of

the innings," he explained. It has got a lot to do with the condition of the leather, he continued. 'The old ball that you suddenly bring out for practice will have a softer feel of the leather and that creates a difference. So, if you are looking at answers, you will only get it in a match simulation

"So my next target during training is to start with a new ball and try to maintain it without saliva and then figure out how it behaves when it gets old. I will have to bowl with it and after may be 20 overs when the batsman has faced it, then you get an idea how the ball behaves," Shami said. Not using saliva is something that Shami is already trying to inculcate, by constantly reminding himself that it's banned for now.
