■ FabiFlu price cut

New Delhi: Glenmark Pharmaceuticals has announced that it has commenced a Post Marketing Surveillance (PMS) study on FabiFlu to closely monitor the efficacy and safety of the drug in 1000 COVID patients that are prescribed with the oral antiviral. Further, Glenmark has announced a price reduction of 27 per cent for FabiFlu. The new MRP . is ₹75 per tab from the earlier ₹103 per tab. The price reduction has been made possible through benefits gained from higher yields and better scale, as both the API and formulations are made at Glenmark's facilities in India, the benefits of which are being passed on to patients in the country.

2 Jaish men killed

Srinagar: Two Jaish-e-Mohammad (JeM) militants, including a Pakistani, were killed while a woman was injured during a gun battle between the ultras and security forces in Anantnag district of Jammu and Kashmir on Monday, police said. One of the slain militants has been identified as Nasir alias Shahbaz alias Baz Bai, a police spokesman said, adding he is a Pakistan resident and an 'A' category militant. The identity of the other militant is yet to be ascertained. Security forces had launched a cordon and search operation early Monday in Srigufwara area of Anantnag

Govt tweaks norms Bhubaneswar pass rate 91.46 % for home quarantine

Bhubaneswar, July 13: The state government Monday changed the COVID-19 treatment guidelines allowing home isolation for asymptomatic patients and those with milder symptoms who do not have

Announcing this, Chief Secretary Asit Tripathy said the state government took this decision as a majority of COVID-19 patients have mild symptoms and do not need hospitalization. He said the change followed the receipt of new guidelines issued by the Centre.

"We have new norms on COVID-19 treatment from the WHO and the Centre for mild and asymptomatic cases. We have decided to allow home isolation of asymptomatic and mild patients in urban areas. This will also include divisional, sub divisional and block headquarter towns," Tripathy said.

He said the state survey of COVID 19 patients has revealed new facts which propelled the government to take such a decision. "Our survey claims that many asymptomatic persons who stay in hospitals developed psychological stress.

616 NEW CASES IN STATE; TOLL UP BY 6

he COVID-19 death toll in the state rose to 70 with six more people succumbing to the virus, even as 616 fresh cases pushed the state's tally to 13,737, a health department official said Monday. Four deaths were reported from Ganjam district, the state's coronavirus hotspot, while Khurda and Cuttack accounted for the remaining fatalities, he said. "Regret to inform the demise of six COVID positive patients while under treatment," the department said. Many of the deceased were suffering from diabetes, hypertension and other ailments. Of the 616 fresh cases, 415 were detected among those in quarantine, while 201 are local-contact infections, he said. Ganjam reported 283 of the fresh cases, followed by Koraput.

Many also take self medication to suppress development of symptoms," he said, adding the decision can also help the patients reduce chances of secondary infections developed from hospitals.

The new norms however bar certain categories of patients who cannot avail the facility of home isolation. "HIV patients, transplant

patients with co-morbidities, lung, liver and heart disease patients cannot opt for home isolation, if tested positive," he said. The government allowed corporate houses and other institutions to keep asymptomatic patients on their campuses (in isolation) if members from their intuitions test positive.

Civic bodies, ECoR, Jharsuguda airport, all ports, PSUs, CISF, BSF, CRPF, NDRF, Odisha Police and all universities, religious institutions, RWAs and NGOs can keep their employees on campus. An adult caregiver will be entrusted with the task to act as a bridge between the government and the patient. It has also been mandated to ensure adequate online training for bio-medical management in such situations.



Cong keeps doors still open for Pilot

Jaipur/New Delhi, July 13: Congress MLAs were holed up Monday in a resort near Jaipur after a legislature party meeting, where they expressed support for Rajasthan Chief Minister Ashok Gehlot and only indirectly referred to Sachin Pilot, whose rebellion threatens his government.

Top party leaders, including Rahul Gandhi and Priyanka Gandhi Vadra, were also in touch with Pilot, assuring that his grievances will be addressed. A resolution adopted at the Congress Legislature Party meeting urged "strong disciplinary action" against any party office-bearer or CLP member who does anything to weaken the government or the party.

But the resolution stopped short of naming Pilot, who is the deputy chief minister and also heads the state unit of the party. Before the meeting, senior Congress leader Randeep Surjewala also adopted a conciliatory tone, saying Pilot and other MLAs could still attend the CLP meeting from which they had distanced themselves.

"Doors are open for Sachin Pilot and other MLAs. They will be heard and solutions will be found. This is the discipline of the party,"

BTP withdraws support

NEW DELHI: The Bharatiya Tribal Party (BTP), a regional outfit with just two MLAS in the Rajasthan Assembly, has reportedly withdrawn support from the Ashok Gehlot government in Rajasthan which is trying to weather its worst crisis since 2018. The ruling Congress stands on the brink of a solit in the state with Mr Gehlot's deputy, Sachin Pilot, openly rebelling. Mahesh Bhai Vasava, the chief of the BTP, has written to his MLAs saying his party will remain neutral in case of a floor test in the assembly. The MLAs have been asked to remain absent during a floor test. Pilot has claimed he has the support of 30 MLAs and that government is now a minority.

Surjewala, who is the AICC spokesperson, said. Apart from Rahul Gandhi and Priyanka Gandhi, other Ahmed Patel, former Union finance minister P Chidambaram and AICC general secretary KC Venugopal are also learned to have spoken with Pilot.

Pilot has been upset since he was denied the Rajasthan chief minister's post after the December 2018 Assembly elections. There was no official word on the number of MLAs who attended the meeting at Gehlot's home.

Google to pump in ₹75K cr to help India go digital

New Delhi, July 13: Google and Alphabet CEO Sundar Pichai Monday announced a Google for India Digitisation Fund through which the company will invest ₹75.000 crore, or approximately \$10 billion, over the next five to seven years to drive digital transformation in the country.

"We'll do this through a mix of equity investments, partnership investments, and operational, infrastructure and ecosystem investments. This is a reflection of our confidence in the future of India and its digital economy," Pichai said during the Google for India virtual conference.

The fund will focus on four areas that are important to India's digitisation. They include enabling af-

fordable access to the internet and to information for every Indian in their own language and building new products and services that are deeply relevant to India's unique needs including consumer tech, education, health and agriculture.

The Google for India Digitisation Fund will also focus on empowering businesses especially small and medium businesses as they continue or embark on their digital transformation. Another area of focus will be leveraging technology and Artificial Intelligence (AI) for social good, including digital literacy, outbreak predictions, and support

for rural economies, Pichai said. Giving a special address at the event, India's Union IT Minister Ravi Shankar Prasad expressed hope that with this new fund, Google



'Primary cause key to determine Covid death'

21 PATIENTS DIE IN STATE DUE TO REASONS OTHER THAN CORONAVIRUS, SAYS GOVT

BISWA BHUSAN MOHAPATRA, OP

Bhubaneswar, July 13: At least 91 Covid-19 patients have died in the state till Monday morning. However, the government claimed that 21 of them died due to diseases other than Covid

According to state government's data, five coronavirus patients died due to non-Covid reasons in Khurda district while the number is three for Cuttack, two each for Balasore. Mayurbhanj, Bhadrak & Ganjam and one each for Kendrapara, Keonjhar, Nabarangpur, Puri and Sundargarh districts

The Indian Council of Medical Research (ICMR) has issued detailed guidelines for physicians to detect the cause of death in a Covid patient. "The cause of death (COD) is defined as all those diseases, morbid conditions or abnormalities. injuries which either resulted in or contributed to death and the circumstances of the accident or violence which produced any such injuries," ICMR defined in its guidelines.

In its guidance for appropriate recording of Covid-19 deaths in India, the ICMR said deaths with in-


conclusive test results, but in which coronavirus symptoms are present will be recorded as "probable Covid-19" fatalities.

Covid-19 would be recorded as an "underlying cause of death" when leading to pneumonia, cardiac injury and clotting in the bloodstream, among others, it said.

Patients may have other pre-existing comorbid conditions such as chronic obstructive pulmonary disease (COPD) or asthma, chronic bronchitis, ischemic heart disease, cancer and diabetes mellitus. These conditions increase the risk of developing respiratory infections and may lead to complications and severe disease in a Covid-19 positive individual. These conditions are not considered as underlying cause of death as they have directly not caused death due to Covid-19, the ICMR mentioned.

Director of Regional Medical Research Centre (RMRC) Sanghamitra Pati said, "When death of a Covid-19 patient occurs, we see the primary cause of the death. For example, if a cancer patient dies and the death is not due to pneumonia or acute respiratory distress syndrome, then it will be



Handwriting in Aditya's diary to be examined

Bhubaneswar, July 13: The death of social activist Aditya Kumar Dash still shrouds in mystery even a week after the recovery of his body on the railway track near Lingaraj Temple Road railway

However, the Government Railway Police (GRP) Monday sent the alleged suicide note collected from his diary along with cheques and other handwritten notes by Aditya to the handwriting bureau of State Forensic Science Laboratory (SFSL) here for a test.

The SFSL's seven-member team will analyse and compare the documents and signatures of Aditya with handwriting in suicide note to ascertain whether it was written by Aditya or not. The GRP personnel also collected the bank account details of Aditya in order to check any suspicious financial transactions

Meanwhile, the GRP officials have been going through the call detail records (CDR) of the cell phone used by the deceased activist. The cops were in search of the two eyewitness slum-dwellers

Aditya was found dead on the tracks near Lingaraj Road railway station here July 7. He had established an old-age home near his residence. He was popular among the netizens as a motiva-



Anubhav moves SC against killing of wild animals

New Delhi, July 13: Biju Janata Dal (BJD) MP from Kendrapara Anubhay Mohanty Monday filed a petition in the Supreme Court seeking a direction against practices of encouraging and rewarding wild animal killing in the country.

The Lok Sabha MP urged the court to issue directions against indiscriminate and brutal killing of wild animals. Mohanty submitted in his petition that many state governments, including Bihar, Himachal Pradesh and Kerala, have financially incentivised the killing of wild animals like Rhesus Macaque, wild boars and Nilgai.

'Unfortunately, a popular way of getting rewarded by the state government is by planting bombs and poisons in our forests," Mohanty said. The BJD MP filed the petition in response to the death of several animals and a child after use of heinous practices such snares, wire traps, explosives, bomb baits, poison baits etc were reported and documented to annihilate wild animals. The appellant prayed the court for directions to states which are rewarding and encouraging killing of wild animals. Mohanty reiterated the protection rendered to animals under the Prevention of Cruelty to Animals Act, 1960 even though they may be declared as vermin under Wildlife Protection Act, 1972, still renders true.

The petitioner sought proactive, constructive and scientific way forward to mitigate human-wildlife conflict instead of encouraging citizens to kill wild animals. Significantly, the apex court had July 10 issued notices to Odisha and 12 other states in another petition as illegal and unconstitutional.

Four deaths were reported from Ganjam district, Odisha's coronavirus hotspot, while Khurda and Cuttack accounted for the remaining fatalities,

Many of the deceased were suffering from diabetes, hypertension and other ailments, the official said. Of the 616 fresh cases, 415 were detected among those in quarantine, while 201 are local-contact infec-

On the other hand, 505 persons recovered from the viral infection Monday, the H&FW department twitted. The recoveries include 248



The DHH keeping the body unattended for 14 hours has left the family fuming. Dillip, son of the deceased, alleged his father died only due to the DHH's negligence. He said the DHH had no answer to his question as to why his father's swab report took so much time to arrive.

Chief District Medical Officer Dr Abhay Kumar Das said, "The swab sample was collected July 8 and sent for test the next day. But the report took time to reach as the testing centre was being sanitised. This was why the post-mortem got delayed.'

TEMPLES' WEALTH

In a landmark judgement on Monday, the Supreme Court (SC) has upturned a verdict of the Kerala High Court and ruled that one of the world's wealthiest shrines, the Sree Padmanabha Swamy Temple in the Thiruvananthapuram, would remain in the hands of the erstwhile Travancore royal family. The High Court (HC) order, on which the appeal went to the SC, had been to hand over the temple governance to the state government.

The wealth of this ancient temple near the coast of the Arabian Sea is estimated to be of the order of more than Rs 140,000 crore (20 billion dollars). The SC ruling apart, feelings are strong that, rather than keeping as much wealth in the temple's vaults, it could be released for public good or used in ways that the society is benefited. The shrine is cited to be the world's richest temple.

Allegations of removal of precious gold and valuables had been raised against the temple managing panel consisting mostly of the royal family members, though the overall wealth of the temple had remained the same. The royal family enjoys a high reputation for integrity though authority over the province had shifted from them to the democratically elected governments since Independence. It is this integrity that possibly weighed in favour of them when the Supreme Court took up the appeal. This simple fact highlights the greatly diminishing trust factor on the government in India, whether at the Centre or the States.

The safety of such huge wealth should be a matter of concern for one and all. The royal family's members in the temple trust change with change of generations. While government officials cannot be trusted with such a large amount of wealth, similarly, the changing generations of the royal family also may not be trustworthy in future. Obviously, this is not a concern limited only to the Sree Padmanabha Swamy Temple. The Lord Venkateswara Temple in Tirupati, run by the Tirumala Tirupati Devasthanams and cited as the second wealthiest temple by virtue also of the huge donations it gets, is another case in point. The earnings of this temple are huge. With the Andhra Pradesh state government playing a major role in the temple's administration through appointment of members to the trust governing panel, there are frequent allegations of massive loot of the temple wealth. Similar allegations have been raised against other rich temples in the country, and the frenzy of loot is believed to be increasing as years pass, matching with the trend in corruption in public life as a whole.

There have been calls for proper use of this wealth which is lying unutilized for the public or the Hindu community, in ways that would benefit the nation. Once this is done, the issue could arise as to why target only Hindu temples. Jain, Christian and Islamic institutions too have huge wealth stocked without any benefit to the nation. There have been submissions that if the stored wealth of 10 top shrines are released, that could help banish poverty from the country. Admittedly, this argument may sound far-fetched and unrealistic.

On the flip side, fears are that this enormous wealth could end up in the hands of unscrupulous men in power structures who will be tasked with the overseeing of such a transfer. No institution in this country is free from corruption today. Even the Judiciary, which held a great aura of uprightness till recently, is now shamed with instances of corrupt practices. Chances are that if the temple vaults are opened and the stocks taken out, much of it could end up in foreign shores or tax havens and the nation will lose them forever

The positive side of such a release of shrine wealth cannot be ignored. These Covid times call for a rethink on the way India manages its wealth and economy. Wealth of religious institutions packed in vaults may be taken out for proper use that would benefit the people, if the safety of its proper use is assured through one or other mechanism. Even temple administrations might respond positively to such a collective urge. But the question is, who will assure whom about honest practices. When the nation is being deprived of knowing how much of the PM-Cares Fund is spent where, it might be impossible to expect honesty from lower rung officials.

■ Suburb

n opposition to the conventional wisdom about the irreversible flight from the inner cities, it was reported not long ago in the Economist that Britain's city centres are booming, not only commercially, but through the willingness of people to move back to them from the suburbs. There is so much of a twentieth-century feel about the suburbs, which have grown hugely alongside rail and road links to city centres, that it is a surprise to discover that the word is first attested as long ago as 1380. The word was a combination of the Latin urbanus, a derivative of urbs, "city", with the prefix sub-, "under, close to". It had a subtly different meaning then, referring to those parts of towns or cities that lay outside the city walls and thus beyond their protection, mainly occupied by the poor and indigent. It survived solely in this meaning for some two hundred years, being joined by its adjective suburban only in the early 1600s, at about the time that the suburbs began to get a bad press among metropolitan writers, who saw them as inferior and debased places of licentious behaviour (a largely deserved reputation to judge from contemporary accounts). With the growth of the railways in the 1840s, and later of the motor car, the chance to move away from crowded, dirty, insanitary and unsafe city centres into suburban villas with space and greenness and particularly a bit of garden became irresistible (greatly encouraged around London and other big cities by railway companies, who knew very well how to generate trade). Among the people who live there, suburbs have undoubtedly been popular, despite their frequent lack of jobs, amenities or access to entertainment. But writers have regularly castigated the repetitive and uninspiring architecture of suburbs, built quickly all from a mould to meet the unceasing need for new homes and summed up by the term suburban sprawl (a favourite hatred of John Betjeman, who once famously exhorted "come friendly bombs, and fall on Slough"). Such writers reject the comfortable narrow-mindedness and lack of vision or opportunity which they feel is so often characteristic of the suburbs, a view summed up in the late nineteenth-century coinage suburbia.

RESEARCH IN A RUSH

here is criticism against the ICMR over its recent diktat to deliver a vaccine for Covid-19 by Independence Day, August 15. The direction is flawed and the ICMR has made itself and India lose respect. That the purpose of this frenzy was political gains rather than technological gain is obvious from the proposed date itself.

Science is in pursuit of truth and technology for human welfare, and it has its rules of probity and procedures. Science is nourished by evidence while the unbiased gathering of evidence is sacrosanct. Politics is in pursuit of several goals with some universally accepted norms in democracies. Politics can make use of science, but there exists the Lakshman-rekha of non-interference. If the line is crossed, scientists must stand their ground and politicians will back off. They will know eventually that this is in the humanity's interest.

Scientific medicine comes in a package of three elements – Public Health, Healthcare and Research – each with its own ethical principles and norms. Medicine believes in and practises science with its demands of ethics and honesty, and can speak truth to the powers that be. Politicians in democracies respect such sentiments even when they do not gel well with their own political or personal agenda.

If we look to our history, from kings and their palace intrigues to the way colonisation looted our wealth and self-respect, and delivered a bureaucracy born to sing in the masters' voice, we can begin to see our weaknesses on demands of duty, character and doing what is right by the people. Activating the 1897 British Epidemic Diseases Act when the pandemic struck this time was not exactly a signal of self-respect and self-reliance, but an admission of 'they knew India better than we' attitude. The Act that Bal Gangadhar Tilak opposed then became the prime weapon of democratic India in 2020!

The Indian Council of Medical Research is an example of the excellent elements of the British legacy. In 1911, the British created

the Indian Research Fund Association (IRFA) to promote medical research through institutions like King Institute in Chennai (Madras) and the Haffkine Institute in Mumbai (Bombay). After independence, IRFA was renamed as the Indian Council of Medical Research. In 2007, the Department of Health Research (DHR) was created under the Ministry of Health and Family Welfare. The secretary to the government in DHR is simultaneously the director-general of ICMR. Has that design, combining a government department with the Indian Council of Medical Research, been good, bad or worse?

When any branch of the Health Ministry needs answers to problems through research, the DHR is there to conduct, commission or encourage and fund the required research – intramural or extramural. Research is integral to scientific medicine, raising the bar constantly on public health and healthcare. As the Ministry does not have a Department of Public Health, a few functions of Public Health are handled by the existing departments, of Health Services and Health Research. Search hard and deep, and we don't see how the executive wings of the government have used DHR and ICMR to solve problems identified by them and raised the bars constantly.

DHR and ICMR on their part

had turned a Nelson's eye on the elephant – the lack of a department of public health and its repercussions on the lack of control over innumerable communicable diseases like cholera, typhoid, chickenpox and hepatitis A. As a medical expert at the NITI Aayog put it, this is like a veritable zoo, to which a new one called Covid-19 is now added.

When the SARS-CoV2 hit India, the ICMR's National Institute of Virology (NIV), Pune, another legacy of colonial times, doubled up for diagnosis, diagnostic reagent-preparation and research. And NIV cultured several isolates of the coronavirus. One of them was supplied to the Bharat Biotech International Ltd in Hyderabad, for the purpose of developing an indigenous vaccine against Covid-19.

We can now see that ICMR has two guiding principles/forces, one as a government department and government-funded institution and the other being the principles of scientific medicine - ethics being sacrosanct. Rudolf Virchow (1821-1902), the physician known as the father of modern-day pathology, once observed that "medicine...as the science of human beings, has the obligation to point out problems and to attempt their theoretical solution; the politician, the practical anthropologist, must find the means for their actual solution." It follows that the

two must work in tandem, demarcating territories. When this doesn't happen, as is the case with the Indian administrative line up, we can see tension between the government's demands and scientific discipline. If the government wants to declare an indigenous vaccine on 15 August, the tension becomes a dilemma.

Does not the government have

high calibre advisers on science, technology, vaccine trials and regulatory requirements, or did the government not want to listen? Vaccine research has both science and uncertainties. The approach of Bharat Biotech, not of the Ministry of Health, is to develop a vaccine candidate out of inactivated (rendered non-infectious) viruses. There is no guarantee that the product will be safe enough for human use or effective enough to protect the vaccinated from the coronavirus disease. Until safety is proven in Clinical Trial Phase 1 and immune response efficacy in Phase 2, the product is not yet a vaccine, but merely a candidate. If both phases are certified successful, Phase 3 can follow. Until protective efficacy against Covid-19 is proven in Phase 3, there is no vaccine for launching, only the hope of a vaccine, a lot of hard work and financial investment.

Wishes are not horses. Patience is required and the government should not be seen to be interfering in the technical processes, by which everyone gets a bad namethe nation, its scientists, the vaccine industry, the health ministry and the government itself - all for some evanescent moment of imagined glory. Of course, it is the right of the government to push. But it is the duty of the scientific community, led in this case by the ICMR, to say why the demand is in violation of its own scientific standards and ethical norms.

e are an examination-obsessed country proven conclusively by the latest guidelines issued by the top higher education regulator, the University Grants Commission. The guidelines say the universities "are required to complete the examinations by the end of September 2020 in offline (pen & paper)/ online/ blended (online + offline) mode following the prescribed protocols/ guidelines related to Covid-19 pandemic."

It took several weeks of deliberations by UGC to come up with the directive, which also modified its guidelines issued in last week of April. UGC goes on to say that "Academic evaluation of students is a very important milestone in any education system. The performance in examinations gives confidence and satisfaction to the students and is a reflection of the competence, performance, and credibility that is necessary for global acceptability." Unfortunately, the socalled competence, performance, and credibility are much more dependent on the overall system and educational framework than just the final semester examination of a multi-year degree programme!

Coming as it does in the face of

UGC guidelines supported by the Ministry of HRD have plunged millions of students into despair and confusion. The annual ritual of examinations is an unchangeable fixture in the Indian education calendar even as the world has moved on from this relic of the past. Centralised board exams have very little value in a technology-driven world where certificates, grades, and ranks matter very little. After Independence when Dr. Sarvepalli Radhakrishnan chaired the first University Education Commission till the release of the latest draft New Education Policy 2019, examination has been a major target for reform. Dr. Radhakrishnan said, "If we are to suggest one single reform in University Education, it should be that of examinations."

The subsequent committees have all emphasised on examination reforms. The new draft education policy emphasises on making examinations more adaptive, flexible, and focused on core concepts rather than memorisation. Our education system has lagged in adapting itself to global best practices though many committees and commissions discussed the matter for years. The scourge of coaching

Now, states like Maharashtra, Delhi and Punjab have declared their intention to circumvent UGC guidelines. Lakhs of students on social media are appealing for the same to be done nationally. Yet, the vice-chairperson of UGC goes on TV to say examination can be held as per UGC guidelines since the country is able to open and run even liquor shops, and as internet is available even at panchayat level!

Already, all examinations other than the terminal examination of final-year students have been scrapped with an alternative assessment process being used to promote students. The same can be done for final year students. Instead, many universities including Delhi University have twice announced dates for final examinations only to defer the same later. Most developed countries have long moved away from centralised terminal examinations at university level. In India, we have adopted a semester system after much dilly-dallying. Conducting common semester examinations across the university

ated by a third party is an anachronism. When IITs, IIMs, NISERs, AIIMS, and Central Universities are excelling with the more-sensible fully internal assessment by the professor who teaches the course, why are we unable to adopt it across the board? Even a top university like Delhi University is unable to trust its faculty to be capable and diligent in assessing their students.

The 2019 draft education policy recommends: "All assessment systems shall be decided by the Higher Education Institutions, including those that lead to final certification. The Choice-Based Credit System of the current UGC will be revised and improved, in order to make clear the basic vision while leaving plenty of room for innovation and flexibility. HEIs should also move away from high-stakes examinations towards more continuous and comprehensive evaluation." If only UGC had read what is being proposed by its parent body, the HRD Ministry, it wouldn't have come up with such obscurantist guidelines!

Punjab bans all public gatherings

Monday, Mohali reported 31 new coronavirus cases and Patiala 59 which is the dist's highest single-day spike

Chandigarh, July 13: Stepping up its fight against Covid-19, the Punjab government Monday imposed a complete ban on all public gatherings, while restricting social gatherings to five and marriages and other social functions to 30 instead of the current 50.

These were among the revised guidelines issued in line with the announcement made by Chief Minister Amarinder Singh.

Mandatory first information reports (FIRs) shall be filed against those found violating the curbs on public gatherings, which now stand strictly disallowed.

A detailed notification issued by the government says joint teams of police and civil administration shall strictly enforce the restrictions on social gatherings (restricted to 5 under section 144 imposed in all districts) as well as weddings and social functions.

The management of marriage halls and hotels would be held responsible and would face suspension of licence in case of violation

Further, the management of marriage halls, hotels and other commercial spaces will have to certify that adequate arrangements for ventilation of indoor spaces have

The state government has also partnered with IIT-Madras experts to intensify surveillance, using technology in order to identify super-spreader gatherings that in the past that have resulted in spread, to guide future action.

Srinagar, July 13: Jammu and Kashmir National Conference (NC) president and Srinagar MP Farooq Abdullah and his son and party vice president Omar Abdullah Monday filed a habeas corpus petition in the high court challenging the 'unconstitutional and illegal' house detention of 16 NC leaders and functionaries.

As per the statement issued from the party headquarters, Farooq Abdullah has filed a petition for the release of Ali Mohammad Sagar, Abdul Rahim Rather, Nasir Aslam Wani, Aga Syed Mehmood, Mohammad Khalil Bandh, Irfan Shah and Sahmeema Firdous from house detention, while Omar Abdullah has challenged the detention of Mohammad Shafi Uri, Aga Syed Ruhullah Mehdi. Chaudhary Mohammad Ramzaan, Mubarak Gul, Bashir Veeri, Abdul Majeed Larmi, Basharat Bukhari, Saifudin Bhat Shutru and



counsel advocate Shariq Reyaz.

Dar said the decision to move to the court has been taken as a last resort to provide relief to various party members who have continuously been under house arrest or have been kept under house detention after being shifted from

detention centers. "Shifting of the detainees from detention centers to their homes only characterised revolving-door detention practice. Quashing of the PSA on party General Secretary Ali Muhammad Sagar underscored the indefensible nature of all detentions in the court of law, leading us to believe that the admin-

tainees in the absence of any con-Party spokesperson Imran Nabi vincing reason.'

"Unfortunately that was not to be. The house detentions without any administrative orders are unlawful, undermining the due respect to human rights and individual liberty," he added. "We are hopeful that the court will

come to the rescue of our colleagues, who have been suffering for no fault of theirs ever since the abrogation of Article 370 and Article 35-A on August 5, 2019. This was the only recourse left to us. We are hopeful that the court will uphold the civil liberties of our colleagues, most of whom have not been keeping well," Dar said.

For the first time in the history of Jammu and Kashmir, no official function was held to commemorate Martyrs' Day observed July 13 every year in memory of those killed in firing by soldiers of Dogra ruler Maharaja Hari Singh in 1931

Kashmir, and Ladakh did not observe 'Martyrs' Day' as an official state holiday Monday, for the first time since 1948, even as political groups in the Valley paid tributes to the '13 July martyrs'.

The erstwhile state of J&K observes 'Martyrs' Day' July 13 as a state holiday to mark a 1931-protest against the rule of Maharaja Hari Singh in the then princely state. On that day, 22 Kashmiri men and women were shot dead as they gathered outside the Srinagar central jail to protest against the arrest and subsequent trial of Abdul Qadeer Gazi, who was seen as a crusader

against Singh's Dogra regime. The people of Kashmir started ob-



Martyrs' Day from 1932 onothers to rise against the ward. After then despotic and J&K acceded to autocratic regime India in 1947, the OMAR ABDULLAH I day was incorporated in the official list of holidays.

Usually, July 13 would see important government functionaries, including the Governor, Chief Ministers, cabinet ministers, heads of various political parties and even separatist groups, visit the martyrs' graveyard or Mazaar-e-Shuhada to pay homage.

However, this was undone last year when the newly-created union territories of J&K and Ladakh re-

National Conference (NC) vicepresident and former J&K chief minister Omar Abdullah said July 13 marks "the collective defiance of the oppressed against oppressors.'

Peoples Conference senior vicepresident and former minister Abdul Gani Vakil drew a parallel between the 1931 situation and the present day.





LT COL MOVES HC AGAINST ARMY'S DECISION TO BAN USE OF SOCIAL MEDIA PLATFORMS

THE PETITION, LIKELY TO COME UP FOR HEARING TUESDAY, SOUGHT THE COURT'S DIRECTION TO THE DIRECTOR-GENERAL OF MILITARY INTELLIGENCE TO WITHDRAW ITS JUNE 6 POLICY

New Delhi, July 13: A senior rank officer of the Indian Army Monday approached the Delhi High Court challenging a recent policy banning armed forces officials from using social networking platforms like Facebook and Instagram.

The petition, likely to come up for hearing Tuesday, sought the court's direction to the Director-General of Military Intelligence to withdraw its June 6 policy to the extent that it orders all the members of the Indian Army to delete their accounts from Facebook and Instagram and 87 other applications.

Lieutenant Colonel PK Choudhary, who is currently posted in Jammu and Kashmir, said in the plea that he is an active user of Facebook and uses the platform to connect with his friends and family as most of them are settled abroad, including his elder daughter.

In the petition, filed through advocates Shivank Pratap Singh and Sanandika Pratap Singh, the officer sought direction to the Central government through Ministry of Defence to withdraw its June 6 policy to "ensure that the fundamental rights of armed forces personnel are not abrogated amended or modified by arbitrary executive action which is not backed by the mandate of law, offends the provisions of the Army Act and Rules made thereunder and is unconsti-

The plea said Choudhary got to



know through a July 9 news report about the Army's order requiring him and other personnel to delete Facebook, Instagram and 87 other applications by July 15.

On July 10, he received a letter titled "Policy On Use Of Social Media Platforms And Mobile Phones In IA" issued by the Director General of Military Intelligence, banning the use of 89 applications and websites and directed deletion the accounts, the plea said, adding that as the policy is classified as restricted, he is not reproducing any part of it here.

The plea claimed that the provisions of the policy violate various fundamental rights of the petitioner under the Constitution including the right to freedom of speech and expression and right

It said soldiers serve in remote areas, extreme weather conditions, difficult terrain, with the lingering threat of an enemy attack at all times and the professional hazards are a direct cause of soldiers committing suicides and in some cases shooting at their fellow soldiers before taking their own lives.

"In a majority of cases the precursor to such incidents is denial of leave to the soldier. The soldiers rely on social networking platforms like Facebook to address various issues arising in their families while posted in remote locations and often use the virtual connect to compensate for the physical distance existing between themselves and their families."

"Soldiers can view pictures, videos etc. of events such as weddings, birthdays and other events of cultural significance in real time or even at a later date as per their convenience and need. This is the beauty of social network platforms like Facebook. Therefore, the respondents (authorities) must wake up to the benefits that these websites/applications enable the use of these websites and applications for soldiers and put in place a mechanism to ensure its misuse," the petition said.

It alleged that the policy which

bans social media platforms is "illegal, arbitrary, disproportionate, violates the fundamental rights of soldiers including but not limited to the freedom of speech and expression, the right to life and the right to privacy

It said the authorities have cited security concerns and risk of data breach as the basis of imposing the restrictions contained in the policy regarding usage of social media platforms but the act of banning it is a clear violation of Article 14 (Equality before law) of the Constitution.

"It is submitted that no other professional army serving in a Constitutional democracy has put such unreasonable and mindless restrictions on its soldiers. The respondent no.2 has conveniently shifted its own burden and responsibility to regulate use of social networking platforms onto the soldiers, assuming that it has unfettered power to abrogate and restrict the fundamental rights of soldiers."

"It is noteworthy that the policy has an entire section dedicated to measures such as sensitisation and training of personnel to avoid breach of security and data. This gives rise to a glaring absurdity," the plea said.

It also sought to declare that the Director General of Military Intelligence is not empowered under the Constitution or under any other law to modify, amend or abrogate the fundamental rights of the petitioner and other members of the armed forces.

Assam flood situation worsens; 42 dead

Guwahati, July 13: The flood situation in Assam worsened after four straight days of heavy rainfall. 42 people have died in flood-related incidents and 13 lakh affected. A severe flood warning has been issued in Assam and neighbouring Arunachal Pradesh after water levels of the Brahmaputra River crossed the danger mark. Heavy rainfall is likely till July 16, the India Meteorological Department (IMD), has said in its latest bulletin.

The Brahmaputra is flowing above the danger level at Guwahati, Dibrugarh, Dhubri, Goalpara, Jorhat and Sonitpur districts.

The state disaster management body said, extensive floods have been reported in Dhemaji, Lakhimpur, Biswanath, Sonitpur, Udalguri, Darrang, Baksa, Nalbari, Barpeta, Chirang, Bongaigaon, Kokrajhar, Dhubri, Goalpara, Kamrup, Morigaon, Nagaon, West Karbi Anglong, Golaghat, Jorhat, Majuli,

Dibrugarh and Tinsukia districts. Over 2,000 villages in 24 districts of the state have been inundated. Dhemaji in upper Assam and Barpeta in lower Assam are the worst-hit. In Arunachal Pradesh, low-lying areas of Pasighat and Namsai are under water. Over 70 per cent of the Kaziranga Nationak Park is also flooded. According to the wild life department, 41 animals have been killed, while 49 were rescued in Kaziranga.

There are reports of deaths due to landslide in Sonapur area, the Assam State Disaster Management Authority said. So far, since the rainy season started, floods and landslides have killed 70 people, according to the Assam government.

The state government has set up 224 relief camps across 16 districts, where over 21,000 people have currently been put up.

Travancore Royal family to manage Sree Padmanabhaswamy temple's treasure

THE SUPREME COURT MONDAY UPHELD THE RIGHTS OF THE TRAVANCORE ROYAL FAMILY IN THE ADMINISTRATION OF HISTORIC SREE PADMANABHASWAMY TEMPLE IN KERALA

Monday upheld the rights of the Travancore roval family in the administration of historic Sree Padmanabhaswamy Temple in Kerala, considered to be one of the richest temples in the country.

It set aside the Kerala High Court's 2011 verdict which had directed the state government to set up a trust to take control of management and assets of the temple. A bench headed by Justice UU Lalit said that as an interim measure, the District Judge of Thiruvananthapuram will head an administrative committee to manage the temple's affairs. The top court delivered the ver-

dict on a batch of appeals, including the one filed by legal representatives of the Travancore royal family, challenging the January 31, 2011 verdict of the high court.

The sprawling temple, an architectural splendour in granite, was rebuilt in its present form in the 18th century by the Travancore Royal House which had ruled southern


While pronouncing the judgement, the apex court held that the death of earlier ruler of Travancore royal family does not affect the right of 'Shebaitship' (the right to manage the deity and the temple as a priest) of Marthanda Varma, the brother of last ruler of the royal family, and his legal heirs. The top court said that death of the

last ruler of royal family does not entitle the state government to take over the management of committee as law of escheat does not apply in this case and the management of the temple continues to vest in trust of the ruler of Travancore.

While making an interim arrangement to manage the affairs of the temple, the apex court said that it will remain in force till a fresh committee is set up and all the members of the committee must be Hindus.

The controversy over the administration and management of the

historic temple was pending in the apex court for last nine years in the wake of charges of alleged financial irregularities.

Even after India's independence, the temple continued to be governed by a trust controlled by the erstwhile royal family for whom Lord Padmanabha (Vishnu) is their family deity. The top court had April 10 last year reserved its judgement on the appeals against the high

court's verdict. The high court had directed the state government to take steps to set up a body or a trust to take control of the temple, its assets and management and to run the temple in accordance with the traditions.

It had May 2, 2011 stayed the high court's direction regarding taking over of the assets and management of the temple.

The top court had also directed that there shall be a detailed inventory of the articles, valuables, ornaments in Kallaras (vaults) On July 8, 2011, the apex court had said that "opening of kallara 'B' is to be kept in abeyance till further orders"

In July 2017, the apex court had

said it would examine the claims that one of the vaults the temple contained extraordinary treasure with "mystical" energy. It had passed a slew of directions including on the security of the treasures, auditing of accounts and repair of the deity

The top court was in July 2017 told by senior advocate Gopal Subramanium, who is assisting the court as amicus curiae in the matter, that 'Kallara' (vault) B of the temple should be opened as it was closed "on the apprehension that there is some mystical energy".

North Dinajpur district Trinamool Congress leader Amal Acharya dubbed it as a 'sad incident'. "I came to know about it this morning. I am deeply saddened. He was a good man. CBSE Class 12 results: Girls outshine boys

New Delhi, July 13: Girls outshone boys by nearly 6 percentage points in CBSE Class 12 examination results declared Monday based on an alternative assessment system adapted after some tests had to be cancelled due to the COVID-19 pandemic.

The Central Board of Secondary Education has decided against releasing the merit list and replaced the term "fail" with "essential repeat" because of the exceptional circumstances. Accordingly, the term "fail" will not figure in the result documents. The pass percentage of girls was 92.15 and that of boys was 86.19. Transgender candidates recorded a pass percentage of 66.67.

The overall pass percentage increased by 5.38 points this year. While 83.40 per cent students cleared the exam last year, 88.78 per cent students cleared it this year. More than 38,000 students secured marks above 95 per cent and over 1.57 lakh scored above 90 per cent. A total of 11.92 lakh candidates appeared for the examination.

The Trivandrum region recorded the highest pass percentage of 97.67 while the Patna region recorded the lowest at 74.57. Delhi recorded 94.39 pass percentage. Also, the government-run Jawahar Navodaya Vidyalaya group recorded the highest pass percentage of 98.70. Private schools recorded a pass percentage of 88.22. The results of 400 students, however, could not be com-

puted as per the alternative scheme and will be announced later, a senior board official said. Students had a tough time accessing the board website which crashed within minutes of announcement of the results and was not accessible even hours later. The board officials advised students to reach out to their respective schools to learn about their results in the meantime.

The board announced the results on the basis of an alternative assessment scheme after the pending exams were cancelled due to a spike in COVID-19 cases in late March. According to the fourpointer scheme, marks have been awarded on the basis of marks scored by a student in his or her best performing subjects.

According to the assessment scheme, students were divided into four categories. The first had students who sat in tests for all their subjects; their results have been declared on the basis of their performance in all the papers.

Students in the second category had appeared for more than three subjects. They have been awarded marks for subjects they did not appear for based on the average of the marks obtained by them in the three best performing subjects.

The board identified a third category of students who appeared in only three subjects. For them, the average of marks obtained in the two best performing subjects has been awarded in the subjects whose examinations were not conducted.

Girl found dead in school

New Delhi, July 13: A 14-year-old girl was found dead at a boarding school in UP's Noida. Her family has alleged that she was raped, killed and the body cremated without their consent by the institute management, police said Monday.

The incident allegedly took place July 3 in the school in Sector 115 and came to light Sunday after an uproar on social media, demanding justice for the girl's family, police said.

No case has been registered as there has been no formal complaint yet at the local Sector 49 police station, even as senior officials assured investigation into the incident if the family approached them with any evidence supporting their claim.

However, the family, based in Mahendragarh district of Haryana, has written to their Chief Minister Manohar Lal Khattar, seeking legal action against senior officials of the Noida school.

The Class 10 student's mother has urged people to support them

The family has claimed that their three children studied in the school. Two girls on the same campus in Sector 115 of Noida, while a boy in another branch run by the school. The children had returned home due to the COVID-induced lockdown and went back to their schools on June 18.

On July 3, the girl's parents got a call from the school, asking them to immediately reach there because it had "something" to do with their eldest child.

The girl's mother said when she and her husband reached the school, their phones were forcibly taken away by institute officials and they were shown the body of their daughter.

The mother alleged the school forcibly got them to sign some papers regarding the cremation

TELANGANA DOC SETS AN EXAMPLE

Hyderabad, July 13: At a time when one comes across news reports and visuals of inhuman disposal of bodies of COVID-19 patients, a doctor in Telangana has set an example for others by driving a tractor to shift a coron-

avirus victim's body for burial. Dr Sriram of government-run hospital in Peddapalli came forward to drive the tractor to shift the body from the hospital on Sunday since the driver of a Peddapalli Municipality's vehicle did not report for duty for some reason.

Dr Sriram offered to drive the tractor since the shifting of the body was getting delayed, much to the relief of the victim's family. Wearing a Personal Protection Equipment kit, the doctor later ferried the body for disposal, earn-



ing praise from one and all.

The victim had died at the district hospital at Peddapalli Sunday. Area people said the doctor was not only performing his duties diligently on the frontline despite all the risks involved but also going out of the way to help the patients and families.

Telangana Finance Minister T. Harish Rao tweeted his praise: "Dr Sriram garu. Heartfelt wishes. You have proved the humanity is still alive. You are an inspiration to all those who are fighting this battle against corona.

Mumbai, July 13: In a significant landmark, the BrihanMumbai Municipal Corporation (BMC) has achieved a doubling-rate of 50 days for Covid-19 cases, a top official said here Monday.

This was possible because of the civic body's 'open testing policy', implying tests without prescriptions, making it the only city in the country to implement it. 'After the open testing policy, our testing has gone up from 4,000 to 6.800, daily. But the total positive cases have come down from 1,400 to 1,200 now," BMC Municipal Commissioner I.S. Chahal said.

Of these 1,200 positive cases, the symptomatic cases are less than 200, so the BMC needs only 200 beds daily, the civic chief said. Even the BMC's discharge rate now stands at 70 percent, and on Sunday, after allotting beds to all patients, there were still 7,000 Covid beds plus 250 ICU beds lying vacant, said Chahal.


For this achievement, Chahal gave the credit to the entire 'Team BMC' where - despite losing a little over 100 officials to the virus civic officials and other Corona warriors are engaged 24x7 in controlling the pandemic for over four months.

Since the first case was detected in Mumbai on March 11 (after the state's first infectees in Pune on March 9) and the state's first death notched in Mumbai on March 17, the current Maharashtra Covid-19 tally stands at 2,54,427 cases and fatalities at 10,289, while Mumbaihas recorded 92,988 cases with a death toll of 5,288.

New Delhi, July 13: After the Galwan Vallev skirmish followed by the economic boycott of Chinese products by India, toys, rakhis and other decorative goods from China may not be sold in the market this festive season.

Indian businessmen have stopped placing orders for toys and decorative lights from China. Rakhi manufacturer and wholesaler in Delhi's Sadar Bazar Magan Jain said the decorative items used in rakhis were no longer being imported from China, so the Chinese accessories will not attract customers on Raksha Bandhan this year.

He said that any businessman having Chinese goods in stock may use them to make rakhis, but this



time around the customers are interested in indigenous rakhis.

The rakhis from Delhi's Sadar Bazar are sold all over the country, but with less than a month left for this year's Raksha Bandhan, the market is not decorated with bright rakhis as it used to be in

previous years. Raksha Bandhan will be celebrated on August 3 this vear. Jain said the rakhi business is sluggish this time due to the ongoing corona pandemic.

Toy Association of India president Ajay Aggarwal said that the retail toy business in the country is worth around ₹18,000- ₹20,000 crore, of which around 75 per cent was met with imports from China.

Traders say the toy quality control order issued by the Indian government in February this year, which will be effective from September 1, will deter businessmen from importing Chinese goods.

According to a February 25, 2020 order by the Department of Promotion of Industry and Internal Trade, Ministry of Commerce and Industry, the display of the ISI mark on toys will be mandatory. This

rule will be applicable to both imported and domestic products.

Aggarwal said that the order would enable Indian traders to have a level-playing field. Manu Gupta, managing director of Playgrow Toys Group, said the growing toy business in the country will provide employment to artisans, especially

Gupta said that stopping the import of toys from China would boost the domestic toy industry in the long run, contributing to the 'Make in India' and 'Self-Reliant India' campaign. In the short-term, it is possible that small retail traders may go out of business because 80 per cent of the toys come from China. Ajay Aggarwal said India imports tovs from Thailand, Malaysia and other countries also, but they are imported in bulk from China.

Beijing, July 13: China Monday imposed visa restrictions on some top US officials and politicians in the latest tit-for-tat response to America's move to sanction several Chinese officials for alleged human rights abuses targeting ethnic minority groups in the Muslimmajority Xinjiang province.

Foreign Ministry spokesperson Hua Chunying told the media here that the behaviour of the US officials and politicians, and visa ban on some Chinese officials from Uyghur Muslim dominated Xinjiang province "severely damaged China-US relations," and should be condemned. Hua made the comments in response to US sanctions and visa restrictions on three senior officials of the ruling Chinese Communist Party from Xinjiang for alleged human rights abuses targeting Muslim Uyghurs.

China has decided to impose sanctions starting from Monday against US Congressional-Executive Commission on China (CECC), US Ambassador at Large for International Religious Freedom Samuel Brownback, Congressman Chris Smit and US Senators Marco Rubio and Ted Cruz. The CECC is headed by Rubio, a vocal critic of China.

Announcing the ban on US officials, Hua reiterated "Xinjiang is entirely the internal affair of China, and the US has no right to interfere. The Chinese government's determination to protect its sovereignty, and crackdown against terrorism, separatism and extreme religious forces is unshakeable.'

Hua said China would take further measures based on the situation. This is the first-time China has banned top US politicians in its retaliation to US sanctions and visa bans on Chinese officials from Xinjiang. Tibet and over the new national security law in Hong Kong.

Beijing's move comes days after the US on Thursday slapped sanctions on some Chinese officials in-charge of Xinjiang Uygur autonomous region who were "believed to be responsible for, or complicit in, the unjust detention or abuse of Uygurs, ethnic Kazakhs and members of other minority groups in Xinjiang".

The three officials banned by the US are Chen Quanguo, CCP Party Secretary of the Xinjiang Uyghur Autonomous Region; Zhu Hailun, Party Secretary of the Xinjiang Political and Legal Committee; and Wang Mingshan, the current Party Secretary of the Xinjiang Public Security Bureau.

China has been saying it would retaliate with similar bans on US officials with "egregious behaviours". Secretary of State Mike Pompeo while announcing sanctions on Chinese officials in Xinjiang on Thursday said "the United States is taking action against the horrific and systematic abuses in Xinjiang and calls on all nations who share our concerns about the CCP's attacks on human rights and fundamental freedoms to join us in condemning this behaviour".

In recent years, China has faced severe criticism from western countries over persistent reports of mass detention of Uighurs and other minorities in Xinjiang.

Islamabad, Jul 13: Pakistan said Monday that it will restore Afghanistan's exports through the Wagah border with India from Wednesday at the special request of Kabul and to faciliate Afghan Transit Trade.

57 injured in fire aboard ship at Naval Base

San Diego (US), July 13: Firefighters were still battling a blaze Monday on a Navy combat ship that injured at least 57 people and sent smoke billowing over San Diego.

The fire began Sunday morning aboard the USS Bonhomme Richard, apparently in a vehicle storage area as the ship was in a berth undergoing maintenance, according to Rear Adm. Philip Sobeck.

Initially, 17 sailors and four civilians were reported injured but by early Monday the number had grown to 57 and five remained hospitalized for observation, the Navy said.

Firefighters attacked the flames inside the ship while firefighting vessels with water cannons directed streams of seawater into the ship and helicopters made water drops. "Sailors across this waterfront are absolutely doing a magnificent job," Sobeck said at a press conference Sunday.

About 160 sailors and officers were on board when an explosion and flames sent up a huge plume of dark smoke from the 840-foot (255metre) amphibious assault vessel. which has been docked at Naval Base San Diego.

That is the message Israel's Nature and Parks Authority is spreading on social media to try to help people overcome the sense of detachment that coronavirus social-distancing rules can bring. "In this unpleasant corona pe-

riod we recommend to people around the world to go out to nature, take a deep breath, hug a tree, express your love and get love," Orit Steinfeld, the authority's marketing director, said in Apollonia National Park.

At the park, about 15 km (nine miles) north of Tel Aviv, tree-huggers such as Barbara Grant heeded the advice during a tour arranged by the Authority.

'The most basic human need is



for connection, for touching, for hugging," she said, lamenting that, as a health precaution, she can't hug her grandchildren. Also out in the park, Moshe Hazan said he wanted to widen his embrace beyond his partner, Pat Arthur, who accompanied him to the forest.

'We are not hugging too many people these days - not our children, not our grandchildren - and hugging a tree is quite a nice thing to do," Hazan said. After flattening a coronavirus infection curve in May, Israel has experienced a spike in new cases over the past

several weeks. Protective masks are mandatory outdoors and Israelis are advised to avoid close physical contact with elderly relatives, with visits at nursing homes held only in the open air. Israel's tree-hugging campaign follows a similar endeavour launched in April by Iceland's forestry service.

Singapore, July 13: Singapore has deported 10 Indian nationals, including students, and barred them from re-entering the country for violating the "circuit breaker" rules enforced to curb the spread of the coronavirus, officials announced Monday, warning that the government would not hesitate to take "strong action" against those bla-

tantly disregarding the laws. The "circuit breaker" period in Singapore began April 7 as part of which all non-essential work places were closed and residents were barred from leaving their houses except to buy food and groceries or to exercise alone in the neighbourhood. The period ended June 2. Singapore is currently in the Phase-2 of its reopening -- starting from June 19 -- with the gradual resumption of operations by more businesses. The 10 Indians, holding student or work passes, were caught having a social gath-

the Singapore Police Force (SPF) and the Immigration and Checkpoints Authority (ICA) said in a joint press release. 

New Delhi, July 13: The DPIIT would soon approach the Union Cabinet to seek approval for relaxing norms to allow up to 74% foreign direct investment (FDI) in defence manufacturing under the automatic route, with a view to attract overseas players in the sector, sources said.

They said the Department for Promotion of Industry and Internal Trade (DPIIT) has discussed the matter with the defence ministry.

The decision to permit up to 74% FDI in the defence manufacturing through the automatic route was announced by Finance Minister Nirmala Sitharaman in May while announcing the fourth tranche of the ₹20 lakh crore stimulus package for the coronavirushit economy.

As per the current FDI policy, 100% overseas investments are permitted in the defence industry - 49% under the automatic route, while beyond that the government approval is required.

In July 2018, the government had relaxed foreign direct investment norms in the defence sector by allowing up to 49 per cent FDI under the automatic route. The move was aimed at boosting domestic industry as India imports about 70 per cent of its military hardware.

nCoV leads to \$1tn global corporate debt in 2020: Survey

London, July 13: Companies around the world will take on as much as \$1 trillion of new debt in 2020, as they try to shore up their finances against the coronavirus, a new study of 900 top firms has estimated.

The unprecedented increase will see total global corporate debt jump by 12% to around \$9.3 trillion, adding to years of accumulation that has left the world's most indebted firms owing as much as many mediumsized countries.

Last year also saw a sharp 8% rise, driven by mergers and acquisitions, and by firms borrowing to fund share buybacks and dividends. But as the virus saps profits.

"COVID has changed everything," said Seth Meyer, a portfolio manager at Janus Henderson, the firm that compiled the analysis for a new corporate debt index. "Now it is about conserving capital and building a fortified balance sheet".

Companies tapped bond markets for \$384 billion between January and May, and Meyer estimates that recent weeks have set a new record for debt issuance from riskier "high yield" firms with lower credit ratings.

Lending markets had slammed shut for all but the most trusted firms in March, but have been opened up wide again by emergency corporate debt buying pro-

Geneva, July 13: Manchester City successfully overturned their twoyear ban from the Champions League Monday in a surprising legal victory.

The Court of Arbitration for Sport (CAS) upheld City's appeal against the UEFA ban, but imposed a 10 million euro (USD 11.3 million) fine on the club for failing to cooperate with independent investigators.

Some UEFA allegations accusing City of breaking finance rules dating back several years were 'time-barred', the court said. CAS plans to publish a detailed written verdict within days.

The decision by the three judges clears the team coached by Pep Guardiola to play in the group stage of the Champions League next season. The case does not affect City's place in this season's competition, which resumes next month.

City's win guarantees tens of millions of dollars in UEFA prize money next season. It also protects against players leaving to seek Champions League action with another club.

Guardiola had pledged to stay in Manchester 'no matter what happens' in the courts. "The club welcomes the implications of today's ruling as a validation of the club's position and the body of evidence that it was able to present," City said in a statement.

UEFA punished Man City in February for "serious breaches" of finance monitoring rules and failing to cooperate with investigators. The allegations included that City, owned by Abu Dhabi's royal family, misled UEFA over several years to meet financial integrity rules — known as Financial Fair Play — required to enter European club competitions.

City denied wrongdoing, and said it had "irrefutable evidence" the claims were not true. "The CAS award emphasized that most of the alleged breaches reported by the Adjudicatory Chamber of the (UEFA club finance panel) were either not established or

time-barred," the court said. City's win will raise doubts about

the future of the UEFAs Financial Fair Play program, created in 2009. Man City joins Paris Saint-Germain and AC Milan in defeating UEFA at CAS in the past two years.

The urgent ruling came one month after a three-day hearing held by video link between Switzerland and England. A full verdict detailing the evidence, expert witness testimony and the judges' reasons is unlikely to be published for at least several weeks.

UEFA-appointed investigators opened a case after leaked club emails and documents from City officials were published by German magazine Der Spiegel in November 2018. They were likely obtained by a hacker from Portugal.

The published evidence appeared to show City deceived UEFA by overstating sponsorship deals from 2012-16 and hid the source of revenue linked to state-backed companies in Abu Dhabi.

City never disputed the docu-

ments were authentic, but argued the evidence was stolen and reported out of context.

UEFA had previously signed

off on City's submitted accounts since 2014. That year, UEFA fined City 20 million euros (USD 22.6 million) of its Champions League prize money in a first wave of assessments of European clubs' finances.

UEFA could choose to challenge the CAS ruling at Switzerland's Supreme Court. Federal appeals in CAS cases rarely succeed and only consider narrow grounds of legal procedure.

UEFA decided to create the FFP system 11 years ago, following the global financial crisis, to monitor finances of 200-plus clubs which qualify each year for its competitions

Clubs must approach break-even on commercial income and spending on transfers and salaries. Sponsor deals linked to wealthy owners must be set at fair market rates.

NOV 15, 2019: City failed in their bid to get UEFA investigation kicked out, although CAS arbitrators stated their claim was "not without merit"

FEB 14, 2020: City were banned from UEFA club competitions for the next two seasons and fined 24.9mn pound after being found to have "com-

mitted serious breaches of the UEFA's club licensing and FFP regulations". City announced they would appeal to the Court of Arbitration for Sport.

Tottenham gun down Gunners

London, July 13: Toby Alderweireld's 81st-minute header sealed a 2-1 Premier League victory for Tottenham Hotspur against Arsenal in the first north London derby in their new stadium Sunday.

The match appeared to be heading for a draw after Son Heungmin cancelled out Alexandre Lacazette's opener. However, Alderweireld's header claimed all three points for Spurs to move Jose Mourinho's side above Arsenal into eighth place in the battle for local bragging rights.

With three games left Tottenham have 52 points to Arsenal's 50, but are seven points behind fourthplaced Leicester City.

Victory maintained Mourinho's impressive record in home games against Arsenal—he has now won six and drawn four—and was a rare highlight for Tottenham in a mediocre season.

While both teams occupied similar league positions before kickoff, Mikel Arteta's have looked the more impressive of the two since the Premier League resumed.

After a cagey opening the derby sparked into life with two goals in quick succession — both from the kind of defensive lapses that have been all too common for Spurs and Arsenal. Tottenham's Serge Aurier was guilty of a poor touch and then lost out in a 50-50 tackle with Granit Xhaka with the ball breaking to Lacazette who looked up and smashed a right-foot shot into the top corner.

The Gunners were not able to enjoy their lead though as they gifted Tottenham their equaliser. Sead Kolasinac's sloppy pass wrongfooted team mate David Luiz and Son was alive to the chance, going through to dink a cool finish over goalkeeper Emiliano Martinez.

Tottenham leftback Ben Davies almost outdid Lacazette with a thumping drive from 30 metres that struck the bar while at the other end Nicolas Pepe curled wide and Pierre-Emerick Aubameyang fired a free kick just past the post.

Arsenal were brighter in the early stages of the second half and Aubameyang fired against the woodwork on the hour after being played in by Lacazette.

Tottenham were re-energised after the second-half drinks break, though, with Harry Kane bursting into the area and setting up Son who delayed his shot too long. The winner was as simple as it gets – Son swung in a corner and Alderweireld rose highest to glance home.

Kane, who was mainly a subdued figure, then almost extended Tottenham's lead late on but was denied by Martinez.

FOXES OUTFOXED

Bournemouth: Dominic Solanke scored twice as Bournemouth's bid for Premier League survival was boosted by a 4-1 victory over **Champions League-chasing** Leicester, who were reduced to 10 men. They were the striker's first goals since joining from Liverpool in January 2019 after failing to score in his 38 previous league appearances. Jamie Vardy put the Foxes ahead in the 23rd minute and kept it intact until the break. Junior Stanislas equalized from the penalty spot in the 66th minute before Solanke put the hosts in front. Leicester defender Caglar Soyuncu was shown a straight red card in the aftermath for kicking out at Wilson as he attempted to retrieve the ball. An own goal by Jonny Evans helped the home team have a two-goal advantage, before Solanke wrapped up the game three minutes from time

HAMILTON CLAIMS STYRIAN GR

Spielberg (Austria), July 13: Sixtime World Champion Lewis Hamilton dominated the Styrian Grand Prix in a Mercedes one-two Sunday to celebrate his 85th Formula One (F1) win and move a step closer

to Michael Schumacher's record of 91 victories.

His Finnish teammate Valtteri Bottas, winner of last weekend's season-opener that was also held without spectators at Austria's Red Bull Ring, finished 13.719 seconds behind with his championship lead cut to six points. Red Bull's Max Verstappen completed the podium, more than half a minute behind Hamilton, on a sunny afternoon at his team's home track.

Hamilton's victory, something of a cruise past the empty grandstands, was his first since Abu Dhabi in November and extended his record run of successive points finishes to 35 races.

"What a weird year it is, but it's great to be back up here, to be driving with this kind of performance," said Hamilton, who started from his 89th pole position after a sensational lap in a rain-drenched qualifying and remained in complete control.

"I'm so grateful to be back in first place. It feels like a long time coming since the last race last year, and to come back in after a difficult weekend last week is a great, great step forwards."

Sunday's race was the first time a circuit has hosted two back-to-back rounds in the same championship year, with the original calendar ripped up and rewritten due to the COVID-19 pandemic.

Ferrari, far from Schumacher's glory years at the turn of the century, provided one of the major talking points with Charles Leclerc and Sebastian Vettel colliding on the opening lap and retiring from the race. It was the second time in four races that the pair had clashed.

Hamilton, who wore a Black Lives Matter T-shirt on the starting grid before the anthem of the Austrian state of Styria, again took a knee with other drivers as part of an anti-racism campaign.

Bottas, who started fourth and now has 43 points to Hamilton's 37, said his afternoon had been about damage limitation.

Verstappen had started on the front row but was passed by Bottas in the closing stages after fighting hard to keep position.

It was less so behind him, with

Red Bull's Alex Albon finishing fourth and Lando Norris fifth, a result that moved the 20-year-old McLaren driver up to third in the standings.

Norris, third last week for his first F1 podium, overtook both

Racing Point drivers on the final lap.

Mexican Sergio Perez was sixth for Racing Point, after damaging his front wing in a clash with Albon, and ahead of Canadian team mate Lance Stroll. Australian Daniel Ricciardo was eighth for Renault.

Spaniard Carlos Sainz completed McLaren's double points finish in

McLaren's double points finish in ninth, and collected a bonus point for fastest lap, and Russian Daniil Kvyat picked up the final point for AlphaTauri.

Apart from the Ferrari duo, Renault's Esteban Ocon was the only non-finisher. The Frenchman was retired by the team as a precaution due to a suspected cooling problem. In last weekend's opener, only 11 cars finished.
