Bhubaneswar, August 10: With the revenue collection of the state having plunged drastically due to Covid-19 pandemic, the government is eagerly awaiting ₹4,200 core compensations from the Centre under the Goods and Services Tax (GST)

The Centre is supposed to compensate states for their loss of revenue after implementation of the GST Act. Under the law, if the states' GST revenues do not grow by at least 14 per cent over the base year (2014-15), the Centre will pay them the difference amount on a bimonthly basis for the first five years from the implementation of

the GST Act. The state government has estimated a compensation of ₹3,647 crore for the first fourth months of the current financial year 2020-21. The dues for the first two months were ₹2.443 crore that increased to ₹3,674 crore by the end of July. However, the Center has not released a single pie as GST compensation for 2020-21 fiscal, official sources said.

Apart from ₹3,674 crore pending as on date for this year, the Centre is yet to clear dues of previous financial years. The ministry of finance has not cleared about ₹230 crore for the financial year 2019-20 and ₹450 crore for the year 2018-19, the source said. The total dues pending with the Centre

# Lockdown blues push auto driver to kill self

Berhampur, August 10: Increasing financial crunch due to the coronavirus-induced lockdown reportedly drove a man to commit suicide at Berhampur. The Government Railway Police (GRP) recovered his body from the rail lines here late Sunday night.

The deceased was identified as Uttam

Sahu, 24, son of Lokanath Sahu, of Dasagharia Sahi in Gosaninuagaon. He was an auto-rickshaw driver. Repeated shutdowns brought him immense miseries as he failed to get passengers.

His body was recovered from the rail lines behind the Saraswati Sishu Mandir in Gosaninuagaon. Preliminary inquiries suggested that Sahu might committed suicide after losing his livelihood due to the Covid-induced lockdown.

The body of the deceased was identified by his brother Amulya Sahu, GRP IIC Jyoti Prakash Nayak said Monday Police registered a case and handed over the

body to his kin after a post-mortem, he said.

Police said Sahu earned his living by working as an auto-rickshaw driver. However, he lost his livelihood after the gov-

ernment imposed repeated lockdowns and shutdowns in the state in view of the pandemic. Ganjam is a Covid hotspot in the state

and due to its increasing caseloads, the administration has doubled down on restrictions. This must have in-

creased the distress of Sahu as he always worried over alternative means to earn a living but in vain. The pandemic and the subsequent lockdowns enforced by the government has dried up local income opportunities

for people. Influx of a large number of migrants to state compounded the situations in Ganiam.

He was last seen at his home in the afternoon when he had his lunch and left home. Family members grew apprehensive after he failed to return by 10 pm. They searched for him in nearby locations but to no avail. Later, they learnt about his death from the GRP.

Patanjali mulls bid for IPL title sponsorship

New Delhi, August 10: Baba Ramdev's Patanjali Ayurved is considering to bid for the title sponsorship of the upcoming Indian Premier League (IPL), according to a company official. The slot of the title sponsorship of IPL was vacated after the Chinese handset maker Vivo decided to exit from it.

The move would help the Haridwar-based firm access a global marketing platform, as Patanjali is focusing on exports for its Avurvedabased FMCG products. Confirming the development, Patanjali spokesperson S K Tijarawala told PTI: "We are considering this". "This is for Vocal For Local and making one Indian brand as global, this is the right platform. We are considering into that perspective," he said. However, Tijarawala also added that the company is yet to take a final call on the issue.

"We have to take a final decision, whether we would take it or not," Tijarawala added. According to him, the Board of Control for Cricket in India is coming with the expression of interest on Monday and it has to submit its proposal by August 14.

Last week, BCCI and Vivo decided to suspend their partnership for the 2020 IPL beginning on September 19, in the UAE, amid clamour to boycott Chinese products in the wake of the Sino-India border stand-off. The title sponsorship is a significant part of the IPL's commercial revenue, half of which is shared equally by the franchises. Vivo had won the IPLtitle sponsorship rights for five years from 2018 to 2022.


At 0.6%, state's Covid fatality rate much better than India's

New Delhi, August 10: As the total coronavirus patients across the country crossed the 22-lakh mark, India's fatality rate dropped to its lowest two per cent in the last 24 hours whereas the recoveries reached a new peak of over 15 lakh so far.

The latest data shared by the Ministry of Health and Family Welfare (MoHFW) reveals that the current Case Fatality Rate (CFR) is two per cent and is steadily declining.

However, the Covid fatality rate in Odisha is much better compared to national average. As against a total caseload of 47.455 in Odisha. the number of deaths in the state



was 286, recording a fatality rate of 0.6 per cent. The report came at a time when the country tested a record over 1,000 deaths in a single day, pushing the death toll so far

### FAST RECOVERIES India's COVID-19 recoveries have crossed the historic peak of 15 lakh Monday, more than twice the active cases The coronavirus infections

still remain concentrated in 10 states that contribute more than 80 per cent of the new cases

to 44,386. The central government said the fatality rate is at its lowest and India is among the countries with lowest fatalities. As per the health ministry, the coordinated efforts of the Centre and states/Union Territories on early detection through aggressive testing and efficient clinical management of hospitalised cases have shown results with continuously decreasing CFR. "Early identification of cases has also led to steep fall in percentage of active cases," it said. Early identification helps to ensure timely and prompt isolation of mild and moderate cases and hospitalisation of severe and critical cases, thereby leading to effective management of cases, the ministry said. The ministry data further men-

tions that India's COVID-19 recoveries have crossed the historic peak of 15 lakh Monday, more than twice the active cases. Recovery of 15,35,743 patients, the ministry said, has been made possible because of the policy of aggressive testing, comprehensive tracking and efficient treatment.

Better ambulance services, focus on standard of care and use of noninvasive oxygen had given the desired results, it said. With the highest-ever single-day recoveries of 54,859 patients in the last 24 hours, the recovery rate had scaled another high of almost 70 per cent.

The record recoveries ensured that the actual caseload of the country, namely the active cases, has reduced and currently comprises only 28.66 per cent of the total positive cases.







# Ensuring no one goes hungry during pandemic: Minister

The coronavirus outbreak is accelerating reforms in India's food-rationing system. At this critical juncture, the public distribution system (PDS) of the state is being managed

by Food Supplies and Consumer Welfare Minister Ranendra Pratap Swain. In an exclusive interview with Manish Kumar of **Orissa POST** (OP), he throws light on challenges posed by the pandemic and measures undertaken by

**OP:** What measures are being undertaken by the Food **Supplies and Consumer** Welfare department to ensure food security for vulnerable sections during the pandemic? 

the state govt. Excerpts:

Keeping in mind the need to

provide food grains to those who need it the most, my department provided three months' ration at one go at the doorstep of beneficiaries. In order to implement it, I fielded a dedicated team both at the department and my residence office which coordinated with officials through technology.

**OP:** Have you implemented any specific norms to curb the **COVID-19** spread during public distribution of foodgrains? We issued detailed Standard Operating Protocol (SOP) to ensure safety of distributors as well as the beneficiaries.

They were instructed to wear masks mandatorily and sanitise not only their hands but also the equipment in use. Most of the field officials used contactless methods to dispense ration. I am happy to inform that none of our COVID warriors contracted the virus during the most crucial, Phase 1 of the lockdown.

**OP:** The Centre launched PM Garib Kalyan Yojana recently. How much did it benefit Odisha?

Odisha is a pioneer and was the first to get off the blocks. Within a month of the decision, we covered most of the beneficiaries. However, providing pulses was delayed because we could not receive it on time from the central government. We are now working to provide foodgrains and pulses under PMGKY till next November. Besides, distributing Rs 1000 to more than 90 lakhs beneficiaries, as announced by our CM, fell on our shoulder and our field staff did not disappoint. Even though more than 90 lakh people were provided cash benefits, not a single case of misappropriation has come to our notice.

There have been reports of starvation deaths in the state during the pandemic. What is your take on that? Starvation deaths are a thing of the past. We have added about 10

lakh people under SFSA who could not be covered under NFSA. Moreover, during the pandemic, we have added close to 3.5 lakh people under SFSA. However, we still get requests and complaints from people. These issues are addressed immediately. Besides, we take

necessary support.

**OP:** Can someone without Aadhaar card in Odisha be deprived of PDS?

Such things have not happened in Odisha. Even though there is a Supreme Court ruling that linking of Aadhaar is mandatory for getting benefits under poverty alleviation schemes, we have taken a liberal view during the pandemic. Whenever any issues arise, our field staffs have been directed to undertake a field report and facilitate distribution within 24 hours. For weeding out corruption and duplication, we strongly advocate linking of Aadhaar and PDS services.

### **OP:** How are you ensuring sta-

bility in prices of food items? There are some reports of price hikes in case of certain vegetables. However, there is no such information on foodgrains because the market is well supplied. We have tried to keep the prices of essential vegetables like onion, potato, tomato

under check successfully. But now we may face difficulty. As you are aware that the Union government has amended the Essential Commodity Act (ECA) which has kept these items out of the purview of ECA except in exceptional cases. States do not have much power to control the prices using the conventional methods. We have to find a way to address the new situation and we will ensure that interests of the consumers are always kept at the top.

**OP:** As a minister, do you find it difficult to manage affairs of the department during the ongoing crisis?

I have been using technology including social media for a long time to communicate. I use it to remain connected during the pandemic too. Many close groups have been formed as per the need and necessary instructions are relayed to the stakeholders. My team is working round the clock to ensure seamless service and I don't find any reason for our work to get hampered.

# **FEW TAKERS FOR COMPLAINT BOXES AT PSes**

Bhubaneswar, August 10: Following a surge in coronavirus cases among the cops, the police stations in the city have placed complaint boxes at the entrances in order to avoid unnecessary contacts with complainants.



# State's COVID caseload at 47,455

ODISHA REPORTS 1,528 NEW INFECTIONS

Bhubaneswar; August 10: State registered its highest single-day spike in COVID-19 deaths Monday as 14 patients succumbed to the disease, while 1,528 new infections pushed its caseload to 47,455, an official of Health and Family Welfare (H&FW) department said.

The fresh fatalities have taken Odisha's COVID-19 death toll to 286, said the official.

Ganjam district, Odisha's COVID-19 hotspot, reported six of the 14 fatalities, while Khurda and Nayagarh registered three deaths each and two patients succumbed to the infection in Sundargarh and Rayagada districts, the official said.

Worst-hit Ganjam has so far reported 137 COVID-19 deaths, followed by 38 in Khurda, the official pointed out, adding that two more COVID-19 patients have died due to other ailments, taking the count of such fatalities to 51 in Odisha.

The fresh cases were reported from 29 of the state's 30 districts. As many as 948 cases were de-

tected in quarantine centres, while 580 people tested positive for the



infection during contact tracing, said the official.

Ganjam reported the highest number of new cases at 233, followed by Khurda (218), Sambalpur (168). Sundargarh (126) and Dhenkanal (107), added the official.

State has so far tested 6,69,266 samples for COVID-19, including 19,083 Sunday, the official added. The twin cities of Bhubaneswar and Cuttack Monday reported 133





### Mad rush for coal waste leads to face-offs among villagers

Lakhanpur, August 10: The high market value of cenosphere has resulted in a mad rush among people for its theft from the ash pond of Ib Thermal Power Project at Banharpali near here in Jharsuguda district, a report said.

The Ib Thermal Power Project is a coal-based thermal power plant at Banharpali. The power plant is operated by the state owned Orissa **Power Generation Corporation** (OPGC) with the help of the coal sourced from Ib Valley Coalfield in the area.

A cenosphere is a lightweight, inert, hollow sphere made largely of silica and alumina and filled with air or inert gas, typically produced as a coal combustion byproduct at thermal power plants.

The mad rush has given rise to serious confrontations in the area. Observers claimed that if not resolved at earliest then the situation might snowball into a major law and order problem. They demanded the OPGC authorities and the district administration to intervene and resolve the impasse

OPGC is producing 1780 megawatt of power from the plant by using lakhs of tonnes of coal from its four units which have now became operational. As a result. lakhs of tonnes of ash are produced daily due to heavy coal combustion in the plant.

The OPGC has constructed several ash ponds at Rengali and Tilia to store the ash. The company has declared the areas as prohibitory zones to prevent the entry of locals. Moreover, security personnel also keep round the clock vigil in the areas to prevent any unauthorised entry.

However, despite the all measures hundreds of people from the adjoining villages daily sneak into the ash pond to collect cenosphere. The product is smuggled due to its high market value.

This has given rise to intense competition among the villagers in collecting the coal waste which they sell to traders for Rs 25-30 per kg.

Things have come to such a pass that the villagers have even pitched tents near the ash ponds to steal the



### Why Dhenkanal is a breeding ground for snake

#### POST NEWS NETWORK

Dhenkanal, August 10: Good news for animal lovers and environmentalists as the population of king cobra and python is increasing in Dhenkanal district.

There are over 300 varieties of snakes in India. Of them, only 52 are categorised as venomous. Similarly, out of the 80 different types of snakes seen in Odisha. 17 are classified as venomous and 10 as highly venomous.

Government reports say that snakebites claimed as many as 128 lives in the last five years. As per snake researchers, most of the deaths occur when any of the snake varieties including cobra, Cobra-de-Capello (locally known as 'Tampa'), painted snake (locally known as 'Chiti'), printed snake (locally known as 'Rana') and sand viper (locally known as 'Dhulia Naga') and Russell's Viper (locally known as 'Chandan Boda') bite.

Dhenkanal's climate plays a major role in the reptiles' increasing population, according to the researchers. King cobras and pythons are found

mostly in Kapilas sanctuary, Phasi Gaon and Kandhara areas under Hindol range and Anantapur forest



reserve under Kankadahada block. Python and king cobra constitute 42 per cent and 35 per cent of the entire snake population in the district respectively. A python prefers a comparatively darker place like a stone cave or a hollow of a tree. Similarly, king cobras prefer dense forest. King cobra generally preys on smaller snakes and rodents. Sometimes, in search of food these snakes slither into human habitations and often end up being killed. In the last week, three king cobras were rescued from human habita-

tions. Two were believed to have

sneaked from Phasi Gaon jungle and one from Kapilas sanctuary.

The one rescued from Phasi Gaon was 16-foot-long. When it was spotted, it was lying in the area motionlessly after being beaten up by local people. On being informed, members of Banyak Foundation rescued and released it in its natural habitat.

Papun Das, a member of the foundation, requests people to not cause any harm to any reptiles as they are nature's gift. Similarly, environmentalist Pradyumna Rath said snakes are the friends of farmers as they

help them get rid of rodents.

Director, Banyak Foundation, S Behera, said the members have providing protection to snakes i district. "We are rescuing these tiles and with the help of fores partment officials releasing the jungles. People get terrified upon ing a snake and in most cases the it which should not be done. Aware can only save people's lives f snakebites. Instead of rushing snake charmer or any sorcerer snakebite victim should instea taken to hospital," he suggested

### **EXAMS IN** COVID TIMES

The state of chaos and confusion that marks India's noisy democracy often presents grim situations. So also with the issue of holding of examinations in the season of the COVID-19 pandemic. It is increasingly clear that the virus spread is not going to end soon - and most likely will not disappear in a few months' time as was foolishly surmised earlier in March this year. No lighting of lamps or beating of pots and pans helped neutralize this deadly disease. The balcony owning crowd in India has not yet comprehended how many people survive homeless in this country. This means readjustments in life styles must be made as the situation is evolving.

Most sectors of public life are learning to live or cope with the new normal until the time a miracle happens in the form of some effective vaccines or drugs. Factories have begun resuming their functions for most part and markets and shopping malls are reopening. Education, however, has taken the worst hit as it involves group activity. That is another in times of a virus spread. For the balcony crowd again, online teaching sessions have become the way forward, but this requires new systems, new equipment and a conditioning of the minds of the students and teachers. On the flip side, educationists, planners and administrators have to take into account the huge number of children left out of online teaching because of not having computers, Internet connections, steady power supply and other facilities at home. On one hand, the recently announced New Education Policy goes lot many steps ahead in its realization of the true situation existing at the ground level. Not only Mid-Day Meal, this new policy has proposed introducing a nourishing breakfast at school. The intention is to attract kids from the age of 3 to attend and probably learn something. When the nation acknowledges the fact that bulk of our children are, even today, malnourished and thereby their mental development has been impacted, the talk of Online Classes could seem like a thought emanating from outer space. There is no balance in this country as far as recognizing and addressing true situations are considered.

Returning to exams, a paralysis of sorts has hit the education sector as a whole. Students can wait a while to resume their studies at the cost of one precious year in their lives. Question is, what of the examinations and the rankings, marks, and assessments that take the students from one level to the other

The confusion was understandable, but the way it was tackled or not tackled effectively by authorities has created a situation in which the matter has ended up in Supreme Court - a time when judiciary as a whole is limping and only supposedly urgent matters, such as Contempt of Court, are taken up for consideration, that too mostly by video-linked remote hearing. The issue of the UGC coming up with a circular to universities to hold annual/terminal/semester examinations irrespective of the presence of the COVID threat has created huge confusion. This is seen to have gone against the new regulations in place for disaster management, which involved social distancing. Examinations are something that cannot be held with strict adherence to present infection related rules, unless, of course, done online. Studies can be done in isolation from homes but it will be impossible to hold exams that way as supervision will not be possible to check malpractices.

The problem was complicated as some states like Maharashtra and Delhi challenged the UGC circular of 6 July and issued executive orders cancelling examinations. The matter ended up in courts, with students and others filing petitions. According to details submitted by the UGC before court, over 600 of the 818 universities have either already conducted their examinations, many of them before the pandemic arrived, or have expressed a willingness to hold the exams. It says nearly 400 universities are ready to hold exams in offline, online, or blend mode this month or the next.

The issue before the apex court, per se, is not whether examinations should be held or not, which is a decision in the realm of the executive, but whether the UGC order contravened the provisions of the Disaster Management Act in the context of the COVID-19 pandemic. The court that took up the matter on Monday has posted the matter for hearing on August 14, while students are left high and dry, in a state of despair.

Appearing for examinations requires a tuning of the mind and preparations of a high order. Students cannot write exams without preparations. They also cannot prepare today and appear for exams six months later. That kind of exams are not the done thing in India since education is based on a rote learning system

# **TRAUMA OF COVID CHILDBIRTH**

The baby is dead. We can't assist you here.' By the time she heard these devastating words, the pregnant Yasmelis Casanova had endured a long and painful journey, passing through multiple COVID-19 checkpoints, to the hospital in Caracas, Venezuela. She bled for hours without treatment. When doctors at a second hospital finally operated on her, they removed her ovaries without her prior consent. Then, she spent 20 days there almost entirely alone; due to COVID-19 restrictions, visits were banned.

Venezuela's healthcare infrastructure was crumbling well be fore the pandemic, but the COVID-19 crisis has pushed it to the point of collapse. Many women experiencing obstetric emergencies now struggle to reach hospitals, let alone gain access to adequate care. Yet such failures can be seen far beyond Venezuela, in rich and poor countries alike.

Last month openDemocracy released the results of a global investigation into the treatment of women in childbirth during the COVID-19 pandemic. Across 45 countries - from Canada to Cameroon, from the United Kingdom to Ecuador – we found what doctors and lawyers describe as 'shocking' and 'unnecessary' breaches of laws and World Health Organization guidelines intended to protect women and babies during the pandemic.

Experts now warn that over the course of just six months, COVID-19 restrictions and healthservice disruptions could cause up to 56,700 additional maternal deaths in low- and middle-income countries. If this is not enough to expose the flaws in current COVID-19-prevention measures, consider how unevenly they are implemented (and lifted). In some parts of England, women can now take their partners to the pub, but not to antenatal appointments.

So far, discussions - especially among policymakers - have tended to be narrow, focused on short-term solutions. If we are to build the 'equitable, resilient, and sustainable post-COVID world that many leaders advocate, we must embrace a much more ambitious vision of what public health really means.

For example, laws protecting the vulnerable need to be enacted and enforced. Health bodies and other agencies must investigate violations and hold medical providers accountable. And governments and donors must allocate far more resources for advocacy in problematic areas such as mater nal health, and for implementing a rights-based approach to medical training and service provision across the board.

The issue extends far beyond direct medical care. Today, women can be imprisoned for having miscarriages (as in El Salvador) and detained for non-payment of hospital bills after childbirth (as in Kenya). Structural inequality and discrimination based on gender, race, class, disability, and more still shapes every aspect of our lives, in rich and poor economies alike. All of these failures undermine public health.

Far too many women have felt alone, scared, and traumatised while giving birth during the pandemic. In openDemocracy's investigation, one woman in Italy expressed her hope that policymakers and medical providers would learn from her suffering, and the suffering of those like her, so that other women wouldn't have to endure what she did. We owe it to these women to ensure that they do.

### Tattoo

he first sense of the term was a signal on a drum or a bugle to call soldiers to their quarters at night. It's first recorded in 1644, during the early stages of the English Civil War. Colonel John Hutchinson was then the governor of Nottingham Castle and head of the Parliamentary garrison in the city (he was to be later one of the signatories of Charles I's death warrant). In his standing orders he wrote: "If anyone shall be found tiplinge or drinkinge in any Taverne, Inne, or Alehouse after the houre of nyne of the clock at night, when the Tap-too beates, hee shall pay 2s. 6d." (Today that would be about £5.00 or \$8.) By the following century, the usual phrase was to beat tattoo, which makes clear that by then it was usually sounded on a drum, hence one of our modern meanings, a rhythmic tapping or drumming ("He beat a tattoo with his fingers on the table-top.") And it's clearly related to taps in the sense of a bugle call for lights to be put out in army quarters (which was originally also sounded on a drum). In the form someone quoted from the website, doe den tap toe, tap is the spigot of a beer barrel. It seems that the Dutch police had a neat way of closing the pubs at night, by making the rounds and instructing innkeepers to shut the taps on their casks. The other sense of tattoo, to mark the skin with pigments, could not be more different. It was brought back from the South Pacific by Captain Cook, and appears in his journal for July 1769: "Both sexes paint their Bodys, Tattow, as it is called in their Language. This is done by inlaying the Colour of Black under their skins, in such a manner as to be indelible." It could be from any one of several Polynesian languages, such as Tahitian, Samoan, or Tongan.





Bangalore, August 10: As the hotspot of the pandemic in Karnataka, Bangalore has registered 20,871 Covid positive cases in the past 10 days, an official said Monday.

For the last 10 days, the city accounted for 1,948; 2,665; 2,147; 2,554; 1,848; 2,035; 1,497; 2,105; 1,852 and 2.220 infections daily respectively since July 31.

On an average, the city has been accounting for more than 2,000 cases a day.

Of 1.78 lakh cases across the state, the city alone accounts for 74,185, recording positive cases at



cent of all infections in Karnataka. Though the total number of cases at present stands at 1.78 lakh in Karnataka, active cases

are 80,973. Incidentally, Karnataka has overtaken Delhi in the number of coronavirus infections, the national capital accounts for 1.45 lakh cases. Despite 93.908 recoveries.

Karnataka currently accounts for the fourth highest number of Covid deaths with 3,198, after Maharashtra (17,367), Tamil Nadu (4,808) and Delhi (4.111).



### NHRC pulls up Karna govt over 'weird' ritual

NECK-DEEP BURYING OF KIDS IN COMPOST PITS TO FIND CURE FOR THEIR DEFORMITIES IN PARTS OF KARNATAKA RILES THE RIGHTS BODY

New Delhi, August 10: The NHRC has sent a notice to the Karnataka government over the alleged practice, in some parts of the state, of neck-deep burying of children in compost pits to find cure for their deformities, officials said Monday,

The Commission has observed that the ritual appears "weird, unethical and cruel towards poor kids, who are being treated with indignity in the name of faith," the rights' body said in a statement.

"The National Human Rights Commission (NHRC) has taken suo motu cognisance of a media report that children with special needs were buried neck-deep in compost pits in Kalaburgi, Karnataka under the belief that exposure to sharp rays

during a solar eclipse will cure them of their deformities," it said.

The incidents were reported from three villages in the district - Taj-Sultanpur on the outskirts of Kalaburgi town and Ainolli and Gadi-Lingadalli villages in Chincholi Taluk, it said.

Reportedly, following a tip-off, the district child protection task force had rescued the children and reunited them with their families after a medical examination, the rights panel said.

The Commission has observed that such rituals tantamount to violation of human rights of the victim children. There is a need to sensitise the authorities as well as the parents of such children not to victimise the young ones in the name of blind faith, it added.



Accordingly, the NHRC has issued a notice to the Karnataka government through its Chief Secretary, seeking a detailed report. "The Commission would like to

know that whether, apart from

Kalaburgi, this inhuman practice is prevalent in other districts of the state, if so, what action is being taken by the authorities," the state ment said.

The report must include if the

state government has issued any guidelines with regard to the subject and status of its implementation. The response is expected within six weeks. The Chief Secretary of the state is expected to look into the matter personally, the statement said.

Issuing the notice, the Commission has also observed that "due to spread of COVID-19, social distancing is being maintained and it is not advisable to organise awareness camps etc. in the villages but through local authorities, with the help of media and various digital modes like video conferencing etc., the awareness with regard to the ill practice and its impact on the tender minds of the children is required to be created amongst the public at large.'

Despite being in the hospital for more than a week, the Chief Minister was in regular touch with the officials. He also cleared files andgave necessary instructions about the flood relief work in the state.





dozen BJP workers in Kashmir have resigned from the party following recent attacks on villagelevel leaders by militants, which prompted the party to suggest "hostel-type" secure accommodation for its members and their families in each district in the Valley.

Worries have escalated after Abdul Hamid Najar, BJP's OBC 'morcha' district president from Budgam, died at a hospital early Monday, a day after he was shot at in his village.

### Will the Disaster Management Act overrule UGC directive, SC asks UGC

New Delhi, August 10: The Supreme Court Monday sought University Grant Commission's (UGC) response on whether the Disaster Management Act will have an overriding effect on its directives for conducting exams after Delhi and Maharashtra decided to cancel exams amid pandemic COIVD-19.

A three-judge bench of the apex court comprising Justices Ashok Bhushan, R Subhash Reddy and MR Shah granted time to the UGC to respond to the decision taken by the Maharashtra and Delhi governments to cancel exams.



The bench listed the matter for hearing August 14.

Will the Disaster Management Act have an overriding effect on the UGC directive? You need to reply on this," the bench said.

Earlier, Maharashtra and Delhi had filed affidavits in the Supreme Court stating that they would not hold exams due to pandemic.

However, Solicitor General Tushar Mehta questioned the stand taken by Maharashtra and Delhi and submitted that such a cancellation is contrary to the decision of the UGC, the only authorised body to confer degree. "When the UGC is the only body to confer degrees, how can states cancel exams and expect UGC to confer degree?" argues Mehta. He sought time from the court to

One Indian businessman lost a whopping Rs 28 crore in such crypto wallet scam, Shah informed.

A single Bitcoin currently costs \$11,000 (over Rs 8 lakh) and Indians are now investing in crores aiming for higher returns.

The modus operandi of such fake wallets is simple. They target people via sending them messages on various social media groups, asking them to sell and buy Bitcoin via their apps.



The scamsters trick them to buy and sell Bitcoin via wallets and offer them trade opportunities with other app users across the world. Once they receive Bitcoin into their

systems, they disappear and stop communication altogether.

Most of these transactions are happening via Swift Global Pay (SGP), Insta Global Pay (IGP) and

International Global Pay wallets, informed Shah.

'I do not see any genuinity in this wallet. I purchased virtual cards by paying Rs 3.70 kakh on SGP. It was delivered online July 15. Till now it is not accepted anywhere online. SGP site chat no response," posted a user that goes with the name Kumar Chvks, Managing Director with an Indian firm.

'Email no response. So only the figures are shown on Dashboard. I tried to withdraw my money in the BTC PayPal and bank. None came till now. It is a clear cheating. Expected to be a scam of 7,000 crore to my estimation," he further posted. According to Sumit Gupta, Cofounder and CEO, CoinDCX which is India's largest and safest cryp tocurrency exchange, as Bitcoin and other cryptocurrencies continue to mature and increase in popularity; they expect more cryptocurrency scam apps to appear and other fraudulent activities emerging.

"Scammers and hackers are getting more sophisticated in their techniques. When installing apps, it is important to stick to some basic security principles, especially when virtual currencies are at stake, Gupta said

The global cryptocurrency market was valued at \$856.36 billion in 2018 and is projected to display robust growth represented by a CAGR of 11.9 per cent during 2019-2024.

New Delhi, August 10: Prime Minister Narendra Modi Monday underlined the need to have a better coordination between all the central and state agencies to have a permanent system for forecast-He also stressed on exten-

sive use of innovative technologies for improving the forecast and warning system. The prime minister made these remarks at a virtual meeting

with the chief ministers of six states to review the flood situation in various parts of the country. The states that attended the meeting, which was convened to review their preparedness to deal with

the southwest monsoon and the current flood situation in the country, were Assam, Bihar, Uttar Pradesh, Maharashtra, Karnataka and Kerala.

A statement from the Prime Minister's Office (PMO) said at the meeting, Modi highlighted that the investments in localised early warning systems should be increased so that the people of an area can be cautioned on time in case of a threatening situation such as breached river embankments, inundation or lightning.

The meet, which lasted nearly an hour and a half, was also attended by Defence Minister Rajnath Singh, Health Minister Harsh Vardhan, Minister of State for Home Nityanand Rai and G Kishan Reddy, and senior officers of the central ministries and organisations concerned.

The prime minister also asserted that in view of the COVID-19 situation, the states must ensure that people follow all health precau-



RAIN tions such as wearing of face masks, hand sanitisa-**FUR** tion and maintaining an adequate physical distance with each other while undertaking rescue efforts.

He said the relief material must include provisions for hand washing and sanitising and face masks for the affected people. Special provisions should be made for elderly people, pregnant women and people with co-morbidities, he observed. Modi said the states should en-

sure that all development and infrastructure projects are built with resilience to withstand local disasters and help reduce the consequential losses. The prime minister pointed out that over the last few years, forecasting agencies such as the India Meteorological Department (IMD) and the Central Water Commission (CWC) are making concerted efforts to make better and more usable flood forecasts. They are trying to provide not only rainfall and river-level forecasts, but also location-specific forecasts of inundation.

Pilot projects are also underway to use innovative technologies such as artificial intelligence to improve the location-specific forecasts, for which the states should provide the necessary information to these agencies and timely disseminate the warnings to the local communities.

# Six-year-old brutally raped

Hapur (UP), August 10: A six-yearold girl, who was kidnapped and brutally raped in Hapur district Thursday, remains in a critical condition even as the police con-

tinue to hunt for the accused. The police have released three sketches of the accused on the basis of the statements of the girl's parents and neighbours. The girl was kidnapped from outside her home in the Garh Mukhteshwar area, reportedly by a man on a motorcycle.

The police launched a hunt for the girl after her parents lodged a missing complaint. She was found the next morning, unconscious and soaked in blood, behind bushes not far from her village. The girl was rushed to a specialised hospital in Meerut where the medical examination confirmed rape.

She has already undergone one surgery and doctors say she is stable but not yet out of danger. The doctors said that the girl was brutalised in a manner that is shockingly similar to the Nirbhava gang rape case of 2012.

Dr S.K. Garg, the principal of the Meerut Medical College where the girl is admitted, said that she will need treatment for a long duration and more surgeries. Hapur SP Sanjeev Suman said that they have not yet been able to record the victim's statement because of her medical condition. He said that six police teams have been formed to arrest the accused. Meanwhile, protests are being held by the Samajwadi Party and Congress over the incident.

### USE OF SANITISATION **TUNNELS** Top court issues notice to Centre

New Delhi, August 10: The Supreme Court Monday issued a notice to the Union government in response to a petition seeking complete ban on the use of sanitisation tunnels across the country to disinfect people visiting public places.

A three-judge bench of the Apex court comprising Justices Ashok Bhushan, R Subhash Reddy and MR Shah sought Centre's response over the use of sanitisation tunnels. The petitioner submitted in the court that the sanitisation tunnels are ineffective in containing the spread of the COVID-19 and the tunnels can also be harmful for humans. The petitioner also contended that the World Health Organisation, Directorate General of Health Services and Ministry of Health & Family Welfare had issued an advisory in April this year against spraying of disinfectants on people. "WHO and other health experts across the world have said that unchecked and mis-informed usage of such disinfection tunnels can have serious physical and psychological consequences on human beings," the petition states. The petitioner urged the court to ban use of such sanitisation tunnels involved in spraying of chemical disinfectants to contain spread of COVID-19 across the country.

The accused, who was a teacher at an educational institution, had been going to the victim's house to teach Arabic to her younger sister for last 15 days. Since Saturday, he was also teaching the victim, Khamardih police station house officer Mamta Sharma Ali said.

### Fine increased

Gandhinagar: In a bid to stem the spread of COVID-19, the Gujarat government Monday increased the fine for not wearing mask in public places to ₹1,000 from the present ₹500. The decision came after the Gujarat High Court in its order last month asked the government to collect a minimum fine of ₹1.000 from those found without mask in public places.

Mumbai, August 10: A Mumbai pavement dweller has become a social media darling after her daring act helped avert potential road tragedy horrors and also enabled flood waters to drain out quickly during last week's monsoon fury. Disregarding her own safety or

wellbeing, the poor flower-seller, Kanta M. Kalan, 50, forced open a gutter manhole cover on the hightraffic Tulsi Pipe Road in Matunga west August 4. This was to prevent further flooding on the road which was already submerged in three feet of water after torrential rains that day, she said.

Unfortunately, the flood waters had washed out Kalan's own tiny shanty and around ₹10,000 savings, but she decided to do something which could clear out the flood waters as heavy rains continued to lash Mumbai on that day.



She took a piece of cloth and tied it to the manhole cover and from a short distance, with the help of a passing motorcyclist, pulled it open to allow the flood waters to gush away directly into the sewerage lines underneath.

As it continued to rain most part of the day, she stood beside the manhole and directed the oncoming traffic to avoid any possible tragedy - from 6 am to lunch time. Later, Kalan had developed fever after her ordeal beside the manhole with rains and gushing flood water around her.

A resident in an adjacent building, Sameer Patekar clicked videos of her and posted them on social media, earning her likes and laudatory comments from people and police personnel. Kalan's husband Maruti was left paralysed after a train accident over a decade ago. She alone supports her two schoolgoing daughters -- Janaki and Tamishree - with the income from selling flowers.

The money she lost was to pay for the online class fees of her daughters studying in Class 8 and 10, respectively, but her immediate priority was to get a roof on their heads as the rains continued Besides, Kalan is also worried that if she is unable to arrange the tuition fees, her daughters may be forced to drop out this year. The BrihanMumbai Municipal Corporation local Ward officials though declined to comment on the issue.

Amroha (Uttar Pradesh), August 10: One and a half years after remaining missing, a woman in Uttar Pradesh surfaced at her home, only to find that her father. brother and another family member has been languishing in jail all this while for apparently murdering her.

The Amroha police put her father Suresh, brother Roop Kishore and a relative Dinesh behind bars for her 'honour killing' in December 2019 after they failed to work out the missing case. The police claimed that they had the confessions of the accused and had recovered a country-made pistol and the clothes of the missing woman.

The 'murdered victim' appeared in her village last week only to find that her three family members were incarcerated. The woman said that she had

been living in Delhi with her boyfriend after leaving home.

The SHO who led the investigation into the 'murder' has now been suspended and an inquiry set up. Amroha's Superintendent of Police (SP) Vipin Tada confirmed that Ashok Sharma, the then SHO of Adampur police station, has been put under suspension. He said that the murder charges against the woman's family members will now be dropped and they will soon be out of jail.

"The woman will be produced before a court where her statement will be recorded. The then SHO will be probed for dereliction of duty," the SP said.

### 15% students in Delhi govt schools not traceable: Sisodia

New Delhi, August 10: Close to 15 per cent students enrolled in Delhi government schools are not "traceable" since the lockdown was announced and have not been attending the alternative classes conducted online or through phones, according to Deputy Chief Minister Manish Sisodia.

Sisodia, who is also the Education Minister, said efforts are being made to locate these students either physically or telephonically to get them into the system

'We are conducting full-fledged teaching learning either online or through phones and teachers have been instructed to ensure personal involvement with each student. So far, there are maximum 15 per cent

students who are not traceable and are not in contact with their schools and hence not attending the classes," Sisodia said. "I have been reviewing this per-

sonally and we have been able to trace few students, for others either they are not staying at the same addresses or their phone numbers mentioned in our records are

not traceable. I have asked that School Management Committees (SMCs) should be roped in to track these students. There are certain students who have gone to places like Uttarakhand and Bihar but are still connected with us and are attending the classes and doing assignments." he added.

Asked about a definite number of the students who have not been traced, Sisodia said, "On an average there are 4-5 students in every class who are in this category. Many of them are class 6 students and numbers for other classes are quite low" There are around 15 lakh students enrolled in over 1100 Delhi government schools.

"We started conducting online classes for class 12 students from April 6 and sending e-learning ma-

terial or activities to those enrolled in classes nursery to eighth over WhatsApp or SMS. The government has also provided a subsidy of ₹200 for internet packages to all its class 12 students who had registered for the online classes," a senior Directorate of Education (DoE) official said.

The HRD ministry had last month asked states and union territories to ensure that the names of children of migrant workers who returned home during the COVID-19 pandemic are not struck off their school rolls

Issuing a set of guidelines, the ministry had also directed the states to prepare a database of children who have left the local area for their homes in other states or other parts of the same state. It also suggested that the state governments may direct all schools to give admission to any child who recently returned to village without asking for any other documents, except for some identity proof.

Universities and schools across the country have been shut since March 16, when the Centre announced a countrywide classroom shutdown as part of measures to contain the COVID-19 outbreak. A nationwide lockdown was announced on March 24, which came into effect the next day and threw economic activities out of gear, rendering many homeless and penniless and leading to an exodus of migrants to their home states. While the government has largely eased restrictions,schools and colleges continue to remain closed.



### Chinese jets intrude **Taiwan's airspace** amid US official visit

Beijing, August 10: China Monday cried foul and lodged a "stern' diplomatic protest with the US over the visit of Health Service Secretary Alex Azar to Taipei, the first high-ranking American official to visit the self-ruled island in over four decades, while Chinese air force jets intruded into Taiwan's airspace in an apparent show of force.

Azar, the highest-ranking Cabinet member to visit Taiwan since the US switched diplomatic recognition to Beijing from Taipei in 1979, kicked off his three-day visit by meeting Taiwanese President Tsai Ing-wen. China, which considers the estranged island of Taiwan as part of its mainland, vociferously objects to any high-level foreign dignitaries meeting Taiwanese leaders

Azar's visit comes amid an alltime low in US-China relations\_ and it was regarded as the major diplomatic setback for Beijing which asserts that the 'One-China' policy constitutes the core of its foreign policy with all the countries which established diplomatic relations with it. Tsai, a firm proponent of Taiwan's independence from China, said Azar's landmark visit is a "new start" for Taiwan-US relations and she expects more breakthroughs in cooperation between Washington and Taipei. Much on the expected lines, Beijing reacted angrily saying that the visit is the betrayal of the US commitment to the 'One-China' policy. Azar's visit was facilitated by the 2018 passage of the Taiwan Travel Act, which encouraged Washington to send higher-level officials to Taiwan after decades during which such contacts were rare. The Taiwan News reported that ahead of the Tsai-Azar meeting, Chinese fighter jets crossed over the median line of the Taiwan Strait Monday. Taiwan's Air Force Command Headquarters said that Shenyang J-11 and Chengdu J-10 fighter jets belonging to the Chinese Air Force crossed the median line of the Taiwan Strait, the unofficial airspace boundary between the two sides, for a brief period at 9 a.m, according to the report.

New Delhi, August 10: Over ₹3 lakh crore of debt to retail and small corporate segment is at risk because of the coronavirus pandemic and will benefit from the loan restructuring scheme announced last week by the RBI, according to a report

The central bank's move will help contain the quantum of sour loans and if not for the recast. the banking system's non-performing assets (NPAs) would have touched a 20-year high of 11.5%, domestic rating agency Crisil said in the report Monday.

Last week, the RBI announced the loan recast package for individuals and entities hit by the pandemic. It formed a committee under former

ICICI Bank chief KV Kamath to come out with detailed rules, and hinted at a case-by-case approach under the contours laid down in



the June 2019 circular on stressed assets to deal with it.

The major beneficiaries will be sub-Rs 500 crore corporate exposures and retail exposures, which were earlier expected to see the highest increase in NPAs in percentage terms, Crisil said.

It estimated the debt at risk

loans at risk of slipping into NPAs this fiscal unless restructured by banks — at a "sizeable" ₹3 lakh crore. The agency said large corporate loans are not at such a high risk, as they were in the last NPA cvcle after the global financial crisis, because of the de-leveraging efforts of the past few years.

"Last time, the NPAs came primarily from bigger and chunkier accounts, whereas this time, an analysis of the top-100 exposures of our large, rated banks reveals that...these entities are likely to be better-positioned to withstand the current challenges," its Senior Director Krishnan Sitaraman said.

A study of 14,000 companies having exposures of over ₹25 crore,

by banks, showed that debt at risk in corporate loan accounts with exposure less than ₹500 crore is ₹2 lakh crore, the agency said.

It added that the ratio of the debt at risk for the sub-Rs 500 crore exposures segment is five times that of larger corporate loans.

The retail segment, which was considered a safe haven for banks in the recent years, is witnessing significant pressure because of the stress being faced by salaried and self-employed borrowers, it said estimating the total debt at risk in this at ₹1 lakh crore. The unsecured loans will be the most at risk, while home loans will be the least because of the psychological attachment of Indians to the homes they live in, and home loans, it said



**SETBACK FOR ATLETICO** 

*Rojiblancos' Correa, Vrsaljko test positive for coronavirus putting their* Champions League quarterfinal encounter with RB Leipzig in disarray

Madrid, August 10: Two members of Atletico Madrid's group set to travel to Portugal for the Champions League quarterfinals tested positive for the coronavirus -the first pandemic-related setback among clubs participating in the final stage of Europe's top club competition.

Angel Correa and Sime Vrsaljko are the players have tested positive for the coronavirus but the rest of the squad have been cleared to make the trip to Portugal for the Champions League quarterfinals.

The last eight is scheduled to begin in Lisbon Wednesday amid tight health safety protocols to prevent a coronavirus outbreak from derailing the competition's finale. The semifinals and August 23 final will also be played in Lisbon.


Other clubs involved in the quarterfinals have not reported any positive tests among its players recently. The Spanish club did not name those who tested positive and did not say if a player was involved. It said both people who were infected had been isolated at their homes.

Atletico, who were expected to travel to Lisbon Monday, said it immediately informed health authorities in Spain and Portugal about the positive results, as well as UEFA and other soccer bodies in both countries.

They said in a statement that the entire group those were set to travel will be tested again, and that the team's schedule is being altered to allow the new tests

Atletico are set to face Leipzig Thursday in the last eight. The quarterfinals start Wednesday with Atalanta facing Paris Saint-Germain. The other one-game series will involve Barcelona and Bayern Munich Friday and Manchester City against Lyon Saturday. The matches will take place at two stadiums in Lisbon.

Earlier this week Atletico had to cancel a friendly of their women's team after a positive test within the group. Atletico said that, after the Spanish league season had ended. the club asked for all Spanish teams still involved in European competitions to keep



voluntarily following the league's health safety protocols.

They said UEFA only required one negative test from each member of the group within 72 hours of the trip to Lisbon, but the team had been testing their members weekly and were still working with the health safety inspector assigned by the Spanish league. Atletico said a total of 93 people had been tested the day before the squad returned to training July 26, and the first team and those in close contact with it were tested again last Sunday, with all results coming back negative.

Atletico is seeking their first title in Europ's most lucrative club competition. They lost the 2014 and 2016 Champions League finals to city rival Real Madrid. They were also runner-up in 1974, losing to Bayern Munich. Diego Simeone's team were eliminated by Juventus in the round of 16 last season.

### Pratap follows Rupinder, Birendra Formers mourn Manitombi's death

New Delhi, August 10: Former India players, including Renedy Singh and Venkatesh Shanmugam, mourned the untimely death of their teammate Manitombi Singh and recalled him as a 'fighter' on the pitch and a 'friend' off it.

Manitombi, a former India and Mohun Bagan footballer, died aged 39 at his native village near Imphal in Manipur on Sunday after suffering from a prolonged illness.

He was a part of the Blue Tigers side that famously lifted the LG Cup in Vietnam 18 years ago. The full-back had also represented India in the 2002 Asian Games in Busan.

"I was really shocked to hear of his death. He was such an asset to Indian football," said his former India teammate Venkatesh, who is now the national team assistant coach.

Defender Debjit Ghosh is someone who not only had played alongside Manitombi in the national team, but had also captained the player during their days at Mohun Bagan

Expressing his surprise at the lat-



ter's untimely demise, Ghosh gave some insight as to the kind of a raw talent the Manipuri was, during his early days in the National Football League.

"I was very surprised to hear that he had passed away. We could all do with some good news this year, and this was certainly not one of them. He was a dear friend off the pitch," said Ghosh.

Venkatesh added, "I had seen him put in some really good performances on the pitch. He was an absolute fighter, but more important was the consistency that he brought in. You know that if he's there on the pitch, he will give you eight out of 10 every time. An absolute commitment player.' The nature of Manitombi's illness

was not clear and his family members did not share any details. He is survived by his wife and an eightyear-old son.

Ex-Blue Tigers winger Renedy Singh had also played alongside Manitombi for both country and club under his leadership at Mohun Bagan.

"As a captain, you have to often lead by example. Manitombi was that kind of a captain. He worked hard on the pitch, and that's how he inspired the rest of us.

When you think of a tough tackler like him, you'd rather have him on your side fighting for every ball, than in the opposition ranks," said Renedy.

In recent years, Manitombi had taken up coaching and was a coach at the Manipur state league champions Anouba Imagi Mangal in the 2015-16 season.

Reminiscing about their playing days, Venkatesh felt that Indian football has lost an asset with Manitombi's death, as he was coaching a number of youngsters in Manipur.
