


■ No Ganesh Puja in Twin City this year



PM's big push for tax reforms

THE PRIME MINISTER LAUNCHES PLATFORM FOR TRANSPARENT TAXATION; SAYS **FOCUS ON SEAMLESS, PAINLESS, FACELESS TAX SYSTEM**

PRESS TRUST OF INDIA

New Delhi, August 13: In a major overhaul of tax administration, Prime Minister Narendra Modi Thursday unveiled faceless tax assessment and appeals to reduce the scope for corruption and overreach by officials, and said a taxpayers' charter is being implemented to ensure a free, fair and transparent tax environment

Launching the 'Transparent Taxation - Honouring The Honest Platform' through video conferencing, he said the taxpayer base at just 1.5 crore in India is very low and urged those who owe taxes to come forward and honestly pay their dues and contribute to nation-building

The taxpayers' charter and faceless assessment are the next phases of direct tax reforms aimed at easing compliance and rewarding honest taxpayers as the government looks to rebuild the pandemic-hit economy.

While, faceless assessment that does not require the taxpayer to visit any office or meet any official, and taxpayers' charter has beeen implemented from Thursday, the faceless appeal will come into force from September 25, he said

'The tax system may be turning



faceless but it promises fairness and fearlessness for taxpayers," he said

Modi said, till now the tax office in the city of residence was handling the scrutiny, appeal, and notices of an individual taxpaver

Now, a central computer will pick up tax returns for scrutiny based on risk parameters and mismatches and then will allot them randomly to a team of officers in any city. The scrutiny by these officers will be reviewed by officers at another randomly selected location

- Faceless assessment does not require the taxpayer to visit any office or meet
- Taxpayers' charter was implemented from Thursday, while the faceless appeal will come into force from September 25
- The taxpayers' charter and faceless assessment are the next phases of direct tax reforms aimed at easing compliance and rewarding honest taxpayers

Notices, if any, will be sent only by centralised computer system, and taxpayer can respond to them electronically without the requirement of visiting a tax office or meeting any official

This, he said, will end the era of "jaan pehchan" (acquaintance) to get scrutiny or notices settled

The Prime Minister said taxpayers' charter provides for fair, courteous, and reasonable treatment while treating taxpayers as honest. It expects taxpayers to be honest and compliant and pay taxes in time

While the number of people filing income tax returns has increased by about 2.5 crore in the past few years, actual taxpayers at just 1.5 crore out of a population of 130 crore "is very very less," he said. "Those who are capable must voluntarily come forward and pay their dues and contribute to the development of the nation," he said

Modi said, economic reforms in the past were done under compulsions or pressure which did not yield desired results

"For us reforms mean reforms based on policy, reforms that are holistic and not piecemeal and one reform forming the base for other," he said. "Reform is a continuous process." MORE P11

1.5L Berhampur residents exposed to virus: RMRC

A STUDY SHOWS 31% SERO PREVALENCE IN GANJAM CAPITAL

Bhubaneswar, August 13: The results of the latest sero survey in Berhampur city revealed that 31 per cent of the population who were tested have developed antibodies against the novel coronavirus.

Regional Medical Research Centre (RMRC) , regional wing of ICMR, Director Sanghamitra Pati said that the study covered 2,830 people, comprising citizens from five urban slums and other High Risk Community members, in the city.

"In the community, we have found sero prevalence up to 31 per cent. This means that 1/3 of the population have developed antibodies against the disease. The sero prevalence ranged from seven per cent to 60 per cent in some areas," she said during a virtual media briefing Thursday.

The RMRC Director said that as per the study trends, 1.5 lakh people in the city seems to have been exposed to the virus. "Ninety per cent of the people who had been infected did not show

any symptoms. Over 1.5 lakh people, as per the survey trends, might have developed antibodies against the infection. In high risk groups the prevalence was 23.4 per cent," The sero survey was con-

Regional Medical Research Centre, Berhampur Medical College and Berhampur Municipal Corporation. In four Wards, 50 per cent of the people tested had de-

ducted jointly by the

veloped antibodies, while 35 per cent citizens in urban slums were found to have developed antibodies. "The infection fatality rate, which hints at the trans-

mission pattern, was 0.02 per cent. When we undertake the next round of serological testing, we hope to get a better result," she said.

The survey was under-

taken by five different teams which conducted tests across the city covering five slums and High Risk Groups, A total of 2,830 people were covered under the survey and theirsamples were tested. RMRC has submitted a detailed report to the state

Shyam was admitted for treatment, while Nanda was shifted to MKCG Medical College and Hospital after his condition deteriorated.

Woman hacks husband to death over affair

Fuming over the incident and in a bid to free herself from the husband's atrocities, she hacked her husband with an axe while he was asleep resulting in his death.

After committing the crime Kabita informed her close relatives about the same following which the latter alerted the cops. On being informed local police reached the spot with a forensic team and sent the body for post-mortem.

Police have detained Kabita for interrogation, while further investigation is on.

Gehlot to bring confidence motion

Jaipur, August 13: In a major twist to the Congress crisis in Rajasthan, the BJP Thursday announced it will move a no-confidence motion against the Ashok Gehlot government in the special Assembly session starting Friday. 'Operation Empty Plate': Chinese diners told to order less food

RESTAURANT DINERS TOLD TO ORDER ONE DISH FEWER THAN NUMBER OF PEOPLE UNDER NEW SYSTEM CRITICISED AS OVERLY CONTROLLING

Beijing, August 13: The Chinese leader, Xi Jinping, has launched a campaign targeting a new enemy of the country: food waste.

"Waste is shameful and thriftiness is honourable," Xi said in a speech published Tuesday, describing the amount of food that goes to waste in the country as "shocking and distressing"

Quoting a poem, he said: "Who knows that of our meal in the dish. every grain comes after hard toil?" He added: "We should still maintain a sense of crisis about food security. The impact of this year's COVID-19

pandemic has sounded the alarm." The focus on food waste comes after weeks of mass flooding across



tributing to rising food prices - already higher after the COVID-19 outbreak paralysed the Chinese economy.

Faced with trade tensions with the US and other countries, food

China - has become even more important. As much as 20% to 30% of China's grains are imported, according to estimates.

Local authorities immediately sprang into action with proposals

targeting the scourge of food waste. or "operation empty plate", an initiative first mentioned in 2013 but elevated anew by Xi's speech. The Wuhan Catering Industry Association called on restaurants in the city to issue a system called "N-1 ordering" whereby a group must order one dish fewer than the number of diners.

Restaurants should offer halfsize and smaller portions as well as offer to-go boxes to pack up leftovers. Following Wuhan's lead, the cities of Xianning, also in Hubei province, and Xinyang, in Henan province, also proposed implementing the N-1 system.

In Chongqing, the Federation of Industry and Commerce issued a statement promising to implement Xi's guidance, setting up LED screens with prompts to "establish a frugal consumption reminder system" as well as measures to "supervise consumers to eat frugally"

In a country where it is seen as polite to order more than the amount needed, "operation empty plate" will encounter difficulties. Meals are often served family-style with shared dishes and hosts tend to order more dishes than the number of diners in the group.

In his speech, Xi called for strengthening legislation, supervision, and long-term measures as well as better public education to "resolutely stop food waste". A report in 2015 by the China Academy Science and partners found that up to 18 million tonnes of food a year was

People's Daily, internet users on Weibo left sceptical and in some cases angry comments. "Can you first limit the dining of officials? Don't always take away from the people," one said, referring to formal banquets and lavish meals held by officials.

One user, alluding to the economic difficulties many in the country are facing, said: "This seems aimed at us bottom class, but we are already thrifty. This will mean nothing to the rich." Another said: "I especially hate this kind of political action that leans on ordinary people to act.'







Centre plans tweak in DMF norms

New Delhi, August 13: In order to bring uniformity in guidelines in all states and for better utilisation of funds, the Union government is planning to make changes in the rules of District Mineral Foundation (DMF), a non-profit body established by states in districts affected by mineral explorations.

According to sources, the Mines Ministry has recently proposed several procedural reforms to enhance employment in mineral and mining industry. The ministry, sources said, has proposed certain changes in the DMF guidelines. It has been stated that the Pradhan Mantri Khanij Kshetra Kalyan Yojana (PMKKKY) guidelines were issued by the ministry and the states framed their own rules. However, sources said, there is no uniformity in the rules framed by



areas affected by mining related operations in the manner prescribed by the state government. The DMFs have been directed to take all major decisions in participatory mode, in consultation with gram sabhas.

The holder of a mining lease, in addition to the royalty, contributes to DMF of the district in which the mining operations are carried out. The amount the mining firms pay to the DMF is equivalent to the percentage of royalty, if lease has not been granted through auction and 25 per cent of royalty, if lease has been granted through

It is to be mentioned here that Rs 6,104 crore was collected by DMF in Odisha till December 2018. Around 11,434 projects were sanctioned and Rs 1,011.11 crore was spent on various projects in

Bhubaneswar, August 13: The twin city has turned into a happy hunting ground for the looters as far as the crime statistics for 2019 released by Commissionerate Police is concerned

The statistics revealed that the twin city experienced a significant rise in dacoity (robbery involving five or more persons), robbery, burglary and theft in 2019 as compared

As per the statistics, 69 cases of dacoity have been registered at different police stations in the twin city in 2019. Of that, 49 were reported in Bhubaneswar while 20 were reported from the Millennium City. However, only 37 dacoity cases – 10 in Cuttack and 27 in Bhubaneswar - were recorded in 2018. The occurrences of dacoity incidents in twin city have almost doubled in

Similarly, there is around 34 per cent increase in robbery cases in 2019 as compared to the previous vear. The cases increased from 282



ing 2019.

The twin city police recorded 758 swindling cases under Section 420 of the IPC including cyber fraud incidents in 2018. The number of cheating cases rose to 917 in 2019, registering an increase of around 18 per cent. Cuttack registered around 50 per cent increase in swindling cases during 2019.

Meanwhile, the Commissionerate Police managed to detect the accused only in 50 per cent of the theft and burglary cases during the period.

Similarly, rape cases in twin city rose to 215 in 2019 as against 192 in 2018, registering around 17 per cent increase. Although sexual abuse cases registered a slight decrease in Silver city, the Capital city witnessed a rise. It registered 149 rape cases in 2019 as against 122 in 2018.

However, there is mixed outcome when it comes to murder cases. Murder cases took a nosedive in Bhubaneswar (from 43 to 39) but increased slightly in Cuttack (from 29 to 30).

nounced the order while hearing a petition filed by Berhampur-based lawyer Lalit Mohan Mangaraj alleging a cold shoulder by the Town police in registering a case against Berhampur tehsildar.

The petitioner had informed the HC



that the incident took place when he was on his way home June 6. "I was hauled up at a Covid-related checking near Gandhi Nagar Square. Berhampur tehsildar Sipak Patra, who was heading the inspection team, entered into an argument with me. In a fit of rage, Patra not only abused me but also my profession," said

the petitioner. Soon after the incident, Mangaraj highlighted the issue with his fellow lawyers of Ganjam Lawyers Association, Berhampur sub-collector, revenue divisional commissioner (Southern Range) and Home secretary. "These apart, I had approached the Town police with a written complaint. But they [police] didn't pay heed to my complaint," the petitioner pointed out. With no way out, Mangaraj knocked the HC door for justice.

The HC has directed the Berhampur Town police to ensure expeditious investigation into the incident,

App to counter coronavirus stigma

Bhubaneswar, August 13: As part of its efforts to counter misinformation campaigns on COVID-19, the Odisha government has launched a mobile application, which would provide necessary details and proper guidance to people to help them combat the disease.

The app, developed by the government in collaboration with the United Nations Population Fund (UNFPA), will generate awareness on the pandemic, especially among the younger population, who account for 55.49 per cent of the state's total coronavirus count, a senior official said. Of the 52,653 COVID-19 cases in Odisha, 29,999 are in the age group of 15 to 40 years, and 15,638 in the age bracket of 41 to 60 years, the official said. "The new app will provide scientific information on COVID-19 in English and Odia. It will help dispel myths and prevent os-

tracisation of coronavirus patients." "Videos on safety measures and guidelines to control the spread of the disease, along with other dos and don'ts, are also available on the app. The self-learning software can be downloaded from Google Play Store," the official said.

Chief Minister Naveen Patnaik had Wednesday said those asymptomatic or with mild symptoms are finding it difficult to undergo home isolation due to the social stigma associated with the viral disease.

"This fear and stigma surrounding COVID-19 must be removed from the minds of the people and communities (at large) so that more and more people can opt for home isolation," the CM had said. Jumbos unsafe in Keonjhar as corridor projects in cold storage

Keonjhar, August 13: Rapid deforestation, rampant mining, poaching, electrocution and road accidents are some of the major factors posing risk to elephants in mineral rich Keonjhar district.

The forest department has taken up measures for protection of elephants, but incidents of elephant casualties have not been checked while several elephant corridor projects including Baitarani elephant conservation project in the district remain unexecuted over years, a report said.

Habitat loss coupled with fodder shortage in declining forested pockets often forces the animals to stray out of their habitats into human settlements, resulting in man-animal conflicts.

In the current year, five elephants have died in the district for various reasons. Lack of monitoring on the movement of elephants under Keonihar forest division recently came to light. Two elephants were found electrocuted by poachers in Joda section of Champua range June 14. A forester and a forest guard had been suspended June 18 for negligence in duty. The state government had ordered a Crime Branch probe into the elephant deaths, but it has not started as yet.

According to reports, for safety of elephants, a corridor had been planned in a forest area of 10,000 hectares in four districts. It was named as Baitarani elephant conservation project about 22 years ago. Sadly, the project had been

For safety of elephants, Baitarani elephant conservation project had been planned in a forest area of 10,000 hectares in four districts about 22 years ago. Sadly, the project had been caught in red tape

No step was taken on other elephant corridor projects like Karo-Kamarpada under Barbil range and Telkoi-Palahada elephant corridor under Telkoi range. Lakhs of rupees had been spent on identifying an area for the elephant corridor comprising Karo-Karmapada and Kardangi-Kakudiamba. The elephant corridor was planned for a 32km stretch from Kardangi to Kakudiamba

Some wildlife experts and environmentalists say, the district was once rich with dense forests, but they have depleted over years due to mining and timber smuggling.

The hilly and forested pockets

like Thakurani, Roida, Mahaparvat, Roida, Kalaparvat, Gandhmardhan, Khandadhar, Baula, Daitari, Baitarani and Siddhamath used to be major elephant habitats in the district. However, over years, these habitats have been badly damaged by mining, becoming unsafe for

Apart from mineral mining, quarrying of grantite, laterite, murram, and other minor minerals are said to be responsible for the thinning of the forest cover.

Wildlife conservator(Honourary) Harekrushna Mohant said there is a need for sufficient food in the areas where forest cover is wanproject been executed, the district would not be seeing man-animal

Statistics have it that since 2010 till date, Keonjhar forest division alone has reported 51 elephant deaths. In 2010-11, the district saw deaths of nine elephants while four died in 201-12.

Nine elephants died in 2012-13; four each in 2013-14 and 2014-15; six in 2015-16; two each in 2017-18 and 2018-19; six in 2019-20 and five in 2020-21(till date). According to official data, there are 105 elephants in the Keonihar division

Upset over elephant casualties, environmentalist and honourary wildlife warden Harekrushna Mohant said, "Rampant mining, and declining forest cover resulted in loss of habitat and shortage of fodder threatening elephants' safety."

He added that increasing movement of mineral-laden vehicles, encroachment of forests, infrastructure development projects such as roads and railways and industrial units in the forested pockets have posed serious threat to animals, which stray out and enter villages, leading to man-elephant conflicts.

Experts suggested that underpasses, overpasses, check gates and bridges should be incorporated into a development plan in the forested pockets to mitigate elephant casualties. Additional conservator of forests, Ghanashyam Mohant said."The department has taken tough stand on protection and safety of elephants. 24X7 patrolling and monitoring have been intensified."

Healthcare services in Kendrapara in tatters

POST NEW NETWORK

Kendrapara, August 13: Healthcare services in rural parts of the district have deteriorated due to lack of doctors in 24 public health centres (PHCs), a report said. With the situation already

worsening due to the pandemic, such deteriorating healthcare services have severely hit the residents. The district being flood prone, many people die due to waterborne and vector-borne diseases like dengue and malaria

The situation is quite worrisome in rural areas where there are very few doctors to attend to patients. The situation in urban areas is more or less same as doctors attend to fewer patients due to Covid guidelines. As a result, quacks are ruling the roost in villages while private nursing homes make hay taking advantage of the situation.

An RTI activist Bibhuti Bhushan Rout alleged that around 24 PHCs in rural areas have no doctors. These PHCs are two in Rajkanika, four in Derabish, seven in Mahakalapara, two in



Marshaghai, three in Rajnagar, two in Aul and two each in Garadpur and Pattmundai.

Things have come to such a pass that PHCs in remote areas like Dangamal, Talachua, Ishwarpur villages are going without doctors for last two years. As a result, villagers take the help

of quacks when they fall ill. Quacks, mainly from Bengali community, fleece gullible villagers. The death of a woman and a child at Tantiapala village in 2019 is a case in point.

Pratap Chandra Padhy, a social activist, said dialysis services were suspended at the district headquarters hospital due to pandemic. A few patients turn up at rural health centres due to strict enforcement of social distanc-

The PHCs with doctors don't touch patients due to fear of Covid. The state government engaging many doctors in Covid-19 duties has affected healthcare services.

Sarpanch Basudev Jena of Nikirai panchavat narrating his woes alleged that he admitted his pregnant daughter to a private nursing home due to a mess at the DHH. His daughter delivered a stillborn child there due to medical negligence. He lodged a complaint at Town police station.Contacted, Collector Samarth Verma said the administration is appointing para-medical staff at PHCs with no doctors while doctors are deputed

at regular intervals.

End restrictions

he Reserve Bank of India (RBI), in its latest monetary review meeting last week, decided against extending the six-month moratorium it had allowed, in phases, for customers on repayment of their existing loans. The central bank had allowed a choice to people to decide if they wanted to avail the moratorium on EMIs or continue to pay them. Ending the moratorium was a right decision by the RBI. We have argued in this column how the moratorium was just a charade. The scheme ensured no relief for customers. People availing the moratorium had to pay the principal plus interest and then interest on interest on their defaulted EMIs. It was also not beneficial for banks as they saw massive slippages on their loan books as people skipped having to pay EMIs. Such large scale defaults choked the cash flow even as it created a mess in banks' loan books. Banks were struggling with economic recession. The outbreak of the pandemic further ravaged the economy. Even as the RBI brought down the repo rate by around 150 basis points since February last year, the response from people in terms of loan offtake was tepid. With demand having crashed, industrial activities came to naught. To that extent, the corporate demand also came down. Banks have reported truncated profits. In this backdrop, default of multiple EMIs could push the banks to the brink. Also, accumulation of EMIs swollen by interest would force customers to default on loan repayments - a clear recipe for shooting the non-performing assets (NPAs) of banks. The larger the NPAs, the weaker the banks become. This would eventually force the government to step in with fresh capital. Thus, the moratorium was a loss and loss proposition for all. Therefore, the end of the moratorium story and its replacement by allowing banks to restructure loans and incentivize loanees based on their repayment track record is a welcome move. The banks have been asked to take into account the payment history of consumers as on March 30, 2020. The new policy will provide help to corporates, retail consumers and MSMEs wherein a consumer will be able to restructure his loan amount, the EMI amount and more importantly, the tenure of his loans. This will be applicable for people who have home loans, car loans, personal loans, education loans, loan against property, business loans and term loans, among others.

With inflation having a lot of upside, the RBI has held off on further raising the rates. This must have brought in additional pressure on the Central government to support an economic recovery even as it is struggling with an upsurge in COVID-19 infections across the country. The economy has been going under ever since the government announced the lockdown in March. Thereafter, repeated lockdowns and shutdowns have nipped all hopes of an early revival of the economy in the bud. It has also been proved that the lockdowns and shutdowns have failed to contain the spread of virus which has passed the 2.2-million mark. With the growth in the Gross Domestic Product (GDP) likely to drop to the lowest since Independence, the government must be weighing plans to present another package to stimulate the economy. Hopes are rising on the government to take more demand-boosting measures. Thrust on ramping up of infrastructure projects and a possible cut in Goods and Services Tax (GST) rates could be other possible options for the government. But every effort by the government and the RBI will be futile as long as the government continues with its policy of restrictions. Economy can only be revived if there is a demand comeback and this will happen only after people are allowed to resume their work and jobs. End of restrictions only can catalyse this.



or most countries, navigating the protracted economic slump brought on by Covid-19 is starting to look more like a marathon than a sprint. According to our estimates at the International Finance Corporation (IFC), domestic private investment and foreign direct investment in emerging economies will fall this year by almost \$700 billion and \$250 billion, respectively, and may not return to pre-crisis levels until 2023.

Worse, the crisis is exacting a massive toll on the world's poor and most vulnerable, jeopardizing decades of hard-won development gains. The World Bank warns that we are about to witness the first increase in global poverty since 1998, with up to 100 million people being pushed into extreme poverty.

How governments and firms navigate this uncertain period between shock and recovery will determine whether there is a sound economic foundation upon which to revive employment, long-term growth, and global development efforts. The situation demands that we reorganize and fix markets. Many companies have had no choice but to reshape their business models, now that the pandemic is accelerating changes in how we work, consume, and communicate. These trends could reshape entire industries, creating opportunities for those with the innovative capacity. But governments, too, must seek creative ways to adapt their economies and protect viable firms, while quickly unwinding those that should disappear because they are insolvent or obsolete. This will be a time of trial and error. requiring strategic vision and pragmatism on the part of business and political leaders.

Countries can do three things to speed up the recovery. The first task is to adapt the rules of the game to new realities. A prolonged crisis means that emerging economies will increasingly find themselves ill equipped to help thousands of companies renegotiate their debts. In many low-income countries, an insolvency

proceeding averages more than three years, a half-year longer than the global norm. But with informal out-of-court mechanisms and simplified court proceedings, governments can give viable businesses an opportunity to weather the storm and avoid lengthy legal processes and costly and cumbersome negotiations. Developing countries can also increase the threshold for insolvency and adapt debt-restructuring rules to prevent unnecessary liquidation of firms that are struggling for no other reason than lockdowns.

Second, governments must adopt a "do-no-harm" principle when organising their responses. Wherever possible, the public sector should limit or simply suspend its arrears to private contractors, especially in job-rich sectors and critical supply chains. That will mitigate the damage to balance sheets, prevent viable businesses from going bankrupt, and limit the kind of ripple effects that could delay the recovery.

In Sub-Saharan Africa, public-sector arrears represent 3.3 per cent of the GDP. Clearing them could create the equivalent of a large stimulus package. At the same time, decision-makers should resist the temptation to use much-needed public money to prop up "zombie" firms with unviable business models. Achieving a strong recovery will require a level playing field for private companies.

Finally, all countries need to think strategically about their spending. Some sectors and industries should be retooled, and others should be phased out. For example, as countries and markets shift toward lower-carbon forms of energy and production, it would be counterproductive to continue subsidizing energy-inefficient industries.

Now is the time to start creating and nurturing the businesses of tomorrow. There are many key areas to choose from, including "green" value chains, recyclable personal protective equipment, resilient tourism, and gender-bal-

anced work environments. In countries with large gaps in access to digital financial services, embracing technologies such as mobile money and artificial intelligence could hasten the process of digitalization, setting the stage for robust growth.

But if these countries are to attract investors, they will need to create opportunities – starting now. That is why IFC has made it a high priority to help lay the foundations for boosting private investment and private-sector growth in the developing world. Accelerating private investment will require policy and regulatory reforms to create the right conditions for business, and to generate bankable projects. This was true before the pandemic, and the urgency of reform is even greater now.

Development practitioners, for their part, need to step up their efforts to foster investable opportunities. That means restructuring and recapitalizing firms, investing equity in support of growing businesses and start-ups, and promoting public-private partnerships to attract investors back to emerging and developing countries. To that end, rather than passively waiting for investors, development-finance institutions need to approach them directly with investment proposals, which would generate feasibility studies and get the ball rolling on var-

ious opportunities.

The economic downturn from Covid-19 will inevitably affect many sectors and jobs. But there is hope yet for a strong recovery, provided we learn from past crises. Policymakers need to muster all their creativity to keep the private sector afloat, and to prepare companies for the return to growth.

An e-rickshaw operatorseeing reduced numbers of passengershas converted his vehicle into mobile vegetable kiosk. People engaged in different trades and vocations are adapting themselves to the new COVID-linked situations in smart and engaging ways. A lot of management insights can be gained from these real-life examples. which are not necessarily taught in B-Schools.

There are five deep-rooted lessons from these business models, which can pass by the acronym RAACE. One is Resilience. Street vendors show tremendous resilience to keep business running even in the face of hardships, and these are driven essentially by economic necessity. Many a time, they are harassed by local authorities, subjected to extortions, made to change locations or suffer damage to their stalls. They cope up with such adversities to face another day.

They withstand severe weather conditions to show up at the right place at the right time. They change

their wares to stay relevant to the needs of their customers. During the lockdown, the e-rickshaw owner turned the crisis into a new business opportunity by keeping in mind the geographic elements of proximity and mobility for the consumers.

Another lesson is Agility, which is discovering potentially new opportunities to occupy a slot before others. In the changed scenario, it is important to know what your customers might look for and how you can serve them profitably. The roadside tailor selling face masks is a good example of Agility. One big lesson is the pace of response to the sudden changes and how to make best use of the resources at our disposal. Experimenting with small, new ideashas been an effective mantra for the street vendors. In times of uncertainty, one has to be agile enough to work without a script, test waters and review the outcome.

Three is Action. If agility is what takes you to the desired slot, then it has to be backed by the right set of tangible actions. What has to be done next and how the same can be executed are critical fac-

tors at this stage. It is like a driver taking a detour to save time but he should have the skills to drive on narrow alleys or in poor road conditions to reach his destination. Agility with improper action will be viewed as stupidity. The e-rickshaw owner acted proactively to stock the requisite varieties of fresh vegetables and fruits to cater to the requirements of his customers.

Next comes Convertibility. Since these are not normal conditions. there is a natural tendency to show resistance to anything about which we are not used to. That is human nature; and running a business is no different. Convertibility is adapting to the new scenario. This decides the winners. Like in cricket matches, the team which acclimatizes to the conditions at the earliest wins the matches. During this phase, they resort to tactical measures like a compelling sales pitch or extra deals. The tailor sensed the demand for face-masks during the pandemic and displayed them on the shop front to attract customers.

The above examples bring to the forefront the enterprising qualities of these informal micro-busi-

ness owners. They undertake risks, manage resources, innovate and re-invent their selling skills with changing times. Without formal education, the vendors teach us a lot of entrepreneurial lessons even if they are selling wares in the streets. Although they do not have great knowledge or resources, they believe in trying out something new. They push themselves hard to acquire new customers and master new selling techniques while operating in a constrained environment.

Bootstrapping is another key lesson we learn from them – the manner many ramp up their businesses successfully with meagre resources.

Street vendors constitute an integral part of our retail and distribution system. In these times when standard operating procedures are getting challenged, we can draw a few lessons embedded in the RAACE approach from these streetsmart entrepreneurs.

EXPERTS SAY SOCIAL STIGMA POSES A CHALLENGE AS CORONAVIRUS CAN INFECT ANYONE

Hyderabad, August 13: Amid battling COVID-19, authorities in Telangana are also up against social stigma attached to the disease with a few people even taking the extreme step of ending their lives over fears of its fallout including being ostracised.

Experts say such fears were totally uncalled for and that social stigma was posing a challenge as they pitch for sensitising the people that coronavirus can infect anyone.

Instead of becoming paranoid, the focus should be on taking adequate preventive steps and remaining courageous even in case of testing positive for the virus, doctors said.

The advice of the doctors assumes significance in the wake of a few individuals committing suicide in recent weeks in Telangana out of fear, either before testing positive or after.

Tuesday, a 60-year-old man from Karimnagar hanged himself in the washroom of his room at a private hospital where he was under treatment for COVID-19 with his family members saying he was under panic



after testing positive.

Also, there have been instances of landlords asking tenants to vacate after the latter tested positive and residents not allowing infected people to enter villages.

Dr B Nagender, Superintendent of the state-run Osmania General Hospital (OGH) here, who was cured of COVID-19, said the recovery rate was high and that people need not nurture fears over the virus.

'There will be some fear (after testing positive). But once, if you retain courage, there will be improvement. Many people are recovering, unless there are a lot of risk factors such as old age, uncontrolled blood sugar, hypertension...Otherwise, it is like viral fever... If it is mild, many people are taking treatment from home,' he told PTI.

Those having moderate or severe symptoms need further medical attention, he said.

Nagender, who took treatment at the state-run Gandhi hospital and the Nizam's Institute of Medical Sciences (NIMS) in the city, said

Hyderabad, August 13: Eleven more people died of COVID-19 in Telangana while 1,931 tested positive for the virus, officials said Thursday.

With the new fatalities the death toll rose to 665 and the cumulative case tally mounted to 86,475.

The case fatality rate in the state stands at 0.76 per cent against the national average of 1.97 per cent. Officials said 53.87 per cent of the deceased had comorbidities.

During the last 24 hours ending 8 p.m. Wednesday, the case load in Greater

Hyderabad Municipal Corporation (GHMC) and surrounding districts slumped while the daily count spiked in other districts.

The GHMC recorded 298 new cases against 479 the previous day. Medchal Malkajgiri and Rangareddy bordering GHMC reported 71 and 124 cases respectively. Sangareddy, another district which shares borders with the state cap-

ital, reported 86 new infections. After a day's gap the cases spiked again in other districts. Warangal Urban was the second worst affected district after Greater Hyderabad with 144 new infections. There were 89 new cases in Karimnagar, 84 in Nalgonda, 64 in Suryapet, 59 in Jangaon, 56 in Jogulamba Gadwal and 52 in Jagtiyal. According to the media bulletin released by the Director of Public Health and Family Welfare, the new cases were reported from all 33 districts.

A total of 39 testing laboratories and 323 rapid antigen testing centres conducted a record 23,303 tests against the state's target of 5,600 as per the World Health Organisation (WHO) benchmark of 140 tests per million per day.

Test results of 706 samples were awaited. The state has so far conducted 6,89,150 tests. Officials said 1.780

people recovered from COVID-19 during the last 24 hours, taking the cumulative recoveries to 63,074.

The state further improved its recovery rate to 72.93 per cent against the national average of 70.37 per

cent. The number of active cases now stands at 22,736 including 15.621 who are in home/institutional isolation. More than 84 per cent of those under home isolation are asymptomatic.

Age-wise Covid positive details show that 65.9 per cent of those tested positive were in the age group of 21-50 years. Those above 51 years account for 24.4 per cent. About 10 per cent were aged below 20 years. Officials said 65.10 per cent of those tested positive were male while the remaining 34.90 per cent were female. According to the media bulletin, out of 20,396 beds in the government-run hospitals, 17,734 beds were vacant.

While 118 private hospitals treating COVID-19 patients have a total of 7,879 beds and out of them 3,426

Economic Offences court rejects Swapna's bail plea

Kochi, August 13: Close on the heels of an NIA court denying bail to Swapna Suresh, the prime accused in the gold smuggling case, an Economic Offences Court Thursday, where the Customs has filed a case against her, also refused to give her bail.

The Customs in their argument said that given her huge and wide ranging contacts with higher ups, granting bail to her could be detrimental to the investigation. This was accepted by the court.

After the scam came to light last month and the NIA was handed over the probe, the Central agency had arrested Swapna and her associate Sandip Nair from Bangalore

Swapna was later arrested by the Customs and the Enforcement Directorate and has undergone multiple rounds of questioning from all the agencies

The gold smuggling case was unearthed when P. S. Sarith, a former employee of the UAE Consulate here, was arrested by the Customs July 5 while he was facilitating smuggling of 30 kg gold in the diplobaggage matic Thiruvananthapuram from Dubai.

It turned murkier when the name of Swapna, a former employee of the Consulate and employed with the state IT Department, surfaced and more so when her links with powerful IAS official M. Sivasankar. came out. Sivasankar held the dual

Thiruvananthapuram, August 13: A day after Kerala Chief Minister Pinarayi Vijayan gave the nod to track the mobile call detail records (CDRs) of Covid positive cases in the state, Leader of the Opposition Ramesh Chennithala has demanded to stop the process immediately, terming it a blatant violation of all rules and regula-

"Disease is not a crime and a patient is not a criminal. It was on Wednesday that the CM announced this and even said this has been going on for a while. If so, we want to know where it is written in the Epidemic Act that this can be done. I went through it and there is no such provision. Vijayan is turning Kerala into a surveillance state and we will strongly oppose it.' said the Congress leader.

He added, "In the case of the state government's deal with a USbased firm on processing data related to Covid-19 patients, the high court had clearly directed that data privacy should be maintained. Kochi, August 13: A research project to assess the status of 27 species of marine mammals and five species of sea turtles in Indian waters has been launched by the Central Marine Fisheries Research Institute

With a budget of Rs 5.66 crore, the project is funded by the Marine **Products Export Development** Authority (MPEDA) for three years, the CMFRI said in a statement here Thursday.

The study aims to address the information gap on the status of stocks of marine mammals as well as bycatch of sea turtles, the statement said.

The research assumes significance in the context of emerging seafood trade-related challenges faced by the country. The National Oceanic and

Atmospheric Administration (NOAA), USA, had issued import provisions of Marine Mammal Protection Act (MMPA) stating that seafood exporting countries should not allow intentional killing of marine mammals in commercial fisheries.

For exporting fish and fish products, the US had given a five-year ex-





COVID-19 RECOVERY RATE RISES TO 70.77%

New Delhi, August 13: The COVID-19 recovery rate has risen to 70.77 per cent on Thursday with the total number of patients recuperating from the disease reaching nearly 17 lakh, while the case fatality rate has further declined to 1.96 per cent, the Union Health Ministry said.

It said "record-high" recoveries have led to a decline in the "actual caseload" of the country, which is the number of active cases, and currently is only 27.27 per cent of the total cases. The number of recoveries from COVID-19 exceed active cases by more than 10 lakh.

The country recorded the highest 56.383 recoveries in 24 hours Thursday, taking the total number of recovered patients to 16,95,982. There are 6,53,622 active cases of coronavirus infection in the country, according to the health ministry data updated at 8 am.

"With the increasing number of recoveries, the recovery rate has risen to 70.77 per cent, while the mortality among COVID-19 patients has further regressed to 1.96 per cent, and is steadily declining," the ministry said.

According to the Indian Council of Medical Research (ICMR), a cumulative 2,68,45,688 samples have The country recorded the highest 56.383 recoveries in 24 hours Thursday, taking the total number of recovered patients to 16,95,982

With a record single-day increase of 66,999 cases, India's COVID-19 tally rose to 23,96,637 on Thursday, while the death toll climbed to 47,033 with 942 people succumbing to the disease in 24 hours, the health ministry data showed.

application.

He said the BSP's writ petition bypasses the available remedy. Sibal contended that he has no problem if the BSP and the BJP are directed to approach the speaker for a proper order. Senior advocate Rajeev Dhavan, who represented one of the six MLAs, also started his arguments but hearing remained inconclusive owing to paucity of time. The matter will now be heard Friday.

The petitioners have challenged the merger of the six MLAs --Sandeep Yadav, Wajib Ali, Deepchand Kheria, Lakhan court and demanded a stay on the Meena, Jogendra Awana and Rajendra Gudha -- with the Congress and demanded stay on the execution of the order passed by the speaker.

They contested and won the 2018 assembly elections on BSP tickets. All of them defected to the Congress in September 2019. The MLAs submitted an application for merger on September 16, 2019 and the speaker issued an order on September 18, 2019. BJP MLA Dilawar challenged the merger and filed a petition before the speaker in March this year which was rejected on July 24. Dilawar challenged the decision of the speaker in the high

merger. Similarly, the BSP filed a separate petition against the merger.

The single-judge bench of the high court on July 30 issued notices to the speaker and secretary of the assembly, and the six MLAs but did not give a stay on the merger against which Dilawar approached the division bench with an appeal.

The division bench disposed of the appeal and directed the single-judge bench to decide the matter. The merger of BSP MLAs with the ruling Congress was a boost to the Ashok Gehlot-led government in the state as the tally of the Congress increased to 107 in the house of 200.

Minister confirms SDPI role

The minister said, four people associated with SDPI have been arrested in this regard and investigation is under way. "K G Halli and D J Halli are peaceful since yesterday and there have been no untoward incidents...as the investigation is progressing new information is coming out. I cannot share with you everything, but in the days to come I will share before

the media." Bommai said. He said, as per the information gathered so far and video footage, most importantly the role of SDPI is coming to light. We are collecting more information regarding it, we are investigating deeply in this regard. "Already, several SDPI office-bearers have been arrested. Muzammil Pasha, the SDPI district secretary is the main (person), also Firoz, Afraz Pasha and Shaik Adil, all of them are from SDPI. Their role is completely being investigated and they have been arrested." he added.

Three people were killed after police opened fire to quell a mob that went on a rampage in a city locality on Tuesday night over an inflammatory social media post allegedly put out by a Congress legislator's relative. Pulakeshinagar MLA Akhanda Srinivas Murthy's residence and a police station at D J Halli were among those targeted by the angry mob.

The house of the MLA, who was

not at home at the time, was allegedly set on fire. The rioters also

torched many police and private vehicles, badly damaged the house and looted the belongings of MLA Murthy and those of his sister. An ATM was smashed into pieces. After the arson and violence, the entire DJ Halli resembled a war zone.

Nearly 140 people have been arrested so far, in connection with the incident. Bommai said, through some video footage it has come to light that SDPI workers had come from neighbouring areas of K G Halli and D J Halli, and it is being



New Delhi, August 13: The Bihar government in its written submission to the Supreme Court Thursday said that on account of political pressure in Maharashtra, neither an FIR was lodged nor any cooperation was provided to Bihar Police in the case in connection with the death of actor Sushant Singh Rajput

The Supreme Court has reserved the order on the plea of main accused Rhea Chakraborty seeking transfer of the case registered in Patna to Mumbai. On Tuesday, the apex court reserved the order and asked all the parties in the case to file their written submissions.

"It is apparent that it is on account of political pressure in the



Maharashtra that neither the FIR has been registered by the Mumbai Police nor did they extend any cooperation to Bihar Police in discharging their obligation to conduct investigation expeditiously," said the Bihar government in its submissions before the top court.

Senior advocate Maninder Singh, representing the Bihar government, had argued on similar lines. Criticizing the quarantine of senior Bihar police officer in Maharashtra, the government said, "Whereas on the one hand, the State of Bihar and its officials had acted with all sense of responsibility and regard to authorities of State of Maharashtra, sadly, it has met with complete absence of reciprocation by similar conduct by the authorities of the State of Maharashtra.'

The written submissions also cited that Rhea in the transfer petition relied upon a tweet to the Union Home Minister requesting for investigation by the CBI. "Even in the Additional Affidavit, Petitioner has stated that she has reiterated for investigation by CBI," said the Nitish Kumar government

The state government argued that the attention of the apex court is also invited to the provision of Section 406 of the CrPC, whereunder it has been envisaged to make a prayer for trans-

Whenever there is information regarding commission of a cog-

nizable offence, u/s 154(1) Cr.P.C it is mandatory to register an FIR and conduct investigation immediately and expeditiously.

"No doubt or dispute with regard to jurisdiction would permit, in any manner whatsoever, to cause any impediment in the expeditious conduct of the investigation. It is in this background that Section 406 provides for transfer of the case and not for transfer of the investigation," said the written submissions.

The state government urged the apex court to reject the transfer petition filed by Rhea.

"It deserves to be rejected/disposed of by the orders of this court. "In the facts and circumstances of the present case, it is humbly submitted that no impediment would deserve to be allowed to come in the way of the CBI to undertake and complete the investigation expeditiously,' said the Bihar government.

The 34-year-old actor was found dead in his Bandra flat on June 14. His father registered an FIR in a Patna police station on July 25 accusing his live-in partner Rhea and a few others of abetment to suicide and misusing ₹15 crore from Sushant's bank account

The ED took over financial probe involved in the case on July 31. The CBI took transfer of investigation from Bihar Police August 7.


Bhushan withdraws contempt petition

New Delhi, August 13: Noted journalist N. Ram, advocate Prashant Bhushan and former Union Minister Arun Shourie withdrew their petition from the Supreme Court. The petition sought directions to declare unconstitutional a contempt law provision, which makes scandalising courts an offence

A bench headed by Justice Arun Mishra told the petitioners counsel senior advocate Rajeev Dhavan that it would not permit withdrawal, for refiling again in the apex court after sometime. Justice Mishra observed: "We can permit withdrawal for liberty to go to the High Court." Dhavan agreed to go before the High Court to challenge the validity of the provision of contempt.

This plea created trouble for some officials in the Supreme Court registry, for listing it before a bench other than the one headed by Justice Arun Mishra which has already taken up similar matters. According to sources familiar with the development, the issues connected with the wrong listing of the case were taken up by officials concerned in the top court. The matter was listed before a bench of Justices D. Y. Chandrachud and K. M. Joseph on August 10, later it was deleted and listed on August 13



before a bench headed by Justice Arun Mishra.

According to a senior official, as per practice and procedure in use, the matter should have been listed before the bench, which is already seized with a similar matter, but, had been listed elsewhere by ignoring established practice and procedure. "In this regard, explanation of officials concerned have been called for," said the source.

The Section 2(c)(i) of the Contempt of Courts Act, 1971, defines 'criminal contempt' as publication of anything -- whether by words, spoken or written, or by signs, or by visible representation, or otherwise of any matter or the doing of any other act whatsoever

- which scandalises or tends to scandalise, or lowers or tends to lower the authority of any court. The petitioners have asked the top court to issue directions declaring Section 2(c)(i) of the Contempt of Courts Act, 1971 as being violative of Articles 19 and 14 of the Constitution.

Doc dies of Covid, kin given another body

Varanasi, August 13: In a shocking incident, the mortuary at the Banaras Hindu University (BHU) hospital, handed over the wrong body to the family of Additional Chief Medical Officer (ACMO) who had died of Covid-19.

The ACMO, Dr. Jung Bahadur Singh, had died late Tuesday night and the body was handed over in a body bag to the family Wednesday. The family took the body for cremation at the Harishchandra Ghat and started the cremation rituals.

Just when the pyre had been lit, the family of a Covid-19 patient from Ghazipur who had also died the same day reached there and apprised the ACMO's family of the mix-up. The ACMO's family removed the wrapper to see



"She knows how to make the hard calls. She's ready to do this job on day one. And we're both ready to get to work rebuilding this nation and building a better," the 77year-old Democrat said. He noted that Trump has already started his attacks, calling Harris nasty, whining about how she is.

"It's not a surprise because whining is what Donald Trump does best, better than any president in American history," the former US vice president said. The event was not open to the public due to coronavirus prevention needs. Both Biden and Harris walked on stage wearing masks to address a socially distanced group of masked journalists. Harris said President Trump's mismangement of the COVID-19 pandemic has plunged Americans into the worst economic crisis since the Great Depression.

"It is also important that we help protect the integrity of our elections," the San Franciscobased social media giant said. Facebook and Instagram users can use the tool to check if they are registered to vote and how to do so if they are not.

The social media group said it would from Thursday add labels to voting-related posts on Facebook and Instagram, after last month rolling them out for politicians.

It is also launching a "Voting Alerts" feature to help state and local election authorities communicate with voters about election-related updates.

Lai, along with his two sons and four senior employees of the tabloidstyle newspaper known for its scathing criticisms of Beijing, was arrested on Monday when more than 200 officers raided the Apple Daily offices, sparking an international backlash. In the 40-minute live chat with the US think tank on Thursday, the 72-year-old said he did not expect the arrests to come so early considering the "strong responses from the international community" after Beijing imposed the sweeping national security law

Beijing/Shanghai, August 13: Two cities in China have found traces of the new coronavirus in imported frozen food and on food packaging, local authorities said on Thursday, raising fears that contaminated food shipments might cause new outbreaks.

A sample taken from the surface of frozen chicken wings imported into the southern city of Shenzhen from Brazil, as well as samples of outer packaging of frozen Ecuadorian shrimp sold in the northwestern Xian city, have tested positive for the virus, local authorities said Thursday.

The discoveries came a day after traces of the coronavirus that causes COVID-19 were found on the packaging of frozen shrimp from Ecuador in a city in eastern Anhui province. China has been stepping up screenings at ports amid the concerns over food imports.

Shenzhen's health authorities traced and tested everyone who might have come into contact with potentially contaminated food products, and all results were negative, the city's notice said.

The Brazilian embassy in Beijing did not immediately respond to a request for comment.

"It is hard to say at which stage the frozen chicken got infected,"



said a China-based official at a Brazilian meat exporter.

The Shenzhen Epidemic Prevention and Control Headquarters

said the public needed to take precautions to reduce infection risks from imported meat and seafood. The health commission of

Shannxi province, where Xian city is located, said authorities are testing people and the surrounding environment connected to the contaminated shrimp products sold in a local market.

In addition to screening all meat and seafood containers coming into major ports in recent months, China has suspended some meat imports from various origins, including Brazil, since mid-June.

The first cluster of COVID-19 cases was linked to the Huanan seafood market in the city of Wuhan. Initial studies suggested the virus originated in animal products on sale at the market.

Li Fengqin, who heads a micro-

biology lab at the China National Center for Food Safety Risk Assessment told reporters in June the possibility of contaminated frozen food causing new infections could not be ruled out.

Xinfadi market in China's capital city Beijing, a sprawling food market linked to cluster infections in June, where virus was found on the chopping board on which imported salmons were handled, will

be reopened from the weekend. How the virus entered Xinfadi market in the first place is yet to be determined, the Chinese Center for Disease Control and Preventionsaid in its latest update of the investigation in July.

New Delhi, August 13: Retail inflation rose to 6.93% in July, mainly driven by rising prices of food items like vegetables, pulses, meat and fish, government data showed Thursday. The inflation based on the Consumer Price Index (CPI) stood at 3.15% in July 2019.

Retail inflation for June has been revised upwards to 6.23% from the earlier estimate of 6.09%, as per the data released by the National Statistical Office (NSO).

The Reserve Bank of India (RBI) has been mandated by the government to keep the CPI-based inflation at 4% (+,- 2%). Retail inflation has remained above the 4% mark since October 2019. Last week, the RBI had kept interest rates on hold to contain elevated inflation. The central bank mainly factors in retail inflation while arriving at its bi-monthly monetary policy.

As per the NSO data, inflation in rural India was 7.04%, while in urban areas it was 6.84% during July, translating into a combined rate of price rise of 6.93%.

The rate of price rise in 'meat and fish' segment was 18.81% in July over the same month last year. Similarly, the annual inflation was 12.41% in 'oils and fats' and 11.29% in vegetables. The annual inflation in the food basket was 9.62%,

NSO collected prices from 1,054 (95%) urban markets and 1,089 (92%) villages during the month of July 2020, an official release said.

The price data are usually collected from selected 1,114 urban markets and selected 1,181 villages through personal visits by field staff of the Field Operations Division of NSO, under the Ministry of Statistics and Programme Implementation, on a weekly roster.

Commenting on the data, Aditi Nayar, Principal Economist, ICRA, said the CPI inflation hardened to a sharper-than-anticipated level, led by core items that are still adjusting to the new demand-supply dynamics, even as the increase in food inflation was along expected lines. Zydus Cadila launches India's cheapest Remdesivir version

New Delhi, August 13: Drug firm Zydus Cadila Thursday said it has launched Remdesivir under the brand name Remdac, used for treating patients suffering from severe symptoms of COVID-19, in the Indian market.

Priced at ₹2,800 per 100 mg vial, Remdac is the most economical Remdesivir brand in India, Zydus Cadila said in a regulatory filing.

The company said the drug will be made available across India through the group's distribution chain reaching out to government and private hospitals treating COVID-19 patients.

"Remdac is the most affordable drug as we would like to enable patients to have access to this critical drug in the treatment of COVID-19," Cadila Healthcare MD Sharvil Patel said.

Through the course of this pandemic, the company's efforts have been focused on supporting people in this healthcare crisis, whether it is through developing vaccines, ramping up production and dis-



tribution of critical drugs and therapies, making diagnostic tests available or exploring new treatment options, he added.

The active pharmaceutical ingredient (API) for the drug has been developed and manufactured at the group's API manufacturing facilities in Gujarat, Zydus Cadila said. Complete backward integration makes Remdac the most economical

Remdesivir brand in India, it added. In June this year, Zydus had entered into a non-exclusive agreement with Gilead Sciences to manufacture and sell Remdesivir, the investigational drug, which has been issued an emergency use authorisation by the US Food and Drug Administration (USFDA) to treat patients suffering from severe symptoms of COVID-19, the filing said. Zydus Cadila's vaccine ZyCov-D is now in phase-II of clinical trials, it added.

Zydus Cadila is the fifth company to have launched its generic version of Remdesivir in India. Hetero Labs, Cipla, Mylan and Jubilant Life Sciences have already launched their generic versions of antiviral drug Remdesivir in the country.

Exports of gems, jewellery slump 38% in July _

Mumbai: India's gems and jewellery exports fell 38% in July from a year ago to \$1.36 billion as shipments of cut and polished diamonds plunged because of the nCoV, a trade organisation said Thursday. The industry was hit twice because of the nCoV, with export orders evaporating and then a shortage of workers caused by a national lockdown to stop the spread of the virus. India's cut and polished



diamond exports in July fell 39% from a year ago to \$918.4 million, the Gems and Jewellery Export Promotion Council (GJEPC) said. In the April to July period, cut and polished diamond exports plunged 46.5% from a year ago to \$2.7 billion, it said.

India announces \$500 million package

for Maldives New Delhi: India will fund the implementation of a major connectivity



project in Maldives through a \$400 million line of credit and \$100 million grant, External Affairs Minister S Jaishankar said Thursday after holding wide-ranging talks with his Maldivian counterpart Abdulla Shahid. The 6.7 km Greater Male Connectivity Project (GMCP) will be the largest civilian infrastructure project in

Maldives, connecting Male with three neighbouring islands: Villingili, Gulhifahu and Thilafushi, officials said. People familiar with the GMCP said it was a key election promise of the ruling MDP for which the President of Maldives Ibrahim Mohamed Solih sought India's assistance during his meeting with Jaishankar in September last year.

INDIAN STARTUPS LURE TALENT FROM TIKTOK, HELO

New Delhi, August 13: A number of Indian startups in the field of social media that came into prominence following the ban on TikTok and Helo, along with other Chinese apps in June, confirmed Thursday that they are attracting talent from these companies as they face uncertainty over their India operations in the long run.

Chinese unicorn ByteDance, which owns TikTok and Helo, has nearly 2,000 employees in India.

"We've got various interests from the employees of ByteDance and other competitive companies. We have received close to 100 resumes from them." Sumit Ghosh, CEO and Co Founder, Chingari App, told

The homegrown short video app Chingari which recently raised 1.3 million (around ₹10 crore) in a seed round currently has just about 25 employees.

Short video-making app Rizzle said that about 10 former TikTok employees have joined it.

"Rizzle attracts a number of sharp engineers, marketers, and other talented individuals from a variety of companies across India. which includes ByteDance among others. An approximate of 10 employees have joined us," informed Lakshminath Dondeti, Co-founder,

This app that allows its users to make 60-second videos said it currently has about 100 people working



In a bid to provide a sense of normalcy to its close to 2,000 employees in India, ByteDance has initiated a performance-review cycle.

Soon after Indian announced the ban on TikTok, along with 58 other apps over national security concerns, TikTok CEO Kevin Mayer who is also the COO of ByteDance said that employees are the company's "biggest strength" and their well-being its "top-most priority".

However, these assurances appeared to be not enough to calm the minds of many of the company's anxious employees.

While many of them are seeking opportunities with apps like Chingari and Rizzle, it is only natural that some will seek opportunities with bigger companies like ShareChat which is seeking to fill many positions like Business Analyst, Product Analyst, Product Manager and Data Scientist, among others, in Bangalore.

Another short video-sharing app, Mitron, which became popular in the wake of the anti-China sentiment, is also looking to hire "the best

'ByteDance in talks with Reliance'

New York: China's ByteDance is in early talks with Reliance Industries Ltd for an investment in its video-based app TikTok's business in India, TechCrunch reported, citing sources. The two companies began conversations late last month and have not reached a deal yet, according to the report. Reliance, ByteDance and TikTok did not immediately respond to Reuters requests for comment. Lisbon, August 13: Arguably the pick of the quarterfinal ties in this season's Champions League will take place in Lisbon Friday night as Barcelona take on Bayern Munich for a spot in the final four.

Barca overcame Napoli in the quarterfinals to book their position at this stage of the competition, while Bayern breezed past Chelsea to ensure that they would be present in the last eight.

Incredibly, this is Barca's 13th successive Champions League quarterfinal - a competition record but they have not won the European Cup since 2015, which is too long for a club of their ilk.

The Catalan giants were incredibly knocked out by Liverpool in the semifinals last season despite a 3-0 victory in the first leg and will be determined to go all the way to the final on this occasion.

There is certainly pressure on Barca as they probably need to win this season's competition to make it a successful campaign. Indeed, they have relinquished control of the La Liga title to Real Madrid, and it would be fair to say that all is not well in the camp following a

difficult domestic season. Barca have only lost two of their last 31 Champions League games, though, and are unbeaten in their last six matches against German clubs since a secondleg defeat to Bayern in the semifinals of the 2015 competition.

Quique Setien's side were far from perfect against Napoli in the round of 16, but a 3-1 victory at Camp Nou saw them book their spot in the quarterfinals courtesy of a 4-2 aggregate success.

The Spanish outfit cannot be written off in any game due to the presence of a certain Messi, although it would be fair to say that the team will have to play a lot better than they have done for the majority of the 2019-20 campaign if they are to book their spot in the semifinals of the competition.
