

# Rivers in Balasore, Bhadrak in spate

TWO PEOPLE WASHED AWAY IN MAYURBHANJ. WHILE ROAD LINKS IN SEVERAL PLACES DISRUPTED

Bhubaneswar/Balasore/Bhadrak, August 20: Even as heavy rains continued to batter various parts of the state over the last few days, water levels in Budhabalanga, Jalaka and Subarnarekha rivers have started swelling in Balasore Thursday.

According to reports, the upper catchment areas of the river have recorded heavy rainfall, which has caused influx of floodwaters into the river. Many low-lying areas under the Sadar block were inundated.

Nine panchayats under the Sadar block were submerged while communication with various parts has been

Similarly, water levels in Jalaka and Subarnareksha rivers too have risen. Even as people in riparian pockets are staring at floods, the district administration has kept a strict vigil on the situation. The water level in Jalaka river at Mathani in Balasore district is flowing at 6.6 metres above the danger mark of 5.5 metres.

Reports from Bhadrak said, low pressure-induced rains during past several days has caused Baitarani river to overflow at Akhuapada anicut Thursday morning. The river's water level reached 17.56 metres at 6 am, as against the danger mark of 17.83 metre.

Water level in Baitarani river has been rising by 0.89 metre every hour. As a result, low-lying areas under dif-

ferent blocks in Bhadrak district have been submerged under rainwater, following low pressure-induced rain. Rainwater will reach the danger mark soon, if rain continues in the upper catchment areas of the river.

Road link between Tinikuda and Balikera in Puri district was disrupted as a temporary bridge over Bhargabi river was swept away by floodwaters. In Kandhamal district, road communication between Phulbani and Dakapala was disrupted due to overflowing of Salunki river.

Similarly, the water level in Hati river in Kalahandi district is also rising, while road communication between Dharmagarh and Junagarh in Kalahandi has snapped as water is flowing over the highway. The waters

level in Indravati and Vaskel rivers in Nabarangpur district too have risen, but there is no flood situation there at present. Special Relief Commissioner (SRC) PK Jena said.

Water-logging was also reported from several low-lying areas in Kendrapara, Dhenkanal, Nabarangpur, Koraput and Boudh districts, he said.

Jena said the state recorded average rainfall of 59 mm since Wednesday and two persons were swept away by strong current while crossing Jambhira river at Golmuhan Ghat in Mayurbhanj district. Nabarangpur district reported the maximum rainfall of 130.6 mm. while Malkangiri district experienced road communication snapped and low lying areas inundated due to the in-

In view of heavy rainfall forecast by IMD, Chief Secretary AK Tripathy held a video conference with senior officials, including Collectors, to review the situation arising out of heavy downpour

After the meeting, Jena said five districts received more than 100 mm rainfall, while ten others reported more than 50 mm.

Revenue and Disaster Management Minister Sudam Marndi who took stock of the situation, said the situation is under control and there is no fear of flood though the water levels in several rivers in the state is rising. The district Collectors have been asked to conduct a thorough assessment of the damage caused by the rainfall and submit detailed reports, he said.

# SC to Bhushan: Take 2-3 days to reconsider your statement

New Delhi, August 20: The Supreme Court Thursday granted time till August 24 to activist-lawyer Prashant Bhushan to reconsider his "defiant statement" refusing to apologise and tender "unconditional apology" for contemptuous tweets against the judiciary and rejected his submission that quantum of punishment be decided by another bench.

The top court, while reserving its verdict on the quantum of sentence to be awarded to Bhushan in the case, also rejected his submission seeking deferment of the hearing till his yet-to-be-filed review plea against its verdict, which held him guilty of contempt of the court, is decided. A bench headed by Justice Arun Mishra said it may now hear the matter August 25 for considering the "unconditional apology" if filed by Bhushan.

Reminding Bhushan of 'lakshman rekha', the top court asked as to why it has been crossed and observed that it has been asked to commit an act of "impropriety" by sending the case to some other bench for hearing the arguments on quantum of sentence in the contempt case.

"Arguments have been heard in the main matter, on sentencing. Order reserved. We have given time to the contemnor (Bhushan) to sub-



ttorney General KK Venugopal urged the bench, also comprising Justices BR Gavai and Krishna Murari, not to ard any punishment to Bhushan in contempt case saying he has already been convicted

The bench said it cannot consider the request of Venugopal unless Bhushan reconsiders his earlier stand of not apologising for his tweets

mit unconditional apology, if he so desires. Let it be filed by August 24. In case, apology is submitted, the case to be posted for consideration on the same, August 25," the bench said.

The apex court, August 14, had held Bhushan guilty of criminal contempt for his two derogatory tweets against the judiciary saying they cannot be said to be a fair criticism of the functioning of the judiciary made in the public interest.

He faces simple imprisonment of up to six months or with a fine of up to ₹2,000 or with both as punishment. "We can give you time and it is better if you (Bhushan) reconsider it. Think over it. We will give you two-three days' time," the bench told Bhushan, who held his ground by refusing to apologise for the tweets.

"I did not tweet in a fit of absence mindedness. It would be insincere and contemptuous on my part to offer an apology for the tweets that expressed what was and continues to be my bona fide belief." he said.

The activist lawyer, however, said he will think over the suggestion of the bench, also comprising Justices BR Gavai and Krishna Murari, which posted the matter again August 25

Bhushan, represented by senior advocates Rajeev Dhavan and Dushyant Dave, also addressed the bench and quoted Mahatma Gandhi.

"I do not ask for mercy. I do not appeal to magnanimity. I am here, therefore, to cheerfully submit to any penalty that can lawfully be inflicted upon me for what the Court has determined to be an offence," he said.

### Acid cure for snakebites in Dhenkanal village

OHRC directs District Collector, SP to submit probe report within 15 days

Bhubaneswar, August 20: The Odisha Human Rights Commission (OHRC) Thursday directed the Dhenkanal District Collector and Superintendent of Police to probe the alleged use of acid by a quack to treat snakebites putting the life of patients in danger.

Taking a suo motu cognizance, the commission asked the district authorities to submit separate probe reports within 15 days of the receipt of the order.

Notably, despite the rapid progress in medical science, people in remote villages are still falling prey to quacks, leading to a cursed life for the victims. The three victims of Mrudangapalli village under Motanga police limits in Dhenkanal district are instance of this.

According to available information, something bit the toe of a 25-vear-old woman August 17 and fearing that she was bitten by snake, the lady was taken to a quack in a nearby village. The practitioner treated her by pouring acid on the affected leg. The next morning, her leg turned black and there were dark blisters.

Similarly, another 45-year-old woman was stung by a scorpion

15 days ago. She was also taken to the same practitioner who treated her in the same way. During treatment, the woman complained of giddiness, and the practitioner smeared acid on her head too.

Instead of getting cured, blisters formed on her entire body. She was immediately rushed to a nearby hospital. Now she is cured but is under severe mental stress due to the black spots on her head.

The third victim of such bogus treatment is 30-year-old Niranian Behera. A snake fell on him from the roof of his house August 15. He caught hold of the snake with his right hand and threw it away. Fearing the snake might have bitten him, he went to the same practitioner. Following the same treatment process, the quack applied acid on his right hand forcing the patient to undergo unbearable pain. Later, blisters appeared on his hand and some body parts.

On being questioned, the practitioner denied charges of using acid and said that he applies a liquid medicine for treatment using a brush.

When contacted, Forensic Medicine Department, AIIMS, Bhubaneswar, additional professor, Dr Sudeepta Ransingh said, "The marks on the hand of the patient look like acid burn marks.'

### **Russian Oppn** leader Navalny poisoned, in ICU

Moscow, August 20: Russian opposition politician Alexei Navalny was placed on a ventilator in a hospital intensive care unit in Siberia after falling ill from suspected poisoning during a flight, his spokeswoman said Thursday morning.

The 44-year-old foe of Russia's President Vladimir Putin felt unwell on a flight back to Moscow from Tomsk, a city in Siberia, Kira Yarmysh said on Twitter. "The plane made an emergency landing in Omsk. Alexei has a toxic poisoning," Yarmysh tweeted.

She told the Echo Moskvy radio station that Navalny was sweating and asked her to talk to him so that he could "focus on a sound of a voice." He then went to the bathroom and lost consciousness.

Yarmysh says the politician must have consumed something from the tea he drank this morning. "Doctors are saying the toxin was absorbed quicker with hot liquid," she tweeted, adding that Navalny's team called police to the hospital.

The politician is in grave condition, Russia's state news agency Tass reported, citing the chief doctor at the hospital.

Last year, Navalny was rushed to a hospital from prison where he was serving a sentence following an administrative arrest, with what his team said was suspected poisoning. Doctors then said he had a severe allergic attack and discharged him back to prison the following day. Navalny's Foundation for

Fighting Corruption has been exposing graft among government officials, including some at the highest level. Last month, the politician had to shut the foundation after a financially devastating lawsuit from Yevgeny Prigozhin, a businessman with close ties to the **MORE P10**



# More tests, unlock behind nCoV spike: BMC

POST NEWS NETWORK

Bhubaneswar, August 20: In the wake of a surge in COVID-19 cases in the Capital city, Bhubaneswar Municipal Corporation (BMC), Thursday, clarified that the rise in cases is due to increased testing and resumption of economic activities in the city.

Bhubaneswar, Thursday, reported 319 new cases taking the city's tally to 6,396. This also marked the second day in a row where the city reported more than 300 cases with Monday witnessing as many as 370 cases. In fact, the average cases recorded in the city during last seven days was 257 which was only 153 previous

"The surge in cases has largely been due to increased testing. While a week ago we had about 1,500 tests daily it has been increased to about 2,500 to 3,000. 

## ₹16,786Cr spent on jobs for migrants: Centre

New Delhi, August 20: The Centre Thursday claimed that in the past seven weeks it has spent Rs 16,786 crore to provide employment opportunities to migrant workers in six states, including Odisha, under Garib Kalyan Rojgar Abhiyaan (GKRA).

According to Rural Development Ministry, a total of about 21 crore man-days have been provided to migrants by the seventh week. Also, a large number of physical assets including 77,974 water conservation structures, 2.33 lakh rural houses, 17,933 cattle sheds, 11,372 farm ponds and 3,552 community sanitary complexes have been created during the

The ministry also revealed that 6,300 projects have been taken up through District Mineral Foundations (DMFs). This apart, 764 gram pan-



chayats have been provided internet connectivity and 2,5487 candidates have been imparted skill training through Krishi Vigyan Kendras (KVKs) under GKRA.

Significantly, the programme was launched by Prime Minister Narendra Modi in June to boost employment and livelihood opportunities for migrant workers returning to their native places and affected citizens in rural areas in the wake of COVID-19 pandemic

GKRA has been implemented in four districts, including one aspirational district, in Odisha.

The two then took him to a house in Chandrasekharpur locality promising to provide him with a teenage girl. However, after they reached the place, the duo physically assaulted the businessman and decamped with two mobile phones, newly-bought luxurious car and cash of the victim.

Following a complaint, Khandagiri police initiated a probe and apprehended the two accused. The vehicle was recovered from Palashpalli. Police sources claimed that hunt is on to nab three absconding members of the gang.

# **Prank calls stymie 104 helpline**

Bhubaneswar, August 20: The 104 helpline service, which has proven to be a lifesaver for many anxious patients during the pandemic, continues to be marred by hoax

The call centre management, however, has little option in this regard. At a time when the pandemic is surging in the state, each call has to be treated like an emer-

"We have issued instructions to our employees to take each call as an emergency call. We are receiving up to 500 hoax calls per day which comprise abusive pranks and hoax calls which divert our resources unnecessarily," said Sabyasachi Biswal, state head, Ziqitza Healthcare, which manages 108, 102 and 104 helpline numbers in the state.

The agency has even lodged police complaints in this regard. Cops have also taken action against many such callers too. The 104 helpline is operational since July 2019. It was earlier used for grievance redres-

identify, classify, register, escalate and track complaints/grievances. It was however diverted to be used as a COVID Helpline from March.

The call centre has now increased its capacity and even allowed the employees to work from home for those living in containment zones and high burden areas. The service provider, however, claimed that the load on 108 ambulances in the state had gone up by 25 per cent in March 2020 but in July, the calls seeking its services have come down.

The load on 108 and 102 Ambulance had gone up by about 25% post March 2020. This was primarily because of complete de-

pendency of the citizens on the state-run Ambulance service due to lockdown. However, calls for ambulance has come down in Julv 2020 due to the introduction of Tele-Medicine facilities at most District Head-quarter Hospitals," he said.

The 108 Ambulance service has refrained from transporting COVID patients. The service provider said all suspected and COVID positive patients are taken through special ambulances positioned at all Block Headquarters. "As an ambulance needs to be sanitised and kept out of service for 24 hours after carrying a COVID patient, we are avoiding carrying such cases in 108 or 102

# COVID-19 surge continues in Khurda

Bhubaneswar, August 20: With detection of 524 fresh cases, the highest in a day so far, Khurda which had surpassed Ganjam in terms of a daily spike August 7 continues to be on the top among the COVID-19 hotspot districts in the state, an official said Thursday.

The district has been reporting the highest number of daily cases for the past few days now. The number of daily cases, which stood between 200 and 300 till August 13, crossed the 300-mark August 14 and 15. On Wednesday, Khurda reported 466 cases of COVID-19. A day earlier—Tuesday, the district registered 419 cases, sources said.

On Thursday, Odisha's COVID-19 caseload crossed the 70,000mark as 2,898 more persons tested

eight fresh fatalities pushed its coronavirus death toll to 380, an official of Health and Family Welfare (H&FW) department said, adding that the fresh infections reported from all the 30 districts have taken the state's COVID-19 tally to 70,020.

Of the fresh cases, as many as 1,792 new infections were detected in quarantine centres, while 1,106 people tested positive for the coronavirus during contact tracing exercise. According to the state government. Khurda district that

encompasses the Capital city Bhubaneswar registered 524 new cases, followed by Cuttack (241), Nayagarh (232) and Ganjam (226). The remaining districts reported less than 200 fresh infections each. The twin cities of Bhubaneswar and Cuttack reported 319 and 150 COVID-19 cases respectively.

Out of the fresh fatalities, Ganjam reported four while Cuttack, Dhenkanal, Khurda and Puri districts reported one death each, the

Meanwhile, 1,641 persons recovered from the disease. Thursday, the H&FW department tweeted.

Ganjam accounted for 166 of the state's 380 COVID-19 deaths, followed by 52 in Khurda, the official further said, adding that 53 novel coronavirus patients have so far died in the state due to other ailments. Odisha has so far tested 11,15,947 samples for COVID-19, including 53,478 Wednesday, the official pointed out. Meanwhile, an official report said that so far 36 COVID warriors have lost their lives in their fight against the coronavirus. They included 11 teachers and nine police personnel.

In Ganjam district alone 29 COVID warriors have lost their lives. Gajapati district reported three deaths while one COVID warrior each in Nayagarh, Bhadrak, Puri and Sambalpur had also passed away.

### Finance co alleges fraud by fake lady IPS officer

She gave two blank cheques and Rs 25,000 to the owner and took away the bike worth around Rs 2 lakh. However, when the time came to encash the cheques, the showroom owner found out that the finance company mentioned in the form did not exist.

Following her arrest, the com-

pany authorities lodged a complaint with Badagad police in Capital city alleging foul play.

As per the complaint, on 6 August, Behera reportedly applied for a two wheeler Loan from our Company and submitted Copy of her Pan Card, Aadhar Card and Bank Passbook with the State Bank of India, branch at Janapath near Ram Mandir. She applied for the loan by posing as a Clerical Staff of Odisha Secretariat.

The bank later granted the loan amounting Rs. 58,000 to buy the Honda scooter 12 August.

Earlier, Behera was also detained by Capital police during lockdown in April for ordering the subordinate police staff to supply various essential commodities and arrange vehicle passes for her.

# 17 yrs on: No Moef nod to Rengali canal 'Fertilizer crunch' hits farming in Nuapada; farmers in lurch

Jajpur, August 20: Hopes of farmers in this district of getting water from the Rengali multipurpose project are drying up fast with the proposal for construction of the left canal of the project hanging fire, a report said.

This is because the project awaits environmental clearance from Union Ministry of Environment and Forests (MoEF) for 17 years.

The construction of the left canal on Brahmani river was undertaken to provide irrigation to farmers of Sukinda, Danagadi and Korei blocks in Jajpur district. However, the construction failed to move ahead as the project is yet to get green clearance from the Centre. The state water resources department had applied for the second phase environmental clearance from the Union government in 2003.

However, the Centre is yet to give its nod. With time running out, Rajendra Kumar Pattnaik, director (R&R), water resources department, has urged the forest department to convert 875 hectares of forest land and hand over the same for construction of the right and left canals of the project in the second phase. Pattnaik has written a letter to the special secretary, state forest and environment department in this regard. Sources said, the construction of

the Rengali multipurpose project was planned in 1980s to provide water to non-irrigated farmlands in the state.

The left canal of the project of 141-km in length was to pass through Jajpur district. The canal, when completed, will help in irrigating 90,500 hectares of farmlands in this district. The land acquisition for the project has picked up but the conversion of the forest land and its subsequent handover is moving at a snail's pace due to lack of environmental clearance.

The state water resources department had sought conversion of 2159 hectares of forest land in 1993 out of which it received environmental clearance for 2107 hectares in the first phase, November 21, 1996. The state water resources de-

partment again applied for the environment clearance on forest land in the second phase in 2003. The MoEF agreed to give environmental clearance on fulfillment of 21

conditions. The state water resources department observed all the conditions and re-applied for a clearance in 2014 for conversion of 1295 hectares of forest land under Angul. Dhenkanal, Athagarh, Cuttack and Keonjhar forest divisions.

Later, the MoEF directed the state forest and environment department (letter no-20941, dated-November 11, 2016) to file a fresh application for conversion of forest land comprising 434 of forest land which was left out in the first phase. It was then decided to use 434 hectares of jungle land for con-

Notably, Sukinda block having 4760 hectares of farmland, Danagadi block with 2881 hectares and Korei block with 4855 hectares of farmland lack any canal for irrigation. The farmers use only lift irrigation, bore wells, minor irrigation and dug well which fail to irrigate even 25 per cent of farmlands in these areas.

When contacted, Purna Chandra Chowdhury, assistant chief engineer of Rengali project, said the project work has failed to move ahead due to lack of environment clearance. Sudarsan Patra, divisional forest officer of Cuttack division, said this is an old case and steps are being taken to expedite

Nuapada, August 20: Even as farming activities are peaking up, farmers in various parts of Nuapada district faced a severe shortage of fertilizers. Amid reports of black marketing of fertilisers, the administration is said to be conducting raids on hoarders, a report said.

They pointed out that the government had made a provision to supply fertilizers at subsidized rates through agriculture department and the cooperative societies, but this has become a farce.

They also alleged that fertilizer traders, companies and officials of the agriculture department formed a racket that has been creating an artificial shortage of fertilizers so that farmers will be bound to buy fertilizers at high prices from open market.

Such a mess in fertilizer supply has come at a time when the post of district agriculture officer is lying vacant. An agriculture officer from Kharial is looking after the duties of the DAO. Reports said, the artificial shortage of fertilizer has affected farmers in Belatukuri, Sarahanga, Dharambandha, Parkoda, Sahipallla, Udvanbandh, Pendarabandh, Budhikomana, Boden, Sinapalli and Sanamaheswar. Farmers alleged that black mar-



keters are taking advantage of the situation and selling fertilizers at high prices. Farmers demanded immediate supply of fertilizer as paddy crops badly required urea at the present stage for growth of its plants.

"If the fertilizer is not applied in the right time, it will affect the growth of paddy plants and the yield," they said.

On the other hand, the administration has sealed some fertilizers godowns, but this action of the administration is a gimmick, farmers alleged. In the current year, the district requires 9000 metric tonnes of urea, but the quantity of fertilizers supplied is much less.

Only 2500 quintals of fertilizers were received in the first phase and 1250 quintals in the second

phase. As per guidelines, half of

fertilizers should be supplied to co-

operative societies for farmers. Only 4350 quintals were given to cooperative societies while 8,150 quintals were provided to authorized dealers. "As farmers fail to get fertilizers at cooperative societies, they have to buy from traders at Rs 280/290 per packet while a packet of fertilizer should be sold at Rs 266.50," farmers said.

Following allegations, the administration has started raids at different places. DAO-in-charge. Narottam Behera said the allegations will be probed.

# Man-elephant conflict proves costly for Odisha farmers

Athgarh/Keonjhar/Sundargarh, **August 20:** Over the years, humans have taken over vast tracts of wildlife habitats in Odisha leading to a rising number of man-animal conflicts that often prove fatal for both animals and humans. Crop loss is also a col-

lateral loss from these conflicts. With kharif season here, wild elephants frequently move towards human settlements and destroy standing crops. Elephant herds often damage agricultural lands, houses and eat up stocked paddy. These incidents are common in Cuttack,

Kenojhar and Sundargarh districts. Cuttack: In Cuttack district's Tangi area, two elephants from Kaliamba forest in Dlaijoda reportedly damaged the house of Rukmini Sardar in Badapokhari village. The jumbos destroyed rice sacks after breaking

the wall of Sardar's house. "The elephants damaged my house and ate away my rice and paddy which I had stocked for the year.

the rest of the year," lamented Sardar. When asked, Safa Range forester Chandra Sekhar Das said, "The department is aware of the matter. After assessing Sardar's loss caused by elephants we will provide compensations to her"

Keonjhar: Elephant menace returned to haunt villagers in the beat area of Patna forest range in Keonjhar district after a herd of 22 elephants from Karanjia forest range went on a rampage and destroyed crops, locals said. The paddy crop damaged by elephants comes after Cyclone Amphan ravaged the farmland last year. The forest department, meanwhile, has been accused of failing to keep the animals at bay. This has



led to discontent among locals.

The farmers said that Cyclone Amphan extensively damaged their crops, and on top of that elephants damaged whatever was left.

For the last two days, animals have been damaging crops at villages like Binida, Balipasi and Mangalpur, and farmers are spending sleepless nights trying to drive

them away. The farmers fear that if the elephant menace is not checked they will have to give up farming.

According to forest officials, the elephants had made their way from Karangia forest range to Patna for est range in search of food. The forest officials are taking steps to drive elephants away from the local settlements.

The forest officials assured the villagers for compensation for the damage. Frequent intrusions by the elephants to the farmlands have robbed farmers of their sleep. Crops in large tracts of farmlands were destroyed in these three villages. This situation has led to widespread panic among the villagers.

Sundargarh: Like the above two districts, the pachyderms have caused severe damage in villages such as Koida, Jarada and Barsuan areas of Sundargarh. Elephants reportedly ate up rice after damaging two houses in Dengula panchavat and also destroyed acres of agricultural land in Kindro village under Jarada pan-

On the other hand, the forest department said they are trying to drive out elephants. Barsuan forester Nabin Pradhan assured the farmers to compensate for their loss.

## Plug GST loopholes

 $\P$  he goods and services tax (GST) regime, especially its architecture and implementation, continues to bug the authorities. Fraudsters keep exploiting the loopholes in the system. In our state alone, GST frauds worth thousands of crores of rupees have come to light. In the latest of such frauds, the state enforcement squad Monday busted a racket and held its kingpin for defrauding the exchequer by ₹712 crore by way of fake invoicing and passing bogus input tax credit (ITC) of ₹129 crore through multiple chains. Fake invoicing, registration of bogus firms and fraudulent ITC seem to be the biggest problems besetting the indirect tax system. Various enforcement authorities in the country have initiated more than 6,000 cases of tax evasion relating to fake invoicing and bogus firms. Many arrests have been made. In the latest case here, the mastermind, Kashmira Kumar Agrawal, Director of M/s Madhusmita Steels Industries, availed bogus ITC of ₹114 crore and passed on bogus input tax credit of ₹129.09 crore in the names of 14 fictitious firms operated by him on the strength of fake invoices. There are thousands of such cases. It would not be possible for the government to recover the entire money lost fraudulently. So what went wrong with the ambitious indirect tax regime rolled out in the country in July 2017? In fact, technology which was supposed to be the bedrock of its success has turned to be its biggest reason for its failure. The new law had set out to provide a 100 per cent IT-based solution. For this, the GST Portal was developed. The portal was meant to record all transactions and receipts from an entity from A to Z. After cross-verification, the portal allowed input tax credit. However, the portal has failed miserably to perform this assigned task. While it was meant to cross-verify the ITC on a monthly basis, such cross-verification happened after six months allowing sufficient time to fraudsters to make a complete ass of the system. With no tracking or cross-verification mechanisms available to pin down the fraud, the authorities were completely clueless about the irregularities that were taking place.

The Modi government, in its rush to earn political plaudits, had railroaded the GST in 2017 without ensuring that there has to be a robust IT infrastructure to support the system. There was absolutely no reason to be in such a hurry to roll out the system. It was introduced at a time when the IT infrastructure for the system had not been fully developed, or tested. For an economy the size of India, the single tax system was completely out of sync with the realities. Added to that was the lax enforcement structure and approach. The inadequacies of the system and in its implementation encouraged people to shortchange it. Various modus-operandi were developed. Bogus firms were registered, fake invoices generated without actual movement of goods. Fake invoices were later used to claim ITC. Also, there was under-invoicing of transactions to reduce the tax outgo. In a way the system was full of faults encouraging fraudsters to milk it the way they wanted. Added to it were wrong interpretations of definitions of products to pay lower taxes as tax slabs depended on the types of products. For example, branded products fell under a higher slab while non-branded products attracted much lower rates. Branded products were often passed off as non-branded products to claim lower rates. The system was full of loopholes that need to be plugged. This is high time the government appointed a committee to overhaul the GST system hook, line and sinker.

### Termagant

t's a long way from the Crusades to the modern sense of the word, but that's the path we must follow to explain where we got termagant from.In the Middle Ages, Crusaders knew almost nothing about Islam and lumped everyone non-Christian together as Saracens or pagans; they thought that Mahmound (or Mahound) and Termagant were among Islam's gods. The word appears about 1100 as tervagaunt; that was in French, in the Chanson de Roland. The Italian equivalent was Trivagante, which may in turn have come from Latin words that meant a threefold wanderer; this referred to the moon, which was considered to travel between heaven, earth, and hell under the three names Selene, Artemis, and Persephone. The word was borrowed into English and became the usual name in the medieval morality plays for an overbearing, violent and turbulent character, the supposed god of the Saracens, who was always dressed in Eastern robes. He was borrowed by Shakespeare and put into the mouth of that early theatre critic. Hamlet: " could have such a Fellow whipt for o'erdoing Termagant: it out-Herods Herod." The name had by then been generalised to mean a quarrelsome person or bully. Around the middle of the 17th Century, the word changed sex to become our modern term for a quarrelsome woman. It's likely that people were confused by the Saracen's robes in the morality plays and assumed that the supposed god Termagant was really female.

### Terms using Dutch

Dutch readers should perhaps look away... In the seventeenth century, the Dutch and British were enemies. Both wanted maritime superiority for economic reasons, especially control of the sea routes from the rich spice islands of the East Indies. The two countries fought three wars at sea between the years 1652 and 1674. At the lowest point of the struggle, in May 1667, the Dutch sailed up the Medway, sank a lot of ships, and blockaded the Thames. The Dutch were powerful, they were the enemy, they were the bad guys, and their name was taken in vain at every opportunity. The stereotype of the Dutchman among the English at this period was somebody stolid, miserly, and bad-tempered, and these associations, especially the stinginess, were linked to several phrases. Only a small number of them are actually recorded in print from the time of the Dutch wars, most being of eighteenth century provenance or later. But there's nothing as long-lasting as traditional enmity: later phrases borrowed the ideas from earlier ones. and in any case many are certainly older than their date of first recording. Examples from the time of the Dutch wars include Dutch reckoning, a bill that is presented without any details, and which only gets bigger if you question it, and a Dutch widow, a prostitute. In the same spirit, but recorded later, are Dutch courage, temporary bravery induced by alcohol and Dutch metal, an alloy of copper and zinc used as a substitute for gold foil.



# LIFE, HEALTH AND GDP

**AS THE INCOMES** 

**OF THE VERY RICHEST** HOUSEHOLDS MAY BE SEVERAL **THOUSAND TIMES GREATER THAN THOSE OF** THE POOREST HOUSEHOLDS. **AVERAGE GDP IS INVARIABLY** LARGER THAN **TYPICAL** (MEDIAN) **INCOME. BUT** WHEN IT COMES TO LIFE **EXPECTANCY IN** THE RICHEST COUNTRIES, THE OPPOSITE **IS TRUE** 

GDP is growing. Many makers, and other critics question the ability of this central measure of government and social success to recognise the welfare gains from technoldegradation, or capture rising inequality. With developments in artificial intelligence and robotics poised to produce considerable labor-market churn while also boosting GDP - a process likely to be accelerated by the ongoing pan- $\underline{\text{demic-these complaints will soon}}$ grow louder.

Numerous alternative indicators have long been on offer, but one especially promising option is healthy life expectancy (HLE), a metric that is easily understood and that has obvious importance to each of us individually. Moreover, HLE is already being measured, and happens to address many of the factors that GDP might omit.

Poor environmental conditions, for example, are not conducive to long, healthy lives. And there is plenty of evidence to suggest that individuals who are happy and fulfilled also tend to live longer and remain healthy for longer. Even more to the point, longer healthier lives connect back to GDP itself. Just as rising GDP helps to provide the resources needed to support health, healthy populations support stronger GDP.

Moreover, by targeting HLE specifically, governments could shine a brighter light on the issue of economic inequality. Because the incomes of the very richest households may be several thousand times greater than those of the poorest households, average GDP is invariably larger than typical (median) income. But when it comes to life expectancy in the richest countries, the opposite is true. The outliers tend to be those who die young, so that typical (median) life expectancy is higher than average life expectancy.

This means that raising the average HLE can be achieved by raising the HLE of those at the bottom of the health distribution



How can we commit trillions of dollars to ensure that GDP is supported while doing so little to avoid declining life expectancy? Certainly, the response to Covid-19, where GDP has plummeted as a result of life-saving measures, suggests that substantial policy measures to boost HLE are worthwhile

to that of the typical (median) perinequality more attractive, but does not require path-breaking medical innovations to achieve longer lifespans – just the achievement of typical outcomes for more people. With this in mind, it is urgent to close the sizeable rich-poor life-expectancy gap – around 15 vears - in the United States.

As a metric for economic and social progress, targeting HLE implicitly acknowledges that aging is malleable (if it wasn't, it wouldn't be a viable target). It turns out that a range of behaviors and policies, as well as the environment we inhabit, influence how we age and how long we live. It is estimated that our genetics account for only onequarter of the factors contributing to how we age. Given this malleability, it is crucial that governments focus on HLE for the maximum number of people.

Such a focus would also help governments confront one of the biggest challenges of the future: societal aging. Given that every country in the world is expected to experience societal aging, focusing on how well we age becomes paramount. This age malleability requires drawing a distinction between chronological and biological measures of age and focusing on the latter.

Yet, because so much government policy currently focuses on the non-malleable chronological metric. too many governments are unprepared for future demographic challenges such as overburdened health and pension systems. Rather than exploring ways to influence how we age, policymakers are focused almost entirely on the number of "old" people. But by targeting healthy longevity, they could help more people lead longer, more productive lives, thereby minimizing the economic costs of societal aging.

After the 2008 financial crisis, policymakers committed to doing "whatever it takes" to stabilise the financial system and restore GDP growth. A subsequent slowdown in trend of productivity growth and the devastating global economic fallout from the current pandemic

have produced numerous policy suggestions and unprecedented spending aimed at reversing trend slowdowns in GDP growth.

To operationalise HLE targeting, governments should follow Japan in establishing "longevity councils." Once policymakers start focusing on the issue, they will realize three things. First, preventive health care is the key. Around the world, health systems tend to be geared primarily toward medical intervention and disease response, rather than toward general health promotion. Second, and relatedly, many of the determinants of long healthy lives fall outside the health system, and are connected to work education, and community, as economists Anne Case and Angus Deaton have shown in their work documenting "deaths of despair." A policy focus on HLE therefore re quires a cross-departmental government approach.

The fact that today's deaths of despair disproportionately affect middle-aged individuals points to the third realization: longevity is about all-of-life and not just endof-life outcomes. With the British government estimating that a newborn girl now has a one-in-five chance of living to 100, it is critical that we expand our view of longevity to the entire life course. Measures targeting HLE must be inclusive across all age cohorts and focus on longevity, not just on the old. After all, today's young people are tomorrow's elderly, and all of one's

time on this planet matters. There are many metrics that governments could use to judge the success of their policies and the health of society. But whatever other measures they use HLE deserves a central position in the policy mix. Few other variables are both as important for us individually and as effective in capturing broader macroeco nomic benefits.

# Unplanned cities, haphazard growth

eastern France. It's just 4km expats who can't afford exorbitant Geneva rents and hotel rates come and stay in Annemasse. Residents of Geneva prefer to come and shop in Annemasse as shopping there is more affordable compared to Geneva. As part of a UN team, I stayed in Annemasse for a month in 2015. We thoroughly enjoyed our stay in this small town of 35,000 people.

What struck me while staying there was how liveable the place was. In five square kilometres, you have shops, markets, a city centre buzzing with activity, churches, kids' play areas, walking tracks, educational institutions etc, apart from abundant greenery. The city has a near-perfect transport system merging seamlessly with those of Geneva. The trams, railways and buses make the public transport system very efficient.

While moving around the length and breadth of the country, what struck me forcefully was how unliveable our cities have become. We are in the midst of a large urban ghetto and still complain that we have low urbanisation at 33 per cent. This signifies low economic development. Cities are where wealth is created, innovation is cradled, creativity is nurtured, risk-taking is taught and employ-

- lively neighbourhood, accessibility and sustainable mobility, a diverse and strong local economy, vibrant public spaces, and affordability. We also recognise social and environmental sustainability as factors contributing to liveability of the cities.

Real estate prices in cities have made accommodation unaffordable. The rich have created gated communities for themselves, oblivious of the fact that beyond a furlong from the gated community one could smell the stench of the open sewer or the sight of an ungainly slum. No man is an island; therefore, urban planning for the last man living within the precincts of a city is most imperative

If a third of India lives in cities and towns, only a sixth of Odisha does so. Unfortunately, most cities and towns in Odisha are turning into urban ghettos. The twin cities of Bhubaneswar and Cuttack do not have modern drainage and sewerage systems. A CAG report in 2017 brought out these issues, and it was stressed that the sewerage projects would be completed by end 2019. The work is still ongoing.

The BCRSB (Bhubaneswar, Cuttack, Rourkela, Sambalpur and

City-watchers mostly recognise rations) lacks modern drainage educational facilities. The governfive main features of a liveable city and sewerage, modern city transport facilities, good arterial-road connectivity within the city, and lack of basic neighbourhood public amenities like parks and playgrounds. The cities are growing in a haphazard manner. Could there be practical, vet cost-effective models of growing the cities that could be the pie of the sky for even a poor resident, de-clog the city centre and make the cities more sustainable?

The low level of urbanisation in Odisha provides a unique opportunity to work for planned future growth of our cities in more socially and environmentally sustainable ways. A socially sustainable city provides for housing for its citizens of all walks and all income groups. The basis for housing is to bring higher FAR for group housing, making it mandatory for builders to have minimum amenities within its boundaries, and freeing land under the government's possession for housing. The Odisha government has announced such a plan, but the government needs to ensure road, water, sewerage, transport and other amenities. State must be a facilitator for planned growth through infrastructure development.

A socially sustainable city needs

Berhampur – all municipal corpoproximate healthcare and primary ate the facilities by itself. The private sector would bring in facilities to cater to the population. A socially sustainable city provides for every income group, and therefore, giving them the security of a house and a means to reach their workplaces (transport). This would encourage people to move away from the city centre. That is how best cities in Europe have developed by creating satellite townships that are as good as or better than the centre of the city in terms of liveability index.

An environmentally sustainable city would have qualitywater treatment plants, sewage disposal system, and clean water. Regrettably, in Bhubaneswar and Cuttack, the rivers of Kuakhai and Kathjodi (and Mahanadi) have become dump yards of untreated water, sewage and filth.

Cities need to grow to nurture economic growth. Also, the government needs to spend money to give back to the cities from where it derives bulk of its revenue. A smartcity programme for the state will be appreciated.

# TN BJP isn't okay with Ganesh Chaturthi at home

CITING THE PANDEMIC AND CENTRE'S BAN ON RELIGIOUS CONGREGATIONS, THE TAMIL NADU GOVT ADVISES PEOPLE TO CELEBRATE GANESH CHATURTHI WITHIN THEIR HOMES

Chennai, August 20: The BJP Thursday attacked the AIADMK government for disallowing celebration of 'Vinayaka Chaturthi' in public places and asked when liquor shops can be opened why Ganesha idols should not be put up.

Citing the Covid-19 pandemic and the Central government ban on religious congregations, the Tamil Nadu government Thursday advised people to celebrate Ganesh Chaturthi within their homes.

In a statement issued here, the government said orders prohibiting the installation of Ganesh idols in public places and taking them in processions, are to prevent the spread of coronavirus

The Madras High Court has also ordered that the government order should be followed while hearing a batch of petitions on the matter. the statement added.

Backing Hindu Munnani, which, about four decades ago, set in motion the now prevalent practice of public celebration of 'Vinayaka Chaturthi', Saffron party's Tamil Nadu president L Murugan asked: "In Tamil Nadu, the government which gave permission for opening TASMAC shops, did not allow putting up Vinayaka statues. Why?"

On the stand of Munnani, state president Kadeswara C Subramaniam said, "We have a right to worship by following guidelines like social distancing to prevent the spread of coronavirus...we

are holding talks with authorities." A prominent Sangh Parivar outfit in Tamil Nadu, Munnani's chief told PTI: "We are seeking permission to put up Ganesha idols only

in such public places that would be completely suitable to follow COVID norms and offer worship."

"We don't insist on any location which authorities considered as not acceptable taking into account

the pandemic." Already, the organisation has decided against public processions of Ganesha idols and made up its mind to confine the public celebration for only one day and stick to norms to reduce the threat of infection, he said.

Also, "the Munnani is for comparatively smaller idols like say five or three feet this year. The authorities should also ponder about the idols that have been made and the plight of artisans who made it.

Asked on his outfit reportedly saying that "government ban on public Ganesha worship will be defied," he denied about he or anyone else making such a statement.

"We did not say that we will violate or defy government orders. We are for following the norms to prevent the spread of the virus."

The state government, meanwhile, citing Centre's guidelines against public worship in view of the pandemic said the Madras High Court too had directed compliance with its directives.

The government has already issued an order banning putting up Ganesha idols in public places, public worship and taking idols in a procession for immersion in water bodies.

# Covid survivors are 'real warriors'



this facility round the clock on information related to Bangalore airport, facilities, flights, F&B and transport,' said the official. Positioned at four

locations in the terminal, the virtual desks will add a new contactless dimension to passenger processing. Enabling a touch-free and a safe way to seek assistance without face to face human interaction, the virtual desks offer the facility in Kannada, English and Hindi.

"Terminal personnel at Bangalore airport have been trained to manage passenger queries in all three languages through the virtual platform," said the official.

In addition to the virtual desk, the city airport had rolled out a contactless journey from parking to boarding in May 2020, including self-bag drop, biometric-based self-boarding, contactless checkin, retail and F & B and touch-free hand sanitisers.



New Delhi, August 20: With indications of the beginning of the Monsoon Session of Parliament in the second week of September, the government is learnt to have planned to clear 11 ordinances on priority amid the Opposition's attempt to keep it on backfoot over the Galwan Valley incident in which 20 Indian soldiers were killed.

Most of these 11 ordinances will lapse if not passed in the upcoming session of Parliament as the Winter Session is held in December. These include -- the Salaries and Allowances of Ministers (Amendment) Ordinance 2020 promulgated by the President Ram Nath Kovind



on April 9; the Salaries, Allowances and Pensions of Members of Parliament (Amendment) Ordinance, 2020 promulgated on April 7; the Epidemic Diseases (Amendment) Ordinance 2020 promulgated on April 22; the Essential Commodities (Amendment) Ordinance, 2020, promulgated on June 5; the Farmers Produce And Commerce Trade (Promotion And Facilitation) Ordinance, 2020, promulgated on June 5; and the Farmers (Empowerment And Protection)

Agreement On Price Assurance

And Farm Services Ordinance, 2020 promulgated on June 5.

The Homeopathy Central Council (Amendment) Ordinance 2020 promulgated on April 24; the Indian Medicine Central Council (Amendment) Ordinance, 2020 promulgated on April 24; the Taxation And Other Laws (Relaxation Of Certain Provisions) Ordinance, 2020 promulgated March 31; the Insolvency Bankruptcy (Amendment) Ordinance, 2020 promulgated on June 6; and the Banking Regulation (Amendment) Ordinance promulgated on June 26 are the other ordinances passed by the Union Cabinet so far this year.

These ordinances are aimed at boosting the economy, empowering rural India through the welfare of farmers engaged in agriculture and allied activities and protection of frontline warriors against physical attacks when the pandemic crippled almost all sectors amid lockdown. Almost five to six of these ordinances will expire if not passed in the Monsoon Session

Ordinances are temporary laws that are promulgated by the President of India on the recommendation of the Union Cabinet, which will have the same effect as an Act of Parliament.

An ordinance has a life of six months. But from the day a session begins, it has to be replaced by a bill which should be passed by Parliament within six weeks, else

The government is at liberty to promulgate the ordinance if the bill fails to get through Parliament. They can only be issued when Parliament is not in session.

# Covid recovery rate nears 74%

Of the active cases of coronavirus infection, 1.92% are in ICU and 2.62% on oxygen support. The country's case fatality rate has further declined to 1.90%

New Delhi, August 20: Recoveries among COVID-19 patients in the country surged to 20,96,664 Thursday, pushing India's recovery rate to 73.91 per cent, while only 0.28 per cent people of 6,86,395 active cases are on ventilator support, the Union health ministry said.

Of the active cases of coronavirus infection, 1.92 per cent are in ICU and 2.62 per cent on oxygen support. The country's case fatality rate has further declined to 1.90 per cent, it said.

Recovery of 20,96,664 patients has been made possible because of effective implementation of the policy of testing aggressively, tracking comprehensively and treating efficiently,



the ministry said in a statement. "Focus on standard of care protocol including use of non-invasive oxygen, better skilled doctors in the ICUs and hospitals, and improved ambulance services have culminated in yielding the desired results," it said.

With 58,794 recoveries in a span of 24 hours, India's recovery rate amongst COVID-19 patients has reached nearly 74 per cent (73.91 per cent) reflecting that the number of patients recovering is on a steady rise over the past several months, it added. India has posted 14,10,269 more

recoveries than active cases. There are 6.86.395 active cases of coronavirus infection which are under active medical care. The record high recoveries have ensured that the active cases, the "actual caseload" of the country, currently comprise only 24.19 per cent of the total cases.

Early identification through testing, surveillance and contact tracing along with focus on timely and appropriate clinical treatment of COVID-19 patients have ensured that not only is the case fatality rate lower than the global average and progressively declining but also a small proportion of the active cases are on ventilator support, the ministry said.

### **GOVT HIKES AVIATION SECURITY FEE**

New Delhi, August 20: The Civil Aviation Ministry has decided to charge higher aviation security fee (ASF) from domestic as well as international passengers from September 1, senior government officials said Thursday.

Making the air travel slightly costlier, the officials said the ASF for domestic flyers will be increased to Rs 160 from Rs 150 starting next month, and international passengers will pay 5.2 USD instead of 4.85 USD as the ASF from September 1.

Airlines collect the ASF from passengers when they book their tickets and then give it to the government. The ASF is used to fund the security arrangement at airports across the country. The ministry had increased the ASF last

On June 7, 2019, the ministry said domestic passengers would be\_ charged Rs 150 instead of Rs 130 as the ASF and international passengers would be charged 4.85 USD instead of USD 3.25 as the ASF from July 1, 2019. The aviation sector has been significantly impacted due to the travel restrictions imposed in India and other countries in view of the coron-

avirus pandemic.

All airlines in India have taken cost-cutting measures such as pay cuts, leave-without-pay and firings of employees in order to conserve cash. After a gap of two months due to the coronavirustriggered lockdown, India resumed domestic passenger flights on May 25. However, the average occupancy rate in Indian domestic flights has been around just 50-60 per cent since May 25.

### 'Malaysia Covid strain no cause for concern'

New Delhi, August 20: The mutant form of the novel coronavirus "10 times more infectious" is not a concern for India as it is widely prevalent here and isn't any more virulent than the strain originating in Wuhan, say scientists.

The D614G strain of the virus was discovered in Malaysia from a cluster, including a restaurant owner returning from India, the country's Director General of Health said in a Facebook post this week. His assertion that it was "found to be 10 times more infectious and is easily spread by an individual super spreader" created a flutter but scientists here dispelled fears and said there is nothing to worry about.

According to virologist Upasana Ray, the mutation may have just been reported in Malaysia but is not new for the world. "We saw it happening in April and it eventually dominated many countries. It is new for Malaysia but is not a new mutation," the senior scien-



tist at Kolkata's CSIR-Indian Institute of Chemical Biology said.

While some reports claim the mutation is capable of enhancing the infectivity of the virus, this is not well established and also does not necessarily indicate more virulence or harmfulness of the disease.

Ray said even a highly infectious and transmissible variant of the virus might actually have a lesser ability to cause disease in humans.

In July, a study in the journal Cell by scientists, including Bette Korber from the Los Alamos National Laboratory in the US, noted that a variant of the novel coronavirus, dubbed 'D614G', can other strains.

The study said this mutant in which a molecule 'aspartic acid' (denoted as D) is replaced by another building block 'glycine' (G) -- had quickly taken over as the dominant strain across the world soon after it first appeared, and grew more rapidly in lab-grown cells.

This mutation is part of the spike protein that the novel coronavirus uses to enter host cells. The strain with the D614G mutation, dubbed the 'G clade', became widely prevalent in India even as far back as April, agreed Kumar Somasundaram, professor of Microbiology and Cell Biology at the Indian Institute of Science (IISc) Bangalore.

### India, China agree to resolve differences

New Delhi, August 20: India and China Thursday agreed to resolve outstanding issues in an "expeditious manner" and in accordance with the existing agreements and protocols, the Ministry of External Affairs (MEA) said after the two sides held a fresh round of diplomatic talks to resolve the border standoff in eastern Ladakh.

MEA Spokesperson Anurag Srivastava said the two sides had a "candid and in-depth" exchange of views on the existing situation on the Line of Actual Control (LAC), and reaffirmed to sincerely work towards complete disengagement of the troops in the western sector.

The virtual talks were held under the framework of the Working Mechanism for Consultation and Coordination (WMCC) on border affairs."The two sides had a candid and in-depth exchange of views Srivastava said at an online media briefing.

"They reaffirmed that in accordance with the agreements reached between the two foreign ministers and the two Special Representatives, the two sides will continue to sincerely work towards complete disengagement of the troops along the Line of Actual Control in the western sector.'

Srivastava further said: "In this context, they agreed to resolve the outstanding issues in an expeditious manner and in accordance with the existing agreements and protocols." External Affairs Minister S Jaishankar had held a telephonic conversation with Chinese Foreign Minister Wang Yi on June 17 during which both sides agreed that the overall situation would be handled in a responsible manner.

On July 5, National Security Advisor Ajit Doval and Wang held a nearly two-hour-long telephonic conversation on ways to resolve the border row.

Chhattisgarh was given the 'Cleanest State' award in the category of states having more than 100 urban local bodies, followed by Maharashtra and Madhya Pradesh.

The Swachh Survekshan awards 2020 -- the fifth annual cleanliness survey of the country -- were announced by Union Housing and Urban Affairs Minister Hardeep

The survey brochure describes the New Delhi Municipal Council as "India's Cleanest National Capital (National or State Capitals/UT)". The NDMC comprises large part of Rajpath and the VIP zone of Lutyens' Delhi. A total of 4,242 cities, 62 Cantonment Boards and 97 Ganga towns were surveyed, and 1.87 crore citizens participated in the exercise, according to the government.

Ambikapur in Chhattisgarh has been ranked the cleanest city in the category of 1-10 lakh population, followed by Mysore in Karnataka and New Delhi Municipal area. The Jalandhar Cantonment Board had been ranked first while Delhi Cantonment Board and Meerut Cantonment Board have grabbed second and third positions respectively.



Till July this year, a total of 2,662 ceasefire violation cases were reported in the valley. Last year, 3,168 ceasefire violations were reported. In 2018, the figure of ceasefire violations was 1,629.

However, security forces have been successful in minimising infiltration attempts. Also the figures state there has been a significant decline in terror activities in the valley. This year till July, a total 120 terror-related cases have been reported and last year during the same period - between January and July -a total 188 cases were reported.

Similarly, this year till July, 35 security personnel lost their lives in line of duty and last year during the same period 75 security personnel had lost their lives fighting terrorists

## 27% students don't have phones for online classes

New Delhi, August 20: At least 27 per cent students do not have access to smartphones or laptops to attend online classes, while 28 per cent students and parents believe intermittent or lack of electricity is one of the major concerns hindering teachinglearning, according to a survey by the NCERT.

The survey with over 34,000 partcipants, including students, parents, teachers and school principals from Kendriya Vidyalayas, Navodyaya Vidyalas and CBSE affiliated schools, has pointed out that lack of knowledge of using devices for effective educational purposes and teachers not being well-versed with online teaching methodologies, caused hindrance in the learning process.

"Approximately 27 per cent of the students mentioned the nonavailability of smartphones and laptops. The maximum number of stakeholders have opted for mobile phones as a medium for teaching-learning during the COVID-19 period," the survey by the NCERT said.

"About 36 per cent of the students used the textbooks and other books available with them. Laptops were the second most favoured option amongst teachers and principals. Television and radio were the least utilized devices for the teachinglearning in the pandemic situation. The absence of enriched interaction between the teacher and the students was one of the reasons as identified by the stakeholders," it added.

# 29% of Delhi exposed to Covid

New Delhi, August 20: Antibodies against COVID-19 infection have been found in 29.1 per cent of people in the latest sero-prevalence survey in the national capital, Delhi Health Minister Satyendar Jain

said Thursday. Interacting with reporters, he said, 15,000 representative samples were taken in the August 1-7 survey from 11 districts, and the next exercise will begin from September 1."In the previous survey, it was found that over 22 per cent people had developed antibodies. Now, the August survey shows it is 29.1 per cent, meaning they had got infected and recovered," Jain said.

The minister also said that prevalence of antibodies found in males was 28.3 per cent, and in females 32.2 per cent in the latest survey. The previous sero-prevalance survey done from June 27 to July 10 by the Delhi government in association with the National Centre for Disease Control (NCDC), had used 21,387



samples and found that around 23 per cent of the people surveyed had an exposure to the novel coronavirus.

"The rise, rather than the exponential rise is not there. So, people are taking safety precautions it seems. But, we cannot afford to be complacent and lower our guard, even though positivity rate at present is 7 per cent," Jain said.

The exercise was undertaken in the first week of August for a comprehensive assessment of the COVID-19 situation in Delhi and to formulate strategies based on

its findings. About 15,000 samples were collected as part of this exercise, spanning different areas and age groups, gender and economic class, he said.

Representative samples were taken from all the eleven districts. Out of total number of samples, 25 per cent were taken from the age group of less than 18 years, another 50 per cent from 18-49 years age bracket and remaining 25 per cent from those in the age group of 50 years or more, the Delhi health minister said.

The sero-prevalence found in North East district was 29 per cent, South district 27 per cent, South East 33 per cent and New Delhi 24 per cent, Jain said. There has been an increase of 6 per cent to 50 per cent in prevalance of antibodies among people in various districts compared to the prevalence found in different districts in the previous survey, he said.

## Only 27% anti-human trafficking units functional: Study

New Delhi, August 20: A study on operational competence of Anti-Human Trafficking Units (AHTUs) across India reveals that only 27 per cent of these units are functional and only 51 per cent have all the power and resources. The sector had received Centre-allocated 'Nirbhaya Fund' to strengthen its role in the states to curb human traf-

The revelation has come just a month after the Ministry of Home Affairs directed the state governments to utilise funds released from 'Nirbhaya Fund' in March this year to establish the AHTUs in all the

The number of notified AHTUs

in many states and UTs were much less than the number of AHTUs that states and Union Territories (UTs) claimed were operational, reveals the study conducted by Sanjog, a technical resource organization, and Tafteesh, a coalition of lawyers, activists, social workers and survivor leaders. The study was spearheaded by a group of five lawyers who filed RTIs in 33 states and Union Territories (UTs) out of which only 22 states and Union Territories re-Responses to the RTIs from 16

states and UTs highlight that only 27 per cent of AHTUs are functional and 51 per cent being notified with all the power and resources. The study collated data between 2010 and 2019 with the objective of eval-



uating the effectiveness of the AHTUs to find out the number of AHTUs actually notified by state and UT governments. Responses from 16 states and UTs showed that

225 AHTUs are set up only on paper with no centralised process to notify them, mentions the study.

Further, it says, the number of notified AHTUs in many states and UTs

were much less than the number of AHTUs that states and UTs claimed were operational. Most of the AHTU postings were only seen as 'notional' offices occupied by near-retirees or police officials taking on 'punishment postings', it said. Pompi Baneriee, a psychologist and researcher at Sanjog and a member of Tafteesh said: "As a result of the pandemic, many people are facing job loss and financial hardship. This makes them more vulnerable to trafficking. Therefore, it is important to understand the effectiveness of the AHTUs, especially when the Ministry of Home Affairs issued an advisory asking the states and UTs to set up new AHTUs and upgrade the existing ones and saying that Rs 100 crore have been al-

located from the Nirbhaya fund in this regard. As specialised police units,

AHTUs are extremely important in the anti-trafficking system. They are the main grassroots-level unit investigating trafficking cases, rescuing survivors, and aiding prosecution of offenders across the

The study also found that only seven states -- Bihar, Kerala, Nagaland, Rajasthan, West Bengal, Tamil Nadu and Uttarakhand -have AHTUs covering all their districts. All the other states either have AHTUs in half or less of their districts, with Andhra Pradesh and Chhattisgarh having the lowest coverage of AHTUs with 30 per cent and 25 per cent, respectively.



#### **Biden to accept** Washington, August 20: US **Democratic Prez** Senator Kamala Harris accepted

n his third campaign for president, former Vice President Joe Biden -- who found his "comeback kid"moment in South Carolina on this year's primary trail -- will formally accept the Democratic Party's nomination for president in a speech Thursday 33 years after he made his first bid for the White House. Under day four's theme of an "America's Promise," Biden will finally assume center stage at the Chase Center in Delaware -- more than 800 miles away from Milwaukee. where the speech was slated to take place in person before the coronavirus pandemic upended the committee's plans and forced

Former US President Barack Obama, speaking just before Harris, also delivered a sharp rebuke of his Republican successor, saying Trump had used the power of his office only to "help himself and his friends.

Obama, whose vice president was Biden from 2009-2017, said he had hoped that Trump would take the job seriously, come to feel the weight of the office, and discover a reverence for American democracy.

Harris' nomination capped the third night of a party convention that has featured a crush of women headliners, moderators and speakers, showcasing the growing power of women in politics and in the Democratic Party. Biden leads Trump in opinion polls, bolstered by a big lead among women voters. Biden, 77, would be the oldest person to become president if he is elected, leading to speculation he will serve only one term. The nomination for vice presidency would make Harris, 55, a potential top contender for 2024.

## **Steve Bannon** charged with fraud

Washington, August 20: Steve Bannon, an architect of President Donald Trump's 2016 election victory, has been charged with defrauding Trump supporters in a campaign to help build his signature wall along the U.S.-Mexico border, prosecutors said Thursday.

As a top adviser to Trump's presidential campaign who later served as White House chief strategist, Bannon helped articulate the right-wing populism and fierce opposition to immigration that have helped define Trump's 3-1/2 years in office. Bannon left the White House in August 2017.

Bannon was among several people charged with wire fraud in an indictment by federal prosecutors in Manhattan for allegedly defrauding hundreds of thousands of donors through a \$25 million crowdfunding campaign called "We Build the Wall," the Justice Department said.

Prosecutors said Bannon received more than \$1 million of that money through an unnamed nonprofit organisation. The White House declined immediate comment. A lawyer for Bannon did not immediately respond to a request for comment.

Trump's signature effort to build a wall along the US-Mexico border - a key 2016 campaign promise - has struggled amid court challenges, logistical hurdles and opposition from Democrats in Congress. In the meantime, more than 330,000 supporters have donated to private fund-raisers and profiteers who have promised to build the wall on their own, according to a 2019 Reuters investigation. Those efforts likewise have met with limited success

Minsk, August 20: Belarus launched a criminal case on Thursday against a new opposition body, accusing it of an illegal attempt to seize power, a day after President Alexander Lukashenko threatened to sweep the streets of protesters who reject his re-election.

Belarus is facing its biggest political crisis since the breakup of the Soviet Union, with tens of thousands of demonstrators rejecting Lukashenko's victory in an Aug. 9 vote his opponents say was rigged. Opponents of Lukashenko, who has been in power for 26 years, unveiled the Coordination Council on Tuesday with the stated aim of negotiating a transfer of power.

Its dozens of members include a Nobel Prize-winning author and the ousted head of Minsk's main drama theatre, as well as exiled presidential candidate Sviatlana Tsikhanouskava, whose followers say she won the election.

The general prosecutor's office described the body as designed to seize power, and the act of setting it up a threat to national security, Russia's RIA news agency reported. No individuals were named as suspects in the case. The council said one of its members, Maksim Znak, had been summoned to appear at the Investigative Committee on Friday over the criminal case. It issued a statement saying its efforts were lawful. "The accusation is completely baseless and without foundation. Our goal is to resolve the crisis without conflict. We are not calling for the seizure of power,' council member Syarhei Dyleuski, leader of a committee of striking workers at the Minsk Tractor Factory said.

A former agent for the KGB and post-Soviet successor agency FSB, Col. Alexander Litvinenko defected from Russia in 2000 and fled to London, where he fell violently ill six years later after drinking tea laced with radioactive polonium-210.

He died after three weeks. A British inquiry found that Russian agents had killed Litvinenko, probably with President Vladimir Putin's approval. Russia denied any involvement.At the time of Litvinenko's poisoning, he had been investigating the killing of Russian journalist Anna Politkovskaya three weeks earlier. ANNA POLITKOVSKAYA

An investigative journalist, Politkovskaya had written critically about abuses by Russian and pro-Moscow Chechen forces fighting separatists in Chechnya – work that earned her repeated death threats. In 2004, she fell severely ill and lost consciousness after drinkIslamic separatists. Two years later. ## Children are silent spreaders of Covid-19: Study

New York, August 20: While most studies have stressed that children are not the harbingers of Covid-19, a comprehensive study now claims that children play a larger role in the community spread of the novel coronavirus than previously thought. In a study of 192 children aged 0-

22, published in the Journal of Pediatrics, 49 children tested positive for SARS-CoV-2, and an additional 18 children had late onset, Covid-19-related illness.

The infected children were shown to have a significantly higher level of virus in their airways than adults hospitalised in ICUs for Covid-19 treatment. "I was surprised by the high levels of virus we found in children of all ages, especially in the first two days of infection. I was



not expecting the viral load to be so high," said study author Lael Yonker from the Massachusetts General

Hospital (MGH) in the US "You think of a hospital, and of all of the precautions taken to treat severely ill adults, but the viral loads of these hospitalised patients are significantly lower than a 'healthy child' who is walking around with a high SARS-CoV-2 viral load," Yonker added. According to the researchers, transmissibility or risk of contagion is greater with a high viral load. And even when children exhibit symptoms typical of Covid-19, like fever, runny nose and cough, they often overlap with common childhood illnesses, including influenza and the common cold. Along

with the viral load, the team examined the expression of the viral receptor and antibody response in healthy children, children with acute SARS-CoV-2 infection and a smaller number of children with Multisystem Inflammatory Syndrome in Children (MIS-C). The researchers noted that although children with Covid-19 are not as likely to become as seriously ill as adults, as asymptomatic carriers or carriers with few symptoms attending school, they can spread infection and bring the virus into their homes.

This is a particular concern for families in certain socio-economic groups, which have been harder hit in the pandemic, and multi-generational families with vulnerable

older adults in the same household. In the Mass General Hospital for Children (MGHfC) study, 51 per cent of children with acute SARS-CoV-2 infection came from low-income communities compared to two per cent from high-income com-

In another breakthrough finding from the study, the researchers challenge the current hypothesis that because children have lower numbers of immune receptors for SARS-CoV-2, this makes them less likely to become infected or seriously ill.

Data from the group show that although younger children have lower numbers of the virus receptor than older children and adults, this does not correlate with a decreased viral load. According to the authors, this finding suggests that children can carry a high viral load, meaning they are more contagious, regardless of their susceptibility to developing Covid-19 infection.

# **RBI UNVEILS 5-YEAR NATIONAL STRATEGY**

Mumbai, August 20: The Reserve Bank of India (RBI) Thursday came out with a '5-Core Actions' approach for promoting financial education, which among other things include development of relevant content for school children and adults, community participation and collaboration among various stakeholders.

The 'National Strategy for Financial Education 2020-2025' (NSFE), released by the RBI, has suggested a multi-stakeholder-led approach for creating a financially aware and empowered India.

The five Cs, outlined by the strategy paper, are: Content, Capacity, Community, Communication and

Strengthening financial inclusion in the country has been one of the important developmental agendas of both the Government of India and the four financial sector regulators (RBI, SEBI, IRDAI and

"Financial literacy supports the pursuit of financial inclusion by empowering the customers to make informed choices leading to their financial well-being," according

To achieve the vision of creating a financially aware and empowered India, NSFE has laid down strategic objectives, like inculcate financial literacy concepts among the various sections of the population through financial education to make it an important life skill, and encourage active savings

Among the other strategic objectives are encouraging participation in financial markets to meet financial goals and objectives, developing credit discipline and encourage availing credit from formal financial institutions as per requirement, and improving usage of digital financial services in a safe and secure manner.

Managing risk at various life stages through relevant and suitable insurance cover and plan for old age and retirement through coverage of suitable pension products are the other key objectives laid down in the document.

The document stresses on development of financial literacy

content for school children (including curriculum and co-scholastic), teachers, young adults, women, new entrants at workplace/entrepreneurs (MSMEs), senior citizens, persons with disabilities, illiterate people.

'Update content of financial education in school curriculum for students of classes VI to X", said action plan for NSFE (2020-25).

It also makes a case for integrating financial education in courses like B.Ed./M.Ed. besides other teachers' training courses to create a cadre of financially educatd teaching professionals.

It also calls for development of a financial literacy mobile app, and leverage social media.

NSFE further said the Technical Group on Financial Inclusion and Financial Literacy (TGFIFL) would be responsible for periodic monitoring and implementation of National Strategy for Financial Education.

There would also be periodic monitoring of the activities undertaken by various stakeholders for dissemination of basic, sectorspecific, and process literacy.

Since the launch of the first NSFE in 2013, various stakeholders have undertaken several measures to improve the financial literacy of the cross-section of the population in the country, it noted.

Financial literacy is defined as a combination of financial awareness, knowledge, skills, attitude, and behaviour necessary to make sound financial decisions and ultimately achieve individual finan-

## Retail inflation for rural workers falls

New Delhi, August 20: Retail inflation for farm and rural workers eased to 6.58% and 6.53%, respectively in July this year on account of lower prices of certain food items, the labour ministry said Thursday.



Inflation based on CPI-AL (Consumer Price Index-Agricultural Labourers) and CPI-RL (Consumer Price Index-Rural Labourers) stood at 7.16% and 7%,

respectively in June. Inflation based on food index of CPI-AL and CPI-RL recorded at 7.83% and 7.89%, respectively in July 2020, according to a labour ministry statement.

Amongst states, the maximum increase in the consumer price index numbers for agricultural labourers was experienced by Meghalaya (15 points) and for rural labourers, it was experienced by Jammu & Kashmir and Meghalaya (14 points) mainly due to rise in the prices of milk, meat goat, fish dry. bidi, vegetables and fruits and bus fare etc, the statement said.

On the contrary, the maximum decrease in the CPI numbers for agricultural labourers and rural labourers was experienced by Tripura (-8 points) and (-5 points), respectively mainly due to fall in the prices of rice, meat goat, fish fresh/dry etc.

The all-India consumer price index numbers for agricultural labourers and rural labourers (base:1986-87=100) for the month of July 2020 increased by 3 and 4 points to stand at 1,021 and 1,028 points, respectively, the

### **Apple captures 51%** of global smartwatch market revenues

New Delhi, August 20: Apple's share in the global smartwatch shipment revenue increased to 51.4% in the first half of this year from 43.2% during the same period last year, Counterpoint Research said Thursday.

Overall, the global smartwatch market posted a healthy 20% revenue growth despite the Covid-19 pandemic due to healthy growth in shipments in India, Europe and the US.

In the first half of 2020, close to 42 million smartwatches were shipped, said the report. The top three brands - Apple, Garmin and Huawei -- contributed more than 69% of the total market revenue in H1 2020.

While Garmin's share in the global smartwatch shipment revenue increased to 9.4 per cent, Huawei's share grew to 8.3%.

"Apple captured a record half of the market in terms of revenue due to strong demand for the Apple Watch S5 models," Senior Analyst Sujeong Lim said in a statement.

"In terms of shipment volumes. Apple Watch grew 22% globally with Europe and North America being the fastest growing markets in the first half of 2020." In terms of shipment of smartwatches. Huawei jumped to the second spot globally with 57% year-over-year growth, Counterpoint said.

Bhubaneswar, August 20: Under the 100% Emergency Credit Line Guarantee Scheme (ECLGS) backed by a Government of India guarantee, banks from public and private sectors have sanctioned loans worth ₹2,151.80 crore in Odisha as of August 18, 2020 of which more than ₹1,617.60 crore has already been disbursed. The date was revealed by the Ministry of Finance.

There are 1,51,180 accounts which were cumulative sanctioned the loans under the scheme out of which 77,083 accounts have already been disbursed with the loans.

Under ECLGS, banks from public and private sectors have sanctioned loans worth over ₹1.5 lakh crore across the country as of the same period of time. Out of total over ₹1 lakh crore has already been disbursed to the eligible accounts. The ECLGS was announced by the government as a part of Aatma Nirbhar Bharat mission, to mitigate the distress caused by lockdown due to COVID-19 by providing credit to different sectors, especially MSMEs.

Across the country, Public Sector Banks have sanctioned loans of ₹76.044.44 crore, out of which ₹56,483.41 crore has already been disbursed. Whereas, Private Sector Banks have sanctioned loans of ₹74,715.02 crore out of which ₹45,762.36 crore has already been disbursed.

The top lenders under ECLGS are State Bank of India, Canara Bank, Punjab National Bank, Bank of India, Union Bank of India and HDFC Bank Ltd.

### KXIP, KKR, RR land in UAE for bio-secure IPL

### Reds begin title defence against promoted Leeds

London, August 20: Leeds' first game in the Premier League in 16 years couldn't be tougher: a trip to champion Liverpool.

The trip to Anfield for Leeds will be Argentine coaching great Marcelo Bielsa's first game in the Premier League after guiding what is regarded as a sleeping giant of English soccer back to the top division by winning the second-tier Championship.

Leeds — a three-time English champion — were one of the country's top teams in the 1960s and 70s, won the English league title in 1992, and reached the Champions League semifinals in 2001.

Man City's home match against Aston Villa and Man United's trip to Burnley on the opening weekend have been postponed as a result of the agreement among all Premier League clubs for every squad to get a minimum of 30 days between December 12-13 and March 6-7.
