■ Woman beaten to death by sons

Bhubaneswar: In a spinechilling incident, a woman was beaten to death by her two sons in an apartment in Airfield police station area here Thursday. Though the exact cause behind the alleged murder is yet to be ascertained, family feud is suspected to have led to the incident. Both the accused are minor, sources said. However, Airfield police seized the body and sent it for post-mortem. The cops also detained the two accused for interrogation initiating an investigation into the incident

■ 3 terrorists, woman killed in J&K

Srinagar: A woman was killed and two security forces personnel were injured during an anti-terror operation in Jammu and Kashmir Thursday morning, police said. Three terrorists were also killed in the operation, they added. The security forces launched an operation in Batmaloo area of Srinagar after receiving inputs on the presence of terrorists in the area. As the security forces zeroed in the cordon, they came under firing from the terrorists. Two security forces personnel including a deputy commandant of CRPF were injured. Bhubaneswar, Sept 17: The state government Thursday sought ₹1,100crore aid from the Centre for carryout response support in the wake of recent flood.

Senior state government officers raised this demand before the Central team, which visited state to assess damages caused due to the flood in August this year.

Special Relief Commissioner (SRC) Pradeep Kumar Jena said that the state government has requested about ₹1.100 crore as response support. The mitigation measures are being worked out and will be indicated in the final memorandum, he said.

During the meeting, the state government has made a detailed presentation of damage, response, relief, evacuation etc.

The central team appreciated the efforts of the state government and also agreed to the suggestion to consider supporting the state not only in response as per State Disaster Response Fund (SDRF) norm, but also include mitigation

About 25.80 lakh people in 135 blocks and 21 urban local bodies (ULBs) of 18 districts have been affected due to heavy rainfall and subsequent flood last month.

About 2.25 lakh hectares of agriculture and crop land have suffered more than 33 per cent damage in the flood. Similarly, about 1,20,000 houses have damaged due to the calamity. Besides embankments, roads, public infrastructure has also been damaged, sources



State seeks ₹1,100cr Badal quits Modi govt over farm Bills

New Delhi, Sept 17: Akali Dal's sole Union minister Harsimrat Kaur Badal resigned from Prime Minister Narendra Modi's Cabinet Thursday as her party faced heat from farmers over its initial support to ally BJP's farm sector Bills. The minister, who attended the Cabinet meet that cleared the Bills, stepped down shortly before the bill was passed in Lok Sabha, tweeting that she was "Proud to stand with farmers as their daughter & sister". Akali Dal chief Sukhbir Badal said they would support the government from outside but oppose "anti-farmer policies".

Punjab Chief Minister Amarinder Singh, however, pointed out that the



Akalis still stand with the BJP and called the resignation a "gimmick". Puniab Chief Minister Amarinder Singh said Harsimrat Kaur's resignation was "too little too late" Questioning the Akali Dal's decision to continue to remain a part of the ruling NDA, he said the resignation was nothing more than a gimmick to fool the farmers of Punjab. The Bills - which the BJP claims

is big ticket reform in the agri sector -- have hugely upset the farmers of Punjab and Haryana, who have been holding protests for weeks. The government said the bills, which would replace the three ordinances issued in June, will help farmers across the country get a better market and price for their produce.

The Akalis, who initially supported the laws, made a U-turn this week after realising the depth of the farmers' resentment. The party had appealed to the Centre to hold off the Bills till the concerns of the farmers are addressed.

But with the BJP deciding to

push through the bills, the Akalis decided to withdraw support and vote against the Bills in Parliament Thursday.

In his speech during a discussion on two of the Bills - the Produce Trade and Commerce and the Price Assurance and Farm Services Bill – Sukhbir Singh Badal said the proposed laws will "destroy" the 50 years of hard work done by successive Punjab governments to build the farm sector.

Earlier, Badal had claimed that Harsimrat Kaur had "expressed reservations when the matter was taken up during a Cabinet meeting". She had said her ministry opposed the proposal during the interministerial consultation too

City to be divided into 3 zones for better COVID management

Cuttack, Sept 17: The twin cities of Bhubaneswar and Cuttack, will soon witness stricter enforcement of COVID-19 regulations. Director General of Police (DGP) Abhay said this during a meeting held here Thursday to review the COVID-19 situation in twin cities.

Bhubaneswar will be divided into three zones for strict enforcement of Covid norms with one DCP looking after each zone, it was decided. It was also decided that the twin city police will collect more PPE kits and face shields from the state central store and encourage their personnel to use the same

In the meeting, it was decided to intensity enforcement in market areas and specified hotspots that keep changing from weekend to weekdays. It was also

decided to provide 50 more officers and five more platoons of armed forces to enforce the guidelines.

The meeting was convened a day after Chief Minister Naveen Patnaik expressed displeasure over COVID-19 enforcement drive in Bhubaneswar and Cuttack.

Meanwhile, the state's Covid-19 tally in the state rose to 1,67,161 Thursday as 4,241 more people tested positive for the infection, while 13 fresh fatalities pushed the state's coronavirus death toll to 669, a health official said. The state had reported its highest single-day spike of 4,270 coronavirus cases Wednesday.

As many as 2,502 new cases were detected in quarantine centres, while 1,739 people tested positive for the infection during contact tracing, he said. Khurda district, under which Bhubaneswar falls, registered the highest number of new cases.

'No force can stop our troops from patrolling'

China does not accept the customary and traditional alignment of the boundary between India and China: Defence Minister

New Delhi, Sept 17: Defence Minister Rajnath Singh Thursday asserted that no force in the world can stop Indian soldiers from patrolling the country's border in Ladakh region.

Making a statement in Raiva Sabha on the situation in eastern Ladakh, he said China has amassed troops on the border and in response India has made appropriate counter deployment, China, he said, made "provocative military manoeuvres" August 29/30 in an attempt to change the status quo in the south bank area of Pangong Lake in the Ladakh region at a time when the two sides were engaged in military and diplomatic talks to de-escalate tensions.

The Defence Minister said there is a mismatch between

what China says and does. "Unki kathani aur karni alaghai (their actions are at

variance with their words), he said The skirmishes and face-

off in the last few months with China, that left 20 Indian soldiers dead and inflicted heavy casualties on the Chinese sides as well, were primarily over the issue of patrolling the Ladakh border.

"No force in the world can stop Indian soldiers from patrolling. Our soldiers have sacrificed their lives only for this," the minister said.

He was responding to a clarification sought by former Defence Minister AK Antony on the issue of Indian forces not being allowed to patrol in certain parts of the Galwan valley.

File FIR against Shouri: CBI court

New Delhi, Sept 17: One of the grandest palace-hotels in Raiasthan was grossly undervalued and sold at a huge loss to the taxpayer in 2002 and former Union Minister Arun Shourie should be charged for it, a special CBI court has said.

In a corruption case involving the sale of Laxmi Vilas Palace Hotel in Udaipur, the court has asked for criminal cases against Arun Shourie, former bureaucrat Pradeep Baijal and hotelier Jyotsna Suri. The court wants the hotel sale case to be reopened.

'Unknown officers and private persons indulged in this conspiracy from 1999 to 2002 to cause loss of money to the government. The land was valued at ₹45 per square vard. Even a spoon in the hotel would be costlier than that," said a special CBI judge. Hotel Laxmi Vilas was valued at over ₹252 crore but was sold for ₹7.5 crore to hotelier Lalit Suri, said the special CBI court. Jyotsna Suri took charge of the Lalit group of hotels after her husband Lalit Suri's death.

Eco-Retreat at five locations now

Bhubaneswar, Sept 17: In the wake of the overhauling response from the firstever Eco Retreat Festival held last year at Konark, the state government has decided to organise such events at five other locations this year.

The Tourism department has decided to hold Eco Retreats at exotic locations like Konark, Satkosia, Bhitarkanika, Daringbadi and Hirakud.

On the line of annual Rann Utsav held at Rann of Kutch where the Gujarat government organises tented accommodation for the tourists, the Marine Drive-Eco Retreat was organised last December to showcase the best of Odisha's food and culture for high-end tourists. The festival was held for 49 days. This time, events would be organized for a period of three months starting from December this year.

The event is being organised to attract high-end tourists through a mix of luxurious accommodation coupled with adventure and water sports activities.

"As the Eco Retreat at Konark last year was a hit, we have planned to organise such event at five locations this year so that we can attract more number of tourists and make Odisha a brand



in tourism sector, not only within the country, but also abroad," said Tourism Director Sachin Ramchandra Jadhav.

The department has floated tenders inviting private players to conceive, develop, finance, operate, maintain, promote and market the Eco Retreat project sites, he said, adding, "We will provide basic amenities like water supply, electricity connection and other requirements at the sites.

To promote the event, the government has also decided to provide Viability Gap Funding (VGF) to the preferred bidders, Jadhay said.

The private operator will setup and manage temporary structures (tented cottages, restaurants, conference halls, reception area, etc.) in compliance with minimum development obligation. The services provided at the Eco Retreat will be at par with any 3-star category hotels, he said. The director said the Eco Retreat at Konark will have 50 luxurious tents, while other destinations will have 20 to 25 units. The government aims to attract

tourists having good spending capacity to visit and stay in Odisha so that they can experience the state's rich art & culture, handloom & handicrafts and natural beauty, and also help in development of the tourism industry in the state. The event will be packed with lots of entertainment, as well as adventure activities such as jet-ski, speed boating, parasailing, archery, rifle shooting, cy-

Rich nations secure deals for 50% Covid vax supply: Report

SUPPLY DEALS HAVE SO FAR BEEN AGREED FOR 5.3 BILLION DOSES, OF WHICH 2.7 BILLION (51 PER CENT) HAVE BEEN BOUGHT BY DEVELOPED REGIONS LIKE THE US, UK, EU, AUSTRALIA, HONG KONG AND MACAU, JAPAN, SWITZERLAND AND ISRAEL

Washington, Sept 17: A group of wealthy nations representing 13 per cent of the global population have already bought up more than half of the promised doses of future Covid-19 vaccines, according to a report by Oxfam Wednesday.

The non-governmental organisation analysed deals struck by pharmaceuticals and vaccine producers for the five leading vaccine candidates currently in late-stage trials, based on data collected by

the analytics company Airfinity. "Access to a life-saving vaccine shouldn't depend on where you live or how much money you have,' said Robert Silverman of Oxfam

'The development and approval of a safe and effective vaccine is crucial, but equally important is making sure the vaccines are available and affordable to everyone. Covid-19 anywhere is Covid-19 everywhere." The five vaccines analyzed were from AstraZeneca, Gamaleya/Sputnik, Moderna, Pfizer and Sinovac.

Oxfam calculated the combined production capacity of these five vaccine candidates at 5.9 billion



ple given that all five future vaccines will or are highly likely to require

Supply deals have so far been agreed for 5.3 billion doses, of which 2.7 billion (51 per cent) have been

bought by developed countries, territories and regions, including the US, UK, European Union, Australia, Hong Kong and Macau, Japan, Switzerland and Israel.

The remaining 2.6 billion doses have been bought by or promised to developing countries including India, Bangladesh, China, Brazil, Indonesia and Mexico, among others. The non-profit added that one of the leading candidates, developed by Moderna, has received \$2.5 billion in committed taxpayers' money, but has said it intends to make a profit and has sold the options for all its supply to rich nations.

Oxfam and other organisations are therefore calling for a "people's vaccine" free of charge, distributed fairly based on need

"This will only be possible if pharmaceutical corporations allow vaccines to be produced as widely as possible by freely sharing their knowledge free of patents, instead of protecting their monopolies and selling to the high-

est bidder," Oxfam said. It added that the estimated cost of providing a vaccine for everyone on Earth was less than one per cent of the projected cost of Covid-19 to the global economy.

'Sputnik V': 14 pc report side-effects

MOSCOW: Russian Health Minister

Mikhail Murashko said that one in seven volunteers who have received a dose of Coronavirus vaccine 'Sputnik V' have complained of side effects; including weakness, fever and muscle pain. Murashko informed to a Russian daily that more than 300 people have already received the 'Sputnik V' vaccine as part of the three-phase trial, adding that 14 per cent have complained about their health. According to the minister, the side effects are predicted and usually disappear after a day or a maximum day and a half.





Demolition at Tagore's Patherpuri sparks row 25 fatal accidents in state's

Puri, Sept 17: Demolition of the boundary walls of Patherpuri Hostel, which carries the memories of Vishwakabi Rabindranath Tagore, has stirred a hornets' nest as the alumni of Samanta Chandra Sekhar (SCS) College here have vehemently opposed the move.

An action committee of ex-students of SCS College has urged the district administration to take immediate steps to renovate the dilapidated hostel

The committee also threatened to intensify its agitation if the administration does not reconstruct the boundary walls of the hostel within a week

"Patherpuri Hostel bears the memories of Vishwakabi Rabindranath Tagore. A single inch land of the old hostel cannot be diverted to any other activities. The administration should take immediate steps to preserve the hostel. Bhubaneswar, Sept 17: A total of 25 fatal accidents have been reported in the coal mines of Odisha since 2017, recent data from the Ministry of Coal and Mines claimed.

According to the latest provisional data from the ministry, the state has already seen five fatal accidents and one serious accident this year.

The data claimed that the state saw five fatal coal accidents in coal mining plants while one serious accident was too reported from the areas in 2017.

In 2018, the number of fatal accidents at such sites increased to eight while two other serious accidents were reported from coal mines in Odisha. Likewise, seven persons lost their lives in coal mines while two serious accidents were also reported from the state in 2019.

The ministry said that three deceased from Odisha have already received compensation from the government in 2020 for the current year's accidents while compensation of one of the employees is under process.

Citing the prime reasons for more accidents in coal mines, the ministry said that underground coal mining is more hazardous and geo-mining conditions in the mine is totally different as compared to non-coal mines and opencast mines.

"Volume of production of coal and removal of 'over burden' is much more and deployment of machinery in underground coal mines is also more in comparison with noncoal mines. Risk/hazard of exposure of employees is more in coal underground mines as compared to non-coal mines," the ministry said.

The ministry has claimed to have

taken some preventive steps too to minimise the accidents. These include preparation and implementation of risk assessment based safety management plans, preparation and implementation of principal hazards management plans along with trigger action re-

sponse plan. The ministry said that some other steps are: Conducting safety audit of mines, online centralised safety monitoring system for monitoring different safety parameters and formulation of site specific risk assessment based Standard Operating Protocol.

COVID violations: ₹9L fine collected

Bhubaneswar, Sep 17: In order to ensure strict enforcement of COVID-19 rules, the Bhubaneswar Municipal Corporation has collected about Rs 9 lakh as fines during the last five months against offenders for not wearing masks or practicing social distancing.

Following directives of Health and Family Department, the BMC had issued an order earlier in April that those found short of following COVID regulations were to be fined Rs 200 for first three offences and Rs 500 subsequently.

As per sources, the BMC between the period of 24th April to 14th Sept has collected a total fine of Rs 8.83 lakhs. While most of the fines included offences against not wearing of masks, social distancing and other COVID norms, the penalties also included spitting in public.

"All three zones under the BMC have observed thousands of violators against COVID during the period when the rule came into force. However, these fines are not built for purpose of earning revenue but to ensure that people follow the regulations which is meant for their own safety," said a senior Enforcement Officer at BMC

Doorstep classes rile teachers, parents Doctor, nurse crunch hits

Bargarh, Sept 17: At a time when Covid infection cases are rising in Bargarh district, the government's doorstep education system as an alternative to teaching students in classrooms has suffered a setback due to opposition from locals and guardians, a report said.

Faced with such a situation, the district teachers' association has boycotted the system. Before Covid pandemic started spreading across the state, the government closed schools and colleges. Teaching was badly affected in all districts.

To deal with the situation, the government thought of an alternative to impart education at the doorstep of kids through teachers. It implemented the Alternative Learning and Mentorship Programme (ALMP) under which around 4.700 teachers were asked to stay at their respective headquarters and reach out to 0.3 million school-going children of Scheduled Tribe and Scheduled Caste communities.

The government found it crucial to ensure children continue to learn even as the schools are closed. The ALMP initiative innovated by the government to reach out to the most marginalized and vulnerable of tribal children.

In view of this, the SC/ST welfare department issued an order to this effect. However, the district teachers' body has boycotted this.

Citing reasons for the boycott. the teacher's body submitted a memorandum to Collector Jyotiranjan Pradhan. In the memorandum, they stated that Covid situation in both rural and urban areas in the district has spiraled out of control and there is panic in

The shortage has worsened the healthcare at the times of Covid when focus is on treating Covid cases. It was alleged that cancer, liver, high blood pressure, diabetes patients are deprived of availing proper treatment for last five

According to information from the district administration, 319 doctor posts are lying vacant at different hospitals in the district while there is a need for 537 doctors to look after the healthcare.



The poor healthcare scenario in the district can be gauged from the fact that only 218 doctors are managing health services in the dis-

Besides, severe shortage of nurses has left an impact on the healthcare system. Only 96 nurses work at different primary and community health centres whereas the district actually requires 656 nurses.

The posts of 542 nurses are lying

vacant. Moreover, posts of 63 pharmacists, 85 women health workers, 223 male health workers, 36 lab technicians, 13 radiographers, 13 Ayush doctors are lying vacant.

The CDMO has already apprised the state government about the shortage of doctors and nurses.

The district has 580 health centres including 460 sub-centres, 89 single-doctor public health centres (PHCs) and new PHCs, 30 community health centres (CHCs) and a district headquarters hospital here.

According to government norms, at least six doctors, including four specialists, should be posted in each CHC. Several hospitals, including the ones at Digapahandi, Patrapur and Kodala are running with doctor shortage.

Organic veggies beat price spiral for Keonjhar denizens

Keonjhar, Sept 17: Fresh vegetables grown organically by tribals in hilly areas are available in markets of this town round the year. These types of vegetables have always been the first choice of people. This is because farmers use various types of organic fer-

tilizers to grow their produces. However, organic vegetables have disappeared from the markets after COVID-19 lockdowns came in. Now with restrictions eased and vehicles plying, the markets in this town have been once again flooded with organic

vegetables. These days one can find papaya, plantain, cucumber, colocasia, egg plants, sweet potato, elephant foot vam being sold by the roadside. Apart from organically grown, these vegetables are sold at comparatively cheaper prices to those sold by retail traders. This is the reason why people in this town have not been really hit

the way consumers in other places of Odisha have been by the steep rise in vegetable prices.

According to locals, if the town has a cold storage, they will get more of these organically grown vegetables. At the same time, the tribals will also

benefit. "They come to the market by buses, trucks or pickup vans. Sometimes, they leave with us produces that remain unsold. They do not want to take those back as they have to pay again for them," said the locals. "If there is a cold storage in this town, they won't have to throw away their unsold produces and they will make good profits," they added.

The tribal people also complained that they have to brave the weather to sell their produces. Sometimes they have to sit under a scorching sun, at other times they get drenched by heavy rains. All of them pleaded for some form of shelter over their heads.

"If there is a resting place allotted to us, it will be good. At times we return to our villages late into the night through dense forests. There is always the possibility of being attacked by animals. If there was a place to rest, we would have definitely taken

shelter if needed," they stated. These days, however, residents of this town are facing problems accruing from organic vegetables. This is because retailers are buying the produces in large quantities and at minimal prices. Then these traders sell the same products at exorbitant rates, alleged some locals.

Safety first

ur state government, like its counterparts in India, arranged to bring back migrant workers from across the country in the aftermath of the Covid-19 outbreak. The Railways, on its part, rushed in with special trains and ferried lakhs of workers from Gujarat, Kerala, Tamil Nadu and Andhra Pradesh, among others to Odisha. Not to take a chance, the government plied buses to bring back the left-over workers still stuck in other states. It was treated like a natural calamity and given all the focus and seriousness it deserved. Thousands of quarantine centres had been set up to provide transit shelter to workers and local Sarapanchs were given power at par with District Collectors to facilitate the decision-making process at the ground level. The state government also put in place structured incentives to attract migrants and take care of their needs in quarantine centres. Incentives, both in cash and kind, were announced to facilitate the safe incoming of workers. More importantly, district administrations were directed to create jobs for these people under the Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGA) and to make the most of other state and Central government schemes. Authorities were directed to map varied skills of returnees and provide them with jobs according to their skills. Over five lakh workers had returned to Odisha between May and July.

However, now we can see how all these the programmes flopped. Not long after the migrant workers reached here, they began to be disillusioned with the promises of the state government. In the absence of quick job guarantee programmes, suitable to workers with different skills, we can now see a rush among them to go back to their workplaces. Under Unlock 4.0, the Centre has allowed most industrial activities to resume. Taking advantage of this, people from Bolangir, Sonepur, Nuapada, Ganjam, Korraput, Rayagada and Sambalpur districts are preparing to go back to where they had come from. With Nuakhai festival gone, they want to go back to their workplaces. Reports reveal that firm owners in Gujarat and Tamil Nadu have engaged middlemen and contractors to lure workers as they are set to resume operations. Workers on their part also are showing keenness to return and have reportedly accepted advance money from middlemen. The eagerness of workers to go back, even as the pandemic has been in an increasingly virulent form, can be gauged by the fact workers move in buses to reach far-off places. Last week, a bus from Ganjam full of migrant workers, on its way to Gujarat, met with an accident near Raipur in Chhattisgarh, killing eight people on the spot and leaving many more injured. Another bus aboard migrant workers bound for Tamil Nadu overturned at Rayagada leaving eight people critically injured. Such accidents happen as people, jobless for months, are desperate to go back to their workplaces. The administration fast failed to provide them with jobs. It is now showing criminal negligence by not ensuring the safety and security of these outbound people. As the government brought them here, it was obligatory on its part to find them gainful employment. Now that they are left to fend for themselves and being forced to arrange their own return, the administration should ensure their safe passage. Earlier, Union Minister Dharmendra Pradhan urged Railway Minister Piyush Patel to ply Shramik Special trains to ferry workers back to their workplaces. This was welcome. Train journeys are relatively safer. The despondency and desperation of returnees stem from the fact that they failed to find remunerative employments during repeated lockdowns and shutdowns. While the resilience of our economy is pushing workers to go back to their workplaces despite the pandemic worsening, the authorities must step in and ensure migrant works reach their destinations safely.

guestion is, "Why the tinker in a tinker's damn?" There are two Atheories about this. One points to the very low social status of tinkers, itinerant menders of pots and pans, and to their well-known tendency to include a swearword in every sentence. So, to say that something "isn't worth a tinker's damn", is to say that it's of no value at all, not worth even a moment's consideration. A more ingenious explanation was put forward in the latter part of the 19th Century: when a tinker was soldering a pot, he would make a small wall out of bread dough around the place he was to flood with solder in order to stop it from spreading. After he had finished, he would naturally throw the dough away as being of no further use, so that "a tinker's dam" was equally something of no value. A century ago, the compilers of the First Edition of the Oxford English Dictionary were scornful of this attempt to make a simple matter more complicated. though it is still to be found in current works on phrase histories. It speaks to that part of us that wants to convert the mundane to the magical, to find something of mystery and interest in even the most ordinary of expressions. The simpler story is much the more likely. It is supported by variations such as tinker's curse and tinker's cuss.

Tinny

inny was once common in both Australia and New Zealand, though it has fallen somewhat out of use. That's very probably because other slang senses have superseded it, such as those for a can or tin of beer and for a lightweight aluminium boat. As it happens, the first example recorded in print is from New Zealand, in the Chronicle of the New Zealand Expeditionary Force of 1918: "Remarks are heard on the 'tinny' luck or otherwise of the [poker] players while the 'stiffs' bemoan their luck." A comment in a book by Eric Partridge two decades later asserts that it was First World War soldiers' slang. Both the Oxford Australian Dictionary and the Oxford New Zealand Dictionary say the origin is the earlier slang tin for money. This is known from 1836. The Oxford English Dictionary notes, "Said to have been first applied to the small silver coins of the 18th century, which before their recall in 1817 were often worn guite smooth without trace of any device, so as to resemble pieces of tin." Part of the stimulus for inventing it may have been the even older brass for money, which is known from the sixteenth century. Various compounds of tin appear in the record earlier than tinny. The Bulletin of Sydney noted in 1898 that a tin back is "a party who's remarkable for luck". Much later, tin-arsed appears as a term for a person who is remarkably lucky. This has puzzled some writers, who don't see the historical link with the money sense of tin, and have suggested it means somebody who is well protected in the fundament by a metal sheet so a kick there doesn't cause any pain. The variant tin bum is known in New Zealand.

DEALING WITH DEVIL

efence Minister Rajnath Singh spoke in Parliamentthis Tuesday on the border face-off with China. Rajnath Singh is an old hand in governance, deeply experienced and extremely articulate. Yet, his statement to Parliament was esoteric, evasive and laconic.

Disappointing, that he did not say a word about what government is intending to do in order to restore the status quo ante pre-May 2020. He was full of platitudes on diplomacy and sentiments about the Army and the 20 soldiers who laid down their lives on 15 June. There is hardly any divergence of opinion or emotions about our Army. Hence, it was esoteric.

No one is itching for a war unless it is imposed, although there is a slender voice doing the rounds that we should give the Chinese a bloody nose even if we get one in retaliation. Diplomacy based on dialogue, negotiations and international campaign is any day a better option than war, however limited. But, in diplomacy, what is our bargaining chip?

Foreign policy is a strategy of a state vis-à-vis other states or international entities and of achieving specific goals defined in terms of national interest, said Plano and Olton in the International Relations Dictionary. Interestingly, there are key determinants which define our national interest which in turn strengthens those determinants. It is not one or a set of factors but it is interplay of several factors under different circumstances that make a foreign policy. There are also external stimuli which a country reacts to and domestic determinants that shape and anchor a foreign policy. While external factors are not necessarily under the control of a country, the indigenous ones are.

In the formative years, immediately after Independence, our foreign policy was based on anticolonialism, peace and progress, non-alignment, political traditions, security imperatives and above all, the personality and the outlook of the leader. Jawaharlal Nehru, who was both Prime Minister and foreign minister, through his talents, experience

and personality, dominated the foreign policy in the beginning. What happened to America's foreign policy after Nixon resigned following the Watergate scandal? What is happening to China under Xi Jinping?

Until the advent of the BJP into power with a majority government led by Atal Behari Vajpayee, Nehruvian foreign policy was followed under the slogan of 'Continuity and Change'. In this, there was only continuity and no change except the tweaking of the concept of non-alignment to say 'genuine non-alignment' under the brief Janata Party period.

Nehru alone dominated the foreign policy arena until 1964, or till his death. Nehru was considered an idealist, less of a pragmatist. Vajpayee added his personal weight both as a foreign minister in the Janata government and later as Prime Minister. He had announced, "Nothing stops India and United States from becoming natural allies". Manmohan Singh, widely considered a weakling by his critics, broke tradition, took a political risk and signed the nuclear deal with the US in 2005. The Leftist allies of his government withdrew support although the government survived with the backing of the Samajwadi Party.

Prime Minister Modi has not signed any substantive agreement on either economy or security with the world's biggest power, the US, despite overtures by the latter. Perhaps, he built a personal rapport with President Donald Trump through two big public rallies in the US and in India. A solid bilateral agreement on trade or security was expected out of such public display of friendship and partnership.

Both normatively and in praxis, the comprehensive national power of a country is the key determinant in matters of diplomacy. The power consists of a strong economy, sound political order, peace, harmony and national unity. Our economy, even before the pandemic, was crumbling. There are lots of statistics in the public domain including the government sources to show the pathetic situation of the

Paradoxically, we are fighting China but our economy is hooked to the trade with it. Even at present, in Covid times, and the border face-off, our trade with China is growing more than with any other country. Our security strategy is making us spend heavily on procuring armaments. A study on the links of Disarmament and Development says how the cost of one fighter aircraft could run our schools for years; likewise, the cost of a missile could run all our old-age homes for years together. Therefore, in order to be able to invest in development of people and infrastructure, we need to have a different security strategy.

Our political traditions, ethos and systems have been our great est strength. Drawing on Buddha, Ashoka, Gandhi, Tagore we have won the confidence of the world. Our political diversity and pluralism have connected us to the world of democracy, human rights, civil liberties, dignity and solidarity. But, of late, we are wit nessing disharmony and discord in the society which is affecting our foreign policy. Remember, the proposed visit of Shinzo Abe to Assam in December 2019 did not happen due to riotous situation in the state following the imposition of NRC. If the visit took place, a big trade investment treaty would have been signed.

James N. Rosneau, the American political scientist said that foreign policy is credible and effective when public officials are accountable to the citizens. Also when there is harmony between the Executive and the Legislature. Is this the case today in our country? Look at the state of Pakistan from 1947 to 1989 because of political instability caused by military coups. So, to downplay India's politics of pluralism and democ racy, will undermine our national interest and its articulation in our foreign policy.

Finally, the talk of participating in a multi-polar world is impractical. Deepening convergences with USA, while managing differences with China and soft-balancing major powers are a throw back to the days of non-alignment. Juggling several balls in the air at a time is easier said than done Maintaining strategic independence in an interdependent world is a tall order. A NATO like alliance is a greater bulwark against aggressive and expansionist neighbours like China. So, our foreign policy determinants have to be reassessed. Is the government on

Moment of truth as Covid-19 spreads

lmost in its tenth month, the Covid-19 pandemic is still ∡ ⊾wreaking havoc on economies and lives around the world. But while the end of the crisis seems as far away as ever, the fact is that we are approaching a potential turning point. World leaders now have an opportunity to seal the deal on a global framework that puts international cooperation above vaccine nationalism in stopping the pandemic.

The moment of truth will be at midnight on September 18. That is the deadline for countries to join the Covid-19 Vaccine Global Access Facility (COVAX), an initiative launched by Gavi, the Vaccine Alliance, the World Health Organization, and the Coalition for Epidemic Preparedness Innovations. COVAX represents the best chance we have to provide people in all countries with rapid, fair, and equitable access to Covid-19 vaccines as soon as they become available. The initiative has already achieved an extraordinary scale, with more than 170 countries already signaling their intent to join.

Nothing like COVAX has ever been attempted, and the short time frame in which it has been assembled makes it all the more remarkable. If successful, this will be the first time that the international community has come together to ensure equitable and simultaneous access to new lifesaving pandemic interventions for rich and poor alike.

As we head into the fall, and Covid-19 continues to spread, the global death toll is approaching one million, with monthly economic losses estimated at \$500 billion. Under these conditions, ensuring fair, universal access to vaccines is necessary if we are to bring the crisis to an end. Until everyone is protected, everyone will remain at risk of the disease, its adverse economic effects, or both.

 $As the only {\it truly global approach}$ available, COVAX's importance cannot be overstated. Although there are more than 200 Covid-19 vaccines in development and at least 35 clinical trials underway. the vast majority are likely to fail. Historically, candidate vaccines at the preclinical stage have less than a 10 per cent chance of succeeding. And of those that do advance to the clinical trials stage, only around 20 per cent will ultimately be approved. Given these odds, even

wealthy governments that are currently negotiating bilateral deals with individual vaccine manufacturers cannot guarantee access to a vaccine on their own.

COVAX's initial aim is to have two billion vaccine doses available by the end of 2021, as that should be enough to protect high-risk/vulnerable populations and frontline health-care workers. But to hit that target, we first need the legally binding commitments of as many countries as possible.

After the sign-up deadline of September 18, the priority will be to complete the development and testing process to ensure that all forthcoming vaccines are both effective and safe. COVAX will need to put in place agreements with drug manufacturers, so that it can begin delivering vaccines at scale as soon as they are approved. And donor funds will be needed to subsidize the purchase of vaccines for low-and lowermiddle-income countries

But even with financial solutions in place, the process of distributing vaccines will pose significant challenges. The delivery of Covid-19 vaccines will be the single largest vaccine deployment the world has ever seen, and it will

have to be executed at a time when misinformation (the "infodemic") is threatening to undermine public confidence in vaccine safety. Though the pandemic is far from

over, we at least have a global solution in sight. COVAX represents the best hope that we have for bringing a prompt end to the crisis. When people look back and marvel at how quickly the scientific community and development practitioners responded to the Covid-19 threat, they will be able to point to the speed with which governments put aside national interests in the name of international cooperation and solidarity. Whatever specific moment future historians choose as the pandemic's turning point, there will be little doubt that the creation and widespread adoption of the COVAX framework played an indispensable role in ending it.

Kolkata, Sept 17: Gross violations of COVID-19 social distancing norms were seen at several ghats of river Ganga in Kolkata and it's adjoining Howrah district as people came in hordes to offer tarpan Thursday morning.

Thousands of people were seen violating safety guidelines as most of them did not ever bother to wear masks and use the sanitising channels while entering the ghats on the occasion of Mahalaya.

The auspicious day marks the last day of *Shradh* and the beginning of the Durga Puja festivities, the day when the goddess Durga is believed to have descended on Earth.

People in West Bengal traditionally wake up early morning Mahalaya in a bid to make offerings to divine entities as per Vedic practice remembering their forefathers and their departed souls.

Amid announcements of maintaining physical distancing guidelines made by the Kolkata Police and disaster management teams, the rituals were performed, at a time when the daily figures of Corona cases reached an all-time high in India.

The state ruling Trinamool Congress volunteers also distributed free masks at several ghats, including Ahiritola Ghat, and joined hands with the police to do the crowd management activities.

Chief Minister Mamata Banerjee also extended warm regards to all the residents of the state.

"On the auspicious occasion of Mahalaya, I extend my warm regards to one & all. Although COVID-19 has restricted how we celebrate festivals, we shall not allow it to



Puja," she said. She urged everyone to come forward, extend a helping hand to those in need and spread joy everywhere.

"As a part of this pledge, I vow to ensure that this Durga Pujo, no one is devoid of the festivities,' Banerjee tweeted, greeting everyone on Shubho Mahalaya.

On the other hand, state Bharatiya Janata Party (BJP) activists had performed the ritual of Tarpan on the eve of Mahalaya for its slain activists, despite the programme to be held at a Kolkata ghat. Initially, the venue was decided at Baghbazar ghat in north Kolkata, then changed to Golabari ghat in Howrah - exactly on the other side of the mighty river.

The Kolkata Police officials cited the prevailing COVID-19 situation for its action and had dismantled a temporary podium Wednesday erected for the Shahid Tarpan, in memory of slain BJP activists in Bengal in order to avert a political face-off.

Bengal forests to reopen for tourists from September 23

Kolkata, Sept 17: Forests in West Bengal will be opened for tourists from September 23, officials said

Every year the forests close down for two months due to the Monsoon -- from July 15 to September 15, but because of the COVID-19 pandemic the forests have been out of bounds for tourists since the beginning of the lockdown in March, they said.

The state government decided to open the forests ahead of the festive season as the prolonged closure was bleeding the tourism economy, they added.

Principal Chief Conservator of Forests Ravikant Sinha said the decision to open the forests was taken at a meeting chaired by Forest Minister Rajib Banerjee Wednesday. He said guidelines will be issued for tourists and the details will be decided at a meeting on Friday.

Baneriee had earlier said that the government was working out modalities to open forests and national parks for tourists during the festive season.

nCoV impact: Unfinished Durga idols, few buyers at artisans' Kolkata studios

Kolkata, Sept 17: It has been an age-old tradition for artisans' of Kolkata's century old potter's town Kumartuli to draw the eyes of Goddess Durga on Mahalaya, as a part of their final touch to the process of idol-making.

This year, the scene was completely different at Kumartuli located in the crumbling neighbourhood of north Kolkata. Most of the studios wore a deserted look with half-done Durga idols and many of them still remained as mere bamboo structures.

'The rituals to draw the eyes of Goddess Durga couldn't be performed this year on Mahalaya as most of the idols were not ready. Many of the puja organisers have still not booked their idols and sent an advance." said Kumartuli artisan Chaina Pal, adding that if they do not receive an advance they finish the idols on time.

Pal said that unlike every year, this time the festival would be held after more than one month from the day of Mahalaya. "That also made

Sources at Kumartuli said that only a few idols, those which are made of fibre or which will travel to remote corners of the country from Kumartuli, have been given the finishing touches so far. The rest are still in an unfinished state.

slow on the preparation," she said.

Since the budget for Durga Puja has been slashed by organisers from across platforms, the artisans of Kumartuli also had to make heavy compromises on the pricing, size and volume of the Goddess to make them fit into tiny budgets.

Interestingly, the traditional family pujas of Kolkata also made certain changes in their annual celebration. According to sources in Kolkata's Daw family, this year their Durga idol would be smaller in size than the previous year.

Pilibhit, Sept 17: A group of villagers in Pilibhit have built bamboo bridge for the Sashastra Seema Bal (SSB) troopers, about 200 metres from the Uttar Pradesh-Nepal border.

The 25-metre-long and 1.2metre-wide bamboo bridge on a deep-water channel has been built by the Bamanpur Bhagirath village head, Gurdev Singh, with assistance from the locals.

Ajay Kumar, Commandant, SSB's 49th Battalion, said: "A bridge was urgently needed for the frequent, prompt and unhindered movement of SSB patrolling pickets, especially during the night.

"The bridge will assist us in keeping an eye on any encroachment from the Nepalese side into the Indian territory as

was reported in June this year." He added that his Nepalese counterpart from the Armed Police Force (APF) had given consent for the construction before the work started.

The construction of the bridge was initiated September 10 and it was completed in just five days at a cost of merely Rs 50,000 on the water channel known as Sutia drain.

As the village panchayat had no provision for the construction, the locals were encouraged to contribute.

The money was contributed by villagers. The bridge holds importance as it provides a vantage point to the troopers patrolling the border, and particularly after a row over the construction of a road between pillars 38 and 39 by the Nepalese side.

The road construction work was, however, halted after Indian

authorities took up the matter their Nepalese counterparts, but the SSB is keeping a tight vigil to ensure the construction work does not resume in any manner.

"The road construction work was suspended till the time joint survey teams of the two countries demarcate the territories. Till then, we have to ensure that no violation of the status quo takes place. Thus, the bamboo bridge will prove advantageous to us in serving our objective,' said Kumar.

Puranpur block development officer Neeraj Dube said: "The bridge was built by village head Gurdev Singh for the SSB's 49th Battalion, but it would also facilitate village farmers to have easy access to their farms around 75 to 80 acres - situated close to the porous border on the other side of the drain.

OPPN LEADERS MEET PREZ India slams Pak over new map

New Delhi, Sept 17: Opposition leaders met President Ram Nath Kovind Thursday and raised questions about the role of the police during the February riots, besides expressing their lack of confidence in the probe of the incident

In a joint memorandum, the leaders raised their concerns over the probe into the riots being conducted by the Delhi Police. The Delhi Police has set up Special Investigation Teams (SIT) and its Special Cell is also probing the aspect of conspiracy behind the Delhi riots in which 53 people lost their lives.

"There are, however, serious questions about the role played by the Delhi Police during the violence and also the manner in which the police is harassing and attempting to falsely implicate activists and young people who took part in the anti CAA/NRC/NPR movements as the perpetrators of violence. "Such a manufactured conspiracy theory has now begun to falsely implicate political leaders," it said.

The memorandum also criticised the police for the reference made to CPI(M) general secretary Sitaram Yechury citing disclosure statements by the accused. "This is a disturbing trend that raises serious questions over the manner of such investigations," the leaders said.

They also alleged that there are several publicly documented accounts and videos of police being "complicit in the violence, directing mobs pelting stones or looking the other way when mobs were indulging in violence".



New Delhi, Sept 17: A PIL has been filed in the Supreme Court seeking legal action against former Supreme Court judge Justice Markandey Katju for casting aspersions and making insinuations on the integrity and credibility of the Indian judiciary while deposing for fugitive diamantaire Nirav Modi before the Westminster Magistracy court of the UK.

The PIL has been filed by Nand Kishore Garg through advocate Shashank Deo Sudhi, "The Indian judiciary must not take this issue casually as such derogatory deposition made the entire judiciary suspect in the eyes of the international community. It is high time to redeem the glory of Indian judiciary by acting proactively to stop such routine false allegations," said the plea.

It contended that the deposition made by Katju is highly derogatory and insulting to the entire judicial system of India. "His allegations amount to questioning the very credibility of judicial institution where millions of citizens are reposing their faith and trust. The allegation of fairness of judicial administration is totally unfounded as the justice delivery system of India is quite strong and robust," argued the petitioner. The petitioner has urged the top court to issue a broad guideline on issues of public criticism/maligning of the judicial system and it's serving judges especially from those who served the highest institution of our country.

Pulwama-type attack averted

Srinagar, Sept 17: A Pulwama-like tragedy was averted by security forces after a large quantity of explosive material was recovered in south Kashmir's Pulwama district Thursday

Acting on a tip-off about the presence of terrorists of proscribed terror outfit Jaish-e-Mohammed, the police along with the Army and CRPF conducted a joint search of a nursery area near forests of village Gadikhal in

During the search, two explosive dumps were found which were concealed underground in two different 250 litre plastic tanks.

"In one plastic tank, 416 high-explosive gelatine sticks have been recovered while in another plastic tank, 50 detonators were recovered. The detonators were destroved by the Bomb Disposal Squad on the spot, due to their risk of carrying/transporting," police said. Police said by virtue of this recovery, security forces have been able to avert a major terror attack by means of explosive substances. The spot is close to Lethpora in Pulwama on the Jammu-Srinagar National Highway where 40 CRPF jawans were killed in a suicide attack.

SHOCKING REVELATION

22 Armymen died in 3 years on high altitude duty

INDO-ASIAN NEWS SERVICE

New Delhi, Sept 17: In a shocking revelation, 22 Indian soldiers have lost their lives without any battle in the last three years because of their duty in highly treacherous terrain along the borders in Jammu and Kashmir high altitudes.

The causes of the deaths in the Siachen Glacier and other super high altitude areas range from those directly related to high altitude like High Altitude Pulmonary Oedama (HAPO) and Pulmonary ThromboEmbolism (PTE) to other

general causes. Eight of the Indian Army soldiers lost their lives while serving at these high altitudes in 2019 and the similar number of troops of the force in 2018. However, a total of

six soldiers died in 2017. The Ministry of Defence has revealed the details in Parliament Wednesday in a written reply to the query of Bharatiya Janata Party MP Gowdar Mallikarjunappa Siddeshwara.

Minister of State for Defence Shripad Naik informed the Lok Sabha when asked: "Whether it is a fact that there have been some casualties of soldiers serving at high altitudes". Asked about the government ac-

tion taken to prevent such casualties and provide a congenial atmosphere to the soldiers working at high altitudes like Siachen, the minister said: "Indian Army is deployed in highly treacherous terrain along the borders in Jammu and Kashmir, where there is constant threat of crevasses, avalanches and

other weather-related calamities to the troops

"The government undertakes several steps to prevent casualties like pre-induction medical examination, requisite medical cover at all medical echelons which are well equipped to deal with any high altitude illness, stringent acclimatisation schedule, provision of specialised training, special living shelters, including provision of kerosene oil, provision of specialised clothing and high quality rations," Naik informed the lower House in the written reply to an Unstarred Question. Steps are also undertaken to utilise modern technological equipment for the rescue missions. prevention of accidents and ensuring rapid and timely evacuation of the casualty, apart from issuing of regular advisories, he said.

The Indian Army's mountain warfare experience and strategies make its troops the 'most skilled in the area'. From the northern borders in Jammu and Kashmir to Arunachal Pradesh, the easternmost part of the country, a large number of Indian soldiers are deployed in the mountains and have mastered the art of fighting in the snowy landscape as well as the harsh barren vastness of Ladakh, the region where they are currently in an eyeball-to-eyeball situation with the soldiers of China's People's Liberation Army.

At present, the world's largest and experienced country with plateau and mountain troops is neither the US, Russia, nor any European powerhouse, but India, read an article by Huang Guozhi, a senior editor of the Modern Weaponry magazine and a Chinese expert. Huang stated that since the 1970s, the Indian military has established and expanded in size and has personnel trained for fighting in the mountains on a large-scale. India also plans to create a mountain strike force of more than 50,000 troops. The Indian Army is the best practitioner of mountain warfare with maximum experience because its officers and personnelspend a major part of their service in the mountains.

THREE MILITANTS, **WOMAN KILLED**

Srinagar, Sept 17: Three local militants and a civilian woman were killed, while two CRPF personnel, including an officer, sustained injuries in a predawn gunbattle Thursday in the Batamaloo area of the city here, officials said.

This takes the number of militants killed this year to 177 in 72 operations. The number includes 22 foreign terrorists. Security forces launched a cordon and search operation in Firdousabad locality in Batamaloo area at around 2.30 am following information about the presence of militants there, the officials said.

They said the search operation turned into an encounter after the militants opened fire on security forces. A civilian, identified as Kaunsar Riyaz (45), was killed in the firing, while two CRPF personnel, including an officer, were injured, the officials said. The injured personnel were taken to hospital, they said.

Jammu and Kashmir Director General of Police (DGP) Dilbagh Singh said all the three militants killed in the encounter were locals from south Kashmir. Addressing a press conference at the Police Control Room (PCR) Srinagar, the DGP said that in the early hours of the day, security forces, while acting on a lead, zeroed in on a house where the militants were hiding.

They were given a chance to surrender, but they refused and fired. One CRPF officer and another CRPF man sustained injuries in the initial exchange of firing. The officer is critical and we are praying for his recovery,' Singh said. He added that the forces conducted the operation in a professional manner and

killed all the three militants. "However, a woman was caught in crossfire. Her death is very unfortunate, and we express sympathy with the bereaved family," the DGP said. The officer was accompanied by IGP, Kashmir, Vijay Kumar and IG, CRPF, Srinagar sector, Charu Sinha. "Arms and ammunition were recovered," he said.

Defence employee arrested

Rewari, Sept 17: A civilian defence employee was arrested for passing on classified information to a Pakistani Military Intelligence (MI) unit after he had been honeytrapped on Facebook.

Official sources said that based on a specific input of Lucknow based Indian Military Intelligence (MI), the Haryana Police's Special Task Force (STF) Wednesday arrested Mahesh Kumar, the civilian employee of Military Engineering Services (MES), from Rewari for sharing the information to a young woman associated with the Pakistani MI in return for money.

Kumar, according to police, was reportedly in touch with operatives of the Pakistani MI unit for the last two and a half years and has received money from them on multiple occasions. Sources said that in June, Lucknow MI received the input that a mobile number used by Kumar, who was posted in Jaipur, was passing on defence related information to a woman working for

The payment module was very similar to what had surfaced in the Rajasthan based espionage case, 'Op Desert Chase', wherein Vikas Kumar and Chiman Lal were arrested. In the first week of September, Kumar was found staying in and around Rewari.

The MI shared the case details with the STF Haryana and a joint team of both the agencies investigated it further.

A swift operation to apprehend and interrogate the suspect was planned for September 13-14. However before the Lucknow MI could obtain desired sanctions and place a team near Rewari, the suspect suddenly moved out of Haryana, the sources said.

The STF Haryana recently indicated that Kumar was likely to visit Rewari again Wednesday

'Govt wants to bring down mortality rate'

New Delhi, Sept 17: Union Health Minister Harsh Vardhan Thursday said the government is aiming to bring down India's COVID-19 mortality rate to less than 1 per cent from the current 1.64 per cent, which is still the lowest in the world.

Replying to a debate in Rajya Sabha, he said the country's recovery rate of 78-79 per cent is one of the highest in the world, adding though the total cases may have crossed 50 lakh, active cases are less than 20 per cent. Deaths in India due to coronavirus are less than many nations in Europe and the government is determined to better the testing rate of the US, he said.

Vardhan said there are chances that a vaccine could come in the country early next year but till then it was necessary for people to follow social distancing and wear masks. The minister said that despite the number of cases, the mortality rate in the country remained one of the lowest in the world. He said steps like testing, isolation of infected persons and other steps can be attributed to this lower mortality rate. Citing the examples of Spain and Brazil, he said the mortality rate in those countries was over 11 times that of India.

"We want to bring it (mortality rate) to less than one per cent. We have 50 lakh cases right now but out of these, only 10 lakh are active cases in the country right now," Vardhan said. He said that various international experts had predicted that the cases in India will rise to 300 million by July-August, resulting in death of 5-6 million people.

"In the country of 135 crore people, we are doing 11 lakh tests now and are second to the US only. It has



been possible only due to the united fight against the disease," he said. On development of a vaccine, he said that the Science and Technology ministry, ICMR and drug companies have come together for a solution. Even this matter is also being personally monitored by Prime Minister Narendra Modi, he added

'Vaccines can come in future. Extensive planning is underway to execute how to manage the scenario, "Vardhan said. During this time, his reply was interrupted for few minutes as the sound system faltered with members in Rajya Sabha unable to hear. Vardhan was speaking from his allocated seat in Lok Sabha.

Continuing after few minutes of disruption, he said there are three vaccine candidates which have reached phase one, two or phase three level. "Under the prime minister, an expert group is studying this. We expect by the beginning of next year we can have a vaccine in the country. In this regard we are also coordinating with WHO and global organisations," he said.

India is among few countries globally which has been able to isolate the virus, Vardhan noted

CBI team back in Delhi

New Delhi, Sept 17: Almost a month after the Special Investigation Team (SIT) of the Central Bureau of Investigation (CBI) went to Mumbai to probe the death of Bollywood actor Sushant Singh Rajput, it has returned to Delhi and will hold a meeting next week with the AIIMS forensic team, sources said Thursday. According to CBI sources, the

team of the SIT has returned to Delhi and will now be holding meetings with the AIIMS forensic team Sunday and later in the coming week also to take its medico legal opinion in the case.

The team had gone to Mumbai along with the forensic team August 20. a day after the Supreme Court gave its nod to the CBI probe into the death of the late actor. During

the CBI's stay in Mumbai, the All India Institute of Medical Sciences (AIIMS) forensic team also visited the flat of Sushant and recreated the crime scene along with Sushant's sister Mitu, Pithani and personal staff.

The CBI last month had roped in the AIIMS forensic department to take its assistance in studying the autopsy report prepared by the Cooper Hospital, the crime scene recreation and to guide the federal agency if there was any foul play in his death. Sushant was found dead in his Bandra flat June 14.

AIIMS Forensic Department head Dr. Sudhir Gupta has constituted a medical team to assist the CBI. AIIMS sources said, "We are in the process of perusal of the case after due medical board meeting and subsequent meeting with the CBI."

100-yr-old Assam woman beats Covid

Handique, Assam's oldest COVID-19 patient, was discharged from the Mahendra Mohan Chowdhury Hospital (MMCH) in Guwahati Wednesday, they said. A resident of the Mothers' Old Age Home, she was admitted to the hospital ten days ago after testing COVID-positive.

The doctors and nurses who were treating her held a small celebration before she was discharged. Handique, who was beaming with excitement, joined the party singing several Assamese songs in her full-



throated voice.

Handique, called Aita (grandma) by all at the hospital, said that she enjoyed her stay and the food. "We were given fish or meat on most of the days while egg and banana were given daily. We were also given 'ruti- bhaji' (chappatis and vegetables) which I enjoyed the most," she said.

According to the Forest and Land Authority, 598,716 hectares of area were affected by fires in the first week of September.

Pak closes 22 Edu institutes in 48 hrs

Islamabad: At least 22 educational institutions in Pakistan have been closed down during the last 48 hours for failing to comply with the government-issued standard operating procedures for curbing the spread of COVID-19, the country's coronavirus control body said Thursday.

'UN facing its 1945 moment'

United Nations: UN Secretary-General Antonio Guterres has warned that the world body was facing its own "1945 moment", noting that efforts must be made to "meet that moment". 5 Chinese hackers targeted Indian networks, says US

The indictment stated that the Indian govt's network was compromised in 2019

Washington, Sept 17: The US Justice Department has charged five Chinese citizens with hacking over a 100 companies and institutions in America and abroad, including the Indian government's networks, and stealing valuable software data and business intelligence.

Deputy US Attorney General Jeffrey Rosen Wednesday announced three indictments have been unsealed in the matter that collectively charge five Chinese nationals with computer hacking and charge two Malaysian nationals for helping some of those hackers target victims and sell the fruits of

The Malaysian nationals were arrested Sunday and the Chinese nationals have been declared fugitive, according to a Justice Department statement.

Rosen severely criticised the Chinese government. "The Department of Justice has used every tool available to disrupt the illegal computer intrusions and cyberattacks by these Chinese citizens. Regrettably, the Chinese Communist Party has chosen a different path - of making China safe for cyber-criminals so long as they attack computers outside China and steal intellectual property helpful to China," the deputy attorney general said. "In about 2019, the conspirators compromised Government of India websites, as well as virtual private networks and database servers supporting the Government of India. The conspirators used VPS PROVIDER servers to connect to an Open VPN network owned by the Government



of India," the indictment said. In the attacks, the conspirators installed 'Cobalt Strike' malware on Indian government-protected computers, it added. According to the charges, the computer intrusions affected over 100 companies in the United States and abroad.

The victims ranged from software development, computer hardware, telecommunication, social media and video game companies. Non-profit organisations, universities, think-tanks, foreign governments, pro-democracy politicians and activists in Hong Kong were also targeted. Security researchers have tracked the intrusions using labels "APT41, "Barium," "Winnti," "Wicked Panda," and "Wicked Spider." These intrusions facilitated the theft of source code, software code signing certificates, customer account data, and valuable business information, the researchers said.

These intrusions also facilitated the defendants' other criminal schemes, including ransomware and "crypto-jacking" schemes, the latter refers to the group's unauthorised use of victim computers to mine cryptocurrency. The Chinese hackers also targeted government computers and networks of Vietnam and United Kingdom.

Pakistan to elevate Gilgit-Baltistan to full-fledged province

Islamabad, Sept 17: Pakistan has decided to elevate Gilgit-Baltistan's status to that of a fullfledged province, a Pakistani media report Thursday quoted a senior minister as saying.

India has clearly conveyed to Pakistan that the entire union territories of Jammu and Kashmir and Ladakh, including the areas of Gilgit and Baltistan, are an integral part of the country by virtue of its fully legal and irrevocable accession.

According to a report in the Express Tribune, Minister for Kashmir and Gilgit-Baltistan Affairs, Ali Amin Gandapur, on Wednesday said that Prime Minister Imran Khan would soon visit the region and make the formal announcement to elevate Gilgit-Baltistan to the status of a full-fledged province with all constitutional rights.

Gandapur said Gilgit-Baltistan would be given adequate representation on all constitutional bodies, including the National Assembly and the Senate.

"After consultation with all stakeholders, the federal government has decided in principle to give constitutional rights to Gilgit-Baltistan," the minister told reporters. India has said the Government of Pakistan or its judiciary has no locus standi on territories illegally and forcibly occupied by it.

India completely rejects such actions and continued attempts to bring material changes in Pakistan occupied areas of the Indian territory of Jammu and

Navalny poisoned in hotel

NAVALNY FELL VIOLENTLY ILL ON A FLIGHT IN RUSSIA LAST MONTH AND WAS AIRLIFTED TO BERLIN FOR TREATMENT

Moscow, Sept 17: The nerve agent used to poison Russian opposition leader Alexei Navalny was detected on an empty water bottle from his hotel room in the Siberian city of Tomsk, suggesting he was poisoned there and not at the airport as first thought, his team said Thursday.

Navalny fell violently ill on a

flight in Russia last month and was airlifted to Berlin for treatment. Laboratories in Germany, France and Sweden have established he was poisoned by a Novichok nerve agent, a poison developed by the Soviet military, though Russia denies this and says it has seen no evidence. A video posted on Navalny's Instagram account showed members of his team searching the room he had just left in the Xander Hotel in Tomsk on Aug. 20, an hour after they learned he had fallen sick in suspicious circumstances. "It was decided to gather up everything that could even hypothetically be useful and hand it to the doctors in



Germany. The fact that the case would not be investigated in Russia was quite obvious," the post said.

The video of the abandoned hotel room shows two water bottles on a desk, and another on a bedside table. Navalny's team, wearing protective gloves, are seen placing items into blue plastic bags. "Two weeks later, a German laboratory found traces of Novichok precisely on the bottle of water from the Tomsk hotel room," the post said. Vladimir Milov, a former deputy energy minister and an ally of Navalny, said his team had outmanoeuvred the FSB security police with their quick thinking: "They took the evidence from under their noses and shipped it out of the country."

Navalny's ally Georgy Alburov told Reuters "the bottles flew with Alexei" when he was airlifted to Germany August 22.

PAK GOVT FREEZES OVER 900 ASSETS OF JuD, JeM

Islamabad, Sept 17: The Pakistan government has frozen a total of 964 assets of proscribed organisations Jamaat-ud-Dawa (JUD) and Jaishe-Mohammad (JeM) as it takes action against elements involved in terror financing and money laundering as part of efforts towards fulfilling requirements of the Financial Action Task Force's (FATF) 27-point action plan.

As per the the Interior Ministry. 907 of the frozen assets belonged to

the JuD and 57 to the JeM. Minister of State for Parliamentary Affairs Ali Muhammad Khan said that the provincial home departments had taken the action to freeze assets of the JuD and the JeM under the United Nations Security Council (Freezing and Seizure) Order 2019, issued by the Foreign Affairs



"A total of 611 properties of the JuD were frozen in Punjab, 108 in Khyber Pakhtunkhwa, 80 in Sindh, 61 in Azad Jammu and Kashmir (Pakistan-occupied Kashmir), 30 in Balochistan and 17 in the Islamabad Capital Territory," he told the Senate, the upper house of the Pakistani legislature, about the government's progress against proscribed outfits.

"Eight properties of the JeM were frozen in Punjab, 29 in Khyber Pakhtunkhwa, 12 in Azad Jammu and Kashmir, four in the Islamabad Capital Territory, three in Sindh and one in Balochistan," he added.

Giving details, Khan said: "The frozen properties of the JuD include 75 schools, four colleges, 330 mosques and seminaries, 186 dispensaries, 15 hospitals, 62 ambulances, a funeral bus (hearse), three disaster management offices, 10 boats, 17 buildings, a plot, agricultural land and two mo-

The frozen assets of JeM, Khan said, include "53 mosques and seminaries, two dispensaries and two ambulances"

The steps come at a time when Pakistan is working hard to comply with all the 27 points of the Action Plan given by FATF to see itself out of the 'grey list'.

Sally leaves massive floods on US Gulf Coast

Pensacola, Fla. Sep 17: Hurricane where it was expected to bring more than a foot of rain to some areas, one day after it flooded streets and knocked out power to hundreds of thousands of homes and businesses on the US Gulf Coast.

Sally made landfall early Wednesday near Gulf Shores, Alabama, with winds clocked at 105 mph (169 kph), making it a Category 2 storm on the five-step Saffir-Simpson scale of intensity.

As of late Wednesday, it was moving north at 12 mph (19 km per hour) after being downgraded to a tropical depression, the U.S. National Hurricane Center said, with maximum winds of 30 mph (50 kmh). The storm is believed to have killed one person in Alabama.

Some parts of the coast were inundated with more than two feet (60 cm) of rain, as the slow-moving storm flooded communities.

'Wearing eyeglasses may offer some protection from Covid'

Beijing, Sept 17: Daily wearers of eyeglasses might be less likely to be infected with the novel coronavirus, say scientists who call for further, large-scale studies to assess the relationship between eye protection and the risk of contracting COVID-19. The single-centre study, pub-

lished in the journal JAMA phthalmology, assessed 276 hospitalised COVID-19 patients at Suizhou Zengdu Hospital in

that those who wore eyeglasses for an extended period of time were relatively uncommon among the study participants.

Based on this observation, the researchers, including those from The Second Affiliated Hospital of Nanchang University in China, speculated that wearing eyelasses for more than eight hours per day may be protective against the novel coronavirus infection.

They hypothesised that this may be due to eyeglasses acting as a barrier that reduces the frequency with which people touch their eyes. "All those who wore glasses

for more than eight hours a day had myopia

and included 16 of 276 patients. The proportion of peowith myopia in Hubei

province, based on a previous study, was 31.5 per cent," the study noted. According to the researchers, the proportion of people with short-sightedness, or myopia, was much higher in the general population than among those with COVID-19.

nCoV plunges additional 150mn kids into poverty: UNICEF

United Nations, Sept 17: An additional 150 million children globally have been plunged into poverty since the COVID-19 pandemic hit earlier this year, taking the number of children living in multi-dimensional poverty across the world to approximately 1.2 billion, according to a new UNICEF analysis.

The new analysis, which was done by the UNICEF and child rights organisation Save the Children and published Thursday, reveals that the number of children living in multi-dimensional poverty - without access to education, health, housing, nutrition, sanitation, or water - has increased by 15 per cent

plunged into poverty since the pandemic hit earlier this year, it said. "The number of children liv-

ing in multi-dimensional poverty has soared to approximately 1.2 billion due to the COVID-19 pandemic," the analysis said. UNICEF, in a release, said that the multi-dimensional poverty analysis uses data on access to education, healthcare, housing, nutrition, sanitation and water from more than 70 countries.

It highlights that around 45 per cent of children were severely deprived of at least one of these critical needs in the countries analysed before the pandemic. The analysis paints a dire picture already and UNICEF warns the situation will

Director Henrietta Fore said. "Families on the cusp of escaping poverty have been pulled back in, while others are experiencing levels of deprivation they have never seen before. Most concerningly, we are closer to the beginning of this crisis than its end," Fore said.

The report notes that child poverty is much more than a monetary value. Although measures of monetary poverty such as household income are important, they provide only a partial view of the plight of children living in poverty.

UNICEF said social protection, inclusive fiscal policies, investments in social services, and employment and labour market interventions to support families are critical to lifting children out ofpoverty and preventing further

"It will also provide wheel pottery training for traditional pottery artisans and Press Pottery training for pottery as well as non-pottery artisans in Self Help Groups," it added.

HMT shares zoom over 123 per cent

New Delhi: Shares of **Happiest Minds Technologies** Ltd had a steller debut at the bourses on Thursday and closed over 123 per cent higher against its issue price of ₹166 per share. The stock of the IT services firm, which got listed at ₹351 apiece, reflected a gain of 111.44 per cent from the issue price on the BSE, rose to a high of ₹395, a jump of 137.95 per cent during the day.

RBI buys ₹10k-cr bonds from secondary markets

New Delhi, Sept 17: The Reserve Bank of India (RBI) on Thursday announced an outright purchase of ₹10,000 crore of bonds from the secondary markets, to be conducted on September 24.

So far, the central bank had been planning to simultaneously buy and sell bonds in equal amounts, with an intention to keep the operation liquidity neutral. However, this is the first time in this fiscal that the central bank announced an outright open market operations (OMO) purchase. In OMOs, RBI buys or sells bonds from the secondary markets.

The RBI had carried out an outright OMO purchase operation of ₹15,000 crore on March 26. After that, all the OMOs were simultaneous buy and sell operations, in which the central bank bought long term securities and sold short-term securities, also called 'Operation Twist' in market parlance.

In the latest round of outright OMO purchase, the RBI would be buying bonds maturing between 2026 and 2031. The central bank said it was doing so in view of the "current liquidity and financial conditions.

banking system has indeed come down from their recent highs of ₹7 trillion to ₹4.67 trillion as on Wednesday, but it is still at a huge surplus. However, investors now expect the banking system to be flush with liquidity, and as such a substantial reduction in surplus liquidity causes flutters and puts pressure on the bond yields. RBI may have wanted to arrest that before vields climb up.

"We still have a long way to go insofar as the borrowing programme is concerned," said R K Gurumurthy, head of treasury at Lakshmi Vilas Bank.

The government's annual borrowing target is ₹12 trillion, of which more than half has been borrowed at near 6 per cent yields,

which is a decade low cost of borrowing for the government, RBI governor Shaktikanta Das said on Wednesday. The 10-year bond yield closed at 6.03 per cent on

Thursday. However, the outright OMO announcement has important ramifications for the future. The bond market has been demanding an OMO calendar, and expects the central bank to chip in with at least ₹2-3 trillion of OMO support to accommodate the heavy borrowing programme. This is also a kind of indirect monetisation, and the central bank has tried to avoid that. However, the OMO announcement removes any such doubt that it is the beginning of many such oper-

6.6 MILLION PRO JOBS LOST: CMIE

New Delhi, Sept 17: An estimated 6.6 million white collar professional jobs, including engineers, physicians, teachers, were lost between May and August, bringing their employment to the lowest level since 2016 and wiping out the gains made over the last four years while five million industrial workers were out of work during the period, the Centre for Monitoring Indian Economy said

According to CMIE weekly analysis based on the data from the 20th wave of CMIE's Consumer Pyramids Household Survey released every four month, the biggest loss of jobs among salaried employees was of white-collar professional employees and other employees.

These include software engineers, physicians, teachers, accountants, analysts and the type, who are professionally qualified and are employed in some private or government organisation. This, however, does not include qualified self-employed professional entrepreneurs'

"From a peak of 18.8 million white collar workers employed in the country during May-August 2019, their employment fell down to 12.2 million in the May-August 2020. This is the lowest employment of these professionals since 2016,'

Petrol demand returns to pre-COVID-19 levels

New Delhi, Sept 17: India's petrol sales rose for the first time in the first half of September since the country's lockdown in late March, signalling demand may have returned to pre-COVID-19 levels.

Petrol sales between September 1 and 15 rose 2.2 per cent year-onyear and were up 7 per cent over the previous month, according to preliminary industry data.

Diesel sales continue to be in negative territory, with demand falling 6 per cent year-on-year. But the demand was 19.3 per cent higher over August 2020. This is the first time that petrol sales in the world's third-largest oil importer have risen since the March 25 nationwide lockdown crippled economic activity and sent demand plummeting.

Petrol sales rose to 9,65,000 tonnes during the first half of September as compared to 9,45,000 tonnes in the same period a year back and 9,00,000 tonnes during Diesel sales continue to be in negative territory, with demand falling 6 per cent vear-on-vear

August 1-15, 2020. Demand for diesel, the most consumed fuel in the country, fell to 2.13 million tonnes from 2.25 million tonnes in September 1-15, 2019. Sales were 1.78 million tonnes during the first half of August this year. Industry sources said while the Indian economy has started to pick up with lockdown restrictions being lifted since June, local lockdowns by states have hampered the demand quickly picking up.

Petrol sales have picked up as commuters are increasingly preferring to personal transport to public transport.

The September rise in petrol is a turnaround from the sharp drop witnessed in August.

109.75L free refills in state

Bhubaneswar, Sept 17: In order to alleviate the socio-economic fallout from the COVID-19 pandemic, the Government of India announced free refills facility for all the Pradhan Mantri Ujjwala Yojana consumers across India.

As per the report, the Oil Marketing Companies (OMCs) have delivered 109.75 lakhs refills to Odisha PMUY beneficiaries under Pradhan Mantri Garib Kalyan Yojana. 

The Institute for Management Development (IMD), in collaboration with Singapore University for Technology and Design (SUTD), has released the 2020 Smart City Index, with key findings on how technology is playing a role in the

In the 2020 Smart City Index, Hyderabad was placed at the 85th position (down from 67 in 2019), New Delhi at 86th rank (down from 68 in 2019), Mumbai was at 93rd place (in 2019 it was at 78) and . Bengaluru at 95th (79 in 2019).

Cities in India (New Delhi, Mumbai, Hyderabad, Bengaluru) suffer significant drops this year. This can be attributed to the detrimental effect that the pandemic has had where the technological advancement was not up to date, the report said.



Abu Dhabi, Sept 17: Mumbai Indians captain Rohit Sharma Thursday conceded that 'incomparable' Sri Lankan pace legend Lasith Malinga, who has opted out of this year's IPL, will be severely missed by his defending champion team given his 'unbelievable' past performances.

The 37-year-old Malinga, who is IPL's highest wicket-taker with 170 scalps to his credit, has pulled out citing personal reasons in a major blow to the four-time champions. MI will take on the Chennai Super Kings in this season's lung-opener September 19

"I don't think it is easy to come and fill his boots. He has been a match-winner for Mumbai. I have said it many times, whenever we sort of find ourselves in trouble, Malinga was the one to bail us out from that," Rohit said in a pre-season online press con-

"His experience will be missed, what he did with MI is unbelievable and it is unfortunate that he is not a part of the team this year.

'We have got likes of (James) Pattinson, Dhawal Kulkarni, Mohsin (Khan) and these are the names that we are looking to replace Malinga with. But obviously what Malinga did for Mumbai, it is not just comparable," he added.

Talking about his own role, Rohit said he will continue to open. "I opened the entire tournament last year and I will continue to do that. Again I keep all the options open, whatever the team wants, happy to do that.

'Even when I play for India, message from my side to the management has always been the same 'do not close any doors' keep all the options open and I will do the same here as well,"

India's white-ball vice-captain also felt that correct reading of conditions would be crucial to his team's fortunes. "The challenge for us will be to adapt to these conditions here which probably none of us are used to, because not a lot of cricketers from our group have played here," Rohit

"I think mentally it is about going out there and understanding what the pitch is doing, and based on that, you need to plan your game - whether it is your batting or bowling. So we have had a good chat around the group about that," he elabo-

According to Rohit, the team's past performances in the UAE in 2014, when it made the play-offs but not the final, won't matter now.

"...eventually the pitches here are going to play a big part and to understand that and adapt quickly and play to your potential, play according to what is being asked of is very crucial here. The past performance would not play a part this time around," he stressed.

Rohit recalled playing the Asia Cup in the UAE and how the pitches were behaving differently at the beginning and at the end of the tournament. He expects something similar this time around too.

"...the first game that we played and the finals that we played, there was a lot of difference in how the pitch was behaving. So we certainly expect the same, as it is going to be a long tournament. The slowness of the pitch will be a big factor," he said

Rohit also said that not only the spinners but the seamers will also get a lot of assistance in terms of reverse swing.

...there will be some reverse swing and we have got some good quality in our line-up as well, who can explore that. We have got balance and variety in our bowling attack, so we can use it depending on the conditions and team composition," he said.

KANGAROOS WIN ENGLAND ODIS 2-1

Maxwell, Carey tons lift Oz in title decider

Manchester, Sept 17: Glenn Maxwell (108, 90b, 4x4, 7x6) and Alex Carey (106, 114b, 7x4, 2x6) struck centuries in a 212-run stand to help Australia reach a record target of 303 at Old Trafford with two balls remaining and secure a 2-1 ODI series win over England.

Mitchell Starc (3/74) started the third and deciding ODI Wednesday by taking wickets from the first two balls of the match, and ended it by sweeping a four for the winning runs under lights as the Australians consigned England to their first loss in a bilateral ODI series at home since 2015.

It was a record ODI chase at the Manchester venue — bettering England's 286/4 against New Zealand in 1986 in a 60-over match – and gave Australia a famous series win over the World Champions to take back Down Under from their white-ball tour that also included a 1-2 loss in a T20I series.

Replying to 302/7, Australia slumped to 73/5 only for Carey and Maxwell to produce Australia's highest sixth-wicket partnership in ODIs and turn the tide. While Carev was the steadier of the pair, Maxwell delivered some trademark big hits all over the short boundary on one side of the ground.

Maxwell eventually fell with 15 balls left and Australia needed 14 off the last two overs. Carev couldn't see the tourists home, either, departing for 106 to a fabulous diving catch by Mark Wood off the seventh-to-last ball.

Starc entered, with Australia needing 10 off the last over bowled by leg-spinner Adil Rashid, and smashed his first ball down the ground for six. After two singles, Starc swept Rashid round the corner and the ball sped to the boundary rope, sealing a three-wicket win and sparking cheers from his teammates on the balcony.

Indeed, England, who won the toss, did well to reach 300 after recovering from losing the wickets of Jason Roy and Joe Root from the opening two balls of the match bowled by Starc. Jonny Bairstow (112, 126b, 12x4, 2x6) was England's star, scoring his 10th ODI hundred with a nonchalant flicked six off Pat Cummins bringing up three fig-

Chris Woakes (53 n o, 39b, 6x4) provided the hosts a late flourish to make Australia's task even harder. Sam billings (57, 58b, 4x4, 2x6) too contributed well to the team's cause.

England will regret a no-ball by Jofra Archer (1/60) — his first in ODI cricket - off which he had Carey caught at third man when on nine. Wicketkeeper Jos Buttler also dropped a tough chance off a nick by Maxwell when 44.

It was England's only series loss of their international summer during which all of their games have been played in a bio-secure bubble without fans — after taking on the West Indies, Ireland, Pakistan and Australia in various formats.
