### 9 Al Qaeda 'operatives' held from Kerala & WB

Of the nine, three are from Kerala and six from West Bengal

New Delhi, Sept 19: Al Qaeda terrorists, who were nabbed early Saturday by NIA teams from Kerala and West Bengal, had plans to travel to Jammu and Kashmir for weapons delivery. They were to deliver with home-made explosives for their other associates even as they continued to take orders from their Pakistan-based handlers, NIA officials said Saturday.

The revelations came as the NIA busted the inter-state terror module after it carried out searches at multiple locations in Murshidabad and Ernakulum. The National Investigation Agency (NIA) arrested nine Al Qaeda terrorists three from Kerala and six from West Bengal.

The Qaeda men have been identified as Murshid Hassan, Yakoob Bishwas and Morshraf Hussien, all three residents of Ernakulam.

They were picked up from Kochi. While Najmus Sakib, Abu Sufiyan, Mainul Mondal, Leu Yean Ahmed, Al Mamun Kamal and Atitur Rehman, were all residents of Murshidabad. These men were from diverse walks of life from second year graduate student to farmer, tailor, cook, electrician, computer science graduate.

Those arrested from Kerala were also originally from West Bengal. A man, who was staying in the same building as Hassan, said the men came to stay on rent during the pandemic-induced lockdown. P9

## FARM BILLS IN RS TODAY

THE BJP HAS A SLIM LEAD OVER OPPOSITION IN NUMBERS GAME WITH OLD ALLIES LIKE AKALI DAL TURNING AGAINST IT

New Delhi, Sept 19: The Rajya Sabha is looking all set for a potentially explosive Sunday-showdown over the Farm bills. With the ruling BJP and the Opposition trying to engineer enough support to either pass or defeat the three pieces of legislation, the Saffron may find itself in a fix.

All the three sailed through the Lok Sabha earlier this week but could face a stronger challenge in the Upper House, where the BJP does not have a majority on its own and will need help from allies - within and outside the NDA. There have been wide spread protests over the 'anti-farmer' bills, particularly in Punjab and Haryana, despite PM Modi's assurances that farmers can still avail a Minimum Sale Price (MSP).

Now, let's break down the numbers and try to understand the odds. House is 243 with a majority mark of 122. In what is already a very tight race, the BJP-led National Democratic Alliance (NDA) is expected to have around 105 votes, while the Opposition should have around 100.

Ten MPs have tested positive for Covid-19 and have been isolated at home. A further 15 MPs, including the Congress' P Chidambaram, who Saturday morning hit out at PM Modi over the farm bills, have expressed their inability to attend. Both these developments should help the Saffron party since it brings down the majority mark.

The BJP, on its own, has 86 members, and, with its NDA allies, it can count on 105 votes. It cannot, however, count on three Akali MPs, who have been given a three-line whip to vote against all the Farm bills. Despite this, the BJP remains confident of mustering the required numbers to see all three bills pass.

#### **■ Diesel cheaper by 22paise in Capital**



Bhubaneswar: For the second day in a row, diesel prices dropped by 22paise in the Capital city, Saturday, while petrol price remained the same. With the price drop. diesel costs ₹78.19 per litre and while petrol stands at ₹81.74 per litre. In the last three days. diesel has seen a reduction of around 81 paisa. In July, petrol demand was down by 34 per cent in Rhuhaneswar and it is lower by 13.66 per cent in August, showing some positive response in fuel sales.

New Delhi, Sept 19: Days after the government informed Parliament that it has no data on the death of migrant labourers, Railway Minister Piyush Goyal told the Rajya Sabha that 97 persons died while travelling on Shramik Special trains between May 1 and September 9.

The Minister said that the national transporter had not collected any fare from the migrants. "Shramik Specials were booked by the state governments or their representatives on payment of fare. Revenue of ₹433 crore was collected from them for running the Shramik Special trains till August 31. As many as 63.19 lakh shramiks/stranded passengers travelled in these trains," Goval said Saturday.

He was responding to a question by Trinamool Congress leader Derek O'Brien in the Rajya Sabha Friday regarding details



of total deaths on board the Shramik trains since they started operating.

Goval said: "Based on the data provided by state police, 97 persons have been reported dead till September 9 while travelling on Shramik Special trains during the Covid-19 crisis." He said that police register FIRs under Section 174 of the CrPC in cases of unnatural deaths and follows the legal process.

#### NO RECORD OF MSMES SHUT DOWN AMID THE PANDEMIC

The Centre Saturday said that it has no record of MSMEs that have faced closure in the wake of the pandemic.

Interestingly, in a written reply to a question in the Rajya Sabha, Minister of State for Micro, Small and Medium Enterprises (MSME) Pratap Chandra Sarangi also said that there is no data on the number of MSMEs closed down from FY 2014-15 to FY 2019-20.

#### MONSOON SESSION MAY BE CUT SHORT

## How Ginsburg's death may reshape US Prez polls

THE SENIOR LIBERAL JUSTICE'S DEATH GIVES TRUMP, WHO IS SEEKING RE-ELECTION NOVEMBER 3, A CHANCE TO EXPAND THE COURT'S CONSERVATIVE MAJORITY TO 6-3 AT A TIME OF A GAPING POLITICAL DIVIDE IN AMERICA

Washington, Sept 19: A fierce political battle was shaping up Saturday over the selection of a successor to trailblazing liberal US Supreme Court Justice Ruth Bader Ginsburg, with top Democrats opposing any move by President Donald Trump to nominate her replacement before the November 3 presidential election.

Ginsburg, the senior liberal justice, died Friday night at age 87 of complications from metastatic pancreatic cancer after 27 years on the court. Her death gives Trump, who is seeking re-election November 3,



a chance to expand the court's conservative majority to 6-3 at a time of a gaping political divide in

Even as large crowds of mourners gathered outside the Supreme Court building well into the night to pay tribute to the iconic liberal jurist, battle lines were forming.



Supreme Court appointments require Senate confirmation, and Trump's fellow Republicans control the chamber, holding 53 seats


of the 100 seats. Democrats lack the votes to block any Trump nominee unless some Republican senators join them.

With the assistance of Senate Majority Leader Mitch McConnell, who has made confirmation of Trump's federal judicial nominees a top priority, the President potentially could announce a nominee and move rapidly through the confirmation process, which usually takes at least two months.

Even before Ginsburg's death, Trump had made public a list of potential nominees.

Trump's Democratic opponent in the Presidential race, Joe Biden, Friday night said the winner of the election should be the one to make the selection and that Trump should not move forward with a nominee. Chuck Schumer, the Senate's top Democrat, agreed.

McConnell pledged that the Senate would vote on any Trump nominee. If he wins, Biden would be sworn in to replace Trump January 20. Trump focused his initial remarks on praising Ginsburg, who he previously had derided, without specifying his next steps. For liberals who considered her a heroine, the grief they have expressed overher death was tinged with fear over what happens next. **MORE P10**



tails like bank account number, PAN card, email Id and phone number in the website. The fraudsters then contacted Sahoo over phone and asked him to deposit various amounts in different bank accounts under different heads like registration fee, GST, late fee, agreement fee and bank setup fee. In order to win Sahoo's trust, the crooks also sent fake registration and agreement applications to his mail address.

Accordingly, Sahoo deposited a whopping ₹10.50 lakh in the accounts of the accused persons. The miscreants dialed Sahoo on different phone numbers registered outside Odisha. The bank accounts in which Sahoo deposited the money were found to be opened in the name of different persons in four states outside Odisha.

Bhubaneswar, Sept 19: Good news for COVID-19 patients who are struggling with breathing problems. A group of IIIT, Bhubaneswar students has developed a helmet-like ventilation device that will make a difference in treating patients with breath-

ing problems. According to the studentsturned-developers, the device has been named as 'Swasner'. It functions on the principle of hyperbaric oxygen therapy. Wearing this device, a patient can inhale pure oxygen. Apart from COVID-19 patients, those who are suffering from respiratory diseases can also get benefits from this device. They further stated that they have used medicated plastic collected from Central Institute of Petrochemicals Engineering and Technology (CIPET) in developing 'Swasner'.

There is a bubble-like enclosure fitted to the base. Oxygen is pumped into the chamber of the enclosure. In hospitals, the device can be mounted on walls. 'Swasner' could be an affordable alternative to  $\rightleftharpoons$ costly ventilators. The developers include Shovit Mitra, Sidharth Shankar Nayak, Ananya Aprameya, Tapaswin Padhi, Sai Sambit Nayak, Divyajyoti Dash, Vitthal Gupta of IIIT. ## WSHGs procure ₹1,010Cr paddy

Bhubaneswar, Sept 19: Women selfhelp groups (WSHGs) have procured paddy worth ₹1010.14 crore during financial year 2019-20.

As many as 199 women SHGs in  $11\,\mathrm{districts}$  have procured  $23.07\,\mathrm{lakh}$ quintals of paddy amounting to ₹419 crore during Kharif 2019-20. They have earned commission worth ₹7.2 crore, official sources said.

Similarly, 113 WSHGs were engaged in paddy procurement in 112



gram panchayats of eight districts during Rabi 2019-20. They have procured 17.58 lakh quintal paddy amounting to ₹319 crore generating commission of ₹5.49 crore. So, cumulatively the WSHGs earned ₹12.69-

crore commission during the Kharif and Rabi seasons.

Currently, 223 WSHGs are undertaking online registration of farmers for paddy procurement for Kharif 2020-21. So far, 312 such groups from 11 districts have been involved in the procurement process. They procured 43.12 lakh quintals of paddy amounting to ₹781.26 crore and got ₹13.46 crore as their commission, the source said.

In May last year, the State Cabinet had decided to tie up women WSHGs

with different departments for provisioning of government services and procurement in a structured manner amounting to ₹5,000 crore over a period of five years. In pilot phase, 17 WSHGs of

Kalahandi district have been engaged in the practice during 2018-19 Rabi season and earned ₹77.25 lakh commission.

After that the Women and Child Development department is planning to engage more number of women in the business.

## **Post-isolation symptoms normal: Docs**

Bhubaneswar, Sept 19: Doctors authorised by Odisha government to talk about home isolation for COVID-19 cases Saturday said that many patients continue to see some symptoms post isolation period.

Jayant Kumar Panda, Head of the Medicine department of SCB Medical College and Hospital in Cuttack, said that even after 17 days of home isolation and quarantine for COVID positive patients, some symptoms are prevalent and consultation with the doctors is needed before medications.

"It's normal. During the post COVID days, there could be some nasal congestion and breathing issues in some patients. If patients who have opted for home isolation see such symptoms they need to continue some medications and consult their doctor for better treatment if such symptoms persist even after 17 days," he said.

He also added, "Under home isolation, the patients need to use the drugs given by the government in the kit. They also need to measure their body temperature everyday and keep watch on any other symptoms. In case the health condition deteriorates they can contact the government and can get admitted to COVID hospitals.

Panda said that under home isolation, the state government is providing Azithromycin (antibiotic),

Paracetamol (anti-pyretic), Vitamin D and Vitamin C tablets and Levo-Cetrizine tablets. "In addition to this the patients with other disease/diseases should continue their medicines as usual. The kit also comprises the norms and suggestions on best ways to manage home isolation," he said.

He also asked the caregiver/attendant to ensure isolation from the positive patients. "The caregiver/attendant needs to take special measures to prevent infection from the person who is under home isolation. They should not stay in the room where the patient is staying and not use their used products. They should use masks when

### **HOME ISOLATION CASES** RISE EXPONENTIALLY: BMC

Corporation (BMC) Saturday said that home isolation rate has increased from 42 per cent to 73.50 per cent in the City. During the last five days ending September 18, home isolation rate for positives stood at 95.44 per cent. Moreover, 79 doctors have been deployed with Rapid Response Teams (RRTs) and four medical officers each at the three administrative zones respectively that are engaged in physical verification of the facilities for home Isolation. While the South West Zone has 26 doctors, the North and the South East Zones have 30 and 23 doctors respectively. "Moreover, we have 54 RRTs with 18 in each zone to monitor home isolation cases. The RRT that were only 13 for the entire city has been increased to shift more and more cases to home isolation. COVID Care Hospitals (CCHs) and COVID Care Centres (CCCs) are reserved for co-morbid, critical and symptomatic patients," stated BMC Commissioner, Prem Chandra Chaudhary. He mentioned that the hospital situation in the city is 'comfortable'. "Asymptomatic patients are being shifted home on a rotation basis. A total of 445 ICUs and 2,500 general beds are available in private hospitals. Squads have been formed to monitor treatment of COVID-19 patients in these hospitals," he added.

#### Twin city police on toes to enforce norms

Bhubaneswar/Cuttack, Sept 19: Amid rising cases of COVID-19 in Bhubaneswar and Cuttack, the Commissionerate Police (CP) has intensified enforcement of COVID-19 norms

The Commissionerate Police prosecuted 7,882 persons and sealed 44 shops in the twin cities during the last 24 hours. "The efforts will be sustained and our request to everyone is to be both aware as well as to cooperate," Commissionerate Police said on Twitter. "During special enforcement drives for implementation of #COVID-19 guidelines at Cuttack, we have booked today 1,186 persons for gross violation of #SocialDistancing and 269 for not #FaceMasking in our fight to contain #COVID19. We urge people to follow COVID-19 guidelines and #staysafe," the Twitter handle of DCP Cuttack said.

The move by Commissionerate Police came after Chief Minister Naveen Patnaik expressed his dissatisfaction over the enforcement of COVID-19 guidelines within the Commissionerate limits. Notably, Odisha Police had provided 50 more officers and five platoons more armed Police to twin city to enhance enforcement. The step was taken as COVID-19 cases continue to surge in the twin cities and especially in Bhubaneswar with Cuttack being a distant second. Bhubaneswar has been divided into three zones and each of the zones will have a DCP level officer.

## State reports 4,209 fresh COVID-19 cases, 9 deaths

Bhubaneswar, Sept 19: Odisha's COVID-19 tally rose to 1, 75, 550 Saturday as 4,209 more people tested positive for the infection, while nine fresh fatalities pushed the state's coronavirus death toll to 691, a Health and Family Welfare department official said.

As many as 2,441 new cases were reported in quarantine centres, while 1,768 infections were detected during contact tracing, he said. Khurda district, under which

Bhubaneswar falls, reported the highest number of new cases at 663, followed by Cuttack (491) and Puri (326), the official said. The state had reported its high-

est single-day spike of 4,270 cases on September 16, he said.

Two fresh fatalities were reported in Bargarh district, and one each in Bhadrak, Bolangir, Cuttack, Gajapati, Puri, Rayagada and Sambalpur districts, the official said. Fifty-three COVID-19 patients have died due to other ailments so far. he said. The state has so far tested over 27.15 samples for COVID-19, including 48,075 Friday, he added. As many as 342 new COVID-19

cases were detected under Bhubaneswar Municipal Corporation (BMC) limits in last 24 hours. While 104 of them are quarantine cases, remaining 238 are local contact ones. Meanwhile, 421 persons who had earlier tested positive for the disease have recovered, said BMC sources.

According to a notification issued by the civic body, as of Saturday, 18,267 persons have tested positive for COVID-19 in Bhubaneswar out of which 14,052 have recovered. While there are 4.133 active cases.

68 persons succumbed to the disease. Odisha health department Saturday said that 4.090 persons who earlier tested positive for COVID-19 have recovered and are being discharged.

Out of 4,090 persons, 605 are from Khurda, 412 from Puri, 371 from Cuttack, 169 from Bargarh, 160 from Nabarangpur, 155 from Sundargarh, 145 from Kendrapara, 145 from Rayagada, 139 from Jajpur, 123 from Bolangir, 121 from Jagatsinghpur, 120 from Koraput, 115 from Mayurbhanj, 110 from Sonepur and 104 from Bhadrak, 99 from Sambalpur, 93 from Jharsuguda, 92 from Keonjhar, 91 from Balasore, 83 from Nayagarh, 78 from Nuapada, 66 from Angul, 56 from Ganiam. 50 from Dhenkanal, 44 from Kalahandi. 44 from Malkangiri, 38 from

## Lokayukta orders stern action against techies, PEO, sarpanch

Jajpur, Sept 19: In a significant step against corruption, the Lokayukta has ordered action against four people including two engineers, an official and a sarpanch in Jajpur.

Reports said, in 2019, the Lokayukta had got complaints about irregularities in a borewell project in Sinduaria panchayat under Dharmashala block of the district.

The directive of the Lokavukta came September 15 based on investigation reports submitted by the district administration and the pachayatiraj, drinking water and sanitation departments in this regard.

The Lokayukta in his order has ordered stern action against these people within five months.

Reports said, a bore well was dug at Sinduria village at a cost of Rs 2 lakh. It was alleged that the depth of the bore well was not up to its prescribed length while a major part of the fund was bungled.

Samiti member Rilu Behura took up the issue with the Lokayukta, which recorded the case (421/2019)

## Powerful state, powerless individual

t is not seen in that way, especially in our part of the world, but the criminal justice system is deliberately designed to protect the rights of the accused. And this is the correct way of seeing it. Why? Because in a criminal case there are two parties. The accused individual versus the state. The state controls the laws under which the system operates. It appoints, pays the salaries of and manages the police forces that arrest and investigate. The state appoints and pays the prosecutors who will represent it against the individual. The state pays and promotes the judges who determine in-

All the powers are with the state. There is no power with the individual. Most accused in India have no money even to get proper representation and therefore defence against the state. That is why we have the principle of innocent until proven guilty because the understanding is that the state has overwhelming and terrible power in a criminal case and there is a mismatch. Even though justice is represented as a blind woman with balanced scales, the scales are not balanced and the state can load as much weight as it wants to on one side. We have seen evidence of the state's mischief in the way that the Delhi riots are being prosecuted. The majoritarian ideology of a political party is finding expression in the crim-

inal justice system because it is in control of a state with overwhelming power.

In India after independence, the state has not been satisfied with the amount of power it has and has needed more. This is not a problem because there is nobody stopping the state from giving more power to itself except the voters. And voters in India have little interest in the criminal justice system. Most middle class in dividuals do not think it concerns them. The state can give itself whatever power it wants And what it wants is a reversal of innocent until proven guilty and make it guilty until proven innocent. And in India the state has been giv ing itself this power to reverse the fundamental principle of the criminal justice system.

Laws that Indians protested against when they were being written by the British in a colonial state can be written up and implemented today by a democratic state though their effect on the individual is the same. The Rowlatt Act for which the Jallianwala Bagh protesters had gathered allowed preventive detention. This is a power under which the state can arrest individuals without a crime, on the assumption that they may commit a crime in future. This is guilty until proven innocent. Today India has many laws that are similar that have been written by our democratic state which allow preventive detention. Every state has more than

one such law and the Centre has them as well. This is why the protesters including women in the Delhi riots can get bail but still remain in jail because there are many options for the state to keep them locked up without conviction. But most of us do not seem to mind this. Many laws that the government has written for itself, including UAPA, on money laundering and even on cow slaughter have a reversal of burden of proof. Meaning that until the individuals can prove their innocence to the satisfaction of the state they can be kept locked up and prosecuted. Such laws do not exist elsewhere in the

Even with more power against the individual than any other modern democratic nation, the Indian government seeks more. Uttar Pradesh has set up a police force that can arrest without a warrant and without the orders of a magistrate. This is a power that other states and even the Centre have. We have no civic or popular pushback against this sort of acquisition of power by the state. In the absence of this the state will continue to acquire more power against us. What we have in India today is autocracy and tyranny in practice under a democratic name. I do not make this accusation against any party because the government is controlled by different political parties at the level of the province. There is no difference between one part of India and another in this matter. It is also true that under a government at the Centre which wants to enthusiastically expand its power the real danger of this is

We may not like the individuals who are being tried by the criminal justice system today because we have made up our minds that they are bad people, even though we have never actually met them. But this dislike is not the reason why we should approve the state being given overwhelming power against the individual because this principle is wrong in law and unjust on the face of it.

ike so many slang or dialect words of previous generations, this one is now very rarely encountered. It gained some publicity in 2011 through being listed by the publishers of Chambers Dictionary as a word with a pleasing sound. When it appeared in the language — in the middle of the seventeenth century - it was a sadly incompetent attempt to say intoxicated, perhaps under the influence of drink ("I'm not so tosticated as you think I am"). An influence may have been the even older tosspot, a person who habitually tossed back his pot of drink, hence a heavy drinker or drunkard. Rather later, the symptoms of that state became confused under the influence of the first syllable of the word perhaps — with those of being tossed about, and took on the idea of being perplexed or distracted. Variously spelled, as tossicated or in other forms, recorders of English dialect near the end of the nineteenth century found it to be widely distributed, from Cumberland and Yorkshire down to Somerset and Devon. But by then it had vanished from the printed word. Chambers is the only British dictionary that continues to include it (apart from the Oxford English Dictionary, which never deletes anything).

oundaries between academic disciplines are always artificial creations intended to facilitate analysis, given our limitations. But as the economist Albert Hirschman once argued, there are times when it is incumbent on us to trespass them. The ongoing battle against COVID-19 and its economic fallout is such a time.

The pandemic has cast a shadow over the global economy. So far, the two worst-performing economies in the second quarter of 2020 (April-June) were Peru and India, where GDP shrank by 30.2 per cent and 23.9 per cent, respectively, in year-on-year terms. These record declines were caused by the pandemic, but also by how we are dealing with it.

In Peru, for example, the crude mortality rate (CMR) - the number of COVID-19 deaths per million people – is 939. The plunge in its GDP is clearly related to this.

Several European countries with high CMRs, such as Spain (647) and the United Kingdom (613), also have reported some of the deepest economic slumps. But India's CMR is only 60, which, though one of the highest in Asia and Africa, makes its sharp second-quarter contraction (bigger than almost any country in the world) difficult to explain – especially given that the Indian economy was among the world's three or four fastest-growing until five years ago.

How can we understand such anomalies? To understand such matters, we need to recognise the interaction between medicine and human behaviour.

Consider the conventional wisdom that COVID-19 is more likely to be transmitted in closed spaces than in open areas. So, you are safer being close to someone in a park than in a restaurant.

We assume that this insight comes from medicine and physics, which tell us, respectively, that COVID-19 is highly infectious, and that aerosols carrying the SARS-

CoV-2 virus (which causes the disease) are likely to be blown away and miss your nostrils in outdoor parks. But that is not necessarily so, because aerosols are relatively heavy and tend to drop quickly in still air. Conversely, a breeze in an open space makes it likely that the aerosol will remain airborne for longer and thus pose a risk that does not exist indoors.

The claim that closed spaces are more dangerous may nonetheless be true - not because of what we know about the coronavirus and the aerodynamics of aerosols, but because of human behaviour.

Assume, for the sake of argument, that the probability of the virus being transmitted by an infected person nearby is 50 per cent in both a restaurant and a park. Assume further that half of the population is infected. So, if you are near a random person in a park or a restaurant, the probability that you will contract COVID-19 is 25 per cent.

Suppose, however, that a trusted authority announces that the risk of contracting COVID-19 is greater in a restaurant than in a park. If people believe this, it can turn out to be a self-fulfilling prophecy. Restaurants will be less attractive to risk-averse people (say, those who don't go to places where the infection risk is higher than 25 per cent). Thus, only more risk-tolerant people will go to restaurants.

It is reasonable to suppose that the restaurant patrons are therefore more likely to be infected, because they would have been taking more risk. Assume, for simplicity, that 75 per cent of risktolerant people are infected, while only 25 per cent of risk-averse people are. The probability that an infected person will transmit the virus is still 50 per cent, as before. Then, if people believe that restaurants are riskier (and only the risktolerant enter them), the probability of contracting the virus in a restaurant is 37.5 per cent, whereas the probability of contracting it in a park is less than 25 per cent.

These probabilities will be borne out by the epidemiological data, and most people will believe that the pattern has something to do with the nature of the virus, rather than being driven entirely by human behaviour. By this argument, if the authorities had announced that restaurants were safer than parks, then parks would in time have become the riskier place. Even if parks were safer than restaurants for reasons of epidemiology and the physics of aerosol movement, you could face a bigger risk in a park than in a restaurant if it were widely believed that parks were more risky

Recognising these kinds of connections creates scope for policy interventions that can contain the virus without crushing the economy. India's mistake was to impose a 'lockdown' – a misnomer be cause it forced tens of millions of migrant workers to spread out across the country, often on foot, after their jobs and wages in urban centres vanished overnight.

Once we pinpoint the links be tween medicine and economics, fascinating policy ideas begin to emerge, as the Georgia Institute of Technology's Joshua Weitz reported in a recent Stockholm School of Economics webinar.

Countries like India or Peru must design rules of behaviour that allow the economy to function, at least partly, while containing the virus. Here is an idea. As increased testing gives us a better sense of who has had COVID-19 and has SARS-CoV-2 antibodies, we can offer these people a very high wage to do COVID-19-risky jobsincluding in hospitals, and in business sectors involving face-to-face interaction. By using them as links between vulnerable people, we can keep supply chains intact while disrupting virus transmission chains.

Under normal circumstances the market would do this on its own: demand for people with antibodies would rise, and so would their wages. But markets do not function well during a pandemic, when many externalities are at work Governments therefore need to intervene with intelligent, welldesigned policies, which would enable us to keep the virus under control without bringing the economy to a halt.

gan of Achche Din! Even after six-long years of the Modi government, good days for the majority of Indians are still a distant dream. Whether economic recovery is going to be V-Shaped, Ushaped or K-shaped, or whether the disparity between the haves and the have-nots would further widen, only time would tell, depending upon the alacrity with which the government takes speedy action. Tall claims of making \$5 trillion economy by 2024-25 need a meaningful strategy.

With the economy contracting to minus 23.9 per cent in the first quarter of this fiscal, the scenario looks grim. Fitch Ratings has slashed India's FY21 growth projection to -10.5 per cent from -5 per cent estimated earlier, saying the continued spread of the virus and imposition of sporadic shutdowns have disrupted economic activity.

No matter if the Hindutva pitch becomes shriller, or the divisive politics is further unleashed, the Aam Aadmi, who is finding it difficult to fetch food for himself, will naturally get disenchanted with the Modi government.

Ironically, while the Congress is reinventing itself after its 135-yearold history, the BJP-led NDA should also learn basic lessons in economics, if it is keen to continue in office for a longer period.

The absence of any policy to

emember the BJP's 2014 slo- deal with the worst economic crisis is reminiscent of the policy paralysis of the UPA government. Similarly, while people still believe the Modi government's intensions cannot be faulted, they know for sure that there is paucity of talented persons at the top to handle the crisis.

Sadly for the NDA, the prevailing

talent in the bureaucracy, when it took over reins from the UPA, was spurned away. Whether it was Raghuram Rajan, Urjit Patel, Arvind Panagariya or Arvind Subramanian, all were shown the door by the government for not following its diktats. Sadly, Arun Jaitley, a man for all seasons, is no more there to guide Modi, while other stalwarts like Yashwant Sinha and Arun Shourie have been pushed to the margins by BJP's political managers

Finance Minister Nirmala Sitharaman had referred to Covid-19 as an 'Act of God' responsible for the economic slump, though former Finance Minister P Chidambaram argued that had it been an 'Act of God', agriculture, forestry and fisheries would not have grown at 3.4 per cent. Is it only India that is worst-affected by the pandemic? Countries like the US and China are far ahead in coping with the economic situation. Moreover, India's GDP growth, even at pre-Covid times was 4.2 per cent, its slowest pace for nearly a decade.

While Modi and Shah have taken

bold political steps in pursuing the Hindutva agenda, whether it is abrogation of Article 370, bringing the Triple Talaaq Bill or Citizenship (Amendment) Act, when it comes to rescuing the country from the economic slump, they have failed miserably. They need to be told that unless the country comes out of the financial mess, no amount of political decisions at the helm would bring solace to the common man. It's only when the stomach of an ordinary man is full that he is able to concentrate on other sundry issues.

With the government clueless on reviving the economy, the best it can do is to induct some lateral entrants. After the death of Sushma Swaraj, Modi was quick to induct former Foreign Secretary S Jaishankar in his Cabinet. In fact. after Rajan's ouster as RBI Governor, Jaitley had expressed the need for lateral entrants in the government, but his suggestion was not heeded.

It's not that the government has floundered only in the aftermath of the pandemic, but even earlier when it had gone in for demonetisation and brought in GST, the economy had reacted negatively. The failure to make GST compensation payments to states has only aggravated the situation, with Chief Ministers, especially from Congressruled states, fuming for not getting their dues. With the pandemic showing no

signs of slowing down, economic

activities are expected to drag at a

snail's pace. When it comes to redressing people's grievances, the government should not be rigid by not acting upon suggestions given by the Opposition. Congress leaders have been shouting from the rooftops, de-

manding increased public spending and transfer of funds directly into bank accounts of people. Even after release of Rs 20 lakh crore in five tranches, the economy has shown no signs of revival. The patient requiring oxygen does not need longterm life insurance policy but a ventilator to revive. Similarly, the economy needs an inflow of money to scale-up demand rather than long-term reforms in PSUs, education and health sectors.

Unless there is a clear strategy to deal with the situation, contraction even in the next quarter cannot be ruled out. The remedy is in meticulous fiscal planning, which Modi and Shah are incapable of formulating, unless they have the backing of skilled economists. After all, even for proving your macho personality, figures like a '56' inches chest are required. A nation's economy cannot be delinked from politics! The government should move fast, as elections in Bihar, West Bengal, Assam, Kerala, Tamil Nadu and Puducherry are in the offing.

#### Need for proactive fiscal policy

Sir, The imposition of the nationwide lockdown to check the spread of the coronavirus has badly affected the economy of India. For India, The International Monetary Fund (IMF) has calculated a 4.5 per cent contraction of the GDP for the 2020-21 financial year. It is obvious as most of the economic activities were halted. However, the recently published quarterly GDP data (year on year basis), which shows a 23.9 per cent contraction, lowest since 1969, for the April-June quarter by the NSSO is worrisome. Despite some measures taken by the government, such GDP contraction indicates a serious financial crisis that the country is going through. The Indian economy is primarily based on consumption. Around 60 per cent of the economy depends upon private consumption. Another 40 per cent is contributed by private investment, government expenditure, and net-export. During the lockdown, as the income of the people declined or stopped and uncertainty prevailed in the market, the consumption expenditure declined by 27 per cent. Therefore, the government should come forward and take necessary steps to increase demand in the economy. The government should inject liquidity in the economy by providing a direct cash benefit to the people so that demand will increase. And further, it will lead to increase in investment. Monetary measures are helpful for the supply-side but without demand, supply has no meaning in the economy

## **Kochi prepared to deal with terror threat: Cops**

Kochi, Sept 19: The city of Kochi, a strategically located South Indian port housing various vital installations including the Southern Naval Command, is prepared to deal with any form of terror threat, top security officials said here Saturday, hours after the NIA arrested nine al-Qaeda cadres during raids here and in West Bengal.

After NIA revealed that the arrested terrorists intended to launch terror attacks on vital installations in the country with an aim to kill innocent people, Defence sources said here that the Kochi-based Southern Naval Command (SNC) has been in heightened security for quite some time.

"The SNC will continue to take all precautions against all possible threats," a Defence source told PTI. Highly placed sources in the Kochi city police said the city police have been effectively carrying out its job to identify the terror elements, and monitoring the activi-



ties of the people visiting and camping in the city. "We are very well prepared to deal with any form of such terror threats," a senior officer said, reacting to the arrest of three West Bengal natives from Ernakulam district.

## 'KERALA HAS FAILED IN **COUNTER-TERRORISM'**

Thiruvananthapuram, Sept 19: Successive governments in Kerala have failed in anti-terror activities said State BJP president K Surendran Saturday.

"It's now come to light that there was a WhatsApp group in the police helping those engaged in terror activities. Also a police official who was suspended for leaking emails from the police and this government was reinstated. This can happen only in Kerala," said the BJP state president.

Surendran alleged that Kerala is

today facing a scenario in which the state cabinet also has a 'terror' presence in State Minister KT Jaleel, a former member of the banned outfit SIMI and he is now facing the heat and has already been questioned by two national agencies.

'If one looks into some of the appointments that Jaleel has made in his department, there are undesirable people who have crept in. We will continue our protests till Jaleel is ousted," added Surendran.

Meanwhile, the Congress also attacked the state government over the issue, alleging the state has become a hub of terrorists under CPI(M)-led LDF rule.

**KPCC** President Mullappally Ramachandran alleged the state police failed to trace the presence of al-Qaeda terrorists in the soil of Kerala.

"With the arrest of three al-Qaeda terrorists from the state, it is evident that that law and order machinery in the state has collapsed and the state has become a fertile soil for terror groups,' Ramachandran told reporters in Thiruvananthapuram.

### Can ignoring loyalists hurt BJP in Bihar polls?

## PM to lay foundation of 9 highway projects in Bihar

New Delhi, Sept 19: Prime Minister Narendra Modi will lay the foundation stone of nine highway projects in Bihar through video conference Monday and also inaugurate optical fibre internet services through which the state's all 45,945 villages will be connected, the PMO said Saturday.

These nine highway projects involve a road length of about 350 kilometres at a cost of Rs 14,258

Modi has recently inaugurated or laid the foundation of a number of development projects, including those related to railways, infrastructure, bridges, drinking water and sanitation, in the state which is set to go to the assembly polls in October-November.

The Prime Minister's Office said in a statement that the proposed highways will pave the way for the state's development as they will enhance better connectivity, convenience and economic growth in and around it. Movement of people and goods will also improve substantially, especially with the neighbouring states of Uttar Pradesh and

Jharkhand, it added. Modi had declared a special package for significant infrastructure development of Bihar in 2015. The package included 75 projects worth Rs 54,700 crore, of which 13 projects have been completed, and work is undergoing at 38 and others are in the process to be launched, the PMŌ said.

With the completion of these projects, all rivers in Bihar will have bridges conforming to 21st century specifications and all major national highways will stand widened and strengthened. Giving details of the optical fibre

internet services programme, the PMO described it as a prestigious project covering all 45,945 villages\_ of Bihar which will enable a 'digital revolution' to reach the state's remotest corner.

This project will be executed by the combined efforts of Department of Telecom, Ministry of Electronics & Information Technology and Common Service Centres (CSC)

The PMO said the CSC has 34,821 centres throughout the length and breadth of Bihar and it will utilise this workforce to not only implement this project but also make it professionally run to provide optical fibre internet services for common citizens at every village

The project would also entail implementation of one Wi-Fi and five free of cost connections to government institutions like primary schools and anganwadi centres

among others, it said. This will lead to digital services like e-education, e-agriculture, tele-medicine, tele-law and other social security schemes to be easily available to all citizens of Bihar at the click of the button, the PMO said.

## Rise in Covid cases makes Shailaja face reality



Havaldar Harvinder Singh (36), a resident of Punjab, was found dead at Rakh Muthi camp in the Jourian area on Friday, a police official said. He said preliminary investigations suggest the soldier took his own life with his service rifle. The body was handed over to his unit after completion of legal formalities.

#### **Cocaine worth ₹4cr seized**

New Delhi: The Narcotics Control Bureau (NCB) on Saturday said it has seized cocaine worth about ₹4 crore. arrested a person from Mumbai and is probing an illegal network of narcotics distribution in the western metropolis that has "possible linkages" with "high-profile' drug users. The federal agency seized a total of 670 gm of cocaine from a parcel that arrived in Delhi from Addis Ababa, Ethiopia early this month. ## INDIA'S HEALTHCARE CREAKS **UNDER MOUNTING CASE LOAD**

New Delhi, Sept 19: Coronavirus patients in India are dying because of a lack of beds in intensive care units and a shortage of oxygen cylinders as the healthcare system struggles to cope with a surge in cases. India's tally of confirmed cases passed 5.7 million this week, second only to the United States, after several weeks with an average of 92,000 new infections a day. More than four million patients have recovered, leaving the country with slightly more than 1 million active cases, while the death toll from Covid-19 has passed 84,000.

"The situation is critical," said Dr Devender Singh Rana, chairman of Sir Ganga Ram Hospital in the Indian capital New Delhi. "We are witnessing an unbelievable rise in the number of cases that we had not even seen in June when coronavirus was at its peak [in Delhi] ... there are no beds; we are all full." The healthcare infrastructure in the country of 1.3 billion was already less than ideal before the pandemic, with one doctor for 1,457 people instead of the World Health Organisation norm of 1,000, and one hospital bed for every 1,844 people, according to World Bank data. The government says it has provided 230,000 oxygen-supported isolation beds and 62,717 critical care beds with ventilators since India recorded its first case January 30. Doctors say this is not enough to deal with the pandemic's onslaught. New Delhi, a metropolis of 22 million people, has just 37 Covid-19 designated hospitals and 2,558 ICU beds to treat more than 30,000 active cases. In Mumbai, the financial capital, there was not a single ventilator

#### Covid tally crosses 53L

New Delhi: India's coronavirus cases Saturday crossed the 53lakh mark after the country detected a spike of 93,337 new cases in the past 24 hours. India's coronavirus tally, including the recovered cases, has now climbed to 53,08,015, according to the Union Health Ministry. A total of 1,247 coronavirus patients have succumbed to the infection in the past 24 hours, pushing the country's death toll due to Covid-19 to 85,619. The Covid-19 case fatality rate has further dropped at 1.61 per cent, the data showed. India's coronavirus caseload includes 10,13,964 active cases.

pitals in the first week of September. A record-breaking surge of one million cases in just 11 days has also triggered a sharp rise in the demand for oxygen cylinders. Nearly 6 per cent of Covid-19 cases experience moderate to severe symptoms and require oxygen support. The demand for oxygen has triggered

hoarding as well as theft of cylinders - a vehicle loaded with oxygen supplies for hospitals was robbed in the city of Pune last week. According to the All India Industrial Gases Manufacturers Association, hospitals and healthcare centres are using up to 2,700 tonnes of medical oxygen a day, compared to 750 tonnes a day at the beginning of the pandemic. Meanwhile, the country's medical personnel are struggling with the lack of equipment, long working hours, public anger and personal risk from exposure to the virus. At least 380 doctors have lost their lives in the last six months while treating coronavirus patients, according to the Indian Medical Association.

In some states, nurses and doctors at government-run hospitals are threatening to strike over non-payment of wages since March. Some doctors have faced discrimination and violence from the general public over fears that they might transmit the virus. The Epidemic Diseases (Amendment) Bill, 2020, was introduced by Health Minister Harsh Vardhan in the Upper House Saturday.

The Bill was supported by the members across party lines; however, some suggested adding in its purview hospital sanitary staff, ASHA (accredited social health activist) workers and 'Corona warriors' in emergency services such as police and personnel from other departments.

The Bill will replace an ordinance issued in April by the government. The government had brought the ordinance April 22 to amend the Epidemic Diseases Act, 1897, to make incidents of violence on health workers treating Covid-19 patients a non-bailable offence with provisions of a penalty and a jail term of up to seven years.

The Bill intends to ensure that during any situation akin to the current pandemic, there is zerotolerance to any form of violence. 

### Man held for cheating 600 people of ₹60cr

Lucknow, Sept 19: The Uttar Pradesh police Saturday arrested a man for allegedly duping over 600 people of around ₹60 crore on the promise of a 60 per cent return on their investments.

The Special Task Force of the UP police said it arrested the racket's mastermind, Hari Om Yadav, from Chandpur village in Sultanpur Road in Lucknow under Gosaiganj

The police also confiscated three mobile phones, five cheque books, one passbook, an Aadhaar card, a laptop and ₹700 cash from the accused, the STF said in a statement.

## India digs deep to boost defences on crucial China frontier

A TUNNEL ALMOST COMPLETE IN THE INDIAN HIMALAYAS WILL SLASH BY HOURS THE TIME IT TAKES TROOPS TO REACH THE CHINESE BORDER

Atal Rohtang tunnel, Sept 19: A tunnel almost complete in the Indian Himalayas will slash by hours the time it takes troops to reach the Chinese border, part of an infrastructure blitz by New Delhi that is gathering pace since a bloody border clash.

The nuclear-armed Asian giants blame each other for a brutal high-altitude battle in June that left 20 Indian soldiers dead and an unspecified number of Chinese casualties.

Both have sent massive troop reinforcements, but India has also stepped up its activities behind the

frontlines - belatedly so, analysts say. Its stepped-up infrastructure programme includes roads and bridges as well as high-altitude helipads and airstrips for civilian and military aircraft.

The showpiece is a \$400-million tunnel in Himachal Pradesh state, providing an all-weather route for military convoys to avoid a 50-kilometre trudge through mountain passes that are snow-bound in winter and subject to frequent landslides.

From late this month, what used to be a four-hour, winding, high-altitude crossing will be cut to a 10minute dash through the mountains in the state-of-the-art tunnel.

"There have been times on the pass route when vehicles have broken down, causing traffic jams of even six to eight hour." said Lieutenant-General Harpal Singh, head of India's Border Roads Organisation (BRO).

This tunnel and the other infrastructure plans change a lot for the troops," he said. **Engineering feat**

**Training the locals** Sanjay Kundu, the Himachal

Pradesh police chief, has also proposed arming locals and training them to report possible Chinese spies and drone and helicopter sightings.

"Ultimately, whether it is at the border or the hinterland, people need to be trained and they need to be trained in defending themselves," he said. The government hopes it will reassure worried villagers.

"In the last few weeks they've seen a lot more activity of fighter planes over the region," said Lobsang

#### 3 LeT terrorists arrested in J&K

Jammu: Three suspected Lashkar-e-Taiba terrorists have been arrested by the security forces from Rajouri district of Jammu and Kashmir with a large cache of arms and ammunition they had received through drones, officials said Saturday. All three belong to South Kashmir's Pulwama district and have been identified as Rahil Bashir, Amir Jan and Hafiz Younis Wani. The girl returned to her home later in the evening after which a case was registered under sections IPC Sections 363 (kidnapping), 364 (kidnapping or abduction in order to murder) and 376 (rape) and provisions of the Protection of Children from Sexual Offences (POCSO) Act.

#### Farmer ends life over farm Bills

Chandigarh: A 70-year-old farmer has died after consuming some poisonous substance during a protest against the new farm Bills in Muktsar district of Puniab. police said Saturday. Pritam Singh, a resident of Akkanwali village of Mansa district, consumed the poisonous substance Friday morning and died at a hospital later in the day, they said. Singh had been participating in the protest since September 15.

#### 15 booked for burning PM Modi's effigy

Muzaffarnagar: Fifteen people, including the national president of a little-known outfit, were booked on the charges of rioting after they burnt an effigy of Prime Minister Narendra Modi on his birthday while observing "Unemployment Day" in neighbouring Shamli district, police said Saturday. The case was registered against 11 unidentified people and four named accused Friday based on a complaint filed by Shamli district BJP president.

## NIA arrests 9 al-Qaeda men from Bengal, Kerala

New Delhi/Kolkata, Sept 19: Foiling an attempt by internationally banned terror group al-Qaeda to set up a base in India, the National Investigation Agency (NIA) swooped on its recruits in West Bengal and Kerala and arrested nine of them, an official spokesperson said

Acting on a tip-off provided by central intelligence agencies, the NIA, with the help of the state police forces, carried out raids in the intervening night of September 18 and 19 at Ernakulam in Kerala and Murshidabad in West Bengal, and arrested the nine men - Murshid Hasan, Ivakub Biswas, Mosaraf Hossen from Ernakulam and Najmus Sakib, Abu Sufiyan, Mainul Mondal, Leu Yean Ahmed, Al Mamun Kamal and Atitur Rehman from Murshidabad.

Hasan was leading the gang and those arrested from Kerala are originally residents of West Bengal, the NIA spokesperson said.

According to the officials investigating the case, the arrested men are highly radicalised and were getting instructions from Pakistan-based al-Qaeda members via cyberspace.

The module was planning to target vital installations as well as targeted killings in India and was in the advanced stage of procuring arms, including automatic rifles and pistols, ammunition and explosives to carry out attacks.

The Governor, who has had regular run-ins with the Mamata

Banerjee dispensation on several issues, had on earlier occasions accused the police and administration in the state of playing a partisan role and causing harassment to leaders and workers of opposition

A closely-monitored operation of the NIA and central intelligence agencies began September 11 when the premier investigating agency registered a case to probe the al-Qaeda module. The group was also planning to go to Kashmir for weapons delivery as it intended to launch terror attacks on vital installations in the country with an aim to kill innocent people, the official said.

A preliminary probe revealed that the arrested men were radicalised by Pakistan-based al-Qaeda terrorists on social media platforms and were motivated to launch attacks at multiple locations, including in the National Capital Region (NCR).

The module was actively involved in fund-raising and some of its members were planning to travel to New Delhi to procure arms and ammunition, the official said, adding that the arrests have prevented possible terrorist attacks in various parts of the country.

Incriminating materials, including digital devices, documents, Jihadi literature, sharp weapons, country-made firearms. a locally-fabricated body armour, articles and literature for making home-made explosive devices, have been seized from the possession of the arrested terrorists, the official said.

### Govt withdraws three labour Bills from LS

New Delhi, Sept 19: The Centre Saturday withdrew three Bills moved by the Labour Ministry in the Lok Sabha and reintroduced them with fresh labour code provisions as part of the labour reforms initiative.

The Occupational Safety, Health and Working Conditions Code, 2019; Industrial Relations Code, 2019; and Code on Social Security, 2019 were withdrawn from

the Lower House when it assembled for the day at 3 p.m.

Minister of State (independent charge) in the Ministry of Labour and Employment, Santosh Kumar Gangwar, moved the proposal for the withdrawal of these Bills

and later reintroduced them with fresh provisions.

In his speech, Gangwar said various changes have been made in the provisions related to the labour Codes as well as their Preamble, necessitating their withdrawal and introduction of new ones. "Because of various changes in the Bills, it is necessary to withdraw earlier ones and introduce Health and Working Conditions Code, 2020; Industrial Relations Code, 2020; and Code on Social Security, 2020 in their place."

The original Codes were introduced in the Lok Sabha in 2019 but later referred to the Parliament's Standing Committee on Labour, which discussed all the three.

"Standing Committee led by Chairman Bhartruhari Mahtab, a Biju Janata Dal MP from Cuttack, made 233 recommendations and we accepted 174 of them.'

The minister said all these changes in the new Bills are part of the labour reforms initiative. "When the country got independence, there were 44 labour laws.

As some of them The minister were later repealed, we are now workreintroduced ing to change 29 them with fresh labour laws into four Codes. This labour code House passed the provisions as first Code with full support; we have part of the labour come with three reforms initiative more Codes.'

Later, the Minister said that his ministry held nine tripartite consultations, four sub-committee meetings, 10 regional conferences, discussed labour court provisions at various places in the country, 10 inter-ministerial consultations and also took suggestions from various departments and Ministries as well as the public.

New Delhi, Sept 19: Delhi Police Special Cell has arrested a Chinese woman and her Nepalese associate for paying freelance journalist Rajeev Sharma for the sensitive information passed on to the Chinese intelligence, police said Saturday.

"The Chinese intelligence had tasked the journalist to convey sensitive information in lieu of large sums of money routed through shell companies. A number of mobile phones, laptops, and other incriminating and sensitive material have also been seized," said Sajeev Yadav, DCP, Special Cell.

The development comes after the Special Cell arrested journalist Rajeev Sharma, a resident of Pitampura in New Delhi under the Official Secrets Act.

"He was found to be in possession of some defence-related classified documents," said the DCP.

Rajeev Sharma, who had worked

for various newspapers and news and presented in a Delhi court the next day. Sharma was sent in police custody for six days.

After his arrest, his Twitter account has also been restricted. The Twitter flashed a message that his account showed suspicious activity and hence was restricted.

In 2019, columnist Rajeev Sharma was supposed to be one of the many victims of the alleged Pegasus snooping. After his arrest, the Delhi Police seized his laptop and mobile phone, and scanned his CDR to know with whom he was in contact with.

Sources said that the Delhi Police had got secret information about his alleged involvement in procurement of classified documents.

The Special Cell is interrogating Sharma to know how he procured the defence-related classified documents and for how long he had been passing sensitive information to the Chinese intelligence.

### J&K announces ₹1,350cr economic relief

Srinagar, Sept 19: Jammu and Kashmir Lieutenant Governor Manoi Sinha announced a ₹1.350-crore economic package for the Union Territory Saturday to give a much needed boost to tourism and other sectors hit by the economic slowdown caused due to the COVID-19 pandemic and the security scenario.

As a part of the package, the government has waived 50 per cent of the electricity and water bill amounts for a year across Jammu and Kashmir with an aim to bring a huge relief to farmers, families and businesses

Sinha also hinted that the Centre is actively considering an "unprecedented and historic package' for assistance to business entities,

which will cover both the existing and new enterprises and will be a big boost to business and industry in Jammu and Kashmir.

Announcing this, the LG said. "You know that at the most, a twoper cent interest subvention is provided and that is what the people expect as well. However, keeping in mind the special situation here – businesses have been suffering for the last about 20 years – we have decided to give an interest subvention of five per cent without any discrimination to all businesses whether small, medium or heavy. This is an unprecedented decision.

He said the Union Territory administration will directly support this with ₹950 crore.

Sinha also announced that stamp duty has been exempted in case of all borrowers up to March next year. He said the new economic package is apart from the package announced by Prime Minister Narendra Modi under the Aatmanirbhar Bharat Abhiyaan.

"Overall, this economic package is historic in terms of volume and reach. I can see that Kashmiris are eager to contribute to the growth of the Union Territory as they are fed up with the cross-border terrorism sponsored by our neighbour."

"I strongly feel that it is our collective responsibility to ensure that a lot of money goes into creation of jobs, strengthening of businesses and coming together of families for a quick bounce-back of Jammu and Kashmir's economy. I have twin objectives – ensure more money in people's pockets," Sinha said.

#### **SW Monsoon** withdrawal likely to begin next week

New Delhi, Sept 19: The Southwest Monsoon is likely to start withdrawing from west Rajasthan by the end of next week, the India Meteorological Department (IMD) said.

Conditions are likely to become favourable in the next two days for the withdrawal of monsoon. North Indians plains are also witnessing above normal temperatures, it said.

'These are one of the weather patterns we see when conditions are ripe for monsoon withdrawal. From September 20 onwards, we don't see the possibility of monsoon rains in west Rajasthan," IMD Director General Mrutyunjay Mohapatra said.

The IMD has revised the withdrawal dates for monsoon from this year. According to the new schedule, monsoon was expected to withdraw September 17. However, due to a low pressure area in the Bay of Bengal, the re-

treat has been delayed. The withdrawal of the Southwest Monsoon from west Rajasthan also makes conditions conducive for onset of winter. Several parts of central and south India are likely to receive heavy rainfall

in the next two days. So far, the country has received 7 per cent more rainfall than normal. The northwest division of the IMD has an overall 15 per cent deficiency. It comprises Rajasthan, Uttar Pradesh, Himachal Pradesh and Puniab.

## Trapped in Chinese debt, Maldives mends ties with India

AS TOURISM, THE MOST IMPORTANT SECTOR FOR MALDIVES, TOOK A HUGE BLOW WITH THE SPREAD OF THE CORONAVIRUS PANDEMIC, CONCERNS OVER DEBT REPAYMENT TO 'ALLY' CHINA ARE LOOMING LARGE

New Delhi, Sept 19: As tourismthe most important sector for Maldives, contributing the most of the nation's gross domestic producttook a huge blow with the spread of the coronavirus pandemic, concerns over debt repayment to 'ally' China are looming large.

The archipelago nation on the Indian Ocean owes about \$1.4 billion to China. It is a huge sum for a country which has a GDP of \$5.7 billion; this translates to almost onefourth. What is worrisome is that, as many analysts said, the figure of \$1.4 billion may not be a true representation, the actual debt feared to be much higher.

With the pandemic hitting the

economy hard, amid the World Bank's projection of an 8.5 per cent contraction in its economy, the nation is in no position to make the repayment. Besides tourism, the country's construction activities have also come to a near halt.

'The shock to tourism adversely affects employment and household earnings, as one-third of adult males and a quarter of females are engaged in tourism-related jobs. Lowerincome households that depend on fisheries are also affected as exports of raw fish have ceased due to weak demand," a World Bank report said. Tourism accounts for about 28 per cent of the country's GDP and generates over 60 per cent foreign exchange receipts.

In 2018, the Maldives government



had indicated that interest rates extended on concessional loans from the dragon nation constitute only about 1.5 per cent to 2 per cent, "while those on loans made under sovereign guarantee are around 6 per cent to 7 per cent". The Nikkei Asian Review had quoted Maldivian Finance Minister Ibrahim Ameer as

saying, "We are mostly looking into increasing the repayment period." The Chinese debt trap

Maldives President Ibrahim Mohamed Solih, soon after getting elected in 2018, said that the country's close tie-ups with China have brought about a financial crisis into the nation.

"Solih appeared to be in no doubt that the country's financial crisis was brought about by the previous administration's overly-close relationship with China. The implication is that China, as it has done in Sri Lanka, has used financial loans to manipulate the Maldives into a position of indebtedness to Beijing," Futuredirections.org.au said.

Just after Maldives celebrated its 55th Independence Day July 26, China issued a notice asking Male to repay \$10 million which was backed by sovereign guarantee. This means that failure to repay would amount to a sovereign default that has serious ramifications for the country's economy. Reports have suggested that the Xi Jinping government in August sought repayment of a larger amount, paid. In 2017, China gave a \$127 million loan to Sun Siyam Resorts Private Ltd but what is interesting is that the Maldivian government had extended sovereign guarantee for the same.

"At \$1.4 billion, of which \$857 million has been disbursed, most of the foreign debt is owed to China for financing former President Abdulla Yameen's infrastructure scale-up,' Maldives Independent reported said.

According to Harvard Business Review, China with its debt diplomacy currently is a major global lender, with outstanding claims now exceeding more than 5 per cent of global GDP. The lending is done both directly by the government and

the state-controlled entities.



#### 2 dead, 1 missing

Athens: Two people have died and one is reported missing in central Greece region of Thessaly after a storm pounded parts of the country overnight and caused flooding. Authorities identified the two victims as an elderly woman found dead in her flooded home and a 63year-old shepherd who was swept by rising flood waters. They said a woman who ignored firefighter and police instructions not to drive into an area where a bridge spans a river is missing. The country's firefighting service said early Saturday that it had fielded almost 2,500 calls from trapped residents in central and western Greece or about removing fallen trees that were blocking roads or had caused property damage. The service reported rescuing more than 600 people.

#### Firefighter dies

Juniper Hills (US): The death of a firefighter on the lines of a wildfire east of Los Angeles was under investigation Friday as another blaze to the north burned homes in a small community on the edge of the Mojave Desert. The death occurred Thursday in San Bernardino National Forest as crews battled the El Dorado Fire about 75 miles (120 kilometers) east of LA, the U.S. Forest Service said in a statement. The fire erupted earlier this month from a smoke-generating pyrotechnic device used by a couple to reveal their baby's gender, the California Department of Forestry and Fire Protection, or Cal Fire, said. The name of the firefighter was being withheld until family members are notified.

#### **Guard suspended**

**London:** A bodyguard who was travelling with Britain's foreign secretary has been suspended from duties after he reportedly left a loaded gun on a plane. British media reported Saturday that the police protection officer travelling with Foreign Secretary Dominic Raab on a visit to the United States left the pistol on a plane at London's Heathrow Airport on Friday. A cleaner found the weapon, media reports said. London's Metropolitan Police said the force was aware of "the incident on a flight into the UK on Friday' and "taking this matter extremely seriously."

#### Quake rattles **California**

South el Monte (US): A magnitude 4.6 earthquake struck Southern California late Friday night, according to the US Geological Survey. The earthquake hit around 11:40 PM, about 3 kilometers outside of South El Monte, near Los Angeles, the agency reported.

# China protests US ban on TikTok, WeChat

Beijing, Sept 19: China Saturday said it was resolutely opposed to the US' move of blocking downloads of WeChat and TikTok apps and warned counter measures to protect the interest of Chinese companies.

The US Friday issued orders to ban popular Chinese social media apps TikTok and WeChat from Sunday to safeguard national security, weeks after India banned them, saying they were prejudicial to sovereignty, integrity and security of the country.

Last month, US President Donald Trump signed an executive order to ban TikTok and WeChat by September 15 unless the ownership of the two Chinese companies changed to American.

Reacting to orders issued by the Trump administration to ban TikTok and WeChat from Sunday, China's Ministry of Commerce (MOC) said it was resolutely opposed to the US' move to block downloads of these apps

In the absence of any evidence, the US has repeatedly used state

power to suppress the two enterprises for unwarranted reasons. which seriously disrupted their normal business activities, undermined the confidence of international investors in the US investment environment and damaged the normal global economic and trade order, the MOC said in a statement.

It said Washington should immediately stop bullying and safeguard international rules and order. "If the US is bent on having its own way, China will take necessary measures to resolutely protect the legitimate rights and interests of Chinese companies," the ministry said, without giving details.

Though the ministry did not specify any retaliatory action, it

issued rules for a widely anticipated unreliable entity list mechanism on Saturday that could severely punish foreign entities and individuals who undermine China's national interests.

The move is believed to counter the US' relentless crackdown campaign against Chinese businesses, state-run Global Times said. The list would include foreign entities or individuals who undermine China's sovereignty, security and development interests and those who violate market principles by cutting off normal transactions with Chinese firms, organizations or individuals, the MOC said. The Ministry did not release specific foreign entities or individuals that will be put

TikTok and WeChat were first banned by India June 29 along with 59 Chinese apps, saying they were prejudicial to sovereignty, integrity and security of the country.

The ban was expanded to 224 Chinese apps later. The ban was imposed in the backdrop of a tense stand-off along the Line of Actual control in eastern Ladakh with Chinese troops.

## 2 killed, 14 hurt in NY shooting ASSOCIATED PRESS

Rochester, Sept 19: Two people died and 14 others were wounded at a backyard party in Rochester, New York, early Saturday, po-

The deaths included a male and a female, both between the ages of 18 and 22, Interim Police Chief Mark Simmons said. The 14 wounded people were taken to two different hospitals. Simmons said none of them were believed to have life-threatening injuries.

This is truly a tragedy of epic proportions," Simmons said near the crime scene, which appeared to stretch at least a block. The shooting comes as the city's police department has been rocked by the suffocation death of Daniel Prude.

Video taken in March and made public by Prude's family September 4 shows Prude handcuffed and naked with a spit hood over his head as an officer pushes his face against the street while another officer presses a knee to his back. The officers held him down for about two minutes until he stopped breathing. He was taken off life support a week later.

Monday, Mayor Lovely Warren fired Police Chief La'Ron Singletary, who she said initially misled her about the circumstances of Prude's death.

The fatal shooting early Saturday did not appear to be linked to the March death.

Officers responded to calls of shots fired and found "approximately 100 people" running from the scene, Simmons said.

many as 50,000 will march over two days in an area of the capital historically associated with political protests, after an estimated 10,000 people turned out for the last major rally August 16. But the early turnout was modest Saturday as a steady light rain fell. Demonstrators wore face masks.

but ignored a Thursday night plea from Prime Minister Prayuth Chanocha to cancel the event, which he said risked spreading the coronavirus and derailing recovery of Thailand's battered economy.

The core demands declared by the protesters in July were the dissolution of parliament with fresh elections, a new constitution and an end to intimidation of political activists. They believe that Prayuth, who as then-army commander led a 2014 coup top-

pling an elected government, was returned to power unfairly in last year's general election because the laws had been changed to favor a pro-military party.

A constitution promulgated under military rule is likewise undemocratic, they charge.

The mostly student activists raised the stakes dramatically at an August 10 rally by issuing a 10point manifesto calling for reforming the monarchy. Their demands seek to limit the king's powers, establish tighter controls on palace finances and allow open discussion of the monarchy.

Their boldness was virtually unprecedented, as the monarchy is considered sacrosanct in Thailand.

## China sends jets as Taiwan honours Lee

Taipei, Sept 19: China sent more warplanes toward Taiwan for the second day Saturday as the island's leader, senior government officials and a high-level US envoy paid tribute to the man who led Taiwan's transition to democracy, former President Lee Teng-hui.

Keith Krach, the US undersecretary for state, kept a low profile at the service. His presence at the event and on the island has drawn a strong rebuke from China, which sent 18 warplanes across the midline of the Taiwan Strait Friday in an unusually large display of force. Saturday, Beijing dispatched 19

more warplanes, two of which were bombers, according to Taiwan's Defence Ministry The island's air force scrambled

their own and deployed an air defense missile system to monitor China's activities, according to a statement.

The service was held at the Aletheia University in Taipei on a balmy Saturday morning, with President Tsai Ing-wen honouring Lee for bringing a peaceful political transition to the island democracy. Lee had built a separate Taiwanese political identity, distinct from mainland China, which claims Taiwan as part of its own territory to be reunited by force if

Lee's carving out of a non-Chinese identity and insistence that the island be treated as an equal country brought him into direct conflict with Beijing. He died July 30 at age 97.

"We have a responsibility continue his endeavours, allowing the will of the people to reshape Taiwan, further defining Taiwan's identity and deepening and bolstering democracy and freedom,' Tsai said. Former Japanese Prime Minister Shinzo Abe and the Dalai Lama also paid tribute from afar.

'We Buddhists believe in life after life, so most probably he will be reborn in Taiwan," the Dalai Lama said in a video message. "His rebirth will carry his spirit continuously.'

The guests included another former Japanese prime minister, Yoshiro Mori. They wore masks and sat spaced out in pews.

### Ocean's hidden heat measured with quake sound

Los Angeles, Sept 19: Scientists have developed a novel method to determine how fast the Indian Ocean is warming by analysing the sound from seabed earthquakes, an advance that may lead to a relatively low-cost technique to monitor water temperatures in all of the oceans.

According to the researchers, including those from the California Institute of Technology (Caltech) in the US, as much as 95 per cent of the extra heat trapped on the Earth by greenhouse gases like carbondioxide is held in the world's oceans, making it important to



monitor the temperature of ocean waters. In the current study, published in the journal Science, the scientists used existing seismic monitoring equipment, as well as historic data on earthquakes, to determine how much the temperature of the ocean has altered, and continues changing, even at depths that are normally out of the reach of conventional tools.

They assessed a 3,000-kilometer-long section in the equatorial East Indian Ocean, and found temperature fluctuations between 2005 and 2016, with a decadal warming trend that "substantially exceeds previous estimates."By one estimate, the scientists said the ocean could be warming by nearly 70 per cent greater than had been believed.

However, they cautioned against drawing any immediate conclusions, as more data need to be collected and analysed.

#### Nepal gets 2 modern $\pm$ trains from India

Kathmandu, Sept 19: India has handed over two modern trains to Nepal that would run between Jaynagar in Bihar and Kurtha in Dhanusa district from mid-December, marking the beginning of the first broad-gauge railway service in the Himalayan nation, officials said Saturday.

The Konkan Railway delivered two modern Diesel-Electric Multiple Unit (DMUC) trains to the Nepal Railway for Jaynagar-Kurtha broad gauge line on Friday. These trains are manufactured by Integrated Coach Factory, Chennai with modern amenities and latest AC-AC propulsion technology

The Indian technicians and the Nepal Railway staff were welcomed at various locations when the trains arrived in the country from India on Friday. Thousands of people gathered to see the new trains despite the coronavirus pandemic that has killed 390 people and infected over 60,000 others in Nepal.

The train operations from Kurtha to Jaynagar, covering a distance of 35-km, will benefit citizens of both the countries, according to Indian Embassy sources. The trial run of the new trains started from Friday on the broad gauge tracks whose construction was completed last year, according to Nepal Railway Company Director General Guru Bhattarai.

Since the border is unlikely to open soon due to the pandemic, the train services would not start now and the trains would be parked at the Nepal Railway Station in Jaynagar for maintenance and safety.

## Ginsburg, a feminist icon memorialised as the Notorious RBG

Washington, Sept 19: Supreme Court Justice Ruth Bader Ginsburg moved slowly. When court was in session, she often had her head down, sometimes leading visitors to think she was asleep. She once acknowledged that she did occasionally nod off. She once confessed to dozing during a State of the Union.

But it was a mistake to equate her gait and gaze with frailty, for Ginsburg showed over and over a steely resilience in the face of personal loss and serious health problems that made the diminutive New Yorker a towering women's rights champion and forceful presence at the court over 27 years.

She made few concessions to age and recurrent health problems, working regularly with a personal

trainer. She never missed any time in court before the age of 85, and then only following surgery in December 2018 for lung cancer. Ginsburg died Friday of complications from metastatic pancreatic cancer at her home in Washington at 87, the court Late in her court tenure, she be-

came a social media icon, the Notorious RBG, a name coined by a law student who admired Ginsburg's dissent in a case cutting back on a key civil rights law. The justice was at first taken aback. There was nothing "notorious" about this woman of rectitude who wore a variety of lace collars on the bench and often appeared in public in elegant gloves.

But when her law clerks and grandchildren explained the connection to another Brooklynite, the



rapper The Notorious B.I.G., her skepticism turned to delight. "In the word the current generation uses, it's awesome," Ginsburg said in 2016, shortly before she turned 83. In 2018, Ginsburg was the subject of a documentary and a feature film "On the Basis of Sex," in which the actor Felicity Jones portraved her.

In her final years on the court, Ginsburg was the unquestioned leader of the liberal justices, as outspoken in dissent as she was cautious in earlier years. Criticizing the court's conservative majority for getting rid of a key part of the landmark Voting Rights Act in 2013, Ginsburg wrote that it was like "throwing away your umbrella in a rainstorm because you are not getting wet."

Her stature on the court and the death of her husband in 2010 probably contributed to Ginsburg's decision to remain on the bench beyond the goal she initially set for herself, to match Justice Louis Brandeis' 22 years on the court and his retirement at the age of 82.

Ginsburg had special affection for Brandeis, the first Jew named to the high court. She was the court's second woman and its sixth Jewish justice. In time she was joined by two other Jews, Stephen Breyer and Elena Kagan, and two other women, Kagan and Sonia Sotomavor.

Both developments were perhaps unthinkable when Ginsburg graduated from law school in 1959 and faced the triple bogey of looking for work as a woman, a mother and a Jew. Forty years later, she noted that religion had become irrelevant in the selection of high-court justices and that gender was heading in the same direction, though when asked how many women would be enough for the high court, Ginsburg replied without hesitation, "Nine." She could take some credit for equal-

ity of the sexes in the law. In the 1970s, she argued six key cases before the court when she was an architect of the women's rights movement. She won five. "Ruth Bader Ginsburg does not

need a seat on the Supreme Court to earn her place in the American history books," President Bill Clinton said in 1993 when he announced her appointment. "She has already done that." Her time as a justice was marked by triumphs for equality for women, as in her opinion for the court ordering the Virginia Military Institute to accept women or give up its state funding. There were setbacks, too. She dissented forcefully from the court's decision in 2007 to uphold a nationwide ban on an abortion procedure that opponents call partialbirth abortion.

## 'Fuel demand to shrink 11.5% in 2020'

New Delhi, Sept 19: Fitch Solutions has revised downward its forecast for fuel demand contraction in India to 11.5 per cent in 2020 in line with further deterioration in the country's economic outlook.

Its economists forecast India's real GDP to contract by 8.6 per cent in the fiscal year 2020-21 (April 2020 to March 2021), down from -4.5 per cent previously.

"Demand weakness is spread across the board, with both consumer and industrial fuels set for the steep decline," Fitch Solutions said in a note. "We have made a further downward revision to our India refined fuels demand forecast for 2020, from -9.4 per cent to -11.5 per cent, in line with further deterioration in the country's economic

It forecast a 5 per cent year-on-year (y-o-y) growth in 2021 and 2022, as the outbreak is brought under control and the economic activity normalises. In the first quarter of 2020-21, the GDP shrank by 23.9 per cent, the steepest contraction on record. The domestic COVID-19 outbreak shows no signs of abating, with daily cases continuing to accelerate.

While the nationwide lockdown (in place since March 25) was lifted on May 31, state-level restrictions remain in place and will likely drag on the economic recovery," it said.

With a nationwide lockdown in place over March to May, domestic demand plummeted, reaching its nadir in April at 48.7 per cent year-

on-year contraction for total fuels consumption. As the lockdown was rolled back, demand began showing some signs of life, contracting by just 8.6 per cent in June. However, statelevel restrictions, persistent disruption to economic activity and continued and aggressive spread of the virus dragged the demand lower once again, with 20.6 per cent contraction in August.

The transport sectors have suffered the heaviest losses, as social distancing measures cut off traffic and travel and curbed demand for road, air and shipping freight.

In percentage terms, jet fuel has seen the sharpest contraction, with consumption falling on average by 46.6 per cent in the eight months to August, it said adding at its April low, the demand contracted by 91.4 per cent y-o-y, due to a total ban on flights, excluding those for essential cargo movement, such as medicines. Gasoline (petrol) demand fell by an average of 16.1 per cent in the YTD (with a low of 60.4 per cent) and diesel demand (which is widely used in the transport, industrial and power sectors) was down by 25 per cent, with a low of 55.5 per cent.

"Industrial demand as a whole has declined sharply, due to restrictions in place on business activities, labour and supply shortages and credit constraints," Fitch said. The one bright spot was LPG, demand for which rose by 4.3 per cent in the year to date. "Social distancing measures have increased residential demand as whole, while the government's policy to offer free cylinder refills to low-income households offered an extra boost," it said.

Fitch said its 2021 and 2022 fuel demand forecast are skewed to the downside. "The economy was already under strain in advance of COVID-19. The virus has only served to exacerbate this strain and the path to recovery is far from clear. Both the manufacturing and services sectors will likely remain under pressure in the coming months, as  $\,$ demand remains weak and statelevel restrictions constrain activity."

A rollback of these restrictions should help normalise output, but in light of the persistence of the outbreak, the return to normalcy will likely be slow, it said.

### Govt introduces three labour Bills in Lok Sabha

New Delhi, Sept 19: The government Saturday introduced three bills related to labour laws, including on industrial relations, in the Lok Sabha amid opposition from the Congress and few other parties. Labour Minister Santosh Kumar Gangwar introduced the Occupational Safety, Health And Working Conditions Code, 2020. the Industrial Relations Code, 2020, and the Code On Social Security, 2020. He withdrew the three bills that were introduced last year and introduced the three new ones.

According to the minister, over 29 labour laws have been merged into four codes and that one of them has already been passed. The Code on Wages Bill, 2019 was passed by Parliament last year.

Gangwar noted that the government engaged in wider consultations over these bills with various stakeholders and that more than 6,000 comments were received online on the bills. These bills were later sent to a standing committee

and 174 of its 233 recommenda tions have been accepted, the minister said. Congress leaders --Manish Tewari and Shashi Tharoor

-- opposed the introduction of the three bills. Tewari noted these three bills are fundamentally changed versions of their earlier forms and urged the minister to withdraw them and hold wider consultations before introducing them. These bills are also a blow to the rights of workers, he added.

Regarding the bill on occupational safety, health and working conditions. Tharoor said it fails to have specific provisions to safeguard interests of unorganised sector workers and also that there was no exclusive chapter on interstate migrant workers. He also said that the bill is discriminatory since there is no specific provision on women's welfare. With respect to the industrial relations code, he said it severely restricts the right of workers to strike and also allows state or central governments to amend the threshold for applicability relating to layoffs.

## Surcharge on dividend income for FPIs may be capped at 15 pc

New Delhi, Sept 19: In a major relief for foreign portfolio investors, the Union Government has proposed to cap the surcharge on dividend income from FPIs with a trust structure at 15 per cent.

Currently, FPIs that operate as trusts have to pay a surcharge as high as 37 per cent if their dividend income is over ₹5 crore and 25 ner cent in case of a dividend income of ₹2 crore and ₹5 crore, following measures in the 2019-20 budget.

"The Finance Act, 2020 is also proposed to be amended to clarify regarding capping of surcharge at 15 per cent on dividend income of

The government has also proposed tax exemption on the income of category-III Alternate Investment Funds in the International Financial Services Centre from masala bonds, derivatives or overseas investments.

Berlin, Sept 19: The new Bundesliga began in an empty stadium with eight-time defending champion Bayern Munich routing Bayern debut and Jamal Musiala be-

league's opening match. And it should have been more. Germany winger Leroy Sane starred Friday and scored on his

came Bayern's youngest ever goalscorer at 17 years, 205 days, but otherwise it was business as usual as they totally dominated and the visitors tried limiting the damage. Schalke's winless run stretched

to 17 games, while Bayern extended their winning run to 22. Serge Gnabry scored a hat-trick and Sane set up two of the goals. It was 3-0 by halftime and Bayern

missed a host of chances. The game took place without fans despite plans for 7,500 spectators to attend. A spike in local coronavirus infections forced authorities to row back.

The team showed no ill effect from the supporters' absence, nor the short break of 26 days after winning the Champions League final against Paris Saint-Germain. It was the biggest opening night win since 2016 when Bayern routed

Werder Bremen 6-0. Gnabry got the side off to a flying start in the fourth minute, taking Joshua Kimmich's pass from midfield, switching direction to elude Schalke captain Benjamin Stambouli, then unleashing a fine strike with

his left boot inside the left corner. Robert Lewandowski almost made it 2-0 a minute later after being set up by Sane, but Sebastian Rudy managed to deflect the Poland striker's shot with his outstretched leg.

Schalke managed to hold out until the 19th, when Leon Goretzka scored against his former side with Thomas Muller laying the ball back.

Sane brilliantly set up Lewandowski shortly afterward, but the Poland striker fired over. Lewandowski finally got off the mark from the penalty spot in the 31st, after he'd been fouled by Ozan Kabak.

Niklas Sule - a central defender - struck the post and Bayern missed other chances before the break, too. Sane set up Gnabry's second goal in the 47th - his first assist for the club – and repeated the trick to help his Germany teammate complete his hat-trick in the 59th.

Lewandowski set up Muller in the 69th by wrapping his right boot behind his left leg, a rabona move, two minutes before Kimmich set up Sane for his first goal.

Sane made way for Musiala to make his second Bundesliga appearance in the 72nd. The 17-yearold English midfielder grabbed his first goal in the 81st.

Bayern board member Oliver Kahn addressed club officials' lack of social distancing during the game. TV images showed at least 10 Bayern officials including Kahn,
