Diesel cheaper by over ₹2/I this month

New Delhi: Diesel prices continued to decline for the fifth consecutive day Monday even though globally crude prices remained steady. Diesel sold ₹77.78 per litre in Bhubaneswar, down 16 paisa while petrol sold ₹81.74 p/l. In the national capital diesel was priced at ₹71.43 per litre, down from ₹71.58 Sunday. Similarly in the other metros of Mumbai, Chennai and Kolkata the fuel was sold for ₹77.87, ₹76.85 and ₹74.94 on Monday, respectively, against the previous levels of ₹78.02, ₹76.99 and ₹75.09 per litre.

Trainee pilot killed in UP copter crash

Lucknow: A rookie pilot was killed after a helicopter carrying four people crashed in Uttar Pradesh's Azamgarh district Monday. Police and local authorities are the spot and rescue operations are underway. The incident took place in Sarai Meer in an agricultural field, according to details available, the aircraft crashed at nearly 11.20 a.m. One person died and another was injured in the crash, while two others jumped out of the

Farm Bills a recipe for disaster

The Centre is trying to steamroll 3 farm Bills without taking the state governments on board. Analysts fear the new Bills may face the fate of the GST which has completely failed to protect the states' financial interests

New Delhi, Sept 21: The Farmers' Produce Trade and Commerce (Promotion and Facilitation) Bill, 2020, and the Farmers (Empowerment and Protection) Agreement on Price Assurance and Farm Services Bill, 2020 passed the muster in the Rajya Sabha in a voice vote Sunday, replacing the respective ordinances. However, the Bills have created an avalanche of protests from the opposition including the Shiromani Akali Dal (SAD) and the Biju Janata Dal (BJD) and farmers in several states, but the loudest protests have come from Punjab and Haryana. The Essential Commodities (Amendment) Bill, 2020 is yet to be taken up in the Upper House. Last week, these Bills were passed in the Lok Sabha. The three Bills claim to increase the availability of buyers for farmers' produce thereby creating more com-

petition and better prices for them. The Farmers (Empowerment and Protection) Agreement of Price Assurance and Farm Services Bill, 2020 will provide a legal cover to contract farming. It enables farmer(s) to enter into an agreement for production of a crop for up to five years. In the poultry and seed production sectors, contract farming has already gained ground and even small and marginal farmers have been signing contracts with aggregators to set up poultry units. Cane farmers also enter into a kind of contract farming with sugar mills. However, the contract farming will be voluntary.

In states like Odisha, such practices are already in vogue, though in an informal manner. Here, moneylenders and middlemen in villages extend ad-

vances to farmers taking advantage of their financial difficulties to grow crops, only to buy them back upon harvest. After adjusting the advance money with interest, they return the remaining amounts, if any, to farmers. This is one type of contract farming which keeps small and marginal farmers perennially poor. After this Bills become law, such unwanted practices

may get legal sanctity. In the Agricultural Produce Market Committees (APMCs) system, marketing committees could not do 100 per cent procurement of the produce. resulting in distress sale by farmers. The so called freedom to farmers to access such formal markets does not make sense unless the farmers have the money to access them. We have heard of large scale farmers' suicides in states like Maharashtra where there is

a well-oiled APMC system. Under the Essential Services Maintenances Act, the state governments exercised power to raid hoarders who created artificial shortages of commodities during their short supply because of poor production and jacked up prices. Under the new Bills, this

power has been taken over by the Centre. The farm Bills aim at enabling farmers to enter into contracts with modern retailers, wholesalers, processors and exporters. However, small and marginal farmers can't enter into contracts with big businesses as they are too fearful of the clout of corporates. This will only encourage middlemen and rich traders to exploit the farmers.

In 2017, the Union governemnt rolled out the Goods and Services Tax (GST) under which it forced states to barter away their financial powers to Centre **Congress to launch** nationwide protests NEW DELHI: The Congress party Monday said it will launch a nationwide agitation against the farm Bills passed by

Parliament and also initiate a campaign for collecting two crore signatures of farmers and the poor against these pro posed legislations. After a meeting of the party's senior leaders, KC Venugopal said the Congress will also launch a massive signature campaign in which it aims to collect two crore signatures from farmers and the poor people against farm bills. A memorandum would be subsequently submitted to President, the Congress leader said. Another Congress leader Randeep Surjewala said a series of pressers will also be organised against the Bills.

which promised to compensate them for their tax shortfalls. Now we have seen a complete failure of the GST. The Centre is not in a position to give funds to state governments. It was still thinkable in the context of GST that transferred financial powers from states to the Centre. But the GST's possible replication in agriculture and food will be a pure recipe for catastrophe.

The Union government should abstain from rushing through these three Bills. It should prepare a road map of the future of MSP, PDS and procurement for the next 10 years. For this, a consensus is required between the Centre and the states. There is a need to reduce the procurement, especially of rice from water-stressed blocks in Punjab, Haryana and Western Uttar Pradesh so as to save the wastage on carrying excessive stocks.

Fire at Covid hosp, 127 patients rescued

Cuttack, Sept 21: Over 125 patients, including pregnant women and newborns, were evacuated after a fire broke out at a COVID-19 hospital in Jagatpur town of Cuttack district Monday, officials said. No loss of life has been reported so far, DG (Fire Service) Satyajit Mohanty said.

"All the patients were rescued safely and immediately taken to nearby COVID facilities," Cuttack Collector Bhabani Shankar Chayani said. Central RDC Anil Samal has ordered an administrative probe into the incident. Health and Family Welfare Minister Naba Das has asked the fire service department to submit a report on the cause of the mishap.

The blaze erupted in one of the ICU wards -- where six critical patients were on ventilators -- on the third floor of the hospital. "The smoke was so dense that we had to use the flashlights on mobile phones to come out of the building," said a patient. Hospital sources said there were at least 10 pregnant women and six others, who had come under

the scalpel for Caesarian section in the last one week. "All the critical patients

in the ICU were first rescued by the hospital staff and subsequently, the remaining wards located in other floors were vacated," Chayani said, adding, a bus and 12 ambulances were pressed into operation to shift the patients to six other COVID facilities located in Cuttack and Bhubaneswar.

Chief Fire Officer Sukant Sethy said the blaze was brought under control within 10 minutes with the help of five fire tenders.

New Delhi, Sept 21: Biju Janata Dal (BJD) MP Amar Patnaik Monday urged the Union government to confer classical status on Odissi music.

The BJD MP said the Odisha Heritage Cabinet, chaired by Chief Minister Naveen Patnaik, passed a resolution September 2 requesting the Centre to confer 'classical status' on Odissi music.

"Odissi dance and music were inspired and enriched by the Jagannath culture. More than a religious deity for the people of Odisha, Lord Jagannath is the fountainhead of our cultural, intellectual and emotionalsustenance. Bharat Muni's Natva Shastra referred to Odra Magadhi style of music and dance which belongs to Odisha. Similarly, Matangi Muni also mentioned Udra Magadhi Prabriti known as 'Kalinga music' or 'Utkal music'," Patnaik said. The Centre had recognized Odissi dance as a classical dance form in 1964.

Mumbai, Sept 21: The Sensex dived 812 points while the Nifty closed below the 11,300-mark Monday, in tandem with a global selloff after a resurgence of coronavirus cases in Europe stoked fears of another round of lockdowns.

Denmark, Greece and Spain have imposed fresh restrictions on activities to tackle a surge in COVID-19 infections. Britain too is considering a second nation-wide lockdown, prompting investors in Europe to offload travel, consumption and banking stocks. Falling for the third straight session, the BSE Sensex ended 811.68 points

or 2.09 per cent lower at 38.034.14. Similarly, the NSE Nifty tumbled 254.40 points or 2.21 per cent to finish at 11,250.55. IndusInd Bank was the top loser in the Sensex pack, tanking 8.67 per cent, followed by Bharti Airtel, Tata Steel, ICICI Bank, M&M, Maruti, Axis Bank and Bajaj Finance. Only three index components ended in the green -- Kotak Bank, Infosys and TCS, rising up to 0.86 per cent.

The market capitalisation of all BSE-listed companies fell to ₹1,54,76,979.16 crore, wiping off ₹4.23 lakh crore of investor wealth. "Indian benchmark indices succumbed to profit booking in the second half of the trading day and

ended more than 2 per cent down. It was in sync with global cues.

"Extra curbs were being considered in Europe following an increase in infections. With high valuations and worries that earnings may not justify such valuations anytime soon, markets may trade uncertain for the time being. said an expert.

Thane, Sept 21: Seven children and four others were killed and 13. including a four-year-old boy, rescued after a three-storeyed building collapsed in Maharashtra's Bhiwandi town on Monday, police said.

The 43-year-old Jhilani building caved in at 3.40 am, police said, adding the dead children include a two-year-old. Personnel of the Thane Disaster Response Force (TDRF) were seen pulling out the boy, Ubed Quraishi, from the debris and feeding him water. Bhiwandi is a powerloom town around 10 km from Thane. The building had 40 flats and around 150 persons lived in it, an official said.

A civic official told PTI that the building, located at Narpoli's Patel Compound near Dhamankar Naka, collapsed while the residents were asleep. Teams of the National Disaster Response Force (NDRF) are at the spot. NDRF DG S N Pradhan said they were using a canine squad to search persons trapped in the debris.

A portion of the building collapsed and many occupants were trapped in the debris, a Thane Municipal Corporation official said. The building was not in the list of dilapidated structures of the Bhiwandi-Nizampur Municipal Corporation, he said.

An eyewitness said local residents rushed to the spot immediately after the collapse and helped pull out some persons from the debris. The power supply to the locality was snapped as a precautionary measure, the official said.

In a first, Indian Navy women officers to join warships crew

New Delhi, Sept 21: Heralding yet another first in the history of Indian naval aviation, two women officers have been selected to join as "Observers" (Airborne Tacticians) in the helicopter stream. Lieutenant Kumudini Tyagi and Sub Lieutenant Riti Singh will be the first women officers in the Indian Navy to embark on Navy warships as part of ship's crew.

They would in effect, be the first set of women airborne combatants who would be operating from warships. Earlier, entry of women was restricted to the fixed wing aircraft that took off and landed ashore," Indian Navy spokesperson Commander Vivek Madhwal said. They are to be part of Multi-Role-Helicopters (MRH)crew.

These officers, Sub Lieutenant

Kumudini Tyagi and Sub Lieutenant Riti Singh, are a part of a group of 17 officers of the Indian Navy, including four women officers and three officers of the Indian Coast Guard (13 officers of Regular batch and 4 woman officers of Short Service Commission batch) who were awarded "Wings" on graduating as "Observers" at a ceremony held on Monday at INS Garuda, Kochi.

"The ceremony was presided by Rear Admiral Antony George NM, VSM, Chief Staff Officer (Training) who presented the awards and coveted wings to the graduating officers," Commander Vivek Madhwal said.

In addition, the chief guest also awarded the 'Instructor Badge' to six other officers, (five from the Indian Navy including a woman and another from Indian Coast Guard) who had successfully graduated as Qualified Navigation Instructors (QNI)



on the occasion.

Speaking on the occasion, complementing the graduating officers, Rear Admiral Antony George highlighted the fact that it is a landmark occasion wherein for the first-time women will be trained in helicopter operations which would ultimately pave way for the deployment of women in frontline warships of Indian Navy

The officers of the 91st Regular course and 22nd SSC Observer course were trained in air navigation, flying procedures, tactics employed in air warfare, antisubmarine warfare and exploitation of airborne avionic systems. These officers would serve on-board Maritime Reconnaissance and Anti-Submarine Warfare aircraft of the Indian Navy and Indian Coast Guard.

From the 91st Regular Observer Course, Lieutenant Hitesh Singh was awarded the Uttar Pradesh Trophy on being adjudged 'First in the Overall Order of Merit' while Lt Anuj Kumar was awarded the Flag Officer Commanding-in-Chief, Eastern Naval Command Trophy for being adjudged 'Best in Flying'.

Lt Hitesh Singh was also awarded the Sub Lieutenant RV Kunte memorial Book Prize on being adjudged 'Best in Ground Subjects'. From 22nd SSC Observer Course Sub Lieutenant Kreeshma R was awarded the Book Prize for being adjudged 'Best in Overall Order of Merit'.

Woman pilot in Rafale fleet

A woman fighter pilot of the Indian Air Force will soon join the newly-inducted Rafale fighter fleet as one of its crew flying the multi-role aircraft, official sources said Monday. The woman pilot has been flying



MiG-21 fighters and was selected to join the Ambalabased Golden Arrows squadron operating the Rafale jets, they said. In 2018, flying officer Avani Chaturvedi scripted history by becoming the first Indian woman to fly a fighter aircraft solo. She flew a MiG-21 bison in her first solo flight. Chaturvedi was part of a three-member women team commissioned as flying officers in July 2016, less than a year after the government decided to open the fighter stream for women on an experimental basis.

BJD'S OPPOSITION TO FARM BILLS SPARKS DEBA

Bhubaneswar; Sept 21: Opposition to farm Bills by Biju Janata Dal (BJD), which has backed the Narendra Modi government on many issues in the past, has triggered sharp reactions in Odisha's political circles with BJP leaders claiming that the regional party fears the measures will end its control over regulated market committees.

Ruling BJD leaders, however, maintained that their opposition was not guided by any political considerations and the party wanted the Bills to be put to more scrutiny to do away with certain inadequacies Nath as the for effective protection of small General (IG) in and marginal farmers as well as

sharecroppers. Out of 10 Rajya Sabha seats in Odisha, BJD has nine members while the BJP has one.

Hitting out at BJD for opposing Farm Bills, which were passed in Rajya Sabha Sunday, senior BJP leader and Lok Sabha member Suresh Pujari said the measures aimed at abolishing the role of middlemen and agents during paddy pro-

curement at mandis. The passage of the Bills will enable farmers to get the actual minimum support price (MSP) for their produce which they can sell at the nearest mandi, he told PTI over

phone. Pujari alleged that the BJD was opposed to the Bills as all the regulated market committees (RMCs) in the state are now being controlled by the ruling party in Odisha.

The RMCs have been preventing farmers from getting actual MSP in collusion with different government departments, he claimed, and alleged that the BJD leaders are against the Bills as collection of money from farmers will now come to an end.

Party's Chief Whip in Rajya Sabha, Sasmit Patra, said the regional outfit has consistently raised its concerns over some inadequacies in the Bills and pleaded for steps to put the measures to greater scrutiny to ensure that the interests of farmers are safeguarded.

Therefore, the BJD, which has extended issue-based support to the Centre on several occasions, had in Lok Sabha sought steps to send the Bills to the standing committee, while in the Upper House it pressed for sending these to the

Select Committee for wider consultations, Patra said The party opposed the Bills because of inadequate protection to

small and marginal farmers as also sharecroppers and emphasised the need for fine-tuning the measures for effective protection of the farm ing community, Patra told PTI over



phone. Senior BJD MP Prasanna Acharva said the party was keen to protect the interests of farmers, but the farm Bills lacked some clarity. Therefore, the BJD pressed for referring the Bills to the select committee for scrutiny.

The two Bills, which the central government says will change the ecosystem of agricultural marketing, are largely good in intent but probably ignore the implementation aspects, said another senior BJD leader, while expressing apprehension about possible dilution of MSP.

The BJD's opposition to the Bills came close on the heels of its support to NDAs Harivansh for election to the post of Deputy Chairman of Rajya Sabha.

The Naveen Patnaik-led party has been backing the BJP-led government on many occasions during the last few years. It supported the Citizenship (Amendment) Bill as well as the Triple Talaq Bill last vear.

The party was in favour of empowerment of women and therefore supported the Triple Talaq measure, a senior BJD leader said. Earlier, the BJD had supported the Modi government on demonetisa-

Bhubaneswar, Sept 21: State's COVID-19 tally rose to 1,84,122 Monday as 4,242 more people tested positive for the infection, while nine fresh fatalities pushed Odisha's coronavirus death toll to 710, an official of Health and Family Welfare (H&FW) department said.

As many as 2,503 new cases were reported in quarantine centres, while 1,739 people tested positive for the infection during contact tracing, said the official.

Khurda district, under which Bhubaneswar falls, reported the highest number of new cases at 652, followed by Cuttack (595), Jharsuguda (205) and Puri (182), the official pointed out.

Two fresh fatalities were reported in tribal-dominated Keonjhar district, and one each in Balasore, Jagatsinghpur, Kandhamal, Khurda, Mayurbhanj, Nabarangpur and Nayagarh districts, said the official, adding that as many as 53 coronavirus patients have so far died due to other ailments.

Meanwhile, 3,704 patients recovered from the disease, taking the total recoveries in Odisha to 1.49.379, the H&FW department official said, adding that the state

Bhubaneswar, Sept 21: As part of COVID elevation measure, a meagre amount of 1 kg of chana dal has been provided to BPL/PDS beneficiaries every month and the state government is planning to stop its allocation from November.

impact on nutritional food security in rural Odisha during COVID-19. The online survey titled "Consumption of Dal and its impact

on nutritional food security in Odisha" which was undertaken with more than 10769 families in the state in 16 districts covering 405

villages of 371 Gram Panchayats in 83 blocks reveal the emerging need of Dal and Edible oil in Public Distribution System to ensure nutritional food security among people in rural Odisha.

According to the study report, 99.9% of surveyed families said that the Dal provided under the Public Distribution System is benefiting them. It emphasizes that people need Dal from the government as a nutrition supplement looking at their consumption trend. The survey report also revealed that 46.6% of the families have to spend between Rs. 81 to Rs. 100 for 1 KG of Dal and around 2% of families have also said that they have to pay more than Rs.110 for 1KG dal. The enhanced price of Dal will most likely distort spending and consumption decisions and this may affect nutrition security, especially for low-income families.

Odisha is one of Empowered Action Group (EAG) states declared by the Ministry of Health and Family Welfare. Though the state has improved on the proportion of malnourished children under -5 in the state shrunk to 34.4% (NFHS-4) from 40.7% (NFHS-3), the tribal communities still suffer the most. Almost 50% of the under-5 children from tribal communities in Odisha are underweight, and 46% are stunted. Another defiance for Odisha is its outreach to remote and particularly tribal populations.

Berhampur, Sept 21: The district of Ganjam gained notoriety a few months back for two reasons. One was due to the number of migrant workers returning to the district, the second one was for it emerging as a hotspot for Covid-19; an induced effect.

However, the district administration by taking prompt measures has now managed the Covid-19 situation. There was a time when the district was reporting close to 650 Covid cases daily. Now because of the preventive measures taken the numbers have come down to 50-60 cases a day.

Active surveillance, strict penalty collection for violation of Covid-19 guidelines, setting up of control rooms for monitoring, capacitybuilding of frontline health workers, better communication and strong community engagement are some of the strategies that have helped in restricting the spread of the disease.

On the other hand in a bid to manage the Covid situation in the district properly the state government had also appointed IAS rank officers to monitor, coordinate and guide actions in the field.

However, early release of technical guidelines on contact tracing, quarantine, isolation, hospitalisation, infection prevention and control, and extensive capacitybuilding by the district Health department also played a critical role in managing the situation.

Here are some of the key points which helped the Ganjam district to reduce the tally from 800 to 80: Early preparation: The Ganjam

district administration had re-



stricted various festivals like Chaitra Mangalbar Yatra and Danda Yatra in the district in the month of March. However, the Covid hit the district with the coming of the migrant workers from different states. Except the public transport car-

rving migrant workers and essential good vehicles, the district administration had not allowed any vehicle to enter the district. For this, the admin had sealed various borders like Ganjam-Andhra Pradesh and intra state borders like at Khurda. Navagarh. Puri and Kandhamal. All these helped the district administration in the fight

against this pandemic. Systemic investment in strengthening health infrastructure: The district administration has systematically invested in health sector in order to strengthen the infrastructure. During the pandemic, the district administration had setup at least four Covid-19 dedicated hospitals and several COVID Care in the district are the mainstay of the district's Covid-19 response. Kulange also instructed all the medical stores in the district to keep the details of each and every person with flu like symptoms com-

The government instituted a longer quarantine from 14 to 28 days initially and built thousands of shelters for migrant workers stranded by the nationwide shutdown. Further COVID Care Centers had been established in all blocks to accommodate non-residents such as tourists and people in transit among others. Adequate infrastructure had been provided at all designated isolation facilities for accommodating residents returning from other states. Though the district administration had to face several criticisms from various quarters for the same but it never stepped back from the Covid-19 rules.

Providing psychosocial support: Fo provide psychological support to the migrant workers at the isolation or quarantine centres the district administration had made arrangements like exercises and yogas at the morning time, listening of music during the evening time and gardening works. The district administration also educated the migrant workers on Covid management at the quarantine centres

TOTAL ACTIVE CASES NOW STAND AT 269

Berhampur, Sept 21: Ganjam district's number of active Covid-19 cases has been constantly decreasing. Currently, the number of active cases in Ganjam district stands at 269.

The district reported 57 fresh cases Monday. With this, the number of COVID-19 infected persons in the district went up to 19,675. So far, 19,182 patients have recovered from the pandemic disease.

The deadly virus has so far claimed 216 lives in the district. The number of patients who have died due to reasons other than COVID-19 is eight.

Notably, there was a time when the district was reporting the highest number of cases in Odisha on a daily basis.

Trample the farmer

hat is touted as a major agriculture reform legislation, when it came, is facing limited resistance from the unorganized farming community. The Union government, in passing the three agriculture related Bills, has tried to play a game similar to the earlier move it made in reforms in the tax system. It had claimed that the One Nation One Tax slogan would make the Goods & Services Tax (GST) the ultimate solution of easing up business and stopping pilferage. Today, barely three years later, the pitfalls created by the implementation of GST have hammered small and medium businesses and, at the same time, in this critical economic crisis period the GST collections have sharply declined and the Union government is unwilling or incapable to pay the states their due. Instead it has compelled the states to borrow at high rates of interest for keeping the wheels turning.

These agriculture Bills should not be compared to a financial or taxation regulation. These could cause immense hardships not only in the farm sector for marginal, small and medium farmers but also for those weaker sections of society who are in non-farming sectors and buy their food. The resignation of the lone Akali Union minister, Harsimrat Kaur Badal, from the Modi government is an indication of ground realities in states like Punjab and Haryana. Farmers in states like Orissa are not aware of the dangers of these new laws and how negatively these will impact them in the near future, unlike their counterparts in other agriculturally developed states. States like Maharashtra or Uttar Pradesh have not yet reacted since their major cash crop-sugarcane- is already in a loose contract farming set up

The government's claim that the new farm Bills will help eliminate middlemen and the transactions will be directly between the farmer and the trader, and that this will largely benefit the farmers, sounds very good. However, there seems to have been no thought given as to who will fill in the vacuum that will be created by the supposed vanishing act to be put up by the middlemen. In a state like Orissa, it is these middlemen who offer advance payment to marginal or small farmers for the future produce. Once they are eliminated, the cash crunch will immediately affect the already debtridden farmer. The trader is probably expected to be the ambassador of a large corporate like Adani or Reliance. For these companies to enter the market and commence periodic or seasonal procurement at every panchavat of this vast nation will take considerable time. End result will be poorer procurement resulting in more distress sale. But there may be no one around to pitch in when the farmer goes in for such a desperate sale.

The devil is in the details. The farm legislation allows farmers to 'trade freely without any license or stock limit.' This could be painted as a positive turn but ground realities speak of farmers incapable to transport their produce to mandis located in adjoining panchayats. With poverty levels being so acute, it would be a matter of great wonder if marginal or small

farmers who form the bulk of that community in a state like ours would have the economic holding power to remain afloat and sell their produce outside their district, let alone the state. Creating these vacuum spaces will bring in whole different systems into play that have not been thought through properly. Most likely, a parallel to the hurried implementation of the GST can be expected here too.

Setting up a grievance redressal machinery sounds good too but which poor

farmer will have the capacity to go through a three-fold adjudication set up is also a matter to ponder over.

The Gramin Agricultural Markets scheme envisages a haat system for agriculturists in each panchayat and sponsored by the central government. Presently, agricultural markets are mostly regulated by the Agriculture Produce Marketing Committee (APMC) and this entity, no doubt, has its flaws. But will the central government, in spite of its greed to usurp powers of the state governments, be able to create the wherewithal to reach every panchayat across the length and breadth of this vast country and execute such a massive and, at the same time, equitable marketing facility for the immensely varied agricultural produce? Should it even be bothered with such a gigantic task in these times of economic distress?

It is claimed that APMC markets were set up with the objective of fair trade between the seller (farmer) and the buyer (trader), from whom the produce reached the consumers. There are problems in this, of a kind that only limited traders are involved in the operations, and this has led to cartelization. New players are not allowed in, and this has limited competition and worked to the disadvantage of the farmer. Now when the existing system is demolished, there is no clarity as to what and how soon a new system will be in place and function smoothly. A comparatively easier taxation system like the GST still seems to have teething problems even after three years of implementation. Laws alone will not help. The APMC model act was introduced in 2017-18, and the idea of contract farming was to get a fillip. The aim was to allow restriction-free trade of farm products, promote competition by encouraging multiple marketing channels, and promote farming through pre-agreed contracts. In reality, most states shied away from implementing several provisions of the reforms suggested in the model law. The present legislation seeks to facilitate barrier-free trade of agricultural products outside the markets, define a framework for contract farming, and impose stock limit option only if and when there is a sharp increase in retail prices. Exploitation of the farm sector has always been rampant. The Indian farmer, the true toiling class, has always been neglected and kept under subjugation. Not only in present modern day India but historically all past rulers have always made efforts to keep the farmer poor and impoverished. That has always suited the powers that be. It is not difficult to imagine where all these new legislations will take this country in the matter of food security. No one dares to speak up now as the money bags favor all sides of the political spectrum. The farmer is voiceless and therefore it is easy to trample him.

SILENCING OF VOICES

he contempt of court case against the Tamil actor Suriya was fortunately and wisely dropped by the Madras High Court. This, and the case of contempt against activist lawyer Prashant Bhushan, raise serious concerns about the judiciary's notions of its selfimage. One wonders if merely raising questions is now being seen as an offence.

Going by the investigation in the Delhi riots, there should be little doubt that the days of citizens' protest against a government policy are a thing of the past. The CAA-related protests emerged due to the selective nature of the Act which sought to provide citizenship to 'persecuted minorities' from the neighbouring countries. The relief was not provided to all neighbouring countries; it was not provided to all minorities either. Nearly a dozen tribal communities in Bangladesh - such as the Bru and the Chakma-are much smaller in numbers than the religious communities that received relief by the amended act. It was the selective nature of the CAA that was being questioned by the protesting groups.

The Delhi riots were an entirely different issue. But in the investigation by the Delhi Police, the two were put together and many young protesters were picked up under the charge of a 'conspiracy.' On the other hand, the leaders from the ruling dispensation who made inflammatory speeches were not even mentioned in the three chargesheets submitted to the court. It appears that the police department is working towards proving its theory of a large-scale conspiracy. The trend is worrisome for citizens who believe that the Constitution gives them the freedom for peaceful assembly and freedom of expression of their views.

What is even more worrisome is that the use of UAPA has become far too frequent. The latest disclosure by the National Investigation Agency is that the UAPA cases over the last few years were 922 (2016), 901 (2017) and 1182 (2018). These numbers are large for

the kind of the provisions that the UAPA contains. The UAPA, which stands for the Unlawful Activities (Prevention) Act, in its original form, had good intentions and good international conduct The United Nations, in response to the 9/11 (2001) attack by al-Qaeda, sensing the need to have legislative backing for the anti-terrorism drive initiated by the member states, had requested the community of nations in November 2001 to form suitable laws. After several related UN resolutions and particularly the UN Security Council Resolution 1822 of 2008, India amended its UAPA (in 2008)

A further amendment to it in 2019, passed through the Parliament in August, altered Section 35 of the UAPA and made it applicable to 'individuals' who could be categorised as terrorists, while in the past it was applied to 'organisations' alone.

The results of this 'reinterpretation' are before us. In April, Masrat Zahra, a 26-year-old photojournalist from J&K was booked under it. In Delhi, Meeran Haider and Safoora Zargar, students from

the Jamia Millia Islamia University, and Umar Khalid from JNU have been held using the provisions of UAPA. In Assam, the well-known RTI activist and human rights defender Akhil Gogoi has been in prison since December 2019. Several prominent intellectuals have been booked using the provisions of the draconian law by claiming that they had incited violence during a meeting held in Pune last year.

Among them have been Gautam Navalakha and Anand Teltumbde. Some weeks ago, Delhi University Professor Hany Babu Musaliyarveettil Tharayil was arrested under the same provisions of the UAPA. The Tamil Nadu CID arrested the cops, the Madurai Bench of the Madras High Court ordered a probe and the CBI was asked to take over the case. The victims killed had been late by half-an-hour in downing the shutters of their small shop. The police officers felt duty-bound to point out the violation of the corona-related business hour regulation. A great tragedy for all four--the killed and the killers-- and their families took place.

As it happened in the colonial nast with communities (now called the Denotified Tribes) that were perfectly innocent but were brought under the spectre of suspicion as 'being potentially criminal,' dissent is at present brought under labels like 'sedition' and 'terrorism'. Regimes, by the very nature of how they are constituted, will always find it convenient to use the law with a semantic twist. However, the Constitution, and the fundamental rights guaranteed by it are bound to get seriously corroded in the process. Governments are creatures of the Constitution. When they wilfully ignore the need to deepen the spirit of the Constitution, they display an insufficient understanding of the relationship between the people, the Constitution and their joint creature, the government.

Allowing the democratic space for dissent ultimately is at the heart of democracy.

He once sent some defence wing finance officials to Siachen Glacier, for them to have a taste of what's what, after he found they were sitting over proposals for sanction of snow boots for the troops. Antony was the longest serving defence minister. He served for eight years, a time when he gave priority to keep up his clean image, starkly, over the need for timely procurement of weapon systems and platforms. Between the 'irrational exuberance' of Fernandes and the self-righteousness of Antony, Pranab Mukheriee was like a savant who brought gravitas and grace to

N.Vittal, the then Central Vigilance Commissioner, met him and harped on the need to usher in transparency in procurement process vis-a-vis defence deals. This sowed the seeds of Defence Procurement Manual 2005 which coincided with my baptism into the MoD as financial adviser and as chairperson to complete this document in consultation with all the stakeholders.

Mukherjee ensured that a Defence Procurement Manual for revenue items and a Defence Procurement Procedure for long-term capital acquisition of weapon systems and platforms were put in place by August, 2005. There was a debate in the defence ministry whether such a manual should have a restricted use in the ministry, or be put up as part of the MoD website. Mukherjee overruled all the conservative mandarins and ensured that India's MoD is a perceived as a transparent defence buyer globally. He stood for transparency and cleared the cobwebs of sleaze that shrouded defence deals.

Mukherjee also put in place a new procedure called the 'Offset Procedure' in 2005, as per which when a country goes for a big ticket acquisition, it can ask the exporting

The other very important provision that was incorporated in Defence Procurement Procedure in 2006 was the Integrity Pact. Admiral Tahiliani (Retd. CNS) who was President of Transparency International, India chapter, brought to the notice of Mukherjee how India ranked very high in the corruption index. As per the Integrity Pact, which is widely practised globally, the purchaser and the buyer sign a commitment of 'no corruption'. Normally such a commitment is given only by the seller and not by the buyer.

We also included the 'Undue Influence clause', through which defence contracts can be cancelled if defence agents try to resort to venal methods to gain contracts. It is to the credit of Mukherjee that the MoD became the pioneer of having an Integrity Pact, which was adopted subsequently by the

Mukhe iee ensured that the exi gency of defence procurement does not cloud fair process, equal opportunity and criteria-based shortlisting and evaluation of vendors. This has been his most enduring contribution in his three years' stay in the defence ministry, before he left for the MEA in 2006.

Mukherjee has written in his memoirs how Indira Gandhi was not aware of the nuances of the Emergency provisions. In his last memoirs. Mukheriee has written of how Sonia Gandhi expected him to be deferential towards her after he became the President. He loathed the idea of being a Gandhi lackey.

In government for long years, Mukheriee recalled precedents with rare ease. Nehru was his hero, as he discovered the Parliamentarian in him; Indira was his most-loved leader as she catapulted him to the position of FM when he was young; and he was not comfortable with Rajiv Gandhi and the concept of dynastic politics. He ended up as a friend, philosopher and guide of Prime Minister Narendra Modi, who conferred on him the Bharat Rata. He was more than an archetypal Bhadralok.

Integrity was their mantra. We still have such judges around. It is time for the others to change for the better.

Sir, The UAPA has been invoked by the Delhi Police to arrest activists like JNU-fame Umar Khalid. They have been booked in a case relating to the anti-Citizenship Amendment Act protests and violence in Delhi in February. The Unlawful Activities (Prevention) Act is primarily an antiterror law aimed at "more effective prevention of certain unlawful activities." It was first promulgated in 1967 to target secessionist outfits. The last amendment in 2019 stipulated that even an individual can be designated as terrorist, while in the past only organisations could be so designated. In UAPA cases, the police custody can be extended to 30 days unlike in ordinary criminal cases where the custody is only for 15 days for initial interrogations. While UAPA has relevance, the government is urged to ensure that its provisions are not misused.

TMC peddles 'soft Hindutva' to stop BJP's forward march

Kolkata, Sept 21: Faced with the prospect of a spirited challenge from the BJP in the assembly polls due next year; the TMC government in West Bengal has loosened its purse strings to extend help to Hindu priests, as it seeks to debunk accusations of minority appeasement.

The Mamata Banerjee government's move to grant Rs 1,000 monthly allowance and free housing to 8000 Brahmin priests is being seen by many as an attempt to shed its pro-Muslim image.

Banerjee, who has repeatedly been accused of "minority appeasement" by the BJP, had shown her government's benevolence towards the minority community, extending monetary benefits to the Muslim clergy.

The Imams of Mosques and Muzzeins, who call the devout Muslims for prayer, get a monthly allowance of Rs 2,500 and Rs 1,500 every month. The arrangement was made in 2012, a year after Banerjee stormed to power defeating the Left Front with the solid backing of Muslims, who constitute around 30 per cent of the state's population. On interrogating the six arrested from Murshidabad Saturday, the NIA sleuths have unearthed the identities of two persons from Malda working in tandem with them, he said.

"There are more members spread in other districts of West Bengal as well as other states having links to al-Qaeda. In fact, the two from Malda were present at a meeting at the Murshidabad house Thursday night. They had left the place early Friday morning and the six were arrested by the NIA Saturday.

"The two are now on the run and a search for them has started," the



official told PTI Monday.

According to the NIA sources out of the six arrested, two are students having close links to some persons in Kashmir.

A few SIM cards which were seized from their possession, the laptop and the mobile phones used by these two students, revealed their link to "unknown" persons in Kashmir.

"One of the two is a second year undergraduate student of comcommunicating apps were also used. We are questioning them," he said. The NIA sleuths Sunday night conducted a raid at the house of Abu Sufiyan, one of the six arrested from Murshidabad, and questioned his family members, the officer said.

They seized electrical circuits and other devices from a concretebunker found inside Sufiyan's residence, he added.

The NIA had Saturday arrested nine terrorists associated with a Pakistan-sponsored module of al-Qaeda, the transnational terror outfit, after conducting simultaneous raids at several locations in Kerala and West Bengal.

The raids were conducted Saturday at Ernakulam in Kerala and Murshidabad in West Bengal.

The NIA has learnt about an inter-state module of al-Qaeda operatives at various locations in India, including West Bengal and Kerala.

Kolkata, Sept 21: With just about a month to go for Durga puja - the biggest annual extravaganza in West Bengal - preparations have begun across the city, albeit at a lower scale this time, as organisers chalk out safety plans to avoid further spread of COVID-19.

Samajsebi Sangha in south Kolkata, known for its thought-provoking marquee themes every year, has decided to change its open-air pandal's direction towards Southern Avenue to enable people catch a glimpse of the deity from a distance without having to alight from their vehicles.

"There will be a canopy on top to guard the 10-foot-high deity, but all three sides of the pandal will remain open. Medical personnel would be stationed next to the marquee with emergency kit and equipment. Volunteers won't allow people to crowd at the pandal entrance. This year, things ought to be different... We have curtailed our budget from Rs 60 lakh to Rs 15 lakh. The amount saved will be distributed among 75 underprivileged families from Sunderbans," Arijit Moitra, the secretary of the puja association, said.



At Md Ali Park, another big-ticket puja, organisers are planning to give pomp and show a miss this year, while "sticking to the basics."

"Lights will be fewer, and the pandal smaller. The height of the deity would not exceed eight feet," Ashok Ojha, the joint secretary of the puja committee, said.

Preparations are also underway at

Bhawanipore 75 Pally, another crowd-puller in South Kolkata, with labourers there made to undergo the COVID-19 test before starting work. "We will have a sanitiser tunnel and proper measures in place to ensure revellers maintain physical distance. The road leading to the pandal won't have barricades on its two sides," Subir Das, an office-bearer of

Bhawanipore 75 Pally committee, said. Tridhara Sammilani, patronised by Kolkata Municipal Corporation official Debashis Kumar, however, is yet to devise its puja plan. Organisers said they were in two minds about going ahead with this year's festivities.

Artisans at Kumartuli, a traditional potters' quarter in north Kolkata, said business was not usual for them, as most puja committees have slashed their budgets this time.

Kanchi Paul, one of the artisans, said that he received 30 per cent less bookings compared to last year. "Almost all top puja organisers have placed orders for eight- or 10-foot-tall idols, at least 5 feet less than what has usually been the norm for them. This is the new normal. We have to adapt to the changing circumstances," he added.

Maha's plan to 'ration' oxygen attracts flak

Mumbai, Sep 21: In a bizarre move, the Maharashtra government has abruptly decided to 'ration' medical oxygen for patients in Covid-19 public and private hospital wards/ICUs, kicking up a row between the state and the medical fraternity.

Doctors in the state have condemned the move as "unprecedented in the world", "terrible, horrible, abominable", something that could lead to "a sharp spike in Covid fatalities", with a veiled warning that they may be forced to abdicate the responsibility of treating Corona patients and "it will be better if the government runs all the private hospitals on its own".

As per a September 18 circular issued by Principal Secretary (Health) Pradeep Vyas, the order was triggered by a very high consumption of Oxygen -- more than thrice the national average -- in comparison to the number of patients in Covid oxygen wards or

intensive care units. Vyas said that the present consumption of medical oxygen is above 600 tonne per day and at the rapid rate of growth, there are fears



that this may outstrip the manufacturing capacity in the state after a few days. "The Government of India has expressed serious concern about the quantum of oxygen being used in Maharashtra per day considering the number of patients who are on oxygen," Vyas said grimly. Adding to the woes is the fact that a figure of around 1,08,000 patients -- who have been discharged

-- has not been updated on the government records owing to a discrepancy in manual tabulation. This implies that a lesser number of discharges and lower recovery rate is shown for Maharashtra, but if this figure was accounted for, then it would point to nearly 15 per cent of all patients getting oxygen treatment in the state - much higher than the national average of 5-6 per cent, he pointed out.

"So, it is clear that there is no judicious use of oxygen," said Vyas' unexpected rap, adding there was a tendency in private hospitals to put patients on oxygen for duration more than necessary for 'commercial reasons' and such activities need to be scrupulously monitored.

Clamping down on hospitals, the government has now ordered that oxygen consumption in wards must be limited to 7 litres per minutes and 12 litres per minute in ICUs.

All hospitals have been directed to comply with these restrictions by conducting a consumption to prevent wastage of medical oxygen due to leaks, etc. Maharashtra Indian Medical Association (IMA) President Avinash Bhondwe minced no words by terming the order as "the biggest and most cruel assault" by the administration at the expense of a patient's life.

"This is another direct battering on the professional autonomy of clinicians, an unwarranted questioning on the clinical acumen of doctors. It's an attempt to cover up bad governance of supply of oxygen by such an unprofessional and unethical notification," Bhondve said.

He said that there are some patients who would need 20 litres/minute and some even upto 80 litres/minute, known as high flow nasal oxygen (HFNO) and keeping such limits of 7-12 litres was "ab solutely absurd", and the move was taken without even consulting the Covid Special Task Force set up by Chief Minister Uddhav Thackeray.

Oppn slams govt over suspension of 8 MPs

New Delhi, Sept 21: Opposition parties hit out at the government Monday over the suspension of eight Rajya Sabha MPs.

The eight members -- distributed among the Congress, CPI (M), Trinamool Congress and the AAP -- were suspended earlier in the day for the remainder of the Monsoon Session over their "unruly behaviour" during the passage of farm Bills in the Upper House of Parliament.

Carrying pillows and blankets at the protest site, the MPs said "we will not budge"

"Suspension won't silence us. We will stand with farmers in their fight. The (Rajya Sabha) Deputy chairman throttled parliamentary procedures yesterday," said CPI(M) MP Elamaram Kareem, who is among those suspended.

Suspension of MPs exposed the coward face of the BJP. People will see through the attempt to divert attention from their undemocratic actions," he said.

Said AAP MP Sanjay Singh, "Wake up crores of farmers of

the country! The BJP government has mortgaged your life to Adani-Ambani, wake up and oppose this black law. We are on an agitation in Parliament. you should agitate outside. The BJP government has passed a black law against farmers. We were terminated for opposing the bill." "That is why we are sitting on a dharna and will keep sitting till the BJP government explains why this black law was passed by strangling democracy," he added.

CPI(M) general secretary Sitaram Yechury too slammed the government and termed the process of passing these Bills a violation of parliamentary"

democracy' "This violation of all parliamentary procedures and denying MPs the right to discuss and opine on the legislation is undermining the basic fabric of Indian parliamentary democracy. The Modi government will not be allowed to wreck the Parliament. These new laws are illegitimate, illegal and the President of India must send back these legislations to the Rajya Sabha for reconsideration under Article 111 of the Indian Constitution," he tweeted.

Though she recovered from the virus and tested negative a week ago, her son did not go to the hospital to bring her home.

As her son, said to be working as an assistant engineer in the electricity department, did not respond to phone calls, the hospital authorities dropped the woman outside her house. However, her

son refused to allow her into the house.

With the old age home also shut due to Covid pandemic and nowhere to go, the woman sat in front of the door. Showing no concern, the man locked the house from outside and left with his wife and children.

Seeing her plight, some neighbours gave her food and drinking water. However, the woman is suffering severe inconvenience due

to incessant rains and the cold. After learning about Balamani's misery, senior civil judge Kiranmayi Monday visited the house and called on her. She assured her all help.

In May, an 80-year-old woman was not allowed into the house by her sons out of Covid fear as she returned from Maharashtra. The incident had occurred in the Karimnagar town. The woman who had gone to Sholapur to meet her relatives was stranded there due to lockdown and returned only after relaxations in the lockdown norms. Though she was healthy and was not infected by Covid, her elder son and his wife did not allow her into the house. The woman's younger son too

had locked his house and gone away out of fear of the virus. Her elder son finally relented at the intervention of police and the local authorities.

Pandemic, LAC tensions cast shadow on Ladakh tourism industry

Leh, Sept 20: The hotels are unoccupied, the taxies unhired and the markets bereft of their usual hustle bustle. Ladakh is missing its guests

As people step out of the Leh airport, Cherring Namgyal (32) waits for tourists he can ferry in his taxi to different exotic locations in Ladakh. But that's a futile wait. Those coming are either locals or people on official work. "The coronavirus has hit us hard and there are barely any tourists this season. The tourist season is coming to an end. To add to it, people are apprehensive about the ongoing tensions on the border,"

as across the globe has been hit hard by the coronavirus pandemic, but the impact is felt harder in Ladakh because the tourism window here is squeezed to just a few months -- mostly from April to mid-October - due to harsh winters.

"There has hardly been any business this year. There are simply no tourists due to coronavirus pandemic and lockdown," Noordin, the vice-president of the Ladakh Taxi Operator Cooperative Ltd who goes by his first name, said. "Many taxi drivers are without

work this year," he said. "This year, some of the taxis have been hired by the Army." The current tension with China at the Line of Actual Control (LAC) too has impacted tourism in a way, he added.



"Many tourists want to go to Pangong Tso. But routes to some places have been shut because of the ongoing tensions," he said. The Pangong Tso lake is one of the places in Ladakh where there is a built-up of troops on both sides.

Ladakh nearly has 4,000 private taxies, Noordin said. Ladakh still has much more to offer beyond the regular tourist spots such as the Pangong Tso lake, he said.

Ghulam Mohiuddin, the owner of Hotel Grand Dragon, a starred hotel in Leh, said the room occupancy is very low this season. "The start of the tourist season coincided with the commencement of the pandemic. So there were no tourists this year and the room occupancy was also very low," Mohiuddin said, adding the economy of Ladakh largely depends on tourism.

"After the lockdown eased, there were tensions on the border. Actually, there is nothing to fear, but people are hesitant largely because of the pandemic and also due to the tension," Mohiuddin added.

The main market in the Leh city depicts the tale of how tourism has been hit this year. Sparsely crowded, many shops did not open this year. "Many Kashmiri businessmen rented shops in the market. But due to the fear of contracting the coronavirus, they have not come back," said a garments shopkeeper.

Riyaz Ahmed (70), the president of the main market in the Leh city, said there has hardly been any business this year. Ahmed, who has seen the region changing, said the tourism industry took an upswing after the '3 Idiots' Bollywood movie starring Aamir Khan.

"All wanted to go to Pangong Tso Lake. There are many such beautiful places across the Ladakh region, but tourists have not come here at all," Ahmed said. He said unlike the rest of the country, tourists visit Ladakh mostly from April to mid-October. After-October the temperature drops to sub-zero levels.

India's recovery rate crosses 80% mark, highest worldwide

New Delhi, Sept 21: India's recovery rate of COVID-19 cases has crossed the 80 per cent mark with over 90,000 recoveries recorded for the third consecutive day, the Union Health Ministry said Monday.

In a statement, the ministry said 93,356 patients were discharged in the last 24 hours. "India has crossed the significant landmark of more than 80 per cent national recovery rate. On a continuous stretch of high recoveries, India has also reported more than 90,000 recoveries for the third day in succession,' the ministry said in the statement.

FIGHT AGAINST PANDEMIC

Twelve states and UTs have registered recovery rate of more than the national average and 79 per cent of the new recovered cases are from 10 states and UTs. "The total recovered cases are close to 44 lakh (43,96,399) today. India tops the global figure of total recoveries. It accounts for more than 19 per cent of the world total," it said. India's COVID-19 tally reached 54.88 lakh with 86,961 people b eing infected in the past 24 hours, while 43,96,399 people have recuperated so far pushing the national recovery rate to 80.12 per cent Sunday, according to the Union Health Ministry data

Phase 3 human trial of **Oxford vaccine begins**

The phase-III human clinical trial of the COVID-19 vaccine being developed by Oxford University, and manufactured by the Serum Institute of India (SII), began at the state-run Sassoon General Hospital here in Maharashtra Monday, a senior official said. "We have started the phase-III trials of the vaccine (candidate Covishield). We will administer dose to 150 to 200 volunteers," said Dr Muralidhar Tambe, Dean, Sassoon General Hospital, Under phase-II, trials had been conducted at the Bharti Vidvapeeth Medical College and also KEM Hospital in the city.

78% of people using clout to get ICU beds: Survey

New Delhi, Sept 2: Only four per cent patients were able to get a COVID-19 ICU bed through the routine process, while 78 per cent had to use connections and clout, a survey revealed Monday

The number of COVID-19 cases in India has mounted to 54 lakh and the country has been recording on average over 90,000 cases daily for the last two weeks. Hospitals now are seeing more critical patients than they did in May-June this year. With the rise in critical cases, the availability of the Intensive Care Unit (ICU) beds has drastically reduced. After receiving many complaints from citizens from across the country about their family

These respondents were taken out of the sample to only analyse experiences of citizens who had someone in their network needing a COVID-19 bed.

When this sample was analysed, 38 per cent respondents said they had to use clout to secure an ICU bed while seven per cent said they had to follow up extensively to secure the ICU bed. 40 per cent said they had to use their connections, follow up extensively. They also had to esca-

late via social media or complain to the government to secure the ICU bed. Seven per cent said they had to bribe (cash or kind) hospital or government officials to secure the ICU bed, while only four per cent said they got the ICU bed without any of the above.

Another four per cent said they did not get an ICU bed at all. In Delhi for instance, patients complained that the Delhi government's app, Delhi Corona, shows ICU beds available in some hospitals, however, when they call that hospital, they are told that the bed is not available. The Delhi government also recently asked 33 big private hospitals in the state to reserve 80 per cent of their total ICU beds for the COVID-19 patients.

Artisans stare at penury as no buyers for Ravana effigies

New Delhi, Sept 21: With the festival of Dussehra still around a month away, artisans who earn their livelihood by making effigies of demon king Ravana, his brother Kumbhkarana, son Meghnada and others are staring at a bleak future as there are no buyers this time for their artefacts in the largest effigy market in Titarpur in Delhi.

Disappointment is writ large on the faces of both aritsans and traders in the Titarpur market adjacent to Tagore Garden as buyers are few and far between, amid the uncertainties due to the coronavirus pandemic. In normal times, one could see

scores of artisans busy making effigies of the demon king and others many weeks ahead of Dussehra year after year. The craftsmen could be seen toiling in the sun to give shapes to the effigies of different sizes and colours on the roadsides, parks, and even terraces of houses in Titarpur. But such scenes have vanished this year amid the pandemic.

Traders rued that the pandemic played a spoilsport for their brisk business expectations this year since the sale was also lukewarm the previous year due to the ban on firecrackers at many places. As a result, the traders had suffered heavy losses. After Prime Minister Narendra Modi performed the 'bhoomi pujan' of the new Ram temple at Ayodhya in Uttar Pradesh, effigy traders were hopeful that people will celebrate Dussehra this year on -(a grand scale. But traders fear this is unlikely to happen in 2020.

The UK already has the biggest official COVID-19 death toll in Europe - and the fifth largest in the world - while it is borrowing record amounts in an attempt to pump emergency money through the damaged economy. But new COVID-19 cases are rising by at least 6,000 per day in Britain, according to week-old data, hospital admissions are doubling every eight days, and the testing system is buckling. "The trend in the UK is heading in the wrong direction and we are at a critical point in the pandemic," Chris Whitty, the government's chief medical officer, will say at a briefing at 1000 GMT Monday. Johnson is due to speak Tuesday.

Addressing the UN General Assembly ceremony, marking the world body's 75th anniversary, Guterres said the coronavirus pandemic has laid bare the world's fragilities.

"We can only address them together. Today we have a surplus of multilateral challenges and a deficit of multilateral solutions," he said. The special commemoration of

the landmark 75 years of the world organisation will be largely virtual as world leaders did not travel to New York due to the COVID-19 pandemic raging across the world and that has in over six months infected more than 30 million people and will soon reach a grim milestone of over a million deaths.

The special UNGA event to mark the 75th anniversary of the UN kick-starts the high-level General Assembly session.

For the week-long General Debate, Heads of State and Government and Ministers will deliver their speeches through pre-recorded video statements, a first in the 75-year history of the world organisation. On this occasion, the 193 UN Member States adopted by consensus a political Declaration commemorating the 75th anniversary of the United Nations.

Looking back, Guterres said the world has seen historic accomplishments including peace treaties and peacekeeping, decolonisation, human rights standards – and mechanisms to uphold them, triumph over apartheid, eradication of diseases, steady reduction of hunger and landmark agreements to protect the environment and the planet - most recently, unanimous agreement on the Sustainable Development Goals and the Paris Agreement on Climate Change provide an inspiring vision for the 21st Century.

Nepal death toll mounts

Kathmandu: Nepal Monday recorded its highest single day death toll due to COVID-19 at 16, taking the total number of fatalities in the country to 427. With 1,154 fresh coronavirus cases recorded in various parts of the country in the past 24 hours, Nepal's coronavirus tally has increased to 65,276, according to the Health Ministry. Of the 16 deaths, 5 were from Kathmandu valley, the Health Ministry stated, adding that in the past 24 hours, 9,533 polymerase chain reaction (PCR) tests were conducted.

Pfizer could win vaccine approval

Washington: US President Donald Trump on Monday suggested Pfizer Inc could secure the first US approval of a COVID-19 vaccine in coming weeks, saying a contender by Johnson & Johnson could come later. Asked which drugmaker could be approved, Trump told Fox News in an interview: "Pfizer's doing really well," adding "Johnson & Johnson...they'll probably be a little later." He also cited efforts by Moderna Inc and AstraZeneca Plc.

nuclear agency said Monday that the landmark 2015 deal between Tehran and world powers on his country's atomic program is struggling since the unilateral US withdrawal, but is still worth preserving.

Salehi, speaking in a video address, said it's of the "utmost importance" that those countries find a solution to resolve "the difficulties caused by the illegal withdrawal of the US from the deal.'

"There is still a broad agreement among the international community that the JCPOA should be preserved," he said.

Speaking after Salehi, US Energy Secretary Dan Brouillette made no reference to the deal, saying only that the "United States remains committed to addressing the threats posed by the nuclear programs of both North Korea and Iran.'

"On top of its horrific record as the world's largest state sponsor of terrorism, Iran has a lamentable history of providing only grudging, dilatory, and incomplete cooperation, if at all, with the IAEA. Iran must do more, much more, to ensure both timely and complete compliance with the safeguards obligations," he said.

Singapore, Sept 21: Singapore has developed a robot that carries out nasal swabbing to diagnose COVID-19, in a bid to reduce healthcare workers' risk of exposure to the deadly coronavirus.

Clinicians from the National Cancer Centre Singapore (NCCS) and Singapore General Hospital (SGH) have partnered with Biobot Surgical, a firm specialising in medical robotics technology, to develop the SwabBot, reported a statebased channel.

The self-administered robot, that automates the taking of COVID-19 swab tests, will help reduce healthcare workers' risk of exposure to the coronavirus, it said.

The robot helps address the limitations of manual COVID-19 swab tests by reducing the need for trained

tered" robot, meaning patients can activate and terminate the process at will. When a patient is ready, they can use their chin to activate the robot and start the swabbing process

The robot then extends the swab

through the nose to the back of the nasal cavity, which is typically about 10cm from the nostrils.

"Even after many swabs, it retains the same gentle touch and precision as surgeons who perform very delicate procedures," said Dr Luke Tay, a consultant with the Department of Vascular Surgery at SGH

"Furthermore, the sample quality remains consistent even though nose structures can vary in size and shapes," said Dr Tay.

Meanwhile, Singapore recorded 31 new COVID-19 cases on Monday, including nine imported infections, taking the country's caseload to 57,607, the Ministry of Health said in its daily preliminary report.

All imported cases had been placed on stay-home notice (SHN) upon their arrival in Singapore, it said, adding that rest of the cases

were migrant workers living in dormitories while there was no case from the community.

The four imported cases, reported on Sunday, came from the Philippines, Iran and Germany between September 8-15. They have been put under a 14-day SHN.

The Sunday's sole case from the community, a foreigner on work permit, was detected during the rostered routine testing of workers in the construction, marine and process sectors who are staying outside the dormitories, and was picked up even though he was asymptomatic.

With 39 patients discharged from hospital on Sunday, 57,181 have fully recovered from the infection, said the health ministry.

Currently, 30 patients are in hospital and 338 at community facilities.

New Delhi, Sept 21: India's imports from China declined by 27.63% during April-August this fiscal to \$21.58 billion over the same period previous year, Parliament was informed Monday.

Value of imports from China stood at \$4.98 billion in August and \$5.58 in July, according to the data provided by Commerce and Industry Minister Piyush Goyal in his written reply to the Lok Sabha.

"India's imports from China have declined by 27.63% during April-August, 2020-21 over the corresponding period of the previous year," he said.

In a separate reply, the minister said there is no proposal under

consideration on withdrawal of Most Favoured Nation (MFN) status to China.

"No such proposal is under consideration at this time," he said while replying to a question whether the government is planning for the withdrawal of MFN status to China to reduce the export-import business with that country. Later in a media briefing, the

minister informed that the country's export is reviving. During the first half of

September, exports have recorded a growth of 10 per cent over the same period last year, he added.

Madrid had won 10 of their last 11 league matches last season to clinch their first title in three years. They are trying to lift back-to-back league trophies for the first time since 2007-08.
