sumers will now have to pay tariff at ₹2.70 per unit for the first 50 units, ₹4.50 per unit above 50 units and up to 200 units, ₹5.50 per unit above 200 and up to 400 units. The tariff has been fixed at ₹ 5.90 per unit above 400 units per month. The power tariffs remained unchanged during last two financial vears-2018-19 and 2019-20.

The OERC has also revised the BSP rate of power distribution companies (discoms) with effect from October 1. The Commission has allowed relia-

bility surcharge of 10 paise per unit for high transmission consumers availing power irrespective of nature of feeder. Similarly, the industrial consumers having 1MW or above line and drawing power in 33 KV will get a rebate of 10 paise per unit for the units consumed in excess of 70 per cent of the load factor. The rebate will be 20 paise, if the industrial consumer consumes more than 80 per cent of the load factor per month. Similarly, 2 per cent rebate will be given to all pre-paid con-

sumers while the rural domestic consumers will get 5 paise per unit in addition to all existing prompt payment rebate, the Commission said.

Meanwhile, Odisha Electricity Consumers' Association president Ramesh Satpathy demanded immediate rollback of the hike. "To safeguard the interests of GRIDCO and discoms, the Commission has put extra burden on the consumers, who are struggling for bread and butter due to the pandemic. We will take legal action," he stated.

Odisha now has 38,546 active coronavirus cases, while 1,53,213 people have been cured of the disease so far. As many as 53 COVID-19 patients have died due to other ailments so far. The state has so far tested over 29.05 lakh samples for COVID-19, including 45,321 Tuesday, the official added.

For 4 days, 2 bodies rot on roadside in Kendrapara village

Kendrapara, Sept 23: Bodies of a woman and her pregnant daughter, 'both murdered', had been lying on the roadside for the last four days at a remote village of Kendrapara. Their family had refused to cremate them, police said Wednesday.

Alleging police inaction, the family along with the locals had been protesting since Sunday at the Manapada village in Mahulia panchayat in the Rajnagar police station area. Pramila Nath (45) and her daughter Satyapriya (22) were reported missing September 19, Sub Divisional Police Officer (SDPO), Ranjan Kumar Dey said.

A day later, their bodies were found in a pond in the vicinity of the village, he said.

The post-mortem was conducted and the bodies were handed over to their relatives.

Satyapriya was found to be in an advanced stage of pregnancy during the autopsy, Dey added.

The villagers were alleging that both the women were murdered, but police are trying to cover up the matter.

A case of unnatural death under section-174 of the Criminal Procedure Code (CrPC) was registered after the post-mortem. Subsequently, a case of murder under section-302 IPC was alsoregistered and a suspect has been detained, the officer said.

Washington, Sept 23: With President Donald Trump poised to nominate a US Supreme Court justice to fill the vacancy created by the death of liberal icon Ruth Bader Ginsburg, a new 6-3 conservative majority could be emboldened to roll back abortion rights.

The ultimate objective for US Conservative activists for decades has been to overturn the landmark 1973 Roe v. Wade decision that legalised abortion nationwide. But short of that. there are other options the court has in curtailing abortion rights.

Republican-led states including Ohio, Georgia, Missouri, Arkansas and

Alabama have passed a variety of abortion restrictions in recent years. Some that seek to ban abortion at an early stage of pregnancy are still being litigated in lower courts and could reach the justices relatively soon

Abortion is one of the most divisive issues in the United States. Conservative opposition to it has been a driving force behind Republicans, including Trump, making a high priority of judicial appointments in recent years.

Trump has said he intends to an-

nounce his nomination Saturday, with Conservative appeals court judges Amy Coney Barrett and Barbara Lagoa considered the frontrunners to be named to succeed Ginsburg, who was a strong defender of abortion rights. Ginsburg died last week at age 87.

The leadership of the Republicancontrolled Senate is poised to move forward with the nomination even as Trump seeks re-election November

Even though the court had a 5-4 conservative majority before Ginsburg's death, some activists on the right were concerned about Chief Justice John Robert's incremental approach. Roberts angered Conservatives by siding with the court's liberals in June when the court ruled 5-4 to strike down a Louisiana abortion restriction in-

volving a requirement imposed on doctors who perform the procedure. Roberts, who wrote a separate opin-

ion explaining his views, signaled he may back other abortion restrictions in future cases but said he felt compelled to strike down Louisiana's law because the justices just four years earlier had invalidated a similar law in Texas.

Trump vowed during the 2016 Presidential campaign to appoint justices who would overturn Roe v. Wade. He already has appointed conservatives Neil Gorsuch and Brett Kavanaugh to the court. Both voted to uphold the Louisiana law.







Revenue Secretary recommends CB probe for fraudulently recording Lingaraj Mahaprabhu's land in favour of private individuals

Bhubaneswar, Sept 23: Expressing anguish over recording of Lingaraj temple land in favour of private individuals, Revenue and Disaster Management secretary Bishnupada Sethi Wednesday recommended Crime Branch probe into the case. In a letter to Khurda collector,

Sethi said that the land belonging to Lord Lingaraj has been incorrectly recorded on the name of three persons. Khata No 1935 of Village Bhimpur was recorded in



favour of Shree Lingaraj Mahaprabhu. Lingha Pradhan and Baja Pradhan were recorded as sub-tenants under the said Khata. However, in the RoR, the property

of Lord Lingaraj has been incorrectly recorded in favour of Lingha Pradhan, Ghana Pradhan, and Annapurna Bhoi.

Shree Lingaraj Mahaprabhu is a against the trust property under

Bhubaneswar, Sept 23: Doctors talked about management of COVID-19 for cancer patients during the daily home isolation interactive sessions conducted by the state government Wednesday.

Dr Surendranath Senapati, an oncologist from the Acharya Harihar Regional Cancer Centre (AHRCC). Cuttack, said, "In non-serious cases, chemotherapy among patients could be deferred for 7-10 days if a cancer patient suffers from COVID-19."

"Cancer patients who are undertaking chemotherapy and get infected, we can defer it. But in some serious cases, we can give low dose chemotherapy or we can treat them with hormone therapy or other forms of treatment. In many cases, we can shift the chemotherapy in young and non-serious patients during the in-

fective phase," he said. He also said that cancer patients are usually more vulnerable to COVID-19 due to their low immunity on account of the disease and undertaking of treatments like

chemotherapy. He, however, suggested that all patients who are taking chemotherapy



can continu from the D ment.

"Several cancer patients have stopped or temporary halted their cancer treatment. This can hamper their health and decrease their chances of getting better. I want to tell that all the District Headquarter Hospitals (DHH) have now several treatment facilities for the cancer patients which they can take during this time," he said.

Bhubaneswar, Sept 23: In a bid to bring consistency in sign boards, the Bhubaneswar Development Authority (BDA) notified recently that it will bring a uniform signage plan for heritage spots and business establish ments in Ekamra Kshetra to avoid any confusion

As per provision of the Odisha and Commercial Shops Establishments (Amendment) Act, 2018, name of a business establishment in the area would be written in Odia language and if required, it can be written in English as a supporting text.

However, presently, different types of signage have been installed in Ekamra Kshetra by various agencies including Bhubaneswar Municipal Corporation (BMC) leading to visual clutter and absence of proper interpretation creating confusion among visitors.

Observing this, the BDA in its Comprehensive Development Programme (CDP) 2030, had identified the need to develop guidelines for unified signage designs for special heritage zones. These zones under the CDP included that of Ekamra Kshetra heritage zone in Old Bhubaneswar,

Aitihashik Kshetra heritage zone (Sishupalgarh) and Sanskritik Kshetra heritage zone (Dhauli).

"As the Old Town or Ekamra Kshetra of Bhubaneswar is one of the most prominent abodes of Lord Shiva, the Heritage Signage Guideline will bring in a perfect sync with the past and the present as this area is the essence of the State Capital. Similar Guidelines will also be prepared for other special heritage zones identified under CDP 2030 which will bring

uniformity in information dissemination and improve the overall visitor experience," said BDA Vice Chairman, Prem Chandra Chaudhary. Furthermore, the notification mentioned that the colour, font, line spacing, paragraph style, arrows and icons, material and scale of all signs will be historically sensitive to the monument/building and the distinctiveness of the old town area. These signage guidelines will be adopted as part of the BDA (Planning

and Building standard) Regulations. As per the guidelines, six types of signages will be put up at heritage sites which will indicate directions, interpretation, orientation, facilities, business establishments and buildings. Moreover, these signages will be followed for all planning and design projects, building plan approval, building construction, addition, alteration, renovation, display boards, and others in the notified area.

Meanwhile, the BDA which had earlier notified Ekamra Kshetra as 'No Hoarding Zone' said that the guidelines will be strictly followed further. While the existing hoardings from all government and private spaces in the area would be removed, advertisement through painting on the walls will be disallowed within the heritage zone.

"We felt there is a greater need to develop guidelines for unified signage designs for special heritage zones as specified in CDP - 2030 due to heavy congregation of monuments in the Old Town and surrounding areas. Besides, there is a need for stronger bridge between tourism signage as per international standards and uniqueness of heritage resources existing within the city," said Suparna Surabhita Das, Assistant Town Planner of BDA.

No COVID test after death: Govt

Bhubaneswar, Sept 23: The state government has asked both staterun and private hospitals to avoid conducting coronavirus tests on the bodies of patients dying while undergoing treatment for non-COVID ailments, an official said Wednesday.

The directive was prompted by incidents of relatives and neighbours abstaining from funerals of people testing positive for the infection after their death, he said.

The Health and Family Welfare department, in a notification is sued Tuesday, asked the hospitals to avoid undue delay in releasing patients' bodies to prevent harassment of bereaved family members.

The department has also directed all hospitals treating COVID-19 patients to submit the death report along with the copy of bedhead tickets, investigation reports and coronavirus test status to the Director of Health Services, Odisha

OHRC breather for nCoV +ve injured youth

Bhubaneswar, Sept 23: The Odisha Human Rights Commission (OHRC), Wednesday, ordered a private hospital here to carry out surgery on an injured youth of the city who had been denied treatment for 12 days after he tested positive for COVID-19

The victim, Ranjit Nayak, 21, of Chandrasekharpur, was allegedly stabbed at his residence by his neighbours after a violent conflict over theft of a mobile phone September 8. The attack caused deep injuries in the lower part of his belly and he was bleeding profusely. Ranjit's parents went to Chandrasekharpur police station to lodge an FIR. However, the police suggested them to hospitalise the youth stating his condition serious and refused to file the FIR. But much to Ranjit's ordeal, the hospitals here – both private and public - denied him the treatment citing COVID regulations or paucity of medical infrastructure.



Raniit was admitted to emerward of AIIMS, gencv Bhubaneswar. In the meantime, Raniit's blood tests were conducted which eventually indicated him to be COVID positive. The hospital authorities allegedly denied surgery owing to 'not having operation theatre for COVID patients.' Ranjit's brother filed a petition in OHRC mentioning that his brother was taken from one hospital to another for treatment despite suffering from severe pain. The OHRC then stated that the patient cannot be denied surgery on the plea of COVID. The commission also asked the Health and Family Welfare department Secretary to probe the alleged medical negligence and submit a report during its next hearing October 15, 2020.

301 NEW CASES IN CAPITAL CITY

Bhubaneswar: As many as 301 new COVID-19 cases were detected under Bhubaneswar Municipal Corporation (BMC) limits in last 24 hours, BMC said Wednesday. While 83 of them are guarantine cases, remaining 218 are local contact ones. Meanwhile, 392 persons who earlier tested positive for the disease have recovered. According to a notification issued by the civic body, as of Wednesday, 19,544 persons have tested positive for COVID-19 in Bhubaneswar out of which 15,746 have recovered. While there are 3,711 active cases, 73 persons succumbed to the disease. Meanwhile, Odisha's COVID-19 caseload touched 1,92,548 with the detection of 4,237 new cases, while 15 more fatalities pushed its coronavirus death toll to 736. As many as 2,485 new cases were reported from quarantine centres, while 1,752 people tested positive for the infection during contact tracing. The state Tuesday tested 45,321 samples for COVID-19, taking the total number of tests conducted so far to 29.05 lakh.



The arrested persons were identified as Madhu Naik, Uttam Bhakta, Gajendra Katual, Galu Naik, Sudarshan Katual and Satrughan Katual. They had entered into the Similipal reserve forest area two days back. As they were attempting



to kill wild animals, forest personnel of the tiger reserve nabbed them near Charichhaka.

A case has been registered against them under relevant sections of the Wildlife Protection Act, Jena said. Horrible species we are

Then Indian elephants meet African elephants, they recognise that they are both elephants. So do Indian tigers meeting Siberian ones. But I have great difficulty recognising that I am of the same species as a person who attends a wild foods festival in New Zealand to drink shots of bull and horse semen taken fresh from animals that have had humans masturbate these animals.

I suppose that if you eat meat it makes very little difference whether you eat the head, the shoulders or the anus. But there seems something so savagely primitive and ugly about people being in celebration at "testicle festivals" held across America in which the testicles of turkey, pigs, bulls and lambs are fried and served.

In the Middle East, grilled testicles along with eyes are served to honoured guests. In New Zealand, they do one better: the young lambs on a farm are routinely castrated to make them fatter; and their testicles are cooked and eaten for lunch at the farm, in front of the animals. Rocky Mountain ovsters or prairie oysters are the name for the Canadian/American delicacy made from bulls' testicles. They are known as huevos de toro (bulls' eggs) in Latin America and Spain, "ox treasures" in China. In Greece, you call them "unmentionables". In Scotland, they eat the testicles of deer. In Syria baidghanam or sheep testicles are grilled in lemon juice and garnished in parsley. Bull fries are floured and breaded testicles prepared from the animals killed during bull-fighting.

Spaniards consider that eating the testicles of prized bulls is a great way to show their bravery and masculinity. Bulls testicles, pink with red veins running through them, called "Ngaupín" in Vietnamese (which means electric battery), are common in supermarkets all over the world. Most of these

testicles are from young animals whose private parts are simply sliced off without anaesthesia while they live in pain for another few months/years till they are killed.

Another great favourite is penises. Bull penis cooked with bananas is a traditional dish in Jamaica and is considered an aphrodisiac. Chinese and Korean eat them too to increase their own manliness. Chinese at the 2008 Summer Olympics munched on deer penises all the time. It reminds me of certain tribes in Africa which, several hundred years ago, used to eat parts of Christian missionaries in order to imbibe their 'goodness".

There is no medical evidence that eating penises has any health benefit but they are frozen,dried and sold as Pizzles in the US and eaten in diets that promote low cholesterol and high protein, minerals and hormones.

In China, the country that gave the world the Corona virus because of its filthy eating habits, there are restaurants that specialise in animal

penises and testicles. A restaurant called Guolizzhuang, started in 1956, states that eating the penis from the head goat of a Mongolian herd will make women more beautiful and men more vigorous. It advertises the genitals of "horses, oxen,chicken, donkeys,dogs, deer, goats, sheep, and snakes.

The dishes are given poetic names such as "The Essence of the Golden Buddha," "Phoenix Rising," "Jasmine Flowers with 1,000 Layers," "Look for the Treasure in the Desert Sand," "Head crowned with a Jade Bracelet," and "Dragon in the Flame of Desire."The restaurant also sells stewed deer faeces, sheep foetus and peacock claws. They sell a hotpot of all these different male genitalia in one dish in order to boost the human libido. After all, what could be more energising for a small thin Asian "man" than eat the penises of every other animal? If you need to celebrate your great manhood, you can eat tiger penises soaked in water with herbs. It is officially banned in China

along with Rhino horns but served openly. Seal penises are eaten in Canada and the Fur Institute of Canada announced in 2015 they were going to kill 1,40,000 grey seals to boost the seal penis market. These penises are also dried and sold as sexual enhancement products. They sell a beverage called Dalishen Oral Liquid to Asians, made from

The spectre of international isolation and supply disruptions now looms over China, spurring Xi to announce plans to hoard mammoth quantities of mineral resources and agricultural products.

But Xi's real miscalculation on the Himalayan border was vis-àvis India, which has now abandoned its appeasement policy toward China. Not surprisingly, China remains committed to the PLA's incursions, which it continues to portray as defensive actions. Late last month. Xi told senior officials to "solidify border



defences" and "ensure frontier security" in the Himalayan region. India, however, is ready to fight In June, after the PLA ambushed and killed Indian soldiers patrolling Ladakh'sGalwan Valley, a hand-to-hand confrontation led to the deaths of numerous Chinese troops-the first PLA troops killed in action outside United Nations peacekeeping operations in over four decades. Xi was so embar-

rassed by this outcome that, whereas India honored its 20 fallen as martyrs. China refuses to state the precise death toll. The truth is that, without the element of surprise, China is not

equipped to dominate India in a military confrontation. And India is making sure that it will not be caught off guard again. It has now matched Chinese military deployments along the Himalayan frontier and activated its entire logistics network to transport the supplies needed to sustain the troops and equipment through the coming harsh winter.

In another blow to China, Indian special forces recently occupied strategic mountain positions overlooking key Chinese deployments on the southern side of Pangong Lake. Unlike the PLA, which prefers to encroach on undefended border areas, Indian forces carried out their operations right under China's nose, in the midst of a major PLA buildup.

If that were not humiliating enough for China, India eagerly noted that the Special Frontier Force (SFF) that spearheaded the operation comprises Tibetan refugees. The Tibetan soldier who was killed by a landmine in the operation was honoured with a wellattended military funeral.

India's message was clear: China's claims to Tibet, which separated India and China until Mao Zedong's regime annexed it in 1951, are not nearly as strong as it pretends they are. Tibetans view China as a brutally repressive occupying power, and those eager to fight the occupiers flocked to the SFF, established after Mao's 1962 war with India.Here's the rub: China's claims to India's vast Himalayan borderlands are based on their alleged historical links to Tibet. If China is merely occupying Tibet, how can it claim sovereignty over those borderlands?

In any case, Xi's latest effort to gain control of territories that aren't China's to take has proven far more difficult to complete than it was to launch. As China's actions in the South China Sea demonstrate, Xi prefers asymmetrical or hybrid warfare, which combines conventional and irregular tactics with psychological and media manipulation, disinformation, law-fare, and coercive diplomacy

But while Xi managed to change

China might have the world's largest active-duty military force, but India's is also massive. More important, India's battle-hardened forces have experience in low-intensity conflicts at high altitudes; the PLA, by contrast, has had no combat experience since its disastrous 1979 invasion of Vietnam. Given this, a Sino-Indian war in the Himalayas would probably end in a stalemate, with both sides suffering heavy losses.

Xi seems to be hoping that he can simply wear India down. At a time when the Indian economy has reg istered its worst-ever contraction due to the still-escalating Covid-19 crisis, Xi has forced India to divert an increasing share of resources to national defence. Meanwhile, ceasefire violations by Pakistan, China's close ally, have increased to a record high, raising the spectre of a two-front war for India. As some Chinese military analysts have suggested, Xi could use America's preoccupation with its coming presidential election to carry out a quick, localized strike against India without seeking to start a war.

Tracklements

'his is a real word, a delightful one. It's not obsolete, but it's not widely known; it is used almost exclusively in Britain, and not especially often there. It refers to any kind of savoury condiment served with meat, such as rowan jelly. Someone said he first learned of the word when he bought a pot of mustard many years ago from the Tracklement Company, and in databases the word turns up most often in that firm's name. Even among cookery writers it seems to be an occasional relish to enliven prose. A rare sighting came from the Independent newspaper in February 1999: "In the best of Kosher kitchens, another delicious relish made from beetroot and horseradish (known as chrain) is the traditional tracklement to both boiled tongue and beef". The English cookery writer Dorothy Hartley claimed to have invented the word, which she used for the first time in her book Food in England in 1954. She said that she had borrowed it from an English dialect word meaning "appurtenances, impedimenta". The problem for those tracking down its antecedents is that the dialect word concerned is not easy to identify unambiguously.

griculture is the primary source of livelihood for over 60 per cent of the population. Farmers here suffer more in marketing their produces than in raising their crops or harvesting them season after season. Markets are not farmer-friendly. Will the new farm legislationhelpfarmers geta fair price for their produce? This remains to be seen.

Notably, India started facing severe shortages of food material during World War II. The Essential Commodities Act (ECA) was enacted in 1955 to regulate the production, supply and distribution in order to make food grains and cereals available to consumers at fair prices. The nation went through severe droughts in 1965-66, which led to import food grains. We overcame such grim situations by ushering in a Green Revolution under the guidance of agriculture scientist MS Swaminathan. By now, the Indian food and grocery market is the world's sixth largest. The nation produces 298 MT of foodgrains. India also has the largest livestock population -some 31 per cent of the world total.

While farming plays a vital role in India's economy, the irony is

that when there is a glut in production of vegetables and crops, there is a shortage of the same in the market. Prices shoot up due to severe supply shortages. Profiteers and black-marketers take advantage of the government's failure to intervene. Farmers switch to new crops due to hardships, uncertainties of pestilence and low yields. Bio-engineered seed varieties are susceptible to virus attacks. Indifferent weather conditions spoil their Rabi crops: but rain is good for Kharif crops.

India has the largest population of hungry people in the world even as there is abundant food production. India is among the 15 leading exporters of agricultural products. But there is a flipside to this great Indian agriculture story. Food grains are rotting in the warehouse. It's timeto accord priority to addressing the causes of food storage and problems in distribution. It's a huge paradox that Indian farmers are poor in a food-rich India.

The local administrations try to control or keep low the food prices to satisfy the urban population at the cost of farmers'interests. In the name of subsidies for fertilizers and free power, the gov-

ernments help well-off farmers instead of the ordinary ones who form some 80 per cent of the farming community. As Mahatma Gandhi said, India lives in its villages.All- weather roads still do not connect rural habitations with cities. Lack of cold storages and transport facility, inadequate postharvest safeguards, bias in procurement policy and inadequate food processing avenues have all resulted in huge waste of food.

TheAgricultural bills2020 promote intra/inter-state trade of farmers' produce beyond the physical premises of APMC (agricultural produce market committee)and MSP (minimum support price) andalso facilitateelectronic trading e-NAM (The Electronic National Agriculture Market). E-NAM was launched to create a unified national market for agricultural commodities by networking with the existing APMCs. It has 16.6million farmers and 131,000 traders registered on its platform whereinsome 1,000 mandis are already linked. The state governments are prohibited from levying any fee on farmers, traders, and e-trading platforms.

protect contract farming under a three-level dispute settlement mechanism. The new law stipulates that stock limit on agricultural produce must be linked to prices. Essential Commodities (Amendment) Act now allows regulating the supply of certain food items only under extraordinary circumstances. The government also allowed 100 per cent FDI in marketing for food products on Ecommerce platforms. The government says the reforms will help farmers get connected to big traders and exporters, thereby bringing them more of profits. Another promise is that the new law will rid farmers and the farm sector of middlemen and other bottlenecks. Yet, farmers have their apprehensions as to what fate awaited them.

Farmers in Punjab and Haryana are up in arms against the law, saying this would hit the functioning of APMC. Ironically, middlemenrun the show by buying farmers' produce in mandis/local bazar at prices even below the MSP, and take high commission. Poor farmers have no choice. Mumbai, Sept 23: Heavy rains lashed Mumbai overnight, leaving many parts of the metropolis in waist deep water and disrupting rail and road traffic Wednesday, officials said.

The Santacruz observatory recorded 286.4 mm rainfall during the 24-hour period ending at 8.30 am Wednesday, making it the fourth highest rainfall in Mumbai since 1974, an IMD official said.

At the municipal Nair Hospital in central Mumbai, the COVID-19

outpatient department (OPD) set up in a temporary shed in the compound was shifted to the casualty ward inside the building due to waterlogging in the compound, they said. A doctor from the hospital said the normal OPD at the hospital has been suspended temporarily and only emergency cases are being examined at the casualty ward.

Two watchmen died in Agripada area after getting stuck inside a lift in the basement of a high rise building because of waterlogging, a police official said.

There was also waterlogging in several areas in the suburbs like Goregaon, Malad and Dahisar, he said. "Around 6 inches high water logging at Andheri

Subway. However traffic has been resumed and police personnel from DN Nagar Police Station are on the spot to ensure convenient

commute for Mumbaikars,' Mumbai Police tweeted. Rains across the island city and the western suburbs picked up late Tuesday evening. There were intense spells across Mumbai overnight, a civic

official said. On Wednesday morning, public transport services were hit and normal life affected in the financial capital due to heavy downpour and waterlogging.

Several streets and low-lying areas were waterlogged due to overnight rains and the road traffic was also badly hit, a civic official said. Some vehicles broke down in the water, affecting the traffic movement, he added.

Mumbai's municipal commis sioner Iqbal Singh Chahal has asked that all offices and establishments in the city, barring essential services, be shut on Wednesday due to the downpour and IMD's forecast of heavy to very heavy rains" in the city.

A Brihanmumbai Municipal Corporation (BMC) release said Chahal has also appealed Mumbaikars not to step out of their homes, unless it is an emergency. Suburban train services of Central Railway and Western Railway were suspended but resumed later as the intensity of the downpour waned. Railways also cancelled or rescheduled many long-distance trains following the heavy rains.

There was waterlogging in Sion-Kurla and Chunabhatti-Kurla sections and traffic was suspended on CSMT-Thane and CSMT-Vashi sections for safety reasons, a CR official said.

Suburban trains, considered the lifeline of Mumbai, are being operated for essential services employees due to COVID-19 outbreak and common citizens are not authorised to travel in them as of now

Dalit farmer beheaded for not sharing water

Badaun (Uttar Pradesh), Sept 23: In a shocking incident, a Dalit farmer was beheaded in Uttar Pradesh because he refused to share water for irrigation with another farmer. The police have arrested the accused.

The incident took place in Badaun's Din Nagar Sheikhpur village where Nathu Lal Jatav was watering his field late Monday.

Another farmer, Roop Kishore, asked Jatav to divert water to his field but Jatav refused, saying that his field needed more water. Jatav was then beaten up and beheaded by the angry farmer.



Some locals tried to intervene, but fled when Roop Kishore attacked Jatav with a spade. The 56year-old farmer is reported to have slumped to his death.

Jatav's son, Ompal, told reporters that he and his father had been working in the field till late in the night.

'My father told me to go home and keep dinner for him. When he did not return home till the early hours of the morning, I went to the field. On the way, one of the locals told me that Roop Kishore had killed my father. I reached the spot and saw my father's beheaded body lying there," Ompal said.

Ompal further said that Roop Kishore alone could not have committed the crime and there were a few others with him

Superintendent of Police (SP) Siddharth Verma said that an FIR has been lodged against Roop Kishore on the basis of Ompal's complaint.

King Edward Memorial Hospital Dean Dr Hemant Deshmukh told

news agency Press Trust of India that the hospital has started screening volunteers for the trials. The medical facility will be conducting the trials on 100 volunteers, he said. The Mumbai-based BYL Nair Hospital, another facility run by the Brihanmumbai Municipal Corporation, has also received approval for conducting trials of the vaccine

Both the King Edward Memorial Hospital and BYL Nair Hospital will be conducting the trials collectively on over 200 volunteers, sources told news agency PTI. As part of the trials, volunteers who are found negative for coronavirus in both RT-PCR and antigen tests will be given the vaccine, they said. Trials of the Oxford vaccine can-

didate are being conducted in Pune as well.

The Pune-based Serum Institute of India (SII) has partnered with British-Swedish pharma company AstraZeneca for manufacturing the COVID-19 vaccine candidate, being developed by the University of Oxford, UK.

Film city euphoria fails to bring cheer to nCoV-hit Agra region

Agra, Sept 23: Amid the announcement by Uttar Pradesh Chief Minister Yogi Adityanath to set up the biggest film city in India in Greater Noida, that will have a ripple effect on the adjoining Braj mandal, the grim reality of Covid-19 infection spreading its tentacles in the region, has subdued the euphoria.

The local organisations of the artists, writers and culture-agents, including Mathura MP actor Hema Malini, have welcomed Yogi's announcement to set up a huge film city in the western part of the state. This will definitely be a big boost for promotion of local culture and open gates for employment to the local youth, said Surendra Sharma, president of the Braj Mandal Heritage Conservation Society.

The Agra Mayor Navin Jain has written a letter to the Chief Minister to congratulate him and also sug-



gest that a mini film city should also be opened in Agra.

However, the health scene remains grim. As daily testing has gone up in the past month, the number of people testing positive has also shown an upward trend. In the past 24 hours, Agra reported 127 fresh cases and one death. The tally now is 5,125, the number of discharged

The expectations are that from the first week of October; more people would start arriving from trains and flights to Agra.

But the health experts also warn that the winter would only aggravate the depressing health scenario.

Patna, Sept 23: A day after taking voluntary retirement, speculation is rife that Bihar's former Director General of Police (DGP) Gupteshwar Pandey may begin his political innings. Though nothing has been finalised yet, Pandey says he will talk to people and plan his journey ahead.

Pandey said that it was not necessary to join politics to serve the people. Pandey, who is active in social service, said after discussing with people, he will decide on the road ahead and then disclose his future plans.

Speaking to reporters Wednesday, he said he was under pressure from the people of many districts in Bihar, including Jehanabad, Begusarai, Valmiki Nagar and Bagaha to contest the forthcoming assembly elections. Thousands of supporters from several places in the state, were in touch with him, he added.

Pandey came into the limelight for his vocal comments after the death of late Bollywood actor Sushant Singh Rajput who was



born in Patna. After the Supreme Court endorsed the CBI investigation recommended by the Bihar government, Pandey had said that Rhea Chakraborty "does not have the aukat (stature)" to comment on the Chief Minister.

Following the VRS, Shiv Sena leader Sanjay Raut launched a sharp attack on Pandey, saying he had been carrying out a political agenda in the Sushant Singh Rajput investigation while holding the post of DGP Bihar. "IPS or IAS officers

We live in a democracy and it is his democratic right. The opinion of BJP or any other political parties is not required,' Anand said.

Pandey has praised Bihar Chief Minister Nitish Kumar. Responding to a question he said, "Nitish ji is verv strict in terms of administration and policing. He does not intervene in policing nor does he tolerate any outside interference in its functioning." Pandey, a 1987 batch IPS officer, took over as Bihar DGP last year. He was scheduled to retire in February 2021 but he took early retirement. Pandey, who has held the post of Superintendent of Police in several districts in Bihar, is renowned for his social work.

Cattle smuggling: CBI books ex-BSF officer

New Delhi, Sept 23: The CBI has booked a former Commandant of the 36 BSF Battalion and three others, including an alleged illegal cattle-trade kingpin, over rampant cattle smuggling on the India-Bangladesh border, officials said Wednesday.

The agency also carried out searches at 15 locations spread across Delhi; West Bengal's Kolkata, Siliguri and Murshidabad; Uttar Pradesh's Ghaziabad, Punjab's Amritsar and Chhattisgarh's Raipur, they said. The case has been registered against Satish Kumar, a former Commandant of the 36 BSF Battalion, alleged cattle smuggling kingpin Enamul Haque and two others - Anarul SK and Mohammed Golam Mustafa, the officials said. Kumar is now posted in Raipur, they said.

Haque was also arrested in March, 2018 by the CBI for allegedly bribing another BSF Commandant, Jibu T Mathew, who was arrested



at the Alappuzha railway station in January 2018 with ₹47 lakh cash.

The agency started digging into Haque's alleged illegal activities through a preliminary enquiry in April, 2018 to unearth his connections with other government officials who facilitated his nefarious business across the India-Bangladesh border.

During enquiry, it emerged that cattle smuggling was rampant along the border and is aided by some corrupt officers of the BSF and Customs who were receiving illegal gratification from the smugglers, the officials said.

The Border Security Force (BSF) is tasked with guarding the border with Bangladesh.

B.Tech student ends life

Agra, Sept 23: A 21-year-old B. Tech student in Agra has allegedly shot himself to death using his father's licensed revolver. However, no suicide note has been recovered.

According to the police, Shubhankar committed suicide on his terrace after locking the door of the staircase from outside. Shubhankar's mother Archana said that she was taking a walk, in front of her house, when she heard the gunshot. She ran towards the terrace and found the door locked.

She took help of her neighbour who jumped to her terrace and found Shubhankar lying in a pool of blood. They took him to S.N. Medical College emergency but doctors declared him brought dead.

Additional SP Saurabh Dixit said that the family members said that Shubhankar had stopped going out or meeting people. The family did not find anything amiss since the boy was preparing for competitive examinations. The ASP said that an FIR has been registered and the revolver license of the father could be cancelled since it was not kept safely and was accessed by his son.

"A high level of testing leads to early identification of positive cases. As evidence has revealed, eventually the positivity rate will fall. The national cumulative positivity rate is 8.52 per cent and tests per million stand at 48,028 today,'

"Duty Officers of police stations of New Delhi Railway Station, Old Delhi Railway Station,

and Hazarat Nizamuddin Railway Station were informed regarding the missing child and his photograph was shared with them on WhatsApp," said the police officer.

Since the boy went missing at around 8.45 p.m., the police tried to find the boy before he could cross the Delhi border. The BJP is enthused with the JDU coming back to the NDA. The importance of the Bihar elections for the BJP can be gauged from the fact that its National President J.P. Nadda has already reached Patna and is busy reviewing preparations for the polls.

The Left which contested the last elections alone is likely to join the Grand Alliance this time. There have been several rounds of talks between the Left and the RJD on contesting the elections together. RJD spokesperson Mrityunjay Tiwari

said the Opposition grand alliance should expand its outreach. Negotiations were on with many other parties, he added. Asked about the resentment over the seat-sharing formula, he said candidates who could guarantee a win were being selected.

The BJP's Bihar unit President Sanjay Jaiswal says the NDA has jumped into the poll fray with full force. The BJP-led NDA parties were contesting on the sole plank of development. In the last Bihar assembly elections, the JDU, the RJD and the Congress had contested together under the Grand Alliance and formed the government with absolute majority. Later, however the JDU broke away from the alliance and formed the government in Bihar by joining hands with the BJP.

Saudi bans flights to and from India

New Delhi, Sept 23: Saudi Arabia has banned flights to and from India from Tuesday amid a surge in coronavirus cases, according to an official document.

In a circular issued on Tuesday, Saudi Arabia's General Authority of Civil Aviation (GACA) said it was "suspending travel to and from the following countries: (India, Brazil and Argentina) including any person who has been in any of the mentioned countries above in the last 14 days prior to their arrival to the Kingdom". However, it excluded "passengers who have official government invitations".

The GACA circular -- titled: 'Suspension of travel to countries where the COVID-19 virus has outbreak' -- was marked to all the airlines and chartered flight companies operating at the Saudi Arabia's airports. Saudi Arabia and the UAE host a significant Indian migrant population.

Five days back, Air India Express had said the Dubai Civil Aviation Authority (DCAA) suspended its flights for 24 hours for bringing two passengers with COVID-positive certificates on August 28 and September 4. Dubai is the most populous city of the United Arab Emirates (UAE).

Navalny appears in public after leaving **Berlin hospital**

Berlin, Sept 23: Russian opposition leader Alexei Navalny has been released from a Berlin hospital after more than a month's treatment for poisoning, with doctors now believing that a "complete recovery" from the Sovietera nerve agent is possible for him, the hospital said Wednesday.

Navalny spent 32 days at Berlin's Charite hospital, 24 of them in intensive care, before doctors deemed his "condition had improved sufficiently for him to be discharged from acute inpatient care.'

As he was released Tuesday, the 44-year-old displayed his characteristic sarcastic sense of humor. In an Instagram post, he took swipe at Russian President Vladimir Putin, scoffing at reported comments by the Russian leader suggesting that Navalny might have intentionally poisoned himself. Navalny, a politician and corruption investigator who is Putin's most visible opponent, was flown to Germany two days after falling ill August 20 on a domestic flight in Russia. He spent those two days in a coma in a hospital in the Siberian city of Omsk, where Russian doctors said they found no trace of any poisoning.

German chemical weapons experts have determined that he was poisoned with the Soviet-era nerve agent Novichok — findings corroborated by labs in France and Sweden. The hospital said based on Navalny's progress, physicians believe that a "complete recovery is possible," but added it "remains too early to gauge the potential longterm effects of his severe poisoning. In recent days, Navalny has been posting regular photos of his convalescence from the hospital on Instagram, first showing him sitting

up in his bed surrounded by his family, then up and about in the building. In his post Tuesday night, he laughed off a report in the French newspaper Le Monde saying that Putin suggested to French President Emmanuel Macron in a call that he "could have taken the poison himself." "Good theory, I believe it deserves the most careful attention," Navalny wrote in Russian.

"Cooked Novichok in the kitchen. Took a sip from a flask on the plane. Fell into a coma." He wryly wrote that the "ultimate aim of my cunning plan" must have been to die in Siberia, where the cause of death would be "lived long enough." "But Putin outmaneuvered me. You can't fool him,' Navalny wrote. "As a result, I lay in coma for 18 days like a fool, but didn't get my way. The provocation failed!" Kremlin spokesman Dmitry Peskov Wednesday said the report about Putin's conversation with Macron was "inaccurate in its reported wording," but refused to elaborate as to which part was inaccurate.

San Francisco, Sept 23: After months of intensive talks with major advertisers. Facebook. YouTube and Twitter have agreed to adopt a common set of definitions for hate speech and other harmful content, the Global Alliance for Responsible Media (GARM) said Wednesday.

GARM is a cross-industry initiative founded and led by the World Federation of Advertisers (WFA) and supported by other trade bodies, including ANA, ISBA and the 4A's. The move comes after over 200 brands including Starbucks and Levis recently pulled their advertising from Facebook and the #StopHateforProfit campaign gained momentum after celebrities, like Kim Kardashian West, froze their social media account for a day.

As a result of the talks between the advertisers and key global platforms, four key areas for action have been identified, designed to boost consumer and advertiser safety.

"The issue of harmful content on-



line has become one of the challenges of our generation. As funders of the online ecosystem, advertisers have a critical role to play in driving positive change and we are pleased to have reached agreement with the platforms on an action plan and timeline in order to make the necessary improvements," WFA CEO Stephan Loerke said in a statement.

"A safer social media environment will provide huge benefits not just for advertisers and society but also to the platforms themselves,' Loerke said. WFA believes that the standards should be applicable to all media given the increased polarisation of content regardless of channel, not just the digital platforms. As such, it encourages members to apply the same adjacency criteria for all their media spend decisions irrespective of the media.

Malaysian oppn leader Anwar plans new govt

Kuala Lumpur, Sept 23: Malaysian opposition leader Anwar Ibrahim said Wednesday he has secured a majority in Parliament to form a new government that is "strong, stable and formidable." Anwar said he has been granted an audience with the king Tuesday but it was postponed because the king was in a hospital for treatment. He said he will not reveal details until after he has met the king.

"Conclusively, we have a strong, formidable majority. I am not talking about four, five or six ... but much more than that," Anwar said. "With a clear and indisputable support and majority behind me, the government led by ... Muhyiddin Yassin has fallen." There was no immediate response from Muhyiddin, who is due to give a televised speech later Wednesday. Muhyiddin has been grappling to maintain support amid infighting in his coalition that has just a slim two-seat majority. He can ask the

If he succeeds, it will mark a dramatic comeback for Anwar after his roller-coaster political journey since the 1990s.

Once a high flyer in the ruling party, Anwar was convicted of homosexual sodomy and corruption after a power struggle with Mahathir in 1998. He was imprisoned for a second time for sodomy in 2014. Anwar and his supporters have long denied the sodomy allegations, saying they were concocted to destroy his political career.

Yet rather than give up, Anwar ended his feud with Mahathir from his prison cell to forge a new opposition alliance that won a stunning victory in May 2018 national elections. Mahathir became premier a second time. Anwar was freed with a royal pardon days after the polls and was Mahathir's designated successor before their alliance fell apart.





mation of the Numaligarh Refinery Limited (NRL) storage terminal at Paradip. Union Minister of Shipping Mansukh Mandavyia has been encouraging ports for such beneficial reuse of dredge materials. This is a unique initiative being taken by Dredging Corporation of India with PPT & NRL.

NRL entered into a tripartite Memorandum of Understanding (MoU) involving Paradip Port Trust (PPT) and Dredging Corporation of India (DCI) for reclamation of the proposed 200 acres of land allotted to NRL for setting up its Crude Oil import terminal (COIT) at Paradip Port.



An MoU was signed to this effect Wednesday at Paradip amongst AK Mahapatra; Dy. Conservator PPT, CGM DCI- S Divakar and DGM (Projects Pipeline) NRL - AJ Phukan in presence of Rinkesh Roy, Chairman PPT, MD NRL, SK Barua & MD DCI, Rajesh Tripathi and other senior officials from all the three organisations.

The terminal is being set up as

part of NRL's integrated Refinery Expansion project that is being implemented at an estimated cost of more that ₹22,000 Crore. The mega project envisages amongst others. import of crude oil at Paradip Port and laying of pipeline to Numaligarh to transport the same. Project activities have gathered pace after receipt of Environmental Clearance in the month of July, 2020.

New Delhi, Sept 23: In a sign that Indians are now no more afraid of ordering food despite a surge in caseloads, Zomato Wednesday revealed that the food delivery sector has recovered to (and even grown beyond) pre-Covid levels in a number of large pockets of the country, led by some of the most affluent residential areas

Connaught Place bounced back to pre-Covid levels and some microlocalities within Central Delhi are at two times of pre-Covid levels, said Zomato.

The food delivery industry continues to grow back steadily to pre-Covid levels, with the overall sector clocking over 85% of pre-Covid

"With more premium restaurants, -- restaurants where a meal for two may cost ₹1,500 and above, now opening up to online delivery

ROHIT, BOWLERS LIFT M Kings XI all set for a Royal challenge

Abu Dhabi, Sept 23: Skipper Rohit Sharma (80, 54b, 3x4, 6x6) led from the front before his bowlers helped Mumbai Indians (MI) secure their first win this year in the IPL beating Kolkata Knight Riders (KKR) by 49 runs.

Jasprit Bumrah (2/32) was going brilliantly, with his figures reading 2/5 in three overs. However, he conceded 27 off his final over with Pat Cummins (33, 12b, 1x4, 4x6) clobbering him for four sixes off that over.

Chasing 196, KKR were never looked like troubling MI as they lost the openers - Shubman Gill (7) and Sunil Narine (9) – inside five overs with the scoreboard reading 25/2. Skipper Dinesh Karthik (30) and Nitish Rana (24) tried to make amends but couldn't negate a disciplined MI bowling attack, which eventually put a lot of pressure on Eoin Morgan (16) and Andre Russell (11).

A lot was expected from the duo, but the pressure got the better of them and both got out in Bumrah's third over. KKR were down to 101/6 inside 16 overs before eventually being restricted to 146/9 in their 20 overs.

Earlier, Rohit led from the front to guide MI to 195/5. After Shivam Mavi (2/32) removed opener Quinton De Kock (1) cheaply, Rohit and Survakumar Yaday (47, 28b, 6x4, 1x6) conjured 90 runs for the second wicket

Dubai: South Africa all-rounder Chris Morris is suffering from a side strain, the team's Director of Cricket Operations Mike Hesson said. Morris, who was bought for `10 crore by RCB in a bid to strengthen their weak death bowling department, had also missed the team's opener against Sunrisers Hyderabad. Gambhir lashes out at Dhoni

NEW DELHI: MS Dhoni did not lead from the front by dropping himself down the batting order during a mammoth chase, opined former India batsman Gautam Gambhir, tearing into CSK captain's decision to bat at No.7 against Rajasthan Royals.

Dhoni sent the likes of Sam Curran, Ruturaj Gaikwad and Kedar Jadhav ahead of him. CSK lost the match by 16 runs.

"I was a bit surprised to be honest. MS Dhoni batting at No.7? And sending (Ruturaj) Gaikwad, Sam Curran before him. Makes no sense to me. In fact you should be leading from the front," Gambhir told ESPNcricinfo's T20 Time Out.

"This is not what you call leading from the front. Batting at No.7 when you're chasing 217. The game was over. Faf was probably the lone warrior," he said.

"See, if someone else would have done this, some other (batsman) captain had batted at No.7, he would have got a lot of flak. It is MS Dhoni

- probably that's why people don't talk about it."

The 38-year-old Gambhir also questioned CSK's intent to win the game. "There is nothing wrong if you end up getting out early, at least start leading from the front, trying to inspire the team as well. What you did in the last over (hitting 3 sixes in last over), probably if you'd done that coming in at No.4 or 5, alongside Faf, you could have made a game out of it," said Gambhir.

"Probably there was no such intent to make a game out of it. I thought after the (first) six overs, they had literally given up on the game. And probably MS was trying to get back into that match rhythm of batting till the end and get some runs under his belt so he can actually play these kind of innings in the coming games.

"You've got to be in the present, try and win each game possible. I thought there was no intent to win the game and they were never there

Gambhir said it was 'absolute miscalculation' on the part of CSK to delay Dhoni's arrival at the crease. "Probably not the right captaincy as well. This is not how you ask someone like MS to lead the side.

U-17 WOMEN'S WORLD CUP INDIA 2021

New Delhi, Sept 23: The women's FIFA U-17 World Cup, which has been rescheduled to February-March, is likely to be postponed yet again in view of the COVID-19 pandemic.

Originally scheduled to be played in five venues of India, November 2-21, the women's age group showpiece was pushed to February 17-March 7 next year due to the pandemic, which has played havoc with sporting calendars worldwide.

With the health crisis still showing no signs of abating and with the qualifying tournaments yet to be held in Africa, North and Central America and South America, there is a high possibility of the tournament getting postponed yet again.

"There is a high possibility that the women's FIFA U-17 World Cup will be postponed again. The new time frame when the tournament will be held is yet not known. But most probably it is getting postponed," a source privy to the development told this agency on condition of anonymity.

All India Football Federation (AIFF) general secretary Kushal Das, however, told this agency that there is 'no official update' on the REUTERS

Nyon, Sept 23: For the first time in 10 years, Lionel Messi and Cristiano Ronaldo are missing from the short-list for the UEFA men's Player of the Year (POTY) award. Kevin De Bruyne and Robert

Lewandowski are leading the pack for the award, European football's governing body said Wednesday.

Lewandowski guided Bayern Munich to their sixth Champions League title, finishing as the competition's top scorer with 15 goals. The Polish striker netted 55 goals in 47 games in all competitions as Bayern won the treble.

City midfielder De Bruyne provided a record-equalling 20 assists in the Premier League last season, the highest in Europe.

Manchester City full back Lucy Bronze, Chelsea striker Pernille Harder and Olympique Lyonnais defender Wendie Renard were short-listed for the women's award.

New York, Sept 23: Serena

Williams' latest quest to make history begins when the curtain rises on the French Open at Roland Garros next week.

While a Grand Slam brings enormous pressure for all, the weight of expectation is greater on Williams than anyone else in her sport, with speculation renewed as to whether she can equal Australian Margaret Court's record 24 major titles.

With World No.1 and holder Ash Barty plus 2019 and 2020 US Open winners Bianca Andreescu and Naomi Osaka out of the tournament, the French Open could see plenty of surprises and a chance for Williams to pounce.

However, the ninth-ranked American, who has won at Roland Garros three times, most recently in 2015, also faces plenty of obstacles.

Her quest for 24 continues on clay – her least productive surface – where Romania's Italian Open winner Simona Halep, Spain's Garbine Muguruza and US Open semifinal foe Victoria Azarenka of



Belarus could all present a major challenge.

Williams must also make a quick switch from hard court to clay, after an Achilles injury kept her out of the Rome event.

She has come close to winning a 24th major on several occasions,
