Gridco fault led to ₹197cr loss: CAG

Bhubaneswar, Oct 6: A recent report by the Comptroller and Auditor General of India (CAG) on Economic Sector and PSUs for 2017-18 released Tuesday talked about a number of delayed and wrong decisions by state PSUs, leading to big losses to the exchequer.

The report claimed that out of 82 State Public Sector Undertakings (PSUs), 56 were operative comprising eight in power sector and 48 in non-power sector. The CAG report said the working PSUs registered a turnover of ₹25,124 crore during 2017-18. The report said total losses incurred by the eight power sector PSUs stood at ₹75.81 crore during this period. While five PSUs earned profit of Rs124.75 crore, two incurred losses of ₹200.56 crore. GRIDCO alone incurred a loss of ₹197.5 crore while the Odisha Coal and Power Limited saw ₹3.06 crore

loss "Failure by GRIDCO to enforce supply of infirm power from Jindal India Thermal Power Limited (JITPL) as per agreed terms resulted in loss of revenue worth ₹56.73 crore as the said infirm power was sold by JITPL outside

OS LIQUOR UNREGULATED

BHUBANESWAR: The Comptroller and Auditor General of India (CAG) report on the revenue sector of the state for 2017-18 claimed that the consumers of out still (OS) liquor pouches suffered due to the apathy of the excise department. The auditor said the state excise department failed to put Maximum Retail Prices (MRP) for such liquor pouches. "Maximum Retail Price (MRP) of OS liquor pouches sold was not fixed by the department. In the absence of MRP, consumers were impacted and left to the vagaries of OS liquor shops. Thus, the department allowed OS liquor sector to remain unregulated," the report said. It also said that the department failed to fully levy fines as prescribed leading to losses of ₹10.23 crore. "Excise duty and fine worth ₹10.23 crore was either not assessed and demanded or short-levied

the state," the CAG report said. It added that delay in re-phasing banks loans to marginal cost of funds-based lending rate also added an avoidable loss of ₹16.76 crore. About the non-power sector PSUs, the CAG said out of 48 working PSUs, 31 earned profit of ₹237.92

from licensees towards short lifting of Minimum Guaranteed Quantity of IMFL and beer," the report said.

It added that excise duty of ₹22.97 lakh was short-levied towards short lifting of country spirit against the Minimum Guaranteed Quantity fixed. The report said motor vehicle tax and additional tax of ₹26.74 crore and penalty of ₹53.48 crore was not realised from registered owners of 27,413 Goods Carriages and Contract Carriages. "The permit database of the state transport authority was not interlinked with regional transport authorities which resulted in short realisation of tax and penalty worth ₹16.62 lakh," the auditor said. The CAG report said non-inclusion of sizing charges in the run-of-mine price of coal during assessing of royalty resulted in

crore and 11 incurred a loss of ₹518.51 crore during the period.

'The loss-making PSUs included Odisha Mining Corporation Ltd (₹463.48 crore), Odisha Rural Housing and Development Corporation Ltd (Rs 42.93 crore) and Bhubaneswar Smart City



Ltd (Rs 9.06 crore)," the report said. Talking about the Odisha State Seeds Corporation Limited, the auditor report said it failed to fix its production target as per the Centre's Seed Rolling Plan. It was also accused of shortfall in production and distribution of certified seeds.

"As OSSC could not produce seeds within the state at lower cost, it procured 1.43 lakh quintals of seeds from outside agencies during 2013-18 with higher cost resulting in avoidable expenditure of Rs13.03 crore," the report said.

On the issue of economic sector, the CAG report hinted how the water resources department lost ₹33.22 crore due to execution of Gohira Irrigation Project without ensuring availability of water for the project.



Denied treatment, baby delivered on roadside, dies

Joda, Oct 6: In a shocking incident, a woman delivered a baby on roadside Monday near Mangala Temple in Joda of Keonjhar district. The baby died soon after delivery.

Earlier; the woman was allegedly denied medical care at Tata Hospital and referred back to a nearby government hospital. Worse, no ambulance service was arranged to shift her to the government hospital.

Sukamati Purty, wife of Kapilash Nayak of ITC Colony in Jalhari panchayat, was admitted to Joda government hospital at 2 pm Monday. As her condition was critical, she was referred to Tata Hospital where no treatment was provided to her except for a Covid test. She was referred back to a government hospital without arranging an ambulance.

Hathras incident horrible, says SC

New Delhi, Oct 6: Terming as "horrible" the Hathras incident, the Supreme Court Tuesday directed the Uttar Pradesh government to inform it by October 8 about the steps taken to protect witnesses in the case in which a Dalit girl was allegedly brutally raped and died due to injuries.

The apex court directed the Yogi Adityanath government to file an affidavit in this regard and also ascertain whether the victim's family has chosen a lawyer.

The apex court observation came while hearing a PIL during which the state government expressed willingness to refer the investigation to the CBI on the ground that fake narratives were being spread about the case with political motives.

A bench comprising Chief Justice SA Bobde and Justices AS Bopanna and V Ramasubramanian said it will ensure that the investigation is smooth in the case.

The top court also asked all parties appearing before it to give suggestions on the scope of proceedings before the Allahabad high court and how the apex court can make it more relevant.

Solicitor General Tushar Mehta, appearing for the UP government, said, "Narratives after narratives being spread in Hathras case, this this needs to be stopped." The CBI probe in Hathras case will ensure no vested interests will be able to create fake, false narrative with oblique motives, Mehta told the court. The state government told the top court that probe in Hathras case may be conducted by the CBI under the apex court's supervi-ernment is not opposing the plea for a fair probe by the CBI.

Stockholm, Oct 6: Three scientists won this year's Nobel Prize in physics Tuesday for advancing our understanding of black holes.

The Royal Swedish Academy of Sciences said that Briton Roger Penrose will receive half of this year's prize "for the discovery that black hole formation is a robust prediction of the general theory of relativity'

Goran K Hansson, the academy's secretary-general, said German Reinhard Genzel and American Andrea Ghez will receive the second half of the prize "for the discovery of a supermassive compact object at the center of our

galaxy. The prizes celebrate "one of the

Penrose proved with mathematics that the formation of black holes was possible, based heavily on Albert Einstein's general theorv of relativity. Genzel and Ghez looked at the dust-covered centre of our Milky Way galaxy where something strange was going on, several stars moving around something they couldn't see.

It was a black hole. Not just an ordinary black hole, but a supermassive black hole, 4 million times the mass of our sun. Now scientists know that all galaxies have supermassive black holes.

It is common for several scientists who worked in related fields to share the prize. Last year's prize went to Canadian-born cosmologist James Peebles for theoretical work about the early moments after the Big Bang, and Swiss astronomers Michel Mayor and Didier Queloz for discovering a planet outside







Bhubaneswar. Oct 6: A report of the Comptroller and Auditor General (CAG) of India, Tuesday, claimed that Odisha was able to achieve only 7 per cent of the targeted renewable energy production during 2017-18.

The CAG report on Compliance Audit for 2017-18 claimed that the projected capacity could not be achieved due to delay in land acquisition for the projects for 34 months (upto September 2018).

"In the Renewable Energy (RE) Policy of the state, it was targeted to add 2,750 mega watt (MW) RE capacity by 2022. Against this, RE capacity of the state stood at 195 MW at the end of 2018, which was 7.09 per cent of the target, it said.

"Both OPTCL and OHPC agreed to permit installation of solar plant only for 6.2 MW. GEDCOL had neither taken steps to establish solar plants in the agreed locations nor had initiated action to acquire land at other suitable locations. As such, Central grant of Rs 38.10 crore remained unutilised for last three years (July 2018)," the report said.

The report also indicated how Western Odisha Development Council (WODC) was of little help for irrigation of the region. "In contravention to their own decision, WODC has allocated only 11.80 per cent of total outlay to irrigation sector during 2015-18 whereas other projects which were not critical to the development of the region, received 38.90 per cent

of the total outlay," it said. It also added, "WODC had not iden-

FISCAL DEFICIT UN

BHUBANESWAR: The CAG report said that the state government had overstated its revenue surplus and understated fiscal deficit during 2018-19 fiscal. "The revenue surplus was overstated by Rs 1,494,89 crore and the fiscal deficit was understated by the same amount on account of net impact of excess contribution of the government towards New Pension System, non-credit of interest to deposits, non-credit of interest to State Disaster Response Fund, unrecouped balance of Odisha Contingency Fund.

"Labour Welfare Cess was not transferred to Welfare Board and Land Revenue Cess was not transferred to Panchavati Raj Institutions (PRIs). Effectively, the revenue surplus and fiscal deficit of the state in 2018-19 were Rs 12,695 crore and Rs 11,652 crore respectively," the report said. The report said total expenditure was good in many sectors except health.

There was, therefore, no assurance that the expenditure of Rs 19,371.21 crore had actually been incurred for the purposes for which it was authorised," the report said. The CAG report also talked about delay in submission of outstanding detailed contingent bills.

In a press statement, Arun Bothra, Chairman-cum-Managing Director, OSRTC said, "We are committed to provide good bus service to the citizens of Jeypore. This temporary closure of depot will not affect common people in any way. OSRTC will run the buses in the region as usual. For the time being, bus operations will be managed from Rayagada and Malkangiri depots. Both depots are fully equipped to handle additional requirement of people of Jeypore.'

The corporation has been facing serious financial crisis due to Covid-19 pandemic. Operations are down because very few people are using buses, he added.

Despite this situation, the OSRTC has been providing financial support to all its regular, contractual and daily wages employees.

Recently there have been alle gations of misappropriation of huge funds by the staff at Jeypore depot.

The OSRTC buses were engaged by the administration for movement of guest workers during the lockdown period. It was alleged that a large amount of the money given to driv ers by the District Collectors for fuel was misappropriated by them.

An enquiry found the allega tions to be true. OSRTC authorities had asked the defaulters to return the misappropriated money. However, instead of returning the money, a few of the employees created ruckus at the depot.

NGT PULLS UP JAJPUR ADMIN

A PROBE REPORT ON ILLEGAL SAND MINING IN KHARASROTA RIVERBANK HAS LEFT THE TRIBUNAL FUMING

Jajpur, Oct 6: The district administration was caught on wrong foot after the National Green Tribunal (NGT) directed it to conduct a fresh probe into the alleged illegal sand mining at a sand quarry in Kharasrota riverbank near Masudpur here, a report said.

The NGT expressed sharp resentment on the probe report submitted by the district administration as it has been conducted during rainy season. The tribunal instead asked the district administration to conduct a fresh probe in dry season and submit an actual report.

The order came following a petition (48/2020/EZ) filed before the tribunal by Pinak Ranjan Das of Masudpur village near the Kharasrota riverbank.

A bench of the tribunal comprising Justice SP Wangdi and expert member Dr Nagin Nanda heard the matter and passed the order October 5, Shankar Prasad Pani, advocate for the petitioner said.

Observers claimed that the NGT order has sparked fear among the government officials who had submitted a fake report before the tribunal to divert its attention away from the issue

The tribunal in its order said that the probe was conducted dur-

ing rainy season when sand extraction remains stopped. This apart, the authorities instead of taking action against the quarry owner for illegal sand mining left him only by collecting fine. Therefore, the NGT directed to conduct a fresh probe in dry season and take action against the owner of the illegal sand quarry. The next date of hearing is slated for December 24

Reports said that the tribunal had first passed an order for a probe into the charges of illegal sand mining at Masudpur sand ghat,

July 19, this year. Accordingly, a three-member team of the district administration comprising Pramod Kumar Behera, regional officer of state pollution control board (SPCB) in Kalinganagar, BK Sahu, assistant mines officer, Jajpur Road and Narayan Chandra Dhal, Jajpur subcollector conducted a probe and submitted its report before the NGT. The report mentioned that there

revenue officials are keeping a close watch and no equipment is being used for sand extraction, the report said.

The local residents have also denied presence of any illegal sand quarry in the area. Moreover, allegations like damage of the river embankment and bridge, soil erosion, revenue loss, environmental pollution were not found during the probe.

The report also stated that the local tehsildar raided an illegal sand quarry in the area twice May 25 and June 9 and collected penalties from the quarry owner Lakshmidhar Mohanty.

When contacted, SPCB regional officer Behera said that subsequent action will be taken as per the NGT order.

renovation work at the Utkela airstrip in this block in Kalahandi district has been undertaken under UDAN, the project has remained stuck halfway for various factors, a report said.

The airstrip was established in 1962 in Utkela panchayat of this block while the Central government started its renovation so as to operate commercial flights of 12 to 50 seat aircraft to Bhubaneswar, Vishakhapatnam, New Delhi, Raipur, Chennai, Mumbai and Kolkata. In 2016-17, the renovation of the airstrip was taken up with Rs3 crore sanctioned under UDAN. The PWD carried out various infrastructure works like expansion of its runway, boundary wall, drainage, signal room, control room, rest house, guest house and other ancillary works for the airstrip, which spreads over 28 acres.

All major works at the airstrip have been completed except works on the signal room, control room and rest houses. The runway of the airstrip is 918 metres long and 32 metres wide extending from east to west. It may be noted here that the



state Works department even wrote to the Union Civil Aviation Ministry requesting it to help in land acquisition for expanding the airstrip in 2014-15 fiscal in Kokomunda and Themra villages located on both sides of the airstrip.

The blacktopping of the runway and construction of roads in the airstrip were completed at an expense of Rs1.15 crore in 2013-14 fiscal. The National Highway-26 connecting the airstrip was also

blacktopped in 2017-18 fiscal. In 2017, the Bhubaneswar-based private airline Air Odisha had announced that it would launch regular flights from Kalahandi to

Bhubaneswar in September, 2017. The airline also conducted a successful trial flight from Bhubaneswar airport to Utkela airstrip May 23, 2016. The airline also announced flight timings and ticket prices for flights from Utkela to Bhubaneswar, Bhubaneswar to Jeypore and Jharsuguda to Bhubaneswar. However, there is a need for 10 acres of land for several other in-

frastructures like terminal building and fuel station while Rs16 crore is required for more infrastructural development. The district administration had submitted a survey report about acquisition of 10 acres of land for approval. But the govern-

Whose responsibility?

s part of the Unlock process set in motion now, the Centre has issued guidelines for reopening of schools in a phased manner from 15th October. States and Union Territories have been asked to frame their own Standard Operating Procedures for safely reopening schools based on local situations. Guidelines on health and hygiene as well as learning with physical distancing have been issued. Schools have been asked to arrange for disinfecting all areas on campus and ensure proper airflow in indoor spaces. Importantly, flexibility in attendance has been stressed upon and students are to attend classes only with written consent of the parents. Alternatively, students will be allowed to attend Online classes if they prefer

The issue of opening of schools is hugely complex both from the perspective of controlling the spread of the virus and also logistically for both school administration and parents/students. Add to that, the uneven spread of the virus infection in various states as also different districts and urban areas within given states, the problem becomes many-layered. Schools have just come to terms with Online learning, with administrators and teachers adapting new skills to cope. Same goes for students as well. When schools would be expected to continue with Online learning while at the same time open up physical classes, the issue of standardized learning for all students will necessarily crop up. Apart from a few top educational institutions, most schools will find it difficult to maintain both modes of learning in tandem. Plus, if students will be given the option to stay away from schools, most may prefer to do it anyway. Thus, it will be difficult to find a balance between testing the risk takers and the ones who wish to stay safe. On the other hand, parents will have to take the hard decision between learning and safety of their wards and family. This burden placed squarely on the shoulders of parents seems unfair when the initial lockdown and all other decisions have been taken by the government at the Centre and the states without consulting anybody.

The logistics of hygiene and maintaining distance in schools is also tricky, with most schools operating within their means without the luxury of extra learning spaces for physical distancing. This would place a lot of schools, including government institutions, at a disadvantage, with the exception of top notch private schools. It has not been mentioned how the schools will go about following the guidelines. The very important issue of testing all students before classes is to begin has not been addressed at all. It is imperative that students are tested beforehand and tests continue for many weeks in schools in a phased manner to identify and contain the spread of the virus. In the US, numerous students tested positive within days of reopening of schools and many institutions were forced to shut down almost as soon as they opened up. This was expected but possible to identify only because testing was done at schools. Without putting in mechanisms and guidelines for this very critical step, it would be suicidal to open up schools. Monitoring has to be an essential step of this exercise. With thousands of schools across the country and millions of students and their families at risk, skipping this step would be like pushing people to war without weapons. The Centre and now the states need to first clarify their strategy for this humongous testing mission, including who will spend the money for testing, before any other step.

Over and above all this, it is very important to consult all stake holders in this process. Without taking the opinions of parents, teachers and school/college managements, the government will again be creating another situation which could be disastrous for the country. Hopefully, the Odisha government will avoid such unitary actions

n his quest for the secret of US democracy in the 1830s, the French aristocrat Alexis de Tocqueville reflected on the important role played by religion in American life. Having escaped from the authority of the Pope, he argued, American Christians were free from any religious authority. Christianity in the New World, he concluded, could only be described as "democratic and republican.'

By republican he did not mean the Republican Party, of course, but the republican form of government. And most Christians he met were Protestants. The American Republic was founded by Protestants, and American elites were for a long time largely Protestant. So far, John Fitzgerald Kennedy has been the only Catholic president, and he had to affirm publicly during his election campaign that his first loyalty was to the United States, not to Rome.

But something extraordinary has happened since the republic was founded by Protestants in 1776. Five of the eight current Supreme Court justices are Catholics, and soon there may be six. The one Protestant on the court, Neil Gorsuch, was raised Catholic. (The other two justices are Jewish.) Nancy Pelosi, the speaker of the House of Representatives, is Catholic, as is the US attorney general, William Barr. And Joe Biden, who might be the next president, is Catholic, too.

How to explain the emergence of so many Catholics in high places? What does it signify? The least one can say is that the dominance of the White Anglo-Saxon Protestant (WASP) elites is over. Catholics, once distrusted and often excluded from public life because of the supposed incompatibility between their faith and liberal democratic principles, now occupy key positions.

Tocqueville, a Catholic himself, did not think Catholicism was inimical to democracy, especially in the US. On the contrary, he said, Catholics are more egalitarian than Protestants, who prize individual liberty more than social

equality. He believed that New World Catholics, often from poor immigrant communities, were perfectly in tune with American democratic ideals

In fact, Catholics are as divided as Protestants. There are left-wing Catholics, right-wing Catholics, and everything in between. Biden. a pious man, and not a radical, was denied communion last year because he supports women's right to opt for an abortion. For many other Catholics, including a considerable number of Latinos, their fervent opposition to abortion is the main reason they support Donald Trump.

Biden and Pelosi are Catholic liberals in the way Kennedy was. So is Sonia Sotomayor, one of the Supreme Court justices. But several other justices, as well as the attorney general, and Steve Bannon, one of Trump's early ideological advisers, belong to a very different strain of Catholicism, which is often at odds with the current head of the Catholic Church, Pope Francis.

Indeed, Elizabeth Bruenig, a commentator for the New York Times, recently wrote that the "Catholic right is no longer recognisably Catholic. Its politics are

more or less identical to those of the other members of the right-

wing Christian coalition. This is partly true. Right-wing Catholics have made common cause with evangelical Protestants, who view Trump as an unholy saviour who will overturn abortion rights and various barriers between church and state. But to claim that they are no longer recognisably Catholic is questionable.

The common cause between reactionary Catholics and Protestant enemies of the secular state goes back more than two centuries. Ever since the French Revolution toppled the authority of the Catholic Church, along with that of the absolute monarchy. Catholic reactionaries, including such anti-Enlightenment philosophers as Joseph de Maistre (1753-1821), have yearned to restore the Church's central position in political life. Likewise, Protestant opponents of Thomas Jefferson branded him an 'infidel' and 'anti-Christian' for limiting religious faith to the private sphere.

Tub thumping

Many Americans are more familiar with Bible-thumping, which has much the same sense. The phrase originally referred to a preacher of a type still familiar: one who does so in an aggressive way and who bangs on the pulpit to give emphasis. At the time the expression was first recorded - in the Cromwellian period of English history, roughly the 1650s - the allusion was to nonconformist preachers. There may be a connection here with the literal tub-thumping of an outdoor orator using an inverted tub as an informal lectern, or perhaps the practice of converting wash-tubs into improvised drums during processions or demonstrations

Tufthunter

uft was from about 1670 a slang term for a golden ornamental tassel that was worn on an academic cap (a mortarboard) at the universities of Oxford and Cambridge. Most members of these universities had only a plain black tassel, but the titled undergraduates - noblemen and sons of noblemen - wore gold ones as a mark of their status. By an obvious transfer of sense, wearers of golden tufts were themselves called tufts. Those individuals who were slavish followers of the tufts, toadies or sycophants, became known as tufthunters. Persons of the toadying persuasion have never had a good press. William Makepeace Thackeray described one in his Shabby Genteel Story of 1840: "Mr. Brandon was a tufthunter of the genteel sort; his pride being quite as slavish, and his haughtiness as mean and cringing, in fact, as poor Mrs. Gann's stupid wonder and respect for all the persons whose names are written with titles before them. O free and happy Britons, what a miserable, truckling, cringing race you are!" By the 1850s, the word had been transformed into toff (sometimes toft in the early days), as a lower-class slang term among Londoners for a person who was sufficiently smartly dressed to pass as a member of the nobility and - by extension for anybody who was rich and powerful. We have forgotten golden tufts, but we still know about their offspring, the toffs.

NSCN(IM) wants Naga peace talks to shift to '3rd country'

THE OUTFIT SAYS IT WAS MAKING THE LETTER PUBLIC FOR 'LACK OF RESPONSE' FROM THE PMO

Dimapur; Oct 6: The NSCN(IM) has demanded direct involvement of Prime Minister Narenda Modi in the talks to resolve the festering insurgency in the northeastern state and insisted that the negotiations be held in a 'third country'

In a letter to Prime Minister Narendra Modi written February 25, but kept secret so far, Thuingaleng Muivah, the general secretary of the group and chief Naga negotiator in the talks with the government, also spoke about the framework agreement (FA) signed in 2015 and its proposal that the state should be allowed to have a Constitution and national flag.

In the letter released to the media Monday, the outfit said it was making public the letter for 'lack of response' from the Prime Minister's Office (PMO).

Muivah, who is the Ato Kilonser (prime minister) of the self-styled Naga government, referred to the circumstances in which he and the then chairman of the outfit Isak Chishi Swu first arrived in India in 2002 and 'patiently' stayed here since 2010 to conclude an 'acceptable and honourable' political settlement.



He said the NSCN(IM) started political negotiation with the government only after it recognised the Naga problem as a 'political issue' and stopped calling it India's internal law and order issue.

Referring to the framework agreement, Muivah said, "We mentioned in our proposal that Nagaland shall use its National

Flag, Anthem, Emblem and Insignia and have a Constitution called 'Yehzabo'.

Though Muivah said it was not 'demand', his letter spoke about how 'sovereignty lies with the people' and the 'peaceful co-existence' of 'two entities' through 'sharing of sovereign power' Talking about the delay in im-

plementing the framework agreement, Muivah said, "In the given circumstances and in order to save the political dialogue, the talks should resume at the highest i.e.

prime minister level, without precondition, and outside India in a third country." Muivah also wrote about the 'obnoxious' conduct of the Ministry of

Home Affairs while dealing with the Naga question. 'We are totally shocked and sur-

prised that even after more than two decades of political negotiation, the MHA and its agencies have become obnoxious. It has come as a total shock and surprise that the Gol has started branding and accusing the members of the NSCN

who are in political negotiation as terrorist and with impunity they are arresting the members of the organisation," he wrote.

He dubbed as 'serious provocation' the conduct of the home ministry, and said it went against the spirit of political negotiation and the framework agreement.

Muivah was also bitter about the role of Nagaland Governor RN Ravi who, before taking up the new assignment, was the Government of India's chief negotiator for the Naga talks

He alleged that Ravi was interfering with the law and order issues in 'deliberate deviation' from his appointment as the Centre's representative for the peace talks. "The activities of the

Representative of the Gol is polarising the Naga society instead of uniting the Nagas for an honourable political solution," Muivah wrote.

He alleged Ravi was meeting only a 'certain section' of the Naga society that is not committed to a 'genuine political solution and who do not represent the genuine aspiration of the Naga people'.

Despite Muivah's fulmination, several rounds of talks to restore peace in Nagaland have been held in New Delhi. The Indian side was largely represented by officers of the Intelligence Bureau (IB).

"We have come to India on the invitation of the Gol and we are in Nagaland to meet our own Naga people vis-a-vis the peace process. If the MHA is trying to stop us from meeting our own people, then their negative intent against the peace process has become very clear," he said. Muivah also wrote that the Indian government should allow him to leave the country if their stay in India is no more welcome. "All necessary arrangements must be made for us to leave India and the political talks be resumed in a third country."

The NSCN(IM) leader said the letter was released belatedly as he expected the PMO to respond 'positively'.

New Delhi, Oct 6: New Delhi has unveiled a slew of plans aimed at reducing the Indian capital's annual toxic smog, as authorities warned the severe pollution could worsen the coronavirus epidemic. Air in the metropolis -- home to

20 million people -- becomes a noxious cocktail of dust and smoke each winter, caused by vehicle fumes, industrial emissions and smoke from agricultural burning. The haze regularly sees the city ranked as one of the world's most polluted.

In a virtual news conference Monday. Delhi Chief Minister Arvind Kejriwal said authorities would introduce a series of initiatives -- including setting up a 'war room' to deal with hot spots when they arise, and trialling new technology to deal with old problems. For starters, authorities will test a so-called bio-decomposer process, which would turn crop stubble into fertiliser, Kejriwal said. The fermented liquid, made with a type of cane sugar and flour, is meant to slowly decompose the

straw Smoke from burning stubble -particularly from neighbouring states - is blamed for nearly half the air pollution in New Delhi, even though it is officially outlawed.

Air quality will be monitored in a new war room, and there will be checks on construction sites.

Authorities will also introduce a phone app for people to report polluters. Delhi's measurements of

government will start spraying Pusa bio-decomposer' solution from October 11 to prevent stubble burning in non-basmati rice fields in the national capital. Scientists at the Indian Agricultural Research Institute, PUSA, have found a low-cost, simple and effective way to deal with the problem of stubble burning, he said. "They have developed 'bio-decomposer' capsules, which are used to prepare a liquid formulation. The solution, when spraved in the fields, can decompose crop residue and turn it into manure, Kejriwal said after inspecting his government's centralised biodecomposer system set up in Kharkhari Nahar village in southwest Delhi.



With more than 100,000 deaths nationwide, India's tally of infections has crossed 6.6 million, but there is little sign of any sustained fall in new daily numbers

Since its first virus burial in April, the Islamic graveyard of Jadid Qabristan has seen more than 700 funerals on a patch of adjoining wasteground designated for pandemic victims.

'We weren't expecting that we will have to clear more land for the graves," said head gravedigger Mohammad Shameem, a 38-year-old in a pale green traditional tunic, who is the third generation of his family to work in cemeteries.

Guwahati, Oct 6: Assam Chief Minister Sarbananda Sonowal Tuesday launched a mobile app to facilitate timely sale of agriculture products, particularly fruits and vegetables, by promoting buyerseller network.

According to an official document, Mizoram's Dampa Tiger Reserve holds the distinction of housing the highest number of clouded leopards in Southeast Asia

The density of population of clouded leopards, locally known as 'Kelral', is 5.14 per 100 sq km in the reserve, situated along the Mizoram-Bangladesh and Tripura

Mizoram Forest Department indicate that clouded leopard density in Dampa Tiger Reserve is perhaps the highest among forests of South and South-East Asia where the species is found.

The state's Environment, Forests and Climate Change Department in recent years placed several camera traps at different places across the Dampa Tiger Reserve, which captured the clouded leopards 84 times. Wildlife expert Apurba Kumar the Dey said that like the clouded leopard, much of the wildlife in India's northeast remains elusive, poorly understood, and inadequately protected. A six-year-old boy was recently mauled to death by a leopard

in Maligaon, on the outskirts of Assam's main city of Guwahati. Maligaon, headquarters of the North East Frontier Railways and a place prone to human-leopard conflicts, comes in the Guwahati Municipal Corporation area, which encircles several big hills and seven reserve forest areas.

Earlier also several people were injured after being attacked by leopards in Maligaon and the adjoining areas. Wildlife activists said that the habitats of leopards and other wild animals have been shrinking over the decades due to encroachment by the people leading to mananimal conflict.

There have also been incidents in the recent past when angry mobs killed leopards and other wild animals. Wildlife activist Mubina Akhtar said that the hills are where the leopards live but people have been encroaching upon their habitats.

"There are seven reserve forest areas adjoining Guwahati city. The forest department has neither demarcated them properly nor has it put up any signs or notice boards, resulting in encroachment of forest land," Akhtar told IANS over phone.

She said: "Since 2010, men and wild animal conflicts are rising in Guwahati areas. However, au-thorities are doing nothing to stop such incidents.'

HEALTH MINISTRY GUIDELINES No festive events in containment zones

New Delhi, Oct 6: The Health Ministry Tuesday issued the standard operating procedures (SOP) on preventive measures to contain the spread of Coronavirus during ensuing festivities and urged people in containment zones, and vulnerable populations to celebrate festivals at their homes.

AGENCIES

'Festive events shall be permitted only outside the Containment Zones. Organisers, staff and visitors from Containment Zones shall not be permitted. People residing inside Containment Zones may be encouraged to observe all festivals inside their homes and not move out," the ministry added.

It said that the festivals, fairs, rallies, exhibitions, cultural functions, processions and concerts associated with the festivities are mass events and advised the administrative requirement such as identification of spatial boundaries and preparation of a detailed site plan in compliance with thermal screening, physical distancing, sanitisation etc

"In case of events that run for days or weeks, the crowd density doesn't remain the same throughout and usually peaks around certain hours of the day and some pre-



viously known auspicious days. Planning for the event should specifically factor this so that crowds are regulated and managed to ensure physical distance and frequent sanitisation," the guidelines added.

In case of rallies and immersion processions, the number of people should not exceed the prescribed limit and proper physical distancing and wearing of masks must be ensured. In any case, the number of such rallies and the distance covered by them may be kept within manageable limits.

The Health Ministry said that the events such as rallies, and processions spread over long distances would require support of ambulance services. Events planned to last

for many days or weeks such as exhibitions, fairs, puja pandals, Ramlila pandals or concerts and plays should have adequate measures to ensure a cap on physical numbers.

"Staggered timings and restricted entry may be considered. Volunteers should be appropriately stationed to ensure thermal scanning, physical distancing and wearing of masks. The guidelines issued for theatre and cinema artists will apply to stage performers. Adequate supplies of sanitisers, thermal guns and physical distancing floor markings to be ensured," the Centre added.

Close circuit cameras would be considered to monitor compliance of physical distance norms, wearing of masks at each venue.

Lowest daily spike since August

NEW DELHI: India has reported its lowest daily spike of cases since August on Tuesday, according to health ministry data. The country's daily death toll has also fallen from peak levels seen in August and September. The country has reported a daily spike of 61,267 cases in 24 hours, taking the total tally of Covid-19 cases in the country to 66,85,083. The total death toll in the country has now gone up to 1,03,569 after 884 new deaths. The fresh data reported by the health ministry today is further indication that India's coronavirus situation is improving gradually. On Monday, a little over 74,000 cases were reported. The daily spike reported today is much lower at just over 61,000. The number of deaths is also marginally lower and below the 900-mark. Another good sign for the country is the fact that the number of daily recoveries has exceeded the number of cases being recorded on a daily basis.

72,500 Sig assault rifles for soldiers at LAC

The Centre has approved the acquisition of the second batch of around 72,500 Sig Sauer assault rifles for soldiers deployed on the China front in Ladakh

New Delhi, Oct 6: A new batch of 72,500 Sig-16 assault rifles from the US will be given to the Indian Army soldiers deployed on the China front in eastern Ladakh.

The Indian government has approved the acquisition of the second batch of around 72,500 Sig Sauer assault rifles from the US under fast-track procedures for the Army.

"The first batch was provided to troops deployed in Jammu and Kashmir. A second lot of the Sig-16 assault rifles would be for the troops deployed on the China front in eastern Ladakh and other areas," top government sources told Aajtak and India Today TV. The new rifles will replace the existing Indian Small Arms System (Insas) 5.56x45mm rifles used by the forces and manufactured locally by the Ordnance Factories Board.

As per the plan, around 1.5 lakh imported rifles were to be used by the troops in counter-terrorism operations and frontline duties on the Line of Control (LoC) and the



newly-activated Line of Actual Control (LAC).

The remaining forces would be provided with the AK-203 rifles, which are to be produced jointly by India and Russia at the Amethi ordnance factory. Amid the ongoing India-China

border dispute, the Indian Army is going to place another order of 72,000 Sig 716 assault rifles from the US.

The Indian Army had been trying to replace their standard INSAS assault rifles for many years but attempts failed due to one reason or the other.

Recently, the Defence Ministry placed an order of 16,000 light machine guns (LMGs) from Israel to do away with the shortage of these guns.

Carried out by UK-based humanitarian organisation Plan International, the survey, titled "State of the World's Girls Report", involved 14,000 women aged 15-25 from 22 countries including India, Brazil, Nigeria, Spain, Australia,

was similar for different regions around the globe. "In Europe 63 per cent of girls reported harassment, followed by 60 per cent of girls in Latin America, 58 per cent in the Asia-Pacific region, 54 per cent in Africa, and 52 per cent in North America," the report found

Ranging from threats of sexual violence to racist comments and stalking, online harassment of young women was directed in different manners.

The survey, titled "State of the World's Girls Report", involved 14,000 women aged 15-25 from 22 countries including India

who identified themselves as from an ethnic minority said they get harassed because of it," found the survey conducted from April 1 to May 5.

Despite the anonymity that social media provides, girls and young women do know something about their harassers. Harassment from

strangers was more frequent and more frightening than from people they knew.

'While 11 per cent of the surveyed girls were harassed by a current or former intimate partner, 21 per cent pointed towards friends and 23 per cent knew their harassers from school or work," it said.

Thirty six per cent of the respondents said they were harassed by strangers and 32 per cent by anonymous social media users.

Whilst women were listed in the examples of known harassers, none of the girls interviewed suggested women were behind the unknown accounts, many directly mentioned they thought they were men. The abuse and harassment faced

For the first time since the standoff between Indian and Chinese troops along the LAC in eastern Ladakh, PM Narendra Modi and Chinese Prez Xi Jinping are expected to come face-to-face virtually at the **BRICS** annual summit

New Delhi, Oct 6: For the first time since the standoff between Indian and Chinese troops along the Line of Actual Control (LAC) in eastern Ladakh, Prime Minister Narendra Modi and Chinese President Xi Jinping are expected to come face-to-face virtually at the BRICS annual summit to be held November 17.

Russia, the chair of the five-nation BRICS, announced that the annual summit of the bloc will be held November 17 via video conference. The BRICS (Brazil-Russia-India-China-South Africa) is known as an influential bloc that represents over 3.6 billion people, or half of the world's population.

The BRICS countries have a combined GDP of \$16.6 trillion.

The theme of the meeting of the leaders of BRICS countries is BRICS Partnership for Global Stability, Shared Security and Innovative Growth'," the Russian government said in a statement.

President Xi have attended all summit meetings of the BRICS in the last few years. PM Modi and Chinese President Xi are attending the virtual summit, said a diplomat, involved in the arrangements for the multilateral event. Last year, the BRICS summit had taken place in Brazilia, the capital city of Brazil. PM Modi and Chinese PresidentXi also held a bilateral meeting on the sidelines of the summit.

India and China are locked in a bitter border standoff in eastern Ladakh since early May that has significantly strained the bilateral ties. Both sides have held a series of diplomatic and military talks to resolve the row. However, no breakthrough has been achieved to end the standoff.

The Russian statement also said, "this year the five countries have continued close strategic partnership on all the three major pillars peace and security, economy and fi nance, cultural and people-to-people exchanges.

Chennai, Oct 6: The Indian space agency is working towards launching its new rocket 'Small Satellite Launch Vehicle (SSLV)' before December 2020, said a senior official.

He also said necessary tests to check its biggest motor - booster motor fired by solid fuel - will be done in November.

"The SSLV launch will be from the first launch pad at Sriharikota rocket port after the flight of Polar Satellite Launch Vehicle C49 (PSLV C49). Post PSLV C49's flight, the launch pad set up has to be reconfigured to suit SSLV," S. Somanath, Director, Vikram Sarabhai Space Centre (VSSC) part of the Indian Space Research Organisation (ISRO) said.

Sometime next month PSLV C49 will fly with about 10 satellites. The rocket will be carrying India's RISAT-2BR2 and other commercial satellites. It will be followed by



PSLV C50 with the GSAT-12R satellite in December. The rocket is being assembled at Sriharikota with various systems coming from different centres. It will fly from the second launch pad. Somanath said.

"From the drawing board to launch pad the time taken is only about two-and-half years. The SSLV is a three stage/engine rocket all powered by solid fuel," Somanath added. The 34-metre rocket will have a

liftoff mass of 120 tons. The rocket has the capability for multiple satellite launches at different orbits. The SSLV can carry a 500 kg payload for low earth orbit (LEO) and 300 kg for sun-synchronous orbit (SSO). According to Somanath, the development cost of the rocket is

about Rs 120 crore. "The major development for SSLV is its brand new electronic systems

with local components. All the qualifications of the systems have been done. The rocket also has a simple pyrotechnic system," Somanath said. The new miniaturised telemetry system developed for SSLV has achieved 70 per cent mass reduction

in the telemetry package. According to Somanath, in order to develop the rocket at a lower cost, ISRO with a simplified man-

agement, coastal land use and regulation, utilities mapping, ufacturing process - for instance, cutting down the machining time development and various other geographic information system (GIS) wherever possible - went to the next level of vendors with the necapplications

Why Balrampur rape case is being ignored

Hathras has gone on to become a story of national shame while Balrampur remains largely uncovered by the media

Balrampur (UP), Oct 6: Two strikingly similar incidents took place at a distance of about 540 kilometres and within a matter of 24 hours last week. A Dalit girl died after being assaulted in Hathras and another Dalit woman was raped and killed in Balrampur district.

In both the cases, the accused were promptly arrested and the police forced the families to cremate their daughters in the dead of the night.

Hathras has gone on to become a story of national shame while Balrampur remains largely uncovered by the media.

Political parties in the opposition have also chosen to ignore the Balrampur incident where the 22vear-old B.Com student was raped. drugged/poisoned and sent home in a rickshaw with her back and

legs broken. The reason why the Opposition has steered clear of the Balrampur incident is more than apparent. The two accused who have been arrested are Muslims-Shahid and Sahil-and non-BJP parties do not wish to "disturb" their base among Muslims by raising the Balrampur incident. Congress leaders have made a

customary visit to the victim's family Monday but their leaders Rahul Gandhi and Priyanka Gandhi Vadra did not find time to do the same. A SP delegation also visited the

family but did not make much noise about the incident.

Two senior officials, including Additional Chief Secretary (Home) Avanish Awasthi, and ADG (Law and Order) Prashant Kumar vis-

ited Balrampur on Sunday to meet the victim's family but the visit did not create ripples in the media and neither did the family make an issue out of it.

The government, interestingly, did not announce any compensation for the victim's family in Balrampur other sops like a house and a job or a family member.

Sources claim that the purpose was to provoke the family so that focus shifts to Balrampur from Hathras. In Hathras, the victim's family was given Rs 25 lakh as compensation and promised a house and a job for a family member.

Interestingly, almost the entire electronic media has also chosen to ignore the Balrampur incident mainly because the distance between Balrampur and Delhi is 720 kilometres and Hathras, in any case, was already providing fodder

for increasing TRPs.

Even some leading newspapers brushed the Balrampur incident into the inside pages while Hathras remained on page one.

The crew of a news channel went to Balrampur but was curtly asked to leave when they asked the victim's family to make a statement that the accused have links with a terrorist group.

SP-Balrampur Dev Ranjan Verma has ordered a probe into the incident after a 34-second video, in which villagers are seen gheraoing the TV journalists and questioning them, went viral.

"You don't need to spread any false news report and create propaganda against the government," the residents were heard as saving. Similar incidents in Azamgarh

and Bulandshahr were also overlooked for similar reasons.

WH nixes FDA guidelines on vax approval

Washington, Oct 6: The White House has blocked new Food and Drug Administration guidelines on bringing potential vaccines for COVID-19 to market that would almost certainly have prevented their introduction before the November 3 election.

At issue was the FDA's planned instruction that vaccine developers follow patients enrolled in their trials for at least two months to rule out safety issues before seeking emergency approval from the agency. A senior administration confirmed the move Monday evening, saying the White House believed there was "no clinical or medical reason" for the additional requirement.

The White House action was first reported by The New York Times. The intervention by Trump officials is the latest example of the administration undercutting its own medical experts working to combat the pandemic that has killed more than 210,000 Americans. FDA Commissioner Stephen Hahn has been attempting to shore up public confidence in the FDA's vaccine review for weeks, vowing that career scientists, not politicians, will decide if the shots are safe and ef-

fective for mass vaccination. But President Donald Trump has repeatedly insisted that a vaccine could be authorized before Election Day, even though top government scientists working on the administration's vaccine effort have stated that that timeline is very un-



commissioners blasted the administration for "undermining the credibility" of the FDA in a Washington Post op-ed and called for the release of the pending vaccine guidelines. The former FDA chiefs warned that public fears that a vaccine was rushed out for political reasons could derail efforts to vaccinate millions of Americans.

The senior administration official, who spoke on the condition of anonymity to discuss the action, said the White House was intent on getting a safe vaccine to market and wanted to make sure "additional loopholes" were not added that would slow down the process.

Beyond the damaging optics of overruling its own FDA, the practical impact of the White House move against the guidelines could be relatively limited. likely. Last week seven former FDA

suggested it could have data on the safety and effectiveness of its vaccine before Election Day. And a number of variables would still have to align for the company to submit, and the FDA to review and greenlight, a vaccine application before November 3. Pfizer's competitors Moderna, AstraZeneca and Johnson & Johnson are working on longer research timelines.

Additionally FDA scientists have been discussing the contents of the guidelines publicly for weeks and have made clear that the recommendations have already been shared with each of the vaccine developers.

"There's nothing there to get all excited about this guidance," said Dr. Peter Marks, the head of FDA's vaccine division, in an online interview last week with the nonprofit Friends of Cancer Research.

UK may face lockdown due to 'technical glitch'



London, Oct 6: A number of areas in the UK could face local lockdowns after it was revealed that nearly 16,000 daily coronavirus cases went unreported due to a technical glitch, media reports said Tuesday.

Cities and areas with universities, including Nottingham, Sheffield, Leeds and Oxford, have seen figures soar after the glitch which was reported October 2, the Metro newspaper reported.

A Telegraph report said that residents in Nottingham city, which was not in the government Covid-19 watch list', were asked to prepare for lockdown measures

Following the glitch, the updated data revealed that the city would have been one of the worst areas in the country last week when compared with the pre-adjusted figures. Despite this, the Department for Health has insisted the new figures do not impact its 'watch list' or change current restrictions in the area, according to the Telegraph



report. The adjusted figures also revealed huge jumps in Manchester, Liverpool, Sheffield and Newcastle. In a statement Monday, Public Health England (PHE) said that 15,841 cases between September 25 and October 2 were left out of the

country's single-day case figures, the BBC reported. They were then added in to reach the October 3 figure of 12,872 new cases and the following day's 22.961

The glitch, which was caused by some data files reporting positive test results exceeding the maximum file size, also meant that the daily count reported on the government's coronavirus dashboard over the past week was lower than the actual number. As of Tuesday, the UK has reported a total of 518,222 coronavirus cases and 42,459 deaths.


New Delhi. Oct 6: Fitch Ratings Tuesday said Indian banks face a tough operating environment in the near term as stressed loans and write-offs increase due to the economic fallout from the coronavirus pandemic.

It said limited room for fiscal support, fragilities in the financial system and a continuing rise in COVID-19 cases are hampering normalisation of activity.

Indian banks face a tough operating environment in the near term, as stressed loans and writeoffs increase as a result of the economic fallout from the coronavirus pandemic, but a swift economic recovery will be critical to limiting loan losses in what is likely to be a protracted period of weakness in the asset-quality cycle, Fitch Ratings said in a statement.

Banks have been permitted by the Reserve Bank of India (RBI) to undertake a one-time restructuring exercise of loans affected by the pandemic, which will provide relief in terms of bad loan recognition and provisioning, Fitch said.

However, the exercise could leave the sector saddled with a high bad loan burden over the next few years if restructured loans do not perform according to agreed milestones, it added.

"NOCs play a critical role in the world's energy markets, dwarfing their counterparts in the private sector - the international oil companies - in terms of global oil and gas production and reserves,' said Hui Ting Sim, a Moody's Analyst.

"Against the backdrop of slowing oil and gas consumption over the next few decades, with the potential for a more abrupt disruption to demand, the NOCs' sovereign sponsors will increasingly impact credit profiles by either providing support or acting as a drag," added Sim.

NOCs in oil importing countries where consumption will keep growing are less exposed to carbon transition risk than those in oil exporting countries.

The impact of sovereign support on NOCs' credit profiles depends on its ability and willingness to provide support even when oil consumption is declining, the degree of its reliance on the NOC for its revenue.

INDIA TO BE WORLD'S LARGEST LPG MARKET

New Delhi, Oct 6: India is expected to overtake China as the world's largest cooking gas LPG residential sector market by 2030, Wood Mackenzie said Tuesday. Liquefied petroleum gas (LPG)

demand in the residential sector will continue to see sustainable growth at a cumulative annual growth rate (CAGR) of 3.3 per cent, reaching 34 million tonnes (MT) in 2030 as households' dependence on solid biomass diminishes in the long run supported by rising average household incomes and urban population, it said in a report.



Wood Mackenzie research analyst Qiaoling Chen said Although nationwide LPG coverage has reached 98 per cent, up 42 per cent from 2014, usage is still low.

Data protection should be backed by law: RBI

New Delhi, Oct 6: Protection of personal data should be backed by a legal provision as it will help ensure privacy and confidentiality of individuals, a senior RBI official said Tuesday.

Data protection is crucial because privacy and confidentiality of individuals is their right under the Constitution, RBI Executive Director T Rabi Sankar said.

"I strongly believe that the protection of use of proprietary data, in particular personal data, needs to be legally provided for rather than through subordinate legislation like regulation through regu-

latory authority," Sankar said. He was addressing the virtual event 'RAISE 2020: Responsible AI for Social Empowerment'.

The bill proposes to put restriction on use of personal data without explicit consent of citizens. Speaking on artificial intelligence (AI), Sankar said the massive generation of data and the

unimaginable use of computing power have given a huge fillip to AI in the last decade.

Computers can make certain decisions based on programming and this has come into the area of banking as well, he pointed out.

'In terms of customer service we have also done something in fraud detection. We have recently issued some instructions on positive pay in the cheque truncation system (CTS) ... to avoid any possibility of frauds... "As the system gets more popular and software develops more, it will be easy to identify misuse of the cheque truncation system and probably may at some point of time minimise it to insignificant level...," Sankar said.

Similarly, data can be used to check money laundering as it will help in identifying the trends in movement of money.

Among others, robo-advisory services too have huge potential for data usage, he said.

"Similarly for credit assessment. this would improve credit assessment of borrowers to the extent that one can envisage going forward at some point of time in future that the credit risk premium that adds to the cost of borrowing can be minimised. It will have a secular impact on bringing borrowing cost down," said the RBI official.

Apart from the CTS, there are other areas such as the Central Payment Fraud Information Registry that the Reserve Bank has put in place, he added. "We are looking at this as, once data is collected over a period of time, it would eventually enable prevention, reduction and early detection of fraudulent transactions in the financial system," Sankar said.

Earlier, Mumbai suffered a mini middle order collapse after a good start but late-hitting from Yadav and Hardik Pandya (30 n o, 19b, 2x4, 1x6) enabled the defending champions to amass 51 runs in the last three overs. The two shared 76 runs for the unbroken fifth wicket stand. Opting to bat, openers Rohit

forged a quickfire 49-run stand. Debutant pacer Karthik Tyagi (1/36) removed De Kock in his verv first over to provide the much needed breakthrough.

Ashwin had courted controversy when he ran out Jos Buttler during last year's IPL when the England batsman backed up too far at the non-striker's end. Several cricketers criticised him for not showing sportsman's spirit.

It became an issue before the start of this year's IPL when Delhi

Capitals head coach Ricky Ponting said he would not let Ashwin run out batsmen in that fashion after the veteran joined them having played for Kings XI Punjab, in 2019.

Ashwin and Ponting had a discussion on the issue after they arrived in the UAE. Ponting was seen smiling when Ashwin let Finch

Paris, Oct 6: The No.17 seed Pablo Carreno Busta set up a rematch against Novak Djokovic by reaching the second French Open quarterfinal of his career.

Carreno Busta was visited by a doctor after the second set but continued to play well and beat 186thranked qualifier Daniel Altmaier 6-2, 7-5, 6-2 at Court Philippe Chatrier. It wasn't immediately clear what was wrong with Carreno Busta.

At the US Open last month, Carreno Busta was the opponent who advanced when Djokovic was defaulted from their fourth-round match for accidentally hitting a line judge with a ball after a game in the first set.

Carreno Busta, a 29-year-old from Spain, would go on to reach the semifinals in New York before blowing a two-set lead against eventual runner-up Alexander Zverev.

Carreno Busta also was a quarterfinalist in Paris in 2017.

The 22-vear-old Altmaier was trying to become the first man since 1996 to get to the quarterfinals of his first Grand Slam tournament. He hadn't dropped a set until Monday.

Elsewhere, Australian Open champion Sofia Kenin turned things around at the French Open after a poor opening set to reach the quar-



terfinals at Roland Garros for the first time.

The No.4-seeded Kenin beat the 49th-ranked Fiona Ferro 2-6, 6-2, 6-1 at Court Philippe Chatrier. Ferro was the last French man or woman still around in singles.

Chair umpire Marijana Veljovic warned Kenin's father, Alexander, for coaching, which is not allowed during Grand Slam matches.

Alexander Kenin had changed seats during the match to be right next to Ferro's coach, Emmanuel Planque, who was closer to the

court. Kenin upset Serena Williams at last year's French Open en route to making it to the fourth round. But until now, the 21-year-old American had never been to the quarterfinals at any clay-court tournament.

She won her first Grand Slam title at Melbourne Park at the start of this season and now is 14-1 at major tournaments in 2020.

"I withdrew from Denmark Open. I decided that I will start the season from January only with the Asian tour," Saina, the London Olympics bronze-medallist, told this agency. The husband-wife duo had ear-

lier sent their entries for the USD 750.000 tournament and also submitted their consent letter to the Badminton Association of India (BAI) last month for the same.

The Badminton World Federation (BWF) postponed the Thomas and Uber Cup Finals (Oct 3-11), three events in Asia (in November) to 2021 and also cancelled the Denmark Masters (Oct 20-25).

The Denmark Open is thus the only World Tour event scheduled to be held in the remainder of the season. Asked if she has any fitness

concerns, Saina, a two-time Commonwealth Games gold medallist, said: "There is no injury issue but if three tournaments were there it would have made sense ... I thought directly from January, I can go for the Asian tour.'

The withdrawal of former World No.1 Saina, one of the Olympic hopefuls for next year's Tokyo Games, means there will be no Indian participation in the women's singles event at Odense as World Champion PV Sindhu has already pulled out.Kashyap, currently ranked World No.24, also decided to skip the event for similar reasons. "I too feel it is not worth the risk to go all the way for one tournament. It is better to start the season afresh participating in the Asia leg from January," the London Games quarterfinalist said.

Former World No.1 Kidambi Srikanth, young Lakshya Sen, Ajay Javaram and Subhankar Dey are the only Indians who will compete in the Denmark Open.

QUALIFIER TO REACH FRENCH OPEN SEMIS Podoroska achieves **Roland Garros history**

Paris, Oct 6: After becoming the first qualifier to reach the women's French Open semifinals in the Open era, Nadia Podoroska threw her racket in the air, tilted her head back and pumped both fists.

Podoroska had just knocked out Elena Svitolina, the third seed who, Tuesday, was stopped from reaching a third semifinal in her past four Grand Slam tournaments.

The Argentine who had never even won a main draw match before coming to Roland Garros could hardly believe she won 6-2, 6-4 on Court Philippe Chatrier.

"Well, it's a little bit difficult for me speaking after the match, my English is not so good," Podoroska said on court. "Thank you everybody for your support. I'm very, very happy.'

Serving at 5-4 down, Svitolina saved two match points, the second with an audacious slice at the net to end a 27-shot rally. But on the third match point, Podoroska hit a crisp forehand winner and then chucked her racket up toward the



blue sky.

In a semifinal that could be even more remarkable, she could face another qualifier in Martina Trevisan of Italy, who also had not won a main draw match before this tournament.

On a day of firsts, Danielle Collins reached the quarterfinals of the French Open for the first time after beating 30th-seeded Ons Jabeur 6-also could scarcely take it in when she won on her first match point.
