Cash sops to mollify central employees

New Delhi, Oct 12: Finance Minister Nirmala Sitharaman Monday announced a payment of cash in lieu of LTC and ₹10,000 festival advance to please government employees ahead of the festival season and to stimulate consumer demand for overall economic recovery She also announced additional capital spending and ₹12,000 crore, 50-year interest-free loan to states to boost the economy that has been battered by the pandemic and the resulting lockdown. At a news conference, she said the government will give its employees incometax-exempt cash vouchers in lieu of their entitled travel allowances this year.

This cash will have to be spent on buying goods that attract 12 per cent or more GST -- a condition which eliminates the possibility of the cash being spent on food items. Central public sector enterprises and banks will also follow the cue and give cash in place of leave travel concession (LTC) as travelling during the pandemic is near to impossible.

Additionally, the government will as a one-time measure give ₹10,000 salary loan to all its officers and employees as festival advance. These two measures are "expected to create a consumer demand of about ₹28,000 crore", she said.

The government, which had in May announced a ₹20 lakh crore 'Aatmanirbhar Bharat' stimulus, is pushing ahead with a full opening to try to boost the economy ahead of the usually high-spending festival season.

A tough lockdown imposed to stem the spread of coronavirus had resulted in the economy contracting by a record 23.9 per cent during April-June.

Together with the loan to states and additional capital spending, Sitharaman said, "very rough estimate is that potential private sector spending through LTC

tax benefit will be at least equal to the government employee-led demand of ₹28,000 crore and the total additional demand estimated to exceed ₹1 lakh crore".

She further said that the measures by the government to stimulate demand must not burden the common citizen with future inflation and must not put government debt on an unsustainable path. "Today's solution should not cause to morrow's problem," she added.

Sitharaman said the central government employees get LTC in a block of 4 years (one to anywhere in India and one hometown; or two for the home town) Air or rail fare, as per scale/entitlement, is reimbursed and in addition, leave encashment of 10 days (pay plus DA) is paid. Due to COVID-19, employees are not in a position to avail LTC

In lieu of one LTC, a cash payment will be made -- full payment on leave encashment and payment of a fare in 3 flatrate slabs depending on the class of entitlement. Fair payment will be tax-free.

An employee, opting for this scheme, will be required to buy goods/services worth 3-times the fare and 1-time the leave encashment before March 31 2021 she

said adding money must be spent on goods attracting GST of 12 per cent or more from a GST registered vendor and through digital mode. If central government employees opt for it, the cost will be around ₹5,675 crore. Employees of public sector banks and PSUs will also be allowed this facility and estimated cost for them will be ₹1,900 crore.

The tax concession will be allowed for state government/private sector too, for employees who currently are entitled to LTC, subject to following the guidelines of the central government scheme.

Demand infusion in the economy by the central government and central PSE/PSB employees is estimated to be ₹19,000 crore. Demand infusion by state government employees will be ₹9,000 crore. She said festival advance along with other similar advances were abolished on the recommendations of the 7th Pay Commission. It is proposed to restore the festival advance with one-time interest-free advance of ₹10,000 to be availed by March 31. The amount is supposed to be recovered in maximum 10 installments. The outgo under the head is expected to be ₹4,000 crore.

Parents sell off 9-yr-old son to fix divorce deal

The news of sale of the boy which took place in Telgabecha village of Kianga panchayat under Mathili block of Malkangiri district, surfaced Monday. Basudev, however, escaped from the house of the person who had bought him and narrated his plight to an Anganwadi worker at Salpapadar village. He alleged he was being tortured and was being forced to do menial jobs, the Anganwadi worker said.



The Anganwadi worker, Jayanti Khara, said that the man who had bought Basudev threatened her with dire consequences for providing shelter to Basudev. Locals came out in support of Jayanti and informed officials of the Malkangiri district administration and police regarding the incident

Mathili block development officer (BDO) Ashish Kumar Bhoi said that the matter is being looked into. "I will look into the matter personally. If the boy wants, we may shift him to his relative's house or else we will provide him education and accommodation facilities. We will also try to contact his parents and launch a detailed probe into the alleged sale," said Bhoi.

Govt twists norms to shield officers

Bhubaneswar, Oct 12: In the wake of the hue and cry triggered by the alleged scam in procurement of masks and PPE kits for Covid warriors, the state government has revised rules to shield officers.

The General Administration (GA) department has notified the Odisha Lokayukta (procedure of filing of complaint) Rules, 2020. As per new norms, the Lokayukta will have to process a complaint protecting the identity of the complainant and the public servant complained against till the conclusion of the inquiry.

However, the complainant himself can reveal his identity to any other office or authority while making a complaint to the

Lokayukta. The anti-corruption panel will have to protect the integrity of the process of inquiry or investigation.

The government has given power to Lokayukta to dispose of a complaint where the contents of the complaint are illegible, vague, ambiguous, trivial or frivolous.

If the Lokayukta is satisfied that there exists a case for an inquiry against the public servant including any person or institution, notice will be served on such public servant, person or institution calling for explanation from the noticee. The noticee will be given 45 days to reply.

The Lokayukta will now have to provide a copy of its order to all affected parties and respective departments concerned.

New Delhi, Oct 12: The prolonged closure of schools due to the COVID-19 pandemic in India may cause a loss of over USD 400 billion in the country's future earnings, besides substantial learning losses, according to a World Bank report.

South Asia region stands to lose USD 622 billion from the school closures in the present scenario or up to USD 880 billion in a more pessimistic scenario, it said, adding while the regional loss is largely driven by India, all countries will lose substantial shares of their GDP.

The report titled "Beaten or Broken? Informality and COVID-19 in South Asia" claims that South Asia is set to plunge into its worstever recession in 2020 as the devastating impacts of COVID-19 on the region's economies linger.



'Temporary school closures in all South Asian countries have had major implications for students. They have kept 391 million students out of school in primary and secondary education, further complicating efforts to resolve the learning crisis," said the report.

'While most governments have made enormous efforts to mitigate on the productivity of a genera-

The report also noted that the pandemic may cause up to 5.5 million students to drop out from the education system and cause substantial learning losses, which will have a lifetime impact

The 'Learning Adjusted Year of Schooling' (LAYS) concept, introduced by the World Bank, seeks to combine access and learning outcomes into a single measure. It combines quantity (years of schooling) and quality (how much kids know

at a given grade level) into a single summary measure of human capital in a society.

The report has projected that based on country data on household labor incomes, the average child in South Asia may lose USD 4,400 in lifetime earnings once having entered the labour market, equivalent to 5 percent of total earnings.

"These projections are based on what we currently know about returns to schooling, using the reduced level of learning caused by the crisis. Summing these numbers for all children in South Asia, the region stands to lose USD 622 billion from the school closures in the present scenario, or up to USD 880 billion in a more pessimistic scenario.

"While the regional loss is largely driven by India, all countries will lose substantial shares of their GDP. For reference, note that South

Asian governments spend only USD 400 billion per year in total on primary and secondary education. The total loss in economic output from the current closures is hence substantially higher than what countries currently spend on education," it said.

The novel corona virus has infected over 3.7 crore people across the globe claiming over 10.5 lakh lives. India's COVID-19 caseload stands at 71.2 lakhs while the death toll is 1.09 lakh as Monday.

Universities and schools across the country were ordered shut March 16 to contain the spread of the novel coronavirus. On March 25, the Centre announced a nationwide lockdown. While several restrictions have been eased gradually in different phases of the 'unlock' since June 8, educational institutions continue to remain closed.

Nobel economics

Stockholm, Oct 12: Americans Paul R Milgrom and Robert B Wilson have won the Nobel Prize in economics for "improvements to auction theory and inventions of new auction formats.'

The winners were announced Monday in Stockholm by Goran Hansson, secretary-general of the Royal Swedish Academy of Sciences. The award caps a week of Nobel Prizes at a time when much of the world is experiencing the worst recession since World War II because of the impact of the coronavirus pandemic.

Technically known as the Sveriges Riksbank Prize in Economic Sciences in memory of Alfred Nobel, the award was established in 1969 and is now widely considered one of the Nobel prizes.

Last year's award went to two researchers from the MIT and a third from Harvard University, for their groundbreaking research into efforts to reduce global poverty.

Few economists could have predicted last fall that the globe would come to a virtual standstill within months, as governments closed their borders, imposed lockdowns and ordered other measures to stop the spread of COVID-19, triggering a sharp dip in business activity worldwide. The prestigious award comes with a 10-million krona (USD 1.1 million) cash prize and a gold medal. The Nobel Committee awarded the prize for physiology and medicine for discovering the liver-ravaging hepatitis C virus. Tuesday's prize for physics honoured breakthroughs in understanding the mysteries of cosmic black holes.

OJEE begins at 53 centres

Bhubaneswar; Oct 12: The Odisha Joint Entrance Examination (OJEE) -2020 began at 53 examination centres across the state. Monday. The examination conducted in three sittings on the first day was attended by at least 71 per cent students, said sources.

The first session was from 9 am to 11 am while the second session started at 12:30pm and ended at 2:30pm. Likewise, the third sitting was from 4pm to 6pm.

On first day, entrance examination was conducted for Lateral Entry Tech (Diploma) aspirants. The examination will be conducted in four sittings for admission to B Pharm course, said OJEE sources.

For MCA and MBA admissions the entrance tests would be conducted in two and three sessions respectively. Similarly, for the B Tech course the tests would be of three sessions.

For aspirants seeking admission to Integrated MBA (IMBA), M Tech, M Arch, M Plan, M Pharm, LE Tech and LE Pharm courses examinations would be conducted in a single session.

"About 79,800 candidates have registered for OJEE 2020 exams. So, the tests were conducted in multiple sittings," informed OJEE chairperson Sudeep Kumar Chand.

All necessary measures, in compliance with COVID-19 guidelines, with respect to hygiene and social distancing, were taken at the test venues. Apart from OJEE. thousands of student also appeared for the Common PG Entrance Test (CPET), conducted by Higher Education department for the first time for admission to PG courses in state universities and colleges.

Around 62,000 students appeared for the test at 68 state universities and colleges for admission to about 14,700 PG seats. The exam will continue till October 22.

NHRC seeks ATR on petrol pump blast

Bhubaneswar, Oct 12: The National Human Rights Commission (NHRC) Monday issued notice to the Secretary of Petroleum & Natural Gas Ministry and Odisha Chief Secretary seeking an action-taken report (ATR) in connection with the explosion at an IOCL petrol pump near Raj Bhawan here October 7.

The rights body sought the ATR while hearing a plea filed by human rights activist Radhakant Tripathy. The NHRC has directed the authorities to submit their reposes within four weeks of the receipt of the order.

Meanwhile, Commissioner of Police Sudhanshu Sarangi has informed about stringent action



against the person found to be allowing negligence resulting in the blast that killed one person while left many injured. He said that stringent Sections like 304 of IPC corresponding to causing death by negligence will be added in the FIR if found any negligence during the course of investigations.

Sources also revealed that none of the officials of Indian Oil Corporation Limited (IOCL) were present during the refilling work on the day of mishap.

On the other hand, several videos reportedly shot a few hours before the explosion at the LPG tank have exposed lapses during the refilling work on the day of the mishap. In the videos, the workers were seen engaged in the work without any safety gears. The family members of the deceased Satya Nayak and missing Simanchala Parida have also alleged lapses during the work at the spot.

FY TO GET TWO MORE CREMATORIUMS

BMC IS FOCUSED ON ENSURING CONSTRUCTION OF THE TWO CREMATORIUMS WITHIN 45 DAYS: CHAUDHARY

Bhubaneswar, Oct 12: Taking note of the rising number of bodies accumulating near Satya Nagar crematorium here and the difficulties faced by locals, the civic body, Monday, declared that it will come up with two more crematoriums in the Capital city.

Briefing the media, Bhubaneswar Municipal Corporation (BMC) Prem Chandra Chaudhary said that the BMC will ensure setting up of two more crematoriums - one in Patia and another in Khandagiri-to reduce the burden on the existing crematorium at Satya Nagar.

"Number of cremations at Satya Nagar crematorium has gone up abnormally due to Covid-19 deaths. Besides, the crematorium is also receiving more bodies as the Puri district administration has banned cremation of bodies coming outside the district at Swargadwar to contain the spread of the virus," Chaudhary said.

The Commissioner also mentioned that while the crematorium at Patia will be gas-based, the Khandagiri one will run on electricity. Sources at BMC said that



the move has come soon after Ladies Forum of Satyanagar moved the Odisha Human Rights Commission (OHRC) alleging rise in number of cremations (both Covid and non-Covid cases) which was causing air pollution in the vicinity.

It is worth mentioning here that Orissa POST had earlier reported that the Capital Hospital had been receiving more than 15 bodies everyday and most of them were found to be Covid-19 cases. The hospital has recorded a 35 per cent rise in the patient inflow as various local medicals including sub-divisional hospitals in the periphery of the city are referring patients to the Capital Hospital. Furthermore, the dysfunctional electric furnace at Satya

Nagar crematorium had made things worse. Source at BMC also said that the civic body has been cremating nearly 25 bodies every day without using electric furnace. Moreover, relatives of patients who died due to the novel coronavirus are either not reporting or coming very late due to the fear of getting infected. However, responding to the is-

STATE'S CORONAVIRUS CASELOAD JUMPS TO 2,54,662 WITH DETECTION OF 2,423 FRESH CASES

Bhubaneswar, Oct 12: State's novel coronavirus disease (Covid-19) tally surged to 2,54,662 Monday as 2,423 people tested positive for the virus, while 18 more fatalities pushed the death toll to 1,040, an official of Health and Family Welfare (H&FW) department said.

The state's quarantine centres reported 1,417 infections and the remaining cases were detected during contact tracing.

Khurda district, comprising state capital Bhubaneswar, recorded 359 new cases followed by Angul (229), Sundargarh (195), Mayurbhanj 128 and Cuttack 118.

Five districts reported daily surge of over 100 positive cases.

For the third day, the state reported a decline in positive cases. While 2,854 positive cases were reported Saturday, it came down to 2,546 Sunday and to 2,423 positive cases Monday.

Angul, Oct 12: Angul district headquarters hospital has been struggling with shortage of gloves and sanitisers for the last one and a half months, forcing COVID-19 warriors; starting from doctors to frontline health workers to reuse their protective kits.

"We are not getting new gloves. So, we are forced to reuse the old gloves after washing and drying them after every single use. If no immediate step is taken to address the problem, it will definitely hamper the service," rued dermatologist and blood bank officer Dr Biswajit Samal. According to him, the same problem has hit the blood bank. While conducting various tests here, the staff is required to wear gloves. Missile 'Nirbhay' test fired after initial snag

Balasore, Oct 12: The Defence Research and Development Organisation (DRDO) Monday test fired the sub-sonic cruise missile 'Nirbhay' from the launch pad no-3 at the Integrated Test Range (ITR) at Chandipur off Odisha coast at 10.33 AM.

DRDO officials said that the missile developed snag during the flight test and the details of the snag were being ascertained, a DRDO official was quoted as saying.

'Nirbhay', developed indigenously by the DRDO, is a long range sub-sonic cruise missile capable of deep penetration into the enemy territory to strike high value targets with precision. The missile has a strike range of 800 km.

The missile is powered by a s

and able to target multiple places simultaneously.

The missile has a length of 6 metres, width of 0.52 metres, a wing span of 2.7 metres and weighs about 1,500 kg. It can carry nuclear warheads of up to 300 kg.

It may be noted here that 'Nirbhay' sub-sonic missiles have already been deployed in a limited number near the border with China. 'Nirbhay' missile is capable of flying at a speed of 0.7 Mach. Its fly-

ing capabilities include sea-skim-

ming and terrain-hugging which helps it evade enemy radars.

'Nirbhay' is the tenth missile test-firing by India's lead defence research organisation in the last 35 days. The DRDO's effort to fasttrack development of 'Made in India' strategic nuclear and conventional missiles - it has fired a missile every four days over nearly a month - comes against the backdrop of China's refusal to step back from the Line of Actual Control.

THE HISTORICAL STUPA BUILT IN THIRD CENTURY AD IS THE OLDEST OF THE ANCIENT **BUDDHIST STUPAS IN THE DIAMOND TRIANGLE IN JAJPUR**

Chandikhole, Oct 12: An ancient Buddhist stupa 'Parabhadi' here in Jaipur district is on the verge of extinction due to lack of conservation and proper upkeep, a report said.

The historical stupa built in third century AD is the oldest of the ancient Buddhist stupas in the Diamond Triangle in the district. The Archeological Survey of India (ASI) has not spent a single pie on its maintenance since its discovery for which it is in a state of complete neglect and slowly inching towards extinction, the report added. This is the reason why nothing is known what lies inside the Parabhadi stupa. The mystery that lies underneath could be unraveled if the ASI takes up its excavation works, historians said.

Diamond Triangle is a collection of three Buddhist sites of Ratnagiri, Udaygiri and Lalitgiri. The sites belong to the Vajrayan sect of Buddhism, which is popularly known as the Diamond Vehicle, and hence the name Diamond Triangle.

Reports said Odisha has carved a niche for itself in national and international map for presence of several ancient Buddhist shrines in the state. This is the reason for which many national and international Buddhist conferences and seminars have been held in the state. These conferences provide a platform to knowledge seekers and scholars to visit these shrines and explore the history in its totality.

Sources said the Parabhadi

cavation of Parabhadi Buddhist stupa was forgotten.

Historian and Buddhist researcher Harish Chandra Prusty said the Parabhadi stupa came to knowledge when Chinese traveler Hiuen Tsang visited Odisha during his India tour. He visited the site and conducted a review of the ancient stupa. The Parabhadi stupa finds mention in the 'Si-yu-ki' book written by the Chinese traveler.

The stupa was 40-ft in height when the ASI took the site in its possession. However, due to constant erosion and for other reasons the height of the stupa has been reduced to 15-ft and is on the verge of extinction due to lack of maintenance.

Historian Prusty said that the Parabhadi stupa is similar to the Buddhist stupas at Sarnath, Sanchi, Nagarjun Kenda and Barbodar in Java. The site might be initially known as Parabodhi but later became Parabhadi as Siddharth Goutam got his en-

known as Tapsu and Bhalluka took the leading role in construction of the Parabhadi stupa. The Buddhist stupa on Landa hill in Lalitgiri and the Parabhadi stupa are of the same time period, he said.

King Ashoka while working towards spread of Buddhism in the world made efforts to conserve the precious articles of Lord Buddha and stupas of the time. The bone relic of Lord Buddha was discovered from the stupa at Lalitgiri. The relics were stored in three small containers wood, silver and gold. The three containers have been conserved in a bullet proof museum built at Lalitgiri last year.

When contacted, Manas Ranjan Sahu, assistant superintendent of ASI said maintenance of the site has not been taken up due to lack of funds. They will certainly take up excavation and conservation of the site if any budgetary allocation is made in this regard.

China in mission mode

efence Minister Rajnath Singh today stated the obvious when he said there is a Pakistan angle to the aggressive Chinese movements in Ladakh region and along the LAC in recent months. He said the creation of a dispute in Ladakh was part of a 'mission', first by Pakistan and then by China. This was only to be expected, given the kind of association that China and Pakistan had over time, which the present day Indian establishment watched with considerable disinterest or surprising casualness. Trouble was in the making. Pakistani forces lay low for quite some time of late, but have resorted to unprovoked firing along the western line a few days ago, at the precise time when Indian attention remained concentrated on eastern Ladakh region. Quite likely, India could be faced with a two-front war, requiring us to divide attention between the northern and western borders. To add to India's predicament, Nepal has strayed away from its long-cherished ties with the southern neighbour and edged closer to China. It could also be that Nepal too could be drawn in by China to take on India. Nepal has already raised problems along its border with India. It came up with ticklish issues like a demand for return of nearly ₹1,000 crore of banned high-denomination Indian currency - done back in 2016. This will have serious implications. The trouble between India and Nepal started shortly after the turn of the century when King Birendra was assassinated in what was touted as a family fight in the palace. Thereafter, with democracy eventually gaining ground, Nepal's drift away from India started. The Himalayan nation adopting a new Constitution, making it a secular nation instead of the old status of being a Hindu nation, too strained bilateral ties as the Modi government did not take kindly to it. China is closer to Myanmar and is building economic bridges with Bangladesh too. A critical security situation is developing around India. China has lasting ties with Sri Lanka; and it stepped into Maldives too. Despite all these, point to note is that India is not giving adequate attention to either change the environment better for itself or equip itself with better military power. Fact that China is now having a five-time stronger military – as against an equal footing 20 years ago – makes the scenario more complex. China is bound to take on India in aggressive manners, and Pakistan is simply biding its time.

Rajnath's utterances, therefore, seem childish as even a common Indian citizen is able to grasp the utter failure in diplomacy as demonstrated by the Modi government in the past seven years. Bravado at home and unacceptability abroad has become the hallmark of the present administration.

Farm reforms face odds

The intervention of the Supreme Court on Monday to re-examine the recently passed farm Bills was only to be expected. Farmers in various states are upset with the provisions of the new Central legislation and are protesting even in the face of the health risks involved in the Covid-19 pandemic times. The court rightly noted that if the matter was not taken up now, the reforms could face problems later when its implementation gains pace. The Centre is also realising that talks are the way forward. It has called for a meeting with protesting farmers, and the Punjab government too has followed suit. The Bhartiya Kisan Union has rejected the offer of talks from the Modi government and is insisting on repeal of the law. At a time when the nation is caught in a serious economic mess, it is important to cool tempers, rather than having further disruption of public peace and order. A grave error on the part of the government was to avoid discussions with stake-holders and the Opposition before such a reform was pushed through in great speed, and at the most-inopportune time. The feeling that Modi's will is India's will is akin to the "Indira is India, India is Indira" days of Dev Kant Barooah and cronies. Such a concept must never be allowed to fester in the minds of elected leaders in any democracy. These mistaken perceptions of individuals prove very expensive and damaging for societies and nations.

Better sense never prevails when one occupies a throne of great power and crowding cronies blind and deafen common sense.

hy do people repay a loan? Firstly, because they are bound by a loan contract to repay. If they break the contract. there could be a remedy in the form of a punishment or penalty. Secondly, if the loan is against a pledged collateral, then non-repayment can result in the loss of that collateral. Often the value of the collateral is more than the value of the loan. Hence, it is better to repay rather than suffer a bigger loss. Thirdly, repayment creates good credit history. That becomes part of a public record, which is useful for getting future loans.

Indeed, in the case of micro-finance loans, which have zero collateral, repayment helps the borrower remain in good standing in the eyes of the lender. Thus, repayment ensures the availability of repeat loans. In informal markets such as vegetable vending, a loan could be taken every day, used in purchasingproduce from wholesale markets, selling it as retail vending, and repaying the loan with interest at the end of the day.

A fourth reason for repayment, especially valid in informal markets, could be due to sheer coercive power, or threat of physical harm. Lastly, repayment of a loan could also be due to the moralistic value, that non-repayment is a sin. Not repaying your debts is tantamount to a sin. As we can see, there are many angles to loan repayment, and the sum total of all this is what is called 'credit discipline'

The economy works if credit discipline is sound and ingrained in both borrowers and lenders. It is this that has to be nurtured and reinforced to ensure that credit becomes available to all who need it. It is credit creation which leads to the expansion of economic activity and growth. An individual may take a loan for education or buving a house. It represents borrowing from his or her future earnings, to build an asset (education degree or a house) for the present. Similarly, a company may borrow to fund working capital needs, or capacity expansion and loan repayment occurs from future earnings. Underlying all this is the foun-



At a time of recession, when the banking system may have additional bad loans amounting to ₹4 lakh crore by next March, it is critically important to shield banking from the ill effects of waivers and moratorium extensions. As the RBI itself submitted to the court in its affidavit, the problem now calls for a comprehensive loan restructuring package through fiscal resources, rather than extending waivers and vitiating credit culture

dation of a strong credit discipline. The banking system critically depends on a credit culture, so that despite legitimate defaults on loans (due to business downturns), it can serve the needs of a growing economy. Hence when repayment is halted by official sanction, it becomes a very critical decision, with long-term and deep consequences. Thus, when a political decision is taken to give loan waivers to farmers, it has consequences on credit culture. Firstly, it is unfair on those farmers who toiled hard to repay and avoid default. Secondly, with repeated waivers, it encourages behaviour of ignoring repayment discipline. Thirdly, it makes bankers and lenders circumspect and avoids lending altogether. It could lead to credit contraction rather than expansion.

But, in times of acute distress, there is no alternative to loan waivers as an emergency medicine. Even in such cases, a moratoriumor loan restructuring is preferable, rather than an outright waiver. The former leaves open the possibility of repayment, by adjusting the time-table. If a

waiver which is less preferable. or a moratorium that is better for credit culture, is decided by the government, then the lender needs to be compensated from the fiscal resources, i.e., by taxpayers. Will the taxpayer agree that this in the best interest of all? What if the lender has been hurt by wilful defaulters? What if there has been fraudulent lending based on collusion and corruption?

Is it fair to impose the burden of the consequent bad loans on taxpayers? Are public sector banks and cooperative banks more prone to defaults and fraudulent lending? How do we improve governance and credit management in public sector and cooperative banks? These arequestions beyond the scope of the present column.

The question of protecting and nurturing credit culture has become relevant due to ongoing public interest litigation in the Supreme Court. The RBI as regulator of all banks allowed a sixmonth moratorium on repayment of all term loans, including home loans, credit card outstanding dues and other retail loans. This was a

temporary measure to help bor

rowers tide over problems of cash flows caused by the sudden stoppage of economic activity after the severe lockdown. However, during the moratorium, interest and repayment dues were accu mulating. The total amount of loans affected is more than ₹38 lakh crore, so that the accrued interest during six months itself is about ₹2 lakh crore This accrued interest whose payment has been postponed itself is like a fresh loan, whose interest burden in turn is about ₹5,000 crore.

The petitioners in the Supreme Court are seeking a waiver of interest on interest. It amounts to denting credit culture. Paying interest is equivalent to paying the time value of money. It is the interest earnings of banks that allows them to repay their depositors with interest on savings and fixed deposits. If those interest earnings are denied, the banks will suffer, and will have to ask for a fresh equity infusion from their owners, shareholders, Since the government is the principal shareholder of public sector banks, it amounts to asking taxpayers for help. So, we are back to square one. Rather than imposing an unfair burden on banks, it isbetter that the government take it squarely on their chin, and give relief directly from the exchequer, i.e., the taxpayer funds. Otherwise, waiving of interest will cause harm to the credit discipline and to a culture built painstakingly over the years.

At a time of recession, when the banking system may have additional bad loans amounting to ₹4 lakh crore by next March, it is critically important to shield banking from the ill effects of waivers and moratorium extensions. As the RBI itself submitted to the court in its affidavit, the problem now calls for a comprehensive loan restructuring package through fiscal re sources, rather than extending waivers and vitiating credit culture. It is imperative that the court recognises this larger danger.

Tussie-mussie

thought was, "what in the name of everything wonderful is a 'tussiemussie'?" A visit to the Web site of the Royal Horticultural Society sorted that out: "Tussie-mussies are posies assembled from a carefully chosen selection of flowers and herbs, usually to convey a specific message." However, some dictionaries said, "Origin unknown". The Oxford English Dictionary is a little more forthcoming. It says that it may be a rhyming reduplicated form of tussy. This may in turn have come from an unrecorded word tus or tusse in the sense of a nosegay or garland of flowers. So its history is indeed poorly understood and "origin unknown" is a pretty good summary. The word has gone through lots of different forms, suggesting that its early users were as uncertain about its antecedents as we are today. Its first recorded appearance was in about 1440, when it was written as tusmose. In later centuries the spelling settled down to tuzzy-muzzy. By the end of the 17thCentury it seems to have disappeared from the standard language. The reason for this may lie in an entry in Captain Francis Grose's Dictionary of the Vulgar Tongue, dated 1811, which says "TUZZY-MUZZY. The monosyllable.' Jonathon Green's Cassell's Dictionary of Slang says it was then a slang term for the vagina, so that "the monosyllable" was presumably cunt. William Dugdale was a famous publisher of porn in London (the Dictionary of National Biography says of him, "During the 1840s he made his name as the largest publisher of obscene titles in England, a position unchallenged for over twenty years.") One of his titles was a song book entitled The Tuzzymuzzy Songster. The term was reintroduced around the 1940s in its original sense of a nosegay by someone who was ignorant of its by then long-defunct slang associations. In the process the spelling was changed to tussie-mussie. The first modern case I can find is in the rules for a flower show in Dixon, Illinois, in September 1947. Altogether, a very interesting word.

Fear psychosis, loss of livelihood, abrupt changes in lifestyle including work conditions as inevitable offshoot of Covid-19 have contributed to the burden of mental diseases. "The novel coronavirus is not only attacking our physical health, it is also increasing psychological suffering: grief at the loss of loved ones, shock at the loss of jobs, isolation and restrictions on movement, difficult family dynamics, uncertainty and fear for the future," warned UN Secretary-General Antonio Guterres.

Yet, with lessons learnt, new lifestyle modalities adopted as a working arrangement could be set with a sensible and pragmatic approach to life. We must understand that problems in realistic life are not that bad as they are made out to be.

Kolkata, Oct 12: Supply of essential commodities in West Bengal is likely to be disrupted as around six lakh truckers went on a 72hour strike from Monday, demanding immediate implementation of revised carrying capacity for goods vehicles among others.

Federation of West Bengal Truck Operators' Association president Subhas Bose said the strike has been called mainly to demand a 25 per cent increase in maximum safe axle weight for goods vehicles plying in West Bengal, claiming that other states have already implemented the rule.

"Revised norms of safe axle weights for transport vehicles have been implemented across the country except West Bengal," he told PTL

Barring a few, around six lakh trucks have gone off-road in the state in support of the strike, Bose said.

"We have requested all the truckers' associations to join the 72hour strike. Most of the organisations participated in the protest but some have not," Bose said.

A body of truckers operating at the port here and the Calcutta Goods Transport Association have not participated in the strike.

The truck operators also demanded the removal of unnecessary no-entry points on highways, withdrawal of tax levied at toll plazas and waiving off the road tax for the current fiscal in the wake of the COVID-19 pandemic.

The FWBTOA had earlier written to Prime Minister Narendra Modi, urging him to withdraw the tax levied at toll plazas.

former Chief Minister Kamal Nath has intensified over the symbolic 'coconut'.

Kolkata, Oct 12: Trams have always been a part of Kolkata's charm, and what better time than Durga puja, the biggest festival here, to take a joy ride across the city and catch a glimpse of the popular marquees, all the while avoiding crowd amid fears of COVID-19 transmission.

The West Bengal Transport Corporation (WBTC) has decided to roll out air-conditioned trams on 'Saptami' and 'Nabami' -- two of the five festival days giving passengers an opportunity to check out the Durga pandals, and click photographs through the large glass windows of the electricity-operated vehicles, an official said.

"We will ensure that the festive fever grips each of our passengers, as dhak music will be played all along the journey and snacks will be served on board the decked-up trams,' said Rajanvir Singh Kapur, the managing director of WBTC -- which runs the only existing tramway of the

Passengers would have access to would also go past the iconic landfree Wi-fi inside the trams, which marks in the metropolis, he said.



"Amid the COVID-19 gloom, we are trying to revive the charm that the city beholds, weaving the tram ride with the biggest festival," Kapur said.

According to the official, the joyride will cost Rs 500 per passenger, including refreshments and on-board guide.

Pandals in the northern part of the city will be unveiled on October 15, those in the Behala and Jadavpur areas the next day and the ones in south Kolkata the day after," the chief minister said. She asked puja committees, willing to invite her for inauguration, to write a mail to her office, and said arrangements would be made accordingly. The CM further said she would be unveiling the pandals around 5 pm on the three days. Later in the day, she visited a popular pandal in the city, patronised by her cabinet colleague Firhad Hakim, and drew the eyes of goddess Durga on her idol, as part of a religious ritual. Banerjee, on the occasion, urged the puja organisers at Chetla Agrani club to strictly abide by COVID-19 protocols. 'Chokkhudan', or the ritual inviting the goddess to Earth by drawing eyes on her idol, is usually performed by the craftsman on the day of Mahalaya, which heralds 'Devi Paksha' or the beginning of Durga puja. This year, however, Mahalaya was observed a month ahead of the festival. Banerjee had been performing the ritual for Chetla Agrani club since 2014. Hakim, who holds the urban development and municipal affairs portfolio, was present at the ceremony, along with other members of the puja committee.

New Delhi, Oct 12: After Pakistan, China is also creating a dispute at the border with India as if it was part of a "mission", defence minister Rajnath Singh said Monday, as Indian and Chinese troops remain locked in a standoff in eastern Ladakh for over five months.

The defence minister, speaking at an online event after inaugurating 44 bridges, said India is not only facing the situations along the frontiers resolutely, but it is also bringing in major development including in border areas. "You are well aware of the conditions created along our northern and eastern borders. First it was Pakistan, and now also by China, as if a border dispute is being created under a mission. We have a border of about 7,000 km with these countries where the tension con-

The bridges inaugurated by Singh included 10 in Jammu and Kashmir, eight in Ladakh, two in Himachal Pradesh, four each in Punjab and Sikkim and eight each in Uttarakhand and Arunachal Pradesh.

In his address, Singh complimented the Border Roads Organisation (BRO) for their achievements in improving infrastructure in border areas and said that dedication of 44 bridges in one go in itself was a record. He said the annual budget of BRO that varied from Rs 3,300 crore to Rs 4,600 crore in years between 2008 and 2016, saw a substantial rise and is pegged at over Rs 11,000 crore in 2020-21.

2 militants killed

Srinagar, Oct 12: A top Pakistani Lashkar-e-Toiba terrorist and his local accomplice were killed Monday in a fierce gunbattle with security forces in Old Barzulla area of Srinagar, police said.

Saifullah, the Pakistani terrorist who masterminded at least three attacks on security forces during the past month, was killed in the encounter with security forces, a police official said. He said Saifullah was the first Pakistani terrorist to be killed in several years during an operation in Srinagar. Security forces had launched a cordon and search operation in Old Barzulla locality of the city in the early hours of Monday after receiving specific inputs about the presence of militants in the area, the official said. He said around 7:45 am, when the searches were going on, militants

fired upon the forces, leading to an encounter: Two militants were killed in the gunfight, the official said.

Director General of Police (DGP) Dilbag Singh said Saifullah was a Pakistani and a top commander of the LeT and was involved in several recent attacks on security forces in and around Srinagar."A top Lashkar commander from Pakistan named Saifullah has been killed in the operation. He was involved in three back-to-back major attacks on security forces in Nowgam, Chadoora and Kandizaal here," Singh told a press conference at police control room here.

The DGP said Srinagar city has witnessed eight encounters so far this year in which 18 militants have been killed. "In total, this

year so far 75 successful anti-militancy operations have been carried out in which 180 terrorists have been killed. Also, 138 militants and their associates have been arrested this year. In terms of operational achievements, it is a record of sorts compared to the last year. The number of both killed and arrested is more this year than the last year,' he said.

The UT's police chief said all the anti-militancy operations conducted this year were clean and were undertaken in a professional manner."Barring one operation at Batamaloo Srinagar, in which a woman got killed unfortunately in a crossfire, all operations were cleanly conducted by the security forces." he said.

Asked about the number of fatalities on the security forces' side, Singh said this year, 19 J&K policemen lost their life, while 21 CRPF personnel and 15 Army soldiers -- majority of them were on the LoC – were killed in the UT.

Asked whether Lashkar and other outfits were trying to set their foot again in the Srinagar city, the DGP said the security forces were able to take care of the militants because of an effective intelligence network.

"Lashkar and all are trying to find their foothold in the city, but our int (intelligence) network is quite good and quite effective and it is because of this effective network that our troops have been able to find them and take care of them," he said. He said at present only one militant was active in the city and so far has been involved in a couple of attacks on the security forces.

Oct 12: Although coming Bihar Assembly elections are unique in many ways since the campaigning and balloting will be held amid coronavirus pandemic, the voters will miss RJD leader Lalu Prasad's light-hearted jibes and potshots at his political rivals since he is in jail after conviction in fodder scams.

Also missed in the political arena will be Lok Janshakti Party leader and Union Minister Ram Vilas Paswan who breathed

his last in Delhi October 8. Veteran socialist and former RJD leader Raghuvansh Prasad Singh would be another leader conspicuous by his absence from the poll battle. Singh, who was close to Lalu, had died September

13 at AIIMS in Delhi. Most political parties have announced their candidates for majority of the seats in the runup to the elections. Regional parties will focus on small ral-

lies instead of big ones in view of the COVID guidelines.

Lalu Prasad, a star campaigner of the Rashtriya Janata Dal in the past elections, has been a crowd-puller capable of changing the course of electioneering and election results with his oratory. But the former Railway Minister will not be able to showcase his skills as he is admitted in Rajendra Institute of Medical Sciences in Ranchi. He cannot participate in campaigning without court permission.

Even RJD leaders admit they miss Lalu Prasad's absence in these elections. Party leader Mrityunjay Tiwari pointed out that the jailed RJD supremo was not only a star campaigner in Bihar but across the country.

The importance of Lalu Prasad and Raghuvansh Prasad can be gauged from the fact that in the 2015 elections, both participated in 170 and 100 RJD rallies and roadshows respectively.



Patna, Oct 12: Seven men in Bihar's Buxar district gangraped a woman and killed her 5-yearold son, an official said Monday. One person has been arrested.

Corona 'extremely robust' for 28 days on glass, currency: Study

New Delhi, Oct 12: The novel coronavirus responsible for COVID-19 may survive for up to 28 days on common surfaces including banknotes, glass -- such as that found on smart phone screens -- and stainless steel. according to a laboratory study by Australia's national science agency. The finding, published in the

Virology Journal, shows that SARS-CoV-2 can remain infectious on surfaces for long periods of time, reinforcing the need for good practices such as regular hand washing and cleaning surfaces.

The research, undertaken at the Australian Centre for Disease Preparedness (ACDP), found that SARS-CoV-2 survived longer at

lower temperatures and on nonporous or smooth surfaces such as glass, stainless steel and vinyl, compared to porous complex surfaces such as cotton.

The researchers at CSIRO, Australia's national science agency, also found that the novel coronavirus survived longer on paper banknotes than plastic banknotes."Establishing how long the virus really remains viable on surfaces enables us to more accurately predict and mitigate its spread, and do a better job of protecting our people," said CSIRO Chief Executive Larry Marshall.

"At 20 degrees Celsius, which is about room temperature, we found that the virus was extremely robust, surviving for 28 days on smooth



surfaces such as glass found on mobile phone screens and plastic banknotes," Debbie Eagles, Deputy Director of ACDP added.

For context, similar experiments for Influenza A have found that it

survived on surfaces for 17 days, which highlights just how resilient SARS-CoV-2 is, the researchers said. The study involved drying the virus in artificial mucus on different surfaces, at concentrations similar to those reported in samples from infected patients and then re-isolating the virus over a month.

Further experiments were carried out at 30 and 40 degrees Celsius, with survival times decreasing as the temperature increased. The study was also carried out in the dark, to remove the effect of UV light as research has demonstrated direct sunlight can rapidly inactivate the virus. 'While the precise role of sur-

face transmission, the degree of surface contact and the amount of virus required for infection is yet to be determined, establishing how long this virus remains viable on surfaces is critical for developing risk mitigation strategies in high contact areas," Eagles said.

According to Professor Trevor Drew, Director of ACDP, many viruses remained viable on surfaces outside their host. "How long they can survive and remain infectious depends on the type of virus, quantity, the surface, environmental conditions and how it's deposited -- for example touch vs droplets emitted by coughing," Drew said. "Proteins and fats in body fluids can also significantly increase virus survival times," he said.

The study may also help to explain the apparent persistence and spread of SARS-CoV-2 in cool environments with high lipid or protein contamination, such as meat processing facilities and how wemight better address that risk, the researchers said.

Mumbai, Oct 12: A rare citywide power outage paralysed Mumbai Monday, halting local train services, trapping people in lifts and disrupting work from home adopted by millions during the ongoing pandemic.

Power restoration efforts began on "war footing" and pocket-wise resumption in supply was started around 12 noon onwards, nearly two hours after the outage.

Trains services took two and half hours to resume operations. beginning with CR's Harbour Line. The trains are carrying only essential services workers at present, which helped minimise the

passenger inconvenience. Both the Western Railway and Central Railway blamed the power cut from Tata Power (their power supplier) for the disruption in services.

With work-from-home becoming the norm across the services sector, employee output was impacted as the homes do not have power back-ups like institutional bodies.

However, a few were not so lucky, like the employees working in an upscale business complex in central Mumbai who found themselves stuck in an elevator during times of social distancing. After a few jittery minutes, they were evacuated. In June 2018, there was a widespread power outage in the city and adjoining areas due to a technical glitch and also led to sustained period of load-shedding for

Maharashtra Chief Minister Uddhav Thackeray took serious cognisance of a massive power outage in the Mumbai Metropolitan Region (MMR) and ordered an immediate probe into it. State Energy Minister Nitin Raut also said the reasons behind the technical snag that caused power failure in parts of the MMR will be probed once the electricity supply is restored.

18,000 tonnes of nCoV waste generated in India since June

New Delhi, Oct 12: India generated 18.000 tonnes of COVID-19 biomedical waste in the last four months, with Maharashtra contributing the maximum (3,587 tonnes) to it, according to Central Pollution Control Board (CPCB) data.

According to the data received from state pollution control boards, all states and Union Territories have since June generated 18,000 tonnes of COVID-19related biomedical waste which is being collected, treated and disposed of by 198 common biomedical waste treatment facilities

(CBWTFs). COVID-19 biomedical waste could include PPE kits, masks, shoe covers, gloves, human tissues, items contaminated with blood, body fluids like dressings, plaster casts, cotton swabs beddings contaminated with blood or body fluid, blood bags, needles, syringes etc.

According to the data, Maharashtra, which has reported over 15 lakh coronavirus cases so far, generated 3,587 tonnes of COVID-19 waste in four months -- 524 tonnes in June, 1,180 tonnes in July, 1,359 tonnes in August and 524 tonnes in September.

Kerala houseboats ready to greet tourists again

Alappuzha (Kerala) Oct 12: After a long wait of seven months. the houseboat industry in Kerala is ready to greet tourists again.

The Kerala government has given its nod to all tourist activities to resume from Monday, while the beaches will open from November 1.

Alappuzha, often referred to as the Venice of the East, offers an exquisite facility to tourism -- houseboats -- the once forgotten traditional rice boats, which used to carry paddy from the fields to the markets or to the barns.

After the Covid pandemic struck in March, the businesses of over 800 houseboats plying the famed Vembanad lake came to a grinding halt. After almost seven months, the authorities



have given the permission to rehouseboats ready for tourists. Speaking to IANS, Tomy Pulikattil, sume activities from Monday and the houseboat owners and the who owns a fleet of houseboats workers are now busy getting the ranging from single bedroom to

six-bedroom, said they are all ready and are waiting for the guests. We have started to contact the guests who got in touch with us in the recent past to check if the houseboats were operating. We have decided to offer 25 per cent discount to all our guests who travel with us.'

'The last seven months were like a nightmare for all of us, as we were having a hand-to-mouth existence. We also had to pay our permanent employees," said Pulikattil. On Monday, the houseboat owners were engaged in last minute cleaning and making the boats ready for welcoming the tourists.

The boats are being sanitised and for that a new pump has been bought. Employees have also been trained to follow the COVID protocols. The biggest houseboat plying here is a 10-bedroom houseboat, while a huge majority are one and two-bedroom ones, and the minimum tariff is ₹6,000 for a 24-hour trip.

'We have been drained completely because of no business. We did raise our concerns with the Kerala government and the report is that all will be given a maintenance grant of ₹1 lakh. Depending on the size of the houseboat, the total expenses will go up to ₹4 lakh," added Pulikattil.

According to the present Covid guidelines, tourists arriving from outside the state but not for more than seven days need not undergo any quarantine.

However, they have to carry a COVID negative certificate. Those who wish to remain in the state bevond a week will have to undergo quarantine for seven days.

A bench, comprising Justices Rakesh Kumar and J Uma Devi, directed the CBI to register an FIR and submit a report in eight weeks.

During the course of hearing, the Court expressed displeasure over the investigation by the state Crime Investigation Department (CID) and commented that cases were not registered against the YSRC leaders only to save them. It directed the state government to cooperate with the CBI in the investigation. The High Court had on its own taken cognizance after a series of alleged derogatory posts were made on social media platforms against judges and the judiciary following some verdicts that went against the state government.

On the directions of the High Court, its Registrar General lodged a complaint with the CID giving names and related evidence but the state police wing reportedly booked only nine people.

The court took serious note of the \rightarrow comments made by Assembly Speaker Tammineni Sitaram, Deputy Chief Minister Narayana Swamy, MPs V Vijayasai Reddy, Nandigam Suresh, former MLA A Krishna Mohan and other leaders of the ruling YSRCand questioned the CID why cases were not registered against them.

EU weighs **Russia sanctions**

Brussels: European Union foreign ministers were weighing Monday whether to impose sanctions on Russian officials and organizations blamed for the poisoning of opposition leader Alexei Navalny with a Soviet-era nerve agent. The ministers, meeting in Luxembourg, are considering a proposal from France and Germany to freeze the assets of those suspected of involvement and ban them from travelling in Europe under sanctions to combat the use and spread of chemical weapons. Navalny, an anti-corruption investigator and major political opponent of Russian President Vladimir Putin, fell ill August 20 during a domestic flight in Russia.

6 kidnapped near Pak-Iran border

Islamabad: At least six pilgrims were abducted by unidentified armed assailants near the Pakistan-Iran border, the media reported. The treaty has been in force since 2011 and is due to expire in February 2021 with a possibility to be renewed for another five years.

Trump claims he is immune to Covid-19



Washington, Oct 12: US President Donald Trump claimed Sunday that he is now "immune" from the coronavirus, though medical research has suggested it is possible to be re-infected with the virus. "It seems like I'm immune,

so I can go way out of a basement," Trump said in an interview on Fox News.

"It looks like I'm immune for, I don't know, maybe a long time, maybe a short time. It could be a lifetime. Nobody really knows," Trump added. Xinhua news agency reported.

White House physician Sean Conley said on Saturday that the president, who tested positive for Covid-19 October 1 and was later hospitalized for three days before returning to the White House with continued treatment, is "no longer considered a transmission risk to others." However, Conley did not disclose when Trump last had a negative test result.

A study published in September in the journal Nature Medicine, however, indicated that recovery from the coronavirus does not confer lifetime immunity.

Before and after Trump's infection, a number of White House staff members have also tested positive for the virus.

China sets new rules for Haj pilgrims

Beijing, Oct 12: China has released new regulations for Muslims visiting Saudi Arabia for annual Haj stipulating that the pilgrimage should be organised only by the country's Islamic Association and pilgrims should follow Chinese laws and oppose religious extremism.

There are 20 million Muslims in China, mostly Uyghurs - an ethnic group of Turkic origin - and Hui Muslims. who are of Chinese ethnic origin. Both Uyghurs and Hui Muslims have a population of about 10 million each, according to an official white paper. About 10.000 Chinese Muslims perform Haj every year. The new regulation issued for Haj pilgrimage has a total of 42 articles, including one that stipulates that Chinese Muslims' pilgrimage should be organised in accordance with laws, and the Chinese Islamic Association is the only organisation that is authorised to arrange for Chinese Muslims to go to Mecca in Saudi Arabia to perform Haj. No other organisation or individual should organise the trips, and Chinese citizens should meet basic requirements when applying for the Haj, the regulation, which would be implemented from December 1, stipulates, state-run Global Times reported. People who go overseas to perform Haj should abide by China's and the destination countrv's laws and regulations, and oppose religious extremism, according to the regulations

FATF keeps Pakistan on 'Enhanced Follow-Up List'

Islamabad, Oct 12: Noting that Pakistan's measures against money laundering and terror-financing "is not yet sufficient to justify a rerating", a regional affiliate of the Financial Action Task Force Monday retained the country on its "Enhanced Follow-up" list, ac-

cording to a media report. The development came only a few weeks ahead of the meeting of the FATF - the Paris-based global money laundering and terrorist financing watchdog - to decide on Pakistan's grev list status.

The first Follow-Up Report on Mutual Evaluation of Pakistan released by the Asia-Pacific Group (APG) underlined that the country's progress on the 40 FATF recommendations on the effectiveness of anti-money laundering and combating financing terror (AML/CFT) system largely remained unchanged - non-compliant on four counts, partially compliant on 25 counts and largely compliant on nine recommendations, the Dawn News reported. Pakistan has improved its full compliance on only two of the

As many as 4,541 rape cases have been reported Bangladesh in the past 16 years and the accused were punished in only 60 of these incidents, according to data from the tribunals.

At least 889 women have been raped in Bangladesh between January and August 2020, rights group Ain O Salish Kendra said. As many as 192 others faced at-

tempted rapes and sexual harassment in this period, while nine of the victims took their own lives, bdnews24 reported.

Rights activists believe the numbers are much higher because many of the victims do not complain to the police

Climate change spurs doubling of disasters since 2000: UN

Major disasters occurred between 2000 and 2019, claiming 1.23 lives, affecting 4.2 billion people and costing the global economy some \$2.97 trillion

Geneva, Oct 12: Climate change is largely to blame for a near doubling of natural disasters in the past 20 years, the United Nations said Monday.

The UN Office for Disaster Risk Reduction said 7,348 major disaster events had occurred between 2000 and 2019, claiming 1.23 lives, affecting 4.2 billion people and costing the global economy some \$2.97 trillion. The figure far outstrips the 4,212 major natural disasters recorded between 1980 and 1999; the UN office said in a new report entitled "The Human Cost of

Disasters 2000-2019" The sharp increase was largely attributable to a rise in climate-related disasters, including extreme weather events like floods, drought

and storms, the report said. Extreme heat is proving espe cially deadly. "We are wilfully de-structive," UNDRR chief Mami Mizutori told reporters in a virtual briefing. "That is the only conclusion one can come to when reviewing disaster events over the last 20 years.' She accused governments of not doing enough to prevent climate

hazards and called for better preparation for looming disasters.

'UPHILL BATTLE "The odds are being stacked

against us when we fail to act on science and early warnings to invest in prevention, climate change adaptation and disaster risk reduction. she said. The report did not touch



on biological hazards and diseaserelated disasters like the coronavirus pandemic, which has killed over one million people and infected over 37 million in the past nine months. But Mizutori suggested coronavirus was "the latest proof that political and business leaders

are yet to tune in to the world around them". Monday's report showed 6,681 climate-linked events had been recorded since the turn of the century, up from 3,656 during the previous 20-year-period.

While major floods had more than doubled to 3,254, there had been 2,034 major storms up from 1,457 in the prior period. Mizutori said public health authorities and rescue workers were "fighting an uphill battle against an ever-rising tide of extreme weather events".

While better preparedness and early warning systems had helped bring down the number of deaths in many natural disaster settings, she warned that "more people are being affected by the expanding climate emergency". DEADLIEST DISASTERS

Monday's report relied on statistics from the Emergency Events Database, which records all disasters that kill 10 or more people, affect 100 or more people or result in a state of emergency declaration. The data showed that Asia has suffered the highest number of disasters in the past 20 years with 3,068 such events, followed by the Americas with 1,756 and Africa with 1,192.

In terms of affected countries, China topped the list with 577 events followed by the United States with 467. While a warming climate appeared to be driving the number and severity of such disasters, there had also been an increase in geophysical events like earthquakes and tsunamis that are not related to climate but are particularly deadly.

The deadliest single disaster in the past 20 years was the 2004 Indian Ocean tsunami, with 226,400 deaths, followed by the Haiti earth-quake in 2010, which claimed some 222,000 lives.

April-June quarter. The additional capex by Centre will be invested on roads, defence

Industrial production contracts 8% in Aug

New Delhi. Oct 12: Industrial production declined by 8% in August, mainly due to lower output of manufacturing, mining and power generation sectors, official data showed Monday.

According to the Index of Industrial Production (IIP) data, manufacturing sector production registered a decline of 8.6%, while the output of mining and power segments fell 9.8% and 1.8%, respectively. The IIP had contracted by 1.4% in August 2019.

It may not be appropriate to compare the IIP in the post pandemic months with the IIP for months preceding the COVID 19 pandemic," the Ministry of Statistics and Programme Implementation said in a statement.

While Shane Watson and Faf du Plessis have had decent outings so far, CSK need a stronger show from their faltering middle-order to.

After facing brickbats for per-sisting with Kedar Jadhav, CSK dropped him in their last match and his replacement Narayan Jagadeesan (33 off 28) made a decent score in the company of Ambati Ravudu (42 off 40). However. CSK's chase fell apart after the duo departed.

The likes of Sam Curran, Ravindra Jadeja and Dwayne Bravo too failed to come to the team's rescue. Dhoni himself has not been able to force the pace while chasing and the skipper had no qualms in admitting the flaws in his batting department.

'Batting has been bit of a worry. We need to do something about it," Dhoni had said. "I think we are better off playing the other way round – play the big shots and even if you get out, it is fine because we can't leave too many after the 15th or the 16th over. That just puts too much pressure on the lower order batsmen."

On the bowling front, Deepak Chahar and Jadeja were impressive the other night and Bravo's return was a welcome relief but the likes of Curran, Shardul Thakur and Karn Sharma need to pull up their performances. The tie also provides Dhoni and Co. a chance to avenge their seven-run loss to SRH in their previous outing.

SRH, on the other hand, are only a tad better-placed than CSK at the fifth spot with three wins from seven games. But the five-wicket defeat to Rajasthan Royals Sunday would be hurting SRH badly as at one stage, they looked in complete control after posting a competitive 158/4

Batting has not been SRH's concern at all as the likes of Jonny Bairstow, skipper David Warner, Manish Pandey and Kane Williamson are all among runs and have the ability to shoulder the responsibility on their own.

But it is the bowling unit which let SRH down Sunday. Despite losing senior pacers Bhuvneshwar Kumar and all-rounder Mitchell Marsh to injuries, SRH have shown tremendous fighting abilities with Rashid Khan and yorker specialist T Natarajan doing the job for the side.

But Sunday SRH let Royals off the hook in the middle overs after reducing them to 78/5. The likes of Sandeep Sharma, Khaleel Ahmed and young Abhishek Sharma are the weak links in bowling which they need to address.

"Therefore, it is a true honour for me to congratulate him on his 20th Grand Slam victory. It is especially amazing that he has now won Roland Garros an incredible 13 times, which is one of the greatest achievements in sport," Federer wrote. "I also congratulate his team, because nobody can do this alone. I hope 20 is just another step on the continuing journey for both of us. Well done, Rafa. You deserve it." This is the first time Federer and Nadal have held the same number of major titles. When they started their careers, Pete Sampras held the all-time Grand Slam championship record with 14. Now Federer and Nadal each have 20, and Djokovic owns 17 major trophies. "Thanks to Roger for the words. As everybody knows, we have a very, very good relationship. We respect each other a lot," Nadal said. "In some ways, I think he's happy when I'm winning and I'm happy when he's doing things well. In some way for me it means a lot, the positive relationship that we have together, because we have been going through a great rivalry for a very, very long time.'

Correction please!

Paris: Former American great Chris Evert called out Novak Djokovic for saying his rivalry with Rafa Nadal was the greatest in the history of tennis after his humiliating defeat by Nadal in the French Open final Sunday, "I've played (Rafa) more than I (have) played any other player in my professional career. Our headto-head is the biggest head-to-head ever in the history of the sport... he's definitely my greatest rival," Diokovic said. Evert, however, was quick to point out how many times she had played Martina Navratilova. "Well, true... in men's tennis... Martina and I played 80 times." Evert, who won 18 Grand Slam singles titles. wrote on Twitter. The Tweet was mentioned by 12times singles Grand Slam winner Billie Jean King who also reminded her followers that Evert and Navratilova had faced each other 80 times. Navratilova also won 18 Grand Slam singles titles and beat Evert on 43 occasions as the pair dominated women's tennis in the 1970s and 1980s.

Night sessions on cards in 2021

Paris: The French Open will have night sessions that will be televised in France exclusively on Amazon Prime Video as of next year, organisers said Sunday. The French tennis federation said that one match a day, from the first Monday until the quarterfinals, would start at 2100 local time. "Spectators are guaranteed to see that day's headline men's or women's match from 9pm onwards," the FFT said in a statement. The FFT's decision leaves Wimbledon as the only of the four Grand Slam tournaments without a night session.
