UNION CABINET APPROVES ₹3,737 CRORE BONUS FOR NON-GAZETTED STAFF

New Delhi, Oct 21: The Union Cabinet Wednesday approved productivity linked bonus and non-productivity bonus for the financial year 2019-20 for over 30 lakh non-gazetted employees.

The bonus will be given in a single installment, through Direct Benefit Transfer, before 'Vijayadashami'. It will cost the government a total of Rs3,737 crore and benefit a total of 3.67 crore non-gazetted employees.

This comes as a reason to cheer for the government employees ahead of the festive season.

The decision to give a productivitylinked bonus and non-productivitylinked bonus for 2019-2020 was taken at the Union Cabinet meeting, Minister of Information and Broadcasting Prakash Javadekar told reporters.

The bonus ahead of 'Vijayadashami' and 'Diwali' will encourage the middleclass to go out and spend and thus add to the demand in the economy, he said.

The bonus will be disbursed in a week's time. "Payment of Bonus to

Machines may take over 85 mn jobs by 2025

New Delhi, Oct 21: Displacement of around 87 million jobs is expected in the coming years due to shift from human labour to machines, a report by World Economic Forum (WEF) has said

The 'Future of Jobs Report 2020', however, noted that 97 million new roles may emerge that are more adapted to the new division of labour among humans, machines, and algorithms. "Although the number of jobs destroyed will be surpassed by the number of 'jobs of tomorrow' created, in contrast to previous years, job creation is



slowing while job destruction accelerates," it said.

Employers expect that by 2025, increasingly redundant roles will decline from 15.4 per cent of the workforce to nine per cent, and that emerging professions will grow from 7.8 per cent to 13.5 per cent of the total employee base of company respondents, the report said.

"Based on these figures, we estimate that by 2025, 85 million jobs may be displaced by a shift in the division of labour between humans and machines, while 97 million new roles may emerge that are more adapted to the new division of labour between humans, machines, and algorithms," it added.

It observed that automation, in tandem with the Covid-19 recession, is creating a 'double-disruption' scenario for workers. In addition to the current disruption from the pandemic-induced lockdowns and economic contraction, technological adoption by companies will transform tasks, jobs and skills by 2025.

Is Pak heading towards a civil war-like situation

SINDH POLICE RISE IN DEFIANCE AGAINST ARMY AFTER FORMER'S CHIEF IS KIDNAPPED

New Delhi/Islamabad, Oct 21: In a major show of open defiance against Pakistan Army, police officers in Karachi have threatened to go on mass leave. Sources said this happened after the Sindh Police chief was allegedly kidnapped and coerced to act against PML (N) vice president Maryam Nawaz Sharif.

Sources in Islamabad added that Pakistan is rapidly slipping into a civil war-like situation with the ongoing tussle between the opposition parties and the Army.

At Karachi in Sindh province, headed by Chief Minister Syed Murad Ali Shah of the Pakistan People's Party (PPP), the Sindh Police in a major show of defiance against the Pakistan Army have

rested Safdar Awan, the husband of Maryam Nawaz Sharif, and the sonin-law of exiled former Prime Minister Nawaz Sharif, from a hotel The arrest came just hours after

the PML (N) vice president criticised Prime Minister Imran Khan's government at a massive rallv of People's Democratic Movement (PDM) – an alliance of 11 opposition political parties which have joined hands to challenge the Imran Khan government backed by the Pakistan Army. He was later released on bail.

Pakistan Army chief General Qamar Javed Bajwa has ordered an inquiry into Safdar Awan's arrest after Pakistan People's Party (PPP) Chairperson Bilawal Bhutto-Zardari questioned the Army and the ISI about the incident in a tweet.

Pakistani media quoted Bilawal alleging that the Sindh Police chief was abducted by Pakistan Army and its intelligence wing for a few hours before Safdar Awan was arrested. Bilawal insinuated that Pakistan military had pressurised the Sindh Police to act against Safdar Awan. The Dawn newspaper reported

that a purported voice message by PML (N) leader and former Sindh Governor Muhammad Zubair was shared by a journalist in which Zubair alleged that the Sindh Inspector General of Police, Mushtag Mahar, was kidnapped and forced to register an FIR against Maryam, her husband Safdar and 200 others for violating the sanctity of Quaid-i-Azam Mohammad Ali Jinnah's mausoleum.





Bhubaneswar, Oct 21: Heavy rain that lashed several parts of the state during past 24 hours will continue to occur for another two days, says Bhubaneswar Meteorological Centre, Wednesday.

The low pressure area formed over central Bay of Bengal and neighbourhood has become a well marked low pressure area over westcentral Bay of Bengal and neighbourhood, the Met Centre said.

It is very likely to move northwestwards during next 24 hours and move north-northeastwards thereafter towards West Bengal Bangladesh coasts across northwest Bay of Bengal off Odisha coast during subsequent 48 hours, it said. The system is likely to concentrate into a depression by Thursday and further into a deep depression during the subsequent 24 hours.

Under its impact, districts like Ganjam, Puri, Jagatsinghpur, Kendrapara, Bhadrak, Balasore, Gajapati, Khurda, Cuttack, Jajpur, Mayurbhanj and Dhenkanal will receive heavy rainfall, Thursday.

"It's no less than a nightmare for me when I came to know about the onion price went to market to buy vegetables. During this Covid time, the unexpected price hike is really hurting me," said Bhagyalaxmi Khuntia, a homemaker.

The price of onion stayed at around Rs 50 per kg in the local markets of Bhubaneswar and the outskirts for about one month but it galloped to Rs 80 Wednesday.

The retail price of one kg of onion has already reached Rs 80mark and it is likely to rise further for another three months, said general secretary of All Odisha Traders Association, Sudhakar Panda.

"The eye care facility at the institute has been severely affected by the opening of the isolation ward. This is evident from the fact that the institute has not conducted a single cataract operation in last eight months. Infrastructure woes have also affected the studies of 27 postgraduate students at the ophthalmology institute," said a source.

Bhubaneswar, Oct 21: The state Wednesday reported 1,931 new Covid-19 cases, which took the infection tally in Odisha to 2,74,181. while 13 fresh fatalities pushed the death toll to 1,181, an official of Health and Family Welfare (H&FW) department said.

Of the fresh cases, 1,120 were reported from various quarantine centres while 811 cases of the viral infection were detected during contact tracing, said the official.

Khurda district, of which state capital Bhubaneswar is a part, recorded the maximum number of new cases at 273, followed by Cuttack at 153, Angul at 120 and Sundargarh

Taking to Twitter, the H&FW department said, "Regret to inform the demise of thirteen #COVID19 positive patients while under treatment in hospitals.

Four new fatalities were registered in Mayurbhanj district, three in Puri, two in Khurda and one each in Balasore, Angul, Nuapada

Ganjam district alone accounted for 225 of the 1,181 Covid-19 deaths reported in the state, followed by Khurda (203) and Cuttack (104). As many as 53 Covid-19 patients died in the state due to comorbidities, the official said.

The Covid toll has gone up to 78 in Puri district with three fresh deaths being reported in the Pilgrim City during the past 24 hours. Balasore has so far reported 63 deaths, including one reported in the past 24 hours, while the virus

State registers 43.5% decline in road fatalities during lockdown

Bhubaneswar, Oct 21: Odisha has registered a 43.5 per cent decline in deaths due to road mishaps in the four months of nationwide lockdown, an official said Wednesday.

Deaths due to road accidents decreased by 43.5 per cent between April and July. 1,048 fatalities were reported in the April to July period as compared to 1,853 fatalities between April to July 2019, informed the State Transport Authority (STA).

The number of fatalities reduced by 74 per cent in April, 42 per cent in May, 18 per cent in June and 19 per cent in July. In the first seven months of the year from January to July, deaths due to road accident has reduced by 30 per cent, the STA said.

As per STA data, 5,125 accidents have been reported between January and July this year. During the same period in 2019, the state had reported 6.690 road accidents.

Govt issues post-Covid health advisory

Bhubaneswar, Oct 21: The State Health and Family Welfare (H&FW) department Wednesday issued advisories for the follow up and management of health of the COVID patients after their recovery from the viral disease.

The advisories have been sent to all the Collectors for necessary actions. The department admitted that several associated health ailments have been seen in recovered patients and batted for a holistic approach for follow up with the doctors for their well-being during the post-COVID period.

"After acute COVID-19 illness. recovered patients may continue to report wide variety of signs and symptoms including fatigue, body ache, cough, sore throat, difficulty in breathing increased incidence/worsening of Coronary Artery Disease, Acute Mycardial Infarction, Heart failure, Myocarditis, Stroke, Impaired Cognitive function, persistence of taste and smell abnormality besides occurrence of depression, anxiety and fear," the department advisory said.

At the individual level, the department has asked the recovered patients to continue taking preventive measures against COVID, drink adequate warm water and continue regular household work if health permits. It also asked to resume office works in graded manner.

The department suggested the people to do yoga, pranayama, meditation and morning walks besides consuming nutritious and balanced diet. It also the recovered patients to refrain from smoking and alcohol consumption.

PMAY fails to meet target in Bhadrak

ADMIN SLAPS SHOW-CAUSE NOTICES ON 22 OFFICIALS IN BANT BLOCK; SALARIES HELD

Bant/Bhadrak, Oct 21: Even as the government stresses timely completion of housing units under the Pradhan Mantri Awas Yojana(PMAY), the administration has failed to achieve the target in Bant block of Bhadrak. Taking a serious note of the issue, the district administration has served show cause notices on 22 officials in the block, a report said.

The report said that following a directive from the Panchayatiraj and drinking water supply department, the authorities had been asked to ensure cent percent target by September end in the housing units sanctioned under PMAY in 2019-20 (additional) and 2020-21 fiscal. Reviewing the progress of

Silk farmers fret over sub-standard seeds

Affected farmers in Naktideula area of Sambalpur has sought an investigation and compensation for loss

POST NEWS NETWORK

Naktideula, Oct 21: Silk farmers in Naktideula area of Sambalpur district have been suffering losses for various factors like fluctuation in climatic conditions and poor silkworm

They alleged they were provided poor silkworm seeds by the officials of the Tussar Cooperative Society in Rairakhole. Almost all worms have died after a few days of rearing leading to their incurring huge losses this year.

"Our hope for silk harvest and making a good profit from silk farming at the difficult Covid times has vanished. Now our worry is how to manage our families at this time when alternative means of earning are not in sight," they lamented.

According to farmers, they had got 2 kg of silkworm seeds each September 25 from Rairakhole Tussar Cooperative society. "We invested a lot of money and time in grooming the seeds for 23 days. Our efforts and funds went down the drains as the seeds were sub-standard and they all died. Now we have no alternative at hand" they rued.

There are three types of silkworms such as Tasar. Mulberry and Eri which are cultivated by farmers in Batagan and Jamujori panchayats under this block over years. Sericulture has been their main source of living for them.

"We earn about Rs 10,000 from sericulture. As we have suffered losses this year due to poor seeds, the losses should be compensated," said farmers like Prabhakar Nayak, Gopinath Nayak and Dhabaleswar Matiari.

Several other farmers like Tarulata Pradhan, Harihar Pradhan, Adhira Pradhan, Rabindra Matiari and Aditya

Matiari have demanded compensation for the loss.

They submitted a memorandum to the assistant director of the Deogarh sericulture department through the secretary of the Tussar Cooperative Society.

Several other outfits have demanded a probe into the supply of sub-standard silk worm seeds and action against those involved in this irregularity.

Notably, the central scheme 'Silk Samagra' is prevalent in the state since 2018-19 for promoting silk production. Tassar farmers are provided mone-

Real men are vegan

hen I was growing up in army cantonments, meat was on our table every day. It was taken for granted that military men ate meat because they were 'real' men. In my grandfather's house all the women were vegetarian, but he had to have his meat at both meals and the vegetarian women cooked it for him. When I became vegetarian, I had to listen to any number of men yapping on about how they avoided 'ghasphoos'. I've never heard such talk from a woman.

On a visit to Jaipur, I had lunch with Dr. Mehta, the ex-head of SEBI and founder of the Jaipur Foot movement. I drew back in horror when I dipped into the curry. It tasted like meat. My host explained the origins of the dish and why they had prepared it specially for me. Two centuries ago, a sage turned the women of the royal families of Rajasthan vegetarian. But since the men were adamant about hunting, fighting and eating meat, the women secretly created a recipe out of wheat and ghee which tasted exactly like meat. The only problem is that the preparation takes hours so it has now become very rare.

Food and gender have been, and continue to be, closely intertwined. It's less 'you are what you eat' than 'you eat what you are'. Women are expected to be compassionate and virtuous, so veganism and vegetarianism are seen as feminine. Men are defined as rough and tough, so eating meat is masculine.

Everyone knows that eating meat is bad for health and humanity, the environment, the economy and animals. The ongoing pandemic is an extreme reminder of all of the above, and meat eating has definitely dipped. But rationally it should have ended. The trouble is that simply making an information-based appeal about the benefits of a vegetarian diet ignores the pri-

mary reason why men eat meat: It makes them feel like 'real' men. And 'real' men are entitled to eat whatever they want, whenever they want, and wherever they want. Damn the consequences

The last vestige of prehistoric man as 'hunter' is his consumption of meat. The man today may be a lazy, paunchy shopkeeper selling plastic toys, and the meat cheap, supermarket sanitised slabs, but in his own mind he is the ultimate male proving his masculinity by stabbing his fork into a fatty steak. The idea is so ingrained that according to research by the University of Hawaii, men often eat more meat in situations where they feel their masculinity is under threat. Which is why for years, until I stopped it, live animals used to be dropped by plane to border areas of the army so that they could get fresh meat.

So why is eating meat still seen as a symbol of manliness? In her book, The Sexual Politics of Meat, Carol Adams explores how the media has marketed meat as a sign of masculinity to boost sales. We've all seen the overtly sexualised commercials selling that idea. In addition to clever marketing, it has been the misleading medical theories emphasising meat as the primary source of protein, which is linked to strength, which is seen as masculine. There is also the misbelief that masculinity requires risk-taking (dangerous driving, excessive drinking); hence the association between unhealthy eating and masculinity: if you're a real man, you shouldn't be so concerned about your health. Numerous studies have found that larger portions and unhealthy food are perceived as more masculine, while healthy food and smaller portions are considered more feminine.

There is also the class angle that, in the past, it was the rich or masters who ate meat which is prepared but not partaken by the slaves. In fact, the English bragged about how they were able to colonise India because their soldiers ate red meat unlike the native men

What is it that deters men from turning vegetarian? Social anxiety.

Paradoxically, these so-called 'real men' are actually afraid to quit meat for fear of being dubbed feminine. In a Twitter poll directed at men, 45 per cent of respondents reported their biggest barrier to leading a vegan diet was social stigma, the fear of being called 'beta males with limited options in the outside world', with 'way low testosterone levels', 'x/y organisms who don't eat meat, not men', 'pushovers, controlled by women, who have feminine characteristics', people who 'aren't capable of hunting and gathering' and 'soyboy, low testosterone feminists'.

The good news is that there's a growing new sensibility that strongly challenges these outdated stereotypes. Most famously, the documentary The Game Changers follows elite special forces trainer James Wilks as he showcases the world's top athletes in sports as rigorous as cross-country running. boxing, wrestling, football and Formula 1 racing, including former bodybuilder Arnold Schwarzenegger, all of whom credit their health and performance to their vegan diets. When asked about his relationship with masculinity and power-lifting after he adopted a vegan lifestyle, Nick Squires, a champion power-lifter and vegan of five years said, "There's so much in the way of traditional gender roles that I think cause men to be reluctant about veganism. Putting aside the misinformed conception that you need animal proteins to build muscle, there's an idea that men need to be muscular, and to most people this is tied to the consumption of animal products." He is living proof that it isn't. In fact, another study found that a plant-based diet leaves men feeling more satiated than a diet including meat and dairy, because they had increased levels of healthy bacteria in the gut.

With better education is dawning a more authentic understanding of masculinity. A recent study found that men who had more education generally consumed less meat. This is further evidenced by another paper, published in the journal Appetite, which examined the compelling link between meat, gender and class status. Part of the research involved offering participants a 'beast burger' presented as either meat-based or vegetarian. The highest demand for the meat option came 'from those who rated themselves lower in socioeconomic status.' Meat, to the extent that it's associated with power, becomes 'substitutable for the status they lack.' The lower you are on the totem pole, the more likely you are to cling to the old-fashioned symbols of masculinity like meat.

Unravelling the strong cultural association between men and meat is critical to the prospects of global sustainability. So, come on out all you closet male vegans and vegetarians. The earth is even more threatened than your fragile male egos. Admit it: real men do eat 'ghasphoos' and are lovin' it.

The Oxford English Dictionary says that umpty is a "fanciful representation of the dash in Morse code", basing this on iddy-umpty, a military slang term of the early 20th Century for a dot followed by a dash. It was a nonsense syllable in poetry, for example as umpty-tumpty-tiddle-dee.

In response, the Ministry of External Affairs stated, "There is a free media in India that reports on issues as it sees fit.

The Indian media has by and large ignored the open letter. In this context, the CPC should be reminded that commitment or agreement is a two-way process and of the 'One India' policy. The response the Foreign Minister of Taiwan tweeted was "#India is the largest democracy on Earth with a vibrant press & freedom-loving people. But it looks like communist #China is hoping to march into the subcontinent by imposing censorship. #Taiwan's Indian friends will have one reply: GET LOST! JW.

II in 1945. Taiwan was awarded to the Republic of China (ROC). Thereafter, the Chinese Civil War Nationalist Party, Kuomintang (KMT), led by Chiang Kai-shek and the CPC led by Mao Zedong. Subsequent to the defeat of the KMT on the mainland, the CPC founded the PRC. Following their defeat, the KMT fled in 1949 to Taiwan with the aim to retake mainland China.

From 1949 until his death in 1975, Chiang Kai-shek ruled Taiwan with an iron hand with the sole aim of retaking mainland China. Following his death, Taiwan began a process of reforms to the political system. Despite its diplomatic isolation, Taiwan is industrialised and technologically advanced. To add to this, the people are disciplined. Taiwan has its own Constitution for democratic governance and directly elects its President and the legislature, and maintains its national defence as well as foreign affairs.

What these prove is that for all practical purposes Taiwan is a sovereign and independent Nation State. The truth is that the PRC rules only Mainland China and has no control of but only claims to Taiwan as part of its territory under the 'One China' policy. Taiwan could do well by making a diplomatic statement laying to

rest the misnomer that Taiwan is a part of China. This could be done with subtlety by dropping the word 'China' from its official name. This should be followed by strengthening informal diplomatic relations by recognising suo motu the maps of all countries having territorial disputes with the PRC and increasing economic activity as well as people-to-people contact.

Recently President Xi, visualising the worst-case scenarios, ordered the People's Liberation Army (PLA) to scale up its battlepreparedness. The Chinese foreign ministry went on record to say that it does not recognise the creation of the Union Territory of Ladakh. It also opposed the building of infrastructure by India on its side of the LAC. China conveniently forgets that they were the first to build border infrastructure right up to Ladakh as well as the road from Tibet to Xinjiang through Aksai Chin. China has been unnerved by India's slow but steady improvement in border infrastructure allowing for faster movement of troops and weapon systems in the forward areas. India has a long way to go before it can correct the asymmetry. Inot be willing to receive a Covid-19 vaccine, while anti-vaxxers have reportedly gained at least 7.8 million social media followers since 2019. Like the pandemic itself, antivax misinformation and rumours know no borders. The biggest tragedy is that the resulting vaccine hesitancy threatens to hurt the poor people the most.

The poor have already been hit hardest by the pandemic. Increasing numbers of women and children from marginalised populations are falling outside the reach of public services – as reflected in the increased incidence of gender-based violence, the rise in teenage pregnancies, and the decline in skilled birth attendance. One million more children could die in the next six months because of the pandemic's knock-on effects, with the bulk of these deaths occurring among the poor. Vaccines protect up to three million lives every year. They are often the first and only health service to reach poor households. People living in squalid conditions bereft of basic sanitation, safe drinking water, hygiene, cleansing agents, and adequate nutrition are most at risk of contracting and dying from vaccine-preventable diseases. And when ill, they often

healthcare. Timely protection with vaccines, which keep diseases in poor communities at bay and reduce preventable child deaths, is therefore their best bet for survival.

By spreading misinformation, anti-vaxxers are increasing the risk of deaths among poor children. An explosion of vaccinationrelated falsehoods in the Philippines is a major reason why the country's childhood immunisation rate has plummeted from 87 per cent in 2014 to 68 per cent today. This resulted in a resurgence of polio and measles cases last year, with the poor bearing the brunt

Similarly, in Cameroon, false rumours that the human papillomavirus (HPV) vaccine causes sterility is scaring parents into refusing it for their daughters. This has put millions of girls at risk of a virus that causes up to 90 per cent of all cases of cervical cancer, which kills 311,000 women every year, primarily in low-income countries. Girls from poor communities need this vaccine the most, because they often have no access to cervical cancer screening. The HPV vaccine is their best protection. Most women who die of cervical cancer are in the prime of their youth, and leave behind infants and children. The threat posed by

HPV vaccines. Equally dangerous cine protection. The ar anti-vax theories make millions of children vulnerable to other preventable diseases. The development of Covid-19 vaccines – and rapid, fair, and equitable access to them - is the only way to end the present health crisis swiftly. But it won't end unless and until we boost people's resilience to false information and build confidence in vaccines. Achieving this will require positive and fact-based information campaigns from trusted sources. and cooperation with social media platforms, so that their algorithms are not abused to propagate harmful rumours. Historically, the wealthiest got preferential access to vaccines, while the poor had to wait decades. With establishment of Gavi, the Vaccine Alliance in 2000. this stark inequity began to shrink. Today, rich and poor have almost equal access to life-saving vaccines.

In India, anti-vaxxers thwarted the introduction of life-saving vaccines in the publicly funded national immunisation programme for several years. As a result, vaccines for Hepatitis B, rotavirus, and pneumonia were available only in private markets at exorbitant prices that only the rich could afford. Poor families whose children were dying in large numbers from these diseases

recent poll found that one lack the financial means to access misinformation is not confined to did not have the money to buy vacfiled a legal petition in court to stop us from introducing these vaccines. On behalf of the government, I argued that "the petitioners are not against vaccines but against free vaccines for the poor." The court concurred. This paved the way for the introduction of new vaccines and saved lives, particularly

among the most vulnerable. That episode raises the question of who has the least to lose from these anti-vax rumours. Often, they originate among people who are privileged enough not to care about timely prevention. They may live in areas where preventable diseases have been largely eliminated, and are perhaps protected by herd immunity through the vaccinations of those around them. And if they do get sick, they can access

quality medical treatment. Anti-vaxxers' misinformation drive ignores those with the most to lose by not vaccinating: the poorest and most vulnerable, who risk dying or sliding into medical impoverishment if they or their loved ones get sick. For much of the world's population, vaccination means inoculation against poverty.

Grover stressed the importance of observing practices such as wearing sunglasses when stepping out, keeping hydrated, avoiding rubbing of eyes, washing hands before touching their eyes, taking frequent breaks from use of laptops and mobiles and having their eyes periodically lubricated with eve drops.

As per the Central Pollution Control Board, out of 35 pollution monitoring stations, the air quality index in as many as nine stations is in the very poor category, while 20 stations recorded the index in the poor category, five logged it in moderate category and two remained non-functional.

Vivek Vihar in Delhi eastern district recorded the highest AQI at 367, followed by 348 by the pollution monitoring station at west Delhi's Dwarka Sector 8. Delhi's neighbouring areas, including Ghaziabad, Faridabad, Noida, Greater Noida, Meerut and Gurugram are also recording foul air. Faridabad is currently the most polluted amongst all.

GREENFIELD HIGHWAY TO COME UP IN RAJASTHAN

THE HIGHWAY WILL BE DEVELOPED AS AN UNDERGOUND PASSAGEWAY PASSING THROUGH THE MUKUNDRA HILL TIGER RESERVE

New Delhi, Oct 21: A 60 kilometre-long stretch of greenfield highway will be constructed in Rajasthan under the Bharatmala Pariyojana to ensure high speed traffic movement between Delhi and Mumbai.

The highway will be developed as an undergound passageway passing through the Mukundra Hill Tiger Reserve.

A source from the Ministry of Environment said the Standing Committee of the National Board for Wild Life (NBWL), in its meeting headed by Union Environment Minister Prakash Javadekar, earlier this month, recommended the proposal of National Highway Authority India (NHAI) for development of eight lanes Greenfield Highway which will stretch from Bhenda Hera village to Moondiya village section of the highway in Rajasthan.

The Greenfield highway will be a 59.6 km long tunnel passing through the Mukundra Hills Tiger Reserve in Rajasthan.

"The proposed highway is part of Bharatmala project and will connect several towns like Gurgaon, Alwar, Bharatpur, Dausa, Sawai Madhopur, Tonk, Bundi, Kota, Jaora, Ratlam etc. and give an in-



frastructure fillip to the states of Delhi, Haryana, Rajasthan, Gujarat, Madhya Pradesh and Maharashtra,"

The highway will be access-controlled and ensure high speed traffic movement from Delhi to Mumbai. The proposed alignment is selected to cover one of the most important North-South arterial connectivity in the country, further interspersed with feeder highways on its either sides.

"The proposed road network is passing through the Mukundra Hills Tiger Reserve and the NBWL recommended the project as a tunnel to be constructed under 8 lanes (Greenfield Highway) from Bhenda Hera village to Moondiya village Section of NH-148N (Total length 59.625 Km) passing through Mukundra Hills Tiger Reserve and its Eco-Sensitive Zone involving 26.6354 hectare land

"The start and end faces of the tunnel shall be minimum 500m away from boundary of Mukundra imposed by National Tiger Conservation Authority (NTCA). This project shows that develop ment can be done without impact ing the environment and wildlife," the ministry source said.

The government envisages building 34,800 km of highways at a cost of about ₹5.35 lakh crore under the

ambitious Bharatmala Pariyojna. According to the Ministry of Road Transport and Highways, 2,921 km of highways have been constructed under the Bharatmala Pariyojna. "A total of 322 projects in a length of 12,413 km have been awarded under Bharatmala Pariyojana till August, 2020. Further, 2.921 km has been constructed under the Project till the same date," the Ministry had said.

'Lost' river that ran through Thar 172,000 years ago found

New Delhi, Oct 21: Researchers have found the evidence of a 'lost' river that ran through the central Thar Desert, near Bikaner, as early as 172 thousand years ago, and may have been a life-line to human populations enabling them to inhabit the region.

The findings, published in the journal Quaternary Science Reviews, represent the oldest directly dated phase of river activity at Nal Quarry in the central Thar Desert.

The study by researchers from The Max Planck Institute for the Science of Human History in Germany, Anna University in Tamil Nadu, and IISER Kolkata indicates that Stone Age populations lived in a distinctly different Thar Desert landscape than we encounter today.

This evidence indicates a river flowed with phases of activity dating to approximately up to 172 thousand years ago, nearby to Bikaner, Rajasthan, which is over 200 kilometres away from the nearest modern river.

'To demonstrate how old such channels are, we had to find evidence on the ground for river activity $% \left(x\right) =\left(x\right) +\left(x\right) +\left($ in the middle of the desert, Achyuthan said.

The team studied a deep deposit of river sands and gravels, which had been exposed by quarrying activity near the village of Nal. The researchers were able to document different phases of river activity by studying the different deposits.

"We immediately saw evidence for a substantial and very active river system from the bottom of the fluvial deposits, which gradually decreased in power through time," Achyuthan said.

The researchers used a method called luminescence dating to understand when quartz grains in the river sands were buried.

The results indicated that the strongest river activity at Nal occurred at approximately 172 and

140 thousand years ago, at a time when the monsoon was much weaker than today in the region. River activity continued at the site between 95 to 78 thousand years ago, after which only limited evidence for the presence of a river at the site, with evidence for a brief reactivation of the channel 26 thousand years ago, the study found. The river was flowing at its strongest during a phase of weak monsoonal activity in the region, and may have been a life-line to human populations enabling them to inhabit the Thar Desert, the researchers said

The timeframe over which this river was active also overlaps with significant changes in human behaviour in the region, which have been linked with the earliest expansions of Homo sapiens from Africa into India, they said.

"This river flowed at a critical timeframe for understanding human evolution in the Thar Desert, across South Asia and beyond," said

Blinkhorn. 'This suggests a landscape in which the earliest members of our own species, Homo sapiens, first encountered the monsoons and crossed the Thar Desert may have been very different to the landscape we can see today," he added.

Mumbai, Oct 21: In a big jolt ahead for the BJP ahead of the Bihar elections, its senior Maharashtra leader Eknath Khadse Wednesday quit the party, holding former Chief Minister Devendra Fadnavis responsible for his decision.

Set to join the ruling Maha Vikas Aghadi partner Nationalist Congress Party (NCP) on Friday, Khadse said that he was repeatedly targeted by Fadnavis on trumped-up graft charges which have still not been proved.

This has come as a major embarrassment for the BJP as Fadnavis is the party's in-charge for the upcoming Bihar polls, voting for which starts from October 28. Making it clear that he nursed no grouse against the BJP's Central leadership. Khadse said that "except state President Chandrakant Patil, no BJP leader has called me up so far".

'My family and I have been humiliated for four years... I worked hard to build up the party in the state for 40 years and this is what I had to undergo.. I am going alone," Khadse told media persons after resigning as a primary member of the BJP.

Ejected as a minister in June 2016 after graft charges surfaced against him, Khadse - the de facto No 2 in the cabinet headed by Fadnavis - faced further agony after BJP denied a ticket in the 2019 Assembly elections, and he remained a political pariah. Khadse detailed how he was hu-

miliated for over four years in the BJP even though "no party, including Shiv Sena, Nationalist Congress Party or Congress, has ever demanded any investigations or my resignation" at that time.

"So many agencies probed me, but nothing emerged... Then, one lady



levelled some molestation charges against me to which Fadnavis asked that a FIR should be lodged against me. This was the kind of low-level politics played against me," an emotionally-charged Khadse said.

Among the tallest BJP leaders with huge grassroots support, Khadse, 68, hails from Muktainagar, Jalgaon, which he represented from 1989-2019, while his daughter-in-law Raksha Nikhil Khadse was elected twice (2014-2019) as BJP Lok Sabha MP from Raver.

Considered an efficient administrator and powerful orator, groomed by the late Pramod Mahajan and the late Gopinath Munde, Khadse is now expected to blunt the Opposition Fadnavisled BJP's tirade on the MVA and Chief Minister Uddhav Thackeray

Ironically, Khadse had once tutored Fadnavis in legislative politics, but was by-passed by the central leadership for the CM's post when the party came to power in 2014. forcing him to play second fiddle to Fadnavis. State NCP President and Minister Jayant Patil announced that NCP would lay the red carpet for Khadse - who is willing to work under Sharad Pawar's leadershipon Friday afternoon, and claimed that many other BJP activists and legislators are likely to follow suit in the coming days. In a guarded reaction amid speculation that the new entrant would join the state cabinet soon, Chief Minister Uddhav Thackeray said: "We welcome Khadse to the MVA family."

ACTIVE CASES REMAIN BELOW 7.5 LAKH-MARK

New Delhi. Oct 21: Active cases of COVID-19 in India settled below the 7.5 lakh-mark for the second successive day, while the national case fatality rate (CFR) has dropped to 1.51 per cent, the Union Health Ministry said Wednesday

Presently 14 states and UTs including Chhattisgarh (0.96 pc), Jharkhand (0.87 pc), Andhra Pradesh (0.82 pc), Telangana (0.57 pc), Bihar (0.49 pc), Assam (0.44 pc) and Kerala (0.34 pc) are reporting case fatality rate of less than 1 per cent.

The Centre has advised states and UTs to aim at bring down the CFR below 1 per cent. There are 7, 40,090 active cases of coronavirus infection in the country which comprises 9.67 per cent of the total caseload, the data stated.

With a high number of COVID-19 patients recovering every day, India's steady trend of posting high levels of daily recoveries also continues. A total of 61,775 recoveries have been registered in a span of 24 hours in the country whereas 54,044 new infections were reported during the same period, the ministry said.

This is when 10, 83,608 tests have been conducted in a span of 24 hours in the country, it underlined. "Successful implementation of test, track and treat strategy along with timely and appropriate treatment has led to the consistent slide in the fatality rate. The national CFR has fallen to 1.51 per cent today," the ministry said.

A total of 67, 95,103 people have recuperated from the disease so far in the country. Higher number of single day recoveries has resulted in a continuous increase in the national recovery rate, which is fast approaching 89 per cent (88.81%).

The ministry said that 77 per cent of the new recovered cases are observed to be concentrated in 10 states and UTs. Karnataka outnumbered Maharashtra in new recovered cases with more than 8.500 new recoveries. Maharashtra and Kerala both contribute more than 7,000 to the new recoveries.

LUCKNOW COVID TEAM'S DATA INCLUDES US COUPLE

However, of five other names, three were of my landlord's family -- two of them were the couple who own the house and are currently in the US -while third report was of the landlord's father who had passed away a few years ago. The remaining two persons are not

known to me," he told reporters. The team, apparently, noted the names of the landlord's family from the nameplate outside the house without actually collecting samples. Ashray reported the matter immediately on the Covid helpline. "Thereafter, a contact team personnel arrived and apologised while promising to get my family's tests done again".

Air pollution contributed to death of 16.7L people

New Delhi, Oct 21: Air pollution contributed to the death of 16.7 lakh people in India in 2019, with over a lakh of them less than a month old, a new global study by a US-based NGO has revealed.

According to the State of Global Air, 2020, a report on global exposure to air pollution, released by Health Effects Institute (HEI) on Wednesday, air pollution is the biggest health risk in India.

"Outdoor and household particulate matter pollution contributed to the death of more than 1,16,000 Indian infants in their first month of life in 2019. More than half of these deaths were associated with outdoor PM2.5 and others were linked to the use of solid fuels such as charcoal, wood, and animal dung for cooking.



"Long-term exposure to outdoor and household air pollution contributed to over 1.67 million annual deaths from stroke, heart attack. diabetes, lung cancer, chronic lung diseases, and neonatal diseases, in India in 2019," the report said.

The report also said there is clear evidence linking air pollution and increased heart and lung

disease, creating a growing concern that exposures to high levels of air pollution could exacerbate the effects of COVID-19.

Dan Greenbaum, the president of HEI, said an infant's health is critical to the future of every society and this newest evidence suggests an especially high risk for infants born in south Asia and sub-Saharan Africa.

'Although there has been a slow and steady reduction in household reliance on poor-quality fuels, air pollution from these fuels continues to be a key factor in the deaths of these youngest infants," he said.

Infants in the first month of life are already at a vulnerable stage. But a growing body of scientific evidence from multiple countries, including recent ICMR-supported studies in India, indicates that particulate air pollution exposure during pregnancy is linked to low birth weight and pre-term birth, the report said.

The new analysis reported in the State of Global Air this year estimates that nearly 21 per cent of neonatal deaths from all causes are attributable to ambient and household air pollution.

"Addressing impacts of air pollution on adverse pregnancy outcomes and newborn health is really important for low- and middle-income countries, not only because of the high prevalence of low birth weight, preterm birth, and child growth deficits but because it allows the design of strategic interventions that can be directed at these vulnerable groups," said Kalpana Balakrishnan, an expert in air pollution and health. The report saidoverall, air pollution is now the largest risk factor for death.



In an advisory issued to presidents and general secretaries of all recognised national and state parties, the poll panel said chief electoral officers and the district machinery would be expected to invoke appropriate and relevant penal provisions against candidates concerned as well as organisers responsible for such violations.

Separate instructions for strict compliance of guidelines are being issued to chief electoral officers and state governments of poll-going states, it said."It has come to the notice of the Commission instances of such public meetings where large crowds assembled in utter violation of social distancing, and the political leaders and campaigners addressing the gatherings without



wearing masks in complete disregard of the guidelines and instructions issued by the Election

Commission," the poll panel said. By not following the norms, the EC said, the political parties and candidates are not only flouting its guidelines "with impunity but exposing themselves as well as the public attending the rallies or meet-

ing the pandemic".

As the most important stakeholders in the electoral process, the parties are duty-bound to observe the norms determined by the Commission for electioneering, it noted. "The Commission has taken a serious view of the laxity on the part of political parties and candidates, on the ground, in terms of maintaining crowd discipline, and hereby reiterates and further advises them to demonstrate utmost vigil and care during electioneering," the advisory said.

Campaigning is on for Bihar Assembly polls as well as for bye-elections in other states. Assembly polls in Bihar will be held in three phases on October 28, November 3 and November 7. Most of the assembly bypolls will be held on November 3. Bypolls to the Valmiki Nagar Lok Sabha seat in Bihar and some assembly seats in Manipur will take place on November 7.

The election commission's advisory comes a day after Prime Minister Narendra Modi urged people to follow all COVID guidelines. including wearing of masks, especially during the festive season. With the onset of festival season, PM Modi on Tuesday made an impassioned appeal to people to follow COVID-19 guidelines, saying this is not the time to be careless as the virus is still around and even a small negligence can dampen the festive spirit.

The poll panel also referred to its October 9 advisory in which it had sought the cooperation of all political parties in following instructions related to COVID-19 at all stages, especially wherever public interface in physical form is involved.

The previous advisory had said the observance of preventive measures, including wearing masks, use of sanitiser and social distancing is a duty cast upon all the stakeholders in the larger interest of public health. "As representatives of public, this onerous responsibility rests with the political parties to ensure that they not only cooperate with the district machinery in following the due norms of public health safety as prescribed but also instil a sense of discipline for civic behaviour in their cadre while doing ground management during campaign times," it had said.

5 dead, 34 hurt in bus mishap

Mumbai, Oct 21: Five people were killed and 34 others injured when their speeding bus fell into a gorge in Maharashtra's Nandurbar district in the early hours of Wednesday, a police official said.

The accident took place at Kondaibari ghat around 3.15 am when the private bus, going from Buldhana to Surat in Gujarat, tried to overtake another bus which was also heading to the same destination from Malkapur, he said.

While overtaking in the ghat section, the bus driver saw a truck coming from the opposite direction. In an attempt to avoid a collision with the truck, the bus driver lost the control over the wheels, he said. As a result, the bus fell into the over 30feet deep gorge, located around 370 km from here, the official said.

Three bus passengers, including a female, the vehicle's driver and cleaner died, Nandurbar Superintendent of Police Mahendra Pandit said. The accident took place on the Surat-Kolkata National Highway (NH-6) where road work is going on, he said.

Only one lane of the highway is operational at the accident spot, the official said. On getting information about the accident, police, local rescue teams and district administration officials rushed to the spot

Out of the 34 injured people, 26 were admitted to Nandurbar Civil Hospital, four in a governmentrun hospital in Visarwadi, three were shifted to Surat and one was taken to a hospital in Jalgaon. dals to strictly maintain 'no entry zone' guidelines for all other purposes. It said the list of persons allowed should be decided on daily basis. These lists must be put outside the pandals every day at 8 a.m.

The original order was modified in the aspects that charts may include 30 names for smaller pujas but not more than 15 people can enter inside the pandal at a time. Similarly, 60 names for larger pujas but not more than 45 people can remain or stay inside the pandal at a time.

The directive, however, said that no other reliefs would be granted as that would have the effect of diluting the order. The high court refused to pass any orders on the appeals by Kalyan Banerjee, who appeared on behalf of the Durga Puja organisers, to allow two important rituals like Anjali (offering prayers) and Sindoor Khela (playing with vermilion).

Hathras case: 2 docs removed

Itanagar, Oct 21: An Assam Rifles jawan was killed while another received bullet injuries Wednesday during an encounter with suspected militants in Tirap district in southern Arunachal Pradesh, the police said.

An official of the Tirap district police control room said that the incident took place when a convoy of Assam Rifles came under attack by suspected terrorists at the Sanliam tri-junction on Khonsa Lazu road of the district, which shares borders with Myanmar.

"In the ensuing gunfight, a jawan of the para-military force died while another sustained bullet injuries." the official said on condition of anonymity. Massive combing operations are being carried out in the area by the Assam Rifles troopers to nab the militants, suspected to belong to the National Socialist Council of Nagaland-Isak-Muivah (NSCN-IM).

Further details of the incident are awaited. It was not immediately known how many Assam Rifles troopers were patrolling the area during the terrorist attack. This was the second militant attack on Assam Rifles this month. On October 4, an Assam Rifles jawan was killed while another was hurt in an ambush by suspected militants in Changlang district of Arunachal Pradesh.

IIT Kharagpur's 'COVIRAP' gets ICMR certification

New Delhi, Oct 21: 'COVIRAP,' the diagnostic machine developed by the Indian Institute of Technology (IIT) Kharagpur researchers, has been successfully validated for its efficacy in Covid-19 detection by the Indian Council of Medical Research (ICMR). the Institute said Wednesday.

After rigorous testing with patient samples by an authorized ICMR laboratory, adhering to their strict guidelines, ICMR has now granted certification for this Covid-19 Diagnostic Test. This test has been designed to be fairly easy to conduct and affordable as well and can produce results within one hour.

"This is indeed one of the greatest contributions in the history of medical science, particularly in the



This new testing method implements a highly reliable and accurate molecular diagnostic procedure that can be conducted in an ultralow-cost portable device unit de-

veloped by the research team. The test results are rendered via a custom-made mobile application for dissemination without requiring manual interpretation.

This innovation has made highquality and accurate Covid testing affordable for the common people with a testing cost of around ₹500 which can further be reduced through government intervention," said Ramesh Pokhriyal Nishank, Union Education Minister. "This machine can be developed at a cost of less than ₹10,000 with minimal infrastructural requirement making the technology affordable to common people. The testing process in this new machine is completed within one hour," Nishank added.

While the Institute can produce the testing kit up to a certain scale,

patent licensing will facilitate commercialisation opportunities for medical technology companies. Dr. Mamta Chawla Sarkar, an internationally acclaimed virologist who oversaw the patient trials on behalf of ICMR-National Institute of Cholera and Enteric Diseases (NICED) said: "A detailed scrutiny of the testing results has clearly shown that this assay holds the capability of detecting extremely low levels of viral loads than any other method based on similar principles of testing." The novel diagnostic test has been subjected to rigorous testing protocols as per the ICMR guidelines, at ICMR-NICED, an Institute authorised by ICMR. ICMR-NICED has further certified the test to be extremely user-friendly.

This contradicted the police, which cited the FSL report, and said that there was "no semen on the body, so there was no rape". The other CMO whose services were terminated is Obaid Imtiazul Haque. He refused to comment on the reasons for his removal.

The doctors were issued an 'urgent letter' on Tuesday asking them "Not to perform any further duties in the medical college". The reason for their removal was not given in the letter issued by hospital in-charge SAH Zaidi.

Islamabad, Oct 21: Pakistan may remain on the grey list of the Financial Action Task Force (FATF) as it has been unable to comply with six of the 27 points in the global terror financing and money laundering watchdog's action plan, a media report said oWednesday.

The Paris-based global watchdog will hold its virtual plenary session from October 21 to 23. It will review Pakistan's progress on the 27-point action plan. The FATF had placed Pakistan on the grey list in June 2018 and asked Islamabad to implement a plan of action to curb money laundering and terror financing by the end of 2019, but the deadline was extended later on due to the COVID-19 pandemic.

"The country will succeed in exiting the FATF's grey list by June next year," The Express Tribune reported, quoting diplomatic sources. The report said Pakistan is unlikely to exit the FATF grey list, but the country has managed to avert being blacklisted.

It said that the country had completed its legal formalities and informed the watchdog that it had managed to comply with 21 of the points in the action plan. Pakistan has succeeded in making 20 per cent progress in the remaining six points of the action plan, it said.

Pak unlikely to 15 KILLED IN AFGHAN STAMPEDE FOR VISAS

An estimated 3,000 Afghans had congregated on the open ground outside Pakistan's consulate to collect tokens needed to apply for visa

Jalalabad, Afghanistan, Oct 21: At least 15 people were killed in stampede among thousands of Afghans gathered near Pakistan's consulate Tuesday as jostling broke out between people applying for visas, officials in the eastern city of Jalalabad said.

An estimated 3,000 Afghans had congregated on the open ground, usually used for sports or pubic gatherings, outside the consulate, waiting to collect tokens needed to apply for a visa, two provincial officials told Reuters a day after the tragedy. An Afghan news channel transmitted images of them holding passports aloft to secure a token.



showed scores of passports strewn across the ground. "The visa applicants jostled to secure their token from the consulate officials...the crowd got out of control, leading to a stampede," said an Afghan official.

A survivor described to Reuters how tempers frayed and the crowd became unruly in the lead up to the stampede. "I stood in the queue all night but at some point people got angry and started pushing, many of us fell on the ground, said Farmanullah, who goes by a single name. Eleven of the 15 victims were women, and several senior citizens were among more than a dozen injured, Sohrab Qaderi, a provincial council member, said.

Tens of thousands of Afghans every year travel to neighbouring Pakistan to secure medical treatment, education and jobs. The two countries share a nearly 2.600-kilometre border. Pakistan hosts about 3 million Afghan refugees and economic migrants, who have fled violence, religious persecution and poverty in their war-torn country.

French militant group dissolved after teacher's beheading

Paris, Oct 21: The French government issued an order Wednesday to dissolve a domestic militant Islamic group after the beheading last week near Paris of a teacher who had shown students caricatures of the Prophet Muhammad.

Government spokesperson Gabriel Attal said the Collective Cheikh Yassine group was formally banned during a Cabinet meeting because it was "implicated, linked to Friday's attack" and it was used to promote anti-republican hate speech.

Other groups will be dissolved "in the coming weeks" for similar reasons, Attal said. He also confirmed that the government ordered a mosque in the northeast Paris suburb of Pantin to close for six months.

A terror investigation is under way into teacher Samuel Paty's slaying. Authorities have identified the killer as Abdoullakh Anzorov., an 18-year-old Moscowborn Chechen refugee who was later shot dead by police.

A judicial official said that seven people who were detained as part of an investigation into the grisly slaying, including two minors, were to go before an investigating magistrate later Wednesday for eventual preliminary charges.

The seven were among 16 people, including five adolescents, initially detained for questioning. Nine are being released.

The official was not authorised to be quoted by name. Named after a slain leader of the Palestinian Hamas, Collective Cheikh Yassine was founded in the early 2000s by a man who is among the individuals detained for questioning in the teacher's

Jamal's fiancee sues **Saudi Crown Prince**

Washington, Oct 21: The Turkish fiancee of slain journalist Jamal Khashoggi has sued Saudi Arabia's Crown Prince Mohammed bin Salman, accusing him of ordering the murder, the media reported.

The civil lawsuit was filed Tuesday in Washington D.C. by Hatice Cengiz and Democracy for the Arab World Now (Dawn), a rights group Khashoggi, who had been living in self-imposed exile in the US, founded before his death, the BBC reported.

In the lawsuit, Cengiz claimed personal injury and financial losses over Khashoggi's death, while the rights group alleged that its operations were hampered.

"The objective of the murder was clear, to halt Khashoggi's advocacy in the US for democratic reform in the Arab world," the BBC quoted the lawsuit as saying.

It added that Khashoggi, also a prominent critic of the Saudi government, was murdered "pursuant to a directive of defendant Mohammed bin Salman"

EU tells Britain to make up its mind

Brussels, Oct 21: The European Union told Britain Wednesday to make up its mind on Brexit, putting the onus back on London to unlock trade talks as the bloc's chief negotiator said an agreement was still within reach with 10 weeks to go.

A frustrated European Union and piqued Britain exhorted each other this week to compromise to avoid a disruptive finale to the fiveyear Brexit drama that would add to economic pain from the coronavirus crisis.

'Time is very short and we stand ready to negotiate 24/7, on all subjects, on legal texts. The UK has a bit of a decision to make and it's their free and sovereign choice," European Council President Charles Michel told the European Parliament.

He said Britain's answer would determine its level of access to the EU's internal market of 450 million consumers. The EU's Brexit negotiator Michel Barnier told the parliament an agreement was still



essence ... Along with our British counterparts, we must find solutions to the most difficult areas," Barnier said, in comments that pushed sterling higher. London has this week refused to continue full negotiations, saying the EU must "fundamentally change" its stance.

'nCoV unlikely to be eradicated'

London, Oct 21: The coronavirus will be around for "evermore" as it is unlikely it will be eradicated, a British scientist on the government's advisory committee for the pandemic said Wednesday, although a vaccine would help improve the situation.

Britain, like other countries in Europe, is currently in the grip of a resurgence in COVID-19 infections, with much of the country under local restrictions and more than 21,000 daily cases reported Tuesday.

"We are going to have to live with this virus for evermore. There is very little chance that it's going to become eradicated," John Edmunds, a member of Scientific Advisory Group for Emergencies (SAGE), told lawmakers.

Although the coronavirus will be around indefinitely, Edmunds said that the prospect of a vaccine towards the end of the winter should impact the government's strategy now.

NASA spacecraft collects rock samples from asteroid Bennu

A NASA SPACECRAFT SUCCESSFULLY TOUCHED DOWN ON THE RUGGED SURFACE OF ASTEROID BENNU. COLLECTING A SAMPLE OF ROCKS DATING BACK TO THE BIRTH OF OUR SOLAR SYSTEM TO BRING BACK TO EARTH

Washington, Oct 21: After a fouryear-long journey, NASA's OSIRIS-REx spacecraft successfully touched down on the rugged surface of asteroid Bennu Tuesday, and unfurled its robotic arm to collect a sample of rocks dating back to the birth of our solar system to bring back to Earth, the US space agency said.

Origins, Spectral Interpretation, Resource Identification, Security, Regolith Explorer (OSIRIS-REx) spacecraft briefly touched the near-Earth asteroid to collect dust and pebbles from its surface for delivery to Earth in 2023.

Asteroid Bennu is currently more than 321 million kilometres from the Earth. It offers scientists a window into the early solar system as it was first taking shape billions of years ago and flinging ingredients that could have helped seed life on

Earth, NASA said. If Tuesday's sample collection event, known as "Touch-And-Go" (TAG), provided enough of a sample, mission teams will command the spacecraft to begin stowing the precious primordial cargo to begin its journey back to Earth in

Otherwise, they will prepare for another attempt in January, according to NASA. "This amazing first for NASA demonstrates how an incredible team from across the country came together and persevered through incredible challenges to expand the boundaries of knowledge," said NASA Administrator Jim Bridenstine.

"Our industry, academic, and international partners have made it possible to hold a piece of the most ancient solar system in our hands,' Bridenstine said in a statement. OSIRIS-REx fired its thrusters to nudge itself out of orbit around



Bennu, extending the shoulder, then elbow, followed by the wrist of its 3.35-metre sampling arm, known as the Touch-And-Go Sample


across the asteroid while descending about 805 metres towards the surface. After a four-hour descent, at an altitude of approximately 125 manoeuvres to allow it to precisely target the sample collection site, known as "Nightingale."

Ten minutes later, the spacecraft fired its thrusters for the second "Matchpoint" burn to slow its descent and match the asteroid's rotation at the time of contact.


It then continued a treacherous, 11-minute coast past a boulder the size of a two-story building, nicknamed "Mount Doom," to touch down in a clear spot in a crater on Bennu's northern hemisphere.

The size of a small parking lot, the Nightingale site is one of the few relatively clear spots on this unexpectedly boulder-covered space rock. 'This was an incredible feat -- and today we have advanced both science and engineering and our prospects for future missions to study these mysterious ancient storytellers of tor for NASA's Science Mission Directorate at the agency's head-

"A piece of primordial rock that has witnessed our solar system's entire history may now be ready to come home for generations of scientific discovery, and we can't wait to see what comes next,' Zurbuchen said. NASA said all spacecraft telemetry data indicates the TAG event executed as expected. adding, however, it will take about a week for the OSIRIS-REx team to confirm how much sample the spacecraft collected. The spacecraft carried out TAG autonomously, with pre-programmed instructions from engineers on Earth.The OSIRIS-REx team will begin to assess whether the spacecraft grabbed any material, and, if so, how much. The goal is at least 60 grammes, which is roughly equivalent to a full-size candy bar, NASA said.

About 5,300 employees based in Hong Kong and another 600 elsewhere will likely lose their jobs, and 2,600 unfilled positions will be cut.

Govt may sweeten deal further for Al sale bid

New Delhi, Oct 21: The government may further extend the date for submission of bids for Air India sale date beyond October 30 to give investors more time to make an offer while sweetening the deal terms further, finance minister's officials privy to the development said.

The submission of initial bid or expression of interest (EoI) may be extended by 45 days to two months to December. Also, officials said that bidders would be given the option to decide on the quantum of debt in Air India books that they will like to absorb rather than freezing the debt amount and seeking investors' bids.

As per the Air India EoI floated by DIPAM in January, of the airline's total debt of ₹60,074 crore as of March 31, 2019, the buyer would be required to absorb ₹23,286.5 crore, while the rest would be transferred to Air India Assets Holding Ltd (AIAHL), a special purpose

With the proposed changes, buyers will decide on the level of debt that they will take and the one taking the largest debt may be considered favourable to be declared

'India at doorstep of economic revival'



Govt relaxes import norms for onion to boost supply

New Delhi, Oct 21: The government Wednesday relaxed import norms till December 15 to facilitate the early shipment of onion to boost the domestic supply and check the retail prices of the key kitchen staple. The Union Consumer Affairs Ministry, in a statement, said it will also offload more onion from its buffer stock in the open market to contain price rise.

An estimated Kharif crop of 37 lakh tonne is likely to start arriving in the Mandis that will give reprieve to the rising prices, it added.

According to the ministry, a sharp spike in onion prices in the past 10 days by ₹11.56/kg has taken the all-India retail price of the commodity to ₹51.95/kg, which was 12.13% higher than the last year's price of ₹46.33/kg.

The retail price of onion has shown a marked increase from August-end 2020, though the price level was below that of last year till October 18, it said.

To facilitate import of onion, the ministry said, "The government has on October 21 relaxed the conditions for fumigation and additional declaration on Phytosanitary Certificate (PSC) under the Plant Quarantine Order (PQ), 2003 for import up to December 15, 2020"

The Indian High Commissions have been instructed in the relevant countries to contact the traders to push for greater onion imports to the country. Such consignments



of imported onions, which arrive at Indian ports without fumigation and endorsement to that effect on the PSC, would be fumigated in India by the importer through an accredited treatment provider.

If Stem and Bulbs nematode (Ditylenchus Dipsaci) or onion maggot (Hylimia Antiqua) is detected it would be eliminated through fumigation and the consignments to be released with no additional inspection fee.

"An undertaking will be obtained from the importers that the onion will be used only for consumption and not for propagation," the ministry said. Such consignments of onions

for consumption will not be subiected to four times an additional inspection fee on account of noncompliance of conditions of import under the PQ order, 2003, it added. In order to moderate prices, the

ministry said that onion from the buffer stock is being released in a calibrated manner from the second half of September 2020 to major mandis, retail suppliers such as Safal, Kendriya Bhandar, and NCCF as well as state governments. "More will be done in the coming days,'

Mumbai, Oct 21: Online spending, which has got a boost during the pandemic, is expected to grow at an annual rate of over 35% to \$200 billion in the next five years, and a lot of this growth will come from direct-to-consumer brands, according to a report.

The domestic direct-to-consumer (D2C) market is estimated to be \$100 billion by 2025, or 11% of the total retail market that is slated to touch \$1.7 trillion by then, investment bank Avendus Capital said

Overall retail market stood at

\$977 billion in 2019, it said. The domestic retail market, which is the fifth largest globally, is projected to surpass \$1.7 trillion by

2025, driven by e-tailing. Of the total retail market, only 17% was in the modern trade in 2019, which is slated to touch 31% by 2025.

The rise in online shopping is fuelled by the 639-million strong internet population, which is growing at 24%. The country has added 80 million shoppers in the past three years to reach 130 million now, according to the report.

Thomas Tuchel's side looked nothing like the one who reached the final of last season's competition as they lacked energy throughout in an empty Parc des Princes.


