Relief to small borrowers CENTRE ROLLS OUT SCHEME FOR INTEREST WAIVER ON LOANS UP TO ₹2 CRORE

New Delhi, Oct 24: The Finance Ministry has announced a scheme for ex-gratia payment of difference between interest for the designated class of borrowers to provide relief in times of Covid-19 pandemic.

The scheme issued by the Department of Financial Services provides the difference between compound interest and simple interest for six months of loans up to ₹2 crore.

The scheme can be availed by designated class of borrowers from March 1 to August 31, 2020.

Those having loan amounts above $\overline{\mathbf{x}}_2$ crore are not eligible. "Borrowers, who have loan accounts having sanctioned limits and outstanding amount of not exceeding ₹2 crore (aggregate of all facilities with lending institutions) as on February 29 shall be eligible for the scheme," it said.

The class of borrowers included: housing loan, education loans, credit card dues, auto loans, MSME loans, consumer durable loans and consumption loans.

As per the scheme, the lending institutions shall credit the difference between compound interest and simple interest with regard to the eligible borrowers in respective accounts for the said period irrespective of whether

The government has clarified that the payment does not constitute a legal, contractual or equitable liability of the Central government and is only an exgratia payment to borrowers in view of the Covid-19 pandemic.

The affidavit said the only solution is that the government should bear the burden resulting from waiver of compound interest.

"After careful consideration and weighing all possible options, the respondent Union of India has decided to continue the tradition of hand-

holding the small borrowers," said the Centre. The Centre said it is impossible for the banks to bear the burden resulting from waiver of compound interest without passing on the financial impact to the depositors or affecting their net worth adversely, which would not be in larger public interest.

The affidavit said: "The government, therefore, has decided that the relief on waiver of compound interest during the six-month moratorium period shall be limited to the most vulnerable category of borrowers.

New Delhi, Oct 24: In a major relief to taxpayers, the Government Saturday announced extension of the due date for filing income tax returns for the assessment 2020-21 by another month to December 31, 2020.

The earlier extension allowed such filing by general taxpayers by November 30. Along with general category of taxpayers, the government also extended the date of filing returns by taxpayers (including their partners) who are required to get their accounts audited and those who are required to furnish report in respect of international/specified domestic

New Delhi, Oct 24: China has illegally occupied Nepal's land at several places spreading over seven_ bordering districts and Indian intelligence agencies have sounded an alert in New Delhi.

The agencies have flagged that Beijing is fast moving forward and further pushing Nepali boundaries by encroaching more and more landmass. "The actual scenario could be worse as the Nepali Communist Party (NCP) is trying to shield the expansionist agenda of the Chinese Communist Party (CCP)," an internal intelligence agency report pointed out. The report also talked about the Survey Department of Nepal flagging China's attempts to grab land before Nepal Prime Minister KP Sharma Oli which was ignored. It stated that Nepali districts which are victims of China's land-grabbing plan include Dolakha, Gorkha, Darchula, Humla, Sindhupalchowk, Sankhuwasabha and Rasuwa. China has pushed the international boundary 1,500 metres towards Nepal in Dolakha including pushing the boundary pillar Number 57 in the Korlang area in Dolakha, which was previously located at top of Korlang. Similar to Dolakha, China has relocated Boundary Pillar Numbers 35, 37 and 38 in Gorkha district and Boundary Pillar Number 62 in Nampa Bhanjyang in Solukhumbu. The first three pillars were located in Rui village and areas of Tom River

The agency warns nations against giving green light to Gilead Science Inc's remdesivir

Geneva/Zurich, Oct 24: Health officials reviewing Gilead Science Inc's remdesivir against Covid-19 should consider all evidence, including a trial in which the medicine failed, before giving it the green light, the top WHO scientist said Friday.

US regulators appeared not to have done so when approving the drug this week, Soumya Swaminathan told a news confer-

The US Food and Drug Administration Thursday approved Gilead's antiviral drug for treating patients hospitalised with Covid-19, making it the first and only



drug approved for the disease in the United States.

The FDA decision came a week after the release of the results of the World Health Organization's Solidarity trial, which concluded remdesivir has little or no impact on a patient's chances of surviving

Covid-19. The FDA said its approval was based on three trials, including a 1,062-patient study by the National

Institute of Allergy and Infectious Disease, which found that remdesivir reduced hospital stays to 10 days from 15 days, and helped reduce the risk of death in some patients who were receiving oxygen. The drug did not improve overall survival.

"The Solidarity results do not refute these findings of benefit to patients," the FDA said in a statement posted on its website.

> Remdesivir is also approved for treatment of patients with severe Covid-19 in Japan, Taiwan, India, Singapore, the United Arab Emirates and the European Union. Gilead is allowing generic compa-

nies to manufacture the drug for supply to 127 low-income countries.

46K non-Aadhaar pensioners turn up

Bhubaneswar, Oct 24: The Department of Social Security and Empowerment of Persons with Disabilities (SSEPD), the nodal department handling pensions in the state, has said that less than 50,000 pensioners without Aadhaar turned up for pensions recently.

This is against the claim of 11 lakh pensioners who were enrolled in different Central and state government pension schemes. A total of 11 lakh pensioners in the state as per government data, were not having Aadhaar or had not seeded them with their pension accounts

Several organisations had been claiming that 11 lakh pensioners were likely to be deprived of their pensions if Aadhaar was made mandatory for pension payment. The government earlier this year had issued notification asking all the District Social Security Officers (DSSOs) to release pensions only to pensioners with Aadhaar cards.

The department had to take back the decision after several civil society members opposed the



mandatory Aadhaar linkage. Many CSOs had feared that it may deprive the elderly, widows, differentlyabled and others who get pensions, be it under the state scheme of Madhu Babu Pension Scheme (MBPS) or the National Social Assistance Programme (NSAP) of the Union government, of their pension

'We knew the ground reality. The notification for mandatory Aadhaar was brought to weed out the fake beneficiaries. But we had to withdraw our order after protests. However, the recent data is promising," a senior official from the department said requesting anonymity.

He added, "There were claims of 11 lakh non-Aadhaar pensioners not getting pensions due to mandatory Aadhaar regime. But

in the latest disbursement, only 46,000 such people without Aadhaar turned up. This raises our doubt.'

The department told this reporter that it has already asked all DSSOs to enroll all left out pensioners with Aadhaar and seed them with their respective pension accounts.

During the past few years, the Rural Development Ministry and other Central ministries have been asking the state and the SSEPD department to shift towards Direct Benefit Transfer (DBT) of pensions and ensure 100 per cent Aadhaar seeding of pensions for the National Social Assistance Programme (NSAP) database.



Though Nepal's official map shows the village as a part of Nepali territory and citizens of the village have been paying taxes to Nepal government, China had occupied the region and merged it with the Tibet Autonomous Region of China in 2017. NRIS quota affront to worthy candidates: HC

Cuttack, Oct 24: The Orissa High Court has observed that a reservation for the non-resident Indian sponsored (NRIS) category for admission to national law universities is 'unconstitutional' and an 'affront to the meritorious candidates' who work hard to secure seats in these institutes through a common entrance test

The court also said the consortium of national law universities (NLUs), the Bar Council of India and all other stakeholders involved in the process should revisit the NRIS reservation and prepare a proper regulation while implementing this quota.

Hearing a petition, a division bench comprising Justice Sanju Panda and Justice S K Panigrahi Tuesday observed that the $\ensuremath{\bar{\mathrm{NRIS}}}$ category is like a 'reservation for the elite class'

"...we are constrained to observe that the NRIS category is an affront to the meritorious candidates who toiled day night to secure seats in NLUs through CLAT (Common Law Admission Test)," the bench observed.

The candidates belonging to the category of NRI or NRIS, who are very low-ranked in the merit list, often get seats in the NLUs, while the general candidates having secured better marks lag behind the reserved students and get disappointed, the court said.

"This is like the reservation for the elite class and this dubious category of quota is unconstitutional," the

Complete bridge over Kanupur project, NHAI told

Bhubaneswar, Oct 24: The state Water Resources department has urged the National Highways Authority of India (NHAI) to take measures to complete the much awaited Kanupur irrigation project in Keonjhar district.

According to the department sources, the dam and spillway works of the irrigation project are almost complete except the river gap portion. River closing is a vital activity for impounding the reservoir and this has been inordinately delayed due to delay in the construction of bridge over the spill channel of Kanupur irrigation project by NHAI, official sources said here Saturday.

Despite repeated reminders, the NHAI is not showing any interest to take up the bridge work, which is resulting cost overrun.

Water Resources secretary Anu Garg has recently written to NHAI chairman urging the later to take appropriate action for early completion of the bridge.

NHAI was supposed to execute the fourlane bridge project over Kanupur spill channel at 173.325 km of Rimuli-Roxy-Rajamunda section of NH-215 (new NH-520). However, it failed to take up the work after several meetings and correspondence at different levels. Therefore, the construction of the bridge came under the purview of Kanupur Project Authority after obtaining the consent of NHAI.

Accordingly, the project authority started the work for the tendered cost of ₹40.68 crore of which NHAI agreed to bear 80 per cent. But, later on, the cost of the bridge was revised to ₹100.53 crore due to change in its design. As the NHAI didn't agree to bear its share of 80% of the revised cost, the work stopped.

In order to resolve the issue, the then Water Resources secretary had held a meeting with NHAI chairman in March 2019 at New Delhi. The secretary stated in the meeting that since NHAI remained firm in bearing 80 per cent of the initial cost of ₹40.68 crore, the work undertaken by state government was terminated. The then secretary requested the NHAI chairman to take up the work at their level.







Bhubaneswar, Oct 24: Female cyber fraudsters have duped a person of more than ₹10 lakhs on the pretext of helping the poor people in India during the pandemic. The victim, Sidhartha Shankar Pani, 45, of Parjang area in Dhenkanal district, lodged a complaint with the cyber police station at the state Crime Branch in Cuttack a few days back.

According to sources, Pani received a text message from a lady who identified herself as Miss Maurine Alex of London, UK on his Facebook messenger. She sought friendship in her text message of the victim which he accepted too.

Subsequently, they entered into a friendship and used to chart on Facebook, Whatsapp and other social media platforms. Meanwhile,

she expressed her willingness to help the poor and distressed people in India who have been undergoing financial hardships due to the pandemic. The con-woman also informed Pani that she would reach India shortly and sought his help for the purpose of helping the poor.

On September 29, Pani received a call from the lady who informed about her arrival at New Delhi Airport. A few minutes later, the lady again called up Pani and sought his cooperation as she was facing difficulties in converting her draft of £2, 50,000 into Indian currency. Subsequently, Pani received another call from another lady who identified herself as the Customs Department official at New Delhi Airport.

Pani also found out from the 'true caller app' that the phone number was registered in name of

Indian Air Port. She allegedly pursued Pani to help Miss Maurine following her instructions as everything will be done according to the Indian government procedures.

Later the victim started depositing various amounts in different bank accounts as instructed by the fraudsters to cover the alleged draft. Pani lost ₹10, 36,200 to the cyber criminals on the pretext of income tax, currency conversion charges, Bank reflection code certificate charge beneficiary anti terrorism and anti money laundering certificate charge for exchange of draft. However, he smelt a rat when they continued to demand more money repeatedly calling him on different pretexts. He even received a fake email from Reserve Bank of India mentioning the procedure in connection with the deposit of draft in his account.

Chhatar Jatra passes off peacefully sans devotees

Bhawanipatna, Oct 24: In a first, the famous Chhatar Yatra of Devi Manikeshwari, the presiding deity of Kalahandi, was held amid Covid-19 restrictions and tight security without devotees here in Kalahandi district. Saturday.

A procession of the representative deity of Manikeshwari called 'Chhatar' left for Jenakhal to the west of Bhawanipatna town at 4.14 am after completion of all secret rituals and animal sacrifice before the deity at the main temple.

An animal sacrifice was also held at the Budharaja (Bhairav) temple on the north gate of the main temple before the start of Chhatar Yatra

The ceremonial 'Chhatar' returned to the temple in a procession passing through the 4-km long road to the main temple under tight security and similar restrictions to prevent congregations.

Even no musical troupes were allowed to participate in the



procession except for the Jena Baja troupe and the Ghumura troupe permitted by the Kalahandi royal palace.

As per the order, no devotee was allowed to enter the temple and take part in rituals during the event. The age-old practice of animal sacrifice by devotees along the raod on the occasion was not reported so far as the animal sacrifice was

banned after the High Court order. The district administration had clamped Section-144 and sealed all entry points to Bhawanipatna town from October 23 to October 24 to prevent people and passenger vehicles from entering the town.

The district administration also prevented people from coming out of their houses by sealing all entry points of the streets.

As per traditions, every year at the Manikeswari Temple, hundreds of animals and birds are sacrficed on the road when the Chhatar of Maa Manikeswari is taken out in a procession from the main temple to Jenakhal, a distance of 4 km, in the town.

As a result, the roads acquire a tinge of red due to the merciless killing of thousands of animals and birds by the devotees. The devotees claim that sacrifice of animals propitiates the deity who in turn fulfills their wishes.

However, the age-old practice of animal sacrifice in Chhatar Yatra for propitiating the deity was restricted this year fearing spread of Covid-19 among the people.

Around 10 platoons of police force comprising an additional SP, four DSPs, 14 police inspectors, 19 sub-inspectors, 32 ASIs,74 constables, 70 home guards including SOG, DVF and CRPF jawans maintained law and order during the festival.

District Collector Gavil Parag Harshad, SPB Gangadhar, sub-collector Susant Singh, ASP Mani Patra, DRDA PD Bimbadhar Sahu and host of administrative and police officials supervised the peaceful completion of the festival.

Notably, Orissa High Court had imposed a ban on animal sacrifice in and around the Devi Manikeswari temple during Chhatar Jatra January 6. Later, the Supreme Court clamped an interim stay on the HC order.

Hilltop villages seek rehab, development

Make voting safer

ndia's electoral system, run by the Election Commission of India, is one of the world's wonders. It was not too long ago (and in fact many of us L can remember those days) when Bihar's elections were associated with violence and booth capturing. A series of innovations from the Election Commission under TN Seshan and his successor MS Gill resulted in violence reducing considerably. And also the introducing of machines ensuring that voting happened smoothly and counting quickly.

Many things have changed in the democratic space in India but it is still the case that all parties believe or assume that the autonomous Election Commission run by 300 officials in Delhi is independent of the government. The EC also has an international reputation because of its accomplishments and officials from Russia, Sri Lanka, Nepal, Indonesia, South Africa, Bangladesh, Thailand, Nigeria, Namibia, Bhutan, Australia, Afghanistan and even the United States have visited it to see how they can improve their own systems better

Voting systems in older democracies come from tradition and are difficult to change both from the point of view of the State and the voting citizen. It is for this reason that the broad and quick reforms and their wide acceptance in India are all the more remarkable

Having accepted all this it must be asked if we cannot further reform the process and also learn from practices that other nations follow that might help us. Bihar is going to the polls in three phases between October 28 and November 7. This splitting of voting will help the State machinery manage its resources such as security personnel better and reduce the load on the EC

However, the phase-wise voting will not be of any use in reducing the risks of Covid transmission. The number of people queuing up to vote in any given polling station will remain the same. Is there a way that this can be addressed? We could look at what is happening in America, which is going to the polls on November 3 to elect their president. As of October 24, about 5.5 crore Americans had already voted for that election. This was a figure that was 40 per cent of the total votes that had been polled for the presidential election in 2016. Meaning that these 40 per cent people would not have to show up in the queue on November 3, greatly reducing the risk of Covid spread overall.

In the days that lead up to the election, it is possible that another 30 per cent or more people will also have voted in advance and that will

reduce the stress and risk at the polling booth for officials and for voters. Voting rules in the US are a state and not federal subject and so each of the 50 US states has its own rules. They allow for voting by mail (voters have to request for a mail-in ballot which is sent to them and which they can then post back) or voting in person at the designated voting booth which opens three weeks before the official voting day.

The counting of votes does not begin till the last day as it would in other places. This ensures that there is no advantage or perception of one side appearing to be so far ahead in early voting as to discourage the other side's voters from showing up. Though this is not a new system and has been around for many years it is without doubt that it is going to help American voters and officials reduce Covid transmission risks in a way that Bihar will not be able to.

A record number of people are expected to vote in this year's US election and even with that it is indisputable that the mail-in ballot and the in-person advance voting system gives America a great advantage. Indeed, the safety of the voting process is also one reason why the numbers of those showing up to vote is so high

The hope is that the Bihar election also passes safely, but we are entering into a fairly long election season when large states like Bengal and Uttar Pradesh are going to vote. India needs to examine some way in which, assuming that there is either no vaccine or a delay in administering it to everyone, voting can be made safer. This will have to be done with the consent of all parties

Matt Haig's latest book the 'Midnight Library' goes on to describe Nora's adventures through the many parallel lives she had given up on for one reason or the other. After many exhilarating journeys and wise conversations with her librarian-cum-life coach, Nora finally returns to the original life as she gets convinced that suicide is not the solution to life's challenges.

Seed decided to commit

As the world deals with the pandemic and death seems to surround us, mental health issues leading to suicide have become a major challenge. Whether it is the much-publicised suicide of a cine star or the multitudes of ordinary people, mental health issues need urgent attention. The book could n't have come at a better time. It weaves a magical spell through the many parallel stories around the central character that conjectures about the existence of parallel universes existing simultaneously as postulated by string theory. Heisenberg's uncertainty principle and the famous Schrodinger's cat experiment also duly come into picture along with Nora's favourite philosopher Thoreau. What Matt missed out on however was the so-called 'Game Theory' of social interaction which is based on science and mathematics

I had a friend at the University of Michigan who was studying game theory or rather using its principles to create actual board games for teens to help teach them about making choices that would

affect their lives. To me, it appeared quite superfluous that one has to teach intelligent kids the fact that if you decide to hang out with friends who do drugs then you would most likely end up in prison. Or if you have unprotected sex, then you may have to deal with unwanted pregnancies and parenthood! But some choices in life are much less straightforward! Brilliant yet troubled minds like that of the American mathematician John Nash, a Nobel laureate in Economics, illustrated this through his work which is best illustrated by the famous thought experiment 'The Prisoner's Dilemma'. Imagine two prisoners (say A and B) who are faced with the choice of whether to confess or keep silent about their crime committed together. The rules of the game are that if both confess then each of them gets two years of jail. If one confesses and the other doesn't then the one confessing gets no jail time with the other getting three years. If both choose not to confess then they each get one year. The Nash equilibrium refers to one's decision to be unchanged knowing the decision of the other. Without know-

ing the decision of prisoner A, B has to confess in order to keep his/her jail term to a maximum of two years. This is known as the 'dominant strategy' in game theory reflecting Adam Smith's freemarket doctrine based on self-interest being paramount. The Nash equilibrium, on the other hand, claims that every such game is a combination of decisions that is not only best for the individual but the group as a whole. In this case, it requires both A and B to neither confess nor cooperate. These kinds of games are called 'competitive games' The other group of games is

known as 'cooperative games' where every player agrees towards a common goal. It could be a situation where a group of friends trying to decide how to divide a bill for dinner at a restaurant or a group of nations trying to determine how to fight climate change together. Like the Nash equilibrium for competitive games, the Shapley value determines a fair distribution of gain from any joint venture taking into account what is known as the marginal contribution of individual players. For example, let's assume player A


can plant 10 trees an hour and player B 15 trees an hour. Working together they can plant 30 trees an hour for which there is a reward of say Rs 3000 at Rs 100 per plant. To determine how to divide the reward in a fair manner, Shapley value determines the average of the reward minus the individual marginal contributions. In this case marginal contributions of A and B being 1000 and 1500 respectively, the Shapley value for player A is half of (1000) + (3000-1500) = 1750. Player B gets 3000-1750 = 1250. In competitive games, game theory teaches us how to be 'smart whereas, in cooperative games, it tells us how to be 'fair'.

Imagine life as a game with as many players as people we interact within our lives with all its complications. Now, we can appreciate the complexity of decision making in a real-life situation, be it in our individual circumstances or in the lives of nations as in politics and economics. Had Nora Seed been as exposed to the game theory of life as she was to philosophy she perhaps wouldn't have had to come to the predicament that she did in the novel. Seed's life story is about all the life choices she made that were documented in the book of regrets. Each of us has our own book of regrets which helps us to know a particular life that might have been if we made a different life choice! The present time is increasingly stressful with a rampaging pandemic, economic distress and loud footsteps of climate catastrophe looming. The game theory holds out the hope for cooperative decision making that would be perhaps humanity's only chance to avoid a painful extinction just as Nora Seed managed to right from the brink.

Unitasker

unitasker is a tool or device that does only one thing. Before it meant Athat, it was a dismissive term for a person who does one job at a time before moving to the next, the opposite of a multitasker. It's one of those slow-burn words that seems to be creeping up on us in a variety of fields, becoming accepted because it's a useful term of abuse to describe those gadgets we buy because they seem like a good idea at the time. This is despite experience teaching us that their advantages don't justify their cost or the space they take up or that a general-purpose item could do the job as well. It's used in particular for specialist kitchen gadgets (electric gravy boat warmers, strawberry slicers, watermelon knives) and odd computing contraptions (USB foot warmers). Unitasker has been popularised by the American TV chef Alton Brown and the website unclutterer.com. Not all unitaskers are bad, of course; some of them are invaluable and their limitations are a strength, not a weakness. What's wrong with a fire extinguisher? It does one job well. (OK, you can use it to prop the door open or brain a burglar, but we're talking about intended uses here.) And one person's useless unitasker is another's onion-ring holder or USB fragrance oil burner.

September 29. But there is a powerful hidden psychology behind the tactic of interjecting and interrupting. Could these two experienced campaigners-and Trump especially-have used it to their advantage in an attempt to appear more dominant and assertive?

The fact that the debate organisers had to seek a technological solution suggests that interruption might be a more potent tactic than many realise. Political and psychological strategists in both campaigns may increasingly be advocating it as a rhetorical weapon. What do they know that we don't?

Psychological research involving scientific experiments has found that people evaluate those who interrupt more as being more capable, confident, dominant, and persuasive. But this comes at a price, because interrupters are also usually seen as less likeable and attractive.

In the midst of a pandemic, some voters may favour the more dom-

searchers have found this to be especially true for female interrupters.

Some research has found that men interrupt (especially with intrusive interruptions) more than women do. Other studies indicate that women are more interrupted than men are, and that men interrupt women significantly more than they do other men. But a lot depends on the precise nature and timing of the interruption.

Different types of interruption have different effects. Deep and 'intrusive' interruptions try to change the subject and prevent the other person from speaking. 'Overlapping interruptions' involve someone interrupting when another person appears to be coming to the end of making a point. There are even so-called silent interruptions where, for example, someone momentarily forgets the word they were looking for, or pauses to find the right phrase. and their adversary steps in to supply it, but then takes over the conversation.

A recent psychology experiment investigating the effects of different kinds of interruption found. surprisingly, that an audience evaluated so-called 'disagreement'

this finding, according to the study's authors, is that 'disagreement' interruptions at least suggested a strong engagement with the issue, and did not necessarily imply the same disregard for the speaker being interrupted as 'change-subject' interjections did. In other words, there appear to be ways of interrupting that seem justified. But as a debating tactic where the aim is to defeat an opponent rhetorically, interrupting has some powerful hidden psychology behind it. For example, if you know that your opponent tends to interrupt and is constantly looking for an opportunity to take the floor from you, then you might speak faster than you normally would. The fear of providing an opportunity for a 'silent' interruption may push you into unfamiliar conversational territory and cause you to stumble or misspeak, resulting in a verbal gaffe that your opponent can exploit.

Moreover, if you are aware that your opponent is interrupting you and gaining more floor time, then you may feel pressured into responding in kind. But if you are less skilled at interrupting, your timing may be poorer and your choice of opportunity may then reflect badly on you. You end up being the one

were hoping. For them not to allow you the chance to speak when you assert that you agree now makes them look like the one seeking conflict and confrontation.

The real psychological power of interrupting perhaps isn't even on display in presidential debates, but instead lies in the way that it disrupts the other candidate's thought patterns. Here lies the real danger: interruptions succeed by stopping you from thinking clearly.

Recent research found that so called 'sub-clinical' psychopaths, tended to detect who interrupted them more, and as a result, appeared to become less interested in a potentially exploitative future relationship. In other words, if you interrupt a psychopath more than they are used to while they are trying to make a point, they notice this quickly and infer that they may be less able to manipulate or use you, and move on to other targets.

So, when Trump interrupted Biden in the two debates, there was a lot more going on beneath the surface than simple rudeness.

he said. The amalgam, which met for the first time after its formation, will come out with a white paper within one month on governance in Jammu and Kashmir over the past one year since the abrogation of article 370, Lone told reporters after the meeting.

"The white paper will not be rhetoric. It will be based on facts and figures to present the reality to the people of Jammu and Kashmir and around the country.... An impression is being given that all the corruption had happened in Jammu and Kashmir," Lone said.

The amalgam decided to hold its next meeting after a fortnight in Jammu, followed by a convention

in Srinagar on November 17. As a mark of defiance to the constitutional changes made by the Centre with respect to Jammu and Kashmir last year, the alliance adopted the flag of the erstwhile state as its symbol.

While the Communist Party of India's Kashmir head AR Trukroo joined the PAGD, Jammu and Kashmir Pradesh Congress Committee has quietly distanced itself from the alliance.

JKPCC chief Ghulam Ahmad Mir, who was part of the meetings that took place before the formalisation of PAGD earlier this month, has skipped the last two meetings. The JKPCC had issued a statement after the previous meeting that Mir could not attend due to the advice of doctors.

This time the party did not explain its absence from the meeting.

New Delhi, Oct 24: Delhi's smog crisis headed for a new toxic peak Saturday but farmers are refusing to stop the stubble burning that is widely blamed for the poisonous clouds engulfing the capital

Air pollution in parts of the city reached 'severe' levels Saturday -- a day after US President Donald Trump described Indian air as 'filthy' -- with monitoring agencies warning it would worsen in the next two days because of the lack of wind. Teams in states around Delhi, home to some 20 million people, are hunting the illegal stubble burners, even driving around country roads at night when most fires are started.

In the past month some 1,265 farmers have been fined in Punjab alone, according to senior pollution officer Krunesh Garg, but satellite detectors have recorded more than 12.000 fires in the state.

In a bid to step up the campaign, the government is offering subsidised machines to clear rice paddies and farmers who are caught starting fires are blocked for bank loans. But thick grey clouds of smoke that carry deadly particles to the world's most polluted capital can still be seen everywhere. Because of Delhi's position and

weather pattern, every winter the city is choked by deadly smog.

Farmers like Paramjeet Singh say they understand inhabitants' health concerns but consider stubble burning a "necessary evil" in the race to clear fields for fresh crops.

tackle pollution is still lacking with central government and Delhi, Punjab and Harayana states unable to agree tough action to clean the air. And this year farmers, who represent a powerful voting bloc, are upset over new laws they fear will let large private retailers control pricing. "Yes we are angry and we don't care about the government. Many farmers I know burnt the crop residue mainly to spite the government," said 62-year-old farmer Yashpal Singh. "If the farmers wanted they could have lis-

New Delhi, Oct 24: Four members of a family have been arrested for allegedly duping several banks of over Rs 20 crore by forging documents and fraudulently availing loans by mortgaging same properties multiple times, police said Saturday.

In one such case, the accused fraudulently availed loan on a property which was already acquired by the Delhi Metro Rail Corporation, they said

Ashwani Arora and Vijay Arora along with their wives, who were absconding for nearly four years. were arrested from different places in Ghaziabad and Delhi after the Economic Offences Wing (EOW) of the Delhi Police conducted simultaneous raids in connection with a 2016 case of bank fraud, they said.

The matter came to light after a complaint was received in 2016 from Zonal Manager of Punjab and Sind Bank, in west Delhi's Nariana, police said.

In the complaint, the bank alleged that M/s Riya Enterprises availed ODP (Overdraft against Property) limit of up to 70 lakhs.

This limit was released against the equitable mortgage of a property on GT Road, Shahdara, which was in the name of Ashwani Kumar who was also the guarantor in this loan. These limits were granted by Punjab and Sind Bank in Karol Bagh.

Based on the complaint, a case was registered and investigation was taken up, he said.

Joint Commissioner of Police (EOW) Dr OP Mishra said during the investigation, it emerged that all the accused prepared forged chain of property papers. on the basis of which, they suc ceeded in getting the property registered fraudulently before the Registrar Office either in their name or in the name of other persons.

"On the basis of these forged documents, they availed loans multiple times on same property from many banks. Using the same modus operandi, they succeeded in availing loan from the complainant bank. After some time they stopped paying interest and duped them of Rs 6 crore. During investigation, it was found that the accused not only multi-mortgaged the properties but also availed loan on a property which was already acquired by the Delhi Metro Rail Corporation," he said.

So far, it has emerged that the accused have duped at least five banks for more than Rs 20 crores, he added. The officer said the accused formed firms and created alibi for taking loans. Thereafter, they created multiple sets of documents of the same properties and on the basis of this, they availed loan from various banks. They created multiple identities by changing their names and parentage, he added.





Faulty military equipment raises doubts over China's tech prowess

The world's fifth-largest arms exporter in 2015-19, China accounted for 5.5 per cent of total global arms exports with its top customers including its Belt and Road Initiative partners

New Delhi, Oct 24: China is fifthlargest exporter of weapon systems, after the US, Russia, France and Germany, but much of its equipment sold to various countries is defective, say sources in intelligence agencies.

The world's fifth-largest arms exporter in 2015-19, China accounted for 5.5 per cent of total global arms exports with its top customers including its Belt and Road Initiative partners as Beijing presents itself as an alternative to Russia.

In 2015-19, Asia and Oceania accounted for 74 percent of Chinese arms exports, Africa for 16 percent and the Middle East for 6.7 percent, while the number of countries to which China delivers arms has grown significantly - from 40 in 2010-14 to 53 in 2015-19. Pakistan was the main recipi-

ent (35 per cent) in 2015-19, as it has been for all five-year periods since 1991. Intelligence agencies have prepared a report recently where it highlighted how Beijing has pushed "defective equipment" to friendly nations in Asia, the Middle East and Africa.

Bangladesh

China gave two obsolete 1970s era Ming class Type 035G submarines to Bangladesh at \$100 mn each in 2017. Recommissioned as BNS Nobojatra and BNS Joyjatra, these were originally used as training vessels for People's Liberation Army Navy and had outlived their utility.

'The condition of these submarines is so bad that they are reportedly lying unserviceable for considerable time," the intelligence report stated.

In April 2003, PLA Navy Ming Class submarine 361 suffered a mechanical failure in the Yellow Sea,

The Pakistan Army has procured nine systems of LY-80 LO-MADS from China, signing two separate contracts for the supply of the Air Defence System along with IBIS-150 radar. Delivery of all nine

systems was completed in 2019. However, three out of nine systems are non-functional due to faults in guidance vehicle, search vehicle and firing vehicle.

"Pakistan Army has conveyed to M/s Aersospace Long-March International Co Ltd (ALIT) that these need to be addressed on priority," the report stated.

Myanmar

Myanmar's senior leadership is unhappy over the quality of Chinese equipment supplied to them but is helpless due to lack of sources. However, they have started diversifying their imports, looking towards India.

Srinagar, Oct 24: After joining the alliance for implementation of the Gupkar declaration, former Chief Minister, Mehbooba Mufti seems to have written the agenda for the alliance.

To be or not to be? Shakespeare's Hamlet has finally come to haunt the members of the Gupkar alliance after Mufti's press conference.

Speaking to the media in Srinagar Friday, the Peoples Democratic Party (PDP) president, Mehbooba Mufti said unless the special status of J&K is restored as it existed before August 5, 2019, participation in any electoral process was meaningless.

Six parties in the alliance for the implementation of Gupkar declaration include the National Conference (NC) headed by Dr. Farooq Abdullah, PDP headed by Mehobooba Mufti, Peoples Conference (PC) headed by Sajad Gani Lone, Awami National Conference (ANC) headed by Khalida Shah, Jammu and Kashmir People's Movement (JKPM) headed by Feroz Peerzada and the local unit of the CPI-M headed by Yusuf Tarigama.

The Gupkar declaration seeks restoration of Articles 370 and 35A and also the statehood for J&K. Farooq Abdullah heads the alliance as the senior-most politician

and also because of the strength of his party cadre. He as the leader of the alliance has been reiterating his commitment to the declaration, but he has, so far, stopped short of making the restoration of the special status a pre-condition for participating in the elections.

Only a day back, the NC made it clear that the decision to participate or stay away from the forthcoming elections for the district development councils (DDC) would be taken by the working committee of the party. The statement clearly indicates that boycotting elections is still not part of NC's campaign for restoration of J&K's special status.

Now that Mehbooba Mufti has stated clearly that there are no grey areas while fighting for restoration of J&K's special status, non-participation in elections unless the pre-August 5, 2019 position is restored.





The question is why unemployment has become such a big election issue in this Bihar, and why the lack of jobs here is far more concerning than the rest of the country.

HIGH UNEMPLOYMENT RATE

A survey conducted by Periodic Labour Force in 2018-19 said the unemployment rate in Bihar was 10.2 per cent, which was almost double the national average of 5.8 per cent. This figure shows how the situ-

ation in Bihar as far as unemployment is concerned is extremely grim when compared nationally. Salaried jobs figure low

According to the survey, only 10.4 per cent of people in Bihar had a salaried job in comparison to the national average of 23.8 per cent people in the country having

a salaried job in 2018-19. Surprisingly, people with salaried job in Bihar in 2004-05 were merely 4.2 per cent clearly indicating the



pathetic job situation in the state. This was the period when Lalu-Rabri government was in place in Bihar and employment opportunities were extremely limited.

This was the time when people usually had no option but to run their own business or enterprise as jobs in the private sector were extremely less.

In 2011-12 people of Bihar with salaried job was 5.8 per cent, 13.1 per cent in 2017-18 and declined to 10.4 per cent in 2018-19.

This was the time when Nitish Kumar government was in place and the situation was better than 2004-05. However, employment opportunities for the youth of Bihar haven't been better than the rest of the other states.

In 2004-05, nationally 14.3 per cent people in the country were salaried, 17.9 per cent in 2011-12, 22.8 per cent in 2017-18 and 23.8 per cent in 2018-19.

When we compare Bihar with the rest of the country, data shows that Bihar has fared worse when compared with the rest of the country.

MIGRATION TO OTHER STATES

As far as migration is concerned, Bihar tops the country with the highest percentage of migration taking place every year. According to 2011 census, 32.3 per cent people in Bihar migrated to other parts of the country for job and employment followed by Odisha at 31.5 per cent.

It is not that migration began in Bihar only in Nitish Kumar's regime. Migration to other states in search of better employment opportunities was also high during the RJD regime when the educational system between 1990 and 2005 crumbled.

Lack of educational institutes (and employment opportunities lead to an increase in migration.

Washington, Oct 24: Democratic presidential candidate Joe Biden has pledged that if elected as President in the November 3 election, he will ensure free COVID-19 vaccination for all Americans, laying out his pandemic response plan just days before the US presidential polls.

In a major policy speech on the coronavirus in his home state of Delaware, Biden Friday flayed US President Donald Trump for his policies to combat the coronavirus pandemic that has killed over 220,000 people and has had a devastating impact on the country's economy.

"President Trump said we're rounding the corner, it's going away, we're learning to live with it. They are quotes. But as I told him last night, we're not learning to live with it. We're learning to die with it. This is a dark winter ahead,



Biden, 77, said.

Already more than 220,000 people in the US have lost their lives to this virus. Worse vet, a new study from Columbia University suggests that anywhere between 130,000 and 210,000 of those deaths were avoidable, he said.

Trump casts early ballot

Washington: President Donald Trump has cast his ballot Saturday morning in West Palm Beach, Florida, and he tells reporters afterward: "I voted for a guy named Trump." Conakry: Guinea's President Alpha Conde has won a third term with 59.49 per cent of the vote. the National Independent Electoral Commission declared Saturday. 4 students killed

Douala (Cameroon): Attackers shot dead at least four students and wounded a dozen others after storming into a private school in Cameroon Saturday morning, an official said. It was not immediately clear why the attack at the Mother Francisca Memorial College occurred. The deputy prefect of the community of Kumba, Ali Anougou, blamed separatists who have been fighting the military in parts of western Cameroon. Some separatists have targeted schools or students. "At least six students were shot at close range," Anougou said.

Stepanakert, Oct 24: Rocket and artillery barrage hit residential areas Saturday hours after the United States hosted top diplomats from Armenia and Azerbaijan for talks on settling their decadeslong conflict over Nagorno-Karabakh.

The heavy shelling forced residents of Stepanakert, the regional capital of Nagorno-Karabakh, into shelters, as emergency teams rushed to extinguish fires. Nagorno-Karabakh authorities said other towns in the region were also targeted by Azerbaijani artillery fire. There was no immediate information about casualties.

Officials in Azerbaijan claimed that the town of Terter and areas in the Gubadli region came under Armenian shelling early Saturday, killing a teenager. They said that another 13-year-old boy died Saturday of wounds he received in an earlier shelling of Ganja, Azerbaijan's second-largest city.

Nagorno-Karabakh lies within Azerbaijan but has been under the control of ethnic Armenian forces

backed by Armenia since a war there ended in 1994. The current fighting that started September 27 marks the worst escalation in the conflict since the war's end.

After two failed attempts by Russia to broker a truce, the US waded onto the scene on Friday, with Secretary of State Mike Pompeo hosting the Armenian and Azerbaijan foreign ministers for separate talks. "Both must implement a ceasefire and return to substantive negotiations," Pompeo said in a tweet after the negotiations.

Lisbon, Oct 24: On average, men produce more Covid-19 antibodies than women, say Portuguese researchers, adding that, 90 per cent of the patients have detectable antibod

ies up to seven months post contracting the SARS-CoV-2 virus. The results, published in the European Journal of Immunology, also show that age

is not a confound ing factor in levels of antibodies produced, but disease severity is. "Our immune system recognizes the virus SARS-CoV-2 as harmful and produces antibodies in response to it, which helps to fight the virus," said study author Marc Veldhoen from Medicina Molecular Joao Lobo Antunes in Portugal.

For the findings, the research

team set up an in-house sensitive specific and versatile Covid-19 serology test. They started to monitor the antibody levels of over 300 Covid-19 hospital patients and healthcare workers, and over 200 post-Covid-19 volunteers.

> The results of this six months crosssectional study show a classic pattern with a rapid increase of antibody levels within the first three weeks after

Covid-19 symptoms and, as expected, a reduction to intermediate levels thereafter.

"In this early response phase, on average men produce more antibodies than women, but levels equilibrate during the resolution phase and are similar between the sexes in the months after SARS-CoV-2 infection,

mit terrorist attacks and providing two powerful assault rifles to a Pakistani-origin couple who carried out a mass shooting in California in 2015 that killed 14 people, according to federal prosecutors. Enrique Marquez Jr., 28, was sentenced Friday by United

States District Judge Jesus Bernal in a major terrorism case that shook America when radicalised Pakistani-American couple Syed Rizwan Farook and Tashfeen Malik massacred 14 people and injured 22 others in a shooting rampage.

The sentencing concludes a case in which Marquez pleaded guilty in 2017 to conspiracy to provided material support and resources to terrorists.

In the plea agreement and in open court, Marquez admitted that he conspired with Farook, 29, in 2011 and 2012 to attack Riverside City College (RCC) and traffic on a highway, the Department of Justice said in a press release.

Marquez also pleaded guilty to making false statements in connection with the acquisition of firearms by serving as the "straw buver" of two assault rifles that he provided to Farook

More than three years later, Farook and his wife Tashfeen Malik used those rifles in the shooting rampage at the San Bernardino Inland Regional Center (IRC) in San Bernardino, California on December 2, 2015.

Farook's wife, 29-year-old Malik, pledged allegiance to ২ Islamic State on social media on the day of the shooting, according to US officials.

Farook and his wife were killed by law enforcement officers, ending what at the time was the worst terrorist attack on American soil since 9/11.

This will push us toward socially conservative gender norms and potentially result in a backslide in gender equality. Unlike many past crises, this pandemic is not bringing people closer together and, despite some exceptions, it is not producing an increase in kindness, empathy or compassion, especially in the US

"Our species is not wired for seeking a precise understanding of the world as it actually is," the authors wrote, and our tribal predispositions toward groupthink are resulting in the large-scale spread of misinformation. We tend to seek out data that supports our opinions, and we too often distrust health experts, they say.




