Int'l flights to remain suspended till Nov 30

New Delhi: The Centre Wednesday extended the suspension of scheduled commercial international flight operations to and from India till November 30, "This restriction shall not apply to international all-cargo operations and flights specifically approved by the Directorate General of Civil Aviation," an official statement said Wednesday. "However, international scheduled flights may be allowed on select routes by the competent authority on a case-to-case basis," it added.

Monsoon bids adieu

Bhubaneswar, Oct 28: The southwest monsoon which arrived in the state June 11 has completely withdrawn from the entire state Wednesday (October 28), the Bhubaneswar Meteorological Centre said.

'The southwest monsoon withdrew from some parts of interior Odisha October 26 and it completely withdrew from entire Odisha and from entire the country today," it said.

This year, the monsoon had hit Kerala, June 1 and set in over Odisha June 11. It covered entire Odisha by June 13.

The state received a total of 1302.9mm rainfall against LPA rainfall of 1251.2mm (4 per cent excess) from June 1 to October 28 (date of withdrawal of monsoon).

A total of 12 low pressure systems formed over Bay Bengal from June to October 28 out of which five low pressure systems consecutively formed in August and three in October.

In June, the state recorded 15 per cent excess rainfall. Many unfavourable conditions like absence of adequate low pressure system over Bay of Bengal (only one low pressure formed over Bay Bengal from July 5 to July 7) and eastern part of monsoon trough lay to northern position than normal or close to foothills of Himalayas in many days resulted in deficient rainfall over Odisha



during July. The state had witnessed 35 per cent deficit rainfall in July.

Similarly, the state received 40 per cent excess and 32 per cent deficit rainfall in the months of August and September respectively. Also in two days (August 26 & 27), a very high amount of rainfall (129.7mm) occurred in state which caused riverline floods in some areas.

In October, the state recorded 69 per cent more than normal rainfall. Rainfall over Odisha in October (till October 28) has been 162.1m against the normal rainfall of 95.9 mm. Out of 30 districts, 18 districts received large excess (60%),

five districts received excess (between 20 per cent and 60 per cent) and rest seven districts received normal rain-

This year, the monsoon withdrawal has been considerably delayed after 2010. In 2010, the southwest monsoon had withdrawn from the entire state October 28. The three consecutive low pressure systems (one deep depression, one depression and one low pressure) formed over Bay of Bengal in this month may be one of the causes for the delay in withdrawal of the southwest monsoon from Odisha, the Met department said.

INTEREST WAIVER

Outstanding as of Feb 29 to be reference point

New Delhi, Oct 28: The loan outstanding as of February 29 would be the reference amount for calculating the differential interest amount under the 'scheme for grant of ex gratia payment of difference between compound interest and simple interest' according to the FAQs released by the Finance Ministry.

The Reserve Bank Tuesday asked all lending institutions, including non-banking financial companies, to ensure that the scheme of waiver of interest on interest for loans up to ₹2 crore for the six-month moratorium period is implemented by November 5, as decided by the government.

Last Friday, the government had announced the scheme for grant of ex gratia payment of difference between compound interest and simple interest for six months to borrowers in specified loan accounts. The lenders were asked to complete the exercise of crediting the amount in the accounts of borrowers by November 5.

OLA winter session by Dec 31: Speaker

Bhubaneswar, Oct 28: Speaker Surjya Narayan Patro Wednesday said the next session of the State Assembly is likely to be conducted before December 31. "The Assembly session

is bound to cover 60 days in a year. In the third session, the house sat for 13 days. It sat for seven days in the fourth session. Now, we need to have 40 more days of the session. We have planned a calendar for the conduction of the 40 days of the Assembly," he said.

He said, "On when we

can start the session, the state government and Governor can decide. No decision has been taken on the date as of now. The session will be conducted before December 31. The COVID outbreak is yet to be eradicated in the country as well as in the state. So the same scrutiny we used in the last session would continue in

the next session too," He said that the Assembly was now equipped with video conferencing, Wi-Fi facilities to make the working paperless. "We will also train our staff for paperless work," he pointed out.

Amid drug rage, state forms panel to fight it

Bhubaneswar, Oct 28: Even as the menace of drug addiction is raging in the country, the state government has formed a special committee of officials to fight the scourge in the state through several interventions.

The department of Social Security and Empowerment of Persons with Disabilities (SSEPD) which deals with drug de-addiction issues has formed an 18-member panel with people with varied expertise such as drug de-addiction, policing, narcotics and others.

SSEPD secretary Bhaskar Sarma is the chairman of the committee while Director General of Police is a member of the panel. Other members in the panel included Additional Chief Secretary from the health department and representatives from the Narcotics Control Bureau, education department, women and child development department and other experts and people working in the sector.

The panel named 'State Level Nasha Mukt Bharat Campaign Committee' would work towards formulating a state campaign activity under the mission. It would also ensure formulation and implementation of a district level mukt campaign in vulnerable districts in the state. The panel would work to-



wards increasing community participation and public cooperation. It has been envisioned that the ban on sale of cigarettes within 100 metres of an educational institution would be enforced by the panel.

Training programmes at different levels would be organized to increase awareness among people. Social media could also be roped in to boost the presence of such activities on the social media.

The panel would visit institutions, hospitals for assessment of preparedness and implementation of the campaign. It has also been planned to obtain information on the availability and sale of drugs and review the action taken on such information.

"The committee will sit at least once in two months to review the situation of Nasha Mukt Bharat Campaign in Odisha and to formulate the future action plan for awareness generation, capacity building, and drug demand reduction and enforcement activities," an office order of the department said Wednesdav.

After early success, boat ambulances set to go places in state

Bhubaneswar, Oct 28: The health department is all set to expand the services of 108 boat ambulances in different cut-off areas to boost delivery of health services in far-flung areas of the state.

Days after the services were well received in two blocks of Kendrapara, they will be rolled out in Koraput, Malkangiri and Kalahandi districts. Sabyasachi Biswal, State-Head Ziqitza Healthcare, the firm which manages the services, said there are six boat ambulances to serve people in cutoff areas. "We have two boat ambulances in Kendrapara, two in Malkangiri, one each in Koraput and Kalahandi. Two are working in Kendrapara and works on others will begin soon," he said.

These boat ambulances offer life support systems like oxygen, anti-snake venom drugs, saline, suction machine, BP meter, stethoscope, stretchers, wheelchairs and others. "There are villages on other side of the Gupti river where motorable roads are either not present or get submerged during monsoons. In some areas, the road takes longer to reach hospitals. Through our service, we try to take patients in the shortest span of time to health centres," Jagannath Behera, cluster leader, Kendrapara, 108 Ambulance Service told Orissa POST.

SUPER CYCLONE ROUNDS OFF 21 YEARS TODAY

Natural defence against calamities fast weakens

Kendrapara, Oct 28: The state continues to remain prone to natural disasters as the Super Cyclone-1999 completes 21 year Thursday. This is because the mangrove forest cover protecting the coastal pockets from natural calamities has declined fast. Mushrooming of prawn gheries has also caused serious damage to the flora and fauna.

Mangroves sustain the ecological balance of coastal areas as well as livelihood security of thousands of fisherman. The Super Cyclone-1999 wreaked havoc in coastal districts. While the official toll then was 9,885 people, unofficial sources estimated the toll to be above 50,000. An estimated 1,500 children were orphaned. Of the total casualty, Jagatsinghpur district alone had accounted for 8,119 people.

At least 13 million people, including 3.3 million children and 5 million women were affected in 1999. The storm had left 7,505 people injured and killed 3,15,886 heads of cattle. The Super Cyclone provided an impetus to the state government to prepare a roadmap to tackle the future natural disasters. As a result, it laid stress on relief and rescue operation during calamities thereafter.

The state government attached



importance to construction of roads, cyclone relief shelters, timely evacuation of people from disaster prone habitats to safer places, installation of sirens to alert people at the time of approaching calamities, upgrading of healthcare facilities and environment management.

However, the mangrove forest cover which acts as a cover against cyclonic storms are fast depleating. Ten out of the 20 sirens in the cyclone alert centres have become defunct. This will hit timely evacuation of people before a calamity. Environmentalists said in the 48 km long sea coast of the district, the Bhitarkanika National Park has 188 sqkm of dense mangrove forests. However, these mangrove is declining at a rapid rate since 1960.

Over 88 sqkm of mangrove forests which are known as a protective wall against sea erosion have been washed away into the sea. Mangroves are salt tolerant plant species found in inter-tidal regions along the creeks and estuaries. They play a significant role in protecting the hinterland against cyclones and ingress of sea water.

Besides, they stabilize the coastal land mass against sea erosion. Sambit Kumar Satpathy, district emergency officer, said proper management of natural disasters is always a priority for the district administration because of which thedistrict witnessed zero casualties in the last cyclonic storms.

Who created Aarogya Setu App? Government does not know

New Delhi, Oct 28: The Central Information Commission has issued show-cause notices to the CPIOs, Ministry of Electronics, National Informatics Centre and National E-Governance Division (NeGD), seeking to know as to why penalty under Section 20 of the RTI Act should not be imposed on them for prima facie obstruction of information and providing an evasive reply on an RTI application related to the Aarogya Setu App, the Live Law reported.

The report said that CIC also asked the NIC to explain that when in the Aarogya Setu website it is mentioned that the platform was designed, developed and hosted by it, then how is it that it doesn't have any information

about the creation of the App.

"The Commission directs the CPIOs, NIC to explain this matter in writing as to how the website https://aarogyasetu.gov.in/ was created with the domain gov.in, if they do not have any information about it," Information Commissioner Vanaia N. Sarna ordered.

"None of the CPIOs were able to explain anything regarding who created the App, where are the files, and the same is extremely preposterous," Sarna said.

The Commission has issued show-cause notices to SK Tyagi, Deputy Director and CPIO, DK Sagar, Deputy Director, Electronics, and RA Dhawan, Senior General Manager (HR and Admin) and CPIO NeGD, the report said.

'The Commission directs the above-mentioned CPIOs to appear

before the bench on 24.11.2020 at 01.15 pm to show cause as to why action should not be initiated against them under Section 20 of the RTI Act. The CPIOs are also directed to send a copy of all supporting documents upon which they choose to rely upon during the hearing. The said documents be sent to the Commission at least five days prior to the hearing via linkpaper.

"If any other persons are responsible for the said omission, the CPIO shall serve a copy of this order on such persons to direct their presence before the bench as well. Swarup Dutta, Scientist F and CPIO NIC, to explain why penalty under Section 20 of the RTI Act should not be imposed on them for prima facie obstruction of information and providing an evasive reply," CICI said.



The development comes in a complaint filed by one Saurav Das, stating that the relevant authorities, i.e., NIC, National E-Governance Division (NeGD) and Ministry of Electronics & Information Technology (MeitY), had failed to furnish information about the process of creation of Aarogya Setu App and other information relating to its creation.

He submitted that the RTI was filed with the NIC, which stated that it "does not hold the information" relating to the App's creation, which is very surprising since it is the App's developer.



The film festival, based in Boston, USA, was held virtually this year, from







EIGHT PROJECTS WORTH ₹257 CR SANCTIONED FOR DEVELOPMENTAL INITIATIVES IN MINERAL-RICH DISTRICTS

Bhubaneswar, Oct 28: The state government has allocated funds to provide broadband connectivity to hospitals and schools in mineral bearing districts of Odisha.

The state government Wednesday approved eight projects for development of mineral-rich districts for which ₹257 crore would be spent from Odisha Mineral Bearing Areas Development Corporation (OMBADC).

The projects were approved at the OMBADC Board of Directors meeting held under the chairmanship of Chief Secretary Asit Tripathy Wednesday. The projects will be implemented in nine mineral bearing districts - Angul, Dhenkanal, Jajpur, Jharsuguda, Keonjhar, Koraput, Mayurbhanj,

Rayagada and Sundargarh. The government has sanctioned

districts was planned at a cost of ₹11.71 crore. Similarly, skill development certificate course for tribal youths at ₹0.16 crore and sex sorted semen for genetic improvement of cattle would be taken up at ₹16.93 crore.

The Chief Secretary directed the department secretaries concerned to work out 'weekly monitoring plan' for expeditious and quality implementation of the projects for completing them before the sched-

The apex court noted that Nachika's bail plea before the HC came up of hearing July 1 but since then the matter is pending with the court

Significantly, Chasi Mulia Adivasi Sangh (CMAS) leader, Nachika Linga, had surrendered before the police in October 2014 at Narayanpatna, his native place. He is wanted in around 28 cases.

He was allegedly involved in agitation for land rights and the attack on Narayanpatna police station in 2009. It is to be mentioned here that CMAS, a mass organisation of tribals in Narayanpatna, in Koraput district, was demanding proper land settlement in Narayanpatna block for many years.

The tribal leader was leading an agitation against encroachment of tribal land by non-tribals in Narayanpatna area for a long time.

Bhubaneswar, Oct 28: The Covid-19 pandemic and unattractive remuneration for vehicles to be hired and human resources have apparently poured cold water on the state government's plan to launch highway patrolling in the state as directed by the Supreme Court in 2019.

The state police neither could appoint the special police officers (SPOs) nor could it succeed in attracting bidders to supply vehicles for patrolling on the selected high-

The stretches of national highways earmarked for patrolling include Bhubaneswar-Puri, Manguli-Sambalpur, Sambalpur-Rourkela, Jaleswar-Ichhapuram and Sambalpur-Sohela.

The state police, in March, had released the advertisement seeking applications from retired police officials for 119 SPO posts on contractual basis to man the highway patrolling vehicles after getting approval from the state government.

However, it had to release a fresh advertisement in September this year as none applied for the SPO posts.

Similarly, he asserted that the vehicle owners also did not show any interest provide their vehicles to Odisha police because of lower monthly rentals. The state

government had earlier fixed around Rs 30,000 as monthly charges for hired vehicles. "Why anyone would allow its vehicle to run 24X7 for a paltry sum of money?" he questioned.

The state police has recently issued another fresh bid to procure 36 highway patrolling vehicles.

However, the police will be able to attract bidders this time due to the increase in monthly charges to Rs 70,000 as compared to the earlier Rs 30,000, claimed the officer.

Bhubaneswar, Oct 28: State's novel coronavirus disease (Covid-19) caseload mounted to 2,85,482 Wednesday as 1,540 more people tested positive for the infection, while 12 fresh fatalities pushed Odisha's coronavirus death toll to 1,284, an official of the Health and Family Welfare (H&FW) depart-

As many as 886 new cases were reported in quarantine centres, while 654 infections were detected during contact tracing exercise, the official said.

Khurda district, under which Bhubaneswar falls, reported the highest number of new cases at 208, followed by Sundargarh 111, Angul 100, Cuttack 99, Balasore 92, Mayurbhanj 91, Jagatsinghpur 78, Bolangir 67, Kendrapada 62 and Nuapada 51 cases.

Two fresh fatalities each were reported from Khurda, Jharsuguda and Nuapada districts, and one each from Nabarangpur, Puri, Sundargarh, Sambalpur, Cuttack and Ganjam districts, the official

Ganjam has so far reported the highest number of coronavirus fatalities at 228, followed by Khurda 221 and Cuttack 106, said the official, adding that as many as 53 coronavirus patients have so far died in Odisha due to other ailments. The state has so far tested over 44.22

BMC to shut Covid care centres

Bhubaneswar, Oct 28: The Bhubaneswar Municipal Corporation (BMC), Wednesday, said that it is mulling to close down several Covid care centres here in a phased manner as occupancy remained nil to low amid falling infections.

Addressing a presser, BMC Commissioner Prem Chandra Chaudhary said that cases have been declining in Capital city and that most of the cases have been referred for home isolation. Observing this the BMC Commissioner stated that it would close different Covid care centres (CCCs) in and around



the city as there is less demand for these centres now.

"We have already surrendered 1,000 beds of CCCs in last 15 days that were earlier made ready to counter the Covid. Since around 75 per cent (1,500-1,600) of present active cases are in home isolation the Covid centres are likely to be closed in a phased manner. However, we still have beds available in Covid hospitals for critical patients in 18 private and six government hospitals," Chaudhary said.

Debunking allegations of reduced testing, Chaudhury further said that testing across the city 'remains more or less the same." "We are still conducting tests at 23 camps spread in the city. Testing has been made available on demand by the BMC. Moreover, we are also providing Favipiravir to nearly 30-35 patients on a daily basis," he added.

Jajpur dist hasn't submitted 38pc of UCs, CAG says

Jajpur, Oct 28: Several departments in Jajpur are yet to submit 38.51 per cent utilisation certificates of the last 10 years of the flood assistance funds. Furthermore, four departments have not submitted their utilisation certificates of their fund utilisation at all by September 30, 2020.

The fact came to the fore when the report of the Comptroller and Khurdha and Jajpur have been facing flood fury at regular intervals. Flood problem has been a perennial issue for them over decades. This issue has not yet been redressed properly despite provision of funds.

The floods caused by Baitarani and Brahmani rivers in August had caused huge devastation in Jajpur. Extent of damage by floods was said to be the worst ever in the last two decades.

About 10 lakh people of 1,244 villages in 258 panchayats were affected by floods and 10 people had

In the devastating floods of 2011, around four lakh people in 499 villages in the district were affected. Huge sum of funds were provided to the district for repair and re-

The district civil supplies officer had submitted an investigation report September 14 to the Collector, pointing out that the rice was not meant for PDS. Around 750 quintal of rice had been supplied to Jharigaon in the third quarter. The rice was not for PDS. Moreover, 92 bags of rice were seized in a godown near ABEO office September 9.

However, the ABEO said that he was unaware of this rice which was seized near his office, but he had seen a transport agency used to take out and in rice there.

The district civil supplies officer in his report said that the rice was supplied in March to the godown, but Hemanta Kumar Chaurasia and Kiran Kimar Pattnaik of a transport agency were taking the rice September 9.

Later, Jharigaon marketing spector told local IIC that Kiran Kumar and Hemanta Kumar were authorised transport dealers who were taking out rice from CWC godown March 23. The district education officer had issued this rice for 253 schools. The MI had also submitted the statements of the rice dealers and copies of gate pass

Impose GST on meat

Thy would any government make policies that make its people poorer and unhealthier? I can only put this down to a complete ignorance of real economics due to which policies have the worst ef-

Let me briefly give you the reasons why you should not eat meat. All living beings require food and water. In order to grow food for animals we need vast amount of land, which we don't have. So, we allow them to graze in forests and this destroys forests, which in turn impacts climate and reduces groundwater. We give them water that we don't have. We grow animal food instead of growing food for humans. To produce one kilo of beef requires 25 kilos of grain to feed the animal and roughly 15,000 litres of water. Pigs and goats are almost the same, and chicken a little less. Their emissions: faeces, urine and methane, degrade the land and water and cause the climate to become hotter. Methane causes 24 times more damage than carbon dioxide and each cow emits 600 litres of methane daily. Livestock farming contributes 18 per cent greenhouse gas emissions worldwide. This is more than the emissions from all forms of transport put together. When the climate becomes hotter we need to do far more coal mining to create more energy to cool humans down during heat waves. The water levels rise and flood lands. The rest of the lands suffer drought as glaciers melt and dry up. Mosquitoes and other pests increase and so do their diseases. We feed grain to animals grown for meat, and so the prices go up and there is no grain left for the poor. If all these grain were fed to humans directly we could feed 3.5 billion people more daily – and keep them healthier.

Because the industrial growing of animals $% \frac{1}{2}\left(\frac{1}{2}\right) =\frac{1}{2}\left(\frac{1}{2}\right)$ does not recognise their bodies as live, they are simply seen as meat machines and deliberately grown to be fatter, larger, softer... whatever. This can only be done by using antibiotics, hormones and chemicals. In both, India and America, 80 per cent of all antibiotics are fed to animals and so the human eating them in his/her meat becomes immune to them. Thousands of people die every day because there is no medicine left to cure them when they become sick. Heart disease, diabetes and cancer are all related to animal eating, and you and I are paying taxes for more and more hospitals. Switching to a plant based diet could save lives, lead to healthcare related savings and avoid climate change damages of up to \$1.5 trillion.

Giving up meat is one of the easiest things we can do to live better. But this is not going to happen unless the government takes a policy decision on whether it wants the country to survive or not. Encouraging meat export is the quickest way of

destroying our land, water and air. The excuse is feeble that meat exports earn money - what is the point if that money is spent on restoring water sources and forests or paying farmers compensation for destruction of crops? Or for trying to undo the effects of climate change? This makes no sense to me at all.

This is where GST comes in. This tax should be made far more sensitive and sophisticated in its social agenda as well as its economic one. And that

The government has decreed no GST on live animals grown for food: bovines, swine, sheep, goats, poultry, geese, ducks, turkeys and guinea fowls. The government has given exemption to all meat of bovine animals, swine, sheep, goats, poultry fresh or chilled. For some reason it has also exempted the meat of horses, donkeys, mules - even though these animals are forbidden to be killed for meat by the FSSAI. Does the Finance Ministry even know the food laws? All offal (which means the parts like anuses, intestines and hooves) and fats of pig and poultry are exempt (so now they can put them happily into vegetarian Dalda). All fish, prawn, shrimp, crustaceans and molluscs and every other aquatic invertebrate, live or dead, are exempt. Considering that a large number of them are banned for any catching/eating under the Wildlife Protection Act, this seems equally bizarre. The prawn/shrimp growing industry is probably the most polluting industry, and the worst for health, because it uses tonnes, literally tonnes, of antibiotics which wash into agricultural fields making those lands dangerous for all grains/vegetable eaters. Eggs are exempt. Milk and all its products, of course, would be exempt as it is a holy cow in itself.

Some countries give food a special tax exempt status. Many states in America exclude groceries from sales tax, and there is no VAT on foodstuffs in UK, Ireland and Malta, though other European countries, add VAT to food. However, regardless of the level of tax charged on food, taxation systems fail to distinguish between different types of food. Simply put, taxes are blind to the differences between meat and other foods like fruit and vegetables. Food which is good for the country and the human is taxed just as much as food that destroys the planet and the individual. Taxes and all revenue collection should encourage or discourage certain behaviour. Do we not put huge taxes on cigarettes and alcohol or luxury cars? Then why should meat get treated on par with fruit and vegetables when it costs the country so much more in terms of pollution, water, land, health? Tax revenue is used (among other things) to support public healthcare and fund government-backed environmental initiatives. So, given that meat compromises both public health and the environment, it surely follows that it should be taxed accordingly.

It makes no sense to me that the Indian government would exempt all forms of meat from all GST. Meat is not a necessity. It is a luxury - and it falls in the same category as cigarettes. The slaughterhouses are run by multi-millionaires who are sending most of the meat abroad and most of the owners are NRIs. If the government were to put GST on meat at the rate of even 10 per cent the potential revenues would run into crores. At a time when internationally calls are increasing for taxing meat on environmental and health grounds, why would India go the other way?

Taxing meat would help nudge Indians in a healthier direction. A reduction in meat consumption, encouraged through taxation, will have both environmental and public health benefits. More revenue would remain with the government, since healthcare costs would come down. By not taxing meat production and consumption appropriately, governments are in fact subsidising environmental and public health destruction.

■ Up the spout

p the spout, gone wrong, ruined, failed or lost, is a slang expression from the British Isles of considerable age, being first recorded early in the nineteenth century. It's still common. To find its origin we must in imagination travel to the low-life world of pre-Dickensian England. Pawnbrokers commonly stored goods that were in hock on an upper floor of their premises, but this required a method by which such items could be moved from their shop counters to storage and back again. This is the way such a device was described in a famous work of the 19th Century:"[The chute] reaches from the top of the house of the Pawnbroker (where the goods are deposited for safety till redeemed or sold) to the shop, where they are first received; through which a small bag is dropped upon the ringing of a bell, which conveys the tickets or duplicates to a person above stairs, who, upon finding them, (unless too bulky) saves himself the trouble and loss of time of coming down stairs, by more readily conveying them down." It was the shape and function of this device, in later years nearer in form to the kitchen lift or dumbwaiter, that caused it to become known to customers and pawnbrokers as the spout. The action of pawning goods was spouting them. Something that had been pawned was said to have gone up the spout. It was so common for the item not to be redeemed because the owner hadn't the money to do so that to put something up the spout implied a likely permanent loss. Much more recently, as a separate development but with implications related to those of the original, up the spout came to mean being pregnant, sometimes an unwelcome development among unmarried women.

ollowing the US elections on November 3 – although its final resolution may take longer - the partisan arrangements of almost the entire US federal government are subject to change. Only the House of Representatives appears certain to remain in the same party's hands (the Democrats'). The Republican-dominated Senate could be won by the Democrats. The conservative-leaning Supreme Court is now shifting far to the right, given the Senate's confirmation of President Donald Trump's nominee, Amy Coney Barrett, to the seat previously held by the late liberal justice Ruth Bader Ginsburg.

One oddity of the US system is that even if Democratic candidate Joe Biden wins the election, overcoming barriers already thrown in his way by Court decisions and voter suppression, the presidency will remain for over two months in the hands of a man whose physical and mental stability are in doubt. The current constitutional arrangements to deal with presidential mental or physical incapacity are unworkable. Little is said publicly about this precarious situation; timorous newspapers are reluctant to mention the crazy uncle in the White House, even though Trump's behaviour of late has been even more aberrant than usual, possibly an effect of having had COVID-19 and taking power-

ful medications. Perhaps confusing the current race with that of 2016, Trump has resumed attacking Hillary Clinton, turning on his most subservient cabinet members for not indicting her, as well as former President Barack Obama, and Biden – for whatever reasons. Trump tosses around nebulous charges of leftwing terrorism and mail-in voting fraud, though The Washington Post has found his charges of ballot fraud fraudulent

If Biden defeats Trump - the polls, currently in his favour, are considered more reliable than in 2016, but polls can't predict voter suppression - his supporters' celebrations may be short-lived. Controversies about counting votes are already in the courts, which have changed dramatically

as a result of Trump and Senate Majority Leader Mitch McConnell appointing an astonishing 220 federal judges. Moreover, Senate Republicans are already plotting how to undermine a Democratic majority.

But the greatest threat to Biden and any progressive government for a long time to come will emanate from the Supreme Court. The approval of Barrett (age 48) has produced, almost certainly, a very conservative 6-3 majority. Chief Justice John Roberts, who has tried to keep the Court from going to extremes, will no longer have the controlling swing vote. The legitimacy of the Court is now in question.

The hearings on Barrett's nomination were a sham. This was not because of her unresponsiveness to questions, but because the fix was in. Trump insisted that he had not questioned Barrett on sensitive issues. Trump, Barrett huffed, didn't ask her about her position on such matters as abortion or the Affordable Care Act. Nor would she have discussed her positions with him. How dare anyone question her integrity?

It was all charade. Through the early spotting, close vetting, and years of cultivation of possible Supreme Court nominees by the right-wing, corporate-sponsored Federalist Society, which effectively controls who gets named to the highest bench by Republican presidents, Trump and his aides were fully aware of Barrett's positions on key issues. (Liberal Democrats also have groups that back judges, but they are not as organised and effective as the Federalist Society.) The purpose of such intensive vetting is to have 'no more surprises' – no more Republican appointees who start out as conservative but move left. The example that most annoys conservatives was David Souter, appointed by George HW Bush. Souter was advertised as a conservative, but became a reliable liberal.

Behind the rush to get Barrett confirmed was Trump's determination to have her seated by Election Day – so that, the president openly said, she would be in place if issues affecting the election came to the Court. Barrett refused to commit to recusing herself from cases that involved Trump's re-election. The rush to confirm her was also a form of protection for conservatives in case the Republicans lose the

The claim of right-wing judges that their 'originalist' jurisprudence reflects judicial restraint and a reluctance to 'legislate from the bench' is also a sham. Originalism is seen by critics as a Trojan horse: it rationalises an activist role of striking down progressive legislation such as environmental, labour, and other regulations, on the grounds that no mention was made of such matters when the Constitution was written.

The Barrett appointment is also another reflection of the religious right's hold on American judicial conservatism. Perpetuation of this arrangement is a major reason Trump has retained evangelical support, albeit with some recent slippage. Barrett's Catholicism, indeed, is of the 'radical,' 'ultramontane' sort that sometimes appears to oppose change itself. She has been involved in a charismatic Christian group, People of Praise, which believes that in households men are superior to women, and its members speak in tongues. Though the group removed all references to Barrett from its public documents, a snippet of one has her once serving as a 'handmaid,' a leadership position.

As for abortion, one does not win the Federalist Society's support unless one has raised objections to Roe v. Wade. With Barrett joining other conservative justices - including Trump's two other appointees, Neil Gorsuch and Brett Kavanaugh – it is now possible that Roe may be overturned-or nullified through other decisions.

With an unprecedented 60-plus million Americans having already voted, it may be too late for Trump to turn things around. So, with winter coming on, COVID-19 cases reaching all-time highs, and the White House having given up on controlling the pandemic, anxious Americans are left speculating not only about who will win the election, but, for the first time in history, whether the president will honour the result and if the Supreme Court will abet him in subverting it.

BJP bracing to dump Nitish

WITH NO LOVE **LOST BETWEEN MODI AND NITISH** THE DUO WOULD **DUMP EACH OTHER** AT THE FIRST **OPPORTUNITY**

rime Minister Narendra Modi and Bihar Chief Minister Nitish Kumar were never friends but they were forced to join hands, given political compulsions in the state. The results of Bihar Assembly elections will once again decide whether they will be seen together, or will it mark the end of their pretentious relationship.

Though as of now the BJP leadership is claiming that it will make Nitish the CM, much depends on the poll outcome. The BJP is ready with its Plan B, of joining hands with Chirag Paswan's LJP, who has no qualms declaring himself as the Hanuman of PM Modi.

The BJP is walking the tightrope by ensuring that it doesn't rub its two alliance partners of NDA on the wrong side. However, given the first opportunity, it will always prefer to form government with the LJP,

if it manages to get enough seats. The relations between Modi and Nitish have always been strained. However, due to political compulsions, both their parties were forced to join hands in 2005 to form the government. Nitish owes the formation of his government mostly to late BJP veteran Arun Jaitley, who, through his good offices, was able to convince the BJP leadership.

I recall that during the BJP national executive meeting in Patna in June 2010, Nitish had thrown tantrums by raising objections over the then Gujarat CM Narendra Modi. Both of them were CMs then and enjoyed popularity in their respective states. In the regional papers of Bihar, Modi got his advertisements published, flaunting the donation given to the flood-affected state. This naturally offended Nitish, who refused to invite Modi at the dinner hosted by him for the BJP leadership during the BJP national executive The dinner was eventually cancelled, as LK Advani, Arun Jaitley, Sushma Swaraj and Venkaiah Naidu

refused to go without Modi. Ever since Modi was projected as the PM candidate, Nitish has been at loggerheads with the BJP, eventually pulling out of NDA in 2013. For the Bihar Assembly elections in 2015, Nitish joined hands with his political bête-noire Lalu Prasad Yadav and went on to retain power in the state. However, he was forced to join hands with the BJP in 2017, when Lalu refused to accept the demand for the ouster of his son and Deputy CM Tejashwi Yadav from the government over graft charges.

With no love lost between Modi and Nitish the duo would dump each other at the first opportunity. In fact, Modi is working towards the same plot and would be too pleased to sever his ties with Nitish if the plan to distance him works out for him in these Assembly elections.

It's not for nothing that Nitish is not to be seen in posters of Modi. It's a well-worked out strategy of BJP which is keen to garner votes in the name of Modi, fully-aware that the popularity of Nitish is gradually waning.

The BJP, which had earlier vowed to wipe-out the trace of Congress from the nation, has gone a step ahead by severing its ties with its own allies - Shiv Sena in Maharashtra and Shiromani Akali Dal in Punjab. The next party will be JD (U), if Nitish fails to live-up to its expectations and fails to cobble-up the numbers. The ultimate goal of Modi is to form BJP's own government in Bihar.

For Nitish, who was once termed as the 'Chanakya of Bihar,' it's a door-die battle. His failure in the elections will shut all doors for him for future alliances. Having run the government for 15 years, his popularity has taken a beating, with no out-of-the-box ideas to end the woes of Biharis. People are disillusioned, with no hopes of getting jobs and lawlessness touching its peak. He, too, is aware the BJP will dump him if he is defeated at the hustings.

Heckled and hooted down in rallies, Nitish has been losing his cool and shouting at audience, giving enough hints to the public that he is on a sticky wicket. Depending on the results on November 10, it will be seen where the JD(U) will finally end its electoral journey. So far, Nitish is at the receiving-end, being attacked by Tejashwi on the one side and Chirag on the other.

BJP, too, will not mind the downfall of Nitish, but not at the expense of the survival of its own government. It would be too pleased to dump him, if it is able to cobble-up the majority for itself, with the help of Chirag. It is not for nothing that it has given him the full liberty to attack its own coalition partner and the CM during the crucial Assembly elections. As of now, the people are being fooled by the politicians. However, the Indian electorate, especially Biharis cannot be taken for granted.

All about viruses

Sir, Viruses have become a pain in the neck for human beings. People who tackled and overcame minor and major viral infections due to rapid strides made in medicine were left bamboozled and stunned by a six-word virus. Never before was a common man beaten into submission by a tiny virus, and perhaps never again. While the world is waiting with bated breath for a vaccine against coronavirus, and scientists continue to grapple with intricacies of Covid, the Nobel Prize for Medicine has been awarded to three scientists for their phenomenal work on another virus that troubled mankind not very long ago - the Hepatitis C. Harvey Alter and Charles Rice of the US were given the Nobel with Michael Houghton of the UK for discovering the viral origin of Hepatitis C and its blood-borne origin in many patients. As a result of their pioneering work, a battery of blood tests, that include the now common liver function tests, are done routinely to validate Hepatitis C in patients. The Hepatitis C disease was a leading cause of death that was largely unexplainable at that point in time when science was struggling to keep pace with people's beliefs. The three men worked tirelessly and independently to supplement each other. At a time when researchers were under a wrong impression that the mysterious deaths were either due to Hepatitis A or B, it was left to the three to bring to the fore the role of Hepatitis C, and they succeeded in doing so. The Nobel winners' understanding and contribution to the 'hepatitis field' have helped identification of drugs to combat Hepatitis C. New Delhi, Oct 28: While the spread of Covid-19 seems to be subsiding nationally, its tally is burgeoning in the capital city consistently for the last few days. Delhi witnessed the highest single day spike till date Tuesday with 4,853 new infections and 44 deaths reported. The tally in the national capital has crossed 3.64 lakh.

Since Friday, Delhi has been reporting over 4,000 cases of COVID-19 daily. Over the last one week, the daily positivity rate - the percentage of people who test positive for the disease versus those who were tested - has also increased, faring above 8 per cent. The situation suggests that the national capital is inching towards its third peak, as stated by the head of the national task force for Covid-19, Dr VK Paul Tuesday.

Experts said that the situation will be challenging as the cases are expected to multiply in the coming weeks due to pollution, laxity and

Dr Prabhakaran Dorairaj, Professor, Epidemiology, Public Health Foundation of India, said the cases are bound to increase as the combination of pollution, overcrowding and winter is proving to be a triple whammy. "The viral infections thrive in winters. They remain suspended for a longer time in the air in cold weather conditions. Pollution aids the longevity to the suspension of the virus. On the top of it, the lack of social distancing during the festivals is instigating the spread further," he explained.



He said festivities have played a major role in the surge as well. "Durga Puja festival is celebrated majorly in eastern and northern parts of the country. And the surge in cases is also reported in these parts only," he observed.

Dr Manoj Goel, director, pulmonology at Fortis Memorial Research Institute, said lack of Covid appropriate behaviour and peak in pollution in the national capital have worsened the situation. 'Cases in Delhi are rising with each passing day. This phenomenon will continue if people do not take necessary precautions. With lockdown being lifted, it is seen people are not observing those rules of social distancing, staying indoors

and wearing masks. He added that taking precautions is the only way forward to deal with the viral disease since Delhi is densely populated. "Due to festival season coming, more and more people have started to socialise and are seen shopping. Delhi has a dense population and extra measures have to be taken to observe

social distancing. People must realise that even when lockdown is not imposed, they have to set their own boundaries and not socialise, maintain social distance and always wear a mask," Goel added.

Dr HS Chhabra, medical director, Indian Spinal Injuries Centre (ISIC), said coordinated communication to the public warning them of the risks posed by such lapses is required to bring about a change in their behaviour. "While relaxations under the unlocks have increased interaction among people during the festive season, lack of adherence to health measures such as use of masks and social distancing is contributing to the rapid increase.'

Wednesday, the Delhi government ordered all schools in the city to remain shut till further orders after the surge in cases. An expert committee, led by Dr Paul, had cautioned a few days ago that city hospitals should be prepared for a surge of 15,000 positive cases a day with the change in season and movement of pa-

Only 'green' firecrackers in Delhi

The Delhi government will launch an anti-firecracker campaign from November 3 and request people not to burn crackers at all considering the pandemic

New Delhi, Oct 28: Environment Minister Gopal Rai said Wednesday that only 'green' firecrackers can be manufactured, sold and used in the national capital.

He also said the Delhi government will launch an anti-firecracker requested people not to burn crackers at all considering the seriousness of the situation due to the COVID-19 pandemic.

"Only 'green' firecrackers can be manufactured, sold and used in Delhi this Diwali as per a Supreme Court order issued in 2018." he told reporters.

In 2018, the Supreme Court had banned the use of polluting firecrackers and allowed the sale of 'green' firecrackers in a bid to control air pollution.



The 'green' crackers are not as polluting as the conventional types of firecrackers and they contain at least 30 per cent less particulate matters such as Sulphur Dioxide and

Nitrogen Oxide. The CSIR-National **Environmental Engineering** Research Institute was tasked with the job of developing 'green' crackers. But only a few varieties were

available in the market last year due to licensing requirements.

The minister said smoke from firecrackers and stubble burning make Delhi's air "hazardous

"The government will launch an anti-cracker campaign from November 3. Under it, 11 special Committee and city police will inspect firecracker manufacturing units to ensure that there is no old stock left," he said. Strict action will be taken against the violators under the Environmental Protection Act and Air Act, he said.

"In fact, I appeal to the people of Delhi to launch a 'no-crackers' campaign. They should try and avoid burning firecrackers completely considering the seriousness of the situation due to the COVID-19 pandemic." Rai said.

Dehradun/Haridwar, Oct 28: Uttarakhand Chief Minister Trivendra Singh Rawat moved the Supreme Court Wednesday against the Nainital High Court order for a CBI probe into the allegations by two scribes that money was transferred into the accounts of his relatives in 2016 to support appointment of a person as head of 'Gau Seva Ayog of Jharkhand.

Amid rising clamour for his resignation by Congress party, Rawat, who was the Jharkhand in-charge for BJP in 2016, filed a special leave petition against the high court judgement through lawyer Divyam Agarwal. The counsel has not yet divulged the grounds of the chal-

The high court verdict came Tuesday on two separate petitions filed by the two journalists - Umesh Sharma and Shiv Prasad Semwal -- seeking quashing of an FIR lodged against them in July this year under various provisions of the IPC relating to sedition, cheating, forgery and criminal conspiracy.

The FIR against Sharma was lodged for posting a video on Facebook alleging that one Amritesh Chauhan from Jharkhand deposited money after demonetisation into the bank account of a couple, Harendra Singh Rawat and his wife Savita Rawat, who are allegedly related to the Chief Minister.

Harendra, a retired professor, had lodged the FIR at a police station in Dehradun against Sharma

Rawat, who was the Jharkhand in-charge for BJP in 2016, filed a special leave petition against the high court judgement through lawyer Divyam Agarwal

and also alleged that the journalist was blackmailing him. While quashing the FIR, the high court ordered a CBI probe into the allegations levelled against Rawat.

The apex court, on October 16, had dismissed a separate plea by Sharma seeking transfer of three criminal cases pending against him to Delhi from Dehradun on the grounds of being targeted by the Rawat government.

The top court observed that "credibility" of Sharma's "journalistic activity" was itself questioned by his member of the sting

The top court had noted that Sharma faces 17 cases in Uttarakhand, four in Uttar Pradesh, five in West Bengal, two in Delhi and out of which one is under investigation of CBI, and another one at Ranchi, Jharkhand,

In its judgement, the Nainital High Court said, "Superintendent of Police, CBI Dehradun is directed to register an FIR on the basis of the allegations levelled in para 8 of the petition in WPCRL no. 1187 of 2020 and investigate the case in accordance with law, with promptitude."

"This Court is of the view that considering the nature of allegations levelled against Trivendra Singh Rawat, the Chief Minister of the State, it would be appropriate to unfold the truth. It would be in the interest of the State that the doubts are cleared. "Therefore, while allowing the petition, this Court proposes for investigation also. In view of the nature of the allegations. this Court is of the view that the CBI should be directed to lodge an FIR on the basis of allegations levelled in para 8 of the instant petition and investigate the case in accordance with law," the high court said. It also observed that criticizing the government can never be sedition and unless the public functionaries are criticized, democracy cannot be strengthened.

"In democracy dissent is always respected and considered, if it is suppressed under sedition laws perhaps, it would be an attempt to make the democracy weak," it said.

Mumbai, Oct 28: The CBI Wednesday told the Bombay High Court that Rhea Chakraborty's accusation that late actor Sushant Singh Rajput's sisters obtained a fake medical prescription for him was "mostly speculative"

Such speculation cannot be the basis of an FIR, the Central agency said in response to Rajput's sisters Priyanka Singh and Meetu Singh's petition seeking to quash the case lodged against them by Mumbai Police.

Chakraborty, Rajput's girlfriend, has alleged that a fabricated prescription was used to help him procure medicines banned under the Narcotic Drugs and Psychotropic Substances Act only a few days before his suicide in

"The allegations in the present FIR are mostly presumptive and speculative in nature," the CBI said. The Central Bureau of Investigation also pointed out that it is probing the complaint filed by Rajput's father KK Singh against Chakraborty and her family members for allegedly abetting the 34year-old actor's suicide.

Rajput's sisters filed the petition through advocate Madhav Thorat on October 6 seeking that the FIR filed against them by Bandra Police here be quashed. The CBI said the police should have conducted preliminary enquiry before registering the First Information Report.

Rhea's accusations 'speculative': CBI 52.24% voting in Bihar till 5 pm

New Delhi, Oct 28: The Covid-19 pandemic could not affect voters' enthusiasm in the first phase of polls in Bihar as the state registered 52.24 per cent turnout till 5 pm Wednesday, the Election Commission of India said here.

Mentioning that the turnout was more than "previous assembly elections as well as Lok Sabha elections", Deputy Election Commissioner Umesh Sinha said the first phase of elections concluded "very peacefully" with a few "stray incidents".

Chief Election Commissioner Sunil Arora said a total of 52.24 per cent turnout was registered by 5 p.m. after the polling at 31,371 polling stations in 71 Assembly segments in 16 districts of Bihar, including 12 Left Wing Extremist (LWE) districts. The polling began at 7 a.m.

As the polling took place at different times depending upon the area, the turnout could be more as polling at some places was on till 6 p.m. The elections gathered momentum in the afternoon as the voting started at a sluggish pace due to technical glitches at some of the polling booths.

Violent incidents were reported in some parts of Bihar including in Kaimur district where two groups comprising more than 50 people attacked each other. They were dispersed by paramilitary force personnel. The situation is now under control. Tekari is another place apart from Ara where an altercation between supporters of two alliances was reported.

The Election Commission had established 31,380 polling booths in 16 districts. There are 1,066 candidates are testing their luck in the first phase. In all, 41,689 ballot units, 31,371 control units and 31,371 VVPATs were deployed in the elec-

Out of these, the replacement rate has been 0.18 per cent for ballot units, 0.26 per cent for control units and 0.53 per cent for VVPATs as per a report at 10 am, the ECI said. In the first phase, 1,066 candidates, including 114 women are in the

However, the ECI claimed that the EVM problem was solved shortly after the fault was detected, voters have to wait in queues for over an hour and some even returned home without casting votes. Due to the technical snags, the functioning of over 75 EVMs or VVPATs in Munger, Arwal, Gaya and Nawada districts of Bihar got affected.

Voters in Gaya, Jahanabad, Aurangabad, Jamui, Bhabhua, Sasaram, Baka, and Kaimur also complained of technical and other errors in EVMs. Due to this, polling started late by 30 minutes to 2 hours at several places. In Munger, technical glitches in Electronic Voting Machines or EVMS were reported in polling booths 165 and 231.

NIA conducts raids in J&K, Bangalore

New Delhi, Oct 28: The National Investigation Agency (NIA) Wednesday carried out searches at 11 locations in Jammu & Kashmir and Karnataka, including the residence of activist Khurram Parvez, in connection with its probe into a case pertaining to so-called NGOs and trusts raising funds in India and abroad in the name of charitable activities and then using those funds for carrying out secessionist and separatist activities

An NIA spokesperson here said that the anti-terror probe agency carried out searches at 10 locations in Srinagar and Bandipora in J&K and one location in Bangalore. The official said that searches

were carried out at the residential and office premises of Khurram Parvez, who is co-ordinator of J&K Coalition of Civil Society, his associates Parvez Ahmad Bukhari, Parvez Ahmad Matta and Bengaluru-based associate Swati Sheshadri, Parveena Ahanger, chairperson of Association of Parents of Disappeared Persons (APDPK) and offices of NGO Athrout and GK Trust

During searches NIA seized several incriminating documents and electronic devices. The action comes in the wake of a fresh case registered by the NIA on October 8 under several sections of the Indian Penal Code and Unlawful Activities (Prevention) Act on receipt of credible information that certain NGOs and trusts are collecting funds domestically and abroad through socalled donations and business contributions etc and are then utilising these funds for secessionist and terrorist activities

Bihar man gets death for killing 9

Hyderabad, Oct 28: A court in Telangana's Warangal district Wednesday sentenced a man to death for killing nine migrant workers by throwing them into a well

after mixing sedatives in their food. The court verdict came five months after the shocking incident as First Additional District Court magistrate found 24-year-old Sanjay Kumar Yadav guilty of the gruesome

killings and sentenced him to death. The police investigations had revealed that to hide the murder of a woman with whom the Bihar man, had a live-in relationship. Sanjay Yadav committed nine more murders by throwing the victims into a well at Gorrekunta village near Warangal town on May 20. Police on May 25 arrested Sanjay Yadav, who confessed to killing the nine people, including six members of one family, by mixing sleeping pills in their food and then throwing them one by one into a nearby well. As all the victims were sedated after having their food laced with sleeping pills, the accused put each person in a gunny bag, dragged them one by one and threw them into the well, about 100 metres away from a godown of a gunny bag making unit where the family of a migrant worker from West Bengal and two Bihari vouth were living.

Another migrant from Tripura who was also present in the building, was also murdered. Police had recovered the bodies Mohammed Maqsood Alam (55), his wife Nisha (48), their sons Shabaaz Alam (20) and Sohail Alam (18), daughter Bushra Khatoon (22), Bushra's three-year-old son, all from West Bengal, Sriram Kumar Shah (26), Shyam Kumar Shah (21), both from Bihar and Mohammed Shakeel (40), a native of Tripura.

Yadav, who was also working at

the gunny bag unit, developed a relationship with Nisha's niece Rafiqa (37), who had come from West Bengal with three children after separation from her husband and was employed in the same factory. Yaday had taken a room on rent and was living with her. After Rafiga admonished him for trying to sexually exploit her daughter, he hatched a plan to kill Rafiqa.

He informed Maqsood's family that he is taking her to West Bengal to talk to her elders for marriage. They boarded the Garib Rath train to Visakhapatnam on March 6, but during the journey, he bought butter milk and after mixing sleeping pills, served it to Rafiga. After she fell asleep, he strangulated her and threw the body from the train near Nidadavole in West Godavari district of Andhra Pradesh.

J&K land laws: Kashmiris fear dilution of identity, culture

Srinagar, Oct 28: The new land laws notified by the Centre for Jammu and Kashmir and Ladakh have stirred a public debate in Kashmir. Notwithstanding the various interpretations given to these laws by local politicians, the common Kashmiri believes that his identity and culture would get diluted once these laws are imple-

Till Tuesday, one needed a Domicile Certificate which had replaced the permanent resident certificate after the abrogation of Article 370, to purchase or sell land in Jammu and Kashmir. This lim-

ited the transfer and inheritance of land to only those Indian citizens who had obtained their domicile certificates.

In addition to the purchase of land, the domicile certificate entitled one to apply for government jobs in J&K, which are still exclusively reserved for the local youth. After notifying new land rules, which came into force by repealing 11 existing land laws of the erstwhile state of J&K, any citizen of India can now purchase land in the union territory to take up residence or start a business here.

"With the already existing small land holdings, it is most likely that the land ownership scenario in J&K



would completely change in a decade or so. It is not just land that would be owned by outsiders, but the impact on the local identity, culture, businesses, etc. would be unavoidable", said Sajad Ahmad, 46, a res-

ident of the old city Srinagar area. Others believe that the predominantly Muslim identify of J&K would also get diluted. "Being the only Muslim majority state that joined the Indian union in 1947, J&K now stands to lose that central identity. Believing that the locals will not sell their lands after the market prices increase manifold due to the competing new buyers is believing too much", said Zafar Ahmad, 57, a local businessman.

Ironically, while expressing fears about the likely dilution of their identity, the average Kashmiris also believe that there would be better industrial and tourism related prosperity once outsiders join these sectors.

There is no doubt that hoteliers and industrialists from outside would look at J&K as an almost virgin investment destination now. They would not initially risk their capital by investing in the Valley, but the Jammu division would be their ideal initial investment destination.

"The new business and industrial houses who venture into Kashmir will definitely demand concessions by way of tax holidays,

etc. The authorities appear to have taken this into consideration especially in light of Lt. Governor Manoj Sinha's assertion that a new era of prosperity would dawn on J&K because of the new land laws",

said Latif Ahmad, 67, a local hotelier. There is a growing fear along the local business and industrial community that they would not stand the ground against investors and competitors from outside.

The fear of the common man about the dilution of his identity and culture has got compounded because of the statements of almost all regional mainstream politiciansthat Delhi has a different roadmap

in mind for the future of J&K.

Gold smuggling: Blow to Sivasankar

Kochi, Oct 28: Minutes after the Kerala High Court Wednesday refused anticipatory bail to the former secretary of Kerala Chief Minister Pinarayi Vijayan, M.Sivasankar was taken into custody by the ED from an ayurveda centre in the state capital.

This is a serious setback for Vijayan in the gold smuggling case registered by the Customs and the Enforcement Directorate (ED), All along Viiavan has claimed to having no clue or knowledge of Sivasankar's links and that it was his personal business

Ever since the gold smuggling case surfaced on July 5, Sivasankar's fate has been hanging in the balance and with the court denying bail in cases filed by the Customs and the ED, arrests by both these agencies was expected all along.

The 58-vear-old was convalescing at an ayurveda hospital in Thiruvananthapuram, and mo-

ments after the verdict came, the key former official was picked up by financial probe agency officials and taken to Kochi. He will be subjected to detailed questioning. The high court last

week extended the status quo -- asking both the ED and the Customs not to arrest Sivasankar till Wednesday ahead of

the court passing its orders. Both these agencies have been strongly opposing the bail plea and the ED went a step further, when it handed over a sealed cover which is believed to contain strong evidences linking the senior IAS official's links with the accused in the gold smuggling case. Reacting to the verdict, State

BJP president K.Surendran said: "It was we who had first told about the role of Vijayan's office. Vijayan was washing his hands off by saying that this has got nothing to do with his office and Sivasankar's is personally responsible. All such arguments of Vijayan have now

fallen flat and it's only a question of time, when the probe agencies now land in Vijayan's office," said

New Delhi, Oct 28: The lockdown due to coronavirus affected everyone's livelihood significantly. The lockdown has adversely affected the future of circuses as there is no audience for the shows. Many circus operators don't even have money to recharge their phones.

Clowns, who bring smiles to many people, animals like lions, tigers and elephants who perform on the directions of ring masters, motorcycles running in the well of death, beautiful girls performing stunts etc might not be seen anymore which means the circus might become a history for the next generation.

Anil Kumar, manager of Asiad Circus, said, "Our circus has been closed since March 13. Some of the



people working have gone back to their homes while some are still living in the camp but they are working as daily wage labourers. They sleep here after coming back from their work."

"The situation was already bad for us, but the pandemic spread has made it worst. Earlier, we hardly managed to earn bread and butter but now we don't even have money to recharge our phones," he said.

There used to be around 150-200 circuses in the country but due to the restrictions imposed due to coronavirus, they are on the verge

of closure. Some of the circuses closed down due to increasing cost while the remaining are closing down due to various restrictions imposed by the government.

Though there is a circus association in the capital but due to lack of members it is also not active. According to circus operators, around 10 to 15 circus closed down due to coronvirus while the remaining are struggling. According to Kumar, circus is no longer a profitable business and if the government does not pay attention, soon it will just be on papers.

However, the growth of multimedia has also affected the circus business as now children have a lot of options for their entertainment. Rambo Circus, one of India's most popular and oldest circus, has been

badly affected by the Covid-19 pandemic. In order to provide financial assistance to the members of this circus, it has started digital shows.

Rajesh Shah, a resident of Boroda, runs a consultancy which helps the circus companies. Shah said, "Out of 20 big circus across the country, only 10 big are existing now. All the artists have gone back to their hometowns because of

"It will be very difficult to get these artists back as they are very hardworking and they will find some other work for themselves. The Great Bombay Circus, which started from Mumbai in 1920, completed 100 years this year and witnessed a great success but currently its condition is bad. Two brothers run this circus.

Mizoram records first Covid death

Aizawl, Oct 28: A 62-year-old man died of Covid-19 Wednesday in Mizoram, the only state where until now there were no fatal cases even though India's tally touched 80,00,000 cases and 1,20,010 people succumbed to the virus since January 30, when the first case was reported in the country.

"The first Covid-19 related mortality in Mizoram comes as a huge shock to the entire state," Mizoram's Directorate of Information and Public Relations tweeted. "He was 62-years-old with existing co-morbidities and was under treatment at ZMC for more than 10 days," the statement said. The health officials in Aizawl

said that the man was suffering with various ailments and was admitted to the Zoram Medical College and Hospital (ZMCH) early last week, after he was tested positive for Covid-19.

Till Wednesday morning, Mizoram has recorded 2,607 positive cases, but 2,233 patients have recovered and there are 374 active cases. Of the total cases, including 563 women patients, 1,747 people were from Aizawl district

With a surge in Covid-19 cases, a week-long total lockdown was enforced in the Aizawl Municipal Council area from Tuesday to check the spread of the disease in the state capital. A Mizoram government health official said that many Covid cases with untraceable contacts have been found in the past few days, forcing the government to take the step.

The official said that at least 34 people, including two infants, have tested positive for Covid-19 since Monday in Aizawl, Mamit, Siaha and Lawngtlai districts with 30 cases alone found in Aizawl.

Male, Oct 28: The US will open an embassy in Maldives, Secretary of State Mike Pompeo announced Wednesday as he held extensive talks with leadership of the strategically located island nation in the Indian Ocean, weeks after the two countries clinched a key defence cooperation agreement.

"I am pleased to announce our plan to open an Embassy in Male. Since the establishment of our diplomatic ties in 1966, we've seen Maldives make great progress in supporting democratic institutions, and we are proud to partner with them on regional security issues," Pompeo tweeted.

US embassy services for Maldives is currently available from the US embassy in Colombo, Sri Lanka.

The State Department earlier said that Pompeo will travel to Male to "reaffirm our close bilateral relationship and advance our partnership on issues ranging from regional maritime security to the fight against terrorism.'

The top US diplomat, who arrived here from India and Sri Lanka after holding talks with the country's leadership, said he had a "great" meeting with the Maldives President Ibrahim Mohamed Solih.

"Great meeting with President @ibusolih in Male. I made a historic announcement regarding our plan to open a US Embassy in Maldives. We deeply value our friendship with the Maldivian people and look forward to taking our partnership to the next level," Pompeo said in a tweet after his meeting with President Solih. President Solih and Secretary Pompeo spoke on a wide range of issues. Discussions pertained to strengthening bilateral relations and multilateral cooperation; trade and investment facilitation; environmental conservation; cybersecurity; combatting terrorism; and upholding the principle of a stable, open and peaceful Indian Ocean region, the Maldives President's Office said in

a statement. While welcoming Pompeo to the Maldives, the President thanked him for the US Government's generous assistance towards the Maldives and their increasingly active and positive engagement with the Maldives on many important bilateral spheres.

President Solih and Secretary Pompeo affirmed their mutual commitment to work towards strengthening Maldives-US ties, the statement said.

Maldives Foreign Affairs Minister Abdulla Shahid said the announcement of the opening of the first-ever US Embassy in Maldives, today, is a significant milestone in our longstanding relationship.

In September, the US and the Maldives inked a defence cooperation deal with Maldives amidst the Chinese Navy's growing presence in the Indian Ocean.

China is engaged in hotly contested territorial disputes in the South China Sea, and with Japan in the East China Sea. Both the areas are said to be rich in minerals, oil and other natural resources.

Beijing claims almost all of the South China Sea. Vietnam, the Philippines, Malaysia, Brunei and Taiwan have overlapping claims in the waterway.

US to open embassy CHINA CRITICISES US' INDO-PACIFIC STRATEGY

Beijing, Oct 28: China Wednesday said its border standoff with India in eastern Ladakh is a bilateral issue, and asked the US to "stop" its Indo-Pacific strategy, terming it as an attempt to impose American hegemony in the region.

The remarks by the Chinese Foreign Ministry came a day after Secretary of State Mike Pompeo assured India that the US stands firmly with it to confront threats to its sovereignty.

Pompeo's remarks came after the third edition of the Indo-US dialogue in New Delhi during which the two sides deliberated prominently upon the Sino-India border row and situation in the Indo-Pacific region.

Reacting to the US push for closer defence ties with India, Chinese Foreign Ministry spokesman Wang Wenbin told a media briefing here Wednesday that "the border affairs between China and India are matters between the two countries."

"Now the situation across the border is generally stable and the two sides are in resolving relevant issues through consultations and negotiations," he said, in apparent



'US' vision of SL different from predator China'

Colombo: America's vision on Sri Lanka is "very different" from that of "predator" China, US Secretary of State Mike Pompeo said here Tuesday as he met the leadership here and reaffirmed US' commitment to the island nation's sovereignty and security. Turkey vows to take 'legal action'

Ankara, Oct 28: Turkey has vowed to take "legal, diplomatic actions" over a cartoon of President Recep Tayyip Erdogan in French magazine Charlie Hebdo.

The cartoon depicts Turkey's president lifting the dress of a veiled woman.

State media say Turkish prosecutors have launched an official investigation into the satirical magazine, the BBC reported.

Tensions between France and Turkey are high after President Emmanuel Macron pledged a tougher stance against radical Islam. Erdogan has called on Turks to boycott French goods and said Macron needed "mental checks".

Macron pledged to defend secularism following the killing of a teacher who had shown his students a cartoon of the Prophet



State secularism is central to France's national identity. Curbing freedom of expression to protect the feelings of one particular community undermines unity, the state says. Presidential Communications Director Fahrettin Altun said: "Charlie Hebdo just published a series of so-called cartoons full of despicable images purportedly of our President. We condemn this most disgusting effort by this publication to spread its cultural racism and hatred."

Vice-President Fuat Oktay called on the international community to raise its voice against "this disgrace". "You cannot fool anyone by hiding behind freedom of thought," he said on Twitter.

In response, the Turkish progovernment satirical magazine Misvak posted a number of cartoons criticising Macron and Charlie Hebdo on its Twitter page.

In 2015, 12 people were killed in an attack on the offices of the magazine in Paris. It was targeted by Islamic extremists for publishing cartoons of the Prophet Muhammad.

The same year, Russia heavily criticised the magazine for two cartoons depicting the Sinai air crash in which 224 people, mostly Russians, died. In 2016, a cartoon depicting Italian earthquake victims as pasta dishes caused outrage.


US early voting tops 70mn, continuing historic pace

Washington, Oct 28: More than 70 million Americans have cast ballots in the US presidential election, more than half the total turnout of the 2016 election with one week to go until Election Day, according to a tally from the US Elections Project.

The tally, which shows a recordbreaking pace that could lead to the highest voter turnout in percentage terms in more than a century, is the latest sign of intense interest in the contest between Republican President Donald Trump and Democratic challenger Joe Biden. It also highlights voters' desire to reduce their risk of exposure to COVID-19 as the pandemic regathers strength heading into

winter. Democrats hold a significant advantage in early voting due to their embrace of mail balloting, which Republicans have historically cast in large numbers but have shunned amid repeated and unfounded attacks by Trump, who says the sys-

tem is prone to widespread fraud. Overall, Democrats hold roughly a two-to-one advantage in early voting numbers. However, Republicans in recent weeks have narrowed the gap in early, in-person voting, data shows. The high level of early voting has led Michael McDonald, the University of Florida professor who administers the US Elections Project, to predict a record US voter turnout of about 150 million, rep-



resenting 65% of those eligible to vote, the highest rate since 1908.

US voters have already cast far more early votes during this pres-

tion campaign, said: "The huge majority of President Trump's supporters are planning to vote on Election Day and Democrats are going to be short of the early vote marks they need in key battleground states. According to the latest Reuters/Ipsos opinion poll released October 21, Biden was in the lead with support from 49 per cent of registered voters, while Trump had the backing of 45 per cent, The Hill news agency reported. idential campaign than they did in all of 2016 when they passed the

An October poll conducted by Henson's organisation found Biden outperforming Trump among independents, 45% to 37%. In 2016, Hillary Clinton lost the same group

by nearly 30 percentage points. The US saw the lowest rates of eligible voter turnout at the end of the 18th century and beginning of the 19th century.

But trends changed in the mid-19th century, when the US began to see "astronomical" turnout, said Barry Burden, a political science professor and director of the Elections Research Center at the University of Wisconsin-Madison.

The turnout rate started to rise in 2004 and, in 2008, the US saw the highest rate of eligible voter turnout in a presidential election in the last 50 years: 61.65%

The 2016 election also saw turnout about 60%, and the 2018 midterm election drew the highest midterm turnout since 1914.

ICICI Securities said Bharti Airtel's second quarter numbers underlined "superior execution" in India mobile and other segments. ICICI Securities believes that higher 4G subscriber base will enable the telco to better transfer tariff hike into Average Revenue Per User (ARPU).

New Delhi: Tata group firm Titan Company Ltd Wednesday reported a 37.81 per cent decline in its standalone net profit to ₹199 crore for the quarter ended September 30, on account of higher expenses. The company had reported a net profit of ₹320 crore in the corresponding period of the previous financial year. Its total income for the quarter was ₹4,389 crore, down 1.72 per cent as compared with the income of ₹4.466 crore previous year.

RBL Bank profit jumps two-fold

New Delhi: Private sector lender RBL Bank Wednesday reported over two-fold jump in its standalone net profit to ₹144 crore for the second quarter ended September 30. The bank had posted a net profit of ₹54 crore in the same quarter previous fiscal. Its total revenue grew by 6 per cent during July-September period of 2020-21 to ₹1,388 crore as against ₹1,310 crore a year ago, RBL Bank said in a regulatory filing. However, net NPAs improved to 1.38 per cent as against 1.56 per cent.

Airtel to stay away from 5G auctions

New Delhi, Oct 28: Lack of a reliable ecosystem and the high price of the coveted 5G spectrum will deter Bharti Airtel from participating in the auctions if they happen next vear.

Bharti Airtel CEO Gopal Vittal said that the company would stay away from the 5G auctions, if they happened next year as the spectrum offered at the current prices were not affordable for the com-

"The 5G ecosystem is yet to develop here and the prices are very high and we can't afford them," Vittal said during the company's post earnings call.

He said that the company woulld not buy the airwaves at the current prices at the rates suggested by the Telecom Regulatory Authority of India (TRAI).

This is not the first time the company has expressed reservations over bidding for the 5G auctions. Bharti Airtel has maintained this stance since the time the regulator came out with its suggestions on spectrum pricing.

TRAI has recommended the auction of about 8,644 MHz of telecom frequencies, including those for 5G services, at an estimated total base price of ₹4.9 trillion.

Telecom companies including Vodafone Idea (VI) and Reliance Jio have said that the current prices

Bharti Airtel on Tuesday posted a net loss of ₹763 crore for the July-September quarter (Q2). The company had posted a consolidated net loss of ₹23,045 crore in the same quarter last year, after provisioning for the adjusted gross revenues (AGR) dues

1K Bargarh weavers trained under HMI

Bhubaneswar, Oct 28: Over 1000 Sambalpuri handloom weavers from Bargarh have been trained in aspects of enterprise creation and business development under Project 'Handmade in India' (HMI) implemented by Entrepreneurship Development Institute of India (EDII).

EDII and Ernst & Young LLP (EY) have jointly undertaken the implementation of HSBC supported project "Hand-Made in India," intending to strengthen the handloom value chain, making the weavers self-reliant. Interventions such as credit linkage, capacity building, market linkage, design development, and enterprise the development were conducted at Bargarh handloom cluster.

"Due to Covid, the price of raw material has also increased which the weavers are unable to afford. Keeping this in mind, the project concentrates on product development to capture larger and high-end markets with a special focus on exports, according to EDII official statement. EDII HMI Cluster teams have

also conducted training sessions on Digital Marketing. The weavers were trained to open their accounts on Facebook, Instagram and other e-commerce portals.

Sugar consumption stagnant, says Govt

New Delhi, Oct 28: The government Wednesday said there is a need to address myths and misgivings about sugar consumption in India, as the per capita consumption of the sweetener has remained stagnant for the last three vears at 19 kilogram.



Food Secretary Sudhanshu Pandey, after launching industry body ISMA's portal 'httpmeetha.org' said India is one of the world's largest consumers of sugar but per capita consumption has remained stagnant at 19 kg, much lower than the world's average per capita consumption of 23.50 kg.

The country's annual sugar consumption stood at 25-26 million tonnes, while production reached 27.5 million tonnes in the 2019-20 season ending September.

There are a lot of myths going around about sugar and sugar consumption without scientific basis. This misinformation multiplies much faster than the truth multiplies. Therefore, it is very important to come up with scientific information so that people can make very informed decisions, Pandey said.

Pandev further said there is also misunderstanding about Indian sugar abroad.

Somehow, it has been created hat Indian sugar industry or Indian sugar is not as good as perhaps the Brazilian sugar or Thai sugar which is not the case, he said.

To counter the false narrative, the Secretary said that Indian Sugar Mills Association (ISMA) through its portal 'httpmeetha.org' and social media campaigns aims to educate people with right and scientific information about sugar.

He suggested the industry body to launch the portal in regional and foreign languages as well for better reach.

The Secretary also mentioned that sugar consumption depends on many parameters such as economic growth, consumption pattern and expenditure.



US: Spy agency ducks questions about 'back doors'

San Francisco, Oct 28: The US National Security Agency is rebuffing efforts by a leading Congressional critic to determine whether it is continuing to place socalled back doors into commercial technology products, in a controversial practice that critics say damages both US industry and national security.

The NSA has long sought agreements with technology companies under which they would build special access for the spy agency into their products, according to disclosures by former NSA contractor Edward Snowden and reporting by Reuters and others

These so-called back doors enable the NSA and other agencies to scan large amounts of traffic without a warrant. Agency advocates say the practice has eased collection of vital intelligence in other countries, including interception of terrorist communications

The agency developed new rules for such practices after the Snowden leaks in order to reduce the chances of exposure and compromise, three former intelligence officials told Reuters. But aides to Senator Ron Wyden, a leading Democrat on the Senate Intelligence Committee, say the NSA has stonewalled on providing even the gist of the new 'Secret encryption back doors

are a threat to national security and the safety of our families - it's only a matter of time before foreign hackers or criminals exploit them in ways that undermine American national security," Wyden told Reuters. "The government shouldn't have any role in planting secret back doors in encryption technology used by

The agency declined to say how it had updated its policies on obtaining special access to commercial products. NSA officials said the agency has been rebuilding



trust with the private sector through such measures as offering warnings about software flaws.

"At NSA, it's common practice to constantly assess processes to identify and determine best practices,' said Anne Neuberger, who heads NSA's year-old Cybersecurity Directorate. "We don't share specific processes and procedures."

Three former senior intelligence agency figures told Reuters that the NSA now requires that before a back door is sought, the agency must weigh the potential fallout and arrange for some kind of warning if the back door gets discovered and manipulated by adversaries.

The continuing quest for hidden access comes as governments in the United States, the United Kingdom and elsewhere seek laws that would require tech companies to let governments see unencrypted traffic. Defenders of strong encryption say the NSA's sometimes-botched efforts to install back doors in commercial products show the dangers of such requirements.

Critics of the NSA's practices say they create targets for adversaries, undermine trust in US technology and compromise efforts to persuade allies to reject Chinese technology that could be used for espionage, since US gear can also be turned to such purposes.

the inclusion of Mitchell Santner in the last game and needs to step up.


CSK, on their part, will be aiming to build on the win over RCB and end the season on a high, apart from hurting the chances of playoff hopefuls.

Madrid, Oct 28: Barcelona president Josep Bartomeu resigned amid the fallout of his feud with star Lionel Messi, and on his way out revealed the Spanish club wants to join a potential new super league of elite European teams.

After one of the club's worst sea-

sons in more than a decade, Bartomeu announced that his entire board of directors also resigned, effectively avoiding a motion of censure vote that was scheduled for the coming weeks.

Bartomeu wanted to delay the vote, citing health concerns for the club's more than 110,000 members amid the coronavirus pandemic, but local officials earlier in the day authorized the vote to take place.

"We have to act responsibly,"
Bartomeu said. "For that reason
we cannot hold the vote of censure
in the current circumstances. It
was necessary to do so in conditions that guaranteed everybody's



health. We cannot nor want to put ourselves in a position of having to choose between protecting people's health and exercising the right to vote. For that reason we have taken the decision to not call the vote and resign forthwith."

More than 20,000 Barcelona members had signed a petition for Bartomeu and his board to face a motion of censure.

The petition was made not long after Messi said he wanted to leave the club, and following the team's embarrassing 2-8 loss to Bayern Munich in the Champions League, a result that capped the club's first

season without a title since 2007-08.

Messi was critical of club directors last season and said he didn't like the direction the club was headed. He personally complained of Bartomeu for not keeping his promise to let him leave.

Bartomeu said on Monday that

he explained to Messi and his fam-

ily that he could not let the world's

best player depart before the end of

his contract, which expires at the end of this season. Bartomeu had also said that resigning had not crossed his mind.

He said "the desire of this board of directors has never been to hold on to power at the club" which will

on to power at the club," which will now be managed by an interim board until new elections are held. Bartomeu added that the club had given its initial approval to a new

Bartomeu added that the club had given its initial approval to a new competition. "I can announce that we approved the requirements to be part of a European Super League," Bartomeu said. "The decision to play the competition now must be ratified by the next (club) assembly."
