# Woman beheaded as 3 killed in knife attack

IT WAS THE THIRD ATTACK IN TWO MONTHS IN FRANCE AMID A GROWING FURORE OVER CARICATURES OF THE PROPHET MUHAMMAD THAT WERE RE-PUBLISHED BY THE SATIRICAL NEWSPAPER CHARLIE HEBDO

Nice, Oct 29: A knife-wielding attacker shouting "Allahu Akbar" beheaded a woman and killed two other people in a suspected terrorist incident at a church in the French city of Nice Thursday, police and officials said.

Nice's mayor, Christian Estrosi, who described the attack as terrorism, said on Twitter it had happened in or near the city's Notre Dame church.

Estrosi said the attacker had repeatedly shouted the phrase "Allahu Akbar", or God is greatest, even after he had been detained by police. One of the people killed inside the church was believed to be the church warden, Estrosi said, adding that a woman had tried to escape from inside the church and had fled into a bar opposite the building.

"The suspected knife attacker was shot by police while being detained, he is on his way to hospital, he is alive," Estrosi told reporters. "Enough is enough," Estrosi said. "It's time now for France to exonerate itself from the laws of peace in order to definitively wipe

A police source said a woman was decapitated. French politician Marine Le Pen also spoke of a decapitation having occurred in the attack.

Estrosi said the victims had been killed in a "horrible way".

Meanwhile, Prime Minister Jean Castex said the country's threat level will be raised to its maximum after an attack near a church killed three people Thursday in Nice.

The move comes just hours before the country was going into its second coronavirus lockdown.

It was the third attack in two months in France amid a growing furor over caricatures of the Prophet Muhammad that were re-published by the satirical newspaper Charlie Hebdo.

Other confrontations and attacks were reported Thursday in the southern city of Avignon and in the Saudi city of Jiddah, but it was not immediately clear if they were linked to the attack in Nice. Sounds of explosions could be heard as sappers exploded suspicious objects.

Pope Francis is praying for the victims of the knife attack at a Roman Catholic basilica in the southern French city of Nice and for an end to all "terrorist" violence.

### DNA test report of body parts out

Bhubaneswar, Oct 29: The Commissionerate Police Thursday clarified that the human body parts found at the petrol pump filling station near Raj Bhawan Square belonged to Simanchal Parida. He had gone missing since a devastating blast rocked the pump, October 7.

With police confirmation, it is now clear that Parida had died due to the blast. With this confirmation, the death toll in the blast climbed to two. Twin City Police Commissioner Sudhansu Sarangi revealed this a press conference here

"The State Forensic Science Laboratory (SFSL) today submitted the DNA analysis of the 21 body parts of a human found from the blast site. They have said that the body parts belonged to Simanchal Parida. His family has been informed," Sarangi said.

He also informed the media that the IOCL authorities have been informed about the outcome as well. The Commissionerate Police are also hopeful of receiving other reports, including the CCTV footage examination report, soon.

Meanwhile, the family members of Parida told **Orissa POST** that they were only orally informed by the



cops about the outcome of the DNA examination. They are yet to send the officially documents regarding the death of Simanchal so that the family can secure his death certificate and fulfill other legalities.

The IOCL authorities have also said that they will release the financial compensation announced earlier to Parida's family after getting all the documents in this regard from the commissionerate police.

Notably, fire broke out at the Indian Oil petrol pump near Raj Bhavan area in Bhubaneswar October 7 at around 1.10pm following a huge blast. One person was killed and seven others iniured due to the blast. Parida. a diploma engineer and a resident of Aska in Ganjam district, was engaged in\_ maintenance work at the pump on the fateful day. He was missing since then.

### Rourkela driver receives ₹28cr GST default notice

Rourkela, Oct 29: In a bizarre development, the Goods and Services Tax (GST) department Thursday served a defaulter notice of over ₹28 crore to Rajendra Kumar Palai, a driver residing in Sector-20 area of Rourkela city.

Palai has been charged with gross tax liability under Section 74(5). The department claims that he has received taxable goods amounting to over ₹23.96 crore. He allegedly also defrauded about ₹4.31 crore under CGST and SGST by producing fake invoice.

### Cabinet approves DRIP for 36 dams in Odisha

New Delhi, Oct 29: The Cabinet Committee on Economic Affairs Thursday approved a ₹10,211-crore project to improve the safety and performance of select dams across India, including 36 dams in Odisha.

The Dam Rehabilitation and Improvement Project (DRIP) - Phase II and Phase III - is financially supported by the World Bank and Asian Infrastructure Investment Bank.

The project envisages comprehensive rehabilitation of 736 existing dams located across the country. This includes 189 dams in Rajasthan, 167 in Maharashtra, 59 in Tamil Nadu, 41 in Karnataka, 39 in Uttar Pradesh and 36 in Odisha. It will be implemented

over a period of 10 years duration in two phases, each of six years duration with two years overlapping from April, 2021 to March

According to the government, the share of external funding is ₹7,000 crore of the total project cost, and balance ₹3,211 crore is to be borne by the concerned Implementing Agencies (IAs). The contribution of the Uniongovernment is ₹1,024 crore as loan liability and ₹285 crore as counter-part funding for central component.

The project aims to improve the safety and performance of selected existing dams and associated appurtenances in a sustainable manner and to strengthen the dam safety institutional setup in participat-



ing states as well as at central level. It also aims to explore the alternative incidental means at few of selected dams to generate the incidental revenue for sustainable operation and maintenance of dams The project will work onrehabilitation and improvement of dams and associated appurtenances. # Why Kashmiri Pandits are opposing J&K land sale to outsiders

THE MIGRANT KASHMIRI PANDITS DEMAND THAT THERE SHOULD BE A BAN ON THE SALE OF ANY LAND UNTIL THE COMMUNITY IS REHABILITATED

Srinagar, Oct 29: Migrant Kashmiri Pandits Thursday demanded a ban on sale of land to outsiders in Jammu & Kashmir till the community is rehabilitated in Kashmir.

Satish Ambardar, chairman of Reconciliation, Return and Rehabilitation, an organisation of migrant Pandits said in a statement: "The Government of India notified land law for Jammu & Kashmir Tuesday, October 27, 2020. The law paves the way for any citizen of India to buy land in J&K.'

"Kashmiri Pandits feel betraved. For 31 years we have been waiting

for return and rehabilitation in our land of origin. Without getting us rehabilitated in our land, the Government of India has thrown open the Kashmir land for sale. Is this justice? Since 1989, the community has suffered genocide and ethnic cleansing in the valley." The successive governments in

the Centre and state failed to protect its own people in the valley. The governments remained a mute spectator to what happened to the community. The forced exodus took a heavy toll on the community. Kashmiri Pandits were killed, their properties looted, burnt, temples desecrated, many women kidnapped,



"The forced exodus has cut us from our roots. This has affected our unique religious, cultural and traditional identity. Today, we feel we feel this

government has completely betrayed us. If the earlier ones did nothing to help us get our land back in Kashmir, this government has made sure that

we remain in exile forever," he said.

"The exodus has scattered the community and after this order the community will always remain scattered, lose its ethnicity and die a slow death. A community which has a 5,000-year history in Kashmir is finally being slowly poisoned by the powers that are there."

'Our Constitution has ensured singularity in plurality, diversity in unity and safeguarding of minorities, but the successive governments have failed to protect the ethnicity of the minority in Kashmir. This order of the Government of India sounds like a death knell for the KP community. It seems that J&K has been put up for sale. The rich and powerful will buy

lands and take over the place whereas the original aborigines will continue to live in exile," he said. 'We fear that land sharks will usurp

our lands, including our temples, shrines and other KP institutions. We demand that there should be an immediate ban on the sale of any kind of land until the Kashmiri Pandit community is rehabilitated. We demand that those 419 families be rehabilitated, who a year ago had given in writing to the Union Ministry of Home Affairs that they want to return. We request all parliamentarians to kindly come forward and help to rehabilitate Kashmiri Pandit refugees in Kashmir.





# Provide loan to farmers: CM to bankers Package soon for coal

Bhubaneswar, Oct 29: In an aim to provide livelihood support to the people during Covid-19 pandemic, Chief Minister Naveen Patnaik Thursday urged bankers to provide credit to farmers, self-help groups (SHGs) and MSME units.

Addressing a State Level Bankers Committee (SLBC) through virtual mode, Naveen said, "Covid as a pandemic has impacted both lives and livelihoods. Doctors and Covid warriors are fighting to save lives. Bankers are also Covid warriors as you are central to our efforts to revive and restore livelihoods.'

Stating his government is very serious about restoring economy both at state and at individual household levels, he said the government is providing more than ₹600 crore for interest subvention to facilitate interest-free loans for

farmers up to ₹50.000 and at 2 per cent up to ₹3 lakh.

In case of women SHGs, the government is providing 100 per cent interest subvention up to ₹3 lakh. Similarly, he said, the state has designed some interest subvention to boost the MSME sector.

Naveen said he would be closely monitoring credit flow to these three crucial sectors and have a district-wise review with Collectors and bankers jointly by the end of November.

Best performing banks would be awarded with Chief Minister's award for champion banks, the Chief Minister said, adding, "I would also inform about the performance to the Union Finance Minister?

'If doctors have a major role in saving lives, bankers play a crucial role in saving livelihoods. I am sure all of you will rise to the occasion in helping the poor and needy, especially—women, farmers, and MSMEs," he added. He appreciated the services being provided by the banking community during the lockdown period.



# STATE'S VIRUS TOLL NEARS 1,300

**ODISHA REPORTS 1,617 NEW NOVEL CORONAVIRUS CASES, 13 FRESH FATALITIES IN 24 HOURS**

Bhubaneswar, Oct 29: State's novel coronavirus disease (Covid-19) tally mounted to 2,87,099 Thursday as 1,617 more people tested positive for the infection, an official of Health and Family Welfare (H&FW) department said.

Thirteen fresh fatalities, on the other hand, pushed the coastal state's coronavirus death toll to 1,297, said the official.

As many as 941 new cases were reported in quarantine centres. while 676 infections were detected during contact tracing, according to the Information and Public Relations (I&PR) department.

Khurda district, under which Bhubaneswar falls, reported the highest number of new cases at 222, followed by Cuttack (128), Sundargarh (93), Mayurbhanj (85) and Kalahandi (84).

Khurda has so far registered 48,287 Covid cases followed by Cuttack (25,674), Ganjam (21,123) and Puri (12,404).

Two fresh fatalities each were reported in Khurda, Cuttack, Balasore, Nuapada and Angul, and one each in Keonjhar, Jagatsinghpur

New Delhi, Oct 29: The Supreme Court Thursday granted bail to Radhika Mallick, Sebastian Mallick and Tirupati Kadapa, who have been awarded life imprisonment in a Maoist attack case in Kandhamal district in 2011.

The association has put forth several demands before the government for consideration. It has threatened to intensify the agitation if their demands are not met.

"We have been badly hit by the subsequent spree of lockdowns in the state. We are demanding ₹10,500 as monthly compensation from the government for the losses. We also want amendment to the Motor Vehicle Act as many of the drivers are harassed by the hefty fines imposed by the government in the name of fines," a member of the association said.

He also said that many of them have also got their licences suspended in the light of the MV Act. 'Their licences must be revoked. No driver wants to meet with an accident and gets into trouble. Many of such drivers in such cases are often facing a lot of problems. We have faced a lot of troubles during Covid-19 but we tried to work during the tough times. The government has now said anything for us and didn't address our issues,' he added. "The government should consider giving us monthly pensions after they cross 60 years of age. Labourers in the state get some government aid but we are deprived of the same. We need attention of the government. We deserve Labour Cards as per others," the association said. The association members said that they had made representations before the CM and Transport Minister but in vain.





It was learnt that 1,34, 462 new farmers had registered their names for paddy procurement in fiscal 2019-20.

In the current fiscal, the total number of farmers having registered their names is 1, 39, 648. Of them, 20, 567 have newly registered names while 1, 19, 081 have renewed their registrations for the current vear. The bank accounts of 492 farmers have been blocked while the cases of eight others are under consideration.

Amid allegations of irregularities of non-farmers pushing paddy in procurement system, the ADM directed revenue inspectors, amins and VLWs to investigate if the registered famers own lands and do paddy cultivation and prepare a report. Doubts were raised in some quarters over lands where paddy

Jajpur, Oct 29: Regular extraction of black stones from six stone quarries on Rahadpur hill under Dharmasala tehsil in the district has posed a serious threat to the existence of two minor irrigation projects in the area.

### Build agro infra

kyrocketing prices of kitchen essentials continue to harass the common man. Most vegetables have remained out of bounds for the poor. Onions and potatoes are getting less visible in kitchens. Only the upper-middle class and the ultra rich from amongst us can afford to buy them. With the Odia month of Kartika a few days away the demand for vegetables in the state is set to further soar and with that their prices will go up. In our state, onions and potatoes are the only vegetables whose prices tend to spiral out of reach within days of their breakout. Other vegetables, most of which are locally produced, remain more or less steady or, at the worst, take time in gaining prices. As Odisha is prone to natural calamities, imports of perishables from other states remain vulnerable to price vicissitudes. Natural disasters such as cyclones and floods disrupt road communications. Vast stretches of national highways are washed away cutting off communication links to the state. Transportation goes haywire at the slightest natural disaster. Yet, little has been done to find a lasting solution to this problem. Short-term measures like raiding hoarders, capping stocks and, on the all-India level, blocking exports or incentivising imports are taken to soften the prices. However, these measures by their very nature fail to deliver the goods. They only serve to bring in temporary relief. Also, these actions, being inherently proconsumer and anti-producer, deter farmers from raising their farm output, thereby perpetuating rather than mitigating the price instability. This time round, the government, both at the Centre and the state, have reacted to the problem in a similar fashion. Ipso facto, the results are bound to be temporary. Can't the government throw its blinkers now and think out of box to find a lasting solution to this nagging crisis?

The failure of the government to create effective agro infrastructure in the state has resulted in finding a permanent solution to price shocks. Incentivising private players to create farm infrastructure could be an option worth considering by the government. Odisha is a consumable surplus state in paddy. However, it does not have enough warehouses to preserve the commodity. Farmers here grow paddy not as a choice but under compulsion as they do not have an alternate crop to fall back on. The total consumable surplus of rice in the state is around 35 lakh metric tonne, while the total installed capacity of warehouses does not exceed 15 lakh metric tonne. Of this, nearly 13 lakh metric tonne of space is government-owned, while hardly 2 lakh metric tonne is privately owned and, hence, scattered around the state. There is an urgent need to create additional storage capacity so that farmers here can be encouraged to produce more. In Kalahandi district, onion farmers were forced to sell their produce at ₹5 p/kg which they are now buying at ₹80 p/kg. They had been forced to resort to distress sale as there was no storage capacity in the district. Last year, the district had around 2,500 hectares of onion crop with a projected output of 38,000 tonne. Farmers in Dharmagarh, Golmunda, Jaypatna, Koksara, Kalampur, Junagarh, Borda, Gurjang, Artal, Kuliamal, Madiguda panhayats and many panchayats in Kesinga and Madanpur Rampur had grown onions. However, due to lack of storage facilities in the district, onion farmers resorted to distress sale. Fearing losses, many old onion farmers are turning away from the crop this year. Inviting private investment in development of agro storage could encourage such farmers. Even large numbers of farmers in Bolangir, Boudh and Kandhmal districts grow onions. Local availability of storage space and creation of market linkages for their produce will go a long way in encouraging them to grow the tuber. The 'Make In Odisha Conclave' should invite corporate houses who could invest in building agro infrastructure in the state. This could be one way of sobering the price volatilities of agri produce and reduce the state's dependence on other states.

#### Brand spanking new

hese days, spanking in expressions like that can be said to mean something like "extremely, strikingly, or remarkably", but really it's no more than a flag to give extra force or emphasis to what you're saying. The word appears in English about the middle of the seventeenth century, but then implied something that was exceptionally good or especially fine, often something showy or smart. It may have come from a Danish or Norwegian word spanke, to strut (it seems not to be connected with the more usual sense of spank, to slap, which may be imitative). Later on horses often had the word applied to them, to mean one capable of moving very fast, but particularly in a smart way. Later still, it could mean no more than moving fast in any kind of conveyance, with no link to horses. Frank T Bullen wrote in The Log of a Sea-waif in 1899: "A large canoe ... was coming off to us at a spanking rate". H G Wells used it in 1904: "The char-a-banc ... was clattering along at a spanking pace" [char-a-banc, an early form of bus, used for pleasure trips]. The idea behind the modern sense in brand spanking new is not so very different from its first use.

### Brass ring

a cursory glance at American newspaper archives shows that the Aexpression is common; a recent example is in Ebony for 1 April 2004: "If you're like the millions of women who are on the go - grabbing for the brass ring, focusing on the family or trying to shatter that glass ceiling — it's past time for you to take a step back and concentrate on finding the real you." # **NUTRITION LEADERSHIP**

n African proverb says, "When the music changes, so does the dance." As governments around the world strive to protect their populations from the Covid-19 pandemic's health and economic effects, the role of decisive leadership has never been more important – not least in the area of nutrition.

When we established African Leaders for Nutrition four years ago, our aim was to highlight revolutionary thinking in addressing malnutrition across the continent. None of our group's founders – African Development Bank President Akinwumi A Adesina, the late former United Nations Secretary-General Kofi A Annan, and I - could ever have imagined the burden that the pandemic would impose on the global development agenda.

The threat posed by this new virus requires us to tackle malnutrition in new ways. Covid-19 has revealed inefficiencies and inequities in all of our efforts to achieve robust and long-lasting improvements in nutrition. Africa's rising number of Covid-19 cases threatens to increase hunger and malnutrition further, and has brought into focus how our thinking must change.

African leaders have a particular duty to mitigate the economic crisis. We must act urgently to safeguard and develop our health and food systems, as well as our social safety nets, in order to slow down the cycle of intergenerational poverty. Only integrated efforts will enable us to coordinate nutrition-related investments and improvements to social protection, and then to examine their impact.

Our task is huge: The 2020 State of Food Security and Nutrition in the World (SOFI) report and recent research published in The Lancet on the impact of COVID-19 on childhood malnutrition make for grim reading. After decades of progress in reducing all forms of malnutrition, the trend is reversing, owing to insufficient investment in promoting good nutrition, climate shocks, violent conflict, and now the effects of the Covid-19 crisis.

lence of malnutrition of any region, and may soon overtake Asia in terms of the number of hungry and undernourished people. Among children younger than five, the economic impact of Covid-19 is projected to increase the incidence of wasting, which results from severe weight loss due to starvation and diseases associated with acute malnutrition. This, combined with reduced access to health and nutrition services, is expected to result in more than 128,000 additional deaths globally in 2020 among under-fives, with more than half of these occurring in Sub-Saharan Africa.

But the data also offer glimmers of hope, and point to three ways in which we can reimagine African leadership on nutrition. First, we have an opportunity to transform the economics of health and hunger. By 2030, global diet-related health costs are projected to reach \$1.3 trillion per year. But shifting to healthy diets could reduce these costs by up to 97%, according to the SOFI report.

Second, nutrition must feature prominently in our Covid-19 response. The World Health Organization estimates that investments in nutrition could save 3.7 million lives globally by 2025.

Our leaders therefore must meet the challenge of providing adequate resources for the highest-impact interventions. These include exclusive breastfeeding, targeted complementary feeding, micronutrient supplementation, and food fortification.

Third, a strong nutrition component in pandemic-related social-protection programs is vital to ensure that Africa no longer trails other regions in this regard. Weaknesses in the continent's social-security programs may prove disastrous for people already suffering from hunger or malnutrition. With disruptions to food systems and supply chains compounded by riding prices, social-protection programs need to focus on broadening access to affordable and nutritious diets.

African Leaders for Nutrition's focus remains the same: to amplify the voices of the continent's leaders in order to support Africa's policy conversations - including by facilitating high-level political engagement. Through our African Leaders for Nutrition Champion, King Letsie III of Lesotho, we are calling on heads of state and government of the African Union Assembly, the continent's premier political institution, to ensure that

nutrition features prominently in their Covid-19 response and recovery plans.

At the same time, our advocacy tools, such as the Continental Nutrition Accountability Scorecard, compile hard data on African countries' progress on improving nutrition, services, governance, and socioeconomic outcomes. African governments must make data-driven choices to save lives and livelihoods during the pandemic and beyond, and such tools aim to guide them toward allocating financial resources and other support to achieve the great-

est impact. Above all, African countries must respond in concert to the challenges they face. That means fighting the pandemic in the framework of a longer-term strategy to end malnutrition and boost Africa's collective problem-solving capacity. By uniting and amplifying the voices of Africa's leaders, we can change the dance.

In spite of the fact that food is the most essential commodity for human life, it is not available to all. We are living in a world where all kinds of food are available to some people within a few minutes. whereas another group waits days together to get a handful of food stuff. People in developed countries are living amidst abundance of food and wasting tones and tones of food everyday while the ill-fated people in developing countries endure the pangs of hunger. Especially during the pandemic Covid-19, the plight of the people in countries like Yemen, Congo, Ethiopia and South Sudan etc. to mitigate hunger is really indescribable

India is second in food produc-

continuous efforts of the Indian government after introducing the Green Revolution in the country in the 1960s it claims to be self-dependent in procurement of food grains. Even the output has became surplus. In spite of the said achievement, 19 corer people in India starve every day. The number of hungry people globally crosses 82 corers.

As per the statistics, in 2020 India has remained in the 94th position among 107 nations in the Global Hunger Index. In 2019 its position was 102 among 117 nations and in 2018 it ranked 55th among 77 nations. This indicates that India hasn't been able to solve its hunger problems till today. All other Asian countries, except Afghanistan, have remained above India in the Global Hunger Index. Bangladesh is in the 75th position and Myanmar in the 78th position. Even Pakistan is above India in this Index and occupies 88th position. If this situation continues it is meaningless to call India a food grain surplus nation. Despite its developed economy and adequate food production it has failed miserably in tackling the hunger problem. Apart from starvation, many

people in India suffer from malnutrition. It is a matter of great regret that in India over 7,000 people die of hunger every day. Similarly about 4,500 children below the age of 5 years die every day due to lack of food and malnutrition. Question arises as to what are the causes of this paradox. Poverty is the main cause of hunger in India. It not only leads to hunger, but also seriously affects the availability of adequate amount of nutritious food for the most vulnerable section of people. It is estimated that in India about 276 million people are in the very low income groups. Thus, major food and nutrition crises occur as people are too poor to obtain enough food.

One major cause of hunger problem is wastage of food in India. India is one of those countries that waste huge quantities of food every day. According to a report, India wastes as much as food United Kingdom consumes. According to the United Nations Development Programme, nearly 40% of the food produced in India goes waste. In terms of money India wastes ₹244 corer worth of food a day and ₹50,000 crore worth of food in a year. Huge amount of fruits and vegetables are also wasted every year due to lack of adequate storage facilities.

The gGovernment has launched several schemes over the years to help alleviate the hunger problem. The notable schemes are Antyodaya Anna Yojana, Garib Kalyan Anna Yojana, Annapurna Scheme, Midday Meal Scheme etc. The intentions behind these schemes are very noble. But due to lack of proper execution at the grass root level and rampant corruption prevalent everywhere the benefits do not always reach the people who need it most.

The hunger problem in India indicates the mismanagement of public distribution system. Several welfare schemes of the government to feed the poor also suffer from many lacunae. Most of the times the subsidies of the government meant for poor are not reaching them. This is due to lack of proper identification of deserving beneficiaries. All the loopholes and weaknesses found in the system should be eradicated by the government immediately in order to make India hunger-free.

#### India-US 2+2 dialogue

# **KERALA CPM SECY'S SON ARRESTED**

The double whammy for the ruling CPI-M has come at a time when the party was getting ready to face two polls – for local bodies in December and the Assembly election in May 2021

Thiruvananthapuram, Oct 29: Hours after the Enforcement Directorate secured custody of Kerala Chief Minister Pinaravi Vijayan's former secretary M Sivasankar, in Bangalore, the ED arrested Bineesh Kodiyeri, the son of CPI-M Kerala secretary Kodiyeri Balakrishnan.

The ED has arrested Bineesh in connection with the funding of money to an accused in a narcotic case - Anoop Mohammed.

Anoop Mohammed was arrested by the Narcotics Control Bureau in Bangalore a few months back.

Bineesh was first interrogated by the ED officials last month and soon after that the ED had also sent him a notice under the Prevention of Money Laundering Act and asked him to give the list of his assets and they directed the State Registration department to prepare a list of his assets and to see that there is no transfer or sale of his assets (properties) without their knowledge.

He was then asked to appear before them October 21, but he wrote to ED that he needs some time and appeared before them Thursday morning.

Soon he was taken into custody and was produced before a court there. Reacting to the developments. Leader of Opposition Ramesh Chennithala said this is not the first time the sons of Balakrishnan have landed in trouble.

"The CPI-M in Kerala is now in custody. First, the secretary to Vijayan - Sivasankar was arrested by ED, now CPI-M party secretary's son has been arrested by ED in a narcotics case. Our request is Balakrishnan should not resign as state secretary. Only if he remains in that post, will it be good for us," said Chennithala.

Many women-led startups scaled down their operations or pivoted their business models to stay afloat amid the pandemic, said the report titled 'State of Women in Tech Entrepreneurship in India 2020'.

Women behind some apparel

startups branched out to manu-

facturing protective face masks and

PPE kits. However, despite Covid-19, startups with at least one woman founder were able to secure 71 funding deals in H1 2020, at par with H1 2019 (70 deals) and H1 2018 (70 deals).

The report is based on in-depth interviews with 100 women tech entrepreneurs across sectors and cities in India, independent research and analysis of data for the period between January 2018 and June 2020

The research showed that there has been a phenomenal '11X increase' in the number of women entrepreneurs in tech in the last decade (2010-2020). Female-founded and co-founded tech startups in India cur rently stand at 285, it said.

Between 1990 and 2010, only 26 startups had at least one woman founder: However, 75 startups added at least one woman founder by 2014 and 184 more by 2019.

# New law to curb air pollution in Delhi-NCR Mayawati suspends

Under the ordinance released by the Ministry of Law and Justice Thursday, the Environment Pollution (Prevention and Control) Authority (EPCA) has been dissolved and replaced by a commission comprising over 20 members

New Delhi, Oct 29: Faced with rising air pollution in Delhi-NCR, the Centre has introduced a new law through an ordinance that puts in place a powerful oversight body and provides for up to five years of jail term and Rs one crore fine for violators with immediate effect.

Under the ordinance released by the Ministry of Law and Justice Thursday, the Environment Pollution (Prevention and Control) Authority (EPCA) has been dissolved and replaced by a commission comprising over 20 members.

"The ordinance may be called the Commission for Air Quality Management In National Capital Region and Adjoining Areas Ordinance 2020. It shall apply to national capital region and also adioining areas in so far as it relates to matters concerning air pollution in the NCR. It shall come into force at once," it said. The ordinance was signed by the President on Wednesday

As per the ordinance, the areas where it shall be in force include Punjab, Haryana, Rajasthan and Uttar Pradesh, adjoining areas of the NCR and Delhi where any source of pollution is located which is causing an adverse impact on air quality in the national capital region.

The commission will have the power to lay down parameters of air quality, discharge of environmen-



tal pollutants, inspect premises violating the law, ordering closure of non-abiding industries/plants etc.

"Any non-compliance or contravention of any provisions/rules or order/direction of the commission will be an offence punishable with a jail term up to five years or with fine up to Rs one crore or with both," it said.

The ordinance comes within days of a statement made by the Centre through Solicitor General Tushar Mehta in the Supreme Court during a matter related to pollution in the NCR in which he had said the Centre will bring a new legislation on "Air Quality Management in the National capital Region and adjoining areas"

The Centre informed the Supreme Court on Thursday that it has come out with an Ordinance on curbing pollution and it has been promulgated already. As per the new law, the Supreme Court appointed body,

EPCA which was formed in 1998, has been dissolved and any action taken by it shall be deemed to have been taken under the corresponding pro visions of the ordinance.

"The order made under environment protection act 1986, constituting Environment Pollution (Prevention and Control) Authority (EPCA) for the national capital region wide order dated January 29, 1998, is hereby repealed and the EPCA is here by dissolved.

"Notwithstanding such repeal anything done or any action taken by the EPCA for the NCR under the said order, shall be deemed to have been taken under the corresponding provisions of this ordinance," it said.

The EPCA was a two-member body with Chairman Bhure Lal and member Sunita Narain, who also heads the Centre for Science and Environment (CSE), an environment think tank

The members of the new com-

mission as per the ordinance shall include a chairperson, who is or has been the secretary of Government of India or chief secretary of a state, a representative of environment secretary and five ex-officio members who are either chief secretaries or secretaries in charge of the environment department of Delhi, Punjab, Haryana, Rajasthan and Uttar Pradesh.

The commission will also include two full time members who have been joint secretaries to the central government, three full-time independent technical members who have specific scientific knowledge regarding air pollution, one technical member from Central Pollution Control Board (CPCB), one technical member nominated by ISRO and three members of NGOs having experience in matters concerning combating of air pollution.

"There shall be a full-time secretary who shall be the chief coordinating officer of the commission and shall assist in managing the affairs of the commission," it said. Other than these, the commission may also appoint associate members, one representative each from the Ministry of Road Transport, Ministry of Power, Ministry of Housing and Urban Affairs, Ministry of Petroleum, Ministry of Agriculture, Ministry of Commerce and Industry and a representative of any association of commerce and industry.

New Delhi, Oct 29: BSP chief Mayawati Thursday suspended seven of her party's MLAs, who had opposed the nomination of its official candidate Ramji Gautam for the elections to the Rajya Sabha, for anti-party activities.

Amid speculation that the MLAs could switch sides in Uttar Pradesh, Mayawati also said to ensure the defeat of Samajwadi Party candidates in future MLC elections, her party will even vote for BJP or any other party's nominee.

The former Uttar Pradesh chief minister said as soon as the rebel MLAs join any party, the BSP would take action against them under the anti-defection law. She also said the party organisation has been informed that the suspended legislators should not be invited to any BSP function.

Those suspended are Chaudhary Aslam Ali, Hakim Lal Bind, Mohammad Mujtaba Siddiqui, Aslam Raini, Sushma Patel, Hargovind Bhargava and Bandana Singh, according to a party statement. She said the suspended lawmakers would not be fielded by the BSP in any future election. People from the castes and religion of the suspended MLAs would be fielded against them. BSP would continue to nurture people from the castes. communities and religions the suspended MLAs represented, Mayawati said.

"Their communities would not be punished for their deeds. Mayawati said her party would leave no stone unturned to defeat SP candidates in the future even if it meant voting for candidates of the BJP or any other party.

Any candidate who dominates over the Samajwadi Party's second candidate will get BSP MLAs vote, she said in a statement. In a jolt to the BSP on Wednesday, six party MLAs reportedly met Samajwadi Party chief Akhilesh Yadav and later threw hints that they may switch sides.

Four of the group of rebels also filed an affidavit, saying their signatures on the party candidate Gautam's nomination for the Rajya Sabha polls had been "forged".

The move turned out to be futile with the Returning Officer still accepting Gautam's nomination as the Bahujan Samaj Party candidate for the November 9 biennial elections for the 10 Uttar Pradesh seats that are falling vacant. Mayawati claimed that when

the Samajwadi Party fielded its senior leader Ram Gopal Yaday, BSP general secretary Satish Misra tried to contact SP chief Akhilesh Yadav over phone but failed. He later contacted Ram Gopal Yaday who said the SP would not field another candidate.



bench overruled two previous Supreme Court verdicts to hold that the statements of accused recorded under Section 67 of the Narcotic Drugs and Psychotropic Substances (NDPS) Act cannot be used as a confession during the The majority judgment by

Justices Rohinton F. Nariman and Navin Sinha said: "The officers who are invested with powers under Section 53 of the NDPS Act are 'police officers' within the meaning of Section 25 of the Evidence Act, as a result of which any confessional statement made to them would be barred under the provisions of Section 25 of the Evidence Act, and cannot be taken into account in order to convict an accused under the NDPS Act.

Justice Indira Banerjee, the third judge on the bench, dissented with the majority view. The top court noted that if confessional statement made before an officer were to be treated as evidence, then it would be a direct infringement of the constitutional guarantees contained in Articles 14, 20(3) and 21 of the Constitution. Citing the previous two verdicts. the top court said both these judgments do not state the law correctly, and are thus overruled. "Other judgments that expressly refer to and rely upon these judgments, or upon the principles laid down by these judgments, also stand overruled for the reasons given by us," it said.

### India files protest with Saudi for wrong map on banknote

New Delhi, Oct 29: India has conveyed its serious concern to Saudi Arabia over "gross misrepresentation" of its external territorial boundaries in a banknote issued by the Gulf nation last week, and asked it to take "urgent corrective steps". the Ministry of External Affairs (MEA) said Thursday. The global map printed on the

new 20 Rival banknote, released to mark Saudi Arabia's presidency of the G20 grouping, does not feature Jammu and Kashmir and Ladakh as part of India.

MEA Spokesperson Anurag Srivastava said India has asked Saudi Arabia to take "urgent corrective steps" in the matter, and asserted that the entire Union Territories of Jammu and Kashmir and Ladakh are integral parts of the country.

"We have seen the banknote referred by you which gives an

incorrect depiction of India's external territorial boundaries. The note was issued by Saudi Arabian Monetary Authority on October 24 to mark the occasion of Saudi presidency of the G20," Srivastava said.

"We have conveyed our serious concern to Saudi Arabia, both through their Ambassador in New Delhi as well as in Riyadh, for this gross misrepresentation of India's external territorial boundaries on an official and legal banknote of Saudi Arabia and asked the Saudi side to take urgent corrective steps in this re-

gard," he said. Srivastava said, "I would like to reiterate that the entire Union Territories of Jammu and Kashmir and Ladakh are integral parts of India. According to reports, the map does not even depict Pakistanoccupied-Kashmir including Gilgit-Baltistan as part of Pakistani territory.

# SC seeks govt reply on plea on COVID drugs

New Delhi, Oct 29: The Supreme Court Thursday sought the Centre's reply on a plea alleging that two medicines Remdesivir and Favipiravir. are being used for treatment of COVID-19 without approval.

A bench headed by Chief Justice S A Bobde issued notice to the Centre on the plea and sought its response in four weeks. Advocate ML Sharma petitioner in-person referred to the bench, also comprising Justices A Bopanna and

Ramasubramanian, the World Health Organization (WHO) report of October 15 and said that nowhere these medicines are designated officially as medicines for coronavirus. The bench said it is only going to

make the central government aware of it and therefore issuing notice. On September 16, the top court had said that there was an approval by the central government on use of



Remdesivir and Favipiravir, as medicines to treat COVID-19.

The top court was hearing a plea seeking registration of an FIR by the CBI against ten Indian pharmaceutical firms for manufacturing and selling these two medicines for treating COVID-19 patients allegedly without valid licences. Remdesivir and Favipiravir are antiviral drugs and their efficacy in treating COVID-19 patients has been a matter of debate among

On September 16, the top court had referred to the New Drugs and Clinical Trials Rules, 2018 and said these medicines have been permitted by the government for using in treatment of novel coronavirus patients. Seeking CBI probe, Sharma had filed the PIL alleging that these two medicines have been wrongly manufactured and sold for treating COVID-19 patients without any valid licences from the Central Drugs Standard Control Organisation.

Sharma has sought prosecution of the Indian companies for offences of cheating and criminal conspiracy besides under the provisions of the Drug Act, 1940. The PIL said that these medicines have not been certified as medicines for COVID-19 till date by any country.

"Thev are under trial and no country, including India, has is sued licence to manufacture and sell them in the country...," it said.

### Pune varsity apologises after question on 'jihad' creeps in exams



Pune (Maharashtra), Oct 29: The Savitribai Phule Pune University (SPPU) authorities late on Wednesday tendered an apology after bizarre questions on 'jihad' terror crept in the online papers of TYBA and TYBCom examinations, officials said here Thursday.

The question in both Marathi-English figured in the multiple-choice options of TYBA Modern World History paper and TYBCom. Defence Budgeting paper, stumping the students.

The TYBA question reads: "Jihad is an example of what type of terrorism?" with options "Religious,

Revolutionary, Political, State-Sponsored".

The TYBCom question said: "Which one of the following is the main cause of Jihadi terrorism?" with the choices "Globalisation, Spread of Communism, Armament Proliferation, Use of violence in the name of Islamic radicalism".

Both questions stumped students and many immediately brought it to the varsity authorities and even took to social media. One such student Hashim Ansari said that though there is a topic on terrorism in the Modern World History subject, there is nothing pertaining to the manner in which the question was framed in the TYBA exam,

and others questioned the relevance of the question for the TYBCom exams.

Despite repeated attempts, SPPU Vice-Chancellor Dr. Nitin R. Karmalkar and Registrar Prafull Pawar were not available for comments. Following a furore, the varsity issued a statement admitting that a "wrong word" had inadvertently crept into the question paper.

'The administration expresses its regret for the same. The person heading the committee, which prepared the question paper, has been asked to give an explanation for the same and the persons concerned have been reprimanded," according to the statement. Ansari and others said that even the SPPU's apology is half-hearted since it has not clarified on the word 'Jihadi' in the mischievously framed questions with "leading" multiple options aimed at a particular religion.

'We are demanding that the university must issue a proper apology, take strong action against those responsible for this mischief in a timebound manner, and refrain from targeting the students who raised the issue," Ansari said. Subsequently, the SPPU authorities claimed that even after the apology, some 'doctored images' were being circulated on the socialmedia for which separate action is being initiated.

# Nitish's twin challenge

Islampur/Patna, Oct 29: It's a twin challenge for Chief Minister Nitish Kumar -- retaining power in Bihar and keeping his party's top position within the ruling alliance -- but a sense of uneasiness seems to be creeping in, including in his home district Nalanda.

While trying to keep the crowd engaged till the chief minister arrives for his election rally, one after another speaker has a common urge for the party's traditional support base of Dalits and extremely backwards that they should not get "misled" by the opposition and keep their faith in Kumar.

Their plea underscores the task  $\,$ before the ruling JD(U) -- that is to rally its traditional base of voters around Kumar in his twin fight. The EBCs, which comprise of numerous small castes, account for around 28-30 per cent of the state's population, and the Nitish Kumar government has wooed them over the years with various initiatives.

Though they are not as politically active as some other castes, a section of EBCs has traditionally

backed the JD(U), while so has been the case with 'Mahadalits' -- a term for scheduled castes except for Paswans, who make up for around one-third of Dalits in the state.

Political watchers believe there is an erosion in the support of upper castes for the JD(U), though they remain strongly behind its ally BJP, and its task has become all the more difficult in several seats due to Chirag Paswan-led Lok Janshakti Party putting up its candidates against Kumar's party across the

Organisationally never as strong as the BJP or the RJD, the JD(U) has relied on the "sushashan babu" image of Kumar to power its politics, and it is this mojo of the chief minister, which has dimmed now critics say."Nitish ji to kaam kiye hain. Lekin abhi badlaav ka hawa hai (Nitish has worked but there is a buzz of change," Ranjan Ram says in a typical local accent.

Asked if he will vote for change, he says he has not decided yet. "He has built roads and given us electricity. But we need roti (employment) too. Why no new industry has come to Bihar?" asks Akash Kumar, a first-year undergraduate

Higher education is in such a sorry state that his Part-I examination has not been held even in more than two years, he says. What good is all this talk of good governance when even Patna suffered so much of flood in 2019, his friend Amarendra Singh says.

# SC stays CBI probe against Rawat FRESH VIOLENCE

New Delhi, Oct 29: The Supreme Court Thursday stayed the Uttarakhand High Court's "drastic order" for a CBI probe into corruption allegations against Chief Minister Trivendra Singh Rawat, saying it was passed without hearing him and taking "everybody by surprise".

The corruption allegations levelled by two journalists pertained to the money transferred allegedly into the accounts of relatives of Rawat in 2016 to support appointment of a person as head of 'Gau Seva Ayog' of Jharkhand when Rawat was the in-charge of Jharkhand BJP unit.

A bench headed by Justice Ashok Bhushan said the "drastic order" passed by the high court without hearing the Chief Minister has taken "everybody by surprise" as there was no prayer in the plea by the scribes to lodge an FIR against

and all of a sudden, an FIR was ordered and such a drastic order was passed taking everybody by surprise," said the bench, also comprising Justices R S Reddy and M

Attorney General K K Venugopal, appearing for Rawat, said that an FIR cannot be lodged without hearing the party who is the Chief Minister and this would "unsettle the elected government". "An elected government cannot be unsettled like this. The question is can a suo motu order be passed without hearing the party," Venugopal said.

"A demand for resignation of the chief minister has already been made and the order has been passed without hearing the CM," he added. Venugopal told the bench that the high court has "mixed up all grounds".

'The person against whom FIR is registered is bound to be heard especially in case of a person who holds a public office," he said. "The

high court passed the order disregarding the fact that this order may destabilise an elected government, he said.

"The high court is entirety wrong on law when it says that it can direct lodging of an FIR without hearing the party and the high court cannot be oblivious that it will result unsettling of the government," he said. Senior advocate Kapil Sibal appearing for the two scribes, said that he was not opposing the stay order but there was ample evidence in support of corruption allega-

tion against Rawat.

The apex court, while staying the high court order for CBI probe against Rawat, issued notices to the state and the two scribes Umesh Sharma and Shiv Prasad Semwal. "Issue notice. Counter affidavit be filed in four weeks," the bench said.

The apex court, however, has not stayed the part of the high court order by which it had quashed the FIR lodged against the two scribes in July this year under various provisions of the IPC relating to sedition, cheating, forgery and criminal conspiracy.

Patna/Munger, Oct 29: The Election Commission has removed the District Magistrate and the Superintendent of Police of Munger over the violence during a Durga Puia event early this week, even as a group of protesters went on the rampage in the town Thursday, setting some police stations and outposts on fire and ransacking the SP office.

The poll panel Thursday also ordered an inquiry into the firing and stone-pelting during the immersion of an idol of goddess Durga late Monday night in which one person had died and several others were injured. The election commission has asked Magadh Divisional Commissioner Asangba Chuba Ao to complete the probe within a week.

Rajesh Meena is District Magistrate and Lipi Singh is SP of Munger. The EC statement said Munger will get a new DM and a Superintendent of Police Thursday itself. Alleging that no action was taken against the SP and other police personnel over the Monday night incident, the agitators allegedly torched muffasil and women

police stations in the town. They also allegedly set police outposts at Purab Sarai and Basudeopur on fire, and ransacked the SP office and several other police stations and outposts. The office of Sub Divisional Officer (SDO) was also allegedly targeted by the

Witnesses said that finding themselves outnumbered, the police personnel at all these stations escaped from the premises. Official sources said the agitators went berserk and also tried to set kotwali and

Kasim bazar police stations on fire,

but there they faced a strong re-

sistance from the policemen who

fired in the air to disperse the mob.

They burnt tyres near Rajiv Chowk in the Munger town, demanding action against the SP and the police personnel responsible for allegedly opening fire during the idol immersion procession. Additional Director General of Police (Headquarters) Jitendra Kumar told PTI-Bhasha in Patna that extra police force has been

sent to Munger. Deputy Inspector General of Police, Munger, Manu Maharaj led a flag march in Munger town to bring the situation under control. The RJD-helmed Grand Alliance has strongly criticised the Monday incident, likening the district police with General Dver of infamous Jallianwala Bagh incident in Punjab during British rule on April 13, 1919. IPS officer Lipi Singh is the daughter of RCP Singh, the JD(U) leader in the Rajya Sabha.

Coming on the eve of the first phase of polling, the incident had its impact voting too as two of the three Assembly seats -- Munger, Jamalpur -- in the district witnessed lower voter turnout as compared to the 2015 polls.

### DELHI RECORDS LOWEST OCT TEMPERATURE IN 26 YEARS

New Delhi, Oct 29: The national capital recorded a minimum temperature of 12.5 degrees Celsius on Thursday, the lowest in October in 26 years, according to the India Meteorological Department.

The normal minimum temperature for this time of the year is 15 to 16 degrees Celsius, it said. Kuldeep Srivastava, the head of the regional forecasting centre of IMD, said the last time Delhi recorded such a low temperature in October was in 1994.

The national capital had recorded a minimum of 12.3 degrees Celsius on October 31, 1994, according to IMD data. The city recorded the all-time lowest temperature (9.4 degrees Celsius) on October 31, 1937, Srivastava said.



The senior IMD scientist said the absence of cloud cover was the major reason for such low minimum temperatures this time. Clouds trap some of the outgoing infrared radiation and radiate it back down-

ward, warming the ground. Another reason is calm winds which allow formation of mist and fog, Srivastava said. The minimum temperature is likely to dip to 11 degrees Celsius by

November 1, the IMD added.

# Two out of five Srinagar residents have COVID antibodies

Srinagar, Oct 29: Over 40 per cent people living in Srinagar district have developed COVID-19 antibodies, claims a latest sero-prevalence survey conducted by a government hospital here, the results of which were questioned by the district administration citing small sample size of the study.

The results of the study conducted by the Government Medical College Srinagar (GMC) show a quantum jump from 3.8 per cent sero-prevalence recorded in a similar study conducted in the city in June, and suggests that a large fraction of the population in the summer capital of Jammu and Kashmir may have been infected by the novel

Giving details, the official said that earlier Srinagar had witnessed 18 per cent of positivity rate for COVID-19 when the testing capacity was around 60,000."However, when test-

ing capacity was increased to 4 Lakh, the rate of positive patients in Srinagar was only 18,000," the official said.

The official noted that the survey results could be misconstrued, and can lead to complacency among the people."The trend is encouraging but there is no way we can say that COVID-19 will be defeated at a certain level of population by developing the antibodies. The scientific community is also wary of using the term herd immunity in the absence of a vaccine," he added.


Herd immunity occurs when a large number of people, usually 70 to 90 per cent, become immune to a contagious disease after being infected by it. But there are many grey areas clouding the issue as

far as the novel coronavirus is concerned with no consensus on when herd immunity sets in.

Srinagar has been the worst affected district by COVID-19 in Jammu and Kashmir with nearly 19,000 persons infected so far and 348 deaths due to the pandemic. The district has 1,651 active cases as compared to 5,300 in the remaining 19 districts of the union territory.

Khan said a wider sero-survey is underway across the remaining nine districts of Kashmir valley where 400 samples have been collected from each district. "The results are expected to come within two weeks from now," he added. Jammu and Kashmir has witnessed nearly 85.000 COVID infections and 1.455 deaths so far due to the pandemic.

#### Typhoon, landslides leave 35 dead

Hanoi: Typhoon Molave set off landslides that killed at least 19 people and left 45 missing in central Vietnam, where ferocious wind and rain blew away roofs and knocked out power in a region of 1.7 million residents, state media said Thursday. The casualties from the landslides bring the over-all death toll from the storm to at least 35, including 12 fishermen whose boats sank Wednesday as the typhoon approached with winds of up to 150 kilometers (93 miles) per hour. Vietnamese officials say it's the worst typhoon to hit the country in 20 years.

Islamabad, Oct 29: In a sensational admission, a senior Pakistani minister Thursday admitted that Pakistan was responsible for the Pulwama terrorist attack in Jammu and Kashmir in 2019 that killed 40 CRPF personnel and brought the two countries to the brink of a war.

"Humne Hindustan ko ghus ke maara (We hit India in their home). Our success in Pulwama, is a success of this nation under the leadership of Imran Khan. You and we are all part of that success," Science & Technology Minister Fawad Chaudhry said in the National Assembly during a debate.

When some of his fellow lawmakers objected to his mention of "success in Pulwama", the minister said that "after the Pulwama incident, the way Pakistan went inside the Indian territory to target it, the entire media in India was ashamed of it."

However, he didn't retract his statement about "success in Pulwama" under Prime Minister Khan's leadership.

Chaudhry, a close aide of Prime Minister Khan, made the remarks a day after Opposition Pakistan Muslim League-Nawaz (PML-N) leader Ayaz Sadiq said that Foreign Minister Shah Mahmood Qureshi in an important meeting pleaded to

### **Imran acquitted in Parliament** House attack case

avirus infections are rising by an estimated 96,000 cases daily across England, according to the findings of a new government-backed study released in London Thursday.

An interim report led by Imperial College London and Ipsos MORI, which includes swab tests on thousands of people taken between October 16 and 25, shows that the prevalence of infection has more than doubled since the last round of similar testing.

This means an estimated 128 people per 10.000 of England's population has the virus that causes COVID-19, compared to 60 as of October 5. "These interim findings paint a concerning picture of the situation in England, where we're seeing a nation-wide increase in infection prevalence, which we know will lead to more hospitalisations and loss of life," said Professor Paul Elliott, director of the programme

Face mask can kill nCoV

Boston, Oct 29: Scientists at MIT have designed a novel face mask that can not only filter out the SARS-CoV-2 virus, which causes COVID-19, but also inactivate it using heat

The new mask incorporates a heated copper mesh and does not need to be decontaminated or

thrown away after use, according to the researchers As the person wear-

ing the mask breathes in and out, air flows repeatedly across the mesh, and any viral particles in the air images courtesy are slowed and inac- of the researchers

tivated by the mesh @ MIT and high temperatures, the researchers said.

Such a mask could be useful for healthcare professionals, as well as members of the public in situations where social distancing

would be difficult to achieve, such as a crowded bus, they said. "This is a completely new mask concept in that it doesn't primarily block the virus. It actually lets the virus go through the mask, but slows and inactivates it," said Michael Strano, a professor at Massachusetts Institute of Technology (MIT) in the US.

> The researchers have begun building prototypes and hope to begin testing them soon. The new design has been described in a paper posted on online preprint server ArXiv, and submitted to a peer-reviewed journal.

> "The masks that we wear now are designed to capture some of the virus.

They do offer protection, but there's no one really thinking about inactivating the virus and sterilising the air. That surprised me," Strano said.

Tith just less than a week for the finale to the US presidential election scheduled for November 3, flurry of hectic political campaigning through electronic, print and social media, including rallies, is going on in both Republican and Democrats' camps at a much rapid pace. Both Republican Party, also known as GOP (Grand Old Party) and Democratic Party have strained every nerve to attract voters through hectic campaigning by convincing them about their respective agenda to garner electorates' support. The incumbent Republican nominee is President Donald Trump who is seeking reelection and Joe Biden is the presidential nominee of the Democratic Party and the challenger.

#### **VOTERS' PROFILE**

According to US Census Bureau, as of July 2019, total population of the US stood at around more than 328 million; and of these White Americans are the racial majority accounting for 76.3%. Hispanic and Latino Americans are the largest ethnic minority, comprising an estimated 18% of the population. African Americans are the second largest racial minority, constituting an estimated 13.4% of the population. There were approximately 4.16 million people of Indian descent in the US in 2018, with 2.62 million of them being US citizens. Out of them, 1.9 million citizens are eligible to vote in the upcoming election - 0.82% of all eligible voters in

#### **ELECTION ISSUES** In August 2020, Washington-based

Pew Research Center conducted a survey of registered American voters to ascertain important issues in the 2020 Presidential Elections and according to the response and percentage following issues emerged: economy (79%), healthcare (68%), Supreme Court appointments (64%), COVID-19 pandemic (62%), violent crime (59%), foreign policy (57%), gun policy (55%), race and ethnic inequality (52%), immigration (52%), economic inequality (49%), climate change (42%), and abortion (40%). As per US media reports, in the final debate between Donald Trump and Joe Biden, the debate veered round following issues - fighting COVID-19, American families, race in America, climate change, national security and leadership.

#### **MAIL-IN VOTING**

Mail-in voting, also known as ab-



sentee voting or postal ballot, has been in vogue in the United States for a long time. Approximately 240 million American citizens are eligible to vote this year. The US has centuries-long history of voting by mail. In the 17th century Massachusetts, people could vote from home if their homes were 'vulnerable to Indian attack. Nevertheless, it was during the Civil Way that America first experimented with absentee voting on a bigger scale, and during the 1864 presidential election, Union soldiers were allowed to vote in camps and hospitals, under the supervision

of clerks or state officials. The absentee voting mechanism was permitted during the First World War for soldiers. In the subsequent period, the people who voted by mail often had to have a specific reason for not being able to vote in person on election day; and this situation underwent a change in 1978, when California became the first State in the US to allow voters to apply for an absentee ballot without having to provide any reason or excuse. In the State of Oregon, the first entirely mail-in federal primary elections occurred and in 1996, the first mail-only general election took

place, and at present it is said to be an all vote-by-mail state. Interestingly, prior to the outbreak of Covid-19, five states - Colorado. Hawaii, Oregon, Washington and Utah - were already conducting entirely mail-in elections. As per American media reports, 29 states and Washington D.C. permitted 'no excuse' mail in absentee voting, and 16 states allowed voters to cast a ballot by mail if they had an excuse. Interestingly, in the 2016 presidential election, about 25% voters are said to have cast their votes via ballots mailed to them. In present times of COVID-19 that are characterised by uncertainties, election officials this author came across in Washington have opined that American electorate can rely on vote-by-mail mechanism being 'safe and secure.

#### **TOWARDS THE FINALE**

Undeniably, national polls are a good guide as to ascertain as to how popular a candidate is across the entire country; nonetheless, they're not essentially a reliable criterion to predict the result of the election. In 2016, for example, Hillary Clinton led in the polls and won nearly three million more votes than Donald Trump, but she still lost - that's because there exists an electoral college system that indicates that winning the most votes doesn't always win you the election. People in the US vote for the persons called 'electors' in their state who are supporting the candidates they want to be in the Oval Office, and this process is called the Electoral College. The more populous a state, the more 'electors' there are for that state. For instance, California, with a population of 38.8 million, has 55 votes whereas Delaware, having a population nearly a million people has just three votes. Presently, there are 538 electors in the Electoral College, corresponding to the 435 Representatives, both congressmen and congresswomen, and 100 senators, along with the three additional electors from the District of Columbia. Election experts in Washington have apprised this author that the candidate with the most electors wins all the state's electoral co'leges' votes and the first candidate securing 270 electoral votes is elected to the office of President of the United States of America.

New Delhi, Oct 29: The government's fiscal deficit rose to ₹9.14 lakh crore, about 114.8 per cent of the annual budget estimate, during the first six months of the current financial year, mainly on account of poor revenue realisation.

The revenue realisation during the current fiscal suffered on account of the lockdown imposed by the government to check the spread of coronavirus pandemic.

In absolute  $\rm \bar{t}erms$  , the deficit was ₹9,13,993 crore, as per the data released by the Controller General of Accounts (CGA).

The deficit at the end of the first six months of the previous financial year was 92.6 per cent of the an-

The fiscal deficit or gap between the expenditure and revenue had breached the annual target in July this year.

The government received ₹5,65,417 crore (25.18 per cent of BE 2020-21 of total receipts) up to September, the CGA data said. The receipts were 40.2 per cent of the target a year ago.

Of the total receipts, ₹4,58,508

crore was tax revenue (Net to Centre), ₹92,274 crore was non-tax revenue and ₹14,635 crore non-debt capital receipts. Non-debt capital receipts consists of recovery of loans (₹8,854 crore) and disinvestment proceeds (Rs 5,781 crore).

₹2,59,941 crore has been transferred to state governments as devolution of share of taxes by Government of India up to this period, which is ₹51,277 crore lower than the previous year, the finance ministry said in a release.

As per the CGA data, the total ex-

penditure incurred by the government was ₹14,79,410 crore (48.63 per cent of BE 2020-21), out of which ₹13,13,574 crore was on revenue account and ₹1,65,836 crore on capital account.

Out of the total revenue expenditure, ₹3,05,652 crore was on account of interest payments and ₹1,56,210 crore towards major subsidies. During the same period of the last fiscal, the total expenditure was 53.4 per cent of the annual target. The government had pegged the fiscal deficit for 2020-21 at ₹7.96 lakh crore or 3.5 per cent of the GDP in the Budget, presented by Finance Minister Nirmala Sitharaman in February. These figures, however, may have to be revised significantly, in view of the economic disruptions created by the outbreak of

# Govt extends fare limit till February

New Delhi, Oct 29: The civil aviation minister Hardeep Singh Puri Thursday extended the cap on domestic airfares till 24 February. In the wake of coronavirus outbreak, the aviation ministry implemented a cap on domestic airfare till 24 November.

India started operating domestic flights after a gap of two months in the last week of May. The domestic flights in India have a cap on fares with both an upper and lower limit. Flights between cities that are under 40 minutes have been classified under section one, while those under 40-60 minutes are under section two. Section three consists of destinations 60-90 minutes apart by flight, section four comprises cities 90-120 minutes apart, section five consists of cities 120-

150 minutes apart. Destinations between 150-180 minutes and 180-210 minutes have been classified under sections 6

and 7, respectively.

The base minimum airfare of domestic flights ranges from ₹2,000 to ₹6,500 and the maximum range from ₹6,000 to ₹18,600. Airlines have to make available 40% of total seats in an aircraft at less than the midpoint price between the highest and lowest fares, aviation secretary Pradeep Singh Kharola earlier said. Puri earlier said the move will mean that the lowest fare between Delhi and Mumbai will be capped at ₹3,500 and ₹10,000 at the higher end.

While the upper price limit is aimed at preventing any sharp rise in fares due to pent-up demand, the lower limit will help ensure that financial viability of airlines does not suffer amid high costs. Puri said.

### Global gold demand dips 19 pc in Sep quarter

Mumbai: Global gold demand declined by 19 per cent during the July-September quarter to 892.3 tonnes, the lowest quarterly total since Q3 of



2009, due to coronavirus-induced disruption, World Gold Council (WGC) said in a report. The total global demand during July-September 2019, stood at 1,100.2 tonnes, according to WGC's Q3 Gold Demand Trends' report. Though the overall demand declined during the third quarter of this year, there was a significant growth in investment demand, the report said. The overall investment demand grew

by 21 per cent at 494.6 tonnes as investors globally bought 222.1 tonnes of gold bars and coins and an additional 272.5 tonnes through gold-backed ETFs (electronically traded funds). Gold ETFs have increased their holdings by a record 1,003.3 tonnes, it added.

The SP Group, one of India's largest construction firms, has an 18 per cent stake in Tata Sons, but the two groups have been embroiled in a legal battle since 2016 when Cyrus Mistry, scion of the family that



controls the SP Group, was sacked as chairman of Tata Sons.

The SP Group said in the statement that, as a non-cash settlement, it should get pro-rata shares in listed entities of the Tata Group where Tata Sons currently owns stake. "For example, 72% of Tata Consultancy Services Ltd. (TCS) is owned by Tata Sons and SP Group's ownership of 18.37 per cent translates to 13.22% per cent shareholding of TCS (valued at ₹1.35.000 crore at present market capitalisation of TCS)," the Group said in

# Higher rural demand unlikely to offset urban plunge

AGRICULTURAL ACTIVITIES HAVE NOT BEEN HIT VERY BADLY, RAISING HOPE THAT RURAL DEMAND MAY DRIVE THE RECOVERY, WHICH IS OVER-OPTIMISTIC, SAYS A REPORT

Mumbai, Oct 29: The 270 basis points (bps) likely incremental growth in agricultural gross value add (GVA) to 17.3 per cent of the economy this year and the resultant spike in rural demand may not compensate for the massive plunge in urban demand, warns a report.

However, an India Ratings analysis of the agri GVA performance of the states says the six states that accounted for nearly 33 per cent of the farm GVA will see a spurt in

overall demand. In spite of the pandemic and the ensuing lockdowns, agricultural activities have not been hit very badly, raising hope that rural demand may drive the recovery, which is over-optimistic, says the report.

We believe rural demand will perk-up somewhat, but will not be able to offset the shortfall in urban demand because the share of agriculture in GVA of the economy has ranged between 14.6 per cent and 17.8 per cent during FY13-FY20 and is expected to be 17.3 per cent in FY21, up from 14.6 per cent in FY20,' warns the report.

Furthermore, ``the contribution"of agriculture to GVA growth has ranged between 4.8 per cent and 11.2 per cent during FY13-FY20 and is expected to increase to only 14.4 per cent in FY21, up from 8.6 per cent in FY20, despite the pandemic-induced contraction in the industrial




and services sectors," the report stated and added that on the negative side the rural wages have been on a steady decline for many years now. But Andhra Pradesh. Madhva Pradesh, Rajasthan, Uttar Pradesh,

Punjab and West Bengal stand to benefit and see higher rural spend as the share of their agriculture in GSVA and its contribution to GSVA growth is higher as these six states contributed 32.7 per cent

to real GVA in FY20.

According to the first advance estimates of Union agri ministry late last month, Kharif food grains production in FY2021 is estimated at 144.52 mt, up from 143.38 mt in FY2020, up only 1.14 mt.

Since the largest chunk of rural population consists of daily wage earners and not farmers, a peep into the rural wages is as vital as the agricultural income to understand the rural demand. And this suggests that rural wages have been under pressure and declined substantially both in nominal and real terms during FY16-FY20. Thus, FY21 may not result in very higher income either for farmers or wage earners than previous years.





"So CSK saying they are going to continue with MS-it is just the relationship, it is just the mutual respect. That's why MS has been so loyal (to the Super Kings). That's why MS has given everything: heart and soul, his sweat, sleepless nights - I'm sure he must have had sleepless nights while he has continued captaining CSK.

Earlier, the CSK management has said that Dhoni would be retained at the next mega auction, which is likely to be held in 2022.

#### **Kean hits brace**

Istanbul: New signing Moise Kean scored twice as Paris Saint-Germain beat Basaksehir 2-0 in the Champions League but lost Neymar to an injury. Kean grabbed his goals in the 64th and 79th minutes as PSG weathered some strong attacks to get back on track after losing their opening game at home to Manchester United. Champions League newcomer Basaksehir sustained a second defeat after losing to Leipzig. Neymar limped off with an apparent thigh injury after 26 minutes and was replaced by winger Pablo Sarabia.

#### **Dortmund victorious**

**Dortmund:** Borussia Dortmund needed a 78th-minute penalty from Jadon Sancho and a stoppage-time goal from Erling Haaland to beat visitors Zenit St Petersburg 2-0 in their Champions League Group F match Wednesday. The Germans, who lost their opener to Lazio, controlled the game from the start but carved out few chances before Vvacheslav Karavaev inexplicably wrestled Thorgan Hazard to the ground for Sancho to score from the spot. Haaland added a second in stoppage time with a powerful run.

### Jayaram, Dey forced out of SaarLorLux Open meet

Saarbrucken (Germany), Oct 29: Indian shuttlers Ajay Jayaram and Shubhankar Dey were Thursday forced out of the SaarLorLux Open after being put in isolation owing to contact with COVID positive father-cum-coach of defending champion Lakshya Sen, who has already withdrawn.

The 19-year-old Lakshya withdrew Wednesday after his father DK Sen returned a positive test for the dreaded virus. DK Sen is asymptomatic at this point.

"BWF can confirm three players have been withdrawn from the tournament as a precautionary measure for all participants after they were in contact with a member of their team entourage who tested positive for COVID-19," the Badminton World Federation said in a statement.

Later, Jayaram, in a Twitter post tagging sports minister Kiren Rijiju, the national badminton federation and BWF, said that he and Dey would like to return to India as the organisers have not given them any information or assistance apart from asking them to isolate.

"Owing to one of the players

failing to follow the COVID protocol and the organisers failing to enforce the protocols set in place, I and Shubhankar have found ourselves in an unfortunate situation...," he wrote without specifying the lapse on part the player concerned and the organisers. "We have currently been asked

to isolate with absolutely no other information from the organisers including our meals. We have our COVID negative certificates, and have NO symptoms. We are unable to contact the local authorities. We would like to know if it is possible for us to get tested here again and come back to India," he added.

Dey also demanded compensation for the ordeal. "Requestingauthorities to compensate us while also allowing us to return to India.'
