Amid 'no headway' in

de-escalation talks, soldiers freeze at -20°C

AGENCIES

New Delhi, Nov 7: The military talks between India and China at Chushul in Eastern Ladakh to resolve the border dispute and de-escalation of forces ended in stalemate. The soldiers of both the countries continue to remain exposed to minus 20 degrees Celsius.

'There was no headway during the talks as China was not ready to withdraw from the disputed position. We had made it clear there is no going back an inch," said a government source.

The eight Corps Commander level talks between both the countries began at 9:30 am and ended at 7 pm Friday. It was for the first time that Lieutenant General PGK Menon led the Indian military delegates.

Earlier, he had attended two such rounds of talks but the delegation was led by then Lieutenant

General Harinder Singh who was transferred last month to the Indian Military

from the Ministry of External Affairs Navin Srivastava was also part of the delegation.

"We have firmly

stated to China that disengagement will happen at all friction points and not at the selected locations as they want. Our stand is clear," the source said

While talks were on, Chief of Defence Staff General Bipin Rawat Friday claimed that situation at Line of Actual Control remains to be tense and war with China cannot be ruled out.

He said: "In the overall security calculus, border confrontations, transgressions, unprovoked tactical military actions spiralling into a larger conflict therefore cannot be discounted.'

New Delhi, Nov 7: Several exit polls Saturday gave the RJD-led Opposition alliance in Bihar an edge over the ruling NDA while at least three of them predicted a clear majority for the 'Mahagathbandhan' which has projected Tejashwi Yadav as its Chief Ministerial face.

Most of the exit polls also predicted RJD to again emerge as the single largest party in the 243-member Assembly along with a clear dip in the seat tally of Bihar Chief Minister Nitish Kumar-led JD(U). Counting of votes for the three-phase Bihar Assembly polls, which ended Saturday, will be held November 10. Exit polls are typically based on feedback from a limited number of voters in select areas and none of them have a 100 per cent accuracy record. Today's Chanakya-CNN News18 projected 180 seats for the RJD-led Grand Alliance, 55 for the NDA and eight for others. The majority mark is 122. India Today-Axis My India poll showed the RJDled block winning 139-161 seats, as against 69-91 for the NDA. It predicted 3-5 seats for LJP and also 3-5 for others.

MAHANADI WATER DISPUTE

Odisha to Tribunal: Pass order in interim application

New Delhi, Nov 7: Odisha Saturday pleaded the Mahanadi Water Dispute Tribunal to pass order on merit in the interim application filed by the state. The government of Odisha sought directions to Chhattisgarh to maintain1.74 million acre feet flow of Mahanadi water during non-monsoon months, starting from November to May. The Tribunal posted the matter for hearing December 5.

During the hearing, senior advocate Mukul Rohatgi appeared for Odisha and pleaded the Tribunal to pass order in the interim application filed by the state. Rohatgi apprised the Tribunal that both states, Odisha and Chhattisgarh, could not arrive on amicable settlement as directed by the Tribunal earlier. Rohatgi also argued that the Tribunal can hold hearing on the interim application in December to record arguments again as the matter is two years old.

A three-judge bench of the Tribunal headed by Chairperson Justice AM Khanwilkarand comprising Justices Ravi Ranjan and Indermeet Kaur also asked both states to frame a specific timeline for early disposal of the main petition in Mahanadi water dispute and apprised the Tribunal on next hearing of the case. Tribunal affirmed that it does not want to drag the matter for a longer period and want to fast track it.

State of Odisha also raised concerns with regard to preparation of common format. Senior advocate Mohan Katarki argued in the Tribunal that the assessor has done good job in preparation of common format but Odisha has

some concerns. Katarki requested the tribunal to conduct Dam Break Analysis of barrages constructed in Chhattisgarh. The senior advocate said that it is important to know whether the barrages are constructed after a proper study. He further argued that if in case the barrages break down they may have huge impact on Hirakud dam and can create chaos in the state.

In response, the Tribunal said that the assessor will consider conducting the Dam Break Analysis and if Chhattisgarh disagreed with the demand of Odisha, then the state can file an application in the Tribunal for the

same Significantly, the Dam Break Analysis involves the field data collection and computer simulation to evaluate the dam failure and the impact of dam break to downstream area.

It is to be mentioned here that Odisha, in 2018, filed an interim application in the Mahanadi Tribunal seeking directions to Chhattisgarh to maintain 1.74 million acre feet flow of Mahanadi river water during the non-monsoon months, starting from November to May. The state had also urged the Tribunal to order stay on the operation and construction of barrages built by Chhattisgarh on Mahanadi river till the adjudication of main petition. The Tribunal completed arguments in the interim application in 2019 and reserved the judgment. The Tribunal had asked both parties to hold meetings and make mutual settlement with regard to interim application. However, despite repeated meetings, both states could not resolve

majority to the RJD-led alliance with 128 seats, while it projected 104 seats for the ruling NDA, seven seats for LJP and four for others. TV9 Bharatvarsh projected NDA to win 115 seats, the Grand Alliance 120 and four each for LJP and others.

In terms of vote share, Today's Chanakya projected 44 per cent for the RJD-led Opposition alliance and 34 per cent for the NDA.

However, ABP-CVoter projected a higher vote share for NDA at 37.7 per cent followed by the Grand Alliance with 36.3 per cent and 26 per cent for others.

India Today-Axis My India poll showed 44 per cent of respondents prefer Tejashwi Yadav as the next Chief Minister, while 35 per cent would like to give another chance to Nitish Kumar.

Is Odisha safe for human rights defenders

BETWEEN 2017 AND AUG 2020, ODISHA RANKS THIRD-WORST STATE FOR HUMAN RIGHTS ACTIVISTS

Bhubaneswar, Nov 7: The role of human rights defenders is inextricably linked to the 'democratic' quotient of a nation. While 2020 has been a tumultuous year in terms of freedom exercise, the recent NHRC numbers presented at the country's Parliament, with state-wise data, paint a grim picture for Odisha.

While one might perceive Odisha as a peaceful state with no restraint on dissenting voices, the NHRC data says otherwise.

The rights defenders often come across serious threats to their lives and harassments while trying to defend the fundamental rights of a lay person belonging to the most vulnerable sections of the society. Lately, India too has come under

severe criticism from several watchdog agencies over treatment meted out to human rights activists. But what comes a surprise is that the state picture is much similar to the national picture.

The defenders in the face of such attacks and harassments approach the National Human Rights Commission (NHRC) or the rights bodies at their respective states seeking protection as the authorities are usually found standing behind the influential oppressors.

Veteran Biju Janata Dal (BJD) leader and MP, Pinaki Mishra recently, raised the issue in the Lok Sabha and sought details regarding the state-wise receipt of complaints received by the NHRC from the activists from 2017 till August this year. The data presented by the Union

minister revealed that Odisha ranks third in connection with number of attacks on human rights activists during the last three years. Uttar Pradesh tops the list closely followed by Tamil Nadu.

G. Kishan Reddy, the minister of state for MHA, revealed that as many as 306 complaints were received by the NHRC regarding harassment of human rights defenders from 2017 till August 2020.

There were 52 complaints filed by

activists from Uttar Pradesh while 33 defenders from Tamil Nadu complained harassments before the NHRC during the period. As many as 26 complaints of harassment of human rights activists in Odisha were lodged with the NHRC between 2017 to till August 2020.

Similarly, as per information available with the Commonwealth Human Rights Initiative (CHRI), six RTI activists were murdered in the state from 2008 to till date. The Odisha Soochana Adhikar Abhivan. a forum of RTI activists, claimed that as many as 54 cases of murderous assaults on activists occurred in Odisha between 2011 and 2019.

Speaking to Orissa POST, rights activist and national core members of the NHRC, Manoj Jena said, "We have been repeatedly requesting

the government to implement Whistleblowers Act to safeguard the human rights activists. Similarly, the dedicated focal point for receiving and examining complaints about alleged violation of Human Rights of the defenders at the earliest is lying largely defunct. The rights body in the state should also create a focal point in Odisha to hear and take stringent action against persons harassing human rights activists. The human rights activists are not anti-government but the defenders of constitution."

Echoing the same sentiments, activist and advocate Biswapriya Kanungo said, "Human rights are universal and inalienable. So, if human rights are protected andpromoted for all, activists shall not be harassed.

State's Covid-19 tally crosses 3 lakh-mark

Bhubaneswar, Nov 7: Odisha's Covid-19 tally crossed the three lakh-mark Saturday as 1.372 more people tested positive for the infection, while 17 fresh fatalities pushed the state's coronavirus death toll to 1,410, a health department official said.

The fresh infections reported from all the 30 districts have taken the state's caseload to 3,00,140, he said. Of the 1,372 new cases, 796 were detected from quarantine centres while the rest were found dur ing contact tracing.

Khurda district, of which the state capital Bhubaneswar is a part, reported the maximum number of fresh cases at 145, followed by Cuttack at 121 and Nuapada at 108. the official said. Taking to Twitter, the Health and Family Welfare Department said, "Regret to inform the demise of seventeen #COVID19 positive patients while under treatment in hospitals.'

Three fresh fatalities were reported from Khurda and two each from Cuttack, Mayurbhanj, Sambalpur and Bargarh. One each died in the districts of Puri, Balasore, Koraput, Kalahandi, Kendrapara and Bhadrak

Khurda has accounted for the highest number of fatalities so far at 245, followed by Ganjam at 231 and reported 64 new Covid-19 cases in Cuttack at 118. BHUBANESWAR: The state government has amended the earlier unlock guidelines for the month of November and empowered the Collectors to take decision on the sizes of crowds for marriage functions. Earlier, the government in their unlock notification had allowed 200 guests for marriage functions by expanding the ceiling from earlier allowed crowd. However, the amendment has given the power to Collectors to monitor the crowds with the new norms. The new norms, issued Saturday said, "Provided that the respective Collector/Municipal Commissioner shall take decision regarding the number of persons to be allowed in marriage related functions (within the overall limit of 200) keeping their local situation in mind in the interest of public health and issue specific order in that regard,"

the official said. Over 48.88 lakh sample tests have been conducted for Covid-19 so far, including 50,385 Friday, he added.

NGT rules in favour of Nuahat water project

Bhubaneswar; Nov 7: The National Green Tribunal (NGT) has passed an order in favour of the state government on the Nuahat Mega Drinking Water Project. The order of the tribunal has come against a petition filed before the NGT seeking its intervention against extraction of water from the Kharasrota river for drinking water project.

The project was planned to serve drinking water in 91 saline gram panchayats in Bhadrak district. The petitioner alleged that despite the availability of other rivers, the Kharasrota river, a tributary of the river Brahmani. was used for extracting water for the project. It was alleged that this could lead to more stress on the water body and other alternatives could be seen by

the government.


It challenged the wisdom of the government on the issue. The NGT. however, based on the hearings and inspection report submitted by the government, ordered in favour of the Odisha government.

The order of the NGT said, "It would appear from the above that the concern expressed by the applicant appears to be unfounded as all relevant factors pointed out by the applicant have been taken into consideration while undertaking the project. The response to each of the queries put by the tribunal clearly indicates this fact.

It added, "We do not deem it necessary to continue further with this matter firstly, on account of the fact that the subject matter raised by the applicant is not a substantial question relating to environment that would attract provi-



sions of the NGT Act, 2010 and secondly, even in its merits, we do not find the applicant having made out any case for our interference in the light of the report of the committee reproduced. The inspection committee re-

Locals oppose land survey for ROB

Puri, Nov 7: A group of locals and shopkeepers who are likely to be displaced by a proposed rail overbridge (ROB) at Sidhhamahaveer level crossing here Friday opposed land measurement and survey for the project at Matiapada Square in the Holv City.

They pleaded for a change in the location of the proposed ROB to avoid the displacement of families from their ancestral lands. The locals claimed that more than a hundred shopkeepers would be affected by the ROB project. They urged the authorities concerned to construct the ROB on government land. The locals alleged that the land measurement and survey for the ROB project had been conducted without holding any Pallisabha.

On being informed, police reached the spot and held discus-

shopkeepers. The residents of the Pilgrim City have been demanding construction of an ROB at Siddhamahaveer level crossing on Puri-Konark National Highway for last two decades. The Centre had given its nod to the project in December 2019.

The NHAI and the district administration had initiated the process for land acquisition for the project January 16 this year. The au-

thorities had planned to acquire 2.66 acres for the 900-metre long ROB, sources said. It is learnt that at least 129 private plots at Balukhand, Kumutipatna, Matiapada and Siddhamahaveer revenue villages would come under the land required for the ROB project. "Around Rs 53 crore has been sanctioned for the proposed ROB. The final design of the project would be made after the completion of land measurement and survey work," said a source.

Land acquisition officer Prasanta Kumar Jena said the land measurement work was being conducted as per the National Highways Act-1956. "The survey is being done to fix the value of the landed properties. The value of the land would be made known to the households. They would have two months to put forth their grievances before the district administration," he added.

Millers, civil supplies dept at loggerheads

Millers demand release of Rs 30-cr dues while the dept refutes the claim; farmers fear distress sale if procurement is delayed

Bhawanipatana, Nov 7: Even as the administration has been bracing up for paddy procurement for the current Kharif season in Kalahandi, the procurement programme is caught in a stalemate over payment of dues - a dispute between the civil supplies department and rice millers.

The administration allegedly shows no interest to resolve the issue. The millers have warned of not cooperating in the paddy procurement process. Farmers in Kalahandi are apprehensive of facing distress sale if the procurement is delayed or stalled. Besides, thousands of labourers who are part of the procurement process will be hit in the event the programme is stalled.

The report said the rice collection season from millers for 2019-20 has been over, but millers have claimed that Rs 25 crore to Rs 30 crores towards transport, unloading and maintenance of paddy in godowns has not been cleared. Besides, they said they are yet to get back 7 lakh

Some millers alleged the civil supplies department is not following procurement guidelines as a result of which they have to incur losses. "There is no transparency in the function of the department,' millers lamented.

The civil supplies department used to pay Rs 22.50 per km as transport fare in 2018-19. The fee was reduced to Rs 18.50 per km in 2019-20. Owing to fare reduction, millers had to suffer the loss to the tune of Rs 6 crore.

"Even though the cost of fuel has increased several times, reducing the transport fare has made things worse for us," they pointed out.

Four gunny bags are needed for a quintal of rice. The civil supplies department is supposed to give two sacks while millers have to arrange two sacks.

Land hurdle for Nalco pipeline

Koraput, Nov 7: About 36 years have passed since Naclo was set up in Koraput. However, some projects linked to its expansion have not been able to make headway for various factors

One of its projects is water pipeline which has been facing opposition from locals.

The administration and the company are allegedly failing to sort out the issue so as to carry forward the project, a report said.

The report further said that the expansion work had been hit by intermittent protests by the land los-

People who have lost their land to the Upper Kolab hydropower project have strongly opposed its water pipe line project.

Notably, Naclo has signed an agreement with the water resources department to draw the water from the Kolab reservoir for its use.

Earlier, Nalco had set up a pump house at Sunabeda and used to take water from Kolab reservoir through pipes. But gradually the water level in that part of the reservoir plummeted. As a result, Naclo faced water shortage.

In order to remove water crunch, Nalco wanted to change its place of water intake at the reservoir.

The central PSU signed another agreement with the state government to draw water of the Kolab reservoir near Puruna Kotiagunda, a low-lying area.

The water resources department had permitted Nalco to lay road and a pipeline in the low-lying area.

A construction agency of Andhra Pradesh was awarded the con-

struction of the pipeline. As soon as the work started Friday, locals opposed it and warned the staff of the construction agency of dire consequences if they continued with the work.

The pipeline is be laid from Puruna Kotiaguda to Damanjodi while its work from Chougan to Damanjodi is nearing completion. But the work from Zero Point to Ghatguda has been stuck due to resistance from residents of Puruna Dumuriput.

Locals were shown documents about the land acquisition for the Upper Kolab, tehsldar's permission and copies of the agreement papers with the water resources department, but the latter refused to budge from their stand. Due to stalled work, the agency faced loss. Saturday, some people detained the

Kendrapara, Nov 7: Jute cultivation is on the wane in Kendrapara district due to lack of government support, a report said. Reports said decades back jute sticks known as 'Kaunria Kathi' in local parlance was used as firewood. However, things have changed over the years as a piece of jute stick now sells for Rs 1 during Diwali festival.

The decline in cultivation of jute is blamed on the rise in the price of jute sticks. Observers said the district has favourable climatic conditions and land resources for jute cultivation but little government support led to a decline in its cultivation. Farmers are turning to other crops to earn a living.

Jute is a long, soft, shiny bast fiber that can be spun into coarse, strong threads. It is one of the most affordable natural fibers, and second only to cotton in the volume of production



and the variety of use. Its fibers are composed primarily of the plant materials cellulose and lignin.

Jute was cultivated on 2,152 hectares in 2005. The cultivation rose to 8000 hectare in 2010 as the climate and soil proved conducive for the cultivation. In view of the increasing prospects for jute cultivatwo quintals in 2018. The centre waded into more problems as it stopped getting seeds from 2019-20. Left with no options, farm-

ers were forced to buy seeds from open market. However, they proved to be of sub-standard quality.

seeds but the centre provided only

Banamabar Sahu, a senior resident, said the district lacks major or small industries and agriculture is the main occupation of people. The farmers are turning away from jute cultivation due to lack of sponsorship from the state government.

The Centre and the state government have imposed a ban on use of plastic bags and replace it with jute bags. However, the district is lagging behind in fiber cultivation.

Niranian Parida, a farmer, of Kansar panchayat said he has cultivated jute on 12 acres and transports the harvest to Kolkata for sale. Farmers also get decent earnings from selling jute sticks ahead of Diwali. However, this year they failed to get seeds due to failure of the agriculture department to supply them.

Saraswati Samal, a woman farmer, of Parapangara said the district has a jute based cottage industry which employs over 60 women belonging to self-help groups. The unit manufactures various jute based products but its profit margin is declining as it has to pay more for purchasing jutes from outside.

When contacted, Ashok Mahasuara, deputy director, agriculture department, said the department is trying to revive jute cultivation in the district from next year as per the plan of the Centre and the state government. The department is also making arrangements to provide subsidies on seeds and other agricultural implements for farming jute.



As the Harvard law professor Mark Tushnet has suggested, a commission of inquiry should be established to investigate policies and acts that went beyond incompetence into the realm of politically motivated malevolence. It is critical that we establish a proper record of these events, perhaps by offering leniency in exchange for candid accounts. The latter should help thinking about structural reforms. making at least quid pro quo corruption and blatant human-rights abuses less likely.

Finally, Trump has broken plenty of informal presidential norms, from the relatively trivial - calling people names on Twitter - to the serious: hiding his tax returns. As many US jurists have argued, a prudent response would be to establish a separate commission to study the structural vulnerabilities of the presidency. Such an investigation may find that many informal norms-from financial transparency to relations with the Department of Justice – need to be codified. This three-pronged approach need not distract from more urgent tasks of governance. Although it might require spending some political capital, the costs of inaction or breezily "moving on" could be even higher, as was arguably the case following Gerald Ford's pardon of Richard Nixon, and the leniency shown after the Iran-Contra scandal and the George W. Bush administration's extensive use of torture in pursuing its "global war on terror.



The Democrats fought the current election on a very liberal platform. On the question of human rights, the most powerful message they were aligned with was Black Lives Matter. This part of the Democratic Party (which includes Jayapal) has become stronger inside because of the success of the human rights messaging.

Indians may not know that in April India was marked as a Country of Particular Concern by the United States Commission on International Religious Freedom. Its report said that "India took a sharp downward turn in 2019" because the Modi government "instituted national-level policies violating religious freedom across India, especially for Muslims". It said of the Citizenship Amendment Act that "this law is meant to provide protection for listed non-Muslim religious communities - but not for Muslims - against exclusion from a nationwide National Register of Citizens and the resulting detention, deportation, and potential statelessness". It said India had seen

Bee's knees

n many ways, there has never been a more dangerous time for journalists than the present. With simultaneous crises threatening media freedom and sustainability, this decade will be decisive for the future of a vocation that is crucial for societies' wellbeing. What would the world look like if there were no professional, ethical journalists to report the news? Worryingly, this question is no longer hypothetical.

The issue of reporters' safety remains vitally important. Although killings of journalists have decreased during the Covid-19 pandemic, threats to their safety continue to evolve and increase. Last year, more journalists were killed in countries supposedly at peace than in war zones, and the percentage of reporters killed on the job who were deliberately targeted was higher than ever before. Many of the victims were working to expose corruption and report on other sensitive topics.

Just a few days ago, on October 29, reporter Arturo Alba Medina was killed in Ciudad Juarez, Mexico, near the US border. He was the sixth journalist murdered this year in Mexico, which remains the dead-

liest country not at war. In the past decade alone, nearly 1.000 journalists globally have been killed in connection with their work. Many of these cases have never been properly investigated, and the vast majority of perpetrators have never been held to account.

This year's International Day to End Impunity for Crimes against Journalists, on November 2, is an ideal opportunity to start taking concrete action to end this endemic impunity for good. The United Nations should appoint a Special Representative for the Safety of Journalists, with the aim of enforcing international law and thereby finally reducing the number of reporters killed every year in the course of their work.

The Reporters Without Borders (RSF) campaign to establish a special representative has gained tremendous momentum in recent vears, but one obstacle remains. Because the appointee would be a representative of the UN secretary-general, we need the secretary-general's active support. Unfortunately, António Guterres has not vet lived up to the promise he made when we met one month after he took office in 2017: "It will take

time, but I will do it," he told me.

Guterres now has a little more than a year of his current term remaining. That is more than enough time to ensure meaningful action to end impunity and protect journalists. Guterres's appointment of a member of his staff as a contact person on this issue – the only concrete step he has taken

so far - is not enough. The mandate for a special representative would not be merely a paper-based exercise that generates more reporting. Rather, it would be a means of bringing together the relevant existing UN mechanisms, resolutions, and recommendations.

Tangible impact is desperately needed in many of the cases in which RSF is involved - including that of Saudi columnist Jamal Khashoggi, who was murdered and dismembered inside Saudi Arabia's consulate in Istanbul in 2018. Many of the cases concern investigative journalists, including Daphne Caruana Galizia, assassinated in 2017 by a car bomb outside her home in Malta; Ján Kuciak, shot dead in 2018 along with his fiancée. Martina Kušnírová. inside their home in Slovakia; the Belarusian journalist Pavel Sheremet, killed by a car bomb in 2016 in Kviv: and the Ghanaian journalist Ahmed Hussein-Suale, shot three times in 2019 while driving his car in Accra.

There are many other cases. The young freelance journalist Christopher Allen was killed in 2017 while reporting on the civil conflict in South Sudan, and Kirill Radtchenko, Alexandre Rasstorgouïev, and Orhan Djemal were murdered in 2018 while making a documentary about Russian mercenaries.

Enough is enough. RSF calls for concrete action now to end violence against all journalists, wherever they live and work. We call on the UN secretary-general to support the establishment of a Special Representative for the Safety of Journalists, and for member states to enable and support the work of this crucial mandate. Finally, we call on the international public - and decision-makers-to join our campaign to end impunity for crimes against journalists once and for all.

Stubble burning

Sir, Every winter, till the end of November or more, burning of stubble augments the pollution levels in Delhi. On an average, 23 million tonnes of rice straw are burnt in north India by farmers to make way for wheat production. A small gap between rice harvesting time and wheat sowing period means the farmers quickly burn the stubble to remove the paddy stubble. The particulate matters emitted by the burning of stubble tend to cause severe air pollution. Waxing and waning of "fire spots", nothing but the number of stubble burning spots, and reduction in pollution due to increased wind speed, occasionally make sure the pollution relents, but only just. Agriculturists are piqued by the meager compensation offered by the government. Manual removal of stubble is not cost effective for them. Pisa bio-decomposer is being projected as the solution to stubble burning. It has been described as one that can change crop residue into manure in about 20 days. The decomposing technology makes use of fungal strains that rapidly decompose the paddy stubbles. Farmers will have to spray the paddy straws with the fungi strains and then decompose them in soil. Subsidised combined harvesters, provided by the government at subsidised rates, are helpful but again a farmer may have to shell out quite a considerable amount towards rent and fuel. Of all methods, the Pusa bio-decomposer looks the most promising because it is simple and cost-effective.

Showik files fresh bail plea

Mumbai. Nov 7: Arrested over two months ago on peddling charges, actress Rhea Chakraborty's brother Showik Chakraborty has moved a fresh bail plea in a special court in an NDPS case, his lawyers said here Saturday

The special NDPS court is likely to hear his bail plea next week, which was earlier rejected by the same court, Metropolitan Court, and the Bombay High Court, his lawyer Satish Maneshinde said.

Showik, 24, was arrested on September 4 by the Narcotics Control Bureau (NCB), which is probing the drugs angle to the death of Bollywood actor Sushant Singh Rajput at his Bandra home on June 14

Rhea, who was arrested in the same case later, was granted bail by the Bombay High Court on October 7. Currently lodged in Taloja Central Jail in Raigad, Showik has pointed out how he had been falsely implicated in the case and that no drugs were seized from him during the investigations.

India's largest Covid hospital facing acute shortage of beds

New Delhi, Nov 7: Lok Navak Jai Prakash Narayan (LNJP) Hospital, India's largest Covid-19 hospital run by the Delhi government appears to be crumbling under the weight of soaring coronavirus cases, with only 6 per cent ventilator beds vacant in the hospital.

According to Delhi government's Corona application, only 19 per cent of the ICU beds with ventilators are vacant across the city. 22 per cent of ICU beds without ventilators are unoccupied, while only 50 per cent of normal Covid-19 beds are available. The patients are running from pillar to post just to occupy a single bed.

LNJP currently has only five vacant ventilator beds, 22 ICU beds without ventilators and 1.398 Covid-19 beds. LNJP Medical Director Suresh Kumar said, "If we run out of beds, we have central allocation. For example, if the beds are full, pa-

tients can be sent to Rajiv Gandhi, GTB or other hospitals. The Medical Director further emphasised, "We are admitting maiority of the patients, but a few stable patients, who require mere observation, are being referred to



other hospitals.

The Rajiv Gandhi Super Specialty Hospital confirmed that it has been receiving patients from LNJP due to shortage of beds. Delhi has been witnessing a massive spike in daily Covid-19 cases for the last one week. It had witnessed its highest singleday spike on Friday, when it reported 7,178 cases. Earlier this week, the increase in

the number of cases had prompted Chief Minister Arvind Kejriwal to admit that a 'third wave' of infection has hit the national capital. Kumar said that admissions to city hospital have doubled in the last one week. "The hospital used to admit over 50 Covid-19 patients every day, but

in the last one week, the admissions have gone up to at least 100 a day, but only serious patients or those with moderate disease are being admitted," Kumar said. He added, "Over the last one week, we are getting more and more elderly people because of the pollution. At one side, you have low oxygen in the air and then the Covid-19. These factors cause double harm to the lungs and people have low oxygen saturation."

"Before this, people from all age groups used to come, but now only those above 60 years of age are coming. Such patients are more critically sick and require more ventilator beds, oxygen support as they have more complications," Kumar said.

A former diplomat who had joined the Central Information Commission as the Information Commissioner on January 1 last year, the 62-year-old has served as India's High Commissioner to the United Kingdom and Sri Lanka. A three-member panel headed by Prime Minister Narendra Modi and including Union Home Minister Amit Shah and leader of the Congress in Lok Sabha, Adhir Ranjan Chowdhury, had short-listed Sinha for the post.

stated that he died at the hands of miscreants on the other side of the border, Mizoram Home Secretary Lalbiaksangi said that 48-year-old Intyaz Ali was apprehended with drugs and he was found dead at a hospital on Monday after he was referred to the health centre for a medical checkup.

Police said that educational institutions, government offices, banks and various financial institutions, shops and markets remained closed and vehicles went off the roads due to the dawn to dusk strike, which passed off peacefully. Both the states have now decided to deploy Central Paramilitary Force (CPMF) personnel at the border.



Over 57% polling in final phase

Patna, Nov 7: The third phase of polling for 78 seats in 15 districts in Bihar ended Saturday with some scattered incidents of violence. The Election Commission of

India recorded 57.70 per cent voting till 6 p.m. The calculation of the voting percentage is still underway in some of the polling booths. A person named Beni Singh, brother of RJD supporter Bittu Singh, was gunned down in Damdaha area of Purnea district.

Jitendra Kumar, ADG headquarters of Bihar police, said that the incident was reported in Purnea district and an investigation is currently underway. It has nothing to do with the election, he added. Beni Singh was working as an observer for the RJD candidate in Damdaha and was on his way to monitor election proceedings in Sarsi village. He was attacked by three to four persons, killing him on the spot.

Kumar said a firing incident took place at booth number 282 in Damdaha in Purnea at 10.30 a.m. on Saturday. He said the firing was resorted to by paramilitary forces in self defence after a large num-



ber of anti-social elements created a ruckus at a polling booth in Damdaha

An FIR was registered against a candidate Sarfaraj Alam in Jokihat police station under sections 171F and 188. He was accused of violating the model code of conduct at a polling booth. Kumar informed that 439 illegal firearms were seized during the third phase and over 1,334 illegal firearms were seized in all the three phases. Besides, the police also asked the licensed arms holders to deposit their weapons and a total of 25,449 weapons were de-

posited. The police also arrested 5.112 persons under the Crime Control

Act in the run up to the elections and during all the three phases. A huge quantity of illegal liquor was also seized. The Bihar police registered 384 criminal cases in the third phase and 880 FIRs in all the

three phases. H R Srinivasa, the chief electoral officer of Bihar, expressed satisfaction over the generally peaceful polling in all the three phases. "This election has significant importance due to timing. It was held in the time of corona with Bihar being a densely populated state," Srinivasa said.

Compared to 2015, Srinivasa said there was a 45 percent increase in polling booths in 2020.

Mumbai, Nov 7: Eighty-two-yearold Father Stan Swamy, arrested in the Elgar Parishad-alleged Maoist links case, has filed an application before a special court here, seeking that he be allowed to use a straw and sipper in Taloja jail in Navi Mumbai, where he is currently lodged.

Swamy was arrested from his home in Ranchi last month in connection with the violence in Bhima Koregaon near Pune in January 2018. The accused, through his lawyer Kritika Agarwal, moved the plea before the special NIA court on Friday seeking straw and sipper in jail citing health issues.

The special court judge D E Kothalikar has asked the national probe agency to file its reply on the matter on November 26. NIA officials have said that investigations established that Swamy was actively involved in the activities of the CPI (Maoist). The NIA has also alleged that he was in contact with "conspirators" -- Sudhir Dhawale, Rona Wilson, Surendra Gadling, Arun Ferreira, Vernon Gonsalves, Hany Babu, Shoma Sen, Mahesh Raut, Varavara Rao, Sudha Bharadwaj, Gautam Navlakha and Anand Teltumbde to further the group's activities.

CBI gets 3-day custody of Kulkarni

Dharwad (Karnataka): The Central Bureau of Investigation (CBI) team secured threeday custody of Karnataka Congress leader, Vinay Kulkarni from the local court in Dharwad Friday. The CBI special team had arrested him after intensely grilling more than eight hours on Thursday for his alleged role in four year old murder case of BJP's slain Zilla Panchayat member, Yogeeshgouda Goudar in 2016. The CBI had petitioned to the court that they needed his custody for three days, the Court however, pronounced its verdict late in the evening as a result of this, Kulkarni will remain in Hindalga prisons in Belagavi. A senior prison officer said that the CBI might take him into custody from Saturday onwards as the prison guidelines do not permit anyone including police or CBI to meet any accused after 6 p.m.

Woman ends life along with child

Noida (Uttar Pradesh), Nov 7: In yet another case of suicide in Delhi's National Capital Region (NCR), a woman committed suicide along with her four-year-old child on Saturday in Noida by jumping from her 17th floor apartment. Both died on the spot.

The woman was alone in the house with her child when she took the extreme step while her husband was away for work in Moradabad. The Noida police has informed the family of the deceased and sent the bodies for post-mortem.

The police said, "As per the information received by the Bisrakh police station, a mother along with her four-year-old child committed suicide by jumping off from her 17th floor Supertech Ecovillage-Phase 1 society apartment. Both are confirmed to be dead. The police officials are present at the spot and necessary inquiries are on."

Additional Deputy Commissioner of Police, Noida, Ankur Aggarwal said, "The deceased woman was alone at her Noida apartment when she took her as well as her only child's life while her sister-in-law had gone to a hospital in the morning. The woman's husband had gone to Moradabad for some work. At present, the case appears primafacie to be that of suicide. The family of the deceased has been informed and the woman's husband is on his way back.

"The reason behind the twin suicides will be revealed only after a further police probe. The bodies of the deceased mother-child have been sent for postmortem," Aggarwal added.

Delhi tops in new cases in last 24 hrs

New Delhi, Nov 7: Delhi overtook Maharashtra and Kerala by reporting 7,178 COVID-19 cases in a span of 24 hours, becoming the largest contributor to the new 50,356 single day infections, according to Union Health Ministry Saturday.

Seventy-seven percent of these new cases of COVID-19 are from 10 states and union territories ----Delhi, Kerala, Maharashtra, West Bengal, Karnataka, Andhra Pradesh, Tamil Nadu, Haryana, Uttar Pradesh and Rajasthan.

Kerala recorded 7,002 new cases followed by Maharashtra at 6,870 new cases on Friday, the ministry said. A total of 50.356 new coronavirus infections were reported in a span of 24 hours, while 53,920 recoveries were being recorded during the same period, it said.

The trend of India's daily new COVID-19 recoveries exceeding the single-day cases for the last five weeks played a pivotal role in push-



ing down the active caseload which is presently pegged at 5.16 lakh cases and comprises 6.11 percent of total cases, the ministry said.

"This trend has been observed for the last five weeks. This also played a pivotal role in pushing down the active caseload which is presently pegged at 5.16 lakh," the ministry said. The last five weeks have seen a continuous decline in average daily new cases of COVID-19.

The average daily new cases have dropped to 46,000 cases from more than 73.000 average daily new cases in the first week of October. The active cases are on a sustained decline as a result of the aforementioned trend. the ministry said.

The number of people who have recuperated from the disease has surged to 78,19,886, pushing the national recovery rate to 92.41 percent.

cross-border firing along the IB in the Hiranagar sector continued throughout the night, the officials said. They said there was no report of any casualty or damage on the Indian side

"At about 2:30 am, Pakistan initiated unprovoked ceasefire violation by firing with small arms and shelling mortars along the LoC in Mankote sector. Army retaliated befittingly," a defence spokesman said. The officials said the firing and shelling between the two sides stopped around 4 am.

Pakistani Rangers started the firing on border outposts in Karol Krishna, Satpal and Gurnam around 10 pm on Friday, prompting strong retaliation by the Border Security Force (BSF) personnel guarding the border, the officials said.

The exchange of fire between the two sides continued till 5.10 am, they said, adding the Pakistani firing caused panic among the border residents who were forced to spend the night in underground bunkers.

Smog not only health hazard, but hits economy too: Experts

New Delhi, Nov 7: Smog, which for long is considered as a health and environment hazard, is quickly taking a toll on economic activities as well

Industry experts contend that if unchecked, the issue of smog will assume a larger role in hampering economic activities in and around north India, especially Delhi-NCR. Among sectors, tourism, construction, aviation, insurance and real estate prices will be heavily dented due

to this winter phenomena. Besides economic disruption, the aspect of reputational damage associated with health risks also exists in Delhi-NCR. "Smog does impact economic activity, but its intensity is very low as a disruptor.

However, if left unchecked, it will definitely have a greater impact in the future," Sunil Kumar Sinha, Principal Economist, India Ratings & Research, said.

"There is also a reputational risk involved with smog and this impacts tourism and other travel related factors, when one considers visiting any place," he added. Given that most of these trends are witnessed year after year, this time around, the Covid-19 pandemic has accelerated some of the downside risks. "Environment externalities are

expected to have a negative impact on growth," said Madhavi Arora, Lead Economist for Edelweiss Securities. "That is one of the reasons why the international community is so much focused on climate and environmental issues," Arora added.



As a case-in-point, travel app ixigo last year shared that bookings and travel searches for New Delhi from key international destinations, including Singapore, Thailand and Qatar, had fallen by 44 per cent owing to the deteriorating air quality.

"Tourists, including foreigners, had a tough time last year coping up with increasing air pollution in Delhi. With air quality dipping to 'severe' category every year around Diwali, there is a growing health concern, especially for the children

and senior citizens who are visiting or residing in the national capital," said Rajnish Kumar, Co-founder and CTO, ixigo. In 2020, when the pandemic has crippled international travel, Kumar said: "We are witnessing a trend of 'escape tourism' this year owing to an increasing level of pollution in metros like Delhi. Current AQI in the city is double of what it was last Diwali when the AQI peaked to 235. This has led to a spurt in outbound travel from Delhi to pollution free destinations like Goa, Uttarakhand and Himachal Pradesh." "We have seen a 35 per cent month-

on-month increase in bookings for Goa from Delhi in October. Low airfares this year around Diwali are further encouraging the travellers to plan green getaways in search of fresh air," he added.

According to Skymet's Chief Executive Yogesh Patil: "It is another type of lockdown when people avoid going outside or even visiting Delhi-NCR for these months just to be safe from smog. The health cost for some people might come out to be as high as their other economic expenditure, so it does have an economic cost.

"However, pollution concerns have not gained the sort of prominence in India that they should have. but fortunately programmes are being started for plantations in urban areas. The pandemic too has triggered people's consciousness regarding the need for a safe and clean environment." The restrictions to curb pollution and smog also delay construction projects.

Three states pass amendments that 'only citizens' can vote

Denver, Nov 7: Voters in Colorado, Florida and Alabama passed ballot measures Tuesday that codify what is already law: That only US citizens 18 and older can vote.

The passage of the largely-symbolic measures has triggered questions about why the pro-Trump group behind them spent time and money on the effort.

The amendments passed overwhelmingly in all three states, including by a nearly 8-to-1 ratio in Alabama and Florida. Before the 2020 election, North Dakota and Arizona were the only state constitutions that specified non-citizens could not vote in state or local elections. A former GOP state legislator from Missouri who led the effort said the ballot measures were needed to combat recent changes that allow non-US citizens to vote in some local elections.

Opponents counter that the measures are unnecessary and fuel antiimmigrant sentiment.

On the Colorado ballot, the question read: "Shall there be an amendment to the Colorado constitution requiring that to be qualified to vote at any election an individual must be a United States citizen?" The Alabama and Florida ballots had similar language.

Had the measures failed, it would have kept Colorado's state's constitutional language of "allowing every eligible U.S. citizen to vote in Colorado elections." Julian Camera, manager for a campaign that opposed the measure in Colorado and field organiser for the American Civil

Cities across the US have con-Liberties Union of Colorado, said the ballot language is misleading.

the Secretary of State. The group's founder is John Loudon, a former Republican state senator in Missouri and past advisor to America First Policies, a group supporting President Donald Trump. Loudon said the ballot amendments were needed because the current constitutional language

isn't strong enough. "The language that we have now is objectively, provably not sufficient because of all the successful efforts to give legal voting rights to non-citizens, at least in local and school board elections all across the country," Loudon said.

Learn from sanctions: Iran tells Biden

Tehran, Nov 7: Iran's President Hassan Rouhani said Saturday he hoped the next US administration will have learnt that sanctions cannot make Tehran bow to American policy.

US President Donald Trump, who lost Tuesday's election to challenger Joe Biden, has applied a "maximum pressure" policy and punishing sanctions against Iran since his 2018 withdrawal from a landmark nuclear agreement with Iran. "We hope the three-year experience will be a lesson for America's next administration to abide by laws and regulations and return to its commitments," Rouhani said in a televised speech

"Our people have faced economic terrorism for the past three years." Rouhani said Iran would "continue its resistance and patience until the other side bows before laws and regulations"

The Islamic republic hoped that "those imposing sanctions realise their path was wrong and that they will not achieve their goals in any way". Iranian officials have said they will focus on the policies of the next US administration rather than who becomes president.

Tehran has also stressed that a possible US return to the nuclear agreement would have to be accompanied by compensation for damages caused by the withdrawal and a "guarantee" it will not be repeated. Iran's supreme leader Ayatollah Ali Khamenei said Tuesday that the US election would have "no effect" on Tehran's policies towards Washington.

Biden has said he plans to embark on a "credible path to return to diplomacy" with Iran if he wins the presidency

'US-China tensions could worsen'

If Trump takes his election grievances to court, it will be difficult for Beijing to establish communication with the Biden team before the matter is settled

Beijing, Nov 7: With the battle for the US presidency likely to rage on for some time, regardless of the official result, observers say there could be a spike in tensions between the US and China on thorny issues like Taiwan and the South China Sea before the inauguration ceremony in January.

Wu Xinbo, director of the Centre for American Studies at Fudan University in Shanghai, said the Donald Trump administration was likely to continue to confront China on political, diplomatic and economic issues.

That might include labelling China's persecution of minority Uygur Muslims in Xinjiang as "genocide", imposing more sanctions on Chinese companies or providing more support for Taiwan.

"Trump has blamed China for the spread of the [coronavirus] pandemic and may think that has cost him the election," Wu said.

"People like (US Secretary of State Mike) Pompeo and (White House trade adviser Peter) Navarro will also seize their last chance to sabotage Sino-US relations.'

In the months ahead of the election, several Chinese experts expressed concerns that Trump's China-bashing tactics heralded a dangerous period in the relationship between the two countries and that tension could reach a peak if the incumbent president lost the White House.

Two of the possible hotspots are



the South China Sea and Taiwan There have been several furious exchanges between Beijing and Washington this year over the US sending aircraft carriers and surveillance planes to the disputed waterway, and Beijing stepping up its military exercises directed at Taiwan.

Liu Yawei, programme director at the Carter Centre China, said in August that China-US relations could enter their "most unstable period" between November 3 and January 20, and called on both sides to show restraint on the South China Sea and Taiwan.

Taiwanese officials said earlier that the People's Liberation Army - China's military - had conducted more than 1,735 air sorties and 1.032 maritime incursions into the self-ruled island's air defence identification zone since the start of the year.

Taiwan's Defence Minister Yen Te-fa warned that Beijing might step up its military deployment against the island during the US election, while Su Chi, the former head of its National Security Council, said the situation might become critical after the election race had been decided.

UAE to relax Islamic laws for personal freedoms



Dubai. Nov 7: The United Arab Emirates announced Saturday a major overhaul of the country's Islamic personal laws, allowing unmarried couples to cohabitate, loosening alcohol restrictions and criminalising so-called "honour killings.'

The broadening of personal freedoms reflects the changing profile of a country that has sought to bill itself as a skyscraper-studded destination for Western tourists, fortuneseekers and businesses despite its legal system based on a hard-line interpretation of Islamic law. The changes also reflect the efforts of the Emirates' rulers to keep pace with a rapidly changing society at home. The announcement also follows a historic US-brokered deal to normalise relations between the UAE and Israel, which is expected to bring an influx of Israeli tourists and investment. Changes include scrapping penal-

ties for alcohol consumption, sales and possession for those 21 and over. The legal reforms were announced on state-run WAM news agency and detailed in state-linked newspaper The National.

Previously, individuals needed a liquor license to purchase, transport or have alcohol in their homes. The new rule would apparently allow Muslims who have been barred from obtaining licenses to

The blast took place at about 7 a.m., in the Makrorayan-e-Char area in the capital city's Police **District 9, reports TOLO** News. The police said that the explosion was caused due to the detonation of a magnetic IED that targeted a vehicle carrying the the three victims.

WTO defers decision on new chief

Geneva, Nov 7: The World Trade Organization (WTO) postponed a General Council special meeting on the appointment of the next Director-General slated for November 9, citing reasons including "health situation and current events.

"It has come to my attention that for reasons including the health situation and current events. delegations will not be in a position to take a formal decision November 9." General Council Chair David Walker of New Zealand said in a written statement to all members Friday, Xinhua news agency reported.

"I am therefore postponing this meeting until further notice during which period I will continue to undertake consultations with delegations," Walker added.

On October 28, Walker told WTO members at a Heads-of-Delegation meeting that based on their consultations with all delegations, the candidate best poised to attain consensus and become the new Director-General was Ngozi Okonio-Iweala of Nigeria.

"She clearly carried the largest support by members in the final round and she clearly enjoyed broad support from members from all levels of development and all geographic regions and has done so throughout the process,' Walker said.

He added that a formal decision had to be taken by the members at

a General Council meeting, originally scheduled for November 9.

But the assessment was challenged by the United States, which said it would continue to support South Korea's Minister for Trade Yoo Myung-hee and could not back the candidacy of Okonjo-Iweala.

Since early October, Okonjo-Iweala had been facing off against Yoo in the final round of race to become the new director-general of WTO. If selected, Okonjo-Iweala would become the first woman and African to head the global trade watchdog in its 25-year history.

The WTO's leadership vacuum was created after its former chief Roberto Azevedo stepped down August 31, a year before the end of his official term

Myanmar's election and Suu Kyi's expected victory

Myanmar holds national and state elections Sunday in which Nobel laureate Aung San Suu Kyi's National League for Democracy party will be looking to hold on to power

Yangon, Nov 7: Myanmar holds national and state elections Sunday in which Nobel peace laureate Aung San Suu Kyi's National League for Democracy party will be looking to hold on to power.

More than 37 million of Myanmar's 56 million people are eligible to vote. More than 90 parties are fielding candidates for seats in the Upper and Lower Houses of Parliament. The NLD's landslide victory in the last election in 2015 came after more than five decades of military or mil-

itary-directed rule. Those polls were seen as largely free and fair with one big exception - the army-drafted constitution of 2008 automatically grants the military 25% of the seats in Parliament, enough to block constitutional changes. That proviso

still holds true. Overshadowing the polls is the coronavirus and restrictions to contain it, which are likely to lower turnout despite government plans for social distancing and other safetv measures. Suu Kyi's party is heavily favoured to win again, though probably with a reduced majority. Suu Kyi is by far the country's most popular politician, and the NLD has a strong national network, reinforced by holding the levers of state power

Nevertheless the NLD has been criticised for lacking vision and adopting some of the more authoritarian methods of its military predecessors, especially targeting critics through the courts.

Suu Kyi's party has lost the cooperation of many ethnic minority parties, which are popular in their border area homelands. In 2015, those parties were tacit allies with



the NLD and arranged not to compete strongly where splitting the

vote might give victory to the military-backed Union Solidarity and Development Party, or USDP.

Suu Kyi's failure to come through with an agreement giving ethnic minorities the greater political autonomy for decades has disenchanted them, and this year they will be working against the NLD rather than with it. The main Opposition USDP was founded as a proxy for the military and again is the NLD's strongest competitor. It is well-funded and well-organised. Whether voters still see it as tainted by its association with previous military regimes is not clear.

To a large extent, the polls are seen as a referendum on Suu Kvi's five years in power, just as the 2015 election was seen as a judgment on military rule. There has been economic growth, but it benefited a tiny portion of the population in one of the region's poorest countries, and fell short of popular expectations.

Not only were ethnic minority groups disappointed by Suu Kyi's failure to grant them greater autonomy, but the well-trained andwell-armed Arakan Army has risen to become the biggest military threat.

Bhubaneswar, Nov 7: State's Micro and Small Enterprises (MSEs) units expressed their concerns over state government's one-sided policy that mandates procuring materials from Government e-Marketplace (GeM) alone. The MSE association claims that the policies have discouraged these units and shut all doors from selling any products to government institutions in the state. MSE bodies Orissa Young Entrepreneurs Association (OYEA), Utkal Pharmaceutical Manufacturers' Association

(UPMA), Orissa Small Scale Industries Association (OSSIA) and Odisha Assembly of Small and Medium Enterprises (OASME) gathered Saturday and asked state gov-

ernment to make amendment in the policy.

OSSIA president Smaraiit Mohanty said, "To help MSEs in marketing their products, Directorate of Export Promotion and Marketing (DEPM) was created which was entrusted with registration of MSE manufacturing units and formulating a process of procurement for the state government called Rate Contract System".

Since then this time tested procurement system is followed for procurement of goods and services and has been incorporated in OGFR as one of the procurement processes for goods and services benefitting majority of MSEs of our state." "However, state finance depart-

ment issued a new circular mandating all procurement through only



GeM. This policy may lead over 1,000 industries to uncertain fate or disastrous situation," Mohanty said.

State government procures around 88 products from thousands of MSE units for a value of around ₹300 crore, on an average, through EPM. But this policy has shut their doors from their business.

It is mandatory to register in GeM to be a participant in the selling business. State's MSEs are unable to register in the portal as they don't have a trademark or proper brand.

The MSE associations claim that the state government's policies have discouraged these units and shut all doors from selling any products to government institutions in the state

In this regard, OASME Secretary General Satwik Swain said, "These are micro and small industries and they don't have proper brand names which is why, they are unable to register in GeM and sell their products. Sadly, they can't register as manufacturers but as retailers." MSE bodies stated that they

don't have any problem with GeM but asked state government to make a balanced policy that also mandates procurement of materials from these local industries through DPEM.

'We the MSEs of the state demand before the government that they involve the stake holders while formulating policies as mandated by IPR and continue with the old time tested mechanism of procurement through rate contract which will create wealth and resources for the state which probably no other sectors can," members of the bodies said.

The associations said that they will go for a peaceful sit-in dharana if their legitimate demands of livelihood are not addressed in its true perspective.

NCRTC, BEL sign MoU to develop platform screen doors

New Delhi, Nov 7: Taking a step forward towards realising PM Narendra Modi's vision of 'Aatmanirbhar Bharat (self-reliant India), the National Capital Region Transport Corporation (NCRTC) Saturday signed a memorandum



of understanding (MoU) with Bharat Electronics Limited (BEL) for indigenous development of platform screen doors (PSDs).

The MoU was signed by NCRTC Director (Systems) Navneet Kaushik and Manoj Kumar, BEL's Executive Director (National Marketing)

The NCRTC and BEL, a government of India enterprise under the Ministry of Defence, will indigenously develop PSD system for the upcoming MRTS/RRTS/highspeed rail projects, both in India and abroad.

According to NCRTC, the PSDs act as a safety barrier between the passengers on the platform and the train.

The PSDs also help in crowd management and prevent any untoward incidents like jumping or falling on the track.

The NCRTC said that till date, the PSDs used in India were imported.

The NCRTC said in a statement that it will design and develop PSDs for different rail-based systems in India and abroad in collaboration with BEL

'This will be a first and one of its kind initiative where indigenously developed PSD system will be used in India and will be exported globally as well," it said.

NCRTC Managing Director Vinay Kumar Singh said, "NCRTC is working continuously towards identifying items that are presently being imported for MRTS/RRTS/highspeed rail projects and make strategies to bring such technologies to India through RRTS seen as determined to maximize their positions ahead of probable project to trigger domestic capacity development.

ITI in talks with firms to offer 5G network gears

New Delhi, Nov 7: State-run electronics manufacturing firm ITI Saturday said it is in discussion with Indian companies to provide end-to-end 4G and 5G network gears in the country.

The company is also looking at manufacturing equipment for E and V band spectrum which are considered essential for 4G and 5G technologies, ITI said in its annual report released on Saturday.

'Our company with its efficient and innovative state-of-art facilities and capabilities for manufacturing telecom equipment plans to manufacture eNodeB and 5G NR (new radio) products in its various plants," ITI chairman and MD RM Agarwal said in the report.

ITI is also in talks with other Indian companies to provide endto-end solutions for 4G and 5G networks across the country through an ecosystem of the local technologies, he added.

ITI has partnered with Tech Mahindra and Tata Consultancy Services (TCS) for development of 4G and 5G technology.

With these tie-ups, two streams of solutions for 4G upgradeable 5G can be worked out with ITI being the common manufacturing part-

EU to impose tariffs on \$4 bn US goods

Brussels/Washington, Nov 7: The European Union is poised to move next week to impose tariffs on \$4 billion of US imports in retaliation for US subsidies for planemaker Boeing, EU diplomats said, teeing up an eleventh-hour showdown with US President Donald Trump.

A majority of EU governments have backed imposing the widely expected tariffs once EU trade ministers meet next Monday - the latest twist in a transatlantic trade saga that has spanned 16 years and four US presidents.

Democratic presidential candidate Joe Biden is edging closer to victory in the US election, but Republican Trump would remain president until January 20 and has plenty of leeway to increase US tariffs on Europe that were im-

However, the bowling unit has done well save a few occasions like the first qualifier, where Mumbai Indians batting took them apart. Kagiso Rabada (25 wickets), Anrich Nortje (20) and Ravichandran Ashwin (13) have done exceedingly well in most of the games.

Sunrisers' batting line-up, which has gathered momentum over the last few games, is well aware of that, and Orange Army's premier all-rounder Jason Holder acknowledged the fact.


