NHRC issues notice to Chief Secy, DGP

NEW DELHI: National Human Rights Commission (NHRC) Friday sought an action taken report (ATR) from the chief secretary and DGP of Odisha in a case related to custodial death of a person in Puri. The NHRC has expressed anguish over the recurrence of such deaths despite several directions and guidelines issued by the Supreme Court and the Commission. The NHRC asked the chief secretary and the DGP to ensure submission of detailed report, lice officials concerned. The Human Rights Protection Cell (HRPC) of the Odisha police launched a probe into the alleged death of K Ramesh, 32, in the custody of Baselisahi police.

The police, meanwhile, rejected the allegation that they have detained the parents of deceased K Ramesh in an undisclosed location.

Meanwhile, Orissa High Court has sought a report from the state government with regard to the alleged custodial death in Puri while accepting a petition from lawyer Sarat Kumar Rayguru. tured" by the BJP to disturb communal harmony, provoking a sharp reaction from Union minister Gajendra Singh Shekhawat.

the Congress leader tweeted. "Jihad has no place in love. They are creating an environment in the nation where consenting adults would be at the mercy of state power. Marriage is a personal decision and they are putting curbs on it, which is like snatching away personal liberty," Gehlot said.

Union Jal Shakti Minister and prominent BJP leader from Rajasthan Gajendra Singh Shekhawat reacted strongly.

"Dear Ashok ji, Love Jihad is a trap that has thousands of young women believing the marriage is a personal affair," he said.

# Global tax evasion costs \$427 billion per year

**Mumbai, Nov 20:** Countries are losing over \$427 billion in tax each year owing to international corporate tax abuse and private tax evasion.

India's annual tax loss aggregates to \$10.3 billion. These are the findings of the first study led by The Tax Justice Network (TJN), which is an independent research based international network, that was published in alliance with other organisations.

The State of Tax Justice – 2020', which is the inaugural edition of the report, explains that of the \$427 billion in tax globally lost by countries each year to tax havens, \$245 billion is directly lost owing to corporate tax abuse by multinational corporations (MNCs) and \$182 billion (or 42.6%) owing to private tax evasion. The report analyses data that was self-reported by MNCs to tax authorities, owing to the Base Erosion and Profit Shifting (BEPS) project spearheaded by the



Organisation for Economic Co-operation and Development (Oecd).

MNCs paid billions less in tax dues by shifting \$1.38 trillion worth of profit out of the countries where they were generated and into tax havens, where corporate tax rates are extremely low or non-existent. Private tax evaders paid less tax than they should have by storing a total of over \$10 trillion in financial assets offshore, adds the report. Solutions suggested by TJN and


other partners to this study, are that governments should introduce an excess profit tax on MNCs such as global digital companies, who are making excess profits during the pandemic.

They also propose introduction of wealth tax with punitive rates for opaquely-owned offshore assets. Lastly, as Oecd is perceived as a rich-countries conglomerate, they seek a United Nations (UN) tax convention to set multilateral standards for corporate taxation and ensure tax co-operation between governments. IMPACT ON INDIA

For India, which is said to lose \$10.3 billion annually in the form of taxes lost to other countries, 'outward foreign direct investments' (OFDI) is its most vulnerable channel, with a 66% vulnerability score.

Mauritius, Singapore and Netherlands are the top three countries that contribute the most to this vulnerability factor. Of the \$10.3 billion annually tax loss that India suffers nearly \$10.11 billion is owing international corporate tax abuse.

According to government data, owing to the pandemic OFDI from India dropped in the first four months (April-July 2020) to \$5.7 billion, in the corresponding period in the previous year it was \$11.13 billion. Historically the government has concentrated more on curbing tax evasions in inbound investments, admits a government official.



New Delhi, Nov 20: Union Petroleum and Natural Gas Minister Dharmendra Pradhan Friday inaugurated a seismic survey campaign of Oil India Limited (OIL), India's second largest National Exploration and Production Company, at Mahanadi Basin in Puri's Kakatpur. Speaking on the occasion, the

Union Minister said that the Rs 220-crore campaign would be a game-changer in the socio-economic development of Odisha.

"It's a matter of great personal pride for me. This will be a major milestone in establishing Mahanadi as a hub of exploration and production operations as well as building hydrocarbon reserves in line with Prime Minister Narendra Modi's vision of Aatmanirbhar Bharat. Commercial production of oil and gas from Mahanadi basin will be a game-changer in the socioeconomic development of Odisha," Pradhan said

According to Pradhan, it was only in 1980s when oil and gas activities started in Odisha.

"With new approach, state-ofthe-art technology and Mahaprabhu Jagannath's blessings, we're confident that we'll get success in the seismic campaign launched today [Friday] in Odisha", he added.

Since 2014, the Centre has introduced a host of policy reforms in hydrocarbon exploration and

production sector, chief among them being the Open Acreage Licensing Policy (OALP), according to the Ministry of Petroleum and Natural Gas.

Seismic data obtained under National Seismic program in Odisha led to detection of five blocks by DGH and OIL won all the five blocks for hydrocarbon exploration under OALP-II and III rounds.

"OIL plans to acquire, process and interpret 1,502 line km of 2D seismic data and 1,670 sqkm of 3D seismic data in the five blocks. Interpretation of the data is envisaged to lead to an extensive exploratory drilling campaign, in quest of establishing hydrocarbon reserves in line with the vision of PM's Atmanirbhar Bharat," the

Ministry said. The total envisaged expenditure on the exploration campaign in the five blocks in Mahanadi Basin (onshore) is Rs 1,248 crore of which Rs 220 crore is for seismic survey The blocks are spread over 11 districts of Odisha-Puri, Khurda, Cuttack, Jagatsinghpur, Kendrapara, Dhenkanal, Jajpur, Bhadrak, Balasore, Maurbhanj and Keonjhar.

## FARMERS' BILL **INTRODUCED IN ASSEMBLY**

Bhubaneswar, Nov 20: The state government Friday introduced five Bills in the Assembly for discussion including one of the controversial Farm Bills.

The legislation titled The Odisha Agriculture Produce and Livestock Marketing (Promotion and Facilitation) Bill 2020 was introduced in the House which seeks to boost contract farming by countering the monopoly of Agricultural Produce Market Committees (APMCs).

The government said that the Odisha Agriculture Produce Markets Act 1956 had the provisions for contract farming but that was not sufficient to protect the interest of the producers for which it does not attract the producers as well as the sponsors.

'The prime reasons are conflict of interests between the APMC which were mandated to promote contract farming while they being market players and also lack of positive facilitation in both promoting contract farming and protecting farmers' interests. This by implication, necessitated a revisit of the legal framework of contract farming," the objective of the legislation said. The legislation claimed to propose Directorate of Agriculture Marketing and Facilitation to look after all the activities of contract farming.

# Twin deaths in custody rock House

Bhubaneswar, Nov 20: The winter session of the state Assembly got off to a stormy start Friday as Opposition BJP and Congress members created uproar in the House over two custodial deaths in the state. Due to the uproar created by Opposition members, Speaker adjourned the House for five times.

The winter session began amid Covid-19 restrictions with obituary references to former Speaker Sarat Kar, ex-MLAs Kartikeswar Patra and Gurupada Nanda. The House also paid tributes to Covid warriors. After passing obituary references, Speaker Surjya Narayan Patro adiourned the Assembly till 3 pm.

However, as the House reassembled at 3 pm for business, Opposition BJP and Congress members created ruckus demanding debate and action against SPs of Puri and Sundargarh for alleged custodial deaths in their respective jurisdictions

As the Opposition members stormed to well of the House and tried to climb Speaker's podium, Patro adjourned the House for 15 minutes. As the situation did not improve, he adjourned the proceedings for another 30 minutes and called an all-party meeting. The adjournment was then extended twice for 15 minutes and 5 minutes. But. the situation in the House did not improve after the meeting. Later, the House was adjourned for the day. Speaking to reporters outside the House, BJP leader and Puri

Chief Minister Naveen Patnaik should make a statement on this issue and a debate should be conducted in the House in this connection before holding any other business, the BJP leader demanded. Stating the law and order situation has collapsed in the state,

Congress MLA Taraprasad Bahinipati demanded suspension of SPs of the Puri and Sundargarh.

However, BJD leader Amar Satpathy said the Opposition members are trying to derail the House proceedings and introduction of important Bills, which is against the tradition and system of Assembly. They can debate on the custodial deaths in form of adjournment motion, he added.

Chief Minister Naveen Patnaik attended the session from his residence office via videoconferencing while two ministers and two senior MLAs participated from Lok Seva Bhawan conference hall.

# CS reviews Bargarh cancer hosp work

Bhubaneswar, Nov 20: Chief Secretary Asit Tripathy Friday reviewed the progress of a dedicated cancer hospital at Bargarh, planned to cater to the needs of the patients of Western Odisha.

In a virtual meeting, Tripathy took stock of the overall development and pace of the construction work for the hospital. He also directed the officials concerned to expedite the work and make the hospital a reality. It had been decided that the new cancer hospital would come up on the premises of Bargarh district headquarters hospital (DHH). The hospital would have advanced facilities for cancer patients. "The major facilities include

radiotherapy, CT simulator, HDR Brachytherapy, dosimetry, immobilization, histopathology laboratory, emergency care and day care chemotherapy. A bunker of 100 ft x 100 ft area will be constructed for radiotherapy unit. It is proposed that the hospital will start functioning with 50 beds," a statement from the office of the Chief Secretary said. During his interactions with the officials of the state health department, National Health Mission and others, Tripathy directed them to ensure the recruitment of adequate trained doctors and paramedical staff for providing health-

care at the new cancer hospital. It was decided to recruit adequate paramedical staff including radiation oncologist, medical physicist, radiotherapy technician, emergency doctors, nurses, front office executives, pharmacist and chemo-nurses along with auxiliary personnel for the hospital. Tripathy also directed the officials to arrange appropriate housekeeping and sanitization system for upkeep of the hospital.

## UTP 'falls to death' at Banapur sub-iail

# **Traders sneak into system as** farmers; admin orders probe

Sonepur, Nov 20: Even as procurement of paddy started in Sonepur from Friday, farmers have alleged various irregularities in registration. As result, middlemen are taking advantage of the irregularities. An investigation into alleged irregularities has started Thursday.

Reports said, the civil supplies department will procure though 62 PACS and 38 SHGs in the current year. The target in the first phase is 23.05 lakh quintals.

Meanwhile, 55,702 farmers have registered themselves which is 8000 more than that of last year.

Though the department assures farmers of smooth procurement via online tokens, the latter are doubtful of the system.

Farmers are producing their land pattas for registration, but the authorities do not go in for checking the category of the land and quantities of paddy produced by the farmers concerned. # Satellite transmitters for 30 turtles

Kendrapara, Nov 20: To gather detailed information about the migratory trajectory of Olive Ridley turtles, marine ecology, weather and other information, scientists of Wildlife Institute of India (WII) have decided to fit more advanced 'Platform Transmitter Terminals' (PTTs) or satellite transmitters on 30 Olive Ridleys this year at the three major nesting sites of Gahirmatha, Devi and Rushikulya river mouths

This was announced by WII's marine expert Dr Shivkumar Kuppuswamy.

He pointed out that transmission contacts through PTTs fitted on the turtles in 2017 had got disconnected within a year. "This year, more advanced PTTs will be used," he added.

Notably, the first satellite telemetry study on Olive Ridley turtles was conducted in April 2001. The WII with the forest department and turtle biologist Jack Frazier of the Smithsonian Institute fitted PTTs on four turtles at Devi nesting beach for an online monitoring of migratory routes

Of the four PTT-fitted turtles, only one migrated towards Sri Lanka. However, all the four turtles stopped transmitting after some months either due to technical problems or trawler-related mortality.

The second study was conducted in 2007. PTTs showed that the turtles undertook open-ocean migrations in the Bay of Bengal and exhibited migratory corridor between Sri Lanka and nesting sites along

#### the Odisha coast.

To prevent turtle mortalities during mating and nesting season, the forest department has imposed a seven-month ban on fishing along the coast between November and May. Last year, over 4.7 lakh turtles had thronged the nesting sites. Their number is expected to go up this year, if weather permits. The satellite transmitters on tur-

tles are meant to gather information on their movements for three years. PTTs have temperature sensors and surface time counters to indicate the proportion of time spent on the surface.

The battery of PTT is designed to last a year, if the turtle spends 30 per cent of its time on the surface. The data will be received, analysed and mapped.

The PTTs will be fitted on the turtles during their mass-nesting. Debasish Bhoi, the range officer of Gahiramatha marine sanctuary, said the WII will pick up 10 turtles each at Devi river mouth. Rusikulya river mouth and Gahiramatha sanctuary to be fitted with PTTs. He added that PTTs have temperature sensors and surface time counters to indicate the proportion of time spent on the surface.

Experts will also gather data about weather through PTTs.

# Legends surround Kupari's Buddha Stupa **RESTORATION OF THE BROKEN STUPA CONTINUES TO ATTRACT TOURISTS**

Khaira, Nov 20: Kupari area under Khaira block in Balasore has a treasure trove of ancient Buddhist relics. A Buddha stupa is at Shamuka village, which is 30 km from Soro and 20 km from Ranital. Locals say, many legends of past centuries lie hidden in the Buddha stupa.

Sculptural ruins of Buddhist culture have been lying scattered in Kupari village. One of the major attractions is a Boudha mandap or Mandira as it is called by local people. Near the stupa is a broken stone image of Lord Budhha in yogic posture. However, there is hardly any research on the antiquity of the culture. Some researchers say, the Buddhist cul-



ture here belongs to 9th century. It is believed that monks of Mahyana sect of the Buddhism had visited Kupari area centuries ago when stupas and stone statutes of Lord Buddha had been built.

These sculptural remains are believed to be of Bhoumkar's time. They bear much similarity with those found at Sishupalgarh, some historians say.

In 1869, the then collector of

Sculptural ruins of **Buddhist culture lie** scattered in Kupari village. The Budha mandap is the major attraction for tourists

Balasore John Beams used to visit Kupari area and proved the place as a hub of Buddhist culture after an intensive research.

In an article published in a journal of West Bengal's Asiatic Society. Beams had claimed that all those scattered sculptural ruins exclusively belonged to Buddhism. Besides, he had sent samples of the sculpture to the Asiatic Society. In 1934, there was research on the Kupari site and its cultural remains.

After the stupa was handed over to the tourism department, restoration works have been done. The archeology department took about a year to restore the broken stupa by spending about Rs 1 crore. The restoration work was done particularly by Jyotiprakash Panigrahy after he was made tourism and culture minister.

Significantly, after restoration work, tourists have started making their footfalls in the village to see the ancient Buddhist culture.

Sarat Kumar Biswal, president of the Baristha Nagrika Manch and villager Biswanrajan Mohapatra observed that after restoration of the broken stupa, tourists were gradually coming here.

# Angul municipality turns waste into wealth

Angul, Nov 20: Once a headache for Angul municipality, the garbage generated in the town has now become a source of earning for the civic body

This is how the municipality is earning from waste. In Angul town, the municipality has set up a micro composting centre (MCC) each at Hemasurapada, Mishrapada and Hulurisingha. These centres are being managed by self help groups. While Maa Ambika self help group is in charge of Hemasurapada MCC, Mishrapada and Hulurisingha MCCs are being taken care of by Chandrasekhar self help group and Dharitri self help group respectively. Every month, the civic body is providing a sum of Rs 35,000 each to the three MCCs.

After receiving the garbage at the MCC, the first step is to separate wet garbage from dry stuff. Then the processing of this garbage is started

In the next step, the garbage is laid out in sun to dry after mixing them with a certain type of organic chemical. Then, it is mixed with cow dung. Now, the organic manure is ready for sale.

The SHG members are doing the entire process carefully. The finished product, i.e. the organic manure is being sold for Rs 20 a kilogram.

While a lion's share of this manure is going to a bio-organic firm, some farmers are buying this manure regularly. That apart, town denizens have also become customers of this manure. They are buying to apply it in their gardens and roof-top gardens

"All of us are well aware of the harmful impact of chemical fertilizers. This is the reason why we have a liking for organic manure. We are using the manure sold by the municipality for our gardens and

kitchen gardens. The municipality will get more customers in coming days but its advertisement is required," observed Kanchan Singh, a town resident.

According to Chandrasekhar SHG. president, Dhulana Dehury they have so far sold 50 kilograms of ma nure. "We are getting customers on a daily basis. In future, the number of customers will definitely increase," said Dehury.

When contacted, executive officer, Angul municipality, Binod Chandra Panda said, "Organic manure is being produced at three MCCs in Angul town. As of now, the manure is being produced manually. To increase the production, machines have already been installed at these MCCs but not connected with power sources. Once these machines are made functional, the volume of production will go up. This means we will be converting more waste into money.'

ndia is being criticised by various International Human Rights watchdogs. The United Nations High Commissioner for Human Rights has expressed "concern over restrictions on nongovernmental organisations, arrests of activists and implications of the Citizenship Amendment Act." The Human Rights Watch has recently said, "The Indian government is using counterterrorism operations to silence peaceful dissenters, human rights activists, and journalists." There is much substance to these allegations.

The human rights as enshrined in the Universal Declaration of Human Rights (UDHR) is indeed a milestone when seen in the backdrop of autocracies like Hitler's Germany and slave-harbouring George Washington of the United States. The position of India is different since we had a "developed" concept of society. For us, the Declaration is actually a regression on many points. While taking the above criticisms seriously and restoring human rights as enshrined in the Declaration, India must simultaneously prepare an alternate Declaration and present it before the United Nations. Article 1 of the Declaration stip-

ulates that all human beings are "equal in dignity and rights." Article 3 stipulates that all have rights to life, liberty and security. Article 13 speaks of rights of freedom of movement. Article 26(1) provides for right to education. The difficulty is that no two of these many equalities can go together. If we were to secure equality of dignity between a weak and strong student in the class, it would be necessary to accept inequality of rights between the two. The right of the bright student would have to be restricted and more time provided to the weaker student in the laboratory to establish equality of dignity between the two. No two of these rights can go together. It was necessary to state upfront which would be the key "right" in which equality would be secured; and to acknowledge that inequality in all other parameters would be acceptable. The Declaration is a hotchpotch of mutually inconsistent equalities. Our tradition has specified that

larger social interest.' Article 29(1) mentions that "everyone has duties to the community." But the discharge of these duties is not compulsory. These are empty advice without teeth. Article 26(2) says that education shall strengthen "respect for human rights and freedoms." It does not say that education shall strengthen the respect for "duties to the community." Articles 18, 19 and 20 provide for freedom of thought, expression and assembly. These are not contingent on one

discharging his duties to the com-

munity. The result has been that human beings are not under any obligation to discharge their duties alongside demanding their human rights. This leads to ever increasing violation of the rights of others. Our tradition, on the other hand, speaks only of duties. Gita says "duties alone are your right." The Declaration should be amended to make human rights contingent on the discharge of human duties.

The Declaration endorses the present constitution of the Security Council, which is based on inequality. But the Article 29(3) says that nothing shall be said against the principles of United Nations.

The civil and political rights of all human beings stipulated in Articles 4, 5, 14(1), 15, 16, 19 etc. have universal applicability. But the economic rights are restricted within the borders of nations. Article 13 restricts the freedom of movement to "within the borders of each State." If all human beings in the world are entitled to equal rights then why should certain human beings be restricted from movement into another country? Article 21(2) provides that the right of equal access to public services will be applicable only within 'his country'. Pray, why? When civil rights are universal then why should not access to public services be universal? Article 22 limits the right to social security "in accordance with resources of each State." Why should then political rights also be provided in accordance with resources of each State? The result of these provisions is that the industrial countries can interfere in the affairs of the developing countries in the name of political rights, but the developing countries cannot interfere in the industrial countries to secure their economic rights.

It is high time that we listen to the international criticism of India's recent record on human rights while, at the same time, we must draw up a more just and equitable charter of human rights and present to the UN General Assembly for adoption.

nion Road and Transport Minister Nitin Gadkari's recent sharp rebuke of National Highways Authority of India (NHAI) officials for the delay in the construction of the NHAI headquarters was delivered with his typical smiling demeanor but carried a lethal punch that shocked the babus. It was surprising in its candour (rare for politicians) and turned what was meant to be a joyous event - the inauguration of the building – into a scathing critique of bureaucratic inefficiency in the country.

This was not meant to turn out like this, more than six years into the NDA government. When the Modi sarkar came to power six years ago, it rode in on huge expectations that it would re-energise the economy, oversee infrastructure development, and improve the functioning of the government and tackle corruption.

Many of its big-ticket economic reforms are still on the anvil or have been watered down following political resistance. Two big "reforms", namely demonetisation and a badly implemented GST, have been disastrous. But the one area where the winds of change were felt the most was the bureaucracy.

It is clearly evident that despite what some saw as a streak of authoritarianism in Prime Minister Modi's approach, bureaucracy in India was shaken out of its long slumber and was compelled to sit up and take note of the new style

of proactive governance.

Now, from hearing it from Gadkari, it appears that in this respect, too, the recalcitrant babus have refused to fall in line with the Modi sarkar's stated culture of direct access, simplifying procedures and eliminating delays in decision-making and implementation. The situation seems to hark back to the days when an administrative paralysis had set in during the UPA-II regime. Despite green signals from the highest levels, the babus in Lutyens' Delhi refuse to take a decision and keep the file moving from one ministry to the other.

It is indeed rare for the political executive to haul up the bureaucracy in the manner that Gadkari did, though the present dispensation at the Centre has moved far more decisively against bureaucratic corruption and inefficiency than its predecessors – compulsorily retiring hundreds of babus for corruption and inefficiency. When it came back to power last year, it started with compulsory retirement of 27 IRS officers and followed this up with instructions to various departments to identify deadwood that the government needed to get rid of. This message was underlined again by Gadkari to his captive audience, just in case some babus felt the government was not serious.

But is this the entire picture? Could there be a flip side - that perhaps it is the workman who is quarreling with his tools for his own failures? After all, the same babus, who were lambasted by the minister, used the same rules and procedures to build the national highways at a stupendous rate of 30kms a day! It could also be pointed out that the political executive also should share the blame for allowing the "naalayak" and "nikamma" babus to fester in the system because it suits them and their populist policies?

Can Gadkari and the government seize the courage to follow through with its campaign to purge corruption in governance or will the corrosive forces of corrupt netas and babus manage to paper over the cracks and survive?

#### Bellwether

t's not uncommon these days, even though the word is still widely used, to find it spelled bellweather or even bellwhether. For example - I do not shrink from naming the guilty - the Washington Times for 29 October 2006: "That's why we should have used some bellweather event like the signing of the Iragi constitution, or the parliamentary elections as our moment to declare victory and exit stage left." There's some excuse for this, assuming a lack of prior knowledge and the absence of a dictionary, since the second part of the word is now rare in our urbanised existence. Wether is an old English word for a castrated ram. The experts think it comes from a prehistoric root meaning a year, perhaps because the ram concerned was a yearling; it's a relative of yeal, via the Latin vitulus, a calf. The shepherd used a wether as the leader of the flock, whom the rest would follow. To be sure to know exactly where he was, a bell was hung around his neck. So: bellwether. By the fifteenth century, it was being applied to people, as a contemptuous term for a leader whom only sheep would follow, especially one who possessed a loud mouth but little judgement. That was still in use centuries later, as you may tell from Francis Grose's Dictionary of the Vulgar Tongue of 1811, in which the word is defined as "[t]he chief or leader of a mob". Many patent owners are lobbying to remove limits on eligible inventions, but opposition from other stakeholders, including several software firms, has stalled proposed legislation. Reformers similarly disagree on whether "patent trolls" - firms whose only business is filing patent-infringement lawsuits – are a drag on truly innovative companies, or whether efforts to combat trolls have weakened the US patent system and innovation. The critical role of innovation in addressing the Covid-19 pandemic has only heightened such concerns.

In a recent policy proposal, we argued that there currently is little credible evidence to support strengthening or weakening patent protection, such as by modifying patent-eligibility standards. Nonetheless, the US patent system can still be improved through more modest changes that have stronger empirical support.

For example, while patents are intended to disclose information about new technologies and who owns

both counts. The good news is that the United States Patent and Trademark Office (USPTO) can address both shortcomings without waiting for congressional action.

One way in which patents fail to disclose accurate information stems from the practice of including hypothetical experiments and results, known as "prophetic examples," in ways that are hard to distinguish from real data. Of course, fabricating results in a scientific paper would be considered fraudulent. But, as Fordham Law School's Janet Freilich has documented, prophetic examples are common in granted US patents.

Freilich found that at least 17% of examples in recent US chemical and biological patents are prophetic, and at least 24% of patents with examples include some that are prophetic. Moreover, these hypothetical experiments confuse even qualified scientists. Ninety-nine percent of prophetic patents cited in scientific publications were cited with phrases such as, "has been carried out," suggesting that the authors did not understand that the experimental work in question was hypothetical.

conomic growth is increas- the rights to them, they often fail on prophetic examples by verb tense: examples based on work that has actually been done are typically in the past tense, whereas prophetic examples must be in the present or future tense. Thus, when a patent describes a chemical reaction in which "230 milliliters of hydrogen is attained," or treatment of a patient whose "pain is substantially alleviated," or a diagnostic patch with micro-needles that "automatically draw small quantities of blood." the present tense signals that the work needed to support these claims most likely had not been carried out at the time the application was filed.

But this tense rule can be misleading for non-specialist audiences, including scientists and investors in new technologies. The USPTO can and should require patent applicants to distinguish prophetic examples more clearly from completed work. The USPTO can also address a second flaw of America's patent system: its failure to provide clear notice about who owns patent rights.

The first page of a patent lists the owner at the time it was granted, but if that patent is sold to a new owner, the change does not need to be recorded at the USPTO. And, be-

of referring to patent owners, different names, abbreviations, or spellings for a single company are not uncommon. Even more confusingly, some patent applicants use shell companies to conceal the real owner.

Lack of transparency regarding patent ownership can make it harder for other companies to search for relevant patents and determine whether their products are infringing them or with whom they should negotiate licenses. This needlessly increases business costs.

The USPTO can improve ownership transparency without legislation. Based on this experience, we propose a more tailored set of reforms. For all patents, the USPTO should require owners to link ownership records to unique IDs and to record changes in ownership. This would reduce the patent system's transaction costs while imposing relatively little burden on patent owners.



# UP farmers rewrite their destiny with dragon fruit farming

Lucknow, Nov 20: Four years ago, Ram Sakal Yadav, a young farmer in Uttar Pradesh's Kaushambhi district, had almost packed his bags. He was set to migrate to Mumbai in search of a job that would ensure him a steady income

"Our agricultural income was reducing and the family was increasing. I had no option but to migrate and feed the family", he recalls.

It was then that a district official in Kaushambhi persuaded Ram Sakal Yadav to stay back and try out an alternative.

The then district magistrate, Akhand Pratap Singh, had got saplings of the dragon fruit from West Bengal and he encouraged Yadav and other farmers to plant it. Initially, not many were willing to experiment but later about 60 farmers agreed to plant the sapling. "Within 18 months, the fruits appeared. No one in the village had seen these types of fruits. The district magistrate made arrangements to send the fruit to Mumbai and Delhi and then the profits started pouring in", says Yadav. Sources, however, insist that the



first crop of the fruit was consumed by farmers from the district who wanted to savour its taste

With help from horticulture experts, the local farmers not only started planting trees but even started cultivating saplings that could be exported. "'Degan phal', (as

ance) ne hamari kismat badal di", says Binda Devi, a 62-year-old widow, who has a daughter-in-law and four grandchildren to take care of after her son abandoned them and left home four years ago.

Explaining the technique of dragon fruit farming, Binda Devi says that the tree is very fragile

and needs to be supported by wooden planks. "You can use one wooden plank to support four trees that require mild watering. The fruits start appearing by the end of 18 months and each tree can vield up to 60 to 120 fruits. The officers have helped us understand the details of 'degan phal' farming", she says.

Horticulture expert DK Trivedi said that the soil of Kaushambhi was conducive for dragon fruit farming

'The fruit, also known as 'pitaya', sells in big cities at Rs 350 to 500 per kilogram and the only major cost of cultivation is the wooden planks that are needed to support the tree. One tree yields fruits for several years and animals do not eat it because of the thorns around it", he said.

The fact that dragon fruit is said to be helpful in the treatment of diseases like diabetes and asthma and has anti-ageing and anti-cancer properties, has also made it popular in the region.

A horticulture expert, Mewa Ram, meanwhile, says that there are about 7,500 dragon fruit trees now in Kaushambhi and the fruit from here is sold in Mumbai, Delhi and Madhya Pradesh.

Seeing this, farmers in Sultanpur have also started dragon fruit farming. Gaya Prasad who has opted for dragon fruit farming recently met UP Chief Minister Yogi Adityanath and said that his agricultural income had gone up eight-fold since he started dragon fruit farming.

# **Rescued jumbos celebrate** decade of freedom

Agra, Nov 20: Celebrating a decade of freedom, elephant couple Maya and Bijli Friday enjoyed a grand feast at the Elephant Conservation and Care Centre in Farah on Agra-Mathura district borders

The two spent many hard years in shackles till they were freed by the Wild Life SOS in cooperation with the Uttar Pradesh Forest Department in 2010.

A former circus trained elephant, Maya was forced to undergo a rigorous training schedule to learn entertaining tricks for the audience. On the other hand, her companion, 40-year-old Bijli, was used as a begging elephant in Uttar Pradesh.

A functionary of the Wild Life SOS said, "The life of a performing elephant is an oppressive one. where it is forced to perform unnatural tricks for people's amusement. The elephants are starved and brutally beaten into submission as part of their indoctrination process. Maya would spend hours practicing standing on two legs or to carry circus performers on her



back at the whip of a stick or sharp bullhook ('ankush'). When not performing, she would be restrained by tight ropes and spiked chains around her limbs with no access to food or even clean drinking water."

Years of overwork, abuse and neglect had not only left her with ailments such as swollen limbs, cracked toenails, and damaged footpads and cuticles with severe toenail abscesses, but she also suffered from psychological trauma.

Shortly after her arrival at the Elephant Conservation and Care Centre (ECCC) in Mathura, Maya was introduced to an elephant named Phoolkali, and her presence has played a significant role -( in Maya's decade-long recovery journey.

# **Delhi records** coldest Nov morning in 14 yrs

New Delhi, Nov 20: The national capital recorded a minimum of 7.5 degrees Celsius Friday, the lowest in the month of November in 14 years, according to the India Meteorological Department.

It is Delhi's lowest minimum temperature in November since November 29, 2006, when the city recorded a minimum of 7.3 degrees Celsius, said Kuldeep Srivastava, the head of the IMD's regional forecasting centre. a cold wave when the minimum temperature is 10 degrees Celsius or below and is 4.5 notches less than normal for two consecutive days.

"The criteria has been met on Friday. We will declare a cold wave in Delhi if the situation persists on Saturday," Srivastava said. Delhi had recorded the lowest minimum temperature of 11.5 degrees Celsius last year. 10.5 degrees Celsius in 2018 and 7.6 degrees Celsius in 2017 in the month of November.

The all-time record for the lowest minimum temperature in November is 3.9 degrees Celsius recorded on November 28, 1938. Mahesh Palawat, an expert at

Skymet Weather, a private forecasting agency, said cold winds blowing from snow-laden western Himalayas have led to a dip in the mercury and a similar situation will continue till Saturday.

# Quad coalition's naval drill ends

The court said that marriage which petitioner man wants to perform with a girl, who is his first cousin, was also per se illegal. "...The submission in the present petition that as and when she (the girl) attains the age of 18 years, they will perform marriage is also per se illegal," the judge said on Thursday while hearing the petition.

The assertion came after a 21year-old man moved the high court against state of Punjab seeking anticipatory bail in a case registered under Sections 363 (kidnapping), 366A (procuration of minor girl) of the IPC at police station Khanna City-2 in Ludhiana district on August 18.

The state counsel, while opposing the bail plea, contented that the girl was a minor and her parents had lodged the FIR as she and the man were first cousins and their fathers were brothers. The man's counsel told Justice Arvind Singh Sangwan that the petitioner had also filed a criminal writ pe-



tition, along with the girl, for protection of life and liberty.

The court file of the criminal writ petition was summoned during the hearing and as per its memorandum of parties. the girl was stated to be 17 years of age and the petitioner man had filed the petition with the submission that both of them

were in a "live-in-relationship". It was stated in the petition that date of birth of the girl was August 2003 and on the date of filing the petition on September 3, 2020, she was of the age of 17 years and 14 days. Along with petition, a representation was also annexed, in which the girl had stated that her parents loved their sons but ignored her, therefore, she decided to live with her friend (petitioner) and on that account, she was apprehending that her parents can harass them and disturb the peace

of their mind.

The searches were conducted at the residences of five accused -- Mohamed Aslam, Abdul Latheef, Nazarudheen Sha, Ramzan P and Muhammed Mansoor.

These accused conspired with the already arrested accused and facilitated smuggling of gold through import cargo addressed to the UAE Consulate General, and its disposal, the agency aid. During searches, several electronic items and documents have been seized, the spokesperson said

The NIA has so far arrested 21 people in the case so far. The NIA registered a case to probe the international ramification of the gold smuggling case pertaining to the seizure of 30 kg gold worth Rs 14.82 crore on July 5 this year at Trivandrum International Airport from the baggage addressed to the UAE Consulate in the Kerala capital.

in Gvantse. Two buildings, 12 sheds and other structures have come up in these areas.

# **COVID caseload breaches 90L-mark**

New Delhi, Nov 20: India's COVID-19 caseload surpassed the 90-lakh mark Friday with 45,882 new cases, while the recoveries surged to 84.28 lakh pushing the national recovery rate to 93.6 per cent, according to the Union Health Ministry data.

The total coronavirus cases mounted to 90,04,365 and the death toll climbed to 1.32.162 with the novel coronavirus virus claiming 584 lives in a span of 24 hours in the country, the data updated at 8 am showed. The COVID-19 case fatality rate has further declined to 1.46 per cent. There are 4,43,794 active cases of coronavirus infection in the country which comprises 4.92 per cent of the total caseload, the data stated.

According to the ICMR, a cumulative total of 12.95.91.786 samples have been tested up to

# Ban on 'love jihad' soon, says CT Ravi

Bangalore, Nov 20: A ban on 'love iihad' and cow slaughter would be a reality in Karnataka very soon, BJP national general secretary C T Ravi said Friday.

The former Karnataka Minister, who is in-charge of party affairs in Maharashtra, Goa and poll-bound Tamil Nadu, said a law banning both practices would be passed in the coming Assembly session. He said there are serious deliberations going on in government circles as BJP state president Nalin Kumar Kateel has also urged Chief Minister B S Yediyurappa to take steps in this regard.

"Love Jihad and cow slaughter ban has been approved by the BJP core committee. The clamour to bring in a law banning cow slaughter has grown louder. We intend to do so," the Chikkamagaluru MLA told a press conference. He pointed out that the Karnataka government has already constituted a committee to ban cow slaughter.

Based on its recommendation, the law will be passed shortly, he said. Ravi said he had already spoken to Animal Husbandry Minister Prabhu Chauhan to get "The Karnataka Prevention of Slaughter and Preservation of Cattle Bill" passed in the cabinet and present it in the coming assembly session. The law was to have been passed

in the previous assembly session, but it did not happen " due to political reasons," he said. Claiming that there was a ban on cow slaughter during the reign of Mughal emperor Akbar, Ravi pointed out that the existing law was inadequate

"Collecting fines from offenders will not discourage this practice. We will review the provisions in the anti-cow slaughter laws in Uttar Pradesh and other states," Ravi said. In 2010, the then BJP government led by BS Yediyurappa had got the 'Prevention of Slaughter

and Preservation of Cattle Bill', which proposed to replace the 'Karnataka Prevention of Cow Slaughter and Cattle Preservation Act, 1964', passed.

The bill had widened the definition of 'cattle' and imposed a blanket ban on cattle slaughter, coupled with stringent penalty clauses for violations. However, the Congress government headed by Siddaramaiah that came to power in 2013 withdrew the bill that was before the President for his assent

On 'Love Jihad', Ravi had said earlier this month that on the lines of the Allahabad High Court's order. Karnataka would enact a law banning religious conversions for the sake of marriage. "We will not remain silent when Jihadis strip the dignity of our sisters," he had said, adding that anyone involved in any act of conversion would face severe and swift punishment.

The Allahabad High Court in its October 31 order said that religious conversion just for the sake of marriage was not valid. The court made the remark while dismissing a plea by a newly married couple in Uttar Pradesh that had approached it to direct police and the woman's father not to disturb their marital life. In the petition, it was stated that the couple got married in July this year, but family members of the woman were interfering in their marital life.

Sources say the internal crisis could be related to the Rajya Sabha elections in which senior leaders like Ghulam Nabi Azad and Anand Sharma, whose terms are expiring were overlooked, and people close to Rahul Gandhi like K.C. Venugopal and Rajeev Satav were nominated.

A Congress leader questioned if the party will be able to send a north Indian leader from the south to the Rajya Sabha. While leaders

#### like Mukul Wasnik were hoping to be nominated, however, except for Digvijaya Singh and Mallikarjun Kharge, most of the senior leaders were ignored.

Even Jitin Prasada, Sandeep Dikshit and Randeep Surjewala, who hoped for tickets, were denied the opportunity. The former two were signatories in the letter written to Sonia Gandhi. The earlier Rajya Sabha elections also saw the revolt and exit of Jyotiraditya Scindia which cost Congress its Madhya Pradesh government.

The dissenting leaders want fresh organisational elections from block to the Congress Working Committee level to rejuvenate the cadres. The party's central election authority (CEA) has met twice to set the ball rolling for elections, and has sought the list of the AICC members but the G23 wants that process of AICC members elections should be done first as the old system of nomination should be done away with, and the election of the party president should be done only after new AICC members are elected.

# For Himachal farmers tomatoes are 'apple of their eyes'

Shimla, Nov 20: Tomatoes turned the new 'apple of eyes' for the Himachal Pradesh farmers this season, literally.

The reason: lack of plantation amidst Covid-19 scare in the kharif cropping season has drastically reduced its overall production in Himachal Pradesh by 35-40 per cent, triggering a massive price hike for the vegetable in north Indian cities.

Currently, the tomatoes are selling between Rs 50 and Rs 65 per kg in Chandigarh and Delhi retail markets, much higher than the price of Rs 20 to Rs 25 they got last year at this point in time, say traders. In Solan town, the hub of tomato plantation, its price ranging between Rs 40 and Rs 45 per kg in whole-



sale With majority of vegetables gone

rotten in the fields, or lying unsold or unharvested due to the coronavirus-induced lockdown from April. the growers in the state were uncertain about the future of kharif crops from August to November, an official with the Agriculture Department familiar with the development said.

He said the farmers opted less plantation of kharif vegetable crops owing to fear and uncertainty. "Our

vegetable crops largely remained unsold during the lockdowns. That is why we have decided to go for less plantation of vegetables during the kharif season. So was the low yield of most of the vegetables that led to shortage and rise in prices," vegetable grower C.D. Verma of Jubbarhatti village, on the outskirts of the state capital, said.

He said during the harvesting season of tomatoes in June-July, its production was good but there was no market owing to countrywide lockdown. Like other vegetables, most of the tomatoes remained either unsold or unharvested. "The farmers who went for normal plantation despite uncertainty and odds, they are making money now," an elated Verma added.

Trade representatives said 80-90

per cent of the tomato crop in the state had sold out. Puran Chand, an agent at Shimla market, said the supply of tomatoes from the local fields has declined with its harvesting almost over. "Now tomatoes from Delhi are meeting the local demand.

Himachal Pradesh is a major tomato-producing state of the region. As per 2019-20 figures, tomato was grown in 13,185 hectares in the state. The total production in 2019-20 was 5.39.540 tonne against 5,02,422 tonne in 2018-19. It was 4,81,936 tonne in 2017-18. About 50 per of the state's total plantation is Solan district with more than 90 per cent of the produce going to markets in northern states. The other growing belts are in Shimla, Mandi, Sirmaur, Bilaspur and

Kullu districts. Ramesh Thakur, a farmer near Kandaghat town, said this season tomato selling turned profitable.

"In July, the price of tomato during lockdown was Rs 15-Rs 20/kg and now tomato is selling for Rs 40-50/kg in the wholesale," he added.

Sellers at the Solan wholesale vegetable market said now the tomatoes from Delhi and Bangalore would meet the demand in north Indian cities till the next crop from Himachal Pradesh will start ar- 🔫 riving in June.

# China will have to play by rules: Biden

#### PRESS TRUST OF INDIA

Washington, Nov 20: US Presidentelect Joe Biden has said that he wants to make sure that China plays by the rules and announced that his administration will rejoin the World Health Organisation (WHO).

Biden was responding to a question Thursday about his remarks during the presidential debates that he wanted to punish China over the way Beijing has been behaving. He was asked if that could include economic sanctions or tariffs on China, the world's second largest economy.

In April, President Donald Trump announced that the US would withdraw from the WHO, accusing the UN organisation for failing to oversee the onset of the coronavirus as it began to spread in China.

"It's not so much about punishing China, it's about making sure China understands they've got to play by the rules. It's a simple proposition," Biden said during a meeting with a bipartisan group of governors in his hometown in Wilmington, Delaware.

He said that is one of the reasons why his administration is going to rejoin the World Health Organisation.

# Morrison vows justice for alleged crimes in Afg

Canberra, Nov 20: Australian Prime Minister Scott Morrison has vowed that allegations of war crimes committed by his country's soldiers in Afghanistan between 2005 and 2016 will be taken "very seriously".

The Australian Defence Force (ADF) Thursday released the findings of a landmark four-year inquiry that found "credible evidence" of the special forces soldiers' murdering 39 prisoners, farmers and civilians during the war in Afghanistan, reports Xinhua news agency.

It recommended that the Australian Federal Police (AFP) open criminal investigations into 19 individuals for their roles in the incidents. Morrison, who previously warned that the report contained "difficult and hard news" for Australians, said the allegations would be pursued until "justice is indeed served".

'Where things don't measure up to those standards as a country and indeed as a Defence Force, we look seriously at those issues, take them seriously and deal with them seriously to uphold those standards," he told



"The selfie-taking and sharing is such a big part of Indian women's lives that it affects their behaviour and even household economics: several women reported that they never wear the same dress again if



they had taken a selfie in it," it said. "As a young women reported, 'I told my mom, I'll never wear this dress again because I posted a selfie in it. She said, 'do you think money comes from the trees?" the study

said. Indian men are also active selfie-takers and users of filters but they tend to focus more on the story aspect rather than their appearance, it said.

Indian respondents expressed

low levels of concern about the impact of filters on their or their children's wellbeing. They exhibit a relaxed attitude towards their children's use of filters, considering it a fun activity, it said, adding that some parents are comfortable using slight beautification filters like lipstick on their child's photo.

Indian parents were more concerned about their children's excessive use of mobile phones or privacy and safety of smartphones rather than the use of filters, it said. Indian respondents are sensitive

to the social ramifications of overfiltering. While some levels of filtering are widely accepted (brightening background, lightening skin tone, application of makeup), major changes that alter the appearance (high cheekbones, eyebrows, hair color) are considered unacceptable, it said.

Respondents in India, similar to other countries, strive for a natural look in their filtered photos. However, their idea of "natural" is much more liberal, with some facial alterations acceptable, the study said.

"The quality of phone camera is very important to Indian users: it's the most important factor in selecting a new phone. Both men and women in India reacted very positively to having automatic beatification function on their phone's cameras. Like respondents in other countries, they do want to have theability to control the on and off setting," it said.

# EU could pay over \$10bn for Pfizer, CureVac vaccines

THE BLOC HAS AGREED TO PAY 15.50 EUROS PER DOSE FOR THE COVID-19 VACCINE CANDIDATE BEING DEVELOPED BY PFIZER AND BIONTECH

Brussels, Nov 20: The European Union could pay more than \$10 billion to secure hundreds of millions of doses of the vaccine candidates being developed by Pfizer-BioNTech and CureVac, an EU official in-

volved in the talks told Reuters. The bloc has agreed to pay 15.50 euros (\$18.34) per dose for the COVID-19 vaccine candidate being developed by Pfizer and BioNTech, according to the official.

That would mean an overall price of up to 3.1 billion euros (\$3.7 billion) for 200 million doses, rising to 4.65 billion euros if another optional 100 million doses are purchased under the deal, the official said. The pricing information, previously undisclosed, confirms the EU is paying less per dose than the United States for an initial supply of that vaccine, as reported by

Reuters last week. The deal includes an insurance for EU countries to get compensation if the companies divert doses to the United States, according to the source, who requested anonymity due to the sensitivity of the matter.



The EU has separately agreed to pay 10 euros (\$11.84) per dose for an initial supply of 225 million doses of the vaccine candidate from CureVac. a discount from the 12 euros the company set as the price

for the shot, the official said. The bloc struck the deal with CureVac this week to secure the supply of up to 405 million doses. of which 180 million are optional. The official said CureVac had committed to starting deliveries by the end of March. It is unclear

whether the additional 180 million doses would cost 10 or 12 euros each. Under the 10-euro price. though, the bloc would pay 4.05 billion euros for 405 million doses. A spokesman for the European Commission, the bloc's executive

#### **Bank credit rises** 5.67 pc: RBI data

Mumbai: Bank credit grew by 5.67 per cent to ₹104.04 lakh crore, while deposits increased by 10.63 per cent to ₹143.80 lakh crore in the fortnight ended November 6 according to RBI data. In the fortnight ended November 8, 2019, bank credit stood at ₹98.46 lakh crore and deposits at ₹129.98 lakh crore. In the previous fortnight ended October 23, 2020, bank credit had risen by 5.06 per cent and deposits by 10.12 per cent.

Of the 18 IOAs identified, 10 are already mature investable areas that have seen good Private Equity and Venture Capital activity, and feature companies that have been able to unlock scale and demonstrate profitability. The remaining eight IOAs are emerging opportunities, which have seen traction from earlystage investors. The map has also identified eight White Spaces, which have seen investor interest and have the potential to grow into IOAs within a 5-6-year horizon. However, these require further policy support and private sector participation to mature into commercially attractive IOAs, UNDP said.

Nearly 50% of the shortlisted IOAs have historical investments that have yielded IRRs in excess of 20%. About 84% of the IOAs have investment timeframes ranging from the short term (less than 5years) to the medium-term (between 5-15 years).

# Former India pacer feels bowlers will decide the fate of India-Australia series

Mumbai, Nov 20: Former left-arm pacer Zaheer Khan believes bowlers will decide the fate of this summer's India-Australia contest as both the teams boast of some of the world's finest bowlers in their squads.

The Indian cricket team is currently in Australia for a full series that includes three ODIs and as many T20 Internationals followed by a four-Test rubber. The tour will start with the ODIs here November 27.

With the likes of Jasprit Bumrah, Mohammad Shami, Mitchell Starc and Pat Cummins, to name a few, up their ranks, both India and Australia have formidable bowling attacks.

"The Australian pitches have alwavs had good bounce and pace, so I think the area which will decide the ODIs, T20Is and Tests will be the bowlers and how well the team bowls as a unit to restrict the opponent to a lower total on the scoreboard," said Zaheer, who was part of the 2011 World Cup winning Indian team. "When someone talks about the top line bowlers in the world right now, the names of the players that come to our mind will all be on the

pitch in this series," he added.

Zaheer also said that India are set to face a stern test in Australia this summer due to the presence of Steve Smith and David Warner.

India had defeated Australia 2-1 in their last Test series Down Under in 2018-19 in the absence of Warner and Smith, as both the players were serving an year-long ban for the infamous ball tam-

pering scandal. "Now with the return of Steve Smith and David Warner to the Australian side, the Indian team is definitely going to face a stiffer competition than their previous tour Down Under," the former India

fast bowler said in a release issued by official broadcasters of the series, Sony Pictures Sports Network.

"There are no favourites going into the series as both the sides have quality batting and bowling line-up in their squad and that is what will make the upcoming tour interesting and exciting to watch."

Zaheer's thoughts were echoed by Australian pace legend Glenn McGrath, who also feels that the Virat Kohli-led side will face a tough competition this time around.

'The Indian cricket team will face a much tougher Australian team now that Smith and Warner are back but the Indian team is



equally strong and have an aggressive mentality and determination to win the series," said McGrath, who has staggering 563 Test wickets.

'The current Indian team has got the confidence of playing in Australian conditions now and they know how to do it as they've been successful here in the last tour."

Former India batsman Sanjay Manjrekar too feels the same. "Australia's Test team will be stronger than it was on India's



# Keeping Kohli quiet key to success: Pat

Sydney, Nov 20: Australia speedster Pat Cummins expectedly considers Virat Kohli the 'big' wicket he would target in the upcoming series against India and said that keeping the visiting captain quiet would be crucial to the home team's chances.

The Indian cricket team are currently in Australia for a full series that includes three ODIs and as many T20Is followed by a four-Test rubber. The tour will start with the ODIs here November 27.

"I think every side has that one or two batters and they are the big wickets. Most teams have their captain - Joe Root for England, Kane Williamson for New Zealand. You feel like if you get their wickets that go a long way in winning the game," Cummins told 'Fox Cricket'.

"He (Kohli) is always a big one. You commentators talk about him non-stop, so hopefully, we can keep

him quiet," he added.

Cummins, who has been named in both the white and red-ball squads as vice-captain, is one of the 11 Australian players currently quarantining here after returning from the UAE where he played for Kolkata Knight Riders in the IPL. Their quarantine period will end on the eve of the opening ODI against India at the Sydney Cricket Ground.

Cummins said Australia is well prepared to give India a tough fight in the series. "It's going to be huge. Obviously, we're back here on home soil. Other than spending a lot of times in hotels and bubbles I feel like our preparation has actually been really good.

'We went over to the UK and had a good tour there. Most of the boys here have been playing 14 T20 matches in the last few weeks and the other guys coming in will be playing shrewd cricket. So, it feels like we are all firing up and got a lot of stuff behind us," he said.

However Maxwell is a big fan of Agarwal-Rahul opening pair that did really well during the first phase



London, Nov 20: Rafa Nadal advanced to the semifinals at the ATP Finals for the first time in five years and knocked out the defending champion in the process, beating Stefanos Tsitsipas 6-4, 4-6, 6-2 at the O2 Arena.

Novak Djokovic also advanced to the semifinals and eliminated Alexander Zverev by beating the German 6-3, 7-6(7-4).

The top-ranked Djokovic set up a match against Dominic Thiem Saturday as he goes for a recordtying sixth title at the season-ending event, and a first since 2015.

It is the sixth time in 10 appearances that Nadal has reached the last four of the season-ending tournament, which is the biggest title he has yet to win in his il-

#### lustrious careers.

Tsitsipas won it on his first try last year but exited after a second loss of the group stage, done in by a shaky serve in the third set when he was broken three times.

Earlier Thursday, the already eliminated Andrey Rublev beat US Open champion Thiem 6-2, 7-5 in a contest that had little real conse-

quence for either player. Thiem was assured of winning the group after beating Tsitsipas and Nadal

in the first two rounds. Nadal never looked threatened on his serve against Tsitsipas until the final game of the second set, when he double-faulted to hand the Greek a way back into the match. Suddenly, neither player could hold serve as the third set started

with three straight breaks, with Nadal taking a 2-1 lead. The Spaniard

finally held and broke again for a 5-2 lead before the clinching the win on his second match point.

Nadal, who improved to 6-1 against Tsitsipas, will play Daniil Medvedev in the semifinals Saturday.

The early match between Thiem and Rublev was delayed after the lights went out unexpectedly at the O2 Arena. Thiem was short of energy, too, when play eventually began.

"It was difficult to keep that amazing intensity like I had in the first two matches," Thiem said. "I wanted to win the match, 100 per cent, but the first two matches were pretty tough, pretty long. So with the fact I was already qualified, in the back on my mind it was difficult to keep the intensity alive."

Rublev played like someone with nothing to lose, overwhelming Thiem with his serve and fierce groundstrokes to take the Austrian's first two service games and clinch the first set in less than 26 minutes. He dropped only three points on serve and had no unforced errors in that set.

The second set was much closer, though Rublev was on top and serving at 4-3 when he lost eight straight points to get back on serve.

Rublev regrouped, broke Thiem after a long next game featuring some intense rallies, then served out the match for his first win in his debut at the season-ending tournament.

"It was not easy for Dommy." said Rublev, who has won five events on the tour this year in a breakthrough season. "I think he (was) focused on the semis. I wish him good luck — he deserves to be where he is and he deserves to win the title.

Manchester, Nov 20: Pep Guardiola distanced himself Friday from suggestions that his decision to extend his contract at Manchester City was linked to the possibility of Lionel Messi moving to the club next year.

City was linked with the 33-yearold Messi after he put in a transfer request at Barcelona during the offseason. The Argentina forward ultimately chose to stay at Barcelona, somewhat against his own wishes, but his contract expires at the end of the season.

Guardiola signed a new two-year deal with City this week that ties him to the club until 2023. He was asked Friday whether the possibility of working with the six-time world player of the year again was motivation for his decision.

"Leo Messi is a player from Barcelona. And you ask me my

opinion, as a person who has huge gratitude for what Barcelona has done for me in the academy as a football player and, after, a manager who gave me absolutely everything, what I want is he finishes his career there," Guardiola said.

"That is what I want. I would wish—as I've said I don't know how many times, maybe a thousand times — I would like as a Barcelona fan for Leo to finish there.'

It is not the first time Guardiola has downplayed a talk of a reunion with his former player at City. This time, though, he left the door ajar.

"But he finishes the year of his contract," he added. "I don't know what is going to happen in his mind. Right now, he is a Barcelona player. The transfer market will be in June, July. We have incredible targets we want to achieve and this is all we have in our minds. The rest I cannot say anything else."
