Ex-Assam CM Gogoi dies at 86




Guwahati: Former Assam Chief Minister Tarun Gogoi died here Monday while undergoing treatment for post-COVID-19 complications, state Health Minister Himanta Biswa Sarma said. He was 86 and survived by wife Dolly, daughter Chandrima and son Gaurav, a Lok Sabha member. Gogoi, a three-time CM of the state from 2001 to 2016, breathed his last at the Gauhati Medical College and Hospital (GMCH) at 5.34 pm, Sarma said. The doctors conducted an ECG and found that his heart has stopped, following which the **GMCH** superintendent confirmed that he is no more, he said. The veteran Congress leader was first admitted to the hospital August 26.

AstraZeneca shot scores 90 per cent

London, Nov 23: Britain's AstraZeneca said Monday its vaccine for the novel coronavirus could be around 90% effective without any serious side effects, giving the world another important tool to halt the COVID-19 pandemic.

The vaccine developed by Oxford University was 90% effective in preventing COVID-19 when it was administered as a half dose followed by a full dose at least one month apart, according to data from the late-stage trials in Britain and Brazil.

No serious safety events related to the vaccine have been confirmed and it was well tolerated across both dosing regimens, it said. "This vaccine's efficacy and safety confirm that it will be highly effective against COVID-19 and will have an immediate impact on this public health emergency," Pascal Soriot, Astra's chief executive, said in a statement.

AstraZeneca will have 200 million doses by the end of 2020, with 700 million doses ready globally by the end of the first quarter of 2021, operations executive Pam Cheng said on Monday.

The vaccine's effectiveness depended on the dosing, and fell to just 62% when given as two full doses rather than a halfdose first. But scientists cautioned against seeing this as evidence that it would be less useful than rival vaccines from Pfizer and Moderna, which each prevented about 95% of cases, according to interim data from their late-stage trials.

"I think it is a real fool's errand to start trying to pick these three (Pfizer/Moderna/Astra) apart on the basis of snippets of phase 3 data from press releases," said Danny Altmann, pro-

Scientists also noted there may be advantages to AstraZeneca's vaccine. "Importantly, from what we have heard the vaccine seems to prevent infection not just disease. This is important as the vaccine could reduce the spread of the virus as well as protect the vulnerable from severe disease," said Peter Horby, a professor of emerging infectious diseases and global health at the University of Oxford.

AstraZeneca's vaccine can also be distributed more easily because it can be kept at refrigerator temperature, unlike the drugs from Pfizer and Moderna which have to be stored frozen. That would make the AstraZeneca shot easier to transport and store globally, particularly in lower and middle-income countries.

Guv appoints VCs for six varsities

Bhubaneswar, Nov 23: Governor and Chancellor of Universities of Odisha Ganeshi Lal appointed Vice-Chancellors (VCs) for six universities of the state Monday.

The Governor appointed Aparajita Chowdhury, Sabita Acharya, Dinabandhu Sahoo, N Nagaraju, Kishore Kumar Basa and Prafulla Kumar Mohanty as VCs of Rama Devi Women's University, Utkal University, Fakir Mohan University, Gangadhar Meher University, North Odisha University and Khallikote University respectively.

In exercise of powers conferred under sub section (1) read with sub-section (7) of section 6 of Odisha Universities (Amendment) Act, 2020, Lal appointed VCs for a period of four years with effect from the date they assume office as such or until further orders whichever is earlier.

Chowdhury was former director, College of Development Council and Professor of Home Science, Berhampur University having more than 37 years of teaching experience. Likewise, Sabita Acharya, formerly chairman, Post Graduate Council and Professor of Anthropology, Utkal University has more than 31 years of teaching experience.

With more than 26 years of teaching experience Dinabandhu Sahoo currently serves as Professor at University of Delhi. Similarly, Nagaraju presently works as Professor in English, Central University of Karnataka.

Basa has 38 years of teaching experience and was Professor Tagore National Fellow, University of Culture, Government of India. Mohanty, a former Professor of Zoology, Utkal University has 35 years of teaching experience.

RT-PCR –ve a must for entering Maha

Mumbai, Nov 23: Maharashtra government Monday made it mandatory for those seeking to enter the state from Delhi, Rajasthan, Gujarat and Goa to carry RT-PCR negative reports. For those flying in, the RT-PCR sample collection should have been done within 72 hours of scheduled time of landing at airports in Maharashtra, a government order said.

In case of journey by trains, the collection of RT-PCR samples should have been done within 96 hours before the scheduled arrival in Maharashtra, the notification issued Maharashtra chief secretary Sanjay Kumar said. There will be mandatory screening at border check posts for people coming by road. Passengers without symptoms will be allowed entry. Road travellers with symptoms shall have the option of turning back and going to their home to recuperate. The four states -

Stir by workers made unlaw

Bhubaneswar, Nov 23: The Odisha **Essential Services Maintenance** Amendment Bill, 2020, which was passed by the State Assembly Monday, has made strike by employees engaged in essential public services unlawful.

The Odisha Essential Services (Maintenance) Act, 1988 was enacted to provide for the maintenance of certain essential services and ensure normal life of people in the state.

"In order to expand the scope of services covered under the Act. other services disruption of which results in grave hardship to the general public and jeopardise the administration, are proposed to be brought under its purview by way of amendment," Minister of State (Mos) for Home Dibya Shankar Mishra said.

Making an amendment to section 2 of the Act, the government prohibited disruption in services related to fire service, public order, public safety and security. Services connected with excise, forest, prison and correctional service have also been brought under its purview.

Similarly, services in the establishments, undertakings and agencies of the state government connected with the matters related to electronics and information & communication whose interruption would affect public administration has been included in the Act, Mishra said.

The government has also included another sub-clause in the Act, which says, "Any other service in connection with the affairs of the state on which the state government is of the opinion that strikes therein would prejudicially affect the maintenance of any public utility service or services necessary for life of the community, it may, by notification, declare to be an essential service for the purpose of this Act.' It means the government has the

power to impose ESMA on any public utility service by issuing a notification.

In the existing Act, the government has included services connected to transportation, water supply, public health & sanitation and power supply under the ESMA. The government has also included provisions for penalty and punishment for irate employees and in-

As per the new norms, an individual who expends or supplies money in furtherance of or in support of strike which is illegal under the Act, will be punished with imprisonment for one year or with fine upto ₹5,000 or both.

Similarly, the amended Act has provision to take disciplinary action against an employee who participates in a strike which is illegal under the Act or instigate others to hold such strike.

The Assembly also passed Bills for minor amendment to the Odisha Lokavukta Act. 2014 and Odisha Local Fund Audit Act, 1948.

State tweaks school merger plan

Bhubaneswar, Nov 23: Conceding the demands of the Opposition, the state government Monday decided to modify the criteria for merger of government schools in the backward KBK (Koraput-Bolangir-Kalahandi) region.

Making an announcement in the Assembly Monday, School and Mass Education Minister Samir Ranian Dash said the schools having less than 15 students instead of 20 as decided earlier in the KBK areas will be merged. The same relaxation will be given for scheduled areas as well, he said. Following a day-long debate in the house Sunday, the minister had agreed to relax the school merger criteria for scheduled areas even though Opposition members demanded relaxation for both KBK and tribal areas.

Opposition members Monday

raised the issue in the floor of the house to pile up pressure on the government.

Participating in a debate on the issue, Leader of Opposition PK Naik, Congress Legislative Party (CLP) leader Narasingha Mishra, other Congress leaders Sura Routray and Taraprasad Bahinipati have demanded relaxation in the school merger norms for the non-scheduled

areas of the KBK region. The state government had iden-

tified 14,382 schools having below 40 students. However, after scrutiny at the district and state-level, the number comes down to 7,772, of which 6.048 schools have student strength of less than 20. To implement the decision, the government is going to spend around ₹300 crore. The merger of schools had been planned in accordance with the law and guidelines of the Niti Aayog. Besides, the new National Education Policy 2020 also



FUEL PRICES UP FOR FOURTH DAY IN A ROW

Bhubaneswar, Nov 23: Petrol and diesel prices in the city went up again for the fourth day in a row. Petrol price went up by ₹0.07 and diesel by ₹0.19 Monday. With the addition, petrol price stood ₹82.17 and diesel at ₹78.

International oil rates broke a nearly two-month-long hiatus in price revision. Petrol price in Delhi Monday was hiked to ₹81.53 a litre from ₹81.46 per litre, according to a price notification from oil marketing companies. Similarly, diesel prices rose to ₹71.25 a litre in Delhi from a level of ₹71.07 a litre Sunday.

State-owned fuel retailers started raising fuel prices from Friday. In four days, petrol price went up by 47 paise and diesel rates have risen by 79 paise per litre. Petrol prices had been static since September 22, and diesel rates hadn't changed since October 2.

Though retail pricing of petrol and diesel has been deregulated and oil marketing companies were following a daily price revision formula, the same was suspended for almost two months to prevent volatility in international oil markets from impacting fuel prices

regularly during the pandemic. But with crude on the boil again on news of a successful coronavirus vaccine launch soon, the OMCs have finally resorted to price increase again to cover for their under-recovery on the sale of two petroleum products.

The benchmark Brent crude has crossed \$45 a barrel on Intercontinental Exchange (ICE). It has remained at over \$43 a barrel for most part of November.

The OMCs need almost $40\,\mathrm{paise}$ per litre increase in retail price of petrol and diesel to cover for \$1 increase in crude. Going by this yardstick, product prices would have to be increased by up to ₹2 per litre to cover under recovery on its sale.





Bhubaneswar, Nov 23: Even though a slew of measures have been undertaken to motivate parents/children towards governmentrun schools, enrolment in these schools continues to take a nosedive each passing year.

The state-run primary schools have failed to enrol a large number of students in the past few years whereas the admission rate is higher in private and English-medium schools. This was revealed from a written reply given by School & Mass Education (S&ME) Minister Samir Ranjan Dash in the Assembly,

As per data given by the minister, altogether 65,43,973 students were enrolled in government schools across the state in the year 2014-15

BLEAK **SCENARIO**

The state-run primary schools have failed to enrol a large number of students in the past few years whereas the admission rate is higher in private and English-medium schools

Altogether 65,43,973 students were enrolled in government schools across the state in the year 2014-15 which came down to 63.91.248 in 2015-16

The enrolment further went southwards from 62,30,310 in 2016-17 to 59,43,448 in 2017-18

However, the enrolment in private schools has increased by 3,02,212 during 2014-15 to 2019-20

Enrolment dips in state-run schools

which came down to 63,91,248 in 2015-16. The enrolment further went southwards from 62,30,310 in 2016-17 to 59,43,448 in 2017-18.

The minister's reply also revealed that the enrolment further declined to 57,42,649 in 2018-19 and 55,47,116 the next year.

In total, the student strength in government-run schools has come down by 9,96,857 between 2014-15 and 2019-20 academic sessions.

However, the enrolment in private schools has increased by 3,02,212 during the same period. The number of students enrolled in all privates schools of the state in 2014-15 was 10,68,069. However, this has increased to a whopping 13,70,281 in 2019-20.

Interestingly, the total number of students in both government and private schools in Odisha is also showing a decreasing trend. The number of students in both private and government schools in the year 2014-15 was 76.12.042 which declined to 69,17,394 in the year

Similarly, the enrolment of SC and ST students also decreased each vear during the period. The number of SC students has come down to 13,17,369 in 2019-20 from 14,58,553 in 2014-15 whereas the number of ST students has declined by 2,35,612 during the period.



ODISHA'S COVID-19 TALLY CLIMBS TO 3,14,629 WITH 668 MORE PEOPLE TESTING POSITIVE **FOR THE VIRAL INFECTION IN 24 HOURS**

Bhubaneswar, Nov 23: State's Covid-19 caseload rose to 3,14,629 with 668 people testing positive for the viral infection, while 17 more fatalities pushed Odisha's death toll to 1,657, an official of Health and Family Welfare (H&FW) department said.

Of the new cases detected from 28 districts, 385 were reported from different quarantine centres, while the remaining 283 were local contact cases.

Nuapada district registered the highest number of 68 infections followed by Khurda at 56 and Sundargarh at 55.

Taking to Twitter, the H&FW department said, "Regret to inform the demise of seventeen #COVID19 positive patients while under treatment in hospitals."

The deaths were reported from Khurda, Sundargarh, Sambalpur, Bargarh Jharsuguda, Bolangir and Kendrapara districts, the official said.

A total of 53 other Covid-19 patients have also died in the state due to comorbidities, said the official. Khurda district alone accounted for 280 deaths followed by Ganjam at 239, Cuttack at 132 and Sundargarh at 127.

The state has thus far conducted over 56.04 lakh sample tests, including 40,606 Sunday. The positivity rate stands at 5.61 per cent.

Meanwhile, another 913 Covid patients recovered in Odisha. taking the total recoveries in the coastal state to 3,06,726, the H&FW department tweeted.

The recovered cases include 118 from Sundargarh, 111 from Mayurbhanj, 66 from Cuttack, 64 from Angul and 62 from Khurda, the department said.

Sambalpur, Nov 23: As many as 6,545 specially-abled students in the state studying in special schools and a college have been deprived of education with the institutions remaining closed due to Covid-19 pandemic, a report said.



2 killed, 5 injured as pickup van rams into kutcha house

Specially-abled students' studies suffer Pvt nursing homes, clinics in Angul 'fleecing' patients

Angul, Nov 23: Private clinics and nursing homes that have mushroomed in Angul district are harassing and fleecing innocent and gullible patients, a report said.

A private nursing home at Similipada is a case in point. Here, an operation was performed on a patient and then he was sent home. saying the operation had failed. The relatives of the patient were also forced to deposit Rs16, 000 to get their patient back home.

A resident of Gadatmul area in Angul district, Deepak Gochhayat had done ultrasound of his stomach at an ultrasound clinic in Angul town following stomachache. He was told he had a stone in his stomach. To be sure, he had visited an ultrasound clinic in Cuttack. The report said he had a stone in his gall-

He had consulted a nursing home located in Similipada where he was told that the entire cost of the operation would be around Rs 30,000 and he had to deposit ₹15,000 before the operation and the rest after the operation. Accordingly, family members had admitted Deepak to the nursing home November 18. They deposited ₹15,000 advance

The doctor performed the operation November 20. As the operation was carried out through laparoscopy, Deepak's belly was punctured at three places.

But to the utter dismay of their family members, the nursing home authorities told them that the op-

eration was not successful. Later, the doctor asked them to take their patient to somewhere else as the stone had slipped into his intes-

Hearing this, Deepak and his family members felt the ground slipping beneath their feet. They were also told that the money deposited with the nursing home as advance would be refunded.

But it was when the family members were taking Deepak out of the hospital after discharge, they were asked to deposit a sum of ₹16,000 towards bed charge, medicine and the laparoscopy camera.

Though the family members and the nursing home authorities had a verbal duel, the former ended up coughing up the sum. They settled the sum with the advance money and returned home.

This incident is just the tip of the iceberg. Though such cases are happening on a regular basis, the district administration is allegedly looking the other way, the report

Even if complaints are lodged, no action is being taken against such nursing homes.

Folklore has it that the shrine has magical healing powers. Elderly persons in the know of things said that villages hit by cholera or chicken pox used the sandals to prevent the spread of the diseases. "Whenever, the sandals were taken to the affected villages, the disease would disappear mysteriously," said a senior resident of the locality. People of nearby Charinangal, Manduka, Nalipur and Gopalpur villages also had many such instances to narrate.

You cannot get someone who can say for sure how old is the dome.

But, historian Harishchandra Prusty believes it dates back to 12th or 13th century.

Every year, the 'World Heritage Week' is observed from November 19 at the site of the dome. During the week, meetings and seminars are organised and decisions are taken to develop the heritage sites. However, development work has never started. This is the reason why the shrine is facing several problems.

Earlier, people would cultivate the lands around the shrine as a token of respect for 'Pir Baba'. Now. however, nothing happens as most

of the land is encroached upon. Local people say the ancient shrine has all the qualities that a famous religious tourist spot requires. It only needs government attention. Once the spot is developed, it will attract tourists from far and near. They have urged the government to announce the shrine as a tourist spot during the ongoing 'World Heritage Week' and take steps for its overall development.

he covert rendezvous with Crown Prince Mohammed bin Salman of Saudi Arabia on Monday is a major political and diplomatic victory for Israeli Prime Minister Benjamin Netanyahu coming as it does a little over two months after signing a peace deal with the UAE and Bahrain. Normalising relations with the Middle East has been a priority for

Netanyahu who has long argued that Israel can and should make peace with the Arab world without needing to find a lasting peace settlement with the Palestinians and his recent overtures with the Middle Eastern countries suggest that he may be making all the right moves.

Normalising relations with the UAE and Bahrain was a genuine achievement for the Israelis. Recent months have seen a dramatic change in the diplomatic landscape of the Middle East with US President Donald Trump's sonin-law Jared Kushner serving as a go-between, linking the Gulf states and Israel. However, the latest meeting has surprised many as Saudi has maintained, until recently, that they would wait for a Palestinian state before any official relationship with Israel.

For such a long time, Israel-Palestinian conflict was the central issue on the global diplomatic agenda. However, of late, the issue has been pushed off the agenda and there is no serious diplomatic impetus to solve the decades-old vexatious issues.

Trump's policies in the Middle East also favoured the Israelis. From moving the US embassy to Jerusalem to Mike Pompeo's recent visit to the occupied Golan Heights, every decision of Trump in the Israel-Palestine conflict angered the Palestinians while cheering Israel.

With his latest move, the Israeli prime minister has not only managed to marginalise the Palestinian cause but found an ally against a common

Iran held sway across the Middle East and Moslem world and projected itself as the champion of the Moslem cause, a role Saudis have coveted but never quite managed to achieve. Saudis also tried to undermine Iran's influence in the region but failed to achieve anything concrete so far. Their puny but next-door-neighbour, Yemen, has been a long time ally of Iran.

Meanwhile, tensions between Israel and Iran have increased after President Donald Trump unilaterally pulled the United States out of the Joint Comprehensive Plan of Action—the 2015 accord to wind back Iran's nuclear program in return for sanctions relief — in 2018.

Netanyahu sees Iran as Israel's number one enemy. Israel and Iran have been antagonists since the 1980s. But, after the US' 2003 invasion of Iraq and the formal withdrawal of American troops in 2011, the regional balance of power was broken. This left the Middle East without a clear leader. That created a vacuum that has brought the countries into increasing conflict.

For Netanyahu, who formed a national unity government with rival Benny Gantz after failing to secure a clear election victory, and faces an indictment for bribery, fraud and breach of trust, this is not only a major triumph but will also help him to divert attention within the country from the corruption charges and his government's failure to effectively tackle the coronavirus crisis.


Venery

It refers to hunting or the chase. Let us leave unexplored the other meaning. which the Oxford English Dictionary defines as "The practice or pursuit of sexual pleasure". At times it may seem to its participants to resemble a hunt, but that sense isn't connected etymologically: it comes from Venus, the Roman goddess of beauty and love. Our sense is from Old French veneri which comes from Latin venari, to hunt. The monk in Chaucer's Canterbury Tales describes himself as "An outrider, that loved venery," by which he meant he loved hunting, though Chaucer's tales are so bawdy that incautious readers might assume the other sense. Venery refers to hunting game animals such as wild boar, hares, wolves, bears and - especially - deer. A close relative to venery is venison, nowadays always meat from a deer but in earlier times the flesh of any hunted animal. Venery dates from medieval England and is closely connected with the royal forests established by the Norman kings and nobles after the Conquest of 1066 (despite the name, the royal forests included fields and open ground as well as woods). The beasts of venery were those that were considered most noble to hunt. There were animals of a lower order, too, the beasts of the chase, which included the fox, as well as beasts of the warren, such as the rabbit and the pheasant. This led to the expression terms of venery, collective nouns for types of game and other wild animals, such as cete of badgers, murder of crows, parliament of rooks and paddling of ducks.

Verbigeration

he American actor, musician, and author John Lithgow remarked in a newspaper interview in February 2015 that verbigeration was his current favourite word. Though it describes the use of words, the concern of any actor or writer, Mr Lithgow would surely not wish it to be applied to himself. One might guess that it refers to the bigging up of verbs, though it's actually said with a soft g, like refrigeration. The association isn't altogether wrong, as it refers to the involuntary repetition of meaningless words and phrases. The psychiatrist Bernard Glueck described it in 1916 as "senseless word salad." Another writer, G Stanley Hall, in a work ten years earlier with the off-putting title Youth: Its Education, Regimen, and Hygiene, preferred to define it as "The continual utterance of certain words or phrases at short intervals, without reference to their meaning." It has been regarded as a symptom of a mental disorder, though we in the UK, currently in the run-up to a general election, may feel it could be used to describe certain British political figures. Its source is Latin, verbum, a word (also the source of verbiage), plus the verb ger re, to carry on or conduct, from which derived the Latin verb verbiger re to talk or chat. An isolated early appearance of verbigeration in English was in the dictionary Glossographia in 1656; Thomas Blount, who compiled it, defined it in this neutral Latin sense

DON'T MICROMANAGE

okia was once the leader of the world in mobile phone handsets. Its largest manufacturing plant was located in Sriperumbudur in India as part of a special economic zone. In a sixyear period it produced more than 500 million handsets, much of them exported. Nokia employed a workforce of more than 30,000 including indirect employment, and it had a big share of women employees. Nokia was indeed the rock star example of what it means to make India a manufacturing hub for the world. It stood for a high-quality product and high quality employment, of a global brand, adding to the then brand of 'Made in India'. But much before 'Make-in-India' became a slogan, the Nokia plant was shut down. It has now become a case study in business schools of the opposite of a Cinderella story, of how a successful dreamlike story can go kaput.

This is not the place to discuss the demise of the Indian factory in all its gory details. A part of the blame goes to excessive zeal shown by India's tax authorities, bordering on tax terrorism, and also broken promises. Blame must also be apportioned to Nokia's own failure to anticipate the global revolution in smart phones, leading to being stuck with a large scale capacity in low-cost feature phones. With hindsight it can be safely said that much of this woeful story was avoidable, and an alternate glorious future could have been written for Nokia as well as India's prowess in mobile phone manufacturing for the global market.

More importantly what have we learnt from the Nokia story? Stories of excessive zeal of the taxman continue. Despite lowering the corporate tax rate to East Asian levels, and for new manufacturing facilities down to 15 per cent, the mindset is still extractive. India's tax regime, including the GST system is still burdensome and inhibits competitiveness. We have been successful in attracting Apple to make its iconic phones in India, so that is something to be cele-

brated. But as compared to the scale of a 100 million phones annual production, achieved by Nokia, Apple is tiny.

The Apple story was successful thanks to an approach called the 'production linked incentive scheme' which gives incentives related to volumes. That has been extended to 13 sectors, including mobile phones, drugs, battery cells, man-made textiles, auto-components and solar panels. The total budgeted outgo on incentives is nearly 2 trillion rupees over the next five years. The PLI scheme seems to be supported by protection via import tariffs. This is an old school economics textbook approach, that to attract investment in the country, you raise tariff walls. And hence a foreign player can access India's vast consumer market only by jumping across that wall, that is, being forced to invest in India. This is not the lesson which Nokia or Sriperumbudur taught us. That plant came to India not by jumping tariff walls, but by being attracted by low cost labour and skills, as well as ease of doing business in an SEZ. If we promote domestic production by raising import tariffs, it increases costs for

the domestic buyer significantly It also acts like an export tax, for entrepreneurs who are using imported components to re-export

their products. Unfortunately, India reversed its two-and-half-decade old progress in tariff reduction in 2018. Since then India's average import tariff on industrial products has gone up from 13 per cent to 18 per cent, and has been applied to nearly one third to one half of all 10,000 odd product lines. Remember, high import duties increase domestic costs, and are a de facto export tax as well. Additionally, the PLI scheme's approach is to pick winners and champions. In some sectors this makes sense. For instance, India's import dependence on China for advanced pharmaceutical intermediates (APIs) is 68 per cent and that needs to go down. It is also a strategic sector since it is in healthcare. But India's status as a leading bulk drugs exporter to the West is also dependent on the import of APIs from China. So, while a PLI for APIs is good, it will take some time to wean away from China dependence. But in general the government cannot, and should not be in the business of choosing winners and cham-

pions, and least of all future trends in technology. Imagine if the government had a PLI scheme for Nokia to produce low cost 2G phones in very large quantities, it would have been stuck paying for an obsolete technology. And if it abruptly discontinued it, then it would have been guilty of breaking a sovereign promise.

Such are the perils of incentivising production in fast technology industrial fields. Another hazard of the PLI scheme is that the government specifies too many details and tries to micromanage. This may be due to the government's bureaucratic approach, or excessive caution in preventing abuse of subsidies. One example of this overkill is that the bid document for the auto sector for those who wish to apply for PLIs is 187 pages long! Imagine the compliance cost. No wonder so far not many big players have stepped in, either for auto or for pharma. Thus, industrial policy which is too intrusive, too prescriptive, too keen to pick and choose winners, and far too based on protectionism is bound to get tangled up and not succeed.

The recent case of BSNL is illustrative. Forced to break away from a confirmed tender to Chinese suppliers for its 4G network, it found that the new bidders were 89 per cent more expensive, and had no proven track record in producing at scale. Another anomaly is in solar panels, where on one hand we want to achieve 100 gigawatt solar capacity but have put tariff barriers on foreign suppliers. This will increase the cost of domestic production of solar power. It is inevitable that with too many conditions, India's industrial policy will become incoherent and inconsistent. The best approach is one which gives private and foreign investors stability, predictability and continuity in a broad policy stance. Leave out the micro specifications if you

Build disaster resilient infrastructure

tricts witness floods and cyclones and western Odisha is prone to acute droughts; whereas a large section of the state is at risk to earthquakes. High population density, encroachments on flood plains, poor socio-economic condition and weak infrastructure increase the vulnerability of costal districts. Out of the state's total geographical area of 15.751 lakh hectares, 1.40 lakh hectares are flood-prone.

As per a study "Economic implications of flood impacts in Odisha, India" conducted by the Madras School of Economics, Odisha incurred average ₹60 crore annual loss due to floods during 1953 to 2002. Such climatic challenges bring disruption in the economy causing losses of life and property. As per a latest government report, the total estimated loss due to cyclone Fani is approximately ₹12,000 crore. Majorly infrastructure like power, telecommunication, roads, water and sanitation facilities and public build-

ings were damaged beyond repair. Disasters affect the Water, Sanitation and Hygiene (WASH) system and infrastructure both in rural and urban areas limiting access to water and sanitation facilities. People drinking contami-

As per the Damage, Loss and Need Assessment report of Fani released by the state government, 18.9 per cent of constructed toilets were partially damaged and 1.4 per cent completely damaged in affected costal districts. Individual toilet recovery expenses were estimated at ₹50.46 crore. In case of drinking water infrastructure, 1,088 piped water sup ply schemes (49 per cent) suffered structural, mechanical, and electrical damage. In order to avoid such huge damage, implementation of sustainable disaster resilient WASH infrastructure is necessary. However, there are challenges that need to be addressed.

Lesser scope and minimum financial allocation for disaster resilient model demonstration in any WASH programme is the major pol icy-level challenge. In the guideline for implementation of first phase of Swachh Bharat Mission, it was clearly mentioned to adopt different toilet technologies, which are geographically suitable and sustainable. However, the missing element was that there was no special financial pro-

curring natural disasters. during and post-flood is a common nological options. As new disaster re-technical skills among masons and small additional budget, so in order to keep cost within ₹12,000 (which was provision), most districts never went for any innovation.

Second, there is low adaptation of disaster resilient WASH infrastructure technology in disasterprone areas. The government and other agencies working in ensuring water sanitation facilities in costal districts have promoted universal infrastructure design for all geographical locations, whereas the need of special disaster resilient water and sanitation infrastructure was missing. For an instance, under Swachh Bharat Mission, the government had promoted only twin leach pit toilets invariably, but this technology is not appropriate and eco-friendly in coastal areas. Other toilet options like bio-disaster toilet, septic tank and eco-san toilet can be promoted. In case of drinking water source promotion, large populations of costal districts depend on shallow hand pumps which can easily suffer bacteriological contamination during floods. High raised hand pumps are promoted in some places but the approach to those is not

accessible for all during disasters. Implementation of any disaster pacity gaps among masons and architects. Traditional designs for construction of water and sanitation infrastructure are still promoted even in disaster-prone areas. So during floods or cyclones those become defunct. The government should come with proper capacity building plan for masons and engineers.

Due to lack knowledge among community members, they never strategically plan for resilient WASH infrastructure even when they invest huge amounts for any infrastructure. Engineers working at district and block offices are the key authorities who design all public infrastructure like schools, hospitals, Anganwadi centres and community halls and approve the plans. But due to lack of tools, techniques and guidelines; the designs and plans are never prepared under the lens of disaster resilience.

In order to address the recurrent losses due to disasters, the government should incorporate action points against the abovementioned challenges to have resilient infrastructure.

TN braces for severe cyclonic storm



Chennai, Nov 23: With the depression over the Bay of Bengal likely to intensify into a cyclonic storm by Tuesday and cross the coast as a severe cyclonic storm a day after, the Tamil Nadu government Monday reviewed the situation, asking the respective district administrations to be on guard.

It announced suspension of inter and intra-district bus services in seven districts from Tuesday, till further orders. Trains were partially and fully cancelled in some dis-

The depression over southwest and adjoining southeast Bay of Bengal moved west-northwestwards a speed of 11 kmph and lay centred at 1130 hrs of Monday over the same region, about 520 km eastsoutheast of Puducherry and 560 km southeast of Chennai, the IMD said.

The depression is very likely to intensify into a cyclonic storm during next 24 hours, the India Meteorological Department (IMD) said in a bulletin. "It is very likely to move northwestwards and cross

Revenue Minister R B Udayakumar and Electricity Minister P Thangamani expressed preparedness of their ministries to respond to any challenges arising due to the cyclone.

Udayakumar told reporters that all arrangements are in place to face the cyclone and special attention will be given to follow social distancing norms in the relief shelters owing to the COVID-19 pandemic.

Those living in low lying areas should immediately shift to relief camps, he said.

Web series row: MP cops book two Netflix officials

A Suitable Boy' showed kissing scenes purportedly on the campus of a temple

Bhopal/Indore, Nov 23: An FIR was registered in Madhya Pradesh Monday against two executives of OTT platform Netflix for allegedly hurting religious sentiments through its web series 'A Suitable Boy' which showed kissing scenes purportedly on the campus of a temple, an official said.

The FIR has named Monika Shergill, Vice President, Content (Netflix) and Ambika Khurana, Director, Public Policies (Netflix), Madhya Pradesh Home Minister Narottam Mishra said.

Meanwhile, Collector of Khargone district Anugraha P told PTI that the controversial kissing scenes do not appear to have filmed inside a temple in Maheshwar town in the district.

Earlier in the day, Shergill and Khurana were booked by Rewa police on a complaint filed by Bharatiya Janata Yuva Morcha (BJYM) national secretary Gauray Tiwari who demanded apology from Netflix and the makers of the series, and removal of 'objectionable scenes,' which he stated were also 'encouraging love jihad.'

"I had asked officials to examine the series 'A Suitable Boy' being streamed on Netflix to check if kissing scenes in it were filmed inside a temple and if it hurt religious sentiments. The examination prima facie found that these scenes are hurting the sentiments of a particular religion," Mishra said in a video statement.

"On the basis of a complaint filed by Gaurav Tiwari, an FIR is being registered under section 295 (A) (malicious acts to outrage and insulting the religious feelings and beliefs) of the IPC in Rewa against Netflix officials-Monika Shergill and Ambika Khurana," he added.

Rewa SP Rakesh Kumar Singh told reporters that the FIR has been registered and further investiga-

plex," the collector said. She said a committee will be constituted to probe the matter in detail if the government orders so.

"As of now, the allegation has not been confirmed that the controversial kissing scenes of the web series were shot inside a temple in Maheshwar, However, if the state government orders us, we will constitute a committee to investigate the matter in detail and send a report," the collector said.

MP SEES COVID-19 SURGE, **REPORTS 1701 FRESH CASES**


Bhopal, Nov 23: Madhya Pradesh Monday reported 1,701 fresh COVID-19 cases, taking the tally of infections to 1,94,745, while ten fatalities pushed the toll to 3,172, health officials said.

A total of 1,120 patients were discharged from hospitals in the last 24 hours, raising the number of recoveries to 1,79,237

Three of the ten fatalities occurred in Indore, while two persons died in Gwalior. One death each was reported from Bhopal, Khargone, Sagar, Damoh and Harda, the officials said.

Of the 1,701 new cases, Indore accounted for 586, Bhopal 349 and Gwalior 108.

The number of cases in Indore rose to 38,247, including 735 deaths, while Bhopal's case tally stood at 29,701 with 506 fatalities. Gwalior so far recorded 14,022 infections, the



Indore now has 3,088 active cases, followed by Bhopal and Gwalior with 2,323 and 708 active cases, re-

With 29,926 samples being tested in the state in the last 24 hours, the count of COVID-19 detection tests rose to around 35.30 lakh.

Coronavirus figures in MP are as follows: Total cases 1,94,745, new cases 1,701, death toll 3,172, recovered 1,79,237, active cases 12,336, number of people tested so far 35,30,106. The state has imposed night curfew in Bhopal, Indore, Gwalior and other cities even as it braces for a possible second wave of Covid-19 infections.

Lucknow, Nov 23: The Indian Railway Catering And Tourism Corporation Limited (IRCTC) has cancelled the operation of the country's first private train Tejas Express from Monday.

The IRCTC has decided to end the operations of the Lucknow-Delhi and Mumbai-Ahmedabad Tejas Express due to a shortage of the passengers. Tejas Express had resumed operations in October after its operation was suspended due to coronavirus.

The IRCTC is a public sector undertaking of the Ministry of Railways, Earlier, the IRCTC had said in a statement that the management has decided to cancel the operations of all Tejas trains due to a shortage of passengers.

IRCTC has cancelled the Lucknow-New Delhi (82501/82502) Tejas Express from November 23 while the Ahmedabad-Mumbai (82901/82902) Tejas Express from November 24. "The management has decided to cancel all departures of the IRCTC Tejas trains due to



low occupancy levels resulting from Covid-19 pandemic. The company will review its decision after seeing the occupancy level of other trains of the Indian Railways operating in both these routes, IRCTC said in a statement.

The two Tejas trains between Lucknow-New Delhi and Ahmedabad-Mumbai were resumed from October 17 in view of the festival rush. The operation of both the trains was stopped on March 19 due to the pandemic. IRCTC had taken several steps to run Tejas Express keeping in mind the coronavirus outbreak.

Sources said that the occupancy of Tejas Express was around 25 to 40 per cent after the resumption of operation as against 50-80 per cent before the coronavirus lockdown

New Delhi, Nov 23: Lok adalats, the inexpensive alternative dispute resolution mechanism, moved to the virtual platform due to the coronavirus pandemic and 27 such e-lok adalats organised in 15 states settled 2.51 lakh cases between June and October.

Over 12,000 cases have been disposed of by lok adalats so far this month, resulting in the settlement of ₹107.4 crore, the law ministry said in a statement Monday. From June to October, 27 e-lok adalats were organised in 15 states, wherein 4.83 lakh cases were taken up and 2.51 lakh cases disposed of, resultUttarakhand and Telangana, wherein 16,651 cases were taken up and 12,686 disposed of, resulting in the settlement of ₹107.4 crore, it added.



Thiruvananthapuram, Nov 23: The CPI(M)-led Left front government in Kerala Monday decided to put on hold a controversial amendment to the Police Act as the law triggered a political storm across the country with many describing the measure as an assault on freedom of expression and media.

Shortly after CPI-M general secretary Sitaram Yechury announced in New Delhi that the amendment providing for up to five years jail term to those making defamatory social media posts would be reconsidered, Chief Minister Pinarayi Vijayan said his government was not "intending" to implement it now.

Further action would be taken after detailed discussions in the assembly and hearing views from various quarters, he said, with the announcement coming amid widespread criticism of the amendment and protests by Congress and threat by BJP to legally challenge it.

While the government has said it brought the amendment through an ordinance to check cyberbullying, opposition parties and even Left sympathisers have slammed it, saying it was against the freedom of speech and media.

Leader of the Opposition in the state assembly Ramesh Chennithala



dubbed as a "hoax" Vijayan's statement that his government was not intending to implement the act and demanded that it be repealed at the earliest. The ordinance has become a law when it was signed by the Governor and no one, even the Chief Minister, could say that a law would not be implemented once it comes into force.

"So, Vijayan's statement that the amendment would not be enforced is only to deceive people," the Congress leader alleged in a statement, adding police can still register cases under the section as long as it remains as a law.

Sources in the Chief Minister's Office (CMO) said that either the state Cabinet will recommend to the Governor withdrawal of the ordinance or the Home Ministry will issue a direction to Police not to take any action under it.

Supreme Court lawyer and constitutional expert Kaleeswaram Raj said the only way to undo the effect of an ordinance was to withdraw the same by way of another

'Since the ordinance is notified, the law has come into being. The stand of the government that it will not invoke the ordinance does not have any legal foundation... It should be recalled by a method known to law," he said.

The International Press Institute condemned the ordinance, saying it was a "nasty and diabolical" attempt to muzzle the media in Kerala. Governor Arif Mohammed Khan on Saturday signed the Kerala Police Act Amendment ordinance envisaging addition of Section 118-A to prevent cyber attacks against women and children.

The section stipulates either imprisonment for up to five years or a fine of up to ₹10,000 or both to those who produce, publish or disseminate content through any means of communication with an intention to intimidate, insult or defame any person through social media.

Justifying the move to bring in the ordinance, Vijayan said the government decided to amend the Police Act in an effort to curb widespread malicious campaigns through social media and other platforms which pose a threat to individual freedom and dignity, constitutionally en-

Ex-Assam CM Gogoi dies at 86

Guwahati, Nov 23: Veteran Congress leader and three-time Assam Chief Minister Tarun Gogoi (86) passed away Monday evening after a protracted illness, Assam Health and Finance Minister Himanta Biswa Sarma said

The former Union Minister and sitting member of Assam assembly is survived by his wife Dolly Gogoi, son Gaurav Gogoi, a Lok Sabha member, and daughter Chandrima Gogoi who lives in the US.

Announcing Gogoi's death, Sarma told the media that the former Chief Minister's body would be kept at the famous Srimanta Sankaradeva Kalakshetra in Guwahati on Monday night. The cremation will take place on Tuesday or Wednesday with full state honours after consultation with his family.

The longest serving Assam Chief Minister, Gogoi's health condition deteriorated since Friday due to

post-Covid-19 complications. He also suffered a multi-organ fail-

Following post-Covid-19 complications, the veteran politician, who was on non-invasive ventilation (NIV) since he was admitted to the Gauhati Medical College and Hospital (GMCH) on November 2, was put under invasive ventila-Doctors at the GMCH said that

Gogoi's health condition deteriobreathing following which the doctors put him on intubation ventilator, which is a machine driven ventilation.

"The doctors have tried hard to revive his organs with medicines and other medical methods besides serving dialysis numerous times, but all the efforts have failed." the Health Minister said.

He said the doctors at GMCH were in constant touch with experts from the All India Institute of Medical Sciences (AIIMS) in Delhi. Due to his critical condition, Gogoi could not be shifted outside the state for medical treatment.

Gogoi was discharged from the hospital on October 25 after he recovered from Covid-19 and other post-recovery complications after more than 60 days. He was administered plasma therapy and subsequently became stable.

The octogenarian Congress leader was under the observation of the nine-member medical team headed by GMCH Superintendent Abhijit Sarmah.

New Delhi, Nov 23: Asserting that the 2014-29 period between the 16th to 18th Lok Sabha is "very important" for a young democracy like India, Prime Minister Narendra Modi Monday said the last six years have been "historic' for the country's development and a lot remains to be done in the remaining period.

As the age of 16, 17 and 18 years is very important for the youth, so is the time between the 16th and the 18th Lok Sabha for a young nation like India, he said while digitally inaugurating 76 multistoreyed flats in the national capital for Members of Parliament.

The 16th Lok Sabha (2014-19) has been historic for the country's

progress, and the 17th Lok Sabha has already become a part of history due to a number of decisions it has taken, he said, referring to the passage of landmark legislations aimed at reforming farm and labour sectors besides abrogation of Article 370 and the citizenship law.

"I am confident the next Lok Sabha (2024-29) will also play a very important role in taking the country ahead in this new decade... There is so much for the country that we have to achieve. Be it 'Aatmanirbhar Bharat' campaign, or economic targets or many other pledges like these, we have to achieve them during this period," he said to an audience of parliamentarians, including ministers and Lok Sabha Speaker Om Birla.

People of Jammu and Kashmir

have also joined the mainstream of development, with many new laws coming into effect in the union territory for the first time, he said in a reference to the abro-

gation of Article 370, which had granted the erstwhile state a special status. "It is our responsibility that when history evaluates different terms of Lok Sabha, this period is remembered as a golden chapter in the nation's development," Modi stated.

The second term of the Modi government is scheduled to end in 2024 when the next general election will be held. London, Nov 23: The UK government Monday said that the Medicines and Healthcare products Regulatory Agency's (MHRA) is reviewing data from Pfizer/BioNTech to determine whether its COVID-19 vaccine meets "robust" standards of quality, safety, and effectiveness

The joint vaccine, produced by American pharmaceutical giant Pfizer and German biotech firm BioNTech, had recently claimed to be 94 per cent effective in protecting people over 65 years old from COVID-19, with trials suggesting it works equally well in people of all ages, races and eth-

'Today, we have renewed hope that we are on the brink of one of the most significant scientific discoveries of our time, as we reach the crucial last stage to finding a COVID-19 vaccine," said UK Business Secretary Alok Sharma.

While this news is a cause for celebration, we must make sure that this vaccine, like all new medicines, meets standards of quality, safety, and effective-



ness. I urge the public to be patient while we wait for regulators to do a thorough assessment. Finding a vaccine is not going to end the pandemic overnight, but we are hopeful of being one step closer to defeating this terrible virus," the Indian-origin minister said. The UK is expected to receive a total of 40 million doses by the end of 2021, enough to vaccinate up to a third of the population, with the majority of doses anticipated in the first half of next year.

"This is another important step

on the road to recovery. We must now allow the MHRA's renowned teams of scientists and clinicians to make an independent assessment of whether it meets their robust standards of quality, safety, and effectiveness," said UK Health Secretary Matt Hancock. "If approval is granted, the NHS [National Health Service] will be ready to deliver. The NHS has vast experience in delivering widespread vaccination programmes and an enormous amount of work has taken place to ensure we have

the logistical expertise, transport and workforce to roll out a vaccine according to clinical priority, at the speed at which it can be manufactured," he said.

The UK government stressed that the COVID-19 vaccine will only be authorised for supply by the UK's independent regulator if it meets strict standards of quality, safety, and effectiveness, and if they are satisfied the vaccine can be consistently manufactured.

While the final deployment plans will depend on decisions by regulators, preparations are underway for the NHS to be ready to begin vaccinating as soon as the first vaccine is approved and delivered to the UK. The Department of Health and Social Care (DHSC) said that general practitioners (GPs) have already been signed up to take part in the programme when an appropriate vaccine is ready and dozens of hospitals across the UK will lead coordination on behalf of neighbouring hospitals, community trusts and local health groups in vaccinating staff and other priority groups. Several vaccination sites will also be set up across the country.

Biden to pick Blinken as Secretary of State

Washington, Nov 23: Joe Biden intends to pick his trusted foreign policy advisor Antony Blinken as the US Secretary of State and Jake Sullivan as National Security Advisor, media reports said on Monday, as the President-elect is poised to make his first round of Cabinet announcements on Tuesday.

Blinken, 58, has served as the Deputy Secretary of State in the second term of the Obama administration and National Security Advisor to Biden when he was the vice president.

A strong India-hand, Blinken was the top foreign policy advisor to the Biden campaign.

"President-elect Joe Biden intends to nominate Antony Blinken to serve as secretary of State, turning to a trusted diplomat and foreign-policy adviser to oversee his work to rebuild US relationships around the globe, according to people familiar with the decision, The Wall Street Journal reported.

"President-elect Joe Biden is planning to announce that he has selected Antony Blinken, one of his closest and longest-serving foreign policy advisers, as secretary of state." The Washington Post



said. "Jake Sullivan, another top Biden advisers, is expected to be named as national security adviser, according to two people familiar with the announcement," the daily said. Last week, Biden said he had decided on his name for the Treasury Secretary. "The announcement of Blinken's selection is expected by Tuesday at the latest, people familiar with the selection said." the Journal reported. Blinken also spoke during the virtual celebration of India's Independence Day organised by the Biden Campaign and addressed by Biden himself and his running mate Kamala Harris, who is now the Vice President-elect. According to The Washington Post, Biden also plans to announce Linda Thomas-Greenfield as his nominee for ambassador to the United Nations.

UK SC TO HEAR CASE OVER 'IS BRIDE' RETURN

At a hearing beginning on Monday, it is challenging a lower court's ruling that Begum can return to Britain to mount a legal challenge aimed at restoring her UK citizenship, which was revoked on national security grounds.

The Court of Appeal said in July that "the only way in which she can have a fair and effective appeal is to be permitted to come into the United Kingdom." But James Eadie, a lawyer acting for the UK government, told the Supreme Court justices that Begum "is considered to pose a real and current threat to national security." Begum, now 21, was one of three east London schoolgirls who traveled to Syria in 2015 to live under IS rule. She says she married an Islamic State member from the Netherlands and had three children, all of

whom have died. She resurfaced at a refugee camp in Syria in 2019 and told reporters she wanted to come home. but was denied the chance when then-Home Secretary Sajid Javid revoked her citizenship. The situation has thrown into sharp relief the larger question of how Western societies deal with people who joined IS but want to go back to their home countries. Begum challenged the decision, arguing she is not the citizen of another country and that Javid's decision left her stateless

European powers see hope for Iran accord in US transition

Berlin, Nov 23: The German, French and British foreign ministers were meeting Monday to discuss the future of the international agreement on Iran's nuclear program amid hopes that the incoming US Administration might help breathe new life into the accord

Germany's Foreign Ministry said. The three European powers have spearheaded efforts to keep alive the agreement, concluded in Vienna in 2015 and officially known as the Joint Comprehensive Plan of Action, or JCPOA. Russia and China also remain on board.

President-elect Joe Biden has said he hopes to return the US To the accord, in which Iran agreed to

limit its nuclear activities in exchange for the lifting of international sanctions. President Donald Trump withdrew the US From the agreement in 2018 and imposed crippling economic sanctions on Iran, which responded by publicly abandoning nuclear restrictions in the agreement.

Monday's meeting at a government guest house in Berlin, which wasn't announced in advance, aimed to discuss "what a further approach involving all signatories to the JCPOA, and perhaps also with a new US Administration, could look like," Foreign Ministry spokeswoman Andrea Sasse told reporters.

"We are confident that a constructive approach by the US Toward the Vienna nuclear agreement could

contribute significantly to breaking the current negative spiral we are seeing with Iran, and opening new prospects for the preservation of the JCPOA," she added.

Sasse renewed calls for Iran to stop its violations of the agreement and comply with all of its provisions in full

She said Monday's meeting also would address Iran's missile program and wider regional role issues that are not addressed by the nuclear agreement, to the displeasure of its critics. Asked whether the Europeans fear Trump taking further steps against Iran before he leaves office that would undermine their hopes, Sasse replied: "if there are such measures, we will evaluate them if they happen.'

Greenhouse gas levels at new high despite lockdowns: UN

Geneva, Nov 23: Greenhouse gases in the atmosphere, the main driver of climate change, hit record highs last year and have continued climbing this year, despite measures to halt the pandemic, the UN said Monday.

The World Meteorological Organization (WMO) said lockdowns, border closures, flight groundings and other measures to rein in the coronavirus crisis had indeed cut emissions of many pollutants and greenhouse gases like carbon dioxide.

But it warned the industrial slowdown due to the pandemic had not curbed record concentrations of the greenhouse gases that are trap-

ping heat in the atmosphere, raising temperatures, causing sea levels to rise and driving more extreme weather.

"The lockdown-related fall in emissions is just a tiny blip on the long-term graph," WMO chief Petteri Taalas said in a statement. "We need a sustained flattening of the curve." The WMO's main annual Greenhouse Gas Bulletin said preliminary estimates indicated that during the most intense period of the shutdowns, daily CO2 emissions may have been reduced by as much as 17 percent globally.

The annual impact was expected to be a drop of between 4.2 and 7.5 percent, it said. But this will not cause concentrations of CO2 in the



atmosphere to go down, it said, warning the impact on concentrations was "no bigger than the normal year to year fluctuations.

Historic CO2 concentrations will continue to rise, albeit at a slightly reduced pace, WMO said, adding that the pace would be no more

than 0.23 parts per million (ppm) per year slower than the previous trajectory -- well within the 1.0 ppm natural inter-annual variability.

"On the short-term the impact of the Covid-19 confinements cannot be distinguished from natural variability," it said.

Emissions are the main factor that determine the amount of greenhouse gas levels but concentration rates are a measure of what remains after a series of complex interactions between atmosphere, biosphere, lithosphere, cryosphere

and the oceans. CO2 is by far the most important long-lived greenhouse gas in the atmosphere related to human activities, and is responsible for

roughly two-thirds of the Earth's

WMO's Bulletin listed the atmospheric concentration of CO2 in 2019 at 410 parts per million, up from 407.8 ppm in 2018, and said the rise had continued this year.

Taalas pointed out that the world breached the global threshold of 400 ppm in 2015, voicing alarm that 'just four years later, we crossed 410 ppm." "Such a rate of increase has never been seen in the history of our records.'

The United Nations agency said that since 1990, there had been a 45-percent increase in so-called radiative forcing, which is the warming effect on the climate by greenhouse gases.

'Asset quality of **Indiabulls Housing** Fin vulnerable'

Mumbai, Nov 23: Asset quality at non-bank lenders IIFL Finance and Indiabulls Housing Finance is "vulnerable" due to the economic contraction, global ratings agency Moody's Investors Service said Monday.

The agency said Muthoot Finance - the third non-bank finance company it rates - is better positioned because of its focus on the gold loans business.

Loan collections have shown an improvement for all the three NBFCs despite the six-month loan repayments moratorium ending in August on a pick-up in economic activity, but "asset quality at IIFL Finance and Indiabulls is vulnerable to economic contraction", it added.

Till now, various types of support measures for borrowers from authorities have prevented a sharp deterioration of asset quality at the lenders, it added.

"However, we expect delinquencies will eventually increase at IIFL Finance and Indiabulls once the support programs end given the severity of the pandemic's impact on India's economy," the agency said.

A modest loan growth and loan sales will help IIFL and Indiabulls maintain capitalisation despite the weakening of profitability, which will be hurt by credit costs for the loan losses, it noted.

'India likely to have current account surplus this fiscal'

New Delhi, Nov 23: Chief Economic Adviser KV Subramanian Monday said India is likely to post current account surplus in the current financial year as there is moderation in import due to under heating of the economy triggered by the COVID-19 crisis.

This crisis is different from what the world witnessed during the taper tantrum, he said while addressing a virtual conference organised by industry body CII.

Taper tantrum phenomenon refers to the 2013 collective reactionary response that triggered a spike in US treasury yields, after investors learned that the US Fed was slowly putting brakes on its quantitative easing (QE) program. This led to a surge in inflation to high double digits emerging economies.

In contrast, he said, the COVID crisis is different and India identified the nature of this crisis and treated it differently from other economic crises of the past.

CIL TO SET UP 3 GW SOLAR **POWER PROJECTS BY FY24**

New Delhi, Nov 23: State-owned Coal India Monday said it plans to set up 14 rooftop and groundmounted solar power projects of 3,000 MW capacity by 2023-24 which will entail an investment of ₹5,650

Coal India (CIL) is mandated by the coal ministry to become a net zero carbon company. Solar power initiative is a part of CIL's diversification plans, the PSU said in a filing to BSE.

The likely investment would be around ₹5,650 crore, it said.

While ₹3,650 crore is planned to be invested through CIL's capex, till 2023-24, the rest would be met through joint venture models that the company intends to pursue for this initiative.

Synergising their efforts, CIL and NLC India Ltd have floated a



joint venture entity 'Coal Lignite Urja Vikas Private Ltd' to develop 1,000 MW solar power projects.

CIL has also tied up a JV with NTPC and an MoU with Solar Energy Corporation of India for solar projects of 1,000 MW each, the progress of which is being worked out individually.

Additionally, the solar power initiative helps CIL reduce its whopping annual power consumption expense, which was around ₹3,400 crore ending FY2020, accounting for around 4.4 per cent of the revenue expense for the year.

PPT's riverine port to come up near Mahanadi

Sources stated that the port will be all weather and multiuser port at river Mouth of Mahanadi and it will be developed

Mahakalpada Block in Kendrapara district and it is expected to be developed in two phases. It was said that around 175 hectare of land required forearly phase development.

Two berths will be established for transportation of 18.43 MTPA of cargo in first phase and it is likely to bear the cost of worth ₹2,110 crore. The capacity of transportation of cargo will increase from 18.43 MTPA to 45.88 MTPA, and an additional 125 hectare of land will be required, sources said.

The riverine port will be connected to National Highway-53 and Haridaspur-Paradip Railway Line for transportation of cargo.





Warner focussing on disciplined batting

Sydney, Nov 23: Australia's big-hitting opener David Warner Monday said his 'days are numbered' in international cricket and continuing an approach of keeping his aggression in check, he would rather ignore than engage if Indian players attempt to sledge him during the upcoming series.

Warner, in a virtual press conference facilitated by the series' official broadcaster Sony, touched upon his evolution as a batsman in the past couple of years.

"I've just recently turned 34, so my days are numbered, when you're in the 30s. There's obviously a riskelement but there's obviously a cricket smarts element to it as well," the explosive opener said ahead of the limited-overs series against India starting with the first ODI November 27.

Warner, who has had his share of aggressive on-field showdowns, said he would prefer to look the other way if Indians try to get chatty with him. "I'll always draw from that mate. To try and get engaged, that's the way they like to play as well," he said.

"We're learning over time, trying not to engage in that. Probably try and reversing the effect by trying and ignoring it, trying to take it on board and using it against them

by using your bat," he added.
"It's probably something I've learnt over time. And you don't know the effect it can have on your teammates as well. You've got to be a bit more humble in that respect."



Warner said at 34, he has become a calculated risk-taker and is focussed on maintaining a strong strike rate. "For myself, it's about getting off to a good start and taking calculated risks in that middle-overs period if we're talking about 50-over games," he said.

"For me, it's about making sure that I am batting as much as I can and at a good strike-rate as well. I think last year was probably the most disciplined I've batted in Test match cricket as well.

"I really took pride in the last 12-24 months, to apply that discipline and you keep learning as you get older...You've got to be on top of your game to be able to adapt to that."

game to be able to adapt to that."

A lot of this discipline has come fatherhood, said Warner, crediting his children for the gradually-acquired patience. "...Not get too aggressive or angry when the kids aren't listening. For me, I am getting tested on and off the field. So, it's about being calm and relaxed and trying to sum up the situation you're playing in," he said.

Mumbai, Nov 23: West Indies great Brian Lara feels that a batsman of Suryakumar Yadav's calibre should have been in the Indian white-ball squad for the tour of Australia.

The Mumbai Indians batsman's non-inclusion, despite being seventh in the IPL run-getters' list with 480 runs at a strike-rate of 145 plus, has become a major talking point.

"I see no reason why, looking at the (Indian) squad, he can't be a part of it," Lara said on Star Sports show 'Cricket Connected'.

Lara said he is impressed not just by the runs but also the manner in which Yadav has scored them. "Yeah, definitely. He is a class



player. I don't just look at players that score runs, I look at their technique, capabilities under pressure, positions that they are batting and for me. Suryakumar Yadav has done such a wonderful job for Mumbai."

The only explanation that has come for the 30-year-old's exclusion is the lack of space in the lineup. Lara said he fits the bill for the No.3 slot.

"He comes to bat on the back of Rohit Sharma, and Quinton de Kock and every time, they are under pres-

sure, he comes in at No.3," he said.
"Just remember, other than the openers, the No.3 batsman in any cricket team is normally your best player, your most reliable player-

player, your most reliable player—(and for me, he (Surya) has been that for Mumbai Indians," he stated.
