FARMERS WON'T BUDGE

Disgruntled farmers refuse offer of alternate protest site, insist on reaching Central Delhi




border between Delhi and Haryana. The large number of farmers, aggrieved over the three agriculture Bills enacted by the government recently, reiterated that they would not accept the Delhi Police's offer to hold their protest at the Sant Nirankari ground at Burari in north Delhi.

The numbers of demonstrators swelled at the Singhu border as the farmers camping there for the 'Delhi Chalo' protest march were joined by more counterparts from Punjab and Haryana, all of them refusing to move towards the Sant Nirankari ground, one of the largest in the national capital.

Gurmej Singh, 62, from Punjab, said the farmers will not give up unless they are able to reach Jantar Mantar or Ramlila Ground in the heart of the national capital and hold their "peaceful" protest there. "We will not go to Nirankari ground. We will either go to Jantar Mantar or Ramlila ground or we will sit here. We have enough ration for six months and will not leave the highway," he said.

Many of these farmers continued to hold their protest peacefully at the Singhu border where they have been holding meetings to decide on their next course of action and have also

3rd self-immolation bid near Assembly

Bhubaneswar, Nov 28: A mother-son duo attempted self-immolation near the Assembly here Saturday, the third such incident in less than a week to draw the government's attention amid alleged police inac-

Sulochana Dash and her son Subrat Dash, of Kujang in the Jagatsinghpur district, attempted to set themselves on fire near IG Park, close to the Assembly premises, officials said.

However, an alert security personnel immediately intervened and prevented them from lighting the matchstick though they had poured kerosene on themselves, they said.

While being taken to custody, Sulochana said she travelled all the way to Bhubaneswar and tried to die by suicide after being unable to get justice from the police in Jagatsinghpur. Her other son Amrut Dash was allegedly killed July 20, 2019 and police closed the investigation into the matter after registering a case of unnatural death, she alleged.

Following the earlier two incidents, security was beefed up around the Assembly premises. Due to

HC-monitored SIT to probe Pari case

BHUBANESWAR: Following uproar inside and outside the Assembly over alleged murder of a 5-year-old girl (Pari) in Nayagarh, the state government Saturday said that a High Court-monitored Special Investigation Team (SIT) will probe the case. As Opposition members alleged that there is some confusion in the statement made by Chief Minister on the SIT probe, Parliamentary Affairs Minister Bikram Keshari Arukha made a clarification in this regard in the Assembly. He said the Home department has issued notification for formation of SIT and requested Registrar General of Orissa High Court to monitor the investigation. The SIT will be led by IG Arun Bothra.

Speaking on the issue, DCP Umashankar Dash told Orissa POST, "We are considering declaring the Sachivalaya Marg as 'restrictive zone'. However, there is no plan to increase more forces at the spot. The detained lady and his son are being interrogated at Capital police station to ascertain whether any persons pursued the duo for the immolation bid.'

Meanwhile. Jagatsinghpur police have issued a press note denying the allegations of any wrongdoing leveled against the district police.

CBI conducts raids at 45 places in four states

ILLEGAL COAL MINING

THE SEARCHES WERE SPREAD ACROSS WEST BENGAL, BIHAR, JHARKHAND AND UTTAR PRADESH

New Delhi, Nov 28: The CBI Saturday carried out a massive search operation at 45 locations in four states after registering a case against alleged coal pilferer Anup Manjhi who was suspected to be acting in collusion with two general managers and three security personnel of Eastern Coalfields Ltd (ECL), officials said. The searches were spread across

West Bengal, Bihar, Jharkhand and Uttar Pradesh, they said.

The CBI registered the case Friday against Manjhi, ECL General Managers Amit Kumar Dhar (of then Kunustoria area, now Pandayeswar area) and Jayesh Chandra Rai (Kajor area) besides ECL Chief of Security Tanmay Das, Area Security Inspector, Kunustoria Dhananjay Rai and SSI and security in-charge Kajor area Debashish Mukherjee.

It is alleged that accused Anup Manjhi alias Lala is involved in the illegal mining and theft of coal from leasehold mines of ECL in Kunustoria and Kajora areas, they said.

The CBI acted on information from "reliable sources" indicating illegal excavation and theft of coal in the leasehold area of ECL in "connivance" with the officials of ECL, CISF and Railways.

The Vigilance department of the ECL and its Task Force had also noticed illegal mining from May 2020 and onwards with the help of large excavation machines and vehicles for transportation that were seized by the team.

'Several instances of installation of illegal weighbridges in concrete form were also detected which confirms illegal coal mining and transportation from ECL areas in an organised manner at a very large scale.'

It is further revealed by the source that illegal mining is going on at the leasehold area of ECL behind Topsi village under Kunustoria area and at Lachhipur village under Kajora area by the coal mafias in active connivance with officials of ECL and those of CISF, the CBI alleged in its FIR.

The departmental raids August 7, 2020 led to the recovery of over nine MT of stolen coal from the railway siding of the Pandaveswar area. Similar recoveries were also made from other locations too.

It is learnt that this illegal activity is being run at Railway sidings by the criminals with the active connivance of unknown Railways officials, the agency alleged. The CBI has alleged Anup Manjhi alias Lala is the kingpin of most of the coal pilferage in the area arising out of illegal mining.

Financing Adani's Oz coal project may hit SBI bonds FRENCH GIANT AMUNDI THREATENS TO OFFLOAD SBI BONDS IF LOAN GRANTED FOR ADANI GOES THROUGH

New Delhi, Nov 28: One of the State Bank of India (SBI)'s investors, French giant Amundi has announced that it would sell off its SBI green bonds if the bank grants Rs5,000 crore-loan to Adani's Carmichael coal mine in Australia.

'We consider SBI should not finance this project. Ultimately, it's their decision but we've been extremely clear on the fact that if they decide to do it, we would immediately disinvest," Director of the Institutional Corporate Clients Division & ESG, Jean Jacques Barberis, was quoted as saying by a global wire service.

"Financing the mine would be in 'total contradiction' to the SBI activities financed through its green bond," he added.

"We have engaged SBI asking them not to participate (in the loan) and now we are waiting for their answer," he was quoted as saying.



Amundi, which holds the bond in its Amundi Planet Emerging Green One fund, said it had learnt this week that SBI was considering financing the Carmichael thermal

New Delhi, Nov 28: Petrol and diesel prices were increased by oil marketing companies Saturday as global oil prices remained firm, reaching their highest levels this fiscal. Petrol prices increased by 24 paise to Rs82.13 per litre, Saturday, from Rs81.89 per litre the previous day.

Diesel prices, on the other hand, increased by a higher margin of 27 paise to Rs72.13 a litre, up from Rs71.86 a litre Friday.

Oil companies have begun increasing pump prices of the two petroleum products from last $\stackrel{>}{\sim}$ Friday after a nearly two-monthlong hiatus in fuel price revision. The prices increased for five consecutive days before going for a day's pause Wednesday last. It has risen on all days thereafter, meaning the prices have risen in eight of the past nine days.





Bedlam in House over Pari murder case

Bhubaneswar, Nov 28: Opposition BJP and Congress MLAs disrupted the proceedings of the Assembly for the fourth consecutive day Saturday over the kidnapping and murder of Nayagarh's 5-year-old girl 'Pari'.

No other business except the demand for grants discussion of Panchayati Raj and Drinking Water department could take place in the House Saturday due to uproar by BJP MLAs, resulting in adjournments for several times.

As soon as the House assembled for the day at 10.30am, BJP legislators stormed to the well of the House and resorted to protests demanding expulsion of Agriculture and Higher Education Minister Arun Sahoo and a CBI probe into

Speaking in the House, Congress Legislative Party (CLP) leader Narasingha Mishra said the Minister of State for Home DS Mishra's statement on Pari case was not a full-fledged one. "Though the Speaker had directed the minister to reply on four aspects related to the case, Mishra only touched upon one aspect while omitting the other three aspects conveniently", Mishra alleged.

He said the MOS's statement did not include the role of the Agriculture minister in shielding the main accused in Pari kidnap and murder case. The Congress leader also demanded a clarification from the government on the SIT probe as mentioned by the Chief Minister in

Speaker SN Patro initially adourned the House for 15 minutes. Later, Parliamentary Affairs Minister BK Arukha assured the members that the government has started the process of SIT probe and the Home department will soon issue a notification in this regard. Unsatisfied with minister's statement, BJP members continued their protests. The House was again adourned till 3pm.

The bedlam prevailed during the second half too. The saffron party MLAs again resorted to protests.

Charan Majhi climbed to the podium of the Speaker and removed the glass shield put for Covid-19, and broke the mikes. Unable to run the House, the Speaker adjourned businesses for 30 minutes further. The BJP. however.

continued to create ruckus in the House.

The demand discussion of Panchayati Raj and Drinking Water department was held amidst the ruckus and supplementary grant of ₹2252.84 crore was passed. The House also passed the supplementary demand for grants for all other departments through guillotine. Later, the Speaker adjourned the proceedings till 10.30am Sunday.

Speaking to reporters outside the House, Leader of Opposition PK Naik accused Chief Minister Naveen Patnaik of shielding the

Agriculture minister instead of giving justice to the victim girl's family. His party has been demanding a CBI probe into the incident and dismissal of Sahoo from

Naik said his party's demands for a CBI probe into the matter and dismissal of Sahoo were yet to be met. The BJP members will continue to agitate both inside and outside the Assembly till the victim's family gets justice.

"Pari kidnap and murder case is not a small incident. The girl went missing on July 14 and her skeletal remains were found in the back

yard of her house on July 23. Her organs have been removed and might have been transplanted in the body of some rich family's child. Therefore, we demand a CBI probe into the incident," Naik

Meanwhile, expressing grave concern over the incident, BJP national spokesperson Sambit Patra said his party will drag the Pari murder case to Delhi.

CLP leader Narasingha Mishra slammed the BJP for disrupting the important Assembly proceedings even after the government agreed for a court-monitored SIT probe.

About CBI probe, he said, everyone knows what happened to the CBI investigation into various cases including the chit fund scam.



SIT to grill bank, forest officials in Pathak case

Bhubaneswar, Nov 28: The Vigilance directorate Saturday decided to issue notices to all concerned including bank officials, forest officials and relatives in connection with multi-crore DA case of IFS officer Abhayakant Pathak.

The Vigilance directorate is all set to tighten the noose around scam-tainted Pathak, and his son Akash. The 20-member Special Investigation Team (SIT) formed by the directorate to probe all the angles related to the case held a meeting Saturday regarding the preparations for a thorough investigation.

This will include bank officials, forest officials, relatives, employees, associates etc. The firms from which costly vehicles have been purchased will also be examined.

The SIT will probe the sources through which Pathak acquired such huge and lavish assets. The team will also scrutinise various investments made by the father-son duo. The State Forensic Science Laboratory (SFSL) will be requested to help in the probe. Cyber cell and cell phone forensic experts will also be part of the SIT.

Ease of doing business gets digital boost

Bhubaneswar: Nov 28: With an aim to increase ease of business, the state government decided to issue electrical safety clearance certificates for industries, commercial establishments and business houses on online mode only.

The business units will no longer require to get in touch with authorities except in cases where inspection/site visit is mandated by law. The energy department has recently issued a notification in

'In order to provide time-bound service in obtaining electrical safety recommendations and electrical safety clearance certificates for industries, commercial establishments and businesses, and to maintain transparency and accountability on the part of the officials, the entire workflow/process of approval for DG set installations for industries, commercial establishments and businesses shall be dealt online

only," the notification said. The electrical safety recommendations and electrical safety certificates downloaded from the online portal will be valid across the state. No one shall make any application offline

No physical/manual applications will be required to be submitted to the authorities in addition to the online applications. No physical copies of the documents which were uploaded by the applicants at the time of submission of online applications will be required by any au-

However, the applicants will have to produce authentic copy of the respective documents on demand by the appropriate authorities during inspection/site visits. The online applications will be disposed of within the stipulated timeline.

The authorities shall accept digitally signed certificates downloaded from the portals as valid and shall not require physically signed/stamped certificates. The applicant shall not be required to meet the authorities in person except in cases where inspection / site visit is mandated by law, it said. A few days ago, the government had issued similar notification for online issuance of fire safety certificates for commercial establishments.

Jumbo herd sparks panic in Angul



Kendrapara, Nov 28: Even as the price of potatoes keeps soaring across the state due to short supply of the tuber from other states, farmers in various parts of Kendrapara are showing interest in potato cultivation. However, shortage of potato seeds has come in their way, a report said.

As the weather is favorable now, farmers in the district have started preparing for potato cultivation. However, in the beginning they are facing an extreme seed crisis.

Some farmers alleged that seeds supply from the government had not been made till date while they have to buy seeds from the open market at high prices.

It may be noted here that Potato Mission has been implemented by the state government from 2015-16 to make the state self-sufficient in tuber production. It initially aimed to pump in Rs 267.05 crore for it. The scheme was to be continued till 2023-24. The mission was in fact taken up after the state faced an



acute shortage of potatoes following West Bengal's decision to stop supplying the tuber.

Apparently, the mission has flopped in the coastal district as

farmers are facing a seed crisis.

According to reports, potato is cultivated in 700 hectares in Kendrapara every year. For a hectare of land, 15 quintals of seeds are required.

Accordingly, farmers need 10,500

quintals of seeds in the current

season. But seeds have not been supplied when preparation for farm-

ing is almost ready.
Gayadhar Dhal, secretary of the

As for seed crisis, Kandha Jena, deputy director of horticulture, said an indent has been sent for seeds which have not been supplied to the district. It will reach by Monday He added that a kg of seeds is purchased for Rs 45 per from open market while it will be available for Rs 11.25 per kg under the government supply.

Dhenkanal, Nov 28: Once regarded as a safe haven for wild animals, the jungles in Dhenkanal district have turned into poachers' paradise, causing headache to the forest department.

The figures shared by the forest department are testimony to why the district has earned the dubious distinction. Between September and November, as many as 32 hunters were arrested from eight ranges. Of them, three were arrested from Dhenkanal Sadar range, nine from Kapilas range, two from Sarangi range, five from Hindol range, three from Kamakhynagar Eastern range, four from Kamakhyanagar Western range and six from Mahabirod range.

Amongst the weapons and animal body parts seized from their possession were included ten rifles, 15 live bullets, bows and arrows, deer hide, deer antlers, Sambar deer antlers, two pieces of tusk, electric wires used for hunting and some amounts of venison and flesh of other hunted animals.

Poachers use the easiest way to hunt animals by laying live electric wires in Kapilas range, a home to a wide range of animals including some endangered ones

With Kapilas range reporting the maximum number of poaching cases, the forest department is presently learnt to be under tremendous pressure.

Kapilas range is known not only for elephants but also for a wide range of animals, including some endangered ones. The poachers here use the easiest way to hunt animals, by laying live electric wires. There were instances in the past wherein elephants got electrocuted after coming in contact

with these live wires.
Similarly, the number of hunting cases involving deer and wild boar has also increased in the jungle close to Deogaon-Tangi road under



Gandia police limits. The hunters' modus operandi is to lay live wire at nights, collect hunted animals the next morning and then sell their flesh in nearby areas.

The entire process is carried out so clandestinely that the forest department hardly gets any inkling of these cases. There are also cases of hunters being killed after coming in contact with the live wires. In one of such incidents reported from Mahabirod area last month.

a youth had died. Some animal lovers said the poaching cases can be checked or, at the very least, brought down if the intelligence system works perfectly, night patrolling is intensified and exemplary punishment is handed out to the accused.

When contacted, Dhenkanal DFO Prakash Chandra Gugnani said poaching incidents have increased in the last few months. We have taken some immediate steps and our efforts are on to stop hunting. The range officers and employees have been directed to intensify raids, he added.



FOCUS BANKING SECTOR

PRELUDE TO PRIVATISATION

ver since the nation embarked on the path of neoliberalism, there has been a constant attempt by the ruling dispensations at the Centre to allow entry of business houses into the banking sector. The Reserve Bank of India (RBI) recently released a report of an Internal Working Group (IWG) headed by PK Mohanty which proposes to allow Indian corporate houses into the banking sector either directly as promoters or through the NBFC route. This is a continuation of the Modi government's "pro-corporate neoliberal" economic policies.

Even when licenses to private banks were issued in the post-liberalisation period (in 1993 and 2001), big business houses were prohibited from getting licenses. The NDA government wants to abandon this long-standing policy. It is also quite contradictory to allow corporates to open banks when the government is expediting mergers of banks, closing branches under the spurious plea of building banking behemoths to compete with their global peers.

The last time (2013-14) when the RBI invited applications for new private banks, a host of corporates including Tata Sons: Aditva Birla Nuvo, L&T Finance Holdings, Reliance Capital, and IMACS Management Services Ltd had applied for permits.

The government's latest move has drawn criticism from experts, who have red-flagged the risks associated with it. Rating agency S&P Global has said it was sceptical of allowing corporate ownership in banks given India's weak corporate governance amid large corporate defaults over the past few years. Former Chief Economist of the World Bank Kaushik Basu dubs the decision as a good looking step in bad direction and may lead to crony capitalism.

Former RBI governor Raghuram Rajan and deputy governor Viral Acharya termed the proposal as a 'bad idea'. While questioning the urgency and timing of the IWG proposals, they have cautioned that such an attempt will allow non-fi-

nancial businesses to gain easy access to the sector and encourage connected lending.

Allowing corporate houses to set up banks is a retrograde step and will overturn the process of nationalisation of banking sector initiated by former PM Indira Gandhi. It is not a 'big bang' reform but just a surreptitious design to weaken the public sector banking system to help corporates take control over financial savings, just the way BSNL was destroyed so that the telecom sector could be overtaken by private companies especially Jio. It is a prelude to privatisation of the banking sector.

It should be recalled here that at the time of Independence, all banks in India were owned by business houses, but none came forward to help the government in its planned economic development projects. Bank nationalisation helped in expansion of branches in every nook and corner of the country and ensured credit flow to priority sectors like agriculture, small-scale industries, housing, and exports.

It is argued that corporates will be allowed as promoters albeit with conditions. The IWG has suggested significant amendments to the Banking Regulation Act, 1949 to prevent connected lending and exposures between banks and other financial and non-financial group entities. This is aimed at increasing the RBI's powers and strengthening the supervisory mechanism for large conglomerates. However, if comprehensive regulation and supervision were only a matter of legislation, India would not have an NPA problem and collapse of private banks. Governance is frail in India. Moreover, regulators can succumb to either political pressure or the urgency of the moment

The foremost problems before the banking sector are mammoth NPAs. the massive scale of banking frauds, huge bad loan write-off. surplus liquidity, closure of rural branches. Banks now need capital infusion by the government which is low as a percentage of GDP in India as compared to other countries. Handing banks to corporates will not solve the above problems rather exacerbate the situation.

There is a strong reason for not inducting corporate houses in the banking industry with significant conflicts of interest. Corporates are basically borrowers from banks. They will divert funds to concerns which they have an interest in and will try to push down lending rates arbitrarily. Also, the risk of contagion from corporate defaults to the financial sector will increase significantly. It will further exacerbate the concentration of economic and political power in certain business houses. In other words, allowing industrial houses to own banks would allow them to corner the bulk of the credit for their own businesses through connected lending. It will be impossible to assess risks and regulate the banking sector in such a scenario. Moreover, it will be affected by cronyism. That is why, many countries, including the United States, prohibit industrial houses from operating banks. South Korea prohibited industrial houses from promoting new banks following the financial crisis in 1997.

If banks are owned by corporates, it will lead to overleveraging. A highly leveraged banking system can lead to unstable dynamics and downward spirals Numerous studies confirm the understanding that the US financial crisis of the years 2007-09 and the subsequent great recession was caused by excessive leveraging of the US banking sector, its exposure to the US real estate sector. Many private and foreign banks have been responsible for highly imprudent and speculative practices. Overleveraging occurs when a business has borrowed too much money and is unable to pay interest pay ments, principal repayments, or maintain payments for its operating expenses due to debt burden

In contrast, the Indian bank ing sector – dominated by the public sector banks - has successfully withstood the global financial crisis. In the light of the global fi nancial crisis sparked off in 2008 by the profligacy of private banks and financial speculation, allowing corporates in banking sector in India is an illogical decision.

India's financial landscape is blotted by scams involving big businesses, big failures of private banks like Centurion Bank of Punjab Global Trust Bank, Bank of Rajasthan, Times Bank, Yes Bank and most recently, Lakshmi Vilas Bank. What is noteworthy is that private banks in crisis are rescued by public sector banks. Banks run by businesses will increase the scope for financial malpractices. The growth of savings will be affected and thereby our savings economy.

Kyrgyzstan's latest revolution began in a typical fashion. Following a parliamentary election on October 4, protesters and rioters took to the streets seeking to annul the result, triggering a full-scale political crisis. By October 6, demonstrators had occupied the White House the government building that

houses the president's office and parliament. In the following days, a peaceful power struggle unfolded. In the end, the Central Election Commission annulled the election results. President Sooronbai Jeenbekov resigned, and Sadyr Japarov, a politician who had just been released from prison, became the acting president.

Meanwhile, as the country's only remaining independent political body, the parliament had continued to work throughout the protests, enacting legislation to hold a presidential election and a vote on a new constitution on January 10, 2021. This reform was initiated by Japarov himself, prompting his opponents to accuse him of attempt-

litical career in 2005, when he was elected to parliament. The government that was elected in 2010 prosecuted him, and he went into hiding abroad. When he returned, he was convicted and imprisoned. Both of his parents and his son died during his incarceration, elevating his status as a political martyr in the eyes of many Kyrgyz.

Japarov's rise to power reflects not just his vivid biography, but also the determination of his activist base of supporters and the loyal MPs who backed him. For all the criticism that he is now receiving, there is no question that he played a central role in preventing the country from sliding into chaos during the critical days of the October revolution.

Many Kyrgyz view Japarov as a political outsider who can unite a fractured country and carry out necessary reforms. He has already announced a program to fight corruption, curb the shadow economy, and renew the political establishment with a younger generation of untainted professionals. If the upcoming vote on constitutional changes succeeds, it will be the tenth time that Kyrgyzstan has amended its con-

But, of course, constitutional changes yield realworld results only when there is a deep public understanding and acceptance of constitutionalism.

Given the speed of events in recent weeks, the international community fears further destabilization. But the Kyrgyz people recognize and appreciate the fact that they have barely avoided falling into the political abyss. During the revolution, law-enforcement agencies seemed paralyzed, unable to ensure security of either state institutions or private property. The only force that proved capable of maintaining a degree of legality was the self-organized 'people's guards' who have cut their teeth during past periods of unrest.

The official law-enforcement agencies were hampered by their own leaders' incompetence, corruption, and lack of professionalism. During the days of rioting, many division chiefs (those with a rank above colonel) simply vanished, no longer even answering calls from their subordinates. The whereabouts of the (former) ministers of internal affairs and national security are still unknown; ing completely on their own.

The Kyrgyz state budget is around \$2 billion – almost all of which is allocated for 'protected items' such as salaries and pensions - whereas annual remittances, mainly from migrant workers in Russia, exceed \$3 billion, accounting for around 30 per cent of GDP. The gap between private and public incomes is one of the main sources of systemic corruption. Kyrgyz do not expect anything from the state. and ask only that it not take too much from them in the form of bribes and kickbacks.

Since the earliest days of Kyrgyzstan's independence, public trust in government has been repeatedly undermined by systemic corruption, falsified election results, and the state's reliance on informal institutions. Unlike in other countries with similar problems, corrupt regimes here are overthrown quickly. But the Kyrgyz people now must learn to build as well as they can destroy. Failing that, they will always be risking another plunge into political chaos, and, with it, the threat of state failure.

Alleging that the Centre has not provided any relief to the state, Panja said that the BJP-led NDA government has denied West Bengal of its legitimate dues.

She claimed that the Union government has not yet paid Rs 50,000 crore dues to West Bengal, of which Rs 36,000 crore is for co-funded schemes of the state and the Centre, while holding that the TMC government has ensured that no project suffered because of this.

"The state is also yet to receive Rs 11,000 crore under devolution of funds as its share from various taxes raised from the state," she said, adding that another Rs 3,000 crore is due from the central government on food subsidy and some other heads.

The minister claimed that apart from the Rs 50,000 crore, the West Bengal government is yet to receive Rs 7,750 crore on account of GST compensation dues. She claimed that the state is also yet to receive Rs 6,787 crore through the Centre's borrowing scheme.

The minister said that the BJP is losing its political allies and is getting itself "new allies" in the central investigation agencies to browbeat political opponents.

Jaipur, Nov 28: The Rajasthan government Saturday fixed the rate for Covid-19 RT-PCR tests by private labs in the state at Rs 800, slashing it by Rs 400.

Chief Minister Ashok Gehlot said the government ordered the lowering of the Covid test rates from Rs 1,200 to Rs 800 following a drop in test kits prices.

The state government issued the order slashing the Covid-19 test rate by private labs soon after the chief minister digitally inaugurated a 70-bed Covid-19 Intensive Care Unit in RUHS Hospital here and disease testing labs in six towns.

Speaking during the programme, Gehlot said his government is making all efforts to strengthen the Covid-19 management infrastructure. "People should not be worried by the rise in positive cases as they will do due to the increasing number of tests," he said.

He sought to assure people of "encouraging" recovery rate in the state, saying Rajasthan has a Covid death rate below one per cent – one of the lowest in the country.

Gehlot said the corona infection must not be hidden at any stage because delaying treatment makes



the disease fatal.

He said those who did not get themselves screened timely had to undergo treatment in hospital.

The chief minister said the health infrastructure has been strengthened throughout Rajasthan for maximum screening and proper treatment of corona-infected persons and now RT-PCR testing facility is available in every district.

Defending Covid-infected Health Minister Raghu Sharma's visit to newly set up ICU in RUHS Hospital, a dedicated Covid hospital, in Jaipur, the chief minister asked who else will conduct a visit if not the health minister.

Gehlot said after testing positive, the minister was admitted in the RUHS Hospital and he inspected the newly set up ICU there.

BJP had raised objections after the Covid-positive minister visited the hospital. The BJP leaders had accused him of putting the lives of others including the hospital staff at risk

Tram to become art gallery in Kolkata

Kolkata, Nov 28: An art gallery on a tram will be Llaunched in Kolkata in the first week of December to celebrate the city's artistic spirit, West Bengal Transport Corporation (WBTC) Managing Director Rajanvir Singh Kapur said Saturday.

Conceived by the WBTC, the Kolkata Tram Art Gallery would display a vista of art and paintings by contemporary artists. A tramcar has been modified in such a way that paintings can be easily displayed in

its interiors.
"The idea of the Tram Art Gallery

is to make art exhibitions accessible, especially for students. The gallery on wheels would reach all parts of the city, rather than people visiting a gallery in one corner of it." Kapur said

On the days artists book the tram, people will be able to view their paintings on paying a nominal entry fee of Rs 6. The WBTC would be displaying a collection of old photos from its archive when there will be no booking,

"The tram would travel the entire city, and would be parked at major junctions like Esplanade, Shyambazar and Gariahat for a

few hours daily or on alternate days, as per the artists' desire," so that people of central, north or south Kolkata respectively are able to see their work, a WBTC official said. The tram would be available to artists at a daily rate of Rs 3,600. The charge for two days would be Rs 6,000 and for three days, Rs 8,000, and after that, it would be Rs 1,500 for each day.

There would be concessions of up to 50 per cent for artists who are students of any school or college and also those from charitable organisations doing an exhibition for any social cause, the official said.

New bird species makes first appearance in Raj

Jaipur, Nov 28: The spotting of a new species of babbler bird has added a new dimension to Rajasthan's rich biodiversity. The small resident bird spotted in Udaipur is a puff-throated babbler, whose scientific name is Pelornius ruficeps.

This new species of bird has been found in the Phulwari Ki Nal Wildlife Sanctuary in Udaipur district. The puff-throated babbler was spotted by environmental scientists Dharmendra Khandal, Satish Sharma and Harkirat Singh Sangha, who are working for biodiversity conservation in south Rajasthan. A detailed report on this has been published in Issue 16 of the 'Indian Birds'.

Udaipur-based ornithologist Satish Sharma said that the newlyspotted bird is a member of the babbler family whose beak and legs are light pink in colour. The colour of the back is light black, the throat is completely white and there are deep stripes on the chest.

The white and black stripe above the eye extends to the back of the

groups and eats insects lying on the ground in the clump of leaves falling down from trees.

This babbler species is found in Vijayanagar, Gujarat, the plateau regions in Bihar and Odisha, Eastern and Western Ghats regions, Palakkad in Kerala, and Chitteri Hills in Tamil Nadu, among other places.

New Delhi, Nov 28: Top doctors have warned elite runners are taking a major health risk by competing in Sunday's New Delhi halfmarathon in the midst of a major coronavirus outbreak and soaring air pollution.

Women's marathon world recordholder Brigid Kosgei from Kenya and Ethiopia's two-time men's winner Andamlak Belihu are among the 49 elite athletes running the 21-kilometre race, while thousands of amateurs are taking part virtually.

Organisers say the "highest level of safety-standards, with bio-secure zones" have been laid on for the race starting at the Jawaharlal Nehru Stadium.

But with New Delhi recording more than 500,000 virus cases, and air quality in the world's most polluted capital hovering between 'un-

healthy' and 'hazardous', health experts said the athletes should think twice. "It will be suicidal for runners to run the race this time. We have such high levels of pollution, we have the risk of coronavirus," Arvind Kumar, founder trustee of the Lung Care Foundation, told this news agency.

"With the presence of this twin threat if people are still running despite knowing everything, well, I have no words to express my anguish." "Whether you are an international elite runner or you are a small boy from a village, the damaging potential of a damaging agent remains the same," said the doctor.



Hacker selling CEO, CFO email accounts for as less as ₹7,400

COMPROMISED CORPORATE EMAIL ACCOUNTS ARE GOLDMINES FOR CYBERCRIMINALS AS THEY CAN BE MONETISED IN MANY DIFFERENT WAYS

New Delhi, Nov 28: A hacker is selling passwords for the Microsoft email accounts of hundreds of toplevel executives including CEOs, CFOs and CMOs on the Dark Web for nearly \$100-\$1,500 (nearly Rs 7,400-Rs 1.1 lakh) per account.

According to a report in ZDNet late Friday, the threat actor is currently selling email and password combinations for Office 365 and Microsoft accounts of C-level executives and the selling price is set depending upon the company size and the role of the executive.

"The data is being sold on a closedaccess underground forum for Russian-speaking hackers called exploit.in"

The high-level employees at risk include chief executive officers, chief operating officers, chief financial officers, chief marketing officers, chief technology officers, presidents, vice presidents and company directors, among others.

The cover security researcher who agreed to contact the seller to obtain samples "confirmed the validity of the data and obtained valid credentials for two accounts". The email accounts belong to the

CEO of a US medium-sized software company and the CFO of an EU-based retail store chain, according to the report. The seller refused to share how

he obtained the login credentials but said he had hundreds more to sell". According to data provided by



threat intelligence firm KELA, the same hacker previously expressed interest in buying "Azor logs," a term that refers to data collected from computers infected with the AzorUlt info-stealer Trojan

Compromised corporate email accounts are goldmines for cyber-criminals as "they can be monetised in many different ways," KELA product manager Raveed Laeb was quoted as saying.

Most likely, the compromised emails can be abused for CEO scams. also known as Business Email Compromise (BEC) scams which are on the rise globally including in India.

Global cybersecurity firm Trend Micro recently said it blocked 438 million email-borne cyber threats in India in the first half of this year which represented the thirdhighest numbers in Asia.

Business Email Compromise (BEC) detections increased by 18 percent from the second half of 2019, in part due to scammers trying to capitalise on home workers being more exposed to social engineering Educational institutions are more

than twice as vulnerable to a carefully-crafted BEC attack as any average organisation, according to a latest report by Barracuda Networks, a leading provider of cloud-enabled security solutions.

Using this form of attack, threat actors have taken hold of schools, resulting in devastating losses.

Such spear phishing attacks hit the Indian education sector hard between June and September, affecting more than 1,000 schools, colleges, and universities, according tothe report that came out earlier this month.



UP ordinance on conversions comes into force

Uttar Pradesh becomes the first state to bring anti-love jihad law after Governor promulgates ordinance

Lucknow, Nov 28: Uttar Pradesh Governor Anandiben Patel Saturday gave assent to an ordinance against forcible or fraudulent religious conversions that provides for imprisonment up to 10 years and a maximum fine of ₹50,000 under different categories.

The promulgation of the Uttar Pradesh Prohibition of Unlawful Conversion of Religion Ordinance, 2020, came four days after the Yogi Adityanath government had approved the draft of the legislation which also curbs religious conversions only for the sake of marriage.

The new law, however, did not go down well with the Opposition Samajwadi Party. Hours after the Governor's nod, SP president Akhilesh Yadav said his party will oppose the Bill when it comes up in the UP Legislature for passage.

"The Samajwadi Party is not in favour of any such law. We will oppose it (when it comes up in the Assembly)," the SP leader said in reply to a question at a press conference here. According to the ordinance, a marriage will be declared "null and void" if the conversion of a woman is solely for that purpose and those wishing to change their religion after marriage need to apply to the district magistrate.

It also has a provision under which if someone returns to their original religion, it shall not be deemed a conversion. While the onus to prove that the conversion has not been done forcibly will lie on the person accused of the act and the convert, it said. In case of contravention of the law, the ordinance says that the court shall grant appropriate compensation payable by the accused to the victim of conversion which may extend to a maximum of ₹5 lakh in addition to the fine.

The ordinance sa shall convert, either directly or indirectly from one religion to another by use or practice of misrepresentation, force, undue influence, coercion, allurement or by any fraudulent means or by marriage nor shall any person abet, convince or conspire such conversion. An aggrieved person, his/her parents, brother, sister, or any other person who is related to

him/her by blood, marriage or adoption may lodge an FIR about such conversion, according to the ordinance.

In cases of mass religious conversion, the registration of the social organisations will be cancelled, and strong action will be initiated against them. If those previously convicted under the ordinance are caught again for the same offence, they shall be subjected to double punishment, it said.

Notwithstanding anything contained in the Code of Criminal Procedure, 1973, all the offences under this ordinance shall be cognisable and non bailable and triable by the sessions court, the ordi-In recent weeks, BJP-run states

like Uttar Pradesh, Haryana and Madhva Pradesh have revealed plans to enact laws to counter alleged attempts to convert Hindu women to Islam in the guise of marriage, which Hindu activists refer to as "love jihad".

The UP Cabinet's approval to the ordinance followed the announcement by Adityanath that his government would come out with a law to deal with "love jihad".

Adityanath had used the Hindu funeral chant of 'Ram Naam Satva Hai' to threaten those who do not respect daughters and sisters

The RJD is gearing to field its own candidate for the upcoming Rajya Sabha by-elections. Earlier, November 27, the Bharatiya Janata Party (BJP) nominated the name of former Deputy Chief Minister and party leader Sushil Kumar Modi as the NDA candidate for the Rajya Sabha by-elections.

The BJP has nominated Sushi Modi for the Rajya Sabha seat recently vacated after the death of former Union Minister Ram Vilas Paswan. With this major decision, the saffron party has put a stamp of approval on Sushil Modi's name by bringing him into national politics. Considering the sheer numerical strength of the NDA in the Assembly, Sushil Modi is likely to be elected as Rajya Sabha member.



seat can be filed till December 3 and the by-elections for the Upper House of the Assembly will be held December 14.

As per RJD sources, two names are being pitched in by the Grand Alliance for the upcoming Rajya Sabha by-elections. The party is likely to nominate RJD state President Jagdanand Singh and senior party leader Abdul Bari Siddiqui for the Rajya Sabha seat. Siddiqui had recently lost the Bihar Assembly elections. 



Iran vows revenge over slain scientist

THE DEFINITIVE PUNISHMENT OF THE PERPETRATORS

Tehran, Nov 28: Iran's supreme leader Saturday called for the "definitive punishment" of those behind the killing of a scientist linked to Tehran's disbanded military nuclear program, a slaying the Islamic

Republic has blamed on Israel. Israel, long suspected of killing scientists a decade ago amid tensions over Tehran's nuclear program, has yet to comment on the killing Friday of Mohsen Fakhrizadeh. However, the attack bore the hallmarks of a carefully planned, military-style ambush.

The slaying threatens to renew tensions between the US and Iran in the waning days of President Donald Trump's term, just as President-elect Joe Biden has suggested his administration could return to Tehran's nuclear deal with world powers from which Trump earlier withdrew.

The Pentagon announced early



Saturday that it sent the USS Nimitz aircraft carrier back into the Mideast. In a statement, Supreme Leader Ayatollah Ali Khamenei called Fakhrizadeh "the country's prominent and distinguished nuclear and defensive scientist."

Khamenei said Iran's first priority after the killing was the "definitive punishment of the perpetrators and those who ordered it." He did not elaborate. Speaking to a meeting of his government's coronavirus task force earlier Saturday, President Hassan Rouhani blamed Israel for the killing.

Rouhani said that Fakhrizadeh's

death would not stop its nuclear program, something Khamenei said as well. Iran's civilian nuclear program has continued its experiments and now enriches uranium up to 4.5 per cent, far below weaponsgrade levels of 90 per cent.

But analysts have compared Fakhrizadeh to being on a par with Robert Oppenheimer, the scientist who led the US' Manhattan Project in World War II that created the atom bomb. "We will respond to the assassination of Martyr Fakhrizadeh in a proper time,' Rouhani said.

He added: "The Iranian nation is smarter than falling into the trap of the Zionists. They are thinking to create chaos." Climate change having uneven impact on world's arid regions

London, Nov 28: While climate change and rising global temperatures are leading to decline in vegetation in arid regions of the world's poorest countries, the situation appears to be better in wealthier countries, says a study.

For the study, published in the journal Nature Sustainability, researchers from University of Copenhagen in Denmark followed vegetation trends across the planet's driest areas using satellite imagery from recent decades.

They found that too little vegetation is sprouting up from rainwater in developing nations, whereas things are headed in the opposite direction in wealthier ones. As a result, the future could see food shortages and growing numbers of climate refugees.

'We observe a clear trend of arid areas developing in a negative direction in the most economically challenged countries," said Professor Rasmus Fensholt from University of Copenhagen. "Here, it is apparent that the growth of vegetation has become increasingly decoupled from the water resources available and that there is simply less vegetation in relation to the amount of rainfall. The opposite is the case in the wealthiest countries." According to the researchers, there may be several explanations for the uneven impact of climate change. Among the most obvious is rapid population growth, in



Africa for example, where there is an increasing need to exploit

land that is otherwise poorly suited for agriculture

Doing so produces lower yields and puts increasing amounts of livestock on too little grass in already fragile ecosystems. Conversely, vegetation in arid areas of the world's wealthier countries seems to be coping better with climate change

This is likely due to the intensification and expansion of larger farms, where more economic resources allow for, among other things, irrigation and fertilisation. "Here, our results demonstrate that in arid regions, particularly those in Africa and Asia, less vegetation grows for the amount of rainwater that falls, while more vegetation grows in arid areas of South America and Australia," said lead author

Christin Abel from University of Copenhagen.

The results suggest that as a result of climate change, future trends for the planet's poorest areas only seem to be getting worse at a time when more than 40 per cent of Earth's ecosystems are arid. Forecasts point to an expansion of today's arid areas where they will make up a larger and larger share of our global ecosystems. This may result in more and more people \rightarrow being left without food and their needing to migrate.

"One consequence of declining vegetation in the world's poorer arid regions areas may be an increase in climate refugees from various African countries, Fensholt said.

Washington, Nov 28: In a fresh setback to US President Donald Trump's efforts to reverse the November 3 presidential election result in the battleground state of Pennsylvania, a court has dismissed a lawsuit filed by his team, observing that "voters, not lawyers choose the president."

The judgement came four days after Pennsylvania certified Trump's Democratic rival Joe Biden as the winner in the state which has 20 Electoral College votes. Trump, a Republican, has refused to accept defeat in the November 3 presidential election, and told reporters Thursday that it would be "hard" to concede to Biden, a Democrat.

The President has said that he would leave the White House if the Electoral College declares Biden as the winner, but made clear he is not prepared to "concede" the election. He has launched a slew of lawsuits in key states, but has not provided any evidence to back his claims of electoral fraud. Many of the lawsuits have been dismissed by courts.

The three-judge panel of the 3rd US Circuit Court of Appeals on Friday upheld a previous ruling that dismissed the Trump campaign's request for an injunction in the case in Pennsylvania to challenge the election results and slammed the lawsuit.

"Free, fair elections are the lifeblood of our democracy. Charges of unfairness are serious, but calling an election unfair does not

make it so. Charges require specific allegations and then proof. We have neither here," Judge Stephanos Bibas said in his order. "The campaign cannot win this

lawsuit," said Bibas, who was appointed by Trump. He authored the order along with two other judges on the bench, Chief Circuit Judge Brooks Smith and Judge Michael Chagares, who were appointed by former Republican president George W Bush.


Trump has refused to concede the November 3 election to Biden and has filed multiple lawsuits challenging the poll results in several states.

Former vice president Biden was declared the winner of the US presidential election on November 7 after flipping Pennsylvania, Michigan and Wisconsin to the Democrats' column.

Biden has 306 electoral votes to Trump's 232 votes. To win the race to the White House, the successful candidate should have at least 270 electoral votes out of the 538-member Electoral College. Biden's tally is far more than the 270 needed to win the race for the White House, and he also leads the popular vote by more than six million.

EPFO extends deadline to submit life certificates

New Delhi, Nov 28: Retirement fund body EPFO has extended the deadline for submission of life certificates by pensioners till February 28. a move which would benefit over 35 lakh persons who could not submit the document by November due to coronavirus pandemic.

The pensioners who could not submit their life certificates till November 30 deadline, would get pension every month till February

"In view of the ongoing COVID-19 pandemic and the vulnerability of elderly population to coronavirus, the Employees' Provident Fund Organisation (EPFO) has extended the time limit up to 28th February 2021 for submission of Life Certificate (Jeevan Pramaan Patra-JPP) in respect of the Pensioners drawing pension under EPS 1995 (Employees' Pension Scheme-1995) and whose Life certificate is due in any month till February 28, 2021," a labour ministry statement said.

Presently, a pensioner can submit JPP anytime during the year up to 30th November, which is valid for a period of one year from the date of issue. All such pensioners can submit life certificates till February 28, 2021.

During this extended period. pension will not be stopped in respect of 35 lakh pensioners who could not submit JPP during November 2020, the ministry added.

Punjab accepts borrowing option to meet GST shortfall

New Delhi, Nov 28: Congressruled Punjab has accepted the Centre's borrowing proposal and will get ₹8,359 crore through the special window to meet GST revenue shortfall.

"Government of Punjab has communicated acceptance of option 1 to meet the revenue shortfall arising out of GST implementation. The number of states which have chosen this option has gone up to 26. All the 3 Union Territories with Legislative Assembly (i.e. Delhi, Jammu & Kashmir and Puducherry) have also decided in favour of option 1. a finance ministry statement said.

The Centre has already borrowed ₹24.000 crore on behalf of the states in four instalments and has passed it on to 23 states and three Union Territories October 23, November 2, November 9 and November 23. From the next round of borrowings, Punjab, Kerala and West Bengal too would receive funds raised through this window. Earlier this week, Kerala and West Bengal too had communicated to the Centre about accepting the borrowing option to meet GST revenue shortfall.

Under the terms of option 1, besides getting the facility of a special window for borrowings to meet the shortfall arising out of GST implementation, states are also entitled to get unconditional permission to borrow the final instalment of 0.50% of GSDP out of the 2% additional borrowings.

India's GDP in the July-September period contracted 7.5%, compared with 23.9% in the preceding quarter.

The GVA in Q2 2020-21 from the manufacturing sector grew 0.6%, as compared with a degrowth of 0.6% in the corresponding quarter of the previous fiscal.

The report by Soumya Kanti Ghosh, Group Chief Economic Adviser, State Bank of India, said: Though the whole press release is full of surprising numbers, the most astonishing number is the positive growth in manufacturing in Q2." He noted that despite being the worst affected sector in Q1 (due

Three MPs and Minister of State MSME Pratap Chandra Sarangi wrote letters to the union commerce and industry minister Piyush Govel to take up the matter of revival of NINL and to release long pending salaries and arrears as early as possible.

In his letter, Sarangi writes, "Considering the protracted disinvestment process, the effort should



be made to start operation of the plant and also 110mn tonnes capacity iron ore mines owned by suitable PSUs, preferable from the Ministry of Steel (MoS) so that thriving plant would be a lucrative offer for the strategic buyers."

"Besides, it is estimated ₹230 crore worth of finished products is lying in NINL plant premises which could be sold suitably to fund NINL for payment of staff salaries.

Further, at a time when disinvestment of NINL is being pursued, it would be at larger public interest to retain the in heren t character of NINL as steel plant by way of selling the stakes to a relevant strategic buyers," the minister added.

He urged the Centre to interfere the matter and expedite the implementation of the decision reached in the meeting held August 13, 2020 in the larger interest of suffering families.

Meanwhile, Lok Sabha MP Mayurbhanj Bishweswar Tudu urged the government to merge NINL with steel PSU SAIL/RINL/NMDC. Jajpur MP Sarmistha Sethi also requested the (Central) government to restart the plant and insisted to release legitimate dues of employees.

With no Plan B in place, Men in Blue need their 'A' game to save ODI series as they face Australia in second match today

Sydney, Nov 28: India's battered bowling unit will have little time to regroup and limited resources at their disposal in a desperate bid to perform a redemption act and save the ODI series against a turbocharged Australia in the second game here Sunday.

Sam Curran, who took 3-28 with the ball to lead England's bowling attack, helped out with the bat with a six of his own right at the end, and was 7 not out.
