BJP sweeps Raj local body polls

Jaipur: In a major shock to the ruling Congress in Rajasthan, the opposition BJP swept 1,989 seats in the recently-held panchayat samiti elections while the Congress was limited to 1,852 seats. The independents gained 439 seats, Bahujan Samaj Party (BSP) got five seats, CPI-M captured 26 seats in the elections while RLP got 60 seats, according to the state election commission website. The elections were held to 4,371 seats in 222 panchayat samitis spread over 21 districts. BJP's winning streak continued with panchayat samiti elections too.

3 militants killed in J&K encounter

Srinagar: Three unidentified militants were killed and a civilian injured in an encounter with security forces in Pulwama district of Jammu and Kashmir Wednesday, police said. Security forces launched a cordon and search operation in Tikken area of Pulwama district in the early hours of Wednesday following information about presence of militants there, a police official said. He said the search operation turned into an encounter after militants opened fire on the security forces, who retaliated.

Eco Retreat's 2nd edition unveiled

Bhubaneswar: Chief Minister Naveen Patnaik Wednesday inaugurated the second edition of Odisha Tourism's flagship Eco Retreat event at five locations namely Ramchandi beach in Konark, Satkosia, Bhitarkanika, Daringibadi and Hirakud. MSP guarantee? No, thanks

Govt offers written assurance on continuing MSP, other amendments; Farmer unions reject proposal

New Delhi, Dec 9: As thousands of farmers continue to protest at various borders of the national capital demanding the repeal of three new farm laws, the government Wednesday proposed to give a "written assurance" that the existing Minimum Support Price (MSP) regime for procurement will continue.

However, the farmers' unions rejected the proposal and said they would intensify their agitation until the government accepts their demand for a complete repeal of the three laws. They said that the agitation would be intensified and have called for a nationwide protest December 14.

The government also proposed to make necessary amendments on at least seven issues.

In a draft proposal sent to 13 agitating farmer unions, the government also said it is ready to provide all necessary clarifications on their concerns about the new farm laws enacted in September, but it did not mention anything about the main demand of protesting farmers for the repeal of the laws.

At a press conference later in the day, farmer leaders said there was nothing new in the government proposal and they will continue their protest.

Separately, Union Minister Prakash Javadekar said at a post-Cabinet media briefing that the government is sensitive to the concerns of farmers as he expressed hope that ongoing deliberations with them, which he termed a "work in progress", over the three agriculture-related laws will yield some

Meanwhile, a delegation of opposition leaders Wednesday met President Ram Nath Kovind and sought repeal of the three farm laws.

The five-member delegation comprised Congress leader Rahul Gandhi, NCP chief Sharad Pawar, CPI(M) general secretary Sitaram Yechury, CPI general secretary D Raja and DMK leader TKS Elangovan.

Govt caps school bag weight at 10% of kid's

New Delhi, Dec 9: School bags should not be more than 10% of the body weight of students across Std I to X and there should be no homework till class II, states 'Policy on School Bag 2020' of the Union Ministry of Education.

They should be lightweight with two padded and adjustable straps that can squarely fit on both shoulders and no wheeled carriers should be allowed. The policy even recommends that the weight of each textbook may come printed on them by the publishers.

The recommendations have been arrived based on various surveys and studies conducted by the National Council of Educational Research and Training (NCERT).

The policy stated that data collected from 3,624 students and 2,992 parents from 352 schools, which include Kendriya Vidyalayas and state government schools were analysed. The 'Policy on School Bag 2020' made 11 recommendations on the weight of the bags, including



A new policy also states that there should be no homework upto Std II and a maximum of 2 hrs per week for Std III to V

adequate good quality midday meal and potable water to all the students so that they need not carry lunch boxes or water bottles.

The policy said there should be no bags in preprimary. Recommending that total study time should be accounted for while planning the syllabus, the policy said while there should be no homework upto class II and a maximum of two hours per week for classes III to V, homework duration for classes VI to VIII should not exceed one hour a day and two hours a day for

'Reserve expired ore blocks for state PSUs'

Bhubaneswar, Dec 9: To ensure uninterrupted supply of ore to industry, Chief Minister Naveen Patnaik Wednesday urged Centre to reserve some of the expired working mineral blocks to state PSUs like Odisha Mining Corporation (OMC). Naveen discussed the issue with

Union Coal Minister Pralhad Joshi, Union Steel Minister Dharmendra Pradhan and senior officials of the Central government via video conferencing. During the meeting, he pro-

posed reservation of some of the expired working mineral blocks under provisions of section 17A of the Mines and Mineral Development and Regulation (MMDR) Act.

Odisha has been one of the first states to conduct an auction of mineral blocks. However, there have been some glitches in com-



mencement of mining operations leading to disruptions in production and dispatch, Naveen said.

As against a production of 123.8 MT (million tonnes) iron ore in Odisha from January 2019 to November 2019, total production in the same period in current year has been only 98.2MT.

Out of the recently auctioned 24 mines in Odisha only five have been able to start production and dispatch till date.

State throws weight behind farmers Govt to launch

Odisha govt to move Centre demanding implementation of Swaminathan committee recommendations on MSP

Bhubaneswar, Dec 9: The State Cabinet Wednesday resolved to move Centre reiterating its demand for implementation of MS Swaminathan Committee's recommendations on Minimum Support Price (MSP) for all crops and doubling of farmers' income.

Headed by Chief Minister Naveen Patnaik, the Cabinet passed a resolution in this regard unanimously.

The MS Swaminathan-chaired National Commission on Farmers had recommended that "MSP should be at least 50 per cent more than the weighted average cost of production.

"The state government considers that the MSP is an important tool for income generation of the farmers. The income of farmers needs to keep pace with the growth of income in other sectors and the rise in the costs of cultivation. The MSP



of any agricultural produce has to be fixed in a holistic manner so as to make farming operations profitable and to safeguard the farmers against all types of risks, Parliamentary Affairs Minister B K Arukha said.

Odisha has been dedicatedly working towards development of farmers and is committed to the doubling of farmers' income, he said, adding, all government policies and programmes, including the new Agricultural Policy 2020— SAMRUDHI, are aimed at achieving rapid agricultural growth through improved profitability, inclusivity and sustainability.

The State Assembly had earlier passed unanimous resolutions in this regard in 2017 and again in 2018. The Assembly, in March 2017, had unanimously adopted a resolution recommending the state government to urge the Centre to increase the MSP of common paddy to ₹2930 per quintal. Though the Speaker sought an appointment with Prime Minister Narendra Modi in this regard, he is yet to respond.

Meanwhile, the Cabinet also approved tender for construction of a new 100-seat government medical college and teaching hospital at Phulbani and 650 bedded teaching hospital for government medical college at Koraput on turnkey basis. The tender has been awarded to M/s Shapoorji Pallonji and Company Pvt. Ltd at a cost of ₹680 crore. The project has been targeted for completion within a period

New Delhi, Dec 9: The government has approved a framework for the proliferation of public Wi-Fi networks through PM WANI scheme, Communications Minister Ravi Shankar Prasad said Wednesday. PM Wi-Fi Access Network

Interface (PM WANI) would unleash a massive Wi-Fi revolution in the country, Prasad said.

This would entail a complete framework involving multiple elements - Public Data Office (PDO). Public Data Office Aggregators and app providers.



"No licence, no registration, and no fee would be applicable for the PDOs, which could be small shops or even Common Service Centres," Prasad told reporters after the meeting of the Cabinet.

The Cabinet has also approved the laying of undersea submarine optical fibre cable to provide high-speed broadband to Lakshadweep, he said.

"The Cabinet has approved laying of an undersea optical fibre cable to 11 Lakshadweep Islands to provide high-speed broadband internet connectivity," said Information and Broadcasting Minister Prakash Javadekar.

The Cabinet has approved Atmanirbhar Bharat Rojgar Yojana at an expenditure of 1,584 crore for the current

Notably, the Madhya Pradesh government sent a pair of big cats comprising a tiger named 'Mahavir' and tigress 'Sundari' in 2018. While 'Mahavir' was caught in a snare and died, 'Sundari' turned hostile and allegedly killed two persons and a bullock at Baghamunda and Tainsi villages inside the Satkosia reserve area. Then, the tigress was tranquilised in November 2018 and kept in the enclosure at Raiguda in the core area of the Satkosia sanctuary.

This does not conform to the behavioral norms of those in the Armed Forces of India. The related scenes need to be withdrawn. @NetflixIndia @anuragkashyap72 #AkvsAk," read a tweet on the official Twitter handle of IAF.

The tweet was a response to Anil's post where he unveiled the trailer. "No more fooling the audience please. As promised, the REAL narrative of #AKvsAK from the REAL AK," he tweeted while sharing the trailer. In the film, Anil will be seen playing himself, and not an air force officer. As far as the uniform is concerned, AKvs AK is a film shot within a film - something which was highlighted in the trailer as well.

The film is directed by Vikramaditya Motwane, and slated to release December 24.

It has been decided to amend the Odisha Secretariat Service Rules 2016 to dispense with the existing mandatory provision of annual recruitment process under

Now, unlike yearly advertisements of vacancies by Odisha Public Service Commission (OPSC), advertisements will be made only when recruitment is required. This was related to the appointment of Assistant Section Officers (ASOs) made through competitive exams by the OPSC

Briefing media persons, Chief Secretary Asit Tripathy said that due to the existing provision, the OPSC has to relax the upper age limit for recruitment of ASOs as it is unable to conduct the examination each year. With this amendment, the Commission will no longer need to relax the age, he The Cabinet has also decided amend the Odisha Professional Educational Institutions (Regulation of Admission and Fixation of Fees) Act 2007 to pave way for nomination of a retired Orissa High Court judge by the Chief Justice of Orissa

Identify stagnant water bodies for restoration, Collectors told

Bhubaneswar, Dec 9: Following an order of National Green Tribunal (NGT), the state government has directed the District Magistrates (DMs) to identify stagnant water bodies of 0.5 acre area each for restoration.

Water Resources secretary Anu Garg has written letters to all the Collectors and secretaries of the departments concerned to take immediate steps for identification, inventorisation, physical verification, of stagnant water bodies in urban, rural, forest and mining excavated areas. The DMs

were also asked to check water quality and ensure geo-tagging of such water bodies.

"All existing stagnant water bodies in different geographical zones of the state and located in urban, rural, forest and mining excavated areas are to be brought into records and inventory to be made. The physical verification, geo-tagging and water quality analysis of such water bodies should be done," Garg said in her letter.



Bhubaneswar, Dec 9: Former AIIMS-Bhubaneswar director Ashok Mohapatra, Wednesday, said that the government is violating child rights and human rights by closing the schools in the state in the wake of Covid-19 pandemic.

Mohapatra said this at a workshop on 'Human Rights: Covid-19 and India's Resilience' organized by World Human Rights Protection Organization on the eve of International Human Rights Day.

Mohapatra claimed that children are at low risk of getting infected by the novel coronavirus. "Despite this, schools have been shut for the last several months. The school closure is affecting the kids in a big way. This is a kind of human rights vi-

olation," he said. The former director of AIIMS-Bhubaneswar opined that greed and unethical practices are the main reason behind human rights violation. "Human beings need at

least four things – water, food, air and shelter—to survive. But many people in the country are struggling to get these four basic things, which is nothing but violation of their human rights," Mohapatra

According to him, the Covid-19 pandemic has made the human beings helpless. "Now, we should come forward to help each other by following Covid-19 norms, including wearing of masks, social distancing and hand washing," he added.

Participating in the workshop, a few experts highlighted the prevailing inequality in the distribution of national wealth in India. The inequality in income and wealth distribution is also a violation of human rights, they asserted.

As per reports, India's richest 1 per cent of the population holds 42.5 per cent of national wealth while the bottom 50 per cent, the majority of the population, owns a meagre 2.8 per cent.

According to a report by Oxfam, India's top 10 per cent of the population holds 74.3 per cent of the total national wealth while the bottom 90 per cent holds 25.7 per cent of the same. India ranked at 144 out of 156 countries in the World Happiness Index-2019, the experts opined.

ECOR IS ALL GEARED UP TO TACKLE FOGGY WEATHER

Bhubaneswar, Dec 9: East Coast Railway (ECoR) has geared up its manpower to cope with the dense fog during night and early morning in various railway sections under its jurisdiction. In areas prone to be affected by fog, precautions have been taken regarding train running during the current season. Railways already have a well laid-down procedure regarding operation of trains during times of fog and dense weather condition.

During winter, in dense foggy weather, drivers (Loco Pilots) have gers and train movement. Apart from this, several precautions have also been taken and train running staff is being counselled by the Railway Officers and Safety Counsellors to cope with the situ-

In areas prone to dense fog, luminous and fluorescent strips have been painted in OHE (Overhead Equipment) masts, Level Crossings and at busy traffic areas before an approaching 'Stop Signal' to warn the loco pilot that the train is approaching a stop signal and running in sensitive areas. The provision of this device has been of great help to the loco pilots who now can spot these luminous strips even during fog and get extra careful regarding the aspect of the approaching signal.

Railway headquarters to accord highest priority for safe train running during foggy weather. The loco pilots and guards have been in-

structed to ensure that, they should put the safety of the passengers at the top and should run trains at such reduced speed in foggy weather as they may feel confident and comfortable, even if it means loss of punctuality to the train.

Detonators are used in foggy weather or otherwise when visibility is severely impaired to provide an audible indication to the locomotive crew that the train is approaching a signal. These detonators are flat, disc-shaped metal containers, usually coloured red, which contain an explosive mixture that detonates with the application of pressure when the wheels of the locomotive pass over.

Station Managers have been provided with adequate detonators and advised to assess whether visibility is impaired badly enough to warrant the use of detonators.

The Guards of the trains have been counselled and instructed to watch that, the loco-pilot does not exceed the prescribed speed limit during fog. During night as well as in the thick foggy or tempestuous weather impairing visibility during day, a Red Tail Lamp of approved design displaying a flashing Red Light to indicate last vehicle check and device should be lit on the last vehicle as per provisions. Guards have been advised to use flasher lamps during daytime also

Kendrapara, Dec 9: Despite multiple boat mishaps in rivers, boats continue to ferry people in various rivers including in Hansua in Kendrapara district without adhering to safety rules, a report said.

During this time, tourists will visit Bhitarkanika, Hukitola, Habelikothi and Batighar. They will depend on country boats. It is often seen that boats are overcrowded. Notably, a ban had been imposed on passenger boats in Chilika lake after the mishap that claimed six lives some years back.

Mahakalpara Youth Club said 17 panchayats including Padanipal, Ekamania, Sinhagan and Batighar have no bridges and people are bound to depend on country boats. Many boats do not have insurance and boatmen have no licences either: In cases of mishaps, passengers have no chances of getting compensations, he added.

Surendra Sahu of Rajnagar area said,"Over 40 unsafe boats operate during the peak tourist season in Bhitarakanika, Hukitolla and other picturesque islands without fitness certificates. The forest department is not paying heed to this aspect,'

He added that tourists usually risk their lives while crossing the water bodies replete with salt-water crocodiles. There is a need for precaution for tourists during tourists.

Boat owners are supposed to make provisions of life jackets for passengers and tourists. The forest department has made it mandatory for all private boat owners to get fitness certificates from the Inland Water Transport Department at Chandabali to carry visitors to Bhitarkanika

The river ghats at Gupti, Chandabali, Khola and Jayanagar are the busiest ghats to ferry tourists to Bhitarakanika. Similarly, the boats from the ghats at Jamboo, Bahakuda and Kharinashi carry

tourists to Hukitola and Batighar. Locals said, some private boats are not designed to carry passengers to places in the Bay of Bengal. Many boats are operated by untrained youngsters in risky weather conditions."After a tragedy in 2004, no step has been taken for safety of passengers," a local fumed.

Divisional Forest Officer (DFO) Bikash Ranjan Das said, "All boat owners operating in Bhitarakanika have been directed to make insurance coverage of their boats.'

350.296 ha forest land to be acquired in Nabarangpur

Nabarangpur, Dec 9: Even as the Centre is pushing the Bharatmala Pariyojana, 904.32 hectares of government land and 350.296 hectares of forest land will be acquired for the project in Nabarangpur district, a report said.

Meanwhile, the district administration has started holding of public hearings on the project and land acquisition. Reports said, in the first phase, the government will complete road projects of 24,800 km by 2020.

Raipur-Vishakhapatna road project is one of the projects. Both government and private lands for the road will be acquired. The Odisha State Pollution Congrol Board (Rayagada) has started public hearings on the issue. A part of the road admeasur-

ing 365.033 km will be laid through

the district (from Dhanra in Nabarangpur to Tumbigua in Koraput). Before carrying out the road construction, 240 km of the road need environment clearance. The road project will pass through 70 villages in

Nabarangpur and 59 villages in

Koraput. The perimeter of the

road will be of 60 metre wide. In this part of the road project, 16 major bridges, 59 small bridges, 295 culverts and two tunnels will be constructed. Sweet potato currently trades at ₹20 a kilogram in Keonjhar market. But in cities like Bhubaneswar and Cuttack, this is being sold at a higher price - often two to three times higher.

ealth and fitness advisors often emphasise on seafood for muscles, high protein and weight loss. Few of them have studied the immense health risks that come with eating seafood.

Mali Ston is an Adriatic Sea coastal town in Croatia, known all over the world for its unique farmed oysters, of which 5 million sell every year. For centuries, rows of oyster-filled underwater farm beds have spread through the bay. An annual oyster tasting feast has tourists pour in. In 2019 they have had to cancel it because the Institute for Marine and Coastal Research in Dubrovnik has detected norovirus in oysters. The virus has been caused by the sewage from the town pouring in all these years into the bay. Norovirus is a dangerous virus, causing over 20 million illnesses and hundreds of deaths annually. Symptoms, which include chronic vomiting and diarrhoea, can become very severe, very quickly, requiring emergency treatment.

Flame-grilled carp, seasoned with sauces and known as masgoof, is Iraq's national delicacy. Iraq produces 29,000 tonnes of carp each year, grown in farms along the Euphrates river. In 2018, millions of carp died overnight in fish farms. Samples of the dead fish, the water and sediment, sent to laboratories, confirmed the fish died of a virus caused by low temperatures, overstocking of fish farms and polluted river. Warnings have been issued by the government not to eat carp. Seafood is responsible for a large proportion of food-borne illnesses. These are caused by a variety of bacteria, viruses, and parasites. Chemicals, metals, marine toxins, and infectious agents have been found in seafood. The illnesses caused by these agents range from mild gastroenteritis to life-threatening conditions.

Some seafood are inherently more risky than others, depending on the environment from which they come, their mode of feeding and how they are prepared and served. All seafood are susceptible to surface, or tissue, contamination. Bivalve molluscs feed by filtering large volumes of seawater. During this process, they can accumulate and concentrate pathogenic microorganisms. Contamination of seafood by pathogens can occur when areas are contaminated with human sewage. Additionally, seafood may become contaminated during handling, processing, or preparation. Unlike meat and poultry, that are usually fully cooked, seafood is often consumed raw, or prepared in ways that do not kill organisms.

Seafood has been implicated in so many outbreaks of illnesses that data is collected by official agencies in every country. The Food and

Veterinary Office of the European Union has initiated a Rapid Alert System for food. The source of danger, and the country of origin, are reported. Between 1992 and November 1997, the 71 seafood alerts from this system represented 42.5 per cent of all food alerts. These alerts have doubled and tripled since. Thirty-three different countries had exported seafood/fish on which an alert was reported. The highest alerts were received on fish sent from India. So you can imagine the state of seafood being sold within India. Thirty-four people died from poisoning by shellfish, and fish in Japan, in 1475 outbreaks of poisoning reported between 1987 and 1996

In Canada 29 species of fish and shellfish, and/or seafood products, were implicated in seafood-borne illnesses. Ten countries, that had exported these fish to Canada, were implicated. India was one of them

In the United States, from 1973 to 2006, over 500 outbreaks involving thousands of people, have taken place. Some of the pathogens responsible for seafood

Vibrio bacteria, which cause outbreaks of gastroenteritis. Symptoms include watery diarrhoea, abdominal cramps, nausea, and vomiting. V. vulnificus is particularly virulent, especially among patients with liver disease and iron storage disorders, who are at increased risk of invasive disease. Infections can lead to sepsis and severe wound infections. The fatality rate is about 50 per cent for bloodstream infections and 25 per cent for wound infections. In January 2007, vibriosis became a nationally notifiable disease.

Salmonella bacteria, which cause acute gastroenteritis, with symptoms including diarrhoea, abdominal cramps and fever.

Shigella bacteria in fish come from sewage in water. Clinical manifesta-

tions range from watery, loose stools, to more severe symptoms, including fever, abdominal pain and bloody diarrhoea. Complications include seizures in young children, toxic megacolon, Reiter's syndrome, and hemolytic-uremic syndrome Clostridium botulinum is characterised by an acute paralysis. Early signs

and symptoms of botulism often include twitching, slurred speech, and difficulty in swallowing, progressing to descending weakness and paralysis. Foods identified in outbreak investigations have included fermented or salted seafood, especially salmon and whale.

Other toxin-forming bacteria: Staphylococcusaureus, Clostridium perfringens, and Bacillus cereus can form enterotoxins that cause acute gastrointestinal illness. Norovirus infection is characterised by diarrhoea, vomiting, nausea, abdominal cramps, headache, myalgias, and low-grade fever. Seafood, harvested from sewage-contaminated waters, has caused large outbreaks of norovirus gastroenteritis

Hepatitis A virus is the most serious viral infection associated with seafood consumption. It is an acute illness associated with fever, malaise, jaundice, anorexia, and nausea; symptoms may last from several weeks to several months. However, deaths can occur. Outbreaks of hepatitis A virus infections, associated with oysters and clams, have been known since the 1960s. The largest reported outbreak occurred in China in 1988; almost 3,00,000 persons were infected after consuming clams harvested from a sewage-contaminated area.

Helminths: large, worm-like parasites that infect most marine animals. Clinical manifestations, associated with helminthic infections, range from no symptoms, to mild, chronic gastrointestinal symptoms, allergic reactions, and sometimes intestinal perforation. Infections are likely under-diagnosed and underreported, due in part to a lack of routine diagnostic tests.

Contamination through sewage is a common practice around the world, and especially in India. Right from production phase to packaging, transport and consumption, seafood is likely to be contaminated with bacteria, viruses and fungal infections. Intensive fish farming, which involve massive crowding of fish into pens, has substantially enhanced the incidence of seafood diseases in India and abroad.

At processing and packaging stage, seafood is often exposed to unhygienic handling by workers, bad storage conditions, irregular temperatures, addition of preservative compounds. With a heavily globalised food trade, the long journey seafood travels before reaching our plates, drastically increases the chances of it becoming dangerously contaminated.

At consumption stage seafood is often prepared in ways that do not kill organisms, or even many times eaten undercooked or raw – making it a particularly dangerous food. It is important that you understand the consequences of seafood consumption. If not for reasons of sustainability and animal welfare, look at seafood in terms of your own immediate health. People with underlying medical conditions such as liver disease, diabetes, or immunosuppressing conditions, are at higher risk of acquiring severe infection and should be especially careful. As waters grow warmer, seafood will get more and more dangerous to eat

GETTING NATO BACK ON TRACK

IT IS CLEARLY BAD FOR NATO AND EU UNITY WHEN THE **UNION'S TWO MOST IMPORTANT MEMBERS ARE AT ODDS ABOUT AMERICA'S ROLE IN EUROPE**

'S President-elect Joe Biden's nomination of Lloyd Austin, a recently retired four-star general, as Secretary of Defense is a further welcome sign that America has come to its senses and will, after January 20 next year, no longer seek to punish its friends and reward its enemies. To demonstrate this shift to the world, Biden should, immediately on taking office, rescind President Donald Trump's order last July to withdraw 12,000 US troops from Germany.

Without costing the US a penny, Biden would dramatically repudiate Trump's isolationism and throw a wrench into Russian President Vladimir Putin's divide and-rule strategy in Europe. Reversing the troop withdrawal would also strengthen NATO, Germany and Chancellor Angela Merkel - whose potential successor will be chosen in mid-January by her Christian Democratic Union (CDU) - as they battle Putin and homegrown anti-Western populists.

Trump claims that he wanted the US troops out because Germany was short-changing the NATO alliance on defense spending, compelling America to make up for the shortfall. But that is nonsense. And as one of the people who previously advocated it, I should know.

For decades, Republican and Democratic presidents never cared that America was spending far more on NATO than Germany was. For a while, I was convinced that they should care, so in 1986 I wrote How NATO Weakens the West, a book about German defense free-riding. So gung-ho was I about this idea that I also wrote a commentary for The Wall Street Journal entitled, "It's Time to Change the Atlantic Alliance."

But never did I imagine that Trump would use my now-ancient strategic argument as a wrecking ball to demolish NATO solidarity and empower Putin. True, Germany may not be spending enough on defense; the French certainly think so. But the argument that Germany is making a fool of the United States with its



The Western alliance needs a US security guarantee for Germany and other European countries, but this cannot come at the cost of a Franco-German split, which would be another gift to Russian President Vladimir Putin

frugal defense spending is simply a fig leaf for Trump's determination to reward Putin while rebuking Merkel. Putin has long wanted a reduced US troop presence in Europe, and in Trump, he found a US president who was willing to collaborate with him.

My own thinking about NATO and Germany's contribution to it began to evolve not long after my book was published. While promoting it, I debated Lawrence Eagleburger, who was subsequently US Secretary of State under President George H.W. Bush, and met many serious, well-informed military people. I recognised then that what counted most for the US - and still does - is control over the structure and purpose of European defense, not its cost. The transatlantic Cold War-era 'bargain,' according to most US military experts, was that America would pay the lion's share of NATO's expenses in return for leadership of European defense.

In fact, I dropped the "Germans are playing us for suckers" line, born of my wish for an effective transatlantic alliance, when I abandoned the conservative populism that had influenced my early thinking. Moreover, evi dence from the 1980s shows that

the military experts who criticised my book were right. The transatlantic disputes of that period were not about money, but rather over issues like sitting Pershing II missiles in West Germany to counter the Soviet Union's ballistic missiles. West Germans, because of their fraught history and strong peace move ment, were wavering on the issue.

After much tumult, and true leadership on the part of the Social Democratic Chancellor Helmut Schmidt and his CDU successor Helmut Kohl, West Germany installed the Pershing IIs in 1983. And they served their purpose well: NATO traded them away in the 1987 Intermediate-Range Nuclear Forces (INF) Treaty with the Soviet Union, a key agreement in defusing the nuclear threat. The Pershing IIs were subsequently destroyed, and rumour has it that some of the scrap material wound up in special ballpoint pens at the Ronald Reagan Presidential Library, which gave them out as gifts.

Although Trump failed to make German defense spending into a major political issue in the US, it has become a contentious subject in Europe. In a recent interview with Le Grand Continent magazine, French President Emmanuel Macron - a staunch advocate of greater European sovereignty in defense matters - strongly criticised German defense minister Annegret Kramp-Karrenbauer for publishing a commentary in Politico entitled "Europe still needs America." Europe would need America less, Macron implied, if Germany increased its defense spending.

It is clearly bad for NATO and EU unity when the Union's two most important members are at odds about America's role in Europe. The Western alliance needs a US security guarantee for Germany and other European countries, but this cannot come at the cost of a Franco-German split, which would be another gift to Putin.

France and Germany must heal their current defense rift, and America must maintain its security guarantee for Europe. The continent needs US boots on the ground, not only in Germany but throughout the Baltic states as well. One way out of the conundrum would be for Germany to contribute more to European defense budgets, thus providing a measure of the independence that France seeks, while keeping the US troops it wants.

Biden could start this process of reconciliation between France and Germany - and, more importantly, between the US and its NATO partners – by canceling Trump's planned troop withdrawal. He could then use the resulting leverage and his personal contacts (Biden has attended the annual Munich Security Conference for decades and knows nearly all of the key German foreign-policy players) to persuade Germany to spend more on European defense. The main aim of such a commitment would not be to placate America, but rather to boost Macron, a genuine friend of Germany.

There is Grand an elderly civil servant passed over at his workplace, with a broken marriage and trying to create the perfect manuscript but never going beyond the first line for want of the right words, giving a helping hand to the doctor. There is Rambert, the journalist who came on an assignment to the plague ridden city waiting for a way to rejoin his wife. When he gets an opportunity to leave he doesn't, because he feels after what he has seen he belongs there with the doctor, and fighting the plague is everybody's business. And vet exigencies of service make them liable to the disease they were fighting and they were "gambling on their luck and luck is not to be coerced." The work of Camus is a monu-

ment to human dignity and solidarity. The plague is not a punishment for anything deserved and it is difficult to understand the suffering of a child. Rieux, all too human feels in the

midst of his duties that a loveless world is a dead world and when one is weary of work and devotion to duty all one craves for is a loved face, the warmth and wonder of a loving heart. As the Plague runs its course and people are finding joy and life once again, Rieux receives the news his wife who was convalescing at the sanatorium out of Oran dies and he sees it as the extension of the suffering he has been witness to. In the end Rieux reflects, his experience of the plague translates to knowledge and memories of friendship and affection. The novel ends with a prophecy "the plague bacillus never dies or disappears for good; that it can lie dormant for years and years in furniture, and linen chests; that it bides its time in bedrooms, cellars, trunks, and bookshelves; and perhaps the day would come when for the bane and the enlightening of men, it roused up its rats again and sent them forth to die in a happy city.'

Setback for Cong as BJP New Gehlot-Pilot rift surfaces sweeps Raj rural polls

Jaipur, Dec 9: In a major shocker to Rajasthan's ruling Congress, the opposition Bharatiya Janata Party (BJP) swept 1,911 seats in the recently held Panchayat Samiti elections while it was limited to 1.781 seats.

The Independents got 425 seats, the Bahujan Samaj Party got 3 seats while the CPI-M captured 16 seats in the elections while the Rashtriya Loktantrik Party got 57 seats, according to the State Election

The results for 4,239 of the 4,371 seats were announced, with counting was still underway in the re-

The BJP's winning streak continued in Panchavat Samiti elections where they have won the Zila Parishad elections in 353 seats while the Congress was limited to 252. The CPI-M garnered two seats, the Independents 18 and RLP 10 seats.

"This victory is the people's stamp on BJP's rural policies. It reflects PM Narendra Modi's developed ideology for farmers and this victory also reflects the hard efforts made by BJP workers," BJP state president Satish Poonia said.

The Panchayat and Zila Parishad poll victories come at a time when Modi's polices were being protested against in Rajasthan by the Congress government which supported the Bharat bandh call by farmers Tuesday. "When they were pelting stones on BJP office as a part of Bharat Bandh, people voted against their two years of misrule which was marred by lawlessness," Poonia alleged. Also there was no implementation of farm loan waiver as promised by Congress leaders during Assembly elections, the school fee issue, electricity bill issue were further left unresolved, he added.

"The outspoken Rajasthan PCC President Govind Singh Dotasara could not make Congress win in his own constituency. Also Health Minister Raghu Sharma and former PCC chief Sachin Pilot could not win in their own home turfs. It seems that the Congress is losing its hold after two years in power, Poonia said.

State Election Commission conducted these elections in 21 districts -- Ajmer, Banswara, Barmer, Bhilwara, Bikaner, Bundi, Chittaurgarh, Churu, Dungarpur, Hanumangarh, Jaisalmer, Jalore, Jhalawad, Jhunjhunu, Nagaur, Pali, Pratapgarh, Rajsamand, Sikar, Tonk and Udaipur.

The polls were held in four phases including November 23, 29,

December 1, and 5. BJP National president JP Nadda tweeted: "I thank the people of the rural areas of the state, farmers and women for putting their faith in the BJP in the Panchayati Raj and Zila Parishad elections in Rajasthan. This victory symbolises the trust of poor farmers and workers in Prime Minister Narendra Modi.'

Jaipur, Dec 9: The two Congress camps in Rajasthan that nearly cost the party the government in the state a few months back are at it again.

Chief Minister Ashok Gehlot, while inaugurating a Congress office in Sirohi district recently, had said that the state government was saved from a crisis as the senior leaders suspended the rebels within the party fold.

He also accused the opposition BJP of restarting the 'game of thrones' yet again to topple his government.

The rebel leaders, he was insinuating at, were former Pradesh Congress Committee chief and his former deputy Sachin Pilot and the Tonk leader's loyalists, including Ramesh Meena and Vishvendra Singh who were suspended and removed as state ministers when Pilot with his 18 MLAs went to Manesar in open rebellion against the Gehlot leadership.

Gehlot's sudden comments have left all stunned. However, sources from the Congress camp revealed that the Rajasthan Chief Minister is planning to make political appointments and expand his cabinet. At this point, his camp doesn't want his former deputy and his team to be re-inducted and



hence comes this statement, sources said. All this as Congress lost big in the Panchayat body and Zila Parishad polls Wednesday as counting was still underway at several places. The central leadership has been in a damage control mode and has intervened on time before things were exaggerated.

Rajasthan in-charge Ajay Maken made an immediate statement soon after Gehlot's comments in Sirohi. He said that Pilot stands as an asset for the party contradicting Gehlot's claim and assured that the state government was safe. The two statements made by Maken have become the most-discussed issue in political corridors. There are whispers about whether all was well between Gehlot and the Congress high command.

Gehlot has not visited Delhi after Pilot was inducted back into the party, after he nearly jolted Gehlot with a 'coup'.

The central leadership replaced Avinash Pandey (Gehlot camp) by Ajay Maken (from Rahul Gandhi's camp) after receiving feedback from the Pilot camp. Also a threemember team was formed to listen to Pilot's grudges which had included KC Venugopal, Maken and the late Ahmed Patel.

Gehlot at that time had termed Pilot as 'nikamma and nakara' (incompetent and useless). However, with the intervention of veteran leaders like the late Patel, Pilot returned to the party.

Ever since there has been speculations that one of the two will have to be shifted to Delhi to make things smoother in the state.

Both camps, speaking to IANS, have denied it and termed such possibilities as 'rumours' and that both leaders were 'sons of the soil' and will stay put in the state.

Maken, this time quoted Privanka Gandhi's statement, who had after the earlier crisis termed Pilot 'an asset for the party.' All eyes are now set on who will

get better appointments -- Gehlot or Pilot camp -- in the party. Further, the state PCC which

was dissolved post crisis also needs to be reconstituted. Maken said that the PCC shall be formed again by December 31 and by January 31, board and corporation presidents shall be appointed.

In fact, Congress state chief Govind Singh Dotasara also met Pilot soon after attending the meeting on political appointments which, sources said, left the Gehlot camp aggrieved further.

Death penalty & speedy trial features of Maha's Shakti Act

Mumbai, Dec 9: In a bid to curb heinous crimes against women and children in Maharashtra, the state cabinet Wednesday approved a draft bill that has provisions for stern punishment, including death penalty, life sentence, and hefty fines, for the perpetrators, and also speedy trial.

The draft bill seeks to amend relevant sections of the IPC, CrPC and the Protection of Children from Sexual Offences (POCSO) Act for the proposed law's application in the state.

The cabinet approved the draft bill at a meeting here and it will be tabled in the state legislature during its upcoming winter session. Home Minister Anil Deshmukh told reporters after the meeting.

A two-day winter session of the legislature begins in Mumbai from December 14.

He said the bill, to be called the 'Shakti Act', will come up for discussion and approval in both houses of the legislature.

It provides for completing probe in a case within 15 days and trial within 30 days, Deshmukh said. After getting the house nod, the

a sum of Rs 10 lakh will be given to an acid attack victim for plastic surgery and facial reconstruction and the amount will be collected as fine from the convict. Investigation shall be completed

within a period of 15 working days from the date of registration of an offence. Reasons for not doing so shall be recorded in writing by the investigating officer concerned and these may include inability to identify the perpetrator, it said

Then the probe period will be extended up to seven working days. After a charge-sheet is filed, the trial shall be conducted on a day-today basis and completed within a period of 30 working days, according to the draft bill.

Some cases will be tried in-camera for recording of evidence of victims and witnesses who are vul-

"There are some 2.6 lakh employees in the state working in the health sector who will get the vaccine dose in the first round. 

Thrissur(Kerala), Dec 9: A crocodile knocking at your door may sound strange, but that is exactly what happened in a house in Kerala early Wednesday.

A family, living in this central district, opened the front door of their house in the morning as usual, only to find a giant crocodile in the verandah outside. The uninvited 'guest' paid a visit to the house of Shajan Thacheth located near the famed Athirapally waterfalls, the largest waterfalls

in the southern state. Shajan's wife, who opened the door by 5.00 am, was shocked at the sight of the aquatic reptile on their porch, which was the play area of their grandchild. The startled homemaker raised an alarm and awakened other members of the family who immediately alerted the forest department officials.

Hearing their cries, some neighbours and local residents also rushed to Shajan's house and tried to drive away the carnivore using a plastic pole. But, their attempts were futile as the reptile crawled under a sofa.

A video, in which the crocodile is seen biting a pole when someone tried to move it away, has gone viral now. Shajan said they heard some strange noise from the verandah during the wee hours and thought it might be a stray dog, but never imagined that it would be a crocodile.

A seven-member team of forest officials, with the help of some locals, first tried to force the reptile out of the premises and move it to the nearby Chalakkudy river. "But, the croc was reluctant to budge after crawling some distance. So, we tied its mouth and tail safely without causing any injury to the reptile and later released it near the waterfall," T A Ajikumar, forest officer, Charpa Forest Range, said.

Kochi, Dec 9: The world may be in the grip of COVID-19 pandemic, disrupting daily schedules and robbing many of their weekend getaways, but life seems to be normal in the small Lakshadweep islands, which is yet to record the first positive case of coronavirus.

No masks, no sanitisers, and many rules of COVID-19 are not in place and every human activity, including marriages and public gatherings continue, thanks to strict Standard Operating Procedure (SOP) that bars easy entry of people to the island in the Arabian Sea.

According to P P Mohammed Faizal, who represents the islands in the Lok Sabha, Lakshadweep has staved off the COVID-19 pandemic since its outbreak earlier this year, reporting zero cases as of December 8. "So far not a single case of coronavirus has been reported from Lakshadweep because of the exemplary precautionary measures we have taken", Faizal said.

Gaining entry to the 36 sq km island comes with its set of strict measures. Whether it is a common man, officials or people's representatives-- they will have to fulfill the measures including mandatory seven-day quarantine at Kochi, the only point from where transportation via ships and helicopters to the Union Territory is allowed. Faizal said no COVID-19 restrictions have been imposed on the people in the islands.

'No masks, no sanitisers because it is a green area. Lakshadweep is the only place where the schools are open and classes are being conducted. From September 21 onwards, the Prime Minister (Narendra Modi)has allowed to open the schools." "It is like normal. All the functions, including religious ones and others like mar-



riages are being held as usual. Everything is normal here", the two-time MP said

The smallest UT in the country, Lakshadweep is an archipelago consisting of 36 islands with an area of 32 sq km. All the islands are 220 to 440 km away from the coastal city of Kochi in Kerala. According to Census 2011, it has a population of 64,000. Faizal said the moment Kerala reported the first case of COVID-19. also the country's first, in January, the local administration mounted a strict vigil. The

first concern was to stop the arrival of tourists-- both international and domestic. "In the month of March 2019, we stopped it", the MP said. The administration then stopped the entry permit to each of the islands from the mainland and allowed access only to capital Kavaratti from Kochi with the approval of the administrator, officials said. By curtailing the issuance of entry permit, the administration could control the inflow of non-islanders to Lakshadweep, they added.

For the entry of islanders who work in other parts of the county and abroad, officials deployed in Lakshadweep and those who travel to mainland for treatment purpose, a standard operating procedure was formulated Accordingly, those who want

to come to Lakshadweep will have to undergo seven days institutional quarantine in Kochi, with the administration bearing the cost involved in it. To ensure proper testing of samples of islanders quarantined in Kochi, the administration has provided a testing machine to the Kalamassery Government Medical College. "Those who tested negative will be allowed to come to Lakshadweep. Once they reach their particular island, again they have to be home quarantined for a week. That has been strictly monitored by medical and police departments," Faizal said.



Top court relief for IIT Bombay entrant

New Delhi, Dec 9: In a big relief to the 18-year-old student who was on the verge of losing a seat at IIT Bombay, the Supreme Court Wednesday directed the institute to grant him interim admission in an engineering course

Siddhant Batra, a resident of Agra, had lost the seat for the fouryear electrical engineering course after he "inadvertently" clicked on a "wrong" link, which was seeking consent to withdraw from the

A bench comprising Justices Sanjay Kishan Kaul, Dinesh Maheshwari and Hrishikesh Rov said: "List in the reopening miscellaneous week after the winter recess. In the meantime, by interim order, we direct that the petitioner should be permitted to



join the respondent-institution and pursue his course subject to fulfillment of all other formalities."

The court said: "He has then drawn our attention to Chapter XXIII which is the Withdraw Option to state that all the processes as envisaged in Rules 56 to 59 have been completed by him and that he would file an affidavit with annexure setting out how the respondents (IIT Bombay) have completed the process.

Batra moved the top court challenging the Bombay High Court, which dismissed his plea on November 23, saying that it cannot intervene at this stage as all the seats for the course were full.

The High Court, citing the IIT Bombay submissions, had emphasised the admission rules had to be followed and Batra could apply next year for JEE (Advanced).

K'taka passes anti-cow slaughter bill

Bangalore, Dec 9: Amid bedlam, the controversial anti-cow slaughter bill was passed in the Karnataka Assembly Wednesday, with the Congress members staging a walkout in protest.

The bill known as the Karnataka Prevention of Slaughter and Preservation of Cattle Bill-2020 seeks a total ban on the slaughter of cows in the state and stringent punishment to those who indulge in smuggling, illegal transportation, atrocities on cows and slaughtering them, BJP sources said.

'Yes, the bill has been passed in the Assembly," Karnataka Law and Parliamentary Affairs Minister J C Madhuswamy said. Besides cows and calves, the bill also intends to protect buffaloes and their calves less than 12 years of age. There is a provision to set up special courts for the speedy trial of the accused people. It also makes provision for setting up Goshala or cattle-sheds for the protection of livestock. Police have been given powers to conduct checking. The law also gives protection to those who protect these livestock. The bill was passed without any discussion as there was din in the House

New Delhi, Dec 9: The Supreme Court Wednesday took note of the Centre's guidelines and said posters and signages should not be affixed by authorities outside homes of COVID-19 patients in the country.

The apex court, however, added that such posters can be affixed only in specific cases when the competent authority issues specific directions under the Disaster Management Act.

A bench headed by Justice Ashok Bhushan said this in its verdict on a plea seeking directions to do away with the practice of pasting posters outside homes of those infected by coronavirus

The bench, also comprising justices R S Reddy and M R Shah, disposed of the plea, saying the Centre has already issued guidelines, and therefore, states and union territories should not affix such posters.

The Centre had earlier told the top court that its guidelines do not contain any instructions regarding affixing posters and signages outside homes of COVID-19 patients, and there cannot be any stigma attached to it.

The bench had reserved its judgement on the plea on December 3. Solicitor General Tushar Mehta had on December 3 referred to the affidavit filed in the apex court by the Ministry of Health and Family Welfare (MoHFW) and told the bench that guidelines do not require any such affixation of posters.

The counsel appearing for petitioner Kush Kalra had told the apex court that there are no such instructions in the guidelines to affix posters outside the home of



those found COVID positive but the "reality is very different".

While hearing the matter on December 1, the top court had observed that once posters or signages are pasted outside the homes of COVID patients, the people affected are treated as "untouchables", reflecting a different "ground re-

In its affidavit, the ministry had said that "its guidelines do not contain any instructions or guidance regarding affixing of posters or other signage outside the residences of those found COVID positive".

Mehta had told the bench that the Centre has not prescribed this practice and some states might be pursuing it on their own to prevent the spread

of the virus. The apex court had earlier asked the Centre to consider issuing guidelines to do away with practice of pasting posters outside the homes of COVID-19 patients.

It had directed so without issuing any formal notice to the Centre on Kalra's plea seeking framing of guidelines in this regard.

In its affidavit, the ministry has said that all states have been intimated to this effect that the MoHFW has not issued any such guideline to identify COVID-19 patients.

Ties under strain: Jaishankar

New Delhi, Dec 9: External Affairs Minister S Jaishankar Wednesday said China has given India "five differing explanations" for deploying large forces at the LAC, adding this violation of bilateral pacts has "very significantly damaged" their relationship that is now at its "most difficult phase" in the last 30-40 years.

The comments by Jaishankar during an online interactive session organised by Australian think tank Lowy Institute came against the backdrop of the over seven-month-long military standoff between India and China at the Line of Actual Control(LAC) in eastern Ladakh.

'We are today probably at the most difficult phase of our relationship with China, certainly in the last 30 to 40 years or you could



argue even more," Jaishankar said highlighting various aspects of the bilateral ties in the last three decades."The relationship this year has been very significantly damaged.""We are very clear that maintaining peace and tranquility along the LAC is the basis for the rest of the relationship to progress. You can't have the kind of situation you have on the border and say let's carry on with life in all other sectors of activity. It's just unrealistic," he said.

Jaishankar further said, "We

have this problem because from 1988, our relationship had its hiccups, we had our issues and differences but the direction of the ties broadly were positive."The external affairs minister said the relationship progressed in trade, travel and various other domains as both sides inked several pacts to maintain peace and tranquility along the LAC."All of this was posited on the fact that while we were trying to solve the boundary question, we would maintain peace and tranquillity along the border areas," he said, adding there were incidents of arguments between patrols along the border "but you never had a major breach of understanding".

He said multiple agreements between the two sides were inked from 1993 with a commitment that both parties will not bring large forces to the border areas.

No stay on criminal conviction, no contesting polls, rules SC

New Delhi, Dec 9: A person stands disqualified from contesting polls under the election law if his conviction in a criminal case, in which a jail term of two or more years has been awarded, is not staved, the Supreme Court said Wednesday.

The top court's observation came in a judgement by which it dismissed an appeal of Saritha S Nair against the rejection of her nomination papers for contesting Lok Sabha polls from Ernakulam, Kerala, by the returning officers in 2019 on account of her conviction and sentencing in two criminal cases related to the Solar scam in the state.

Hibi Eden of Congress party won the seat.

Nair had also moved the top court against rejection of her nomination papers on the same grounds for contesting Lok Sabha polls from Wayanad seat against Rahul Gandhi.

The plea was dismissed earlier on November 2 on account of nonprosecution.

A bench comprising Chief Justice S A Bobde and Justices A Bopanna and Ramasubramanian trashed the contention of Nair that the rejection of her nomination papers was incorrect as her sentence of three years was suspended by appellate courts. The bench said that

the suspension of the execution of the sentence would not "alter or affect" the conviction and that therefore such a person would remain disqualified.

The top court was very critical of the Kerala High Court for holding the defects such as lack of proper verification, incomplete prayer and allegations against former Chief Minister as incurable in Nair's petition.

"The High Court committed a grave error in holding the three defects...As incurable. The defects are curable and as rightly contended by the counsel for the petitioner, an opportunity to cure the defects ought to have been given..," it said.

Sonia at 74 presides over 'weakest' Congress ever

A landslide brought down trees in the area of the port town of Koper and flooded regional roads, while rising Adriatic Sea waters submerged parts of nearby Piran.

Tight lockdown curbs in Ukraine

Kyiv: Ukraine will introduce tight lockdown restrictions in January, hoping to stop the rapid spread of COVID-19 infections, Prime Minister Denys Shmygal said Wednesday. The measures, which include the closure of schools, cafes, restaurants, gyms and entertainment centres and a ban on mass gatherings, will be in force from Jan. 8 to 24, Shmygal told the televised government meeting.

UK probes possible allergic reactions to Pfizer/BioNTech

London, Dec 9: Britain's medicines regulator Wednesday issued a warning for people with "significant" history of allergic reactions to medicines, food or vaccines to not have the Pfizer/BioNTech jab, a day after the first set of patients were administered their first of two doses of the vaccine against COVID-19.

The warning comes after two National Health Service (NHS) workers experienced "anaphylactoid reaction" symptoms shortly after being injected, but are now said to be recovering well. NHS England said all its trusts involved with the mass vaccination programme have been informed and from Wednesday, all patients scheduled to receive the vaccine will be asked if they have a history of allergic reactions.

'As is common with new vaccines, the MHRA have advised on a precautionary basis that people with a significant history of allergic reactions do not receive this vaccination after two people with a history of significant allergic reactions responded adversely," said Professor Stephen Powis, medical director for the NHS in England.

An anaphylactoid reaction tends to involve a skin rash, breathlessness and sometimes a drop in blood pressure and both the NHS workers who experienced this are said



to have a history of serious allergies and carry adrenaline pens around with them.

'We have been advised by MHRA [Medicines and Healthcare products Regulatory Agency] of two yellow card reports that may be associated with allergic reaction due to administration of the COVID-19 BNT162b2 vaccine," Pfizer UK said in a statement. "As a precautionary measure, the MHRA has issued temporary guidance to the NHS while it conducts an investigation in order to fully understand each case and its causes," it said. Dr June Raine, the head of the MHRA, told a joint select committee hearing on Tuesday that "real-time vigilance" will continue throughout the vaccine rollout process. "We know from the extensive clinical trials that this [allergy] was not a feature, but if we need to strengthen our advice now that we have had this experience in vulnerable populations, the groups selected as a priority, we get that advice out immediately," she said. Experts have indicated that such reactions are to be expected in rare cases with any vaccine, including the annual flu vaccine. Several thousand people became the first to be vaccinated against COVID-19 Tuesday, the day marked as V-Day or Vaccine Day in the UK. Indian-origin husband and wife couple, Hari Shukla, 87, and his wife Ranjan, 83, were among those on the prioritised list of recipients finalised based on those at the highest risk of death from the deadly virus. The NHS has announced that the vaccination programme will be expanded out of the 50 hospital hubs to general practitioner (GP) surgeries around the country from next week. Doses are expected to be delivered to around 200 GP surgeries initially to allow them to start next Tuesday, when over-80s will be invited first.

UK, EU head for supper showdown

Brussels, Dec 9: Leaders of Britain and the European Union will meet Wednesday for a dinner that could pave the way to a post-Brexit trade deal - or tip the two sides toward a chaotic economic rupture at the end of the month.

Early-morning comments from both sides insisting that it was for the other to compromise only highlighted the difficult task ahead for UK Prime Minister Boris Johnson and European Commission President Ursula von der Leyen. Within just a few hours they would need to unstick negotiations that are deadlocked on key aspects of the future relationship. British officials said they hoped political pressure from the top could break the logjam, but room was limited.

BREXIT TRADE DEAL

"Unless we see some movement on the EU side, then it will be very difficult," UK Cabinet minister Michael Gove told Times Radio. The bloc insists the UK needs to move to secure agreement.

German Chancellor Angela Merkel said "there is still the chance of an agreement," but stressed that the EU would not compromise on its core principles.

Merkel told the German parliament that the bloc would "take a path without an agreement if there are conditions from the British side that we can't accept.

West undermining our ties with India: Russia

Moscow, Dec 9: Russian Foreign Minister Sergev Lavrov has accused the US-led West of attempting to "undermine" Russia's close partnership and privileged relations with India.

Speaking at a meeting of the staterun think-tank Russian International Affairs Council via a video link Tuesday, Lavrov said the West is seeking to reinstate the unipolar world order that would include all states but for Russia and China with which it would deal later.

"'Poles' like Russia and China are unlikely to be subordinate to it. However, India is currently an object of the Western countries' persistent, aggressive and devious policy as they are trying to engage it in anti-China games by promoting Indo-Pacific strategies, the socalled 'Quad'," he was quoted as saying by the Russian Foreign Ministry. The US, Japan, India and Australia had in 2017 given shape to the long-pending proposal of setting up the "Quad" or the Quadrilateral coalition to counter China's aggressive behaviour in the Indo-Pacific region.

The US says Quad is not an alliance but a grouping of countries driven by shared interests and values and interested in strengthening a rules-based order in the strategically-important Indo-Pacific region. "At the same time the West



is attempting to undermine our close partnership and privileged relations with India. This is the goal of the US' very tough pressure on New Delhi in the military and technical cooperation area (with Russia)," the top Russian diplomat

In 2018, India and Russia announced that they have elevated their strategic partnership into a "special privileged strategic partnership". In October 2018, India had signed a \$5 billion deal with Russia to buy five units of the S-400 air defence missile systems, notwithstanding warning from the Trump administration that going ahead with the contract may invite US sanction.

The S-400 - known as Russia's most advanced long-range surfaceto-air missile defence system - can destroy incoming hostile aircraft. missiles and even drones at ranges of up to 400 km. Rejecting the objective trends towards the formation of a multipolar world, the USled West has launched a "game," Layrov said.

Heroic pilot Chuck Yeager dies

Washington, Dec 9: Chuck Yeager; the first person to travel at a speed faster than the speed of sound, has passed away at the age of 97.

"It is w/ profound sorrow, I must tell you that my life love General Chuck Yeager passed just before 9pm ET," Victoria Yeager tweeted on her husband's account Tuesday.

"An incredible life well lived, America's greatest Pilot, & a legacy of strength, adventure, & patriotism will be remembered for-

Yeager was born in 1923, in Myra, West Virginia. He enlisted in the Army Air Corps in September 1941, was accepted for pilot training under the flying sergeant programme in July 1942, and received his pilot wings and appointment as a flight officer in March 1943 at Luke Field, Arizona, the US Air Force said on its website.

During World War II, Yeager distinguished himself in aerial combat over France and Germany during the years 1943-1945 by shooting down 13 aircraft, five on one mission, including one of Germany's first jet fighters.

Yeager made history October 14, 1947, when he became the first man to fly faster than the speed of sound during his nine-year assignment as the nation's leading test pilot. He also became the first man to fly more than twice the speed of sound in level flight, flying the Bell X-lA December 12, 1953, the US Air Force said.

"Today's passing of Gen. Chuck Yeager is a tremendous loss to our nation. Gen. Yeager's pioneering and innovative spirit advanced America's abilities in the sky and set our nation's dreams soaring into the jet age and the space age." NASA Administrator Jim Bridenstine said in a state-

than 60 years in aviation, Chuck was the first man to fly at the speed of sound, and his achievements rival any of our greatest firsts in space. Not content to rest on his laurels, he went on to break his own record and travel at Mach 2.44. But even before that he was serving his country heroically in World War II." Yeager's heroics have been immortalised in the book "The Right Stuff."

Biden details plan to combat nCoV

Washington, Dec 9: US Presidentelect Joe Biden has said that in the first 100 days of his administration, he would mandate everyone to wear a mask, ensure 100 million COVID-19 vaccinations and reopen the majority of schools as he assured Americans that his "crisis-tested" team of experts will deliver better healthcare and revive the economy

The US is in the midst of a deadly pandemic that has infected almost 15 million Americans and killed 286,000. Globally, there are 68.2 million COVID-19 cases and the pandemic has claimed more than 1.5 million lives. Announcing his national health team, Biden asked the Trump



administration to act now to purchase the doses it has negotiated with Pfizer and Moderna and to work swiftly to scale manufacturing for the US population and the

"This can be fixed. If it does, my team will be able to get at least 100 million vaccinations done in my first 100 days. Third, it should be a national priority to get our kids back into school and keep them in school," he said Tuesday.

Biden named Xavier Becerra as Secretary of Health and Human Services, Indian-American Dr Vivek Murthy as his Surgeon General. He named Dr Anthony Fauci as Chief Medical Adviser to the President on COVID-19, while Dr Rochelle Walensky has been named as Director of the Centers for Disease Control and Prevention: and Dr Marcella Nunez-Smith as COVID-19 Equity Task Force Chair.

Biden announced that in consultation with Dr Fauci, his team has developed the first three obiectives and new initiatives that he is asking them to complete during his first 100 days in office.

Marla, a traditional unit of area used in India, Pakistan and Bangladesh, is considered as equal to 272.25 square feet or 25.2929 square metres. The archaeology department has sent a formal request to the provincial government for releasing over Rs 2 crore for purchasing both the historic buildings, where the two greats of the Indian cinema were born and raised in their early days before the Partition

Raj Kapoor's ancestral home, known as Kapoor Haveli, is situated in the fabled Qissa Khwani Bazar. It was built between 1918 and 1922 by the legendary actor's grandfather Basheswarnath Kapoor.

'Despite lockdowns, world heads to temperature rise'

Nairobi, Dec 9: A green pandemic recovery could cut upto 25 per cent off predicted 2030 greenhouse gas emissions and bring the world closer to meeting the two degree celsius goal of the Paris Agreement on climate change, said a new UN Environment Programme (UNEP) report Wednesday.

The UNEP's annual Emissions Gap Report 2020 reveals that despite a dip in the 2020 carbon dioxide emissions caused by the Covid-19 pandemic, the world is still heading for a temperature rise in excess of three degree celsius this

However, if governments invest in climate action as part of pandemic recovery and solidify emerg-

ing net-zero commitments with strengthened pledges at the next climate meeting -- taking place at Glasgow in November 2021 -- they could bring emissions to levels broadly consistent with the two degrees celsius goal. By combining a green pandemic recovery with swift moves to include new net-zero commitments in the updated Nationally Determined Contributions (NDCs) under the Paris Agreement, and following up with rapid and robust action, governments could still attain the more ambitious 1.5 degrees goal. Each year the Emissions Gap Report assesses the gap between anticipated emissions and levels consistent with the Paris Agreement goals of limiting global warming this century to well below two degrees and pursuing 1.5 degrees celsius. The

report reveals that during 2019 the overall greenhouse gas emissions, including land use change, reached a new high of 59.1 gigatonnes of CO2 equivalent (GtCO2e). Global greenhouse gas emissions have grown 1.4 per cent per year since 2010

on an average, with a more rapid increase of 2.6 per cent in 2019 due to a large increase in forest fires. As a result of reduced travel, lower industrial activity and lower electricity generation this year due to the pandemic, carbon dioxide emis-

sions are predicted to fall up to 7 per cent in 2020. However, this dip only translates to a 0.01 degree celsius reduction of global warming by 2050. Meanwhile NDCs remain inadequate. A green pandemic recovery, however, could cut up to 25 per cent off the emissions the globe would expect to see in 2030 based on policies in place before Covid-19. A green recovery would put emissions in 2030 at 44 GtCO2e, instead of the predicted 59 GtCO2e - far outstripping emission reductions foreseen in unconditional NDCs, which leave the world on track for a temperature rise of 3.2 degrees celsius.Measures to prioritise in green fiscal recovery includes direct support for zero-emission technologies and infrastructure, reducing fossil fuel subsidies, no new coal

plants, and promoting naturebased solutions -- including largescale landscape restoration and reforestation. The report finds that action on a green fiscal recovery has been limited. Nearly one-quarter of G20 members have dedicated shares of their spending up to three per cent

of GDP to low carbon measures. There nonetheless remains a significant opportunity for countries to implement green policies and programmes. Governments must take this opportunity in the next stage of Covid-19 fiscal interventions, the report revealed. At the time of report completion, 126 countries covering 51 per cent of global greenhouse gas emissions hadadopted, announced or were considering net-zero goals.

Centre releases ₹6Kcr to states

New Delhi: The Centre Wednesday said it has released the sixth installment of ₹6,000 crore to the states to meet the GST compensation shortfall. With this installment, a total amount of ₹36,000 crore has been released so far. Debt funds drive inflows into MFs

This had the industry-wide mutual fund assets expanding 6.3 per cent in November to settle at a record high of ₹30.01 lakh crore.

Covid vax to have differential pricing

New Delhi: Global pharma major Pfizer has said it will have differential pricing on its COVID-19 vaccine for different countries, as the company aims to make the vaccine available across the world. The company's Indian arm has sought emergency use authorisation (EUA) for the Pfizer/BioNTech vaccine against COVID-19 in the country from the Indian drug regulator.

FB India FY-20 revenue up 43%

New Delhi: Social media giant Facebook India's revenues grew 43 per cent year-on-year to about ₹1,277.3 crore in 2019-20, while its net profit more than doubled to ₹135.7 crore, as per regulatory documents. The net profit increased by over 107 per cent to ₹135.7 crore in FY20 as compared to ₹65.3 crore in the preceding fiscal.

New Delhi, Dec 9: The Centre has granted permission of reformlinked borrowing worth ₹23,523 crore to nine states.

A Finance Ministry statement said that so far nine states have successfully completed reforms in PDS and implemented One Nation One Ration System – Andhra Pradesh, Goa, Haryana, Karnataka, Kerala, Telangana, Tripura and Uttar Pradesh.

"On completion of reforms, additional borrowing permission of ₹23,523 crore has been issued to them," it said.

In view of the challenges posed by the COVID 19 pandemic for mobilisation of financial resources, the Government of India has taken multiple measures to avail funds to states. These include grant of additional borrowing permission of 2 per cent of the Gross State Domestic Product (GSDP) in the year 2020-21.

This has enabled the states to mobilise additional financial resources to fight the pandemic and maintain the standards of service delivery to the public. However, to ensure long-term debt sustainability and prevent any adverse impact on future, a part of the additional borrowing was linked to the States carrying out reforms in the sectors critical for service deliv-

One of the sectors identified for reforms is the Public Distribution System. Out of the additional borrowing limit of 2 per cent of GSDP, 0.25 per cent is linked to implementation of 'One Nation One Ration Card system'.

This was aimed to ensure that the beneficiaries under the National Food Security Act (NFSA) and other

welfare schemes, especially the migrant workers and their families, get ration from any Fair Price Shop (FPS) across the country.

Department of Food and Public Distribution in the Ministry of Consumer Affairs, Food and Public Distribution is the nodal department to certify that a state has met the conditions stipulated for this reform. Further, to become eligible for additional borrowing, the states have to complete the reforms by December 31, 2020.

It is expected that many more states will complete this reform before the stipulated date, as per the ministry. In addition to the One Nation One Ration Card, other reforms specified as a precondition to avail additional borrowing are ease of doing business reform, urban local body or utility reforms and power sector reforms.

Agritech start-up ties up with FPOs

ICICI loans to Videocon an 'imprudent decision'

Mumbai, Dec 9: The scrutiny of the credit sanctions in the ICICI-Videocon loan case by the Reserve Bank of India (RBI) has highlighted these sanctions to Videocon Group between June 2009 and April 2012, as "imprudent."

This was when Chanda Kochhar was the bank's Managing Director and CEO. The loans were an "imprudent decision" and a clear case of "conflict of interest on her part", the Enforcement Directorate charge sheet mentions. The 308 page charge sheet, filed

by the financial probe agency in Special PMLA court here last month and witnessed by IANS, held that RBI official Malli Sudhakar, in a scrutiny report dated August 3, 2018 and in his statement to the agency October 16 this year, revealed that there was "conflict of interest" on the part of Kochhar.

Sudhakar had cited "absence of transparency in excluding the charge of securities and releasing existing security of Videocon Group taken by as collateral by ICICI Bank and imprudent decision in sanctioning of proposal to Videocon Group by ICICI Bank, of which Chanda Kochhar was Chairperson of recommending committee and member of sanctioning committee, when she was MD and CEO of the bank."

The ED contended that the RBI official, in his statement, reiterated that it was an "imprudent decision" by the ICICI Bank to in-



crease its exposure to Videocon Group by sanctioning fresh rupee term loan (RTL) of ₹750 crore.

Sudhakar further cited the release of security or non-creation of charge by ICICI Bank on the assets of the group.

"The primary security cover available with ICICI Bank in regard to Videocon Group declined from the existing 2.67 times to 1.67 times," he said.

He also claimed that there was a "conflict of interest" on part of ICICI Bank, as advocates and solicitors for the RTL agreement between the bank and the Videocon under debt consolidation were Amarchand and Mangaldas and Suresh A. Shroff and Company.

He claimed that the same firm was also appointed as the legal firm by the board of the bank to investigate into the alleged quid pro quo arrangement between Chanda and Videocon group reflecting conflict of interest.

'Limited credit impact' likely on Asia under Biden admin

THE MOODY'S REPORT ALSO SAYS THAT THE US POLICY TOWARDS CHINA IS UNLIKELY TO CHANGE DRAMATICALLY IN THE EARLY STAGES OF THE BIDEN ADMINISTRATION

New Delhi, Dec 9: The policies of US President-elect Joe Biden's administration may have a marginal impact on the credit conditions in Asia and is less likely to deepen trade linkages between the US and Asia, said a report by Moody's Investors Service.

The report also said that the US policy towards China is unlikely to change dramatically in the early stages of the Biden administration.

In addition, a renewed emphasis on improving relations with traditional allies in Asia is likely to confront the longer-term shifts in the economic and geopolitical balance that are increasing China's cen-

trality to the region. "In consequence, we expect the Biden administration's policies to have at the most a marginal impact on credit conditions in Asia," it said.

It noted that outside China, Biden's policy may attempt to revive the "pivot to Asia" adopted by former President Barack Obama.

This policy aimed to increase diplomatic and investment ties with the region while retaining the strategic imperatives of closer security relations with Australia, India, Japan and some Association of Southeast Asian Nations (ASEAN) countries.

However, the Biden administration is more likely to focus on boosting security alliances, with less emphasis on enhanced trade linkages.

"With Japan and Korea, we expect Biden to restore traditional relations under long-standing alliances, making them less transactional. As such, issues related to cost-sharing for military spending are not likely to be intertwined with trade issues, with the resulting invest-



ment certainty supporting the automotive and semiconductor sectors.

The US acting to moderate tensions between Japan and Korea should also help improve reciprocal trade for both countries. For Korea, however, geopolitical risk will remain elevated, with Biden likely to maintain a strategy of maximum pressure on North Korea.

The Biden administration is less likely to deepen trade linkages between the US and Asia, as per the report. The US remains unlikely to join multilateral trade agreements such as Comprehensive and Progressive Agreement for Trans-Pacific Partnership in the near term.

CL tie postponed as players walk off over alleged racism

Paris, Dec 9: The Champions League game between Paris Saint-Germain and Basaksehir was postponed when players walked off the field after alleging that fourth official Sebastian Coltescu of Romania used a racial term when identifying an assistant coach

Players from the Turkish team were furious Tuesday after assistant coach Pierre Webo was shown a red card by referee Ovidiu Hategan of Romania at Parc des Princes, saying Coltescu had used a racial term to describe Webo, who is from Cameroon, before he was sent off.

Basaksehir substitute Demba Ba demanded that the fourth official explain himself, while PSG players Neymar and Kylian Mbappe also demanded an explanation.

Basaksehir coach Okan Buruk said 'you are racist' to Coltescu. The score was 0-0 when the incident took place about 15 minutes into the match. UEFA said the match would resume Wednesday evening with new officials. "Following an incident at

> tonight's (Tuesday) UEFA Champions League match between PSG and Basaksehir, UEFA has — after discussion with both clubs - decided on an exceptional basis to have the remain-

match played tomorrow with a new team of match officials," UEFA said late Tuesday. "A thorough investigation on the incident that took place will be opened immedi-

ately," it added.

Television footage captured the exchange between the fourth official and the referee, with Coltescu telling Hategan that Webo should be reprimanded for his behavior on the sidelines: "Go and give it (the red card) to the Black one, this is not possible (tolerable), go and identify him, go verify, the Black one over there," Coltescu allegedly said, in Romanian, about Webo.

Webo was enraged and was heard to repeat at least six times "Why you say negro?" as he sought an explanation from Coltescu.

Moments later, Ba came off the bench and stood in front of Coltescu and said: "Why when you mention a black guy, you have to say 'This black guy?

During the interruption, Basaksehir posted a message on Twitter against a UEFA backdrop with the message 'NO TO RACISM'.

PSG defender Presnel Kimpembe, who was on the field during the game, also posted that message on his Twitter account.

Seven years ago, Hategan was in charge of a match between CSKA Moscow and Manchester City when City's black players were racially abused. City captain Yaya Toure directed referee Hategan toward fans making monkey noises at the English club's black players.

PARTHIV HANGS UP HIS GLOVES PRESS TRUST OF INDIA

New Delhi, Dec 9: Parthiv Patel, one of the youngest to have played Test cricket for India at the age of 17, Wednesday announced his retirement from all forms of the game, three month's short of his 36th birthday.

The baby-faced Parthiv, who made his Test debut under Sourav Ganguly, aged 17 years and 153 days, played 65 international games for the country, which included 25 Tests. 38 ODIs and two T20Is.

'Today, I announce retirement from all forms of cricket and as I bring down curtains on this 18 yearold cricketing journey, I feel heavier with gratitude for many," the 35year-old Parthiv said in a statement on his official twitter and instagram account.

The left-handed batsman scored nearly 1,700 runs (1696) across formats with 934 runs (6 half centuries) coming in the longest format.

In ODIs, he scored 736 runs with four half-centuries and a highest score of 95. He effected 72 dismissals in Tests, which include 62 catches and 10 stumpings

Parthiv burst onto the scene in early 2002, when he was sent to England after having played for India A in South Africa and even before he made his Ranji Trophy debut.

'The BCCI showed generous amount of confidence and faith in a 17-year-old boy to play for India. I have enormous gratitude towards them for guiding me and hand holding me in the formative years of my young career," Parthiv further stated. In fact, he played his first Ranji

Trophy after he was dropped from the India squad in 2004 due to belowpar glovework on tours of Australia and Pakistan. He was thankful to all his captains and 'especially Dada', referring to BCCI president Sourav Ganguly.

Once MS Dhoni burst on to the scene, just like the other glovesmen of that time, Parthiv also had to play the catch-up game and be satisfied being the second keeper and at times playing as a specialist bats-

He rediscovered himself as an opening batsman in white ball cricket and that's how he played a few ODIs for India during his second coming but chances were few and far between.

However, Parthiv like a true sportsman had always accepted that he can't blame Dhoni for his sporadic national appearances as both he and Dinesh Karthik got chances to cement their places before Dhoni.

But he did become a domestic legend and before retirement, played an astonishing 194 first-class games in which he had scored 11,240 runs with 27 hundreds at an average of 43 plus.

Add to it, 194 List A games and 204 T20 games, Parthiv had a long run but it was just that Dhoni was a few lightyears ahead as a per-

But Parthiv did play for a lot of IPL teams, including Mumbai Indians, Chennai Super Kings, Royal Challengers Bangalore during the last 13 editions. Probably not getting a game in this IPL edition for RCB was decisive in his case.

"I want to thank the IPL franchises and their owners who made me a part of their teams and looked after me well," he said.

A long time leader of the Gujarat Ranji team, his finest hour would certainly be captaining his state to maiden Ranji Trophy triumph in 2016-17 season.

It was Parthiv, who with his leadership and ability to identify talent, made Gujarat from a middle-level domestic team to one of the best in the country.

Not to forget, he was one of the world's premier fast bowlers Jasprit Bumrah's first skipper at the senior level during the Syed Mushtag Ali Trophy back in 2013, in whichhe made an impression to be picked for Mumbai Indians.
