DESPITE ONLINE CLASSES, MANY STUDENTS ARE UNABLE TO GET ITS BENEFITS

Bhubaneswar, Dec 10: Uncertainty prevails over the reopening of educational institutions in the state with different departments stating different dates for the resumption of physical classes. The Higher Education department has said that they are expecting the educational institutions to repoen in January and this was also echoed by the School and Mass department. Education A final decision in this regard, however, would be taken by the Odisha government after reviewing all the related aspects, including the prevailing Covid-19 pandemic in the state, said Commissioner-cum Secretary of Odisha Higher Education department Saswat Mishra, Thursday.

The School and Mass Education department had hinted earlier that it would reopen in-person learning for students from Class X to XII early next year. The Higher Education department via a notification issued December 7 stated that UG and PG examinations will be held after resumption of classroom teaching and completion of syllabus.

In a letter to vice-chancellors of the state-run universities and principles of all government and non-government colleges, Saswat Mishra had said that the academic session has been badly affected due to prevailing Covid-19 pandemic-related dislocations.

Despite the online classes, most of the students are unable to get its benefits due to various reasons, the notification read.

"Therefore, at present it is not desirable to hold examinations only on the basis

of online teaching. Examinations should be conducted only after resumption of physical classes and completion of syllabus by such classes," it added.

However, the Higher Education department had allowed reopening of laboratories at higher educational institutions across the state. "The higher educational institutions are permitted to open laboratories only for research scholars, MPhil and PG students in science and technology streams requiring laboratory/experimental works," the department had said in a letter

REPRESENTATIVE PIC Meanwhile, School and Mass Education department Minister Samir Ranjan Dash Thursday said there is a possibility of reopening the schools from January 2021.

Addressing the press meet Dash said, "A decision on reopening schools in January has been arrived at and priority would be given to physical classes for students of Classes X, XI and XII so as to help the students appearing for the board examinations next year."

Dash further said, "Around six lakh students will appear in the examinations after 100 days of classroom teaching. Each student will get a 'question bank' to prepare for the examinations."

"That's why we are gearing up for reopening of schools from January next year," added Dash.

Meanwhile, expressing displeasure on statements issued by different departments over the reopening of schools and colleges in the state, Chief Minister Naveen Patnaik said the government will take appropriate decision after considering all aspects.

Farmers' unions threaten to intensify stir

New Delhi, Dec 10: Virtually ruling out repealing of new farm laws, the government Thursday asked farmer groups to consider its proposals for amending the Acts to address their concerns and said it is open to discussing its offer further whenever the unions want, but protesters remained defiant and threatened to block railway tracks too in addition to highways.

As the issue remained deadlocked with both sides sticking to their respective positions, Prime Minister Narendra Modi, while laying the foundation stone for a new Parliament building, invoked Guru Nanak to underscore the importance of dialogue and noted that the Sikh Guru had said that interaction should continue till eternity.

A day after protesting farmers rejected the government's offer for a written assurance on Minimum Support Price (MSP) and amend few provisions in the new farm laws, Union Agriculture Minister Narendra Singh Tomar said at a press conference that union leaders must consider the proposals and said he is ready for further discussions with them, but left it to the farmer groups to propose a date for the next round of talks.

At least five rounds of formal talks have taken place between the Central government and representatives of thousands of farmers, mainly from Punjab and Haryana, protesting on various borders of the national capital for about two weeks, but the deadlock has continued with the unions sticking to their main demand for the repeal of the three contentious laws and repeatedly rejecting the Centre's offer to make some changes in law.

Bhubaneswar, Dec 10: Chief Minister Naveen Patnaik Thursday said the state government will not tolerate banks found neglecting credit disbursement to different livelihood programmes launched to counter the impact of the pre-

vailing Covid-19 pandemic. Patnaik said this while reviewing the Covid-19 situation in the state and the government's efforts in tackling the pandemic situation.

Patnaik has earlier launched several livelihood programmes for farmers, members of Mission Shakti, MSME and others affected due to outbreak of the disease. The banks were told to disburse

adequate credit to the vulnerable groups in order to bail them out of the pandemic situation. "The Chief Minister will take a

review of the credit disbursement

to different livelihood programmes with district magistrates and bank authorities December 22, an official statement said.

"The state will not tolerate negligence in disbursement of credit to the livelihood programmes. The state government will lodge complaint against the erring banks if found neglecting credit disbursement," Patnaik said.

The state government December 22 will write to the Finance Ministry on the erring banks, a statement issued by the Chief Minister's Office said, adding that Patnaik has asked the state administration to remain alert towards the challenges posed to the state's economy. The Chief Minister said that the sero-survey will be undertaken in Ganjam, Nayagarh and Koraput district by December 31, while the next round of sero-survey to take place in Bhubaneswar and Cuttack in January

New Delhi, Dec 10: Prime Minister Narendra Modi laid the foundation stone of the new Parliament building Thursday and described the event as a "milestone in India's democratic history", asserting that if the old Parliament House gave direction to the country post-independence, the new one would be a witness to the making of an 'Aatmanirbhar Bharat'.

Addressing a gathering after laying the foundation stone and performing the ground-breaking ceremony, Modi urged the people to take a pledge to keep 'India First' and asserted that every decision should increase the strength of the country, whose interest is paramount.

Asserting that Indian democratic traditions predate the Magna Carta, a 13th century document many scholars consider as the framework for a modern republic, the prime minister said that the day is not far when the



world will term India "mother of democracy" if Indians extol the country's democratic history with confidence.

"It is a very historic day. Today is a milestone in India's democratic history... We, the people of India, will together build this new building of Parliament," Modi said, adding that the new building will be an inspiration when India will celebrate 75 years of its independence. The making of the new Parliament building is an example of co-existence of the new with the old, he said.

The new building, whose construction is likely to be completedin 2022, will have an area of 64,500 square metres.

Chinese products flood City electronic markets

Bhubaneswar, Dec 10: Several campaigns urging people to boycott Chinese products notwithstanding, inexpensive 'Made in China' items continue to flood the electronic markets in the state capital.

Several electronic outlets at Bapuji Nagar and other parts of the city are flooded with Chinese items procured from Delhi and Mumbai. Encouraged by the popularity of short videos filmed with the aid of mobile applications like Instagram Reels and Facebook Video Status, several youths are trying to use the gadgets to get online fame.

Moreover, the online classes during the lockdown have drawn par-

ents and students to the electronic market for inexpensive laptops, computers, headphones and webcams, boosting the sale of these

'Made in China' products. Buoyed by the easy availability of supporting equipments like ring lights, tripods (stand), mobile zoom lens and others, the electronic market has become their favourite destination. Traders here told **Orissa POST** that the amateur videomakers often seek such equipment at low prices.

"In fact, very few consumers refuse Chinese products and opt for Made in India alternatives. However, there are very few Indian alternatives when it comes to cheap videomaking devices. So most consumers opt for the Chinese items," said Manas Ranjan Sahoo, a shopkeeper from Bapuji Nagar .

Sahoo also claimed that after the ban on Tik tok, the demand for such basic video-making devices has dwindled. Echoing the same sentiments, others shopkeepers from the area said that besides the ban, Covid-related lockdowns also disrupted the sale of electronic items in the city.

Debasis Sahoo, another trader dealing with electronics item in the city, said, "Not only the demand for such items have declined, the supply of new innovative items has also seen a dip. Our sector suffered a setback midway during lockdowns. However, it is picking pace now as online classes have become the norm."

He added, "The online classes, on the other hand, gave a fillip to the electronic sales where the webcams, headphones, laptops and computers among others saw a boost in sales."

HC should monitor SIT **probe: Narasingha**

Bolangir: Bolangir MLA Narasingha Mishra, Thursday demanded a special investigation team (SIT) under the supervision of the Orissa High Court to ensure an impartial probe into Nayagarh minor girl's murder case. Mishra, who is also the leader of Congress legislative party in the State Assembly, said, his party has no objection whether an officer of state police or CBI becoming the member of SIT formed by the state government. However, the SIT should work under the direct supervision of Orissa High Court for an impartial probe. He questioned that how could IG Arun Bothra could probe the Pari murder case as he is posted as the CMD of Odisha State Road Transport Corporation (OSRTC) and has no power as a police officer on the basis of Section-36 of the Code of Criminal Procedure (CrPC). He demanded that whoever becomes a member of SIT should be vested with powers on the basis of Section-36 CrPC. Moreover, the probe by the SIT should be monitored by Orissa High Court following which the probe into Pari murder case could be impartial and trustworthy, he added.

Family seeks stern action against cops

Nayagarh: Soudamini Sahu, the mother of five-year-old Pari, alleged Wednesday evening that the IIC of Sadar police station Rinarani Sahu had misbehaved with her. The investigation of the murder was intentionally played down upon the direction of Minister Arun Sahoo, she added. "I had already expressed that the IIC of Sadar police station has links with Minister Arun Sahoo. She has been deliberately investigating the murder in a different angle to shield Babuli Nayak including and Sahoo. Why has she not been arrested or interrogated so far," Pari's mother questioned. Police picked up Pari's parents from their house at 10am on the 12th day of her murder. They were dropped at their house around midnight. The IIC has been forcing for a false confession, the mother stated. "Police have been treating us like criminals. Once, they even forcibly barged into our house and manhandled me including my mother. The IIC along with Nayagarh SP should be suspended. Strong action should be taken against them," she demanded. Revealing the unholy nexus between the Minister and the criminal, Soudamini said, "I have heard the IIC talking with the minister over phone and taking instructions from him while I was there in the police station for a lie detection test. I can assert that Sahoo is involved in this sensitive murder case."

"On the plea of Covid pandemic, general and other patients are denied treatment and referred to Cuttack. People have to suffer a lot. The hospitals are plagued by staff shortage. Covid management has been in disarray as the ruling party has failed. Massive irregularities have been committed," they alleged.

They demanded a whitepaper on Covid management in the district. Congress workers warned of intensifying the agitation if their demands are not fulfilled immediately.

Two arrested for gemstone smuggling

Rayagada, **Dec 10**: In a major crackdown, the Rayagada police arrested two persons including a teacher Thursday afternoon in connection with smuggling of gemstones in the district.

According to police, they were Radhamohan Mahana, 53, of Sudha Street area in Boudh district and Subash Ratnallu, 45, of Muniguda area in Rayagada district. However, Radhamohan works as a block grant teacher.

Notably, the Special Task Force (STF) of the Crime Branch had raided and seized 23 gemstones worth over Rs 1.5 crore from a house at Jagannath Complex in Rayagada town December 7.

Later, police had arrested Jitendra Kumar Behera from Bijabandali village of Ambadala panchayat under Muniguda tehsil in Rayagada. The STF team confirmed during interrogation that Radhamohan and Subash were also allegedly involved in the supply of gemstones. Further investigation in this connection is under way.

20 hurt as bus turns turtle in Mayurbhanj

Baripada/Rairangpur, Dec 10: Around 20 persons were injured Thursdav after a bus in which they were travelling turned turtle near Kalikapur of Rairangpur in Mayurbhani, According to an eye-witness, the vehicle was on its way to Baripada from Rairangpur locality. The driver of the bus lost control over the wheels, following which the ill-fated vehicle skidded off the road and overturned and fell into a nearby farmland, the eye-witness said. A team of local police and fire-fighting personnel rushed to the spot after they were informed about the accident. They rescued the injured passengers and sent them to Rairangpur hospital. Later some of those injured were shifted to the Pandit Raghunath Murmu Medical College and Hospital, as their conditions deteriorated. Rairangpur police have seized the bus and initiated a probe in this connection. The driver and conductor of the bus managed to flee the spot soon after the mishap, a police official said.

Archana died Thursday morning due to heavy bleeding after delivering a baby girl in the private hospital.

The woman's husband alleged that though they had informed the hospital doctors in this regard, they had not taken the matter seriously.

Other family members decried medical negligence.

Her kin lodged a complaint with Bhadrak Town police alleging negligence on the part of the doctors and hospital staffers during her treatment.

Locals also protested and demanded police to take the matter seriously and punish the real accused responsible for the woman's death. Police have started an investigation into the incident. paddy with scores of them angrily awaiting their turn for procurement. of paddy by middlemen. The crackdown on middlemen will continue, he added.

Reports from Keonjhar said, scores of farmers in Ghasipura area have applied for tokens at Khaliamenta cooperative society. They have harvested their paddy, but tokens have not been issued to them. "We have not received tokens for procurement. The officials concerned have not verified their land records as attached during the registration in August. We are in problem," they lamented. 537 farmers were deprived of tokens due to technical reasons.

Sources in the department said the land of farmers was categorised as irrigated through lift irrigation, but in reality the lands are non-irrigated. Assistant registrar of cooperative

societies Pramod Bariha said such

problems have arisen due to lack of coordination among the district civil supplies department, the cooperation department and the lift irrigation department.

On the other hand, farmers were surprised to learn about the reverse status of their land in registration records. "We have no irrigation points in the area. We have not even mentioned the lands as irrigated during the registration. How could this happen to us," they wondered.

They are worried about preservation of their paddy when the area is haunted by elephant menace.

Many of them said inordinate delay in procurement will force them to sell the paddy to traders. They have taken up the issue with the district administration. services. It was learnt that Odisha Sub Ordinate Staff Selection

Sub-Ordinate Staff Selection Commission floated a notification inviting applications from eligible candidates for filling up of 6,432 vacant posts of nursing officers.

Exploiting masses

There is a runaway rise in fuel prices in the country. So much so that pump prices of petrol and diesel are at a two years' high. Already reeling from a prolonged economic recession and pandemic-triggered distress, the unrelenting rise in petrol and diesel prices is hurting the common man the hardest. Over the last three weeks, petrol price rose by nearly ₹2.5 per litre, while diesel became dearer by ₹3 per. Petrol currently sells at nearly ₹90/per litre, while diesel costs in the upwards of ₹80. In the pandemic time when household incomes are at rock bottom, high fuel rates are adding to the general distress of the people. After six days of continuous rise, fuel prices paused for the third day Thursday. Earlier this month, the RBI had flagged rising fuel rates as one of the key drivers of the steep rise in consumer price index (CPI) inflation. The fresh upturn in fuel rates looks to pose a major challenge even as the Indian economy struggles to recover from the damage inflicted by the Covid-induced economic slowdown. Why are fuel prices rising even when the economy is plodding along? There are two factors for the gyrations of fuel prices. One is the change in international crude prices and, secondly, taxes being levied by the Center and the state governments. First, the global factors: In, 2018 the commodity sold at almost \$70 per barrel, much higher than what it is right now. A barrel of Brent crude currently costs below \$50. Yet, fuel prices are reaching all-time highs. The reason is not far to find. Higher taxes levied by the Centre and state governments are pushing up the pump prices of fuel. For every litre of petrol that we buy we pay in the upwards of ₹50 towards taxes, while for diesel it is over ₹40. High level of excise duty (levied by the Centre) and the value added tax (levied by the states) accounts for 65 per cent of petrol and 60 per cent of diesel costs. The Centre levies around ₹30 as tax on petrol and diesel. This includes basic excise, special additional excise and road or infra cess. This number has almost doubled over the last year. Added to that are taxes by the state governments which vary from state to state. Criticizing the high fuel rates. BJP leader Subramaniam Swamy has dubbed it a monumental exploitation by the Centre of the people of India. Swamy said petrol must sell at maximum ₹40 per litre. Fuel tax constitutes a lion's share of state finance and that is why state governments never want to bring it to within the ambit of the goods and services tax (GST). The higher the prices go up the fatter becomes the government's kitty. Both the Centre and the state governments do not care for the mindless rise in fuel prices even as the poor suffer silently. Ironically, tax receipts of the government have fallen even as the excise on petrol and diesel has grown sharply. The Centre's receipts from excise duty, a bulk of which is generated from petrol and diesel and crude oil sales, have shown a 40 per cent year-on-year rise. High fuel prices will blunt public consumption of fuel and will prove counter-productive for the economy. That apart, the unforeseen fuel rates will stoke resentment among public as fuel is a major input in rising consumer price inflation. India's retail inflation is close to a seven-year high of 7.6 per cent. Food inflation has already seen a steep rise and high fuel costs have further increased the grocery bills. The public anger is building up amid high inflation. It was reflected in the success of the Bharat Bandh called by the farmer unions Tuesday. The bandh was spontaneous and got enormous public sympathy. But this torturous exploitation of the poor must stop before it becomes too late for the government.

ntil very recently, the standard British expression has been railway station, a term which had been in use since the early days of passenger on on rails, and which is still usual among people over the age of about 40. The OED's first citation is from 1838, eight years after the world's first passenger station was opened in Manchester on 15 September 1830. but which must surely have been employed earlier. The word railway itself is rather older, first used in the 1770s. The idea of moving goods by wagons running on parallel sets of rails goes back to the sixteenth century at least, but these early routes had wooden rails (or even stone ones at times, as at Bovey Tracey in south Devon) and were usually called wagonways or tramways. The shift in emphasis that led to the use of the word rail instead was partly due to the increased use of the technique in the colliery routes in north-eastern England, which came to be called lines of rails, but I suspect was most strongly influenced by the introduction of iron rails in the late eighteenth century. They became known as rail ways or rail roads, at first two words, using the word rail in its sense of "rod; bar". This comes from an old French word reille, "iron bar", whose Latin precursor regula, "straight stick, rod", has also bequeathed us regular and rule. At first railway and railroad were used pretty much equally, but by the 1830s the former had prevailed in British English, though the latter was taken to North America and became the dominant term there. Incidentally, when cast iron began to be employed in colliery tramways in the mid eighteenth century - as a result of the new manufacturing method using coke that had been pioneered by Abraham Darby at Coalbrookdale in Shropshire – it was cast into flat plates, usually with a flange. The men who laid this kind of track came rapidly to be known as plate layers and this name persisted as the standard British English term for the men who maintain the track, the permanent way in British railway jargon, even after the iron began to be cast into the form of rails instead. A similar example of the conservative use of language can be found in the name for the conveyances on the new passenger railways. They were called carriages by analogy with horse-drawn vehicles, and this remains the standard term in British English for rail-drawn vehicles, specifically those containing seating for passengers (for which American English would use coach). American English has the general term car for railway vehicles, which British English only uses in compounds, such as restaurant car or sleeping car. (Incidentally, car is not an abbreviated form of carriage but a quite distinct word; they came from the Latin original by different routes, car being a very general term for any wheeled conveyance.) As early drawings show, the design of British railway carriages was actually based on the enclosed carriages of the time and looked exactly like stage coaches on rails; unsurprising, as there were plenty of coach builders about who knew exactly how to create a vehicle of that type (a similar example of fabricational conservatism can be seen in the Iron Bridge over the Severn in Shropshire, which is fastened together exactly as though it were made in wood). A similar effect is apparent in the early days of the motor car, but at least we have been spared the cumbersome name of horseless carriage.

that tenure of a minimum of five years is necessary to make a lasting impact in an executive position. Short tenures cause loss of continuity, reset momentum, and cre ate a leadership vacuum. Revolving doors are no good for stability. Vice-chancellors, presidents, or directors come in with a vision for the institution and prepare a strategic plan to turn the vision into reality. It needs time - especially in higher education where a leader has to work with many stakeholders in a participatory governance model.

The recent move by the state government to replace the member of the search committee rep resenting the university syndicate with a representative of the government is not going to help the situation. As per the recommendation of the 2011 Higher Education Taskforce, the government should reform the outdated university Acts and Statutes in line with the latest UGC guidelines rather than reverting back to the much older Odisha Universities Act, 1989, with amendments by ordinance. It would appear that the unfortunate Indian tradition of selecting academic leaders for 3-4 year tenures in state government institutions is borrowed from a similar practice for bureaucrats. A practice that has been long discarded by the British who introduced it in India for no reason other than the fear that with a longer tenure if an officer becomes popular that may be a problem for the British rulers. Unfortunately, such undesirable traditions seem to linger on in our country in many domains. Of late. there are also reports of ideological dispositions of the ruling dispensation, outright bribery, and quid-pro-quo affecting such appointments. Such perversions would harm the prospects of affected institutions of higher education very badly when it comes to competing with their peers on a global platform.

SKYROCKETING UNEMPLOYMENT IT IS INTEGRAL TO INCORPORATE MARKETABLE AND REAL-WORLD SKILLS WITHIN THE EDUCATION SYSTEM

n an age of skyrocketing unemployment, made worse by L the pandemic, it is integral to incorporate marketable and realworld skills within the education system. A system that integrates skills and education can go a long way in ensuring that the youth are better equipped to handle a chal-

lenging employment market. Employers need to interact with education providers. Both can benefit from strong reciprocal relations, with employers advising educators what skills they need (and even assisting in designing curricula and extending faculty support) and educators providing students with practical training and hands-on learning. There are compelling economic benefits in rebalancing the labour market; conversely, the human costs of failing to do will be enormous.

By deploying its corporate and social responsibility (CSR) capital on skill development projects, the private sector stands to benefit enormously from the availability of a large skilled and disciplined workforce. This can parlay into better levels of customer service, increased productivity and efficiency, reduced absenteeism and em-

ployee turnover, along with lower wages and recruitment costs.

The results of several such programmes have, however, been mixed. Programmes have reported high dropout rates, low employment percentages and continued attrition post-placement, leading to unsatisfied employers as well as frustrated youth. Providing 'skilltraining and certification' alone cannot be a solution to the problem. There is clearly a case for going back to the drawing board.

The new emphasis on skill training should focus on a lifecycle approach. This approach looks at all aspects of skilling, from the aspirations of people before training to counselling and following up with beneficiaries during their employment. Adopting a lifecycle approach to skilling will make sure the kind of skills imparted to trainees are marketable and linked to the available jobs.

It is also important to ensure that specific skills are not scaled across multiple areas in the same region as it saturates the market with limited opportunities for those who are trained. If everyone is trained in becoming a blacksmith, there will be too many blacksmiths

and not enough jobs. Imparting locally relevant skill sets like repairing bicycles or motorised twowheelers, solar lamps, mobiles and running a poultry unit or small animal husbandry and the like makes families self-sustaining.

There are hundreds of organisations and agencies engaged in honing vocational skills and promoting entrepreneurship. While these successful efforts demonstrate the critical roles that emplovers and social sector actors play in the development of a healthy workforce, they are not able to achieve system-wide change. Businesses, educators, governments and young people need to adopt a collective approach and synergise their latent strengths. Closing the skills gap requires that educators and employers work together more closely.

The missing link that underlies the growing unemployment is 'skill development', which is the key ingredient to robust economic growth. With the dilutions of the old 'iron bowl' of employment protection, the idea of lifelong secure employment has now been shattered.

Technology is advancing faster avenues. than we can adapt, upending the job

market and delivering unimaginable shocks to both our values and or patterns of thinking Repetitionbased jobs are stagnating the world over and will soon disappear. Most children entering school today will do jobs that don't exist vet.

Many of the children now being educated in the old system will find the norms, institutions and patterns of working and civic life they were trained for scrambled, when they enter the adult world. Tools of the job are in a state of extreme flux. Spreadsheets, PowerPoint presentations and other boardroom documents have all been changed by the cloud — sharing and group editing are the new norm.

Skills development holds the key to India's ability to activate the vast potential of its youth population for inclusive growth and to evolve as the hub of the global economy. It is perhaps most crucial to long-term alleviation of poverty. Several challenges remain for skill development in India. The huge proportion of informally trained workers who form a part of the informal sector have still no formal training

108-ambulance service failed to reach 50 pc of patients within time between 2014-15 and 2018-19

Bangalore, Dec 10: The Comptroller and Auditor General (CAG) in its latest report has highlighted Karnataka government's successive failure in running the emergency medical services (EMS) under the 108 ambulance services.

The CAG said that in 50 per cent of the trauma cases, ambulances nearly did not reach within the critical golden hour, between 2014-15 and 2018-19.

Besides, the CAG also observed that only in 72 per cent of the cases the ambulance services have reached in the stipulated 30 minutes duration.

The CAG further noted that studies have indicated that the 108 services in cases of cardiac ailments, respiratory and stroke cases, though the time frame stipulated was 10 minutes, in over 60 per cent of cases, it reached much later.

"The success of EMS is largely dependent on its responsiveness to emergencies and the adequacy of the infrastructure in place. Audit noticed that EMS fell short of achieving the desired objectives completely," the CAG explained.

HOW BEEF-BAN IN KARNA HURTS TOURISM IN GOA

GOA IS LARGELY RELIANT ON THE SOUTHERN STATE TO FULFILL ITS DEMAND FOR LIVE CATTLE OR **SLAUGHTERED BEEF**

Panaji, Dec 10: The new anti-cow slaughter bill passed in the Karnataka state Assembly Wednesday is likely to paralyse beef sales in Goa. Goa is largely reliant on the southern state to fulfill its demand for live cattle or slaughtered beef.

'The new law prohibits even the transport of cattle with a jail term. This will make it near impossible for us to bring live cattle to Goa for slaughter," Manna Bepari, president of Quraishi Meat Traders' Association, said Thursday.

Majority of the beef sold in Goa is sourced from the neighbouring state of Karnataka, especially from the border district of Belgavi. On an average, Goa consumes nearly



25 tonnes of beef every day, and the demand rises during the tourism season which stretches from October to March.

The red meat is commonly consumed by tourists, as well as by the members of the minority communities in the state, which account for more than 30 per cent of the population.

Over the last few years, supply of beef in Goa's meat stores has been inconsistent on account of erratic functioning of the state's only authorised abattoir, the Goa Meat Complex, which is allowed to slaughter cattle. Raids by cow vigilante groups on trucks transporting live cattle as well as slaughtered beef from Karnataka have also taken a toll on the easy availability of the red meat

Bepari maintains that the supply of beef from Maharashtra had already dwindled on account of the strict laws being enacted in that state and now with the anti-cattle slaughter bill being strengthened by widening the definition of cattle as "cow, calf of a cow and bull, bullock, and he or she buffalo below the age of thirteen years" in Karnataka would mean that very little amount will come from the southern state too. "In Maharashtra. the law was already strict but now in Karnataka the law has changed

too," Bepari said.

The arrested persons were iden tified as hairstylist Suraj Godambe and drug peddler Lalchandra Yadav who is an auto-rickshaw driver who delivered drugs to the customers. They were produced in the Chief Metropolitan Magistrate Court and were remanded to NCB



custody till December 16, said NCB Zonal Director Sameer Wankhede.

The duo was caught near Meera Towers in the posh Oshiwara area of Jogeshwari West and the NCB team recovered 11 gram of cocaine and Rs 56,000 cash from them. "We have seized 16 packets containing overall 11 gram of cocaine along

proceeds amounting to Rs 56,000,' the NCB said.

While Godambe worked with several top Bollywood personalities and film production houses, Yadav was the conduit who supplied the contraband on behalf of a Nigerian drug syndicate. With this several prominent Bollywood names have come under the NCB scanner and are likely to be summoned for questioning soon.

The latest development comes a couple of days after the NCB seized more than 5 kg of 'Malana Cream' hashish worth more than Rs 2.5 crore and arrested two persons from the Oshiwara area through whom the drugs were procured allegedly for Sushant Singh Rajput.

Lucknow, Dec 10: The Yogi Adityanath government in Uttar Pradesh is planning to amend laws that will prosecute people who harass and evict their parents from the property.

According to official sources, the government is planning to bring in changes to 'UP Maintenance of parents and senior citizens rules 2014' wherein the older parents' children could be punished for evicting them from their property.

The children, in such cases, may also be divested of their rights to parents' property. The Uttar Pradesh Law Commission has prepared an amended draft and sent it to the state government.

The maintenance rules for the parents were prepared in 2014 but there were not enough provisions for protection for the property of senior citizens from their children. Earlier this week, the Lucknow bench of the Allahabad High Court had taken cognizance of the case of an elderly couple whose daughters were trying to force their parents out of their house. The court directed the Lucknow district magistrate to provide protection to an elderly couple who are allegedly being harassed by their daughters for property. The court also sought the state government's reply on the measures taken for the establishment of the tribunal and appellate tribunal under the Maintenance and Welfare of Parents and Senior Citizens Act, 2007, and the rules framed under it for welfare and protection of senior citizens in Uttar Pradesh.

The Allahabad High Court had granted three months' time to the state government to issue notification for establishment of tribunal and appellate tribunal, designate maintenance officer, establish old age homes, constitute district committee of senior citizens ures to give wide publicity in media and to sensitize the public of the state.

Lucknow, Dec 10: It took 12 years for a man to get acquitted of the charges of stealing mangoes and attempting to kill the owner of the orchard.

Rashid Ali Beg, the owner of the orchard, had lodged an FIR at Malihabad police station in June 2008 alleging that Farid Pindari and Hafiz Abdul Rais had forcibly plucked mangoes from his orchard in Malihabad. Beg alleged that the two tried to kill him when he objected to their stealing mangoes.

In the FIR, attempt to murder charges under Section 307 of the IPC (Indian Penal Code) were levelled against Farid Pindari and Hafiz Abdul Rais.

During the course of the legal battle, Hafiz Abdul Rais died and the case against him was closed

In the judgment delivered here earlier this week, the additional sessions judge P.C. Kushwaha acquitted Farid Pindari of the charges of theft of mangoes and attempt to murder. Kushwaha stated that the prosecution had failed to prove that Farid Pindari had forcibly stolen mangoes from the complainant's orchard or had tried to kill him. The investigating officer's (sub-inspector) report also pointed out that no gunshot was fired and no mangoes were stolen. The allegations were levelled due to personal enmity.

Farmer's son sells free winter clothes at Singhu border

New Delhi, Dec 10: Not everything comes with a price tag. Not love, not respect and not the sweaters and jackets that Shakeel Mohammed Qureshi gives away free to protect farmers protesting at the Singhu border from the biting cold.

Around 8 am every day, Qureshi starts setting up his roadside stall, from where he sells locally-manufactured warm clothes for free to the farmers protesting at the Delhi-Haryana border against the Centre's three new contentious farm laws. The 35-year-old man, whose father is a farmer in Uttar Pradesh's

Baghpat district, has distributed around 300 jackets and sweaters for free among the peasants. On an average. he used to earn a profit of around Rs 2,500 daily by selling the winter wear.

"My father is a farmer, too, so I know that their life is very tough," says Qureshi, who lives in Narela in north Delhi with his wife and children. "Farmers don't ask for much from the government, except a fair price for their produce. Unwilling to talk about the price, Qureshi says: "This is my contribution to a good cause. That's all. Help has been pouring in from dif-

ferent quarters for the protesting



farmers at the border. While some individuals and NGOs have been or-

ganising langars (community kitchens) and distributing items of

daily need, others have set up free medical camps. Many have volunteered to clean utensils, collect garbage. charge mobile phones and wash clothes

The farmers have been protesting at several border points into Delhi for the past two weeks over their demands to repeal the new legislations, which they claim would benefit the corporates and end the traditional wholesale markets and the minimum support price regime. The union leaders had rejected a government proposal on Wednesday to amend the new legislations and announced that they would intensify their agitation.

Most of the farmers have come prepared, but a few need support to keep fighting, according to Qureshi, who hopes to have a merchandise store of his own before he turns 40. His head held low, Qureshi smiles when a protesting farmer, who just got a free jacket from his stall, said: The god will give you a fortune in return. You have a small shop, but 🛁 a large heart.'

New Delhi. Dec 10: In a veiled reference to China's aggressive military behaviour, Defence Minister Rajnath Singh Thursday said exercising self-restraint in the conduct of activities and avoiding actions that may further complicate situation will go a long way in bringing sustained regional peace

In his address at the ASEAN Defence Ministers' Meeting-Plus (ADMM-Plus), Singh also said terrorism remains a major scourge for the region and the world. The structures that support and sustain terrorism continue to exist, including in India's neighbourhood, he said in an apparent reference to terrorism emanating from Pakistan. He called for stronger commitment and need to strengthen international mechanism to fight terrorism, "jointly and vigorously".

Talking about key geo-strategic issues, the defence minister high-



lighted India's vision for an open and inclusive order in the Indo-Pacific region based on respect for sovereignty and territorial integrity of nations and peaceful resolution of disputes through dialogue.

Chinese Defence Minister Wei Fenghe was among those who attended the virtual meeting of the ADMM-Plus, a platform comprising 10-nation ASEAN (Association of

Southeast Asian Nations) and its eight dialogue partners-- India, China, Australia, Japan, New Zealand, Republic of Korea, Russia and the United States.

"As we enhance mutual trust and confidence, exercising self-restraint in the conduct of activities and avoiding actions that may further complicate the situation, will go a long way in bringing sustained

peace to the region," Singh said. Singh's comments came amid the seven-month-long military standoff between India and China in eastern Ladakh, and Beijing's increasingly aggressive military behaviour in the South China Sea and Indo-Pacific region. A number of ASEAN member nations have territorial disputes with China in the South China Sea.

The defence minister also said the ability of the grouping to collectively respond to challenges based on the fundamentals of freedom, inclusivity and openness in the region will define its future."Threats to the rules based order, maritime security, cyber related crimes and terrorism, just to name a few, remain the challenges that we need to address as a forum," he said.

The defence ministry, in a state ment, said Singh also emphasised that the Indo-Pacific region confronts numerous traditional and non-traditional security threats.

Sisodia's house attacked by BJP goons, says AAP

The Delhi BJP, however, refuted the allegations, saying their protest was peaceful. Chief Minister Arvind Kejriwal also condemned the incident and wondered why the BJP was "getting so desperate by the day in Delhi" "I strongly condemn the systematic, organised and violent attack on Dy CM Manish Sisodia's home. The goons entered his house in police presence when he was away. Why is BJP getting so desperate by the day in Delhi?" he tweeted.

Addressing a press conference, AAP spokesperson Saurabh Bhardwaj alleged that the police did not stop the goons from entering Sisodia's residence and even removed the barricades around the house.

He also played a purported video of the outside area of Sisodia's residence where a group of people can be seen forcefully entering in-

side. "BJP goons attacked the house of deputy chief minister while he was not at home. The Delhi Police helped the BJP goons in this act," Bhardwaj added.

No immediate reaction was available from the city police. AAP leader Atishi called it a "black day" in Delhi's political history. "This is a black day in Delhi's political history that the Union Home Minister is now using his party goons and Delhi Police to attack the family of Aam Aadmi Party (AAP) leader and Deputy Chief Minister Manish Sisodia in his absence from his residence," she said at the press conference.

Reacting to the charges, Delhi BJP vice president Ashok Goel Devraha claimed AAP leaders were trying to divert attention from the 'conspiracy' to kill BJP mayors and other corporation leaders. "We protested outside Sisodia's residence to make it clear that the BJP workers are capable of answering any form of challenge," he said.

The Delhi BJP had on Wednesday lodged a police complaint against Sisodia and AAP leader Durgesh Pathak, alleging that they were conspiring to kill leaders of the party-ruled municipal corporations. Pathak had rubbished the allegation, saying the BJP has a habit of mixing random audios with random videos to "defame and malign" the image of people.

The shocking development came to light when Nagpur Police arrested one of two persons involved in the crime, top officials said. The prime accused Tapas Ghosh, 49, was nabbed while his wife, who is named in the police complaint, is under investigations, said Police Commissioner Amitesh Kumar said.

He was produced before the court and remanded to police custody till December 16, while further investigations in the matter are underway, said Deputy Commissioner of Police (Zone II) Vinita Sahu.

The DCP declined to reveal further details as the probe is still underway by a Special Investigation Team, under her supervision.

As per a complaint lodged in August with Sitabuldi Police Station by the CJI's mother Mukta Bobde, she is the owner of a hereditary property, Seadon Lawns, near the Akashwani Square which

was hired out for weddings and other functions.

As the manager of the property since over 12 years, Ghosh was paid a salary and commission on the rentals which he used to collect on her behalf.

Owing to the complainant's advanced age and frail health, the accused couple allegedly forged receipts of the income from the property and did not deposit the entire amounts collected.

The goings-on came to light during the pandemic lockdown when many customers cancelled their bookings but failed to get their refunds.

When the fraud came to light around four months ago, the Bobde family approached the police which set up a SIT and the subsequent probe unearthed the scam worth around ₹2.50 crore, sending the police and political

circles in a tizzy. Under DCP Sahu's supervision, the Economic Offences Wing (EOW) is probing the matter from all angles, including the possible involvement of any more persons besides the couple.

New Delhi, Dec 10: India and Nepal have decided to resume flight services under a bilateral air bubble arrangement, authoritative sources said on Thursday in reflection of efforts to restore normalcy in ties that came under severe strain following a bitter border row.

Initially, the service will start with one flight daily from each side between Delhi and Kathmandu, they said. The decision to resume the flight service comes two weeks after Foreign Secretary Harsh Vardhan Shringla visited Kathmandu during which he held extensive talks with the political brass. Nepalese

Foreign Minister Pradeep Gyawali is likely to visit India in the next three weeks.

"India and Nepal have decided to open flights under a bilateral bubble arrangement, as we have done with several countries," said a source. The flights between the two countries were suspended following the outbreak of coronavirus pandemic.

'We had proposed to Nepal some time back and Nepal has cleared it now," said a source. It is not immediately known when the flight service will be started. The sources said Shringla, during his visit to Nepal on November 26 to 27 had highlighted the importance of people-to-people connectivity in sync with the special relationship between the two countries.

"We are starting the service with Indian and Nepalese nationals and holders of Overseas Citizenship of India (OCI) and Persons of Indian Origin (PIO) cards of all nationalities, and all valid Indian visa holders except tourist visa," the source said.

From the Indian side, the flights will be operated by Air India which, in normal times, had a daily flightbetween Delhi and Kathmandu, the sources said.

According to the health department, Zydus had done trials on 20 people in Kanpur last month but the details were not shared. However, the process has been kept transparent for the third phase. Dr. Tripathi said the drug controller had given the approval and the vaccine stock would reach Kanpur soon.

The Indian Council for Medical Research (ICMR) earlier had shortlisted Prakhar Hospital as one of two centres for human trials. Dr. J.S. Kushwaha, the head of Prakhar Hospital, said none of the volunteers who were administered the vaccine had complained of any side-effects so far.

Fifty-seven more people were given Covaxin in the third trial in Kanpur. The volunteers included the doctors and engineers who were examined by an ICMR team, which is staying in Kanpur during this phase.

Only 13 volunteers went for

doses at the Ganesh Shankar Vidyarthi Memorial (GSVM) Medical College, where the trial of Sputnik vaccine was going on. Seven others refused after learning that a Haryana Minister tested positive for Covid-19 even after he was given one dose of a vaccine. Prof. Richa Giri, vice principal of the medical college, said, "There

is no reason for them to be apprehensive. I think their fear stems from the social media posts on this issue. They need to realize vaccine is the only way we can defeat corona and they should be mentally prepared."

US records highest daily nCoV death toll

Washington, Dec 10: The US has set a new grim record of more than 3,000 COVID-19 related deaths in a single day, reflecting a bleak reminder of the pandemic's devastating toll, even as two coronavirus vaccine candidates appear to be on the verge of clearing the country's final regulatory hurdles.

According to The COVID Tracking Project, the US Wednesday reported as many 3,054 reported deaths -- the highest single-day total to date.

The previous single-day record was May 7 at 2,769 deaths, it said. Overall, there were 1.8 million tests reported on Wednesday, 210,000 cases, and a record 106,688 COVID-19 patients in US hospitals, it said. The 7-day average for COVID-19 deaths are at an all-time high as deaths are rising throughout the country, it said.

Trump knocks Supreme Court's door against poll results

Washington, Dec 10: President Donald Trump has approached the US Supreme Court against the results of last month's presidential election, which he alleges were rigged in favour of his Democratic challenger and President-elect Joe Biden

Trump, a Republican, has been making unsubstantiated claims about widespread voter fraud and electoral malpractice in the presidential polls. State election officials have denied any such large-

scale fraud. Trump Wednesday moved to intervene in a Supreme Court case brought by the Texas attorney general Ken Paxton that demands that the 62 total Electoral College votes in Georgia, Michigan, Pennsylvania, and Wisconsin be invalidated.

"We will soon be learning about the word "courage", and saving our country. I received hundreds of thousands of legal votes more, in all of

the Swing States, than did my opponent. ALL Data taken after the vote savs that it was impossible for me to lose, unless FIXED!" Trump said in a tweet, soon after which his campaign announced that he has filed a petition in the Supreme Court. "Trump, in his personal capacity

as a candidate for re-election as President of the United States, moved on Wednesday to intervene in the Texas v Pennsylvania, et. Al. Action at the United States Supreme Court," his campaign said.

A day earlier, the State of Texas filed a lawsuit in the Supreme Court seeking its intervention to overturn the results of the 2020 presidential election in key battleground states that would tip the scales in his favour.

The Trump campaign said that the president intervened because his rights as a candidate are affected by the Defendant States' failure to follow and enforce state election laws during the 2020 election. "I'm honoured that the President asked me



to represent him in this matter. I think his intervention in this case strengthens an already very strong original action by the state of Texas, said John Eastman, Counsel of Record for Trump.

The Trump campaign has yet to produce concrete evidence of corruption or widespread fraud in court. Attorney General William Barr has said his department has yet to see proof that widespread

fraud occurred that would change the outcome. As many as 17 Republican attorney generals joined Trump and the State of Texas in challenging the election results in the Supreme Court. The brief states that the Texas "Bill of Complaint raises constitutional questions of great public importance that warrant this Court's review."

The battleground states flooded their people with unlawful ballot ap-

plications and ballots while ignoring statutory requirements as to how they were received, evaluated and counted, the Republican official alleged

The lawsuit filed by Trump said that the public record demonstrates a ballot-counting process replete with chaos, confusion, and partisan bias.

The Supreme Court has not yet indicated whether it will hear the case. The high court dismissed a case day earlier brought by Pennsylvania Republicans to nullify Biden's victory in the state.

Meanwhile, with West Virginia certifying its presidential election results, all 50 US states and the District of Columbia have now certified the outcome of the November 3 presidential polls, according to a media report Thursday.

President-elect Joe Biden, a Democrat, is projected to win 306 electoral votes, and incumbent President Donald Trump is set to win 232.

Compared to 4.8 MT booked by non-power consumers during April-November last fiscal, the growth is more than a three-and-a-half folds or 262%

bookings at 9.4 MT, clocking 23.7% growth last November, but CIL could also net 30% premium over the notified prices.

This is a big leap from 13% premium the auctions fetched in October when CIL for the first time in the present fiscal introduced add on over the notified price, after a six month hiatus, to gauge the market response.
