■ Train runs over two in Rourkela



State weighs green cess on diesel

AS PER THE DRAFT ELECTRIC VEHICLE POLICY. THE STATE WILL IMPOSE A CESS OF 25 PAISE/LTR OF DIESEL

Bhubaneswar, Dec 18: In order to promote electric vehicles (EVs) in the state, the government is planning to impose pollution cess of 25 paise per litre

The plan has been mentioned in the draft Electric Vehicle Policy 2020, which is now in the discussion stage. The government is set to offer various incentives to EV buyers and manufacturers. It will establish a dedicated fund to facilitate these incentives.

As per the draft policy, the cess will later be imposed on all internal combustion engine (ICE) vehicles.

On similar lines, the government is mulling an additional road tax on diesel and petrol vehicles, especially on luxurious cars. The additional tax will be based on a sliding scale with high price diesel vehicles paying the highest additional road tax and low price two wheelers incurring a small addition.

Further, the government has planned to levy appropriate congestion fee on all trips originating and terminating from different places in Odisha and also from car aggregators. This tax will be waived for e-vehicles. The gap left after funding from the above sources will be met through budgetary allocation.

The transport department will be the nodal agency to implement the pol-

A State-level Task Force headed by chief secretary and Steering Committee led by Transport secretary will be formed for effective implementation of the policy. The draft policy will be finalised soon and notified, sources said. Nearly 82 per cent of all new vehicles registered in the state comprise two wheelers. It is the most popular segment of vehicles which contribute a major part in air pollution. Similarly, three wheelers numbers constitute 3.06 per cent and cars (light motor vehicles) make up 7.04 per cent of total registered vehicles in the state.

Vaccination for Covid-19 will be voluntary: Govt

New Delhi, Dec 18: Getting vaccinated for Covid-19 will be voluntary, the Union health ministry has said while underlining that the vaccine introduced in India will be as effective as any vaccine developed by other countries.

The ministry further stated that it was advisable to receive a complete schedule of the anti-coronavirus vaccine irrespective of past history of infection with Covid-19 as this will help in developing a strong immune response against the disease

It also said that protective level of antibodies generally develop two weeks after receiving the second dose. "Vaccination for Covid-19 is voluntary. However, it is advisable to receive the complete schedule of the vaccine for protecting one-self against this disease and also to limit the spread of this disease to the close contacts including family members, friends, relatives and coworkers," the ministry said in response to a question on if it is mandatory to take the shot.

its work. Odisha Police is committed to fair and diligent investigation. We assure that no stone will be left unturned to ensure justice," it added.

A college student Saroj Sethy of Jadupur village has levelled the serious allegation against Bothra. He was under the SIT scanner in the murder case as the minor girl had visited his residence for berries a day before her abduction in July.

The rescue of the youngster, 40 hours after his abduction, has brought relief to the family members. The boy was identified as Jammi Hardhik, son of Jammi Gopi of Kumuti Sahi locality. He was playing with his friends when he was abducted. Hardhik's uncle, Patanuru Naresh, had gone to Koithapadar village. There, he spotted his nephew inside the under-construction building. He contacted the police who reached the spot and rescued Hardhik.





Only the temple servitors and their family members will be allowed to the temple from December 27 to December 31, informed BMC commissioner Prem Chandra Chaudhary in an order. The temple would remain closed January 1 and 2, 2021. However, the daily rituals would be taking place as usual, the BMC commissioner said. From January 3 to January 5, the temple would remain open only for the residents of Bhubaneswar. Devotees will have to produce Covid-19 negative report obtained during the 'last five days' to enter the temple. From January 6, tourists, devotees from other parts of the state and the country will be allowed inside the temple with strict observance of Covid-19 safety protocol, said Chaudhary.

Woman, daughter Abhay Pathak moves found dead in Cuttack

Cuttack, Dec 18: The bodies of a 35-year-old woman and her sevenmonth-old daughter were recovered from the former's house at State Bank Colony under Bidanasi police limits here, police said Friday.

Police suspect that the woman might have killed her daughter before ending her life.

"We recovered the bodies of Manasmita Ojha, an employee of State Bank of India (SBI), and her seven-month-old daughter. The child's mutilated body was found in a pool of blood, while Ojha's body was found hanging from her room's ceiling," a Bidanashi police official said.

The incident took place in the evening when Ojha's husband, an engineer, was out for some work.

On his return, the man grew suspicious as his desperate knocks at the door went unanswered. "Perturbed. the man raised an alarm following which his neighbours rushed to his help and broke open the door to find the lifeless mother-daughter duo," said one of the neighbours who witnessed the entire episode and informed the police.

Uphold rights of paralytic in jail, NHRC tells Prisons DG

New Delhi, Dec 18: The National Human Rights Commission (NHRC) has asked the Director General of Prisons, Odisha, to take appropriate action in order to prevent the alleged human rights violation of Binod Naik, an undertrial prisoner, who has been allegedly afflicted with paralysis.

Naik was arrested by the Odisha Police in 2016 for his alleged involvement in Maoist related activities. According to reports, he has been lodged in Sambalpur circle jail for four years.

The NHRC has asked the DG, Prisons, to take immediate and appropriate action over the matter. The NHRC order came in a petition filed by Bijayani Mishra, a PhD scholar of Jawaharlal Nehru University here. The petitioner pleaded the commission to issue a notice to the jail authorities to prevent

Manoranjan claimed that his brother had no links with any Maoist outfits. 'However, police arrested him and some innocent and poor youths on false charges as the ultras had their presence in their area for a brief period," he added. Many of them have been acquitted by the court for want of evidence while Naik is still languishing in jail due to delay in hearing of his bail plea, he said.



Long term murram leases will destroy Asia hill range

Chandikhole, Dec 18: Long term leases of murram quarries at different places under Darpan tehsil of Jajpur are feared to cause largescale destruction of jungles in these areas, a report said.

According to the report, the tehsil administration has floated tenders to give away murram quarries on long term basis at Manduka, Asia and Achyutabasant areas. Local residents and environmentalists ap prehended that if quarries were given to lease holders for long periods, the Asia hill rage in the area will see clearing of thousands of trees. Besides, many species of wild ani mals residing in the hill range will do a vanishing act, they observed.

There are 2,600 acres of forest land in the Asia hill range. Lands belonging to the revenue department are near the jungle land. The area was once under the scanner of the Crime Branch as murram mafia used to loot minor minerals at their will. Since then, no part of the hill range had been leased out for murram mining,

However, the tehsil administration has come out with a notification (vide letter 3605, dated November 25, 2020) for leasing the land for murram extraction

Here are details of the land to be leased out. Five acres of land linked to Khata no-737(plot-491) in Asia mouza are of pahad kisam (hill category). Besides, 9.75 acres of land liked to khata-471(plot no-1061) in Achyutabasat mouza is of Parbat kisam land (hill category). The tehsil also plans to lease out 12 acres (khata-1349, plot-3611) belonging to parbat kisam in Manduka

Bolangir admin rescues 21 labourers on way to Andhra

Bolangir, Dec 18: Twenty one migrant labourers who were allegedly being trafficked from Bolangir district to Andhra Pradesh were rescued from the Kantabanji railway station in the wee hours of Friday. They were waiting for a train when police rescued them. Among the labourers, four were women.

The efforts of Bolangir police and Kantabanji block administration paid off and the labourers were saved in the nick of time. Acting on a tip-off, the team reached the railway station to rescue the workers. The agent who was taking them to an unknown destination in Andhra Pradesh has been detained by the police. A majority of the villagers belonged to Siluana village of Kantabanji block.

The labourers said they were in need of jobs and hence they were travelling to the neighbouring state. "The state government had promised us jobs when we returned home due to the pandemic. Since that did not happen we are being forced to look for work elsewhere to sustain ourselves." some of the workers said. "With no source of income here, we are struggling to make both ends meet. So we are forced to move to other states in search of work," said a migrant worker. November 14, 56 migrant labourers were rescued from Kantabanji station.

In the notification, it was stated that 14807 cusec/metre of murram will be extracted annually in Asia area while the volume of murram extraction in Acgyutabasant area is 30227 cusec/metre. In Mandua mouza, the lease holder will have to extract 33721 cusec/metre annually. The revenue department will get Rs 35 as royalty per a cusec/metre of murram extraction while additional charges amount to Rs 45.

Locals say Asia-Charinagal reserve forest is home to wild ani-

mals life hyena, sambar, barking deer, spotted deer, boars and other reptiles. Due to illegal murram mining, their population has been fast declining in the area, it was

On one hand, the forest department has spent crores of rupees for regeneration of forests while on the other, the revenue department leases out the land for murram extraction. Whenever these areas had been leased out earlier, lease holders had allegedly resorted to excessive murram mining, thus causing loss of revenue as well as forests. Locals had reportedly protested against it in the past.

Nabarangpur, Dec 18: Land hurthe long awaited Jeyore-Nabarangpur railway line under East Coast Railway. Now, the administration has laid stress on expeditious land acquisitions, a report said.

According to reports, a review meeting on the project was held at the Mission Shakti conference hall here recently under the chairmanship of Nabarangpur MP Ramesh Chandra Majhi.

The state government is committed to providing free land to the project. But the land required for the project has not been acquired till date.

At the meeting, Collector Ajit Kumar Mishra assured that staff would be engaged for land acquisition, which will be carried out within 45 days. Public hearings will be held over the project and the land acquisition, he added.

As per information, the Jeyore Nabarangpur railway line will be laid for 45. 35 km while a stretch of 11 km will be constructed through Nabarangpur. It was learnt that 149.927 acres of private land and 5.418 acres of government land will be acquired in Nabarangpur sadar area, Daibhatta, Gadabaguda and Padalguda.

A map for the land acquisition has been drawn up. The railway project entails construction of nine big bridges, 51 small bridges and two stations. Jeypore sub-collector representing the Koraput district administration presented detailed data about the size of land to be acquired in Koraput

The battle for the West Bengal assembly elections looms ahead but skirmishes have already started. After the attack on BJP president JP Nadda's convoy in the state, the Centre retaliated against the TMC government by recalling three IPS officers from the state on Central deputation. Further, to perhaps underline the "message", the Ministry of Home Affairs summoned state Chief Secretary Alapan Bandopadhyay and Director General of Police Virendra to Delhi to explain the law and order situation in Bengal.

A defiant Chief Minister Mamata Banerjee refused to comply with the summons. Also, she declined the Centre's demand to send the three IPS officers – Bholanath Pandey, Rajeev Mishra and Praveen Kumar Tripathi – on deputation saying there was a dearth of good officers in the state, and the state could not spare the three officers.

There is a precedent here. The then Chief Minister of Tamil Nadu J Jayalalitha had similarly denied the Centre in 1991 when the state police had

conducted a raid on the house of former state Chief Minister and DMK leader M Karunanidhi, her arch rival. The Centre had asked the Tamil Nadu government to relieve the three officers involved for Central deputation. Like Mamata now, she had refused to spare those officers.



Apparently, there is little the Centre can do against civil service officers who are posted under the state government. For any action to be taken on an officer, the state and the Centre both need to agree.

REBELS FOR A CAUSE?

Outliers are far and few in between in the civil service, which runs on obedience than resistance. But sometimes momentous events reveal "rebels' with a cause. Punjab DIG (Prisons) Lakhminder Singh Jakhar has resigned from service in support of farmers who are in Delhi protesting against the three new farm laws. There are politicians, sports people, even ex-Defence forces officers who have renounced their awards and medals in protest, but an IPS officer resigning from service for the farmers' cause is a first in the

Of course, IAS officer Kannan Gopinathan resigned from the service to protest against the restrictions imposed in Jammu & Kashmir following the abrogation of Article 370. Similarly, Shah Faesal, the young IAS officer from J&K resigned from the service in 2019 to start a political party. And just a few months ago, the DGP of Bihar Gupteshwar Pandey opting for VRS in a bid to contest the state Assembly poll (his position his still vacant), but that was not for a public cause.

Meanwhile, Jakhar who had served the army joined the IPS as a 1994-batch officer and was slated to superannuate in August 2022. Interestingly, he had been suspended in May earlier this year on alleged corruption charges but was reinstated within a month. Clearly, outliers defy easy definition!

TN RELUCTANT TO LET GO OF CHIEF SECRETARY

By seeking the extension of the tenure of Tamil Nadu Chief Secretary K Shanmugam, the state government has stirred a hornets' nest in the upper echelons of the administration. An extension of tenure for Shanmugam could mean that several senior Tamil Nadu cadre officers eligible to succeed him

According to sources, Shanmugam, a 1985-batch IAS officer, has already received two extensions. Meanwhile, there 30 IAS officers in the state in the Additional Chief Secretary rank, including four who are Secretaries to the Central government. For them, the third extension for Shanmugam seems to indicate that the state government doubts their abilities to handle the

Interestingly, when Chief Minister Edappadi K Palaniswami first sought an extension of tenure for Shanmugam, it was for one year, but the Centre granted approval only for three months. The second extension was for another three months. Now the state government has requested a six-month extension for the babu who reportedly is playing a "critical role in Covid management in the state". Will the Centre oblige again?

THE BRUSSELS EFFECT

THE NEW REGULATIONS WILL **COMPLEMENT** THE EU'S **ANTITRUST AUTHORITY, WHICH HAS** REPEATEDLY **BEEN USED TO EXTRACT BILLIONS OF DOLLARS IN FINES FROM US TECH GIANTS**

The European Commission has just unveiled landmark regulations for the digital economy, setting vet another global standard. The Digital Services Act (DSA) and the Digital Markets Act (DMA), designed to curtail the power of Big Tech, will have a far-reaching impact on the business practices of Apple, Amazon, Facebook, Google, and other primarily US-based giants. The European Union is expected to designate these companies as the "gatekeepers" of the Internet, justifying a targeted regulatory push to rein in their outsize market power.

The new regulations will complement the EU's antitrust authority, which has repeatedly been used to extract billions of dollars in fines from US tech giants and to mandate changes to their business practices. Under the DMA, for example, practices such as selfpreferencing will be "blacklisted" - presumed illegal without the need for the EU to bring an antitrust challenge to demonstrate harm to competition.

The DSA, for its part, will impose more onerous obligations on Big Tech companies to disclose their algorithms or remove illegal or harmful online content, including hate speech and disinformation. Together, these measures will assert significant new regulatory control over the digital economy both in Europe and beyond.

The stakes for the Big Tech giants are particularly high because EU regulations often have a global impact - a phenomenon known as the "Brussels effect." Because the EU is one of the world's largest consumer markets, most multinational corporations accept its terms of business as the price of admission. To avoid the cost of complying with multiple regulatory regimes around the world. these companies often extend EU rules to their operations globally. That is why so many large non-EU companies follow the EU's General Data Protection Regulation (GDPR) across all of their operations.

Unsurprisingly, Big Tech leaders and other critics of EU regu-

lation are pushing back, accusing the EU of regulatory overreach and protectionist motives. But the EU is not unfairly infringing on successful US tech companies' commercial freedom, nor is it undermining US regulators' autonomy. Even if EU regulations do prove costly for big US companies, many smaller US firms will benefit from them. For years, these smaller US players have had to rely on the EU – rather than on their own government - to challenge the giants in their industry.

Likewise, thanks to their global reach, EU regulations have brought significant benefits to American Internet users, many of whom welcome enhanced privacy protections and less rampant online hate speech.

The United States' own inaction has paved the way for the EU's rise as a regulatory superpower. Embracing deregulation and techno-libertarianism as its approach to governing the digital economy, the US has long watched from the sidelines as the EU sets regulations for the global marketplace. By abandoning international engagement and regulatory cooperation, the Trump administration reinforced this regulatory isolationism – effectively, albeit inadvertently, trading globalisation for Europeanisation.

But the winds in the US may finally be changing. Legislators and enforcement agencies are starting to wake up to Big Tech's excesses. Earlier this year, the House Judiciary Committee's report on competition in digital markets issued a powerful call to action and outlined a new vision for revitalizing US antitrust laws.

Moreover, the US Department

of Justice is now challenging Google's monopolistic practices (after tolerating them for the past decade), and the Federal Trade Commission – along with 46 of the 50 states, Washington, DC, and Guam - is suing Facebook as an illegal monopoly. It is unclear whether these steps mark the beginning of a progressive antitrust revolution in the US, or whether they will stall in a divided Congress or before conservativeleaning courts that are accustomed to a more limited role for antitrust law.

In any case, the US would do well to abandon its hands-off approach to technology companies. It needs to stop being a rule-taker and start shoring up its own regulations. A federal privacy law would be an ideal place to start, con-

sidering that the idea already has support from leading US companies such as Microsoft, Facebook, and Apple.

A more robust privacy law would help the US reinstate data flows with the EU, which were halted by the European Court of Justice, owing to the lack of privacy protections in the US. It would also allow the US to address its concerns about Chinese government surveillance of American citizens. The Trump administration's haphazard effort to ban the Chinese-owned socialmedia platform TikTok from the US market is not a substitute for regulations to protect Americans personal data.

The case for renewed US regulatory leadership is even more compelling in view of China's increasing global influence over tech-governance standards Chinese companies, all with varying ties to the ruling Communist Party, have supplied critical technological infrastructure to countries around the world. China has also supplied artificial intelligencedriven surveillance technology to numerous governments that are eager to pursue illiberal ends.

Given China's authoritarian vision of the Internet, the US would gain much from working closely with the EU on regulating Big Tech and the digital economy. Their disagreements when it comes to antitrust, privacy, and taxation. are manageable, and should be addressed as part of a broader effort

to reset transatlantic relations. Instead of fighting the EU's legitimate attempts to defend its vision of the digital economy, President-elect Joe Biden's administration should explore how it can work with the EU to advance a shared vision. After all, citizens on both sides of the Atlantic want a human-centric Internet that is grounded in the values of liberal democracy and individual autonomy.

Agricultural markets in Odisha

THE RAGING **CONTROVERSY OVER THE NEW FARM LAWS AND** THE COUNTRY-**WIDE PROTESTS OF FARMERS HAVE ONCE AGAIN BROUGHT TO FOCUS THE CRUCIAL ROLE PLAYED BY AGRICULTURAL MARKETS** of farmers have once again brought to focus the crucial role played by agricultural markets in economic development. States like Punjab, Haryana and Maharashtra have well developed marketing systems which have contributed to their prosperity. Other states have lagged and continued with the traditional systems. Reforms have taken a back seat

Agriculture market reform in India has historically been a vexatious issue. The Royal Commission on Agriculture in 1928 noted the need to regulate agricultural markets. The Madras Commercial Crops Act 1933 (which was then applicable to areas of present day Odisha) laid down certain restrictions. The Constitution of India (1950) prescribed that "Agriculture", "markets and fairs" and "trade and commerce within the state" are all State subjects (Entry 14, 26, 28. List II, Seventh Schedule). Agricultural markets have therefore been the responsibility of the states. In fact, Odisha was one of the first states to notify Orissa Agricultural Produce Markets Act 1956. Its main objective was to assure the agricultural producer "of his legitimate share of the price paid

Similar laws grettably, the stated objectives of the legislations remain unfulfilled. Sporadic attempts have been made to introduce the much-needed reforms in the agriculture sector. The Central government circulated a new Act in 2003. Model APMC Rules were also framed in 2007 and states were asked to adopt them. Reportedly 11 states adopted them fully and seven states partially. But there has been no significant improvement at ground level and in most cases, it remains business as usual.

Odisha has 66 Regulated Market Committees (RMCs) with 180 subyards. A number of markets remain under the control of local bodies. The state has 76 municipal markets and approximately 2000 gram panchayat markets (out of which about 250 are managed by RMCs). The Government of Odisha also tried some piecemeal reforms. In an attempt at disintermediation, it set up 43 Krushak Bazaars where farmers can sell their produce directly to buyers. It has also set up 14 Special Commodity Markets. Yet, the markets have poor infrastructure and most of the transactions take place outside the market yards. Bulk of the market fee is

project in 2016 to study and frame a new law for agricultural marketing in Odisha. Our company, Global AgriSystem, was appointed as the consultant. We conducted extensive survey of the existing markets in the state, held in-depth discussions with the State Marketing Board and other stakeholders and proposed a new law. This was discussed and approved

at a high-level meeting of the state government in the presence of the concerned minister and secretary. The proposed act was designed to pave the way for new age marketing concepts such as e-markets, commodity exchanges, facilitation of buying by bulk buyers (retail chains, processors, exporters, warehousing, and trading companies). It was proposed that the entire state shall be considered as one market and checkgates will be abolished. Producers will be allowed to sell anywhere in the state. It was suggested to have a single point registration for all traders and wholesale buyers and issue unified registration number (URN), which will permit them to buy anywhere in the state. Market fee would be abolished and only service charges will be

The International Finance cilities. The Act was designed to way to augment government resources in setting up of agricultural infrastructure and reduce postharvest losses. Private markets would be licensed by the state government provided they had or agreed to build the necessary infrastructure like warehouses or electronic trading platform.

If the state government had adopted these proposals in 2016, Odisha would have been the first state in the country to adopt a progressive modern agricultural marketing act and it would have saved the farmers from suffering the pain points of the new Central farm laws. In view of the persistent doubts about the constitutional validity of the Central laws on agriculture, which is a State subject, many states including Punjab, Rajasthan and Chhattisgarh have passed new laws on the subject in their state Assemblies. Odisha should consider what is in its best interest. (Concluded)

6 UP farmers get ₹50L PM'S VARANAS OFFICE LISTED notice over protests

FARMERS HAVE BEEN ORGANISING PROTESTS IN THE DISTRICT OVER THE THREE CONTENTIOUS FARM LEGISLATIONS

Sambhal (Uttar Pradesh), Dec 18: Six farmer leaders in Sambhal district have been issued notices, asking them to furnish personal bonds of ₹50 lakh in view of the apprehension that their actions may lead to breach of peace.

The six farmers, who were served notices, include Bharatiya Kisan Union (asli) district president Rajpal Singh Yadav and farmer leaders Jaiveer Singh, Brahmachari Yadav, Satyendra, Rohdas and Veer Singh.

However, two days after the notices were served, Circle Officer Arun Kumar Singh, said that the amount was a 'clerical error' and will be reduced.

"The SDM is currently on leave and once he comes back we will correct the error and make it a bond of ₹50,000 since the earlier one was a clerical error," he said

The notice issued by Sambhal SDM Deependra Yaday stated. "In the context of what is happening in Delhi and other farmer agitations, six persons are going from village to village and inciting the



farmers with false information, which can lead to the breakdown of peace in the region.

"We are satisfied with the report of the local police station in this regard. It is hereby directed to furnish a reason as to why the farmers should not be providing a guarantee of worth ₹50 lakh and a bail amount of the same money to maintain peace for one year." Farmers have been organising protests in the district over the three contentious farm legislations.

We have got a report from the

persons are inciting farmers and there can be breach of peace, and they should be asked to fill personal bonds," the Sub-Divisional Magistrate Deependra Yadav had

earlier told the reporters. The notices have been issued under Section 111 (magistrate order against any person who is likely to commit breach of peace) of the Code of Criminal Procedure on the basis of a report submitted by police, the official said.

Samajwadi Party (SP) supremo Akhilesh Yadav Friday attacked the Uttar Pradesh government for sending notices to farmers asking them to submit personal bonds assuring there will be no breach of peace during protests against farm laws in Sambhal. "Even though the Supreme Court has given legal acknowledgement to peaceful protests by farmers, the BJP government in UP is lodging FIRs to realise ₹50 lakh from them. There has never been an anti-people government like the BJP." the SP leader said in tweet in Hindi with the hashtag "#Nahi_Chahiye_Bhajapa


PM'S VARANASI ON OLX FOR 'SALE'

Bhelupur police station limits, Varanasi Senior Superintendent of Police (SSP) Amit Pathak said. "Yesterday, it came to our notice that the prime minister's office here has been put up on sale on OLX website. An FIR was immediately lodged at the Bhelupur police station, and the matter is being investigated," Pathak said. "Four people involved in the case have been taken in custody," the SSP said, adding that the person who took the picture and put it on the website is among them. The accused are being questioned, and further legal proceedings are being carried out, he said.

Delhi Assembly passes resolution for CBI probe

New Delhi, Dec 18: The Delhi Assembly passed a resolution by voice vote on Friday, demanding a CBI inquiry into the alleged ₹2,500 crore scam in the BJP-ruled municipal cor-

AAP MLA Saurabh Bhardwaj initiated a discussion on the issue following which the resolution was passed. "Scams come up regularly in BJP-ruled corporations. The new councilors have broken the record of their predecessors in corruption," he

"The MCD is like a daughter of Delhi which was given to the BJP that has acted as a mother-in-law. The BJP is acting the same by demanding ₹13,000 crore from the AAP. In the 2017 municipal polls, the BJP changed all its sitting councilors because people were unhappy with



The AAP MLA alleged that the scam runs into thousands of crores of rupees. "The building department of corporations is known for corruption and demanding bribes. A BJP councillor was caught red-handed by the CBI for taking ₹10 lakh for construc-

tion of a building," he added. However, Leader of Opposition in the assembly Ramvir Singh Bidhuri termed the allegations of misappro-

priation of funds worth ₹2,500 crore "baseless". BJP MLA OP Sharma boycotted the House when he was not allowed to speak in the debate.

Party legislators displayed placards at their seats, demanding the release of financial dues of ₹13000 crore to the civic bodies. Earlier in the day. AAP MLAs trooped into the well of the House raising slogans against the BJP-ruled MCDs as soon as the session

Speaker Ram Niwas Goel had adjourned the house for 15 minutes as the party MLAs continued to wave placards and raise slogans despite his attempt to bring order and continue the proceedings. Delhi Chief Minister Arvind Keiriwal on Friday said the alleged scam of ₹2.500 crore in the BJPruled municipal corporations was even bigger than the Commonwealth

Addressing a special session of the Delhi Assembly, he claimed that scams of ₹5,000-10,000 crore happen every year in municipal corporations while giving required permissions for buildings. "It's a very painful day as we are discussing the biggest scam in MCD. ₹2,500 crore scam is bigger than the Commonwealth Games scam. Even people on the street say there is corruption in MCD and the same people say the Delhi government is honest," he said.

Icy winds, cloudy Saturday, fog ahead



New Delhi, Dec 18: The MET Friday sounded an orange alert for the national capital for two days till Sunday after icy winds blowing from the snow-clad Himalayas brought down the city's mercury to nearly 3 degrees Celsius. It will be a cloudy Saturday with fog causing trouble for traffic till Monday.

The IMD has four colourcoded warnings as per the intensity of any weather system -- green, yellow, orange and red. Orange alert is given to authorities to be prepared.

Safdarjung The Observatory, which provides representative data, recorded a minimum temperature of 4.4 degrees Celsius, while Ayanagar and Lodhi Road weather stations registered 3.5 and 3.8 degrees Celsius. The city is likely to record another "severe" cold day Friday.

"Cold day to severe cold day at a few places and cold wave to severe cold wave conditions at many places. Ground frost at isolated places," stated IMD in its bul-

letin. The city will witness partly cloudy sky Saturday and shallow fog for the three subsequent days

According to the head of the India Meteorological Department's regional forecasting centre, Kuldeep Srivastava, the icy winds are blowing towards the national capital region from Jammu and Kashmir and Himachal, which had witnessed heavy snowfall on December 12.

Besides this, the whole northern plains is in the grip of a severe cold wave. Navdeep Dahiya, founder of Live Weather of India stated that Halwara in Punjab recorded the lowest temperature at minus 0.6 degree Celsius, followed by Churu in Rajasthan recoding minus 0.3 degree Celsius and Amritsar at 0.4 degree Celsius

According to the weather department, there will be no significant change in minimum and maximum temperatures over parts of northwest India for the next two to three days till Monday and rise by 2-3 degree Celsius in minimum temperatures and

4-5 degree Celsius in maximum temperatures during subsequent three days till December 24.

"Cold day to severe dold day conditions very likely in some pockets over Punjab, Haryana, Chandigarh, Delhi and West Uttar Pradesh. "Cold day conditions in isolated pockets over Jammu division, Himachal Pradesh, Uttarakhand, east Uttar Pradesh, Rajasthan and west Madhya Pradesh during next 24 hours (till Saturday) and decrease thereafter," IMD

The IMD also issued alert for the ground frost over Delhi, Jammu and Kashmir, Ladakh, Gilgit-Baltistan, Muzaffarabad, Himachal Pradesh, Uttarakhand, Punjab, Haryana, Chandigarh, west Uttar Pradesh and Rajasthan during the next two days till Sunday. Ground frost refers to the various coverings of ice produced by the direct deposition of water vapour on objects and trees, whose surfaces have a tempera-

ture below the freezing point

of water.

Chetan Sood is busy giving a final touch to a tattoo on the arm of a Sikh youth, who has come from Hoshiarpur, Puniab, to the Singhu border to protest against the Centre's three contentious farm laws.

Sood and his five assistants wanted to contribute whichever way possible. Therefore, the group decided to do what they know best. The six men reached the Delhi-Haryana border on Friday morning carrying ink, tattoo

Music teacher arrested

New Delhi: A music teacher has been arrested for allegedly harassing and molesting his 23-year-old student, police said Friday. The arrest was made after the victim, who was doing her Diploma Honour in Kathak at a centre in Chanakyapuri, accused the 52-year-old teacher of harassing her, they said. According to the complainant, the accused -- a 'pakhawaj (rhythm instrument) teacher at the centre -- molested the victim of touching her inappropriately and also harassed her by sending obscene messages on WhatsApp. The matter came to light on December 14 when the girl along with her mother approached officials of the Chanakyapuri police station to register a complaint him, police said.

Woman buried alive in Jharkhand

Dhanbad: A 35-year-old woman was buried alive after being sucked into a crater following land subsidence in a colliery area of the Bharat Coking Coal Limited in Jharkhand on Friday, police said. Sindri Deputy Superintendent of Police Ajit Kumar said that the charred body of the woman was brought out from the fire hole, under Bastakola Industry Colliery, after a fivehour rescue operation. Underground fires have been hurning under the country's largest coalfield for over a century. The incident occurred at 7.30 am after the woman, a mother of three children, was defecating in the open, police said.

Shops gutted

Jalpaiguri (WB): A major fire broke out at a market in West Bengal's Jalpaiguri district in the early hours of Friday, gutting at least 150 shops, officials said. The flames were spotted around 3 am at the Dhupguri market by a shopkeeper, they said. India, China resume talks

The talks were held under the framework of Working Mechanism for Consultation and Coordination (WMCC) on India-China border affairs

New Delhi, Dec 18: Resuming diplomatic talks on their military standoff, India and China Friday agreed to continue working towards ensuring complete disengagement of troops in all friction points along the Line of Actual Control (LAC) in eastern Ladakh at the earliest.

At the virtual talks, the two sides agreed that the next round of military dialogue should be held at an early date so that they can work towards an early and complete disengagement of troops in accordance with the existing bilateral agreements and protocols, the Ministry of External Affairs (MEA) said.

The talks were held under the framework of Working Mechanism for Consultation and Coordination (WMCC) on India-China border affairs. The MEA said the two sides reviewed the developments along the LAC since the last round of the WMCC talks held on September 30. The military standoff erupted in early May

'The two sides agreed that based on the guidance provided by senior leaders and the agreements reached between the two Foreign Ministers and Special Representatives, they would continue to work towards ensuring complete disengagement in all friction points along the LAC in the Western sector at the earliest," it said in a statement.

"The two sides noted that the seventh and eighth rounds of senior commanders meetings held on October 12 and November 6 respectively had in-depth discussions



in this regard and that these discussions had also contributed to ensuring stability on the ground,' the MEA said.

It said both sides agreed to maintain close consultations at the diplomatic and military level."They agreed that the next round of senior commanders meeting should be held at an early date so that both sides can work towards early and complete disengagement of troops along the LAC in accordance with the existing bilateral agreements and protocols, and fully restore peace and tranquility," it said.

The talks came a day after India hoped that further discussions between the two countries will help to achieve an agreement on a mutually acceptable solution for ensuring complete disengagement in all friction points along the LAC in eastern Ladakh.

India and China have held several rounds of diplomatic and military talks in the last few months to resolve the standoff. Nearly 50,000 Indian Army troops are deployed in a high state of combat readiness in various mountainous locations in eastern Ladakh in subzero conditions as multiple rounds of talks between the two sides have not yielded concrete outcome to resolve the standoff. China has also deployed an equal number of troops. according to officials.

MEA spokesperson Anurag Srivastava on Thursday said the two sides continue to maintain communication through diplomatic and military channels and these discussions have helped both sides to enhance understanding of each other's positions.

"It is our expectation that the further discussions will help both sides to achieve an agreement on a mutually acceptable solution for ensuring complete disengagement in all friction points along the LAC in the Western sector and full restoration of peace and tranquility as early as possible," he said. The eighth and last round of military talks had taken place on November 6 during which both sides broadly discussed disengagement of troops from specific friction points.

SC issues notice to Kamra, Taneja

New Delhi, Dec 18: The Supreme Court Friday issued notice in the criminal contempt of court cases against stand-up comedian Kunal Kamra and cartoonist Rachita Taneja for posting scandalous tweets and cartoons against the top court.

Earlier, Attorney General K.K. Venugopal had given his consent for filing contempt pleas against Kamra and Taneja. A bench headed by Justice Ashok Bhushan and comprising Justices R. Subhash Reddy and M.R. Shah said the AG in his letter dated November 12, 2020 had granted consent on the request of the applicant to proceed by way of initiating contempt proceedings against Kunal Kamra.

"Issue notice returnable within six weeks. The respondent-contemnor not to appear in person, said the top court, which issued a similar direction in Taneja's case. However, the top court dispensed them from personal appearance.

The plea against Kamra was filed by law students Shrirang Katneshwarkar and Nitika Duhan, and advocates Amey Abhay Sirsikar, Abhishek Sharan Raskar and Sattyendra Vinayak Muley. "The alleged contemnor (Kamra) has the following of 1.7 million people. The scandalous tweets of the alleged contemnor were seen by his followers and many of them retweeted the same," read the plea.

Citing Section 2 (c) (i) of Contempt of Courts Act, 1971, the petitioners argued that this section is explicit and the tweets published by Kamra clearly showed he allegedly committed gross contempt of the apex court. Granting consent, the AG had said that today people believe that they can boldly

and brazenly condemn the Supreme Court of India and its judges by exercising what they believe is their freedom of speech.

"But under the Constitution, the freedom of speech is subject to the law of contempt and I believe that it is time that people understand that attacking the Supreme Court of India unjustifiedly and brazenly will attract punishment under the Contempt of Courts Act, 1972." the top court cited AG's response.

In case of Taneja, the AG had said that he is satisfied that each one of the tweets with the cartoons attached to them is in contempt of the Supreme Court. "Hence I give my consent to initiate proceedings under the Contempt of Courts Act, 1971 with regard to each one of the tweets," the AG had said.

Dissident MLA Tiwari makes U-turn

Kolkata, Dec 18: Within 24-hours of his resignation, dissident Trinamool Congress lawmaker Jitendra Tiwari made a U-turn Friday night saying that he is not going anywhere from the party.

Tiwari held a closed-door meeting with senior Trinamool leader Arup Biswas and political strategist Prashant Kishor at south Kolkata's Suruchi Sangha club. "It was my mistake. There were some misunderstandings. Whatever I said it was absolutely wrong on my part. I am told that Didi was hurt at my gesture. I cannot do anything that hurts Didi," Tiwari told media after the meeting.

Tiwari resigned from the post of chairman of the administrative board of the Asansol Municipal Corporation on Thursday. He represented Pandabeswar in the state Legislative Assembly.

"Jitendra Tiwari was, is and will be with the Trinamool Congress. He will fight against the BJP as a loyal soldier of Mamata Banerjee," said Arup Biswas, adding that such small things may happen in a big family.

Tiwari had resigned from the post of Trinamool Congress' district president in West Burdwan. He sent his resignation to Trinamool Congress state president Subrata Bakshi.

"Given the current situation, it is difficult to work and I am stepping down from the post of chairman of the administrative board of Asansol Municipal Corporation. We have been deprived of the smart city. We have also been deprived of the solid waste management system," he wrote in his resignation letter. Tiwari had alleged that Asansol has been deprived of many development works. "I will personally meet Mamata didi and seek her apology. I will continue to work for the Trinamool Congress," he added.

COVID has spread like wild fire: SC

New Delhi, Dec 18: It is a "world war" against COVID-19 and the unprecedented pandemic has spread like a "wild fire" due to lack of implementation of guidelines and standard operating procedure (SoPs) issued by authorities to contain it, the Supreme Court said on Friday while expressing concern that the treatment for coronavirus was not affordable to the common people.

The apex court, which suggested either more and more provisions are to be made by the state governments and the local administrations or there shall be cap on the fees charged by the private hospitals. observed that states must act vigilantly and work harmoniously with the Centre as safety and health of citizens must be the first priority rather than any other considerations.

It said "strict and stern action" should be taken against those who are violating guidelines and SoPs as they cannot be permitted to play with the lives of others. A bench headed by Justice Ashok Bhushan

while noting that right to health is a fundamental right and it includes affordable treatment, said treatment has become costlier and is not affordable to common people at all. 'Even if one

COVID-19, many times financially and economically he is finished. Therefore, either more and more provisions are to be made by the state government and the local administration or there shall be cap on the fees charged by the private hospitals, which can be in exercise of the powers under the Disaster Management Act," said the bench, also comprising Justices R S Reddy and MR Shah, which was dealing the matter suo motu.


Banerjee noted that Adhikari did not hand over the resignation letter to him personally, and maintained that he wasn't aware if his move was "voluntary and gen-

Guj man beats COVID after 113 days in hosp

Ahmedabad, Dec 18: A 59-yearold man was Friday discharged after a stay of 113 days in a city hospital for COVID-19 treatment with Gujarat deputy chief minister Nitin Patel claiming this is to be possibly the longest spell of hospitalisation for a coronavirus patient in India.

Ravindra Parmar tested positive for coronavirus on August 26 and was admitted in a private hospital in the Dholka area of Ahmedabad. However, he had to be shifted to the state-run Sola civil hospital on August 28 after his condition deteriorated.

"Ravindra Parmar's is a rare case of recovery as he was brought to Sola civil hospital in critical condition. Out of the 113 days here, he was in ICU for 90 days."At one point of time, he had to be given 75 litres of oxygen per minute for survival," Patel, who was present when Parmar was discharged, said. "This is the longest hospital stay for any COVID-19 patient in Gujarat, and, perhaps, even in the country. Doctors have given him the finest treatment," said Patel.

Covid vaccination: Can India deliver that shot to all?

New Delhi, Dec 18: As the wealthy nations like the US and the UK begin vaccinating their public, the road ahead for India does not look very rosy as both Pfizer-BioNTech and Moderna vaccines currently making headlines are yet to reach the country owing to a host of factors including scarce supply, tricky transport and an absence of proper

cold chain. For over 130 crore Indians, two promising vaccines -- Astrazeneca and Oxford university developed and Serum Institute of India (SII)manufactured Covishield, and Covaxin by Bharat Biotech Ltd-are

still a distant dream owing to factors not in the control of the manufacturers or the government.

Sanjay Rai, who is the principal investigator (PI) of Covaxin trial, said Friday that the rollout of Covaxin may get delayed as the All India Institute of Medical Sciences (AIIMS), where its Phase-III human clinical trial is underway, is strug-

gling to find takers of the trial shots. However, Dr Harshal R Salve, Associate Professor at Centre for Community Medicine at AIIMS told IANS on Friday that hopefully, we will see approval for an appropriate vaccine in a month or so by a competent regulatory authority.

"In Phase 1, India is planning to

vaccinate 30 crore people - healthcare workers, frontline workers such as military professionals, police force, disaster management workers and people with existing diseases aged more than 60 years, Salve said

India has the world's largest immunization programme in the world with beneficiary of more than 60 million annually. According to Salve, India has also demonstrated outreach and decentralised delivery of public services during general

"These experiences will help India roll out the Covid-19 vaccination at the mass level. The use of IT is crucial in tracking and implementa-



tion of individual-level vaccination. However, administration of vaccine should be kept as a voluntary exercise and should not be made mandatory," Salve stressed

However, due to scarce data on the Covid-19 vaccination and its masslevel efficacy globally, nothing can be predicted at this crucial moment. An analysis by Duke University's 'Launch and Scale Speedometer', which is updated every two weeks, shows India has made deals for 1.6 billion doses of three global vaccine candidates upon them being ready and certified for use.

Globally, 10.1 billion doses were reserved even before any candidate was approved for market, showed the data. "Countries with manufacturing capacity, such as India and Brazil, have been successful in negotiating large advance market commitments with leading vaccine candidates as part of the manufacturing agreements," according to Duke University's 'Launch and Scale Speedometer'.

Dr Neha Gupta who is infectious diseases specialist at Medanta Hospital in Gurugram said that the potency of vaccines depends upon the temperature at the storage level. "Cold chain needs to be properly maintained. The government needs to keep a designated staff for the mass vaccination of healthcare workers, elderly population and patients with common comorbidities like hypertension, COPD (chronic obstructive pulmonary disease),diabetes and cardio-cerebrovascular disease," she said.

PM defends farm laws, blasts Oppn

Bhopal, Dec 18: Prime Minister Narendra Modi Friday stoutly defended the new farm laws, saying they were in the works for decades and those who are opposing these laws now for gaining lost political ground were once votaries of the same reforms.

The opposition parties were against the new laws as they were upset that he would get the credit, Modi said, adding that he did not seek any credit but nobody should mislead farmers. Accusations such as the new laws will lead to the scrapping of Minimum Support Price (MSP) for crops were blatant lies, the prime minister said, addressing farmers of Madhya Pradesh through virtual mode.

The government was willing to hold talks with farmers, the prime minister said, as the agitation against the new farm laws at Delhi's borders entered its 23rd day. "Even after all these government's efforts if anyone has any doubt over the farm laws, we, with folded hands and heads bowed, are ready for talks." he said.

The new agriculture laws have not been drafted overnight but political parties, agriculture experts and progressive farmers have demanded it for a long time,' Modi said. Farming in India should get modernized in the changed global situation, he added, defending the contentious laws.

'In the last 20-22 years, the Centre and the state governments have deliberated on these agriculture reforms in detail. Farmer bodies, agriculture scientists and farmers too were continuously demanding them," he said.

"Farmers should ask the parties which are opposing the new laws why they advocated and promised similar measures in their election manifestos but never im-



plemented them," Modi said. They dithered because "it was

not their priority", the prime minister alleged." I feel that they are in pain because what they could not do, Modi has done. They do not want Modi to get credit for it. Give credit to your manifesto and not to me. I just want the progress of farmers, but stop misleading them on the issue," he said.

"We are asking them again and again to point out problems in the new farm laws, but they don't have any answer. Those who have lost their political space in the country are misleading farmers that they will lose their lands," he said.

'When these parties were in power, they sat on the Swaminathan committee's report on the farm sector as they did not want to give farmers higher MSP (which the report had recommended), Modi said,' targeting the Congress.

"In the changed global scenario, this should not be accepted. The things (reform) which should have taken place 25 to 30 years ago have been done now. We have already been late," he added.

He also accused the Congress of not fulfilling its promise of loan waiver for farmers in Rajasthan and Madhya Pradesh.

SC GRANTS RELIEF TO BJP LEADERS PRESS TRUST OF INDIA

New Delhi, Dec 18: The Supreme Court Friday granted interim protection to five BJP leaders, including Mukul Roy and MPs Kailash Vijayvargiya and Arjun Singh, in criminal cases lodged against them in West Bengal and directed the state police not to take any coer-

A bench headed by Justice Sanjay Kishan Kaul sought response from the West Bengal government on five separate pleas filed by BJP leaders alleging foisting of criminal cases to deter them from political activities and said interim protection from coercive action will continue till the next date of hearing.

Hrishikesh Roy posted the batch of pleas for further hearing in the second week of January. Besides

Roy, Vijayvargiya and Singh, two other BJP leaders Souray Singh and Pawan Kumar Singh have moved the apex court for protection in cases lodged against them

While granting protection to these five leaders, the bench directed the Ministry of Home Affairs to submit in a sealed cover a report regarding alleged scuffle between TMC workers and security staff of West Bengal BJP leader Kabir Shankar Bose, who has filed a separate plea in the

During the hearing, senior advocate Mukul Rohatgi, appearing for petitioner Arjun Singh said that 64 criminal cases have been filed against the BJP leader in 2019 after he had joined Bharatiya Janta

Party (BJP) leaving Trinmool Congress party.

"I am an MP and these cases have been filed after I left TMC," Rohatgi said, adding, "The first case against Arjun Singh was registered on March 24, 2019 after he left the TMC".

Vijayvargiya's counsel told the bench that the BJP leader is an MP from Madhya Pradesh and false cases have been lodged against him in West Bengal. "I am an MP from Madhya Pradesh and just because I am going to West Bengal due to some party works, false cases have been filed against me," Vijayvargiya's counsel said.

The BJP leaders have also sought investigation by an independent agency into the cases registered against them in West Bengal

The two officers were again called on Thursday for a meeting on Friday. They again refused to come but offered to attend the meeting through a video-conference. They were asked by the Union home secretary to ex-

plain the law-and-order situation in West Bengal which they did, a home ministry official said

The home secretary is also believed to have asked the two officers about the political violence in the state and the steps taken to check it

The attack on Nadda's convoy and the state government's refusal to relieve three IPS officers summoned for central deputation were also understood to have figured in the meeting, another official said.

The chief secretary and the DGP were called by the home ministry on December 14 after receiving a report on December 11 from West Bengal Governor Jagdeep Dhankhar on the law-and-order situation in the state.

Dhankhar was asked to submit a report after Nadda's convoy was attacked with stones and bricks in West Bengal's Diamond Harbour on December 10 during his two-day

visit to the state.

The Centre and the West Bengal government have been at loggerheads since the attack that took place in the Lok Sabha constituency of Chief Minister Mamata Banerjee's nephew Abhishek Banerjee

After the attack, the home ministry summoned three IPS officers -- Bholanath Pandey (SP, Diamond Harbour), Praveen Tripathi (DIG, Presidency Range) and Rajeev Mishra (ADG, South Bengal) -- for deputations at the Centre. The three were responsible for Nadda's se-

curity during his visit to the state. However, the state government refused to relieve them citing a shortage of senior police officers. On Thursday, the home ministry sent a fresh missive to the West Bengal government, asking it to immediately relieve the three IPS officers, saying they were already given new assignments.

India to produce 300mn doses of Sputnik V vaccine

New Delhi/Moscow, Dec 18: India will produce about 300 million doses of the Russian Sputnik V coronavirus vaccine in 2021, the head of the Russian Direct Investment Fund (RDIF) Kirill Dmitriev said in an interview with a TV channel.

"In India, we have agreements with four large manufacturers. ..India will produce about 300 million doses or more of the vaccine for us next year," he was quoted as saying to Rossiya 24 TV channel by TASS news agency on Thursday. RDIF is Russia's sovereign wealth fund.

Dmitriev noted that out of 110 production sites that negotiated production of Sputnik V, RDIF chose 10 that meet its requirements. "The Russian Sputnik V will be actively produced in the world and we see that this is built on a safe platform based on the human adenovirus," Dmitriev said



duction of Sputnik V began in other countries, in particular in India, Korea, Brazil, and China, Registered by Russia on August 11, Sputnik V became the world's first coronavirus vaccine.

The vaccine was developed by the Gamaleya National Research Center of Epidemiology and Microbiology. Its post-registration trials began in Moscow on September 7, with volunteers receiving the first vaccine on September 9. A total of 40,000 people are involved in the programme. RDIF supports the development of Russia's Covid-19 vaccine by the Gamaleya Center and is investing in mass production of the vaccine by RDIF portfolio companies.

Over 4.5 cr people will be forced to migrate from homes by 2050

New Delhi, Dec 18: Over 4.5 crore people will be forced to migrate from their homes in India by 2050 due to climate disasters including floods, droughts and cyclones, three times more than the present figures, according to a new report.

In 2020, the number of people displaced in India is 1.4 crore, it said.

The report 'Costs of climate inaction: displacement and distress migration' assessed climate-fuelled displacement and migration across five South Asian countries --Bangladesh, India, Nepal, Pakistan and Sri Lanka - and calculates a devastating likelihood of over 6 crore people being homeless and displaced by 2050 in South Asia alone.

It is based on a study conducted by International agencies ActionAid International and Climate Action

Network South Asia. Quoting figures, the report claimed that 4.5 crore from India will be forced to migrate from their homes by 2050 due to climate disasters.

'Political failure to limit global warming to below 2 degrees Celsius as per the Paris agreement goal is already driving 18 million climate migrants from their homes in 2020," the report said.

The report released on Friday, estimates that climate migration will treble in South Asia alone, a region badly affected by climate disasters, including floods, droughts, typhoons and cyclones. The research was undertaken by Bryan Jones, one of the authors of the inaugural Groundswell Report on internal climate migration in 2018.

The report called for strong leadership and ambition from developed countries to cut emissions and support for developing countries



to adapt to climate change and recover from climate disasters

It recommended a holistic approach that places the onus on rich countries to provide support and urges developing countries to scale up efforts to protect people from climate impacts. Harjeet Singh, Global Climate Lead at ActionAid,

said, "We are facing melting glaciers in Nepal, rising seas in India and Bangladesh, cyclones and inhospitable temperatures.

Climate change is increasingly forcing people to flee their homes in search of safety and new means to provide for their families.

"Rich countries need to take

greater responsibility to reduce their emissions and support South Asian countries in cutting emissions and dealing with climate impacts. The human cost of inaction is too high," he said. The research reveals that in all five countries, women are left dealing with the negative fallout

from climate migration. "They are left behind to take care

of household chores, agricultural activities, look after children and elderly and manage livestock. Women who migrate to urban settlements are often then forced to take up work in precarious settings where workers

rights violations are rife," it said. Sanjay Vashist, Director, Climate Action Network South Asia said, "South Asia is geographically vulnerable to climate disasters and is regularly lashed with floods and cyclones, but poverty and environmental injustice are also determining factors in this climate migration crisis.

"South Asian leaders must join 🗦 forces and prepare plans for the protection of displaced people. They must step up and invest in universal and effective social protection measures, resilience plans and green infrastructure to respond to the climate crisis and help those who have

been forced to move," he said.

Five killed in US winter storm

Washington: At least five people died after a massive winter storm hit the US Northeast this week, the Weather Channel reported. In New York state, two deaths connected to the storm were reported, Xinhua news agency quoted Governor Andrew Cuomo as saying Thursday. Shocking photos showed at least 66 vehicles, including 11 passenger ones. were involved in a pileup on Interstate 80 in Clinton County, Pennsylvania, Wednesday. One person was killed and several others were injured in the pileup.

Abducted boys released

Katsina (Nigeria): Over 300 Nigerian schoolboys were released Thursday after being kidnapped in an attack claimed by Boko Haram, officials said, although it was unclear if any more remained with their captors. The assault last Friday on a rural school in Kankara, Katsina state in northwest Nigeria. was initially blamed on criminals, known as bandits, who have terrorised the region for years. But Tuesday Boko Haram, the brutal iihadist group behind the abduction of 276 schoolgirls in Chibok in 2014, claimed responsibility for the raid.

UNHCR rescues 126 immigrants

Tripoli: The UN Refugee Agency (UNHCR) said that 126 illegal immigrants were rescued off the coast of Libya. Up to "126 persons among them eight women and 28 children were returned to Libya this morning after their boat was rescued/ intercepted at sea", the UNHCR said in a Twitter post. Several hundred immigrants, mostly Africans, chose to cross the Mediterranean from Libya towards Europe, due to the state of insecurity and chaos in the North African nation following the fall of former leader Muammar Gaddafi in 2011.

Rickshaw bomb kills 15 kids

Kabul: A bomb rigged to a rickshaw killed at least 15 children and wounded 20 others in a Taliban-controlled area in eastern Afghanistan Friday, a provincial official said, as violence in the warweary country continued to surge. The bomb went off after a man driving a motorized rickshaw entered a village in the Gilan district to sell goods and was soon surrounded by kids. according to Wahidullah Jumazada, spokesman for the

Ghazni provincial governor.

For years, the Pentagon sits on racial discrimination data

Washington, Dec 18: Army Sergeant Major Das'Chara Champ couldn't have known that the answer to her question about racial discrimination survey data was sitting in an office somewhere in the vast Defense Department bureaucracy

Few people do.

"Has there been any kind of survey done on the perceived level of racism or racial discrimination in the Army," Champ, who is Black, asked in a video played at a Pentagon town hall September 24.

On the other end of the question were some of the most senior leaders in the US military: Then-Secretary of Defense Mark Esper, Army General Mark Milley, the chairman of the Joint Chiefs of Staff, and Milley's senior enlisted advisor, Ramon Colon-Lopez. Virtual town halls like this have been a way for the Pentagon's top brass to address concerns in 2020 about racial discrimination in a military - America's largest employer - which is diverse in lower ranks but largely white and male at the top.

Apparently unbeknownst to Colon-Lopez, who responded only indirectly to Champ, the Defense Department not only carries out granular surveys about discrimination but has been legally-required to do so since the 1990s. The last survey of the active duty force, conducted every four years, was for fiscal year 2017.

However, the Defence Department denied repeated requests from Reuters to release the 2017 survey



data, including through a Freedom of Information Act request. It has also not released a separate report about the 2017 survey data or clearly explained why the data has been

Maryland Rep. Anthony Brown, a retired Army Reserve colonel and the only member of the Congressional Black Caucus on the House Armed Services Committee, said the failure to release the data was troubling.

"It concerns me tremendously," Brown said, adding Congress had established a clear reporting requirement and the public had a

right to know. In its final response to Reuters this month, rejecting the Freedom of

Information Act request, the Department of Defense said the survey data constituted "information of a pre-decisional, deliberative nature.'

If released, the Pentagon asserted it could "reasonably be expected to interfere with the government's deliberative process.

Still, the data is already so old that the Pentagon is now in the awkward position of having to start planning for another survey in the ongoing 2021 fiscal year, which ends September 30.

In 1985, he covered the Air India bombing in which 329 people were killed aboard from Montreal to Heathrow. He has chased that story for the last 35 years, covering the entire investigation and inquiry into the case.

Milewski retired as CBC's senior correspondent in 2016, returning occasionally as a guest host on the network's Power and Politics.

Biden's bond with Capitol Hill tested

Washington, 18: President-elect Joe Biden brings more Capitol Hill experience than any President in decades, but his transition has stumbled in ways large and small, exposing the challenges of navigating a Congress that is a different place than when he last served in 2009.

He rolled out an almost all-white national security team when allies were expecting diversity. He filled top posts with familiar Washington hands rather than newcomers. His team clumsily floated some names and retracted others for the Cabinet.

None of the setbacks has been politically devastating. In fact, key Republicans are reaching out for personal calls with Biden, and Democrats are excited about the skilled and savvy professionals poised to join the administration as it battles the Covid-19 crisis and withering economy

But taken together, the slights and slip-ups of Biden's interactions with Congress leave the impression his team is misreading the Capitol Hill audience he'll be relying on for legislative outcomes.

And it calls into question one of the incoming president's most prized attributes - his presumed ability to work with an often unruly Congress. Biden last walked the marbled halls as a senator more than a decade ago. Only one-third of the senators with whom he served remain in office, forcing the president-elect to create new relationships.

"A strong belief that my dad drilled into my head: First impressions are lasting, and you don't get a second chance to make a first impression," Rep. James Clyburn, the highest-ranking Black lawmaker in Congress and a top Biden ally, said in an interview Thursday

Clyburn said people were "raising hell" over what he called the "herky-jerky" rollout of the initial, predominantly white Cabinet.

Airstrikes kill 30 militants in Afghan

There have so far been no comments made by the Taliban militants who are active in parts of the Ghazni province with the Ghazni city as its capital, 125 km south of Kabul.

Iran builds new nuclear facility amid US tensions

Dubai, Dec 18: Iran has begun construction on a site at its underground nuclear facility at Fordo amid tensions with the US over its atomic programme, satellite photos obtained Friday by The Associated Press show.

Iran has not publicly acknowledged any new construction at Fordo, whose discovery by the West in 2009 came in an earlier round of brinkmanship before world powers struck the 2015 nuclear deal with

While the purpose of the building remains unclear, any work at Fordo likely will trigger new concern in the waning days of the Trump administration before the inauguration of President-elect Joe Biden. Already, Iran is building at its Natanz nuclear facility after a mysterious explosion in July there that Tehran described as a sabotage attack.

"Āny changes at this site will be carefully watched as a sign of where Iran's nuclear programme is headed," said Jeffrey Lewis, an expert at the James Martin Center



for Nonproliferation Studies at the Middlebury Institute of International Studies who studies Iran.

Iran's mission to the United Nations did not immediately respond to a request for comment. The International Atomic Energy Agency, whose inspectors are in Iran as part of the nuclear deal, also did not immediately respond to a request for comment. The IAEA as of yet has not publicly disclosed if Iran informed it of any construction at Fordo.

Construction on the Fordo site began in late September. Satellite images obtained from Maxar Technologies by the AP show the construction taking place at a northwest corner of the site, near the holy Shiite city of Qom some 90 kilometers southwest of Tehran.

Washington, Dec 18: The US Food and Drug Administration (FDA) has said it was working with Pfizer to revise a fact sheet for recipients of the Pfizer-BioNTech Covid-19 vaccine after two people had allergic reactions.

The two people, both health workers, were vaccinated in Alaska and one of them had a serious or "anaphylactic" reaction resulting in hospitalization.

Doran Fink, deputy director of the FDA's division of vaccines said: "All of these individuals were treated with appropriate medical intervention and thankfully, all are recovered or recovering.



"We anticipate that there may be additional reports, which we will rapidly investigate.'

He added that US authorities, including the Centers for Disease Control and Prevention, were investigating the two cases and work ing with Britain to better understand two similar cases that occurred there. "While the totality of data at this time continues to support vaccinations under the Pfizer EUA (emergency use authorisation), without new restrictions, these cases underscore the need to remain vigilant during the early phase of the vaccination campaign," Fink said.

To this end, he said, "FDA is working with Pfizer to further revise the fact sheets and prescribing information for their vaccines to draw attention to CDC guidelines for post vaccination monitoring and management of immediate allergic reactions.

The revision will include the current warning for people who have a history of allergic reactions to the vaccine's ingredients to avoid getting the shot for now.

It will also include the warning that facilities where vaccines are being administered should ensure that medical treatment formanaging serious allergic reactions is immediately available.

Wuhan, Dec 18: In a crowded Wuhan beer hall, Zhang Qiong wipes birthday cake from her face after a food fight with her friends.

"After experiencing the first wave of epidemic in Wuhan and then the liberation, I feel like I'm living a second life," says Zhang, 29, who works in a textiles shop in the central Chinese city that was the original epicentre of Covid-19.

Outside, maskless partygoers spill onto the streets, smoking and playing street games with toy machine guns and balloons. Nightlife in Wuhan is back in full swing almost seven months after the city lifted its stringent lockdown and

the city's young partygoers are embracing the catharsis. In scenes unimaginable in many cities around

the world reeling under a resurgence of the pandemic, young Wuhan residents during a recent

Indian tech contractors: Survey

Mumbai, Dec 18: The United Kingdom, Ireland, the Netherlands, the United States and South Africa are among the top countries attracting and retaining high-skilled Indian workers in the contracting market place, says a survey.

The survey titled 'Global Demand for Indian IT Contractors' has been done by contractor hiring platform Techfynder that a majority of companies from these regions on the platform have shown an interest in hiring for core domains that include cloud, cyber and digitisation.

The findings are based on the survey of 52,000 contractors from across the country between January and December 2020, to find out the trends in the contractual job mar-



ketplace in India.

Due to the pandemic, many businesses are going online to offer their products and services, which has further increased the demand for IT contractors in roles such as software engineers, senior java developers, cyber security engineers, data scientists, web developers, and UI/UX designers, it noted.

As per the survey, the UK, Ireland. Netherlands, the US, and South Africa are the top five countries

attracting and retaining a highlyskilled Indian workforce in the contracting market place. Further, it said since March this

year there was a staggering 610% growth in job postings for IT contractors across the Philippines, Netherlands, Nigeria, Canada, Kenya and Brazil.

IT sector tops the charts with 48% hiring of the contractual workforce. It is followed by insurance (18%), banking and finance (16%), telecommunications (12%) and pharmaceuticals (6%), the survey said. "The IT contractual job market has always seen good traction. However, the growth for contractors in India has only been exemplified during the pandemic, which massively impacted the global job market.

FICCI suggests rationalising of GST slabs

New Delhi, Dec 18: As the Finance Ministry prepares for the upcoming Union Budget for the FY21-22, it has been speaking to several stakeholders; industry body FICCI has come up with a number of suggestions, including support for infrastructure projects and rationalisation of GST slabs

The industry body has asked government to incentivise investments in infrastructure. A stimulus to investments in infrastructure can provide a major fillip to the growth engine, creation of jobs and spur in demand, it said.

"Erstwhile Section 10(23G) of the Income Tax Act exempted income by way of dividend, interest and long-term capital gains arising out of investments made in an enterprise engaged in the business of developing, maintaining and operating an infrastructure facility," said a statement by FICCI.



A benefit similar to section 10(23G) of the Act to incentivise investments in infrastructure may be provided in the upcoming budget, it added. It noted that measures to revive the growth cycle, creation of jobs are of paramount importance in the current scenario.

On rationalisation of GST slabs, it said that currently there are seven rate slabs for goods and five

rate slabs for services. In addition, compensation cess applies

"Government should consider converging the existing band of GST rates to three in line with international standards. This will help resolve interpretation issues, reduce complexity and probability of disputes," it said.

The FICCI has also recom-

mended the government to abolish the GST law.

"Given that the tenure of National Anti-Profiteering Authority was initially prescribed for a two-year period and with GST law largely been settled, it is recommended that the determination of prices should be left to the market forces and the provision of anti-profiteering in the GST law should be discontinued with prospective effect.'

The lack of guidelines on the subject is just adding to ambiguity in implementation of anti-profiteering provision by the industry, it added

Urging the government to take growth-oriented measures, it said that the economy is recovering at a quick pace and this momentum needs to be sustained.

It noted that next year's budget must prioritise growth-oriented measures and fiscal considerations should be secondary.

The retail inflation for farm workers and rural labourers were at 9.41% and 9.23%, respectively. in November last year.

Inflation based on food index of CPI-AL and CPI-RL stood at 6.88% and 7.06%, respectively, in November, compared with 12.03% and 11.85% in the corresponding month of the previous year.

The all-India CPI-AL and CPI-RL indices increased 8 points each to stand at 1,060 and 1,065, respectively, in November 2020.

Labour Minister Santosh Gangwar said, "The inflation based on CPI-AL and RL have dipped to 6 per cent and 5.86 per cent, respectively, which will have a positive impact on the income of labourers working in rural area."

Labour Bureau Director General DS Negi said, "The inflation based on CPI-AL and RL eased during November 2020, owing to a decline in the prices of wheat-atta, chillies-green, ginger, poultry, gur,bajra, fresh fish, kerosene oil and vegetables.


