New Delhi, Jan 17: While the roll out of Covid-19 vaccines has raised hopes of getting relief from the pandemic, many are concerned over the safety of the vaccines, especially among the elderly with serious underlying health conditions.

According to latest reports, at least 84 people have died in different countries due to complications following inoculation, while several others have suffered varied degrees of adverse effects. At least 55 people have perished in the

United States after receiving a Covid-19 vaccine, reports Epoch Times quoting the Vaccine Adverse Event Reporting System (VAERS), a federal database.

Norway, which witnessed death of 23 senior citizens Friday after receiving the vaccine produced by Pfizer and BioNTech SE, saw the fatalities climb to 29 Sunday. All the victims were in the age group of 75 from 80. Norway has given at least one dose to about 42,000 people and focused on those considered most at risk if they contract

the virus, including the elderly. In Portugal, a health worker died two days after getting the Pfizer coronavirus vaccine. According to a report in the DailyMail, Sonia Acevedo, 41, suffered a 'sudden death' at home on New Year's Day 48 hours after receiving the jab.

Meanwhile, Reuters quoted Mexican authorities saying rhat they are studying the case of a 32-year-old female doctor who was hospitalised after receiving the Pfizer-BioNTech Covid-19 vaccine. The doctor: whose name has not been released, was admitted to the intensive care unit of a public hospital in the northern state of Nuevo Leon after she experienced seizures, difficulty breathing and a skin rash. She is said to have a history of allergic reactions.

In the US, the deaths have occurred among people receiving both the Moderna and the Pfizer-BioNTech vaccines, according to VAERS. VAERS reporting system is passive, meaning reports aren't automatically collected and

must be filed. VAERS reports can be filed by anyone, including healthcare providers, patients, or family members.

VAERS reports "often lack details and sometimes can have information that contains errors," according to the reporting system's website. Still. reports on VAERS represent "only a small fraction of actual adverse events,' the site states, though underreporting is believed to be less common for serious events.

In some cases, patients died within days of receiving a Covid-19 vaccine.

One man, a 66-year-old senior home resident in Colorado, was sleepy and stayed in bed a day after getting Moderna's vaccine. Early the next morning, on Christmas Day, the resident "was observed in bed lying still, pale, eyes half open and foam coming from mouth and unresponsive," the VAERS report states. "He was not breathing and with no pulse.'

In another case, a 93-year-old South Dakota man was injected with the Pfizer-BioNTech vaccine January 4 around 11 a.m. About two hours later, he said he was tired and couldn't continue with the physical therapy he was doing any longer. He was taken back to his room. where he said his legs felt heavy. Soon after, he stopped breathing. A nurse declared a do-not-resuscitate order.

Moderna and Pfizer didn't respond to requests for comment.

NAYAGARH MURDER

HC refused to monitor **SIT probe in Dec: RTI**

Investigation Team (SIT) probe into the alleged rape and murder of a minor girl in Nayagarh by a sitting judge of the court in December last year.

Amid a raging controversy on the issue, the Orissa High Court has given an additional reply to the RTI applicant who had sought information related to the crime. The HC had earlier claimed that it did not receive any proposal from the state government to monitor the SIT probe by a sitting

judge of the HC. In its latest reply, the court said that it received a proposal from the state Home department but diverted it to the confidential section of the HC office. Later, the HC declined to appoint a judge to monitor the probe December 1, 2020.

GUNMEN KILL TWO FEMALE AFGHAN SC JUDGES

Govt officials, scribes and activists have been targeted in recent months. stoking fear, particularly in Kabul

Kabul. Jan 17: Unidentified gunmen killed two female judges from Afghanistan's Supreme Court Sunday morning, police said, adding to a wave of assassinations in Kabul and other cities while government and Taliban representatives have been holding peace talks in Qatar. The two judges, who have not vet been named. were killed and their driver wounded, in an attack at around 8:30 am, police said, adding the case was being investigated by security forces. A spokesman for the Taliban said its fighters were not involved. Afghan President Ashraf Ghani issued a statement condemning attacks on civilians by the Taliban and other militant groups. Ghani said "terror, horror and crime" was not a solution to Afghanistan's problem and beseeched the Taliban to accept 'a permanent ceasefire" Government officials, journalists, and activists have been targeted in recent months, stoking fear particularly in the capital Kabul. The Taliban has denied involvement in some of the attacks, but has said its fighters would continue to "eliminate" important government figures, though not journalists or civil society members. Rising violence has complicated USbrokered peace talks taking place in Doha as Washington withdraws troops. Sources on both sides say negotiations are only likely to make substantive progress once US President-elect Joe Biden takes office and makes his Afghan policy known. The number of US troops in Afghanistan has been reduced to 2,500, the lowest level of American forces there.









Woman hires killer to eliminate daughter

Balasore, Jan 17: Police Sunday arrested two persons, including a woman, on charges of hiring the services of a contract killer to eliminate her daughter in lieu of₹50,000 with a view to "save the honour of her family". The incident took place in the Sadar Police limits in Balasore district.

The body of the victim, Sibani Nayak, 36, was recovered from under Belnala bridge in the same police station's jurisdiction, January 13.

The startling crime was revealed by Sadar SDPO Prabhas Chandra Pal at a press meet,



Sunday. The police launched a probe after Asim Giri, brother of the victim, filed an FIR in this connection. The accused were identified as Sukanti Giri, 52, of Maida village under Sadar Police limits, and the victim's male friend Pramod Jena, 37, of Raisuan village under Basta Police limits in the district.

The SDPO said that Sukanti. mother of the victim, tried to get rid of Sibani as she was allegedly involved in bootlegging and other illegal activities, which were tarnishing the honour of the family

Accordingly, she sought the help of her daughter's male friend Pramod to kill Sibani and hatched a conspiracy with him.

The Sadar SDPO said the accused Sukanti had contacted Pramod to kill her daughter and had given an advance of

₹8,000 two months back while assuring to give the remaining ₹42,000 after Sibani was killed.

Pramod, who works as a driver, knew Sibani as she used to frequently travel with him to different places, said Pal Though Sibani was married, she was staying near her parents' place for the last 11 years.

On the fateful day (January 12), Pramod took Sibani to an isolated place on the pretext of some work. Later with the help of two of his associates, Pramod made Sibani consume alcohol and later bludgeoned her to death using a stone. He dumped her body under the bridge, Pal said.

Orissa HC directs woman to handover baby to his father

Cuttack, Jan 17: The Orissa High Court has allowed a man to take custody of his 15-month-old son observing that continuance of the custody of the toddler with the mother, who is now staying separately, would be detrimental to the child's mental and physical development and may also affect his psychology negatively.

The court direction came after watching a video in which it is seen that the mother was repeatedly torturing and beating the child mercilessly.

A Division Bench of Justices SK Mishra and Savitri Ratho Friday while allowing a writ of Habeas Corpus filed by one Chakradhar Nayak of Puri district directed his wife to hand over the baby boy to his father within seven days.

"In case of her failure to do so, the police shall take appropriate steps in taking the child from the physical custody of the mother and handover the child to the father", the high court directed.

"We found from the video that the mother was mercilessly beating the infant on several occa sions. Finding the cruelty, torture and assault to the small boy, we directed the police to secure the attendance of the mother along with the child", the high court said.

made their way to the crucial National Security Council of the White House, thus leaving a permanent imprint on the country's foreign policy and national security.







State tops list in road fatalities due to parking along shoulders

A perusal of NCRB reports for the last couple of years reveals that fatalities in road mishaps due to illegal parking of vehicles in Odisha outnumber the fatalities caused by driving under the influence of drugs and alcohol

Bhubaneswar, Jan 17: Continuous rise in the number of road fatalities has been a major cause of concern for the state government. The authorities have failed to bring the number of road mishaps under control despite taking a series of initiatives.

Meanwhile, the state again witnessed a disturbing spike in road mishaps after easing down the Covid-19 lockdown between September and October last year. The road mishap fatalities increased by 27.5 per cent during festive months-September and October of last year compared to the same period in 2019.

In 2018, the incidents of road accidents rose to 786 compared to 524 the previous year. The state recorded 241 deaths and 564 injuries in road accidents caused by illegal park-

Demand for inquiry Professionals take Pattachitra art to new heights into custodial death

Lodged for more than a decade, Rabi Dulal of West Bengal breathed his last Saturday at Jharpada special jail after suffering cardiac arrest

Bhubaneswar, Jan 17: Rabi Dulal, an undertrial prisoner, who had been in jail since the last 12 years, died Saturday at Jharpada Jail here. He was a native of Sanataranga village under Badasaranga police station of Bankura district in West Bengal. Though police had registered

nine cases against him, he was acquitted in five cases and due to long judicial process and delayed justice system he lost his mental balance, sources said. In the meantime, he kept sending petitions to the Human Rights Commission of West Bengal, NHRC and the courts where his trial was underway. But nothing happened and in the end he died due to such delayed bureaucratic as well as the justice system, sources said.

In this context Narendra Mohanty, Convener and Biswapriya Kanungo, advisor of Campaign Against Fabricated Cases (CAFC), Odisha demand a proper inquiry



into the death of the undertrial prisoner and sought handing over the dead body to his family members as well as to implement the quick justice delivery system for other prisoners especially for political prisoners.

The deceased had spent more than a decade as an undertrial prisoner at Jharpada special jail in Bhubaneswar. As per reports he suffered a serious cardiac arrest while filling up drinking water Saturday morning. The authorities immediately rushed him to the Capital hospital where the doctors declared him brought-dead.

Bhubaneswar, Jan 17: As three cars of tourists make their way into the heritage crafts village of Raghurajpur in Puri district which is famous worldwide for its 'Pattachitra' art, the villagers display anxious looks.

Sitting in the foyers of their houses which are artistically painted, they look up curiously at the visitors in



the car before passing a smile. Some turn back to carefully paint the 'Pattachitra' while some welcome the visitors with folded hands. In the middle of the village which has houses in two rows facing each other, is the house of Bhagaban Swain, a 65-year-old retired school teacher. The four walls of the medium sized room are packed with shelves displaying the ancient Pattachitra paintings beside vari-

ous other forms on wooden and stone carved pieces. Bhagaban Swain's son Shibanarayan Swain, 23 is doing MCA from Odisha University of Agriculture & Technology, Bhubaneswar and takes pride in displaying the art forms like Patta painting, Tasser painting and palm leaf engraving that has been the

tradition for not only his family but the approximately 160 houses in the village. His mother Sakhi too has mastered the art with perfection. "This is my ancestral work, though I am doing MCA, I will make sure I take the art forward and bring more acknowledgement and pride to Raghurajpur village. I have mastered the art from my father and uncle Biswanath Swain who was a national awardee in palm leaf engraving. My professional degree would help me to take the art to another level," Shibanarayan Swain says as he carefully picks up a Pattachitra painting from the shelves. There are others in the village too

who are professional degree holders but have continued with the traditional art form.

"There are many professionally



take pride in the art for the village. A man in the village is a chartered accountant, one is a supply inspector and another a traffic officer," Shibanarayan said. A few metres away from the Swain house in the opposite lane, separated by a temple, a young girl Pragya Vernita Das stands with her younger brother. She has beautifully displayed the various miniatures of deities and temples on the door.

"I am doing graduation but I have learnt the art at an early age. I will continue to balance studies with the art form. Even if I decide to do a job one day I will make sure that I keep finding time to do Pattachitra and other art forms our village Raghurajpur is famous for," Pragya said with a smile.

A few steps ahead, five boys are seen cheering one who is playing a mobile game. A loud roar is heard, an indication the player Joyant Maharana has won. "I and my brother Chandan have learnt the village art from our parents. It is our duty to take the art forward and make Raghurajpur famous at the international front," said Joyant. The Tourism department of the state also has a development programme for the heritage village.

"We also have plans to develop the village Raghurajpur in near future as the village has much tourist and the traders' footfall from across the world. We would ensure better coordination between the villagers and the visitors," said Vishal K. Dev, commissioner-cum-secretary, Department of Tourism, Odisha.

Patta means cloth and Chitra means paintings, so Pattachitra is essentially a painting on a piece of cloth. The popular forms of Pattachitra are the paintings on cloth depicting scenes from mythology and epics, the Tassar cloth Pattachitra are also popular worldwide. The Pattachitra etched on dried palm leaves are picked up as souvenirs, also the paper mache masks and paintings on coconut. Apart from these, artists also engage in making miniature temples and deities and toys of stone and wood with paintings on them.

Of the 183 new cases, 106 have been reported from different quarantine centres, while 77 detected during contact tracing.

Angul district recorded the highest number of 20 new cases, followed by Sambalpur (19) and Sundergarh (18).

The Health and Family Welfare department expressed regret over the death of a 52-year-old male Covid-19 positive patient from Bhubaneswar, who was also suffering from diabetes, hypertension, chronic kidney disease, and had undergone renal transplantation.

It is worth mentioning here that Srimandir, the abode of Lord Jagannath, was shut for devotees in March, last year in the wake of Covid-19 pandemic.

"Local mafia in league with timber traders from other areas has been running the racket. They are targeting teak wood trees in dense forests. After cutting down trees,



Big boost to mushroom farming in Ganjam

Chhatrapur, Jan 17: In a bid to augment income of rural people, particularly women, the District Rural Development Agency (DRDA) has taken up a major step to boost mushroom cultivation in Ganjam district. The aim is to make the district a mushroom hub. Steps have been taken to set up 503 mushroom farms in the district.

This was informed by DRDA Project Director, Shinde Dattatraya Bhausaheb on Twitter Sunday. Mushroom farming will provide

income opportunities for rural women associated with SHGs.

The DRDA will execute the project through the Odisha Livelihood Mission. SHG members promoted under Mission Shakti will be encouraged to take up mushroom farming. About 80 per cent of the population in the district depends on agriculture. Paddy straws are the



main raw material for mushroom farming. As straw is abundantly available, it will be made good use for mushroom farming.

Paddy straw mushroom is the easiest crop for rural people. It is cultivated for at least 10 months in a year. This farming has potential to make people self-employed.

The DRDA has set a target to set up 503 mushroom farms in the first phase under MGNREGS.

SHGs will manage these farms. Each SHG will be provided with Rs 1 lakh as assistance.

Through the National

Horticulture Mission, SHGs will have to bear only 40 per cent for the cost. Technical assistance will be provided by the horticulture department.

Vaccine Nationalism

ndia has joined the ranks of wealthier nations by beginning to inoculate health workers on January 16 in what is going to be the world's largest COVID-19 vaccination campaign. Among the 195 countries in the world the United States, Britain, Israel, Canada and Germany have already adopted some measure of protection with at least one dose of vaccine. Over 35 million doses of various COVID-19 vaccines have been administered around the world, according to the University of Oxford. India is second to the US with 10.5 million confirmed cases, and ranks third in the number of deaths, behind the US and Brazil, with a toll of over 150,000 lives.

The vaccination programme was launched in India on a day when Norway expressed concern about the safety of Pfizer's coronavirus vaccine on elderly people after at least 29 of them died within days of receiving the shot. The Norwegian authorities are reported to have decided to exclude elderly people from vaccination for the time being. The most striking difference between vaccination in the rich countries and in India is the fanfare the government of India is making over a life-and-death issue underplaying the risks involved in order to make political capital of it.

The government is in effect equating the drive with its political-economic slogan of "atmanirvar India" (self-reliant India) and "make in India" even though scientists and doctors across the globe have been working overtime to find out the right remedies to fight this pandemic. It is glossing over the fact that one of the two vaccines being rolled out - Covaxin - has not yet completed the third phase of clinical trial for which fears among the people about it, produced by Bharat Biotech, persist. They wonder whether they are being made guinea pigs by a politician-business nexus. Undermining the seriousness of the problem of unparalleled magnitude, ministers and politicians are singing paeans of praise for Prime Minister Narendra Modi giving him all the credit for the vaccination and making it a hilarious issue. Against the backdrop of the rising global COVID-19 death toll topping 2 million on 15 January, the clock is ticking to vaccinate as many people as possible. But the campaign has been uneven. Immunization drives have barely gotten off the ground in most countries and many experts are predicting another year of loss and hardship in places like Iran, Mexico, Brazil and India, which together account for about a quarter of the world's deaths.

India gave the nod for emergency use of two vaccines - one developed by Oxford University and UK-based drug maker AstraZeneca, and another by Indian company Bharat Biotech - on January 4 following which 16.5 million shots have been sent to different states last week. This was done dismissing health experts' worry that the regulatory shortcut taken to approve the Bharat Biotech vaccine without waiting for concrete data to show its efficacy could only amplify vaccine hesitancy. At least one state health minister has opposed its use.

The government's hurry to be populist over COVID-19 vaccination is understandable. It has handled the pandemic in a sordid manner. The country's economy is in shambles and its foreign policy has been so myopic that India is beset with dangers posed by a belligerent, ambitious and pro-active China. In such a backdrop its decision to roll out the vaccines without waiting for clearance for their safety may not be in the best interest of the common man.

The government is trying to convince the people that the country has the record of successfully administering polio and other vaccines and as such they can trust the government during the current programme. But, the vaccination against Covid-19 is not like running childhood vaccination programmes. Experts say countries that get enough vaccine for 20 per cent of the population will not be able to stop transmission. They will be in an "endless cycle". The coronavirus is not going away anywhere anytime soon. The whole world is watching how the Indian experiment pans out. The need is for an extremely cautious approach. Cynical political calculations should not dictate the timing of safe and efficacious vaccination and the scientific community should be given enough time to complete the due process.

CAN AMERICA LEAD AGAIN?

S President-elect Joe Biden's impending inauguration has raised hopes that his administration will "make America lead again." If the United States is to transform its rivalry with China into constructive competition, this is the right approach. But whether Biden can restore and sustain America's global leadership depends on how effectively he mends domestic fractures and addresses deep-seated misgivings about globalisation held by segments of the US electorate.

Biden has repeatedly pledged to restore America's international reputation and global standing. which were severely damaged under Donald Trump. To that end, he will quickly rejoin multilateral institutions (such as the WHO) and international agreements (beginning with the Paris climate agreement) from which Trump withdrew the US.

These pledges point to a vision of the US back at the head of the liberal international order, a position from which it can more effectively compete - and cooperate-with China. But there is good reason to believe that many Americans do not want their country to lead again.

Biden's electoral victory in November fell short of the decisive repudiation of Trump and his toxic brand of populism that liberals expected. Yes, Biden won over 81 million votes - more than any US presidential candidate in history. But Trump received more than 74 million - the second-highest number on record - and increased his share across minority groups, compared to 2016. This is despite an unprecedented parade of scandals and a disastrously mismanaged pandemic.

What explains Trump's enduring popularity? One explanation, advanced by Peter Singer in November, is that nearly half of America has "lost its soul." This diagnosis is certainly true of the most disturbing elements of Trump's voter base, which includes the white nationalists and

Still, it would be simplistic to dismiss support for Trump as nothing more than an endorsement of bigotry. It is worth remembering that 13 per cent of those who voted for Trump in 2016 voted for Barack Obama in 2012. And Trump received ten million more votes in 2020 than in 2016

Trump draws support from a motley array of sources. Racism and xenophobia are among them, but so is anger among rural and working-class voters over stagnating incomes and rising inequality. Some Asian voters also fell for his hawkish stance on China. As a political outsider, Trump was able to exploit resentment of the political establishment, hack the Republican apparatus, and package himself as a champion of the disaffected.

These voters have been misguided to put their faith in Trump, who never intended to address

For many US policymakers, this was unacceptable: if the US bears the costs of sustaining a world order, they believe, it should get to ensure that its interests come first

True to his promises of "America First," Trump withdrew the US from its previous global leadership commitments, pared down its engagement overseas, and built a wall. He delivered exactly what his voters wanted. But his policy inevitably produced a consequence that US leaders couldn't accept: China's rising profile, as it stepped in to fill the leadership vacuum the US left behind.

In response, the Trump administration portrayed China as America's mortal enemy, launched a ruinous trade war, and imposed a slew of sanctions. For Beijing, such hostility confirmed long-held suspicions that the US would never accept its rise without a fight, so it has reacted defensively. The resulting vicious cycle of mistrust and antagonism has yet to be broken.

For the Biden administration two lessons stand out. First, the US cannot have it both ways. It cannot withdraw from global leadership and refuse to allow anyone to take its place; if it insists, confrontation and brinkmanship will ensue. Second, America's clash with China over the last four years has been as much a divorce from that country as a divorce from globalisation.

This means that, if the US is to reclaim the leadership position that will enable it to compete constructively with China-and retain it for more than an election cycle - the Biden administration must tackle inequality and the costs that globalisation has brought Otherwise, Trump - or, worse, a more competent version of Trump - could well recapture the presidency in 2024 or 2028, and reverse whatever progress the Biden ad-

Xenotransplantation

The shortage of suitable organs for transplants is now severe, to the extent that the invention in the late sixties by the science-fiction writer Larry Niven of organlegging - murdering people to resell their body parts - no longer seems so fanciful. One solution that is being considered is the use of organs from other species, and it was reported at the end of 1996 that doctors in India had successfully transplanted the heart of a pig into a person. Two reports on the technique the same year (one in the US, one in Britain) agreed that though such transplants were acceptable on ethical grounds, there was legitimate concern over the risk that infectious diseases might be introduced with the transplanted organs. Pathogens such as retroviruses that might be benign or even undetectable in the host animal could become virulent when moved to the new environment of the human body. The term xenotransplantation is a compound of transplantation with the Greek prefix xeno-, 'foreigner; stranger', which also turns up in xenophobia and in some specialised medical terms like xenobiotic. An instance of the technique is a xenotransplant, a word which doubles as the verb; a person undertaking the process is rarely called a xenotransplanter.

Xenozoonosis

t's long been known that many communicable diseases - such as diphtheria, influenza, rabies, anthrax, chickenpox and mumps - were originally diseases of animals, which spread to humans once we began to domesticate them. The general name for such a disease is zoonosis (with plural zoonoses), which derives from the Greek words zoion, "animal", and nosos, "disease". As a result of current research into ways to transplant animal organs into humans, the risk of previously unknown diseases transferring with the grafts is greatly exercising medical minds, leading to calls for such techniques to be banned or at least closely monitored until the risk to heath is better known. A disease which might be transferred in this way is a xenozoonosis, using the Greek xenos, "stranger", in the same specialised sense as it is beginning to be used in words such as xenotransplantation and xenograft, which means "something (transplanted) from a different species". The adjective is xenozoonotic.

have developed, tested, and begun to deploy multiple effective vaccines for COVID-19. Now we must bring the same resolve to bear on fighting the other great existential threat to humanity: climate change. As UN Secretary-General António Guterres put it last month, "our future security and prosperity depend on bold climate action."

And yet, even at the most recent Climate Ambition Summit on December 12, many leaders' commitments still fell far short of what is needed to meet this collective challenge. To be sure, the EU, the UK, and even some of the smaller countries that are most vulnerable to climate change have significantly strengthened their 2030 emissions-reduction targets. But the US, Japan, China, and other major greenhouse-gas emitters still need to follow suit, preferably well ahead of the UN Climate Conference (COP26) in Glasgow this coming November.

Five years ago, after long and painstaking negotiations, the world \$100 billion commitment would be a concrete complement to rejoining the Paris accord. This money was already pledged during Barack Obama's presidency, so there is no excuse to keep it sitting in the US Treasury's coffers.

By the same token, other rich countries must not use the renewed focus on the US as an alibi for backpedaling on their own commitments. German Chancellor Angela Merkel's recent announcement that she will initiate a new international process on climate finance next year is a welcome declaration of intent. But past experience shows that we cannot count on lofty rhetoric.

Moreover, all countries in 2021 must give clear proof that they are reviewing and seeking to heighten the ambitions of their nationally determined contributions, the voluntary instrument through which signatories will uphold their commitments under the Paris agreement.

Solidarity and justice lie at the heart of both the Paris accord and the UN's Sustainable Development Goals, which were also adopted in 2015. These principles, and the responsibilities they entail, are more

wasted too much time in the five years since Paris. The policies we need to cut emissions - including an end to fossil-fuel subsidies, a meaningful carbon price, and investment in renewable energies have been fitful, inconsistent, and uncoordinated. But the climate crisis, like COVID-19, observes no borders and is indifferent to national sovereignty

While attention has properly been focused on the virus, the world has also witnessed ever more extreme weather phenomena, from wildfires in Australia and California to the costliest storm on record in the Bay of Bengal, which forced two million people to evacuate their homes.

As we move from Paris to 2030, global leaders, businesses, and citizens alike should expect to be judged by the actions that are (or are not) taken today. Neither our descendants nor the planet will tolerate more selfish short-termism.

Ego war at the cost of governance

Sir, Generally, the common people or the Opposition go on 'fast' or 'dharna' protesting against the ineffective ways of a government. However, the people of Puducherry are eyewitness to a strange spectacle. Social welfare minister M Kandasamy is on a dharna seeking audience with Lieutenant Governor (LG) Kiran Bedi. Chief Minister V Narayanasamy joined him for a few hours. Ever since the former police officer came to Puducherry as governor in 2016, tussle between the state and the governor has done no good to the administration. The ego war between Naravanasamy and Bedi has no precedence in the Union Territory. The two have clashed on major as well as trivial issues. Narayanasamy would have been a much relieved man if the Centre had recalled Bedi. Bedi has had a brush with controversy quite often. The 'obstructionist' in Bedi is an extension of her police career and the AAP stint. The LG should know she merely 'shares' power with the CM and his Cabinet; she is not the 'power'. The LG is a nominal head and the CM is the 'real head'. Bedi has tried to usurp upon the domain of the government by picking holes in the government's ambitious rice scheme. Grants-in-aid are delayed by Bedi's inquisitive nature. As a consequence, according to Kandasamy, salaries and appointments are held-up much to the dismay of the workers. Interestingly, a few months ago, Kandasamy had advised the CM and the Governor to bury the hatchet for the sake of governance in the Union Territory. The Centre's clever ignorance to the happenings in the Union Territory under a Congress-led Secular Democratic Alliance (SDA) government cannot be coincidental. Narayanasamy would have been a much relieved man if the Centre had recalled Bedi. Armed with the Centre's support. Bedi is unlikely to blink first. Ahmedabad, Jan 17: Prime Minister Narendra Modi Sunday flagged off eight trains connecting Gujarat's Kevadia, where the Statue of Unity of Sardar Patel is located, to different regions of the country.

He said that both treated and untreated effluent is released into the estuary of the Mahisagar and Gulf of Cambay, flouting the guidelines of the Central Pollution Control Board (CPCB).

As per the official parameters, if the chemical oxygen demand (COD), which indicates organic pollutant load, is higher than 250 mg per litre, then it should not be released into

the rivers "Most of the Gujarat rivers where

COD level is in the range of 700 to 1000 mg per litre. While Dissolved Oxygen (DO) level [indicating the health of a riverl in perennial rivers like Mahisgar should be in the range of 6 to 8 mg per litre, it is actually below 2.9 mg per litre," he added.

In December 2020, Mr. Prajapati and a few others wrote a letter to the State authorities providing evidence, including videos and photographs, of how toxic effluents were being dumped into the Mahisagar and other rivers by industries.

"The Vadodara Enviro Channel Ltd, which runs a 55-km-long pipeline to discharge treated effluents into the deep sea, releases the effluents into the river. The effluents are not getting discharged into the deep sea as required," a for-

The report states that Rs 785 crore was disbursed in the second quarter of 2020-21, against Rs 1,583 crore in the corresponding quarter of 2019-20.

Interfaith marriage triggers row in Raj

New Delhi, Jan 17: A plea in the Delhi High Court has challenged the scheme of amalgamation of Lakshmi Vilas Bank (LVB) with Development Bank of Singapore (DBS), contending that its shareholders have been "left in the lurch" and the Centre and the Reserve Bank have failed to protect their interests.

The petition was listed before a bench of Chief Justice DNPatel and Justice Jyoti Singh on January 13, but was adjourned to February 19 after the bench was told that the Reserve Bank of India (RBI) has moved a plea in the Supreme Court to transfer all pleas against the amalgamation scheme to the Bombay High Court. The petition in the Delhi High Court has been filed by lawyer Sudhir Kathpalia, who was also a shareholder in Lakshmi Vilas Bank (LVB) and lost his 20,000 shares in the company due to the amalgamation scheme.

Kathpalia has sought quashing of the clause in the scheme which



states that from the date of merger, "the entire amount of the paid-up share capital and reserves and surplus, including the balances in the share/securities premium account of the transferor bank, shall stand written off". The petition has said that under the scheme, DBS was not required to give any shares to the LVB investors in return and they were "left in the lurch"

The amalgamation scheme was approved by the RBI on November 25, 2020 and the merger took place on November 27, 2020. The petition has contended that the Centre and RBI have failed to protect the interests of the shareholders

It has also claimed that DBS was chosen for the merger without inviting bids from other banks and financial institutions. It has alleged that the "scheme of amalgamation was irregular, arbitrary, irrational, unreasonable, illegal and thus, void".

widely used language in RS

New Delhi, Jan 17: The use of regional languages during Rajya Sabha proceedings has increased more than five times and parliamentarians spoke in 10 of the 22 scheduled languages for the first time during 2018-20 with Sanskrit emerging as the fifth most widely used Indian language in the Upper House.

With 12 interventions in Sanskrit, all during 2019-20, it has emerged as the fifth most widely used language in the Rajya Sabha among the 22 scheduled languages after Hindi. Telugu, Urdu and Tamil.

Four of the 22 scheduled languages such as Dogri, Kashmiri, Konkani and Santhali were used for the first time in the Upper House since 1952, further to the introduction of Simultaneous Interpretation

Service in these four languages and Sindhi language at the behest of Rajya Sabha Chairman Venkaiah Naidu in 2018. Besides, six languages like

Assamese, Bodo, Gujarati, Maithili, Manipuri and Nepali have been used after a long gap, a Rajya Sabha document reveals.

While Hindi and English are the widely used languages during the proceedings of the House, the use of 21 other scheduled Indian languages (other than Hindi) has increased more than five times (512 per cent) per sitting in 2020 over that of the 14 year period between 2004-17. Rajya Sabha members spoke

in 10 scheduled languages (other than Hindi) in the House on 269 occasions during 923 sittings between 2004 and 2017 at the rate of 0.291 per sitting.

WHATSAPP, TELEGRAM OR SIGNAL? WELCOME TO THE ILLUSION CALLED DATA SECURITY

New Delhi, Jan 17: As millions shun WhatsApp and download new chat platforms in search for a secure experience, mind you that security is nothing but an illusion and there is no guarantee that Telegram or Signal may not be hacked in the future, especially when nation-state actors with highly sophisticated tools and huge resources are on the prowl

Encryption is fundamentally flawed and once hackers get to know any vulnerability or bug in the whole data travel journey - apps, mobile operating system, public Wi-Fi, Cloud and the physical data cen-

tres -- your personal and sensitive information is always at their mercy.

The Telegram development team is based in Dubai. The Telegram team had to leave Russia due to local IT regulations and has tried a number of locations as its base, including Berlin, London and Singapore. It does not store data within the boundaries of India. Signal does not own its own data

centres. The company is entirely Cloud based, which puts data at risk as cyber-attacks on Cloud-based services have increased in the recent past. In case the data is compromised. India which does not have a dedicated law on privacy or on cyber security, will not be able to do much,



unlike Europe which has a strong General Data Protection Regulation (GDPR) that treats the safety of its users' data diligently and seriously. According to Pavan Duggal, one

of the nation's top cyber law experts and a seasoned Supreme Court lawyer, if you are looking at complete and absolute security, you have to realise that security is a relative term.

"What was secure vesterday is not secure today and what is secure today will not be secure to-

morrow. Blindfoldly relying upon these platforms would not suffice. There is a need for people to incorporate cyber security as a way

of life," Duggal told IANS. Be it Pegasus software attack on WhatsApp or the great Twitter crypto hacking last year that compromised accounts of celebrities like US President-elect Joe Biden, former US President Barack Obama, Tesla CEO Elon Musk. Microsoft founder Bill Gates, Amazon founder Jeff Bezos (you name it), people are always facing the risk of losing their data. The latest is the SolarWinds attack that has rocked the US agencies and several tech giants. It is not that the bad actors directly compromised their networks; they used a third-party software called Orion sold by IT management company SolarWinds to infiltrate the systems even of the US Department of Justice (DoJ).

The suspected Russian hackers installed a malware in the Orion software and accessed sensitive data belonging to at least 250 US government agencies and businesses. Around 18,000 private companies and government agencies downloaded the infected Orion software.

At least 24 big companies, including tech giants like Intel, Cisco, VMware Nvidia and even a cybersecurity firm FireEve, have suffered the 'SolarWinds' hack.

Arnab drops names in leaked WhatsApp chats

New Delhi, Jan 17: The Whatsapp chat between Republic TV founder Arnab Goswami and former BARC chief Partho Dasgupta reveals a sensational nexus between the two. Latest chats revealed that the ex-BARC CEO even asked Arnab Goswami's help in getting a media advisor-type job at the PMO.

The screenshots, that have also been leaked on social media, suggest bid by top BARC executives to manipulate ratings in favour of Republic TV and the Hindi channel Republic Bharat.

The WhatsApp conversations have also show how Arnab Goswami dropped names insinuating that he had the backing of the govt. The chats have already invited the ire of opposition leaders. Who slammed Goswami's TRP euphoria over the Pulwama terror strike. Several ex-servicemen have also accused him of putting personal gains above national interests.The leaked conversations have also provided evidence regarding conflict of interest as well. The two had discussed the Kangana Ranaut-Hrithik Roshan story as well. Dasgupta was arrested in the alleged TRP rigging scam by crime branch of the Mumbai Police December 24 last year. A Mumbai court had earlier this month rejected his bail plea, stating that he appeared to have played a vital role in the scam to rig TRP as per the police's case. The Mumbai Police had earlier told the court that Republic TV Editorin-Chief Arnab Goswami had allegedly bribed Dasgupta with "lakhs of rupees" to ramp up the news channel's viewership numbers fraudulently. Dasgupta, was rushed to the state-run hospital in central Mumbai from the Taloja Central Prison in Navi Mumbai in the early hours of Saturday after his blood sugar levels shot up, a prison official had said, adding that he was put on oxygen support.

here is an interesting tale as to why Maharashtra strongman Sharad Pawar suddenly developed national ambitions and jumped into Opposition unity fray without actually donning the mantle of the UPA chairman's post. It was Leader of the opposition Rajya Sabha, Ghulam Nabi Azad who called up Sharad Pawar pleading with him to come out of Maharashtra and play a role at the national level. After Azad a couple of other dissident Congress leaders also talked to Sharad Pawar. Washington, Jan 17: By the busload and planeload, National Guard troops were pouring into the US capital, as governors answered the urgent pleas of defense officials for more troops to help safeguard Washington even as they keep anxious eyes on possible violent protests in their own states.

Military leaders spent chunks of Thursday evening and Friday calling states in an unprecedented appeal for more National Guard troops to help lock down much of the city in the days before President-elect Joe Biden's inauguration.

In dribs and drabs, governors responded, some agreeing to send an extra dozen, 100 or even 1,000, while others said no.

The calls reflect fears that violent extremist groups are targeting the city in the wake of the deadly insurrection at the U.S. Capitol Jan. 6. The threats range from armed insurgents to possible attempts to plant explosive devices at so-called soft targets.

But as Washington begins to resemble an armed camp, with more than 25,000 Guard due in the city by early next week, concerns about violence at state capitals has grown. Oregon Gov. Kate Brown said she turned down the federal re-

They have both previously served as former prosecutors -- Harris in California, Sotomayor in New York. Sotomayor, 66, is third female justice in US Supreme Court history.

Indonesia quake toll rises to 73

Mamuju (Indonesia), Jan 17: Indonesian rescuers on Sunday retrieved more bodies from the rubble of homes and buildings toppled by a strong earthquake, raising the death toll to 73, while military engineers managed to reopen ruptured roads to clear access for re-

lief goods. More heavy equipment reached the hardest-hit city of Mamuju and the neighboring district of Majene on Sulawesi island, where the magnitude 6.2 quake hit early Friday, said Raditya Jati, the National **Disaster Mitigation Agencys** spokesperson.

Power supplies and phone communications also began to improve. Thousands were left homeless and more than 800 have been injured, more than half still receiving treatment for serious injuries, Jati said.

The disaster agency's data showed nearly 27,850 survivors were moved to shelters. Most of them went to makeshift shelters that have been lashed by heavy monsoon downpours. Only a few were lucky to have tarpaulin-covered tents

They said they were running low on food, blankets and other aid, as emergency supplies were rushed to the hard-hit region.

"We are unable to return to our destroyed homes," said a father of three who identified himself only as Robert

Reporting normally declines on weekends, suggesting next week may bring even higher numbers. The country also recorded 1.219 more deaths, a near-record.

Kampala: Uganda's electoral commission said Saturday that President Yoweri Museveni won a sixth five-year term, extending his rule to four decades, while top opposition challenger Bobi Wine dismissed "cookedup, fraudulent results". In a generational clash watched across the African continent with a booming young population and a host of aging leaders, the 38-yearold singer-turned-lawmaker Wine posed arguably Museveni's greatest challenge yet.

Only about 200,000 people applied for the vaccine in Serbia, a country of 7 million, in the days after authorities opened the procedure.

New Delhi, Jan 17: The Confederation of All India Traders (CAIT) has announced that it will launch a nationwide movement against the present Goods and Services Tax (GST) system which it claims has become "extremely complicated" because of several

"arbitrary" amendments According to CAIT, the GST has become a hurdle in the smooth retail trade because of the complexi-

ties and arbitrariness of its provisions. In a statement Sunday, the traders' body said that it will convene a three-day conference of trade leaders of all states from February 8-10 at Nagpur to chalk out the future course of action. About 200 prominent trade leaders from across the country are likely to participate.

"Post-Covid, the retail trade is fighting hard for its survival and in such a situation, the GST system has become a devil for the business community due to several arbi-



trarv amendments. In such a sce nario, we have decided to oppose such amendments tooth and nail," the CAIT said in a statement

CAIT Secretary General Praveen Khandelwal said that implementation of various programmes of the central Government have become a cause of severe pain for the traders, of which GST is one of the causes.

The present GST violates its basic fundamentals which were announced at the time of its implementation in 2017, he said.

"In place of 'Good and Simple Tax', it has become an obnoxious and complicated taxation system,"

he said. Khandelwal added that the CAIT conference will also discuss e-commerce and the proposed ecommerce policy, empowering women entrepreneurs, appraisal of Mudra Scheme, easy availability of finance for traders, among others.

He was of the view that the retail trade stands neglected, although it generates an annual business turnover of ₹80 lakh crore. As many as 8 crore traders in the country employ around 40 crore persons.

Budget 2021: Real estate sector seeks input tax credit

New Delhi, Jan 17: The government should allow commercial real estate developers to set off GST paid on inputs like cement from the tax liability on rental income to avoid double taxation and give a boost to the office market to help India maintain its advantage in various sectors like IT and startups, realty firms and consultants said Sunday

In its Budget recommendation for the 2021-22 fiscal year. industry body CII has demanded that Section 16 read with Section 17(5) of the CGST Act should be amended to enable the real estate players to avail ITC (input tax credit) on procurement of goods and services during the construction phase where the said immovable property is intended for commercial leasing or

renting. The denial of ITC, leads to blockage of funds for a real estate player, it said.

"In case of commercial leasing of properties and outlets at malls, the renting of such premises attracts 18 per cent which is available as credit to the client. Disallowance of credit during the construction phase leads to the increased cost

of construction, working capital loss, increased financing costs impacting the entire supply chain," CII said.

Tata Realty & Infrastructure Ltd MD & CEO Sanjay Dutt mentioned that as per current GST provisions, input GST credit during the construction phase (for commercial properties) is not available for setoff against output GST liability from earning of rental income. "In other words, the GST charged

on input services (like procurement of cement, steel, works contract services, etc) is required to be capitalised to the cost of construction. Since the input GST rates on this score are significantly high (in the range of 18% to 28% for cement, steel and other big-ticket items), the developers are losing/foregoing substantial cash

flows on this score," Dutt said. He demanded that input tax credit should be allowed in commercial real estate properties meant for leasing purposes.

"It would immensely help the commercial real estate developers in conserving significant cash flows and help developers to sustain themselves...if such input GST is permitted to be utilised to be off-set against the output GST liability," Dutt said.

This will keep India's competitive advantage in the IT & ITES sector and startups through commercial real estate, he added.

Dutt said this would help the Indian office market, which witnessed a decline in net leasing during the 2020 calendar year because of the Covid-19 pandemic.

Bank credit to manufacturing muted amid Covid

New Delhi, Jan 17: Bank credit to manufacturing sector has remained muted in the current financial year amid the pandemic, while few sectors, including construction and trade, have witnessed resilient

According to the Financial Stability Report of the Reserve Bank of India (RBI) for January, credit growth in the manufacturing sector in October 2020 contracted by 2%, while that in construction witnessed a growth of 5.1% and credit to trade, hotels and restaurants was up 13.9%

"An analysis of sectoral credit growth, specifically to those that are critical in terms of gross value added (GVA), shows resilient flows to sectors such as construction. trade and hospitality, while bank credit remained muted to the manufacturing sector," the report said.

It said that the profile of wholesale credit in first half of 2020-21 and in the third quarter of 2020-21 (up to November) reflects a subdued credit situation across bank groups, pointing to risk aversion and



muted demand weighing on the outlook

With the onset of Covid-19, retail credit growth (y-o-y) has suffered, while wholesale credit growth has held up though at low levels.

'With stress tests pointing to a deterioration in asset quality of banks, early identification of impairment and aggressive capitalisation is imperative for supporting credit growth across various sectors alongside pre-emptive strategies for dealing with potential NPAs," it said.

As per the report, the gross nonperforming asset (GNPA) of scheduled commercial banks (SCB) are likely to increase to 13.5% by September 2021 in the existing scenario.

If your insurer has a digital platform, right from claim notification to submission, all the required documents can be done digitally. Below is a common (but not limited to) list of

documents that will be required to the file claim: In case of accidental unfore-

seen damage: Narration about the loss, purchase invoice of the damaged item(s), repair(s) estimate, repair bill, payment receipt, etc.

- In case of theft or burglary: Details of lost items covered under the policy, purchase invoice of the lost item, narration about the incident occurred, First Information Report (FIR), Final Police Report, etc.
- If loss is above ₹1 lakh, insurer may appoint an independent surveyor for verification and assessment of loss. Upon the visit, show the surveyor all the dam ages and also keep a list of lost/damaged items. In case you have any receipts of these items, share those with the surveyor too. Once you submit necessary information with the surveyor, s/he will then submit the final survey report to insurer with relevant assessment.

Insurer may later get in touch with you in case any further information or document is required. Usually, it takes 5-7 working days to settle small claims of up to ₹1 lakh and around 10 working days for large claims above ₹1 lakh once all the documents have been submitted by the insured. While the insurance company will pay the claim as per terms and conditions (T&C) of the policy, it is also the responsibility of the policyholder to take necessary steps for minimising the damage. For instance, dousing the fire with water immediately or safeguarding contents as much as possible to avoid damage in case flood water enters the house

Whether you are a house owner or a tenant, having a home insurance policy ensures that you don't suffer huge financial losses in case of any damage to your home and/or its contents due to an unfortunate event. It is always advisable to understand the (T&C) of the policy along with its claims procedure, so that at the time of claim you are not caught unaware.

Perhaps, he thought of trying to come close to Australia's total as the lead was very less," his father M Sundar stated from Chennai, "I speak to him in Australia every day. I told him last (Saturday) evening whenever you get a chance, get a big score. He said, 'sure I will'. Sundar's father is upset because he

feels that his son's batting capabilities are not being utilised. He is also surprised that Sundar is not a part of the Tamil Nadu Ranji Trophy team for the last three years, "He has played 12 first class matches for Tamil Nadu. He has performed whenever, he has got an oppurtnity," pointed out M Sundar.

Back in 2017, he was called up for the (pink-ball) Duleep Trophy final just a month short of his 18th birthday. The off-spinner and left-handed batsman picked 11 wickets and scored 130 runs (88 and 42) to help India Red beat an India Blue side that comprised the likes Ishant Sharma, Pankaj Singh and Jaydev Unadkat as well as Suresh Raina.
