Threats to artistes, directors worry 70 per cent OTT users

eventy per cent OTT users do not approve of threats of intimidation, violence and death issued to artists, directors and producers of movies and shows.

As per a survey conducted by LocalCircles, a social media platform to discuss issues, there have been a spate of cases of threats of intimidation, violence and death issued to artists, directors and producers of movies and shows.

Recently, one of the artistes, Richa Chadha received violence and death threat for allegedly stereotyping Dalits in the movie, Madam Chief Minister.

These providers include Amazon Prime Video, Netflix, Disney-Hotstar, SonyLiv, MX Player, Jio Cinema, Eros Now, Viacom (Voot), Alt Balaji, Arre, HoiChoi, Hungama, Shemaroo, Discovery___ Plus, Aha and Lionsgate Play.

Consumers however currently seem to have little understanding of the OTT code of regulation and when asked if they would like more information about the OTT code of conduct, majority of them i.e. 78 per cent said "Yes," 14 per cent said "No", and eight per cent couldn't say.






Vax for those above 50 from March 1

Bhubaneswar: Following healthcare professionals and frontline workers, people above 50 years will get Covid-19 vaccines. The state government is going to start the vaccination drive for such citizens from March 1. "The state government has decided to inoculate people above 50 years from March 1. The vaccination drive will begin after registration of those citizens," said state government's technical spokesperson Jayant Panda Monday. The second dose vaccination of healthcare workers (HCWs) was also started Monday. It will continue till March 15. Meanwhile, 200 CRPF jawans received Covaxin shots at the CRPF group centre.

Mkts at fresh high

Mumbai: Equity benchmark Sensex rallied over 610 points to finish above the 52,000-mark for the first time Monday, tracking significant gains in financial stocks amid a positive trend in global markets. After touching a record high of 52,235.97 during the day, the 30-share BSE index ended 609.83 points or 1.18 per cent up at 52,154.13. Similarly, the broader NSE Nifty soared 151.40 points or 1 per cent to finish at a record high of 15,314.70. It touched an intraday peak of 15,340.15. Axis Bank was the top gainer in the Sensex pack, climbing around 6 per cent, followed by ICICI Bank, Bajaj Finance.

Bandh peaceful in state

THE BJD NEITHER SUPPORTED NOR OPPOSED THE BANDH BUT THE BJP CRITICISED THE CONGRESS FOR CAUSING TROUBLE TO PEOPLE BY ENFORCING THE BANDH

Bhubaneswar, Feb 15: The six-hour bandh call given by the Congress protesting against the runaway rise in fuel prices and other issues including law and order problem in the state passed off peacefully.

Educational institutions remained closed, train services were affected and vehicles remained off the roads during the bandh that began at 7 am. The shops and other business establishments remained closed in several places in the state. No untoward incident, however, was reported from any district.

Congress activists blocked the national highways in various parts of the state, including in the capital city, leading to huge traffic jams. Congress members led by MLA Suresh Routray staged a 'rail roko' at Bhubaneswar railway station.

Air and bus travellers also faced a tough time reaching their destinations due to the unavailability of public

Bijay Kumar Ray, one of the stranded



station .said. "I arrived at the station during wee hours today but failed to get any autos to go to the bus stand. We are waiting for the bandh to end soon so that we would board a Kendrapara-bound bus to go home."

Hundreds of buses and heavy vehicles were lined up on the national highway-16 following the shutdown. Passengers were seen stranded at the railway stations and bus stops. However, emergency vehicles including ambulance, milk van, and marriage party vehicles were allowed.

"Both the Centre and the state government are imposing unreasonable taxes on fuel leading to a steep hike in their prices which in turn lead to an increase in the prices of other essential commodities," said Pradesh Congress Committee (PCC) president Niranjan

He said the Narendra Modi government is not paying heed to the plight of the poor and the middle-class. "I thank the people of Odisha for supporting the bandh," he added.

As vehicles remained off the roads, many government employees pedaled to offices across the state including in Bhubaneswar. The state Congress president himself used a two-wheeler to reach the Congress office here.

The main gates of the Lok Seva Bhavan were closed at 10.15 am to prevent agitators from entering the premises while employees used side gates for entry and exit.

The Congress workers were found involved in a scuffle with the Commissionerate Police at AG square when the later tried to stop them from breaking the barricades. The workers were also engaged in a verbal duel with a commuter at the PMG Square. The glasses of the car were allegedly damaged by the workers.

Some government and private offices in the city were spotted functioning but with a reduced attendance as compared to the normal days. Some vehicles also started plying on the city roads after 11 am.



Fuel prices up for 7th day in a row

New Delhi, Feb 15: Petrol and diesel prices maintained a northward rally Monday, the seventh day in row when the retail prices rose across the country, with oil on the boil in global markets and both crude and product prices seeing a big spike.

Oil marketing companies raised the pump price of diesel by a high level of 29 paise per litre and petrol by another 26 paise per litre in Delhi. With this increase, petrol is now priced at ₹88.99 a litre and diesel ₹79.35 a litre in the national capital. In the last seven days, the price went up by ₹2.06 per litre for petrol while diesel **FUEL PRICES IN CITY** PETROL ₹89.68 (+0.26) DIESEL ₹86.45 (+0.32)

rate has risen by ₹2.56 a litre. Across the country as well the petrol price increase ranged from 23-26 paise per litre and diesel price 28-30 paise per litre depending on the level of local taxes on the two petroleum products.

In Mumbai, petrol price is just ₹4 per litre short (₹95.46 a litre) of touching three digit mark of ₹100 per litre for the very first ever anywhere in the country. Diesel price in the city is closing on ₹90___

Delhi Police looks for Maha lawyer, techie

New Delhi, Feb 15: A Mumbai lawyer and a Beed engineer joined arrested climate activist Disha Ravi in creating a protest toolkit backing the farmers' agitation with the aim of "tarnishing the image of India" and collaborated with pro-Khalistani elements, Delhi Police officials said Monday

Non-bailable warrants have been issued against lawyer Nikita Jacob and engineer Shantanu Muluk. who are absconding. On January 11. 15 days ahead of the Republic Day violence in the national capital, the two attended a Zoom meeting organised by pro-Khalistani group Poetic Justice Foundation, said Joint Commissioner of Police (Cyber) Prem Nath.

The meeting decided the modalities to create the toolkit titled "Global Farmer Strike" and "Global Day of Action, 26 January", Nath said at a press conference.

As the case added layers, polarising views on social media and outside, officials said they are also probing an ISI element through a man called Peter Friedrich whose name is on the document and who is known to be associated with an operative of the organisation.

Ravi, Jacob and Muluk created the toolkit and sent it to others, officials alleged as a fierce political debate broke out between the opposition and and the ruling BJP over the action against 21-year-old Ravi in the case related to the "toolkit Google doc", which came to light when it was shared by global climate campaigner Greta Thunberg.

According to Nath, the email account created by Shantanu is the

"owner" of the Google document and PFJ founder Mo Dhaliwal had contacted them through a Canadabased woman called Punit.

"Disha, Shantanu and Nikita created and edited the toolkit. Disha sent the toolkit to Greta Thunberg through Telegram. Disha deleted a Whatsapp group which she created to spread the toolkit. Due procedure was followed when Disha

was arrested," Nath said. "The toolkit was aimed at tarnishing the image of India," he added and described the toolkit as a dynamic document with hyperlinks to Google docs, "a lot of which are 'pro-Khalistani". The police claimed that Ravi "coaxed" teen activist Thunberg to act on it. Ravi was arrested from Bangalore Saturday and sent to police remand for five days by a Delhi court Sunday with officials claiming she was an editor of the "toolkit Google doc" and "key conspirator" in its formulation and dissemination

4 mid-sized PSBs to be put on block

New Delhi, Feb 15: The government has shortlisted four mid-sized staterun banks for privatisation, under a new push to sell state assets and shore up government revenues, three government sources said.

Privatisation of the banking sector, which is dominated by staterun behemoths with hundreds of thousands of employees, is politically risky because it could put jobs at risk but Prime Minister Narendra Modi's administration aims to make a start with second-tier banks.

The four banks on the shortlist are Bank of Maharashtra, Bank of India, Indian Overseas Bank and the Central Bank of India, two officials


told Reuters on condition of anonymity as the matter is not yet public. Two of those banks will be selected for sale in the 2021/2022 fiscal, the officials said. The shortlist has not previously been reported. The government is considering mid-sized to small banks for

its first round of privatisation to test the waters. In the coming years it could also look at some of the country's bigger banks, they said.

The government, however, will continue to hold a majority stake in India's largest lender State Bank of India, which is seen as a 'strategic

bank' for implementing initiatives such as expanding rural credit. A finance ministry spokesman declined to comment on the matter. India's deepest economic con-

traction on record caused by the pandemic is driving the push for bolder reforms, economists say The government also wants to overhaul a banking sector reeling under_ a heavy load of non-performing assets, which may rise further once banks are allowed to categorise loans that soured during the pandemic as bad. PM Modi's office initially wanted four banks to be put up for sale in the coming fiscal, but officials have advised caution fearing resistance from unions representing the employees

Servitor hurt after being hit by colleague

Puri, Feb 15: The Hastidwar (northern gate) of the Jagannath Temple in Puri had stains of blood Monday after a servitor was attacked by one of his colleagues. The injured servitor has been hospitalized.

Damodar Gochhikar, a 'Jatri Sahayak' servitor, was on duty at the northern gate of the temple Monday. He stopped Ramakrushna Khuntia, a 'Suara' servitor, from entering into the shrine with clay pots known as kudua.

Following the directions issued by the Shree Jagannath Temple Administration (SJTA), Gochhikar stopped Khuntia and asked him to enter the temple from Ashwadwara (southern gate). Thus, the two servitors entered into a verbal duel.



Gochhikar with a 'kudua' on his forehead. Fellow servitors immediately rushed him to the district headquarters hospital (DHH) where he is undergoing treatment.

Sources said the Singhadwar police station has lodged a case and launched a probe. As per the tradition, if blood spills on the temple floor; the servitors perform Maha Snana (the purification of the temple).

WhatsApp may be big, but people value privacy more: SC

New Delhi, Feb 15: People have grave apprehensions on loss of privacy, the Supreme Court said on Monday, making it clear that it is the court's duty to protect this right as it heard an application against WhatsApp's new privacy policy.

The observation came as senior advocate Shyam Divan, representing petitioner Karmanya Singh Sareen, sought direction to restrain WhatsApp from implementing its new privacy policy in India.

"They have come up with new differentiating privacy policy for the Europeans and different set of

rules applicable to Indians," Divan argued. He added that till the time new data protection law comes into force in India, WhatsApp should not bring its new privacy policy. At this, Chief Justice SA Bobde replied: "We will issue notice in the matter."

A bench, headed by the Chief Justice and comprising Justices Bopanna and

Ramasubramanian, told counsel for WhatsApp: "People have grave apprehensions about loss of privacy. You may be 2 or 3 trillion dollar company, but people value their privacy more than your money... we have to protect people's privacy."

The top court issued notice to



WhatsApp and Facebook on this

plea against its new privacy policy. Senior advocates Kapil Sibal and Arvind Datar, appearing for WhatsApp, strongly contested Divan's argument, saying that the Delhi High Court is already seized of the matter.

Sibal said that Europe has a dif-

ferent set of data privacy laws, and WhatsApp's new privacy policy for India is similar to policy applicable in the US, Australia and other countries. "The fact is that this policy is applicable to the rest of the world except Europe.. In Europe, it is different because they have a special law," he argued.

Solicitor General Tushar Mehta, representing the Centre, said the right to privacy is a fundamental right and they cannot compromise

with the privacy of people. Divan cited that WhatsApp has already delayed the implementation of its new privacy policy till May 15 this year and sought a notice which is returnable before this date. The bench said it is impressed with Divan's submission that while the Data Protection Bill is about to be brought into force, WhatsApp is framing a policy to share data. Datar also said that the messages are encrypted end to end. The top court directed WhatsApp and Facebook to file their statement contesting the contentions in the present application.

The Chief Justice told WhatsApp counsel that people think if a message is sent from a person to another and then to a third person, the

whole thing is disclosed to Facebook. As counsel contended that this is not happening, Chief Justice Bobde disagreed, saying that they are telling information heard and read through news reports, and if WhatsĀpp disagrees, it should clarify this on oath.

The top court noted that it will have to consider if a similar petition, pending before the Delhi High Court, is maintainable when the apex court's constitution bench is already seized with the matter wherein WhatsApp's 2016 privacy policy has been challenged. After a detailed hearing in the matter, the top court issued notices to WhatsApp, Facebook and the Centre in the matter and fixed for further hearing after four weeks.



Bhubaneswar, Feb 15: The state government has once again urged the Centre to immediately withdraw the draft heritage bylaws issued by National Monuments Authority (NMA) relating to Shree Ananta Basudev and Shree Brahmeswar temples of Ekamra

This time, Chief Secretary Suresh Chandra Mahapatra has written to Union Culture secretary Raghavendra Singh, Monday Earlier. the Lingaraj Temple Trust Board and Endowment Commissioner have written to the NMA member secretary for immediate withdrawal of the draft bylaws relating to Ekamra Kshetra.

The NMA had published draft notification of heritage bylaws for Puri Srimandir along with Ananta Basudev and Brahmeswar temples of Bhubaneswar. Following a hue and cry, the heritage bylaws related to the Srimandir has been with-



drawn by the NMA

However, the draft notification for Ekamra Kshetra temples are still in force causing distress to the Sevayat community, people at large and devotees, Mahapatra said.

'There have been frequent agitations regarding the non-withdrawal of these draft notifications and there is serious apprehension that this will lead to widespread agitation and disturb the day-to-day rituals in the temples," he said, adding,

on these sensitive temple matters "This kind of atmosphere in temples is bound to hurt the religious sen-

timents of lakhs of devotees." It is important to have a peaceful atmosphere and full cooperation of sevayats for conduct of the upcoming annual Maha Shivarati festival (March 11) when lakhs of devotees from all over the state would congregate, the Chief Secretary said.

 $Therefore, the \, state \, government$ has strongly recommended the

Ananta Basudev temple Union government for immediate withdrawal of the draft bylaws re-

lating to the two city temples.

Mahapatra has also suggested the NMA to have a stakeholder consultation including sevayats, temple administration and the state government on these sensitive temple matters where the living deity and rituals are interlinked.

Meanwhile, political slugfest over the issue continued in the state. BJP leader and Bhubaneswar MP

Aparajita Sarangi said, "The draft bylaws for five monuments have been posted on the website to invite objections/suggestions. If there is any objection, the state government should file objections. What is the meaning of withdrawal of draft bylaws?

She claimed that the heritage bylaws are intended to help the general public by streamlining the norms for taking up reconstruction/renovation activities in the restricted areas

On the allegation that Centre had not taken the state agencies into confidence while preparing the draft bylaws, Sarangi slammed the state government agencies for not taking central agencies like ASI into confidence while taking up the demolition drive in Ekamra

Despite repeated attempt from the ASI and NMA, the state government had refused to share any architectural plan or detailed proj ect report, she alleged.

Centre releases ₹3,584 crore so far to meet GST shortfall

New Delhi, Feb 15: The Union government has so far released ₹3,584.17 crore to Odisha to meet the GST compensation shortfall.

The Centre has also allowed ₹2,858 crore additional borrowings to the state to meet GST compensation shortfall to help them mobilise additional financial resources.


the GST Council. The Finance ministry said that the remaining five states, Arunachal Pradesh, Manipur, Mizoram, Nagaland and Sikkim do not have a gap in revenue on account of GST implementation.

The ministry also said that till now 86 per cent of the total estimated GST compensation shortfall has been released to the states and UTs with legislative assemblies. "Out of this, an amount of ₹86,729.93 crore has been released to the states and ₹8,270.07 crore has been released to the three UTs with legislative assemblies," the Finance ministry said.

Significantly, the Centre had set up a special borrowing window in October this year to meet the estimated shortfall of ₹1.10 lakh crore in revenue arising on account of implementation of GST. The Finance ministry said that the borrowings are being done through this window on behalf of the states and UTs.

'The amount has been borrowed this week at an interest rate of 4.6480 per cent. So far, an amount of ₹95,000 crore has been borrowed by the Central government through the special borrowing window at an average interest rate of 4.7831 per

Bhubaneswar, Feb 15: State's Covid-19 tally mounted to 3.36.262 Monday as 88 more people tested positive for the infection, while one fresh fatality pushed the state's coronavirus death toll to 1,911, a senior Health and Family Welfare (H&FW) department official said.

As many as 51 new cases were reported in quarantine centres, while 37 infections were detected during contact tracing, said the official.

Sundargarh district reported the highest number of new cases at 27, followed by Bargarh (10) and Puri (nine). "Regret to inform the demise of

a 74-year-old male Covid positive patient of Sambalpur district who expired due to cardiogenic shock," the H&FW department tweeted.

The state had reported its previous coronavirus fatality February 8. Fifty-three coronavirus patients

Khurda district, under which Bhubaneswar falls, has so far reported the highest number of fatalities at 336, followed by Ganjam (248) and Sundargarh (173)

The state now has 661 active cases, while 3,33,637 people have recovered from the disease so far.

Odisha has so far tested over 80.43 lakh samples for Covid-19, including 19,839 Sunday.

The H&FW department has extended the Covid vaccination drive till February 25 to ensure 100 per cent coverage of all health workers

in the state. Odisha had achieved 85 per cent vaccination coverage in the first phase till Saturday. As the state failed to achieve 100 per cent Covid-19 vaccination coverage, the Centre extended the deadline for the completion of first dose vaccination of all healthcare workers.

Draconian Step

inally, it has come full circle. A young climate activist, Disha Ravi, is ar- \dashv rested and charged with sedition over accusations that she edited and circulated a Google doc toolkit that was also tweeted by internationally famous climate activist Greta Thunberg about the ongoing protests by farmers in India. This arrest has raised much hue and cry not just in India but also globally. Within India, many social media accounts have jumped out of their skins to support the arrest in Bengaluru by the Delhi police. These account holders most likely would never have worked on Google Docs where hundreds can edit a document across the world simultaneously. Similarly, many of them would not know what 'toolkit' implies. Yet, the charge of sedition against Disha seems acceptable to the faithful.

The manner in which Disha was hounded out of her residence in Bengaluru and whisked away to Delhi by air by the Delhi Police without reportedly following due process of law involving arresting an individual is reminiscent of the dreaded knock on the door for taking a government critic into police custody during the Emergency clamped by Indira Gandhi in 1975. The irony is the BJP-led NDA government, which never misses an opportunity to bash the Congress for trampling civil liberties and perpetrating atrocities on people is now reinventing the horrors of Emergency. The arrest of Disha has all the elements of an authoritarian rule.

Indira is dead and gone. Emergency is history. India had started blossoming as a healthy democracy with a vibrant and growing economy. The Indian youth had started dreaming of becoming the citizen of a nation which was to be considered a world power. The GDP showed signs of a healthy growth and a general sense of happiness had started pervading the atmosphere. The first blot on this outlook was by the former Congress-led UPA government with its intense corruption. People got irritated and not once but twice voted the corrupt Congress out. However, the promises of 'Vikas' or development through unity (sabka saath sabka vikas) first got the deathblow with demonetization in November 2016. Then onwards, all laws enacted, police actions perpetrated and suppression of free speech have started working against that very promise of Vikas. India's foreign policy has got muddled. The latest being international criticism heaped on India due to inept handling of the farmers' agitation. A government that had reached its pinnacle through social media now seems frightened of those very platforms. If Twitter can boldly put forth its point by telling the Government of India 'Let the tweets keep flowing' implies, especially after the fall of Donald Trump that India is being spoken of in the same breath as North Korea or Syria. It could also mean that internationally, the message is out that India is in hot waters, which could be followed by a possible change.

■ Buck up

We use it now to suggest somebody should cheer up, and not be downhearted or oppressed by circumstances. It is a phrase from nineteenth century Britain, derived from those bucks or dandies who were regarded as the acme of snappy dressing in the Regency period. (In its turn, that word came from buck in the sense of the animal, and had a slightly older meaning still that suggested male gaiety or spirit, with unsubtle suggestions of rutting deer.) In its dandyfied sense buck up first meant to dress smartly, for a man to get out of those comfortable old clothes and into something drop-dead gorgeous. Since to do so was often a fillip to the spirit. the phrase shifted sometime around the 1880s to its modern meaning. It seems to have been public school slang to start with, probably from Winchester College, and rather stiff-upper-lip British. It could suggest that the person being addressed should stop acting like a wuss, ninny or coward, as here from Edith Nesbit's The Wouldbegoods of 1901: "Be a man! Buck up!", and was something of a cliché at one time in stories of Englishmen abroad bravely facing adversity. From the early years of the twentieth century, it could also be an injunction on somebody to get a move on or hurry up; here's an example, from D H Lawrence's Sons and Lovers of 1913: " 'Half-past eight!' he said. 'We'd better buck up' ".

■ Bug

The most common version of this story is that bug results from an incident with the US Navy's Harvard Mark II computer soon after the end of World War Two, in which a technician cured a fault by extracting a moth from between the contacts of a relay in the system. It is also said that this was the source of debug, the process of finding and removing errors from a computer programme. The incident really did happen: the log book, dated 9 September 1947, survives with the actual moth taped to it and is available online; that page says it happened in 1945 but recent research shows it actually happened two years later. The log entry itself blows to pieces the story about this being the origin of bug by noting under the insect, "First actual case of bug being found". This makes it clear that bug for a fault was already in use. Indeed, Rear Admiral Grace Hopper (an early programmer who worked on the machine and who inspired the computer language COBOL) used to tell this story in lectures and would remark that the word was applied to problems in radar electronics in World War II. It's actually older still. An early recorded use is in reference to the inventor Thomas Alva Edison and appeared in the Pall Mall Gazette in 1889: "Mr. Edison, I was informed, had been up the two previous nights discovering 'a bug' in his phonograph - an expression for solving a difficulty, and implying that some imaginary insect has secreted itself inside and is causing all the trouble". I've been assured by one of the editors of Edison's papers that the word was commonly used in his notebooks from the 1870s to describe a problem. It seems it wasn't new even with him: an electrical handbook of 1896 suggests it had long been used by telegraphers to suggest that electromechanical glitches were caused by bugs getting into the cables. Debug is also recorded before the moth incident: a writer in the Journal of the Royal Aeronautical Society in 1945 wrote "It ranged from the pre-design development of essential components, through the stage of type test and flight test and 'debugging' right through to later development of the engine."

VOLUNTEERS VS VIGILANTES

THE MODERN STATE CANNOT FUNCTION BASED ON APPEALS TO THE ETHICAL AND MORAL VALUES OF CITIZENS. **IT MUST ADEQUATELY PROVIDE FINANCES THAT CAN FUND VARIOUS SOCIAL SECTOR PROGRAMMES**

n his inaugural address as the 35th President of the United States America on January 20, 1961, John F Kennedy spoke these famous words, "ask not what your country can do for you; ask what you can do for your country". This was the call by a charismatic leader for public action. Kennedy appealed to Americans to think beyond themselves for a larger cause. In India too, we remember the appeal of Prime Minister Lal Bahadur Shastri who appealed to fellow Indians, to give up one meal a week, considering national shortages and food inflation. In response to that appeal, thousands, or millions of Indians indeed spontaneously responded, and to this day there are people who observe a weekly fast, in remembrance of that noble appeal. President APJ Abdul Kalam too launched an anti-corruption movement, especially for the youth, called "What can I give" campaign. This too was an appeal to ethical values, and the spirit of giving, rather than taking. Prime Minister Narendra Modi too often exhorts people of India, to work collectively toward national development, in a spirit of self-sacrifice and volunteerism. One of his well known campaigns was an appeal to give up LPG subsidy, especially by those who can afford to pay full market prices. This was to enable the government to provide up to 80 million free cooking gas connections to households from the lower income strata, providing considerable health benefits and empowerment, especially to women. Rather than depend only on aggregate tax collections to pay for this social scheme, the PM asked his fellow Indians who could afford, to join the enterprise. In fact the scheme also had a feature, which the donor could see where the subsidy that he or she willingly gave up had been directed. In that sense the appeal for donations for COVID relief to the PM Cares Fund too garnered significant amounts. That fund will now be used to pay for the vaccinations, as reported by the Union Health Minister. However, that fund is not subject to scrutiny under the right to information.



Asking citizens to volunteer in the enterprise of national development by making individual sacrifices is one thing. But asking volunteers to secretly spy on fellow citizens, become de-facto vigilantes without any accountability, is quite another

Of course the modern State cannot simply function based on appeals to the ethical and moral values of citizens. It must adequately provide finances that can fund various social sector programmes that are aimed for the benefit of the vulnerable and the downtrodden Philanthropy, charity, sacrifice and volunteerism can coexist, but cannot be at the cost of replacing or re-

ducing the obligation of the State. The State's functions and obligations are even more critical in the areas of law and order. For instance, as the saying goes, "you cannot take the law into your own hands". Nor can the State enlist private citizens to discharge functions that relate to enforcing law and order. This is a very dicey proposition. In Maharashtra there has been an experiment to enlist cleanliness marshals who are authorised to impose a fine on the spot for littering and spitting etc. At the other extreme is the case of Salwa Judum, a private militia deployed for anti-insurgency movement against Naxalites, with the blessing, backing and training by the State. The Supreme Court passed an order in 2011, essentially outlawing the outfit. From cleanliness marshals to private militia is a long road but that road is slippery

It is in this context that one must view and express concern about a recent initiative of the Home Ministry. Its cybercrime cell has started a new programme under which citizens can participate as volunteers to identify, flag and report to the government illegal and unlawful content including child pornography, rape, terrorism, radicalisation and antinational activities. This is a pilot project which is being launched only in Jammu and Kashmir, and Tripura and then may be later extended to other states. This cyber volunteer project is a far cry from the spirit of volunteerism asked by Kennedy. This enlistment can potentially grant extraordinary destructive powers to these socalled cyber volunteers who can become a vigilante force. There seems

to be no accountability for their actions and they can end up being secret police reporting and ratting on the people. Such enlistment takes the notion of a "surveillance state" into a dark territory. It is undoubtedly true that the social media has been excessively infected with hate speech, and speech which can incite violence, bigotry and cause disorder. But it is up to the State to set up mechanisms to regulate content on social media, and indeed this is the way things are evolving in many countries. Also it is up to the State to identify those responsible for criminal offenses on social media and cannot ask volunteers to do this job. Moreover, curtailing hate speech is always a dicey proposition as it should not end up infringing on the fundamental right to free speech. Hence, it cannot be left to private citizens who may have an incentive to wrongfully implicate others.

Another related development is a recent facility launched by the Income Tax department. This allows people to provide a tip-off about undisclosed foreign assets, benami properties or tax evasion. There is now a link on the e-filing portal of the department and it also allows the informer to remain anonymous. A unique complaint number is generated. This too has shades of a surveillance State going down a slippery road. Is it not again a case of the State passing on its function of chasing taxevaders to informers who may be motivated by malice?

Asking citizens to volunteer in the giant enterprise of national development by making individual sacrifices or through positive actions like donations is one thing. But asking volunteers to secretly or anonymously spy on fellow citizens, become de-facto vigilantes and help in law-enforcement without any accountability, is quite another. It will lead to greater distrust and fear. The very foundation of a robustly functioning democracy is a high degree of social capital and trust. Let us not jeopardise that.

"Donald Trump's impeachment" is over and he is acquitted. He is no longer the President. Therefore, the US Senate decided it has no authority to convict him. In a way the whole thing was more of a political drama than an actual trial. The verdict was known before the trial began. It was a strictly party line vote. Seven Republican senators joined their Democratic counterparts; still there was no two-thirds majority to convict Trump. The Democratic majority in the House of Delegates found that Donald Trump as President committed "high crime and misdemeanor". They brought it to the Senate for trial. Very shrewdly. Mitch McConnell. the majority leader put the trial off for a few days. A special election in the state of Georgia was coming up. Any negative comments about the President or the party during the trial could influence the voters negatively. So he bid for time. However, Georgia chose two Democratic senators and McConnell lost his job.

In his explanation to the world, McConnell said after the trial that "Trump is practically and morally responsible for the incitement"

on January 6, 2021. It was the result of his "disgraceful dereliction of duty," he said. Yet, he had not tried to persuade any of his fellow Republicans to vote to convict Trump.

For five consecutive days the drama of impeachment played out on national media. People every where for one more time watched the vivid pictures of the mob attacking the US Capitol. There was plenty of argument from both sides. Finally, when it came to vote against a President who caused all that havoc, it was the need for survival that prevailed.

Right now, Trump is sitting on \$340 million that he can use for any public purpose he wants to. Out of this, \$70 million, left over from his previous election, he can use for his own election or the election of whosoever he chooses. The rest of the money was collected from his supporters who wanted to help him to overturn the election result. He could spend that money any way he wants. Republican senators are afraid that should they vote against him he could set up candidates against them in the primary or could urge his support ers to vote against them. After all,

The American drama of that happened at the US Capitol 74 million Americans voted for not escape the fact that should they Donald Trump. This is a number, higher than what he secured last time, no Republican presidential candidate had ever reached before. Joe Biden got 85 million and beat him because of a meticulous Voters Registration Strategy among the Blacks in the South.

The trial and its result prove that Trump represents a mindset in America that is in danger of fading. Neither science nor reality is able to sustain it. Yet, millions hold on to that mindset because it is convenient and they are used to it. Trump has tapped into their frustration and anger. To coal miners he promised to reopen the closed coal mines. To the idle workers at towns of old steel mills he promised to reopen them. When that could not happen he blamed bureaucrats who nitpicked on everything in the name of law and rules. He accused immigrants and China for the debacles of the rust-belt. Losing their familiar jobs and seeing their small towns rot in neglect, this section of Americans needed to blame somebody for their misfortune. Trump channels their anger for them and they love it. The senators who were to judge Trump, especially from deep red states, could

convict him; they will remain forever guilty in the hearts of their constituents who so overwhelmingly voted for Trump. They could not risk their careers.

The drama of the Donald Trump impeachment shows that democracy is fragile thing. Had Trump had any ally in the American military he would have been the President today. But the military to its credit, remained true to its oath. The House of Delegates did the right thing by accusing him of insurrection and incitement through impeachment. However, the fundamental tenets of democracy, peaceful transfer of power, were never in doubt. Joe Biden became the 46th President of the United States and Trump was dumped into history. There has been no precedence of trial by the Senate of an American President after he left his job. He or she can be tried in a regular court. Yes, there was a riot and four tragic deaths occurred. But the fundamental of the democratic order of the United States was never in any danger.

Contract farming

Sir, Some people advocate that "contract farming" will double farmers' incomes and make them richer. Is this really true? PepsiCo, which produces beverages, also makes potato chips. Usually potatoes are not of same size, but where does PepsiCo get the same size potatoes from? In fact, Pepsi has signed contracts with farmers and is giving them special seeds. Farmers are producing these special potatoes and

can only sell them to PepsiCo. For the past 10 years, farmers in Punjab have been cultivating potatoes through contract farming and selling those potatoes only to Pepsi and the company is making profits. Big farmers say contract farming is good for them, but the small farmers suffer. Private companies want to do business with big farmers, because they have large lands. Due to this big companies do not agree to work with the small farmers because the cost increases due to the small size of their land. The higher the cost, the lower the profit. In such a situation, the big farmers are leasing land from the small farmers and signing contracts with companies. It is clear that small farmers are being affected by "contract farming". There is another problem with small farmers. They buy Pepsi seeds from the market and cultivate potatoes without any contract with the company, but Pepsi does not buy those products because they do not have a contract with



the company. The incident took place with nine farmers in Gujarat. They produced potato crops without a contract and sold them in the market. Pepsi filed a lawsuit against them. Each farmer was fined ₹1 crore. At the same time, the farmers' unions agitated for them and forced Pepsi to roll back. Why did Pepsi do this? "If everyone grows potatoes with their seeds, anyone can buy them, make chips and sell them in the market, and it will hurt Pepsi. It is clear that Pepsi wants to do a monopoly on the market. What does the new agricultural policy formulated by the government say about "contract farming"? If there is a dispute between the company and the farmers in contract farming, the farmers cannot go to court. Everything will be decided in the SDM tribunal. This is where the fear of the peasants lies, for which they are going against the new farm laws. Asit Mohanty, JAJPUR

Urea black marketing ails Bargarh farmers

KNOWN AS THE RICE BOWL OF THE STATE, FARMERS HERE SUFFER DUE TO SHORTAGE OF **UREA DURING THE PEAK PERIOD OF RABI**

POST NEWS NETWORK

Bargarh, Feb 15: Agriculture sector in Bargarh district, which is known as the rice bowl of the state, is always plagued with uncertainty as farmers are hit by scarcity of urea when cultivation works pick up in the district, a report said.

Farmers were found to have completed sowing of seeds and even planting of saplings in many part of the district. However, black marketing of urea by some profit mongering traders has led to an artificial scarcity and hit the farmers hard when they need the fertilizer most to make further progress in their cultivation work. This has pushed the farmers into distress and forced them to buy them buy the fertiliser at an high rate for their cultivation works.

Observers say a packet of urea weighing 45 kg costs Rs 265. However, the profit mongering and unscrupulous traders are selling a packet of urea anything between Rs

Sources said paddy is cultivated on 1,59,000 hectare of land for the Rabi season for which farmers need 24,000 mt of urea fertiliser to raise their crops. However, only 12,000 mt of urea fertiliser has reached the district. The primary agriculture cooperative societies are also facing fertiliser shortage as the district has received less than the required quantity of fertiliser.

Taking advantage of the situation, licenced sellers are allegedly selling the fertiliser to the farmers at a much higher rate than the actual market price.

A farmer Surendra Kathar of

Jamtikra alleged that he purchased a packet of urea fertiliser from a

agriculture officer (CDAO) Dinabandhu Gandhi said an additional 12,000 mt of urea fertiliser is required for the district. However, as regard to black marketing of the fertiliser, his department will investigate the unscrupulous traders. He assured of action if any farmer files a complaint before him regarding black marketing of urea

Here, puppetry survived digital onslaught

Dhenkanal, Feb 15: Puppetry is synonymous with Dhenkanal district. The availability of all sorts of modern forms of entertainment these days notwithstanding, the puppets dancing on string ends are hugely popular. The people's love for this art form is seen to be believed.

There are 14 traditional art forms in Dhenkanal district. String puppet dance is one of them. There are over 18 puppet dance troupes in the district and all of them are active. If this ancient art form is still surviving the onslaught of film, TV, internet, mobile phones and web series, it is due to the tireless efforts of some master performers like Guru Raghunath Pradhan. Sushant Dhal. Nabakishore Dhal. Binay Dhal, Rabi Jena, Gagan Dhal, Bhagirathy Sahu, Braj Dhal and Kailas Jena. They are earning their livelihood from staging puppet shows on a regular basis. They have been in this profession for the last 30 to 40 years.

According to some senior Gurus, 60 years ago, the artistes from Berhampur in Ganjam district would come to Dhenknal district. They would stay here, make puppets and organise shows. Later, the present Gurus who were then youths with little knowl-



edge of puppetry evinced interest to learn the art. Now, they are carrying on the decades-old tradition.

There are four types of puppet shows. They are 'Hand Puppet', 'String Puppet', 'Rod Puppet' and 'Shadow Puppet'. The last form is of puppet show is also known as 'Ravana Chhaya'

Puppet shows do not need an auditorium or a hall. They can be conducted on makeshift stages also. The lifeless wooden puppets measuring between one foot and two feet come alive once they get the touches from their masters. They are made of lightweight wood. One by one, the puppets appear as per the story, mostly a mythological one, and give the audience an engrossing viewing experience. The masters not only give movements to these puppets but also produce different

sounds as per the requirement. This art form, at one point of time regarded as dying art, was given a fresh lease of life in 2011. Thanks to the effort of Chief Minister Naveen Patnaik,

the Zilla, Block and Nagar Kala Sanskruti Sangha were formed to save ancient art forms from dying. And it has made a huge difference to the pup-

According to District Folk Artists Association, vice-chairman, Abani Mishra, the puppet dance of Dhenkanal district has its own identity. "Since 2011, folk art forms and songs are being used for propagating government schemes and programmes. So the puppeteers have been getting some projects and earning their livelihood," he

When contacted, guru Sushant Kumar Dhal of Raidihi village said, "I have been in the profession since 1972. The puppet dance has seen many ups and downs. It has its popularity but it will net fill our stomachs. Our children are not showing interest to carry on the profession as our payments are not encouraging enough. If it receives more patronage from the government, then some may come forward to keep alive the art form.

In this regard, project coordinator, Culture Department, Basudev Malabisoi said, "Puppet dance is one of the popular art forms in the state. It has its own viewership. It is the best medium to carry government's messages to people.'

AYYANNAPATRUDU HAVE FAILED TO SECURE PRESENTABLE RESULTS IN THEIR CONSTITUENCIES

Amaravati, Feb 15: Andhra Pradesh Municipal Administration minister and YSRCP leader Botcha Satyanarayana has claimed that opposition Telugu Desam Party (TDP) is one step closer to obscurity after the recent 'drubbing' in the second phase of the panchayat elections.

"The TDP has lost its relevance in Andhra Pradesh and the polls prove the same," claimed Satyanarayana.

The TDP made light of the claim and said that after the second phase of counting, the TDP had won over 37 per cent of the panchayats.

According to the ruling YSRCP's leaders, even the loyalists of senior TDP leaders such as Ayyannapatrudu have failed to secure presentable results in their constituencies

Yuvajana Sramika Rythu Congress Party (YSRCP) leaders claimed that the TDP managed to win only 26 of the 101 panchayats in Ayyannapatrudu's constituency, compared with YSRCP's 73 victories.

In Icchapuram constituency of TDP MLA B Ashok, the TDP allegedly won just 11 of the 98 panchayats while the ruling party bagged 83 sarpanch posts.

Likewise, in Uravakonda seat represented by TDP MLA P Keshav, YSRCP reportedly won 15 of the 19 panchayats, restricting the TDP to wins on just four sarpanch posts.

In Raptadu, the constituency of former TDP Minister Paritala Sunita, YSRCP leaders claimed they won 45 of the 58 panchayats, relegating TDP to just 12.

Similarly, in Janaganapalle constituency, from where TDP's Bejjam Parthasarathi hails, the ruling party's leaders claimed that teh TDP won just 13 of the 102 panchayats while the YSRCP managed to win as many as 88 of them.

Showcasing the strength of YSRCP, party leaders claimed that the ruling party won 53 of the 67 panchayats in Jaggampeta segment represented by YSRCP leader B Chanti Babu while the TDP al-

legedly managed to win only 14. Vidadala Rajini's Chilakaluripeta constituency, the YSRCP won 34 of the 51 panchayats, compared with TDP's 16 victories.

India's maiden human spaceflight module 'Gaganyaan' will be launched after the second unmanned mission planned in 2022-23, Union Minister Jitendra Singh said last week.

Minister Nirmala Sitharaman has said the first unmanned launch is slated for December this year.



CBI books nine **NTPC officials**

New Delhi: The CBI has registered an FIR against nine former and serving officials of the NTPC for alleged shortfall of cement and steel stock worth over ₹1 crore at its upcoming 4000 MW plant at Lara in Chattisgarh, officials said Monday. According to the National Centre for Seismology, the tremors measured 3.5 on the Richter scale and were felt around 9.23 pm. The epicentre was close to the state capital, at a depth of five km, it said. The tremors were mild enough to go unnoticed by a large section of the population here.

ED arrests Sachin Joshi

Mumbai: The Enforcement Directorate (ED) has arrested Sachin Joshi, an actor-producer hailing from a family having gutka manufacturing business, in connection with a money laundering case against the city-based Omkar Realtors and Developers, officials said Monday. They said Joshi, 37, was arrested under relevant sections of the Prevention of Money Laundering Act (PMLA) Sunday after he was questioned for several hours by the investigating officer of the case.

3 charred to death

According to police, the incident took place at Salaidih situated under Birni police station of Giridih district.

40 YRS ON, BEHMAI VICTIMS STILL AWAIT JUSTICE

Kanpur (Uttar Pradesh) Feb 15: It has been exactly 40 years since 20 villagers were lined up and shot dead by once bandit queen Phoolan Devi in Behmai village.

The incident took place February 14, 1981 and the families of the victims are still awaiting justice even though the main accused Phoolan Devi was shot dead in 2001.

Rajaram Singh, the main witness of the 1981 Behmai massacre and the plaintiff in the case, also died after prolonged illness at Behmai in December last year at the

Rajaram's two younger brothers, Banwari Singh and Himmat Singh, cousin Naresh Singh, nephews Dev Singh, Hukum Singh and Dashrath Singh were among those killed by the Phoolan gang.

"The killing of my husband Lal Singh and 19 others by Phoolan and her gang left us in agony for life. The failure of the system in delivering justice is hurting even more," said Munni Devi, who was just nine-year-old when she had been

"I had never seen my husband as the ritual of 'gauna' was not held by then. My life was completely jolted when the news of Lal Singh's death came. I had lost my parents and was being raised by my siblings. My brothers sent me to Behmai the next day to participate in rituals as a widow," she recalled.

Sumitra, widow of another victim Ram Singh was doing household chores when the gang arrived.

"None of the men at home were spared. My husband and others were asked to stand in a queue. The dacoits then started firing from all sides. People did not have time to run away. Some fell prey to bullets immediately. There were no medical facilities nearby, so many injured died later," said Sumitra.

Among the 20 killed, there were 17 Thakurs, one Muslim, one Dalit and one OBC, while six were injured. The bereaved families got ₹7,500 from the government as compensation. A local court of Kanpur had framed charges in the case in August 2012-- 31 years after the massacre. Out of the 23 accused, 16. including Phoolan Devi, are already dead. Charges were framed

against four surviving accused. while the court issued a non-hailable warrant against three ab sconders--Maan Singh, Ramkesh and Vishwanath.

The special court (dacoity) was scheduled to pronounce verdict in the case in January last year, but it was adjourned several times since the original case diary was found missing from court records and a probe was ordered. As things stand today, no one knows when the verdict will be delivered and there is no word about the missing

Bombay HC refuses to quash FIR against SSR's sister

Mumbai, Feb 15: The Bombay High Court Monday refused to quash an FIR lodged against late actor Sushant Singh Rajput's sister Priyanka Singh for allegedly forging and fabricating a medical prescription for her brother.

A division bench of Justices S S Shinde and M S Karnik, however, quashed the FIR against Meetu Singh, another sister of Rajput.

The court said while there was prima facie evidence against Priyanka Singh, the case against Meetu Singh does not stand. "We are of the considered opinion that the FIR against petitioner Meetu Singh does not survive," the bench said.

"However, the FIR against petitioner Priyanka Singh is not quashed as we prima facie find that a case is made out," the court said. The bench said its judgment shall not cause an impediment for the investigating agency to probe the FIR and submit whatever report it deems fit.

The sisters had approached the HC seeking to quash the First Information Report (FIR) lodged for alleged forgery and fabrication of a medical prescription for their brother for anxiety issues.

The FIR was lodged against Priyanka Singh, Meetu Singh and doctor Tarun Kumar of Delhi's Ram Manohar Lohia Hospital by the Bandra police in Mumbai on September 7 last year, based on a complaint filed by Rajput's girlfriend Rhea Chakraborty. As per the complaint, Rajput's sisters and the doctor prepared a forged and fabricated prescription for antidepressants for the actor a few days before his death. Rajput, 34, was found dead at his home in suburban Bandra on June 14 last year. His father K K Singh later lodged a case of abetment of suicide and cheating against Chakraborty and her family members. The CBI is conducting a

probe into the case.

15 dead as truck overturns in Maha

Jalgaon, Feb 15: Fifteen people were killed and five others injured after a truck carrying labourers overturned and fell into a roadside pit in Maharashtra's Jalgaon district in the wee hours of Monday, police said

The accident took place near a temple in Kingaon village around 1 am when the papaya-laden truck was on its way to Yawal tehsil in Jalgaon from Dhule, an official from Yawal police station said.

The deceased included two children, aged 3 and 5 years, and a 15year-old girl.

A 14-year-old boy, who was sleeping on top of the truck, escaped unhurt, the official said. The labourers belonged to Abhoda, Vivra, Kerhala villages and Raver tehsil in the district, he said.

Prime Minister Narendra Modi expressed grief at the loss of lives. The Maharashtra government announced an ex-gratia of ₹2 lakh to the kin of each of the deceased.

China dismantles shelters at Pangong

India and China are engaged in a nearly 10-month-long military standoff at the LAC

Dehradun, Feb 15: The Chinese People's Liberation Army is finally vacating Finger 4 area on the northern bank of Pangong lake that it had occupied last year and changed the status quo on the Line of Actual Control with India. The Chinese troops are dismantling shelters and removing other structures they had built up during the occupa-

This is happening as per the disengagement agreement between India and China. The agreement states that Chinese troops will move back to Finger 8 and Indian troops will pull back to the Dhan Singh Thapa post between Finger 2 and 3 of the north bank of Pangong lake. Further, there would be a temporary moratorium on military activities, including patrolling in the traditional areas.

The mountain spurs jutting into the lake are referred to as 'Fingers' in military parlance. The north bank of the lake is divided into 8 fingers. India has claimed its territory till Finger 8 and China disputes its claims till Finger 4.

A senior government official said there has been a considerable thinning of troops from Finger 4. The official also said that the PLA is removing its boats from the lake. China has deployed a lot of men and materiel at Finger 4 and south of the lake to alter the status quo at the LAC. Before the tensions last year, boats were deployed beyond Finger

Further, Indian and Chinese troops are also falling back from eveball-to-eveball confrontation positions on the south bank of the lake. On the southern bank of the lake, tanks that were separated by less than 100 metres have been pulled back by both countries' forces.

India and China are engaged in a nearly 10-month-long military standoff at the Line of Actual

Control. The confrontations began on the north bank of Pangong lake, both in the waters and the bank as Chinese incursions increased in early May last year.

The confrontation later spilled over to the southern bank following which the Indian Army occupied crucial heights irking the Chinese that led to incidents of gunshots being fired in the air.

Once complete disengagement is achieved at all friction areas, both sides will undertake de-escalation along the LAC . Hence, India should continue to create military, economic and diplomatic leverages. Besides disengagement and deescalation, India's efforts should be to get the LAC demarcated at the earliest.

The current environment is favourable to expedite the process. In addition, a strategic approach based on active defence and preemption along the LAC should be pursued to protect our territory. This entails identifying the vulnerable spots and keep its forces ready for pre-emptive operations as also effective proactive diplomatic steps to keep China under

Kanhaiya meets Nitish

Patna, Feb 15: Many eyebrows were raised in Bihar Monday as news broke of a meeting between CPI's rising star Kanhaiya Kumar and Ashok Choudhary, a minister and key aide of Chief Minister Nitish Kumar. A fiery former JNU student

leader, Kanhaiya has been soft toward Nitish Kumar despite their parties rarely getting on the same page on most issues. Kanhaiya met Choudhary Sunday. During his failed bid for the Lok Sabha in 2019, the former student leader had avoided attacking Kumar. Kumar had come out in support of Kanhaiya when the JNU controversy erupted in 2016. The JD(U) was then not a part of the BJP-led NDA. The two retained the soft spot for each other even after Nitish Kumar returned to the NDA in 2017.

Choudhary's meeting with Kanhaiya, a staunch communist, came at a time when the charismatic young politician is said to



have been left mortified by a censure motion that the CPI recently passed against him.

Earlier, there had been tensions between the aspiring leader and his party during the Lok Sabha elections when the CPI reportedly insisted that he share a part of money he had raised through crowdfunding.

Sources close to Kanhaiya as well as Choudhary insisted that it was a "non-political" meeting and that both have known each other for long. It has, nonetheless, evoked reactions from those holding strong views on nationalism and against the so-called "tukde tukde gang". Subhash Singh, a state minister

mer JNUSU president a "lunatic" (paagal) and said his meeting with a senior leader of an alliance partner was "not appropriate".

Govt liberalises restrictions on geospatial data for map-making

THE CHANGE IS MADE SPECIFICALLY FOR **INDIAN COMPANIES** THROUGH UPDATING THE CURRENT **GUIDELINES PERTAINING TO DEVELOPING MAP TECHNOLOGIES**

New Delhi, Feb 15: Announcing a sweeping change in India's mapping policy, the Centre on Monday liberalised regulations on geospatial data, making it freely available in the country for innovation and

IT companies. The change is made specifically for Indian companies through updating the current guidelines pertaining to developing map technologies

According to an official statement, the government realised that the existing regime imposed significant restrictions on the mapping industry, from creation to dissemination of maps, requiring Indian companies to seek licences and follow a cumbersome system of pre-approvals and permissions.

Compliance with these regulatory restrictions has subjected startups in India to red tape, hindering Indian innovation in map technologies for decades, it said. The Union Science and Technology Ministry, while announcing the new guidelines, said that it will



greatly enhance the preparedness of the country for emergency response

"With the new guidelines, individuals, companies, organisations, and government agencies shall be free to process the acquired geospa-

tial data, build applications, and develop solutions in relation to such data and use such data products, applications, and solutions by way of selling, distributing, sharing, swapping, disseminating, publishing,," it said. However, self-certifica-

tion will be used to convey adherence to these guidelines, it added.

Union Science and Technology Minister Harsh Vardhan said that the move will help drive efficiencies in agriculture and emergency-response capabilities while also facilitating rise of new-age indus-

The availability of comprehensive, highly accurate, granular, and constantly updated representation of geospatial data will significantly benefit diverse sectors of the economv and will significantly boost innovation in the country and greatly enhance the preparedness of the country for emergency response," he added.

The ministry also stated that the policy change is aligned to the vision of "Atmanirbhar Bharat" to achieve a \$5 trillion economy.

Science and Technology Secretary, Professor Ashutosh Sharma, said that increased participation of the private sector will augment the growth of new technologies, platforms and application of geospatial data contributing to the country's progress. However, the government has put in place a few new rules to function. Sharma said that there is restriction on revealing the attributes or features of sensitive areas even though there would be none on surveying the area itself.

"The data is not for access, but only 🗦 for surveying," he added.

Similarly, terrestrial mapping and surveying will be allowed only by Indian entities. The data generated from such processes can be owned only by Indians. Foreignplayers can licence the information but not own it.

Washington: The total number of global coronavirus cases has topped 108.7 million, while the deaths have surged to more than 2.39 million, according to the Johns Hopkins University. In its latest update Monday morning, the University's Center for Systems Science and Engineering (CSSE) revealed that the current global caseload and death toll stood at 108,788,324 and 2,399,330, respectively. The US is the worst-hit country with the world's highest number of cases and deaths.

Support grows for Capitol riot inquiry after Trump acquittal

Washington, Feb 15: A day after former President Donald Trump won his second Senate impeachment trial, bipartisan support appeared to be growing for an independent September 11-style commission into the deadly insurrection that took place at the Capitol.

Investigations into the riot were already planned, with Senate hearings scheduled later this month in the Senate Rules Committee. House Speaker Nancy Pelosi, D-Calif., has asked retired Army Lt. Gen. Russel Honoré to lead an immediate review of the Capitol's security process.

Lawmakers from both parties, speaking on Sunday's news shows, signaled that even more inquiries were likely. The Senate verdict Saturday, with its 57-43 majority falling 10 votes short of the twothirds needed to convict Trump, hardly put to rest the debate about the former president's culpability

'There should be a complete investigation about what happened,' said Louisiana Sen. Bill Cassidy one of seven Republicans who voted to convict Trump. "What was known, who knew it and when they knew, all that, because that builds the basis so this never happens again.'

An independent commission along the lines of the one that investigated the September 11 attacks would probably require legislation to create. That would elevate the investigation a step higher, offering a definitive government-backed accounting of events. Pelosi has expressed support for such a commission.

There's still more evidence that the American people need and deserve to hear and a 9/11 commission is a way to make sure that we secure the Capitol going forward," said Sen. Chris Coons, D-Del., a Biden ally. "And that we lay bare the record of just how responsible and how abjectly violating of his constitutional oath President Trump really was.

House prosecutors who argued for Trump's conviction of inciting the riot said Sunday they had proved their case. They also railed against the Senate's Republican leader, Mitch McConnell, and others who they said were "trying to have it both ways" in finding the former President not guilty but criticiz-

Impeachment isn't the final word for Trump

Donald Trump's acquittal at his second impeachment trial may not be the final word on whether he's to blame for the deadly Capitol riot. The next step for the former president could be the courts. Now a private citizen. Trump is stripped of his protection from legal liability that the presidency gave him. That change in status is something that even Republicans who voted on Saturday to acquit of inciting the January 6 attack are stressing as they urge Americans to move on from impeach ment, "President Trump is still liable for everything he did while he was in office, as an ordinary citizen, unless the statute of limitations has run," Senate Minority Leader Mitch McConnell of Kentucky said after that vote. He insisted that the courts were a more appropriate venue to hold Trump accountable than a Senate trial. "He didn't get away with any thing yet," McConnell said. "Yet." Trump also faces legal exposure in Georgia over an alleged pressure campaign on state election officials and in Manhattan over hush-money.

UK PM under pressure to lift COVID lockdown

London, Feb 15: British Prime Minister Boris Johnson is under mounting pressure to lift all COVID-19 lockdowns in two and a half months as lockdown-sceptic Tories called on him to commit to a timetable for easing the restrictions with a complete end to controls by the end of April.

In a letter to the prime minister, leaders of the Covid Recovery Group (CRG) said the "tremendous pace" of the vaccination rollout means restrictions in England should begin easing from early March, the a local newspaper reported Sunday.

They said ministers must produce a cost-benefit analysis to justify any controls that remain in place after that date, with a "roadmap" stating when they would be removed. COVID conspiracy shows vast reach of Chinese disinformation

IT TOOK JUST THREE MONTHS FOR THE RUMOUR THAT COVID-19 WAS ENGINEERED AS A BIOWEAPON TO SPREAD FROM THE FRINGES OF THE CHINESE INTERNET AND TAKE ROOT IN MILLIONS OF PEOPLE'S MINDS

Brussels, Feb 15: It took just three months for the rumour that COVID-19 was engineered as a bioweapon to spread from the fringes of the Chinese Internet and take root in millions of people's minds.

By March 2020, belief that the virus had been human-made and possibly weaponised was widespread, multiple surveys indicated.

The Pew Research Center found, for example, that one in three Americans believed the new coronavirus had been created in a lab; one in four thought it had been engineered intentionally.

This chaos was, at least in part, manufactured.

Powerful forces, from Beijing and Washington to Moscow and Tehran, have battled to control the

narrative about where the virus came from. Leading officials and allied media in all four countries functioned as super-spreaders of disinformation, using their stature to sow doubt and amplify politically expedient conspiracies already in circulation, a nine-month Associated Press investigation of state-sponsored disinformation conducted in collaboration with the Atlantic Council's Digital Forensic Research Lab found.

The analysis was based on a review of millions of social media postings and articles on Twitter. Facebook, VK, Weibo, WeChat, YouTube, Telegram, and other plat-

As the pandemic swept the world, it was China - not Russia - that took the lead in spreading foreign disinformation about COVID-19's



Beijing was reacting to weeks of fiery rhetoric from leading US

Republicans, including then-

President Donald Trump, who sought to rebrand COVID-19 as "the China virus.

China's Ministry of Foreign

Affairs says Beijing has worked to promote friendship and serve facts, while defending itself against hostile forces seeking to politicize the

"All parties should firmly say no to the dissemination of disinformation," the ministry said in a statement to AP, but added, "In the face of trumped-up charges, it is justified and proper to bust lies and clarify rumors by setting out the facts."

The day after the World Health Organization designated the COVID-19 outbreak a pandemic, Zhao Lijian, a spokesman for China's Ministry of Foreign Affairs, shot off a series of latenight tweets that launched what may be the party's first truly global digital experiment with overt disinformation.

"When did patient zero begin in

US?" Zhao tweeted March 12. "How many people are infected? What are the names of the hospitals? It might be US army who brought the epidemic to Wuhan. Be transparent! Make public your data! US owe (sic) us an explanation!"

What happened next showcases the power of China's global messaging machine.

On Twitter alone, Zhao's aggressive spray of 11 tweets March 12 and 13 was cited over 99,000 times over the next six weeks, in at least 54 languages, according to analysis conducted by DFRLab.

The accounts that referenced him had nearly 275 million followers on Twitter - a number that almost certainly includes duplicate followers and does not distinguish fake accounts.

Exports rise 6.16% in Jan; trade deficit narrows to \$14.54bn

New Delhi, Feb 15: Growing for the second consecutive month, the country's exports rose 6.16 per cent year-on-year to USD 27.45 billion in January 2021 following healthy growth in pharma and engineering sectors, according to provisional data of the commerce ministry.

Trade deficit during the month narrowed to USD 14.54 billion from USD 15.3 billion in January 2020. It was USD 15.44 billion in December 2020. Imports in January 2021 rose 2 per cent to USD 42 billion.

Exports of pharmaceuticals and engineering grew 16.4 per cent (USD 2 billion), and about 19 per cent (USD 7.4 billion), respectively, the data showed.

Other sectors which recorded growth included oil meals, iron ore, tobacco, rice, fruits and vegetables, carpets, handicrafts, spices,

tea, cashew, plastic and chemicals. Export sectors which recorded negative growth included petroleum products (-32 per cent), readymade garments of all textiles (-10.73 per cent), and leather (-18.6 per cent).

In December 2020, the country's merchandise exports had recorded a growth of 0.14 per cent.

States' fiscal deficit to narrow to 4.3% of GDP

Mumbai: The aggregate fiscal deficit of states is likely to be at 4.3% of the gross domestic product (GDP) in 2021-22 compared to 4.6% in 2020-21, says a report by India Ratings and Research. The rating agency has revised the outlook on state finances to stable for FY22 from stable-to-negative. "We expect the aggregate fiscal deficit of states for FY22 to come in at 4.3% of the GDP compared to 4.6% (revised) in FY21," the agency said in a report. It had earlier forecast FY21 fiscal deficit of states to be at 4.5% but revised it later due to a sharper-than-expected contraction of 6.1% yo-y in the nominal GDP. The agency estimates the nominal GDP to grow 14.5% in FY22, and believes a gradual pick-up in revenue collections could lead to an improvement in the capital expenditure from FY22. The report said due to the economic downturn, even the union government finances are under pressure, leading to a lower-than-budgeted devolution of ₹5.50 lakh crore to states in FY21 (revised estimate: RE) as against the budget estimate (BE) of ₹8.03 lakh crore.

WPI inflation rises to 2.03% in January

New Delhi, Feb 15: The wholesale price-based inflation rose sharply to 2.03% in January on costlier non-food manufactured items and experts are projecting further uptick in the rate of price rise in the next few months. The WPI inflation was 1.22% in December, 2020 and 3.52% in January last year.

While food articles saw softening in inflation, the sharp rise in the WPI inflation in January was led by manufactured non-food products, fuel and power, and crude petroleum and natural gas, data released by the Commerce and Industry ministry showed Monday.

Food inflation in January stood at (-) 2.8%, against (-) 1.11% in the previous month. In vegetables and potatoes, it was (-) 20.82 per cent and 22.04% respectively.

Core inflation rose to a 27-month high of 5.1% in January 2021.

In non-food articles, inflation was higher at 4.16%, while in the fuel and power basket it was (-) 4.78%, during the month under review. ICRA Principal Economist Aditi Nayar said a deeper disinflation in primary food articles helped to cushion the impact of the sharp rise in core inflation.

Rising demand and strengthening pricing power will make core inflation rise further to as much as 7-7.5% during April-June quarter, according to ICRA.



'AMAZON HAD ASKED FOR \$40MN AS COMPENSATION'

New Delhi, Feb 15: Amazon had asked for USD 40 million (around ₹290.41 crore) in compensation from Future Group for the deal with Reliance Industries, and Amazon's claim of not being informed of the deal is incorrect, documents submitted to the emergency arbitrator of SIAC by the Kishore Biyani-led firm said.

According to the submission by Future Group in October last year, Amazon was well aware of Future's

₹24,713 crore deal with RIL. "In August 2020, two phone calls among the 3rd respondent (Kishore Biyani) and 8th respondent (Rakesh Biyani) and Abhijit Mujumdar on behalf of the claimant (Amazon.com NV Investment Holdings LLC), the claimant asked for USD 40 million as compensation in exchange for the Future Group and Reliance proceedings with the disputed transaction," the document said



It further stated that "the claimant's contention in the NOA and the application that it did not have any information in connection with the disputed transaction is incorrect".

The document - dated October 12, 2020 - also noted Future Retail had made a public announcement on August 29, 2020, about the deal "after having informed the claimant's representatives that discussions were ongoing with Reliance".

"So, leaving aside the messages,

calls and e-mails referred... the claimant was aware of the disputed transaction for more than a month before it initiated the present arbitration proceedings," Future said in its submission, a copy of which was seen by PTI. Amazon did not respond to e-mailed queries seeking comments on the matter. On August 29, 2020, Future Group had announced that its retail and wholesale business would be sold to Reliance Retail. owned by oil-to-chemical conglomerate RIL in a ₹24,713 crore deal.

variants in the next five years. With the company pushing for electrification of its vehicles, the company will also undergo reorganisation of its manufacturing units as a result of which its plant

at Castle Bromwich would be repurposed in future although it will continue to produce the existing vehicles till the end of respective lifecycles.

"As a proud member of the Tata ecosystem, with its industrial strength and worldwide standing, we are something truly unique at Jaguar Land Rover. Truly unique in the automotive industry. And now is the time to realise its potential," Bolloré said while addressing a virtual conference.

Jaguar Land Rover's aim is to achieve net zero carbon emissions across its supply chain, products and operations by 2039, he added.

Commenting on JLR's plans, Tata Sons Chairman N Chandrasekaran said, "The Reimagine strategy takes Jaguar Land Rover on a significant path of acceleration in harmony with the vision and sustainability



priorities of the wider Tata Group." Chandrasekaran, who is also the chairman of Tata Motors and Jaguar Land Rover Automotive plc, further said, "Together, we will help Jaguar realise its potential, reinforce

Land Rover's timeless appeal and col-

lectively become a symbol of a truly responsible business for its customers, society and the planet."

As part of this ambition, the company is also preparing for the expected adoption of clean fuel-cell power in line with the maturing of From 2025 Jaguar will become an all-electric luxury brand to 'realise its unique potential', the company said

the hydrogen economy.

Development is already underway with prototypes arriving on UK roads within the next 12 months as part of the long-term investment programme.

Bolloré said at the heart of JLR's 'Reimagine' plan will be the electrification of both Land Rover and Jaguar brands on separate architectures with two clear, unique personalities.

Under the plan, Land Rover will use the forthcoming flex Modular Longitudinal Architecture (MLA).

It will deliver electrified internal combustion engines (ICE) and full electric variants in the future.

In addition, Land Rover will also use pure electric biased Electric Modular Architecture (EMA) which will also support advanced electrified ICE. On the other hand, future Jaguar models will be built exclusively on a pure electric architecture, the company said.

In the next five years, Land Rover will have six pure electric variants of its luxury SUVs of three families of Range Rover, Discovery and Defender. The first all-electric variant will arrive in 2024, the company said. From 2025 Jaguar will become an all-electric luxury brand to 'realise its unique potential', the company said, adding the planned Jaguar XJ replacement will notform part of the line-up although the nameplate may be retained".
