It's official: Maha into 2nd Covid wave

New Delhi: Maharashtra is in the beginning of second Covid-19 wave, a central report has said, highlighting that there is limited active effort to track, test, isolate cases, and there is no adherence to Covid appropriate behaviour. Based on the report, Union Health Secretary Rajesh Bhushan wrote to the state government, stating "measures such as night curfews, weekend lockdowns etc. Have very limited impact on containing/suppressing the transmission" and urged the state to focus on strict containment strategies strengthening surveillance and augmenting testing.

Top PM aide quits

New Delhi: Former Cabinet Secretary and Principal Advisor in the Prime Minister's Office (PMO) PK Sinha, has resigned from his post on personal grounds. Sources said the retired 1977-batch IAS officer of the Uttar Pradesh cadre put in his papers Monday evening. Sinha was appointed in the PMO in September 2019 following the general elections, after he retired as the Cabinet Secretary. The veteran former bureaucrat was earlier made the Officer on Special Duty in the PMO August 30, 2019 after Modi accepted the request of his Principal Secretary Nripendra Misra to be relieved from the post.

35K acres Jagannath land to be sold out

Bhubaneswar, March 16: The state government has initiated a process to sell 35,272 acres of land belonging to Lord Jagannath, in Odisha and six other states, Law Minister Pratap Jena told Assembly, Tuesday.

Giving a written reply to a question of BJP lawmaker Mohan Charan Majhi, Jena said as per the recommendations of a committee formed under the chairmanship of then Governor BD Sharma, the government is taking necessary steps to sell 35,272.235 acres of land properties of the temple. Jena said Lord Jagannath owns

60,426.943 acres spread over 24 of the 30 districts of Odisha. Out of which, the temple administration could prepare final Record of Rights (RoR) over 34,876.983 acres. "In accordance with the recommendation of the commission, steps are being taken to sell out the land as per state government's approved Uniform Policy (Saman Niti), the minister told Assembly. Meanwhile, the government has al-

ready sold out 315.337 acres of Jagannath's land including Bharati Matha building in Cuttack city and ₹11.20 crore earned from the land sale has been deposited in the temple corpus fund, the minister said. Similarly, steps are being taken to sell

395.252 acre of land identified in six states outside Odisha. The government has written to the concern District Collectors in this purpose, he said. Sources said the 12th-century tem-

ple has maximum of 322.930 acre in West Bengal followed by 28 218 acre in Maharashtra, 25,110 acre in Madhya



Pradesh, 17.020 acre in Andhra Pradesh, 1.700 acre in Chhattisgarh and 0,274 acre in Bihar. The minister further said about 100 acre has been identified at Bagha area and the government is collecting share amount of paddy each year from the sharecroppers. A Khamari has been engaged at Bagha in this purpose while another Khamari has been engaged at Dochhian to take care of land properties located in the area, he said, adding, paddy collected from the Dochhian area is also sold each year.

Besides, 582.255 acres located in Khurda have been given to Odisha Cashew Development Corporation

(OCDC) on a lease basis. In return, the government is getting ₹3 lakh from the corporation each year, the minister added

According to sources, people who have occupied Srimandir land for more than 30 years would have to pay ₹6 lakh per acre to take the temple land in possession. Those who have acquired Srimandir land for less than 30 years but more than 20 years would have to pay ₹9 lakh per acre to purchase the plots.

Besides, individuals who have occupied the temple plots for less than 20 years but more than 12 years would have to pay a hefty sum of ₹15 lakh per acre, the source said.

The law minister further said the state government has constituted four commissions to bring reforms and probe various incidents related to the Jagannath temple. The panels are-justice BK Patra Commission, a committee headed by BD Sharma, Justice PK Mohanty Commission and Justice BP Das Commission. To implement various recommendations made by the commissions, a committee has been constituted under the chairmanship of temple chief administrator following the approval of the Shree Jagannath Temple Managing Committee, he added.

₹10cr lost as smart signal project fails

Bhubaneswar, March 16: The capital city projected itself as an ultra 'smart city' in the country ahead of the Hockey World Cup 2018. Fast forward to 2021, a slew of ambitious projects launched then are lying waste now.

Among the many projects launched by the Bhubaneswar Smart City Limited (BSCL) was the Adaptive Traffic Signal Control (ATSC) that indicates how public funds should not be utilized. As per an RTI inquiry by Odisha Soochna Adhikar Abhijan, the BSCL received Rs700 crore from the Centre and the state government to develop the smart city here.

With an aim to efficiently manage the rising traffic in the City, ATSCs were erected at 50 junctions to optimise the traffic flow by dynamically changing the signal timings. As per the RTI, the BSCL spent about Rs. 10 crore on the project.

"The number of vehicles has increased dramatically in the city and so have the gridlocks. ATSCs are there at selected places only. Peak rush hours see huge congestions in Rasulgarh.



Market Building and Bomikhal areas that don't have ATSCs. As it heavily relies on manpower, absences of traffic cops sees people ignoring the system," observed Smruti Ranjan Patnaik, an urban planner here. Moreover, the project

brought in about 14 pelican signals and five blinkers at different locations to ensure road safety. Pelican signals are manually-controlled signals that give pedestrians a duration of 15 seconds by turning the traffic lights red to cross the roads safely. Blinkers were to help commuters to be cautious while manoeuvring important junctions

Thanks to poor awareness and lack of enforcement, the initiative has turned out be a complete failure. Put up at key locations like RD College, Press Club Road, KIIT School and Sum Hospital, the riders give two hoots to traffic lights even if they turn red.

Your SMSes are up for grabs at just ₹1,160

New Delhi, March 16: In what could put smartphone users at a new privacy and security risk, text-messaging management services are now being misused for as little as ₹1,160 (nearly \$16) to covertly redirect text messages from users to hackers, giving cybercriminals access to two-factor codes/login SMSes.

The invisible cyber-attack on companies providing SMS redirection services is being carried out in connivance with workers at telecom companies, reports Motherboard. "The method of at-



tack, which has not been previously reported or demonstrated in detail, has implications for cybercrime, where criminals often take over target's phone numbers in order to harass them, drain their bank account, or otherwise tear through their digital lives," the report said late on Monday.

Using these services, attackers are not only able to intercept incoming text messages, but they can reply as well. "It's not hard to see the enormous threat to safety and security this kind of attack poses." US Senator Ron Wyden said in a statement. There are several other methods to exploit the SMS services and SIM swapping is one of those. But with SIM swapping, it's easy to find out that you are under attack asvour device will be disconnected from the cellular network.

22 of world's 30 most polluted cities are in India: Report

DELHI RANKS THE MOST POLLUTED CAPITAL CITY GLOBALLY WHILE GHAZIABAD THE SECOND MOST POLLUTED IN THE WORLD FOLLOWED BY BULANDSHAHAR

New Delhi, March 16: Twenty-

two of the world's 30 most polluted cities are in India, with Delhi being ranked as the most polluted capital city globally, a new report said Tuesday. The report is prepared by Swiss organisation, IQAir, in the form of the 'World Air Quality Report, 2020', which has released globally.

The report, however, shows that Delhi's air quality improved by approximately 15 per cent from 2019 to 2020. It said that despite the improvement, Delhi ranked as the 10th most polluted city and the top



polluted capital city in the world.

"India continues to feature prominently at the top of the most polluted cities ranking, with 22 of the top 30 most polluted cities globally," the report said.

Besides Delhi, the 21 other Indian cities among the 30 most polluted

cities in the world are Ghaziabad, Bulandshahar, Bisrakh Jalalpur, Noida, Greater Noida, Kanpur, Lucknow, Meerut, Agra and Muzaffarnagar in Uttar Pradesh, Bhiwari in Rajasthan, Faridabad, Jind, Hisar, Fatehabad, Bandhwari, Gurugram, Yamuna Nagar, Rohtak and Dharuhera in Haryana, and Muzaffarpur in Bihar.

As per the report, the top most polluted city is Xinjiang in China followed by nine Indian cities. Ghaziabad is the second most polluted city in the world followed by Bulandshahar, Bisrakh Jalalpur, Noida, Greater Noida, Kanpur, Lucknow and Bhiwari.

The global cities ranking report is based on PM2.5 data from 106 countries, which is measured by ground-based monitoring stations, most of which is operated by government agencies. The report also reveals the impact of COVID-19 lockdown and behavioural changes on global particulate pollution (PM2.5) levels.

Major sources of India's air pollution include transportation, biomass burning for cooking, electricity generation, industry, construction, waste burning and episodic agricultural burning. "The transportation sector is one of the major contributors to India's lead-

cities," the report said. Contextualising the global IQAir report in the Indian context, Avinash Chanchal, Climate Campaigner at Greenpeace India said while many cities, including Delhi, have recorded

ing PM2.5 emission sources across

marginal improvements in air quality due to lockdowns, the health and economic cost of air pollution remains severe. He said it is pertinent that governments prioritise sustainable and clean energy sources, as well as the cities, need to encourage low cost,

active and carbon-neutral mobility choices such as walking, cycling, and accessible public transport.





Din over paddy continues for 4th day

Bhubaneswar, March 16: Even after an all-party meeting convened by the Speaker twice, stalemate continued in the Assembly for the fourth consecutive day Tuesday. The House witnessed several adjournments and no business could take place throughout the day.

Janla case: Cops receive sketch of dead lady's face

Bhubaneswar, March 16: The Commissionerate Police Tuesday received a preliminary sketch of the face of an unknown woman whose skeleton was recovered from a seized SUV on the premises of Janla police outpost in February. Speaking to the media, Bhubaneswar DCP Umashankar Dash said that a software firm in Hyderabad has sent a rough sketch which will be examined by the cops before making it public.

The human skeleton's images had been sent to Hyderabad for skull mapping. Experts of a software company will reconstruct the face of the lady using artificial intelli-

gence (AI) for identification of the deceased. He also said that after finalization, the sketch will be pasted outside all the police stations in the city urging the public to verify the identity of the dead woman.

Similarly, the police Tuesday recorded the statements of several people including the doctor who conducted autopsy of the skeleton and suspended OIC of Janla outpost, Satyabrata Grahacharya. Dash also revealed that the police will interrogate the persons who have visited the outpost since November 2019. He assured that police have been taking all the steps to get the identity of the lady and the circumstances that led her to get into the vehicle.

Achyuta Samanta, who was born to a poor family, is now one of the biggest social entrepreneurs globally. His life story is an inspiration to all. He dedicated himself to the cause of upliftment of the poor. He is also the founder of Kalinga Institute of Industrial Technology (KIIT) and Kalinga Institute of Social Sciences (KISS), Odisha, and has been working relentlessly for zero poverty, zero hunger and zero illiteracy. During an interaction with **Orissa POST**, KIIT-KISS founder **Achyuta Samanta** shared several glimpses of his journey. Excerpts...

■ Education is everything to all of us. In present days, a child can't do anything without education even though he/she has two eyes. I am the best example of the said statement. I was born to a very poor family but what I am now is because of education. It's because of and education that the world can see me and so can I.

■ Why are we lagging behind in educational research and innovation as compared to other parts of the

■ Education is really the backbone of a society. When we see Europe and USA, there are universities that are much older like 1,000 or 700 years old. But in India, we have only 150-year-old universities. I believe the countries or states which have developed their educational facilities have developed themselves. These counties have strong facilities for research and innovation because they have established their strong education system. However, at present, our country and Odisha have been focusing on education.

■ How was concept of KIIT and KISS

■ Well, it is a long story. I started both the organisations - KIIT and KISS in a rented house in 1992-93. So, in a sense it was a 'startup' venture with a capital of just Rs 5,000. When I started these organisations, I was much worse than a beggar. Now, they have reached milestones and garnered appreciations from across the world. This is nothing but God's blessings, for what we are now! Success of KIIT and KIIS is because of my hard work and sacrifice.

■ You lost your father at a tender age but now you're the 'father' of over 60,000 tribal kids. How do you

express your feelings?

■ It is actually satisfying. When I lost my father, there was no one to take care. comfort, encourage or guide me. I had decided to offer that kind of support, that I never received, to poor children. And now the vision has come true. It is more satisfying and joyful experience

■ Have you planned for expanding

See, about one-fourth of the tribal population of our state are majorly inhabited in 20 districts. I have a passion to bring tribal children into the mainstream through education. To accomplish that vision, we are opening KISS branches in the state. We have already opened branches in five districts and it is likely to be opened seven more districts this year. I wish to open such branches in these 20 districts.

■ You hail from a remote village in Cuttack but now the world knows you. What is the mantra of your suc-



PANDEMIC HAS HIT ALL STAKEHOLDERS IN AUTO INDUSTRY HARD: PARIKH

The Covid-19 pandemic has hit the automobile industry hard. Now, people involved with this industry are looking forward to revival and growth. While the Centre's Scrappage Policy has given this industry a ray of hope, high taxes hinder growth. In an interview with

Orissa POST, Shaunak Raj Parikh, Director of Utkal Automobiles *Private Limited, talks about how the pandemic hit the automobile* industry and what they plan to do ahead. Excerpts:

■ What impact did COVID-19 have on your

COVID-19 impacted all the stakeholders in the value chain, such as suppliers, OEMs, dealers/distributors, mobility & online players. The Indian automotive industry suffered losses worth more than Rs 2,300 crore per day during the prolonged lockdown period. Job loss in the sector is estimated to be about 3.45 lakh. Besides. 286 auto dealers had to shut shops. Revenue generation in Odisha dropped to 58% in motor vehicle tax collection in the first quarter of 2020. Impact on dealers was - blockage of working capital in BS-IV inventory, potential decline in BS-IV sales as it was expected to pick up in March, delay in production and availability of BS-VI models led to further decline, drop in automotive demand due to price increase for BS-VI transition.

■ What is your view on buying behaviour of customers in Odisha?

Consumer behaviour has been evolving. The number of visits to brick-andmortar dealerships has dropped. Digital media is playing an increasingly important role in determining purchase decisions of customers. Consumers today are researching online before purchasing a vehicle, even in smaller cities and towns. Behaviour of customers in Odisha is digitally driven.

■ How would you differentiate Utkal Hyundai in terms of service? What do you offer the customers?

Our offers are always in line with Hyundai guidelines. Offers do change from month to month depending on a lot of factors like availability of stock, schemes offered by competitors etc.

■ Automobile industry facing various problems. Demands have also muted. What should the govt do to help the auto industry?

■ Scrappage Policy: The Central government has been talking about the scrappage policy which I feel, if rolled out, will help generate demand.

High rate of taxation: Affordability has become one of the main hindrances in the growth of automobile sector in India. Prices have increased due to several factors like upgradation of safety and emission standards (Bharat Stage-VI emission norms), high rate of taxations like GST-28%, cess imposed on cars from 3% up to 48%, TCS-1%, state road and registration tax etc. All factors cited above are driving up the costs of automobiles which need to be addressed carefully.

■ Automobile dealers play an important role in providing jobs as well as revenue to the government. What do you want from state government in this regard?

■ The automobile industry is one of the largest employment providers in the country and employs close to 37 million people across the country. But due to the pandemic situation it is not only unable to generate employment, but also raising questions on the sustainability of dealership itself. State government's role has a lot more to do with the cost of operating an industry. The taxation of the state government is quite high, petrol tax for example is much higher and the affordability of a car is very much de-



grows. There are some states like Jharkhand & Gujarat and Union Territory like Chandigarh where road taxes are calculated before GST. However, other states, including Odisha, calculate road taxes on exshowroom price, resulting in the increase of vehicle cost which affects the ability of customers to buy new vehicles, leading to drop in sales. In reference to above, sales were much higher in these states compared to those which didn't increase road taxes. Our state government should look into this

■ What motivated you to step into automobile dealership business?

■ I was born and brought up in a family running an automobiles business. This business is inherent in my blood. Apart from that, this industry deals with an array aspects, knowledge and experience that motivated me to come in this business

■ What is your view on success? Any

advice to the youth? ■ The meaning of success varies from one person to another. It could be career, title, money, big house, stable relationships, social status etc. Success doesn't come overnight. It needs a dream that won't let you sleep, a clear vision that you have to focus on, hard work that you have to do even if you feel exhausted, consistency that takes courage & honesty that should last forever even if everyone is against you. What matters in the end is how happy you are. My message to the youth is choose a career that makes you happy and for which you can devote yourself for the rest of your life. Don't avoid something because it is seen as unacceptable. Do whatever pleases you.

Villagers draw lots to get drinking water

Chhatrapur, March 16: Have you ever heard of lots being drawn to decide who will go home with a pitcher full of drinking water? Strange as it may sound, it does happen. This rule is followed at Station Road Sahi village in Chhatrapur of Ganjam district. It is bizarre as Chhatrapur town is the district headquarters.

There are 20 to 25 families residing in Station Road Sahi village, which suffers from lack of drinking water with the advent of every

For the residents, it is a matter of great regret that their village has only tap delivering water. What is more appalling is that water is supplied only for 15 minutes in an en-



Initially, the villagers would fight with each other to get a pitcher full of drinking water. This constant quarrelling led to the evolvement f the lottery system.

Every day the lots are drawn. When the tap delivers water, the person with the No.1 token gets the first chance to fill up his vessel. Then tokens 2, 3, 4 and 5 follow in sequence to get water. By the time the fifth person reaches the tap, the flow of water turns into a trickle and finally stops. So the others have to return empty-handed.

Sushama Padhy, a local resident, narrated the ordeal of the villagers. "No one realises our problem. One has to experience the hardship to believe it. We have repeatedly informed the RWSS junior engineer about our problems, but to no avail," she stated.

Echoing the same grievances, R Laxmi, who is Sushama's neighbour, alleged that she managed to take two pitchers of drinking water back to her house. Now she has been without drinking water for the last couple of days.

When contacted, NAC, executive officer, N Ganesh Babu said the problems faced by residents of Station Road Sahi village have already been brought to the notice of the higher officials. "I hope, their problems will soon be addressed,

Messing With Banks

he two-day national strike called by the United Forum of Bank Unions (UFBU), an umbrella body of nine bank unions, to register their protest against the Centre's proposed privatisation and disinvestment plan, entered the second day on March 16 causing widespread hardships to customers across the country. The dislocation of services is severe as the nation's 12 public sector banks employ 1.3 million-strong workforce with about 1 lakh branches spread over the country. The nationwide strike comes in the wake of the Union Finance Minister Nirmala Sitharaman's announcement during the Budget presentation in February that the government would privatise two more public sector banks.

The decision is yet another evidence of the government's bankruptcy of ideas to improve the country's financial health. The disinvestment route to fix the economy has been repeatedly failing. Yet, the government is persisting with this policy. The grandiose plan to privatise government units with the ostensible goal of rejuvenating the economy has simply fallen flat. The government could not get the large sums it expected the disinvestment would

The bank unions fear the privatisation of banks, like the insurance sector, would not only lead to massive job losses, but would only help private players those that are close to the ruling party earn windfall profits. They are gearing up to launch an even greater movement on lines of the ongoing farmers' agitation.

On the first day of the protest, thousands of bank employees took to the streets across several states. Nearly a million bank staff joined the protest as claimed by the unions. The managers participating in the strike head 80 to 90 per cent of the branches. This shows the scale of disruption affecting key services, including cash withdrawals, deposits, cheque clearances, and remittances across public sector banks. According to one report, 2.01 crore cheque instruments worth ₹16,500 crore could not be processed at the three national grids in Chennai, Mumbai and Delhi. Clearing of cheques could not be done as branches did not accept cheques.

The fear of the agitators that the government's policies are going to worsen the economy further is not misplaced. The government's intention seems to compromise the country's financial security in order to placate private players who are keen on maximsing profits.

The striking unions got support from former Reserve Bank of India Governor Raghuram Rajan who remarked it would be a colossal mistake to sell the banks to industrial houses. The government has already privatised IDBI Bank by selling its majority stake in the lender to LIC in 2019 and has merged 14 public sector banks in the last four years.

As the government is handing over public sector banks to private players, the irony is it was able to implement its own schemes like zero-balance Jan Dhan accounts only on the back of the public sector banks, though it is doubtful in whose interests the accounts were opened. There were reports these accounts were used to turn black money into white during the ill-conceived demonetization.

Moreover, India was largely untouched by the 2008 global financial meltdown as it had strong public sector banks. These banks as well as public sector units are the only ones that give strength to public policy initiatives. For instance, the government has been insisting on digitisation of virtually every mode of financial transaction. With privatisation of banks, one can very easily foresee a situation where the private owners would prefer and will definitely try to shrink the number of branches, eliminating those in the rural belt that are not profitable as standalone units. This would lead to the creation of more compact and efficient operations for the new owners but would also entail banks moving away from a large section of the public. This is bound to happen sooner than later, no matter what counter arguments are put up at present. When cash has already been sucked away from the system and banks will not be physically available, the bulk of the country will be again pushed into the old Indian system of money lenders playing a crucial financial role. Lest some forget, it is this money lending activity that had created bonded labors. Apart from this, the disappearance of banks will lead to people depending more on chit funds and micro finance of which, barring a very few, most are rogues. This has been especially proven in Orissa and West Bengal.

While it is undoubtedly preferable if government gets itself out of commercial activities, it must also be kept in mind that the corporate sector of India has never demonstrated any innovation except trying to achieve super-normal profits for itself. Banking is a very core public utility service which can be equated with drinking water or electricity supply. It is required for survival of every individual. Handing such critical services over to untrustworthy companies with dark pasts can never be considered as a decision favorable to the national interest.



Methinks

he Australian-born humorist, broadcaster and poet Clive James wrote In the Guardian "I save time on the web by reading nobody's opinion that contains the word 'methinks'." His dislike is understandable. The Oxford English Dictionary describes it as archaic, poetical and regional. It might have added "pretentious" because that's surely the quality of online writing that James finds unattractive and likely to waste what little time he has left in this world. He would presumably have passed over an appearance in the Guardian: "So, where will the steel be purchased? Methinks from George Osborne's new friends in China." Luckily for the reputation of the paper in James's eyes, that was in a reader's letter. Methinks has long ago fallen out of spoken usage, except in expressions such as "Methinks the witness doth protest too much", a misquotation from Hamlet. Style guides mostly don't bother to include it, not even to tell readers to avoid it, which would be good advice. Bryan Garner does provide an entry in his guide, without castigation but calling it "an everpopular archaism". I would have contested that, had I not found more than a thousand examples in a database of British newspapers from the past 20 years. Many appearances of methinks suggest that the OED should have added "humorous" to its list of likely contexts, though the jocularity can be so ponderous that the eyelids droop in sympathy. Some journalists do seem to believe it marks prose as elevated or serious, as in the downmarket Sun in July 2015: "Time, methinks, for author John O'Farrell to republish his excellent memoirs", and in May in the mid-market Daily Telegraph: "Methinks that a bit more modesty about how 'rich' we are, and accordingly about our ability to dish out largesse, might not go amiss." Methinks isn't only archaic but also ancient. It's in one of the oldest works in English, King Alfred's translation before 899 of Boethius' De Consolatione Philosophiæ, the Consolations of Philosophy. It was then two words, me thyncth (but then written me binco, using the old characters thorn and eth). The word looks like a thrusting together of me and think, meaning "it seems to me", and as though it comes directly from the Old English equivalent of think. But at that time there were two closely similar verbs, in modern spelling thencan, to think, and thyncan, to seem or appear. The source of methinks is actually the second one. In Middle English the two became confused and coalesced into one form that evolved into our modern verb to think. Methinks followed. If you're ever tempted to use the past tense, it's methought. But please don't.

don't use incorrect terms.' However, this happened not for the first time. In another similar exchange in the CJI's Court in August, 2020, when a lawyer used the term 'Your Honour', CJI Bobde had reprimanded him, "Are you appearing before the United States Supreme Court? The use of 'Your Honour' is in the US and not in Indian Supreme Court." When the concerned lawyer explained that there was nothing in the Law that prescribed such an address by the lawyers, the CJI said, "May not be in Law, but it is about prac-

ticularly what you call us, but

tice of the Court." Surprisingly, what CJI Bobde terms as 'incorrect terms', was held correct by him in 2014 when he was a puisne justice in the SC. On 6 January, 2014 an SC Bench comprising the then CJI HL Dattu and Justice SA Bobde heard a PIL filed by a lawyer named Shiv Sagar Tiwari who prayed for banning the use of the terms 'My Lord' and 'Your Lordship'. Tiwari's contention was that these terms were the symbols of slavery of the colonial era and should be strictly prohibited in Indian Courts as it was against the dignity of the country.

The PIL was dismissed by the Bench without citing any specific reason, but the Bench held that calling the SC judges 'My Lord' was not mandatory for lawyers and held, "When did we say it is compulsory? You can only call us in any dignified manner. To address the Court what do we want? Only a respectable way of addressing. You call (the judges) 'Sir', it is accepted.



It is high time a democratic republic like India whose Constitution champions the cause of liberty, equality and dignity of the individual, gave up the disgraceful colonial address of "My Lord" and replaced it with "Your Honour" or "Respected Sir/Madam"

On 6 May, 2006 the Bar Council of India (BCI) published its resolution in the Gazette of India mentioning: "Consistent with the obligation of the Bar to show a respectful attitude towards the Court and bearing in mind the dignity of Judicial Office, in form of address to be adopted whether in the Supreme Court or High Courts or Subordinate Courts should be as follows: "Your Honor" and "Hon'ble Court" in Supreme Court and High Courts and in the Subordinate Courts and Tribunals it is open to the lawyers to address the Court as "Sir" or the equivalent words in respective regional languages." An explanation was also provided as - "My Lord" and 'Your Lordship" are relics of colonial past, it is proposed to incorporate the above rule showing respectful attitude to the Court.

This resolution by the BCI was taken after considering the observations made by the SC while hearing a PIL filed by the Progressive and Vigilant Lawyers' Forum for abolishing the terms

"My Lord" and "Your Lordship". The SC dismissed the PIL on the ground that the matter relating to the manner in which the Bar would address the Bench was a matter to be decided by the BCI. The BCI has incorporated this resolution into the Bar Council of India Rules, as Chapter- III-A, Part VI.

Following the above BCI resolution and BCI Rules, many SC and HC justices have from time to time conveyed the Bar not to address them as "My Lord". In 2009 Justice K Chandru of Madras HC, in 2020 the Rajasthan HC, earlier this year (2021) Justice S Muralidhar of the SC, the Chief Justice of Calcutta HC Justice TB Nair Radhakrishnan and very recently, on March 3, 2021 Justice Arun Kumar Tyagi of Punjab & Haryana HC notified to the members of the Bar not to address them as "My Lord" or "Your Lordship", and instead use the terms "Your Honour" or just "Sir".

The origin of the address "My Lord" certainly goes back to the disgraceful colonial era. Since the judges of the Supreme Court of England were holding Lordship, which was a typical feudal title of the British system, they were

addressed by the British lawyers as "My Lord" or "My Lady". The mannerism and address of the Britishers were accepted by the subject-people of India during preindependence era. However, after independence also this disgraceful and ludicrous colonial legacy continued for quite long, as perhaps old habits die hard.

The sanctity or dignity of the Courts is directly proportional to the respect the judges command from the Bar and the common people. So the lawyers must display their highest respect to the judges. However, there is no rhyme or reason behind demanding to be addressed as "My Lord". Firstly, this British custom has its root in its conservative feudal tradition which has till today preserved the Monarchy even though it prides itself to be the mother of modern democracy. The Upper House of the British Parliament is known as House of Lords.

Secondly, people out of respect and reverence provide judges the status of divinity. But judges are certainly not omnipotent or omniscient gods. They are also mortals like any human being and are also fallible, and that's why there are multiple layers of courts of appeals to reconsider erroneous judgments.

The address of "My Lord" is only retained by the ex-colonies of the British Empire like India, Sri Lanka, Pakistan, Canada and a few other countries. Even the former colony Australia and New Zealand have given up such colonial addresses. In many of the European countries like France, Italy, Germany, Sweden, Russia, and the US the Judges of their respected Apex Courts are being addressed as "Your Honour" "Honorable Judge" or simply "Sir"

It is high time a democratic republic like India whose Constitution champions the cause of liberty, equality and dignity of the individual, gave up the disgraceful colonial address of "My Lord" and replaced it with "Your Honour" or "Respected Sir/Madam". A large portion of both the Bench and the Bar have already done it spontaneously and willingly, and that has never reduced the prestige, dignity, majesty, sanctity or sublimity of judges.

f you've been vaccinated against Covid-19, please accept my sincere congratulations. You have not only protected yourself from the virus, you have also shown concern for those around you: your family members, your neighbours, your dog and cats.

Your pets may not get Covid from you, but if you get the virus and are hospitalised, who is going to feed them?

Millions of Covid vaccine doses are being distributed around the world, made by pharmaceutical companies such as Pfizer Moderna. Johnson & Johnson and AstraZeneca. In most countries. priority for the vaccine has been given to people considered most vulnerable. This includes people with certain underlying medical conditions, such as cancer and heart disease, as well as frontline workers and healthcare profes-

Old people also have priority, because if you do not keep the old people alive, who is going to force the young people to get vaccinated?

Old people and young people do not have the same fears about the

Grandson: "If I get Covid, I might give it to my grandpa and he might Nobody enjoys getting vacci-

nated, but considering everything we've been through for the past year, everyone should be excited to get the Covid vaccine. But many people are like my teenage daughter, Divya, who does not like any type of vaccination whatsoever. If there was a vaccine to protect her against school teachers, she wouldn't get it.

Divya is not yet eligible to get the Covid vaccine, but I'm sure she is already having nightmares about it—picturing a nurse approaching her with a syringe and a needle as long as a fishing pole.

Nurse: "Divya, do you want it in your left arm or your right arm?" Divya: "Can you put it in my dad's arm?

Fear of the needle is just one of

a number of reasons that many people are reluctant to get the Covid vaccine, even if they're eligible for it. A few of them are just plain lazy. It takes a little effort to get vaccinated. You can't just click a button on your phone. Healthcare professionals do not generally visit your home to vaccinate you. If someone came to our door holding a syringe and needle, Divya would hand over all our possessions. "Take everything we own," she would say, "but please do not vaccinate me.' Some people are reluctant to get

the vaccine because they've received either misinformation or disinformation about it. Misinformation comes through the internet; disinformation comes through Donald Trump

As a result of this false information, people have started to believe some of the myths about the Covid vaccine. Here are just three examples of these myths:

Myth 1: The Covid vaccine causes infertility. This is not true. If you want to have a baby, one of the best things you can do is get vaccinated against Covid. Ask any medical professional and they will tell you that in order to have a baby, it's absolutely necessary that you stay alive.

Myth 2: The Covid vaccine will give you the Covid virus. Some people actually believe this—that you might get Covid from the vaccine that was created to protect you from Covid. These are the same people who will avoid going to the police station to report a robbery, because they're afraid that the police might rob them.

Myth 3: The Covid vaccine will alter your DNA, turning you into another person altogether. People who are happy with their lives do not want to get vaccinated and find that they've suddenly turned into someone else. But others may be willing to take the risk, hoping that they will suddenly find themselves writing like Salman Rushdie or batting like Virat Kohli. Of course, if the vaccine actually alters their DNA, they're far more likely to find themselves writing like Kohli and batting like Rushdie.

Beginning of Covid 2nd Telangana doubles farm output in 7 yrs wave: Centre warns Maha

In a letter to Maharashtra Chief Secretary Sitaram Kunte, which is based on the assessment of a central team, the Union health ministry has urged the state to bring down its positivity rate and step up contact-tracing

New Delhi, March 16: The Centre warned Maharashtra Tuesday that the state is witnessing a beginning of the second wave of the Covid-19 pandemic and asked the state government to focus on containment strategies and scale up the pace of vaccination campaign, especially in districts witnessing a sharp increase in infections.

Issuing a letter to Maharashtra's Chief Secretary Sitaram Kunte, which is based on the assessment of the central govt team, the Union health ministry has urged the state to bring down its positivity rate and step up contact-tracing.

The letter enclosed the analysis of the pandemic in Maharashtra by a central team which was deputed there to assess the situation on the ground. The team noted the lack of Covid-19-appropriate behaviour and tracking and testing of cases as the prime reason behind the infection surge, apart from the apathy of the district administration to implement already prescribed measures for transmission control.

"Maharashtra is at the beginning of the second wave of Covid-19 pandemic. There is very limited active effort to track, test, isolate cases and quarantine contacts. There is no adherence to Covid-appropriate behaviour among people both in rural and urban areas. Union Health Secretary, Rajesh Bhushan, warned in the letter.

He also pointed out that eight of the top 10 districts of India in terms of active Covid-19 infections are in Maharashtra and the only way to curb the spread is to increase the pace of vaccination.

"Covid-19 pandemic in the recent past has shown a rising trend in Maharashtra where the number of active cases has increased by 171.5% over the last one month from 36,917 cases February 11, 2021, to 1,00,240 cases March 11, 2021,' Bhushan wrote to Kunte.

The letter also noted that the number of people testing positive was high, ranging from 5.1% in Mumbai to 30% in Aurangabad, implying that many cases were not being tested and "there is high transmission in the community".

The report by the central team revealed that the main concept of contact tracing was not clearly understood by the field level staff.

Due to limited contact tracing, a large pool of asymptomatic and pre-symptomatic people was not being tracked and tested, said the letter, suggesting that testing be considerably enhanced according to protocol laid down by the Indian Council of Medical Research.

The team observed no adherence to Covid-appropriate behaviour among people, both in rural and urban areas. This was conspicuous both for physical distancing and for use of masks/face covers. There should be persuasive communication to sustain adherence to Covid-appropriate behaviour," the report said.

The central team also pointed to the lack of human resource to implement test, track, isolate and treat policy for Covid positive cases. "As the health staff too is pre-occupied with vaccine administration, there is the limited human resource for the surveillance and contact tracing activities," it reported.

Besides, the team also found a lackadaisical approach of the district administrations to manage the situation on the ground. "The district administrations are not much worried about the evolving situation. We could sense a feeling that enough has been done already. This complacency may take its toll," it concluded.

Hyderabad, March 16: India's youngest state Telangana has achieved a turnaround in agriculture by almost doubling the agriculture production and the area under cultivation during the last

Officials say this could be possible due to completion of several irrigation projects, revival of tanks, 24X7 free power to farmers and Rs 10,000 financial assistance to farmers towards input costs per acre

In 2014, when Telangana was carved out of Andhra Pradesh, the area under cultivation was 1.41 crore acres. The same has now gone up to 2.10 crore acres during the combined period of Vaanakalam (Kharif) and Yasangi (Rabi) seasons. The agriculture yield has doubled from 2.05 crore tonne to 4.11 crore tonne during the same period.

According to official figures paddy was cultivated in 34.97 lakh acres in 2013-14, and this has gone to 1.04 crore acres in 2020-21. The procurement of paddy by the government has gone up from 24.30 lakh tonnes in 2014 to 1.11 crore

The government claims that state has become the rice bowl of the country. The fact was highlighted during Governor Tamilisai Soundararajan's customary address to the joint session of both the houses of state legislature Monday, the first day of the budget session. She said Telangana has become Annapurna or food provider to the country.

Last summer, the Food Corporation of India (FCI) procured 1.15 crore tonne of paddy all over the country. Of this, 64 lakh tonne, that is about 56 per cent was procured from Telangana alone.

Paddy production during Vaanakalam was around 1.3 crore tonne and during Yasangi it is expected to be 1.25 crore tonne, the highest for any state in the country during Rabi season. Thus the paddy

Govt should open doors for dialogue: SKM

New Delhi, March 16: The Samyukta Kisan Morcha (SKM), an umbrella body of the farmer unions protesting against the Centre's new agriculture laws at Delhi's borders. Tuesday said the government should remove "obstacles' and open the doors for dialogue, over a month and a half since the talks between the two sides hit a roadblock.

New Delhi, March 16: Two men in their early 20s were stabbed to death after a horrifying chase by their assailants in a case of road rage in Outer Delhi's Paschim Vihar Tuesday.

The deceased Rohit Agrawal. 23, and Ghanshyam, 20, were chased by two bike-borne assailants after a minor case of grazing or touching between the two vehicles.

New Delhi, March 16: Rajya Sabha Tuesday passed a bill to raise the upper limit for permitting abortions from the present 20 weeks to 24 for "special categories of women" including rape survivors, victims of incest, minors and differently-abled.

The Medical Termination of Pregnancy (Amendment) Bill, 2020 to amend the Medical Termination of Pregnancy Act, 1971 was passed by voice vote. The bill was passed by Lok Sabha about a year ago. A resolution moved by Congress leader Pratap Singh Bajwa to send the bill to a select committee of Rajya Sabha was defeated by voice vote, along with some other amendments proposed by members. "The bill as amended is passed," Rajya Sabha Deputy Chairman Harivansh Narayan Singh said. Union Health Minister Harsh Vardhan said the amendments in the bill have been made after studying global practices and wide consultation within the

country. "Under the leadership of Prime Minister Narendra Modi, we will not frame any law which harms women. This is to preserve and protect the dignity of women," he said. Besides Congress, members of various parties including Shiv Sena, AITC, CPI, CPI-M and Samajwadi Party had demanded to send the bill to the select committee.

The bill amends the act passed in 1971 to Medical Termination of Pregnancy (Amendment) Act, 2020.

Under the new act, pregnancy in special can be terminated "where the length of the pregnancy exceeds 20 weeks but does not exceed 24 weeks" if no less than two registered medical practitioner are of the opinion that the continuance of the pregnancy would involve a risk to the life of the pregnant woman or of grave injury to her physical or mental health or there is substantial risk that if the child were born, it would suffer from any serious physical or mental abnormality.

ISRO taking space ties with US, Japan & Oz to a higher orbit

Bangalore, March 16: As Quad takes a leap forward, India is deepening space ties with the US, Japan and Australia -- the other three member nations of the group.

Known as the "Quadrilateral Security Dialogue", the Quad grouping held its first virtual summit last week. The four countries plan to establish a series of working groups that will focus on climate change; critical and emerging technologies, including working to set technology standards and norms and jointly developing some of the critical technologies of the future, officials said.

The Indian Space Research Organisation (ISRO) last week shipped

(SAR) to US space agency NASA's Jet Propulsion Laboratory as the joint NASA-ISRO SAR (NISAR) mission moved forward.

Women smear dry colours on each other during Holi celebrations in Nadia district

NISAR is a joint collaboration for a dual-frequency L and S-band SAR for earth observation, "NISAR will be the first satellite mission to use two different radar frequencies (L-band and S-band) to measure changes in our planet's surface less than a centimetre across", according to NASA (National Aeronautics and Space Administration). The mission is targeted for launch

in 2022 from ISRO's Sriharikota spaceport in Andhra Pradesh's Nellore district, about 100 kms north of Chennai. NASA is providing the mission's L-band SAR, a high-rate communication subsystem for science



data, GPS receivers, a solid-state recorder and payload data subsystem.

ISRO is providing the spacecraft bus, the S-band radar, the launch vehicle and associated launch serv-

ices for the mission, whose goal is to make global measurements of the causes and consequences of land surface changes using advanced radar imaging. On March 11,

Bangalore-headquartered ISRO and Japan Aerospace Exploration Agency (JAXA) reviewed the ongoing cooperation in earth observation, lunar cooperation and satellite navigation.

'Both sides have agreed to explore opportunities for cooperation in space situational awareness(SSA) and professional exchange programme", according to ISRO.

On the occasion, ISRO and JAXA signed an 'Implementing Arrangement' for collaborative activities on rice crop area and air quality monitoring, using satellite data". ISRO and JAXA have planned a joint mission -- Lunar Polar Exploration (LUPEX) -- to explore the Moon's south pole in 2023.

LUPEX received a boost as Japan reportedly earmarked 2.8 billion Yen (USD 26 million) for it for the fiscal 2021. In February, ISRO and Australian Space Agency (ASA) inked an Amendment of the '2012 India Australia Inter-Governmental MoU for cooperation in Civil Space Science, Technology and Education' .This Amendment makes India's Department of Space and ASA as the Executive Organisations and provides scope for other related entities to conclude implementing arrangements for specific cooperation activities. The two agencies reviewed the sta-

tus of ongoing cooperation activities in earth observation, satellite navigation, space situational awareness and establishment of transportable terminal in Australia to support Indias 'Gaganyaan' programme.



'Shah conspiring to harass TMC'

Mejia/Chhatna/Raypur (WB), March 16: West Bengal Chief Minister Mamata Banerjee Tuesday accused Union Home Minister Amit Shah of 'hatching a conspiracy' to harass TMC leaders ahead of the assembly polls, and sought to know if the Election Commission (EC) is taking instructions from him. The CM also said that she would be forced to stage a protest outside the poll panel's office, if the BJP continues to "interfere" in its day-to-day functioning

Contending that Shah is "frustrated" over the poor turnout at his rallies, Banerjee, who addressed three public meetings in Bankura during the day, accused the BJP of plotting to kill her, and claimed that her director of security, Vivek Sahay, was removed from the post by the poll panel, following her injury in Nandigram, for this reason.

"Amit Shah is frustrated as his rallies have registered poor turnout. Instead of running the country, he is sitting in Kolkata and hatching conspiracies to harass TMC leaders. What do they want? Do they want to kill me? Do they think they can win elections by killing me? If they think so, they are wrong," she said.

Urging the EC to take note of Shah's "antics", Banerjee wondered whether the EC has been reduced to a political tool of the saffron party. "Is Amit Shah running the EC? (It seems) he is giving instructions to the EC. What happened to their



independence? My director security (Vivek Sahay) was removed (by EC) under his instructions," she said.

Banerjee claimed Shah, who held a series of meetings with the state leadership Monday night, has understood well that his party is still miles away from the seat of power. "Will the home minister run the country or spend time harassing senior government officials, politicians? Will he harass the home secretary? Send CBI notice?

"They are booking all hotels. They are planning to frame cases against TMC candidates, send CBI, ED teams to harass political rivals? They are sending notices to those behind the Nandigram land movement. Bankura and Bengal should show others the way to defeat these

dictators," she said.

Demanding free LPG gas for every citizen, she said, the BJP is "selling off" railways, Coal India, closing down BSNL and banks and 'people should unite against this move".

"They have renamed a stadium after Prime Minister Narendra Modi. If they get to have their way they will change the name of the country," she said.

At another meeting in Chhatna, the CM said "Bengal will soon vote to decide who will be at the helm." Continuing her tirade against Shah, she said, "There is a home minister who garlands a statue mistaking it for that of Birsa Munda's. The bust of Vidyasagar statue was also vandalised in his presence.

"He is professing his love for

Cong, govt engage in war of words in LS

New Delhi, March 16: A war of words erupted between the Congress and the government in Lok Sabha Tuesday over registration of sedition cases with the opposition party alleging that the stringent law is being misused, drawing a sharp retort from Union Minister G Kishan Reddy who asked it not to lecture others on

During the Question Hour, Congress member from Telangana Anumula Revanth Reddy sought the number of cases registered under the offence of sedition across the country during the last 10 years, the conviction rate and the steps taken for their speedy trial.

The focus of his question was on climate activist Disha Ravi who was arrested in the farmer protest toolkit case earlier this year and later granted bail, and cases registered against farmer union leaders after the January 26 violence in the national capital.

Reddy, the Minister of State for Home, tabled a written response to the question in the House.

According to the data, 47 cases of sedition were registered in 2014; 30 in 2015; 35 in 2016; 51 in 2017; 70 in 2018 and 93 in 2019. The highest 54 cases of sedition

were registered in Assam between 2014 and 2019, 36 in Jharkhand, 31 in Haryana, 30 in Karnataka, 25 in Jammu and Kashmir and 17 in Uttar Pradesh. The minister also made it clear that "there is no direct involvement of the Centre in sedition cases". However, Anumula was not satisfied with the response. He said he had sought details for 10 years but the information was provided only from 2014-2019. Anumala said, "Giving half information is taking the house towards a wrong direction." He also asked whether there is a proposal to drop the "false charges" against farmer union leaders protesting against the Centre's three farm laws. In response, the minister said the National Crime Records Bureau (NCRB) data is based on the information received from all the states. The minister added that after the Modi government took charge, it started presenting a sep-



Summer shock: Prices of veggies on the rise

New Delhi, March 16: With the onset of the Summer season, prices of potatoes and other vegetables have started shooting up. Pointed gourd, cucumber, ridged gourd and lady's finger have gone out of the reach of the common man across the country.

Prices of cauliflower, radish. brinjal, spinach, peas and tomatoes have surged in March. Prices of potatoes, which was expected to have a bumper yield this year, have also started increasing.

Noida vegetable seller Pappu Kumar said that now the potatoes entering the market have little moisture. As a result the traders have started storing the vegetable which has led to the increase

At the same time, new vegetables like lady's finger, cucumber and pointed gourd are yet to find a profitable market. The retail prices of these veggies have increased to Rs 20 from Rs 10 per kg

The consumer price index (CPI)based retail inflation was at 4.06 per cent in January.

The rate of price rise in the food basket accelerated to 3.87 per cent in February, as against 1.89 per cent in the preceding month, according to the National Statistical Office (NSO).

A major reason for the rise in retail and wholesale inflation rates has been the rise in the prices of food and beverages.

The prices of pulses and edible oil was already on the rise and now the prices of vegetables have also started rising this month. Vegetable wholesale traders say that the consumption of vegetables has increased due to the fact that lentils are expensive, so prices of cabbage, tomato and other vegetables have started to rise, while the whole sale price of potatoes has increased marginally.



India saw air quality improve in 2020: Report

New Delhi, March 16: All Indian cities showed air quality improvements in 2020 owing to the Covid-19 impact compared to 2018, while 63 per cent saw improvements compared to 2019, said the 2020 World Air Quality Report Tuesday that is based on PM2.5 data from 106 countries.

Air quality improvements across major cities in 2020 compared to 2019 include Beijing (minus 11 per cent) Chicago (minus 13 per cent), Delhi (minus 15 per cent), London (minus 16 per cent), Paris (minus 17 per cent) and Seoul (minus 16 per cent). However, India continues to feature prominently at the top of the most polluted cities ranking, with 22 of the top 30 most polluted cities globally. The report by IQAir said in 2020, 86 per cent of the cities in China experienced cleaner air than the previous year.

Despite this, Chinese residents are still exposed to PM2.5 levels more than three times the World Health Organization (WHO) annual guidelines. Hotan in northwestern China ranks as the world's most polluted city, largely due to sandstorms ex-



acerbated by climate change.

Only 24 out of 106 monitored countries met the WHO annual guidelines for PM2.5 in 2020.

The report says climate change continues to affect air quality. The vear 2020 is tied with 2016 as the hottest year on record. Wildfires

and sandstorms fueled by the warming climate led to extremely high pollution levels in California, South America, Siberia and Australia. South Asia is the most polluted

region of the world with Bangladesh, India and Pakistan sharing 42 of the 50 most polluted cities worldwide.

Europe, with Bosnia Herzegovina, North Macedonia and Bulgaria taking the lead. "The year 2020 brought an unexpected dip in air pollution. In 2021, we will likely see an increase in air pollution due to human activity, again," said Frank Hammes,

CEO of IQAir.

"Many parts of the world experienced unprecedented, but shortlived, improvements in air quality in 2020, as restrictions related to the COVID-19 pandemic caused a steep drop in fossil fuel consumption," said Lauri Myllyvirta, lead analvst at the Centre for Research on Energy and Clean Air (CREA), who also contributed to the report.

Sanaa: Yemen's Houthi militia said they launched a new attack Tuesday at the King Khalid Airbase in Saudi Arabia's Khamis Mushait city. "The attack hit the target accurately," Xinhua news agency quoted Houthi military spokesman Yehya Sarea as saying in a statement. However, the Saudi-led coalition forces said earlier Tuesday that they had intercepted and destroyed an explosive-laden drone fired by the Houthi militia from Yemen towards Kamis Mushait, Saudiowned Al Arabiya TV reported.

Israel to allow all flights

Tel Aviv: Starting Tuesday, flights to Israel will be allowed from all destinations, following a decision by the cabinet to enable nationals to arrive ahead of the March 23 general elections. However, the cabinet decided to keep a guota of no more than 3,000 arrivals per day, reports Xinhua news agency. Passengers will be required to carry out coronavirus tests at the airport. Israel had imposed a ban on incoming and outgoing flights January 24.

Maldives approves Sinopharm vax

Male: The Covid-19 vaccine developed by China's Sinopharm has been approved for emergency use in the Maldives, the Maldives Food and Drug Administration (MFDA) announced at a press conference Monday. Beijing/New Delhi, March 16: China has made it mandatory for people coming from India and 19 other nations to get Chinese-made COVID-19 vaccines if they want to travel to this country.

For the purpose of resuming people-to-people exchanges in an orderly manner, starting from 15 March, 2021, the Chinese Embassies and Consulates in India will provide the persons having taken Chinesemade COVID-19 vaccine and holding the Certificates of Vaccination, a notice posted on the Chinese Embassy in New Delhi said.

The announcement makes little difference for thousands of Indian students besides professionals working in China and their family members who are stuck in India awaiting Beijing to permit their return as there are no Chinese vaccines available in India.

The Chinese Embassy notice did not specify how Indians can access the Chinese-made vaccines in India as they are not available in the country.

Over 23,000 Indian students, most of them medical students, besides hundreds of professionals working in China are stuck in India since last year due to coronavirus travel restrictions.

Despite repeated representations from the Indian embassy and appeals by the students, China is yet to respond positively.

State-run Global Times reported that such notices were put up by Chinese embassies in 20 countries.

China approves 4th COVID vax

EU regulator 'convinced' N Korea warns US Astra benefit outweighs risk not to 'cause a stink'

Brussels, March 16: With coronavirus cases rising in many places, governments faced the grimmest of dilemmas Tuesday: push on with a vaccine that is known to save lives or suspend use of AstraZeneca over reports of dangerous blood clots in a few recipients, even as the European regulator said there was "no indication" the shot was responsible.

It has created a jagged divide across the globe, forcing politicians to assess the health risks of halting the shots at a time when many countries, especially in Europe, are already struggling to overcome logistical hurdles and vaccine hesitancy among their populations.

Sweden was the latest to join a swelling group of European Union nations choosing caution over speed. even as the head of the European Medicines Agency said the agency



is "firmly convinced" that the benefits of the AstraZeneca shot outweigh the risks.

Emer Cooke noted Tuesday that thousands of people across the EU develop thromboses every year for a variety of reasons and that there were no reports of increased blood clots in the clinical studies of the AstraZeneca vaccine. Still, experts would undertake a "very rigorous analysis" and make a recommen-

dation Thursday, she said. Europe has the luxury to be able to pick from several vaccine candidates — but the decision is still not an easy one on the continent,

where the virus is again surging and where the vaccination campaign has repeatedly stumbled.

The Vatican said Monday that priests cannot bless same-sex unions and that such blessings are not valid, in a ruling that disappointed gay Catholics who had hoped their Church was becoming more welcoming under Pope Francis.

In some countries, parishes and ministers have begun blessing same-sex unions in lieu of marriage, and there have been calls for bishops to institutionalise de facto such blessings. Conservatives in the 1.3 billion-member Roman Catholic Church have expressed alarm over such practices.

New piece of Dead Sea Scrolls jigsaw discovered after 60 years

The scroll is one of a trove of ancient Jewish texts called the Dead Sea Scrolls that were found in 1947 by local Bedouin in the caves of Qumran

Jerusalem, March 16: Israeli archaeologists racing against treasure hunters to search caves near the Dead Sea have discovered a trove of artefacts, including fragments of a biblical text, the like of which has not been seen for decades.

The finds, preserved by the hot, dry air of the Judean desert, also include the 6,000-year-old partly mummified skeleton of a child, and a perfectly intact, finely woven basket dating back 10,500 years that the Israel Antiquities Authority said on Tuesday was likely to be the oldest in the world.

The Authority has overseen a survey of more than 100 km of cliffs and the caves carved or eroded into

them. The fragments of parchment, about 2,000 years old, bear biblical verse, written in Greek, and match a scroll discovered about 60 years ago called the "Book of the 12 Minor Prophets". That scroll is one of a trove of an-

The proposed legislation will give effect to the Budget announcement made by Finance Minister Nirmala Sitharaman February 1. The government has proposed ₹20,000 crore to capitalise the

The Cabinet has cleared this Bill, through which we will have an institution and institutional arrangement, which will help in increasing long term funds," she said after the meeting of the Cabinet.

The proposed DFI will have 50 per cent non-official directors, Sitharaman added.

In her Budget 2019-20 speech, Sitharaman had proposed a study for setting up DFIs for promoting infrastructure funding. About 7,000 projects have been identified under the National Infrastructure Pipeline (NIP) with a projected investment of a whopping ₹111 lakh crore dur-

India's diesel sales rise 7.4%

New Delhi, March 16: Indian state fuel retailers' diesel sales rose 7.4% to 2.84 million tonnes in the first fortnight of March from a year earlier, preliminary industry data showed Tuesday.

This is the first annual rise in gasoil sales in the country since October. Fuel sales in India took a hit in March last year as the government imposed a nationwide

lockdown to curb the spread of the novel coronavirus.

India's economy returned to growth in the three months to December and the recovery is expected to gather pace as consumers and investors shake off the effects of the COVID-19 pandemic.

The rise in gasoil sales, which account for about two-fifths of the country's overall fuel demand, comes despite record-high local retail prices and points to rising industrial

production in the country. State companies Indian Oil Corp,

Hindustan Petroleum Corp and Bharat Petroleum own about 90% of India's retail fuel outlets.

State retailers sold 3.3% less cooking gas in the first half of March than a year ago to 1.01 million tonnes as a significant reduction in subsidies curtailed demand for the fuel, the data showed.

Jet fuel sales were down 36.5% to 204.000 tonnes.

Rlys will never be privatised: Piyush Goyal

New Delhi, March 16: Railways Minister Piyush Goyal Tuesday asserted that Indian Railways will never be privatised but said private investment should be encouraged for more efficient

Replying to a discussion on Demands for Grants for Railways, Goval said there has been no death of any passenger due to a rail accident in two years and the railways has been putting enormous focus_ on passenger safety.

He said the country can progress towards high growth and create more employment opportunities only when the public and private sectors work together.

"Indian Railways will never be privatised. It is a property of every Indian and will remain so." the minister said, adding that it will remain with the government of India. Goyal said the Modi government has hiked investment in railways to ₹2.15 lakh crore in 2021-22 fiscal, from ₹1.5 lakh crore in 2019-20 fiscal.

'We are focusing on passenger safety. I am happy to say that there has been no passenger death in past two years. The last death due to train accident happened in March 2019," the minister said.

"People criticised lockdown, but had it not been done, continuation of train services would have spread Covid-19 across the country," added Goyal.

SC shuts back-door arrangement for defaulting promoters The impact of this judgment could be felt in many IBC cases where a resolution plan falls

through and a company ends up in liquidation

New Delhi, March 16: Defaulting promoters, who are barred from a resolution plan under Section 29A of the Insolvency and Bankruptcy Code (IBC), cannot use the scheme of arrangement and compromise to gain control of a company while it's in liquidation, the Supreme Court said Monday. As such, the scheme of arrange-

ment under Section 230 of the Companies Act does not stop anybody from proposing a plan. However, if this provision is used to revive a company which is facing liquidation under IBC, the rules of 29A will apply in keeping with the intent of the law, the top court clarified.

Specifically in this case, the SC order barred promoters of Gujarat NRE Coke, a defaulting company, from proposing a revival plan in the event of liquidation under IBC.

"The stages of submitting a res-

company as a going concern during liquidation, all indicate that the promoter or those in the management of the company must not be allowed a back-door entry in the company... Proposing a scheme of compromise or arrangement under Section 230 of the Act of 2013, while the company is undergoing liquidation under the provisions of the

SC judgment by bench comprising Justices Dhananjaya Y Chandrachud and MR Shah said.

The court was hearing the petition of Gujarat NRE Coke promoter Arun Kumar Jagatramka, who challenged the provision 2B introduced by the Insolvency and Bankruptcy Board of India (IBBI). The provision says that that parties ineligible to propose a resolution plan under the IBC cannot be a party to a compromise or arrangement.

"Any other interpretation would have left a gaping hole in the scheme of IBC and defeated the very object of Section 29A bar introduced both for resolution and liquidation processes under the IBC," said Misha (who only uses her first name), Partner at Shardul Amarchand Mangaldas & Co.

Legal experts said the latest order had settled the two conflicting positions of IBC, ensuring revival of the corporate debtor versus protecting the corporate debtor from its own management. What you cannot do directly you cannot do indirectly. "It would not be surprising to see the route of schemes of arrangement being completely discontinued during liquidation, given the incompatibility between the two processes," said Harish Kumar, partner, L&L partners.

The SC also said the need for judicial intervention or innovation from the National Company Law Tribunal (NCLT) and National Company Law Appellate Tribunal (NCLAT) should be kept at its bare minimum and should not disturb the foundational principles of the IBC.

The 'arrangement' strategy was approved by the NCLT and NCLAT too in the interest of promoting the core objective of IBC - revival of a company. But, the idea was not to create room for a backdoor entry of defaulting promoters. It was in this context that IBBI had brought the provision 2B for liquidation proceedings.





title since 2014, had a comfortable lead until recently, having won only two of their last six league games. They were held to 0-0 at Getafe Saturday. Diego Simeone's team will visit Barcelona in May. "We always said we wouldn't

give up," Barcelona midfielder Pedri Gonzalez said. "We have a good squad that can keep fighting for this title and we have momentum on our side.'

Barcelona, coming off elimination by Paris Saint-Germain in the Champions League last 16, was in control from the start Monday.

It affects the quality of the competition but also provides the 19member Indian contingent an opportunity to go deep in the draw and recapture the trophy which has been won by just two Indians so far -the legendary Prakash Padukone

(1980) and P Gopichand (2001). While former World No.1 Saina



Nehwal had a runner-up finish in 2015, Sindhu's best finish was a semifinal in 2018 but none of the other Indian shuttlers have been able to go

deep in the tournament till now. Olympic silver medallist Sindhu will again be one of the top contenders but Saina is nowhere near her best with just two quarterfinal

finishes to show in the last two years. Among other Indians, former No.1 Kidambi Srikanth and young men's doubles pair of Satwiksairaj Rankireddy and Chirag Shetty, currently ranked 10 in the world, had a good run in Swiss Open and will look to put their best foot forward.

Fifth seed Sindhu will kick off her

campaign with a clash against Malaysia's Soniia Cheah and is likely to face Japan's Akane Yamaguchi in the quarterfinals, provided she wins her initial rounds.

London Olympics bronze medallist Saina has drawn in-form seventh seed Mia Blichfeldt of Denmark in her first round and might meet Scotland's Kristy Gilmour next.

In men's singles, Srikanth will open against Tommy Sugiarto of Indonesia, while World Championships bronze medallist B Sai Praneeth will take on France's Toma Junior Popov and is likely to clash next with second seed Viktor Axelsen, who has won the two Super

1000 titles in Thailand, and the Swiss Open.

Commonwealth Games gold medallist Parupalli Kashyap will open against World No.1 Japanese Kento Momota, who is returning to international circuit after a horrific car accident last year that saw him undergo an eye surgery.

Among others in fray, former top-10 player HS Prannoy will meet 🛶 Malaysia's Daren Liew. Sameer Verma will be up against Ygor Coelho of Brazil in opening round and may face third seed Anders Antonsen of Denmark next. Young Lakshya Sen will meet Thailand's Kantaphon Wangcharoen.
