Bhubaneswar, March 18: In the aftermath of the news that 35,000 acres of Jagannath land are up for sales, questions are being now raised over the 'Uniform Policy' that will purportedly determine the value of the land.

Observers said the concept of the Uniform Policy is faulty as the ceiling price of land scattered across the state cannot be valued at the same rate. For example, land in Khurda district cannot be equated with land in remote Nuapada district in terms of their value. Similarly, questions were also raised as to who will be the ultimate beneficiaries of the policy-the temple or the encroachers.

The report published Monday in Orissa POST triggered an earthquake of reactions on social media with people cutting across parties attacking the government's policy to sell the Jagannath land.

The Uniform Policy was framed in 2003. According to it, the Odisha government had formed a panel named as 'Land Committee, Shree Jagannath Temple, Puri' in November 2002. The panel comprised bureaucrats from law, revenue & finance departments along with Puri ADM and chief administrator of the temple.

Subsequently, at a meeting, the temple authority put forth the draft policy, which was later approved by the law department. Notably, policy has not been discussed in the Assembly. Moreover, neither the government nor the temple administration had made any major effort to get back the Lord's land before coming up with the policy.

Even though over 60,426.923 acres of land belonging to Jagannath have been detected in 24 districts in Odisha, the temple administration has been able to get record of rights (RoR) for 34,876.983 acres only. Commenting on the issue,

Jagannath Sanskruti Surakhya Manch convener Laxmikanta Dash said. "It is the land of Lord Jagannath. not the government or temple administration. Earlier, they have given

huge amounts of land in Puri to a private company. In return what the temple got? Instead of selling the land, the temple administration should give it on lease for five or 10 years,' and added, "The value of money will decrease, but, the price of land and property will increase each year." Meanwhile, a political slugfest

began over the issue. Leader of Opposition Pradipta Naik condemned the move. "This is highly objectionable, unethical, against the spirit of crores of Hindus. Temple lands. property belong to gods and not the government, he said. Congress leader Suresh Routray said, "We will strongly protest the conspiracy of the government to sell the land of Lord Jagannath. The lands were donated by devotees to Lord Jagannath, who are you to sell it.'

## SJTA DENIES 'LAND SALE'

BHUBANESWAR: Chief administrator of Shree Jagannatha Temple Administration (SJTA) Krishan Kumar issued a clarification Thursday contradicting the statement made by Law Minister Pratap Jena in the House March 16. Jena had said the Odisha government is taking steps to sell off approximately 35,000 acres of Jagannath Temple land as per the recommendation of the BD Sharma Committee. Kumar, however, claimed the media reports based on the minister's statement is 'false and motivated'. "Lands which are occupied or are under the possession of people since long belong to Shree Jagannatha Mahaprabhu. Those are being settled by the temple committee as per the 'Unified Policy', framed for the purpose in the year 2003," Kumar said in a tweet. Kumar, however er, mentioned that 291 acres were settled between 2001 and 2010 and 96 acres have been settled between 2011 and 2021. These have been settled for the benefit of the public mostly in the form of schools, medical college and roads, among others, he said.



Bhubaneswar, March 18: Odisha Chief Minister Naveen Patnaik's intervention Thursday payed the way for a solution to the ongoing imbroglio in the Odisha Legislative Assembly. After discussions with BJP lawmakers, a decision was taken that Food Supplies Minister Ranendra Pratap Swain will give his statement Friday regarding paddy procurement at 11.30am in the Assembly. The BJP and the Congress for the last six days had been demanding an explanation from the government over the alleged mismanagement in paddy procurement.

However, prior to this decision, high voltage drama was witnessed in the state capital. The BJP MLAs led by Leader of Opposition, Pradipta Naik first questioned the silence of the government on irregularities in procurement of paddy and also questioned the CM's absence in the Assembly. They then decided to march from the Assembly towards Naveen Nivas.

were ministers and leaders like Bikram Keshari Arukha, Debi Prasad Mishra and Pratap Jena. They were seen negotiating with the protesting BJP leaders.

However, when negotiations failed, Patnaik decided to take matters into his own hands. The chief minister welcomed the protesting BJP MLAs and invited them for discussions inside his residence.

"The CM held talks with the protesting MLAs regarding the Assembly imbroglio and paddy procurement issues. We are now hopeful of resolving the deadlock in the Assembly," Arukha said.

After around two hours of hectic parleys at Naveen Nivas another all-party meeting was convened at the Assembly premises. It was decided that the government would respond to the allegations of mismanagement of paddy production in the Assembly.

"It was also decided during the all-party meeting that Food Supplies Minister Swain will give his statement on paddy procurement at 11.30am Friday," Speaker Surjya Narayan Patro said.

This development is certainly a ray of hope as for six days the functioning of the Assembly has remained stalled over protests and counter-protests over paddy procurement.

## Life imprisonment for Bachan Sudha killer

Bhubaneswar, March 18: Khurda District and Sessions judge Thursday sentenced Dipti Ranjan Patnaik, the main

accused in the sensational Bachan Sudha Patnaik murder case to life imprisonment. The verdict came little more than seven years after the crime had been committed. The court also asked Dipti to pay ₹5,000 as fine failing which he will undergo another two months in prison.

The deceased was the wife of businessman Manu Charan Patnaik and the couple was staying at their residence at Sabar Sahi in Rasulgarh under Mancheswar police limits. Dipti worked as a security guard at

the residence of the couple. He knew that they always kept cash and expensive jewellery in the house. So he hatched a

plan to rob them. ANOTHER BRUTAL MURDER IN CITY Dipti entered the house September 11, 2013 when Bachan Sudha was alone. He killed her by slitting with a kitchen knife and fled with a diamond locket, some ATM cards and other valuables. Bharat Charan Sahoo the

## LIKELY HIKE IN **POWER TARIFF**

Bhubaneswar, March 18: Power tariff is likely to be hiked further in the state as Discoms have filed a petition before the Odisha Electricity Regulatory Commission (OERC) proposing to increase the electricity tariff for the year 2021-22. The proposed hike in tariff is expected to be ₹1.50 per unit.

Six months back, the OERC had increased electricity charges to ₹5.25 with a rise of 20 paise per unit. If the rates are revised again it will certainly pinch a hole in the pocket of the consumers every month.

However, the Odisha Consumers' Association has said that they will oppose the possible hike in power tariff. The association has threatened widespread agitation across Odisha, if the power charges are revised and increased.







## Barang mason found dead

Barang, March18: A 50-year-old mason was found dead under suspicious circumstances in Naranpur area here Thursday, police sources said.

The deceased was identified as Tikina Swain of Munda Muhana village here. According to sources a few locals discovered a naked and lifeless Swain on the veranda of Mahaveer Sporting Club near Naranpur playground and informed the police.

A team, comprising additional commissioner of police (ACP) (Zone-IV) Satyaranjan Mallick and Barang inspector in-charge (IIC) Sashikanta Rout, reached the spot and carried out preliminary investigations. Later, a forensic team also joined the probe

Police got the body identified by Jayanti, Swain's wife, before sending it for an autopsy. "We've recovered a pair of blood-stained men clothing and slippers from near the body. There were a few injury marks on the body's face," the ACP said.

On the basis of a complaint lodged by Jayanti, Barang police registered a case (69/21).

According to Jayanti, her husband was a drunk ard. And his death could be a mishap. However, the autopsy report and footage of nearby CCTVs will help us land at any conclusion, Mallick pointed out.

tered 256 complaint cases and ar rested 87 persons during the last decade. However, the Capital police cops are yet to arrest 340 accused persons in the 1CC cases referred by the Magistrates

Nayapalli police station received 221 complaint cases during the period. As many as 110 persons were arrested by the Nayapalli police during the period. On the other hand, as many as 200 persons are yet to be arrested during the last 10 years. Likewise, as many as 234 complaint cases were registered at Laxmisagar police station between 2010 and 2020. However, the cops arrested 87 accused persons while 340 persons are still at large.

The situation is no different in other police stations. The above data has been pointing fingers towards a lack of interest by police to solve complaint cases referred by the Magistrates.

## **AUTO SECTOR FACES SHORT-TERM LIQUIDITY CONSTRAINT: PRADEEP AGARWAL**

Even as the scourge of Covid-19 has taken a heavy toll on every sector of the economy including automotive sector, the industry needs to familiarise itself with some of the new realities of the post-Covid-19 world like preference for personal mobility, going digital, online marketing among others. Speaking to Orissa POST, Pradeep Agarwal, Managing Partner, JMG automobiles highlights more about the constraints and the way forward. Excerpts...

gathering pace, companies believe normalcy will be back before long. In a conversation with **Orissa POST**. Jagadish Prasad Naik, Chairman-DN Group, believes the sector will be back to normalcy in a year's time.

#### ■ How do you see the real estate scenario in Odisha? What are the growth prospects?

The real estate market in Odisha is different from what they are in other states. The real estate market was stable as compared to other tier 1 & tier 2 cities during recession in 2008 -09 when lots of cities faced adverse time. The prime reason for this is the supply-demand ratio. The supply has never spilt over demand in Odisha. It has rather remained below demand. It will take some years to reach that level. The local real estate companies are doing well and a few have established themselves with a better brand value catering to both investors and end-users

In the 30 years of the real estate industry in Odisha, Bhubaneswar has been the real estate hub of the state, but now there is an RE presence in other cities too which should have happened a decade back. As Bhubaneswar holds the major infrastructural backing as compared to other cities of Odisha, it is still in the top priority of any home seeker in Odisha. Operation of airport, commercial developments like mall multiplexes, star hotels in the prime industrial and commercial cities of the state can encourage the real estate sector in those cities, because these aspects have been encouraging the Bhubaneswar real estate market for the home seekers of the state as of now. The growth prospect is always

there in real estate as its demand is not going to end at any given point of time. The sector also comes in top five employment generators of the country growing year by year and is also indirectly linked to about 300 allied industries.

### Pandemic has negatively impacted Indian GDP. How has the real estate sector been impacted?

Pandemic has impacted all the sectors of the country with very few exceptions and real estate is also a worst hit sector. The real estate sector had a plunge in the two quarters and thereafter it regained slowly. People didn't think of a new house during those period as many company laid off their employees and selfemployed were in financial crunch. The first and foremost priority was to save money for the future. Thereafter, the sector started improving slowly with the survivors of the pandemic which is about 50% of the

pre-pandemic period. To start with the 50 per cent figure is not a bad one, but at the same time it is not a positive indicator too. Once the vaccines roll out to the mass and the normalcy resumes, the sector will bounce back which may take a year's time or so.

Your company is well-known to customers. What are the future projects and the specialties of your customer service?

■ Yes, our company is of course a popular brand among the home seekers for which we have been working for the last 17 years and improving ourselves every day to retain our brand value, which is a tough task. We have various projects coming up in future as we have also verticals in hospi tality and education, but in real estate there are 5 mega residen tial projects coming up in southern part of Bhubaneswar.

#### How did covid-19 impact automobile business? What were the challenges you faced and how did you overcome them?

■ The pace of change across all industries is accelerating. Dealerships are facing disruptions from multiple directions - evolving mobility solutions, intensifying competition, product innovation, technology proliferation, stringent regulations, and changing customer preferences. Digitisation is the harbinger of change in the vehicle distribution industry, impacting everything from customer acquisition and vehicle delivery to sales. From the point of sale via digital tools to customer data analytics, remote servicing, and predictive maintenance - the way vehicles are purchased, distributed, and serviced is

changing dramatically. Online presence is increasingly becoming critical to first time customers. However, it continues to be a blind spot for traditional dealers as most of them do not intend to increase their online presence.

#### Market is not showing that type of growth in demand. How would you see the trend in two-wheeler sales?

Going forward, market volumes are likely to improve on the back of greater economic activity and better sentiment due to Covid vaccine. Meanwhile, dealers looking at ways to reinvent themselves such as reaching out to the customer in an all-new way through online platforms while delivering a personalized experience. A positive outlook for monsoon, strong rural demand, and the availability of finance are all indicators of a good economic recovery and buoyant demand, going forward in 2021-22. Challenges will remain in the short term due to the uncertainty of the pandemic and its impact on the supply chain. However, every crisis is an opportunity and we are trying to learn from it and define new norms, which we can benefit from.

**SC unshackles private** schools from fee row

New Delhi, March 18: In a major relief to a number of private unaided schools in Odisha. the Supreme Court Thursday exempted them from the binding effect of the state government's notification directing waiver of fees for the pandemic period, beginning from April 2020 till reopening of schools.

A three-judge bench of the apex court, headed by Justice AM Khanwilkar, held that the notification issued by state government January 19 for fee waiver will not have binding effect on those ICSE and CBSE private un-aided schools which were not signatories of the memorandum of understanding signed in September last year.

The bench, also comprising Justices Dinesh Maheshwari and Krishna Murari, asked the state government to consult with these school associations to make arrangements with regards to fees. The bench also asked the state government to go through its order in a similar case of Rajasthan. The court granted liberty to schools for approaching the High Court if they are aggrieved with any notification of the state government in future

Significantly, the Supreme Court in Gandhi Sewa Sadan Rajsamand vs State of Rajasthan case had allowed the schools to collect 100 per cent fee for the academic year 2019-20 and 2020-21 in six monthly installments

The association had challenged the order of Odisha High Court that upheld the notification issued by the state government January 19 allowing the fee waiver due to pandemic

In the petition, filed through its secretary, the association of Odisha ICSE Schools had challenged the state government's January 19 notification, issued in compliance to



the order of Orissa High court dated January 7 that took on record the memorandum of understanding, dated September 10, 2020, where government and several other parties had agreed for fee waiver in a flat rate and prepared a slab of fees to be waived by private Un-aided institutions.

The petitioner had contended in the petition that the state government had contradictorily taken support of the MoU despite its clear submission before the High Court that there is no provision under the Orissa Education Act. 1969 for fixation of fee structure of different Private Un-Aided schools. The Petitioner had submitted that during the lockdown almost all

schools were conducting online classes and teachers were discharging their duties by imparting course work over an online system.

## **'WE FORESEE GOOD SALES IN ACs, REFRIGERATORS IN THIS SUMMER'**

Like many other products, electronic goods took a hit during the pandemic. Sales across board plummeted. Increased prices of goods and raw materials also impacted sales. Yet with custom-made solutions and a well-motivated staff, Spectra Vision weathered the tough months. **Debraj Rath**, Managing Director of Spectra Vision, shares his experience during the pandemic and his other business experiences with **Orissa POST**. Excerpts of an interview.

### The impact of the pandemic on your business

Our business got severely affected as lockdown was imposed to contain Covid-19 outbreak. When it was withdrawn with certain conditions, we saw positive business in the months of May and June. Customers made purchases in these two months. With some difficulties in business again in July, we saw some improvement in October and November. Overall, business has not returned to normalcy yet. ### How did the pandemic affect the supply chain?

Appliance and Consumer Electronics (ACE) market depends on import. We had to shut our factory due to lockdown. Supplying the products was a challenge for us, and we still face the same challenge. It also impacted our business. Moreover, increased prices of electronic and other products have affected the retailers as well

### What is the current market scenario in electronic segments?

■ The price of raw materials, used to manufacture electronic products, has increased by 40-50 per cent in international market. Manufacturers have already used their stocked raw materials. Increased price will affect the producers when they go for fresh procurement.

Retail prices have increased by 10-12 per cent due to high production cost. We may face 5-6 per cent additional cost for new taxation policy. Such high prices will impact our business.

### Customers' services during the lockdown

We took best care of our employees. Considering urgency, we didn't cut their salaries. We also took care of customers' services. We acquired special pass from government and reached out to our customers during their needs. We continuously communicated with our customers over phone. Affected businesses can get back on track but health of our employees was important.

### ■ The journey of Spectra Vision

It was started in 1984 and we have experienced many events ever since. We are the first generation to come into this business. We started with Konark TV dealership. TV was newly launched in the market. After starting TV transmission, I showed my interest for

this business. My interest to associate with electronic businesses was the reason behind the inception of Spectra Vision.

## **Procurement politics**

addy procurement has always been a problem area in our state. Every vear, the government receives flak for its inept handling of the programme. The Odisha State Civil Supplies Corporation (OSCSC), the key player of the state's ₹12,000 crore plus paddy procurement programme, has not learnt a lesson from its past mistakes. Allegations of corruption against supply department officials and those of regulatory market committees (RMCs) have been dime a dozen. Complaints of their hand in glove with rice millers and recently with Women Self-Help Groups (WSHGs) and Pani Panchayats (PPs) fly thick and fast. Yet, the government has done precious little to fix the problem. Like in the past, this year too there are issues with procurement. Ever since paddy procurement was decentralised in the state and the OSCSC was given the mantle of the programme, procurement has been mired in controversies. In 2005-06, the government had experimented with private players who bought paddy on behalf of the Food Corporation of India, but that was discontinued after two-three years. There were no such complaints then of non-lifting of paddy. The private players who procured paddy from farmers by investing upfront tried to do maximum lifting so that their returns are maximised. Delayed payments or non-payments to farmers, non-opening of mandis, and the token issue have bogged the process. These issues are cyclical. It is not that we have a set of new problems to grapple with this year, yet the government has failed to find a permanent solution to these problems.

Odisha is predominantly an agricultural economy. Over three quarters of its populace depend on farming for their livelihood. As paddy is the only crop that is sold at minimum support price (MSP), farmers here majorly cultivate paddy. In the absence of an open market for paddy, and lack of avenues to make rice-based products, farmers look to the government to buy their paddy. The programme happens in two phases - November to February and the summer paddy that arrive between May and June. The state Food and Consumer Affairs department under whose control the OSCSC functions has to find a way out to end this mess. Farmers taking poison in mandis over their frustration to sell paddy, farmers staying up in mandis for days to sell their produce, and the much cursed token systems are cyclical problems. This year, the issue has been pushed to the centre-stage. The Opposition is not allowing the Assembly to function demanding that the government resolve the problems. That a BJP member attempted to commit suicide by consuming sanitizer in the House has brought in added gravity to the paddy procurement issue. While the BJD has demanded an apology from the member for his suicide bid in the floor of the House, the Opposition has been steadfast in its attack on the government. The stalemate in the House over paddy procurement continued for the fifth day Wednesday. Going by the way both the ruling party and the Opposition are arrayed over the issue, the session is headed for a washout.

What is the way out to end the recurring problems in paddy procurement? Is this not the time to review the entire programme? Is this not the time to divest the OSCSC, which is already overburdened with too many responsibilities, of paddy procurement work? The corporation not only procures, it also distributes rice to the beneficiaries through various Central and state government schemes. Added to that are its myriad other responsibilities. Can't the state government crate something like a special purpose vehicle (SPV) to take care of the paddy procurement? The government on its part should also stop meddling in the process in the form of involving WSHGs and PPs in paddy procurement. The SHGs in Odisha have been great tools for the government to win votes. Paddy procurement has been an uber-lucrative programme. If one studies the Centre's cost-sheet, there are fat commissions earmarked for every stakeholder involved in the exercise. This is the reason why the OSCSC has been zealously trying to hold on to its turf and the government throwing breadcrumbs to its patrons to retain their goodwill. When everybody in the game is a winner, why should the farmer lose?

# **CHINA'S WAR AGAINST ANT**

ver since Alibaba founder Jack Ma criticized Chinese financial regulation in a speech last October, a regulatory storm has pummeled the country's entire online financial and consumer sector. The Shanghai Stock Exchange suspended the planned initial public offering of fintech conglomerate Ant Group – an Alibaba affiliate – just two days before its launch, and regulators subsequently launched a massive crackdown on Chinese Big Tech. While Ma's speech appears to have been an unforeseeable random event, the logic of Chinese bureaucratic politics made Ant's IPO debacle inevitable. As I elaborate in my new book,

China previously regulated its financial system using a "one bank and three commissions" structure. The People's Bank of China (PBOC, the central bank) was responsible for monetary policy and macro-prudential regulation, while separate banking and insurance regulators and the China Securities Regulatory Commission (CSRC) oversaw their respective sectors. But these institutions' overlapping functions and lack of coordination allowed some non-financial firms to seek regulatory arbitrage, as the fallout from financial scandals involving the Anbang Insurance Group and Tomorrow Group made clear.

After these scandals came to light, the Chinese government implemented a series of organisational shakeups to address regulatory failures. In 2017, the 19th National Congress of the Communist Party of China made reducing financial risk a top economic priority, and emphasized "high-quality" rather than "highspeed" growth. The State Council also established the Financial Stability and Development Committee, a super-regulator headed by Vice Premier Liu He, to

A massive government overhaul in 2018 further consolidated financial regulatory power by merging the banking and insurance regulators into the China Banking and Insurance Regulatory Commission (CBIRC). Meanwhile the PBOC took over the CBIRC's legislative functions, further solidifying the central bank's leading role in maintaining financial stability.

In addition, CBIRC Chairman Guo Shuqing was also appointed party secretary of the PBOC, a move widely viewed as a step toward facilitating coordination between the two banking regulators. By 2018, therefore, the balance was already tilting toward tighter regulation of non-financial businesses. Ant is one of those targets. From the start, the group has marketed itself as an internet technology firm that uses Alipay, its highly popular mobile-payment app, to provide a wide range of financial services. But Ant presents Chinese regulators with unprecedented challenges because many of its services fall outside the scope of

existing financial rules.

ties. Its mission to ensure financial stability makes it a persistent regulator, and Ma's speech gave the central bank exactly the opening it needed to rein in Ant. His scathing criticisms of Chinese financial regulation directly irked many senior officials who previously had voiced contrasting opinions on the same regulatory issues.

These policymakers soon revealed their displeasure with Ma and Ant. A few days after the speech, the PBOC-affiliated newspaper Financial News published three consecutive commentaries criticizing Ant's business model.

Once the powerful central bank publicly turned against Ant, bureaucrats who had endorsed the group fell silent and other departments began to jump on the bandwagon. For example, China's antitrust authority has always had a clear interest in regulating the country's large tech firms in order to expand its policy domain, but had been taking a lax approach because it was uncertain whether to put innovation or regulation first. The top leadership's adverse reaction to Ma's speech gave the authority the green light to act against tech giants like Alibaba.

Ant's rapid growth and emergence as an internet finance titan reflected not only regulatory lag but also the firm's agile adaptation to rule changes. "We always step ahead of the regulators - we have to," Ma said in 2017. "Otherwise, we go nowhere." This time, though, it seems the regulators have finally caught up.

Busman's holiday is originally British, dating from the end of the nineteenth century. It initially spread to other countries through reports of London affairs and then caught on locally. It appeared in the Sunday Times of Sydney, Australia, in May 1896 and the Auckland Star of New Zealand in October 1902. It reached North America in 1909. It's now known throughout the English-speaking world. Some writers on etymology have got into a mess trying to explain it. A typical story appeared in John Ciardi's A Browser's Dictionary in 1981: "British drivers of horse-drawn omnibuses, becoming attached to their teams, were uneasy about turning them over to relief drivers who might abuse them. On their days off, therefore, the drivers regularly went to the stables to see that the horses were properly harnessed and returned at night to see that they had not been abused".

around the world have offered almost \$12 trillion in financial aid to businesses and households affected by COVID-19, equivalent to 12% of global GDP. But how well have they delivered that unprecedented amount of assistance to the intended recipients? And what lessons do these efforts hold for the future?

Many are asking such questions, from policymakers and fintech innovators to economists and civil-society watchdogs. We recently sought answers by analysing 12 government pandemic-support programmes, for both individuals and small and medium-size enterprises (SMEs), in seven countries - Brazil, India, Nigeria, Singapore, Togo, the United Kingdom, and the US.

We assessed the ambition of each programme's design – its scope, scale, and specificity - and the effectiveness of delivery, measured by the speed and coverage of disbursements. Our study revealed considerable variance. Some programmes combined ambitious design with effective delivery. But many fell short in one or both areas, with problems including slow rollout, failure to reach eligible beneficiaries, and in some cases fraud. This is true for all countries, but emerging economies have more to gain than richer countries in economic value for every percentage point of GDP spent on incremental government disbursements. That may be because advanced economies already have more digital financial infrastructure in place.

In our study, Singapore's Job Support Scheme and the UK's Job Retention Scheme were among the best performers in terms of both design and delivery. But some emerging-economy schemes also scored well. Two Indian programmes – one targeted at women, and an emergency credit guarantee scheme that benefited more than three million SMEs and micro-businesses – were able to build on existing financial infrastructure to perform strongly. Togo, which has less developed financial infrastructure, was still able to make good use of what it has: its Novissi programme made fortnightly cash transfers to informal workers' mobile money wallets that amounted to 30% of the minimum monthly wage for the duration of local lockdowns

tures of financial infrastructure in common: digital payment channels, a basic digital ID system with broad population coverage (such as India's Aadhaar programme), and simple data on individuals and firms that are linked to the digital ID.

Countries whose financial infrastructure included these three features could design programmes optimally and deliver them quickly. Singapore's SME job-support programme, for example, transferred funds automatically to eligible businesses: amounts were calculated based on firms' payroll, without the need for an application process. This was made possible by the "CorpPass' digital ID system, which assigns each SME a unique ID linked to government data on the firm's tax payments and employee wages.

But countries lacking one or more of these infrastructure features had to make trade-offs between their assistance programmes' design ambition and delivery success. The US Economic Impact Program sought to pay more than 50% of the population, but had only limited targeting; all individual Social Security recipients and tax filers earning less than \$75,000 annually received the same amount, for example.

Before the COVID-19 crisis, we estimated that applying basic and advanced digital ID to a wide range of interactions between individuals and institutions could deliver an economic gain by 2030 of between 3-13% of GDP, depending on the country. But we now estimate that the potential gain could be up to 20% higher.

The pandemic has served as a high-stakes stress test for many countries' financial systems, highlighting critical gaps and opportunities. At the same time, it provides valuable lessons about how to improve efficiency and resilience.

Our analysis covers only a subset of assistance programmes in a small number of countries. But it shows that strong financial infrastructure for SMEs and individuals is vital, not just for responding to unexpected and potentially catastrophic crises such as the coronavirus pandemic, but also for boosting financial resilience and economic growth.






## After 40 years in jail, Calcutta **HC** releases Nepal resident

Kolkata, March 18: The BJP has announced its second list of candidates Thursday for the Bengal elections, naming 148 candidates including Mukul Roy from Krishnanagar. In this list the BJP has fielded a fifth MP - Jagannath Sarkar. The parliamentarian from Ranaghat will contest at Shantipur.

The name of Dilip Ghosh - the



party's state unite chief is not on the list. Sources said he would not contest the Assembly elections. Veteran Bengal unit leader Rahul Sinha will contest from Habra.

The party also continued with fielding celebrities in this round too, naming folk artiste Ashim Sarkar from the Haringhata Assembly seat. Scientist Gobhardhan Das was fielded from Purbasthali Uttar.

The names announced Thursday are for the phases five, six, seven and eight. The party's

first list of candidates, issued last week, had triggered huge protests that continued for two days and had to be quelled by the police with a lathi charge.

Angry supporters had gathered at the party's election office in Kolkata and even heckled senior leaders Mukul Roy, Ariun Singh and Shiv Prakash. They were joined by protestors from Udaynarayanpur, in Howrah.

Talking to this news agency, Eknath Khadse, a prominent leader from Jalgaon who quit the BJP in October last year and joined the NCP, claimed the BJP corporators were upset since the last two-and-a-half years.

"Since the BJP came to power two-and-a-half years ago, it became arrogant and did not work for the development of the city. The BJP's own corporators wanted to teach the party leaders a lesson," he claimed, referring to BJP leader Girish Mahajan.

## Buddhist monk group condemns military crackdown in Myanmar

Kolkata, March 18: Mvanmar's government-appointed body representing Buddhist monks has opposed the bloody crackdown by the military junta in the country that has left more than 200 dead.

The draft statement by the State Sangha Mahanayaka Committee called upon the military junta to 'immediately halt' firing on demonstrators. "Killing peaceful protesters must stop," the statement said.

The final draft was released by the Sangha Maha Nayaka committee Thursday after it is discussed with the religious affairs minister, a monk close to the government-appointed organisation told this news agency.

When that happens, it might be the most forthright condemnation of the military's bloody crackdown on pro-democracy protests since the February 1 military takeover.

Buddhist monks, often the most



revered in Myanmar and whose numbers run in thousands, have often led pro-democracy movements in the country.

They were at the forefront of a 2007 "Saffron Revolution" against military rule that paved the way for the 2008 military drafted Constitution and subsequent elections in the country.

The military tried to swing the Buddhist clergy their way by secretly funding radical groups such as Ashin Wirathu's Ma Ba Tha and playing on the Bamar Buddhist identity during the 2017 turmoil in Rakhine state when Rohingva Muslim rebels attacked more than twenty police stations.

## Maha farmers start fresh fruit cake 'movement'

Pune. March 18: Fruit growers in rural Maharashtra have started an innovative 'movement' to promote fresh fruit cakes as a healthier option, instead of the traditional bakerv-made cakes, to celebrate birthdays and other special occasions. According to farmers and agrar-

ian experts, the aim of this 'spontaneous' movement, which is gaining popularity on social media, is to encourage farmers and their families to increase the intake of fruits in their diet and to find a new way of selling their produce in the times of COVID-19.

As part of the movement, farmers, their families and various organisations of cultivators are en-

couraging cakes made locally using fruits like watermelon, muskmelon, grapes, orange, pineapple and banana while celebrating special events. Deepak Chavan, a Punebased agriculture analyst, told this news agency that of late, the production of fruits in several regions of the state has increased, leading to a surplus supply in markets and causing a drop in the prices of fruits.

Farmers have already suffered due to the lockdown and now due to surplus supply, traders are purchasing their produce at lower rates, he said. "As a solution, farmers have started this innovative movement on social media where cakes made of fresh fruits are being used to celebrate birthdays, marriage anniversaries and other events, Chavan said. Generally, it has been seen that fruit cultivators and their families do not consume adequate fruits as part of their diet, he said.

'The movement is serving the right purpose as farmers and their families are now consuming fruits on different occasions in the form of fresh fruit cakes. These cakes are far better than the bakery-made cakes which have less nutritional value," he said. Chavan said the movement is currently restricted to farmers and their families, but he is hopeful it will become a sustainable solution for all fruit growers. 'Hoy Amhi Shetkari', a farmers'

organisation, is holding a 'fresh

fruits cake' competition on social media. Participants are supposed to make cakes using only locally avail able fruits.

"As the fresh fruit cake movement is picking up steam, we decided to hold a competition and invited entries from people to send photos and videos of fresh fruits cakes," said Sangli-based farmer Amol Patil, who is a member of the group.

He said they have so far received over 150 entries, with people and farmers sending pictures of their fresh fruit cakes. Patil said their organisation's social media platform wall is now abuzz with pictures of fresh fruit cakes sent by farmers, their families and other people.

Some people are also using their  $\rightarrow$ decorative skills to make the cakes more attractive by using locally available fruits, he said.

"The movement is at a nascent stage and professional and commercial touch is needed to make the en-deavour more sustainable to support farmers and their produce," he said.

The top court said judges can play a significant role in ridding the justice system of harmful stereotypes. "They have an important

responsibility to base their decisions on law and facts in evidence, and not engage in gender stereotyping," it noted.

The bench also added the judges should identify gender stereotyping, and identify how the application, enforcement or perpetuation of these stereotypes discriminates against women or denies them equal access to justice. "Stereotyping might compromise the impartiality of a judge's decision," it observed.

The bench said men, perhaps more than women, have a duty and role to play in averting and combating violence against women.

Noting Attorney General K.K. Venugopal had suggested steps that

should be taken to sensitise all stakeholders, especially courts, while dealing with offences against women, the bench said: "On gender equality and gender sensitisation, the Attorney General argued that to achieve the goal of gender justice, it is imperative that judicial officers, judges, and members of the bar are made aware of gender prejudices that hinder justice.

The top court said if judges fall ter, especially in gender related crimes, they imperil fairness and inflict great cruelty in the casual blindness to the despair of the survivors as it passed a slew of direction on the aspect of gender sensitisation in the legal fraternity.

83 thatched houses gutted in Arunachal

Itanagar, March 18: Two persons, including a five-year-old girl, were charred to death and 83 thatched houses gutted after a fire broke out in a village in Arunachal Pradesh's Tirap district on Thursday, an official said.

The incident took place around 12.30 pm at Longliang village, and no fire tenders could be pressed into service as the rural hamlet is on a hillock, Tirap Deputy Commissioner Taro Mize said. Though initial reports from the district suggested that 143 houses were reduced to ashes, but after further assessment, the number was revised to 83 houses out of a total of 139 in the village with a population of 702.

'An elderly person, who was bed-ridden, and a little girl were charred to death. The deceased have not been identified," Extra Assistant Commissioner (EAC) of Lazu D K Thungdok said. He said the extent of damage and the cause of the fire are yet to be ascertained.

Mize said essential commodities have been dispatched through special relief teams. Meanwhile, senior Congress MLA from the district Wanglin Lowangdong has urged the state government to immediately make ex-gratia payment to the next of kin of the deceased and relief to the affected.

## India saw largest spike in malware attacks in 2020: Report

**MORE THAN 25 MILLION MALWARE ATTACKS IN DECEMBER 2020, SAID THE "2021** SONICWALL CYBER **THREAT REPORT**"

Mumbai, March 18: India experienced the largest spike in malware attacks, with the monthly volume more than tripling between September and October, said a new report from cybersecurity firm SonicWall.

The pandemic's work-from-home reality resulted in an unprecedented change for organisations as they fought to defend exponentially greater attack surfaces from cybercriminals armed with powerful Cloud-based tools, cloud storage and endless targets.

As working environments evolved, so did the methods of threat actors and other motivated perpe trators, as detailed in the report. "2020 offered a perfect storm for

cvbercriminals and a critical tipping point for the cyber arms race, SonicWall President and CEO Bill Conner, said in a statement.

'The pandemic -- along with remote work, a charged political climate, record prices of cryptocurrency, and threat actors weaponising cloud storage and tools -- drove the



effectiveness and volume of cyberattacks to new highs. The report highlights how Covid-19 provided threat actors with ample

opportunity for more powerful, aggressive and numerous attacks, thriving on the fear and uncertainty of remote and mobile work-

forces navigating corporate networks from home.

There is no code of conduct when it comes to cybercriminals, their methods of attacks and the selection of their targets," said Conner. The findings showed that there

was a 62 per cent increase in ransomware globally, and a 158 per cent spike in North America.

It suggests that cybercriminals are using more sophisticated tactics and more dangerous variants, like Ryuk, to earn an easy payday.

First identified in August 2018, Ryuk did not appear outside of North America, Europe or Asia as late as January 2020

The following month, Ryuk began climbing the charts, eventually overtaking top-ranking Cerber ransomware.

With 109.9 million cases detected worldwide, Ryuk was logged nearly every eight seconds in September alone, said the report.

The research shows the shift to employees working from home fulltime could be directly linked to the increased utilization of Office files and PDFs as malicious vehicles armed with phishing URLs, embedded malicious files and other dangerous exploits.

New SonicWall data indicates a 67 per cent increase in malicious ২ Office files in 2020.

Once thought to be a dying attack vector after the industry's major mining operation boarded its online service, cryptojacking is back thanks to rising cryptocurrency values and its appeal of concealed payouts.


New Delhi, March 18: With India Thursday recording highest single-day rise since December, the cases in Maharashtra accounted for 63.21 per cent of the daily new cases, followed by Kerala and Punjab. The country recorded 35,871 new Covid-19 cases in the last 24 hours. A single-day spike of 36,011 new infections were recorded December 6. According to the Health Ministry,

Maharashtra, Punjab, Karnataka, Gujarat and Tamil Nadu continue to report a surge in the COVID daily new cases. 79.54 per cent of the new cases are from these five states.

Maharashtra has reported the highest daily new cases at 16,620, accounting for 63.21 per cent of the daily new cases. It is followed by Kerala with 1,792 while Punjab reported 1.492 new cases.

A rising trajectory of daily new cases is also visible in eight states. These are Maharashtra, Tamil Nadu, Punjab, Madhya Pradesh, Delhi, Gujarat, Karnataka and Haryana. Kerala is reporting a consistently declining trend over last one month. With death of 172 people in the last 24 hours, the fatality toll has reached 1,59,216 in India. The active caseload in country has mounted to 2,52,364, rising by over

17.958 cases from previous day. Five States account for 84.88 per cent of the new deaths. Maharashtra saw the maximum casualties (84). Punjab follows with 35 daily deaths and Kerala reported13 deaths in the last 24 hours. Health Ministry



## 400 INFECTED WITH UK, **SA, BRAZIL MUTANT**

Amid surge in Covid-19 cases, the Health Ministry on Thursday said that 400 patients have been found to be affected with UK, South Africa and Brazil mutant variants of the coronavirus. On March 4, the country had recorded 242 cases with these variants. The cases increased by 158 in merely two weeks.

Secretary Rajesh Bhushan said that 70 districts in 16 states have witnessed an increase of cases by more than 150 per cent from March 1 to March 15. Amid rising cases of COVID-19 in Punjab, Chief Minister Amarinder Singh Thursday announced a two-hour extension in the night curfew in the state's nine worst-affected districts. Singh said the coronavirus situation in the state is critical and warned people of stringent measures if they don't follow COVID appropriate behaviour.

The service will give an opportunity for induction of suitably qualified fresh legal talent selected through a proper all-India merit selection system as well as address the issue of social inclusion by enabling suitable representation to marginalised and deprived sections of the society, he said in a written reply.

The proposal to constitute AIJS with views from the high courts and state governments received thereon was included in the agenda for the Chief Justices conference held in April 2015, he recalled.

## Stop spreading Covid fear: Farmers to Govt

New Delhi, March 18: The farmers agitating against the three contentious farm laws at the borders of Delhi are not perturbed by the surge in the Covid cases, rather they have asked the government not to spread fear to end the agitation.

On Wednesday, in a meeting with the Chief Ministers amid growing alarm over the resurgence of Covid-19, Prime Minister Narendra Modi urged them to act fast against the emerging "second peak" of the pandemic, warning "if we do not stop this now, a country-wide outbreak

can occur". Amid the rising Covid cases, Section 144 has been imposed in Ghaziabad.

Talking about the Covid-19 surge, Ghazipur border protest committee spokesperson Jagtar Singh Bajwa told IANS, "Farmers are here from the last four months but not a single Covid-19 case has been reported from here. The government is spreading the fear so that people don't come here to participate in the protest. This is a conspiracy to end the protest. We condemn this act of the government." Bharatiya Kisan Union president of Uttar Pradesh Rajvir Singh Jadaun said, "We started the protest amid the pandemic outbreak and now when we have vaccine then why the government is spreading the fear. Rather than sending the vaccine to the foreign countries, for free, the government should provide it to its citizens.'

"The Prime Minister's concern about the villages is fine but Covid-19 surge is not the only concern in the villages. Not a single farmer has been infected while working on the farms. Instead of spreading fear, the government should proactively think about saving the lives of the people," he added.

## 'Sticky bombs' pop up as fresh security challenge in J&K

THE THREAT, SUSPECTED TO BE AN IDEA OF PAKISTAN'S INTER-SERVICES INTELLIGENCE (ISI) OPERATIVES WHO PUSH TERRORISTS IN THE VALLEY, CAME TO LIGHT AFTER VARIOUS RAIDS AND OPERATIONS SAW SECURITY FORCES RECOVER SUCH BOMBS

New Delhi, March 18: Inputs about 'sticky bombs' to use on vehicles by terrorists have emerged a new concern for security agencies in Jammu and Kashmir with the **CRPF**, Jammu and Kashmir Police and the Army gearing up to tackle this probable threat which could add a new dimension to insurgency in the region.

However, this new method of attack has not been used so far anywhere in the Union Territory. The use of sticky bombs first came into light during questioning of some arrested terrorists and their home-grown linkmen in the Kashmir Valley.

Central Reserve Police Force's

(CRPF) newly appointed Director General Kuldiep Singh had

Thursday revealed the new threat. 'We have heard about sticky bombs. It is really a challenge but there is not a single input about seizure of any such bombs from any vehicle in Jammu and Kashmir. Neither we noticed any such incident in which such bombs were used," he said.

"Based on inputs from some accused, a few sticky bombs have been recovered from some particular places. These bombs were not even used on any vehicle," he reiterated. The Jammu and Kashmir Police earlier this month recovered around two dozen sticky bombs from the Jammu region,



based on inputs received from some accused, prompting security agencies to amended procedures to deal with the new threat. There have been some instances in which "sticky bombs" were dropped by terrorists sitting across the border in Pakistan using drones, and these explosives were seized from Samba sector of Jammu region along the International Border earlier this month.

London, March 18: As the UK's National Health Service warned of a "significant reduction in weekly supply" of vaccines to protect against COVID-19 by the end of this month, the focus Thursday turned to 5 million doses that are

expected to be delivered from India. The Serum Institute of India (SII), which is producing the Oxford AstraZeneca vaccines under the label of Covishield as part of a tieup, was contracted to supply a total of 10 million doses to the UK.

While five million of these have been received, the remaining batch is now held up with some reports indicating that the Indian government may be weighing up domestic needs before clearing exports.


"A number of global manufacturers are experiencing issues." **UK Communities Secretary Robert** Jenrick told BBC when asked if the delay had an Indian connection.

## **NEW CORRUPTION CHARGES LEVELLED AGAINST SUU KYI**

Yangon, March 18: New corruption allegations against Aung Sang Suu Kyi, the detained former de-facto leader of Myanmar, were aired on national television Thursday, as the military seemed to seek to strengthen the case for its February 1 coup against her government.

In the broadcast, U Maung Weik, a business owner, is shown explaining how he handed over envelopes full of cash to Suu Kyi or her associates starting 2017, reports dpa news agency. In all, Weik said he had handed over a total of \$550,000 during four separate incidents.

A news reader said the businessman has been found guilty of bribery and that the country's anti-corruption commission is investigating

After Suu Kyi was dislodged by the February 1 coup, the military has piled on charges against her, from illegally importing walkietalkies to sowing disorder by inducing others to commit offences against the state to mishandling the government's response to the coronavirus pandemic.

When queried by DPA, Khin Maung Zaw, a lawyer for Suu Kyi, dismissed the new allegations.

"I am here not to tell this as her lawyer, but as a Myanmar citizen. We all believe her character. You can criticise her in many ways but you cannot criticise her such as silly ideas of corruption.'



## Total lockdown in Poland

Warsaw: The Polish government said that it will reintroduce a full nationwide lockdown from Saturday onwards in the wake of a resurgence of new coronavirus cases. ## In a first, baby born with antibodies against nCoV

New York, March 18: Pediatricians have reported the first known case of a woman, who was given the first dose of the COVID-19 vaccine during her pregnancy, giving birth to a baby with antibodies against the novel coronavirus.

According to the yet-to-be peerreviewed study, posted in the preprint server medRxiv, the mother had received a single dose of the Moderna mRNA vaccine at 36 weeks and three days of her gestation period.

Three weeks later, she gave birth to a vigorous, healthy, fullterm girl, whose blood sample taken immediately after birth revealed the presence of antibodies against the SARS-CoV-2 virus, the study noted.

"Here, we report the first known case of an infant with SARS-CoV-2 IgG antibodies detectable in cord blood after maternal vaccination. noted the co-authors, Paul Gilbert and Chad Rudnick from Florida Atlantic University in the US.

The woman, who has been breastfeeding the baby exclusively, received the second dose of the vac-

cine as per the normal 28-day vaccination protocol timeline, the doctors noted.

While earlier studies showed that the passage of antibodies from COVID-recovered mothers to their foetuses via the placenta was lower than expected, the current research suggests "potential for protection and infection risk reduction from SARS-CoV-2 with maternal vaccination."

However, Gilber and Rudnick note that further long-term studies are needed to quantify the antibody response in babies born to vaccinated mothers.

Bhubaneswar, March 18: National Green Tribunal's (NGT) recent order declaring PET bottles use safe for packaging of pharmaceuticals has finally given a rubber stamp on a scientific fact, endorsed by both the government, scientific community and the pharmaceutical industry.

An especially designed plastic polyethylene terephthalate or PET is widely used for packaging water, medicines, beverages, edible oil, etc. across the world because of its safety, utility and economic viability for the packaging of products of mass consumption.

Recently, the principal bench of National Green Tribunal dismissed a litigation filed by Him Jagriti Uttaranchal Welfare Society in 2014 stating that Indian government has already ensured guidelines for safe and regulated use of plastics for packaging and as the industry is adhering to global guidelines formulated under Pharmacopeia no further legislation changes is required.

The order comes after an expert Committee set up by the Health Ministry in 2015, led by former biotech secretary MK Bhan. submitted a report to the tribunal stating, "There is no conclusive evidence to suggest that use of PET or additive like antimony for pharmaceutical packaging may leach substances beyond limits that pose threat to human health".



United Nations, March 18: India's economy, estimated to contract by 6.9% in 2020 due to the coronavirus pandemic, is forecast to record a "stronger recovery" in 2021 and grow by 5%, according to a UN report which said the country's current fiscal year budget points to a shift towards demand-side stimulus, with an uptick in public investment.

The report, 'Out of the frying pan ...Into the fire?' published Thursday as an update to the Trade and Development Report 2020 by UN Conference on Trade and Development (UNCTAD) said the global economy is set to grow by 4.7 per cent this year, faster than the 4.3% predicted in September 2020, thanks in part to a stronger recovery in the US, where progress in distributing vaccines and a fresh fiscal stimulus of \$1.9 trillion are expected to boost consumer spending.

## 'World may see peak of petrol, diesel demand by 2035'

New Delhi, March 18: The world is likely to see peak demand for petrol by the late 2020s and for diesel by 2035, but auto fuels will continue to see growth in India as the economy expands, a senior petroleum ministry official said Thursday.

Speaking at the 'India Chem 2021' conference, Sunil Kumar, Joint Secretary (Refinery), Ministry of Petroleum and Natural Gas, said the country will see different energy systems co-exist through the next few decades as demand is expected to remain robust

Fuel demand in years to come will be impacted by factors such as the availability of substitute fuels, the advent of electric vehicles (EVs) and the development of renewable fuels.

"Globally, demand for gasoline (petrol) is expected to peak in the late 2020s and of diesel by 2035," he said. However, in India, different energy

systems, including fossil fuel, will co-exist over the next few decades. 'Demand for petrol and diesel in

India is expected to remain robust in the foreseeable future...at least up to 2040 because our pie is increasing," he said. "India's demand for petrol and diesel will continue to rise despite new sources.

The time till the demand peaks can be used by the country and the oil industry to prepare for future where crude oil can be converted directly into chemicals instead of the current practice of first it getting

turned into fuel. "Refining and petrochemicals have to have a synergy by sharing of streams and there is a lot of



thinking and planning in this regard," he said. "Changing market dynamics clearly indicate that integration of refining and petrochemicals is more of a ne-

cessity than a choice" and is needed for improving margins and remaining competitive.

The International Energy Agency (IEA), he said, sees the biggest

growth coming from petrochemical feedstock such as ethane, LPG, naphtha, and jet fuel. "It is estimated these products will account for around 90 per cent of the net increase in total oil prod-Demand uct demand

Kumar said India's oil refining capacity will rise from 249 million tonnes per annum now to 300 million tonnes by 2024-25 and 443 million tonnes by 2030.
