# Babus flout norms, benefit pvt firms

CAG AUDIT REPORT RELEASED RECENTLY FOUND SEVERAL IRREGULARITIES BY ODISHA OFFICIALS TO HELP UNDESERVING FIRMS

Bhubaneswar, April 10: Decisions taken by some bureaucrats such as the former Executive Director and CEO of Odisha Rural Development and Marketing Society (ORMAS) seem to have offered safe havens to several ineligible and tainted private firms who looted taxpayers' money allegedly in connivance with these babus.

The audit reports of the Comptroller and Auditor General of India (CAG), which were released recently, revealed that several private firms gained undue benefits, thanks to ORMAS officials. In few cases, the Principal Secretary of the Panchayati Raj department too defied norms crafted by the Union government under the Deen Daval Upadhaya Grameen Kaushalya Yojana

Massive irregularities were reported in selecting the Project Implementing Agencies (PIAs), private agencies hired by the government for training, placement and other works. In the absence of verification of the background of the agencies, several tainted PIAs obtained lucrative contracts from ORMAS - the key agency involved in the project.

An audit of the contracts given to these PIAs indicated that many of them had fudged data and cheated the government in several ways, produced fake PF and ESI numbers and inflated their earnings to procure government

In many cases, the ORMAS  $\operatorname{ED}$  and CEO personally interfered in awarding contracts to some private agencies in open defiance of the established norms. He even helped them get second or third contracts despite not performing as per the provisions and verification agencies like NABARD Consultancy Services Pvt Ltd (NAB-COMS) and others submitting adसपने हो रहे साकार

 $verse \, reports \, of \, \, fudging \, data \, by \, these$ PIAs. At times, ORMAS formed additional panels for verification sidelining NABCOMS and others to give clean chit to the erring PIAs against whom NABCOMS brought charges of irregularities.

ASD Education Private Limited, an Indian training arm of an Australian training company is a case in point. Two IAS officers - Principal Secretary of Panchayati Raj and Secretary of Skill Development & Technical Education, in addition to the ED of ORMAS, were invited by the firm to Australia in June 2017. In turn, these officials favoured the firm by placing its pro-

posal before the internal committee in July 2017, exempting them from furnishing the qualitative appraisal.

The Central government's norms make it mandatory for PIAs to get their 'qualitative approval' done prior to placing the proposal before a Project Approval Committee (PAC). While applications of many agencies were rejected on this basis, the application of ASD Education Pvt Ltd was approved by the PAC even without the qualitative appraisal, the CAG report said.

Many such private agencies also got contracts of higher amounts while as per norms they were allowed to be given contracts only up to four times

of their annual turnovers based on their categories. In one case, during verification of a PIA named Surya Wires Pvt Ltd in 2018 it was found to lack facilities to open a centre for training.

"Despite such reported deficiencies the ORMAS ED proposed that ₹2.90 crore be released to the PIA as first installment of the project. The Principal Secretary of Panchayati Raj also gave his nod to the project," the CAG report said. Later, during inspections, ORMAS found that the centre was not functioning at all.

placed post training had salary accounts opened in UCO Bank. When asked by CAG to substantiate the claim, the bank said that six bank accounts were non-existent and no such transaction had taken place in 33 accounts. It was claimed that these candidates were employed by three PIAs who received ₹27.89 crore from the government.

There are several such cases of gross negligence in scrutiny, compliance of the norms and interference by ORMAS babus in awarding government contracts to ineligible PIAs.

In response, the ORMAS either admitted those charges or claimed to have initiated recovery processes. The CAG in its report demanded fixing responsibility of the gross irregularities and proceedings against the erring officials. CAG report said that between 2014 and 2019 14, per cent of the trainings and 77 per cent of the placements under the scheme were false and fabricated, hinting at the large-scale irregularities and loss of taxpavers' money.



#### BMC still charging holding tax at hiked revised rates

Bhubaneswar, April 10: Despite state government's order to refrain from collecting holding taxes on the basis of the revised rates, the Bhubaneswar Municipal Corporation (BMC) continues to charge the taxes as per the new rates on its online platforms making life difficult for denizens.

In view of  $\operatorname{rising} \operatorname{COVID}$ cases, the civic authority here had closed its office for the general public, allowing entry only to staff members. It requested the citizens to use its online platform, Bhubaneswar.me, to redress any grievances, license approvals or payment of dues.

However, much to surprise of the citizens, the online portal and the application which allows payment of holding taxes under BMC's citizen services, is still charging the inflated amounts. This despite the Odisha government order in March putting on hold the BMC's decision to collect holding tax at higher rates until the High Court gives it verdict on the issue.

"I used to pay about ₹780 as holding tax yearly before the BMC increased the rates.



The new rates shot up my holding tax up to 45 times and I was asked pay about ₹35,000 annually. However, I was relieved after the government ordered the BMC to collect taxes on the old rates," complained Prafulla Panda, a senior citizen at Satva Nagar.

It can be mentioned here that the BMC in October 2019 had revised the benchmark value of land cost of different mouzas and effected the new rates from April 2020. This resulted in unprecedented rise of holding taxes for the people. Meanwhile, responding to the non-compliance of the state government orders, BMC's Deputy Comm-issioner, Revenue, Srimanta Mishra said, "We are following the orders but the non-revised rates only apply to physical mode of payment. Kolkata/Cooch Behar, April 10: Five people were killed, including four in the firing by CISF personnel, during the fourth phase of polling Saturday for 44 assembly seats of West Bengal, triggering a political firestorm.

Four people were killed as Central forces opened fire allegedly after coming under attack from locals, who "attempted to snatch their rifles", in West Bengal's Cooch Behar district,

police said. The Election Commission ordered stopping the voting exercise at polling station number 126 in Sitalkuchi where the incident hap-

pened when polling was underway. "According to preliminary reports, four persons were killed as CISF personnel opened fire after coming under attack in a village. A scuffle took place, and locals gheraoed them and attempted to

snatch their rifles, following which

the central forces opened fire.

Further details are awaited," a police official said. The EC has sought a detailed re-

port on the incident. According to official sources, the preliminary report submitted by EC's special police observer Vivek Dubey said a huge mob of around 350-400 people had gheraoed the central forces, following which

New Delhi, April 10: With 1,45,384 fresh coronavirus infections, India has recorded the highest-ever single-day surge since the start of the pandemic, taking the tally to 1.32,05,0926, the government data this morning showed. In the last 24 hours, 794 people died; 1,68,436 people have died so far.

Active cases in the country hit by the second COVID wave have now passed the 10 lakh-mark as the spike in cases triggers fresh restrictions in different parts.

This is the fourth consecutive day that India has recorded more than 1 lakh cases in 24 hours.

Over 6.16 lakh infections have been reported just in the last five days. 3,335 people have died during this period. The fresh daily surge in more than double the number of cases recorded on March 31 - 53,480. The number of deaths recorded in the last 24 hours is also the highest since March 31. Across the country, fresh curbs are being imposed to contain the spread of infection. Weekend lockdown starts from today in Maharashtra, which recorded 58,993 COVID cases in the last 24 hours.

The state, worst-hit in India, is headed towards a lockdown if the situation does not change. Maharashtra-Health Minister Rajesh Tope had earlier told reporters.

# China slaps record \$2.7bn fine on Jack Ma's Alibaba

THE FINE, ABOUT 4% OF ALIBABA'S 2019 DOMESTIC REVENUES, INDICATES CHINA'S ANTITRUST ENFORCEMENT ON INTERNET PLATFORMS HAS ENTERED A NEW ERA

Shanghai/Hong Kong, April 10: China slapped a record 18 billion yuan (\$2.75 billion) fine on Alibaba Group Holding Ltd Saturday, after an anti-monopoly probe found the e-commerce giant had abused its dominant market position for several years.

The fine, about 4% of Alibaba's 2019 domestic revenues, comes amid a crackdown on technology conglomerates and indicates China's antitrust enforcement on Internet platforms has entered a new era

after years of laissez-faire approach. The Alibaba business empire has come under intense scrutiny in China since billionaire founder Jack Ma's stinging public criticism of the country's regulatory system

A month later, authorities scuttled a planned \$37 billion IPO by Ant Group, Alibaba's Internet finance arm, which was set to be the



### Hello Charlie has neither laughs nor logic



irector Pankaj Saraswat of *Hello Charlie* had once upon a time screenplayed a delightful little comedy called Main Meri Patni Aur Woh. That was in 2005, over a decade and a half ago. All these years later, Saraswat has chosen mindless monkey mayhem for his feature film directorial debut -- the sort that stopped being funny a while back.

The movie largely draws from stock formulae, banking mostly on not very witty but nonetheless funny gags to score. It takes a certain knack to pull off such a trick (ranrecall:

Rajkumar Santoshi's *Andaz Apna* or the numerous films Privadarshan recreated from his old Malayalam hits, or even Indra Kumar's *Dhamaal*). The generic prerequisite of such films is to raise the laughs, never mind being low on logic. Hello Charlie has neither



New Delhi. April 10: Even as the process of resolution at Mahanadi Water Dispute Tribunal is running at snail's pace owing to Covid-19 pandemic, officials from both the states –Odisha and Chhattisgarh– opine that the Centre needs to grant extension of the tribunal for time lapse due to the pandemic.

The tribunal, constituted in 2018, has completed three years March 12, 2021 and is now on the statutory extension of two years. The officials of both the states opined that the Union government should grant extension to the tribunal for the period lapsed due to Covid-19 pandemic as two-year extension is not enough. For, it is unpredictable as to how long the pandemic would

An Odisha government official said that the tribunal, through its 20 sittings held so far, has completed only 20 per cent of the work while 80 per cent is still pending. The tribunal had to cancel many hearings due to the pandemic in 2020 and it has again cancelled the April 10 hearing following a letter from Chhattisgarh government wherein the state has expressed its inability to appear in the tribunal as many areas were declared containment

### **Outfit holds 'Jal** Satyagraha' in Cuttack

**CUTTACK:** Activists of Mahanadi Bachao Andolan Saturday held a 'Jal Satyagraha' in Mahanadi river near Jobra barrage here to highlight their demands.

Activists of the outfit claimed that the Mahanadi Water Dispute Tribunal, which was scheduled to hear a case over sharing of Mahanadi water Saturday, has postponed the same to May 8 by accepting a plea from Chhattisgarh.

They urged the tribunal to pronounce an interim order and ask Chhattisgarh to open the gates of Kalma barrage and ensure uninterrupted water flow in Mahanadi.

The outfit also sought a whitepaper on Green Mahanadi Mission from the state government. The mission had been launched to plant at least 2 crore saplings along Mahanadi and its distributaries, outfit sources said.

The outfit also pleaded for construction of a few new barrages on Mahanadi in Odisha and concrete steps to conserve the river water.

The state government should take immediate steps to remove encroachments from Mahanadi riverbank and check water pollution in the lifeline of Odisha," the outfit said.

Commission, Ministry of Environment and Ministry of Jal Shakti took long time to share the documents even after the order of the tribunal. Still some documents are yet to be shared by the Central agencies," the official said.

Bhubaneswar, April 10: In a shocking incident, dreaded gangster Suleiman Hyder Saturday escaped from surgery ward of the SCB Medical College and Hospital in Cuttack by reportedly drugging the lone security guard in place.

The security guard is now undergoing treatment at SCB while the Commissionerate Police has launched a manhunt to arrest the gangster. According to sources, Hyder was recently shifted from VIMSAR in Burla to SCB for treatment and kept in Cabin No. 5 of

the surgery ward. Speaking to media persons, Cuttack DCP Prateek Singh said Hyder drugged the sentry and escaped from ward. He said that search on the notorious criminal and all the entry and exit points to the city have been sealed. A special team has been formed to nab Hyder. Kendrapara and Jajpur SPs along with DCP, **Cuttack DCP Prateek** Singh said Hyder drugged the security guard and escaped from ward

Cuttack have jointly launched a manhunt. All the neighbouring SPs have been alerted about the incident. The whole episode put a huge question mark on the lackadaisical approach by the jail authorities towards the security arrangements for the notorious criminal.

Hyder was serving life imprisonment in the circle jail at Sambalpur after he was found guilty of killing Rashi Ranjan Mohapatra and Sk Chuna. He was shifted to Sambalpur circle jail following a gang war inside Jharpada jail in 2017. Hyder along with Tito was engaged in several wrongful activities in the coastal belt of state for several decades.

### UTP at Jharpada jail alleges torture

Bhubaneswar: An undertrial prisoner (UTP) lodged in Jharpada special jail has alleged severe torture by some staffers of the prison. The UTP has reportedly submitted a plea to the Chief Justice of Orissa High Court through one student leader Mahesh Prasad recently. Prasad Saturday revealed the whole episode before the media here. According to the letter, November 11, 2020, the UTP, Rakesh Behera, was waiting to make a phone call again to his advocate as the lawyer did not pick up the first call. But a warder, Jayaprakash Pradhan, snatched away the phone from him. Upon protest, Pradhan allegedly beat Behera in front of other inmates. Behera also alleged in the letter to the Chief Justice that Pradhan along with eight other staffers came to Beher's ward and started beating him up mercilessly. Behera sustained severe injuries and also broke one of his limbs.


Jailor show-caused


# OHRC to investigate RTI activist's death

Bhubaneswar, April 10: The Odisha Human Rights Commission (OHRC) has recently directed its investigating wing to probe the alleged murder of RTI activist Ranjan Kumar Das last year.

The commission, while hearing a plea filed by the state body of RTI activists, directed the ADGcum-director, investigation wing of OHRC, to personally enquire into the suspicious death of Das. The ADG has been directed to submit its report within six weeks of the issuance of the order.

Earlier, Kendrapara district Superintendent of Police, in its report submitted before the OHRC. claimed that the deceased Das had died in a road mishap 30 January, 2020. However, the complainants objected to the conclusion by the SP. They also reportedly presented various evidences suggesting murder of the activist by unknown miscreants. Das had also allegedly received a number of threats for exposing corruption in the block and other nearby areas

## 14-year-old rape survivor's pregnancy terminated

Cuttack, April 10: The pregnancy of a 14-year-old rape survivor was terminated at a hospital in Cuttack Saturday, following an order of the Orissa High Court, officials said. The girl was in the 23rd week of her pregnancy, they said.

The procedure was done at SCB Medical College and Hospital after approval by a medical board, they added.

The High Court, Friday, directed the medical superintendent of the hospital to constitute a board of three experts to examine the girl and go for the procedure "at the very earliest" as per its suggestion.

The direction was given by a division bench comprising Chief Justice S Muralidhar and Justice BP Routray on a writ petition filed by a native of Puri. In the petition. the father of the girl prayed for the medical termination of the pregnancy of his daughter as per the MTP (Amendment) Act of 2021.

referred the girl for the hospital in Cuttack March 26, noting in the referral sheet that her pregnancy was 21 weeks old.

On March 30, the referral hospital wrote to the Director of Medical Education and Training (DMET), stating that since the pregnancy was more than 20 weeks old, the medical termination of pregnancy (MTP) could only be done with permission from the court.

Considering the recent amend-

ment in the MTP law, the HC directed the SCB authorities to form an opinion by Saturday noon and proceed to arrange for the termination procedure at the very earliest as the rape survivor is already in the 23rd week of pregnancy.

The new law has raised the upper limit for permitting abortions to 24 weeks for "special categories of women", including rape survivors, \_ victims of incest, minors and the differently-abled.

inequality across the state. Speaking on gender equality, Dr. Sonu H Subba, head of Community Medicine and Family Medicine at AIIMS, Bhubaneswar said that inequalities in the healthcare has been affecting the sector and is more evident when it comes to gender gap. She said that out of 156 countries, India was ranked 140 on global gender gap index.

# Subarnarekha water level sinks

WATER SCARCITY HITS FARMING AND GROUNDWATER LEVEL IN RIPARIAN AREAS

POST NEWS NETWORK

Jaleswar, April 10: The Subarnarekha river is said to be the lifeline of north Balasore, but its usual water level has been down due to continuous lifting of sand from its riverbed. The riverbed is sinking every year with rampant mining of sand by the Bengal mafia, a report said.

The deepening of the riverbed has resulted in massive erosion of its banks at many places and change

The falling water level of the river has caused problems for irrigation of farmlands. River water is out of reach for farmers in the riparian pockets, locals alleged.

It has also impacted the groundwater level in the area. The groundwater has gone down by 100 ft this summer. Many tube wells have been defunct due to shortage of water in the river basin areas, it was

"Earlier, we used to get enough water from the river to irrigate our farmland during summer. People used its water for various purposes like drinking and bathing. Now, river water has been scarce. Water crisis has affected many areas," locals lamented.

### Junagarh skill training institute defunct

Junagarh, April 10: A skills training centre for various professional courses has been lying closed for decades in Junagarh area of Kalahandi district. There has been no effort to revive it, a report said.

According to the report, the government had set up a Training -cum-production Centre (TCPC) at Junagarh in 1950 so as to impart training to unemployed youths on various trades like carpentry, ice engine, tile-making and sewing. About 50 youths could get training in a batch. Teachers and trainers had been appointed.

However, the old institute lost its relevance in 1961 after the government set up an ITI at Bhawanipatana, TCPC gradually became paralysed and finally shut down. In 1989-90, the teachers and

appointed by the SC/ST welfare department, lost their jobs, Costly machines and implements were shifted to the Hirakud ITI and Bhawanipatana ITI. Two acres of land used by the TCPC are lying un-

In the old building of the TCPC, office of the government treasury was operating for a few years. After the treasury office was shifted to the tehsil office, the horticulture office functioned from the TCPC building for some years

Now, the old building is lying abandoned while its premises play host to anti-social elements day and night, locals alleged. In 2018-19, the government had initiated steps for revival of the TCPC. Two of its building near Indravati Colony were restored at a cost of Rs 20 lakh. However, contractors botched up

These two buildings are in a dilapidated state. "Buildings and land are there. Thousands of youths are unemployed. ### **Curtailed freedom**

This morning has brought the headline 'People are free to choose their religion: Supreme Court'. The report was about a public interest litigation which sought to stop Indians from converting out of the faiththey were born in. The judges were angry. They said: "What kind of writ petition is this? Why should a person above 18 not choose his religion?"

The petitioner was the BJP's Ashwini Upadhyaya. The Indian judiciary has had a long history with the freedom of religion. It might be appropriate to revisit it. First, let readers understand this. You have no freedom of religion. You have no right to convert out of the faith you were born into. I do not know if our judges know this or have actually read the law. But it is

Article 25 of our constitution reads: "all persons are equally entitled to freedom of conscience and the right freely to profess, practise and propa-

This is apparently a Fundamental Right, meaning one which enjoys a high degree of protection from State encroachment. The Fundamental Right was drafted after a debate in which India's Christians had specifically asked for the right to propagate (to convert other people) because it was an article of their faith. In India Muslims do not do mass propagation; even the Tablighi Jamaat only seeks to make Muslims better Muslims. It is the Christians who believe their religion requires them to spread the good word of Christ and to invite people into their faith. They asked for this right and were given it

specifically by our Constitution's makers including arch Hindu fundamentalists like KM Munshi who agreed with the Christians. Only one Hindu in the Assembly opposed the right to propagate and that was 26-year-old Brahmin man from Odisha, Loknath Misra, whose brother Rangnath Misra and nephew Dipak Misra would both become chief justices of India.

Misra said that by making India secular, Hindus had done a favour to other communities and that propagation should be allowed but not given as a Fundamental Right. He need not have worried because this right was taken away by subterfuge as has been the case for many rights in India under the approving eye of the Supreme Court. Let us see how by looking at just

In 2003, under Narendra Modi, Gujarat passed a law that essentially removed all freedom of religion for Gujaratis. It requires individuals changing their faith to take the permission of the government. They had to fill out a form explaining to the District Magistrate the reasons they were choosing to convert; their occupation and monthly income; how long they had been in the religion they were converting out of; to

reveal whether they were Dalit or Adivasi; the date and time of their conversion; the names, addresses and ages of themselves and all in their family; the names and addresses of all guests attending the ceremony. If they did not do so within ten days of their conversion, they faced one year in jail.

The person who is converting them has to fill out another form with all of the details referred to above and must submit, one month before the conversion, an application to the District Magistrate seeking permission. The bureaucrat has one month in which to approve or deny permission. This denial of propagation obviously also affects the right of the person who wants to change their faith. One had to remain in the faith they were born in unless the government approved.

The District Magistrate must also maintain a register that has the number of applications received, approved, denied or pending which he must re-

port every quarter. The coercion can be imagined. Gujarat's Assembly was told in January 2020 that in the previous five years a total of 1,895 'applications' for conversion had been filed in the state. Gujarat had denied permission to convert to 889 individuals.

The government 'gave permission' to 1,006 applicants, almost all of whom were Dalits in Surat converting to Buddhism. The number of Dalit applicants to convert to Buddhism had swelled because in 2014, they had been denied permission to convert in a mass ceremony. The Modi government attempted to modify the law to exclude conversions from Buddhism and Jainism to Hinduism and vice versa from the State's regulation. Meaning that Jains and Buddhists would be seen legally as Hindus and therefore would not really be 'converting'. But this was objected to by Gujarat's Jains who resisted being clubbed with Hindus and the modification was withdrawn.

I have used the example of Gujarat but all most of India's states have these laws criminalising what is supposed to be a Fundamental Right.

The Guiarat law's punishment for propagation is three years (four years if the convert was a woman, Dalit or Adivasi). But how the District Magistrate's denial of permission would work at the level of faith was unclear. One priest I spoke to said India's religion laws made no sense because of the nature of belief. He said: 'Suppose I stopped believing in Christ today. This would be a conversion from being a believer to a non-believer. I am supposed to take permission from the State for this change, but I have already stopped believing.

In recent months, B.IP run states like Uttarakhand, IIP MP and others have passed the 'love jihad' laws which tighten the State's grip on religious freedoms further. It is totally and demonstrably false to say Indians have free-


#### Mociology

# INDIA'S INFRASTRUCTURE BINGE



**INFRASTRUCTURE FINANCING WOULD BE A GAME CHANGER** IN THE **ECONOMIC MANAGEMENT OF THE COUNTRY** 

ridging the infrastructure deficit is a major challenge for India. In the past, between 1948 and 1964, three financial institutions were established to provide long-term finance — the Industrial Finance Corporation of India (IFCI), the Industrial Credit and Investment Corporation of India (ICICI) and the Industrial Development Bank of India (IDBI). Three decades down the line with policy changes the Reserve Bank of India (RBI) could not continue with the concessional funding it was providing in the form of longer-term operation funds. As a result, these institutions were subjected to market-based borrowing and lending rates which they could not sustain. Subsequently, the institutions were converted into banks. This policy change also left an institutional vacuum in infrastructure financing.

In the context of infrastructure development it is worth noting the observations of Raghuram Rajan, former RBI Governor, in his book "I do what I do" (2017). It precisely mentioned that the ambitious plan for building our infrastructure includes: ensuring the availability of inputs such as power, minerals and water at competitive prices; linking everyone electronically and financially; encouraging development of markets, warehouses, regulators, information aggregators and business correspondents. In certain areas our achievement is commendable and in some a lot has to

Infrastructure financing would be a game changer in the economic management of the country. The concept of setting up of a national infrastructure bank at the apex level was suggested by this author in his article "National Infra Bank" published in **Orissa POST** on 24 April 2013. It's good to see that this concept has seen the light of the day in the Union Budget 2021-22.

In the Budget, Union Finance Minister Nirmala Sitharaman announced that "Infrastructure needs long-term debt financing. A pro-

fessionally managed Development Financial Institution (DFI) is necessary to act as a provider, enabler and catalyst for infrastructure financing. Accordingly, I shall introduce a Bill to set up DFI.'

Taking the matter forward, the government on March 23, 2021 tabled in the Parliament and passed the National Bank for Financing Infrastructure and Development Bill 2021 that among other things, seeks to establish a statutory institution to support the development of long-term infrastructure financing in India and to carry on the business of financing infrastructure. The statutory institution called National Bank for Financing Infrastructure and Development (NABFID) would have developmental and financial objectives. As per the government pronouncements, NABFID will be a statutory body to be ready shortly. It will be set up with a corpus of ₹20,000 crore and the government will give an initial grant of ₹5.000 crore. The Centre expects the DFI to leverage the fund to raise upto ₹3 lakh crore in the next few years. This is a significant step in transforming India's manufacturing sector and a positive move towards \$5 trillion economy, which may take more than five years to realise.

In the past, the government had experimented in India's infrastructure financing. India Infrastructure Finance Company Limited (IIFCL) was incorporated as a wholly-owned Government of India company in January 2006 and commenced operations from April 2006 to provide long-term finance to viable infrastructure projects. The RBI invested \$5 billion from its foreign exchange reserve, in fully government guaranteed foreign currency bonds issued by an overseas SPV of the IIFCL. The funds thus raised were used by the company for on-lending to Indian companies for infrastructure. In response to an announcement in the Union Budget 2014, the RBI in July 2014, allowed banks to issue long-term bonds with minimum maturity of seven ing (i) long-term projects in infrastructure and (ii) housing. The scheme was not very successful as banks may face ALM mismatch

and the lurking NPA load. It may be recalled that reforms in infrastructure sector started to gather momentum in the mid-1990s. In 1996, the Expert Group on Commercialisation of Infrastructure Projects (Chairman DrRakesh Mohan) gave a blueprint for reforming the sector as it addressed issues of both financing and regulation. In 1997-98 the Infrastructure Development Financial Corporation (IDFC) played a pivotal role in financing infrastructure projects. In the same period. Telecom Regulatory Authority of India(TRAI) was set up. In 1995, the National Highway Authority of India (NHAI) and in

1998 the National Highway Development Project (NHDP) were set up to enhance connectivity. Pradhan Mantri Gram Sadak Yojana was having the same ef fect on rural connectivity. Side by side Tariff Authority of Major Ports was set up and private sector was allowed. The period 1995-98, thus, saw a quantum jump in infrastructure policy development to push growth.

Power sector reforms were initiated in Odisha in mid-1990s based on policies first introduced with the help of the World Bank. The reform process involved 'unbundling of vertically integrated public-sector power utilities into separate entities involved in generation, transmission and distribution of power. The Electricity Act, 2003 supports creation of a single national market for power with multiple buyers and sellers.

Tele-density in India has witnessed a quantum jump. In 1991, at the beginning of financial reforms, five million Indians had telephones. India's telecommunication network is the second largest in the world by number of telephone users (both fixed and mobile) with 1171.80 million subscribers as on 31 October 2020. As on 31 October 2020, India has the world's second-largest Internet user-base with 734.82 million broadband Internet subscribers.

Developing corporate bond market would go a long way in augmenting resources for infrastructure. So far the corporate bond market has not made any visible progress in India. Bond market finds it difficult to have a decent market share. SEBI is taking steps to develop the bond market. Foreign investments help deepening debt and derivative markets as they contribute to liquidity and price discovery.

The infrastructure development would expand international trade, make the exports cost competitive, enhance economic fortune of the country, spur growth and create a new economic geography.

ity in a turbulent region. That assumption seemed sound. Jordan was barely scarred by the upheavals of the Arab Spring a decade ago. But if that stability turns out to be illusory, one must worry about Jordan following Syria and Iraq into a state of turmoil that could also drag in Israel and Saudi Arabia, as well as providing new terrain for extremist groups like the Islamic State and al-Qaeda. Given the stakes, the US and Jordan's other Western allies might vet find themselves involved in another Middle East conflict.

am not the person responsi-evitable. Hamzah denies any role in between King Abdullah and Israeli as the International Monetary Fund. ment on April 5: "In light of the developments of the past two days, I put myself at the disposal of His Majesty the King." Since King Abdullah had dismissed Hamzah as crown prince in 2004, replacing him with his own son, that declaration of loyalty (grudging or not) is valuable.

But as custodians of Jerusalem's al-Agsa mosque, the third holiest site in Islam, the Hashemite dynasty stands in the way of MBS' grand ambitions for the House of Saud. It was MBS's own grandfather, after all, who wrested control of Mecca and Medina from the Hashemites back in 1924-25.

Notwithstanding the supposed solidarity among Arab monarchies, MBS might see normalisation of Saudi relations with Israel as a way to gain unchallenged control of al-Aqsa. This could be presented as the natural next step following the Abraham Accords between Israel, the United Arab Emirates, Bahrain, Sudan, and Morocco.

In this scenario, sidelining the Hashemites would be a small price to pay. In weighing the risks, MBS knows that the Jordanian monarchy is utterly dependent on largesse - much of it from the Arab petrostates, the US, and agencies such

pends on his political skill, efficient security agencies, and luck. Since ascending to the throne in 1999 following the death of his father, King Abdullah has benefited from all three. However, luck can run out, even for a dynasty that traces its lineage back to the Prophet Muhammad. Roughly half of Jordan's ten million people are Palestinian. And while Jordanian tribes'loyalty has traditionally been beyond question. Hamzah's popularity with them may have spurred suspicions of a coup.

Hashemite rule in Jordan has survived wars with Israel, waves of Arab nationalism, conflict with the PLO, and the lure of Islamist extremism. More challenges are bound to come, and, as King Abdullah well knows, survival is not guaranteed. "Sedition came from within and without our one house,' the king said on April 7, "and nothing compares to my shock, pain, and anger as a brother and as the head of the Hashemite family, and as a leader of this proud people.

**Vax will last for five** days only: Punjab CM

Hoping that the Centre would send fresh batches of vaccine supply soon, the Chief Minister said if the state is able to meet its target of 2 lakh vaccines a day, then its current supplies will last only five days

Chandigarh, April 10: With Punjab left with only five days of supply (5.7 lakh Covid vaccine doses) at the current levels of vaccinating 85,000-90,000 persons a day, Punjab Chief Minister Amarinder Singh has urged the Centre to share the schedule for supply of vaccines with the states over the next quarter based on their confirmed supply orders.

Hoping that the Centre would send fresh batches of vaccine supply soon, the Chief Minister said if the state is able to meet its target of 2 lakh vaccines a day, then its current supplies will last only three days. He said he had written to the Prime Minister and the Union Health Minister to give confirmed supply schedules.

Despite being a slow-starter in vaccination, Punjab has vaccinated more than 16 lakh persons, at an average of around 85,000-90,000 per day, he said during a video conference convened by Congress President Sonia Gandhi to discuss the Covid



situation. The meeting was attended by chief ministers of the Congressruled states, as well as senior party leaders, including Rahul Gandhi.

Captain Amarinder said people in Punjab were still not coming out in large numbers for the vaccination due to the massive anger prevailing against the government of India on the issue of farm laws.

Since Punjab has majority population among the agriculture community, even the common man is affected by the farmers' agitation, he said, adding "this anger is impacting the vaccination drive.a

#### Kerala records 6,194 Covid-19 cases, toll crosses 4,700

Thiruvananthapuram, April 10: Kerala continued to witness a steep surge in COVID-19 cases with 6,194 cases being reported Saturday as the active cases crossed 39,000 and the toll mounted to 4,767 with 17 more deaths. As many as 2,584 people have been cured of the infection, taking the total recoveries to 11.115.342



The total caseload has soared to 11,60,204 and 39,778 are undergoing treatment for the infection, according to a government release. As many as 1,64,894 people are under observation in various districts, including 5,906 in hospi-

In the last 24 hours ending 2 pm, 61,957 samples were tested and the test positivity rate rose to 10 per cent, the release said. So far, 1,37,03,838 samples have been sent for testing.

Ernakulam recorded the highest number of cases -- 977- today, followed by Kozhikode at 791 cases.

### Kerala min to move HC after Lokayukta asks him to quit

The dollar case pertaining to the alleged smuggling of USD 1,90,000 (equivalent to ₹1.30 crore) by a former finance head of the UAE Consulate in Thiruvananthapuram to Muscat in Oman, came to light during the probe into the Gold smuggling case.

Swapna Suresh, key accused in



# Plea in SC seeks transfer of petition on 'Uniform Civil Code'

New Delhi, April 10: A plea has been filed in the Supreme Court seeking transfer of a petition on Uniform Civil Code issue, pending in the Delhi High Court, to the apex court to avoid multiplicity of litigations.

#### 'Tika Utsav' from Sunday

New Delhi: A 'Tika Utsav' or vaccine festival will be marked in the country from April 11-14 at the behest of Prime Minister Narendra Modi with an aim to inoculate maximum number of eligible people against the coronavirus amid a surge in cases. Several states such as Uttar Pradesh and Bihar are gearing up with appeals being made to eligible people to get themselves vaccinated during the duration of the 'Tika Utsav'. In his interaction with chief ministers to discuss the COVID-19 situation and the ongoing vaccination drive Thursday, Prime Minister Modi had urged them to focus on vaccinating all those who are above 45 years in age in high caseload districts.

The country's lowest daily spike of just 8,635 infections was reported February 2. But the ebbing did not last long, and the infections began surging again in March 2021. A large number of healthcare

workers have contracted the virus too, including those who have taken both doses of the vaccine. Over 9.78 crore COVID-19 vaccine

doses have been administered in the country so far to healthcare and frontline workers, and people above 45.

India is racing against time to contain the second wave of the coronavirus by again imposing restrictions like night curfews and vaccinating over 20 lakh people daily. Making matters worse, several more infectious variants of the coronavirus have surfaced, and many experts believe might be behind the surge of cases in the country.

### 3 rescued rhino calves to be released into wild

Golaghat (Assam), April 10: Three rhino calves, including two females, rescued during the 2019 Assam floods will soon be released into the wild.

The rhinos, rescued near the Kaziranga National Park, will be kept at a livestock enclosure for a stipulated period of habituation before their final release into the Manas Tiger Reserve in Barpeta district, a Wildlife Trust of India (WTI) statement said. They underwent

two-year-long rehabilitation at the Centre for Wildlife Rehabilitation and Conservation, Kaziranga National Park and Tiger Reserve Director P Sivakumar said.

"This is the right time to release the calves into the wild as they will soon be developing horns," he was quoted as saving. The calves will undergo a medical check-up and will be marked before they are released, he said. "We have augmented Manas with 19 rhinos since 2006, out of a total population of 44 in the tiger reserve," he added.

New Delhi, April 10: India and China have agreed to resolve the outstanding issues aimed at disengagement along the Line of Actual Control (LAC) in Eastern Ladakh, thereby paving the way for complete de-escalation, the Indian gov-

ernment said Saturday. The two sides agreed on the need to resolve the outstanding issues in an expeditious manner in accordance with the existing agreements and protocols, a government statement said.

Talks between Indian and Chinese military delegates were held at Chushul Friday to discuss the next phase of disengagement in Eastern Ladakh, which lasted for 13 hours.

The 11th round of Corps Commander-level talks at Chushul took place after a nearly two-month gap. The Indian military delegation was led by Lieutenant General PGK Menon, the Commander of 14 Corps based in Leh.

The two sides had a detailed exchange of views for the resolution of the remaining issues related to disengagement along the LAC.

It is also highlighted that completion of disengagement in other areas would pave the way for the two sides to consider de-escalation of

**Srinagar, April 10:** The terrorists were inside the mosque and security forces, as well as a host of anxious locals, outside. The situation in Kashmir's Shopian town was volatile and the challenge was to flush out the five men while protecting the place of worship but it was 'mission accomplished', officials said Saturday.

Enabling the successful effort, which culminated in what was the first time in more than 20 years that five terrorists were gunned down in the restive south Kashmir town, were the parents of the terrorists and prominent citizens of the area, the officials said, counting up to 17 appeals made to them to surrender peacefully.

As the tension built up over the hours between Thursday night and Friday afternoon, the loudspeaker rang out intermittently with appeals from the parents of the terrorists holed up inside the Jama Masjid, citizens and Army personnel. Groups of people were also sent inside to negotiate with the men to come out peacefully, officials recounted. That didn't happen. Finally, Friday

afternoon, the last of the five men of the banned Ansar Ghazwatul Hind (AGuH), a shadow group of the Jaish-e-Mohammed, were gunned down and with minimal damage to the mosque. Narrating the events of the day, officials said the forces of the 44 Rashtriva Rifles and



Within no time, the area was sealed and many civilians evac-

gunned down at 2 pm Friday. The Army had deployed drones to keep a close watch on the movements of the terrorists. Officials said the parents of one of the terrorists, the brother of another and a prominent citizen were sent inside the mosque to ask them to give up arms but to no avail. At one point, a terrorist fired at a citizen who asked them to surrender in order to ensure the mosque is not damaged. The terrorists, officials said, also attempted to set ablaze a portion of the mosque in their attempt to flee.

### UN chief applauds IMF, WB measures to address COVID-19 debt crisis

United Nations, April 10: United Nations Secretary-General Antonio Guterres welcomed the steps announced by the International Monetary and Finance Committee (IMFC) and the World Bank Group Development Committee to address debt crises and other financial distress to economies arising from the Covid-19 pandemic.

In a statement issued via his spokesperson Friday, the UN chief said developing economies had struggled to secure enough financial resources to cope with the onset of the coronavirus crisis, "let alone to recover from it", Xinhua news agency reported.

Since the beginning of the crisis, the secretary-general has called for liquidity, the statement continued, through a large issuance of Special Drawing Rights (SDRs) - an instrument created by the International Monetary Fund to help supplement cash reserves - for those most in need, and a reallocation of unused SDRs.

The secretary-general welcomed the IMF committee's "concrete calls" for a new allocation of SDRs, and voluntary reallocations to countries in need. He said he was encouraged by the

#### Apple to use **ProMotion display**

# revise recapitalisation roadmap for PSBs

New Delhi, April 10: The government may redraw the recapitalization plan for public sector banks (PSB) in the current fiscal as the institutions face additional burden to meet interest on interest obligation for all its borrowers while changes in valuation norms AT1 bonds by Sebi will make the instrument less attractive for banks to raise their capital.

Sources said that the finance ministry has already started a preliminary exercise to determine the capital requirement of banks in wake of the changes in norms and rise in bad assets during the time of the pandemic. Based on the inputs received by banks, additional capital may be provided to them from budgetary resources.

The Budget allocated ₹20,000 crore towards recapitalisation of PSBs to help them consolidate their financial capacity. Some balance from previous year towards recapitalisation is also available for disbursement. Moreover, PSBs have proactively built buffers during financial year 2020-21 (FY21) to im-

#### **SAT ASKS SEBI TO PASS FINAL ORDER** IN SIX MONTHS

New Delhi, April 10: The Securities Appellate Tribunal (SAT) has asked markets regulator Sebi to pass final order in six months in a case related to CG Power and Industrial Solutions. wherein the company's ex-chairman Gautam Thapar and three other former officials were banned from the securities market.

Besides Thapar, the other officials banned were CG Power former chief financial officer V R Venkatesh and former directors Madhav Acharya and B Hariharan.

The SAT ruling comes after Thapar, Hariharan and others moved to the tribunal against a Sebi confirmatory order passed in March 2020, whereby it had barred Thapar, Venkatesh, Acharva and Hariharan "from buving, selling or otherwise dealing in securities in any manner whatsoever, either directly or indirectly, till further orders".



However, they were allowed to liquidate up to 25 per cent of the value of the securities held by

The confirmatory order followed an interim order passed by Sebi in September 2019, which had restrained the officials from the capital markets for "serious" mis-statement of accounts as well as diversion of funds. Besides, it had ordered forensic audit of the company.

Noting that the restraint order is continuing since September 2019, SAT said it cannot be allowed to continue forever.

"Sufficient time is already passed, for the respondent to analyse the forensic report.



Earlier, Suresh Raina announced his IPL comeback with a blazing 36-ball 54 (3x4, 4x6) and powered CSK to a solid 188/7. Sam Curran smashed away to 34 off only 15 balls (4x4, 2x6) to prop up the CSK innings towards the end. The last five overs yielded 52 runs for CSK, thanks to Curran's power-packed innings.

Asked to bat first by Pant, Ruturaj Gaikwad got CSK off the mark with a pleasing drive through the off side between point and cover, two deliveries after being beaten all ends up by a Woakes outswinger.

Last season's runners-up DC didn't have to wait long for their first breakthrough as Avesh (2/23 in 4 overs) had Faf du Plessis trapped in front of the wicket in the second over.

In the first ball of the third over, Woakes had Gaikwad caught in the




