Firm flourishes with OSMCL aid

SANITARY NAPKINS FOR 'KHUSHI' PROCURED AT HIGHER PRICES BY OFFICIALS

Bhubaneswar, April 14: Several private agencies now seem to have made Odisha one of their favourite destinations for making hay while the sun shines at the tax payers' expense, thanks to the officials of the Odisha State Medical Corporation Ltd (OSMCL) who connived with these firms to make it possible.

The indulgence of the erring officials of OSMCL came to the fore recently in the light of audit reports of the Comptroller and Auditor General of India (CAG) relating to the procurement of sanitary pads by private agencies under the KHUSHI scheme. The scheme was launched by Odisha government in 2018 to supply sanitary napkins to adolescent girls

in schools. Interestingly, the supplier of these napkins who sold the same item at lower rates to other states got far better prices from OSMCL. The important arm of the state Health department in its final tender process in 2018 selected one M/s Shree Radhe Hygiene Products Pvt Ltd, Pune to procure the pads at a rate of ₹2.30 per piece.

This firm had given the product at ₹1.57 per piece to Tamil Nadu in 2017-18 and at ₹1.78 per piece to the same state in 2018-19. The firm however received a very attractive rate from Odisha government which procured it at ₹2.30 per piece in 2018-19, leading to an additional payment of ₹19.39 crore in total by the Odisha government. In January 2018, the government had decided to distribute



17.26 lakh pads to adolescent girls under the scheme.

The CAG audit claimed that the failure of the price negotiation mechanism by the OSMCL officials and acceptance of the quoted price of this firm led to loss of government money. As reported, in a imilar scheme named Rastriya Kishor Swasthya Karyakram (RKSK), the supplier had given the pads at lower prices

"The selected firm had agreed to supply the same sanitary napkins at ₹1.74 per piece under the RKSK in May 2018 and quoted (November 2018) ₹2.30 for same napkin in a re-tender for KHUSHI scheme. Therefore the committee should have called for price justification and carried out price negotiation accordingly," the CAG report said.

The CAG audit report also said that OSMCL ignored the prices offered by these firms to other states, giving extra profit to the private agency hired by them. The CAG in its report said that the estimated price submitted by the Expenditure Finance Committee to the Odisha government for budget provision stood at ₹2.08 per price. The audit report said this was also ignored by the OSMCL officials while awarding the contract to the Pune-based firm.

'The financial cost for supply of sanitary napkins cost under KHUSHI is estimated to be ₹85.789 crore (approx) per year. This would involve an extra expenditure of ₹15.29 crore annually compared to the price under RKSK. This aspect was not taken into cognizance while evaluating the price bids," the CAG report said.

The report claimed that interventions by OSMCL officials to get the best rates (lowest) for government were not used and it offered higher prices compared to other states. "Extra expenditure incurred on this account is a loss to the state exchequer and an undue favour to the supplier," said the CAG report.

The Health department in its reply to the CAG justified their decision citing inadmissible input tax credit, additional transport cost and extra packaging cost.

The CAG however dismissed the argument and said that it procured the item at unreasonably high rate and did not go for negotiation to reduce the offered price to save taxpayer's money. The OSMCL also continued to place more orders from the firm, despite the issues raised during the audit.

This clearly demonstrates a well orchestrated plan to siphon off funds from the state exchequer by involved officials. Interestingly, even after the CAG's report, the government has not thought fit to take action against any official involved in the process yet.

Bhubaneswar, April 14: Like other states, Odisha is also witnessing a surge in COVID-19 cases. Keeping this in mind, Chief Minister Naveen Patnaik dedicated Wednesday 47 new advanced life support ambulances to the people of Odisha on virtual mode.

Patnaik expressed hope that these ambulances will meet the increasing demand for transportation of critical patients with advanced life support system. Wishing the people on the occasion of Odia New Year and Maha Vishuba Sankranti, the chief minister expressed confidence that with cooperation from all, the state can beat the second COVID-19 wave

Out of these 47 ambulances, 28

will be managed under 108 emergency services while 19 will be deployed at medical colleges and hospitals to facilitate patient transportations.

These ambulances have been funded from various sources including MPLAD, CSR, District Mineral Foundation (DMF) and Odisha Mineral Bearing Area Development Corporation (OM-BADC)

Odisha has been running emergency medical ambulance services since March 5, 2013. The current fleet comprises of 596 vehicles, out of which 540 have basic life support system and 56 have advanced

life support system. With the addition of these new ambulances, the total number of advance life support vehicles has increased to 103

Haridwar, April 14: More than a 1,000 people have already tested positive in the ongoing Kumbh Mela, officials said Wednesday. This number may rise drastically in the coming days as the present figure has been achieved through random testing. Lakhs of devotees in the past few days and Wednesday flouted COVID-19 guidelines with impunity to take a dip in the Ganga during the third 'shahi snan' of the Kumbh mela festival. Uttarakhand government offi-

cials said that some 50,000 random samples have so far been tested. Among them 408 reports were found positive Monday and 594 Tuesday taking the total number of infected people to 1,002. It is not yet known, how many persons the infected persons have come in contact with. So there is every chance of the numbers increasing manifold in future.

In spite of such a large number of positive cases, the devotees remain impassive and unaffected. "Our faith is the biggest thing for us. It is because of that strong belief that so many people have come here to take a dip in Ganga," Siddharth Chakrapani, a member of one of the Kumbh Mela organising committees said Wednesday. "They believe that Maa (mother) Ganga will save them from this pandemic," he added.

The 'royal bath' marked 'Mesh Sankranti' and 'Baisakhi', and fell two days after a similar convergence of 'sadhus' and other devotees for the second shahi snan-events where following social distancing norms appeared impossible. By noon Wednesday between

eight and 10 lakh people had taken a bath in the river, Uttarakhand DGP Ashok Kumar, who was supervising the arrangements here, said. Sadhus from four of the 13 akhadas were through with the 'snan' by this time.

Police personnel were seen distributing masks among people in the mela area. However, social distancing norms were violated openly by the seers when they and their followers descended the steps at 'Har ki Pauri' ghat to wade into the river.

Most of them were without masks.

The seers from the akhadas took the dip along with their revered deities carried in ornate palanquins at 'Har Ki Pauri', which was reserved exclusively for them. Lakhs of common devotees bathed at the other ghats of the Ganges here and in Rishikesh.

Amid all this Uttarakhand recorded its highest single-day spike in Covid-19 cases Tuesday with 1,925 people testing positive. Dehradun with 775 cases and Haridwar with 594were the biggest contributors to the day's tally.

In Odisha, food security is ensured to the needy under the National Food Security Act (NFSA) and the State Food Security Scheme (SFSS). The HC in its order said, "It

is therefore essential for the State of Odisha to ensure that there are mechanisms put in place even under the SFSS which is supposed to cover the gap under the NFSA, so that no BPL or vulnerable group

person is left out." It also added, "It is not sufficient to state that the government has already covered 80 per cent of the state population under Public Distribution System (PDS). There cannot be any person belonging to vulnerable categories in Odisha who is left out of either the NFSA

or the SFSS. A constant endeavour must be made to increase the coverage with every passing month.

The court has asked the Commissionercum-Secretary of FS&CW department to submit a

longing to BPL and other vulnerable groups have been specifically targeted and included under the SFSS irrespective of whether they are located in an urban or a rural area and whether each such person has a ration card or other document which enables such person to approach a fair price shop or any other distribution centre to avail the rations," the court order said.

OHRC reels under staff crunch, pendency of cases: RTI reply

The rights panel rejects over 20% of complaints lodged by the distressed people

Bhubaneswar, April 14: A person in distress approaches the Odisha Human Rights Commission (OHRC) as a last resort after failing to get justice from any government department. The commission usually receives around 5,000 complaints every year. However, staff crunch and huge pendency of cases have stood as obstacles to justice delivery for the complainants.

The commission rejects more than 20 per cent of the complaints lodged by the distressed people. Most of the cases dismissed by the commission are related to property dispute matters that can be heard in a regular court only. During 2003-04, the commission had received 920 cases out of which 433 cases were dismissed. Similarly, out of the 4,475 cases lodged at the OHRC in 2020, as many as 1,182 cases were rejected as 'dismissal in limine'

Meanwhile, the pending cases are piling up with the rights body every year. The pendency of cases was 459 during 2003-04 that shot up to 16,108 till end of December 2020.



Answering to a query sought through Right to Information (RTI). the commission recently revealed that it has not taken up a single case suo motu during the last couple of years.

The Public Information Officer (PIO) of OHRC revealed that the commission has taken up 76 cases suo motu during the financial year 2015-16. The number of suo motu cases registered at the OHRC dipped to 49 during 2016-17.

However, the PIO informed the applicant that there were no suo motu cases registered at the commission during 2017-18 and 2018-19. Meanwhile, no information is available with the

Some locals claimed that the lady who claims to be the girl's mother is actually her stepmother. However, police reiterated its earlier stand that the lady is her real mother. The CWC will record the girl's statement after she gets normal in the coming few days.

The victim girl in a video had earlier claimed that she along with several others is being forced into prostitution by the locals of a slum under Bharatpur police station. The girl also revealed that the miscreants lured her of a job at a paper mill in Bhubaneswar with a monthly salary of Rs 20,000 and later forced her into prostitution.

The girl, Monday evening, managed to escape from a house at the slum where she was held captive when the miscreants had gone outside.

Record 2,267 fresh cases in state

Bhubaneswar, April 14: Odisha's Covid-19 tally mounted to 3,55,353 as the state registered this year's highest single-day spike of 2,267 new cases Wednesday, a health department official said.

The daily count crossed the 2,000 mark for the first time in 2021, he said. Of the fresh cases, 1,314 were reported from quarantine centres and 953 were detected during contact tracing. Sundargarh district registered the highest number of new cases at 458, followed by Khurda (348), Sambalpur and Bargarh (120 each), Cuttack (117), Nuapada and Nabarangpur (104 each).

'The daily count breached the 2,000 mark almost six months after 2.019 fresh infections were recorded



October 19. 2020." the official said Odisha now has 12.244 active cases, while 3,41,123 patients have so far recovered from the disease.

The state has tested over 94.61 lakh samples for Covid-19, including 33,251 Tuesday, and the positivity rate stands at 3.74 per cent.

The government has started imposing night curfew from 10 pm to 5 am in 10 districts bordering Chhattisgarh and Andhra Pradesh

Nuapada: Migrants return, Covid spiralling

Nuapada, April 14: As Covid-19 plays havoc in neighbouring Chhattisgarh, adjoining Nuapapada district has been witnessing a spike in Covid cases. Migrant workers who have started coming back home are being subjected to antigen tests before allowing entry.

The district administration has stepped up alertness on fringe areas. Some border points have been sealed.

The entry point from Chhattisgarh is the Jonk river railway gate on the Khariar Road. Police personnel and medical staff have been deployed there.

Meanwhile, SP Rahul Jain has taken stock of the situation in Khariar Road and hinted that more police deployment will be done in the area to tighten the Covid-19 curbs on borders.

People coming from outside are told to produce Covid-19 negative certificates while they are put to antigen tests before being allowed entry into the district. As Covid situation is worsening

due to influence of the neighbouring state, the administration has taken up various measures to curb it.

The administration has sealed seven routes linked to Chhattisgarh.

On the other hand, migrant workers from other states have started coming home. The migrants are put to antigen tests and then are put in home quarantine, the SP said.

SAMBALPUR: Veer Surendra Sai Institute of Medical Sciences and Research (VIMSAR) in Burla will have the second Covid Care facility with 300 beds, Chief Secretary Suresh Chandra Mahapatra said Wednesday.

RISE IN INVOLVEMENT OF MINORS IN CRIMES

AT LEAST 102 MINORS HAVE BEEN HELD OVER LAST YEARS FOR COMPLICITY IN CRIMES IN THE SILK CITY

Berhampur, April 14: Minor children are increasingly taking to crime in the Silk City. This came to light as names of over 102 children figured in various criminal cases over last three years, a report said. Reports said that crimes com-

mitted by children under statutory age are described as juvenile delinquency. As per data released by the National Crime Records Bureau (NCRB), juvenile criminals between ages 16 and 18 accounted for more than 60 per cent of the crimes registered against minors in India in 2013.

The city has produced various dreaded criminals in the past. Many of these criminals form their own gangs to establish their supremacy and hegemony in the town. As the number of minors stepping into the field of crime has increased alarmingly, it has become a headache for the law-enforcement agencies as well as the denizens.

According to reports, these minors do not hesitate to commit any type of crime including serious and heinous crimes. They have reportedly taken to this field to lead a lavish and luxurious lifestyle, experts said.

According to available records, over 102 minors have been arrested on charge of committing various crimes during last three years from 2018 to 2020. As many as 22 minors were arrested in 19 cases in 2018, while it was 41 minors in 38 cases in 2019. In 2020, 39 were arrested in connection with 31 cases. A review of some of the crimes

in the city over last few years indicates that there is an increase in involvement of minors in crimes. The gruesome murder of a professor couple or the killing of dreaded anti-social Chicken Ravi took place with the involvement of minors. Minors have been found involved in many robberies, snatchings, attempts to murder and rape cases in the city. The murder of a woman at Ramnagar in Kamapali area in 2014 led to the arrest of a minor, who killed the woman after she resisted his attempt to rob. The

minor decided to loot the woman after he lost all his money in IPL betting, police said.

Similarly, police arrested a rickshaw-puller and his five minor accomplices in a case involving cash loot from Jagannath temple at Courtpeta under Baidyanathpur police limits in 2016. Three minors on a bike assaulted a truck driver and robbed him of cash at Bhabanagar Square on New Bus-Stand Road the same year.

Two minors were arrested on charge of theft of ₹3 lakh from a bike showroom at Khodasingi under Baidyanathpur police limits, December 20, 2020. Similarly, two minors were arrested for the murder of a youth at Masihakhali village under Sadar police limits during New Year celebration, December 31, 2020.

Later, five minors were arrested in connection with the murder of Rabi Pradhan, January 18, at Mahurikalua Square under Sadar police limits in the city. A close analysis of the cases suggests that the major contributing factors to juvenile crimes include peer pressure, bad company, poor education, poor socioeconomic status, substance abuse, parents' neglect and an urge to earn big to lead a lavish lifestyle.

Farmers script success in guava farming

Chitrada, April 14: Years ago, a patch of 50 acres of land lay fallow in Morada block of Mayurbhanj district. Not even a blade of grass would grow there.

Years later, one would be surprised to see the patch of land rich with greenery. Significantly, it provides livelihood to 40 local farmers.

A guava orchard has been raised on the land. The land produces a high yielding variety of guava and fetched good earnings for the growers. These 40 farmers have set an example in successful joint farming.

holesterol is a waxy, fat-like substance that is found in all the cells in your body. Your body needs cholesterol to make hormones, vitamin D, and substances that help you digest foods. Cholesterol comes from two sources: Your liver which makes all the cholesterol you need; the cholesterol in your body that you do not need comes from animal bodies.

If you have more cholesterol in your body than you need, then you are heading for heart disease and heart attacks. A build-up of cholesterol narrows arteries, causing a restriction of blood flow to the heart. Very often a person with high cholesterol levels has no symptoms until he has his first heart attack. This is even more problematic if you are overweight - which you will be, because the food that causes an increase in cholesterol also increases your weight. Though some cholesterol components are stored in the liver and gallbladder, the main storage area is in fat cells called adipocytes. When you have too much cholesterol, these cells swell up and you gain weight. Too much cholesterol can be caused by eating too much fat or carbohydrates.

There are two types of cholesterol: HDL and LDL. High density lipoprotein (HDL) is good cholesterol which protects you from hearts attacks, and strokes, by mopping up excess bad cholesterol. It takes the cholesterol that you don't need back to the liver. The liver breaks it down so it can be passed out of your body. LDL is bad cholesterol. This blocks the blood supply and causes strokes and heart attacks. Non-HDL takes cholesterol from the liver to the cells around your body. Too much bad cholesterol (non-HDL) can be harmful because it sticks to the inside walls of your arteries. This can lead to fatty material (atheroma) building up - this process is known as atherosclerosis.

Cholesterol is found in animal foods, meat, milk, butter and cheese. There are only two things that raise cholesterol in the blood: saturated and trans fats. Saturated fats are found in meats, dairy products, chocolate, baked goods like biscuits and popcorn, margarine, deep-fried, and processed foods. Basically junk food. Trans fats occur in some fried and processed foods. Also

in junk food. In adults, total cholesterol levels less than 200 milligrams per deciliter (mg/dL) are considered healthy; 200 - 239 mg/dL is borderline high; 240 mg/dL and above is high. LDL cholesterol levels should be less than 100 mg/dL.

How do you know that your cholesterol levels are high? You usually don't. There are no typical signs if you have high cholesterol, which is why it's so important to get it checked. It's a hidden risk factor, which means it happens without us knowing until it's too late. Some people get soft, yellowish, growths or lesions on the skin, especially round the eyes, called xanthomas. If you are lucky you develop left-sided chest pain, pressure, or fullness; dizziness; unsteady gait; slurred speech; or pain in the lower legs. Any of these conditions may be associated with high cholesterol. How do you flush cholesterol out of your body? Stop eating meat or drinking milk. Avoid ghee, butter and paneer, and seafood like crabs, shrimps and lobsters. Don't smoke. Exercise.

Eat fewer refined grains such as maida. Foods to avoid if you have high cholesterol levels include white bread, white potatoes, and white rice, highly processed sugars. Fried foods should be avoided, as well as foods high in saturated fats. Eat fruits, vegetables, beans and whole grains, every day.

A report from Harvard Health has identified foods that actively decrease cholesterol levels: Oats, barley and whole grains, beans, eggplant and okra, nuts, vegetable oil (canola, sunflower), fruits (mainly apples, grapes, straw berries, and citrus), soy and soy-based foods. Eating just one and one-half cups of cooked oatmeal a day can lower your cholesterol by 5 to 8 per cent. Oatmeal contains soluble and insoluble fibre - two types that your body needs.

In June 2020, a report, led by Imperial College London Majid Ezzati, et al. and involving dozens of universities, "Repositioning of the global epicentre of non-optimal cholesterol" was published in Nature. It said that while cholesterol levels have declined in high income countries, particularly Europe, since 1980, they have increased vastly in lower and middle income countries, with Asia, especially Southeast Asia, now being the centre.

The reason for this is the consumption of animal based foods, refined carbohydrates (maida) and palm oil. In short, the heart attack and stroke risks have been globally repositioned with the shifting of a high cholesterol diet. A group of nearly 1,000 researchers, from around the world, analysed data from 1,127 studies comprising 102.6 million adults. to assess global trends in cholesterol levels from 1980 to 2018. This is the largest ever study of global cholesterol levels. Previously cholesterol was considered a problem in highincome Western countries. The report said that Belgium, Sweden, Switzerland (the centre of the milk/meat diet) and Iceland (meat) had shown the steepest declines in cholesterol, going from the highest to the lowest. There has been a sharp drop in LDL cholesterol in the UK, according to the British Heart Foundation. China, which had the lowest levels of cholesterol in 1980, was among the highest in 2018. India, Malaysia, the Philippines and Thailand have not covered themselves in glory either. In 1980, Australian women ranked 32nd highest in the world in cholesterol levels. Today they are 146th. Australian men have fallen from 31st highest to 116th.

Furthermore, shipping does not mean only ships and oceans – it has a lot of associated industries. It would be true to say that it is one of the most comprehensively integrated industries which in addition to ships includes ports, environment, bathymetry, ocean **WORLD** engineering, hydrodynamics, and human resources, to name a few. For the sake of clarity, I will call

it the Maritime Ecosystem. It must be appreciated that even during the height of the pandemic when the world was under almost total lockdown, shipping continued to carry goods all around the world. This ensured food grain and oil reached its destination so that half the world did not go hungry, and the other half did not freeze. These ships were manned by seafarers who were stuck on board for months together without being able to set foot ashore. In fact, due to trade dispute between Australia and China some seafarers were stuck on board their ships for more than 14 months. It

would be unimaginable for those ashore to live in such an isolated and confined environment as well to battle with the elements of nature. Under such circumstances normal people ashore would have created a riot. Even today, with a new wave of Covid variants and governments thinking twice before even considering enforcing a total lockdown, ships continue to carry and deliver cargo come hail, snow, or pandemic.

Thus, it is essential to understand and nurture the entire Maritime Ecosystem to have a sustainable economy.

The 11 major ports functioning under the restrictive ambit of the Major Port Trusts Act, 1963 (MPT) had difficulty in operating in a highly competitive environment and responding to market challenges. The business practices have changed drastically since the 1960s. Since, the major ports were falling short of providing the expected services several nonmajor ports and private ports stepped in and captured more than 40 per cent of the market share of the cargo handled in India. Hence, the government had to comprehensively revise the MPT to provide corporate governance of these ports. Nonetheless, it must be appreciated corporate governance does mean only monetising the existing assets i.e., the land banks available with the port trusts. We need to plan at least 50 years ahead and work towards ensuring that the

entire maritime sector is sustainable. This means involving all sectors as mentioned above to ensure that it is sustainable for the future. Sustainable development is

the name of the game today. Maritime coastal states have recognised the importance of the maritime sector and have set up State Maritime Boards. Unfortunately, this has been restricted to building ports to facilitate the movement of export and import cargo. Building and sustaining a port is not restricted to setting up berths and cargo handling gear. We must understand the environmental and safety issues and address all aspects comprehensively. For example, when building and operating a port constant dredging is needed to ensure that the water depth is maintained for safe navigation. We can use the dredged material to enhance the river embankments for controlling floods. The nutrient rich silt can also be used to rejuvenate fallow agriculture land. The oceans can be harnessed to capture clean energy by using tides and ocean current. This is not only clean and cheap but also goes a long way towards mitigating threats posed by climate change. Apart from enhancing the economy of the region, it also has tremendous potential for job-creation. The opportunities are unlimited, we just have to recognise them and work to implement them. Recently, Odisha passed the

Odisha Maritime Board Bill, The proposed board is expected to have 12 members from the state and central government with the Chief Secretary as the chairman along with a maritime expert. The board is expected to frame guidelines for non-nationalised inland waterways as well exercise licensing and regulatory functions relating to port infrastructure and services. In fact, there is no one person who can claim to be an expert in all matters related to the maritime sector. The need of the hour is to take inputs from not only the stakeholders but all ancillary and associated sectors and then take a considered decision while finalising a maritime project. This will ensure that the infrastructure not only meets the commercial needs but also the environment and safety require ments. We can also take lessons from our history where the Cholas as well as the kingdoms of Odisha like the Sendha dynasty had a comprehensive maritime infrastructure which was sustained over generations. They had a thriving maritime trade with South

were renowned for it. Finally, not only as a nation but each maritime coastal state individually, we have world renowned experts in all fields related to the building of a sustainable Maritime Ecosystem. Hence, there is no need to employ expensive foreign consultants who, by and large, would propose ideas that have been used in developed countries without understanding the ground realities in India. Indian professionals would also be far more cost effective than foreign consultants. All that is required is that decision-makers take inputs from the entire range of the Maritime Ecosystem before making the final decision.

Monkey's uncle

What it means is nothing very profound. It's just an exclamation of surprise: "Well, I'll be a monkey's uncle!" It has been assumed to be a reference to Darwin's Origin of Species of 1859, in which he argued the close evolutionary relationship between humans, apes and monkeys. You may recall the famous debate between "Soapy Sam" Wilberforce, the Bishop of Oxford, and Thomas Huxley, in which the bishop is said to have asked sarcastically whether "it was through Huxley's grandfather or grandmother that Huxley claimed his descent from a monkey." A direct link with Darwin's book would place the expression's genesis later than 1859 and indeed most reference books suggest it dates from the 1920s, most probably accepting the first example in the Oxford English Dictionary, which is from an Ohio newspaper of 1925. It had become a catchphrase in the US earlier than that: an advertisement in the El Paso Herald on 31 July 1917 for the comedy play Brass Monkey at the Unique Theatre is headlined "Well, I'm a monkey's uncle!" This parody of Longfellow's Song of Hiawatha appeared in James Parton's compendium The Humorous Poetry of the English Language in 1856 It's said to be from Punch: Out came sundry comic Indians Of the tribe of Kutan-hack-um. With the growling Downy Beaver, With the valiant Monkey's Uncle. This may be just an accident of invention, but two British newspapers a decade earlier included reviews of a comic play, The Wigwam. Mr. Frank Matthews was all that a runaway "governor" could hope to be in savage life, with a plurality of wives; while Mr Oxberry was a veritable monkey's uncle in his rage and jealousy (The Morning Post, 26 Jan. 1847).

f the Covid-19 pandemic has taught the world one thing, it is L the high price we pay – in lost lives, damaged economies, and wasted human potential - when we undervalue resilience. By applying this lesson, we can bolster our ability to weather future shocks.

Over the last few centuries, societies have found a simple formula for progress and prosperity: economic growth. A steady increase in output and productivity is seemingly the panacea for all troubles, including food insecurity poverty and disease. But have we now reached a point where the strategy of growth is becoming a trap, generating new problems on an ever-larger scale

It appears so. In a recent report published in advance of this month's first-ever Nobel Prize Summit, "Our Planet, Our Future," my colleagues and I argue that the world's failure to value social and ecological resilience means that shocks this century will hit harder, be more disruptive, and have longerlasting effects over centuries and even millennia. But we can build social resilience by promoting equality, trust, and collaboration, and ecological resilience by valu-

ing diversity and complexity over efficiency and simplicity.

Our economies have become so mutually dependent that the fate of one rests on the performance of others half a world away. Our cities, usually hives of industry and innovation, have become disease hotspots. Our transport systems are perfectly designed for shuttling pathogens around the planet.

Extreme levels of inequality reduce societal resilience, often in obvious ways. Poorer countries. with fewer hospitals, less research power, and weaker governance, have less capacity to manage the pandemic. In wealthy societies, poorer people are often the most vulnerable, because their risk factors are greater. They are exposed to higher air pollution, are more likely to suffer from obesity, and live in more crowded conditions than the wealthy. The pandemic has thus hit them harder and spread among them faster. But economic inequality can also erode resilience in other ways. Trust in governments tends to be lower in more unequal societies, partly because poorer citizens think politicians mainly serve the interests of elites. This can encourage the rise of populist lead-

ers, and make it difficult to pursue long-term policies affecting all citizens within and across societies.

All of this is challenging enough. But, in our report, we conclude that by far the biggest likely shocks this century stem from our toxic relationship with nature. The biosphere – the zone close to the Earth's surface where life thrives – is at least 3.5 billion years old. But in a single lifetime, largely since the 1950s, humanity has systematically reduced the resilience of its own home, resulting in climate change

and biodiversity loss. Humans are slicing, dicing, and simplifying the biosphere. We manage 75 per cent of habitable land on Earth, largely for agriculture. As we hack our way through forests, wetlands, and grasslands, the most resilient species - the ones that can adapt fastest and even thrive in a human environment – are often those like bats and rats, which readily host deadly pathogens. The biosphere's resilience-its abil-

ity to persist, absorb shocks, and develop under ever-changing conditions - depends on variety, and on the ability of life to regenerate materials and evolve in novel ways in the face of uncertainty and the unknown. Boosting this resilience requires us to respect planetary boundaries and support ecological diversity.

We are facing a perfect storm. Our survival on Earth will require us to rethink our approach to valuing the resilience of our global civilization, starting with acknowledging that it is embedded within and dependent on the biosphere. Simply put, we must start collaborating with the planet on which we live. We cannot calculate the value of the Amazon rainforest in the same way we value the company of the same name

We must now transform our economies to prioritise diversity and resilience over simplicity and efficiency. This means, first and foremost, moving beyond facile and destructive growth strategies that are disconnected from the planet we call home. Instead, governments must redirect economic dynamism toward ensuring resilience for both humans and their natural environment. Ultimately, valuing resilience means valuing our future.

Vaccine crunch

Is MP hiding Covid casualties? Will spare none: Didi after meet

QUESTIONS ARE BEING RAISED ON THE OFFICIAL FIGURE OF DEATHS DUE TO CORONAVIRUS INFECTIONS EVEN AS CREMATORIUMS IN BHOPAL STRUGGLE FOR SPACE

Bhopal, April 14: The apparent spike in deaths caused due to Covid-19 has resulted in crematoriums and burial grounds in Bhopal struggling to dispose of bodies as these facilities have started facing several issues, including that of space crunch.

The number of bodies being brought to the crematoriums or burial grounds has been witnessing a surge over the last few days, say the operators of these establishments.

"In the last four days, we have cremated 200 bodies, including those that needed to be disposed of as per COVID-19 protocols. Now, we have created a new such facility on two acres of land," said Mamtesh Sharma, secretary of the management committee of Bhadbhada Vishram Ghat, one of the biggest Hindu crematoriums in the state capital.

"The situation is explosive. As many as 58 bodies, including 47 that needed to be disposed of as per COVID-19 guidelines, were cremated Tuesday, while Wednesday. more than 50 bodies were cremated so far and more are coming," he told PTI

The Bhadbhada Vishram Ghat management committee has created an additional space on two acres of land space for cremation of bodies as per COVID-19 protocols.

"We have created an additional space for 30 pyres in the adjoining open plot...There is no other crematorium in the country to have such a dedicated space (for cremation of COVID-19 victims)," Sharma said, adding that another additional space for 20 pyres will be created in the next two-three days.

Sharma said that earlier there was space for cremation of 20-22 bodies



at this Vishram Ghat.

"But due to the spike in the number of bodies coming to the Vishram Ghat, the management committee is telling the family members of the deceased to collect the ashes the next day," he said. Talking to PTI, Shobhraj

Sukhwani, manager of Subhash Nagar Vishram Ghat, said that more than 40 bodies are being brought there everyday for cremation since the past one week.

"We are using the land of a park for the cremation as we have run out of space," he said, adding that a total of 34 bodies were cremated by Wednesday afternoon. Of these. 16 to 17 were cremated as per the COVID-19 protocols, he said.

Similar situation is prevailing in Jhada Kabristan, a Muslim graveyard, in the state capital.

"The situation is deteriorat-

The family of the deceased will get justice. Don't fall into the trap of any kind of instigation. We will not spare anybody, however, influential the person might be, they will be tried.

The Chief Minister was referring to the five persons including the four villagers of Jor Patki village who were killed in the firing by the central forces and one person was killed by some unknown miscreants while coming out after casting vote. The four persons who were killed in the firing on Saturday last are identified as Amjad Hossain (28), Chalmu Mian (23), Jobed Ali (20) and Nameed Mia (20).

The chief minister also met Jagadish Barman - the father of Ananda Baraman (18), the first time voter of Pathantuli, Golenawhati GP Sitalkuchi, Cooch Behar who died when he was shot from a firearm by unknown miscreants.

This will save the time taken for the transportation of oxygen tankers from places like Rourkela (Odisha) and Bhilai (Chhattisgarh), located far from MP, he said.

"We are tracking oxygen tankers. It is taking a lot of time. The oxygen tankers are being escorted by police to ensure they reach on time without any hindrance. I feel uneasy even if a tanker gets late by an hour," he said.

Record poll seizures include hilsa, sarees

Kolkata, April 14: The seizures made in West Bengal in this election season so far has surpassed the captures made in the recent polls in the state, making it obvious that money power has started making its

footprints in the state. The different agencies working under the Election Commission of India have made seizures worth more than ₹290 crore, which is far more than the seizures made in the

past elections. The data released by the Commission show that the different agencies cumulatively made seizures worth ₹290.4 crore till date from the date of announcement of the polls.

This seizures include cash recoveries of ₹47.8 crore, liquor worth ₹28.3 crore, narcotics worth ₹118.2 crore, gold and silver worth ₹11.8 core and freebies worth ₹84.3 crore. "Polling has not yet been con-

cluded in the state, but the huge amount of seizures made by the agencies show that large amounts are involvement in these elections, which are mainly used to influence the voters," a senior Election Commission official said.

The list of seizures also includes certain surprising items such as Hilsa fish, sarees, readymade garments, tobacco and pan masala, and mobile phones, among others.

"These items were mainly seized along the Bangladesh border, which shows that these items were brought into the country to appease the voters. Though no one has been arrested, the recovery itself is a significant development in the polling history of the state," the official said.

According to the EC officials, this is highest seizure made in any election season in the state so far. During the Lok Sabha elections in 2019, there was a cumulative seizure of ₹177.5 crore, including ₹65.9 crore in cash and liquor worth ₹111.6



crore.

There was negligible recovery in the last Assembly polls in 2016 when there was a seizure of only ₹8.2 crore during the entire elections, including cash recovery of ₹7.8 core and liquor worth ₹40.5 lakh.

"There were no financially sen-

sitive constituencies in the state because of the low recovery in 2016, but after this election the Commission will have to think in a different manner. The recent trend shows that like Tamil Nadu and Assam, money power has started making its footprints in the state,"

the official added.

After the polls were notified on February 26, all constituencies in Bengal had formed special surveillance teams and flying squads. The police in Kolkata also played a crucial role working on the leads. The STF and the detective department also made several interventions. Many gun runners have been nabbed across the state," said a police officer.

"Since the announcement of the elections February 26, Bengal Police, Kolkata Police, state Excise Department, Income Tax Department, Directorate of **Revenue Intelligence**, Narcotics Control Bureau, flying squads, Static Surveillance Teams and other regulatory agencies have been working round the clock to detect any suspicious movement of cash, liquor, valuables, narcotics, among other contrabands, acrossthe poll-bound state," another officer in the CEO's office said.

New Delhi, April 14: As the CBSE cancelled its exams for class 10 and deferred those for class 12, Madhya Pradesh, Rajasthan, Himachal Pradesh and Maharashtra have also postponed their state board exams for these classes due to an alarming surge in coronavirus cases.

States like West Bengal and Uttar Pradesh said they were monitoring the situation and are yet to decide whether to go ahead with the hoard exams

Karnataka said it will conduct the exams as scheduled. Meghalaya too said it is ready to hold the state board exams for class 12 but will take a decision on class 10 exams after a review of the situation is completed.

The developments came as the central government announced the cancellation of class 10 exams and the postponement of class 12 exams conducted by the Central Board of Secondary Education, following a high-level meeting chaired by Prime Minister Narendra Modi.

This is the first time that the CBSE has completely cancelled the board exams and it will affect over



21 lakh students across the country.

The Council for the Indian School Certificate Examinations (CISCE), the other prominent national board besides the CBSE, said it will soon decide on conducting class 10 and 12 board exams.

We are reviewing the situation and will soon take a decision in this regard," CICSE Chief Executive and Secretary Gerry Arathoon said. Its class 10 exams are scheduled to begin from May 5 while class 12 exams have already begun from April 8. The board exams last year

had been cancelled because of the coronavirus pandemic. Students were evaluated based on internal assessment

The Himachal Pradesh govern ment postponed the ongoing state board exams for classes 10 and 12 in the wake of the rising COVID-19 cases, state education secretary Rajeev Sharma said.

The situation will be reviewed at the government level May 1 and further directions will be issued accordingly, he said.

Global warming making Indian monsoon stronger, chaotic: Study

New Delhi, April 14: Climate change will make summer monsoon rainfall in India stronger and more erratic, according to a study that predicts extremely wet years in the future, with potentially grave consequences for over a billion people's well-being, economy, food systems and agriculture.

The study, published in the journal Earth System Dynamics, compared more than 30 state-of-the-art climate models from all around the world. We have found robust evidence for an exponential dependence for every degree Celsius of warm-

ing, monsoon rainfalls will likely increase by about 5 per cent, said study lead author Anja Katzenberger from the Potsdam-Institute for Climate Impact Research (PIK) in Germany.

Hereby we were also able to confirm previous studies but find that global warming is increasing monsoon rainfall in India even more than previously thought. It is dominating monsoon dynamics in the 21st century, Katzenberger said.

The researchers noted that more rainfall is not necessarily a good thing for the farming sector in India and its neighbouring countries. Crops need water especially in the



initial growing period, but too much rainfall during other growing states can harm plants -- including rice on which the majority of India's pop-

ulation is depending for sustenance, said study co-author Julia Pongratz from Ludwig-Maximilian University (LMU) in Germany.

This makes the Indian economy and food system highly sensitive to volatile monsoon patterns, said Pongratz. A look into the past underlines that human behaviour is behind the intensification of rainfall, according to the researchers.

Starting in the 1950s, humanmade forcings have begun to overtake slow natural changes occurring over many millennia, they said. At first, high sun-light blocking aerosol loadings led to subdued warming and thus a decline in rainfall.

However, from 1980 onwards, greenhouse gas-induced warming has become the deciding driver for stronger and more erratic Monsoon

seasons. We see more and more that climate change is about unpredictable weather extremes and their serious consequences, said group leader and co-author Anders Levermann from PIK and Columbia University in the US.

Because what is really on the line is the socio-economic wellbeing of the Indian subcontinent," 🔫 Levermann said.

He explained that a more chaotic monsoon season poses a threat to the agriculture and economy in the region and should be a wakeup call for policy makers to drastically cut greenhouse gas emissions worldwide.

Ahmedabad, April 14: Prime Minister Narendra Modi Wednesday said the new National Education Policy is futuristic and as per world standards, and aimed at fulfilling Dr S Radhakrishnan's vision of education that empowers a student to participate in national development.

India takes pride in being the mother of democracy as its values are embodied in our social life, Modi said addressing the Association of Indian Universities' 95th annual meet and a national seminar of vice-chancellors via video conference. The Centre unveiled the new National Education Policy (NEP) last year. The National Education Policy is futuristic and as per global parameters, Modi said.

Every student has certain capabilities. These capabilities pose three questions before the student and the teacher, he said.

First, what they can do. Second, what is their potential if they are properly taught, and third, what they want to do, Modi said.

The answer to the first question is the inner strength of students, he said. But, if institutional strength is added to that inner strength, their development will get expanded and they will be able to do what they want to do, the prime minister said. He said the NEP is aimed at fulfilling the vision of Dr S Radhakrishnan (India's second President and academician) of education that frees and empowers a

student to participate in national development.

Education management should be undertaken keeping the whole world as a unit, but also focusing on the Indian character of education, he said. Modi said the role of skilled youth is continuously increasing as India walks the path of 'aatmanirbharta' (self-reliance).

India is being looked upon as the future centre of Artificial Intelligence, Internet of Things, big data, 3D printing, virtual reality and robotics, mobile technology geo-informatics, smart healthcare and defence sector, he said.

To meet the requirement of var ious skills, Indian institutes of skills are being set up in three big cities of the country. In Mumbai, the first batch of the Indian Institute of Skills has already started, Modi said. He also asked universities to be multi-disciplinary. We want all universities to be multi-disciplinary and provide flexibility to students, like an easy entry and exit from courses and creation of an academic bank for easy completion

of courses, he said. For this, every university will have to collaborate, he added.

New Delhi, April 14: A sedentary lifestyle is associated with more severe COVID-19 infection and an increased risk of dying from the viral disease, according to a largescale study.

Researchers, including those from the University of California San Diego, found that COVID-19 patients in the US who were consistently inactive during the two years preceding the pandemic were more likely to be admitted to hospital. Inactive patients were also more likely to require intensive care, and die compared to those who had consistently met physical activity guidelines, they said.

The study published in the British Journal of Sports Medicine, showed that physical inactivity was surpassed only by advanced age and a history of organ transplant as a risk factor for severe disease.

"It is notable that being consistently inactive was a stronger risk factor for severe COVID-19 outcomes than any of the underlying medical conditions and risk factors identified by (The Centers for Disease Control) except for age and a history of organ transplant," the researchers said.

"In fact, physical inactivity was the strongest risk factor across all outcomes, compared with the commonly cited modifiable risk factors, including smoking, obesity, diabetes, hypertension (high blood pressure), cardiovascular disease and cancer," they said.

Several risk factors for severe COVID-19 infection have been identified, including advanced age, male sex, and certain underlying medical conditions, such as diabetes, obesity,

New York, April 14: Bernie Madoff, the financier who pleaded guilty to orchestrating a massive Ponzi scheme, died in a federal prison early Wednesday, a person familiar with the matter told The Associated Press. He was 82.

Madoff died at the Federal Medical Centre in Butner, North Carolina, apparently from natural causes, the person said. The person was not authorized to speak publicly and spoke to the AP on the condition of anonymity.

Last year, Madoff's lawyers filed court papers to try to get him released from prison in the coronavirus pandemic, saying he had suffered from end-stage renal disease and other chronic medical conditions.

The request was denied. Madoff admitted swindling thousands of clients out of billions of dollars in investments over decades. A courtappointed trustee has recovered more than \$ 13 billion of an estimated \$17.5 billion that investors put into Madoff's business

Minneapolis, April 14: The judge at Derek Chauvin's murder trial Wednesday turned down a defense request to acquit the former officer in George Floyd's death.

Judge Peter Cahill pressed on with the case after Chauvin attorney Eric Nelson argued that prosecutors had failed to prove that Chauvin killed Floyd. Requests for an acquittal are routinely made midway through a trial and are usually denied.

Nelson said the prosecution's expert witnesses gave conflicting opinions about what caused Floyd's death after the 46-yearold Black man was pinned under the white officer's knee for what authorities say was 9 1/2 minutes last May.

The request came on Day Two of the defense case. The prosecution rested its own case Tuesday after 11 days of testimony and gripping video evidence.

The defense for a former police officer charged in George Floyd's death challenged the heart of the case against the officer, calling a use-of-force expert who testified that Derek Chauvin was justified in pinning Floyd and said it might have gone easier if the Black man had been "resting comfortably" on the pavement.

Taking the stand Tuesday at Chauvin's murder trial, Barry Brodd, a former Santa Rosa, California, officer, stoutly defended Chauvin's actions, even as a prosecutor pounded away at the witness, banging the lectern at one point during cross-examination and growing incredulous over Brodd's use of the 'resting comfortably" phrase.

"It's easy to sit and judge ... An officer's conduct," Brodd testified. "It's more of a challenge to, again, put yourself in the officer's shoes to try to make an evaluation through what they're feeling, what they'resensing, the fear they have, and then make a determination.'

Singapore, April 14: People who have recovered from Covid-19. especially those with pre-existing cardiovascular conditions, may be at risk of developing blood clots due to a lingering and overactive immune response, according to a study.

The study, led by researchers from the Nanyang Technological University in Singapore, found that recovered Covid-19 patients had twice the normal number of circulating endothelial cells (CECs) that had been shed from damaged blood vessel walls.

The elevated levels of CECs indicate that blood vessel injury is still apparent after recovering from viral infection. The recovered Covid-19 patients also continued to produce



high levels of cytokines -- proteins produced by immune cells that activate the immune response against

pathogens -- even in the absence of the virus. Unusually high numbers of im-

mune cells, known as T cells, that attack and destroy viruses were also present in the blood of recovered Covid-19 patients.

The presence of both cytokines and higher levels of immune cells suggest that the immune systems of recovered Covid-19 patients remained activated even once the virus was gone, revealed the findings published in the peer-reviewed scientific journal eLife.

The researchers hypothesise that these persistently activated immune responses may attack the blood vessels of recovered Covid-19 patients, causing even more damage and increasing the risk of blood clot formation further.

"While Covid-19 is mainly a respiratory infection, the virus may also attack the linings of blood vessels, causing inflammation and

Govt to sell 20% in NFL

New Delhi: The government will sell up to 20% stake in National Fertilizers Ltd (NFL) and 10% in Rashtriva Chemicals and Fertilizers (RCF) through an offer for sale in the current fiscal. The Department of Investment and Public Asset Management (DIPAM) has invited bids from merchant bankers by May 5 for managing the proposed share sales. The government holds 74.71% in NFL and 75% in RCF.

Paris, April 14: After Neymar missed several chances to finish off defending champion Bayern Munich, Paris Saint-Germain was left clinging to a 0-1 home defeat that nevertheless sealed the French club's second straight Champions League semifinal. PSG now face either Manchester City or Borussia Dortmund in the semifinals.

Bayern had to score twice Tuesday after losing 2-3 in Germany in the first leg of their quarterfinal and survived several scares from livewire Neymar in the first half before largely taking control in the second. But without the prolific Robert

Lewandowski, the six-time champions lacked a cutting edge and could not add to Eric Maxim Choupo-Moting's first-half goal against his former club.

In Seville, the cross from the right was curling away from goal at shoulder height when Mehdi Taremi took off, connecting with a spectacular scissor kick that sent the ball into the top corner from 12 metres out.

A beautiful goal — arguably the best in the Champions League this season — to settle an ugly match. It wasn't enough for Porto.

Chelsea qualified for the semifinals for the first time since 2014 despite a 0-1 loss to the Portuguese champions Tuesday, the English team going through 2-1 on aggregate to meet either Real Madrid or Liverpool for a place in the final.

Aside from Taremi's stunning, acrobatic effort in the fourth minute of second-half stoppage time, Chelsea successfully stifled Porto in what proved to be something of an arm-wrestle and was happy to rely on the away goals scored by Mason Mount and Ben Chilwell in the first leg, which was also played in Seville because of coronavirus

restrictions. After losing 1-0 to Bayern in last year's final, PSG stands one step away from the second final of its 51vear history and remains on course to win it for the first time.

Neymar had three shots saved by goalkeeper Manuel Neuer and hit the woodwork twice in an eventful first half that tilted Bayern's way when Choupo-Moting headed home in the 40 minute.

Bayern's wingers were a constant menace and PSG's defenders were relieved to see standout goalkeeper Keylor Navas stretch his right hand to keep out Leroy Sane's dangerous cross deep into injury time at Parc des Princes.

That was Bayern's last chance on a night when the usually so prolific German side paid the price for its wastefulness without Lewandowski. Injury-hit Bayern were also miss-

ing midfielder Leon Goretzka, as well as winger Serge Gnabry because of coronavirus. In fact, Flick couldn't even fill his substitute's bench.

Still. PSG was not at full strength. either. Defender Marquinhos had an adductor problem, while midfield schemer Marco Verratti stayed on the bench after recovering from COVID-19. Early into the game, Kylian

Mbappe shot wide from the right and Neuer saved Neymar's close-range shot following a scramble. Bayern's main threat came from

Tokvo. April 14: Tokvo pitched itself as "a safe pair of hands" when it was awarded the Olympics 71/2 years ago. "The certainty was a crucial factor," Craig Reedie, an IOC vice president at the time, said after the 2013 vote in Buenos Aires.

Now, nothing is certain as Tokyo's postponed Olympics hit the 100days-to-go mark on Wednesday. Despite surging cases of COVID-19, mvriad scandals and overwhelming public opposition in Japan to holding the Games, organizers and the IOC are pushing on.

Tokyo's 1964 Olympics celebrated Japan's rapid recovery from defeat in World War II. These Olympics will be marked by footnotes and asterisks. The athletes will aim high, of course, but the goals elsewhere will be modest: get through it, avoid becoming a super-spreader event, and stoke some national pride knowing few other countries could have pulled this off.

"The government is very conscious of how the world' views Japan," Dr Gill Steel, who teaches political science at Doshisha University in Kvoto, wrote in an email.

The Olympics may also determine the fate of Prime Minister Yoshihide Suga, who replaced Shinzo Abe seven months ago. It was Abe who famously told IOC voters in 2013 that the Fukushima nuclear disaster of March 11, 2011, was 'under control.'

Despite being billed as the "Recovery Olympics," the northeastern area of Japan is still hurting a decade later. Many blame the Olympics for the slow recovery and siphoning off resources.

IOC President Thomas Bach has repeatedly called Tokyo the "best 🛁 prepared Olympics in history" and he's restated it during the pandemic. Handsome venues went up quickly including the USD 1.4 billion National Stadium by Kengo Kuma and the Games were on track until the pandemic hit. But the "safe pair of hands" have often been shaky.
