SHORT TAKES No LL, DL tests

Bhubaneswar: With a rapid surge in Covid-19 infections, the government suspended Learner's License (LL) and Driving License (DL) tests across the state from April 22. "It is ordered that all learner's license and driving license tests are hereby suspended wef 22.04.2021 till further orders to prevent transmission of infection in the state," the State Transport Authority said in an order, Tuesday. All regional transport offices have been asked to reduce quota per slot or cancel the existing slots for all driving related and VAHAN related services in their respective regions.

New Delhi: The UGC-National Eligibility Test (NET) scheduled to be held from May 2 to 17 was postponed in view of the COVID-19 situation, Union **Education Minister Ramesh** Pokhriyal 'Nishank' said. An order of the National Testing Agency said, revised dates for the exam will be announced later, at least 15 days before the examination. Stock up on O₂, beds: CM

OFFICIALS TOLD TO ENHANCE COVID PREP

Bhubaneswar, April 20: Echoing concern over the acute shortage of hospital beds and oxygen in other states. Chief Minister Naveen Patnaik Tuesday asked officials in the state to ramp up hospital beds with oxygen system.

"Although there is no problem of beds and oxygen in the state now, still then we will have to remain prepared," he said while holding a high-level review meeting on Covid management through videoconferencing with Collectors and senior officials.

The second wave of Covid infections has seriously affected many states. The health system in some cities is under severe strain due to rapid increase in the number of Covid positive patients, he said.

Stating that the number of cases in Odisha has been increasing over the last few days, Patnaik said, "Due to our alert preparedness and pro-active measures, we have been able to manage the situation to a large extent. However, we need to be prepared for a worst-case scenario and ensure that every patient is treated with dignity and we put in best efforts to save precious lives.

The Chief Minister sought an increase in the number of beds in Covid hospitals and Covid Care Centres across the state. "Special focus should be given on providing maximum possible number of beds with oxygen support. The system has to work on warfooting to ensure this within committed timelines," he directed the officials.

The officials were instructed to closely monitor the oxygen supply situation and ensure that all related accessories at the hospital level are available on priority.

As many states are facing a shortage in critical medicines, the CM said, "Even though we have sufficient medicine stock we must ensure a buffer stock to tackle higher demand in coming weeks.

cials to scale up the awareness campaign and enforcement activities.

The local community, Mission Shakti group, PRI members will be involved to create awareness among people on the dangerous spread of the second wave and the need for active adherence to Covid protocols.

With lockdowns having been imposed in seriously-affected states, the Collectors were asked to be prepared for the return of the migrants. They have been told to reactivate the protocols followed earlier immediately based on the existing database. "The quarantine norm and testing should be ensured for all the returnees from other states. Senior officers were assigned as observers and told to put in their best efforts like last year," he said.

The Chief Minister once again appealed to the people of Odisha to cooperate with the government to manage the Covid situation without lockdown. "We are facing grave danger and unless the people cooperate and act responsibly, it will be very difficult to tackle the situation," he added.

Fresh hospital norms out

Bhubaneswar: The state health department Tuesday released a new set of norms for government as well as private hospitals to thwart the spread of Covid-19 in healthcare facilities.

"In order to reduce such risks of hospitals getting converted to Covid hotspots, the norms are to be strictly adhered to both by the hospital management and staff of all government and private hospitals," it said. The hospitals have been asked to create separate fever clinics and isolation zones where health checkups and testing of persons with flu like symptoms could be done. They have been asked to make special provisions for entry and exit of symptomatic persons.

The health setups will ensure mandatory screening and triage of incoming patients. "All hospitals are to ensure adequate hand washing, hand rub facilities and enforce use of masks and social distancing. There should be adequate rational use of PPE by healthcare professionals. There should be safe handling and disinfection of equipment/instruments," the norms read. The guidelines also said that only dedicated Covid ambulances could be used to transport Covid patients to hospitals. The government has asked hospitals to ensure they have adequate infrastructure to fight the pandemic.

"Hospitals must have facilities to deal with all types of emergency procedures for Covid patients including maternity care, safe delivery and childcare. No life threatening procedure/treatment shall be denied or deferred on the ground of suspicion of Covid infection or non-availabilitv of Covid test report, the hospital shall undertake such treatment taking all universal precaution as per guidelines," the norms said.

Queen enters 'twilight' of reign after farewell to Philip

SHE HAS ALREADY STARTED TURNING OVER **RESPONSIBILITIES TO PRINCE CHARLES, 72**

London, April 20: Now that the Royal Family has said farewell to Prince Philip, attention will turn to Queen Elizabeth II's 95th birthday on Wednesday and, in coming months, the celebrations marking her 70 years on the throne.

This combination of events is reminding the United Kingdom that the reign of the queen, the only monarch most of her subjects have ever known, is finite. That has triggered speculation about how long she will remain on the throne, what the monarchy will look like in the future and, for some, even whether it should continue to exist.

"The queen is certainly moving now into the twilight of her reign and a new phase of her reign," said Anna Whitelock, director of the Centre for the Study of Modern Monarchy at Royal Holloway, University of London. "She now is a widow, and it remains to be seen how she's going to respond to that."

While most observers say the queen is unlikely to abdicate given her lifelong commitment to public service, she has already started to turn over more responsibilities to Prince Charles, 72, her eldest son. That process is likely to accelerate

following Philip's death. Charles' increased role began gradually, when the queen began cut-



ting back on long-haul flights, resulting in Charles taking her place at a 2013 Commonwealth Heads of Government meeting in Sri Lanka. Then in 2017, he represented the

queen at the annual Remembrance Day ceremony marking the end of World War I, laying the monarch's wreath at the foot of the Cenotaph in London. It was the first time the queen hadn't performed the solemn ritual, other than when she was pregnant or out of the country.

Since then, Charles has taken on an increasing number of public engagements and been named the queen's designated successor as head of the Commonwealth, a voluntary association of 54 nations with links to the British Empire.

"Symbolically, the transition towards the succession is already underway," said Ed Owens, a historian and author of "The Family Firm, Monarchy, Mass Media and the British Public 1932-53." "T anticipate that we're going to see a lot more of Prince Charles in the next couple of years so that we, as a people, start to see him in his future role as king." For now, the longest serving monarch in British history continues to reign. But she will do so without Philip, the man the queen called her "strength and stay," a source of emotional support in her often lonely job.

Her loss was underscored by Saturday's funeral at St. George's Chapel on the grounds of Windsor Castle, where the figure of a widow

in black sitting alone offered a glimpse of the next solitary phase of the queen's reign. "Constitutionally, Prince Philip's death doesn't change anything. But, of course, at a time when the queen is approaching her 95th birthday, she's vulnerable and aging," Whitelock said. "Clearly, Prince Philip's death has begun this transition to the future and the beginning of the end of this phase of monarchy." Questions about the end of the queen's reign will also fuel the debate over the long-term future of the monarchy, seen by many as a symbol of national unity but by others as an obsolete vestige of the past. New Delhi, April 20: The ICSE Class X board exams have been cancelled in view of the worsening Covid-19 situation and the option for students to appear later has been withdrawn, board secretary Gerry Arathoon said Tuesday. Last week, the board had postponed both Classes X and XII exams.

The Council for the Indian School Certificate Examinations had announced that Class 10 students will get an option to either write the exams later or get evaluated on the basis of an alternative criteria.

"Given the present worsening situation of the COVID-19 pandemic in the country, the CICSE has decided to cancel the class 10 examination. The option for students announced earlier, stands withdrawn. The safety and wellbeing of our students and teaching faculty is of topmost priority," said Arathoon, Secretary and Chief Executive of the CISCE.

'We are committed to devising a fair and unbiased criterion for declaring Class 10 results. The criterion as well as the date of declaration of results will be announced later." he said. The CISCE has advised schools to begin the admission process for Class 11, if not already started.

"In addition, schools should prepare a schedule to begin online classes for the class 11 students at the earliest." Arathoon said. adding that the status of Class 12 exams remains same. Last week, the Central Board of Secondary Education (CBSE) had cancelled its Class 10 board exams and deferred the Class 12 board exams. Several state boards have postponed or cancelled their exams too.

State records 4,761 fresh Covid cases, 5 fatalities

Bhubaneswar, April 20: State's Covid-19 tally soared to 3,77,464 Tuesday as a record 4.761 more people tested positive for the virus. while five fresh fatalities pushed the state's coronavirus death toll to 1,953, a senior Health and Family Welfare (H&FW) department official said.

As many as 2,785 new cases were reported in quarantine centres, while 1.976 fresh infections were detected during contact tracing.

Khurda district, under which Bhubaneswar falls, reported the highest number of new cases at 820, followed by Sundargarh (673), Nuapada (534), Bolangir (322), Jharsuguda (234), Bargarh (198), Puri (193) and Sambalpur (183), said the official.

Meanwhile, health officials said that 23 Kumbh Mela returnees, including 13 from Cuttack and 10 from Rayagada, are among the new patients.

Khurda has so far reported the highest number of 59,337 Covid cases followed by Cuttack (31,318), Ganjam (22,260), Sundargarh (22,112)

21-yr-old drowns in Kuakhai river

I'll approach the police and lodge a complaint against them," the woman said as tears rolled down her cheeks.

Bihar liquor traders head for Balasore

Bhograi, April 20: Liquor traders and mafia from Bihar are heading towards Odisha to carry on their business. Most of them, tainted with crimes, are found in Bhograi area of Balasore. They find the coastal region safe for liquor trader, a report said.

A notification had been issued by the Excise department inviting applications for opening new liquor shops in the state. During the draw of lots for liquor trading licenses, many Bihari traders and mafia obtained permission for opening outlets in the state.

Over 10 non-Odia people have got licenses to open liquor outlets in Balasore alone. Most of them hail from Bihar.

They have opened foreign liquor off-shops at Talsari, Deulahat, Batagram near Thana Chhak under Bhograi block; one at Karmarda; seven shops in Jaleswar and two in Baliapal. It was learnt that most of the liquor shop owners are blacklisted and tainted in Bihar.

Various outfits, social activists and intellectual groups have expressed concern over this trend in the liquor trade.

It was also leant that most of the liquor shop owners have been black-

Covid & Judiciary

t is a matter of concern that the judiciary has to intervene and dictate the executive what it needs to do and when. This is valid even to deal with L a colossal public health disaster such as the Covid-19 pandemic. Both the Central as well as most State governments wasted the past year and did not focus on building up a fairly good health support system and assisting infrastructure. Due to this the governments' response has been woefully inadequate when thousands of people are dying and hundreds of thousands getting infected daily during this current second wave. The Centre continued its inept handling after the Delhi High Court, in a recent ruling, gave it a rap on the knuckles for following an opaque policy on the production of the two vaccines - Covaxin and Covishield. The Telangana government has been forced to impose a night curfew in the state from April 20 only a day after the Telangana High Court, headed by Chief Justice Hima Kohli, threatened to pass orders in 48 hours if the state government didn't take a call on night curfew or weekend lockdown. Similarly, claiming that there are 'serious issues of importance', the Bombay High Court has sought response from Center and State while dealing with a PIL that claimed mismanagement in handling of the Covid-19 crisis.

The Allahabad High Court too ordered on April 19 a weeklong lockdown in the badly hit Prayagraj, Lucknow, Varanasi, Kanpur and Gorakhpur districts of Uttar Pradesh till April 26.

It passed the order saying that the rising Covid cases had 'virtually incapacitated' the medical infrastructure of UP.

Hearing a PIL on the 'inhuman' condition at quarantine centres and the state of Covid treatment, a Division Bench of Justices Ajit Kumar and Siddhartha Varma of the Allahabad High Court said that while ordering a lockdown was the government's prerogative, it was disappointed by the measures taken since its last order, calling them an eyewash. On April 13 the High Court had asked the state government to look into the viability of a complete lockdown in districts where the Covid situation was alarming.

The insensitive Uttar Pradesh government refused to abide by the HC order and moved the Supreme Court against it instead. The Supreme Court, promptly and within 24 hours, on April 20 has, unsurprisingly, gone in the state's favour. Although some may term this as government-guided, it must also be appreciated that in a democratic system, HCs should not be instrumental in breaking the glass ceiling. It is improper on the part of Courts to command an elected government to do its biddings, even if it is in greater public interest. The need to control the pandemic, no doubt, should be the first priority for any and every part of the Establishment.

There is not a shred of evidence that disproves the allegation that today the executive in this country stands totally paralysed in the face of the pandemic. It has no idea on how to handle the catastrophe. The bureaucracy, which is the mainstay of governance in India, is at a complete loss to understand how to bring the government apparatus to grapple with and subdue the crisis. It is, therefore, understandable that the judiciary feels, especially the High Courts, that they have to din it into the governments' ears what the administration has to do.

The Division Bench of the Allahabad HC has laid bare the hollowness of the government's spurious argument of keeping the economic life stable which is but a ploy to hide its abysmal failure to protect lives and health of the people under attack by the coronavirus. Yet the judiciary must not overstep in its eagerness to be perceived as a do-gooder. The SC overturning the HC's order seems anti people and still may seem democratic and proper for this time. If the HCs are permitted to carry on with their present sense of being correct and the government is forced to obey, it could set a very dangerous trend for the future. On the other hand, any act of any wing of society or System that proves beneficial to people, especially a large number of citizens, must be considered democratic. Today the demarcating line between democratic and undemocratic acts may have become invisible at many places and instances.

THE DISEASE THAT KILLS US

There is no escaping the death and destruction of the SARS-CoV-2 pandemic that is upon us in a second disastrous wave. Experts tell us we will hit a peak soon. The numbers will then begin to climb down as a majority of Indians are exposed to the virus and/or the variants that are thought to have caused the havoc in this round. With nothing more left to burn, even the wildest of fires die. Nature would have found a way to bring some calm – we did precious little, and can only pray that there will be no third wave.

But right now, we are submerged. And yet, we may ask: is it Covid-19, the disease caused by SARS-CoV-2, that is killing us? Or is it something more that has left us so exposed, so vulnerable and so helpless? Images of ordinary people begging for a hospital bed, queues for Remdesivir and a shortage of oxygen and vaccines have become all too common. In neighbourhoods across the nation, the myth of India as a would-be superpower in charge of its destiny stands busted as a defeatist resignation takes hold. The virus has exposed us as the backward, bottom-of-the-heap and almost irrelevant player we have been, unable to respond to a crisis that has come upon us not once but twice in the last 12 months.

Examples of how badly we fought this war come from all directions. It is difficult to get ambulances. Remdesivir is being black-marketed, the latest being the BJP seeking to procure these vials in a private operation in Mumbai, leading to the arrest of two directors of a manufacturer. The

distribution of vaccines has become a bone of contention between the Centre and non-BJP ruled States. In Maharashtra, for example, no one can miss the fact that vaccines are in short supply. Several vaccination centres have closed. Yet, this has led to the lowness of a Trumpian twitter war. not a fix of the problem at hand. New Delhi is as fast as ever with tweets, and terrible with building trust. What does it take to keep away

pettiness, to take decisions that are simple yet bold and to let the nation see and feel that this is a government geared to fight the pandemic, not merely to win the next election round the corner? We can see Covid-19 is the disease but just beneath the surface is the real disease that kills us -- narrow mindedness, one-upmanship and the turning away from an evidencebased approach that allowed the government to endorse a holy bath and a gathering of lakhs-devotees duly facilitated with 12 pairs of special trains and welcomed with front page ads featuring the Prime Minister of India and the Chief Minister of Uttarakhand. The announcement to end the mammoth Kumbh Mela gathering came over the weekend -- too late in the day. The announcement is significant because it tells us that belief, faith and ritual are not contradictory to the scientific approach. Yet, the former has been put to work and exploited at the cost of the latter. An Associate Professor at the All-India Institute of Medical Sciences,

Rishikesh, has been funded by the Department of Science and Technology to run a pilot to study the "effect of Gayatri Mantra and pranayama in terms of inflammatory markers in hospitalised Covid-19 patients." The official record states: "...Scientists are racing against time for a miracle cure/vaccine to fight this pandemic which has gripped the world. In this scenario, role of pranayama and Gayatri Mantra chanting which has been used in other diseases and has shown promising effects becomes vital." Millions of Indians who chant the Gayatri Mantra, Hindus and non-Hindus alike, will understand that this is not the best way to respond to the

pandemic.

On the other hand, the Indian SARS-CoV-2 Genomics Consortium (named 'INSACOG') comprising 10 labs identified to study variants of the virus in India. launched in December 2020, had received no funds till at least as late as Marchend. This was a critical activity be cause variants are thought to have delivered the new wave. Yet, the nation has been too slow to launch this kind of sustained, planned and coordinated activity to sequence the virus genome. On 24 March, the health ministry reported that "though VOC (variants of concern) and a new double mutant variant have been found in India, these have not been detected in numbers sufficient to either establish or direct relationship or explain the rapid increase in

cases in some States."

That begs the question: What has caused the current spike? Where is the epidemiological insight? As of 16 April, only 13,614 Whole Genome Sequenced samples were processed at the 10 designated IN-SACOG labs. Sequencing was targeted for 5 per cent of total positives beginning December 2020; what was sequenced cumulatively as of mid-April is barely 5 per cent of daily rise in infections!

Meanwhile, there is a daily release on vaccination numbers that look large in absolute terms but offer the true picture of the task at hand when we see that barely 1.2 per cent of India is fully vaccinated, according to data from the University of Oxford. This compares to 25 per cent fully vaccinated in the US, 14 per cent in the UK and 3.8 per cent in Brazil, which India overtook this month to have the second largest number of infections in the world

after the US. Moonshine

Professor Richard Borcherds of Cambridge University was awarded the Fields Medal, the mathematicians' equivalent of a Nobel Prize, for proving a highly abstruse result in number theory called the moonshine conjecture. It seems it was given this name because it was based on a coincidence between a result in number theory and the number of symmetries in an exotic concept called the Monster object. It was thought so unlikely that two such distinct areas of mathematics should have anything in common that the conjecture was described as moonshine, and the name has stuck. Professor Borcherds was guoted as saying, "I was over the moon when I proved the moonshine conjecture", a nice conflation of two of the common evocations of the Moon in the language. Moonshine originally meant the same as moonlight. In A Midsummer Night's Dream, Snug asks whether the moon will shine the night they perform their play, and Bottom replies in a brief panic: "A calendar, a calendar! Look in the almanack; find out moonshine, find out moonshine!" It still has this literal meaning in poetical or elevated contexts but we no longer use it in that way in daily life. unlike the matching sunshine. Instead, it commonly means something insubstantial or unreal, and so foolish or visionary. The word for working at a second job, usually at night, moonlighting, is actually a modern re-use of an older term describing some nocturnal expedition or illicit action. And there is a wonderful British expression, now somewhat long in the tooth but still understood: a moonlight flit. A person who does one of these decamps or moves house under cover of darkness to avoid a debt, usually paying the landlord his rent. Another such expression, long defunct, is moon-curser or mooncusser. This was originally a link-boy, a person who carried a torch of flaming pitch to guide pedestrians at night before towns had street lights. The moon-curser pretended to guide people to their destinations but actually led them into the hands of robbers. Moonlight was no good to such rogues, for then the link-boy wasn't needed to help people find their way about. Later, the same word was applied to wreckers in England and on the eastern seaboard of America, particularly around Cape Cod, who were accused not only of salvaging what was washed up on shore from genuine accidents, but of bringing disaster about by shining lanterns from the shore to confuse seafarers. At one time Wiltshire people were thought excessively slow and stupid and a story was told in neighbouring counties to illustrate this. A group of local yokels were found raking a pond at night. When asked what they were doing, one explained that they had seen this big white cheese in the pond and were trying to get it out. The word moonraker was for long applied generally as a term for a simpleton. Even today, by that tendency people have of taking ancient insults to their hearts, some people from Wiltshire use it to describe themselves. But as you might expect they have a different explanation of the story. The moonrakers were indeed found in the pond, but by Excisemen. They pretended to be drunk and told the story to divert attention from their real intention of combing the pond to retrieve the barrels of smuggled brandy they had hidden there. No lessons learnt

Sir, The second wave of Covid-19 has led to a sharp surge in demand for hospital beds, medicines, and, crucially, oxygen. Prime Minister Narendra Modi has directed the authorities to ensure the movement of vehicles carrying medical oxygen. The government prohibited the supply of oxygen for industrial purposes to divert the stock for medical use, began a process to import 50,000 tonnes of medical oxygen. While these steps are welcome, the scarcity of oxygen could have been avoided with better planning and proactive governance. It is pathetic the situation demands the intervention of court to examine the availability of oxygen. According to some reports, it took the Centre eight months to invite bids for new oxygen generation plants after India declared the pandemic to be a "disaster" on March 14, 2020. Surprisingly, the delay was not due to a lack of funds. The outlay for 162 oxygen plants is ₹201.58 crore, which had been allocated from the PM-Cares fund. However, only 33 plants are operational, according to the health ministry. This postponement, which is leading to the loss of lives, was a result of administrative inertia, and a flawed tendering process that awarded contracts to companies that are ill-equipped to do the work required. In some cases, state governments failed to provide the infrastructure to set up plants. Last year, a harsh lockdown was imposed to ramp up the health infrastructure. Apart from these, front line workers (police, revenue, drinking water, electricity department workers) who have not yet been vaccinated but are deputed in hotspot areas/containment zones should be vaccinated on a priority basis to ensure their life is not threatened. Since January 16, 1.13 crore

people have been vaccinated in the state. Rajasthan reported a record spike of 12,201 new COVID-19

cases Tuesday, taking the infection tally in the state to 4,38,785, even as efforts to contain the disease are underway.

The state also reported 64 more fatalities, pushing the death toll due to the viral disease to 3,268, according to an official bulletin.

Jaipur, April 20: In the first Board of Investment (BOI) meeting chaired by CM Ashok Gehlot Monday, Rajasthan government cleared the customised package of incentives for investment worth over Rs. 1,67,000 crore in the state, of which the major contributor sector is renewable energy.

What if they completely stop construction activities for a longer period? What will we eat then? Last time we waited for the situation to get better but ultimately had to go back home anyway.

"I have seven members in mv family, including a senior citizen. During the last lockdown, we went to Nepal after the situation became worse. We returned around four to five months ago. We work as a daily labourers and do not have work due to the ongoing situation. We have no work back in our native place so we will have to come back but not sure when as the lockdown could be extended." she told PTL



In the state capital, many busy areas, including Thampanoor and the Statue area in front of theSecretariat wore a deserted look by 9 pm as vehicles were off the roads. Shops were also closed. Malls and cinema houses in the state functioned only till 7.30 pm.

Singh had Monday urged the forces to be on war footing in fight against Covid, providing all medical help to the affected people. He also directed the army to

open up medical facilities for local people and directed that forces top commanders to get in touch with chief ministers of the states. The states unable to control the Covid-19 situation were looking upon the Central government for help. A senior Defence Ministry official said that the defence minister spoke to the Army Chief General Manoi Mukund Naravane and asked him to instruct commanders in state capitals to reach out to chief ministers and provide all possible assistance.

New Delhi, April 20: The Delhi High Court Tuesday said wastage of even a single shot of the COVID-19 vaccine was a "criminal waste" and directed the Centre to vaccinate whomsoever it can to ensure each vial is used fully.

A bench of Justices Vipin Sanghi and Rekha Palli said that according to news reports there is a daily wastage of six per cent of vaccines and till now 44 lakh vaccines out of 10 crore have been wasted, maximum in Tamil Nadu. "This is a huge wastage. Give it to those who want it. Whomsoever vou can vaccinate, please vaccinate. Whether 16 year old or 60 year old, all need vaccination. The pandemic does not discriminate," the court told the Centre.

The bench said the wastage was occurring due to the restriction with regard to age and categories of persons who are entitled to take the vaccine. It said that the Centre recently an-

nounced that from May 1 all above the age of 18 years would be entitled to take the vaccine.

"In our view, wastage of a single dose of vaccine, which has proven to be life saving, is a criminal waste, it said and directed the central government to find a way to ensure full utilisation of the vaccine, if not utilised by the age/category for which it is permitted by 5pm each day. It said that the Centre can de-

vise ways and means to register volunteers between the ages of 18-45 years who can be called to take the vaccine, if some doses are left after 5pm each day.

"That would ensure all doses are fully utilised and not wasted. For this purpose the Centre should modify its COWIN application (meant for registering people who want to get vaccinated)," the bench said.

The observations by the bench came during the hearing of a disposed of petition related to COVID-19 tests which was revived April 19 (Monday).

The high court Monday noted that the virus has raised its "ugly head" once again and the pandemic is raging with much greater intensity and "it is evident that the healthcare infrastructure is at the stage of imminent collapse".

Its chairman D S Rana said, "6.000 cubic meters of it is left, which at the rate of current consumption will last till 1 am. Need urgent replenishment." Kejriwal had on Sunday termed the shortage of oxygen for coronavirus patients an "emergency". He had also written to Union Minister of Commerce and Industries Piyush Goyal, seeking his intervention in the matter.

The Delhi government Monday, set up a 24-member committee to ensure "rational" use of oxygen for treatment of COVID-19 patients. An order issued by the Health Department said the 'Oxygen Audit Committee' willidentify areas of wasteful consumption.

More states opt for lockdown-like curbs

New Delhi, April 20: More states went for partial-to-full lockdown, night curfew and other restrictions Tuesday as India's active COVID cases crossed 20 lakh after 2,59,170 new coronavirus infections and a record 1.761 new fatalities.

The Centre stressed that the next three weeks will be critical for the country reeling from the worst medical crisis as it announced a series of measures to shore up medical infrastructure and supplies and scale up vaccination in the country.

After Delhi, Jharkhand declared a one-week lockdown from April 22, while Maharashtra indicated a similar step soon. Telangana announced night curfew while Uttar Pradesh ordered a weekend lockdown.

The decision by the Uttar Pradesh government came as the Supreme Court granted an interim stay on its plea against the Allahabad High Court order directing lockdown till April 26 in five cities.

The state government held that it has taken several steps to contain the spread of coronavirus the high court order would create immense

administrative difficulties. Night curfew has already been imposed in Uttar Pradesh and several other states including Punjab, Rajasthan, Kerala, Odisha, parts of Chhattisgarh and Madhva Pradesh and the Union Territory of Jammu and Kashmir. However, there was no sign of the COVID wave ebbing as several states like Rajasthan, Odisha, Andhra Prsdesh and Kerala recorded the highest daily rise Tuesday.

Registering a steady increase for the 41st day in a row, the active cases increased to 20,31,977, comprising 13.26 percent of the total infections, while the national COVID-19 recovery rate has dropped to 85.56 percent. In the last 11 days, the



daily count of cases has almost doubled from 1.31 lakh reported April 9 to 2.73 lakh April 20. Expressing concern over the

worrying scenario during a review meeting with Union Territories, Member (Health) NITI Aayog V K Paul pointed out the criticality of the next three weeks for COVID response measures.

J&J seeks nod for vax trial in india

New Delhi, April 20: Global healthcare major Johnson & Johnson Tuesday said it has sought an approval from the India's drug regulator to conduct a bridging clinical trial of its single-dose COVID-19 vaccine in the country.

The US Food and Drug Administration (USFDA) had in February approved Johnson & Johnson's COVID-19 vaccine that works with just one dose for emergency use.

"Johnson & Johnson is partnering with health authorities and the world's best scientists to provide the safety and efficacy data necessary to support worldwide emergency use of the Janssen COVID-19 vaccine candidate," the company said in a statement.

This comes close on the heels of the central government last week deciding to fast-track emergency approvals for all foreign produced coronavirus jabs that have been given a similar nod by the World Health Organization or regulators in the United States, Europe, Britain or Japan.

Such vaccines will be given emergency use approval mandating the requirement of post-approval parallel bridging clinical trial in place of conduct of local clinical trial under the provisions of the New Drugs and Clinical Trials Rules 2019, the health ministry had said.

'In line with this commitment, we have submitted an application to the Drugs Controller General of India (DCGI) requesting approval to conduct a bridging clinical study of our single-dose Janssen COVID-19 vaccine candidate in India to comply with local regulations", the statement added.

Johnson & Johnson's vaccine can be stored at refrigerator temperatures.

So far, two vaccines -- one developed by Oxford University and AstraZeneca and the other developed by Bharat Biotech in collaboration with the Indian Council of Medical Research - National Institute of Virology -- are being used in India. Both the vaccines are being manufactured within the country by domestic firms.

SC lays guidelines for appointment of ad-hoc judges in HCs

New Delhi, April 20: In order to address the challenges of huge backlog of cases in the High Courts, the Supreme Court Tuesday passed certain guidelines with respect to appointment of retired judges as adhoc judges in the High Courts under the Article 224A of the Constitution.

A three-judge bench of the apex court headed by Chief Justice SA Bobde emphasised upon activating the "dormant provision of the constitution - Article 224A - for the appointment of ad hoc Judges to deal with the backlog of cases pending in the High Courts, which has now crossed the figure of 57 lakh coupled with the consistent ratio of vacancies of almost 40 per cent.'

In order to exercise the power of the Article 224A in a transparent manner, the bench also comprising Justices S K Kaul and A Surva Kant held that the powers under the Article can be invoked if the vacancies in the High Courts are more than 20 percent of the sanctioned strength. The bench also said that in the scenario where the cases in a particular category are pending for over five years or more than 10 per cent of the backlog of pending cases are over five years old or the percentage of disposal of cases are lower then the appointment of ad-hoc judges shall be made. Significantly, the Supreme Court made it clear that the recourse of Article 224A is not an alternative to regular appointments. The bench held that if recommendations have not been made for more than 20 per cent of the regular vacancies then the trigger for recourse to Article 224A would not arise.

The Supreme Court ruled that the past performance of recommendees in both quality and quantum of disposal of cases should be factored for selection as the objective is to clear the backlog. The bench also held that the Chief Justice of High Court should prepare a panel of judges, on the anvil of retirement, and former judges who have retired within a period of one year. However, the bench said, the Chief Justice can also recommend a judge retired earlier but his expertise is required in a particular subject matter after holding an interac-

tion with the concerned judge. The Supreme Court held that since the Judges are already appointed to the post through a warrant of appointment, the occasion to refer the matter to the IB or other agencies would not arise in such a case, which would itself shorten the time period. The bench said three months should be sufficient to process a recommendation under Article 224A and thus ideally a Chief Justice should start the process three months in ad-

vance for such appointment.

New Delhi, April 20: The Supreme Court Tuesday granted an interim stay on the Allahabad High Court order directing lockdown in five cities of Uttar Pradesh in the backdrop of the worsening Covid-19 situation.

Solicitor General Tushar Mehta, representing the Uttar Pradesh government, said the state government has accepted several directions of the High Court, but imposing lockdown in five cities would not be appropriate.

Mehta added that the state government has issued several directions to contain the spread of Covid-19 and it has been taking adequate precautions. A bench headed by



Chief Justice S A Bobde queried. it would be as rigorous as a lockdown, but the High Court had observed that they are nowhere close to a complete down After a hearing in the matter, the bench said In these circumstances there would be interim stay of the order. The top court observed that Mehta had submitted that the blanket lockdown imposed by the High Court in five cities in terms would create immense administrative difficulties.

The top court also appointed senior advocate PS Narasimha as amicus curiae while directing the state government to submit a report on steps it has taken and that it proposes to take to contain the pandemic. The next hearing in the matter will be held after two weeks. The Uttar Pradesh government had moved the Supreme Court challenging the order passed by the Allahabad High Court imposing a near total lockdown in five cities in the state.

Earlier, during the day, Solicitor General Tushar Mehta mentioned the matter before a bench headed by Chief Justice seeking urgent listing. Mehta submitted that a virtual lockdown has been imposed by way of a judicial order in cities like Prayagraj and Lucknow.

Real time satellite monitoring of Himalayas to avoid disasters

THE IIT KANPUR TEAM SUGGESTS THAT EFFORTS TO HELP MITIGATE GLOF EVENTS IN THE FUTURE SHOULD INCLUDE THE **CREATION OF A NETWORK OF SATELLITE-BASED MONITORING STATIONS THAT COULD PROVIDE IN SITU AND REAL-TIME DATA**

New Delhi, April 20: To avoid the Chamoli mishap from recurring, the Ministry of Science and technology with IIT Kanpur has conducted a study on how the satellite-based realtime monitoring of the Himalayan glacial catchments would improve understanding of flood risk in the region and help inform an early flood warning system that could help curb disaster and save human lives.

The integration of monitoring

devices with satellite networks will

not only provide telemetry support

in remote locations that lack com-

plete cellular connectivity but will

also provide greater connectivity in

coverage in the cellular dead zones

in extreme topographies such as

valleys, cliffs, and steep slopes,'

the authors explained.

"This should be the future strategy to reduce loss of human lives during glacial lake outburst floods (GLOF)," said a study carried out by scientists from IIT Kanpur.

The study was carried out by Dr Tanuj Shukla and Prof Indra Sekhar Sen, Associate Professor from IIT Kanpur, with support from the Department of Science & Technology, Government of India, has been published in the international journal 'Science'. The IIT Kanpur team suggests

that efforts to help mitigate GLOF events in the future should include the creation of a network of satellite-based monitoring stations that could provide in situ and real-time data on GLOF risk.

Temperature and the numbers of extreme rainfall events are rising at an increased rate because of cli-



mate change. Suitably called Earth's "Third Pole", the Himalayan region is home to the largest ice mass outside of the planet's Polar Regions. The glaciers in the Himalayas are melting at a faster rate creating

new lakes and expanding the ex-

isting ones. Besides, the rising temperatures and extreme precipitation events make the region increasingly prone to a variety of natural hazards, including devastating glacial lake outburst floods (GLOFs)

GLOFs occur when either a natural dam containing a glacial lake bursts or when the lake's level suddenly increases and overflows its banks, leading to catastrophic downstream destruction.

For example, in 2013, an avalanche caused the glacial moraine holding back Chorabari Lake in northern India to give way, releasing a sudden torrent of water, boulders, and debris that scoured the river valley below, resulting in the deaths of more than 5,000 people. With climate change, these events are likely to increase in frequency and magnitude throughout the Himalayas.

However, the remote, challenging Himalayan terrain and the overall lack of cellular connectivity throughout the region have made the development of early flood warning systems virtually impossible.

"In their recent work, the Scientists also point out that the surge of meltwater in mountain streams is most commonly caused by cloud-burst events during the monsoon season (June-July-August) time frame." However, the recent (February 7, 2021) sudden surge of meltwater in the river tributary of the Ganga, Dhauli Ganga, during the dry season suggests that this time frame needs to be expanded.

The catastrophe in the upper Dhauli Ganga basin is linked to processes other than precipitation events, such as snow avalanches, rock landslides, or other unidentified drivers, and therefore determining all of the potential major and minor drivers behind sudden surges of meltwater into headwater streamsis vital for understanding the hazard profile of the region.

"Bossing others around or med-

dling in others' internal affairs would not get one any support. We must advocate peace, development, equity, justice, democracy and freedom, which are common values of humanity, and encourage exchanges and mutual learning among civilizations to promote the progress of human civilization," Xi said, without directly referring to the US. 'What we need in today's world

is justice, not hegemony," he said addressing the annual Boao Forum for Asia (BFA), a China promoted influential think tank based in Hainan via video link.

"Big countries should behave in a manner befitting to their status and with a greater sense of responsibility," he said.

His snide remark against Washington came as US President Joe Biden vigorously pursued a strong China containment policy initiated by his predecessor



by Donald Trump.

Biden united US allies like the UK, the EU and Japan over his China policy. He also held the first quadrilateral summit of the emerging alliance called Quad, which included US, Australia, Japan and India.

The US, the European Union, Britain and Canada have imposed coordinated sanctions on China over alleged human rights violations against Uygur Muslims in Xinjiang, a charge Beijing denied. These countries have also taken

united position on China firming up its control over Hong Kong with its new national security law subduing the massive prodemocracy agitation in the former British colony.

Xi, in his address, also called on all countries in Asia and beyond to

London, April 20: India is among the guest countries invited to join parts of the G7 Foreign and Development Ministers' meeting to be hosted by the UK next month, the Foreign, Commonwealth and Development Office (FCDO) said Tuesday.

The meeting in London will be the first in-person summit of the foreign ministers of the Group of Seven countries - Canada, France, Germany, Italy, Japan, US and UK as well as the European Union (EU) and will be held in what has been dubbed a COVID-secure way between May 3 and 5.

"The Foreign Secretary has also invited India, Australia, the Republic of Korea, South Africa, and the Chair and Secretary-General of the Association of Southeast Asian Nations (ASEAN), to join parts of this year's G7 Foreign and Development Ministers' meeting as guests," the FCDO said.



"Their attendance will bring broader experience and geographic representation, and demonstrates the importance of the Indo-Pacific region," it notes.

UK Foreign Secretary Dominic Raab confirmed the plans for the meeting in Parliament Tuesday, highlighting that the event would be an opportunity for the world's biggest democracies to come together. "The meeting of G7 Foreign and Development Ministers next month is an opportunity to show how the world's biggest democracies work together to ensure equitable access to vaccines, build back better from the pandemic, support girls in the poorest countries get a good quality education and agree ambitious action to tackle cli-

Brussels, April 20: The European Union (EU) has imposed fresh sanctions on 10 individuals and two companies in Myanmar for their alleged involvement in the February 1 military coup. The individuals "are all re-

sponsible for undermining democracy and the rule of law" in Myanmar, and for "repressive decisions and serious human rights violations", the Council of the EU said in a statement Monday following a virtual meeting of the bloc's Foreign Ministers.

In the statement, it said the two entities, Myanmar Economic Holdings Public Company Limited (MEHL) and Myanmar Economic

Corporation Limited (MEC), were large conglomerates "owned and controlled by the Myanmar Armed Forces (Tatmadaw), and provide revenue for it". Pre-existing EU restrictive measures also remain in place, said the press release.

EU citizens and companies are forbidden from making funds available to the listed individuals and entities. A one-year state of emergency was declared in Myanmar

after President U Win Myint and State Counsellor Aung San Suu Kyi, along with other officials from the National League for Democracy (NLD), were detained by the military on February 1.

The military had claimed that there was massive voting fraud in the country's November 2020 general elections, which saw the NLD win a majority of seats in both houses of parliament.

The February coup has prompted widespread protests, to which soldiers have responded with a violent crackdown on the population.

Nearly 2,850 have been arrested, and at least 598 have been killed, including 48 children, according to the Assistance Association for Political Prisoners, a non-profit organization.



Deby, a former army commander-in-chief, first came to power in 1990 when his rebel forces overthrew then-President Hissene Habre, who was later convicted of human rights abuses at an international tribunal in Senegal.

New Delhi, April 20: The government is likely to waive 10 per cent customs duty levied on imported vaccines in a bid to keep low the cost of overseas vaccines that are being eved to supplement domestically made shots ahead of opening COVID-19 vaccination to all citizens over 18 years of age, sources said

While Russia's Sputnik V vaccines are due to arrive this month or latest by next month, manufacturers like Moderna and Johnson and Johnson have been urged to seek emergency use approval in India. The government presently levies 10 per cent customs or import duty plus a 16.5 per cent I-GST and social welfare surcharge on vaccines coming from overseas. These taxes would make the imported vaccines costlier than the ones made by Serum Institute of India (SII) and Bharat Biotech.

'Power under GST law to order provisional attachment draconian'

The Top Court emphasised that this power of attachment can't be used as an "unguided discretion" by the authorities

New Delhi, April 20: The Supreme Court Tuesday said the rule of law in a constitutional framework is fulfilled when law is substantively fair, procedurally fair and applied in a fair manner, as it held that the power to order a provisional attachment of property, including a bank account, of a taxable person, under the GST law is "draconian in nature'

The top court emphasised that this power of attachment can't be used as an "unguided discretion" by the authorities

A bench of Justices DY Chandrachud and MR Shah said: "The power to order a provisional attachment of the property of the taxable person including a bank account is draconian in nature and the conditions which are prescribed by the statute for a valid exercise of the power must be strictly fulfilled." The bench noted a provisional at-

tachment under Section 83 is contemplated during the pendency of certain proceedings, meaning thereby that a final demand or liability is yet to be crystallised. "An anticipatory attachment of this nature must strictly conform to the re-



quirements, both substantive and procedural, embodied in the statute and the rules," said the bench.

In the 61-page judgement, the bench observed the formation of the opinion must be based on tangible material which indicates a live link to the necessity to order a provisional attachment to protect the interest of the government revenue. "The commissioner must be alive to the fact that such provisions are not intended to make preemptive strikes on the property of the assessee, merely because property is available," the bench said.

The top court allowed an appeal by Radha Krishna Industries, challenging the Himachal Pradesh High Court order of January 1, 2021. The High Court had dismissed its plea against the order for provisional attachment of properties.



AS THEATRES AND OFFLINE ENTERTAINMENT AVENUES REMAINED SHUT CONSUMERS TURNED TO INDOOR ENTERTAINMENT

New Delhi, April 20: Amid the pandemic, online payments, indoor entertainment and gaming witnessed over 100 per cent growth in India last year, a new report said Tuesday.

As theatres and offline entertainment avenues remained shut consumers turned to indoor entertainment, the OTT segment witnessed an incredible 144 per cent increase in the number of transactions and a 139 per cent increase in expenditure between 2019 and 2020, according to on-

line payments solution provider PayU.

The pandemic gave a huge boost to online payments, seen in the 24 per cent increase in the number of transactions and 23 per cent increase in expenditure across the PayU platform, year on year.

"PavU is committed to partnering with merchants to facilitate adoption of digital infrastructure," said Hemang Dattani, Head- Data Intelligence, PayU. Interestingly, during the fes-

tive season (October-December 2020) there was a 45 per cent spike in the number of online transac-



tions vis-a-vis the same period in the previous year.

expenditure through UPI grew a phenomenal 331 per cent between 2019 and 2020. The gaming segment saw a phenomenal 100 per cent increase in expenditure and a 154 per cent increase in average ticket size between the two years.

"For gaming and entertainment, the number of transactions made at night increased by 34 per cent while the number of transactions made during the day decreased by 11 per cent in 2020 vs. 2019, an indication of the increased dependence on indoor entertainment while working from home,"

the findings showed.

Travel and hospitality were some of the most impacted sectors with an 86 per cent drop in the number of transactions and expenditure between pre and post-COVID quarters (January-March vs April-June 2020).

Compared to 2019, there was a 46 per cent drop in the number of transactions and a 52 per cent in drop in expenditure in '20.

"Edtech emerged as a winner, with a 78 per cent increase in the number of transactions and a 44per cent increase in expenditure," the report mentioned.

WTC final to go ahead as planned, says ICC

Dubai, April 20: The World Test Championship (WTC) final between India and New Zealand will go ahead as planned in Southampton from June 18, the International Cricket Council (ICC) has assured after Britain added India to its travel 'red list' following a massive surge in COVID-19 caseload.

India's entry into the 'red list' effectively bans all travel from the country and makes a 10-day hotel quarantine compulsory for UK residents arriving back home.

However, the ICC expressed confidence in staging the WTC final in a bio-secure environment. "The ECB and other members have demonstrated how we can stage international cricket safely in the middle of a pandemic and we are

confident that we can continue to do that and that the WTC Final will go ahead as planned in June in the UK," said the ICC in a statement Monday night.

"We are currently discussing with the UK Government the impact of countries being on the 'red list'," it added.

A BCCI source told this agency that it's difficult to say anything at this point in time and the Board is hoping that India will not be in the 'red list' by the time the team leaves for UK in early June for the WTC final.

Media reports in the UK said that in case it is required, the Rose Bowl in Southampton and it onsite hotel could be cleared for 'red list' arrivals by reverting to the full bio-secure set up that saw it successfully stage international fixtures last season

Liverpool held at Leeds

Leeds, April 20: Liverpool conceded an 87th-minute equalizer to draw at Leeds 1-1, denying Jurgen Klopp's team a spot in the top four of the English Premier League. Which position Liverpool fin-

ishes might not matter anymore, given the team is one of the 12 clubs behind the creation of a controversial Super League that is threatening to split the historic structure of European football. The breakaway league could po-

tentially launch as early as next season, rendering meaningless the race for Champions League qualification

that currently involves Liverpool, Chelsea and Tottenham - three of the six rebel English clubs.

Liverpool stayed in sixth place, outside the Champions League places, after Spain defender Diego Llorente scored with a header from an inswinging corner to earn Leeds a point that the team's second-half fightback might have deserved.

Sadio Mane Monday stroked the ball into an empty net in the 31st minute from a squared pass from Trent Alexander-Arnold to give Liverpool the lead and put the deposed champion on course for a fourth straight victory.

A win would have lifted Liverpool

above West Ham and into fourth place. Liverpool came in for lots of criticism ahead of the game from their own fans and those of rival clubs - for being greedy and damaging the integrity of the English and wider game because of its role in the Super League plans. The club's American ownership bore the brunt of the criticism but the players were jeered and verbally abused as they arrived at Elland Road.

Leeds' players wore T-shirts during the warm-up, which had the words 'Earn it' on the front and "Football is for the fans" on the back — seemingly a message to the rebel clubs.

With the confirmation of seven more medals, the 20-member Indian contingent is now assured of 11 medals from the ongoing championship. Earlier on Day 6, Vinka, Alfiya, Gitika and Poonam had advanced to the semifinals.

In a clash between two strong gold contenders in women's 51kg category, Asian youth champion Chanu put up a strong tactical performance to overwhelm her Polish opponent Kubicka 5-0. The Manipuri boxer will now take on Lucia Ayari of Italy.

Arundhati and Sanamacha were also dominant during their quarterfinals. While Arundhati outpunched Ukraine's Anna Sezko 5-



0, Sanamacha sent Russian Margarita Zueva packing with referee stopping the contest in the second round.

In the men's category, Asian junior champion Bishwamitra and Asian youth championship silver medallist Narwal also lived up to expectations and notched-up easy 5-0 victories against Serbian Omer Ametovic and Brazil's Ezequiel Da Cruz respectively. Manish (75kg) and Sumit (69kg) were the only two Indian boxers who suffered defeats in the quarterfinals.

With seven women in the semifinals, India is placed at the top of the table alongside Russia with highest number of boxers qualifying in the last-four stage. In the men's section, India is placed fourth on the standing with four boxers in the semifinals.
