VACCINES HAVE VANISHED

Govt not sure as to when the doses for Covid-19 vaccination would arrive in state

POST NEWS NETWORK

Bhubaneswar, April 27: The state government Tuesday said the Co-WIN portal meant for registration of the new set of beneficiaries aged between 18 and 44 would start the registration from Wednesday. However, the state health department said while all eligible persons can register on Co-WIN, their real vaccination may be delayed as there are no vaccines available now.

In Cuttack, vaccination stopped due to lack of vaccines at government and private hospitals, Tuesday, Inoculation drive was shut at all government and private medical facilities. While 100 doses were administered at CDA CHC, 200 shots were given at SCBMCH.

The state government is not yet sure as to when the doses would arrive. The state health and family welfare director, Bijay Panigrahi, Tuesday admitted that there might be a delay for the inoculation drive for the 18 plus group to start. "The registration of people in this age group on the Co-WIN website can start from Wednesday. But there can be no booking of slots. We will announce slot-booking when we get enough supply of vaccines," he added.

Talking about the registration, the official said people will need to seed their



mobile numbers and register through OTPs and other ID details in Co-WIN.

When asked when the vaccines will arrive here, he said, as per the information the government has it may get Covisheild doses in mid May. The Serum Institute of India will inform the government about their likely date of consignment, he said. "We are hopeful of getting Covaxin supply in May. The vaccine drive in the state depends

on the availability of vaccines with us. We are ready with the infrastructure. We will announce the number of vaccine centres and other details after getting our supply of doses," the health department official said.

The state government is already struggling to get their initial beneficiaries like health workers, frontline workers, elderly and people above the age of 45 years vaccinated owing

KIT CRUNCH HITS TESTING

BHUBANESWAR: Even as the state government makes tall claims on its Covid management, people in many parts of the state are facing a tough time to get tests. According to reports, people were denied testing at Komna community public health centre in Nuapada district Tuesday. "I was waiting in a queue for Covid test. But, now, the heath officials say they don't have antigen kits," said a man. The health centre in-charge has admitted that they were not getting enough antigen kits to conduct tests.

The situation was similar in Bhubaneswar. Test kits in the community health centre at Brahmeswar Patna got exhausted at 10 am Tuesday. "We get fewer test kits from Capital Hospital. So we were not able to test people coming here," said a lady staff of the hospital. The testing tim-

to shortage and erratic supply of vaccines. In the last one month, several vaccination centres in the state have been shut due to shortage of Covid 19 vaccines. While the state government has been regularly facing the ing has also been changed. No testing is being conducted at urban health centers of Bhubaneswar in the second half. The only hope is the Capital Hospital where people stay in queues for hours to get tested.

Private labs including GENX, In DNA and Redcliffe Life Sciences have refused to conduct antigen tests. They conduct only RT-PCR tests. "As there was allegation that antigen test reports are not fully correct, we are not conducting antigen tests," said an official of a private laboratory at Saheed Nagar.

However, the health department has a different story. "There is no shortage of testing kits. As more people are coming forward for tests, the kits might have been exhausted in one or two places," said Director, Public Health, Niranjan Mishra.

Remdesivir missing from open markets

Bhubaneswar, April 27: With a steep hike in Covid-19 cases, the shortage of remdesivir in the open market has added to the problems of Covid patients in the state. The state is facing a shortage of remdesivir, the drug used for treating the SARS-CoV-2 virus in hospitalised adults, Drugs Controller Annada Sankar Das told media here Tuesday.

Das said the Centre has brought the distribution of the essential drug under its control. The Centre is providing the anti-viral drug to states, he said. The Drugs Controller supplies remdesivir to private hospitals whereas the Odisha State

Medical Corporation distributes the drug to government hospitals.

Around 21,000 vials have been allocated to Odisha for the period from April 21 to April 30 which are being sent on a daily basis, he said. "The requirement was nearly 2,000 vials yesterday, but the state had received only 92 vials. We have got information that even fewer vials are reaching today, but we have no information about the exact quantity," Das said, adding, private medical stores are not allowed to store or sell the drug. However, there is no shortage of Fabiflu. Pharmaceuticals in said there is also a shortage of


Covid duty: 12 OAS officers deputed

At time of national crisis, we can't be a mute spectator: SC

New Delhi, April 27: Terming the massive resurgence of COVID-19 cases a "national crisis", the Supreme Court Tuesday said it cannot remain a mute spectator and made clear that its suo motu proceeding on devising national policy for COVID-19 management is not

meant to supplant high court cases. A bench headed by Justice DY Chandrachud said high courts are in a better position to monitor the

pandemic situation within their territorial boundaries. There is a need for top court's intervention on certain national issues as there might be matters related to coordination between states, it said.

'We are playing complementary role, if High Courts have any difficulty in dealing with issues due to territorial limitations, we will help," said the bench, also comprising Justices L Nageswara Rao and S Ravindra Bhat. Last Thursday, the bench took note of the pan-

demic situation due to sudden surge in COVID-19 cases as also mortality and said it expected the Centre to come out with a "national plan" to deal with distribution of essential services and supplies, including oxygen and drugs. Observing that oxygen to patients infected with the virus is said to be an "essential part" of treatment, the top court had said it seemed that a certain amount of "panic" has been generated due to which people have approached several high courts.

Bhubaneswar, April 27: Eminent writer, editor and columnist Manoi Das passed away Tuesday evening. He was undergoing treatment at a hospital in Pondicherry. He was 87. Das was suffering from age-related aliments and was admitted to the hospital for past few months.

Das was the foremost bilingual Odia writer and a master of dramatic expression both in his English and Odia short stories and novels. In 2000, he was awarded with Saraswati Samman. He was awarded Padma Shri in 2001 and Padma Bhusan in 2020 for his contribution in the fields of literature & education. The Kendra Sahitya Akademi awarded the Sahitya Akademi Award Fellowship to Das.

Das was born February 27, 1934 in Shankari village in Balasore district. Governor

Ganeshi Lal condoled the sad demise of the legendary writer and thinker and conveyed his heartfelt sympathy to his family and readers. "He would continue to inspire generations through his timeless literary works," observed Governor. In 1971, his research in the archives of London and Edinburgh brought to light some of the little-known facts of India's freedom struggle in the first decade of the twentieth century led by Sri Aurobindo for which he received the first Sri Aurobindo Puraskar.

His deeper quest led him to mysticism and he has been an inmate of Sri Aurobindo Ashram in Pondicherry since 1963 where he taught English literature and the Philosophy of Sri Aurobindo at the Sri Aurobindo International University. Among his other important positions he was authorconsultant, Ministry of Education, government of Singapore, 1983-85. MORE P3

Washington, April 27: In a show of solidarity, the CEOs of about 40 top American companies have come together to create a first-of-its-kind country-specific global task force to mobilise resources and coordinate efforts to help India fight the battle against COVID-19.





he Brightest Sun of Indian literature goes down, A permanent void in Odia literary circuit.. A magician who could instill life to his character bids adieu...

These were some of the headlines of popular social media handles after the death of Manoj Das, arguably the greatest writer Odisha has ever produced.

Manoj Das had appeared in Indian-English literary sky as a luminous star during the mid-sixties of last century. Needless to say, he was one of the few gifted writers of India who could write in Odia, his mother tongue and English with equal ease and dexter A follower of the vision and phi-

> Mother, Manoj always sought to explore the hidden truth in the different realities of life. He was an optimist who believed in a trans formed future of mankind. A great architect of tran-

losophy of Sri Aurobindo and The

scendental literature, Manoj Das dealt with a number of themes. They ranged from the happenings of everyday life to the events suggestive of supernatural. At the same time his stories are greatly influenced by Indian literature-mythology and folklore. As an Indian writer, he has never forgotten to re-

flect on the age-old rich cultural and literary tradition of India. He always felt that there are certain truths that are found only in Indian culture and they should be presented on global platform. Orissa POST takes a close look at his life and body of works.

Manoj Das was born at Shankhari, a small village in Balasore district. He had started writing early as his first work, a book of poetry in Odia, Satavdira Artanada, was published in 1949 when he was all of 15. He launched a literary magazine, Diganta, in the next year. His first collection of short stories Samudrara Kshudha (Hungry Sea) came out that year.

He was active in student politics while studying BA in Cuttack College. He was a youth leader with radical views during his college days and spent a year in jail for his revolutionary activities. In 1959, he was a delegate to the Afro-Asian students' conference at Bandung, Indonesia. During his college, he kept on writing and he published a novel 'Jeebanara Swada', a collection of

Known as the chief architect of transcendental literature in India and beyond, Manoj Das was one of those living writers on whom maximum number scholars have done their doctoral theses

short stories titled 'Vishakanyar Kahani' and a collection of poems 'Padadhawani'.

After graduating with a degree in English literature, he got a post graduate degree in English literature from Ravenshaw College. After a short stint as a lecturer in Christ College (Cuttack), he joined Sri Aurobindo Ashram at Pondicherry, Since 1963, he has been a Professor of English Literature at Sri Aurobindo

International Centre of Education, Pondicherry He edited the cultural magazine, The Heritage, published from Chennai in 1985-1989. This apart, he wrote columns on quest for finding eternal truth in common lives in national dailies like The Times of India, The Hindustan Times, The Hindu and The

CM for smooth supply of O2, drugs

Bhubaneswar, April 27: Expressing concern over the prevailing crisis of oxygen and some Covid-19 drugs in many states, Chief Minister Naveen Patnaik Tuesday directed senior officials to ensure smooth supply of the same to the patients.

Patnaik gave this direction while holding a high-level meeting on Covid management Tuesday evening through videoconferencing

Stating that oxygen is the most vital requirement in treating Covid patients, the Chief Minister directed officials to ensure that the supply of oxygen continues in a smooth manner and that adequate oxygen is delivered to the patients on time. He also advised the officials to stock essential medicines and ensure their flawless supply. "Every life is precious and we continue to do our best to save one life. If one infection is reduced, the pressure on one ICU and one bed will be reduced." he said.

The state government continues to work towards providing the best possible healthcare facility to Covid patients, and doctors and health workers continue to work day and night. Therefore, the administration has to work very carefully to reduce the burden on the healthcare system, Patnaik said.

The Chief Minister said, "Despite increase in number of infections, we continue to serve. But the situation in some districts has raised concerns. The double and triple mutants of the virus

are spreading rapidly, and in this second wave our youth are particularly infected. We need to be prepared to deal with the worst situations in the world, just as we have in dealing with natural disasters.

He directed the district Collectors and SPs to assess the situation at the grassroots level and formulate a micro management plan. The Covid observers have been asked to be vigilant. The CM instructed the Chief Secretary to review the matter on a regular basis and inform him at the next meeting.

He lauded the trade associations in different districts, who had voluntarily stepped in to control Covid by restricting business hours and closing shops in some places.

Chief Secretary SC Mahapatra said senior officials are keeping a close watch on the situation. Covid Care Centres and all Covid hospitals have been operationalised. Steps are

being taken to increase the number of beds in medical colleges and converting new private hospitals into Covid hospital, he said. Number of oxygen beds is being increased to 35 per cent from existing 30 per cent.

Additional Chief Secretary, Health, PK Mohapatra said there are currently 50,958 active cases in the state and 70 per cent active cases reported from seven districts. He said the state now has 31,471

beds. Apart from ICU beds, oxygen support is being facilitated at 17,495 beds. He said steps are being taken to increase the number of beds in both public and private Covid hospitals. The government is working towards providing more oxygen to the beds, Mohapatra added.

SOP issued for rational use of O₂

BHUBANESWAR: The state Health department Saturday issued a fresh SOP for rational use of oxygen in hospitals especially

in treatment of Covid-19 patients. Additional Chief Secretary PK Mohapatra sent the SOP to the district Collectors and other officials concerned. In his communication to the officials, Mohapatra said that indiscriminate usage of

medical oxygen must be stopped. "It is noticed that the number of Covid cases are increasing by the day and government is keen on setting up of sufficient Covid facilities with general beds, high dependency units (HDU) beds and ICU beds. Such patients require oxygen which is the mainstay of treatment. Oxygen is precious and we may face acute shortage if not managed properly, rationally and judiciously," the letter to

Collectors read. "Also timely use of oxygen can reduce the mortality as well as morbidity to a large extent. In view of the above, the Standard Operating Procedure (SOP) shall be followed scrupulously for rational use of Oxygen in the Covid facilities. This shall be followed in true letter and spirit in all government and private Covid-19 hospitals,

letter read. Mohapatra also said that expert teams would visit hospitals periodically for strict compliance of such protocols. "Any deviation to the rational use shall be viewed seriously," the government

State reports 10 more fatalities, 6,073 cases

Bhubaneswar, April 27: Odisha's Covid-19 caseload Tuesday surged to 4,20,129 after 6,073 more people tested positive for the infection, while 10 fresh fatalities pushed the toll to 2.007. a Health and Family Welfare (H&FW) department official said.

Accordingly, the number of active cases rose to 50,958, which is 12.12 per cent of the caseload.

Of the 6,073 new cases, 3,522 were detected from quarantine centres and the remaining during contact tracing, the official said.

Khurda district, of which state capital Bhubaneswar is a part, reported the maximum number of new cases at 1,092, followed by Bolangir at 457 and Nuapada at 400. Other districts which reported more than 100 cases include Sundargarh (371), Jharsuguda (359), Bargarh (286), Kalahandi (277), Keonjhar (266), Angul (239), Puri (266).

Four fatalities were reported from Khurda, three from Sundargarh, two from Rayagada and one from Boudh.

The state's case-fatality ratio (CFR) stands at 0.47 per cent, the official said.

As many as 3,67,111 people have recuperated from the highly infectious disease. Odisha's positivity rate has touched

Ganjam Collector Vijay Amruta Kulange talks more on the issue. Excerpts:

■ Do you now see influx of migrants to Ganjam like last year?

Last year, around 4 lakh migrants had come to Ganjam from different parts of the state and the country when the Covid cases rose across India and lockdown was imposed. However, this year the numbers are quite low. This year, we have seen return of only 11,000 migrants. The number this time is not expected to swell like last year.

■ Where the maximum migrants of Ganjam are heading towards?

Ganjam migrants are not distressed migrants. They are skilled people. Maximum migration is towards Surat in Gujarat. Many of them are doing good job in the textile and diamond industries

■ There was Covid explosion in Ganjam last year. What were the reasons behind this?

Till the initial days of May 2020, we had been reporting the minimum cases of the infection in the state but as large number of people from other states came back to the district, the cases kept on rising.

Cong demands postponement of Pipli bypoll 50-year-old forces

THE PARTY HAS ALREADY LOST ITS CANDIDATE AJIT MANGARAJ TO COVID-19 LEADING TO THE DEFERMENT OF POLLING DATE TO MAY 16

Bhubaneswar, April 27: Opposition Congress Tuesday demanded postponement of the May 16 by-poll in Pipli assembly seat in Odisha in the wake of the resurgent Covid-19 pandemic across the country.

A delegation of the Odisha Pradesh Congress Committee (OPCC), led by its working vice-president Pradeep Majhi, submitted a memorandum at the office of the state Chief Electoral officer addressing to the Election Commission (EC).

"We are optimistic that our appeal will be heard and the polling to be postponed," Majhi told reporters.

The Congress leader said that allowing polling May 16 is as good as putting the lives of people in danger as health experts have warned that the Covid-19 infection will reach its peak in the second week of May.

Majhi questioned, "The leaders are becoming super spreaders (of coronavirus) as they reach out to the masses. Therefore the campaign is now restricted. What is wrong if we put polling on hold till the situation becomes normal?'

Congress has already lost one of its candidates, Ajit Mangaraj to Covid-19 leading to the deferment

of the polling date to May 16.

'When the situation in Odisha has assumed alarming proportions. why is the Election Commission determined to conduct the by-poll? Are the votes so important for the Election Commission? We demand that the by-poll be postponed till the pandemic is brought under control," Majhi said at a press conference here. Besides, it is not possible for any party to campaign in Pipli as the people of the constituency block roads to their villages to prevent political leaders from canvassing. "Under such circumstances, how will the political parties campaign for their candi-

dates?" Majhi asked. He also appealed to the ruling BJD and opposition BJP to make similar demands to the EC in the larger interest of public health. "You see the situation of West Bengal where elections are being held. It is better for the lives of 4.5 crore people of the state to refrain from any kind of election for now,'

BJD vice-president Debi Prasad Mishra said as the EC, as a statutory body, has decided to conduct the by-poll under the 'Representation of Peoples Act' of the Constitution, neither BJD nor the state government has anything to say about it.

The BJD is not campaigning as per the direction of Chief Minister Naveen Patnaik, he added.

State BJP leader Prithviraj Harichandan said if the political parties strictly follow the Covid appropriate behaviour while campaigning, the by-poll will be held without any problem and will set a precedent for the ensuing elections in the neighbouring states.

The demand to defer the Pipli by-poll is a "political gimmick" of the Congress, he asserted.

Majhi rejected Harichandan's charge and said that there is no politics behind the demand. People's lives are important, not elections, he added. The EC has totally banned election meetings and rallies. It has allowed only five persons including the party candidate, to conduct door-to-door campaigns. This is being resisted by the people who are not willing to allow outsiders into their villages and houses.

Covid-19 has already claimed the lives of two leaders in Pipli. While Pipli MLA Pradeep Maharathy died of the infection in October, 2020 leading to the by-election, Congress candidate Ajit Mangaraj too succumbed to coronavirus April 14 in the middle of campaigning. The by-poll which was slated for April 17 was then rescheduled to May 16.

The CB took up the probe in three cases registered at Talabania and Town police stations in Puri and Lingaraj police station in Bhubaneswar.

According to sources, the minor girl had lodged a complaint with Talabania police accusing a 50year-old person of putting pressure on her to marry him March 16, 2021. The girl also alleged that the accused had threatened to make viral her obscene photos on social media when she refused to budge. The family members of the accused allegedly threw poisonous snakes in front of their residence preventing the family from going outside. The mother of the minor girl had also filed a similar complaint with Town police in Puri accusing the persons of forcing the 12-year-old girl to marry the CB took up the probe in three cases registered at **Talabania and Town** police stations in Puri and Lingaraj PS

accused at gunpoint in February 2021. Similarly, her mother had also lodged another complaint with Lingaraj police against the accused. She alleged that the accused and his aides followed the mother and the daughter when they were going to Cuttack and allegedly beat the duo near Ravi Talkies here.

Peeved at the snail-paced police investigation and continuous torture, the victim's family moved the NHRC. The rights panel urged the CB to initiate an independent enquiry into the allegations and alleged police inaction.

Meanwhile, Lingaraj police officials told Orissa POST that the investigating officer had repeatedly requested the victim's mother to assist the police. However, she is not cooperating in the investigation. She had not appeared before the police even for once after the lodging of the compliant.

2nd wave more severe: Experts

Bhubaneswar, April 27: Doctors at the state government-sponsored medical briefing Tuesday said that the second wave infections are more severe which trigger more demand of oxygen from the Covid infected

Dr Sampath Kumar Das, Aditya Ashwini Hospital Tuesday briefed the people on Covid-19 and ways to tackle it. In a virtual communication with the state health department, Dr Das cited the difference in symptoms in the second wave com-

pared to the first wave and the difference in terms of severity.

"In the second wave we are seeing a difference in symptoms. Last year, we used to see moderate and low grade fever among the Covid patients. This year, the fever is often high grade. Last year, gastro intestinal issues in were not seen much which is more visible in the second wave infections.

He also said, "This year, the severity and oxygen demand needed in Covid cases are higher compared to last year.'

Meanwhile, Dr Jayant Kumar



Panda from SCB Hospital, Cuttack said that the mortality in the second wave is lower but the infection rate is quite high.

"The second wave mutant strains are more infectious in nature. This year, the kids and youths are also getting infected in good numbers. The new strains are staying suspended in the atmosphere for longer period of time in indoor areas and where number of people are more,' he said. He also added, "The chances of infection in overcrowded areas are much higher now. Chances of infection are higher in people who are not wearing masks properly or not wearing masks at all. Those people who have not been vaccinated are becoming victims of the disease. However the mortality rate in the second wave is a bit lesser which has given



No vaccine drive in Keonjhar, Jajpur today

Bhubaneswar, April 27: The state government is now grappling with massive shortage of Covishield vaccine, government data hinted Tuesday.

According to the state government, by 8pm of Tuesday the government was left with only 54,040 doses of Covishield vaccine in the state, raising doubts over the smooth vaccination drive.

The state has planned only 464 sessions instead of its earlier plan to undertake the drive at 1,500 active sites. The government has now planned to halt the vaccination drive for Keonjhar and Jajpur for Wednesday.

The Health department Tuesday was able to conduct the drive at only 617 active sites. Vaccine was not available in many areas in several district vaccination centres and people were being turned away.

The government claims that by Tuesday a total of 57,04,916 persons have been vaccinated. On the other hand, the government was able to vaccinate only 65,766 persons Tuesday.

Sambalpur, April 27: Blood donation drives by the blood banks in the state might get seriously affected with Chief Minister Naveen Patnaik Sunday announcing free vaccination for all above 18 years in the uncoming vaccination drive from May 1 for the Covid-19 pandemic, a report said.

The move for free v for youths by the state government has received wide appreciation from various quarters. Youths who are above 18 years are equally ecstatic for taking the vaccine with the pandemic spreading its tentacles in the state.

According to reports, blood banks are making all efforts to ensure that they don't run out of blood for emergency patients. However, various bottlenecks are preventing them in achieving the desired results.

While the vaccination drive has triggered fears of slowdown in blood collection, the weekend shutdowns announced by the state government and the sweltering heat of the summer are also playing truant. Moreover, the Covid-19 pandemic has also slowed down the blood collection drive as people are hesitant to attend blood donation camps fearing infections.

It is apprehended that blood banks in the state might run out of blood and emergency patients in need of blood transfusion could face serious problems with a large number of youths opting for vac-



youths who are the major contributors of blood to the blood banks might not be able to donate blood for a period of 28-days after taking the vaccine, the report said. When contacted, Debashis

Mishra, officer of blood bank at VSS Institute of Medical Sciences and Research (VIMSAR) at Burla, said that the youth are the major blood donors at any blood donation camp organised anywhere in the state. He said that blood donation camps

are organised at various places in the state to ward off the blood shortage in the blood banks, especially during the pandemic. This has helped in preventing blood shortage in various blood banks in the state. As a result, critical and other patients have been able to receive blood when they required it. The weekend shutdown has also

affected the blood collection drive as people fear to step out of their homes fearing crackdown by the police. Moreover, kin of emergency patients find it difficult to reach the blood banks and receive blood for the same reason

He said that the blood bank currently has 200 units of blood, while 70-80 units of blood are supplied daily to the patients in VIMSAR. He, however, said that the situation might improve after a month as there are plans to organise five blood donation camps by April end to ensure that there is no shortage of blood.

Dr Kalpesh Kakad, an officer of blood bank at the district headquarters hospital, said that the blood bank in the hospital faced acute blood shortage with only 30 units of blood in its stock. However, the number went up after organising two camps at two different places.

The total blood collection reached 111 after collecting 61 units from one camp and 50 from another camp. Now, the blood bank is left with only 141 units of blood, which is likely to be exhausted in five days. Two more camps will be organised by April end, he added.

Chitrada, April 27: Sabai grass, which is cultivated in many pockets of tribal-dominated Mayurbhanj district, has turned out to be a money spinner for scores of women in Morada block. They make various household, handicraft and decorative items from sabai grass. On selling these items, they are earning in thousands.

Women of Haduapani village under this block have scripted success stories in self-sufficiency centering on sabai grass by dint of their effort and determination.

Notably, sabai grass is a natural fibre. It is grown abundantly in the hilly areas such as Jadunathpur, Kamalashol, Purnachandrapur,



Beladunguri and Astajharan in tribaldominated Badasahi and other blocks.

According to reports, 35 women from nine self-help groups had taken seven-month training on making household, handicraft and decorative items. They use sabai grass, date stems and threads to make about 25 different items, including flower baskets, bags, dust bins, fruit baskets,

pachhia (a kind of sieve) and other household items. Now, their business has started given them financial benefits as these items have high demand in the market.

Sale of these items is going up. "On an average, each woman engaged in this work earns ₹3000 a month. Women are becoming self-sufficient and supplement their family incomes," says Dhanabati Dhal.

'Our family members extend a helping hand in our work. If our group is registered, we will carry forward our income-generating activities," said Lili Nayak.

"The items that we make have high demand in the market. It has potential for good incomes, observed Sanjukta Raj.

BPM of Odisha Livelihood Mission, Himansu Bhusan Sahu said that he is aware of the group and advised Minati Das of Chadeigaon about the benefits of registration.

If these women approach the authorities in 2021-22, their group will be formed and registered, he added.

Business of Vaccine

et the games begin! This used to be the Roman phrase for letting the hungry lions enter the arena to fight slaves. Today, in India, we seem √to be going back to the Roman mindset. If we look back into history, India as well as the world has encountered many epidemics. Spanish flu, cholera, plague, swine flu, small pox as well as diseases that do not strictly fall into epidemic category such as malaria, polio, tuberculosis, leprosy and such have always made the administration dole out free medical assistance in the form of vaccines, medicines and hospitalization. There have been reports about patients of different castes and religions receiving differential treatment during the Spanish flu pandemic in India. However, there is no record of government fixing prices of essential lifesaving vaccines or medicines for epidemics and large scale contagious diseases. Children receiving polio drops have been common knowledge for long many years. Similarly, leprosy patients being administered MDT tablets is also known. All such medicines have always been free for citizens globally and not just in India. Rather, India has gone a few steps ahead by ensuring leprosy patients take their MDT tablets on a regular basis by involving the VLWs (Village Level Workers) in distribution of the medicines.

Move forward to the present day. India is hitting global headlines because of dire shortage of not only oxygen and hospital beds but also vaccines during this Covid-19 pandemic. While some claim this is a second wave with double and triple mutants, others assert the first wave continues while the virus is constantly mutating. With this in the backdrop, the Supreme Court of India has suddenly woken up to the situation and is claiming that it can

no longer remain a mute spectator. Notably, the SC could not respond in time to the plight of citizens, especially the migrant labour force, after the sudden national shutdown announced by Prime Minister Modi last year. This year too, after a long delay. the SC has asked the government to give complete details based on which the costing of the vaccines have been computed. The exercise for the life saving vaccination of every citizen has been under discussion in



all countries across the world. Interestingly, all nations are offering free double dose of the vaccines to their citizens. India, which till the other day, was boasting of its ability to produce large number of vaccines and claimed it could also export vaccines worldwide, is now failing to meet its home demand. On top of that, the unspoken promise of free vaccination has now sunk into discussion of cost per unit. The shortage of vaccines is evident in a state like Orissa where AstraZeneca's Covishield produced by Serum Institute of India has completely disappeared even in a place like Cuttack. State government has officially declared almost all vaccination centres shut. That apart, private hospitals too have depleted their stocks and are turning away people who wish to have their first or even their second jabs.

It is necessary to analyse why such a situation has arisen. The moment people in power demanded that the Central government permit releasing 50 percent of the vaccines to the open market, the free vaccines simply vanished from the centres. Most citizens would be aware that government supplied free medicines are usually plundered and sold to the black market by the concerned officials. It is also a known fact that even gauze, cotton, syringes and such supplies to government hospitals find their way to the select few medicine shops strategically located across the street. Now, with the situation of life and death in a balance for everyone, the concept of half paid and half free will create an immense scope for huge amounts of illegal money to be made. In the process, those who can afford the jabs will be forced to pay a much higher price while majority of the poor and indigent will not be able to access the free portion of the jabs that is their due. It needs no reminding that most families in India have single bread earners. The bulk of employed youth in urban and semi-urban India are barely able to make both ends meet. It would be near impossible for this segment to afford vaccines at a cost of Rs 600 or Rs 1200 for themselves and their families. Apart from this, rural India has a majority of population living below poverty line. Resultantly, these huge sections of citizens would opt out of a high cost vaccine and take chances with their lives. This will ensure the pandemic continues in India for a long time and extracts a heavy toll on human lives and

mournival beats a gleek. If we were playing poker, you might well comment equivalently that four of a kind beats three. We are, indeed, in the realm of card games, though gleek, which takes its name from the threesome group in it, is one you have probably never heard of. People are first recorded playing it in England under that name early in the 1530s, though Henry VIII's first wife, Catherine of Aragon, was reportedly fond of it in her youth, which would take it back to the beginning of the century or perhaps a little earlier. In fact, it's almost certainly the same game as the earlier French glic. It was a gambling game for three players, often called halfpenny gleek, penny gleek or twopenny gleek, whose names refer to the monetary value of each point scored, not the total bet. An English penny was worth a lot at the time, so losing could be expensive — in 1646, the poet and writer John Hall warned that "gleeke requires a vigilant memory and a long purse". Samuel Pepys recorded in his Diary in February 1662, "We played at gleeke, and I won 9s. 6d. clear, the most that ever I won in my life. I pray God it may not tempt me to play again." One phase of the game involved declaring any gleeks or mournivals of aces or court cards that you had in your hand, which gained money from each opponent. In penny gleek, for example, a mournival of aces got you eight pence from each of the other two players. Mournival comes most probably from old French mornifle for a group of four cards, which may be the same word as that for a slap in the face (which might be the figurative effect of finding an opponent has one). Gleek is also French, perhaps from an older Dutch word that means "like". It's unconnected with the obsolete English word of the same spelling, contemporary with the card game sense, that refers to a joke or playing a trick on somebody.

■ Moxie

Moxie, usually so spelt, was (and in New England it would seem still is) the name of a non-alcoholic drink, first produced in substantial quantities by the Moxie Nerve Food Company of Lowell, Massachusetts in about 1884. Its founder, Dr Augustin Thompson, originally developed it in the 1870s as a patent medicine or nerve tonic, claiming it cured paralysis, loss of manhood, and softening of the brain. The name may come from the Algonquin Indian word root maski- "medicine" which became moxie as a name for wintergreen, one of the early constituents of this bitter drink. Moxie was the first carbonated and bottled soft drink that was widely distributed in America (just beating Dr Pepper and Coca-Cola), being sold from "Moxie bottle wagons" and later "Moxiemobiles".

CLIMATE CHANGE GEOPOLITICS

The European Union is emerging as the world's climate trailblazer. Just recently, lawmakers and European governments agreed on the European Climate Law, which anchors our climate-neutrality target in statute. With the Green Deal as our growth strategy and our 2030 emissions-reduction target of at least 55 per cent, the EU is well on the way to achieving climate neutrality by 2050. But Europe is not alone: a critical mass is developing globally as more countries strengthen their decarbonisation commitments.

Recent meetings with John Kerry, the US special presidential envoy for climate, confirmed that the EU and the US are once again working closely to mobilise an international coalition around the goal of substantially raising climate ambitions for November's United Nations climate summit (COP26)

There is no time to lose. Unchecked climate change - with its devastating droughts, famines, floods, and mass dislocations would fuel new migration waves and significantly increase the frequency and intensity of conflicts over water, arable land, and natural resources. To those who complain about the large investments needed to tackle climate change and biodiversity loss, we would simply point out that inaction would cost far more.

By tackling the climate and biodiversity crises, everyone will be better off, thanks to better jobs, cleaner air and water, fewer pandemics, and improved health and well-being. But, as with any broad transition, the coming changes will upset some and benefit others. creating tensions within and between countries. As we accelerate the transition from a hydrocarbon-based economy to a sustainable one based on renewable energy, we cannot be blind to these geopolitical effects.

In particular, the transition itself will drive power shifts away from those controlling and exporting fossil fuels, and toward those mastering the green technologies of the future. For example, phasing out fossil fuels will significantly improve the EU's strategic position, not least by re-

ducing its reliance on energy imports. In 2019, 87 per cent of our oil and 74 per cent of our gas came from abroad, requiring us to import more than €320 billion (\$386 billion) worth of fossil-fuel products that year.

Moreover, with the green transition, the old strategic choke points - starting with the Strait of Hormuz – will become less relevant, and thus less dangerous. These seaborne passages have preoccupied military strategists for decades. But as the oil age passes they will be less subject to competition for access and control by regional and global powers.

Phasing out energy imports will also help to reduce the income and geopolitical power of countries like Russia, which currently relies heavily on the EU market. Of course, the loss of this key source of Russian revenue could lead to instability in the near term, particularly if the Kremlin sees it as an invitation to adventurism. In the long term. though, a world run on clean energy could also be a world of cleaner government, because traditional fossil-fuel exporters will need to diversify their economies and free themselves from the 'oil

curse' and the corruption it so often fosters.

At the same time, however, the green transition itself will require scarce raw materials, some of which are concentrated in countries that have already shown a willingness to use natural resources as foreign-policy tools. This growing vulnerability will need to be addressed in two ways: by recycling more of these key re sources, and by forging broader alliances with exporting countries.

Moreover, as long as other countries' climate commitments are not on par with our own, there will be a risk of "carbon leakage." That is why the EU is working on a carbon border adjustment mechanism (CBAM). We know that some countries, even among our allies, are concerned about this. But we want to be clear: setting a price on imported carbonintensive goods is not meant to be punitive or protectionist.

In addition to ensuring that our plans are compliant with World Trade Organisation rules. we will engage with our international partners early on to explain what we have in mind. Our goal is to facilitate cooperation and help others reach their climate targets. The CBAM, we hope, will trigger a race to the top.

Though the green transition will bring about more sustainable and resilient economies, it will not automatically usher in a world with less conflict or geopo litical competition. The EU, harbouring no illusions, will need to analyse the impact of its policies across different regions, recognising the likely consequences and planning for the foreseeable

For example, in the Arctic, where temperatures are rising twice as fast as the global average, Russia, China, and others are already trying to establish a geopolitical foothold over territory and resources that were once under ice. While all of these powers have a strong interest in reducing tensions and "keeping the Arctic in the Arctic," the current scramble for position is putting the entire region at risk.

To Europe's south, there is enormous potential to generate energy from solar and green hydrogen, and to establish new sustainable growth models based on renewable energy. Europe will need to cooperate closely with the countries of Sub-Saharan Africa and elsewhere to seize these opportunities.

The EU has embarked on a green transition because science tells us that we must, economics teaches us that we should, and technology shows us that we can. We are convinced that a world run on clean technology would benefit people's well-being and political stability. But the road to get there will be fraught with risks and obstacles.

That is why the geopolitics of climate change must inform all of our thinking. Geopolitical risk is not an excuse to alter our course or reverse direction. Rather, it is an impetus to accelerate our work toward a just transition for all. The sooner we can ensure that global public goods are there for everyone to enjoy, the better.

Appreciate your benefits, don't exploit them

MANY PEOPLE, OF **COURSE, HAVE CALLED OFF SICK FROM WORK** WITHOUT A TRULY **LEGITIMATE REASON, SUCH AS** A WORLD CUP **MATCH ON TV**

f you're a full-time employee of a large organisation, you probably enjoy a number of benefits, including paid holidays, sick leave and maternity leave. These benefits vary widely from employer to employer, as well as from country to country. The movie streaming company Netflix, for example, offers both fathers and mothers up to one year of paid leave after the birth or adoption of a child. There is a catch though: you have to allow Netflix to come to your home and record the reality series "First Year with Baby.

Actually, the only catch seems to be that any parental leave that's longer than 30 days needs to be approved by the human resources department. All you need to do is give HR a call. First you'll have to speak to Miguel in Manila, who will soon transfer you to Manoj in Mumbai, who will transfer you to Marisol in Mexico City, who will put you on hold for 30 minutes. Just as you're about to hang up, you'll hear a voice that says, "Hello, this is Manuel in Madrid. May I help you?"

In other words, it might not be easy to be approved for a full year of parental leave. But even if cer**Netflix offers both fathers** and mothers up to one year of paid leave after the birth or adoption of a child. There is a catch though: you have

tain benefits aren't always easy to get, at least you have an opportunity to get them. If you're lucky enough to have them, you shouldn't take them for granted.

Employees of Zomato, the food delivery company, should be pleased that the company introduced a policv in 2020 that offers women up to 10 days of period leave a year. Even if you're a man, you should be happy to work for a company that cares about its employees. Today, it offers time off to recover from periods: tomorrow, it might offer time off to recover from mother-in-law visits.

It's also important to use benefits only when necessary, to not take advantage of them, to show your employer that you can be trusted. Many people, of course, have called off sick from work without a truly legitimate reason, such as a World Cup match on TV. They make sure they use up all the sick days they're eligible for, even if they have to risk running into a co-worker at the movie theater.

Taking advantage of the system may make it harder for other employees to legitimately gain access to a benefit. But that wasn't a concern for a bank employee in Taiwan who ensured that he'll never get the "Employee of the Year" award.

Employers in Taiwan are required to give employees eight days of leave when they get married. Most employees take advantage of this policy only once in their lifetimes, unless they happen to get divorced and remarried. But in 2020. the bank employee decided to get married not once, not twice, not

thrice, but four times! By doing so, he was able to qualify for 32 days of paid leave

This man devised a way to take advantage of the policy four times, while also ensuring that he didn't have any ex-wives.

On April 6, the man married his bride for the first time. Ten days later, on April 16, the couple got a divorce, only to remarry the next day, allowing the man to qualify for another eight days of paid leave. The second marriage ended in divorce on April 28, but the couple reconciled in time to remarry the next day, giving the groom another eight days of leave. On May 11, they divorced again, before remarrying the next day, allowing the bank employee to get eight more days of leave.

While the employee was technically eligible for 32 days, the bank did not approve his application and he had to appeal to the Labour Department. The case has not yet been resolved. But needless to say, the employee would be wise to start working on his résumé. If he and his wife are thinking of having children, he may want to apply to Netflix.

THE STATE MAY GET SII VACCINE DOSES ONLY AFTER MAY 20

Mumbai, April 27: Sparking worries, the Pune-based Serum Institute of India (SII) has informed the Maharashtra government that it can supply Covishield vaccines to the state only after May 20, Health Minister Rajesh Tope said here Tuesday.

Tope said the availability of vaccines remains an uphill task and the state needs at least one week's quota delivered at one go in order to inoculate the maximum number of

"The SII has informed the state government that it can supply the Covishield vaccines only after May 20," Tope told mediapersons, even as the state has only 72 hours left before rolling out the vaccination drive for people in the 18-45 age group from May 1.

Expressing concern over the development, the state spokesperson of the Congress, Sachin Sawant, said that SII's stance that it cannot supply the vaccines till May 20 since all stocks have been booked by the Modi government would put question mark on the upcoming inoculation drive for the 18-45 age group.

Slamming Prime Minister Narendra Modi, Sawant said that this is not the time to discuss lack of availability of vaccines.

"Where is your strategy? Modiji has no clue about supply of vaccines. The Centre has restricted the supplies to only two companies, and now it wants the states to buy from these two companies for the 18-45 age group," Sawant pointed out.

Since vaccines are in short sup-

ply and the Centre will take care of the 45-plus population, he sought to know whether the PM can set a target date for completing the vaccination drive in India.

Goa CM, Health Minister differ over lockdown as Covid spike intensifies

Panaji, April 27: Goa's battle against the raging Covid-19 pandemic appears to have reignited a fresh bout of one-up-manship between Chief Minister Pramod Sawant and Health Minister Vishwaiit Rane.

Traditional political rivals before Rane formally joined the BJP in 2017, the see-sawing relationship between the two leading politicians, who are anchoring Goa's fight against the steep surge in Covid-19 infections, has played out in the open once again over the issue of imposing lockdown in the state.

Rane Monday made a plea for imposition of a Maharashtra and Karnataka-like lockdown in Goa, on a day when the state registered a record 2,321 fresh cases and 38

"Goa definitely needs to go under lockdown on the lines of other states like Maharashtra and Karnataka for a particular period. More than economic activities, the lives of the people matter to us," Rane had said.

The Health Minister even tweeted that Goa could stand to lose more than 200-300 lives "within the next 10 days" if the lockdown was not imposed. The tweet was later deleted.

When asked for a response to the comment made by Rane seeking a lockdown, Sawant said: "You can ask him about it."

Sawant has, however, remained steadfast in his position that a lockdown is not feasible vet and the measure would be considered if

the situation in the state deteriorates

The Chief Minister for now has found the backing of the state's business and industry captains, who have thrown their weight behind Sawant over the issue of skipping lockdown.

A lockdown, said the president of the Goa Chamber of Commerce and Industry, Manoj Caculo, is unnecessary, while restraint is essential, as he slammed wedding parties and election related public gatherings.

We strongly support the CM in his decision to keep economic activities rolling by avoiding a complete lockdown. We need to keep businesses running to ensure that all the employees are paid. It's the uncontrolled social and political events that are responsible for the spread," Caculo said.

"Look at the videos of election results day or wedding parties... are the protocols being followed? Let the

tions on them," Caculo said.

Rane's popular cry for imposing a lockdown has, however, once again exposed the rift between him and the Chief Minister, that too at a time of crisis.

Opposition politicians like Maharashtrawadi Gomantak Party MLA Sudin Dhavalikar have pitched their support behind Rane and his demand for a lockdown for now.

"Our health infrastructure is overburdened, and as per reports from the health department and senior doctors, we are expecting to witness more cases and higher mortality rate if the situation remains the same. We need to prioritise human life over economy. We can bring back the economy, but



HC, CENTRE SLAM **DELHI GOVT OVER** O₂ CRISIS MGMT

New Delhi, April 27: The Delhi government has come under scathing attack from both the High Court and the Centre over its handling of the medical oxygen crisis that has hit COVID-19 patients here with the former saying Tuesday if the state cannot handle the situation it will ask the latter to take over gas refiller units as it can't let people die.

"Our confidence (in you) has shaken. Mr Rahul Mehra (Delhi government counsel) get your house in order," the Delhi High Court said, observing that the Delhi government has left re-fillers "to have a free run" even as hospitals "are crying hoarse for oxygen".

'Enough is enough. If you can't do this, tell us, we will ask the central government to take over these (oxygen refilling) plants. We can't let people die," a bench of justices Vipin Sanghi and Rekha Palli observed, as it came down heavily on the AAP government over its "failure" to check black marketing of oxygen cylinders. "The problem lies with the Delhi government."

In a strong criticism of the Kejriwal government for its alleged failure to arrange tankers for transportation of oxygen for the city's hospitals overstretched by mounting COVID-19 cases, the Centre said pro-active actions by it on a "war footing" could

Delhi hospitals to reopen admissions

New Delhi: After days of scrambling for oxygen, hospitals in Delhi Tuesday said they are in a comparatively better situation in terms of supply and have reopened admissions. Covishield, Covaxin effective against 'Indian strain' of virus

New Delhi, April 27: Covishield and Covaxin -- the two coronavirus vaccines currently in use in India -- have efficacy against the 'Indian strain' and show "milder" illness in case of infection post vaccination, a senior scientist said on Tuesday citing preliminary results of a study.

Anurag Agrawal, the Director of the Institute of Genomics and Integrative Biology (IGIB), said the study on effectiveness of the available vaccines on the B.1.617 variant of SARS-CoV2 suggests that post vaccination, the infections are milder. The B.1.617 variant is also



neutralisation studies of B.1.617, with both post-Covaxin or Covishield sera, are correlatable with milder disease during post-vaccination breakthrough infections. This is a positive while we get quantitative data for better understanding of infection protection," Agrawal tweeted.

IGIB is an institute under the Council for Scientific and Industrial

Another study by the Centre for Cellular and Molecular Biology (CCMB) in Hyderabad under the CSIR suggests that early results using in-vitro neutralisation assay show that both convalescent (prior infection) sera and Covishield-vaccinated sera offer protection against the B.1.617 variant.

Indians doubt efficacy of domestic drugs: Govt to SC

New Delhi, April 27: The Union government has informed the Supreme Court that the people in the country have developed a perception that only imported drugs can effectively treat the inflammatory burst medical condition in COVID-19 patients and the domestically produced drugs cannot.

In an affidavit filed in the suo motu case before the Supreme Court on the COVID-19 crisis, the Union government submitted that Tociluzumab Injection, manufactured by a company situated in Switzerland, is approved in the country for treatment of rheumatoid arthritis. The provision of its administration to COVID-19 patients is listed only as an investigation therapy in the national clinical management protocol for COVID for severe cases.

The Union government also informed the apex court that there are other domestically produced alternative drugs available for the treatment of COVID-19 which are either equivalent to or better than Tociluzumab such as Itulizumab, dexamethasone, methyl prednisolone etc to treat a medical condition which exactly the

Tociluzumab injection treats. "Recently a public perception is development that, being an imported drug, it is only Tociluzumab injection which can effectively treat the inflammatory burst medical condition in COVID-19 patients and not the domestic drugs. This is a wrong perception," the

Centre told SC. The Union government contended that the production of Remdesivir drug has been upped in light of the growing demand for the same during the second surge of COVID-19.

Enforcing COVID norms states' responsibility: EC

New Delhi, April 27: Facing flak over its alleged failure to ensure COVID-19 appropriate behaviour during poll campaigns, the Election Commission Tuesday said enforcing provisions of the law to fight the pandemic is the responsibility of state disaster management bodies.

The commission also asserted that it has continuously directed state and district authorities to enforce instructions of the National Disaster Management Authority (NDMA) to prevent the spread of the coronavirus.

The poll panel underlined that on "no occasion" it takes over the task of a state disaster management authority (SDMA) for enforcement of instructions issued in the wake of the COVID-19 pandemic.



The Election Commission's (EC) remarks came a day after the Madras High Court made harsh observations against it for failing to enforce COVID appropriate behaviour during poll campaigns.

Elections have been held in Assam, Tamil Nadu, Kerala and the Union Territory of Puducherry. The last of the eight phase West Bengal polls is Thursday. Counting for votes for all the assembly elections is May 2.

The commission in a statement said while it will comply with all directions of the high court, on April 30, during the next hearing, it will apprise the bench of all the steps already taken by the poll panel for free, fair and safe elections.

It also said "statements being attributed to the Hon'ble High Court in certain sections of media" do not find mention in the order which was finally passed.

The EC was apparently referring to the oral observations made

by the bench against it. Referring to the petition that was moved in the Madras High Court to ensure "COVID safe" counting May 2, the statement said that similar petitions concerning COVID-19 compliant behaviour during ongoing elections were filed, and the EC had already responded to them.

Prone position helped octogenarian beat Covid

Gorakhpur (Uttar Pradesh). April 27: As Covid patients across the state gasp for oxygen, an 82-yearold woman from Gorakhpur has managed to bring up her oxygen levels by lying in a prone position.

She has recovered from Covid without an oxygen cylinder and is setting an example for others.

Vidya Srivastava from Alinagar in Gorakhpur tested positive for Corona earlier this month.

Her elder son, Hari Mohan Srivastava, said, "My mother tested positive and we kept her in home isolation. One day her oxygen levels dipped to 79 and everyone in the family was worried. However, we did not give up and made her lie down in the prone position with stomach down towards bed. Gradually, the situa-



tion improved and the oxygen level rose to 94 within four days.'

Hari Mohan spent four days in his mother's room and monitored her oxygen levels regularly. She was not given an oxygen cylinder. The entire family then tested positive but we did not lose hope and tried to keep each other in a positive frame of mind. We took precautions and medicines after taking advice from the doctor. Now, finally the entire family has recovered from the deadly virus, he said.



New Delhi, April 27: The second wave of Covid-19 has turned more lethal, infecting more people and taking more lives. Besides causing financial and physical problems, it has also affected people mentally, creating panic in their minds.

The uncertainty about their present and future, coupled with government mandates to stay at home. is all exacerbating mental illness. The feeling of being cooped up at home, distant from their loved ones, devoid of social support and fear about new variants is increasing mental illness, according to mental health experts.

"The current situations are affecting the mental well-being on account of the uncertainty of the present and the future, the impact on the physical health of the self and loved ones, impact on work and



productivity, and as a result, an effect on the relations that surround them." Dr Samir Parikh, Director, Department of Mental Health and Behavioural Sciences, Fortis Healthcare, told IANS

While the current scenario is af-

fecting all individuals, regardless

of their age, gender or other de-

mographics, more adolescents and

adults have reached out seeking help for mental health issues.

"Since the beginning of April, there has been a rise in tele-psy chiatric consultations by at least 20 per cent. While the face to face consultations have plateaued, teleconsultations requests for seeking help have steadily increased." Dr Satish Kumar, Consultant Clinical

Psychologist, Manipal Hospitals, Bengaluru, told IANS.

The most prominent problem reported by people is anxiety and depression. Teens are more stressed out about their future plans, resulting in an existential crisis while the adults are overwhelmed by the fear of survival, financial insecurity and job security.

These fears are coupled by "Covid anxiety/pandemic anxiety. People fear that they are going to die, increasing their death anxiety issues", Kumar said.

"People are also worried about being spreaders and causing harm to their loved ones. Even those people who never had mental health issues, even in their family history, are now reaching out for medical support as they are facing a lot of emotional stress," Kumar.

"Many experience guilt around not being able to adequately support

those around them. These experiences can impact people's sense of self, their confidence and belief in the worldviews they hold as well as their positivity, optimism and resilience to cope with situations," Parikh said.

To cope with the current situation, Parikh suggested that one must: focus on the here and now; try and look at the things that you can control; attempt to maintain a routine and follow a balanced schedule; integrate relaxing and recreational activities to help unwind and relax; not engage in excessive information overload to not feel overwhelmed; focus on the small good things that will allow you to maintain positivity in your thoughts; speak to people around and maintain social connectedness; and ensure to follow all safety protocols and maintain Covid appropriate behaviour.

The UK is sending 495 oxy gen concentrators, 120 noninvasive ventilators and 20 manual ventilators this week. Out of these, 100 ventilators and 95 oxygen concentrators have already arrived on Tuesday.

France is sending relief material in two phases. In the second phase, five liquid oxygen containers will arrive next week.

The government of India has so far provided 15,65,26,140 vaccine doses to the states and LITs free of cost. "The total consumption, including wastage, is 14,64,78,983 doses. More than 1 crore doses (1,00,47,157) are still available with the states and UTs to be administered. More than 80 lakh (86.40.000) doses will be received in addition by the states and UTs in the next

three days," the ministry stated.

The ministry said that recently some media reports quoting some government officials from Maharashtra have pointed out that the state has exhausted vaccine doses. thereby adversely impacting the vaccination drive. "It is clarified that the total COVID vaccine doses received by Maharashtra as April 27 (at 8 am) are 1,58,62,470. Of this, the total consumption, including wastage (0.22 pc), was 1,49,39,410.

"Balance of 9,23,060 doses is still available with the state for administration of vaccine doses to the eligible population groups. Furthermore, 3,00,000 doses of COVID vaccines are in the pipeline for delivery in the next three days," the ministry stated.

New Delhi, April 27: The Indian Railways has handed over 169 train coaches to various states for Covid care.

In the united fight against the Covid-19 pandemic, the Railways has developed nearly 4,000 Covid care coaches with almost 64,000 beds ready for use by the states.

In a statement, the Ministry of Railways said, "New demand for Covid coaches has come from Nagpur district. In this direction. an MoU has been signed between the divisional railway manager, Nagpur, and the commissioner of Nagpur Municipal Corporation."

Accordingly, the Railways will deploy a Covid care rake with 11 coaches comprising modified sleepers with a capacity to accommodate 16 patients in each coach.

The coaches will be equipped with the necessary medical infrastructure by the state health authorities with Railways devising the segmentation of space and utility for medical personnel in line with the MoU, besides taking care of sanitation and catering arrangements.

The Railways will also mobilise Covid care coaches for Nagpur, Bhopal, Ajni ICD (Nagpur), and Tihi (near Indore) as per the states'

KUMBH MELA: SEERS KEEP LAST 'SHAHI SNAN' SYMBOLIC

Dehradun/Rishikesh, April 27: The last 'shahi snan' at the Kumbh Mela in Haridwar Tuesday was a subdued affair with seers keeping the ritual symbolic in view of a nationwide surge in COVID-19 cases.

Crowds at the ghats of the Ganga started thinning down drastically since last week after the key 'akhadas' of seers began pulling out of the Maha Kumbh, one of the largest religious gatherings in the world, citing the spike in the number of coronavirus cases.

Many spots wore a deserted look Tuesday at the Kumbh which will formally close only April 30.

Centre's Covid jab for world spells 'ouch' in India?

Mumbai, April 27: In a startling revelation under RTI, it has emerged that the country has exported the Covid-19 vaccines to at least 47 countries globally at rates cheaper than India, even as the domestic patients run helter-skelter for the life-saver jab.

Replying to an RTI query by a Nagpur-based activist-based lawyer, Ministry of External Affairs (MEA)'s Under Secretary Arun Kumar has stated that vaccines were supplied as 'grant' and 'contractual supplies' under the Covax facility.

"For grant supplies, vaccines were procured at a rate of ₹200/dose plus GST from Serum Institute of India Pvt Ltd (SII-Pune) and at a rate of ₹295/dose from Bharat Biotech International Ltd (BBIL), in accordance with the authorization given by the Ministry of Health & Family Welfare (MHFW)," the MEA's RTI reply stated. In addition, the MEA said that the prices of other supplies undertaken by the manufacturers in accordance with their commercial agreements are not

available with the government.

The development comes on a day when the government appealed to the two main vaccine manufacturers SII (private) and BBIL (government-owned) to slash their prices for the mega-phase of inoculations starting May 1. Till today, a total of 14.53 crore people have got their first or second jabs, as per the official data. "As per the data supplied

till April 10, the Centre has already exported a total of 6.37 crore doses to 89 countries. This constitutes 1.03 crore doses at ₹200+GST rates. and the rest 3.44 crore doses at commercial rates. For the same doses, now the Centre has allowed the same companies to levy double the rates in the Indian markets," Adv Ajmera told IANS

According to the current data

(April 27), the number of beneficiary countries has gone up to 95 and the total doses supplied are 6.63crore, including 1.07 crore as grant ₹200/dose+GST), and the rest 3.57 crore doses as per commercial agree ments, he pointed out.

Among the beneficiaries, Bangladesh - which Prime Minister Narendra Modi visited last month - has got the lion's share of 1.03 crore doses, including 33-lakh doses as 'grant' and the rest commercially.

The other big ones are Myanmar (17-lakh doses), Nepal (11-lakh), and on the lower rung is Seychelles (0.5lakh) and Dominica (0.7-lakh), and a 'grant' of 2-lakh doses to UN Peacekeepers

"The question that arises is when India with such a huge population is dying for the doses, where is the need for us to display such generosity to far-flung countries with low rates of infections and fatalities, many not heard of in India or visible on maps, some never visited by Indian leaders," Adv Ajmera asked.

He said the surprise is 'grant' to prosperous countries like Bahrain

and Oman, Nigeria, Kenya, and the tearing hurry in which at least 12 nations got their doses even before the drive had fully got underway in India! Against this, the two companies have announced their latest prices for the vaccines supplies for the domestic market.

The SII is supplying its Covishield vaccine to state governments at ₹400/dose and to private hospitals for ₹600/dose, and the BBIL is giving it at ₹600/dose to state governments and ₹1200/dose to private hospitals. Apparently justifying their rates, the SII said that global vaccines in the private markets are available at much higher rates ₹1,500/dose (American jabs), and ₹750/dose (Russian and Chinese jabs), while BBIL said the company is exporting its products at between \$15-20/dose (roughly averaging to ₹1.200/dose).

Adv Ajmera said that ideally, India should have ensured sufficient doses for her own citizens, create a surplus before doling out the doses or permitting commercial exploitation by Indian companies at the cost of the local population.

Iran wants nationals freed from US jails

However, he said, "their number is bigger than that of American prisoners in Iran."

In 2019, a prisoner exchange saw Iran free a Chinese-American scholar from Princeton who had been held for three years on widely criticized espionage charges. At the time, Tehran said American authorities were holding about 20 Iranian nationals in iail. Iran has expressed readiness for

Lanka Cabinet approves proposal to ban burqa in public places

Colombo, April 27: Sri Lankan Cabinet Tuesday approved a proposal to ban all forms of face coverings in public places, citing a

threat to national security. However, wearing face masks to combat COVID-19 is allowed.

The move came weeks after Minister of Public Security Sarath Weerasekara signed a paper in March, seeking the approval of the Cabinet to ban burqas -- outer garments that cover the body and face worn by some Muslim women.

The Cabinet has decided to ban all forms of face coverings in public places, Cabinet spokesperson and information minister Keheliya Rambukwella told reporters here, without specifying burgas.

"All forms of face covers are a threat to national security," he said. The covering of the full face will automatically include burqa and niqab.

The proposal now must be approved by Parliament to become a law. Last month, Pakistan's High Commissioner to Sri Lanka Ambassador Saad Khattak had criticised the proposal to ban the wearing of burqas in the country, saying such "divisive steps" in the name of security will not only hurt the sentiments of Muslims but also strengthen wider apprehensions about the fundamental human rights of minorities in the island nation.

Meanwhile, Weerasekera in a Facebook post wrote that the Cabinet has approved the proposal to ban all face coverings, including the burqa.

The Buddhist-majority nation in 2019 had temporarily banned wearing of burgas under emergency regulations following the Easter Sunday attacks.

Court restricts Navalny's anti-corruption foundation

Moscow, April 27: A court in Moscow ruled Tuesday to restrict the activities of an organisation founded by imprisoned Russian opposition leader Alexei Navalny, pending a decision on whether it should be outlawed as an extrem-

The Moscow City Court's ruling on Navalny's Foundation for Fighting Corruption came amid a sweeping crackdown on Russian President Vladimir Putin most prominent critic, his allies and his political infrastructure.

The Moscow prosecutor's office petitioned the court this month to label the foundation and Navalny's network of regional offices as extremist groups and effectively outlaw their activities, exposing members and supporters to lengthy prison terms.

If the court grants the request, it would be a crippling blow to Navalny's beleaguered team. He has been in prison since January,

and many of his aides and associates were arrested or facing criminal charges

Monday, the prosecutor's office ordered Navalny's offices in dozens of Russian regions to suspend their activities, prompting them to effectively shut down. The Tuesday ruling on the foundation just barred it from performing certain activities. Ivan Pavlov, a lawyer representing the foundation, said the organization is no longer allowed to use the media or the internet to distribute content or to organize rallies and public events, take part in elections or use bank deposits.

Restrictions on the foundation, however, will not disrupt its work, director Ivan Zhdanov said on social media, arguing that most of the restrictions don't apply to the anti-corruption organization's activities.

"Some nonsense," Zhdanov tweeted. "(These) aren't going to influence our work in any way."

Navalny's foundation opened 10 years ago and has since targeted



high-ranking Russian officials with exposes on corruption, many in the form of colorful and widely watched YouTube videos

One of its latest posts, which received 116 million views, alleges that a lavish palace on the Black Sea shore was built for Putin through an elaborate corruption scheme. The Kremlin has denied there are any links to Putin.

Along with the foundation, Navalny set up a vast network of regional offices in dozens of Russian regions when he was campaigning to run against Putin in the 2018 presidential election. He eventually was barred from running but kept the infrastructure in place.

cident on Monday. After a botched safety test in the fourth reactor of the plant, located in what was then Soviet Ukraine, clouds of radioactive material from Chernobyl spread across much of Europe in what remains the world's worst nuclear disaster.

When a French journalist collected water and soil samples from the Chernobyl area after the accident in 1987, the KGB swapped the samples for fake ones in a special operation, the SBU cited another KGB report as saying.

Thirty-one plant workers and firemen died in the immediate aftermath of the 1986 disaster, mostly

from acute radiation sickness. Thousands more later succumbed to radiation-related illnesses such as cancer, although the total death toll and long-term health effects remain a subject of intense debate.

The present day government in Kyiv has highlighted the Soviet authorities' bungled handling of the accident and attempts to cover up the disaster in the aftermath. The order to evacuate the area came only 36 hours after the accident.

"The 35th anniversary of the Chernobyl tragedy is a reminder of how state-sponsored disinformation, as propagated by the totalitarian Soviet regime, led to the greatest man-made disaster in human history," the foreign ministry said.

Rush to hospitals, big gatherings worsen India's Covid crisis: WHO

GENEVA, April 27: People in India are rushing unnecessarily to hospital, exacerbating a crisis over surging Covid-19 infections caused by mass gatherings, more contagious variants and low vaccination rates, the World Health Organization (WHO) said Tuesday.

India's death toll is now pushing towards 200,000, and hospitals that do not have enough oxygen supplies and beds are turning away coronavirus patients.

The WHO is providing critical equipment and supplies to India, including 4,000 oxygen concentrators, which only require an energy source, WHO spokesman Tarik Jasarevicsaid, Less than 15% of people infected with Covid-19 actually need hospital care and even



"Currently, part of the problem is that many people rush to the hospital (also because they do not have access to information/advice), even though home-based care monitoring at home can be managed very safely," Jasarevic said. Community-level centres should screen and triage patients and provide advice on safe home care, while information is also madeavailable via hotlines or dash-

RBI issues guidelines for appointment of statutory auditors of banks, NBFCs

Mumbai, April 27: The Reserve Bank of India Tuesday issued guidelines for appointment of statutory auditors of banks and non-banking finance companies (NBFCs), including housing finance companies.

'Guidelines for Appointment of Statutory Central Auditors (SCAs)/ Statutory Auditors (SAs) of Commercial Banks (excluding RRBs), UCBs and NBFCs (including HFCs)' will be applicable for financial year 2021-22 and onwards.

However, non-deposit taking NBFCs with asset size below ₹1,000 crore have the option to continue with their extant procedure.

The guidelines provide necessarv instructions for appointment of SCAs/SAs, the number of auditors, their eligibility criteria, tenure and rotation, etc. while ensuring the independence of auditors, the Reserve Bank said.

As the guidelines are being implemented for the first time for Urban Co-operative Banks (UCBs) and NBFCs from 2021-22, "they shall have the flexibility to adopt these guidelines from the second half of FY 2021-22, in order to ensure that there is no disruption".

Banks and UCBs will be required to take prior approval of Reserve Bank of India (RBI) for appointment/reappointment of

"It shall be ensured that joint auditors of the entity do not have any common partners and they are not under the same network of audit firms. Further, the entity may finalise the work allocation among SCAs/SAs, before the commencement of the statutory audit. in consultation with their SCAs/SAs," it said.

The guidelines further said that in order to protect the independence of the auditors/audit firms. entities will have to appoint the SCAs/SAs for a continuous period of three years, subject to the firms satisfying the eligibility norms each year.

Banks to remain closed for 12 days in May

Mumbai, April 27: Banks in India will remain shut for up to 12 days in May 2021, including weekends and festivals. Only the gazetted holidays are observed by banks all over the country. According to the Reserve Bank of India (RBI), banks in most of the states will remain closed May 14, 2021, on account of Eid-UI-Fitra. In May, banks including the public sec tor, private sector, foreign banks, cooperative banks and regional banks, will observe holidays on May 1, May 7, May 13, May 14 and May 26 on account of Labour Day Jumat-ul-Vida, Id-Ul-Fitr, Akshaya Tritiya and Buddha Pournima respectively.

Mumbai, April 27: The Confederation of All India Traders (CAIT) Tuesday wrote to Union Minister for Commerce and Industry Piyush Goyal seeking action against e-commerce giants Flipkart and Amazon for "supplying non-essential items" amid the COVID-19 restrictions imposed by several states.

"Amazon and Flipkart are making illegitimate financial gains by supplying non-essential items which have been strictly prohibited by many state administrations due to ongoing lockdowns to prevent the spread of COVID-19," the traders' body stated in its letter to Goval.

Amidst the raging pandemic, the foreign e-commerce companies are trying to "capture the market share from small traders by defin-



ing every item as essential including mobile phones and accessories," the CAIT alleged.

The CAIT, further marking its angst, said that the "government is closing its eyes towards all violations" by the e-commerce companies as they are "larger than life corporations".

The letter by the traders' body to Goyal comes days after a number of state governments imposed lockdown-like curbs, providing only a four-to-five-hour window to shops selling essential items including groceries. The non-essential shops and establishments have been asked to completely remain shut.

The e-commerce activities are allowed throughout the day in most of the states, but are restricted to only essential deliveries.

The CAIT, apart from accusing Flipkart and Amazon of delivering non-essential items amidst the curbs, has also accused both the companies of violating the inventory control policy.

Allow debt recast for borrowers of NBFCs: FIDC to RBI

Mumbai, April 27: The Finance **Industry Development Council** (FIDC) has written to the Reserve Bank seeking restructuring of stressed retail and individual borrowers of non-banking finance companies, irrespective of whether these loans have been restructured earlier.

In a letter written to the RBI Governor Shaktikanta Das, the industry body also requested loan recast for smaller NBFCs, having asset size of less than ₹500 crore.

"Considering the severe second wave of COVID-19, the retail borrowers, including the MSMEs, as also the retail and wholesale trader industry shall be in urgent need of support from the lenders, to revive their economic activities," FIDC said requesting extension of the restructuring scheme till March 31, 2022.

It said the borrower accounts, irrespective of whether or not such accounts had been 'restructured' on any earlier occasion and which are 'standard' accounts as on March 31, 2021, may be allowed 'restructuring' without any downgrade in asset classification However, this will be subject to

the lending NBFCs undertaking fresh credit assessment of the borrowing entity, it said.

The industry body urged the RBI $\,$ to allow standstill on buckets for restructured accounts for the first quarter of FY22. The letter further said the only mode of borrowings for the smaller NBFCs (having asset size of less than ₹500 crore) is to raise term loans from banks, fiFIDC

New Delhi, April 27: The Supreme Court Tuesday allowed Vedanta to operate its closed oxygen plant at Tuticorin in Tamil Nadu, saying the order has been passed in view of "national need" for oxygen and there should be no political bickering over the generation of the gas by the company as the country is facing a "national crisis"

The apex court made it clear that Vedanta shall not be allowed to enter and operate its copper smelt-



ing plant under the garb of this order and that permission to operate oxygen plant would not create any equity in the company's favour.

A bench of Justices DY Chandrachud, L Nageswara Rao and S Ravindra Bhat directed the Tamil Nadu government to form an oversight committee to oversee the functioning of the plant which would include District Collector and Superintendent of Police (SP) of Tuticorin, District Environmental Engineer, Sub-Collector Tuticorin and two government officials

The bench asked Vedanta to submit a list of technical and non-technical staff to the committee who are essential to run the oxygen plant. It said the order allowing Vedanta

to operate its oxygen plant would be in operation till July 31, 2021 after that it will assess the ground situation of the COVID-19 pandemic.

While submissions were being nade raising various issues connected with the plant, the bench said, "We are in a national crisis today where people are dying due to the lack of oxygen.

Mumbai, April 27: Bharti Airtel and Reliance Jio are neck and neck in terms of active mobile subscriptions, and hence the industry is unlikely to see any unanimous tariff hikes in 2021-22, a report said

Tuesday. Domestic credit rating agency Crisil's research wing pointed out that there is a close contest between the top two telcos, when one goes by active subscriber base with Jio's share at 33.7 per cent and Airtel's

at 33.6 per cent. The active subscriber market share data indicates the top two players are neck and neck, with neither ready to bite the bullet and raise tariffs, it said.

The build-up in competitive intensity also indicates that the industry is unlikely to see unanimous tariff hikes at least in the near term, limiting a large upside in average revenue per user (ARPU) in fiscal year 2022, it added.

The report said there is a universe of 250-300 million active non-4G subscriber base which will be on the radar of the telcos for conversion to 4G users in order to increase revenues.

While competition to attract this user base did exist before, inadequate spectrum and 4G coverage made operators err on the side of caution, it said, adding that with the recent spectrum acquisition, telcos are well-positioned to handle any surge in data traffic, leading to increased



aggression by the players to gain market share.

competition will be indirect in the form of tie-ups with smartphone However, a price war like the one manufactures for low-cost phones, seen before 2019 is unlikely and increased bundling of over the top

(OTT) content and lower entry points for upgrade customers, the report said.


It said Jio's recently launched JioPhone 2021 plans offering handsets along with one and two-year unlimited calling validity for ₹1,499 and ₹1,999, respectively, is representative of the same.

Individual players will most likely increase tariffs on selected plans given their immediate need to improve ARPU, it said. While all players agree that tariff hikes are paramount, they have differing levels of urgency to implement the hikes.

With the onset of the second wave of the pandemic and the resultant restrictions, there is once again reverse migration of labour. That could mean another quarter of subscriber churn. Also, given the restrictions in major cities, smartphone sales are likely to be impacted as well, which would slow 4G subscriber additions in the current quarter, it said.

The pace of additions should pick up gradually over the remainder of this fiscal as competitive intensity in the wirelesstelecom market increases, the report said.

In the best case, 4G subscribers may rise to 820 million by the end of this fiscal year from 720 million in 2020-21 end, assuming restrictions last only for the current quarter. In the bear case, where lockdowns extend through the secondquarter, the number will reach 800-







RCB BEAT DC IN THRILLER

Ahmedabad, April 27: So near yet so far - this was the situation for Delhi Capitals as they lost by just one run in their IPL encounter against Royal Challengers Bangalore here, Tuesday.

Chasing a competitive 172, skipper Rishabh Pant (58 n o, 48b, 6x4) and Shimron Hetmyer (53 n o, 25b, 2x4, 4x6) almost pulled it off for Delhi despite their side being reduced to 92/4 in 12.4 overs. The duo added an unbeaten 78 runs in just 7.2 overs.

Delhi were needed to score 14 off the final over - bowled by Mohammed Siraj, but they managed to score only four runs off the first four delivery including a dot ball. Pant struck a couple of boundaries off the last two balls but it was not enough.

Delhi lost their top three - Prithvi Shaw (21), Shikhar Dhawan (6) and Steve Smith (4) – in 7.2 overs with the scoreboard reading 47/3. Pant and Marcus Stoinis (22) tried up the ante with 45 runs stand before the Australian all-rounder perished off Harshal Patel (2/37).

Earlier, the ever-reliable AB de Villiers (75 n o, 42b, 3x4, 5x6) hit an unbeaten half century to power RCB to 171/5. It was a collective effort from the Delhi bowlers – Ishant Sharma (1/26), Axar Patel (1/33), Kagiso Rabada (1/38), Amit Mishra (1/27), Avesh Khan (1/24) – who all picked one wicket apiece.

De Villiers hit 22 runs off the last over bowled by Stoinis (0/23) that included three sixes. Rajat Patidar (31) and Glenn Maxwell (25) also provided valuable contributions.

Put in to bat, Devdutt Padikkal (17) and skipper Virat Kohli (12) were off to a flying start, amassing 30 runs in 3.5 overs. However, that changed as DC bowlers affected back-to-back blows.



IPL foreign recruits assured safe return

New Delhi, April 27: The BCCI Tuesday said it would do everything to ensure that foreign players competing in the IPL reach their respective countries seamlessely once the tournament ends, a day after three Australians quit the event amid an upsurge of COVID-19 cases in India.

Andrew Tye (Rajasthan Royals) and the duo of Kane Richardson and Adam Zampa (both Royal Challengers Bangalore) withdrew as apprehension set in after a couple of weeks went by smoothly for the league held in front of empty stands across six venues.

"We understand that many of you are apprehensive about how you will get back home once the tournament concludes... We want to apprise you that you have nothing to worry about," BCCI COO Hemang Amin said in a letter ad-

dressed to the players.
"The BCCI will do everything to ensure that you reach your respective destinations seamlessely. The BCCI is monitoring the situation very closely and is working with the government authorities to make arrangements to get you home once the tournament con-

"Be rest assured that the tournament is not over for BCCI till each one of you has reached your home, safe and sound," he added.

India is recording over three lakh daily cases for the past few days and the health infrastructure is struggling to handle the rise with shortage of oxygen and some crucial medicines adding to the crisis.

Australia, Tuesday, suspended all direct passenger flights from India with immediate effect until May 15 due to the "very significant" spike in COVID-19 cases.

Kolkata Knight Riders mentor David Hussey acknowledged that Australians in the IPL are a "bit nervous" about getting back home in the wake of the situation here. Amin lauded the players for car-

rying on. "As some of you have said, 'if we can help distract people from all the troubles of recent times, even if it is for a short while, we have done a great job'. When you all walk out onto the field, you are bringing hope to millions of people who have tuned in.

"If, even for a minute, you can bring a smile on someone's face, then you have done well. While you are professionals and will play to win, this time you are also playing for something much more important," he concluded.

The letter also stated that the teams will no longer be allowed to order food from outside. "...Earlier in the tournament, we had permitted food deliveries from outside your designated hotels, but these privileges have also been withdrawn. Apart from this, we have also increased our level of caution to strengthen our bio-bubbles," it said. "I am sure you will understand and co-operate with us on these steps taken to strengthen the bubble.

Several England and New Zealand players are also competing in the event but haven't yet spoken about their concerns. The IPL final is scheduled to be held May 30 in Ahmedabad.

As many as 14 Australian players remain in the event, including stars such as Steve Smith (DC), David Warner (SunRisers Hyderabad) and Pat Cummins (Kolkata Knight Riders), as well as coaches Ricky Ponting (DC) and Simon Katich (RCB).

Commentators Matthew Hayden, Brett Lee, Michael Slater and Lisa Sthalekar are also among the Australians involved with the league

One bitcoin was trading at over ₹40 lakh, Tuesday evening. Bitcoin is not considered legal tender in India but that has not stopped Lee, one of the fastest bowlers to have played the game, from lending a helping hand.

Like Cummins, who plays for Kolkata Knight Riders in the IPL, Lee is also in India as part of the IPL commentary panel

'Now is the time to be united and ensure we do as much as we can to help the ones in need. I'd also want to thank all the frontline workers who have been working round the clock during these tough times.

"I request people to please take care, stay at home, wash your hands and head out only if absolutely necessary, wear a mask and maintain social distancing. Well done Pat Cummins for the initiative yesterday," Lee said.

Iheanacho's hot streak could push Leicester over the line in the race for Champions League qualification, too. The win cemented third place for Brendan Rodgers' team, which is four points ahead of Chelsea in fourth and seven clear of West Ham in fifth. Liverpool is a point further behind, with all four teams having five games to play.

The Foxes faded away badly at the end of last season to drop out of the top four on the final weekend. That doesn't look like happening this time, with a second year in the Champions League — after 2016-17 — looking likely even after a grueling season that included a 🛶 Europa League campaign.

Leicester's win left Liverpool with even slimmer hopes of qualifying for the Champions League, just a year after Jurgen Klopp's team won the league for the first time in 30 years.
