MORE NUMBER OF VACCINATION CENTRES ON THE CARDS FOR INOCULATION OF 18-44 YEARS AGE GROUP

Bhubaneswar, April 28: Health and Family department of the Odisha government said Wednesday, that the vaccine doses it had received till now cannot be used for persons in the age group for 18 to 44 years. Bhubaneswar, April 28: With the state capital and Cuttack seeing a steep hike in Covid-19 cases, director of the state Health department Bijay Panigrahi said Wednesday that the twin cities may be hit hard by community transmission. The state capital reported 1,044 new Covid-19 cases in the past 24 hours, while the figure for Cuttack stands at 496.

Panigrahi said the number of cases in the twin cities is increasing as many people are visiting the two places from different districts. One positive person is infecting multiple people. Hence community transmission-like is prevailing.

However, Panigrahi said, there is no shortage of beds at the hospitals. While occupancy of ICU beds is around 53 per cent, for ventilators and general beds it is approximately 33 per cent and 36 per cent respectively. "We are monitoring the situation daily and accordingly increasing the number of beds when and wherever it is required," he informed.

With Odisha registering a huge spike of more than 8,000 new Covid-



19 cases Wednesday, the highest this year, health experts said more restrictions need to be put in place to contain the virus.

"The present situation will continue, the number of daily cases is likely to go up to 30,000 per day by mid-May. Therefore, lockdown like steps should be enforced," said senior doctor and health expert Niroj Mishra.

Former director of AIIMS, Ashok Mohapatra too had a similar opinion to offer. "In Chhattisgarh, the entire population is less than that of Odisha. It has reported 12,000 to 15,000 new cases for the last few days. So it will be wrong to say that Odisha will only report 6,000 cases during the peak." Mohapatra said.

Factors like population density and public movement are responsible for the rise in cases in some pockets of Odisha, he pointed out.

Indian Covid-19 variant in 17 nations: WHO

THE B.1.617 TYPE HAS MORE TRANSMISSIBLE QUALITIES LEADING TO THE RAPID RISE IN CASES

New York, April 28: The World Health Organisation (WHO) said Tuesday that a variant of Covid-19 feared to be contributing to a surge in coronavirus cases in India has been found in over a dozen countries. The UN health agency said Tuesday that the B.1.617 variant of Covid-19 was first found in India. It had been detected in over 1,200 sequences uploaded to the GISAID open-access database 'from at least 17 countries'.

"Most sequences were uploaded from India, the United Kingdom, USA and Singapore," the WHO said in its weekly epidemiological update on the pandemic. The WHO recently listed B.1.617 - which counts several sub-lineages with slightly different mutations and characteristics – as a 'variant of interest'. But so far it has stopped short of de-

It stressed that other variants circulating at the same time were also showing increased transmissibility, and that the combination 'may be playing a role in the current resurgence in India'. "Indeed, studies have highlighted that the spread of the second wave has been much

faster than the first," the WHO said. It highlighted though that 'other drivers' could be contributing to the





Puri to get 150-bed **Covid hospital soon**

Govt draws action plan for crop diversification

A TARGET WAS SET TO ACHIEVE NON-PADDY

Bhubaneswar, April 28: With an objective to encourage farmers to cultivate cash crops, the state government has started an ambitious initiative of crop diversification in mega lift irrigation point (MLIP) avacut areas of Odisha

An action plan in this regard for the coming kharif season was discussed at a high-level meeting held on digital mode under the chairmanship of Chief Secretary SC Mahapatra Wednesday.

A target was set to achieve non-paddy cultivation in 60 per cent of the MLIP ayacut areas in the state during the coming cropping

District-wise target was set for cultivation of non-paddy crops as per the inputs received from different districts. Targets were set to achieve 100 per cent crop diversification in Ganjam district and more than 70 per cent diversification in the districts like Bargarh, Gajapati, Koraput, Malkanagiri and Nabarangpur.



Similarly, more than 50 per cent crop diversification target was set for Kalahandi, Rayagada and Sambalpur districts

Crop-wise yield rate, cost of production and net profit for non-paddy products were also discussed in the meeting where it was decided to make the farmers aware of it through intensive campaigns.

Emphasising on the positive impact of crop diversification on agricultural sector, Mahapatra directed the officials to enhance non-paddy cultivation in MLIP areas during the ensuing kharif season.

Agriculture Secretary Suresh Kumar Vashishth said, "The total ayacut area of the MLIPs is around 1,22,835 hectares. As per the present irrigation design, each outlet is programmed to irrigate 20 hectares. The actual crop area and cropping pattern of these ayacut areas have been assessed. Arrangements have been made through agencies like

Nafed and Markfed for procurement of the non-paddy produces."

Agriculture department director Muthu Kumar said that the directorate of horticulture is preparing a web portal for market engagement and Farmer Producer Organisations (FPO) operations. The system for marketing through E-NAM is also being strengthened.

Agriculture Production Commissioner Raj Kumar Sharma advised the officials to undertake intensive awareness campaign and engagements with farmers for bringing about real changes on the ground level.

Water Resources secretary Anu Garg apprised the meeting that the ayacuts would be redesigned and water supply would be regulated as per the requirements of nonpaddy crops.

Further, the Chief Secretary directed the officials to assess the annual non-paddy requirement for utilisation in different programmes like PDS, MDM and ICDS supplementary nutrition programmes in residential school hostels.

The Agriculture department was also asked to explore the marketing facilities of non-paddy produces through e-NAM. Markfed and online marketing systems both in the government and private sectors.

Presently, non-paddy produces are being procured through agricultural primary cooperative societies. The proposal for involving women SHGs and FPOs in the procurement process was given in principle approval by the Chief

2nd wave rises, falls sharply: RMRC dir

Bhubaneswar, April 28: Director of Regional Medical Research Centre (RMRC), Sanghamitra Pati Wednesday shed lights on the second wave of Covid-19 and asked people to abide by the safety protocol of the pandemic.

She attempted to allay the fears of the people about Covid-19 and answered several questions related to isolation and testing and management. The programme was organised by the state Health department virtually.

"Worldwide the second wave is considered more infectious than the first one. It is marked by sharp rise and sharp fall. More infections are attributed to the new variants of Covid-19. Moreover, people at large have also become lax when it comes to Covid-appropriate behaviour. The combined effect now is higher cases of the disease."

She also said that people needed to go back to the first wave compliance of Covid safety protocol. To break the chain of transmis-



sions, the role of the citizens and government are important too,

When asked about the ideal time to go for testing after coming in contact with a Covid positive person, she said, "When a person comes in contact with a Covid patient, he/she should get himself/herself tested when symptoms come up or the best is to test after five days of getting in touch with the infected person. If the person tests negative it is unlikely that the person is infected."

On the issue of vaccinated persons and their vulnerability, she said. "Those who have taken two doses of vaccines and came in contact with infected persons also need to take measures of isolation and

Bed strength in City to be doubled: BMC

Bhubaneswar, April 28: With an exponential rise in Covid-19 cases being observed in Capital city, the Bhubaneswar Municipal Corporation (BMC), Wednesday, stated that it would double the capacity of beds here.

Informing about the present bed capacity, BMC Commissioner Prem Chandra Chaudhary stated that there are about 3,000 beds in the hospitals here. "Steps are being taken to increase the bed capacity in Covid hospitals by 3,000 in about 10 days. At present, there are around 3,000 beds in Covid hospitals of which 50 per cent are occupied," he said.

Meanwhile, informing about home isolation cases, Chaudhary said more than 90 per cent of Covid positive cases are in home isolation and BMC is providing essential drugs to them. Sources said that out of daily positive cases being identified, about 50-100 patients are being shifted to Covid

The BMC Commissioner also urged people to come forward for testing. "It is being observed that many symptomatic people are doing self-treatment and are not getting tested to avoid social stigma. I request them to get themselves tested at the private and public testing centres so that they could be treated accordingly," he said.

Khilar challenged her termination at the OAT, which directed the state government to reinstate her by creating a supernumerary post

necessary. The state government challenged the order of the tribunal before the High Court. The HC quashed the OAT direction saying, "However, since the vacancy is available, the petitioners will give appointment to Kamalini Khilar against one of such vacancies available in Bhadrak district within a period of four weeks," the HC ruled.

Significantly, the Supreme Court held that the termination of the service of Khilar was unavoidable in the light of the binding order of the tribunal. The apex court set

aside the order of the High Court which directed the state govern-

Koksara, April 28: Onion farmers in this block in Kalahandi district are a disappointed lot as they have failed to get right price for their crop due to lack of storage and marketing facilities.

There is an increase in onion cultivation in this block. Reports said farmers in Gotomunda, Sanapodaguda, Temra, Kashibahal, Puphga, Mahima, Gambhariguda, Badapodaguda, Baradanga panchayats cultivate the cash crop for a long time.

According to private estimates, over 9,500 quintals of onion were harvested under this block this year However, farmers are forced to sell their produce at a price of Rs 1,000 to Rs 1,200 per quintal to local traders due to lack of marketing and conservation facilities.

Farmers alleged they carry on cultivation even though they do not get incentives and seeds from the state government at the right time. Farmers alleged this year they were forced to buy seeds and fertilisers from the open market at higher prices due to their unavailability in government-approved stores.

Farmers claimed this situation could be avoided if the government takes care to establish a cold storage in the block. The establishment of cold storage will help in solving onion scarcity in the state, they added.

When contacted, Tapan Kumar Patra, assistant horticulture officer in Koksara said onion seeds are being supplied to farmers at subsidized rates while some farmers are being given training in storing onions for a long period. Sambalpur, April 28: Even though crores of rupees have been spent on solar fencing in forested areas of Sambalpur over last five years, these efforts by the forest department have served no purpose due to substandard work, a report said.

BODIES OF COVID PATIENTS FERRIED ON CARTS, BICYCLES

Deogarh/Bolangir, April 28: Amid rising numbers in fatalities owing to Covid-19 infections, several incidents of inhuman treatment of bodies were seen in various parts of the state Wednesday.

In the first such incident at Tileibani Suguda village in Deogarh district, the body of a Covid patient was carried on a bullock cart and was finally cremated after remaining unattended for around nine hours.

According to sources, a villager named Chandrasekhar Sahu from Tileibani had tested positive for Covid-19 a few days ago. He had been put in home quarantine on being advised by doctors

After his health condition deteriorated Tuesday afternoon, the man's family members contacted a nearby Covid care hospital. However, the man succumbed to the virus

On being contacted, Deogarh Assistant Collector Kaibalva Kar admitted that cremation was delayed. "Neighbours and relatives of the deceased had initially agreed to cremate the body, but later refused to do so. which led to delay in the cremation," Kar said.

In the second incident reported from Bolangir district, the body of a man, who had succumbed to Covid-19, was seen being carried by his son on a bicycle after his relatives did not turn up to lend their shoulders.

The incident took place at Bhaludunguri village under Khaprakhol block

A man named Ayodhya Sahu (55) had also succumbed to Covid-19 at Khaprakhol health centre. Other family members including relatives refused to assist his son for cremation.

The cruelty-free way

arangle am hopeful that, in my lifetime, I am going to see a disruptive change in the eating and wearing of animal flesh. It is coming fast: the largest slaughter companies, and the largest investors in the world, have invested in laboratory-created real meat (called clean meat) and milk. These meats are already in the market in countries like Singapore. Perfect Day, which makes milk cells, is on the market with yoghurt (under the label Smitten) that is made of animal-free dairy. The Netherlands and Israel are far ahead in meat grown from in-vitro animals' cell culture, instead of from slaughtered animals. Indeed, if clean meat would replace intensive farming as an industry standard, the benefits for the environment would be immense. As consumers, we would also have 'cleaner' meat, meaning a product that doesn't have the antibiotic residues and bacterial contamination that come with slaughtered meat. We would also save the lives of over 56 billion animals yearly. Yes, that's the number of animals that are eaten every year by humans.

The meat industry keeps bringing out statistics that vegans and vegetarians are still less than 5 per cent of the market. That is simply not true. If it were, entire supermarket sections and fast food vendors would not be catering to them. Impossible Foods, which makes plant-based meat, is one of the fastest growing companies in the world. Its current valuation is \$4 billion. And the largest slaughterhouse companies in the world would not be investing in an alternative meat future.

Vegetarians and vegans finally have meat eaters on the run.

But the wearing of meat in the form of leather - has it gone down? Not yet. But it will. Apart from the millions of animals that it kills every year, especially young calves, the leather industry is extremely dangerous for the Earth's survival. The rivers are polluted with the toxic chemicals used in leather, leather polish alone kills millions of fish. A 2018 global impact study, by Quantis, stated that 700 million tonnes of CO2 are emitted by the leather footwear industry annually a major reason for global warming.

The New Zealand shoe company, Allbirds, which is in partnership with the giant Adidas. has just announced that it is investing millions in plant-based leather. Allbirds has been going this way for a long time: shoes made of eucalyptus and cotton fibre for instance, insoles made of castor bean oil, recycled plastic laces. This new material, plant leather, is made from vegetable



per cent natural plant-based leather" to its product lineup by December 2021. This material, which is called Mirum, is said to have 40 times less carbon impact than real leather, and produces 17 per cent less carbon than synthetic leather made from petroleum-based sources. Mirum will be constructed without any polyurethane, meaning that the material can biodegrade at the end of its life, without leaving traces of plastic in the soil, or it can be reground into new Mirum. Joey Zwillinger, co-founder of Allbirds, said in a press release, "For too

long, fashion companies have relied on dirty synthetics and unsustainable leather, prioritizing speed and cost over the environment. Natural Fiber Welding is creating scalable, sustainable antidotes to leather, and doing so with the potential for a game-changing 98 per cent reduction in carbon emissions. Our partnership with NFW, and planned introduction of Plant Leather based on their technology, is an exciting step on our journey to eradicate animals and petroleum from the fashion industry.'

Vegan leather, an oxymoron, is the ethical and cruelty-free alternative to traditional leather. It is meant to look and feel like traditional leather, without the baggage of pollution and suffering. As more and more people grow aware of the leather industry's effects on the environment and on animals, the market for cruelty-free alternatives keeps growing. British materials company, Ananas Anam, set up in 2013, was among the first to come out with a plant-based leather alternative called Piñatex. The material uses fibre derived from pineapple leaves, sourced from the Philippines. The fibre is mixed with polylactic acid (PLA), a bioplastic derived from corn, to create a flexible and durable material. Piñatex is being used by Hugo Boss and Canadian

 $Major\,luxury\,fashion\,houses\,including\,Stella\,McCartney,\,Adidas, and\,Gucci$ parent company Kering have invested in a leather substitute product called Mylo, a soft leather like material, created from mycelium, the branching filament structure that mushrooms and other fungi use to grow. The material consumes substantially less water than is needed to produce animal leather, while emitting fewer greenhouse gases. It takes just days to produce and is completely biodegradable and non-toxic.

Will's Vegan Store is an online store that makes luxurious vegan leather shoes from cereal crops. The company's vegan leather is made from a mix of polyurethane and bio-oil made from cereal crops. The company is trying to move away from using polyurethane, and has recently rolled out a new product using viscose made from eucalyptus bark.

In 2017, the high-end vegan shoe company Veerah rolled out leather made from 50 per cent apple peels leftover from the apple juice industry, and 50 percent polyurethane. The peels are dried and ground into a fine powder, which is then mixed with non-toxic pigment, and polyurethane, to become a leather-

Here are the Indian entrepreneurs that you should buy from, or invest in: Malai Biomaterials Design Pvt Ltd, a Kerala-based initiative, is the brainchild of Zuzana Gombosova and Susmith Suseelan. It produces a vegan alternative to leather, using sustainable bacterial cellulose sourced from waste coconut, banana stem, sisal fibre and hemp fibre. It is completely biodegradable, flexible, water-resistant, stretchy and has the same thickness as leather. The company collects coconuts from farmers in Kerala. The water is left undisturbed for bacterial culture to feed on. The end process results in jelly-like cellulose which is mixed with banana fibre, or gum, to create raw material in the form of sheets or 3-dimensional shapes. To make the sheets colourful and glossy, the company uses natural dyes such as indigo, madder or cutch. The company's major clients are prestigious companies like Crafting Plastics, TON, Ma-tt-er, Kazeto, and the products are bags, wallets, backpacks. I do not know whether they have started making shoes as yet. Aulive is an online Indian brand that has genuinely beautiful vegan, cruelty-free leather products. It labels itself as "Genuinely Not Leather" and uses Pinatex. They have come out strongly against the cruelty, and toxicity, of the animal leather trade. Look up the site when you want to buy suitcases, briefcases and bags. Kanpur Flower Cycling, owned by engineer Ankit Agarwal, has created Fleather; leather made of temple flowers. Even though it's not in the market yet, Fleather has already won a UN Sustainability Award and a PETA award for best innovation. The company has already been making Florafoam- a compostable alternative to styrofoam (non-biodegradable plastic) from moulding dried flowers with natural fungi. Brands, like Bajaj and Havells, are already using Florafoam packaging. Fashion houses, like Anita Dongre, have also shown interest in this breathable and tensile material called 'Fleather'.

These companies can only be successful if you change your buying pattern.

A massive increase in global electricity production will be required-from 27,000 terawatt-hours today to around 100,000 TWh by 2050. Total battery capacity will soar, and huge investments will be needed in expanded transmission and distribution networks.

But there are abundant natural resources available to support this 'green' electrification. Each day, the sun provides 8.000 times as much energy as the entire human population needs for a high standard of living. Even if all of the 100,000 TWh of electricity came from solar resources (and none from wind), we would only have to cover about 1 per cent of the world's land area in solar panels.

Nor is there any ultimate shortage of the key minerals required. Two billion electric cars each with a 60 kilowatt-hour battery would require a stock of 15 million tonnes of pure lithium, which, once in place, could be endlessly recycled. Today's known lithium resources are 80 million tonnes. Supplies of nickel, copper, and manganese are also plentiful, and concerns about cobalt supplies have unleashed technological progress



While rapid technological progress is our best hope for mitigating climate change, today's living standards in rich countries threaten both catastrophic climate change and local environmental destruction. Responsible consumer choice matters as well

which makes possible zero-cobalt

In everything connected with converting photons to electrons and electrons into what physicists call 'work' (driving engines) or into heat (or cold), there are no long-run planetary boundaries to human living standards. By 2060, we will be able to enjoy guilt-free flying, guilt-free heating and cooling, and guilt-free economic growth.

But, for two reasons, we still face potential disaster, with a dwindling chance of limiting global warming to the 'well below 2° Celsius' promised by the 2015 Paris climate agreement.

First, we have left it desperately late to act. If rich countries had committed in 1990 to achieve zero-carbon economies by 2030, we would already be approaching that goal and global warming would be decelerating. But we didn't, and from where we are now, we should ideally cut carbon dioxide emissions

by 50 per cent in the next 10 years. Achieving a cut on that scale is much more difficult than getting to zero emissions by mid-century

Even if all new cars sold in 2030 were electric, most cars on the road then would still have internal combustion engines spewing CO2 from their exhaust pipes. And even if all growth in electricity supply is now met from zero-carbon sources, closing already existing coal plants in India and China will take time.

The second threat lies in our food and land-use systems. The challenge is not how much energy we consume in food form, but how inefficient we are in producing it. If all of the world's nine billion people in 2050 had an adequate intake of 2,200 calories per day, that would require 7,400 TWh of energy, or only about 6 per cent of likely non-food energy use.

But while we can use clean electricity to meet most of what we require for heating, cooling, industry, and transport, we cannot substitute electrons for the carbohydrates and proteins in the food we eat. Instead, we derive food from photosynthesis of plants, which is far less efficient than converting photons into electrons

Research by the World Resources Institute shows that even fastgrowing sugarcane on highly fertile tropical land converts only 0.5 per cent of solar radiation into usable food energy. By contrast, a field of solar panels can achieve 15 per cent efficiency, increasing over time with technological advance. And when we use a cow's stomach to convert plant protein into meat, we lose over 90 per cent of the stored energy.

As a result, food and fiber production is by far the main driver of tropical deforestation. Along with methane emissions from farm animals and nitrous oxide emis sions from fertilizer, deforestation accounts for 20 per cent of all greenhouse-gas emissions and threatens to create feedback loops that accelerate global warming.

In the long run, new technologies will probably solve this problem, too. Synthetic meats produced using precision biology require 10-25 times less land than animalbased production, and if synthetic techniques become more efficient while cows do not, they will eventually be lower cost. By mid-century, Gates may be proved right and Thunberg too pessimistic even in relation to food and land use. All production ultimately depends on knowledge and energy, and there is no limit to human knowledge and no relevant limit to the energy the sun gives us for free.

But while rapid technological progress is our best long-term hope for mitigating climate change, Thunberg is partly right today. Living standards in rich countries threaten both catastrophic climate change and local environ mental destruction, so responsible consumer choice matters as well. We should fly less, get on our bikes, and eat less red meat. And we must ensure as rapidly as possible the massive flows of finance from governments, companies, and individuals-needed to halt deforestation before it is too late.

Case for free universal vaccination

PRICE DISCRIMINATION MAY LEAD TO SUB-OPTIMAL DISTRIBUTION OF VACCINES

above statement of Walter Orenstein, professor of medicine at Emory University, captures two important aspects of the economic world: production and distribution. We can add another dimension: only mandatory vaccination can help in subsiding pandemics like Covid-19.

Development, production, and distribution of vaccines can be examined through pricing. Pricing is the process of recovering cost and return on investment and it can also be used as a tool to manage the behaviour of consumers.

The invisible hand of market is expected to help in arriving at an optimal price. However, history is replete with cases of market failures. We cannot fully fall back on the market to address the issues relating to the production and distribution of vaccines which have

very high positive externalities. Governments promised to make vaccines available free. Such free distribution would have been possible with production fully under the government control. That is the not the case in India. Both vaccines are being manufactured by private entities. Production requires investment and investors require

accines do not save lives return and returns are possible to Covid and consists of domestic but vaccinations do." The only if the producers can sell at a price higher than the cost.

> Every investor looks for returns. Serum Institute of India and Bharat Biotech are not exceptions. But transparency is conspicuous by its absence in the pricing process. People of the country have no idea about the cost and consequently on the pricing process.

Instead of reducing the infor-

mation asymmetry, the latest vaccine policy allows manufacturers to sell 50 per cent of their production in the open market at a price which is different and significantly higher than that was sold to the government in the first and second phase of vaccination. Why should the price shoot up if volumes are actually going up? Is the increase in price due to the increase in cost? Is it to allow the companies to earn higher returns? Will price discrimination work? Many such questions remain unanswered.

Price discrimination may lead to sub-optimal distribution of vaccines. Even those who can afford to pay will try to take the benefit of free vaccination at the government hospitals and in the process deprive those who cannot pay for the vaccine. The class which is deprived of vaccination is more vulnerable

vendors and many others at the bottom of the pyramid who provide different support services. Society may lose more by not vaccinating this group of people. For some the perceived risk of the disease may be less than the benefits of vaccination because they ignore the impact of their decision on the larger world. So price discrimination may lead to a situation where the poor may not get the vaccine and those who can afford may not go for vaccination at market price.

There is a need to make vaccination universal and free without any discrimination. Voluntary vaccinations are unlikely to eradicate diseases like Covid and mandatory vaccination is not possible through market driven pricing. Mandatory universal free vaccination should be the priority. Even the Indian Medical Association has demanded that the vaccine be given free.

Vaccine is not a trade commodity so the ultimate user need not pay the price. Let the cost be shared by the central government, state governments, and corporate entities. No investment is unreasonable to control Covid which has affected lives and livelihoods of millions.

ernment is correct; the total cash required for vaccinating 90-95 crore people will be around ₹54,000-57,000 crore. The central government has already budgeted around ₹35,000 crore for vaccination in the Budget-2021. State governments and corporate entities may be asked to chip in for the balance money. If the top fifty profit-making companies contribute towards the cost one may not need to charge anything to the users. These companies have earned around ₹3 lakh crore as profit even during the pandemic.

Moreover, there is a possibility that with the announcement of free universal vaccination people from different walks of life may also come forward to contribute to the mission provided there is a transparent vaccine distribution policy. We are already witnessing such a response in Kerala. A small contribution from many may have a huge impact on mankind.

So the government should revisit the present policy of price discrimination and seriously start working on free universal vaccination

Prayagraj, April 28: The Allahabad High Court has issued notices to Uttar Pradesh State Election Commission (UPSEC), seeking an explanation on why it failed to check non-compliance of Covid guidelines during multiple phases of panchayat elections.

Taking cognizance of reported deaths of 135 teachers, shiksha mitras and investigators assigned panchayat election duty, the Allahabad High Court, Tuesday, issued the notices.

The court further asked why action should not be taken against the state poll panel and its officials and why those responsible for Covid violations should not be prosecuted.

Hearing a PIL on Covid care, a division bench comprising Justice Siddhartha Varma and Justice Ajit Kumar further directed the State Election Commission to 'take immediately measures in remaining phases of panchayat elections to ensure Covid guidelines are complied with, else action would be taken against officials involved in the election process'.

While passing the directives, the court observed, "It is reported that during recent phases of panchayat elections, Covid guidelines were violated. It appears that neither police nor the State Election Commission did anything to save people on election duty from getting infected by the virus

New Delhi, April 28: The Supreme Court Wednesday directed the Uttar Pradesh government to shift journalist Siddique Kappan, suffering from various ailments and arrested last year on way to Hathras where a young Dalit woman had died after being gangraped, to a hospital in Delhi for better medical treatment.

Keeping in mind the basic human rights of an accused, Chief Justice of India NV Ramana headed bench granted the relief and directed the state to provide medical treatment to the Kerala-based scribe.

The bench also comprising Justices Surya Kant and AS Bopanna said that Kappan will be transferred back to Mathura jail after his recovery. The top court, however, granted him liberty to approach an appropriate forum challenging his arrest or for any other relief and disposed of the plea filed by Kerala Union of Working Journalists (KUWJ) and his wife, seeking his release from alleged illegal detention.

The district administration has clarified that efforts will be made to provide oxygen only to those hospitals and nursing homes registered with it. An order in this regard was issued by Additional Chief Secretary TC Gupta.

The District Magistrate has appointed nodal officials at each hospital to monitor the Covid situation and from wherever there is a demand for oxygen it will be supplied as soon as possible.

At present, nearly 40 tonnes of liquid oxygen has been made available in the district while earlier it was only 20 to 22 metric tonnes. Small nursing homes and clinics have been advised not to admit serious Covid-19 patients. Only patients with isolation or care can be placed

New Delhi, April 28: Candidates or their agents will not be allowed inside counting halls without a negative coronavirus report or without having both Covid-19 vaccine doses, the Election Commission said Wednesday in its latest guidelines for counting of votes May 2.

Issued amid spiralling coronavirus cases, the guidelines bar public gatherings outside venues during the counting process, but allow candidates to name a fresh agent if the first one tests positive for Covid-19.

Counting of votes for assembly polls in Assam, West Bengal, Tamil Nadu, Kerala and Puducherry, besides various other assemblies and Lok Sabha bypolls begins at 8 am May 2.

"No candidates or agents will be allowed inside the counting hall without undergoing RT-PCR/RAT test or without having two doses of vaccination against Covid-19 and will have to produce negative RT-PCR report or RAT report or vaccination reports within 48 hours of start of counting," the guidelines read. The district election officers will organise Covid tests for candidates and their counting agents, it said. The Madras High Court had earlier this week made harsh observations against the EC for failing to ensure Covid-appropriate behaviour during campaigning. The poll panel has to apprise the high court April 30 about steps it has taken to ensure a Covid-safe counting process

The fresh EC guidelines go beyond the ones issued by poll panel for the Bihar assembly elections last year which were being used as a template for elections being held during the coronavirus pandemic.

On Tuesday, the poll panel had barred victory processions after counting to check large gatherings amid rising coronavirus cases.

It had also restricted the number of people who could accompany the candidate to collect his or her election certificate from the returning officer. As per the latest guidelines, there

should be sufficient number of personal protective equipment (PPE) kits for counting agents and can-"The counting agents' sitting

arrangement shall be made in such a way that between 2 counting agents 1 agent shall be in PPE, the guideline read

The counting hall, according to the EC, should be sufficiently big to maintain social distancing, and should have proper ventilation, windows, exhaust fan as per available protocol of the State Disaster Management Authority.

The counting centres should be disinfected before, during and after the counting, while sealed outer boxes of electronic voting machines and paper trail machines should also be disinfected.

Assembly polls: EC Govt in Delhi means LG now

New Delhi, April 28: The new act notified by the Centre has left Delhi's elected government virtually toothless by giving sweeping powers to the lieutenant governor who now controls nearly 80 departments and can even stall a bill enacted by the assembly, officials said.

After the Government of National Capital Territory of Delhi (Amendment) Act, 2021, was notified Tuesday night, the LG, in layperson terms, would be the one running the national capital henceforth, officials explained while assessing the import of the Act coming into effect.

The Act, passed by Parliament last month, came into force April 27, Tuesday, the Ministry of Home Affairs said in an order.

Under the new law, 'government' now means the LG, officials said. The Delhi government will have to take permission from the LG before taking any action on subjects that had so far been under its control. These include anti-corruption, education, health, social welfare, tourism, central jail, excise, some colleges as well as hospitals and transport. The LG can also pass directions to

officials directly without consulting the city government while elected representatives will have to take the LG's consent for the implementation of any of its orders as well as transfers, the officials explained.

According to officials, Delhi is a union territory with a legislature like Jammu and Kashmir and Pondicherry but does not have powers similar to them. Three key subjects -- public order, police and land - are with the Central government while other sectors are with the city government. However, after the new Act, the Delhi government

will have to get the LG's nod for making any minor or major

"It has become necessary to make it clear that Delhi is a UT with limited powers. It is not a full state and those in the powers of the Delhi government must understand this fact," one official told PTI while explaining the reasons behind bringing in the new law.

The Delhi assembly can make laws on all subjects in the state list and concurrent list but it shall not come into force until the LG gives his assent. "Any of the rules made before the commencement of the Government of National Capital Territory of Delhi (Amendment) Act, 2021, shall be void," states the

In the case of Jammu and Kashmir and Pondicherry land is with the local government and public order and police with the Central government. Other UTs — Chandigarh, Ladakh, Andaman and Nicobar Islands, Lakshadweep and Dadra and Nagar Haveli and Daman and Diu — don't have legislative assemblies and are under direct control of the Central government. Officials said the executive powers of the LG of Delhi are different from the powers of state governors and the amendment in the Government of NCT of Delhi Act will remove ambiguities in the existing law. The Centre has been maintaining the bill is in line with the Supreme Court's July 2018 ruling on the ambit of powers of the lieutenant governor and the Delhi government after a series of runins between the two. Minister of State for Home G Kishan Reddy had said in Parliament that Delhi is not a full-fledged state and does not have full power.

"The victim managed to free herself and reached home. She narrated her ordeal before her family members who approached local police," the IO said.

Maha may face 3rd Covid wave if vaccination slows: Experts

Mumbai, April 28: A slowdown in the ongoing vaccination drive in Maharashtra, battling a savage surge in COVID-19 cases, will potentially pave the way for a third wave of the infection in the state, health experts warned Wednesday.

The warning came on a day when the Maharashtra government said it is not going to start the vaccination drive from May 1 for the 18-44 age group because of unavailability of sufficient doses.

Health Minister Rajesh Tope has already expressed concern over the inadequate supply of vaccines for Maharashtra, the state worst-hit

by the pandemic, amid reports of a shortage of doses for the existing beneficiaries (45-plus people), putting the inoculation drive on a slow track. The true curbing of COVID-19 can happen only if two thirds of the population eligible for vaccination is covered under the inoculation drive.

"Out of 9 crore people eligible for vaccination in Maharashtra, we have just covered over 1.50 crore so far, which is negligible," said a senior official from state health department.

He pitched for fast-tracking the inoculation drive which began January 16 with healthcare professionals and was later extended



to cover frontline workers and people in the 45-plus age group. "If we do not accelerate the pace of vaccination, sooner or later people will venture out for jobs and other work

and this could invite the third wave of COVID-19," he warned.

Lockdown extended; vaccination delayed

The COVID-19 vaccination drive beginning May 1 cannot be launched in Maharashtra because of the unavailabily of sufficient doses of vaccines even as the state Wednesday extended the current lockdown-like restrictions till May 15 given the rise in the COVID-19 cases. State Health Minister Raiesh Tope also said the people in the age group of 18 to 44 years will receive free vaccines at state-run centres but citizens will have to pay for the jabs at private facilities. The free vaccination decision was taken at the cabinet meeting chaired by Chief Minister Uddhav Thackeray. The move will put a burden of Rs 6,500 crore on the state's coffers, Tope said.



Centre in process of banning PFI, SC told

A bench of Chief Justice N V Ramana and Justices Surya Kant and A S Bopanna was told by Solicitor General Tushar Mehta, appearing for Uttar Pradesh government, that Kerala journalist Siddique Kappan has association with PFI, whose office bearers were found to be associated with banned Students' Islamic Movement of India (SIMI).

The bench asked Mehta whether PFI has been banned. Mehta replied, "In several states PFI has been banned. As per my information Centre is also in the process of banning it.

The bench then said, "So, as of now it is not banned".

Mehta, while reading from an affidavit filed in December last year, said, "No. Many office bearers of PFI were found to be associated with SIMI"

The top court later directed the UP government to shift Kappan, suffering from various ailments and arrested last year on way to Hathras where a young Dalit woman had died after being gang raped, to a hospital in Delhi for better medical treatment.

Keeping in mind the basic human rights of an accused, the bench granted the relief and directed the state to provide medical treatment to the scribe. It said that Kappan will be transferred back to Mathura jail after his recovery.

The top court, however, granted him liberty to approach an appropriate forum challenging his arrest or for any other relief and disposed of the plea filed by Kerala Union of Working Journalists (KUWJ) and his wife, seeking his release from alleged illegal detention.

Tejas added the 5th generation Python-5 air-to-air missile in its airto-air weapons capability Tuesday. Trials were also aimed to validate enhanced capability of already integrated Derby beyond visual range AAM on Tejas, said an official.

He said the test firing at Goa completed a series of missile trials to validate performance of the aircraft under extremely

challenging scenarios.

Derby missile achieved direct hit on a high speed maneuvering aerial target and the Python missiles also achieved 100 per cent hits, thereby validating their complete capability. The trials met all their planned objectives, the official said.

Prior to these trials, extensive missile carriage flight tests were conducted at Bengaluru to assess integration of the missile with the aircraft systems on board the Tejas.

Python-5 missile live firing was conducted to validate target engagement from all aspects as well as beyond visual ranges. In all the live firings, missiles hit the aerial target, the official said.



Mogadishu: At least seven people were killed and more than 11 others wounded when a vehicle exploded outside a police headquarters in Somalia's capital, police and health officials said Wednesday. The al-Shabab extremist group claimed responsibility. A police spokesman, Col. Abdigani Mohamed Qalaf, said the suicide bomber tried to drive into the headquarters near the ex-control Afgove road but was thwarted

Indonesia seizes 2.5 tons of meth

Jakarta: Indonesian police said they shot dead one and arrested 17 other people as they broke up a major drug ring attempting to smuggle more than 2.5 tons (5,000 pounds) of methamphetamine originating from Afghanistan. Police found the first load of more than 1,278 tons board a ship that docked in Aceh Besar district April 10. Five days later, police seized another 1,267 tons from Aceh Barat district, said the chief of Indonesia's National Police, Listyo Sigit Prabowo.

India declines UN's US Navy fires warning shots in assistance on Covid

United Nations, April 28: India has declined assistance offered by the United Nations of its integrated supply chain for COVID-19 related material, saying the country has a "robust system" to deal with the required logistics, a spokesperson for UN Secretary General Antonio Guterres said.

"One of the things we did is we offered the assistance of our integrated supply chain if it was required. We've been told at this point that it's not needed because India has a reasonably robust system to deal with this. But our offer stands. and we're willing to help in whatever way we can," said Farhan Haq, Deputy Spokesman for the UN.

On whether any shipments of essential materials from UN agencies are expected to reach India amid the crisis, Haq said, "none have been sought so far, but like I said, we do have people, including our people who deal with operational and logistical issues who are willing to help, if we're needed, and we're in touch with our counterparts in India to see whether that will be useful.'

No revision of 2015 peace deal: Russia dismisses Ukraine

Moscow, April 28: Russia's foreign minister sternly warned Ukrainian officials Wednesday that Moscow would not accept their push to revise a peace deal for eastern Ukraine.

Foreign Minister Sergey Lavrov's comments followed Ukrainian President Volodymyr Zelenskyy calling Tuesday for a modification of the 2015 agreement and inviting other nations to help mediate the stalled peace talks between Ukraine and Russia.

Fighting between Ukrainian forces and Russia-backed separatists erupted in Ukraine's eastern industrial heartland, called Donbas, shortly after Moscow's 2014 annexation of Ukraine's Crimean Peninsula. More than 14.000 people have been killed during the seven-year conflict.

In recent weeks, increasing violations of a shaky cease-fire in eastern Ukraine a Russian troop buildup across the border drew Ukrainian and Western concerns about the potential for large-scale

Dubai, April 28: An American warship fired warning shots when vessels of Iran's paramilitary Revolutionary Guard came too close to a patrol in the Persian Gulf, the US Navy said Wednesday

The Navy released black-andwhite footage of the encounter in international waters of the northern reaches of the Persian Gulf. In it, lights can be seen in the distance and what appears to be a single gunshot can be heard, with a tracer round racing across the top of the water. Iran did not immediately acknowledge the incident.

The Navy said the USS Firebolt fired the warning shots after three fast-attack Guard vessels came within 68 yards (62 meters) of it and the U.S. Coast Guard patrol boat USCGC Baranoff. "The US crews issued multiple warnings via bridge-to-bridge radio and loudhailer devices, but the (Guard) ves-



sels continued their close range maneuvers," said Cmdr Rebecca Reharich, a spokeswoman for the Mideast-based 5th Fleet.

"The crew of Firebolt then fired warning shots, and the (Guard) vessels moved away to a safe distance from the U.S. Vessels." She called on the Guard to "operate with due regard for the safety of all vessels as required by international law." "US naval forces continue to remain vigilant and are trained to act in a professional manner, while our commanding officers retain the inherent right to act in self-defence," she said.

The interaction marked the first "unsafe and unprofessional" incident involving the Iranians since April 15, 2020, Rebarich said. However, Iran had largely stopped such incidents in 2018 and nearly in the entirety of 2019, she said.

The incidents at sea almost always involve the Revolutionary Guard which reports only to Supreme Leader Ayatollah Ali Khamenei.

Typically, they involve Iranian speedboats armed with deckmounted machine guns and rocket launchers test-firing weapons or shadowing American aircraft carriers passing through the Strait of Hormuz, the narrow mouth of the Persian Gulf through which 20 per cent of all oil passes

Some analysts believe the incidents are meant in part to squeeze President Hassan Rouhani's administration after the 2015 nuclear deal. They include a 2016 incident in which Iranian forces captured and held overnight 10 US sailors who strayed into the Islamic Republic's

'Covaxin found to neutralise 617 variant of COV

Covaxin works by teaching the immune system to make antibodies against the SARS-CoV-2 coronavirus, says Dr Anthony Fauci

Washington, April 28: Covaxin, India's home grown COVID-19 vaccine, has been found to neutralise the 617 variant of the deadly virus, said White House chief medical adviser and America's top pandemic expert Dr Anthony Fauci.

"This is something where we're still gaining data on a daily basis. But the most recent data, was looking at convalescent Sera of COVID-19 cases and people who received the vaccine used in India, the Covaxin. It was found to neutralise the 617 variants," he said

'So, despite the real difficulty that we're seeing in India, vaccination could be a very very important antidote against this. Fauci added. "Covaxin works by teaching the immune system to make antibodies against the SARS-CoV-2 coronavirus. The antibodies attach to viral proteins, such as the so-called spike proteins that stud its surface. Fauci said in an interview.

Developed by Bharat Biotech in partnership with National Institute of Virology and

the Indian Council Medical Research. Covaxin was approved for emergency use January 3. Trial results later showed the vaccine has an

efficacy of 78 per cent. Responding to a question, Dr Andy Slavitt, White House COVID-19 Response Senior Advisor, said that a strike team



from the Center for Disease Control and Prevention is headed over to India to help coordinate this response

"We are making sure that we are locating some of the raw materials necessary to create more vaccines in India, which I think is going to be an important help there," he said.

Given the strong portfolio of approved, highly effective and safe vaccines here in the United States, the administration is looking at options to share AstraZeneca vaccines with other countries as they become available. This should amount to around 60 million doses or so over the next two months. he added.

NASA astronaut successfully harvests 2 plants in space



New Delhi, April 28: Health and safety are at the core of all important consumption led decisions with the Covid-19 pandemic extending its grip across the globe. according to the latest wave of 30day analysis-based consumer sur-

vey by Deloitte. The survey said that with respect to India, which is seeing a significant increase in Covid cases, the consumer is seen to be cautiously approaching the future by prioritising health safety, preferring online channels for purchases, and choosing to

delay large purchases. "Our survey insights are a reflection of the heightened consumer

apprehensions, which are at the core of their decision-making. As the health crisis again takes centerstage in the country, the average Indian consumer prefers to use digital and online channels wherever applicable." said Porus Doctor. partner and consumer industry leader, Deloitte Touche Tohmatsu Throughout the pandemic, on-

line medium has emerged as the preferred channel for purchase and continues to grow. The survey brought out that 22% of the consumers were buying online medicine, followed by electronics (34%), clothing (33%), online food from restaurants/takeaways (33%), and if available, the next vehicle on-



line (57%) due to the various restrictions. But during the current race of the pandemic, the consumption pattern of consumers brings out a cautious approach. The survey said the spending intent

shows that consumers are focussing more on non-discretionary items as compared to the previous waves of the survey.

For instance, 48% consumers show net spending intent towards healthcare, 33% towards medicines, 42% towards internet, 47% towards groceries and 44% towards household goods, indicating that consumers want to focus on non-discretionary spends in the time of crisis.

Moreover, the consumer persona shows that stock piler (63%), convenience seeker (69%) and bargain hunter (51%) still remain high among the Indian consumers, as

per the survey. Also, Indians are significantly more concerned about returning to the workplace than they were in February 2021. About 28% today worry about returning to their offices, as compared to 15% in February 2021, said the Deloitte

Individuals are not looking to venture out as they do not feel safe about going to a store, restaurant, staying in a hotel, returning to workplace, taking a flight etc., the survey brought out.

The other aspects captured by the survey includes a vast majority of consumers (67%) preferring more locally sourced items going forward even if they cost a bit morewhile 71% prefer brands that re-

sponded well during the pandemic.



MI LOOK TO RETURN

New Delhi, April 28: Defending champions Mumbai Indians will look to sort out their middle-order woes and bring their campaign back on track when they take on an inconsistent Rajasthan Royals in an IPL game here, Thursday.

MI are coming into the match after suffering back-to-back losses, the last one being a nine-wicket defeat against Punjab Kings in Chennai and need to start the Delhi leg afresh.

The Sanju Samson-led Rajasthan have lost thrice in the tournament so far and will seek to build on the six-wicket win over Kolkata Knight Riders in the previous match.

Mumbai skipper Rohit Sharma (201 runs) has got starts but hasn't played a big knock and the Mumbaikar would be itching to get one as would be his opening partner Quinton De Kock (47 runs).

But Mumbai's middle order, which boasts of hard-hitting batsmen like Suryakumar Yadav (154 runs), Ishan Kishan (73 runs), Hardik Pandya (36 runs), Krunal Pandya (29 runs) and Kieron Pollard (65 runs), hasn't fired in unison so far.

In the bowling department, pace duo of Trent Boult (6 wickets) and Jasprit Bumrah (4 wick-



ets) have been exceptional, particularly at the death.

Leg-spinner Rahul Chahar (9 wickets) and Krunal (3 wickets) have also been impressive and will again need to play their parts to perfection. Pollard is used as the fifth or the sixth bowler. Mumbai, however, might play Adam Milne in place of Jayant Yadav.

Rajasthan, on the other hand, have a lot of issues to ponder over, particularly in the absence of key foreign players – Jofra Archer, Ben Stokes, Liam Livingstone and Andrew Tye.

RR are yet to have a settled opening combination. They tried Manan Vohra (42 runs) and Yashasvi Jaiswal (22 runs) at the top but both failed to convert their starts.

Englishman Jos Buttler would need to score big to compliment his skipper Sanju Samson, who is the team's leading run-scorer (187) despite being inconsistent.

And the likes Shivam Dube, David Miller and Riyan Parag, would have to support the top order by chipping in with muchneeded contributions.

All-rounder Chris Morris (9 wickets and 48 runs) has blown hot and cold and will again be under pressure to deliver his high price tag. Left-arm pacer Chetan Sakariya (7 wickets) has been a revelation, while the experienced duo of Javdev Unadkat (4 wickets) and Mustafizur Rahman (4 wickets) have been decent.

Leg-spinner Rahul Tewatia has got just one wicket from five games, while Shreyas Gopal, another leggie, has gone wicket-less in the two games he has played.

Madrid, April 28: With a dominant start and a milestone goal by Christian Pulisic, Chelsea showed its strength against Real Madrid in the Champions League semifinals. The second leg is in London,

Chelsea took control early in Tuesday's first leg to hold the Spanish powerhouse to a 1-1 away draw, with Pulisic becoming the first US international to score in the tournament's last four. He also surpassed DaMarcus Beasley to become the top American scorer in Champions League history with five goals.

A red-hot Karim Benzema equalized for a lackluster Madrid squad on a rainy night at the Alfredo Di Stefano Stadium in the first Champions League match since the controversial Super League folded last week amid widespread criticism. The largely closed breakaway competition would have had Real Madrid as one of its leaders. and Chelsea also was among its founding members before dropping the idea along with the other English

Madrid didn't officially back out of the Super League but had downplayed the possibility of retalia-

controlled a loose ball with his head before turning and firing a volley into the top of the net for his 13th goal in his last 14 matches. It was Benzema's 16th goal in his last 17 home games with Madrid.

Chelsea gave little space to Madrid and was the more dangerous team early on at the Di Stefano in Madrid's training complex. The hosts struggled defensively with their setup of three central defenders.

Not long before Pulisic's opener, Timo Werner had his strike from in front of the goal stopped by a superb reflex save by Courtois, a former Chelsea player.

Former Chelsea forward Eden Hazard, coming off a long injury layoff, entered the match in the second half but couldn't find spaces to spark Madrid to victory. Madrid, making a record 14th

semifinal appearance, won three straight Champions League titles from 2016-18, before Cristiano Ronaldo left, but the 13-time champion was eliminated in the round of 16 in the last two editions.

Chelsea won the European title in 2012 and returned to the semifinals two years later, but hadn't been back to the last four since. Tuchel is trying to make it to a second consecutive final after a runner-up finish with PSG last season

Venue shifted

NEW DELHI: The Asian Boxing Championship, which was scheduled to be held here next month, was Wednesday moved to Dubai because of the deepening COVID-19 crisis in India but the national federation will remain a co-host along with its UAE counterpart. The tournament was to be held at the Indira Gandhi Indoor Stadium May 21-31 in the national capital, which is recording over 20,000 daily cases right now. The ASBC stated that the upcoming edition will now take place between May 21 and June 1.

Tourney unlikely

NEW DELHI: The three-team Women's T20 challenge, which is held during the IPL, is unlikely to go ahead this year given the current restrictions imposed by countries on air travel with India due to the massive spike in COVID-19 cases here. While the BCCI was planning a camp for the Indian women, the tournament has hit choppy waters as none of the Australian, English, South African or West Indies cricketers will be able to travel to India because of the unprecedented 'health crisis'.

India miss Olympic qualifier World Relays

NEW DELHI: An Indian athletics team, including star sprinters Dutee Chand and Hima Das, was Wednesday forced out of next month's Olympic qualifying World Athletics Relays in Poland after the suspension of a connecting flight to Amsterdam owing to a record-shattering spike in COVID-19 cases here. The women's 4x100m and the men's 4x400m relay teams were to board a KLM flight to Amsterdam in the wee hours Thursday but the Dutch government suspended flights from India effective Monday evening. The Athletics Federation of India (AFI) tried to book an alternate flight available to any European city en route to Silesia in Poland where the event will be held May 1-2 as there is no direct flight to Poland from India. The Indian women's 4x100m team includes Dutee, Hima, Dhanalaxmi Sekhar, Archana Suseentran, Daneshwari TA and Himashree Rov while men's 4x400m squad is comprised of Muhammed Anas Yahiya, Arokia Rajeev, Amoj Jacob, Nirmal Noah Tom and Sarthak Bhambri. The top eight teams from the World Athletics Relays will automatically qualify for the Tokyo Olympics. The World Relays would have been the first major international event for Indian sprinters since the Asian Athletics Championships in Doha in April 2019.
