

TOP COURT WARNS AUTHORITIES FROM THE CENTRE DOWN TO POLICE CHIEFS AGAINST SILENCING PEOPLE



The top court made clear that any attempt to clampdown on free flow of information on social media including the call for help from people would be treated as contempt of court.

"There should be free flow of information, we should hear voices of citizens," said a bench headed by Justice DY Chandrachud, and asked the Centre, states and all DGPs not to take any action against anyone who is posting messages on social media about issues like shortage of oxygen, beds or doctors as spreading rumour. "If any action is taken against such posts by citizens in distress, we will treat it as contempt of the court," said the bench which also comprised Justices L Nageswara Rao and S Ravindra Bhat.

The observations assume significance in view the recent decision of the Uttar Pradesh administration to prosecute people under the National Security Act for allegedly raising false alarms on social media.

New Delhi: Amid the raging second wave of the Covid-19 pandemic in India, the country will start receiving consignments of Russian Sputnik V vaccine doses from May 1 onwards, India is expected to receive 5 million doses of the vaccine by June. According to media reports. around 150,000 to 200,000 doses of the vaccine will be delivered by early May and another 3 million doses by May end.

Bhubaneswar, April 30: In a bid to break the chain of Covid-19 infections, the Odisha Traders' Association has proposed to the state government that all shops across the state will down their shutters from 2 pm daily from May 3 to May 15.

Secretary of the Odisha Traders' Association Sudhakar Panda said, "The body has taken the decision to break the COVID-19 infection chain. In this regard, the body has communicated to the state government and

we hope the government will support us." Panda also mentioned that the association will hold a virtual conference May 1 to discuss the matter properly. All details will be informed to the media after the meeting.

But he hoped that all loading and unloading activities will not be restricted during the period. When asked about the impact of their decision on traders. Panda said all shops will remain open till 2pm.

According to media reports, the Cuttack Municipal Corporation (CMC) has also approved the proposal of

shutting down all shops in the city from 2pm. The restrictions will start from Monday and continue for 15 days, CMC Commissioner Ananya Das said



Kolkata, April 30: China is planning to develop a massive defence logistics infrastructure in Tibet that will turn the once independent kingdom into a military hub to dominate the Himalayas.

The plans were approved during the plenary session of China's National People's Congress (NPC) in March this year and also by the Chinese People's Political Consultative Conference (CPPCC). The Tibet infrastructure development projects have been included in the 14th Five Year Plan (2021-2025). The Long Range Objectives-2035 additionally identifies a number of strategic military projects for completion by 2025 and 2035. The G318 Sichuan-Tibet Highway and the G219 and G331 national highways will be upgraded and extended to run

along China's southwestern

The new 1,800-km Chengdu-Lhasa high-speed railway network will be the second strategic railway connecting Tibet to the Mainland, reducing travel time from Chengdu to Lhasa to just 10 hours.

Chengdu is now the headquarters of the integrated Tibet-Sichuan military command that makes it possible for the People's Liberation Army (PLA) to move strategic reserves swiftly from the borders with other Southeast Asian nations to beef up both offensives and strategic defence on the India front.

Shigatse (Rikaze), Tibet's second-largest city, will emerge as a rail transportation hub as work has begun on railways to link Shigatse with Jilong in Guizhou province and Hotan in Xinjiang province.

The document clarifies China's national strategic intent and identifies the core areas of national security and development.



A number of factors make sustaining non-fiction shows under such circumstances extremely difficult, says JD Maiethia, chairman. Indian Film and Television Producers Council (IFTPC).

"Non-fiction shows require h sets and infrastructure. A lot of planning has to be done on a big



different cities, and their accommodation and everything else is a huge responsibility. It is a costly affair," he tells IANS.

Reports suggest that Indian Idol 12 has temporarily moved its set to Daman from Mumbai, with a new panel of judges. However, Majethia points out, unlike fiction shows, moving a non-fiction show out of the city isn't always a prudent decision.



State govt urges Centre to immediately supply 25L Covishield shots

Bhubaneswar, April 30: In a startling revelation, it has come to the fore that more than 7.52 lakh people in the state have missed their second dose of Covishield vaccine owing to shortage of the shots.

In order to ensure that people aged 45 years and above get their second dose of Covid-19 vaccine, the state government once again urged the Centre to urgently supply at least 25 lakh doses of Covishield vaccine in a single lot.






Pneumonia shots at govt hosps from June

PNEUMONIA VACCINES ARE NOW AVAILABLE AT PRIVATE HOSPITALS ONLY

Currently, the pneumococcal vaccines are available only in private health centres in the country. It was rolled out in pockets of the country on pilot basis. The cost of 10-valent pneumonia vaccine in the private hospitals is around Rs 1,600 while 13-valent pneumonia costs around Rs 3,200

per dose. While 10-valent protects kids from 10 types of pneu-



mococcal diseases, the 13-valent protects kids from 13 such types of diseases causing pneumonia. The 10-valent doses are said to give cross protection to the additional three variants.

Now, it will be made available for kids at free of cost. This comes after the last Union Budget made provisions of starting the pneumonia vaccine drives in government hospitals to reduce chances of the infection in kids in their formative days of development. "Inclusion of vaccines in

government setups is likely to scale up the administration of the same to larger sections of the population. It can help in checking the chances of spread of the disease in children and thus prevent several preventable deaths in the state. Earlier, it was either available in private hospitals or at a few government setups under a pilot project," Dr Braja Kishore Behera, a paediatrician from the city, said.

He also said that these vaccines not only protect the kids from pneumonia but also from infections of ear and brain.

Interim orders of HC extended till June 30

Bhubaneswar, April 30: Taking suo motu cognisance of the upsurge in Covid-19 cases in the state, a twojudge Bench of Orissa High Court headed by Chief Justice S Muralidhar ordered extension of validity of interim orders till June 30.

The High Court allowed several relaxations to different stakeholders in the light of the pandemic. It also said that keeping in mind the Supreme Court hearing on the related matter, it passed orders which are not likely to be dealt in the apex court. The court granted extension of timings in several cases either pertaining to the HC or lower courts under its superintendence.

"That all interim orders/directions issued or protection granted including any order requiring any compliance by the parties to such proceedings, by this Court or any court subordinate to it or any Family Court or Labour Court or any Tribunal or any other Judicial or Quasi Judicial forum in the State of Odisha, over which this Court has



power of superintendence, subsisting as on this day, and those passed hereafter, unless a longer date is specified, shall stand extended till 30th June, 2021," the HC said in its order

The HC said that the interim orders or directions of any court in the state, which are not of a limited duration and were meant to operate till further orders, shall continue to remain in force until modadvanced by 3 weeks **CUTTACK:** The summer vacation in the

"The summer vacation of is advanced to May 3 and the vacation shall continue up to June 5," said a notifi cation issued by the Orissa High Court Registry here Friday. The Registry also said that the vacation for subordinate courts in the state was also advanced to May 3.

Parole granted to a person through orders passed by a court exercising the criminal jurisdiction and limited by timeframe specifying an expiry date, was also extended till June 30. The court also advised the police department not to arrested persons till the time unless required in

"Unless there is necessity of arrest for maintenance of law and order, in a cognizable offence prescribing sentence up to seven years imprisonment, the police should not be in a hurry to arrest the accused without complying with the provision of Section 41(A) Cr PC. This shall be effective till 30th June, 2021," the order said.

3,007 VILLAGES DECLARED CHILD MARRIAGE FREE

Bhubaneswar, April 30: The 11th state-level PCMA committee meeting for prohibition of child marriage in Odisha was held Friday under the chairmanship of W&CD department Principal Secretary Anu Garg. It was organised virtually and was attended by several departments.

In the meeting, 3,007 villages were declared as child marriage free with not a single occurrence of child marriage in these villages during 2020-21.

Considering the instances of child marriage amidst Covid-19 lurking high and the fact that Akshaya Tritiya being an occasion where mass marriages take place, vigilant efforts of the district level task force will be geared up and all-out measures will be taken to stop any instance of child marriage.

Also, efforts like putting up information boards with the message that the temple authorities do not support child marriage will help curb the issue.

Besides this, it is felt that making the submission of date of birth or school leaving certificate mandatory will also help strengthen the efforts to stop child marriage.



Bhubaneswar; April 30: The Odisha State Commission for Protection of Child Rights (OSCPCR) Friday recommended a host of measures for protection of child rights amid Covid-19 pandemic.

In a letter to special relief commissioner and additional chief secretary to state government (Disaster Management) Pradeep Jena, OS-CPCR chairperson Sandhyabati Pradhan said, "As Covid is inducing issues like child marriage, child labour, trafficking and abuse, there is a need to strengthen the community mechanism through panchayat level child protection committees and women self-help groups, and help them address the issues. Necessary awareness drive and supply of information to these community groups may be extended."

The recent study of the commission on street children in five different urban locations of the state has exposed the plight of the children as well as their parents. 'The urban local bodies may carry out special drive to make them aware on Covid appropriate behavior and may also provide safe

shelters," Pradhan said. Children of destitute, who were infected with Covid, may need care

and protection. Also in case of death of parents, the child may require immediate support and care. Necessary arrangements need to be done to reach out to these children at the earliest, the commission observed.

SDPO of Angul. However, the victim recently came to know from various newspapers that her husband has filed a divorce petition against her at a court in Cuttack without her knowl-

When she accosted him, he revealed that he had already married his lady colleague in a temple in Cuttack in 2014.

The policeman had allegedly warned his wife of dire consequences January 27 this year, which included killing her with his service gun, if she disagreed for a mutual divorce.

Vehicle lifters' gang busted; 7 held

However, all these marine police station are plagued by staff shortage, which has resulted in poor vigil on the waters. Given the situation, many people from West Bengal (one of the hotspot states for Covid) are seen entering Odisha through water routes when Covid pandemic is surging fast in the state.

On the other hand, the rate of Covid infection is spiking in fringe areas of Balasore. It is alleged that many people from West Bengal and Bangladesh are fishing in territorial waters. They come to Odisha to repair boats and their fishing nets. Their entry will worsen the Covid situation in coastal pockets like Bhograi, Baliapal, Sadar area, Bahanaga and Remuna.

Notably, after the 2008 terrorist attack on Mumbai, the central government took steps to tighten coastal security along the porous coastline. Thereafter, three marine police stations were set up along the coast in Balasore.

When Balaramgadi marine police station was set up, it was provided with an inspector, six sub-inspectors, six ASIs, 17 havildars and 48 constables.

The police station had two vans and two boats for patrolling. Besides, 16 ex-Army personnel were appointed at the police station. Now, the police station lacks half of the previous manpower. It is now manned by a sub-inspector, a havildar, four constables and six home guards

Kasaphala police station is also plagued by staff shortage. It is manned by an inspector, a havildar and seven constables while Talasri marine police station has an inspector, three ASIs and four con-

The existing personnel have been feeling the pinch of work pressures. At this pandemic time, patrolling along the coast has been vital to check infiltration, but staff shortage in the marine police stations fails to ensure strict vigil along the coastline.

IIC of Balaramgadi police station, Ajay Kumar Murmu, said they are still carrying out patrolling in the sea with a boat.




CVC losing patience over pending cases

reaucratic denial. The anti-corruption watchdog regularly reviews pending cases and even called for a probe into pending corruption cases, but little has resulted from its efforts. Earlier this year in January, the commission set a timeline to finalise pending cases. It directed all chief executives and vigilance officers in various government organisations to finalise pending cases from the period between January 2011 and December 2018 by end of May this year.

With just about a month left for the deadline, Chief Vigilance Commissioner Sanjay Kothari has now upped the ante and advised Union ministries to sort out complaints against officers within three months of their receipt. Reminding them of the May 31 deadline, Kothari has now mandated that at the end of the third month from the date of receipt of the complaint and after deciding on a course of action, a copy of the complaint shall be made available to the concerned employee within 15 days. Once a decision is made to pursue the vigilance case, the concerned organisation shall send its inquiry report to the CVC or Chief Vigilance Officer seeking first stage advice within three months of registration of a case.

Key appointment hangs in balance

Away from the Covid-19 din, there is a tussle going on between the Punjab government and the Centre over the naming of 2002 batch IAS officer Vijay Namdeorao Zade as the Finance Secretary of the



According to sources, the Ministry of Home Affairs (MHA) has sought details about Zade's professional profile and other information in a 17-point proforma. It wanted to know about Zade's completion of service in the cadre, the reason for seeking deputation, vigilance status and details of annual property returns etc

Sources say that this is the first time the ministry has asked for such details and there is no convention for this. Despite their reservations, the Punjab government has responded by providing all the information that was sought about the official. There has been no action from the MHA since then. It has to be remembered, sources say, that the recommendation of Zade was forwarded to the Centre last year but there is no sign of any movement on the issue.

Maharashtra political rivalries affecting babus

The churning in police circles in Maharashtra continues unabated even after the unsavoury Param Bir Singh episode. And, not surprisingly, politics seems to drive most of what is going around these days between the Maharashtra Vikas Aghadi (MVA) government and the opposition BJP.

The state government has now tasked Mumbai Police to investigate the leaking of a report on corruption in the state police to BJP leader Devendra Fadnavis. The report, sources say, was prepared by former state intelligence chief Rashmi Shukla but landed into the hands of Fadnavis. As part of the probe, the Mumbai Police has summoned Shukla, who is now ADG of CRPF, to Mumbai to join the investigation.


The back story is interesting. The FIR was filed at the behest of state Chief Secretary Sitaram Kunte, who had reportedly alleged in a report to Chief Minister Udhav Thackeray that the "finger of suspicion" seemed to point at Shukla herself. The episode has split opinion within the babu corridors with many murmurs about the probe as more of a hatchet job than a fair inquiry into the truth. The political waters in Maharashtra are roiled as it is, and this is hardly going to make way for more clarity.



Butterscotch

Nobody seems to know the origin of the word. Some argue that the second part is actually scorch, from the manner of its making. The Collins Dictionary says that it may have been called that because it was first made in Scotland. Neither suggestion is supported by evidence, though the Scottish link seems plausible because Keillers of Dundee was one firm that made butterscotch commercially. The Oxford English Dictionary's first citation (indeed, its only citation) is from 1865. It's not hard to take that back a while: the first example I can find is from The Boy's Autumn Book of 1847. Although that was published in New York it quotes a British itinerant seller of sweets. Wikipedia states that the first maker of butterscotch was Samuel Parkinson of Doncaster, in 1817. The firm did make it during the nineteenth century and Doncaster became famous for it. The Parkinson papers are deposited at the Doncaster Archives, from where Dr Charles Kelham tells me they begin only in 1848, although an article published in The Doncaster Review in September 1896 asserts that "It was on the 11th of May 1817, that the late Mr. Samuel Parkinson commenced the manufacture of butterscotch." If he did so, it may be unlikely, from the lack of written evidence before 1847, that he called it by that name. An advertisement found by subscriber Gemma Dearing in The Lady's Newspaper of London, dated 20 March 1847. The word "improved" certainly suggests that butterscotch was known by that name rather earlier. Other writers argue that the sweetmeat has no link with Scotland. Charles Earl Funk noted in Horsefeathers in 1958: "All directions for the preparation of this candy after it is properly cooked close with some such statement as: Pour upon oiled paper or well-buttered pan and when slightly cool score with a knife into squares."

MORALS AND VAX MARKET

UNTIL A FEW MONTHS AGO, **ACTIVISTS FOR ACCESS TO MEDICINES AND OPEN SCIENCE WERE HOPEFUL THAT THE ENORMITY OF** THE PANDEMIC **WOULD LEAD TO A REJECTION OF PROPRIETARY SCIENCE AND PATENT-BASED MARKET MONOPOLIES**

s the second wave of the COVID-19 pandemic outstrips the severity of the first, a clear global bifurcation is emerging. The pandemic is abating, gradually and unevenly, across richer countries, but flaring up in several developing and emerging economies, most notably India, but also to varying degrees in countries such as Bangladesh, Pakistan, Turkey, the Philippines, Ethiopia, and Kenya.

There are many reasons for this divide, but uneven access to healthcare-particularly the glaring inequity in access to COVID-19 vaccines - is impossible to ignore. On January 18, the director-general of the World Health Organization, Tedros Ghebreyesus, noted that more than 39 million doses of COVID-19 vaccine had been administered in at least 49 higher-income countries. By contrast, he said, "Just 25 doses have been given in one lowest-income country. Not 25 million; not 25 thou-

sand; just 25.' More than one billion vaccine doses have now been administered worldwide, but vast disparities remain. Seychelles tops the list, having fully vaccinated 59% of its citizens, while Israel (56%), Chile (34%), and the United States (30%) also rank high. Brazil, however, is 43rd globally, with just 5.9% of its population fully vaccinated, while India and Bangladesh are much lower, at 1.8% and 1.7%, respectively. And in some countries, mainly in Sub-Saharan Africa, virtually no one has been vaccinated.

Given that a COVID-19 vaccine is an essential good like food and shelter, we should be ashamed of such grave inequities. Making the problem worse, many rich countries are stockpiling vaccines beyond what they need, as a precautionary buffer.

Until a few months ago, activists for access to medicines and open science were hopeful that the enormity of the pandemic would lead to a rejection of proprietary science and patent-based market monopolies. In May 2020, for example,

the WHO launched the global COVID-19 Technology Access Pool (C-TAP) with the aim of encouraging the widespread voluntary sharing of pandemic-related intellectual property.

Similarly, the COVID-19 Vaccine Global Access (COVAX) facility, also established last year, was supposed to provide subsidized vaccines to poor countries, with financial support from the rich world. But even by then, as Alexander Zaitchik – echoing a common sentiment - recently wrote in The New Republic, "The optimism and sense of possibility that defined the early days were long gone.'

If we reflect on the world's failure to ensure equitable access to COVID-19 vaccines, we will at least be less likely to leave poor countries in the lurch in the future. The failure is both intellectual and moral. With the best of intentions, many activists' plans and proposals paid little attention to individual incentives. But while it is right to campaign for corporations to behave morally, it is folly to assume they are moral

We can conceive of a future where people invest in knowledge creation and then contribute their findings to an open-access pool, instead of trying to make money. But we clearly are not there yet. For now, we must let private players acquire rights over the intellectual property they create to ensure that they invest in costly research

At the same time, there is scope for cutting the profits of pharmaceutical firms considerably - by compelling them to sell products more cheaply and enable generic producers to sell in certain regions - without killing the pharmaceutical industry's incentives to spend on research.

To do this properly, we need to understand the structure of markets for knowledge-based products like new vaccines. Currently, we do not: the "market" is a mishmash of competition and side deals. According to a recent paper from the Institute for New Economic Thinking, governments and pharmaceutical companies last year concluded 44 bilateral COVID-19 vaccine deals, many of which have undisclosed details

and poorly understood escape clauses. Poor countries were, by and

We sorely need a theoretical framework to understand this market. Currently, it resembles what oligopoly must have looked like before Augustin Cournot captured its essentials in 1838. Cournot's breakthrough later enabled the development of the first antitrust laws, like the US Sherman Antitrust Act of 1890, which allowed firms to set prices but prohibited secret multilateral deals to prop up prices. These laws gradually became sharper.

Today, we are making vaccinemarket rules while trapped in a fog of uncertainty. From the little we know, it is clear that intellectualproperty rights must continue to play a role, at least for now. On the other hand, pharmaceutical firms are arguably making vastly larger profits than needed to sustain their incentive to innovate (especially given how much of their IP has resulted from publicly funded research). In large pandemics such as the current one, we should compensate drug companies with lumpsum payments to cover costs, revoke some of their patents, and allow generic firms to mass-produce es-

sential vaccines. In the long run, we can go further, by emphasizing that a society's success does not depend on profit alone. The popular slogan, "None of us will be safe until everyone is safe." amounts to urging the rich to be more selfish, because helping others is in their self-interest. But the pandemic is a clarion call to start thinking beyond the narrow confines of economic rationality and identify others' interests as part of our own.

The case can be registered under Public Health Act. A clear message has been sent for spreaders of infodemic and scare mongers. We are in the midst of second wave of COVID-19, adversely affecting everyone's life. Everyone is looking for a miracle to happen to end the pandemic. True, miracles happened but in Israel and America. Both the countries relaxed their COVID guard and the citizens can now move around without mask. They could convince their citizens to take the vaccines and it worked and developed herd immunity.

A survey conducted just before the launch of India's vaccination programme showed that about 59% of Indians were sceptical about COVID-19 vaccines. They expressed that they won't rush to take vaccines. Scepticism is common perhaps due to the speed at which the vaccines were developed and received emergency approval. People started perceiving the clinical study conducted in the development of vaccine as superficial one. This misunderstanding is further fuother generic disinformation. The minimum study required for assessing safety and efficacy is done and the vaccines were approved for emergency use just because sufficient period of follow up was not done owing to the urgent need in pandemic. The choice is simple: we need vaccine or corona? In addition to the doubt on safety and efficacy of vaccines; widespread rumours, false information and misinformed campaigns further confused people. Let's look at some of the misin-

formation spreading around us leading to vaccine hesitancy among the public. Some mongers spread that the vaccines contain aluminium which is harmful. It can cause brain damage. The truth is: none of the COVID-19 vaccines approved has aluminium as component. In some other vaccines, often very small quantity of aluminium is used to build stronger immunity. Some people believe that the COVID vaccine contains cow blood, meat, or fat; aborted foetus, pigs, and chimpanzee feces; and could cause infertility and so on. The list is endless. None of the information is true. Even professionals too have their own reservation. In one leadwas intended for only frontline health workers, the doctors and other hospital staff kept away from the vaccination booth. In another incident, one medical officer instructed the nurse to hold a cotton ball to his arm to make it look like he took the injection. In another city, many of the hospital staff went on sudden leave just to skip vaccine doses. All the incidents were reported in the media. The irresponsible behaviour of these professionals cannot be justified but it definitely influenced the attitude of general public towards corona vaccines.

The misinformation around COVID-19 vaccine is massive. In order to counter this COVID-19 vaccine misinformation. Google has launched a \$3 million fund to support journalistic efforts to effectively fact check misinformation about COVID-19 immunisation process. Fake news spreaders use the strategy to develop negative empathy towards pro-vaccine opponents with sinister or mercenary motives. The same empathy can be used to counter misinformation and help communicate corrective information to the public. Opinions of the harmed persons

to help spread responsible information. The control of COVID-19 is now

our first priority to save lives and resources. The most effective and proven weapon: universal immunisation till we achieve herd immunity is available with us. In spite of having two indigenously available vaccines and launching countrywide immunisation, the immunisation coverage is not encouraging. Though many reasons can be cited for this, misinformation spreading against vaccines and vaccination through social and other unregulated media is a major contributor for vaccine hesitancy among the general population. In an attempt to safe guard public health and promote vaccination, the Prime Minister in his 76th edition of "Mann Ki Baat" called upon the countrymen to get information from the right sources.

Bengal announces partial lockdown

Govt shuts down malls, restaurants, gyms; bazaars to remain open for limited hours

Kolkata, April 30: The West Bengal government Friday ordered shutdown of all shopping malls, beauty parlours, restaurants, bars, sports complexes, gyms, spas and swimming pools in the state with immediate effect until further orders, amid the surge in COVID-19 cases.

According to the order, all forms of social, cultural, academic, entertainment-related gatherings and congregations have been prohibited in the state for the time being.

Bazaars, market places will be allowed to operate twice every day from 7 am-10 am and 3 pm-5 pm. Activities related to the elec-

toral counting processes and vic-

tory rallies will be guided by the Election Commission protocols, the order said.

Medical shops, medical equipment outlets, grocery stores, along



with home delivery services, have been kept out of the order's purview.

"The restrictions will be in place till the administration reviews the situation again," a senior official told this news agency.

Any person violating these measures will be liable to be proceeded against as per the provisions of the Disaster Management Act. 2005. besides action under Section 188 of the Indian Penal Code and other legal provisions as applicable.

New Delhi, April 30: The Bharatiya Janata Party (BJP) has claimed that the party would form the next government in West Bengal by winning more than 200 seats, even as all exit polls except two suggested a win and hat-trick for the Mamata Banerjee-led TMC government.

BJP's IT cell head Amit Malviva the West Bengal co-in-charge, told this news agency: "The BJP is going to win more than 200 seats regardless of whatever the figures of the exit polls suggest. During the 2019 Lok Sabha elections nobody said that the BJP may win 18 seats. However, the party stunned everyone. Let's wait for the results on May 2...everything will become clear.

Meanwhile, BJP national spokesperson Gopal Krishna Agarwal told this news agency: Exit polls cannot be treated as exit polls. West Bengal is amid the air of change. The way Mamata Banerjee has created a confrontation with the Central government;

kept the people deprived of the Central benefits, indulged in appeasement politics... she is going to lose elections badly. In West Bengal, BJP government is going to be formed with an absolute majority.'

Apart from the Axis My India-India Today and the Republic-CNX exit polls, which gave the BJP an

edge in the battleground state, all other surveys, including the CVoter Exit Poll for Times Now/ABP News, forecast a third victory for the Trinamool, putting it ahead in the 294-member Assembly.

However, the survey of $\operatorname{Axis}\operatorname{My}$ India-India Today, whose predictions in the 2019 Assembly elections had shown the immense BJP gains in the state, again gave the party its first-ever victory in the state polls. According to it, the BJP could end with 134-160 seats, the Trinamool with 130-156, and the Left with a mere 0-2.

On the other hand, the P-MARQ survey gave the Trinamool 152-172 **Apart from the Axis** My India-India Today and the Republic-CNX exit polls, which gave the BJP an edge in the battleground state, all other surveys forecast a third victory for the Trinamool

The ETG Research poll gave Banerjee's party 164-176, the BJP 105-115 and the Left 10-15 seats. CVoter gave Trinamool 152-164, the BJP 109-121 and the Left 14-25.

The Republic-CNX poll, however, showed a BJP victory, giving it 138-148 seats, with 128-132 for the Trinamool and 11-21 for the Left.

Legal luminary Soli Sorabjee passes away

Distinguished jurist and former Attorney General Soli Sorabjee, who appeared in several historic cases like Kesavananda Bharti and SR Bommai, passed away due to COVID-19 at a hospital here Friday. The 91-year-old is survived by wife, a daughter and two sons.

A recipient of the Padma Vibhushan, the second highest civilian award of the country, the renowned human rights lawyer served as the Attorney General for India from 1989-90 and then from 1998-2004 during the tenure of VP Singh and Atal Bihari Vajpayee respectively.

President Ram Nath Kovind, Vice President Venkaiah Naidu and Prime Minister Narendra Modi were among a host of leaders who condoled the passing away of the eminent jurist.

The Prime Minister him as an outstanding lawyer who was at the forefront of helping the poor and downtrodden through law. Chief Justice of India (CJI) NV Ramana also condoled the demise of Sorabjee. "I am deeply saddened to learn about the passing of Shri Soli Jehangir Sorabjee, former Attornev General of India. In his nearly 68 year long association with the judicial world, he made immeasurable contribution in enriching the global jurisprudence of Human Rights and Fundamental Right," he said.

Considered one of the best Constitutional law experts, Sorabjee wrote several books on laws and justice, press censorship and the Emergency, and vehemently fought against human and fundamental rights violations.

One of his recent court battles pertaining to fundamental right violations was the Shreya Singhal case in which the Supreme Court in 2015 agreed to his submissions and struck down a provision in the Information Technology Act relating to restrictions on online freedom of speech and expression.

A ferocious second wave of coronavirus in New Delhi has overwhelmed hospitals and caused a shortage of oxygen, leaving many helpless as they try to treat their sick relatives at home. As she waited outside a refilling plant in a shabby industrial estate in the capital, Saha began to panic, falling to her knees and begging for the facility to open, but police and security guards told her to wait.

SC fines commerce person for prescribing COVID medicine

New Delhi, April 30: The Supreme Court has imposed a fine of ₹1,000 medicines for COVID-19. The man, who has a post graduate degree in commerce, had approached the court after his petition was dismissed by the Calcutta High Court. Calling the petition frivolous,

Chief Justice of India NV Ramana asked Suresh Shaw, "Are you a doctor or a scientist? What's your qualification?'

The man said he is not a doctor but postgraduate in commerce and that research is his natural activity. The country's top judge pulled up Shaw and said, "You want to prescribe medicines to the whole world and doctors do not know the medicine? A commerce person teaching doctors and scientists

When Chief Justice Ramana asked if the court can impose a fine of ₹10 lakh on him, the man said he is an unemployed teacher and cannot pay ₹10 lakh. He said he can pay ₹1,000.

What is your knowledge in science and treating Covid? Not satisfied with Calcutta High Court and you came all the way. Can we impose ₹10 lakh fine?"



Chief Justice Ramana asked the

Dismissing the petition, Supreme Court said the man has to pay the fine to the Calcutta High Court Legal Services Authority.

The Supreme Court had taken up the issue of the shortage of oxygen, beds, essential drugs like Remdesivir and Faviprivir and vaccines, and asked for the Centre's response. Many High Courts too are hearing petitions related to the shortage of critical supplies.

Coronavirus has infected over 3.86 lakh more people in India in yet another worrying daily high and killed 3,498 in the last 24 hours. India's tally of more than 1.87 crore COVID cases is the second-highest globally, behind the United States and ahead of Brazil.

for 18-44 age group: Kejriwal

New Delhi, April 30: Delhi will not COVID-19 vaccination for people aged 18-44 years on May 1, with Chief Minister Arvind Kejriwal Friday saying that required vaccine doses have not been received yet for the drive.

He appealed to people in the targeted age group not to line up at vaccination centres in the city on May 1. In the next one-two days, around three lakh Covishield vaccines will be received and the drive for vaccinating people in the age group 18-44 years will commence, Kejriwal

said in an online briefing. The third phase of the $\check{\text{COVID-19}}$ vaccination drive to inoculate people aged 18 years and above will roll out in the country on May 1. However, some states have said they would be unable to start the drive on day one due to the shortage of vaccines. Kejriwal said his government has placed orders for supply of 67 lakh doses each of Covishield and Covaxin from man-

ufacturers in three months. Kejriwal, who had earlier appealed to the manufacturers to bring down prices of their vaccines, said the "Delhi government

"I appeal to all citizens to not queue up at vaccination centres before our announcement as this might lead to violation of social distancing and create a law and order situation," Kejriwal said.

The government is in constant touch with the companies. As soon as the vaccine doses are received, Delhi government will make an official announcement for starting vaccination covering those aged 18 years and above, he added.

"We have not yet received the vaccine, and are in constant touch with the companies and hope the vaccines will be delivered in a day or two. We've been assured of this.'

The Delhi Chief Minister assured that everyone is to be inoculated and required infrastructure

has been readied for it.

"This includes 412 movable properties amounting to ₹47 crore and 426 immovable properties worth ₹257 crore," it said.

The Rose Valley group of companies "had collected huge amount of money from gullible public by floating various fake and fictitious schemes and defaulted the repayments.

Probe found that several properties in West Bengal, Odisha, Tripura, Assam, Maharashtra, Jharkhand and others states were "acquired in the name of various companies of group, by illegally diverting the funds collected from the common public", the central agency said. These assets were earlier provisionally attached by the ED under the anti-money laundering law and after getting approval from the Adjudicating Authority (under the PMLA), the agency is empowered to take pos-

session of such properties. The ED had filed a criminal case of money laundering against the firm, its Chairman Gautam Kundu and others in 2014 and later arrested him in Kolkata.

Multiple charge sheets have been filed by it in this case till now even as the probe continues.

India's O₂ crisis to ease by mid-May, output to jump 25%: Report

MEDICAL OXYGEN CONSUMPTION IN INDIA HAS SHOT UP MORE THAN EIGHT-FOLD FROM USUAL LEVELS TO ABOUT 7,200 TONNES PER DAY

New Delhi, April 30: India's severe medical oxygen supply crisis is expected to ease by mid-May, a top industry executive told Reuters. with output rising by 25 per cent



and transport infrastructure ready to cope with a surge in demand caused by a dramatic rise in coro-

Dozens of hospitals in cities such as New Delhi and Mumbai have run short of the gas this month. sending relatives of patients scrambling for oxygen cylinders, sometimes in vain. Medical oxygen consumption in India has shot up more than eight-fold from usual levels to about 7,200 tonnes per day this month, said Moloy Banerjee of Linde Plc, the country's biggest producer.

"This is what is causing the crisis because no one was prepared for it, particularly the steep curve up,' Banerjee, who heads the company's South Asia gas business, told Reuters Thursday. Linde - whose two affiliates in the country are Linde India and Praxair India - and other suppliers are ramping up production to a total of more than 9,000 tonnes per day by the middle of next month, he said.

A logistics crisis impeding the speedy movement of oxygen from surplus regions in eastern India to hard-hit northern and western areas would also be resolved in the coming weeks as more distribution assets are deployed, Baneriee said. "My expectation is that by the middle of May we will definitely have the transport infrastructure in place that allows us to service this demand across the


country," he said. Banerjee said India was importing around 100 cryogenic containers to transport large quantiLinde providing 60 of those. Some are being flown in by Indian Air Force aircraft.

Many of these containers will be placed on dedicated trains that would cut across the country, each carrying between 80-160 tonnes of liguid oxygen and delivering to multiple cities. The company is also looking to double the number of oxygen cylinders in its distribution network to at least 10,000, which would improve supply to rural areas with weak infrastructure.

"We are trying to create a hub-andspoke type of system so that we make a lot of liquid oxygen available at the local area, from where the local dealers can pick it up, Banerjee said.

Delhi LG tests **Covid positive**

New Delhi: Delhi Lieutenant Governor Anil Baijal said Friday that he had tested positive for coronavirus with mild symptoms. Baijal had taken both doses of the vaccine. He took the first dose of COVID vaccine at the Tirath Ram Shah Hospital in New Delhi last month, an official said. "I have tested positive for COVID with mild symptoms," he tweeted. "Have isolated myself since the onset of symptoms and all those who were in contact with me have been tested."

AIADMK rejects exit poll forecast

Chennai: The AIADMK Friday rejected the exit polls forecasting a victory for the DMK-led opposition in Tamil Nadu, saying the party would maintain its winning streak and repeat the success of the 2016 assembly elections. Party coordinator and deputy Chief Minister O Panneerselvam and cocoordinator and Chief Minister K Palaniswami, in a joint statement, recalled a similar situation in 2016 when exit polls had been proved wrong.

Telangana extends night curfew

Hyderabad: The Telangana government Friday extended the night curfew (from 9 PM to 5 AM the next day) till May 8 (5 AM), an official order said. The state government had earlier imposed the restrictions from April 20 to May 1 (5 AM) to curb the spread of COVID-19. The government also issued an order imposing restriction on screening of movies in view of the night curfew.

Kumbh Mela ends

Dehradun/Rishikesh: Seventy lakh devotees participated in Haridwar's Kumbh Mela, the mammoth religious congregation which ended Friday after triggering a scare that it might have acted as a coronavirus 'super-spreader". Despite the huge number of people gathering around Haridwar to take a dip in the holy Ganga, the 2021 event was a comparatively modest event -- reduced to just one month and scaled down midway due to the raging pandemic. Held over three months in normal circumstances, the Kumbh Mela this time formally begun as late as April 1 due to concerns over COVID-19.

'Covid cases may peak next week'

THE SURGE HAS LED TO A PUBLIC HEALTH CRISIS IN THE COUNTRY, FORCING THE GOVERNMENT TO SEEK OXYGEN, MEDICINES AND OTHER ESSENTIALS FROM COUNTRIES AROUND THE WORLD

New Delhi, April 30: India's Coronavirus cases may peak between May 3 and 5, according to a mathematical model of a team of scientists advising the government, a few days earlier than a previous estimate as the virus has spread faster than expected.

The country has reported more than 3 lakh new infections daily for nine consecutive days, hitting another global record of 3.86 lakh today.

The surge has led to a public health crisis in the country, forcing the government to seek oxygen, medicines and other essentials from countries around the world.

'Our belief is that by next week. the daily new cases nationwide would have peaked," M Vidyasagar, head of a government-appointed group of scientists modelling the trajectory of infections, told Reuters.

The group previously told senior government officials in a presentation April 2 that cases would peak between May 5 and 10, said Mr Vidyasagar.

"We said (at that presentation) that it was not a matter of putting up some structures that would come up in July or August, because by then

Govt to import 4.5L Remdesivir vials

New Delhi, April 30: The government has placed orders for import of 4.5 lakh vials of antiviral drug Remdesivir with the first consignment of 75,000 vials expected to reach Indian shores Friday, Chemicals and Fertilisers Ministry said in a statement.

The government has started importing the vital drug from other countries to ease its shortage in the country, it said. The first consignment of 75,000 vials will reach India Friday, it added.

Demand for Remdesivir has gone up manifold in the country with a surge in COVID-19 cases. The antiviral drug is being used in the treatment of infectious disease. HLL Lifecare Ltd, a Government of India owned company has ordered 4,50,000 vials of Remdesivir from M/s Gilead Sciences Inc USA and Egyptian Pharma Company, M/s Eva Pharma, the release said. It is expected that Gilead Sciences will dispatch 75,000 to 1,00,000 vials in the next one or two days, it noted.

Further one lakh vials will also be supplied before or by May 15, the release said. EVA Pharma will supply around 10,000 vials initially followed by 50,000 vials every 15 days or till July, it added. The Chemicals and Fertilisers Ministry said it has also ramped up the production capacity of Remdesivir in the country. As April 27, the production capacity of the seven licensed domestic manufacturers has increased from 38 lakh vials per month to 1.03 crore vials per month, it said.

Mega **scare**

Raigad/Mumbai: Sparking a mega health scare, at least 90 Covid-19 patients in Maharashtra's Raigad district, who were administered Remdesivir doses of a particular brand, developed severe sideeffects following which the state government has imposed a temporary suspension on its use here. FDA Minister Raiendra Shingane said. "The incident took place on Thursday in around three hospitals in the district. The patients who were administered Remdesivir manufactured by the company Hetero Drugs had complained of side-effects," Shingane told IANS. The shocking incident came to light when some patients developed chills, drop in blood pressure, fall in SPU count, varying degrees of fever or other health issues in various hospitals. Releasing a videostatement, Raigad Collector Nidhi Choudhari said that following complaints from patients in different hospitals, the district health authorities acted on them immediately.

Today, however, with the pandemic raging on and the death toll mounting, the number of 'ghant' hanging on Peepal tree is growing by the day. There are more than two dozen 'ghant' hanging here. People are not coming back to collect the ashes of



their family members and we cannot discard them. Maybe, after waiting for a few more days, we will immerse them in the river." said Krishna (name changed on request) a worker

where the relatives have left the bodies at the cremation ground without cremating them because they were asked to wait for their turn.

Workers at the cremation grounds say that here is no time to perform pre-cremation rituals that include chanting of mantras.

"We now do the basics and the pyre is set on fire because there are bodies waiting in the queue. Even the cremation of non-Covid bodies is being rushed up. It is a sad situation but the fact is that no one - not

even the closest relatives, want to

stay at the cremation ground Abhimanyu Tiwari, a priest at

Rasoolabad ghat in Prayagraj, said, "We are performing cremation for around 60-70 bodies every day and more than half of them are not able to perform the last rites. Still, there are so many Ghant tied on the tree that just a look makes a person shiver." Post death rituals are also being done away.

'When my father died last week, my mother-in-law, husband and sister-in-law had also tested positive. They are all in home isolation and there is no question of even holding a prayer meeting for my father-in-law," said Nalini Singh, a young home-



Treat available O2 as critical commodity: Centre OVER 1 CRORE VAX DOSES AVAILABLE

New Delhi, April 30: The Centre Friday said it has asked the states to treat the available oxygen as a critical commodity and undertake an oxygen-consumption audit at all hospitals, including private ones, amid a shortage of the life-saving gas in several parts of the country.

Addressing a press conference, Joint Secretary in the Ministry of Health and Family Welfare Lav Agrawal said from the start of the pandemic, the government had identified oxygen-supported beds as major clinical interventions. He said the government had procured 1,02,400 oxygen cylinders at the national level in April-May 2020 and distributed those among the states.

We have requested the states to treat the available oxygen as a critical commodity and also to ensure a rational use of oxygen," Agrawal

said. Listing out the steps taken by the Centre to augment the supply of oxygen, he said the National Pharmaceutical Pricing Authority (NPPA) has issued instructions for fixing the price of liquid medical oxygen. Agrawal said 162 pressure swing adsorption (PSA) plants of 154-MT capacity each have been sanctioned across the country. Of these, 52 plants are already installed, 87 have been delivered and work to commission these plants at the earliest is on. The PSA plants can enable hospitals for insitu generation of oxygen. Agrawal

Emergency financial powers to armed forces

New Delhi, April 30: Defence Minister Rajnath Singh Friday granted emergency financial powers to the three services to allow formation commanders to establish and operate hospitals as well as quarantine facilities for COVID-

The emergency powers have been granted initially for a period of three months from May 1 to July 31 and are in addition to the similar powers delegated to the medical officers of the armed forces last week, officials said. They said vice chiefs of the three

services as well as General Officer Commanding-in-Chiefs (GOC-in-Cs) and holders of equivalent rank will be able to clear procurement proposals to deal with the coronavirus crisis. Singh's office said he invoked spe-

cial provisions and granted emergency financial powers to the armed forces to empower them to speed up efforts in the nationwide fight against COVID-19.

These powers will help Formation Commanders to estab-

lish and operate quarantine facilities/hospitals and to undertake procurement/repair of eqpt/items/ material/ stores, besides provisioning of various services and works required to support the ongoing effort against COVID," his office tweeted.

The defence ministry said vice chiefs of armed forces including chief of integrated defence staff to the chairman chiefs of staff committee (CISC) and GOC-in-Cs and equivalent rank holders of all three services have been given full powers. It said the corps commanders and area commanders have been delegated powers up to ₹50 lakh per case while division commanders and sub area commanders and equivalents have been delegated powers up to ₹20 lakh per case. The emergency powers were sanctioned to the armed forces last year too when the COVID-19 pandemic first broke out.

Last week, the ministry sanctioned emergency financial powers of ₹5 crore to the director general of medical services of the three services for COVID-19 related pro-

'NOVEL SMELL TEST MAY **HELP DIAGNOSE COVID'**

New Delhi, April 30: A new capsule-based smell test may help in the rapid diagnosis of various diseases linked to the loss of smell such as COVID-19, scientists say.

The test has been found to be easy to use in patients with Parkinson's disease, and could also be helpful in diagnosing COVID-19 in the broader population, according to the study published in the journal Royal Society Interface.

The researchers at Queen Mary University of London in the UK noted that smell tests have the potential to support the diagnosis of certain neurological conditions, including Parkinson's and Alzheimer's.

However, these tests are not widely available, expensive, and take too long to administer in routine healthcare settings, they said. To address this problem, the team developed a novel smell testing kit which uses capsules of aromatic oils placed between two



strips of single-sided tape.

To take the smell test, the capsules are simply crushed between the fingers and the tape strip peeled to release the aroma contained within the capsules. Based on a person's ability to recognise these smells, a score would be generated that can be sent to their doctor if they are experiencing a loss of smell.

"Our capsule-based smell test can assist in the rapid diagnostic of various diseases linked to the loss

of smell," said lead researcher Ahmed Ismail from Queen Marv's School of Engineering and Materials Science. "These include chronic neurological conditions such as Parkinson's and Alzheimer's disease, as well as COVID-19, which is known to affect the sense of smell," Ismail said.

Being non-invasive and less stressful, the capsule-based smell test has benefits over the nose swab in diagnosing COVID-19, according to the researchers

GOA GOES INTO LOCKDOWN

Panaji, April 30: Amid an extremely high test positivity rate of over 50 per cent, Goa went into a four-day -long "lockdown" to curb COVID-19 cases as people stayed indoors, while streets were largely bereft of vehicles in the tourist state Friday.

The tiny coastal state, with a population of around 16 lakh, has been witnessing an unprecedented surge in COVID-19 cases during the second wave of the infection.

In a development that will worry the administration in Goa, the state reported over 50 per cent test positivity rate Thursday when out of 5,910 samples tested for coronavirus, 3,019 returned positive, health department data showed. Also, 36 patients succumbed to the viral infection during the day. The test positivity rate (TPR) is defined as the percentage of samples that return positive among the total tested.

The COVID-19-related restrictions on movement of people and non-essential activities came into force at 9 pm Thursday and will remain applicable till 6 am Monday (May 3). The state government has said all essential services would be allowed to function during the period.

Myanmar drug surge worry for neighbours including India

Kolkata, April 30: A spike in illegal narcortics from the 'Golden Triangle' to South and Southeast Asian countries as a result of pandemic-related supply gluts and a likely increase in production is worrying Myanmars neighbours, including India.

Anti-narcotics authorities in neighboring Thailand have seized more than 80 million methamphetamine pills, or yaba, in the past six months, a record haul that they blame partly on a supply glut caused by the Covid-19.




The Assam Rifles that guards India's borders with Myanmar has

also reported a significant rise in drug seizures in northeastern states like Manipur and Mizoram but many feel the "seizures are mere tips of the iceberg". Assam Rifles DG Lt Gen Sukhdeep Sangwan said during a recent seminar that his traditional counter-insurgency force is "fully geared to meet the drug threat from Myanmar." 2020 was boom year for Myanmar's drug trafficking syndicates, with the United Nations Office on Drugs on Crime (UNODC) reporting a sharp drop in

the price of methamphetamines in East and Southeast Asia to its lowest level in 10 years. That was because the market was overwhelmed with supply. This boost owes to cartels in 'Golden Triangle', like the United Wa State Army (UWSA), developing the ability to produce the ingredients to manufacture various synthetic drugs, including amphetamine-type stimulants like crystal meth and yaba, as well as synthetic opioids. The UNODC has warned that the region should brace for a larger flow of illegal drugs as the crisis in Myanmar deepens, and the formal economy all but collapses amid strikes, protests, and increasingly violent crackdowns by the security forces. The International Crisis Group puts the total value of the Golden Triangle drug trade at around \$40 billion per year. The worry for India and Bangladesh emerges from a dynamic shift in the Burmese illicit drug industry. Smaller cartels like the Wei Brothers, Zhang Ming group and Lo Hsin Nian group have moved their production facilities to Western-Myanmar on borders with India and Bangladesh.

Close to goal of 500k shots a day

Rome: Italy is nearing its goal of administering a halfmillion COVID-19 vaccines a day. Premier Mario Draghi's office said early Friday that provisional data indicates some 497,993 doses were administered Thursday, a daily record. Italy's vaccine czar has aimed to have at least 500,000 shots administered per day by the end of April, to reach the goal of inoculating 80% of the population by September.

Brazil surpasses 400k virus deaths

Sao Paulo: Brazil has became the second country to officially top 400,000 COVID-100,000 lives in just one month, as some health experts warn there may be gruesome days ahead when the Southern Hemisphere enters winter. The country's Health Ministry registered more than 4,000 deaths on two days early in the month, and its seven-day average topped out at above 3,100.

The Health Ministry announced late Thursday night that three people tested positive for the new variant in the Bouches-du-Rhone and Lot et Garonne regions of southern France. All three had travelled to India and are under medical observation.

Orthodox Jews had thronged to the Galilee tomb of 2nd-century sage Rabbi Shimon Bar Yochai for annual Lag B'Omer commemorations that include all-night prayer, mystical songs and dance.

Witnesses said many of the dead were caught in a tightly packed passageway around 3 meters (yards) wide after crowds packed the slopes of Mount Meron in northern Israel in defiance of warnings to maintain social distancing against COVID-19.

Many of the dead had yet to be identified and police asked family members to provide pictures and personal information of those who attended the festival and were still



missing to help with the process. Videos posted on social media

showed ultra-Orthodox men clambering desperately through gaps in sheets of torn corrugated iron to escape the crush. Bodies lay on stretchers in a corridor, covered in foil blankets. "There was some kind of mess. police, screaming, a big mess, and after half an hour it looked like a scene of a suicide bombing attack, numerous people coming out from there on stretchers," said 19-year-old festivalgoer Havim Cohen.

"We were going to go inside for

the dancing and stuff and all of a sudden we saw paramedics from (ambulance service) MDA running by, like mid-CPR on kids," said 36year-old pilgrim Shlomo Katz. As rescue workers tried to extricate the casualties, police shut down the site and ordered revelers out.

The Mount Meron tomb is considered one of the holiest sites in the Jewish world and is an annual pilgrimage site. The event was one of the largest gatherings in Israel since the outbreak of the coronavirus pandemic more than a year ago.

125 Europe-bound children rescued off Libyan coast

Cairo, April 30: A total of 125 Europe-bound children were rescued at sea this week by Libyan authorities off the Mediterranean coast, the United Nations child welfare agency said Friday, adding that most were brought to detention centres. The children, fleeing war and

cued are sent to overcrowded detention centres in Libva under extremely difficult conditions and with no or limited access to water and health services. Nearly 1,100 children are in these centres," read the statement.

UNICEF urged the Libyan authorities to release all children and to put an end to immigration detention.

"The Central Mediterranean continues to be one of the deadliest and most dangerous migration routes in the world," UNICEF said.

A new law published Friday makes clear that Vatican city-state prosecutors have jurisdiction over cardinals, bishops and need only the pope's consent to proceed with investigations against them.

The law abrogated a regulation, upheld as recently as last year, that said only the tribunal's highest appeals court, which is composed of three cardinal judges, could assess the actions of cardinals and bishops accused of criminal offenses.

The reform is the latest sign that after eight years of preaching about ending corruption and other criminal activity in the Holy See, Francis is taking concrete steps to hold his own cardinals and bish-



ops accountable.

Dubai, April 30: America's longest war, the two-decade-long conflict in Afghanistan that started in the wake of the September 11 terrorist attacks, killed tens of thousands of people, dogged four US Presidents and ultimately proved unwinnable despite its staggering cost in blood and treasure.

This final chapter, with President Joe Biden's decision to pull all American troops from Afghanistan by the 20th anniversary of the terrorist attacks, has prompted a reckoning over the war's lost lives and colossal expenditure.

Here's a look at the spiraling cost of America's campaign—the bloodshed, wasted funds and future consequences for the war-battered nation teetering on the brink of chaos.

THE COST IN LIVES Afghans have paid the highest

ians have been killed in the war as of mid-April, according to the Costs of War project at Brown University, which documents the hidden costs of the post-9/11 wars. Gun and bomb attacks targeting

THE COST IN DOLLARS

The US has spent a stunning total of \$2.26 trillion on a dizzying array of expenses, according to the Costs of War project.

est 2020 report said war-fighting costs totaled \$815.7 billion over the

Afghanistan, everything from fuel

and food to Humvees, weapons and

ammunition, from tanks and ar-

mored vehicles to aircraft carriers

Washington has poured over \$143 billion into that goal since 2002, according to the latest figures from the Special Inspector General for Afghanistan Reconstruction

Of that, \$88 billion went to training, equipping and funding Afghan military and police forces. Another \$36 billion was spent on reconstruction projects, education and infrastructure like dams and highways, the SIGAR report said. Another \$4.1 billion has gone to humanitarian aid for refugees and disasters.

It has also paid \$296 billion in medical and other care for veterans, according to Costs of War. It will continue to pay both those expenses for years to come.

THE COST OF LEAVING

Although few want to prolong

the war interminably, many fear its end may jeopardise Afghanistan's modest gains in health, education and women's rights, made in the early years as the US expanded the economy and toppled the Taliban, which had imposed tough strictures on women.

Since 2001, life expectancy has increased to 64 years from 56, the World Bank says. Maternal mortality has more than halved. Opportunities for education have grown, with the literacy rate rising 8% to roughly 43%. Life in cities has improved, with 89% of residents having access to clean water, compared to 16% before the war.

Child marriage has declined by 17%, according to UN data. Girls enrollment in primary school has nearly doubled, and more women have entered college and served in-Parliament. These figures are still pale compared with global standards.

'Demand for MGNREGS jobs doubles in April'

REVERSE MIGRATION ON RISE

Mumbai. April 30: Indicating massive reverse migration to villages amid the second wave of Covid-19, a SBI Research report Friday said the demand for work by households under rural employment scheme or MGNREGS has almost doubled to 2.57 crore in April.

There is no official data on internal migration or reverse migration at the national level with a single source information centre. The country has been topping the list of daily coronavirus infection caseload and death toll for more than two weeks now.

The latest numbers released by the Union health ministry this morning said the country recorded a new daily caseload with as many as 3,86,452 new infections in the past 24 hours, pushing the tally to 1,87,62,976, while active cases crossed the 31-lakh mark. The death toll increased to 2.08.330

with 3,498 new fatalities, the data updated at 8 am on Friday showed. The active cases have also jumped to 31,70,228, comprising 16.90 per cent of the total infections.

As cases continue to soar every



day, the nation has been snapping at the seams as hospitals are overcrowded with patients gasping for breath as they don't have enough oxygen supplies, and so are crematoriums and burial grounds across the major cities. More than 100 people have died for want of oxygen, while tens of hundreds are dying every day for want of drugs.

'The demand for work by households under rural employment scheme (MGNREGS) has increased

by 92 per cent to 2.57 crore households in April 2021 -- the highest in any April since compilation of the data started in 2013 -- so far, as against 1.34 crore in April 2020.

Covid disruption unlikely to impact April GST collections, says report

Mumbai, April 30: Even with the new wave of Covid-19 resulting in 'lockdowns' in 15 parts of the country and impacting business all across, the country's GST collections, the barometer of economic activity in India, is likely to cross the ₹1 lakh crore mark for the sixth time in as many months in April, a SBI Ecowrap report said Friday.

According to the internal simulation model adopted by SBI Ecowrap, the April GST collection is expected to be in the range of ₹1.15-1.20 lakh crore. This is marginally short of the record high GST collection in March of ₹1.24 lakh crore. The optimism about possible GST collection in April. the report says, is from a healthy growth in E-way bill generation.

"This will be quite impressive given the fact that during April, most of the states imposed partial



note that despite the curbs due to the second wave, the All India GST E-way bills till April have reached 4.89 crore and we estimate it to cross 5.5 crore comfortably, given the past trends," the report said.

"We believe that any disruption in GST collections will be transient and the states will have comfortable SGST collections.

The consultant further said that around 26% of the sales were in ₹45-75 lakh price bracket, 10% in ₹75 lakh to ₹1 crore and 19 per cent above ₹1 crore. Out of the total sales, 44% contribution came from two-bedroom apartments.

Earlier this month, PropTiger reported that housing sales across eight major cities declined by 5% yo-y at 66,176 units. Mumbai, Pune, and Bangalore witnessed a fall in sales, while the other five cities --Delhi-NCR, Kolkata, Chennai, Hyderabad, and Ahmedabad--- saw growth in demand.

Ahmedabad, April 30: Skipper KL Rahul scored a combative unbeaten 91 (57b, 7x4, 5x6) while Harpreet Brar (3/19) accounted for three key batsmen as Punjab Kings thumped Royal Challengers Bangalore by 34 runs in an IPL match here, Friday.

Put into bat, Punjab were in a spot of bother at one stage but Rahul's perseverance, power-hitting of Chris Gayle (46, 24b, 6x4, 2x6) and energy of Brar (25 no, 17b, 1x4, 2x6) ensured they had a competitive 179/5 on board.

Rahul and Gayle shared a 80-run stand but Punjab's middle order collapsed as Brar, batting at No.7, was the only other batsman to manage a double-digit score. Rahul and Brar then added 61 runs for the unbeaten eighth wicket to rescue the

side after the RCB bowlers had seized the initiative following Gayle's dismissal in the 11th over.

Manchester, April 30: Manchester United handed Roma another heavy beating at Old Trafford, winning 6-2 thanks to doubles from Edinson Cavani and Bruno Fernandes to move in sight of the Europa League final.

Fourteen years after getting thrashed 7-1 in the Champions League quarterfinals, Roma imploded again at the home of the English team after leading 2-1 at halftime in the first leg of the semi-

Cavani scored two of United's five second-half goals, with Fernandes adding a penalty to his brilliantly taken first-half opener before Paul Pogba and substitute Mason Greenwood also netted.

United now look set to end their struggles in the semifinals of major competitions under Ole Gunnar Solskjaer, having lost at this stage on four occasions in the past 16 months alone — including to Sevilla in last season's Europa League.

The other semifinal is more finely poised, with Villarreal leading Arsenal 2-1 heading into next week's

Villarreal take lead

VILLARREAL (SPAIN): Unai Emery won the first battle against his former club as Villarreal defeated Arsenal 2-1 in the first leg of the Europa League semifinals. Wrestlers reach Sofia for Olympic qualifiers

NEW DELHI: A final chance to make the

Olympic cut at stake, India's wrestlers have finally landed in Sofia, Bulgaria for the World Qualifiers starting May 6 after missing an earlier scheduled flight because of the travel ban on the country. A group of 10 wrestlers were to leave for Sofia via Amsterdam Wednesday but their tickets were cancelled at the last minute by a Dutch airline. The Wrestling Federation of India (WFI) then swung into action and arranged for fresh flight tickets via Paris. The World Qualifiers will be held, May 6-9. India have so far earned qualification in six categories. They are three men's free-style wrestlers - Ravi Dahiya (57kg), Bajrang Punia (65kg) and Deepak Punia (86kg) and three women's wrestlers - Vinesh Phogat (53kg), Anshu Malik (57kg) and Sonam Malik (62kg).

'Shooter Dadi' Chandro Tomar succumbs to COVID-19

NEW DELHI: Shooter Chandro Tomar, nicknamed 'Shooter Dadi', died Friday after battling COVID-19. She was 89. "Mera saath chhoot gaya, Chandro kaha chali gayi (She has left me, Chandro where have you gone?)," her sister-in-law Prakashi Tomar, who is also one of the oldest female sharp shooters in the world like Chandro, wrote on her Twitter page. Earlier this week, Tomar was admitted to a hospital after complaining of difficulty in breathing. Tests revealed she had contracted the highly contagious virus that is leading to over 3,000 deaths daily in the country. Hailing from the Baghpat village in Uttar Pradesh, Tomar was already 60-plus when she picked up the gun for the first time but went on to win many national competitions, even inspiring a Bollywood movie (Saand Ki Aankh) on her life.
