Aahar centres to remain open

Bhubaneswar: Revising its earlier order issued ahead of statewide lockdown, the state government Monday allowed Aahar Centres to remain open during the lockdown (May 5 to May 19). However, the facility is only for takeaways and dinein is strictly prohibited. The government provides cooked meal at ₹5 at Aahar Centres at all major hospitals and public places. Also, central government bodies like IIT, IIM and others were allowed to keep their hostels open.

Minor tribal rape victim dies

Baripada: A minor tribal rape victim of Mayurbhanj district died during treatment at SCB Medical College and Hospital, Cuttack Monday, police said. The 15-year-old girl, a student of Class IX, was missing from her house at Jhaliamara village of Mayurbhanj district since April 25 and she was found in serious condition on the roadside near Baghuasol village five days later, police said. She was immediately rushed to the PRM Medical College, Baripada where doctors said the girl was raped

O2 crunch kills 24 in Karna

Bangalore, May 3: In yet another hospital tragedy in the country in recent days, 24 patients, 23 of them Covidinfected, died in Karnataka's Chamarajanagar due to alleged oxygen shortage in the district hospital in the last 24 hours, with the government warning of stringent action against those found guilty.

The government ordered a probe into the matter and appointed senior IAS officer Shivayogi Kalasad as the inquiry officer. Following the incident, Chief Minister B S Yediyurappa convened a meeting with oxygen producers, where a number of decisions were taken to ensure supply of allocated quantity of oxygen to the state by the Centre.

Among these were to reduce the time taken to refill oxygen tankers, provide a green corridor for faster commuting of oxygen tankers and avoid unnecessary delay at toll gates. Utilising the service of the LPG tanker tanker drivers in case of emergency was also another important decision.

Health Minister Dr K Sudhakar maintained that only three people had died due of oxygen shortage and not 24 as reported, though he stressed that the probe would reveal the truth. The incident evoked a sharp response from the Congress, with party leader Rahul Gandhi wondering "how much more suf-

fering before the 'system' wakes up. In heart-breaking episodes preceding today's incident in the country, a fire at a mall in Mumbai housing a Coviddesignated hospital in March left nine, including those on ventilators, dead, while 22 COVID-19 patients who were either on ventilator or oxygen support, suffocated to death when their oxygen supply stopped suddenly due to a malfunction in the main storage at a civic hospital in Nashik

Similarly, 15 coronavirus patients died after a fire broke out at the Intensive Care Unit of a private hospital in Palghar district, also in Maharashtra in April. Further, 12 COVID-19 patients, including the HoD of the gastroenterology department of Batra Hospital in Delhi died allegedly due to oxygen shortage Saturday. A glitch in oxygen supply in Vizianagaram in Andhra Pradesh resulted in three deaths last week.

At Chamarajanagar, a pall of gloom descended on the district hospital as the grieving kin of the deceased gathered after hearing the news. Family members of the dead also staged a demonstration at the hospital and alleged

there was shortage of oxygen and raised slogans. Speaking to reporters in Chamarajanagar, Sudhakar said 123 COVID patients were admitted to the hospital. "Of these, 14 are on ventilator, 36 are on Non Invasive Ventilator, 58 were on High Blow Oxygen, 29 are on normal oxygen (Up to 10 litres per minute)." According to Sudhakar, 14 people, all of whom had been undergoing treatment for the past 14 to 18 days, died due to COVID from Sunday 7 am to 12 midnight. Their condition had worsened and they died naturally due to the disease he added

"Between 12 midnight to 3 am, three people died. From 3 am to 7 am, seven people died. So three people died due to shortage of oxygen, according to the district authorities, our health department officials and doctors," he told reporters. He said 23 people died in the district hospital and one at Kamagere village in the past 24 hours. Chamarajanagar district in-charge Minister S Suresh Kumar said he has ordered a death audit report from the district administration into the incident.

He, however, maintained that all the deaths did not occur due to oxygen shortage. It's not appropriate to say that all the 24 deaths were due to oxygen shortage. These deaths occurred from Sunday morning to this morning.

New Delhi, May 3: The AIIMS chief Monday warned against rushing for CT scan in cases of mild COVID-19, saying it has side effects and can end up doing more harm than good.

Stressing that there is no need for doing CT scans in mild COVID cases, AIIMS Director Dr Randeep Guleria said that many people are opting for the test the moment they find out they are positive for COVID-19 and added that misuse of CT scans and biomarkers may cause damage.

"One CT scan is equivalent to 300 to 400 chest x-rays. According to data, repeated CT scans in younger age groups increase the risk of cancer in later life. Exposing yourself to radiation again and again may cause damage. So, there is no point in doing CT scan in mild COVID-19 if the oxygen saturation is normal," Guleria said.



Even in mild illness and ac-

cording to a study, even in asymptomatic cases, a CT scan may show patches which go away on their own without treatment, he said. He advised that CT scans should be done in cases of moderate disease, when hospitalised. "And if there is a doubt, one should opt for a chest x-ray," he said.

He said that several blood tests for biomarkers are also not needed in mild illness or in home isolation if the oxygen saturation is fine, fever is not high and there are no other symptoms. He said that clinical management norms are clearthat people with mild illness need no medicine.

Won't demoralise HCs by asking them not to question: SC

THE APEX COURT SAID IT CAN'T ALSO RESTRAIN MEDIA FROM REPORTING AS IT IS IN PUBLIC INTEREST

New Delhi, May 3; Batting for "free flow of dialogue" in courts, the Supreme Court Monday said it would neither restrain the media from reporting oral observations during proceedings in public interest, nor demoralise high courts - "vital pillars of democracy" - by asking them to refrain from raising questions.

The apex court said however that it's order would take into account Election Commission's submission that "wanton charges" levelled against it by the Madras High Court were unwarranted and would try to strike a balance between two Constitutional bodies.

It termed as "too far-fetched" the poll panel's plea of restraining media from reporting remarks made in court

proceedings. A bench of Justices DY Chandrachud and MR Shah reserved its order on the EC appeal against the Madras High Court's "critical" remarks holding it responsible for surge in COVID-19 cases in the country and fastening responsibility on its officials with the murder charge.

It assured the poll panel that the high court's remarks were not meant to 'run down" a constitutional body but may have been made "momentarily" in the flow of discussions and that's why it was not in the judicial order. "Election Commission is a seasoned constitutional body, entrusted with the responsibility to ensure free and fair election in the country. It should not be rattled by the observations made.

'We cannot say in today's time the media will not report the discussions taking place in the court as it is



also in public interest. The discussions that take place in courts are also important as is the order. Therefore, unfolding of the process in the court of law is in public interest," the bench said. It said that the media is a "powerful watchdog" of unfolding of the process in court of law and "we cannot object to that reporting by media".

Justice Chandrachud said that judges ask questions to elicit response from lawyers and it does not mean that the court is against that person or body. "We have an Indian pattern of arguments in our courts. It's not a monologue that one person will speak and then judges will

speak. We have discussions here and there is an aspect of application of mind," the bench said.

Senior advocate Rakesh Dwivedi, appearing for the poll panel said that it is not objecting to the discussions and observations made by the high courts but it has to be in the context of matter in hand and there should not be any off-thecuff remarks.

The bench said: "Some observations are made in larger public interest. Sometimes it is anguish and sometimes they are made to make a person do the work, he is required to do...Some judges are reticent and some judges are verbose. Justice Chandrachud said that what he is saying is not to belittle the poll panel and it should not be taken in that context.

Covid handling not our prerogative, EC tells SC

NEW DELHI: The Election Commission, rattled over the strong high court observations related to conducting of just concluded Assembly elections, told the Supreme Court Monday that COVID-19 management was not its prerogative and it does not run the governance of the state. A bench of Justices DY Chandrachud and MR Shah was told by senior advocate Rakesh Dwivedi, appearing for the EC, that remarks of murder charges made by the Madras High Court against the constitutional body were unwarranted and such conclusive remarks should not have been made

without hearing the poll panel.

Speaking to **Orissa POST**, an employee of a liquor shop at Patia revealed that the shop recorded brisk business due to huge footfall of customers Monday. He, however, denied selling more than two bottles of wine per customer.

Customers at another liquor shop at CRP square were seen carrying huge quantities of liquor bottles in large plastic bags.

Madhusudan Jena, one of the customers, who works for a contractor was spotted carrying liquor worth around ₹15,000. Jena said that he has been keeping the stock for 14 days as the officials including engineers working at construction sites will demand this every alternate day.

Meanwhile, sources also revealed that many are buying liquor in bulk with a view to selling it in black market at a higher price during the lockdown.

It was observed that distancing norms were thrown to the winds at a liquor shop in Patia even though police were present over there.

BHUBANESWAR: A petition was lodged with National Human Rights Commission (NHRC) Monday seeking Rs 15 lakh aid to the relatives of a minor girl of Mayurbhanj who died after allegedly being sexually abused by a youth for five days. Sources claimed that the minor succumbed to injuries Monday while undergoing treatment at SCBMCH in Cuttack. Rights activist Himanshu Sekhar Nayak moved the NHRC urging the latter to direct the state Chief Secretary to pay compensation of Rs 15 lakh to the family members of the victim. The NHRC has also been requested to instruct the Mayurbhanj SP to take stringent action against the culprit as well as the police officials of Chandua PS who did not pay any heed to the missing complaint filed by victim's parents. Notably, the victim's family had lodged a complaint with the police after they found the girl missing April 25. However, police reportedly took no action to trace the minor.

MLU will be a model institution, says Kamaljeet Singh

Madhusudan Law College, one of the oldest law institutes in Odisha and India, was officially upgraded to the status of a university April 28. **Professor Dr Kamaljeet** Singh has assumed office as the first Vice-Chancellor of Madhusudan Law University (MLU). Singh, who has served as Member, Himachal Pradesh Private Educational Institutions Regulatory Commission, opens up in an

interview. Excerpts...

- What would be your first reaction as the VC of a new varsity (MLU)?
 - A VC has nothing much to do after joining an already established university. On the other hand, it is no less than a challenge to be the VC of a new university. It is an opportunity for me and I will utilise my foresight to establish the institute as a model university.
- How would you manage regular teaching and exam
 - processes? MLU has started operations April 28, 2021. We are preparing a syllabus for the students who will take admissions to the law university. MLU's syllabus, admission and examination processes will be out of the box.
- How do you think the journey would be from a teacher to an administrator?

I have more than 27 years of teaching experience. Moreover, I have worked in several positions at 17 universities and 277 colleges. Hence, I have an exposure to a host of areas. I believe that this experience would definitely help me further.

What according to you is the most challenging task in varsity management?

Managing a varsity is full of challenges. From admissions to hosting classes, challenges are everywhere. It is more, especially, during the pandemic as we are unable to host physical classes. Our efficacy, however, improves only with challenges.

What are your plans for the university's development?

There are three key parts of a varsity-students, faculty and non-teaching staffers. We believe that development of the university is directly proportional to the development of the three. As students play a key role in an educational system, our focus would be to offer state-of-the-art classroom, library and infrastructure to them.

How you think MLU is going



to create an identity in national and international levels?

- We will try focussing on this once the university starts functioning in a full-fledged manner. We will sign agreements with national and international universities apart from starting the student-teacher exchange programmes.
- Can we expect a competition between National Law **University and MLU?**
- National Law University (NLU) and MLU are totally different. While NLU has only 15-20 per cent students from Odisha, MLU will have 100 per cent Odisha students. We don't have any competition with NLU. I want to provide law educa-tion to common students in Odisha.

329 tonne O₂ carried through ECoR green corridor

Bhubaneswar, May 3: East Coast Railway (ECoR) has carried 329 tonne of Liquid Medical Oxygen (LMO) from different steel plants in its jurisdiction to states like Maharashtra, Telangana, Haryana and Delhi.

A total of 187 tonne LMO has already been transported from Tata Bhushan Siding in Angul, Similarly, 105 tonne of LMO has been transported from Rashtriya Ispat Nigam Limited, Visakhapatnam and 31 tonne of LMO from Jindal Steel, Angul

Different hospitals in various states are in dire need of oxygen. Getting requests from different state governments, Indian Railways has prepared itself to provide oxygen transportation services to all the states in need. Green corridor has been provided for faster movement of the Oxygen Express. Indian Railways is ensuring that the medical oxygen is made available to Covid-19 patients across the country through Oxygen Express.

The first Oxygen Express, loaded with 105 tonne of LMO in 7 tankers, left from Visakhapatnam. The second Oxygen Express was loaded with 32 tonne of LMO in two tankers from Tata Bhushan Steel Plant for

4,410 TONNE OXYGEN SENT TO 10 STATES

BHUBANESWAR: Standing in solidarity with states facing acute shortage of medical oxygen, the Odisha government has so far sent 241 tankers carrying 4,410.462 metric tonne (MT) of the life-saving gas to 10 states

The states which received the LMO are: Telangana, Andhra Pradesh, Tamil Nadu, Haryana, Maharashtra, Madhya Pradesh, Chhattisgarh, Delhi, Punjab and Uttar Pradesh.

Andhra Pradesh has received the highest quantity of 1,404.83 MT medical oxygen in 68 tankers, followed by Telangana (1,124.179 MT in 67 tankers), Madhya Pradesh (417.55 MT in 25 tankers), Haryana (528.782 MT in 27 tankers), Uttar Pradesh (362.42 MT in 20 tankers),

at the earliest.

Since liquid oxygen is a cryogenic cargo, utmost care has been taken about the maximum speed, maximum acceleration and maximum deceleration at which it can be carried.

Maharashtra (211.16 MT in 13 tankers), Chhattisgarh (182.931 MT in 12 tankers) and Tamil Nadu (116.22 MT in six tankers) in the last 11 days.

In addition to the above, two tankers with 33 MT of oxygen were also sent to Delhi and one tanker with 29.32 MT to Punjab.

These tankers were loaded at oxygen plants in four districts -Angul, Dhenkanal, Jajpur and Sundargarh (Rourkela).

The lion's share of medical oxy gen-1,844.412 MT-was sent in 98 tankers from Rourkela. A total of 1,314.53 MT, 458.02 MT and 793.5 MT of medical oxygen were sent in 65, 28 and 50 tankers from Jajpur, Angul and Dhenkanal districts respectively.

Earlier, ECoR General Manager Vidya Bhushan had instructed officials to take it as a challenge to supply oxygen at the earliest during the crisis. He had stressed upon proper lashing and packing of the tankers on the rake

Most importantly, the headmasters have been asked to provide the marks allotted to the students in the Class IX annual examinations and Class X tests.

4 years on, mega power project in Jajpur yet to be functional

Rasulpur, May 3: Although four years have passed since work on a mega electricity project was started under Kundapatna electricity section of this block in Jaipur district, it is yet to become operational or be of any use for thousands of consumers in the region, a report said.

The Kundapatna electricity section functions under Dharmasala electricity sub-division and Kuakhia electricity division. The project, a 33/11 KV electric sub-station, was started four years back with an aim to provide optimum and uninterrupted power supply to the consumers who have been reeling under frequent power cuts and low voltage problems. A plan outlay of Rs 6 crore was sanctioned for the project.

The project has crossed its deadline, which expired six months back, but works on the project is yet to be completed. As a result, over 10,000 consumers in eight panchayats of the

Residents have demanded to make the project functional without any further delay. While the project is getting delayed, power distribution

Reports said that residents in-

habiting eight panchayats under Kundapatna, Kaema and Kotpur feeders are yet to receive power supply from this sub-station. These panchayats are Routrapur under Rasulpur block, Kaema, Patpur, Mangalpur, Mirzapur, Kotpur, Deoda and Uttarpratap panchayats under Dharmasala block. Keeping the problems in view, the state government decided to set up a 33/11 KV power sub-station at Narsinghpur village under Kaema panchayat which would make power supply uninterrupted to the residents in these eight panchayts.

The project has two five MVA transformers and three feeders at Kundapatna, Kotpur and Nalakula. The implementing agency has completed work on the main structure and three feeders, while power connection has been established between one 33KV line and two 11KV lines

The transformers have been charged and preparations are un-

derway to connect the new lines with the old line. An electrical inspector from Odisha Electricity Regulatory Commission also visited the site and issued certificate to make the project operational, February 8, 2021. On April 13, the OERC also asked the implementing agency to cooperate with the distribution firm TPNODL in charging the line.

When contacted, Dhiren Kumar Behera, field engineer of L&T, said that work on the project has been completed and it will be handed over to TPNODL a fortnight after it is charged in May.

Chittarnjan Bhuyan, engineer of Kundapatna electricity section, said that non-completion of works is the reason behind the delay in making the project functional. He, however, hoped that the project will become functional by May.

A local resident, Prabhat kumar Prusty held both the implementing agency as well as the power distribution firm responsible for the delay.

Consider that on April 19, the Prime Minister announced a "liberalised and accelerated phase 3 strategy" of vaccination effective May 1 that brought in a publicprivate and states-Centre distinction in vaccination policy and rollouts. Within two days, on April 21, Serum Institute announced differential pricing for states and the private sector, keeping silent on prices for the Centre. On April 22, Dr. Krishna M. Ella, the Founder-Chairman and MD of Bharat Biotech reportedly said that he would "like to get the maximum price...to recover all costs...'

Poonawalla is known for his high-flying ways. Dr. Ella is known for his simple living. Both have now begun talking the language of profits. This is quite a change from the vision of the founder of Serum Institute, Dr. Cyrus Poonawalla, the current CEO's father, who has often stressed on affordability. Worse, the current pricing games are about a vaccine that has not vet been fully licensed, and is only approved for "restricted use" Because of this, these vaccines technically cannot be sold, at least not yet.

It may be futile to look to the vaccine makers for answers when the government of the day is mired in games and projections, not facts and solutions. It would have been possible to stand tall and write a story of grit and growth: to be af fordable and profitable. If the vaccine makers insisted on higher prices, compulsory licensing could have been invoked. We could have said when the time came, we stood together and tall. Alas, we were all pulled down.

Fugitive Blames Govt

Then India is fighting a grim battle against the second wave of Covid-19, here comes the shocking revelation from the fugitive Serum Institute of India (SII) chief Adar Poonawalla that the vaccine shortage will continue through July as the government didn't anticipate in January the second wave would hit the country. The complacency stemmed from the decline in caseload.

A report in Financial Times quoted him as claiming that the SII couldn't scale up its production of Covishield since there were no orders. The vaccine shortage will be felt even more acutely as the government has opened vaccination to all adults from May 1.

Poonawalla told the paper that he had been wrongly victimised. That apart, his decision to flee the country and seek refuge in the UK when the country has turned into hell with no one knowing whose turn it next is to be infected with the virus is a gross act against the country.

He has moved to the UK with his family for an "extended period" just in time before the foreign shores stopped entry of any Indian into the country.

If money launderers and frauds such as Vijay Mallya, Mehul Choksi, Nirav Modi, Lalit Modi et al had fled India to escape arrest for their economic offences, Poonawalla followed in their footsteps in a similar but much cleverer manner, blaming inability to withstand threats and pressures for supplying vaccines as he claimed in an interview to The Times, London. Interestingly, not only had the government paid him ₹3,000 crore recently, he had also been accorded 'Y' category security by the Central government just days before he scooted from India. But, that was obviously not enough for him.

People afflicted with Covid are dying on the streets, in cars and inside and outside hospitals for lack of oxygen, vaccines and immunity boosting medicines. He must have found India to be too unsafe for his family and used his resources and contacts to find safety in the UK leaving millions of his countrymen in the jaws of death. Many other superrich have already chosen foreign shores to escape the scourge wiping out the population daily by thousands. Unfortunately, those still supporting Poonawalla and his ilk forget conveniently that common Indians like you or me do not enjoy the privilege of moving out of India when we are under great stress. We are compelled to grin and bear all hardships, even be prepared to die with an infection that this man could have helped us overcome with his vaccines.

Poonawalla has chosen to flee the country when less than 2 per cent of the population has been vaccinated against Covid and there is mad rush for the jabs. Poonawalla said he made the move because there was a grave threat to his life in India. "I don't want to go back to that situation. Everything falls on my shoulders but I can't do it alone...I don't want to be in a situation where you are just trying to do your job, and just because you can't supply the needs of X, Y or Z you really don't want to guess what they are going to do," he stated in the interview. His words sound so pathetic especially when they came in the wake of allegations of ruling BJP politicians cornering stocks of vaccines and other medicines Covid-hit patients need.

If his words tell the truth, they tend to confirm the allegations about blackmarketing and hoarding of vaccines. The alleged threats are likely since the SII's Covishield is the more common vaccine in the country and Poonawalla has had to balance international contracts and domestic commitments in the past two months

Earlier this month, the government had also given a "stressed" Poonawalla an advance loan of ₹3,000 crore to ramp up production. According to some, this amount was too little too late. There has been widespread criticism of the Centre for monopolising procurement and distribution of the two vaccines - Covishield and Covaxin. When the situation went out of control, the Centre tried to find a scapegoat in the state governments and passed the blame for the collapse of health care system to save the people from the pandemic to the states. It also 'liberalised' its vaccine policy in a cynical manner allowing SII to sell Covishield directly to the states at a premium of ₹300 per dose as against the central government price of ₹150. With this policy, Poonawalla can sell half of his stock directly to the states and private hospitals, which has triggered a scramble for an already scarce vaccine supply. If his claim of undue pressure is to be believed, the reason for that is the Centre's confusing purchase policy which set the hawks on him.

The Centre failed to anticipate the grave crisis India would plunge into. The government kept lulling itself into complacency and dished out a false narrative that Prime Minster Narendra Modi's leadership was the best in the world and that India had "defeated Covid-19." Publicity has been the corner stone of this government's governance policy for which the country is now paying with the lives of its citizens. The SII CEO's admission betrays the smug confidence the government had. Instead of working on a war footing to fight the pandemic, they were relaxing with a misplaced self-confidence. "We'd struggled through 2020 to get everything ready. I thought I could put my feet up and take a vacation, but it's been the exact opposite. It's been chaotic," Poonawalla said. The brazenness of the government was shockingly in display first when it announced a 2-day 'Tika Utsav' celebration and again when it told the Supreme Court there is no shortage of oxygen when hospitals after hospitals are still sending SOS to governments for supply, people are dying without oxygen, cylinders are being sold at a premium in the open market and whatever foreign help is landing up, it is being immediately gobbled up by the central government.

Graham Greene, the celebrated English writer, compared him with RK Narayan, the first Indian fiction and embrace the philosophy of Sri writer in English to catch the global eye, with 'perhaps an added mys-

Aurobindo. He moved to Pondicherry in 1963. Marx disappointed him, spiritualism spurred his inner self and literature catapulted him, thereafter.

He was against sectarian secularism and exhorted his fellowmen to imbibe the true spirit of secularism. He recalls how in a get together for celebrating Sahitya Akademi award to Kalindi Charan Panigrahi in 1968, Sahid Zahir, the poet sang the glory of Krishna. For him the myth of Krishna was not the monopoly of Hindus but an inheritance of all Indians. Secular Hindus for him must try to broaden the outlook of non-Hindu brothers and sisters. Secular intellectuals should also divert their zeal to lift the orthodox Hindu society from the pit of casteism. He wrote that Ayurveda cannot be shunned by non-Hindus, just as Unani cannot be dismissed by Hindus just because the medieval Muslim physician brought the systems from

Village and rural culture of Odisha are the central tools of Das' writing. Lack of respect for rural grace along with the inability to see the consequences of certain kinds of development activities often appear in his story. He is like Indian Chekhov in his awareness of human miserv and ironies of life and in the art of exposing all that is vulgar, shameful and pitiable. A master of spinning of yarn, the reader seems to watch leisurely through a corridor and ante chamber like the merry pilgrims of Chaucer ambling their way to Canterbury. His stories contain messages which are not didactic but very subtle. While he presents predicament in his stories, his world is not dark and bleak like Kafka. His writing is also refreshingly free from horror, sex and violence as he strongly believed that negative impulses can be transcended by a feeling of love, sympathy and fellow feeling.

Manoj Das wrote a number of delectable edits, commentating on a number of social issues. On the centenary year of Jallianwala Bagh he writes, that no one can undo history but a British apology would have been symbolic "of collapse sympathy mingled harmoniously in cartoons, prompting Nehru to say: Do not spare me Shankar. The punch was closed in 1998.

Quest for Indianness has remained the most central concern of his artistic endeavour. He depicted transition of rural Odisha from feudalism to capitalism. He was sympathetic towards struggle that females had to undergo in patriarchal social setup of India. Lakshmi's Adventure is a heartrending story of a poor mother who cannot afford to buy a frock for her daughters. Novella Cyclones is a critique of environmental degradation of eco-friendly villages where government officials and greedy corporate join hands to devastate environment. Manoj Das was not merely Vishnu Sharma of Odisha, peddling mythology and mystique, but was a humanist par excellence. He was disillusioned with Marxism but his writing persistently carried his passionate plea for socio-economic and gender justice. Sir, In Assam, Kerala and Tamil Nadu, exit polls had made it amply clear as to what was in store. Cult politics set to return in TN with Stalin's win

Cult politics had subsided after the passing away of M Karunanidhi and J Javalalithaa

Chennai, May 3: With the DMK winning Tamil Nadu Assembly elections after crushing the AIADMK-led front, and MK Stalin set to become the Chief Minister, the cult politics, which had subsided after the passing away of M Karunanidhi and J Jayalalithaa, may as well return.

After MG Ramachandran, a matinee idol and superstar of Tamil Nadu entered the state politics, the cadres and sympathisers found in him a new messiah. He was adored and worshipped just like he was in the movies and there were jokes going round in Tamil Nadu that 'if MGR was found falling down during a fight scene in a Tamil movie, the spectators would throw knives at the screen so that MGR could use them and win the fight'. While this may be a joke, the point of adoring MGR as a Tamil icon and saviour of Tamil Nadu was clear. When MGR split the DMK and formed his own party, the AIADMK in 1972, the fans followed him and he won the elections with a comfortable majority.

M. Shivakumar, a political analyst and a former journalist with a Tamil newspaper of Madurai told IANS "While Periyarr and Annadurai gave the ideological moorings to the Dravidian politics in Tamil Nadu, MGR raised it to a cult status and he was adored and worshipped across the spectrum and his movie fans moved on with him as his political fans and there started the

cult worship in Tamil politics." Karunandihi, one of the best lvricists and writers of Tamil Nadu, had a special gift of the gab

and his oratory skills had kept the audience spellbound. He was also worshipped and adored within and outside the Dravidian politics even though the ideology was rationalism.

MGR had carefully picked Jayalalithaa, his one-time pair in filmdom as his political successor. But after his passing away, Jaya was kicked out of the party and even from the funeral procession of her mentor. However, Jaya bounced back and became a powerful Chief Minister with a huge fan following. She, as Chief Minister took the cult politics and image of invincibility to a higher level and even ministers and senior party functionaries were seen prostrating at her feet in public domain.

After the passing away of Jayalalithaa and Karunanidhi, the cult politics of Tamil Nadu had taken a backseat and both Palaniswami and Panneerselvam were ordinary leaders who were

accessible to the general public, bureaucracy and party office bearers. However, after the DMK captured power with a sizeable majority and MK Stalin set to become the Chief Minister, the politics of cult worship will find an entry into the political firmament of Tamil Nadu as he has the aura of the political dynasty of Karunanidhi

which is being worshipped by the cadres and leaders of the DMK. C. Rajeev of the Centre for Policy and Development Studies, a think tank based out of Chennai while speaking to IANS said, "With Stalin coming to power, the DMK cadres and leaders will commence the worship culture again which will ultimately lead to cult worship. If Stalin does not fall into this trap and stick to his business of administering the state, there can be a respite but the culture of this politics is not easy to be erased and

there is every likelihood that cult politics will continue in the state.'



New Delhi, May 3: The CBI has reg istered an FIR against former Kerala police officials for allegedly framing space scientist Nambi Narayanan on false charges in the 1994 ISRO espionage case, officials said Monday.

The CBI has officially refused to comment on the names of the accused in the FIR and the specific charges, but sources have said several former officials of the Kerala police have been named.

The Supreme Court, April 15, directed the CBI to conduct further investigation into the allegations of the framing of Narayanan on false charges by the police, based on the findings of a three-member committee under retired apex court judge Justice DK Jain.

The court had also ordered that the findings of the committee should not be published.

"On the basis of the report, the Supreme Court directed the CBI to proceed in the matter in accordance with law, being a court-directed enquiry," CBI Spokesperson Joshi said.

Accordingly, the CBI has registered a case, he added. Narayanan (79), who was working at ISRO's Liquid Propulsion Systems Centre (LPSC), was absolved of the espionage charges following the CBI probe. He had approached the Supreme Court seeking action against Kerala police officials.

Naravanan, the then director of the cryogenic project at the Indian Space Research Organisation (ISRO), along with the then ISRO deputy director D Sasikumaran, were arrested by the Kerala police in the 1994 case pertaining to the alleged selling of secret documents to Pakistan through a Maldivian woman, Rasheeda.

The police registered two cases at Thiruvananthapuram's Vanchivoor police station in October and November of 1994 over stay beyond visa limits and espionage re-

It accepted Narayanan's plea that the authorities, who were responsible for causing such a "harrowing effect" on his mind, should face 'legal consequences".

The home ministry constituted the three-member committee under Justice Jain, which submitted its report to the apex court after nearly wo-and-a-half years of investigation.

April 5 this year, the Centre moved the top court seeking an urgent hearing and consideration of the panel's report. After going through the report, the court ordered it to be kept in a sealed cover and not to be published.

It asked the CBI to take the findings of the report as part of its preliminary investigation and directed the agency to submit its report to it within three months.

Party woman leader Dr C Swaraswathi defeated DMK candidate, Subbulakshmi Jagadeeshan by a margin of 1,244 votes. Dr. Saraswathi is a medical doctor who has been in the forefront of several social activists in the constituency for long.

Palaniswami's epic fight slows down DMK juggernaut

IF NOT FOR PALANISWAMI, IT IS HARD TO GUESS IF **THE AIADMK WOULD HAVE BEEN ABLE TO GARNER 33.3 % VOTE SHARE AS AGAINST THE** DMK'S 37.7 %

Chennai, May 3: Undoubtedly, top AIADMK leader and outgoing Chief Minister K Palaniswami put up an epic fight against the DMK which fetched his party steered alliance 75 seats, nearly one third of the 234 seats in the Tamil Nadu Assembly and despite a decade of anti-incumbency. Beset by a resurgent DMK that

was firing on all cylinders to capture power and a renewed challenge from TTV Dhinakaran's camp, Palaniswami kept his poise and focused on polls and governance matters in view of the COVID-19 pandemic. If not for Palaniswami, it is hard to guess if the AIADMK would have been able to garner 33.3 per cent vote share as against the DMK's 37.7 per cent. AIADMK won 66 seats, its allies PMK and BJP five and four seats respectively and proved yet again that the western region was its fortress. The DMK front bagged 159 constituencies.

The fresh trouble from Dhinakaran camp surfaced when his aunt VK Sasikala was released from prison just ahead of polls in January and it was another matter that she eventually announced staying away from politics.

Several of Palaniswami's decisions like the 7.5 per cent reservation for government school students



in medical admissions who clear NEET, the Rs 12,000 crore plus farm loan waiver benefitting 16.43 lakh farmers and declaring the Cauvery delta region as protected agricultural zone were seen as politically astute and measures that helped slow down the DMK juggernaut. Beginning December last.

Palaniswami criss-crossed the state. taking on DMK and questioning its track record while in seat of power: Betting on populism, a shared value of Dravidian politics, Palaniswami assured three phase power (24x7) for farmers and took pride in rejuvenation of over 5,500 waterbodies under Kudimaramathu scheme' across the state.

Carefully, he focused on his identity as a farmer and put his best foot forward to convince them that their interests would be best protected by him, one of them. He tagged projects including the Cauvery-Godavari link proposal, Athikadavu Avinashi Scheme, new check dams and accused DMK chief M K Stalin of "entering into an MoU for hydrocarbon exploration" in Cauvery delta region whereas his government banned such initiatives by declaring it a protected zone. The 'good governance' of Amma's government established the rights of Tamil Nadu in Cauvery and Mullaiperiyar issues and it should continue, he appealed to people at his rallies.

Several welfare measures also contributed in preventing a complete rout for AIADMK and such schemes were often highlighted by Palaniswami. It includes Rs 2,500 cash assistance as part of 'Pongal' hamper to 2.07 crore ration card holders, free textbooks, bicycles, laptops and uniform for government school students.

New Delhi, May 3: With states scrambling to secure vaccines, Adar Poonawalla, whose firm is the main supplier of COVID vaccine in India, Monday said his firm cannot ramp up production overnight as vaccine making is a specialised process. Serum Institute of India (SII)

has orders from the Government of India to supply 11 crore more doses over the next few months on top of 15 crore already supplied, he said in a statement. Another 11 crore doses will be sup-

plied to states and private hospitals in the next few months, he said. He, however, did not give a timeline for supplying the vaccines.

Pune-based SII can produce 6-7

crore doses a month and is reportedly planning to ramp up production to 10 crore by July

Facing the world's fastest-growing coronavirus outbreak, India has seen a near collapse of its health care system in several parts as hospitals ran out of oxygen and did not have enough beds to admit new patients.

To deal with the crisis, the government has among other measures, opened up vaccination for all above 18 years. But the procurement of vaccines for those between 18 and 44 years has been left to states and private hospitals.

This has led to state after state rushing to SII, which can meet only a small part of the demand.

Poonawalla, who had last week



cited unprecedented pressure and aggression for him and his family temporarily leaving the country for the UK, said everyone wants the vaccine to be available in the quickest possible time.

This is our endeavour too and we are making every effort to achieve that, he said. We shall work even harder and strengthen India's fight against Covid-19

Banerjee made public a purported SMS from the Nandigram Returning Officer to a CEO official, claiming that he had expressed fear that if he ordered recounting he would face serious consequences, and may even have to die by suicide.

"Why was the server down for four hours? We are willing to accept people's mandate but if the result of one place has anomalies, there may be something beyond what appears. We have to seek the truth,' she added.

India's lone fossil of world's oldest animal found in Bhimbetka

DICKINSONIA IS AN EXTINCT GENUS OF BASAL ANIMAL THAT LIVED DURING THE LATE EDIACARAN PERIOD IN A GEOGRAPHICAL AREA NOW DIVIDED INTO AUSTRALIA, CHINA, INDIA, RUSSIA AND UKRAINE

New Delhi, May 3: Researchers have discovered fossils of one of the Earth's earliest known multicellular animals -- the 550-millionyear-old Dickinsonia -- on the roof of the Bhimbetka rock shelters in

Madhya Pradesh Dickinsonia is an extinct genus of basal animal that lived during the late Ediacaran period in a geographical area now divided into Australia, China, India, Russia and

Ukraine. The individual Dickinsonia typically resembles a bilaterally symmetrical ribbed oval. Its fossils are known only in the form of imprints and casts in sandstone beds.

The specimens found in

Bhimbetka are around 17 inches long, where as the ones that have been found in other parts of the world exceeded four feet in length, the researchers from Geological Society of India (GSI), Nagpur, Maharashtra, noted.

The finding, published in the journal Gondwana Research, confirms close proximity of Australia and India, according to the researchers

"Dickinsonia fossil was first discovered in 1947 in Flinders Ranges of South Australia. Its fossils have also been discovered in Ukraine, Russia and China," Ranjit Khangar

Director & Coordinator, GSI, told PTI. "Bhimbetka Rock Shelters, a UN-ESCO World Heritage Site for Paleolithic and Mesolithic cave art,



near Bhopal, is once again highlighted worldwide due to the first discovery of oldest animal fossil, Dickinsonia from India," Khangar said. The new fossils were discovered on the last day of 36th

International Geological Congress 2020 field trip conducted by GSI in March last year.

However, it took the team almost a year to publish the findings.

Other teammates involved in the

study were from the University of Oregon in the US, National Operations Center, Bureau of Land Management, Geospatial Section, US, and the University of Witwatersrand in South Africa.

'Dickinsonia is the earliest Ediacaran multicellular animal life yet found -- predating explosion of life in Cambrian Period (around



541 million years) in geological time scale," Merajuddin Khan, senior geologist and member of GSI, Nagpur, noted.

"Palaeobiologists believe that these earliest living creatures were used to live in shallow warm seas, as early as 570 million years ago, and are representative of earliest complex life form in animal kingdom,' Khan told PTI.

As the fossil is out of reach, multiple digital images of the site were processed using three-dimensional (3D) modelling, the researchers said.

The geological condition and occurrences of Dickinsonia were compared with fossils reported from-(South Australia before arriving at the final conclusion, they said.

New Delhi, May 3: The Centre Monday said medical oxygen being given to COVID-19 patients, especially in hospitals, should be used "judiciously" and claimed that there was "shortage" of the lifegiving gas in the country. At a routine briefing on steps

taken by the government to battle the COVID-19 crisis, Additional Secretary, Ministry of Home Affairs (MHA) Piyush Goyal told reporters that multiple efforts were being undertaken to enhance production and quickly transport oxygen to the hospitals and patients.

"It is very important for all the hospitals that they ensure judicious use of oxygen as per the guidelines issued in this context by the Union Health Ministry. Many efforts are being undertaken in this context and we are getting positive results also." "We need to continuously monitor this so that very judicious use of oxygen is undernow

taken," Goyal said.

He appealed to the citizens to not get "jittery about the lack of oxygen in the country." "Oxygen is

Goyal was speaking to reporters in the presence of Joint Secretary, Union Health Ministry Lav Agarwal and AIIMS Director Dr Randeep Guleria. The country is grappling with a raging second wave of the pandemic with lakhs of patients and their family members anxiously scouring for oxygen beds in hospitals, cylinders, medicines and

Goyal also sought the support of citizens in ensuring that no "hoarding or black marketing" of oxygen cylinders takes place so that these are made available to patients who are gasping for breath

due to the coronavirus infection. The officer said the production of medical oxygen has increased in the country as he cited data to say that while on August 1 last year, the total production was 5,700 metric tonnes, it is 9,000 metric tonnes

"This is 125 per cent of daily production capacity (of medical oxygen)," he said. He reiterated that despite increase in the demand of medical oxygen for patients due to rapid surge in COVID-19 infection. the country had "adequate" oxygen and the government was also importing it from abroad for future needs.

The officer said both traditional and non-traditional avenues are being explored and enhanced for production of liquid oxygen. He said a group of senior officials from the Centre, various states, Union Territories, manufacturers and other stakeholders were making a daily assessment of the oxygen de mand in the country and oxygen is being allocated to states as part of a "dynamic process" being undertaken everyday.

Goyal said the oxygen demand of no state was being "ignored" and the Centre has deployed Indian Air Force (IAF) heavylift aircrafts to transport empty oxygen tankers and the railways to ferry filled oxygen tanks from the place of production to their destinations. He said major medical oxygen production facilities are based in the eastern part of the country while the maximum demand at present is in the central and northern region.

BSc or GNM qualified nurses may be utilised in full-time Covid nursing duties under the supervision of senior doctors and nurses, it said. The individuals providing services in Covid management will be given priority in forthcoming regular government recruitments after they complete minimum of 100 days of Covid duty the statement said.

Mr Sonowal and his powerful ministerial colleague Himanta Biswa Sarma are being seen as the two most obvious contenders for the top job.

BJP sources said internal confabulation is on in the party, and the its parliamentary board may soon name central observers to preside over the meeting of its newlyelected party MLAs in Guwahati where they will pick their leader.

Central observers generally convey the choice of the party top brass to the state leadership which in turn is endorsed by the MLAs. The ruling BJP-led NDA has retained its grip on Assam, bagging



74 of the 126 assembly constituencies that went to polls, while the opposition Congress-led grand alliance managed to clinch just 50 seats.

The BJP alone won 60 constituencies, the same as in 2016.

The BJP's decision to not name its chief ministerial candidate during the polls had fuelled speculation about the likely choice in the eventuality of the party retaining power. While Mr Sonowal, who hails

from upper Assam, a BJP stronghold, is seen as a soft-spoken leader with a clean image, Mr Sarma enjoys the image of an efficient administrator with sharp political instincts

New Delhi, May 3: A team of Israeli researchers have identified a link between coronavirus and stroke victims, especially in healthy young people, media reports said.

The global study led by researchers at the Hebrew University of Jerusalem involved at least 136 medical centers in 32 countries, i24news.tv reported.

Of the 380 patients who suffered stroke while suffering from Covid-19, nearly 38 per cent were asymptomatic to the coronavirus, and had no recognisable symptoms from the virus such as cough or fever. The diagnosis came only after they were admitted to the hospital for stroke. The study, published in the journal 'Stroke', led researchers to fear that the virus may increase the risk of stroke,



even in people without chronic conditions like high blood pressure or diabetes. Of the 432 patients, 323 had acute ischemic stroke, 91 had intracranial hemorrhage, and 18 had cerebral venous or sinus thrombosis.

The younger patients with ischemic strokes had no known existence of the types of aclassical' risk factors that contribute to the onset of stroke such as vascular disease, high blood pressure, diabetes or smoking, the report said. "This study further strengthened our understanding of the link between coronavirus and stroke in young patients," said Ronen Leker, a professor from the varsity.

"In the future, we recommend performing PCR tests routinely on all young stroke patients, especially those who have had a stroke, especially in those with no known pathologies," Leker added.

US denies Iran claims of prisoner deal

Washington, May 3: The United States and Iran are in active talks over the release of prisoners, a person familiar with the discussions said Sunday as Washington denied a report by Iranian state-run television that deals had been struck.

Prisoner swaps between the US and Iran are not uncommon and both countries in recent years have routinely sought the release of detainees. But any movement between the two countries is particularly sensitive as the Biden administration looks to restart nuclear talks. A 2015 atomic accord between the nations included prisoner exchanges. The issue burst into public view

with a report in Iran of a deal for the Islamic Republic to release US and British prisoners in exchange for Tehran receiving billions of dollars. US officials immediately denied the report, though a person with knowledge of the discussions who was not authorised to discuss them publicly said talks are active, with messages passed between intermediaries.

It wasn't immediately clear if the report represented a move by the hard-liners running the Iranian broadcaster to disrupt negotiations with the West amid talks in Vienna on Tehran's tattered nuclear deal.



Even after an initial American denial, an anchorwoman on Iranian state TV still repeated the announcement. "Some sources say four Iranian prisoners are to be released and \$7 billion are to be received by Iran in exchange for releasing four American spies," the

anchorwoman said. She described the claimed deal as coming due to congressional pressure on President Joe Biden and "his urgent need to show progress made in the Iran case."

But Iran's ambassador to the United Nations, Majid Takht-e Ravanchi, later denied the report of the prisoner swap, saying that it's "not confirmed," according to the Telegram channel of state-run IRNA news agency. "Iran has always emphasised the comprehen-

State Department spokesman Ned Price immediately denied the Iranian state TV report. "Reports that a prisoner swap deal has been reached are not

true." Price said.

"As we have said, we always raise the cases of Americans detained or missing in Iran. We will not stop until we are able to reunite them with their families.

Biden's chief of staff Ron Klain told CBS' "Face the Nation" that "unfortunately, that report is untrue.

There is no agreement to release these four Americans." "We're working very hard to get them released,' Klain said. "We raise this with Iran and our interlocutors all the time, but so far there's no agreement.

Tehran holds four known Americans now in prison: Baquer and Siamak Namazi environmentalist Morad Tahbaz and Iranian-American businessman Emad Shargi. Iran long has been accused of holding those with Western ties prisoners to be later used as bargaining chips in negotiations.

Despite the American denials, there have been signs that a deal on prisoners may be in the works based on Iranian officials' remarks in recent weeks.

Although no formal proposal for a swap has yet been presented to officials in Washington, let alone been signed off on by the White House, the specificity of the reports from Iran suggested that working-level consideration of a deal is at least underway.

Russia turns to China to produce Sputnik shots

Russia has announced three deals totaling 260 million doses with Chinese vaccine companies in recent weeks

Taipei, May 3: Russia is turning to multiple Chinese firms to manufacture the Sputnik V coronavirus vaccine in an effort to speed up production as demand soars for its shot. Russia has announced three deals totaling 260 million doses with Chinese vaccine companies in recent weeks.

It's a decision that could mean quicker access to a shot for countries in Latin America, the Middle East, and Africa that have ordered Russia's vaccine, as the US and the European Union focus mainly on

domestic vaccination needs. Earlier criticism about Russia's vaccine have been largely quieted by data published in the British medical journal The Lancet that said large-scale testing showed it to be safe, with an efficacy rate of 91 per cent. Yet, experts have questioned

whether Russia can fulfill its pledge to countries across the world. While pledging hundreds of millions of doses, it has only delivered a fraction. Kremlin spokesman Dmitry Peskov has said demand for Sputnik V significantly exceeds Russia's



domestic production capacity.

To boost production, the Russian Direct Investment Fund, which bankrolled Sputnik V, has signed agreements with multiple drug makers in other countries, such as India, South Korea, Brazil, Serbia, Turkey, Italy and others. There are few indications, however, that manufacturers abroad, except for those in Belarus and Kazakhstan, have made any large amounts of the vaccine so far.

Airfinity, a London-based science analytics company, estimates Russia agreed to supply some 630 million doses of Sputnik V to over 100 countries, with only 11.5 million doses exported so far: RDIF declined to disclose how many doses are going to other countries. Through April 27, less than 27 million two-dose sets of Sputnik V have been produced in Russia.

At least 26 die as speed boat overturns in Bangladesh river

Dhaka, May 3: An overcrowded speedboat ferrying over 30 passengers and defying the COVID-19 restrictions capsized after hitting a stationary sand-laden cargo vessel in the Padma River Monday, leaving at least 26 people dead, a senior Bangladesh police officer said.

The accident occurred at the old Kanthalbari ferry terminal in Shibchar upazila of Madaripur at around 8 am. The boat, driven by an inexperienced driver, overturned in the Padma River in central Bangladesh while heading for Madaripur district from Munshiganj district. Rescuers have retrieved at least

26 bodies, police said.

"We have retrieved 26 bodies, rescued alive five others... But searches are underway for more as several speedboat pas ers are feared missing," said Ashigur Rahman, the police inspector of a nearby ferry terminal.

DARKNET CHILD PORN NETWORK WITH 400,000 MEMBERS BUSTED

Berlin, May 3: German police said Monday they had shut down "one of the biggest darknet child pornography platforms in the world" and arrested four of its members in a series of raids in mid-April.

The platform, named as "Boystown", had existed since 2019, counted over 400,000 members and was "set up for the worldwide exchange of child pornography", federal police said in a statement.

The darknet forum allowed users to communicate with others and share graphic image and video content which included "serious sexual abuse of toddlers", the



statement said.

Three men between the ages of 40 and 64 were arrested in seven raids in Germany, while a further suspect was detained in Paraguay on the request of German authorities. The suspect in Paraguay's Concepcion region, also a German citizen, is to be extradited back to Germany on the basis of an in-

ternational arrest warrant issued by a court in Frankfurt.

Three of the men are accused of having managed the platform as administrators, providing technical support and advice to members on how to avoid being discovered by the authorities, while another was "one of the platform's most active users", police said. Investigators added that the months-long, German-instigated operation had been coordinated by Europol and supported by law enforcement in the Netherlands, Sweden, the United States and Canada.

Both "Boystown" and other chat platforms were taken offline following the raids.

He said that they were informed the driver of the speedboat was an inexperienced underage boy.

Witnesses and survivors said the boat was carrying over 30 passengers and the vessel was transporting sand in the Padma River near the town of Shibchar of Madaripur," he said.

Divers from the local fire service station and river police rushed to the spot and joined the rescue operation, he added. All the deceased, one female and 25 males, were passengers of the speedboat, the Daily Star newspaper reported.

London, May 3: A commitment of \$15 billion to help women in developing countries access jobs and global targets to get girls into school will be the UK's focus for the G7 Foreign and Development Ministers meeting, which begins in London Monday

External Affairs Minister S Jaishankar arrived for the summit Monday afternoon local time and is expected to join the discussions with other guest nations invited by the UK, which holds 2021 presidency of the G7-which comprises Canada, France, Germany, Italy, Japan, US, UK and the European Union (EU) Alongside India, Australia, the

Republic of Korea. South Africa and the chair of the Association



of South East Asian Nations (ASEAN) have also been invited to the meeting as part of Britain's foreign policy focus on ties with the Indo-Pacific region.

"Ensuring girls get 12 years of quality education and women can work and earn an income are some of the smartest investments we can

make to change the world, transforming the fortunes not just of individuals, but whole communities and nations," said UK Foreign Secretary Dominic Raab.

"This year, as we build back better from the pandemic, the UK is putting girls' and women's rights at the heart of our G7 presidency,

uniting countries that share our values so we shape a better path ahead," he said.

The Foreign, Commonwealth and Development Office (FCDO) said the ministers will agree to invest \$15 billion in development finance over the next two years to help women in developing countries access jobs, build resilient businesses and respond to the devastating economic impacts of COVID-19.

The funding is aimed at the 2X Challenge, a partnership between G7 Development Finance Institutions [DFIs] launched in 2018. According to the UK government, it leverages funding from DFIs and

Multilateral Development Banks to provide finance to female-owned and staffed businesses or products or services that particularly benefit women, supporting female economic empowerment.

DFIs are funded primarily by national governments and invest in developing countries and emerging markets to create jobs, boost growth, and fight poverty.

The ministers will also sign up for new global targets to get 40 million more girls into school and 20 million more girls reading by the age of 10 in low and lower-middle-income countries by 2026.

"Educating girls is one of the smartest investments we can make to lift people out of poverty, grow 🔫 economies, save lives, and build back better from COVID-19. A child whose mother can read is 50 per cent more likely to live beyond the age of five years, twice as likely to attend school themselves – and 50 - (per cent more likely to be immunised," the FCDO said.

Bhubaneswar; May 3: Responding to the shortage of oxygen for treatment of Covid-19 affected people in the country, leading steelmaker Jindal Steel & Power Ltd (JSPL), has been supplying Liquid Medical Oxygen (LMO) from its 6 MTPA mega steel complex at Angul in Odisha, since April. Several hospitals across the country have received oxygen dispatched through tankers as per the government advice.

"JSPL has been always standing with the country and countrymen during calamities and emergencies and will continue to do so during the pandemic. For us, it is nation first. I am sure together we shall defeat Covid-19, JSPL's Chairman Jindal had stated few days before.

"We are improving our efficiency. The government is also ensuring the best way to tackle logistics on oxygen supply," he added in a Twitter message.

The company continually produces LMO at its oxygen plant within the steel complex at Angul and tankers are filled in round the clock. The tankers are being dispatched to several states that need medical oxygen like Andhra Pradesh, Telangana, Delhi-NCR, Madhya Pradesh and Maharashtra and several other states as per the advice of the government.

A dedicated team, under the direct supervision of JSPL's Chairman Naveen Jindal, is working day in and day out to ensure the timely despatch of oxygen as per the government's directive.

An Oxygen Express train run by the Indian Railways also carried LMO tankers to other states. Similarly two tankers airlifted from Maharashtra were also filled with LMO from JSPL Angul recently.

India's production rise at slowest rates in 8 months in April: PMI

New Delhi, May 3: India's manufacturing sector activity was largely flat in April, as rates of growth for new orders and output eased to eight-month lows amid the intensification of the Covid-19 crisis, a monthly survey said Monday.

The seasonally adjusted IHS Markit India Manufacturing Purchasing Managers' Index (PMI) was at 55.5 in April, little changed from March's reading of 55.4.

In PMI parlance, a print above 50 means expansion while a score below 50 denotes contraction.

"The PMI results for April showed a further slowdown in rates of growth for new orders and output, both of which eased to eight-month lows amid the intensification of the Covid-19 crisis." said Pollvanna De Lima. Economics Associate Director at IHS Markit.

Lima also noted that "the surge in Covid-19 cases could dampen demand further when firms' financials are already susceptible to the hurdle of rising global prices."

The daily Covid-19 cases in India showed a slight dip with 3,68,147 new coronavirus infections being reported in a day, taking the total tally of cases to 1,99,25,604, according to the Union Health Ministry data updated on Monday. "The headwinds facing manu-

New export orders increased for the eighth consecutive month in April and at the fastest rate since October 2020 The rise was associated with a pickup in international demand for Indian goods, the survey said.

AN EASY GUIDE TO YOUR MOTOR INSURANCE CLAIM

Our motor vehicles are an in-dispensable part of our lives which we are heavily dependent on

for our everyday routine life. Today in the wake of the pandemic, people are avoiding public transport and cab services as a safety measure, ever more increasing the dependency on personal vehicles.

If you own a vehicle most probably you have a comprehensive motor insurance cover or at least a third party cover which is mandatory as per law. Due to large number of people

buying personal vehicles, motor insurance has become one of the most sought after insurance product which also consequently witnesses high number of claims every year.

Most of us are caught off guard when we witness our first motor claim. The intent of this article is to help readers understand about motor insurance claims.

Types of claims

Motor insurance claims are typically classified into two categories Cashless Claims and Reimbursement claims.

Cashless Claims - Under cashless claims, you need not bear any upfront expenses in case of damage to your vehicle which further needs repairs. The insurer directly pays the expenses incurred for the repair to its network garage. You, the customer, has to only pay the depreciation and deductible when applicable. The percentage of depreciation varies according to the age and part of the car. For example, fibre glass part has 30% depreciation. So if this particular part is damaged and needs to be replaced, the insurer will pay 70% of the cost with the remaining 30% to be borne by the policyholder.

Reimbursement Claims - Under

reimbursement claims, in case of any damage to your vehicle, you can get it repaired at any garage. You will have to bear the cost of repair and will have to apply for reimbursement afterwards with the insurer. Make sure that you take all the repair receipts and bills from the workshop. Insurer will make the payment after validating the claim documents and bills.

There are three types of claims in motor insurance based on the incident:-

- Third party Liability
- Own damage
- Theft

Third Party (TP) - Third party is a mandatory cover by law in India. The purpose of TP is to provide coverage against legal liability claimed by a third party wherein they have suffered a damage or injury from your vehicle. TP section doesnot provide any cover to you or your vehicle. Under the TP section, a third

party, which has suffered injury, property damage or death arising out of your vehicle, can claim for compensation. In case of death or injury there is no limit capped on the compensation, the amount is to be decided by court of law.

Own damage (OD) - OD claims trigger when your vehicle is damaged due to an accident. The first step is to inform the police and vour insurer. You should not move vour vehicle from the accident scene without the consent of the police and insurer. Once you have the consent to remove the vehicle from the scene of the accident, vou can take the vehicle for restoration and the insurer will make the payment either on cashless or reimbursement basis.

Theft -In a situation where your vehicle has been stolen, you need to register an FIR with the police, inform the insurer and the RTO about the theft. You will be required to submit a copy of the FIR, driving license, vehicle registration certificate etc. to the insurer. The police will investigate the matter; however, if your vehicle is not traced within 90 days, the police will issue a no trace report. A no trace report is mandatory to settle the claim in case of theft. Once you submit the report along with required documents, insurer will start the process for claim settlement.

To conclude I will say, a smooth and hassle-free claim process is a big relief to customers. This can be a differentiator when you are evaluating your insurer. Drive safe, enjoy your ride and in case of an unfortunate accident, always reach out to your insurer!

New Delhi, May 3: A COVID-19 outbreak left the IPL and its organisers on tenterhooks as Varun Chakravarthy and Sandeep Warrier of Kolkata Knight Riders (KKR) tested positive for the dreaded virus. The development forced postponement of the team's game Monday evening against Royal Challengers Bangalore (RCB) in Ahmedabad. The match will be rescheduled some time later during the tournament, organisers said.

"Varun Chakaravarthy and Sandeep Warrier were found to be positive in the third round of testing in the last four days. All other team members have tested negative for COVID-19," the IPL organisers said in a press release Monday.

The situation took a turn for the worst with CSK bowling coach L Balaji testing positive twice Monday. He is a regular face in the CSK dugout and had interacted with

Leg-spinner Chakravarthy and pacer Warrier, both 30, have been isolated and the rest of the KKR contingent has returned negative reports for now.

'The medical team is in contin-

uous touch with the duo and is monitoring their health. Meanwhile, KKR have now moved towards a daily testing routine to identify any

other possible cases and treat them at the earliest," the IPL body said. KKR last played April 29 against Delhi Capitals in Ahmedabad. It is bound to trigger anxiety in the

league, which had been going along smoothly so far in a bio-secure bubble in front of empty stands.
"Now, the DC players (currently in Ahmedabad) will also have to be tested and every member of the team contingents that came in contact with Chakravarthy and Warrier will also be contact traced through the app watch that has been given

n to everyone," a BCCI source said. According to IPL's Standard Operating Procedure for COVID-19 management, any close contact of an infected person has to iso-

late for six days. To return to the event, the person has to get three negative tests on days one, three and six.

In a late night development Monday, KKR CEO and MD Venky Mysore said that both Chakravarthy and Warrier are doing 'fine' and the team are hopeful of returning to action for their next IPL game once the quarantine phase is over. "Difficult times, but I'm happy to report that both Varun and Sandeep are doing well," Mysore told host broadcasters 'Star Sports'.

"We have taken all the precautions that are necessary and have been advised by the medical teams of IPL and KKR. Sandeep, in particular, is doing fine. No temperature, no other symptoms, and he is feeling good. Varun is still a little under the weather, but better than Sunday and both of them are in good spirits," Mysore added.

PRESS TRUST OF INDIA

New Delhi, May 3: Players, especially overseas recruits, are feeling edgier following the emergence of two COVID-19 cases in the Kolkata Knight Riders camp Monday. However, the teams feel 'there is no going back' and the IPL should continue despite the ever-increasing threat of the raging pandemic. The positive results of Varun Chakravarthy and Sandeep Warrier have left everybody worried. Foreign cricketers, who were already anxious about getting home with travel restricted from India, are a more worried lot.

Australian pacer Pat Cummins incidentally is a member of the same team. "There's no suggestion at the moment of any charter flight," Hockley told Melbourne radio station 'SEN'. "We're working closely and talking closely with the Australian Cricketers' Association, with the players and with the BCCI to make sure everyone's okay," he added.

ANTONIO CONTE CONJURES UP SERIE A TITLE WIN FOR 'NERAZZURRI' Inter Milan end 11-year wait

Rome, May 3: Inter Milan claimed the Serie A title Sunday for the first time in 11 years to end Juventus' nine-year reign in Italy. Antonio Conte's side clinched their 19th 'Scudetto' after nearest rivals Atalanta drew 1-1 at Sassuolo to leave the 'Nerazzurri' 13 points clear with four games remaining.

Conte had started Juventus's record run, winning the first three titles in a winning streak that stretched from 2012 to 2020. The 51-year-old took over Inter in 2019 and lifted the trophy after finishing second last season. "Tm astonished," said Conte.

The club said they would not seek punishments for those fans who protested peacefully, including those outside the stadium.

"Many fans wanted to exercise their right to protest and express their opinion peacefully," Man U said in a statement. "However, some were intent on disrupting the team's preparation and the game itself, as evidenced by activity at the Lowry Hotel and at the stadium," the club added.

Man U officials said that the 'club have no desire to see peaceful protestors punished, but will work with the police to identify those involved in criminal activity'.

The first details of the investigation were released as United said speculation floated by the Manchester United Supporters' Trust that protestors were able to access the stadium through a gate left open by club staff was 'completely incorrect'. India slip 1 place in ODI rankings

Dubai, May 3: India retained their second place in the ICC Twenty20 team rankings but dropped a rung to third in the ODI chart following the annual update carried out Monday. India are trailing topranked England (277) by five rating points in the T20 team rankings. During this period, England

drew a three-match series against Pakistan 1-1, defeated Australia 2-1 and South Africa 3-0 before losing an away series to India by a 2-3 margin.

New Zealand have also gained in the annual T20I update, moving up from fifth to third after series wins over the West Indies, Pakistan, Australia and Bangladesh. Australia have moved the other way, down from third to fifth.

In the annual update of the ODI team rankings, India dropped a place to third behind Australia and new table-toppers New Zealand. The Kiwis have replaced reigning World Champions England as the No.1 ranked side in the ODI rankings.

New Zealand, who defeated Bangladesh 3-0 in their only ODI series in the past year, have advanced two slots after gaining three rating points to reach an aggregate of 121. Australia are second with 118 points while India and England are both on 115, with the former ahead on decimal points.
