
Mamata sworn in for 3rd term in WB

Kolkata: Trinamool Congress (TMC) supremo Mamata Banerjee was Wednesday sworn in as the chief minister of West Bengal for the third consecutive term. Immediately after assuming office, she shot off a letter to PM Narendra Modi demanding free vaccination for all and asking for 'transparency' in distribution of vaccines. She also said that her main priorities would be to contain Covid-19 as quickly as possible and end the political violence and book all those guilty in West Bengal.

SC strikes down Maratha quota law

New Delhi: The Supreme Court struck down Wednesday the Maharashtra law granting quota to Marathas in admissions and government jobs, terming it as 'unconstitutional'. It held there were no exceptional circumstances to breach the 50 per cent reservation cap set by the 1992 Mandal verdict. The top court also refused to refer the Mandal judgement to a larger bench for reconsideration, saying it has been upheld time and again by its various verdicts. Maharashtra Chief Minister Uddhav Thackeray termed the verdict as

Bhubaneswar. May 5: As the surge in Covid-19 cases continue in Odisha. there has been a huge rise in demand for oximeters. Panic-stricken people now want to keep oximeters handy to monitor the oxygen saturation level in their bodies. However, suddenly the device has become a scarce commodity in the Odisha capital. People are running to every nook and corner in search of oximeters, but are returning empty-

A survey of various shops in the city proved that there indeed is a shortage of oximeters and some other items needed to fight the menace of Covid-19. Sodium Hypochlorite (NAoCI) which is used as a disinfectant is also unavailable. The non-availability of such vital items has become a headache for residents of this city.


"Around two weeks ago I bought an oximeter for ₹650. In the last three days I have visited several medicine shops and have not been able to procure one. In some shops, oximeters are being sold at rates between ₹2,500 to ₹3,500," informed one of the buvers.

Shop owners are claiming that due to the sudden increase in demand, they have exhausted their stock of oximeters. "There has been a huge demand and the medicine stores were not ready for the rush. Due to this, most stores do not have the device available with them," said the

Virus claims 16

BHUBANESWAR: Odisha registered 9,889 new Covid-19 cases Wednesday, pushing the total tally to 4,89,641, while 16 fresh fatalities raised the toll to 2,104, a senior Health department official said. This is the highest fatality rate recorded during the 2nd wave in Odisha. Of the new cases, 5,611 were reported from guarantine centres and the rest were detected during contact tracing, the official informed. Odisha currently has 77,257 active cases, while 4,10,227 patients have so far recovered from the highly infectious disease. Odisha's positivity rate stands at 4.74 per cent. Khurda district once more topped the list of new cases with 1,331 reported in the last 24 hours.

RBI respite for small borrowers

Mumbai, May 5: RBI allowed Wednesday certain individual and small borrowers more time to repay debt and allowed banks to give priority loans to vaccine makers, hospitals and Covid-related health infrastructure as it announced support measures to cushion the pandemic's blow on the economy.

The moratorium of up to two years will be available to individuals and small and medium enterprises that did not restructure their loans in 2020 and were classified as standard accounts till March 2021, RBI Governor Shaktikanta Das in an unscheduled address. This facility will be available to borrowers with a total exposure of ₹25 crore, he in-

formed. "In respect of small businesses and MSMEs restructured earlier, lending institutions are also being permitted as a one-time measure, to review the working capital sanctioned limits, based on a reassessment of the working capital cycle, margins, etc," Das said.

Bankers had reportedly asked the RBI for a threemonth moratorium, particularly for retail and small borrowers. This they said till March 31, 2022.

TEMPORARY SC RELIEF FOR CENTRE. BUT 700MT MUST BE PROVIDED DAILY TO NATIONAL CAPITAL

New Delhi, May 5: The Supreme Court stayed Wednesday contempt proceedings initiated by Delhi High Court against Central government officials for non-compliance of the direction to supply 700MT of medical grade oxygen for Covid-19 patients in the national capital It will certainly be a relief to the Centre. However, the stay will not restrain the high court from monitoring Covid-19 management related issues, a bench of Justices DY Chandrachud and MR Shah said.

The top court, in an urgent hearing, directed that a meeting be held between officials of the Centre and Delhi government by Wednesday evening to discuss various aspects of augmenting the oxygen supply to the national capital.

This is an all-India pandemic situation and we will have to find ways to ensure oxygen supply to the national capital as 'we are answerable to people of Delhi', the bench pointed out. 'We are also in Delhi. We are

helpless and have been on phone. We can imagine what citizens are going through," Justice Chandrachud said. He added that his office is hearing cries from people including lawyers seeking help.

The top court said it cannot review its order of April 30 and the Centre will have to inch towards sup-

Dehradun/Haridwar: Five Covid-19 patients, including a woman, died at a private hospital in Roorkee in Uttarakhand's Haridwar district allegedly due to disruption in oxygen supply to the facility for around 30 minutes. The incident occurred in the early hours Wednesday when oxygen supply to the hospital remained disrupted between 1.30 and 2.00am, a doctor said. One of the patients who died was on ventilator support while four others were on oxygen beds,

Online sale of liquor proposed

Bhubaneswar, May 5: The state Excise department urged Wednesday Special Relief Commissioner (SRC), PK Jena to allow home delivery of liquor during the lockdown period. Excise Secretary SK Lohani submitted a proposal to Jena in this regard. However, no final decision has so far been taken by the government.

The Odisha government has imposed a 15-day lockdown with effect from Wednesday. Hence all nonessential shops will remain

shops. Based on past experience, the Excise secretary said in such situations black marketing of liquor becomes rampant. Spurious liquor is also sold leading to health and safety hazards.

Similarly, country-made liquor should also be allowed for home delivery, he said. Fuel prices increase for 2nd straight day

New Delhi, May 5: Petrol and diesel prices were increased for the second day in a row Wednesday as state-owned fuel retailers resumed daily rate revision after a more than two-week long hiatus during Assembly elections in states like West Bengal. Petrol price was increased by 19 paise per litre and diesel by 21 paise a litre, according to a price notification of stateowned fuel retailers. Petrol in the national capital now costs ₹90.74 a litre and diesel comes for ₹81.12 per litre.

Rates have been increased across India and vary from state to state depending on the local incidence of taxation (VAT).

Oil companies had Tuesday resumed daily price revision in line with cost after ending an 18-day hiatus. Prices were hiked Tuesday by 15 paise per litre for petrol and 18 paise on diesel.

In two days, more than half of the 67 paise a litre reduction in petrol and 74 paise per litre cut in diesel prices effected between March 24 and April 15, has been wiped out.

Despite the concerns about rising COVID-19 cases in India denting demand, crude oil prices in the international market have risen primarily on account of strong US demand recovery and a weak dollar. Prices have been on a continuous uptrend since April 27, an industry official said adding crude oil price hit USD 65 per barrel mark. It is expectedthat the crude oil prices will remain firm in the near future.

Bhubaneswar, May 5: Food Supplies and Consumer Welfare Minister Ranendra Pratap Swain asked Wednesday civil supply officers (CSOs) to check black marketing and hoarding of essential consumable items. This development comes as Odisha went into a 15day lockdown beginning Wednesday.

There is a possibility that some traders may resort to hoarding of essentials like potato, onion, edible oil and wheat during lockdown. So the minister has directed the CSOs of various districts to personally visit grocery shops and store houses and check on those

The state government is keeping a vigilant eye on availability of the essential items, he said. Field level officials have been directed to visit shops every day and take action against traders who unnecessarily hoard items, the minister stated.

During lockdown, shops providing ration under PDS and stores selling groceries, fruits, vegetables, dairy and milk products, meat, fish, animal fodder, seeds and pesticides have been allowed to open. These shops will remain open Monday to Friday (6.00am to 12 noon). However weekly and daily haats will remain closed.

Lucknow, May 5: After Bengal it is the turn of Uttar Pradesh to give a jolt to the BJP. The verdict is from an early round of biggest electoral fight in the business - the Uttar Pradesh Assembly elections to be held next year. However, the results of the recently-held panchayat polls in UP did not augur well for the saffron party and UP CM Yogi Adityanath. There is a peculiar rule in the UP panchayat elections. Candidates are supported by political parties but they do not contest

as their representatives The BJP has managed only eight of a possible 40 seats in Ayodhya which has been in the news for Ram Mandir. It saw a 'bhoomi poojan'



presided over by Prime Minister Narendra Modi. In Ayodhya, Akhilesh Yadav's Samajwadi Party (SP) managed 24 seats, Mayawati's Bahujan Samaj Party (BSP) won four and independents four.

In Mathura, which the Sangh has decided will be the new nerve centre of Hindutva with a highdecibel campaign planned, the BJP won only eight of the 33 zila panchayat seats, while the BSP emerged

as the biggest gainer with 13 seats.

In Varanasi, which has twice elected Narendra Modi to the Lok Sabha, the SP won 15 seats, the BSP plus independents 17 and the BJP just eight. The Ayodhya unit of the BJP has

conceded that it did not do as well as expected. "The results are disappointing. Despite having sitting BJP MLAs in all constituencies in Ayodhya district, we won only eight out of 40 zila panchayat seats," BJP's district spokesperson Diwakar Singh said Wednesday.

Yadav said the results are an indication of things to come. "The panchayat election results showed that the BJP is a sinking ship. Signals emanating from the polls in the state show that the BJP will be wiped out in 2022," he asserted.

Dip in Mahaprasad sale hurts servitors No vaccination in 9 dists today

Puri, May 5: The Suar-Mahasuar Niyog of Srimandir has urged the district administration and the Shree Jagannath Temple Administration (SJTA) to take steps for the sale of Mahaprasad during the 14-day lockdown in the state. Suar-Mahasuar Niyog secretary

Krushna Chandra Pratihari Wednesday claimed that the sale of Mahaprasad witnessed a drastic fall as the 12th century shrine has been shut for devotees till May 15 to contain the spread of the novel coronavirus.

"The volume of Mahaprasad cooked at Srimandir has come down by 60-70 per cent due to the virusinduced restrictions. Now, we are cooking the temple delicacies for offerings before the presiding deities and meeting the demands of around 200-300 people," Pratihari said.

The Srimandir servitor, however, rejected reports that claimed huge quantities of unsold Mahaprasad are being buried at Koili Baikuntha on the shrine premises. "We usually distribute the unsold Mahaprasad among the inmates of orphanages and the

destitute. As per Srimandir record of rights, servitors bury Mahaprasad only when there are some untoward incidents and disruption in rituals," he added.

Pratihari further claimed that the 14-day lockdown in state would add to the woes of Suar-Mahasuar servitors and all other people who assist in the preparation and sale of the temple delicacies.

"The restrictions imposed by the

state government would cause financial miseries to Suar-Mahasuar servitors and Pania, Tunia and Bojhia workers of Srimandir. The administration should think about

Bhubaneswar, May 5: The state Health department Wednesday said that there would be no Covid-19 vaccination in nine districts Thursday due to shortage of Covishield doses.

The districts where vaccination has been halted are: Bolangir, Bargarh, Boudh, Gajapati, Jharsuguda, Keonjhar, Koraput, Nabarangpur and Sonepur, said the department.

According to sources, the vaccination programme was suspended in 15 districts Wednesday due to the shortage of doses. The Health department was able to inoculate only 21,804 persons through 92 sessions Wednesday. It used Covaxin doses during 41 sessions, sources said. The government claimed that till now a total of 7,535 persons in the age group of 18-44 years received the first dose of Covaxin shots. Till date, the government has been able to vaccinate 59.51.329 people in the state.



Berhampur, Balasore and Jeypore. The RDEs have been looking after the educational systems of 30 districts of the state.

The Balasore RDE looks after four districts-Balasore, Bhadrak, Keonjhar and Mayurbhanj. Similarly, Jeypore RDE takes care of four tribal-dominated districts Koraput, Malkangiri,

Nabarangpur and Rayagada. The RDEs of Bhubaneswar and Sambalpur had nine districts each, while Berhampur RDE has four dis-

The RDEs not only look after the

matters relating to the Higher Education department but also monitor the affairs of the directorate of higher secondary education coming under the jurisdiction of School and Mass Education department. They streamline the administration and expeditious disposal of various matters in the field of education

The regional directors conduct inspection of government and non-government colleges including general supervision of the work of the principals of non-government colleges and government colleges except autonomous and lead colleges. They can recommend the government to accord permission or recognition of nongovernment colleges. They can also give recommendations for opening of new streams/ subjects/ honours subjects and raising the seats in colleges

It will be increased post lockdown or as per the demand," he added.

The BMC had earlier roped in about nine NGOs to distribute food to the poor and needy. As per sources, individuals belonging to the economically disadvantaged sections and those residing in different shelters and colonies in the state capital have been found living in absolute shortage of daily meals during weekend shutdown. The NGOs were permitted to distribute hygienic food to them in strict adherence to Covid-19 guidelines.

A year ago, the state government had sent closure/merger notifications to 11,560 primary schools having less than 20 students, forcing the children in several remote villages to drop out from the schools.

Many School Management Committees filed a PIL with the High Court against the government's order. The court Tuesday pronounced its order in response to the PIL.

BODY CREMATED SANS KNOWLEDGE OF FAMILY IN SUNDARGARH

Bengal traders cash in on groundnut distress sale

Jaleswar, May 5: Distress sale of groundnuts in Jaleswar, Bhograi and Baliapal blocks of Balasore district has left farmers in a spot. Traders from neighbouring West Bengal are taking advantage of the situation. Groundnut farmers have to sell their crop at throwaway prices to Bengal traders, a report said.

As there has been no provision of the government-backed procurement for the groundnut, farmers are selling the cash crop for Rs 52 a kg to the Bengal traders

According to the report, groundnut has been raised across 9000 hectares in the three coastal blocks. It is said that farmers have harvested about 70 per cent of the crop. But the problem is that there are no takers for the cash crop in the

Some farmers alleged that the state government was promoting cash crops to augment the income of the farmers, but there is no provision of procurement of the cash

crop like paddy.

They said they have spent a lot of money on seeds purchase, land tilling and wages. The input cost for farming groundnut in an acre is Rs 20,000. They allege that they are entitled to input subsidies, but they are deprived of it in most cases.

"If the crop is sold immediately after the harvest, we are a little relieved. We have to clear the pending dues of labourers and credit in the input costs. But now the crop has no takers and we are bound to sell it to Bengal traders for peanuts,"

Groundnut is grown in 3000 hectares in Jaleswar; 3500 hectares in Baliapal and 2500 hectares in Bhograi. As there has been no provision of the government-backed procurement for the groundnut, farmers are selling it for Rs 52 a kg to the Bengal traders.

"In the current year, the groundnut has been grown at Kotasahi, Rayanramchandrapur, Gobarghatta, Maohammednagarpatana, Paikasida, Jhadpipal, Baiganbadia and Laxmannath panchayats," said Rajlaxmi Mohanty, assistant agri-

culture officer of Jaleswar.

larities were committed in the construction of quarters for firefighters and other staff of Kaptipada fire station in Mayurbhanj district. Now, the administration has started an investigation into it.

According to reports, Kaptipada fire station was set up in October 2015. Later, staff quarters were built by the Odisha State Police Housing and Welfare Corporation (OSPHWC) at a cost of Rs 1 crore. But the work was allegedly botched up. Before the quarters were handed over to the fire department, plasters had fallen off from CC roofs while there were cracks at the plinth level of the buildings. Sub-standard wood was used for doors and windows of the quarters. The floor was supposed to be covered with marble, but it was paved with poor quality tiles.

Low quality iron was used for gates while steel railings were not of good quality. Poor quality electrical equipment – wires, switch boards, and other fittings -- were used in the wiring of the quarters. What is shocking was that in records, Rs 40,000 was shown as expense for felling of trees on the land, but in reality there was no

10th century Vishnu idol found from Bhadrak pond

Bhandaripokhari, May 5: Residents of Sathagaon village under Kurigaon panchayat of Bhadrak Wednesday demanded excavation of the area after an idol of Vishnu dating back to 10th century AD was found May 2.

The district administration and the state archaeology department should excavate the place to unearth the ancient carvings that are supposedly buried underground, some villagers said.



A number of ancient stone carvings were also found from the area. According to a source, a rare stone idol of Lord Vishnu in sleeping gesture (Anant Sayan mudra) was found during the digging of a pond on a private farmland near Dudheinala creek of Kurigaon panchayat under Bhandaripokhari block in Bhadrak district.

A villager named Ramesh Parida had been digging a pond in his farmland when the stone idol, around two feet in height, was unearthed. The idol is made of sand stone, a local researcher Biswambar Rout opined. Fearing that the ancient idol might be stolen by miscreants, it was brought to Maa Sunamuhin temple premises in the village. Later, the villagers informed the district administration about it.

Farmers stare at crop loss as canal goes dry



Sambalpur, May 5: Farmers living on the downstream of Sasan canal in the district are staring at a possible crop loss this year due to unavailability of water from the water body for their farmland, a report said. Farmers allege that water does

not reach their farmland on the downstream while it overflows in the upstream due to lack of renovation of the water body. They apprehend that they might face serious crop loss if the water problem persists for long. Reports said that paddy cultiva-

tion in Sambalpur district depends on water available from Hirakud reservoir in various canals like Sasan, Paramanpur and Huma tail Water drawn from Hirakud reservoir passes through these three canals and helps in irrigation of the farmland in the district.

This has happened as the Sasan canal which was built 50 years back is in a dilapidated condition and is in an urgent need of repair. The main canal is 80 km in length while the branch canal and channel is 300 km in length. Its embankments have become weak resulting in seepage of water from the canal.



As a result, the water flow does not reach the downstream but overflows at the upstream. They said the state government wants to increase the cultivable area and has launched various schemes for the purpose.

The government is also constructing minor and lift irrigation projects for the purpose. However, these projects have limited socio-economic benefits for the people for whom they were designed. While the state government sanctions funds for new r plans, it does not release funds for the renovation of

the Sasan canal. Meanwhile, the district administration and the irrigation department have prepared a detailed project report (DPR) for the renovation of the canal. They have submitted it before the state government for its approval. Although two years have passed since the DPR was submitted, the government is yet to give its approval to the plan.

Sources said unavailability of water happen during Rabi season. The water retaining capacity of Sasan canal is 630-ft. However, the water flow in the canal is much more than its capacity. The water flow has hampered due to formation of massive moss in the canal. A

study has revealed that two to three centimeter of moss is formed on a daily basis which also obstructs the flow of water downstream.

Reports said that cultivation is done on 26,000 hectares of farmland during kharif while rules have been made to carry out cultivation on 14,500 hectares in rabi season which is about 60 per cent of the kharif cultivation.

The crops cultivated during rabi season include paddy, green grams, black grams, pulses, cash crops like sesame, mustard and vegetables. However, the cultivation has been carried out on 18,000 hectares which is more than the target fixed by the district administration.

Moreover, paddy has been cultivated in over 3,500 hectares in noncommand area. However, lack of water flow to the downstream of the canal has left the farmers high

Pramod Panda, executive engineer, irrigation department, admitted that the Sasan canal is in a bad shape and is in urgent need for repair. However, unavailability of funds has hit its renovation. He said farmers are facing water shortage due to increase in the cultivable land and illegal drawing of water for vegetable cultivation.

Pet-friendly campuses

🕽 ome months ago Anoushka, Abhishek, Sarthak, Garvita and Rishabh wrote to me from Thapar Institute and Technology, Patiala College in Patiala, requesting guidance with an animal welfare group they had started on the campus called Puppers Helpers Tiet.

This gave me a new idea – of starting animal welfare groups in every college campus. So we put yet another Anushka, who came to me as a legal intern, in charge of this. If any of you would like to start a group you can contact her at: anushkapfacampus@gmail.com. She already has 30 college units, and my target is 50,000.

In the meantime, Enactus, which is a student organisation of social work that exists in most colleges in Delhi, has, on its own, started making animal welfare groups in every college in Delhi. The group is called Desi, and it is handled by Lakshita, the President of Enactus, Motilal Nehru College. They are doing an excellent job treating animals, having them adopted, start-

Thousands of students across India have been feeding and looking after animals during COVID. Many opted to stay back in their hostels to see that resident animals were fed. When the staff of Jindal University wanted to throw out animals, over 600 students called, wrote in, and went there to protest till the university authorities backed down. The worst case has been IIT Madras: A place ruled by two extreme leftists, who spend much of their time abusing the government and being vicious to animals. In spite of government orders, and dozens of campus staff and students protesting, they made a ghetto for dogs where they were kept chained till most died. They did this in the name of wanting to save the deer on the campus. They then fed the deer dog biscuits and plastic till a number of those died. They fi-

nally had to back down under court orders, but not before they had wreaked misery on man and animal. They could have learned a lesson from KG Reddy College of Engineering and Technology in Moinabad, which puts "world's first animal friendly educational campus" as part of its advertising! The campus doubles as a shelter for abandoned and abused animals. I quote from an article on them which made my day: "Most of the videos that captured the cruel treatment of animals, and shared widely this year on social media, had the same set of perpetrators - youngsters. Recognising the importance of making the youth compassionate towards animals, the management of an engineering college has decided to impart more than just technical subjects, by starting an animal shelter within its campus." The college has let dogs, cats, pigeons, turkeys, ducks and rabbits take refuge on the premises. "The thought was that students can bring in a change in society, and be the ambassadors in spreading the message to their family and friends

about loving animals and being sensitive towards them," says K. Krishna Reddy, Chairman of the institute.

Students of KJ Somaiya Institute of Management Studies and Research in Mumbai, St Xaviers' College in Ahmedabad, and Symbiosis Institute of Media and Communication in Pune, also have animals on the campus and students and college administrations work out feeding and vaccination schedules, scheduling visits to the vet, even laying down rules about go and no-go areas — pets are allowed into hostel buildings and canteens. In Symbiosis, they are allowed into classrooms as well.

Institute director Vidya Yeravdekar says: "Students dealing with emotional insecurities, relationship problems and stress, benefit from pet therapy. We want to focus on the emotional well-being of our students too and hence this

Students in Somaiya use a WhatsApp group to sync feeding routines, veterinary visits, and work with a local NGO to care for their campus pets. The group calls itself Animal Welfare Association of Somaiya (AWAS).

Students of IIM-Indore's 193 acre campus, have turned their campus into a dog-friendly vicinity and take care of all campus dogs by joining hands with the NGO—Helping Hands For Animals (HHFA). The campus has approximately 50 dogs and the students feed them daily, take care of their health and ensure their safety, marking the dogs with luminescent collars so that they are visible from a distance at night. The group also plans to train a few dogs for security and safety of the institute at the main gates.

The National Service Scheme volunteers of Kochi's St Albert's College will now get to learn the basics of animal welfare. The college has recently signed an MoU with the Humane Society International to conduct webinars and campaigns on animal protection. Sebastian AV, the college's NSS coordinator says: "We want to create a general cognisance in students that the world belongs to other beings too. We have asked our students to feed strays, keep water bowls for birds and take pictures of these." St Alberts' is the first NSS unit in the state to tie up with an animal welfare organisation.

During the pandemic an animal welfare club was formed, to take care of animals on the campus, by The Indian Institute of Engineering Science and Technology (IIEST), following an appeal from the students' senate. A group of students, under the banner "People for Animal Welfare, IIEST", has been raising funds since April to feed the strays on the campus that has been closed since the third week of last March with the onset of the lockdown. The institute made the club a statutory body to enable the administration to help 200-odd dogs and 30-odd cats. An IIEST professor of electrical engineering is professor-in-charge of the club.

IIT-Delhi has recently invited candidates for the position of a dog-handler in the institute. The position, worth Rs 45,000 per month, is for a Bachelor of Veterinary Science to care for the community dogs on the campus. "I am proud of IIT-Delhi for considering that the planet does not only belong to humans," says a student. "Appointing a dog handler will solve the issues of both animal lovers and animal haters." During the pandemic, when students left, IIT-Delhi used their guards to feed the animals

The JNU campus in Delhi has over 20 feeding spots, where dogs, nilgais and peacocks are fed by students. It has an animal cell and an animal ethics committee. The lockdown meant students had to leave the premises, leaving these animals with no fixed source of food. Why is it important to have animal welfare groups institutionalised on campus? Research shows that those who commit crimes against animals have a higher disposition to commit crimes against humans. Research has consistently reported childhood cruelty to animals as the first warning sign of later delinquency, violence, and criminal behaviour. Nearly all violent crime perpetrators have a history of animal cruelty in their profiles. We must

change attitudes early. For students the advantage, that all research has shown, is that having dogs and cats around can help lower high blood pressure, and this calming effect is especially important as students juggle lectures, assignments and

internships, prepare for exams, feel homesick. Puppers Helpers now has 60 volunteers. It is an official club headed by a teacher. It has made a temporary shelter for campus animals and held first aid classes, and is currently engaged in spreading awareness on how to treat parvo virus. I am so proud of them.

mass tragedy, a basic is to be sensitive to the victims and those who are grieving. Western media, which doubles as the international media. usually observes this rule at home but discards it when reporting on disasters in non-Western societies. The coverage of India's devas-

tating second wave of COVID is a case in point. Western media has been filled with images of bodies and other graphic scenes that generally would not be shown following a similar disaster in a Western country. About half of global COVID deaths have occurred in Europe and the US alone, yet Western media has avoided presenting harrowing images from those settings.

Even at the height of the pandemic in the US and Europe, it was unthinkable that television crews would barge into emergency rooms to show how overwhelmed the doctors and nurses were. Yet such scenes have been broadcast internationally from inside Indian hospitals, with little concern for how the intrusion could affect life-ordeath decisions. Television journalists have also swarmed Indian families who lost loved ones, turning their private grief into a public spectacle for Western consumption. When covering grief in their own countries, the same media organisations are far more careful. For example, coverage of mass graves being dug to accommodate New York City's early surge of COVID fatalities featured sanitized images of misty tree-lined fields. By contrast, India's pandemic experience will be remembered for the haunting images of bodies burning on pyres - images that the Western media beamed around the world.

The funerary fire is a classic



Western media's unvarnished coverage of suffering, grief, desperation, and ineptitude is much more likely to come from distant lands

trope in Western novels, travelogues, and paintings about India. By directing their cameras to the burning pyres, Western media outlets are satisfying their audience's morbid fascination with the Hindu tradition of cremating the dead (even though this environmentally friendly practice is increasingly catching on in the West). Utterly ignored in this coverage is the fact that showing ghastly images of burning pyres is a grotesque and deeply disrespectful invasion of what is a very private affair in India.

This is hardly the first time Western media outlets have been insensitive in covering disasters abroad. In the coverage of the 2011 Fukushima disaster, the victims were treated as a secondary issue to the more lurid story of radiation leaks. Western reporting was also rife with cultural and racial stereotypes: the workers who stayed behind to deal with the accident-hit nuclear reactors were dubbed "nuclear samurai," "human sacrifices." and "nuclear ninias on a suicide mission." In reality, no radiation casualties occurred at Fukushima, owing to the preventive evacuation of the area's 100,000 residents. But that didn't stop Western

media from feeding the hysteria with false and inflammatory comparisons to Chernobyl. As a result of this sensational coverage, cargo ships started avoiding Japanese ports – even those far from Fukushima-and several countries evacuated their citizens from Japan.

Western media brings a similar approach to Africa, portraying it as a continent of heathen hordes. unending disasters, and very few happy, smiling faces. The 2014-16 Ebola epidemic that swept across Guinea, Liberia, and Sierra Leone ultimately killed 11,325 people, meaning that the death toll over two years was roughly the same as the two-day COVID death toll in the US just three months ago. Nonetheless, the Western media's coverage of the Ebola story was all about body bags, traditional mourning practices, and West African burial rituals. The 2015 Pulitzer Prize for feature photography was awarded to a freelance photojournalist who had followed body collectors and documented West Africans' suffering, death, and despair for The New York Times.

 $Meanwhile, coverage \ of \ COVID$ did not feature in any of the 2020 Pulitzer Prizes or nominations. And when the 2021 prizes are an

nounced in June, it would come as quite a surprise if any were to be awarded to journalists who documented the deaths from the pandemic in the West. Western media's unvarnished coverage of suffering, grief, desperation, and ineptitude is much more likely to come from distant lands. While images of dead American soldiers are rarely published, photographs of dead Afghans, Iraqis, and others are all too common. True, Western media should not be regarded as monolithic - indeed, Anglo-American outlets dominate. Nor is Western media averse to offering sensational coverage of bad news when it happens at home. But the overall pattern is clear: Western media coverage of tragedies elsewhere tends to traffic in cultural stereotypes and violations of privacy and dignity that would not be accepted at home.

This double standard has important implications. International perceptions are shaped by how the dominant Western media organisations present the news. As the Ebola epidemic showed, sensational images and stories make us think that a dreadful tragedy is even worse or more widespread than it actually is. The Ebola cases and deaths were almost all confined to three West African countries, yet the virus became associated with Africa as a whole.

A journalist's duty is to inform. not to exploit human suffering with intrusive, voyeuristic, ratings-driven coverage of tragedies in faraway lands. Good journalism rises above clichéd coverage and reliance on shock value. With the coronavirus rapidly mutating and spawning dangerous new strains, we urgently need more responsible, sensitive reporting of these issues.

puzzled when reading about people being referred to as critics. I wondered why anyone would want to criticise something, and more importantly, why others not only allowed the critic to make unpleasant remarks, but actually paid him for doing so.

As I grew older, I understood that ritics' role included pointing out the good as well as the bad, and also the need to see criticism as a tool for growth and improvement. As someone who has been in the Information Technology domain for a number of years, the importance of critics, or Testers as they are called here, cannot be praised enough. While coders claim all the glory, these backroom warriors ensure that the bugs in the code are caught before the application is released to users. Which is why, it is both sur-

prising as well as disturbing to see the vehemence with which criticism is being met. Especially, if there is even an imagined hint of a political bias in the criticism. The first step in solving any problem is to recognise its existence. And this recognition is most often triggered by criticism of the existing circumstances. There are three basic charges used to stifle criticism - it demoralises people who are working hard at resolving problems, creating awareness of an existing problem would help enemies in pulling us down, and finally, saying that instead of finding faults, find solutions.

Take the example of the DM of a Northeastern state who was caught on video stopping a wed-

s a child, I remember feeling ding ceremony that had gone bevond the curfew hours. Shared widely on social media, it primarily evoked two responses - one group of people applauded the DM for ensuring the law was followed, and saying that criticising his actions would be akin to promoting lawlessness, while the other group criticised him for his uncouth behaviour saving that this was a brazen display of might by an official drunk on the power at his disposal.

> While both groups argued their hearts out, I could not help feeling that both were right. It was the DM's duty to ensure the curfew was respected, at the same time, it was also necessary for him to maintain the dignity of his office by behaving with courtesy and respect towards citizens of his district. What remained unsaid was that ultimately, he too is a human being and unlike most of us, has been saddled with huge responsibility. At the fag end of what must invariably have been an exhausting day, seeing what appeared to be a flagrant violation of the law must have caused the disturbing display of power abuse.

But does that mean he should not be criticised for his actions? The jury is still out on this. It is also true that whenever criticism is expressed, it could be used by those seeking to harm us. However, there are two assumptions being made here one, that those who wish to do us harm were not aware of the problem, and secondly that those in charge are already aware of the problem and are working to fix it, and hence, criticism should not have been made. Both these are dangerous assumptions - the first indicates we are underestimating our enemies - for all we know, they may be pretending to not know of the problem so that they can use it to their advantage later. Secondly, assuming the faults are known and are being fixed does not mean they actually are - and if by not pointing out the problem there is a chance that it is not recognised and resolved, it is always safer to bring it to attention.

The rise of social media has made it so easy to criticise - people, products, services, politics - everything is fair game. And this is the reason those opposed to criticism say that instead of criticising, people should try to find solutions. The thrust is to emphasise positivity instead of the negativity that criticism arouses.

However, what this implies is that unless one has the ability and authority to find solutions to a problem, one cannot point it out. This approach effectively silences everyone, for if it is a problem that is my responsibility to resolve, I will not make it public - and for all other problems, since I cannot resolve them, I have to keep silent!

There are also many who espouse the 'ignore' method of handling criticism. The hope is that with the passage of time, criticism even if it is valid and needs an active response, will be forgotten. The reason for this is simple - acknowledging the criticism means admitting mistakes have been made. And in a society where failures are frowned upon, it is always better to pretend the criticism does not exist and thus live in denial till such time the problem is forgotten or resolves itself. Of course, this can cause tremendous pain and suffering to those affected, but ____ then, that's karma.

At governmental level, traditionally media has played the role of critic - pointing out mistakes and praising good work. As the fourth pillar of democracy it ensured that through it, citizens could give feedback to the government about the effects of its policies. This feedback, both critical as well as complimentary, helped the government fine tune its work. Today, thanks to social media, the common citizen too has a chance to have his voice heard directly. While there is no issue with praise, when it comes to criticism, it tests the strength of the nation's democratic values. It was with wonder, interspersed with a little bit of envy, that I watched former President Donald Trump being grilled by correspondents during his press meets. For me, this was the pinnacle of democracy, where the head of the state could be asked uncomfortable questions without fear of consequences.

Which is why, the recent statement from the Supreme Court saying, FIRs against appeals for help in combating Covid on social media would be treated as contempt of court, and that the voices of citizens need to be heard not clamped down, is so gratifying. Hope exists still for Indian democracy.

The condition known as hypercapnia or hypercarbia may worsen in the presence of respiratory insufficiency, especially in Covid positive patients.

Covid spikes in rural Karnataka

DOCTORS SAY LACK OF STAFF AND EXPERTISE ARE MAJOR REASONS FOR INCREASED DEATH TOLL

Kalaburagi, May 5: Doctors from remote rural areas like Aland taluk in Karnataka's Kalaburagi where four Covid patients reportedly died due to shortage of oxygen have had their own harrowing experiences of dealing with the spreading pandemic.

Aland in Kalaburagi, which borders Covid-battered Maharashtra, has off late seen the contagion sweep the taluk indicating that Covid has penetrated even into interior parts of the state.

Doctors there reveal that lack of staff and required expertise are major reasons for increased death toll in rural parts of the state.

They said that most of the patients in rural areas come at last minute in most of the cases when their oxygen saturation level drops to below 80 per cent. "At this juncture, we are forced to administer them oxygen. Therefore, hospitals in interior parts do face 'constraint' in supplying oxygen," Aland taluk health officer Ratnakar Toran told reporters.

Aland is a dry area, with low rainfall and most of the population lives in poverty. It also wit-



nesses large scale migration to cities due to lack of water, poor education facilities and employment opportunities besides power shortages. Aland is also one of taluks that records a high level of farmer suicides.

Aland Hospital surgeon, Abhay Kumar said that four patients who died Monday were admitted only at 5 pm and all four had below 80 per cent oxygen saturation, while one of them had below 70 per cent, who was very critical. "All these four died past midnight. There was no oxygen shortage. But peo-

ple tend to attribute all deaths to this factor," he said. The doctors also feel that many people feel ashamed to disclose that their family members have tested Covid positive and continue to mingle with relatives and friends, thus becoming 'super spreaders'.

"Finally when they reach hospitals, their oxygen saturation level would have fallen drastically over which ill-prepared doctors like us have absolutely no knowledge about handling critical care patients... this either leads to overcrowding of neighbouring district hospital or by

the time treatment is given to such patients, it would have been too late," Kumar said, terming himself ill-prepared to handle this contagion at critical stage. "I am a surgeon... all throughout my life I practiced and studied about surgery and related to this subject. Critical care has never been my forte," he said.

He also added that the majority of hospital staff have tested Covid positive, while he being surgeon, and Ratnakar being an ayurvedic doctor, it is very difficult to cope up with the pressure. "Our X-ray machine operator is Covid positive, and still we are managing to run it with the help of Class D employees. There is no one tp monitor in-patients. When we leave it to their relatives, they mishandle the oxygen outflow to patients," the doctor rued.

Aland town shot to limelight for all the wrong reasons Tuesday when a report of families of four Covid patients alleging about their relatives dying due to lack of oxygen supply in hospital, while district authorities including newly appointed district in-charge minister, Murugesh Nirani denied there was any oxygen shortage.

Guj: Women flock religious event to 'eradicate' virus

A video of the incident, which occurred in Navapura village in Sanand taluka May 3, showed around 500 women carrying water pots on their heads while walking towards a temple. The video grab also shows some men taking these pots to the top of the temple and emptying them.

After the video clip went viral Wednesday, Ahmedabad rural police said appropriate action had already been taken.

A police officer said villagers believed that coronavirus will just go away if water is poured on the Baliyadev temple.

Augmenting oxygen supply from sources: Centre tells Guj HC

Ahmedabad, May 5: The Centre has told the Gujarat High Court that it is augmenting oxygen supply for COVID-19 patients from all available sources within India and also importing it from other countries through "diplomatic channels as well as personal intervention of the political executive."

In a report on the supply of medical oxygen submitted before the HC Monday, the Centre said a total allocation of 8,410 metric tonnes of oxygen has been made for 22 high burden states and Union Territories based on their demand, the Centre told the HC Tuesday.

The states should also make an

effort to manage their oxygen demand through rational usage of this "scarce and critical resource" by continuous and close monitoring of hospitals and stringent audit of the oxygen usage, it said

A division bench of Chief Justice Vikram Nath and Justice B D Karia had sought the Centre's response while hearing a PIL taken up suo motu on the COVID-19 situation.

The Union government said it is "augmenting oxygen supply from all available sources within India and also importing oxygen from other countries using not only the diplomatic channels but also personal intervention of the political executive."

The process is going on at the national level and is also being undertaken at an international level, it stated.

Any deviation by any judicial order based upon fact, situation and considerations existing in one state will "completely frustrate the whole exercise and shall have a cascading effect", the Centre said.

"It is submitted that while this exercise is primarily in the nature of managing the supply side of medical oxygen, it is imperative that there are simultaneous efforts to manage the demand side by all the states by focusing on rational usage of this scarce and critical

resource in the present circumstances through continuous and close monitoring of all hospitals as well as stringent measures of oxygen usage audit," the Centre said.

It said the supply of liquid medical oxygen (LMO) by the steel sector increased from 1,000 MT per day in the first week of April 2021 to around 2,600 MT on April 21.

From April 28 onwards, Gujarat was allocated 975 MT oxygen, it said. Based on the projected requirements of these critically affected states, 4,880 MT, 5,619 MT and 6,593 MT were mapped for the supply of medical oxygen to 12 states with high number of COVID-19 cases, to meet their projected demand as on April 20, April 25, and April 30, respectively, and duly approved, it said.

The initial demand for 15 states was revised to 5,619 MT from 4,880 MT as on April 20, with the requirement of Gujarat being at 1,000 MT. it said.

Against its production capacity of 847 MT as on April 28, Gujarat required 1,000 MT LMO, and was allocated 975 MT, out of which the state received 902 MT, the central government said.

"No stone is left unturned to ensure quickest possible transit of medical oxygen," it said, adding that the defence aircraft and Indian navy ships are being used for the purpose.

Gujarat Wednesday reported 12,955 new coronavirus positive cases even as 12,995 people recovered from the infection, the state health department said, adding that 133 patients died. With the addition of the new cases and the fatalities, the overall COVID-19 tally in Guiarat rose to 6.33.427 and the toll to 7,912, the department said in a release. At 12,995, the fresh recoveries outnumbered new cases in a day after several weeks. With 4,77,391 recoveries so far in Gujarat, the case recovery rate improved marginally to 75.37 per cent.

Gujarat is now left with 1,48,124 active cases, it said.



Panel formed to probe 24 Covid patients' death

Bangalore, May 5: The Karnataka government Wednesday appointed retired High Court judge Justice BA Patil as the one-man commission to inquire into the death of 24 COVID patients in Chamarajanagar district allegedly owing to oxygen shortage.

A notification regarding the appointment of Justice Patil was issued by Additional Chief Secretary in the Home Department, Rajneesh Goel Wednesday. The term of reference of the Commission read, "To inquire into the circumstances and events leading to the death of COVID-19 patients in District Hospital, Chamarajanagar May 3, reportedly due to scarcity of oxy-

gen and any further similar incidents, which are entrusted to the Commission of Inquiry by Government." The office of the commission has to submit its report in one month. The notification said the officers concerned including the Deputy Commissioners of Chamarajanagar and Mysuru districts should hand over immediately all requisite documents and material evidence to the Commissioner of Health and Family Welfare Department for onward submission to the Inquiry Commission. The order came following the directions of the Karnataka High Court, which had taken a serious note of the deaths in Chamarajanagar and recommended a judicial inquiry. The state

government had previously appointed IAS officer Shivayogi Kalasad, the managing director of the Karnataka State Road Transport Corporation, as an investigating officer to probe the matter within three days. The state Health Minister Dr K Sudhakar had maintained that only three deaths took place due to shortage of oxygen and not 24 as has been reported. The opposition Congress, however, claimed that 28 people died. Close on the heels of the Chamarajanagar incident, seven COVID patients died in Kalaburagi and Belagavi district allegedly due to lack of oxygen Tuesday. There has been an unprecedented rise in cases in the state, which is reporting over 44,000 cases and over 200 deaths daily.

He said the gene therapy injection by Novartis, considered as one of the costliest drugs in the world, is the only treatment for spinal muscular atrophy and it has to be imported after placing the order.

"The injection arrived from the US a few days back. We reached Mumbai Tuesday and admitted our son in the hospital, where he was given the Zolgensma injection Wednesday. It is a one-time gene therapy to treat children suffering from spinal muscular atrophy," he said. Rathod works at a private company and lives with his wife and

son in neighbouring Godhra town of Panchmahal district.

The couple learnt about their son's health disorder a month after his birth as he could barely move his hands and legs.

"A doctor diagnosed my son with spinal muscular atrophy type-1, a rare genetic disorder which restricts muscular movements and breathing. We were warned that it could eventually prove fatal as the

child grows," Rathod said.

He said the gene therapy injection by Novartis was the only hope, but its price was too high for them.

Rathod is now hopeful that his son would be able to lead a healthy life.



SC quashes Maratha quota Act

New Delhi, May 5: The Supreme Court Wednesday struck down the Maharashtra State Reservation for Socially and Educationally Backward Classes (SEBC) Act, 2018, which enacted to provide 16 percent reservation to the Maratha community in educational institutions and government jobs, as it breaches 50 per cent ceiling limit.

The Supreme Court held that there were no exceptional circumstances to grant reservation to Maratha community in excess to the ceiling limit of 50 percent reservation prescribed by the apex courtin its 1992 judgment in Indira Sawhney vs Union of India. The court ruled that the exceeding of ceiling limit without there being any exceptional circumstances clearly violates the Article 14 and 16 of the Constitution. The act is against the principle of equality.

"There is no case of extraordinary situation for exceeding the ceiling limit of 50 percent for grant of reservation to Maratha community over and above the 50 percent," the Supreme Court ruled.

The apex court held that the representation of Maratha Community in Grade A, B, C and D in public services is adequate. Thus, it does not

fulfil the Constitutional pre-condition that a backward class is not adequately represented

A five-judge Constitution bench comprising Justices Ashok Bhushan. L Nageswara Rao, S Abdul Nazeer. Hemant Gupta and S Ravindra Bhatalso made it clear that the 1992 judgment in Indira Sawhney vs Union of India, that put 50 per cent cap on reservation, need not be referred to a larger bench as it is a good law.

"We do not find any substance in the argument to refer the judgment The said judgment has been repeatedly followed by this court and has been approved by at least four Constitution Benches of this court," the bench ruled.

Significantly, the top court also upheld the 102nd Constitutional Amendment that inserted Article 342A in the Constitution. Article 342A lays provision for identification of communities in states as socially and educationally backward classes by the President, in consultation with the Governor of the states. The question was that whether the Article 342A deprived the states of community as SEBC.

The Supreme Court ruled that the Article 342A "does not affect or damage" the federal polity and does not violate the basic structure of Constitution. The bench had different view on the interpretation of the Article 342A. Justices Ashok Bhushan and S Abdul Nazeer held that the use of term 'the Central List' under Article 342A refers to a list of classes for Central government services only and states can make their own list of SEBCs. However, the rest of the judges asserted that the list under Article 342A is to be the only list for all purposes of Constitution in relation to each state and Union territory. It does not imply that the states have any manner of power to publish their list of SEBCs.

It is to be mentioned here that several appeals were filed in the Supreme Court agains the order of the Bombav High Court that upheld the Maratha reservation act. The SEBC act, enacted in 2018, was challenged before the Bombay High Court as it increased the reservation in the state from 52 per cent to 68 per cent. The Bombay HC declared the act constitutionally valid but reduced the quantum of reservation to 12-13 per cent for education and government jobs respectively.

Death due to O₂ shortage is genocide: Allahabad HC

Prayagraj (Uttar Pradesh), May 5: Taking note of stories viral on social media of hapless citizens begging for an oxygen cylinder to save the life of their near and dear ones, the Allahabad High Court has termed it as a 'criminal act. no less than genocide'.

Observing the Covid situation in India, the high court Tuesday said that the deaths of patients due to non-supply of oxygen amounts to a 'criminal act', nothing short of a 'genocide' on part of those entrusted to ensure such supplies. We are at pain in observing that

the death of Covid patients just for non-supplying of oxygen to the hospitals is a criminal act and not less than a genocide by those who have been entrusted the task to ensure continuous procurement and supply chain of the liquid medical oxygen, read an order passed by the Allahabad high court bench of Justice Ajit Kumar and Justice Siddhartha Varma

The Allahabad High Court took stock of reports of shortage of medical oxygen due to rise in Covid-19 infections

The bench also observed the rampant hoarding of oxygen cylin-



ders and harassment of citizens who are desperately in need of them.

The court pointed out that, "The news went viral that five patients had died in ICU of a new trauma centre of Medical College, Meerut Sunday last. Similarly, news was also being viralled that one Sun Hospital in Gomti Nagar, Lucknow and another private hospital at Meerut had taken their hands off the admitted Covid patients only because oxygen supply was not made even after demand. We find these news items showing a quite contrary picture to one claimed by the Government that there was sufficient supply of oxygen.'

The high court further stated, "The current state of affairs about the management of an online portal created by the government today casts a shadow upon Covid-19 hospital management by the state government."

Delhi to suffer water shortage

New Delhi: Amid the surge in Covid-19 cases and severe shortage of oxygen, many parts of the national capital are also likely to witness water shortage from May 6 to May 8 due to an alarming dip in raw water supply through the Yamuna. According to a Delhi Jal Board (DJB) notice issued Wednesday, the water level at Wazirabad, which is fed by the Yamuna river, had fallen to 667.20 feet against the standard level of 674.5 feet.

3 killed in O2 cylinder blast

Lucknow: Three persons have been killed and six others injured in a blast at an oxygen refilling station in Lucknow Wednesday. According to initial inputs, the blast took place while the workers were refilling an oxygen cylinder. The fire caused by the blast engulfed the refilling station located in the Chinhat area of Lucknow. The injured have been admitted to a hospital. Chief Minister Yogi Adityanath has expressed grief at the incident and has directed officials to provide help to the affected people. The fire has been doused and rescue operations are underway.

Himachal imposes curfew till May 16

Shimla: To break the coronavirus chain, the Himachal Pradesh government Wednesday decided to impose curfew in the state till May 16 from Thursday midnight. All government and private offices and establishments will remain closed. However, essential services like health, electricity, telecommunication, water supply, sanitation, etc would be open.

Kolkata, May 5: Trinamool Congress (TMC) supremo Mamata Banerjee was Wednesday sworn-in as the chief minister of West Bengal for the third consecutive term. She vowed that there will be no 'respite' for those indulging in political violence and also said that an all out war will be waged against Covid-19. However, she also said that West Bengal cannot survive another lockdown.

Governor Jagdeep Dhankhar administered her oath of office and secrecy at a low-key ceremony at Raj Bhavan held amid the raging COVID pandemic. Banerjee took the oath in Bengali language. She is the 21st chief minister of West Bengal and eighth person to hold the office. Sources said that Banerjee's cabinet will be expanded with the induction of other ministers May 9, the birth anniversary of the state's icon, nobel laureate Rabindranath Tagore.

"Our first priority is to control the COVID situation," Banerjee said after taking the oath. "The second priority is to tackle the law and order

Submit report on post-poll violence: Centre The home ministry dispatched a terse reminder to the West Bengal government Wednesday to submit a detailed report on the post-

poll violence in the state, warning it that the matter will be taken "seriously" in case it fails to do so, and asked it to take necessary measures to stop such incidents "without any loss of time", officials said. In a letter dispatched Wednesday, the home ministry reminded the West Bengal chief secretary that May 3, it had sought an immediate report from the state government on the post-poll violence. However, the West Bengal government is yet to send the report, the officials said. According to latest inputs, the violence has not stopped in West Bengal and this means that effective measures were not taken by the state government to control it, the letter said. In case the report is not sent by the state government, the matter will be taken seriously, the letter added. At least six people were killed in post-poll violence in different parts of the state till Tuesday. The Bharativa Janata Party (BJP) has alleged that TMC-backed goons have killed a number of its workers, attacked its women members, vandalised houses, looted shops of its members and ransacked its offices. Claiming that at least 14 BJP workers were killed and nearly one lakh people fled their homes in post-poll violence in West Bengal, party president J P Nadda alleged Wednesday that the chief minister's silence speaks of her involvement. Banerjee rejected the charges, saying violence and clashes were taking place in those areas where the BJP candidates emerged victorious in the election.

High-tech hunt for COVID vax in India raises equity concern

New Delhi, May 5: Indian tech experts have written software code and designed websites to help people book scarce COVID-19 vaccinations online, raising concern about an unfair advantage for the tech savvy and jeopardising chances of an equitable vaccine rollout.

India has faced criticism for a slow vaccine campaign as it battles a second wave of coronavirus infections that is seeing about 350,000 new cases recorded every day. Only 2% of its 1.3 billion population have been fully immunised.

The government further opened up vaccination for adults from May 1 but registration on its CoWIN website is mandatory for those between the ages of 18 and 44. Slots are hard to get as demand far outstrips



In a bid to streamline the process, computer experts have used the publicly available coding of the CoWIN platform to create websites that post results every few minutes

after running automated searches on the government website.

Alerts are sent over email and routed to several Telegram app chat groups where thousands are waiting. Berty Thomas, 35, automated

a search to book himself a slot then created a website - under45.in which checks for slots and sends alerts to about 100,000 people in 60 Telegram groups in various cities.

I feel happy I'm able to use my skills to help people get vaccines, said Thomas, an investment banker based in the southern city of

Shyam Sunder said his website getjab.in - was notifying users by email when slots become available. Some 80,000 people from 400 districts across the country had registered with his site, he said.

But the technological workarounds are facing criticism from those who say they sacrifice the goal of vaccine equity in a country where many people - especially in rural areas - do not have the digital skills to join the online hunt.

What we need Free and equitable vaccination policy. What we have got Techies making use of scripts to quickly book off the entirety of whatever little vaccine slots that Twitter user Rakshith said.

R S Sharma, chairman of the government panel managing the CoWIN platform, told security measures were in place and there was no unfair use of the booking platform, which he said was getting 55,000 hits a second.

STRESSFUL LOTTERY

To book a slot, users of the CoWIN website need to log in with their mobile phone number and get a one-time password, before beginning their hunt of vaccine centres

via an area code or district name. In the short time that takes, slots

often get snapped up.

Authorities in the city of Mumbai have faced criticism for issuing a notice on Twitter Tuesday telling people to get ready as limited slots were opening in minutes, wishing the

hopeful all the best. Playing a stressful lottery every day is in extremely bad taste, Twitter

user Nanaki wrote In their defence, Mumbai authorities wrote on Twitter they were trying their best and just wanted to keep the communication light. Those in rural areas with limited or no access to high-speed internet or

smartphones are bound to lose out. Driver Dhanamali Bariha, 28, in the eastern state of Odisha, said he wanted to get vaccinated but was stumped by the online registration.—

Separatist leader Sehrai dies

Jammu: Prominent separatist leader Mohammad Ashraf Sehrai, who was arrested under the Public Safety Act in July last year, died at a hospital here Wednesday, officials said. Sehrai, 77, a close confidant of hardline Hurrivat Conference leader Sved Ali Shah Geelani, was incarcerated at the district jail in Udhampur. He was shifted to Jammu's Government Medical College (GMC) hospital after his health deteriorated on Tuesday, the officials said. Sehrai, who replaced Geelani as chairperson of the Tehreek-e-Hurriyat in 2018, had tested negative for COVID-19 in a rapid antigen test. His RTPCR report is still awaited, they said.

Blaze in Noida slum

Noida (UP): A major fire broke out Tuesday night in a slum in Noida after which a dozen fire tenders were rushed to the spot that doused that flames, officials said. The police said they were alerted about the fire in Barola village in Sector 50 around 8.30 pm and officials from the local Sector 49 police station were immediately deployed. "The chief of the Fire Department along with his teams also rushed to the site. 12 fire tenders were used that doused the flames and controlled fire in about two hours," a police official said.

Wrestler dies after fight with colleagues

New Delhi: Two-time Olympic medallist Sushil Kumar's role is under scanner after his name emerged in connection with a brawl that led to the death of a wrestler inside the Chhatrasal Stadium complex in north Delhi, police said. Kumar, the county's only athlete to have won two individual Olympic medals, was named in the FIR, they said.

Man shot dead

Moradabad (UP): A man was shot dead by unidentified assailants who were fleeing after looting his house, while one of the robbers was beaten to death by villagers in this district of Uttar Pradesh, police said. According to police, a group of assailants entered the house of farmer Riyasat in Sadar Nagar village Tuesday night and allegedly looted valuables worth over ₹2 lakh. Riyasat's son Shahzad (25) tried to chase the robbers but they opened fire on him which lead to his death on the spot, Superintendent said.

THIRD WAVE OF **COVID 'INEVITABLE'**

New Delhi, May 5: The government Wednesday said that a third wave of coronavirus pandemic was "inevitable", although a timeframe for it could not be predicted.

In a press briefing by the Ministry of Health Affairs Wednesday, officials said the long COVID wave of such "ferocity" that the country was experiencing currently "was not predicted". Twelve states, including Maharashtra, Karnataka, Kerala and Uttar Pradesh, have more than 1 lakh active COVID cases, the government said.

Karnataka, Kerala, Tamil Nadu, West Bengal, Rajasthan and Bihar are among the states that show increasing trend in daily cases, it said.

The government also said that 24 states and UTs show more than 15 per cent COVID positivity rate. From May 1, 6.71 lakh people in the age group of 18-44 years in nine states have been administered the vaccines, it added. "Phase three is inevitable given the higher levels of circulating virus, but it is not clear on what time-scale this phase three will occur. We should be prepared for new waves," said K Vijay Raghavan, the principal scientific advisor to the Centre. Member, NITI Ayog, Dr VK Paul requested "physicians' fraternity" to come forward and provide teleconsulta-

RECORD RISE IN DAILY DEATHS

IAF brings 352 empty O₂ cylinders from abroad

New Delhi, May 5: Mighty transporters IL-76 of the Indian Air Force (IAF) brought 352 empty cylinders and cryo-containers from Singapore and Bangkok respectively Wednesday to combat oxygen crunch in the country, officials said.

One of the IL-76 brought empty oxygen cylinders from Singapore to Delhi which is facing an acute shortage of medical oxygen amidst another wave of coronavirus.

"The IL-76 is picking up 352 empty oxygen cylinders for Delhi. This Union Home Ministry coordinated exercise will help in increasing oxygen availability amid the current COVID-19," a Home Ministry spokesperson said Wednesdav. Another one transported three cryocylinders from Bangkok to its Panagarh base in West Bengal, he said. Pictures of IL-76s picking up empty cylinders and cryo-containers was also issued by the Press



Information Bureau. Meanwhile, the European Union Wednesday announced an initial Euro 2.2 million (approx Rs 19 crore) in emergency funding to support the World Health Organisation's measures to help India deal with increasing cases of COVID-19.

Meanwhile, the Supreme Court Wednesday heard Centre's appeal against Delhi High Court's order of issuing contempt notice and seeking personal appearance of its officials for non-compliance with the directions on supply of 700 MT oxygen daily to treat COVID-19 patients in the national capital. The apex court stayed contempt proceedings against central government officials saying putting officers in jail would not bring oxygen and efforts should be made to save lives.

A bench headed by Justice D Y Chandrachud said that it had ordered supply of 700 MT oxygen to Delhi daily from May 3 as the pandemic in Delhi was at a very critical stage. "Tell us how much oxygen you have allocated to Delhi in the last three days," the bench said. Overstretched health infrastructure is gasping for breath because of an acute shortage of medical oxygen in the city after serious COVID cases started flooding the hospitals. Several hospitals approached the Delhi High Court and made SOS pleas on social media, saying their oxygen supplies were running out.

On Tuesday, the Delhi High Court asked the Centre to show cause why contempt should not be initiated against it for failing to comply with order on supply of oxygen to Delhi for treating COVID-19 patients. The high court noted that the apex court has already directed, and now the high court is also saying that the Centre will have to supply 700 MT oxygen daily to Delhi right away by whatever means.

In a tweet, External Affairs Minister S Jaishankar, who is heading the Indian delegation at the G7 summit in London, revealed that he is attending the meetings virtually because he may have been exposed to the infection.

Was made aware yesterday evening of exposure to possible Covid positive cases. As a measure of abundant caution and also out of consideration for others, I decided to conduct my engagements in the virtual mode. That will be the case with the G7 Meeting today as well." Jaishankar tweeted.

Posting a picture of him attending the meeting virtually, he further tweeted, "A cyber participation at the G7 Foreign Ministers' Meeting. So far, yet so near."

Jaishankar also revealed that he had a useful virtual meeting with the Foreign Minister of

Canada, Marc Garneau, on the sidelines of the G7 summit.

"Discussed our respective Covid challenges. Talked about various aspects of our bilateral relationship. Also exchanged views on Myanmar." he said. The Indian delegation, as per the British media, had tested negative for Covid-19 before departing for the UK. But on arrival in London, in the tests conducted by Public Health England (PHE), two of the members tested positive.

British media reported that all physical meetings between the Indian delegates and their counterparts from Britain, Canada, France, Germany, Italy, Japan and the US were cancelled immediately. The meetings are being held virtually. Though not a part of the G7. India was invited by the Boris Johnson government to join the summit as a guest. Cheap antibiotics sold as 'life saving' drugs

life saving drugs. Instead of Remdesivir, which is required for critically ill Covid patients, similar looking vials of Monocef or Zetri, a low cost antibiotic injection,

are being sold in the black market. Criminal gangs and swindlers active in Delhi-NCR and Western Uttar Pradesh are reportedly buying Monocef vials in bulk, each piece costing around ₹52, and selling them to desperate customers for over ₹5,500 to ₹10,000 apiece. Taking note of such rackets gradually reaching the smaller towns and rural areas, the Uttar Pradesh Police have alerted all the districts, particularly in western and central parts of the state, to keep a strict vigil on the stockists, distributors and wholesalers of medicines.

Security Act," Prashant Kumar, Police (ADG), Law and Order, UP, said. Acting on specific inputs, the Delhi Police on Tuesday unearthed a gang involved in selling fake vials of Remdesivir for ₹5,500 each. The gang, which was active in the Nand Nagri area of the national capital, had purchased low cost Monocef injections in bulk. "They got labels of Remdesivir printed from a local press fixed them on the Monocef vials. And it's not only in Delhi-NCR and its neighbouring states where such rackets are thriving. Fake Remdesivir injections are being sold in far off places like Gujarat and Odisha. In a major crackdown on such rackets, the Detection and Crime Branch of Ahmedabad Police arrested seven persons last week who were selling antibiotics as Remdesivir.

After the arrival of the new batch, the number of Rafale jets with the IAF will go up to 21. The new squadron of Rafale jets will be based in Hasimara airbase in West Bengal.

The first Rafale squadron is based in Ambala air force station. A squadron comprises around 18 aircraft. India had signed an inter-governmental agreement with France in September 2016 for the procurement of 36 Rafale fighter jets at a cost of around Rs 58,000 crore.

Intel alert on Hefazat radicals fleeing into India

Kolkata, May 5: Indian intelligence has been alerted by their Bangladeshi counterparts about scores of Hefazat-e-Islam militants fleeing into neighbouring Indian states like West Bengal and Assam, which were caught up

with conducting polls until recently. A top official of a central intelligence agency said that Bangladesh's Sheikh Hasina government has initiated a massive crackdown on the Hefazat-e-Islam after the Islamist radical group unleashed a violent campaign opposing Prime Minister Narendra Modi's

visit to Bangladesh in March. More than 50 top Hefazat leaders and some belonging to other Islamist jihadi terror groups have been ar-

rested and nearly 300 donors who paid into Hefazat coffers have been identified. That includes top Hefazat leaders like Mamunul Huq who has reportedly confessed now that his group had set itself the objective of toppling the Hasina government and establishing a Taliban type Islamic state in Bangladesh.

Bangladesh intelligence, with whom its Indian counterparts share excellent information-sharing relations, has told Indian agencies that they have reports that some Hefazat topshots have fled or are trying to flee into Indian states like West Bengal and Assam.

'We take their alerts seriously because fleeing Islamist radicals can easily melt into states like West Bengal and Assam, where the administration and police was until

recently focussed on conducting elections. We have alerted state police forces and the BSF to be extra vigilant," the top central intelligence agency official said.

Covid scare at G7 meeting

The Group of Seven foreign ministers' meeting in London was hit by a Covid-19 scare Wednesday when India's foreign minister and his entire team said they were self-isolating after two delegation members tested positive



London, May 5: Britain is hosting the three-day meeting, the first such G7 event in two years that has been heavily billed as a chance to restart face-to-face diplomacy and an opportunity for the West to show a united front against threats from China and Russia.

India, currently undergoing the world's worst surge in COVID-19 cases, is attending the G7 as a guest and had been due to take part in meetings Tuesday evening and throughout Wednesday.

'Was made aware yesterday evening of exposure to possible Covid positive cases," Indian Foreign Minister Subrahmanyam Jaishankar said on Twitter.

"As a measure of abundant caution and also out of consideration for others, I decided to conduct my engagements in the virtual mode. That will be the case with the G7 Meeting today as well.

The meeting is a precursor to the main G7 summit due to take place at a rural English resort in June, with US President Joe Biden and other world leaders set to attend.

A British official confirmed the two positive tests and said the entire Indian delegation was self-isolating. British rules require a 10day self-isolation period.

The Indian delegation had not yet

attended the main summit venue at Lancaster House, and so meetings scheduled for Wednesday went ahead as planned

Asked if, in light of the positive tests, it had been a mistake to hold the summit in person, Prime Minister Boris Johnson said: "I think it's very important to try to continue as much business as you can as a government.'

Johnson said he would speak with Jaishankar later Wednesday

British foreign minister Dominic Raab was seen greeting and fistbumping other G7 members as they arrived at the venue.

"We deeply regret that Jaishankar will be unable to attend the meeting today in person," a senior UK diplomat said. "This is exactly why we have put in place strict Covid protocols and daily testing.'

Iran envoy drops appeal in bomb plot conviction

Tehran, May 5: An Iranian diplomat sentenced to 20 years in prison for planning a bomb attack in France has dropped an appeal in Belgium and will serve his sentence, his representative said Wednesday.

Belgian authorities have said they will oppose any potential swap deal with Western prisoners, lawyers said.

Assadolah Assadi was found guilty of attempted terrorism in February after a foiled plot to bomb a 2018 rally of the National Council of Resistance of Iran (NCRI), a French-based dissident

It was the first time an Iranian official had been tried for suspected terrorism in Europe since Iran's 1979 revolution.

"This has been a political trial since the beginning and he does not want to participate any longer," Assadi's lawyer Dimitri de Beco told reporters in Antwerp, where he was sentenced on Feb 4.

Judges had ruled that diplomatic immunity as third counsellor at Iran's embassy in Vienna did not protect Assadi from charges of using the post for statesponsored terrorism.

In its ruling, the Belgian court said it ran a state intelligence network and Assadi bought explosives for the Paris plot with him on a commercial flight to Austria

Nepal's Oli govt now in minority

Maoist's decision comes days before Prime Minister Oli had decided to seek a vote of trust from Parliament May 10.


Through the vote of confidence, Oli will try to prolong his stay while the Opposition will try to unseat him who are now struggling to get required magic numbers to remove him.

Canada okays Pfizer vax for age 12 to 16

Toronto, May 5: Canada's health regulator has authorised Pfizer's Covid-19 vaccine for ages 12 to 16. a person familiar with the decision the told the Associated Press Wednesday.

The official spoke on condition of anonymity, as they were not authorized to speak ahead of the upcoming announcement.

The US Food and Drug Administration is also expected to authorize Pfizer's vaccine for voung by next week, setting up shots for many before the beginning of the next school year. The announcement comes barely a month after the company found

that its shot, which is already authorized for those age 16 and older, also provided protection for the younger group.

Pfizer in late March released preliminary results from a vaccine study of 2,260 US volunteers ages 12 to 15 showing there were no cases of Covid-19 among fully vaccinated adolescents compared with 18 among those given dummy shots.

Kids had side effects similar to voung adults, the company said. The main side effects are pain, fever, chills and fatigue, particularly after the second dose. The study will continue to track participants for two years for more information about longterm protection and safety.

60 years since 1st American in space: Tourists lining up

Cape Canaveral, May 5: Jeff Bezos' Blue Origin company is finally opening ticket sales for short hops from Texas launched by a rocket named New Shepard Wednesday the 60th anniversary of Shepard's Mercury flight.

Richard Branson's Virgin Galactic aims to kick off tourist flights next year, just as soon as he straps into his space-skimming, plane-launched rocketship for a test run from the New Mexico base.

And Elon Musk's SpaceX will launch a billionaire and his sweepstakes winners in September. That will be followed by a flight by three businessmen to the International

Space Station in January.

"It's a huge leap, right?" said NASA astronaut Shane Kimbrough, commander of SpaceX's most recent flight to the space station. "But it's pretty cool ... Citizens will be able to have the chance to go to space and experience what we get to.'

It's all rooted in Shepard's 15minute flight May 5, 1961.

Shepard was actually the second person in space — the Soviet Union launched cosmonaut Yuri Gagarin three weeks earlier, to Shepard's everlasting dismay. The 37-year-old Mercury astronaut

and Navy test pilot cut a slick scifi figure in his silver spacesuit as he stood in the predawn darkness at Cape Canaveral, looking up at his



Redstone rocket. Impatient with all the delays, including another hold in the countdown just min-

utes before launch, he famously growled into his mic: "Why don't you Sixty years after Alan Shepard became the first American in space. everyday people are on the verge of following in his cosmic footsteps

this candle?"

His capsule, Freedom 7. soared to an altitude of 116 miles (186 kilometers) before parachuting into the Atlantic

Twenty days later; President John F. Kennedy committed to landing a man on the moon and returning him safely by decade's end, a prom11's Neil Armstrong and Buzz Aldrin.

Shepard, who died in 1998, went on to command Apollo 14 in 1971, becoming the fifth moonwalker and lone lunar golfer.

Since Gagarin and Shepard's pioneering flights, 579 people have rocketed into space or reached its fringes, according to NASA. Nearly two-thirds are American and just over 20% Soviet or Russian.

"Our goal is one day that everyone's a space person," NASA's human spaceflight chief, Kathy Lueders said following Sunday's splashdown of a SpaceX capsule with four astronauts. "We're very excited to see it starting to

New Delhi, May 5: The Department Telecommunications (DoT) has permitted telecom service providers (TSPs), including Bharti Airtel, Reliance Jio Infocomm, Vodafone Idea, and MTNL, to conduct 5G trials. As largely anticipated, Chinese

An official statement said that the TSPs have tied up with original equipment manufacturers and technology providers -- Ericsson, Nokia, Samsung and C-DOT. In addition, Reliance Jio Infocomm will also be conducting trials using its own indigenous technology.

The permissions have been given by the DoT as per the priorities and technology partners identified by TSPs themselves. The experimental spectrum is being given in various bands which include the mid-band (3.2 GHz to 3.67 GHz), millimetre wave band (24.25 GHz to 28.5 GHz) and in sub-Gigahertz band (700 GHz).

2nd wave may derail strong recovery: S&Ps

New Delhi, May 5: The second wave of Covid infections may derail a budding recovery in the Indian economy and credit conditions, S&P Global Ratings said Wednesday projecting a lower than previously anticipated GDP growth rate in different scenarios.

S&P, which in March had seen Indian economy growing by 11% in the fiscal year to March 2022, saw GDP growth rate dropping to 9.8% under 'moderate' scenario where infections peak in May, and falling to as low as 8.2% under 'severe' scenario under which caseload would peak only in late June.

RBI declares liquidity measures for healthcare infra, services firms

Mumbai, May 5: Amid spurt in coronavirus cases, RBI Wednesday announced an on-tap liquidity window of ₹50,000 crore for companies engaged in healthcare infrastructure and services.

The facility of on-tap liquidity with tenors of up to three years at the repo rate will remain open till March 31, 2022, RBI Governor Shaktikanta Das said while announcing steps to deal with the impact of the second wave of coronavirus pandemic.

Under the scheme, banks may provide fresh lending support to a wide range of entities including vaccine manufacturers, importers/suppliers of vaccines and priority medical devices, hospitals and dispensaries, pathology labs, manufactures and suppliers of oxygen and ventilators, importers of vaccines and Covid-related drugs, logistics firms and also patients for treatment. The banks, Das said, are being incentivised for quick delivery of credit under the scheme through extension of priority sector classification to such lending up to March 31, 2022

These loans, he added, will continue to be classified under priority sector till repayment or maturity, whichever is earlier.

"Banks may deliver these loans to borrowers directly or through intermediary financial entities regulated by the RBI. Banks are expected to create a COVID loan book under the scheme," the Governor said. 
sector activities eased to a threemonth low in April, as the rise in business activity was constrained by the pandemic and sentiment towards growth prospects faded, a monthly survey said Wednesday. The seasonally adjusted India Services Business Activity Index fell to 54 in April from 54.6 in March, the slowest increase in output in three months.

In PMI parlance, a print above 50 means expansion while a score below 50 denotes contraction. "The PMI results for April showed

a more resilient economic performance for the service sector than expected given the escalation of the crisis in India," said Pollyanna De Lima, Economics Associate Director at IHS Markit.

She further noted that firms foresee higher output volumes over the course of the coming year, but business sentiment was dampened by worries surrounding the pandemic. As per the survey, Indian services firms were optimistic regarding the 12-month outlook for business activity, but the overall level of positive sentiment fell to the lowest since last October. The escalation of the pandemic was the main drag on confidence.

On the prices front, service providers noted the steepest rise in

overall expenses since December 2011. Some firms lifted their selling prices in April amid the pass through of rising cost burdens to clients, but 98 per cent of companies left fees unchanged due to efforts to secure new work and remain competitive.

Manchester, May 5: By the time Riyad Mahrez completed the counterattack that sealed Manchester City's spot in a first Champions League final, it looked so effortless overcoming a PSG line-up that lost its cool and composure.

It was the Paris-born winger who netted twice before PSG had Angel Di Maria sent off. City won 2-0 to eliminate last season's finalists 4-1 on aggregate, Tuesday.

It's been anything but comfortable for City getting a shot at lifting European football's top prize for the first time despite 13 years of lavish investment. Even reaching this semifinal required a fight in court to overturn a ban from this season's Champions League for breaching UEFA's financial rules.

And it's only two weeks since the Abu Dhabi-owned team exposed itself to fresh sanctions for joining a brief, ill-fated bid to split to help form a breakaway European Super League.

Now City could win the competition it tried to leave in what could be an all-English final May 29 in Istanbul if Chelsea overcomes Real

Madrid. Chelsea and Real Madrid played to a 1-1 draw in the first leg.

It's not just City that's endured frustration in its quest to win the biggest prize in European football. Pep Guardiola, a Champions League winner as Barcelona coach in 2009 and 2011, has been waiting a decade to return to the final.

He fell short three times with Bayern Munich and has taken until his fifth season at City to even reach the semifinals.

City is now accustomed to success — sitting on the brink of its third Premier League title in four seasons after already collecting the League Cup last month. But its only continental title came with the now-defunct European Cup Winners' Cup in 1970.

Zinchenko passed to Kevin De Bruyne, whose shot was blocked by Keylor Navas but Mahrez was alert to the rebound to put the ball through the goalkeeper's legs on a field covered in the remnants of a spring hailstorm.

Mauro Icardi was proving ineffective in a PSG attack shorn of Kylian Mbappe, who wasn't fit enough to start and never entrusted with being deployed from the bench.

There were headers over from Marquinhos and Neymar but PSG could find no way past a defense that had Ruben Dias proving such a robust barrier.

The PSG back-line was easier to breach, which happened again in the 63rd minute. There was a surging run down the left flank by Phil Foden before a combination with De Bruyne and a cross delivered for Mahrez to sweep into the net.

ARSENAL'S 25-YEAR RUN IN EURO EVENT ON LINE

London, May 5: So much for Arsenal being one of the elite soccer clubs in Europe. Three weeks after being among the instigators of the controversially closed-off and ultimately ill-fated Super League, the English team is facing the ignominy of being shut out of continental competition for the first time in 25 years.

A failure to overturn a 1-2 deficit against Villarreal in the Europa League semifinals Thursday would end Arsenal's quarter-century run of participating in either the Champions League or UEFA's secondary club competitions.

Such a degrading of status would be ironic, considering the planned Super League — devised and then aborted within a chaotic 48-hour period last month — would have positioned Arsenal as one of 12 elite teams in the European game.

The significance of the match against Villarreal, likely to be played against the backdrop of more fan protests against Arsenal's American ownership for its involvement in the Super League project, isn't lost on Mikel Arteta.

It's not just Arteta's future that could be on the line on Thursday. Arsenal's ability to attract players for next season, and to retain the services of its own best players,

might hinge on winning the Europa League and gaining the bonus prize of qualifying for next season's Champions League.

Arteta delivered the FA Cup to Arsenal in August, at the end of his
