SINGLE SPUTNIK DOSE



MOSCOW: Russian authorities gave regulatory approval Thursday to a single-dose version of the country's Sputnik V vaccine. They argued that the move could accelerate the process of achieving herd immunity against Covid-19. Named 'Sputnik Light', the new version is identical to the first dose of the two-dose Sputnik V. Russia started human trials of 'Sputnik Light' in January and is currently assessing results. 'Sputnik Light' is the fourth domestically developed Covid-19 vaccine approved in Russia. President Vladimir Putin said, "It's nice to know that this range of tools (against COVID-19) is expanding.'





Pvt hospitals to continue vax

18-45 YEARS AGE GROUP BENEFICIARIES CAN GET THE INJECTION BY PAYING ₹100 AT FACILITIES

POST NEWS NETWORK

Bhubaneswar, May 6: With the aim to speed up vaccination in Odisha, the state government has allowed private hospitals to administer the jab to persons in the 18-45 years age group. Vaccination of people in 45-plus category will henceforth be available for free at all government-run medical facilities, Additional Chief Secretary PK Mohapatra said Thursday.

"Many private hospitals were engaged in vaccination, charging recipients ₹250 per shot. However, since May 1, the Centre stopped providing vaccines to private facilities and asked them to procure it on their own. As they have failed to do so, the Odisha government will provide these facilities with vaccines so that the speed of the drive increases. The 18-plus populace will have to pay ₹100 to the private hospital from which they will get the jab," informed Mohapatra. He also said about 17 lakh persons are waiting for second dose in Odisha.

Mohapatra informed that there is abundant quantity of the Covaxin jab which is being provided to people in the BMC area. "The rest of the state is being given the Covishield injection and the problems regarding it is well known," he said. "The chief minister, health minister and other officials have repeatedly written to the Centre to provide us with the

Covishield vaccine. We have demanded 15 lakh doses of it. Hopefully we will get it soon," he added.

ODISHA REGISTERS RECORD SPIKE

BHUBANESWAR: Odisha's COVID-19 tally breached the five-lakh mark Thursday with 10,521 fresh cases. It is the highest so far in a single day reported in the state. It pushed the tally in Odisha to 5,00,162. In the last 24 hours 17 fresh fatalities has taken the toll to 2,121, a senior health department official said. The number of people infected by the virus in the state capital went past the 50,000mark with 1,118 new cases. This is the highest single-day spike in the City, added the official. Naveen demands exemption of GST

Bhubaneswar, May 6: Seeking active cooperation of the Centre in the fight against the pandemic, Odisha demanded Thursday exemption of GST on the purchase of coronavirus vaccines and sought financial assistance to states from the cess and surcharge collected by the Union government from various products. At present five per cent GST is charged for coronavirus vaccines. States have been asked to purchase vaccines from their resources for inoculating people between the ages of 18 and 45.

Odisha Chief Minister wrote Thursday to Union

Finance Minister Nirmala Sitharaman on this issue. "I hope the suggestions will be examined and urgent necessary action is taken in view of the emergency health situation in India and to strengthen our unified fight against Covid. If vaccines are exempted from GST, it will reduce the cost on the part of the states. and facilitate the drive towards universal vaccination," the chief minister said.

In a related development, Patnaik sanctioned an additional amount of over ₹7.50 crore to Puri. Subarnapur. and Sambalpur districts from the Chief Ministers Relief Fund (CMRF) for Covid-19 management.

BBIL urged to start vaccine production

Bhubaneswar, May 6: Facing an acute shortage of Covid-19 vaccine, the Odisha government has asked Bharat Biotech to start Covaxin production by June next year in the state. Bharat Biotech International Ltd (BBIL) had taken 30 acres of land to set up a vaccine unit at Andhrua, on the outskirts of the capital city. However, the project till date, remains a nonstarter for reasons best known to the authorities.

The foundation stone for the project was laid twice. The stone for the Biotechnology Park was laid October 25, 2009 while the groundbreaking ceremony for setting up of a multiple human vaccine production plant was laid November

EC should take criticism in right spirit, says apex court

New Delhi, May 6: The Supreme Court said Thursday that constitutional authorities should perform better rather than complain and ask for restrictions on the media. It was hearing the Election Commission's (EC) petition complaining about media reports on the Madras High Court telling the poll body it should be 'booked for murder' for not stopping political rallies amid Covid-19. The apex court observed that the question of expunging the Madras High Court's critical remarks does not arise as

they are not part of a judicial order. A bench headed by Justice DY Chandrachud acknowledged however that the high court's remarks were 'harsh' and at times 'off the cuff' remarks are susceptible for misinterpretation'. The bench, also comprising Justice MR Shah, said the media cannot be restrained from reporting observations made



during the course of hearings.

The bench lauded the high courts for commendable work done by them in effectively supervising Covid-19 pandemic management. "It will be retrograde to restrain HCs from making observations or gagging media from reporting observations," the top court said

Courts have to remain alive to evolving technology of the media and it is not good if it is restrained from reporting judicial proceedings, the bench said. The apex court further stated that Article 19 of the Constitution not only gives the right to freedom of speech and expression to people but also confer the same right to media.

Fuel prices hiked for

New Delhi, May 6: In one of the steepest increase since daily rate revision started again, petrol price Thursday was hiked by 25 paise per litre and diesel by 30 paise as oil companies raised rates. Petrol price in the national capital was increased to ₹90.99 per litre from ₹90.74 while diesel rates went up to ₹81.42 a litre from ₹81.12, according to a price notification by state-owned fuel

This is the third straight day of increase in petrol and diesel prices since state-owned fuel retailers ended an 18-day hiatus in rate revision during Assembly elections in states like West Bengal.

Rates have been increased across the country and vary from state to state depending on the local incidence of taxation (VAT)

In three days, petrol price has increased by 59 paise per litre and diesel by 69 paise. The hike has neutralised most of the reduction that came between March 24 and April 15. State-owned fuel retailers, IOC, BPCL and HPCL had reduced petrol price by 67 paise a litre and diesel by 74 paise per litre effected between March 24 and April 15.

Oil companies, who have in recent months resorted to unexplained freeze in rate revision, had hit a pause button after cutting prices marginally on April 15. This coincided with electioneering hitting peak to elect new governments in five states including West Bengal.

However, now officials said prices have been on a continuous uptrend since April 27. They added that crude oil prices are near USD

"I am safe, but my driver was injured, few car windows were also smashed. the minister stated.

Bhubaneswar, May 6: The Bhubaneswar Municipal Corporation (BMC) has decided to hire medical officers, nurses, pharmacists and other healthcare professionals on temporary basis to manage the worsening Covid-19

The additional district urban & public health officer (ADUPHO) invited applications from eligible Ayush Medical Officers (AMOs), unemployed and registered auxiliary nurse and midwives (ANMs). staff nurses and pharmacists to be engaged on a daily wage basis for Covid management.

'We are taking steps to increase our manpower to efficiently manage the pandemic in coming days. At present, we have about 70 staffmembers under each category. We are looking for additional 20-30 AMOs, about 50 ANMs and 100 nurses. The additional force will be engaged in administering vaccines, management of Covid care centres, distribution of Covid kits and other activities," said a BMC official.

The official also mentioned that the new recruits would work on a temporary basis for a period of three months. The merit list will be prepared based on marks obtained in their professional or degree



Meanwhile the department has also forecast light to moderate rains in different parts of the state. Similar trends are likely to prevail in the next three days as per the weather prediction of the department. The department however said that chances of change in the maximum day time temperature in the state for the next four days are low. After that the temperature is likely to rise by 2 degree to 3 degree Celsius in different parts of the state

The IMD also said maximum and minimum temperatures in the state capital are very likely to be around 37°C and 25°C respectively.

Thursday, the highest temperature was recorded in Sonepur which saw 40.8°C while the minimum temperature i.e. 18.5°C was recorded in Daringbadi.

The cyber help desk opened at the office of Deputy Commissioner of Police (DCP) has received 476 calls from victims from various parts of the state who lost their money to such criminals in April.

According to the data shared by the Commissionerate Police, the cyber fraudsters duped ₹1,19,63,297 from 476 victims in April only.

However, the actual amount whisked away by the fraudsters would be several times more since many people are unaware of the help desk in the state. The desk exclusively investigates fraud cases reported by denizens of the Bhubaneswar Urban Police District (UPD) only.

Bhubaneswar, May 6: The state has so far dispatched as many as 345 tankers carrying 6,354.742 metric tonne (MT) of medical oxygen with a police escort from Rourkela, Jajpur, Dhenkanal and Angul districts to at least 10 states facing acute shortage of the life-saving gas in treating Covid patients, an official said Thursday

According to the data shared by state police, as many as 35 tankers were dispatched from Angul with 585.98 MT of oxygen, 84 from Dhenkanal with 1322.78 MT of the life-saving gas, 88 from Jajpur with 1815.99 MT of oxygen and 138 tankers from Rourkela with 2629.992 MT of the gas

"As many as 105 tankers with 2147 MT of oxygen were sent to Andhra Pradesh, while 97 tankers with 1657.109 MT of oxygen were sent to Telangana. Tamil Nadu received seven tankers with 136.42

234.36 MT of oxygen were sent to Maharashtra, while 243.461 MT of oxygen-filled in 16 tankers have left for Chhattisgarh. While 27 tankers have carried around 488.68 MT of oxygen to Uttar Pradesh, 35 tankers with 601.52 MT of oxygen were sent to Madhya Pradesh.

Moreover, two tankers with 33 MT of oxygen were sent to Delhi and one tanker with 29.32 MT sent to Punjab in the last 14 days.

Notably, a special cell has been formed under ADG (Law and Order) YK Jethwa to monitor the transportation of medical oxygen by Odisha to various states facing a deficit of medical oxygen.

The state owned Odisha State Handloom Weavers Cooperative Society Ltd (OSHWCS) popularly known as Boyanika acts as an intermediary in providing marketing support and quality raw materials to scores of weavers in the state. The weavers function under primary weavers cooperative societies and produce quality handwoven fabrics. However, the members of the

Odisha Weavers Federation have alleged that Boyanika is spending the fund in buying clothes from its

She said the committee has purfrom two agencies in her own district instead from local weavers.

CB probe looks at multiple angles

Sonepur, May 6: The State Crime Branch has intensified its investigation into financial wrongdoing in the National Health Mission(NHM) in Sonepur. The CB, which is looking at multiple angles linked to the fraud, has arrested Samir Pati, a resident of Rourkela Thursday.

Notably, cyber fraudsters have allegedly managed to withdraw over ₹5.1 crore from the bank account of NHM at the district headquarters hospital.

The cyber fraud came to the fore after district accounts manager of the NHM Saroj Kumar Panda filed a written complaint in this regard a few days ago.

The Economic Offence Wing of the Crime Branch, Bhubaneswar, is looking into the matter.

A four-members CB team led by DSP Iti Das started investigation

ing team visited the NHM office at the district headquarters hospital and enquired about monetary transactions through NHM. The CB officials have hinted that the fraud will be exposed soon.

NHM has its account (32333146321) at the main branch of the SBI here.

The CB came to know that money has been transferred online to acBank in Rourkela from the NHM account April 7. The account in the Central Bank has been opened in the name of MS Natural.

The NHM authorities came to know about the fraud after the SBI provided monthly account details to the former.

It is surprising, how such huge amounts of money were transferred without the knowledge of the NHM, that too through Public Financial Management System. It is suspected that someone might have provided ID and password of the NHM account. Without ID and password, it is not possible to transfer money from the NHM account

Docs swear by plasma therapy

Balasore, May 6: Even as the second wave of Covid-19 is sweeping across the state, doctors increasingly pin their faith on plasma therapy for the treatment of Covid-19 positive cases at the district headquarters hospital in Balasore, a re-

Notably, a plasma bank was inaugurated at the DHH August 18, 2020. Scores of Covid-19 patients from various parts of Balasore, Bhadrak and Mayurbhani are benefitting from the plasma therapy. Earlier, Covid patients from north Odisha used to go to SCB Medical College and Hospital in Cuttack to avail of plasma therapy.

Now, the plasma bank has 69 units of plasma in stock. The critically ill Covid patients are immediately provided with plasma therapy. Doctors say, as immunity in some Covid patients gets low, their condition worsens. In the second wave of the Covid-19, patients have poor immunity, leading to an increase in the number of fatalities.



If the plasma therapy is put to use in time, critical Covid patients have good chances of quick recovery, they added. Plasma therapy has proved beneficial for people affected by Swine Flu and Ebola. They added that even during the first wave of the Covid-19, patients have been treated successfully in the state. Experts say, about 80 per cent of the Covid-19 patients recover due to plasma therapy.

Chief district medical officer Dr Dulalsen Jagdev asserted that the district plasma bank received 59 units of plasma in 2020 and 28 Covid-19 patients were successfully treated then. In the current year, 38 plasma units were donated to the plasma bank while the bank is capable of preserving 200 units in -40 degree freezer, he added.

He further added that as Covid-19 infections are rapidly spreading in the district, adequate stock of plasma units will be ensured for patients in coming days.

lilicon Valley leaders tell us that the Fourth Industrial Revolution will bring untold benefits. They say it is already underway and accelerating, powered by artificial intelligence and other technologies, and warn that we will be left eating dust if we don't get with the program.

This upheaval – which also reflects the impact of robotics, bio- and nanotechnology, 5G, and the Internet of Things (IoT) – is a general-purpose revolution. Its leaders and their boosters promise that it will help societies to tackle climate change, address poverty and inequality, and stem the dramatic loss of biodiversity.

The revolution might play out like that. Or it might not.

Consider the most recent digital revolution, which brought us Google, Facebook, and Twitter, and changed the way information flows around the world. At first, the ability to connect to others online, and to create and share digital content seamlessly through ever-growing virtual social networks, seemed straightforwardly beneficial.

But today, the global flood of misinformation enabled by these platforms is making it more difficult to manage the Covid-19 pandemic and tackle climate change. Few realised what was happening until it was too late, and now we are dealing with the fallout. So, how can societies minimize the risk of inadvertent, ignorant, or willfully malicious use of the next generation of technology?

My work has increasingly focused on the collision of two worlds. The technosphere comprises the stuff that humans have created, which amounts to an estimated 30 trillion tons, or 50 kilograms per square meter of the Earth's surface. The biosphere is the thin layer clinging to the Earth's surface where life thrives, and where humans have enjoyed a 10.000-year stretch of relatively stable climate.

I first became interested in the relationship between these worlds while exploring the growth of semi-automated global early-warning systems for disease control. This made me appreciate how deeply technology alters human, organizational, and machine behavior. Sometimes that influence is linear, simple, and direct. But more often than not, the effects of technological change are indirect; they move through complex webs of causation and become visible to us only after a long time. Social media are a good example

The technosphere is all around us. It is on track to become so-called "cog-

nitive infrastructure," with the ability to process information, reason, remember, learn, solve problems, and at times even make decisions with minimal human intervention through increased automation and machine

In evolutionary terms, this may prove to be a giant leap. But decisions regarding the technosphere's design and direction must reflect social goals and the state of the planet. Building a more sustainable future therefore requires us to rethink some deeply held assumptions about the role of technology, and artificial intelligence in particular.

The biggest imperative may be to broaden the dominant "AI for climate change" narrative. In its simplest form, this narrative focuses on using AI to predict climate, or to optimize energy systems or traffic flows. But the climate system is fundamentally connected to the biosphere, with its biodiversity, forests, oceans, and agricultural ecosystems. Developing and deploying AI responsibly to tackle urgent sustainability challenges requires embracing this connection with the living planet, and our role in it.

Moreover, framing AI's contribution in terms of optimization and efficiency is the

wrong way to think about bolstering the long-term resilience of people and the planet. Resilience – the ability to rebound from shocks and adapt ing conditions – requires diversity and redundancy. A city with one huge freeway through its center is vulnerable to gridlock if hit by a flash flood or terrorist attack. One that has many routes from one place to another is more resilient.

Systems that are optimized to maximize output (say, of a particular crop) are prone to shocks and changing circumstances. Optimizing agricultural land for maximum yields using predictive analytics and automation is a tempting strategy, but it could accelerate loss of local ecological knowledge, amplify existing inequalities, and increase reliance on monoculture in response to commercial pressures.

AI's potential to help address the climate challenge lies not in optimizing systems, but in augmenting people's capacities to become stewards of the biosphere. Such a broader view is urgently needed today. But there are two big risks in striving to direct intelligent machines to foster biosphere

The first is hype. As the pressures on our planet and the climate system increase, so will the hope that AI solutions can help "solve" deeply complex social, economic, and environmental challenges. Our knowledge about whether AI actually offers large climate benefits (and to whom) is limited. and existing assessments are often wildly optimistic, given what we know of technological evolution. All claims must be rigorously and independently tested as AI technologies evolve and diffuse over time.


The second risk is acceleration. The deployment of AI systems and related technologies like IoT, 5G, and robotics may well lead to more rapid loss of biosphere resilience and increased extraction of fossil fuels and the raw materials that underpin these technologies. For example, oil and gas firms are increasingly seeking to cut costs through digitization. According to one estimate, the market for digital services in the fossil-fuel sector could grow 500% in the next five years, saving oil producers about \$150 billion annually.

Digitisation, automation, and AI have untapped potential both to strengthen sustainability and to optimize exploitation. To harness the Fourth Industrial Revolution to sustainability, we need to start directing its technologies better and stronger now.

So far Finance Minister Nirmala Sitharaman has refused to budge as her economy has collapsed over almost -23.9 plus another about 8 per cent since June 2020. invoked National Disaster Management Act 2005 merely to amass power, did come out with a road map of a year ahead. But, the nation remained adrift in complacence of "having conquered" Covid-19 and patting of self back, only to realise a year later that it has once again been failed, infections are spurting, oxygen and medicines unavailable - sorry nobody ever thought the country would need these. Millions are losing lives and the State remains a mute spectator leading the courts to intervene to stop the administration from smothering voices being raised against the monumental failure.

It is a year of massive failure that the Council of Ministers April 30 without listing an outcome, says the press release, "PM Narendra Modi said that all arms of the government are working unitedly and rapidly to deal with the situation". In 2014, the new NDA government decided to wind it down. It began the process of economic wilderness and whimsical decisions of demonetisation

on November 8, 2016, without even caring to discuss with a woman, who bore its brunt or introduce an abandoned GST by the Congress, severe joblessness and turning India's entrepreneurship into a

It followed putting brakes on the Indian Railways during the past one year, demolishing what the nation painstakingly built strong public sector organisations, Central Vista, an unnecessary new Parliament building and taking decisions to fill up the coffers of private companies, who have doubtful contributions to nation build ing. Destroying even the credentials of national institutions like HAL, which have build Sukhoi, Gnat and many others. The decisionmaking process was steamrolled during the past few years.

The latest indicators from the RBI on the banking system do not bring a happy note. The bank losses or NPAs are mounting. Credit squeeze is obvious. Rupee is plunging. Petrol prices are at an artificial high. The young students have become skeptical of claims and wonder if the country has not done a bit in 70 years what it aspires to sell to the sharks. 'Bed-for-cash' scam

Sir, Bangalore South Constituency BJP MP Tejasvi Surya has made startling revelations in media saying that a bed scam exists in Karnataka in an unprecedented scale. The team, which will also assess the ground situation in the state. is likely to visit several areas in the city as well as South 24 Parganas, Godkhali, Sunderbans and Jaggadal, they said.

The ministry had Wednesday sent a terse reminder to the West Bengal government to submit a detailed report on the post-poll violence and to take necessary measures to stop such incidents "without any loss of time"

It has also asked West Bengal Governor Jagdeep Dhankar to give a report on the law and order situation in the state, particularly the violence that took place following the election results May 2.

Chief Minister Mamata Banerjee Thursday said that 16 people have lost their lives in post-poll violence in the state. Also, the government plans to sign an agreement with private hospitals for free CT scan and other

medical tests of patients, the official said. At the meeting with senior bureaucrats, the Chief Minister reviewed the Covid-19 situation in the state. Covid is a big crisis for humanity. The only option to control the corona is to break the chain of infections



Madhya Pradesh zoos, tiger reserves put on alert



MP Forest officials and zoo authorities have been put on alert with eight Asiatic lions at the Nehru Zoological Park in Hyderabad testing positive for Covid-19

Bhopal, May 6: Madhya Pradesh Forest department officials and zoo authorities have been put on alert with eight Asiatic lions at the Nehru Zoological Park (NZP) in Hyderabad testing positive for Covid-19.

NZP officials were informed by the Centre for Cellular & Molecular Biology (CCMB) orally that the RT-PCR tests of these lions were positive. MP is home to the highest number of tigers in the country (526), and several other species.

Officials say, the zoos, tiger reserves, national parks, sanctuaries and safaris were already on

alert following an advisory from the Ministry of Environment and Forests (MoEF) regarding possibility of spread of Covid-19 virus among wild animals and deaths of lions

"With Hyderabad zoo lions testing positive we would be more cautious. However, there won't be any random testing. Collecting samples from lions and tigers in the zoo is not that easy. It will cause undue stress on them. But if we find any of them sick, we will follow the protocol," says Upendra Yaday, of Gwalior zoo, which hosts lions, tigers and leopards along with several other wild animals.

MoEF advisory, which was sent to MP among other states, calls for reducing human-animal interface citing reports of animals contracting the disease from both symptomatic and asymptomatic human carriers of Covid-19. It says, field functionaries must be Covid-19 negative when they are deputed for duties and should follow Covid-appropriate behavior. Besides, the constitution of a taskforce/rapid action force with field managers, veterinary doctors and frontline staff has been advised to manage the situation as quickly as possible. Officials have also been asked to set up essential services for emergency treatment of animals and their safe release back to natural habitats as and when required.

Also, the advisory mentions enhancing disease surveillance, mapping and monitoring systems through coordinated efforts amongst various departments. The MoEF has asked chief wildlife wardens of all states and Union Territories to close down the national parks/sanctuaries and other protected areas to tourists immediately and also to take all preventive measures to stop the transmission and spread of the virus from humans to animals and vice-versa.

The advisory says "In view of spread of Covid-19 in the country and reports of deaths of lions due to Covid-19, it is felt that there are possibilities of spread of the virus amongst animals in national parks/sanctuaries and other protected areas and also transmission of virus from human to animals and vice-versa.'

9 dead drinking meds to get high

Prepare for third wave: SC

During the hearing, the top court observed that Centre's oxygen formula required complete revamp

New Delhi, May 6: The Supreme Court Thursday asked the Centre to spell out its plan to deal with a possible third wave of the Covid-19 pandemic, even as it held that the Centre's formula to distribute oxygen to state governments, particularly the national capital, was a gross underestimate.

A bench comprising Justices D Y Chandrachud and MR Shah said, 'The third surge which is around the corner, according to experts, will affect children. What is the problem in enhancing the supply? It will save from oxygen panic and create a buffer.'

The top court told the Centre, which claimed though it supplied 730 MT oxygen Wednesday, that this much oxygen was not required in Delhi. However, it also emphasised need for a speedy vaccination process, and suggested forming a committee of experts for oxygen audit as sought by the Union government.

Earlier, during the hearing, the top court observed that Centre's oxygen formula requires complete revamp. If preparations are made right away, we may be able to tackle the third wave for which scientific planning to vaccinate persons would be needed, it said.

Elaborating on the third wave, the



top court observed that when a child goes to hospital, the mother and father will also have to go. That is why vaccination will have to be over for this group of people. We need to plan for this in a scientific way and thus make arrangement, it said. The Centre informed the top court that oxygen supplies may dip to 560 MT in the next two days. But the top court said that supplying 700 MT daily will help Delhi build buffer stock and panic will not be there among people.

Solicitor General Tushar Mehta, representing the Centre, submitted that the government must have

a solution thereby, to have a minimum fault-prone formula. We are not saying that formula is cast in stone. We will revisit the formula,

Justice Chandrachud told Mehta that important points were missed by the Centre's committee, which they, as judges, came across. We need to deal with it. I'm not saying it's the Centre's fault. I am saying that we need to deal with the third surge in a scientifically planned manner: he noted.

The bench added that if we prepare today, we may be able to handle it. It also urged the government to explore the possibility of utilising services of doctors who have completed MBBS and waiting to enroll for PG courses. Under these pressing times, their services could prove crucial for the third wave, it

All items received up to 5th May 2021 have been effectively allocated and promptly dispatched to the states/institutions. This is an ongoing exercise, the ministry said in a statement. It said the Empowered Group No 3 met Thursday under the chairmanship of NITI CEO Amitabh Kant to discuss ways and means of expediting the distribution of material aid received from abroad.

The meeting was attended by Union Secretary (I&B) Amit Khare, Union Secretary (Expenditure) Dr T V Somanathan, Additional secretary (MEA) Shrir Dammu Ravi, and Additional Secretary (Health) Arti Ahuja. Additional Secretary (MEA) told the meeting that as and when they come to know about the relief material leaving off shores, the information is sent to the Union Health Ministry which then works out the distribution plan.

Additional Secretary (Health



Ministry) said the distribution plans of material received from abroad are already in place by the time it lands in India.

The Centre has been receiving international donations and aid of COVID-19 relief medical supplies and equipment since April 27 from different countriesorganisations, the ministry said.

UK variant dominates North India, double mutant Maha, Guj, K'taka

New Delhi, May 6: The UK strain of coronavirus is currently dominating parts of north India while double mutant could be found mostly in Maharashtra, Karnataka and Gujarat, Sujeet Singh, Director of National Centre for Disease Control (NCDC), has said. He, however, added that the B1.1.7

lineage of SARS CoV-2 (UK variant) is declining in proportion across the country in the last month and a half. Addressing a press briefing Wednesday, Singh said the UK strain is dominating parts of north India including Punjab (482 samples) and Delhi (516), followed by Telangana (192), Maharashtra (83) and Karnataka (82).

He said 10 top gove oratories and institutions have been sequencing the genomes of coronavirus since December, A total of 18,053 samples have been sequenced so far, he added.

Singh said the information on genome sequencing has been shared with the states twice in February, four times in March

and again four times in April. He said in the video-confer-

Railways cancels premium trains

The to-and-fro services of eight Shatabdi Express, two Rajdhani Express, two Duronto Express and one Vande Bharat Express are among around 28 trains that have been cancelled till further advice by the Northern Railways.



Among these are Shatabdis originating from Delhi to places like Kalka, Habibganj, Amritsar, Chandigarh, Rajdhani trains from Delhi to Chennai, Bilaspur, Duronto trains to Jammu Tawi and Pune.

Poor patronisation of once popular trains also indicates that a lesser number of people are travelling amidst the surge in coron-

avirus cases, officials said. The Northern Railways has decided to cancel the following special trains due to poor patronisation and a surge in COVID-19, an NR spokesperson said.

The Central Railways has cancelled 23 passenger trains. These include Nagpur-Kolhapur special up to June 29, the CSMT-Kolhapur special up to July 1, the CSMT-Pune special up to June 30.

'No test needed after 10 days of home isolation in mild cases'

DO NOT ATTEMPT TO PROCURE OR **ADMINISTER** REMDESIVIR AT HOME, SAID THE **HEALTH MINISTRY GUIDELINES**

New Delhi, May 6: The Union Health Ministry has issued revised guidelines for home isolation for patients with mild or asymptomatic

symptoms. The new revised guidelines said,

"Patient under home isolation will stand discharged and end isolation after at least 10 days have passed from onset of symptoms (or from date of sampling for asymptomatic cases) and no fever for 3 days. There is no need for testing after the home isolation period is over.

As per the revised guidelines, the patient should be clinically assigned a mild asymptomatic case by the treating Medical Officer. The asymptomatic cases are laboratory confirmed cases not experiencing any symptoms and having oxygen saturation at room air of more than 94 per cent.

Clinically assigned mild cases are patients with upper respiratory tract symptoms (and/or fever)



without shortness of breath and having oxygen saturation at room air of more than 94 per cent are recommended for home isolation,

the revised guidelines said. It said that a caregiver should be available to provide care on a 24x7 basis and a communication link be-

tween the caregiver and hospital is a prerequisite for the entire duration of home isolation. Elderly patients aged more than 60 years and those with co-morbid conditions such as hypertension, diabetes, heart disease. chronic lung, liver or kidney disease, cerebro-vascular disease shall only be allowed home isolation after proper evaluation by the treating medical officer.

Talking about treatment protocols, the revised guideline said, Patients must be in communication with a treating physician and promptly report in case of any deterioration. If fever is not controlled with a maximum dose of Tab Paracetamol 650mg four times a day, consult the treating doctor who may consider advising other drugs like nonsteroidal anti-inflammatory drugs (NSAID) (ex Tab. Naproxen 250 mg twice a day).


It further stated that consider Tab Ivermectin (200 mcgkg once a day, to be taken empty stomach) for 3 to 5 days. Inhalational Budesonide (given via inhalers with spacer at a dose of 800 mcg twice daily for 5 to 7 days) should be given if symptoms (fever and/or cough) are persistent beyond 5 days of disease onset.

The decision to administer Remdesivir or any other investigational therapy must be taken by a medical professional and administered only in a hospital setting. Do not attempt to procure or administer Remdesivir at home, it said.



Chartered plane makes belly-landing at Mumbai airport

Mumbai, May 6: A chartered plane carrying five people, including a patient and a doctor, landed on its belly at Mumbai airport late Thursday evening after declaring a full emergency, with the airport authorities foaming the runway to avoid the plane catching fire.

All passengers were evacuated safely after belly-landing of the plane, which was flying from Nagpur to Mumbai, according to the airport. A full emergency was declared for the non-scheduled Beechcraft flight.

While it could not be independently confirmed, reports said that a wheel of the aircraft came off soon after taking off from Nagour, Pictures of the plane landing on the foamed runway were also doing the rounds on social media. In a detailed statement, the Mumbai airport said the plane -carrying two crew members, one patient, one relative and a doctor -- did a belly-landing at the airport at 2109 hours on Thursday.

"As a precautionary method, CSMIA also foamed RWY 27 in order to avoid the aircraft catching fire. All passengers were evacuated safely and flights operating in and out of CSMIA remain on schedule," the airport said in a statement. According to an official, the aircraft belonged to Gurugram-based Jet Serve Aviation Pvt Ltd. "The airport's emergency response team, including the fire and rescue responders, follow-me vehicles, CISF, medical team amongst many others, was activated instantly and on standby to provide immediate assistance to ensure the safe evacuation of the passengers," the statement said

Oximeters, thermal scanners for cows in UP's 'gaushalas'

Lucknow, May 6: Amid the surge in coronavirus cases, the Uttar Pradesh government is providing oximeters and thermal scanners for cows housed in the state's 'gaushalas'.

A recent press release from Chief Minister Yogi Adityanath's office also said the state government has issued instructions to set up help desks in every district for



its cow protection agenda.

The government has issued instructions that all cowsheds must strictly follow the COVID-19 protocol, and made wearing masks and frequent thermal screening mandatory there. It is providing thermal scanners and oximeters, apparently to detect early symptoms in animals of COVID-19, which authorities said Thursday had killed 353 people in the state over the past 24 hours.

There are reports of hospitals



turning away patients and long waits at crematoriums at several places in the state as it battles the second wave of the pandemic.

The press release on cowsheds said the 'gaushalas' will be 'equipped with all the medical equipment such as oximeters and thermal scanners for cows and other animals as well"

"In view of the current Covid situation, a total of 700 help desks for the welfare of cows have been set up across the districts of the state. With this, 51 oximeters and 341 thermal scanners have also been provided to ensure better animal care and testing," it said.

The statement said stray cows in large numbers are being given shelter at the 'gaushalas' due to the efforts of the chief minister. The government is also rapidly increasing the number of the existing cow shelters to deal with the stray cattle menace, it said.

MEDICAL INFRA OF STATE IN SHAMBLES: HC TO DELHI GOVT

The Delhi High Court made the remarks while hearing petitions relating to various issues including oxygen supply arising due to the rise of Covid cases in the national capital

New Delhi, May 6: The Delhi High Court Thursday said the existing medical infrastructure in the national capital was "exposed" and in "shambles" when put to the test during the pandemic and directed the Delhi government to provide facility for medical treatment as required by all residents of the national capital who are suffering from COVID-19.

A bench of Justices Vipin Sanghi and Rekha Palli further said the government was behaving like an ostrich with its head in the sand if it was disputing that the medical infrastructure was not in shambles.

The bench said,"the existing medical infrastructure in the state is completely exposed... When it was put to the test and this court cannot turn away people like the petitioner by merely telling him that the state does not have the infrastructure to deal with his situation..." To this Mehra said, "The existing infrastructure is struggling, but the court may not say it is in shambles as that has a different connotation to it. In the absence of oxygen what could the infrastructure do. Hospitals were reducing beds due to lack of oxygen." He said the government has taken several initiatives, like augmenting

beds by 15,000 and ICU beds by 1,200, which are in the pipeline and the oxygen is also coming in. However, the bench said "No that is not right. It is not just oxygen. Is oxygen enough? If you have oxygen, do you have everything? Pipeline is pipeline. They are not there now". The observations and direction came while hearing a 53 year old COVID patient's plea for an ICU bed with a ventilator as his SPO2 (oxygen saturation)levels had fallen to around 40 and he was unable to get ICU beds anywhere.

The court said that it was the obligation of the state to provide sufficient infrastructure to protect the lives of the people and the same cannot be understated. "At the same time, we cannot lose sight of the fact that we are faced with a one in a century pandemic and even the most economically advanced countries found their infrastructure lacking to deal with the massive surge of COVID-19 patients requiring hospitalisation," the bench said. Referring to the relief sought in the instant plea, the bench said it was sworn to protect the fundamental rights of the people and therefore, "we are bound to issue a writ to the state to provide the infrastructure to enable the petitioner to undergo the treatment required to save his life.

Three Navy warships on 'Onset of Monsoon expected around June'

New Delhi, May 6: Monsoon rains that mark the start of the fourmonth rainy season are likely to enter India through the southern coast around June 1, in line with typical patterns, a top government

official said Thursday.

This is an early indication," Madhavan Rajeevan, secretary of the Ministry of Earth Sciences, said in a tweet. India's weather office will issue its official forecast for this year's monsoon onset May 15, Rajeevan said.



Nearly half of the country's farmland, which has no irrigation cover, depends on annual June-September rains to grow crops such as rice, corn, cane, cotton, and soybeans. The country's weather office said last month the country was expected to get average monsoon rains this year, raising expectations of higher farm output, which is central to the country's economy.

Last year, monsoon rains, which typically arrive on the southern tip of Kerala state around June 1 and retreat from the desert state of Rajasthan by September, were above average for the second year in a row - the first time that has happened in more than six decades. Last year's monsoon rains replenished soil moisture and led to higher crop yields.

23cr Indians pushed into poverty amid Covid: Study

New Delhi, May 6: As the pandemic and the eventual lockdowns wreaked havoc on the economy and livelihoods, around 23 crore Indians have been pushed into poverty during the past one year, showed a report by Azim Premji University.

It said that the rural poverty rate increased by 15 percentage points and the urban poverty rate was up nearly 20 points.

"The number of individuals who lie below the national minimum wage threshold (Rs 375 per day as recommended by the Anoop Satpathy committee) increased by 230 million during the pandemic,' said the report titled 'State of



Working India 2021: One Year of Covid-19'. It noted that though incomes fell across the board, the pandemic has taken a far heavier toll on poorer households.

In April and May, the poorest 20 per cent of households lost their entire incomes. In contrast, the richer households suffered losses of less than a quarter of their pre-pandemic incomes. Over the entire eight-month period (March to October), an average household in the bottom 10 per cent lost ₹15,700, or just over two months' income. Further, as per the report about 1.5

crore workers remained out of work by the end of 2020. About 10 crore people lost jobs during the nationwide April-May 2020 lockdown. "Most were back at work by June 2020, but even by the end of 2020, about 15 million workers remained out of work," it said. Incomes also remained depressed

Average monthly household income per capita in October 2020 (Rs 4,979) was still below its level in January 2020 (Rs 5,989). Job losses were higher for states with a higher average Covid case load. Maharashtra, Kerala, Tamil Nadu, Uttar Pradesh, and Delhi, contributed disproportionately to job losses.

During the lockdown and in the months after, 61 per cent of working men remained employed and 7 per cent lost employment and did not return to work. For women, only 19 per cent remained employed and 47 per cent suffered a permanent job loss during the lockdown, not returning to work even by the end of 2020.

The report showed that younger workers were much more impacted, experiencing higher job losses, of a more permanent nature. Around 33 per cent of workers in the 15-24 years age group failed to recover employment even by December 2020.

Vice-Chancellor of Azim Premji University, Anurag Behar said: "The pandemic has revealed a systemic and moral failure that makes the most vulnerable always pay the greatest price for everything. We have to change this from the core."

NGOs DEMAND UN IMPOSE ARMS EMBARGO

United Nations, May 6: More than 200 global organisations urged the UN Security Council to impose an arms embargo on Myanmar, saying the time for statements has passed and immediate action is needed to help protect peaceful protesters against military rule and other opponents of the junta.

A statement by the non-governmental organisations said the military "has demonstrated a callous disregard for human life" since their Feb 1 coup, killing at

least 769 people including 51 children as young as six years old and detaining several thousand activists, journalists, civil servants and politicians. Hundreds of others have disappeared, it said.

"No government should sell a single bullet to the junta under

these circumstances," the NGOs said. "Imposing a global arms embargo on Myanmar is the minimum necessary step the Security Council should take in response to the military's escalating vio-

Pak court asks India to cooperate in Jadhav case

Islamabad, May 6: A top Pakistani court hearing the case of death row convict Kulbhushan Jadhav has asked India to cooperate in the legal proceeding over the matter, saying appearing before the court did not mean a waiver of sovereignty.

A three-member bench of the Islamabad High Court (IHC), comprising Chief Justice Athar Minallah, Justice Aamer Faroog and Justice Miangul Hassan Aurangzeb, Thursday resumed hearing of the petition by Pakistan's Ministry of Law and Justice seeking appointment of a lawyer for Jadhav.

Attorney General Khalid Jawed Khan told the bench that to comply with the ruling of the International Court of Justice (ICJ), Pakistan last year promulgated the law, CJ (Review and Reconsideration) Ordinance 2020 to enable Jadhay to

avail himself of the statutory rem-

However, he argued, the Indian government deliberately avoided joining court's proceedings, was raising objections to a trial before a Pakistani court, and had declined to even appoint a counsel for the IHC's proceedings saying it "is tantamount to surrendering sovereign

"It appears the Indian government has objected, not for non-implementation of ICJ's verdict but to engineer default on the basis of which it would [try to] justify going to the ICJ again," he said.

The chief justice expressed surprise that the Indian High Commission in Islamabad, which had approached the IHC seeking the release of five prisoners and had secured a decision in their favour, was questioning the legitimacy of the same court, the report said


China condemns G7 criticism on human rights

Beijing, May 6: China condemned Thursday a joint statement by G7 foreign ministers that expressed support for Chinese-claimed Taiwan and cast Beijing as a bully, saying it was a gross interference in China's internal affairs.

G7 foreign ministers said in a communique after a London summit that China was guilty of human rights abuses and of using "coercive economic policies", which the G7 would use collective efforts to stop.

In an unusual step, the G7 also said they supported Taiwan's participation in World Health Organization forums and the World Health Assembly - and expressed concern about "any unilateral actions that could escalate tensions" in the Taiwan Strait.

Tumbling Chinese rocket expected to re-enter atmosphere May 8

Colorado, May 6: Remnants of a large Chinese rocket launched last week are expected to plunge back through the atmosphere this weekend in an uncontrolled re-entry being tracked by US



Space Command, the US military said Thursday.

The Long March 5B rocket blasted off from China's Hainan Island April 29 carrying the Tianhe module, which contains what will become living quarters for three crew on a permanent Chinese space station. The Tianhe launch was the first of 11 missions

needed to complete the station.

The rocket's exact point of descent into Earth's atmosphere as it falls back from space "cannot be pinpointed until within hours of its reentry," which is projected to occur around May 8, Space Command said in a statement posted online. Harvard-based astrophysicist

China silent amid rising concerns

China Thursday declined to comment on reports that the debris of its Long March 5B rocket amid concerns that it could cause damage if it crashes in civilian areas. While the Foreign Ministry spokesman Wang Wenbin parried questions about the reports that the US defence department was tracking the falling rocket debris, official media here quoted Chinese experts as saying that the parts of the disintegrated rocket will fall in international waters. Asked what measures China is taking to deal with the situation arising out of the falling rocket, Wang said "for specifics I refer you to the competent authority." "As a principle, China is committed to the peaceful use of outer space and believes we should conduct international cooperation in this area," he said. "We stand ready to work with all parties to make efforts for the peaceful use of outer space and uphold its safety and security," he said.

Jonathan McDowell said potentially dangerous debris will likely escape incineration after streaking through the atmosphere at hypersonic speed but in all likelihood would fall into the sea, given that 70% of the world is covered by ocean.

There is a chance that pieces of the rocket could come down over land, perhaps in a populated area, as in May 2020, when pieces from another Chinese Long March 5B rocket rained down on the Ivory Coast, damaging several buildings, though no injuries were reported, said McDowell.

The 18th Space Control Squadron at Vandenberg Air Force Base, about

160 miles (257 km) northwest of Los Angeles, is tracking the spent rocket, plotting updates on its location as it descends, the US Space Command said. The squadron tracks more than 27,000 man-made objects in space, most of them in low orbit, it said.

Based on its current orbit, the debris trail is likely to fall somewhere as far north as New York, Madrid or Beijing and as far south as southern Chile and Wellington, New Zealand, or anywhere in between,

McDowell said. McDowell said most countries have sought to design spacecraft in such a way as to avoid large, uncontrolled re-entries, since large chunks of the NASA space station Skylab fell from orbit in July 1979 and landed in Australia.

"It makes the Chinese rocket designers look lazy that they didn't address this," he said, calling the situation "negligent."

China suspends economic dialogue with Australia

Beijing, May 6: China "indefinitely" suspended Thursday all activity under a China-Australia Strategic Economic Dialogue, its state economic planner said, the latest setback for strained relations between the two countries.

"Recently, some Australian Commonwealth Government officials launched a series of measures to disrupt the normal exchanges and cooperation between China and Australia out of Cold War mindset and ideological discrimination," China's National Development and Reform Commission (NDRC) said on the decision.

The commission did not say in the statement what specific measures prompted the action.

China's foreign ministry spokesman, Wang Wenbin, told a tech giant Huawei from its 5G net-

London, May 6: Chelsea's decision to fire a club legend suddenly doesn't seem so callous after all. While Frank Lampard's name has hardly been forgotten by the Chelsea fans — there were chants outside Stamford Bridge before kickoff Wednesday — new manager Thomas Tuchel is quickly creating his own legacy after leading the London club into the Champions League final against Manchester City.

Chelsea even made record 13-time European Cup champions Real Madrid look ordinary as goals from Timo Werner and Mason Mount sealed a 2-0 victory that ousted Madrid 3-1 on aggregate.

Perhaps the stragglers leaving the bars near Stamford Bridge could hear the roar Tuchel let out on the field inside the empty stadium long after his players had departed the field. It will certainly have been heard in the Chelsea boarddismiss Lampard in January and hire Tuchel now seems vindicated.

Just like when owner Roman Abramovich made mid-season managerial changes in the 2007-08 and 2011-12 seasons, Chelsea will end the campaign by contesting the biggest game in European football.

And by the end of the month two Champions League trophies could be at Stamford Bridge, with Chelsea the first club to reach the men's and women's finals in the same season.

Even though the men's showpiece will be an all-English encounter May 29, the Premier League rivals will have to fly four hours to play the UEFA showpiece in Istanbul, which is currently in a coronavirus lockdown.

And so they did, helped by the arrival of Christian Pulisic from the bench as Werner's replacement to spark the second goal. The American headed to N'Golo Kante and received the ball back to feed Mount, who lifted a shot over

London, May 6: Thousands of English football fans will be hoping that a ban on international travel ends in time for them to get to Turkey in three weeks to see Chelsea and Manchester City contest the Champions League final without facing restrictions.

In a further easing of coronavirus laws in England, the government is set to allow overseas travel again from May 17 but it's unclear which destinations will still require forms of quarantine on return.

High infection rates saw Turkey last week enter its first national lockdown. That is due to end May 17, creating the possibility of that country not being on the green list to allow fans to return from the all-English Champions League final May 29 without having to self-isolate at home for 10 days.

Up to 4,000 fans from both Chelsea and City could be allowed into the 76,000-seat Atatürk Olympic Stadium, which was originally due to host last season's final.

date, Turkey announced 26,476 new coronavirus cases and 356 deaths, taking its overall toll to 41,883.

4 English counties interested to host remainder of IPL 2021

London, May 6: Four premier English counties - Middlesex, Surrey, Warwickshire and Lancashire - have expressed interest in hosting the remaining 31 games of the Indian Premier League, which was postponed after coronavirus breached the bio-bubble to infect four Indian cricketers.

With India anticipating a third wave of the pandemic later during the year, BCCI is exploring a window in September after the conclusion of India's England tour to complete the tournament. India's tour of England ends September 14.

According to 'ESPNCricinfo', Lord's, Oval (both London), Edgbaston (Birmingham) and Emirates Old Trafford (Manchester) are understood to be part of the group who wrote to the ECB expressing their interest.

"The plans would see the tournament completed in around two weeks in the second half of September," according to the report. BCCI is ideally looking at a 20-day win-

dow in order to complete the meet. It is expected that at the ICC Chief Executives Meeting scheduled later Thursday, the representatives of the BCCI and the ECB may discuss the matter. A logic that goes in the favour of IPL is that it provides a good opportunity to players to prepare for the World T20 which in all likelihood will be moved to the UAE from India.


Saina, Srikanth's Olympics hopes hang by a thread

New Delhi, May 6: London Olympics bronze-medallist Saina Nehwal and men's star Kidambi Srikanth's last hopes of Olympic qualification hang in balance as the Indian government negotiates for their participation in the Malaysian Open amid a ban on

flights from India in that country. Following the postponement of the India Open (May 11-16), Saina and Srikanth's hopes of qualifying for the Tokyo Games hinge on the (May 25-30) Kuala Lumpur event followed by the Singapore Open (June 1-6).

In the wake of an unprecedented COVID-19 surge in India, Malaysia and Singapore have banned flights



from the country effective April 28. "The Sports Ministry, through the Ministry of External Affairs, has approached the Malaysian Government requesting to grant permission to the Indian Badminton Team to travel to Malaysia to participate in the Malaysian Open



scheduled from May 25 to May 30," the Sports Authority of India said in a statement

"This is in light of a temporary travel ban that has been imposed by Malaysia on travellers from India, owing to the rising COVID-19 cases in India." it added.

After an initial request made earlier this week, the Indian High Commission in Malaysia "received information from the Malaysian Government that the travel of the team may not be possible immediately". "However, with 19 days left for the competition to begin, the possibility of travel cannot be ruled out completely," SAI stated.

The tournament is one of the last events that contribute to Olympic qualification which ends June 15. All top Indian singles and doubles players like PV Sindhu, Saina Nehwal, Kidambi Srikanth, Sai Praneeth, Satwiksairaj Rankireddy, Chirag Shetty, Ashwini Ponnappa and Sikki Reddy are due

to participate in this. The Badminton Association of India said it has still not given up hope and is awaiting for a response from the Badminton World Federation (BWF)

"Indian nationals won't be allowed in Malaysia as well as in Singapore, this is already in public knowledge. This is why we had written to both the Member Countries to consider our request as a special case with respect to the Olympic Qualification of some of our players," BAI general secretary Ajay

Singhania told this agency. "The matter has been taken up with BWF as well and we are awaiting Badminton Malaysia's response. Until they decline any possibility we will continue to pursue every opportunity that we have to send our
